# Unification of the Gauge Theories

#### Abstract

We take the Christoffel coefficients as an operator and introduce new mappings for quaternionic products to reach the theory of electrodynamics in general spacetime. With the help of the directional operator of the covariant derivative, we generalize the quaternioic mechanism to the theory of gravity and show that the Einstein equation has the freedom to choose the constant term in agreement with the covariant derivative.


Keywords: Quaternions, Theory of gravity, Christoffel connections, Riemann's curvature tensor, Ricci tensor

## I. INTRODUCTION

After general relativity succeeded in explaining the universe, numerous attempts were made to develop geometric electrodynamics. Most of these attempts were unsuccessful $[1-11]$. Our goal now is to attempt this objective in a significantly different way. We want to incorporate the theory of gravity into the mechanism of electrodynamics. This may help us with a higher appreciation of quantum gravity. Since the realization of quantum gravity is universally craved by physicists, it is possible to confirm the results of this work by separating the components of Riemann's curvature tensor. This is because the realization of quantum gravity, as a worthwhile goal, has forced us to propose a change in spacetime dimensions [12-19]. In tackling the enigma, we face local obstacles from quaternionic production, such as the contraction of the indices of tangent and cotangent spaces, but the result is crucially the same regardless of the space chosen. Such new perspectives will help us change the theory of gravity. We approach two types of structures, the spacetime metric and the quaternionic metric (quaternionic production under new metric). With quaternions, the transition from electrodynamics to gravity is possible, as will be shown. However, there is a fundamental difference between the two theories. Systematically, electrodynamics is a theory with two components which can be clarified as the strength tensor in four-dimensional space. If one extends electrodynamics to gravity theory using quaternions, there are four components in a fourdimensional spacetime. Hence, we encounter the concept of component separation. This change in the structure of the components leads to equations of motion and finally to Bianchi's identity [20-25].
The result of this article could be a modified gravitational theory (a modification of the Einstein equation), which formally assumes additional conditions [26-29]. The additional conditions added to the Einstein equation are seen strictly from a pure point of view, never achieved by the concept of geometry. We will derive Einstein's equa-
tion with additional conditions and prove its necessity. The interpretation of Einstein's historical theorem is one of the consequences of the theory that has the potential to be transformative [21, 22, 24]. It is an achievement to induce the behavior of gauge fields in gravity. The last theorem is complicated by Riemann's four-component curvature tensor. Of course, the theory of gravity has a gauge-theoretic property similar to that of gauge fields theory. The definition of the directional covariant derivative operator is an innovation in the present work. We will explain its action in a subsection, but presently we will use its results only.

Clarification- It is necessary to emphasize some definitions and denotations: (1) The vector and dual spaces (distinguished by $\varepsilon$ and $\varepsilon^{\star}$ ) are ordered, and denoted by $\varepsilon^{\star} \otimes \varepsilon$; other orders are not allowed. $u^{\alpha} e_{\alpha} \in \varepsilon$ and $u_{\alpha} e^{\alpha} \in \varepsilon^{\star} ; e_{\alpha}$ and $e^{\alpha}$ are also the tangent and cotangent unit vectors. (2) The notation of $u_{\mu \nu}^{\alpha \beta \cdots}:=$ $u_{\mu \nu}^{\alpha \beta \cdots} \hat{e}^{\alpha} \times \hat{e}^{\beta} \cdots \otimes \hat{e}_{\mu} \times \hat{e}_{\nu} \cdots$ shows the multicomponent member. The notation is changed as follows; the $u_{\mu \nu}^{\alpha \beta}$ parts are denoted by $u_{\mu \nu}^{\alpha \beta}$. (3) The interaction of indices occurs only from a vector to the dual space, left to right and vice versa, anyhow, from a vector space into the dual one. (4) Metric similarity transformations have no influence on the physical conditions.
Establishing- Introduction to "Ast" Mapping: We define the new mapping (ast product) based on its result as the only direction-independent action of the vector on its relevant dual space,

Also, the definition of the mapping as an action is:

In this way, $\varepsilon^{\star} \overrightarrow{\times} \varepsilon$ and $\varepsilon \overleftarrow{\times} \varepsilon^{\star}$ lead to invalid results. We can also represent this with $e_{\alpha} \times e^{\beta}$ and so on. Now we follow the classical relation of the Christoffel coefficients; we define $B_{\nu ; \alpha}^{\mu}=B_{\nu, \alpha}^{\mu}+\Gamma_{\alpha \beta}^{\mu} B_{\nu}^{\beta}-\Gamma_{\alpha \nu}^{\beta} B_{\beta}^{\mu}$ and the ast mapping, and we define the directed gamma operator as follows;

Here we will not mention the direction of the action. Therefore, operator $\hat{\Gamma}$ obtains a structure of $\varepsilon^{\star} \times \varepsilon$ and
consequently $\hat{\Gamma} \propto \varepsilon^{\star} \times \varepsilon$. We point out that the operation of $\hat{\Gamma}$ is the contraction. In summary, $\hat{\Gamma}$ is an operator in the space of indices.
Due to assumption 1, the contraction of the indices occurs up to the allowed cases; $\Sigma_{\alpha} \hat{e}_{\alpha} \times \hat{e}^{\mu} \hat{e}^{\nu}=\Sigma_{\alpha}\left(\delta_{\alpha}^{\mu} \hat{e}^{\nu}+\right.$ $\left.\hat{e}^{\mu} \delta_{\alpha}^{\nu}\right)$. We assign a Lorentz index of $\hat{\Gamma}_{\mu}$ to the operator (see appendix).
Metric- According to the definition of ast mapping, the metric is a mapping of the form;

The symbol " $\mathbf{g}$ " is the general metric element and comprises $\varepsilon \times \varepsilon$ or $\varepsilon^{\star} \times \varepsilon^{\star}$. Equations 1 and 2 show that the metric (with a repeated index) does not obey the rules of the operator, and it is clear that any other interpretation of equations 1 and 2 would be wrong for the action of the metric. It can be shown that the metric effect does not play a role in the calculation of the components. Following the definition of ast mapping, the operator $\hat{\Gamma}_{\kappa}$ is represented as follows;

We have considered the inverted version of $\hat{\Gamma}_{\kappa}$ as the operator due to the compatibility of the Christoffel connections with the role of the operator. Furthermore, except for the " $\kappa$ " index in $\hat{\Gamma}_{\kappa}$, its other two indices are repeated and dummy. Anyway, according to assumption $2, \hat{\Gamma}_{\kappa} \equiv \hat{\Gamma}_{\kappa} e^{\kappa}$ (without summation), which is the missing part of relation equation 3 . From this follows (a connection coefficient of the first kind):

The above statements and results become easier to understand with the new representation, because the $\hat{\Gamma}_{\zeta}$ operator yields " $\hat{\Gamma}_{\kappa}=\Sigma_{\alpha, \beta} \Gamma_{\beta \kappa}^{\alpha}|\alpha><\beta| \equiv \Gamma_{\beta \kappa}^{\alpha}|\alpha><\beta|$ ". The ast mapping becomes more formal when referring to the "bra- ket" representations. Moreover, the representation corresponding to the "bra-ket" extends our possibilities for future calculations. The $\alpha$ and $\beta$ are dummy indices in the $\Gamma_{\beta \kappa}^{\alpha}|\alpha><\beta|$-operator. They are used, among other things, for the gamma operator effect;

In this process, the box is mated with the alpha vector. That is, the box takes the alpha index. Hence,

We emphasize that in changing the $u_{\lambda}$ notation, the position of the index $\lambda$ in " $u_{\lambda}$ " is the main, but the name of the index changes in "ast" multiplication. However, we should use the ast mapping relations as simply as possible.
Quaternions- The relations that exist between the quaternions' generators $\hat{q}_{1}=I, \hat{q}_{2}=J$ and $\hat{q}_{3}=K$ hold under a Euclidean metric and satisfy the following relations: $\hat{q}_{i} \cdot \hat{q}_{j}=\delta_{i j}$ and $\hat{q}_{i} \times \hat{q}_{j}=\Sigma_{k} \epsilon_{i j k} \hat{q}_{k}$. If we add $\hat{q}_{0}=\Im$ (as identity), we obtain the quaternion expressed by the Lorentz quantities (parameters of the Lorentz index). They are coupled and are called " $q$ vector". The Lorentz quantities (quantities carrying the Lorentz index) are represented by the quaternions. Thus, we have two representations of the Lorentz index: the four-vector and the $q$-vector. We will use the notation $A, B, \cdots$ to represent the quaternions and normally, we construct quaternions from four vectors: $\mathrm{A}=A_{0} \Im+A_{k} \hat{q}^{k} \equiv\left(\mathrm{~A}_{0}, \mathrm{~A}_{k} \hat{q}^{k}\right)_{q}$. Bold letters are used for the space part of the four vectors. The four-vector representation has the basis of the spacetime metric, and the Euclidean metric is for the quaternion representation. This configuration has consequences for quaternionic products. We also consider the Lorentz index in coupling the physical parameters to the quaternion generator. In this way, we can generalize the range of the coupled quantities from four vectors to tensors.
For the $q$-vectors $\hat{\Gamma}$ and C, the extended Grassman quaternion multiplication " $\triangleright "$ (with $*$-product), is defined as follows [30-33]

According to the above, $\vee$ and $\wedge$ add the spatial and temporal components to the above two commutators;
i) The commutator associated with the product " $*$ " is denoted by $[\hat{\Gamma}, C]_{*}=\hat{\Gamma} * \mathrm{C}-\mathrm{C} * \hat{\Gamma}$.
ii) Moreover, we can introduce a new commutator, i.e. the commutator associated with the multiplication of the quaternion $[\mathrm{B}, \mathrm{C}]_{\triangleright}=\mathrm{B} \triangleright \mathrm{C}-\mathrm{C} \triangleright \mathrm{B}$ containing the product $" * "$, when at least one of them is operator.
Based on the operator rule for the connection coefficients $\hat{\Gamma}$, we introduce a new covariant derivative,

where " $e$ " is the coupling coefficient constant with a value of one. As mentioned earlier, $\hat{\Gamma}_{\mu}$ contains two coupling
indices. Due to the operators $\hat{\Gamma}$ 's and the "*"-product $\Delta_{\mu}$ is a semi-complete operator. Equation 7 with the "*"-product has the expected effects

The covariant derivative is not complete. The incompleteness of the derivative operator is evident from equations 4 and 5 .
$\mu$ and $\zeta$ are free indices in $\hat{\Gamma}_{\mu} * \mathrm{~B}_{\zeta}$. This means that $\hat{\Gamma}_{\mu} * \mathrm{~B}_{\zeta}$ ends up being a second rank tensor; In other words, $\hat{\Gamma}_{\mu} * \mathrm{~B}_{\zeta} \propto \Gamma_{\mu \zeta}^{\alpha} B_{\alpha}$ actually has the two free indices $\mu$ and $\zeta$ that can be considered as free indices; $\Gamma_{\mu \zeta}^{\alpha} B_{\alpha} \equiv \Gamma_{\mu \zeta}^{\alpha} B_{\alpha} \mid \mu, \zeta>$. Equation 3, and our calculations in the "bra-ket" notation show that,

It is clear that the free indices after transposition can be seen. In this way, $\left(\Gamma_{\mu \lambda}^{\zeta} \Gamma_{\nu \zeta}^{\kappa}-\Gamma_{\nu \lambda}^{\zeta} \Gamma_{\mu \zeta}^{\kappa}\right)(|\kappa><\lambda|)$ as an operator contains the two free indices $\kappa$ and $\lambda$. It becomes a simplicial $\left[\hat{\Gamma}_{\mu}, \hat{\Gamma}_{\nu}\right]_{* \lambda}^{\kappa}$ which has free $\lambda$ and $\kappa$ indices. Next, we follow the computation of $\left[\Delta_{\alpha}, \Delta_{\beta}\right]_{*}$. We compute the case without torsion,

We are in a situation where the four components of the Riemann's curvature tensor have become a single operator with two distinct subspaces. Then, we will look at the roles of the components. With the action role and equation 10 , and for a space with torsion, the new covariant derivative satisfies the following commutation relation, $\left[\Delta_{\alpha}, \Delta_{\beta}\right]_{*}=e \hat{R}_{\alpha \beta}+e^{2}\left(\Gamma_{\alpha \beta}^{\lambda}-\Gamma_{\beta \alpha}^{\lambda}\right) \hat{\Gamma}_{\lambda}$. ## II. ELECTRODYNAMICS

In this section we present a mechanism according to which, first, the components of gauge fields $\mathbf{A}$ are coupled with the generators of the quaternions $(\mathbf{A} \rightarrow \mathbf{A})$. Then, a coupling between the components of the covariant derivative and the quaternion generators is established in the same way. The quaternion variables obtained in this way help us to reconstruct the strength tensor of the fields. Due to the semi completeness of the covariant derivative operator, we will introduce a new quaternion commutator to obtain the equation of motion and conclude the theory.
Based on the above, we will define new commonly used quatrain variables and operators. Starting from the tangent spaces, we introduce the operators and vectors as $q$-variables, $z_{t}=\left(\imath \mathrm{A}^{0}, \mathrm{~A}^{i} \hat{q}_{i}\right)$ and $D_{t}=\left(\imath \Delta_{0}, \boldsymbol{\Delta}_{i} \hat{q}^{i}\right)$. The position of the indices is important here. A vectors are the fields; $\mathbf{A}$ is the vector potential and $\mathrm{A}_{0}=\phi$ represents the scalar case. There are two more i.e. $z_{c}=\left(\imath \mathrm{A}_{0}, \mathrm{~A}_{i} \hat{q}^{i}\right)$ and $D_{c}=\left(\imath \Delta^{0}, \Delta^{i} \hat{q}_{i}\right)$.
We show that Maxwell's equations are accessible with augmented quaternions. The given content confirms the above definitions of the $q$-vectors. We emphasize that the quaternion mapping creates two separate spaces: the tangent and the cotangent $q$-vectors. Basically, the measures of these two spaces are connected by the new matrix elements, not by the Minkowski metric. Our calculations show that the law of direct and crossed multiplication between $q$-vectors is given by $H^{\mu \nu}=\left(\begin{array}{cccc}1 & \imath & \imath & \imath \\ -\imath & -1 & 1 & -1 \\ -\imath & -1 & -1 & 1 \\ -\imath & 1 & -1 & -1\end{array}\right)$, where

The $n_{k}^{i j}$ symbol is used when its indices are all on the same row. When all indices are in a row, it is similar to the Levi-Civita symbol. We will see later where the temporal index is located. Since the product of the quaternions is a quaternion, the new $q$-variable in the quaternoin space can be named as

## III. GEOMETRY

In this section, the gauge fields are replaced by the Christoffel connections A to $\Gamma$. This change does not affect the definition of the covariant derivative operator. Using the same method of the previous section and multiplying the four components of the Riemann's curvature tensor into two two-component subspaces, we define the quaternion variables as $z_{c}=\left(\imath \hat{\Gamma}_{0}, \hat{\Gamma}_{i} \hat{q}^{i}\right)$ and $D_{c}=\left(\imath \Delta^{0}, \Delta^{i} \hat{q}_{i}\right)$. It is clear that $\hat{\Gamma}^{0}=g^{0 \zeta} \hat{\Gamma}_{\zeta}$, and this is a general case. If we set the above points and emphasize the position of the indicators, we can write

With the help of these preliminary remarks, and similar to the relation in 15 , we arrive at the definitions

The new notation $\mathcal{F}_{\mu \nu}$ (Eq.14), is only to visually separate the variable of this part from that of the previous part, i.e., $\mathcal{E}_{\mu \nu}$. Therefore, all the previous relationships and their placements are maintained with this transformation. Thus, the relation in 18 will be the equation of motion for the new fields $\mathcal{F}_{\mu \nu}$. By entering the quaternion current density and separating the main equations into real and imaginary components, we have

The relationship between the dynamics of the geometric tensor and the sources is clear and obvious. Comparing the results from the previous section, it is clear that the properties of the gauge field strength tensor apply to both components of Riemann's curvature tensor. These performances emphasize that the Christoffel connections have the gauge property. Equations 25 and 27 give the source less equations:

Eq. 28 represents the Bianchi identities and can be derived from $\hat{G}^{\mu \nu}=\frac{1}{2} \varepsilon^{\mu \nu \alpha \beta} \hat{R}_{\alpha \beta}$. For the Bianchi identities, the sub-components of the released space behave independently. But in the second relation, which is independent of the source, the behavior of the second Bianichi identity is intertwined with the basis of the subcomponents. The remaining two relations of the basic equation of motion (Eq.27) are as follows:

which $J_{\nu}$ in Eq.29, still gives the current density as Eq.21. together with $\hat{R}_{\mu \nu}^{; \mu ; \nu}=0$ and the condition $\mathrm{J}_{\nu}^{; \nu}=0$. Besides the gauge condition, the precondition

A new tensor, $G^{\kappa \lambda}{ }_{\mu \nu}$, can be introduced here:

$\mathcal{R}$ is the Ricci scalar. As far as we know

& :=\mathrm{S}_{\mu \nu}^{\lambda},

so Eq. 30 becomes

if one now sets $\mathrm{S}_{\mu \nu}^{\lambda}:=\mathrm{T}_{\nu ; \mu}^{\lambda}$ and that based on the equation $9,-\frac{1}{2} \delta_{\nu}^{\lambda} \mathcal{R}_{; \mu}+R^{\lambda \alpha}{ }_{\nu \alpha ; \mu}=\left[\Delta_{\mu}, \frac{1}{2} \delta_{\nu}^{\lambda} \mathcal{R}+R^{\lambda \alpha}{ }_{\nu \alpha}\right]_{*}$, one finds a more completely form of 31 ,

is like the famous case $\mathrm{C}_{\lambda \nu}=-\Lambda g_{\lambda \nu}$. It turns out that $\mathbf{C}_{\lambda \nu}=f_{\lambda \nu}(\mathbf{g})$ (for example $\left(e^{\kappa \mathbf{g}}\right)_{\lambda \nu}, \mathbf{g}$ is the matrix for the metric). $\mathrm{C}_{\lambda \nu}$, is a geometrical quantity, not matter. However, it can be considered as general background matter and can be absorbed by the tensor $\mathrm{T}_{\lambda \nu}$ and become zero. In the case of lower indices,

In the last equation, the characters of geometry and matter are separated. The fact that in Einstein's theory of gravitation Einstein's term (in agreement with the covariant derivative) is not the only way to choose $\mathrm{C}_{\lambda \nu}$ is another result of this mechanism. We must also consider some constants that indicate the spacetime constraints to solve the equation of gravity. It is a question of finding the constant from equation 34, because it is not a unique quantity. For any kind of principal change in the constant of equation 34 (constant in agreement with covariant derivative), we naturally enter a new universe. Among the possible options for the constant $\mathrm{C}_{\lambda \nu}$, equation 34 makes a perturbation theorem. What can be obtained, however, is the non-uniqueness of Einstein's famous theorem.

## IV. DISCUSSION

Here, we have used a quaternion mechanism to form new vectors. We have given $q$-vectors as physical quantities-such as events in the manifold of spacetimecorresponding to the position of the Lorentz indices and coupled to the generators of quaternion algebra. By introducing the operator $\hat{\Gamma}_{\mu}$ and the mapping "ast" (*product), we then succeeded in obtaining the theory of gauge fields in a general spacetime. If we introduce the new antisymmetric tensor $n_{k}^{i j}$ and use the equations of gauge theory motion, we obtain the Bianchi identities. We have also shown that the Bianchi identities are physical relations, not mathematical structures. As we proceeded, we replaced the gauge fields with the Christoffel coefficients and followed the improved quaternion mechanism to access the theory of gravity. Our calculations have shown that with this substitution and with more degrees of freedom for Riemann's curvature tensor, the gravitation theory is still followed and that the Einstein constant term is a necessity for the equation of motion. The results of gravity are much higher than those of electrodynamic theory, and the reason for this difference is Riemann's curvature four-component tensor. As for the Bianchi identities in gravity, we have concluded that the identities are part of the equations of motion. Perhaps the most important result after the derivation of the
equation of gravity is the formalization of the constant term (as Einstein's constant term) in the Einstein equation. We have also established that the constant term is exclusively geometric. Having decomposed the fourcomponent Riemann's curvature tensor into one with two component subsections, another result of this work is to emphasize the independent behavior of the two component subsections of the curvature tensor. The result of the present work is a commentary on [27, 28] and many other references and matches the physical data with the solutions of the Einstein equation, with many corrections to the Einstein theory of gravity using the unprincipled modification approach to the Einstein equation (modifications that do not apply to equation 32). By separating the components of the Riemann's curvature tensor, we can also develop a new approach to quantum gravity. The conclusion of this article is that any type of manipulation in Einstein's equation is not correct and must be compatible with the condition, "Covariant derivative is equal to zero".

## V. CONCLUSIONS

We demonstrate that, proving gravitational issues, such as dark matter, Einstein's equation can't take any additional terms. Modifying Einstein's equation is possible only by vanishing covariant derivative terms.

## VII. APPENDIX

After defining the Christoffel coefficients $\Gamma_{\kappa \beta}^{\alpha}$, according to assumption 3 and using the "bra-ket" notation, we can write:

& =g^{\mu \alpha}\left(g_{\mu \beta, \kappa}+g_{\kappa \mu, \beta}-g_{\beta \kappa, \mu}\right) e_{\alpha} e_{\mu} \times e^{\mu} e^{\kappa} e^{\beta} \\
& =\Gamma_{\kappa \beta}^{\alpha} e_{\alpha} e^{\kappa} e^{\beta}=e_{\alpha}\left(\Gamma_{\kappa \beta}^{\alpha} e^{\kappa}\right) e^{\beta} \tag{35}
\end{align*}
$$

this occurs when $\kappa$ is selected. Actually, to define a gamma operator in the space of indices, we need to choose either $\kappa$ or $\beta$. Now, if we choose the $\hat{\Gamma}_{\kappa}$ operator, then we do not have summation on $\kappa$ while there is summation on $\alpha$ and $\beta$. In this way, we will have
