# ARITHMETIC PROPERTIES OF AN ANALOGUE OF $t$-CORE PARTITIONS

#### Abstract

An integer partition of a positive integer $n$ is called to be $t$-core if none of its hook lengths are divisible by $t$. Recently, Gireesh, Ray and Shivashankar ['A new analogue of $t$-core partitions', Acta Arith. 199 (2021), 33-53] introduced an analogue $\bar{a}_{t}(n)$ of the $t$-core partition function $c_{t}(n)$. They obtained certain multiplicative formulas and arithmetic identities for $\bar{a}_{t}(n)$ where $t \in\{3,4,5,8\}$ and studied the arithmetic density of $\bar{a}_{t}(n)$ modulo $p_{i}^{j}$ where $t=p_{1}^{a_{1}} \cdots p_{m}^{a_{m}}$ and $p_{i} \geq 5$ are primes. Very recently, Bandyopadhyay and Baruah ['Arithmetic identities for some analogs of the 5 -core partition function', J. Integer Seq. 27 (2024), \# 24.4.5] proved new arithmetic identities satisfied by $\bar{a}_{5}(n)$. In this article, we study the arithmetic densities of $\bar{a}_{t}(n)$ modulo arbitrary powers of 2 and 3 for $t=3^{\alpha} m$ where $\operatorname{gcd}(m, 6)=1$. Also, employing a result of Ono and Taguchi on the nilpotency of Hecke operators, we prove an infinite family of congruences for $\bar{a}_{3}(n)$ modulo arbitrary powers of 2 .

## 1. Introduction and statement of results

A partition $\pi=\left\{\pi_{1}, \pi_{2}, \cdots, \pi_{k}\right\}$ of a positive integer $n$ is a non-increasing sequence of natural numbers such that $\sum_{i=1}^{k} \pi_{i}=n$. The number of partitions of $n$ is denoted by $p(n)$. The Ferrers-Young diagram of $\pi$ is an array of nodes with $\pi_{i}$ nodes in the $i$ th row. The $(i, j)$ hook is the set of nodes directly to the right of $(i, j)$ node, together with the set of nodes directly below it, as well as the $(i, j)$ node itself. The hook number, $H(i, j)$, is the total number of nodes on the $(i, j)$ hook. For a positive integer $t \geq 2$, a partition of $n$ is said to be $t$-core if none of the hook numbers are divisible by $t$. We illustrate the Ferrers-Young diagram of the partition $4+3+1$ of 8 with hook numbers as follows:


It is clear that for $t \geq 7$, the partition $4+3+1$ of 8 is a $t$-core partition.

Suppose that $c_{t}(n)$ counts the $t$-core partitions of $n$, then the generating function of $c_{t}(n)$ is given by (see [6, Eq 2.1])

\begin{equation*}
\sum_{n=0}^{\infty} c_{t}(n) q^{n}=\frac{\left(q^{t} ; q^{t}\right)_{\infty}^{t}}{(q ; q)_{\infty}}=\frac{f_{t}^{t}}{f_{1}} \tag{1.1}
\end{equation*}
$$

where here and throughout the paper, for $|q|<1$, we define $(a ; q)_{\infty}:=\prod_{k=0}^{\infty}\left(1-a q^{k}\right)$ and for convenience, we set $f_{k}:=\left(q^{k} ; q^{k}\right)_{\infty}$ for integers $k \geq 1$.

In an existence result, Granville and Ono [9] proved that if $t \geq 4$, then $c_{t}(n)>0$ for every nonnegative integer $n$. A brief survey of $t$-core partitions can be found in [5].

Again, for an integral power series $F(q):=\sum_{n=0}^{\infty} a(n) q^{n}$ and $0 \leq r<M$, we define the arithmetic density $\delta_{r}(F, M ; X)$ as

$$
\delta_{r}(F, M ; X):=\frac{\#\{0 \leq n \leq X: a(n) \equiv r \quad(\bmod M)\}}{X}
$$

An integral power series $F$ is called lacunary modulo $M$ if

$$
\lim _{X \rightarrow \infty} \delta_{0}(F, M ; X)=1,
$$

that is, almost all of the coefficients of $F$ are divisible by $M$.
Arithmetic densities of $c_{t}(n)$ modulo arbitrary powers of 2,3 and primes greater than or equal to 5 are recently studied by Jindal and Meher [11].

Recall that for $|a b|<1$, Ramanujan's general theta function $f(a, b)$ is given by

$$
f(a, b)=\sum_{n=-\infty}^{\infty} a^{n(n+1) / 2} b^{n(n-1) / 2}
$$

In Ramanujan's notation, the Jacobi triple product identity [3, p. 35, Entry 19] takes the shape

$$
f(a, b)=(-a ; a b)_{\infty}(-b ; a b)_{\infty}(a b ; a b)_{\infty}
$$

Consider the following two special cases of $f(a, b)$ :

$$
\begin{align*}
& \varphi(-q):=f(-q,-q)=\sum_{n=-\infty}^{\infty}(-1)^{n} q^{n^{2}}=\frac{f_{1}^{2}}{f_{2}},  \tag{1.2}\\
& f(-q):=f\left(-q,-q^{2}\right)=\sum_{n=-\infty}^{\infty}(-1)^{n} q^{n(3 n-1) / 2}=f_{1} . \tag{1.3}
\end{align*}
$$

In the notation of Ramanujan's theta functions, the generating function of $c_{t}(n)$ may be rewritten as

$$
\begin{equation*}
\sum_{n=0}^{\infty} c_{t}(n) q^{n}=\frac{f^{t}\left(-q^{t}\right)}{f(-q)} \tag{1.4}
\end{equation*}
$$

Recently, Gireesh, Ray and Shivashankar [7] considered a new function $\bar{a}_{t}(n)$ by substituting $\varphi(-q)$ in place of $f(-q)$ in the generating function of $c_{t}(n)$ (in (1.4)), namely

$$
\begin{equation*}
\sum_{n=0}^{\infty} \bar{a}_{t}(n) q^{n}=\frac{\varphi^{t}\left(-q^{t}\right)}{\varphi(-q)}=\frac{f_{2} f_{t}^{2 t}}{f_{1}^{2} f_{2 t}^{t}} \tag{1.5}
\end{equation*}
$$

They proved several multiplicative formulas and arithmetic identities for $\bar{a}_{t}(n)$ for $t=$ 2, 3, 4 and 8 using Ramanujan's theta functions and $q$-series techniques. Using the theory of modular forms, they studied the divisibility of $\bar{a}_{t}(n)$ modulo arbitrary powers of primes greater than 5 . More precisely, they proved the following theorem.

Theorem 1.1. Let $t=p_{1}^{a_{1}} \cdots p_{m}^{a_{m}}$ where $p_{i}$ 's are prime numbers greater than or equal to 5. Then for every positive integer $j$, we have

$$
\lim _{X \rightarrow \infty} \frac{\#\left\{0 \leq n \leq X: \bar{a}_{t}(n) \equiv 0 \quad\left(\bmod p_{i}^{j}\right)\right\}}{X}=1
$$

They also deduced a Ramanujan type congruence for $\bar{a}_{5}(n)$ modulo 5 by using an algorithm developed by Radu and Sellers [15]. Bandyopadhyay and Baruah [2] proved some new identities connecting $\bar{a}_{5}(n)$ and $c_{5}(n)$. They also found a reccurence relation for $\bar{a}_{5}(n)$.

Recently, Cotron et. al. [4, Theorem 1.1] proved a strong result regarding lacunarity of eta-quotients modulo arbitrary powers of primes under certain conditions. We observe that the eta-quotients associated with $\bar{a}_{t}(n)$ do not satisfy these conditions, which makes the problem of studying lacunarity of $\bar{a}_{t}(n)$ more interesting. In this article, we study the arithmetic densities of $\bar{a}_{t}(n)$ modulo arbitrary powers of 2 and 3 where $t=3^{\alpha} \mathrm{m}$. To be specific, we prove the following theorems.

Theorem 1.2. Let $k \geq 1, \alpha \geq 0$ and $m \geq 1$ be integers with $\operatorname{gcd}(m, 6)=1$. Then the set

$$
\left\{n \in \mathbb{N}: \bar{a}_{3^{\alpha} m}(n) \equiv 0 \quad\left(\bmod 2^{k}\right)\right\}
$$

has arithmetic density 1.
Theorem 1.3. Let $k \geq 1, \alpha \geq 0$ and $m \geq 1$ be integers with $\operatorname{gcd}(m, 6)=1$. Then the set

$$
\left\{n \in \mathbb{N}: \bar{a}_{3^{\alpha} m}(n) \equiv 0 \quad\left(\bmod 3^{k}\right)\right\}
$$

has arithmetic density 1.
The fact that the action of Hecke algebras on spaces of modular forms of level 1 modulo 2 is locally nilpotent was first observed by Serre and proved by Tate (see [16], [17], [18]). Later, this result was generalized to higher levels by Ono and Taguchi [14]. In this article, we observe that the eta-quotient associated to $\bar{a}_{3}(n)$ is a modular form whose level is in the list of Ono and Taguchi. Thus, we use a result of Ono and Taguchi to prove the following congruences for $\bar{a}_{3}(n)$.

Theorem 1.4. Let $n$ be a nonnegative integer. Then there exists an integer $c \geq 0$ such that for every $d \geq 1$ and distinct primes $p_{1}, \ldots, p_{c+d}$ coprime to 6 , we have

$$
\bar{a}_{3}\left(\frac{p_{1} \cdots p_{c+d} \cdot n}{24}\right) \equiv 0 \quad\left(\bmod 2^{d}\right)
$$

whenever $n$ is coprime to $p_{1}, \ldots, p_{c+d}$.
The paper is organized as follows. In Section 2, we state some preliminaries of the theory of modular forms. Then we prove Theorems 1.2-1.4 using the properties of modular forms in Sections 3 5 5 respectively. And finally, we mention some directions for future study in the concluding section.

## 2. Preliminaries

In this section, we recall some basic facts and definitions on modular forms. For more details, one can see [12] and [13].

Firstly, we define the matrix groups

\begin{aligned}
\mathrm{SL}_{2}(\mathbb{Z}) & :=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right]: a, b, c, d \in \mathbb{Z}, a d-b c=1\right\}, \\
\Gamma_{0}(N) & :=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \mathrm{SL}_{2}(\mathbb{Z}): c \equiv 0 \quad(\bmod N)\right\}, \\
\Gamma_{1}(N) & :=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \Gamma_{0}(N): a \equiv d \equiv 1 \quad(\bmod N)\right\},
\end{aligned}
$$

and

$$
\Gamma(N):=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \mathrm{SL}_{2}(\mathbb{Z}): a \equiv d \equiv 1 \quad(\bmod N), \text { and } b \equiv c \equiv 0 \quad(\bmod N)\right\}
$$

where $N$ is a positive integer. A subgroup $\Gamma$ of $\mathrm{SL}_{2}(\mathbb{Z})$ is called a congruence subgroup if $\Gamma(N) \subseteq \Gamma$ for some $N$ and the smallest $N$ with this property is called the level of $\Gamma$. For instance, $\Gamma_{0}(N)$ and $\Gamma_{1}(N)$ are congruence subgroups of level $N$.

Let $\mathbb{H}$ denote the upper half of the complex plane. The group

$$
\mathrm{GL}_{2}^{+}(\mathbb{R}):=\left\{\left[\begin{array}{ll}
a & b \\
c & d
\end{array}\right] \in \mathrm{SL}_{2}(\mathbb{Z}): a, b, c, d \in \mathbb{R} \text { and } a d-b c>0\right\}
$$

acts on $\mathbb{H}$ by $\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] z=\frac{a z+b}{c z+d}$. We identify $\infty$ with $\frac{1}{0}$ and define $\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \frac{r}{s}=\frac{a r+b s}{c r+d s}$, where $\frac{r}{s} \in \mathbb{Q} \cup\{\infty\}$. This gives an action of $\mathrm{GL}_{2}^{+}(\mathbb{R})$ on the extended upper half plane $\mathbb{H}^{*}=\mathbb{H} \cup \mathbb{Q} \cup\{\infty\}$. Suppose that $\Gamma$ is a congruence subgroup of $\mathrm{SL}_{2}(\mathbb{Z})$. A cusp of $\Gamma$ is an equivalence class in $\mathbb{P}^{1}=\mathbb{Q} \cup\{\infty\}$ under the action of $\Gamma$.

The group $\mathrm{GL}_{2}^{+}(\mathbb{R})$ also acts on functions $f: \mathbb{H} \rightarrow \mathbb{C}$. In particular, suppose that $\gamma=\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \in \mathrm{GL}_{2}^{+}(\mathbb{R})$. If $f(z)$ is a meromorphic function on $\mathbb{H}$ and $\ell$ is an integer,
then define the slash operator $\left.\right|_{\ell}$ by

$$
\left(\left.f\right|_{\ell} \gamma\right)(z):=(\operatorname{det}(\gamma))^{\ell / 2}(c z+d)^{-\ell} f(\gamma z)
$$

Definition 2.1. Let $\Gamma$ be a congruence subgroup of level $N$. A holomorphic function $f: \mathbb{H} \rightarrow \mathbb{C}$ is called a modular form with integer weight $\ell$ on $\Gamma$ if the following hold:
(1) We have

$$
f\left(\frac{a z+b}{c z+d}\right)=(c z+d)^{\ell} f(z)
$$

for all $z \in \mathbb{H}$ and and all $\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \in \Gamma$.
(2) If $\gamma \in \mathrm{SL}_{2}(\mathbb{Z})$, then $\left(\left.f\right|_{\ell} \gamma\right)(z)$ has a Fourier expansion of the form

$$
\left(\left.f\right|_{\ell} \gamma\right)(z)=\sum_{n \geq 0} a_{\gamma}(n) q_{N}^{n}
$$

where $q:=e^{2 \pi i z / N}$.
For a positive integer $\ell$, the complex vector space of modular forms of weight $\ell$ with respect to a congruence subgroup $\Gamma$ is denoted by $M_{\ell}(\Gamma)$.

Definition 2.2. [13, Definition 1.15] If $\chi$ is a Dirichlet character modulo N, then we say that a modular form $f \in M_{\ell}\left(\Gamma_{1}(N)\right)$ has Nebentypus character $\chi$ if

$$
f\left(\frac{a z+b}{c z+d}\right)=\chi(d)(c z+d)^{\ell} f(z)
$$

for all $z \in \mathbb{H}$ and all $\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \in \Gamma_{0}(N)$. The space of such modular forms is denoted by $M_{\ell}\left(\Gamma_{0}(N), \chi\right)$.

The relevant modular forms for the results of this paper arise from eta-quotients. Recall that the Dedekind eta-function $\eta(z)$ is defined by

$$
\eta(z):=q^{1 / 24}(q ; q)_{\infty}=q^{1 / 24} \prod_{n=1}^{\infty}\left(1-q^{n}\right)
$$

where $q:=e^{2 \pi i z}$ and $z \in \mathbb{H}$. A function $f(z)$ is called an eta-quotient if it is of the form

$$
f(z)=\prod_{\delta \mid N} \eta(\delta z)^{r_{\delta}}
$$

where $N$ is a positive integer and $r_{\delta}$ is an integer. Now, we recall two important theorems from [13, p. 18] which will be used later.

Theorem 2.1. [13, Theorem 1.64] If $f(z)=\prod_{\delta \mid N} \eta(\delta z)^{r_{\delta}}$ is an eta-quotient such that $\ell=\frac{1}{2} \sum_{\delta \mid N} r_{\delta} \in \mathbb{Z}$,

$$
\sum_{\delta \mid N} \delta r_{\delta} \equiv 0 \quad(\bmod 24) \quad \text { and } \quad \sum_{\delta \mid N} \frac{N}{\delta} r_{\delta} \equiv 0 \quad(\bmod 24),
$$

then $f(z)$ satisfies

$$
f\left(\frac{a z+b}{c z+d}\right)=\chi(d)(c z+d)^{\ell} f(z)
$$

for every $\left[\begin{array}{ll}a & b \\ c & d\end{array}\right] \in \Gamma_{0}(N)$. Here the character $\chi$ is defined by $\chi(d):=\left(\frac{(-1)^{\ell} s}{d}\right)$, where $s:=\prod_{\delta \mid N} \delta^{r_{\delta}}$.

Consider $f$ to be an eta-quotient which satisfies the conditions of Theorem 2.1 and that the associated weight $\ell$ is a positive integer. If $f(z)$ is holomorphic at all the cusps of $\Gamma_{0}(N)$, then $f(z) \in M_{\ell}\left(\Gamma_{0}(N), \chi\right)$. The necessary criterion for determining orders of an eta-quotient at cusps is given by the following theorem.

Theorem 2.2. [13, Theorem 1.64] Let $c, d$ and $N$ be positive integers with $d \mid N$ and $\operatorname{gcd}(c, d)=1$. If $f$ is an eta-quotient satisfying the conditions of Theorem 2.1 for $N$, then the order of vanishing of $f(z)$ at the cusp $(c / d)$ is

$$
\frac{N}{24} \sum_{\delta \mid N} \frac{g c d(d, \delta)^{2} r_{\delta}}{g c d(d, N / d) d \delta}
$$

We now recall a deep theorem of Serre [13, Page 43] which will be used in proving Theorems 1.2 and 1.3 .

Theorem 2.3. [13, p. 43] Let $g(z) \in M_{k}\left(\Gamma_{0}(N), \chi\right)$ has Fourier expansion

$$
g(z)=\sum_{n=0}^{\infty} b(n) q^{n} \in \mathbb{Z}[[q]] .
$$

Then for a positive integer $r$, there is a constant $\alpha>0$ such that

$$
\#\{0<n \leq X: b(n) \not \equiv 0 \quad(\bmod r)\}=\mathcal{O}\left(\frac{X}{(\log X)^{\alpha}}\right) .
$$

Equivalently

$$
\lim _{X \rightarrow \infty} \frac{\#\{0<n \leq X: b(n) \not \equiv 0 \quad(\bmod r)\}}{X}=0
$$

Finally, we recall the definition of Hecke operators. Let $m$ be a positive integer and $f(z)=\sum_{n=0}^{\infty} a(n) q^{n} \in M_{\ell}\left(\Gamma_{0}(N), \chi\right)$. Then the action of Hecke operator $T_{m}$ on $f(z)$ is defined by

$$
f(z) \mid T_{m}:=\sum_{n=0}^{\infty}\left(\sum_{d \mid \operatorname{gcd}(n, m)} \chi(d) d^{\ell-1} a\left(\frac{n m}{d^{2}}\right)\right) q^{n}
$$

In particular, if $m=p$ is prime, then we have

$$
\begin{equation*}
f(z) \mid T_{p}:=\sum_{n=0}^{\infty}\left(a(p n)+\chi(p) p^{\ell-1} a\left(\frac{n}{p}\right)\right) q^{n} \tag{2.1}
\end{equation*}
$$

We note that $a(n)=0$ unless $n$ is a nonnegative integer.

## 3. Proof of Theorem 1.2

Putting $t=3^{\alpha} m$ in (1.5), we have

$$
\begin{equation*}
\sum_{n=0}^{\infty} \bar{a}_{3^{\alpha} m}(n) q^{n}=\frac{f_{2} f_{3^{\alpha} m}^{2 \cdot 3)^{\alpha} m}}{f_{1}^{2} f_{2 \cdot 3^{\alpha} m}^{3{ }_{m}}} \tag{3.1}
\end{equation*}
$$

We define

$$
A_{\alpha, m}(z):=\frac{\eta^{2}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta\left(2^{4} 3^{\alpha+1} m z\right)}
$$

For any prime $p$ and positive integer $j$, we have

$$
(q ; q)_{\infty}^{p^{j}} \equiv\left(q^{p} ; q^{p}\right)_{\infty}^{p^{j-1}} \quad\left(\bmod p^{j}\right)
$$

Using the above relation, for any integer $k \geq 1$, we get

$$
\begin{equation*}
A_{\alpha, m}^{2^{k}}(z)=\frac{\eta^{2^{k+1}}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta^{2^{k}}\left(2^{4} 3^{\alpha+1} m z\right)} \equiv 1 \quad\left(\bmod 2^{k+1}\right) \tag{3.2}
\end{equation*}
$$

Next we define

$$
\begin{aligned}
B_{\alpha, m, k}(z) & :=\frac{\eta(48 z) \eta^{2 \cdot 3^{\alpha} m}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta^{2}(24 z) \eta^{3^{\alpha} m}\left(2^{4} 3^{\alpha+1} m z\right)} A_{\alpha, m}^{2^{k}}(z) \\
& =\frac{\eta(48 z) \eta^{2 \cdot 3^{\alpha} m+2^{k+1}}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta^{2}(24 z) \eta^{3^{\alpha} m+2^{k}}\left(2^{4} 3^{\alpha+1} m z\right)}
\end{aligned}
$$

In view of (3.1) and (3.2), we have

$$
\begin{align*}
B_{\alpha, m, k}(z) & \equiv \frac{\eta(48 z) \eta^{2 \cdot 3^{\alpha} m}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta^{2}(24 z) \eta^{3^{\alpha} m}\left(2^{4} 3^{\alpha+1} m z\right)} \\
& \equiv \frac{f_{48} f_{2^{3} 3^{\alpha+1} m}^{2 \cdot 3}}{f_{24}^{2} f_{2^{4} \cdot 3^{\alpha+1} m}^{3 \alpha}} \equiv \sum_{n=0}^{\infty} \bar{a}_{3^{\alpha} m}(n) q^{24 n} \quad\left(\bmod 2^{k+1}\right) \tag{3.3}
\end{align*}
$$

Next, we will show that $B_{\alpha, m, k}(z)$ is a modular form. Applying Theorem [2.1, we find that the level of $B_{\alpha, m, k}(z)$ is $N=2^{4} 3^{\alpha+1} m M$, where $M$ is the smallest positive integer such that

$$
2^{4} 3^{\alpha+1} m M\left(\frac{-2}{24}+\frac{1}{48}+\frac{2 \cdot 3^{\alpha} m+2^{k+1}}{2^{3} 3^{\alpha+1} m}+\frac{-3^{\alpha} m-2^{k}}{2^{4} 3^{\alpha+1} m}\right) \equiv 0 \quad(\bmod 24)
$$

which implies

$$
3 \cdot 2^{k} M \equiv 0 \quad(\bmod 24)
$$

Therefore $M=4$ and the level of $B_{\alpha, m, k}(z)$ is $N=2^{6} 3^{\alpha+1} m$.
The representatives for the cusps of $\Gamma_{0}\left(2^{6} 3^{\alpha+1} m\right)$ are given by fractions $c / d$ where $d \mid 2^{6} 3^{\alpha+1} m$ and $\operatorname{gcd}\left(c, 2^{6} 3^{\alpha+1} m\right)=1$ (see [4, Proposition 2.1]). By Theorem 2.2, $B_{\alpha, m, k}(z)$ is holomorphic at a cusp $c / d$ if and only if

$$
-2 \frac{\operatorname{gcd}(d, 24)^{2}}{24}+\frac{\operatorname{gcd}(d, 48)^{2}}{48}+\left(3^{\alpha} m+2^{k}\right)\left(2 \frac{\operatorname{gcd}\left(d, 2^{3} 3^{\alpha+1} m\right)^{2}}{2^{3} 3^{\alpha+1} m}-\frac{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+1} m\right)^{2}}{2^{4} 3^{\alpha+1} m}\right) \geq 0
$$

Equivalently, $B_{\alpha, m, k}(z)$ is holomorphic at a cusp $c / d$ if and only if

$$
L:=3^{\alpha} m\left(-4 G_{1}+G_{2}+4 G_{3}-1\right)+2^{k}\left(4 G_{3}-1\right) \geq 0
$$

where $G_{1}=\frac{\operatorname{gcd}(d, 24)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+1} m\right)^{2}}, G_{2}=\frac{\operatorname{gcd}(d, 48)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+1} m\right)^{2}}$ and $G_{3}=\frac{\operatorname{gcd}\left(d, 2^{3} 3^{\alpha+1} m\right)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+1} m\right)^{2}}$.
Let $d$ be a divisor of $2^{6} 3^{\alpha+1} m$. We can write $d=2^{r_{1}} 3^{r_{2}} t$ where $0 \leq r_{1} \leq 6$, $0 \leq r_{2} \leq \alpha+1$ and $t \mid m$. We now consider the following two cases depending on $r_{1}$.

Case 1: Let $0 \leq r_{1} \leq 3,0 \leq r_{2} \leq \alpha+1$. Then $G_{1}=G_{2}, \frac{1}{3^{2 \alpha} t^{2}} \leq G_{1} \leq 1$ and $G_{3}=1$. Therefore $L=3^{\alpha+1} m\left(1-G_{1}\right)+3 \cdot 2^{k} \geq 3 \cdot 2^{k}$.

Case 2: Let $4 \leq r_{1} \leq 6,0 \leq r_{2} \leq \alpha+1$. Then $G_{2}=4 G_{1}, \frac{1}{4 \cdot 3^{2 \alpha} t^{2}} \leq G_{1} \leq \frac{1}{4}$ and $G_{3}=\frac{1}{4}$ which implies $L=0$.

Hence, $B_{\alpha, m, k}(z)$ is holomorphic at every cusp $c / d$. The weight of $B_{\alpha, m, k}(z)$ is $\ell=$ $\frac{1}{2}\left(3^{\alpha} m+2^{k}-1\right)$ which is a positive integer and the associated character is given by

$$
\chi_{1}(\bullet)=\left(\frac{(-1)^{\ell} 3^{(\alpha+1)\left(3^{\alpha} m+2^{k}\right)-1} m^{3^{\alpha} m+2^{k}}}{\bullet}\right) .
$$

Thus, $B_{\alpha, m, k}(z) \in M_{\ell}\left(\Gamma_{0}(N), \chi\right)$ where $\ell, N$ and $\chi$ are as above. Therefore by Theorem [2.3, the Fourier coefficients of $B_{\alpha, m, k}(z)$ are almost divisible by $r=2^{k}$. Due to (3.3), this holds for $\bar{a}_{3^{\alpha} m}(n)$ also. This completes the proof of Theorem 1.2,

## 4. Proof of Theorem 1.3

We proceed along the same lines as in the proof of Theorem 1.2. Here we define

$$
C_{\alpha, m}(z):=\frac{\eta^{3}\left(2^{4} 3^{\alpha+1} m z\right)}{\eta\left(2^{4} 3^{\alpha+2} m z\right)}
$$

Using the binomial theorem, for any integer $k \geq 1$, we have

$$
\begin{equation*}
C_{\alpha, m}^{3^{k}}(z)=\frac{\eta^{3^{k+1}}\left(2^{4} 3^{\alpha+1} m z\right)}{\eta^{3^{k}}\left(2^{4} 3^{\alpha+2} m z\right)} \equiv 1 \quad\left(\bmod 3^{k+1}\right) \tag{4.1}
\end{equation*}
$$

Next we define

$$
\begin{aligned}
D_{\alpha, m, k}(z) & :=\frac{\eta(48 z) \eta^{2 \cdot 3^{\alpha} m}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta^{2}(24 z) \eta^{3^{\alpha} m}\left(2^{4} 3^{\alpha+1} m z\right)} C_{\alpha, m}^{3^{k}}(z) \\
& =\frac{\eta(48 z) \eta^{2 \cdot 3^{\alpha} m}\left(2^{3} 3^{\alpha+1} m z\right) \eta^{3^{k+1}-3^{\alpha} m}\left(2^{4} 3^{\alpha+1} m z\right)}{\eta^{2}(24 z) \eta^{3^{k}}\left(2^{4} 3^{\alpha+2} m z\right)}
\end{aligned}
$$

From (3.1) and (4.1), we have

$$
\begin{align*}
D_{\alpha, m, k}(z) & \equiv \frac{\eta(48 z) \eta^{2 \cdot 3^{\alpha} m}\left(2^{3} 3^{\alpha+1} m z\right)}{\eta^{2}(24 z) \eta^{3^{\alpha} m}\left(2^{4} 3^{\alpha+1} m z\right)} \\
& \equiv \frac{f_{48} f_{2^{3} \alpha^{\alpha+1} m}^{2 \cdot 3}}{f_{24}^{2} f_{2^{4} \cdot 3^{\alpha+1} m}^{3 \alpha+1}} \equiv \sum_{n=0}^{\infty} \bar{a}_{3^{\alpha} m}(n) q^{24 n} \quad\left(\bmod 3^{k+1}\right) \tag{4.2}
\end{align*}
$$

We now prove that $D_{\alpha, m, k}(z)$ is a modular form. Applying Theorem [2.1, we find that the level of $D_{\alpha, m, k}(z)$ is $N=2^{4} 3^{\alpha+2} m M$, where $M$ is the smallest positive integer such that

$$
2^{4} 3^{\alpha+2} m M\left(\frac{-2}{24}+\frac{1}{48}+\frac{2 \cdot 3^{\alpha} m}{2^{3} 3^{\alpha+1} m}+\frac{3^{k+1}-3^{\alpha} m}{2^{4} 3^{\alpha+1} m}+\frac{-3^{k}}{2^{4} 3^{\alpha+2} m}\right) \equiv 0 \quad(\bmod 24)
$$

which gives

$$
8 \cdot 3^{k} M \equiv 0 \quad(\bmod 24)
$$

Therefore $M=1$ and the level of $D_{\alpha, m, k}(z)$ is $N=2^{4} 3^{\alpha+2} m$.
The representatives for the cusps of $\Gamma_{0}\left(2^{4} 3^{\alpha+2} m\right)$ are given by fractions $c / d$ where $d \mid 2^{4} 3^{\alpha+2} m$ and $\operatorname{gcd}\left(c, 2^{4} 3^{\alpha+2} m\right)=1$. By using Theorem [2.2, $D_{\alpha, m, k}(z)$ is holomorphic at a cusp $c / d$ if and only if

$$
\begin{gathered}
-2 \frac{\operatorname{gcd}(d, 24)^{2}}{24}+\frac{\operatorname{gcd}(d, 48)^{2}}{48}+2 \cdot 3^{\alpha} m \frac{\operatorname{gcd}\left(d, 2^{3} 3^{\alpha+1} m\right)^{2}}{2^{3} 3^{\alpha+1} m}+\left(3^{k+1}-3^{\alpha} m\right) \frac{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+1} m\right)^{2}}{2^{4} 3^{\alpha+1} m} \\
-3^{k} \frac{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+2} m\right)^{2}}{2^{4} 3^{\alpha+2} m} \geq 0
\end{gathered}
$$

Equivalently, $D_{\alpha, m, k}(z)$ is holomorphic at a cusp $c / d$ if and only if

$$
L:=3^{\alpha+1} m\left(-4 G_{1}+G_{2}+4 G_{3}-G_{4}\right)+3^{k}\left(9 G_{4}-1\right) \geq 0
$$

where $G_{1}=\frac{\operatorname{gcd}(d, 24)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+2} m\right)^{2}}, G_{2}=\frac{\operatorname{gcd}(d, 48)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+2} m\right)^{2}}, G_{3}=\frac{\operatorname{gcd}\left(d, 2^{3} 3^{\alpha+1} m\right)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+2} m\right)^{2}}$
and $G_{4}=\frac{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+1} m\right)^{2}}{\operatorname{gcd}\left(d, 2^{4} 3^{\alpha+2} m\right)^{2}}$.
Let $d$ be a divisor of $2^{4} 3^{\alpha+2} m$. We write $d=2^{r_{1}} 3^{r_{2}} t$ where $0 \leq r_{1} \leq 4,0 \leq r_{2} \leq \alpha+2$ and $t \mid m$. We now consider the following four cases depending on the values of $r_{1}$ and $r_{2}$.

Case 1: Let $0 \leq r_{1} \leq 3,0 \leq r_{2} \leq \alpha+1$. Then $G_{1}=G_{2}, \frac{1}{3^{2 \alpha} t^{2}} \leq G_{1} \leq 1$ and $G_{3}=G_{4}=1$. Hence, we have $L=3^{\alpha+2} m\left(1-G_{1}\right)+8 \cdot 3^{k} \geq 8 \cdot 3^{k}$.

Case 2: Let $0 \leq r_{1} \leq 3, r_{2}=\alpha+2$. Then $G_{1}=G_{2}, \frac{1}{3^{2(\alpha+1)} t^{2}} \leq G_{1} \leq \frac{1}{3^{2(\alpha+1)}}$ and $G_{3}=G_{4}=\frac{1}{9}$. Therefore $L=3^{\alpha+2} m\left(\frac{1}{9}-G_{1}\right) \geq 0$.

Case 3: Let $r_{1}=4,0 \leq r_{2} \leq \alpha+1$. Then $G_{2}=4 G_{1}, \frac{1}{4 \cdot 3^{(\alpha+1)} t^{2}} \leq G_{1} \leq \frac{1}{4}$, $G_{4}=4 G_{3}$ and $G_{3}=\frac{1}{4}$. Hence, we have $L=8 \cdot 3^{k}$.

Case 4: Let $r_{1}=4, r_{2}=\alpha+2$. Then $G_{2}=4 G_{1}, \frac{1}{4 \cdot 3^{(\alpha+1)} t^{2}} \leq G_{1} \leq \frac{1}{4 \cdot 3^{2(\alpha+1)}}$, $G_{4}=4 G_{3}$ and $G_{3}=\frac{1}{36}$. Therefore $L=0$.

Therefore $D_{\alpha, m, k}(z)$ is holomorphic at every cusp $c / d$. The weight of $D_{\alpha, m, k}(z)$ is $\ell=\frac{3^{\alpha} m-1}{2}+3^{k}$ which is a positive integer and the associated character is given by

$$
\chi_{2}(\bullet)=\left(\frac{(-1)^{\ell} 3^{2 \alpha 3^{k}+3^{\alpha} \alpha m+3^{\alpha} m+3^{k}-1} m^{3^{\alpha} m+2 \cdot 3^{k}}}{\bullet}\right) .
$$

Thus, $D_{\alpha, m, k}(z) \in M_{\ell}\left(\Gamma_{0}(N), \chi\right)$ where $\ell, N$ and $\chi$ are as above. Therefore by Theorem [2.3, the Fourier coefficients of $D_{\alpha, m, k}(z)$ are almost divisible by $r=3^{k}$. Due to (4.2), this holds for $\bar{a}_{3^{\alpha} m}(n)$ also. This completes the proof of Theorem 1.3,

## 5. Proof of Theorem 1.4

First we recall the following result of Ono and Taguchi [14] on the nilpotency of Hecke operators.

Theorem 5.1. [14, Theorem 1.3 (3)] Let $n$ be a nonnegative integer and $k$ be a positive integer. Let $\chi$ be a quadratic Dirichlet character of conductor $9 \cdot 2^{a}$. Then there is an integer $c \geq 0$ such that for every $f(z) \in M_{k}\left(\Gamma_{0}\left(9 \cdot 2^{a}\right), \chi\right) \cap \mathbb{Z}[[q]]$ and every $t \geq 1$,

$$
f(z)\left|T_{p_{1}}\right| T_{p_{2}}|\cdots| T_{p_{c+t}} \equiv 0 \quad\left(\bmod 2^{t}\right)
$$

whenever the primes $p_{1}, \ldots, p_{c+t}$ are coprime to 6 .
Now, we apply the above theorem to the modular form $B_{1,1, k}(z)$ to prove Theorem 1.4 .

ARITHMETIC PROPERTIES OF AN ANALOGUE OF $t$-CORE PARTITIONS
Putting $\alpha=1$ and $m=1$ in (3.3), we find that

$$
B_{1,1, k}(z) \equiv \sum_{n=0}^{\infty} \bar{a}_{3}(n) q^{24 n} \quad\left(\bmod 2^{k+1}\right)
$$

which yields

$$
\begin{equation*}
B_{1,1, k}(z):=\sum_{n=0}^{\infty} F_{k}(n) q^{n} \equiv \sum_{n=0}^{\infty} \bar{a}_{3}\left(\frac{n}{24}\right) q^{n} \quad\left(\bmod 2^{k+1}\right) \tag{5.1}
\end{equation*}
$$

Now, $B_{1,1, k}(z) \in M_{2^{k-1}+1}\left(\Gamma_{0}\left(9 \cdot 2^{6}\right), \chi_{3}\right)$ for $k \geq 1$ where $\chi_{3}$ is the associated character (which is $\chi_{1}$ evaluated at $\alpha=1$ and $m=1$ ). In view of Theorem 5.1, we find that there is an integer $c \geq 0$ such that for any $d \geq 1$,

$$
B_{1,1, k}(z)\left|T_{p_{1}}\right| T_{p_{2}}|\cdots| T_{p_{c+d}} \equiv 0 \quad\left(\bmod 2^{d}\right)
$$

whenever $p_{1}, \ldots, p_{c+d}$ are coprime to 6 . It follows from the definition of Hecke operators that if $p_{1}, \ldots, p_{c+d}$ are distinct primes and if $n$ is coprime to $p_{1} \cdots p_{c+d}$, then

$$
\begin{equation*}
F_{k}\left(p_{1} \cdots p_{c+d} \cdot n\right) \equiv 0 \quad\left(\bmod 2^{d}\right) \tag{5.2}
\end{equation*}
$$

Combining (5.1) and (5.2), we complete the proof of the theorem.

## 6. Concluding Remarks

(1) Theorems 1.2 and 1.3 of this paper and Theorem 1.8 of [7] give us the arithmetic densities of $\bar{a}_{t}(n)$ for odd $t$ and similar techniques can not be used to obtain the arithmetic density of $\bar{a}_{t}(n)$ when $t$ is even. It would be interesting to study the arithmetic density of $\bar{a}_{t}(n)$ for even values of $t$.
(2) Computational evidence suggests that there are Ramanujan type congruences for $\bar{a}_{t}(n)$ modulo powers of 2,3 and other primes $\geq 5$ for various $t$ which are not covered by the results of [2] and [7]. We encourage the readers to find new congruences for $\bar{a}_{t}(n)$.
(3) Asymptotic formulas for partition functions and other related functions have been widely studied in the literature. For instance, the asymptotic formulas for $p(n)$ and $c_{t}(n)$ were obtained by Hardy and Ramanujan [10] and Anderson [1] respectively. It will be desirable to find an asymptotic formula for $\bar{a}_{t}(n)$.
(4) Some relations connecting $\bar{a}_{t}(n)$ and $c_{t}(n)$ have been discussed in [2]. A combinatorial treatment to $\bar{a}_{t}(n)$ might reveal more interesting partition theoretic connections of $\bar{a}_{t}(n)$.
