## <span id="page-0-1"></span><span id="page-0-0"></span>Spinning straight cosmic strings with flat exterior solutions generically violate theweak energy condition

Any interior solution for <sup>a</sup> cylindrically symmetric, stationary cosmic string with flat exterior, spinning around its longitudinal axis, and without internal longitudinal currents  $(g_{zz} = 1, g_{tz} = 0)$ , must somewhere violate the weak energy condition of standard genera<sup>l</sup> relativity. Existing interior solutions may be readily fixed by adding mass to the string above that generating its angular deficit, but at the cost of introducing an exterior gravitational field.

This note concerns interior solutions for spinning flat-exterior cosmic strings, when modelled as objects of finite thickness, in standard genera<sup>l</sup> relativity. As far as I know, there are only two such examples in the literature [\[1,](#page-1-0) [2\]](#page-1-1); however, the difficulty described below seems to be quite general.<sup>[1](#page-0-0)</sup>

In the following, where  $r$  appears as a subscript it represents a partial derivative,  $f_r = \partial f / \partial r$ , and geometric units are used such that c and  $8\pi G =$  $1.^2$  $1.^2$ 

<sup>A</sup> stationary cosmic string with <sup>a</sup> flat vacuum exterior can be describedby the metric

with w and b both functions of r. [\[1\]](#page-1-0) For a string of non-zero thickness to be 'regular' (locally Euclidean) on its central axis, its interior solution must have  $b(r) \to r$  and  $w \to 0$  as  $r \to 0$ . For its exterior to be flat, outside some finite coordinate radius  $r = r$ , marking the boundary of the string h and w finite coordinate radius  $r = r_1$  marking the boundary of the string b and w must have the form  $b = B(r + r_c)$ ,  $w = w_1$ , with B,  $r_c$ ,  $w_1$  constant.



Figure 1: General form of  $w(r)$  and  $b(r)$ . As explained in the text, their specific functional forms aren't relevant.

In the local frame defined by  $dx^{\hat{0}} = dt - w d\phi$ ,  $dx^{\hat{1}} = dr$ ,  $dx^{\hat{2}} = dz$ ,  $dx^3 = b d\phi$ , the string's energy tensor is

Outside the string,  $w_r, w_{rr}, b_{rr}$  vanish and the spacetime is vacuum. For the static string where  $w = 0$  everywhere, the energy tensor simplifies to  $T^{00} = -T^{22} = -b_{rr}/b$ , which for  $b_{rr} < 0$  represents a longitudinal tension equa<sup>l</sup> in magnitude to the string's mass density. [\[5](#page-1-4), [6\]](#page-1-5)

For <sup>a</sup> rotating string, the troublesome boundary condition turns out tobe  $w_r = 0$  at its external boundary  $r = r_1$ , which is necessary to smoothly (at least  $C^1$ ) match  $w(r)$  to constant  $w_1$  outside (figure [1\)](#page-0-2). A fast timelike observer travelling at constant  $r = r_1$  with (covariant) four-velocity (note that here  $\beta$  does *not* denote  $v/c$

For any  $\beta$ , an observer travelling sufficiently close to  $v = c$  can reduce  $\epsilon \ll \beta^2$ , so that this expression of the weak energy condition (WEC) of classical genera<sup>l</sup> relativity may arbitrarily closely approac<sup>h</sup> the null energy

<span id="page-1-8"></span><span id="page-1-6"></span><span id="page-1-3"></span><span id="page-1-2"></span><span id="page-1-1"></span><span id="page-1-0"></span>condition for a lightlike observer with  $\epsilon \to 0.3$  $\epsilon \to 0.3$  By choosing a path with  $\beta$ <br>sufficiently small and of the same sign as  $w = (4)$  can be made negative sufficiently small and of the same sign as  $w_{rr}$ , [\(4\)](#page-0-3) can be made negative. Thus any interior solution for <sup>a</sup> rotating string, varying only the spacetime's angular deficit  $b(r)/r$  and angular velocity  $w(r)$ , must at some point violate the weak energy condition.

Neither the magnitude at  $r_1$  of w nor its particular functional form within the string affect this result. In particular, neither enforcing continuitygreater than  $C^1$  at the boundary (so that  $w_{rr} = 0$  at  $r_1$ ) nor pulling  $r_1$ out to spatial infinity will remove the problem (appendix [A\)](#page-1-7).

This violation is easy to miss unless one is looking for it. For seeminglyreasonable values of  $w_1 \ll r_1$  (well below, say, the threshold necessary to create closed timelike curves) interior solutions can be constructed that will create closed timelike curves) interior solutions can be constructed that will satisfy the WEC for any timelike  $u^a$  with spatial component projecting in either one of the z or  $\phi$  directions. [\[4\]](#page-1-3) The violation becomes apparent only when one considers trajectories with <sup>a</sup> little bit of both.

That is not to say that rotating strings can't exist. [4](#page-1-8) If there is <sup>a</sup> difference in  $g_{t\phi}$  between the central axis and some other point in the spacetime, the exterior to the string cannot be simply flat. Some additional field or fields must be added to the metric and energy tensor to compensate for the energyfailure close to  $r_1$ , so that  $T^{\hat{0}\hat{0}}$  will have enough of a mass surplus over the other components to satisfy at least the WEC for all timelike observers (appendix [B\)](#page-1-9). That part of the mass density of <sup>a</sup> rotating string due to its angular deficit  $\mu = 2\pi(B-1)$  is insufficient by itself to support a physically realistic interior solution.

### Appendices

### <sup>A</sup> Adjusting the boundary

What matters for [\(4\)](#page-0-3) is that either  $bw_{rr}$  or  $w_r b_r$  (if  $w \to 0$  on the central<br>axis  $r = 0$ , w, and  $-w$ , must have the same sign at  $r_1$ ) must vanish less axis  $r = 0$ ,  $w_r$  and  $-w_{rr}$  must have the same sign at  $r_1$ ) must vanish less fast with increasing r than  $w_r^2$ . For an interior solution where  $w_{rr}$  also equals 0 at the boundary  $r_1$ , there will still be some point inside the string where  $|w_{rr}| \gg w_r^2/b$ , and the WEC will be violated there. And even if the outer boundary of the string were stretched out to  $r \to \infty$  (so that the string filled all of space) such that for large  $r, w \sim w - C/r^n$  the WEC string filled all of space) such that for large  $r, w \sim w_1 - C/r^n$ , the WEC could not be satisfied for any  $n > -1$ , which would result in  $|w| > Cr$  as  $r \to \infty$ —increasing without bound instead of tapering off.

<span id="page-1-9"></span><span id="page-1-7"></span>with  $f = -m \ln(r/r_c)$  and  $k = -mf$ , and with some suitably chosen interior f (such that f and  $f_r$  are continuous at  $r_1$  and  $f_r = 0$  at  $r = 0$ , and  $f_{rr} \leq 0$  within the string so that  $T^{\hat{0}\hat{0}}$  is positive and dominant over all combinations of  $T^{\hat{a}\hat{b}}$ 's other components) would be sufficient to ensure that an interior solution with  $b$  and  $w$  of the general form here would be physically satisfactory. Other exact solutions for infinite line sources may be adapted to the spinning string in <sup>a</sup> similar manner. An explicit example adaptingthe van Stockum solution is <sup>g</sup>iven in [\[8\]](#page-1-11).

<sup>&</sup>lt;sup>3</sup>This trajectory corresponds to that of an observer travelling close to light speed on <sup>a</sup> path parallel to the <sup>r</sup> axis, and spiralling around it against the rotation of the source.

<sup>&</sup>lt;sup>4</sup>The larger problem of their unrealistic infinite extension in the  $\pm z$  direction can be fixed by enclosing them within <sup>a</sup> suitably bounded object, such as the toroidal trap of [\[7\]](#page-1-10).
