# Effective Field Theory of Gravity: Leading Quantum Gravitational Corre
tions to Newtons and Coulombs Law

In this paper we consider general relativity and its combination with scalar quantum electrodynamics (QED) as an effective quantum field theory at energies well below the Planck scale. This enables us to compute the one-loop quantum corrections to the Newton and Coulomb potential induced by the combination of graviton and photon fluctuations. We derive the relevant Feynman rules and compute the nonanalytical contributions to the one-loop scattering matrix for charged scalars in the nonrelativistic limit. In particular, we derive the post-Newtonian corrections of order  $Gm/c^2r$  from general relativity and the genuine quantum corrections of order  $G\hbar/c^3r^2$ .

## I. INTRODUCTION

At the classical level the interaction between two harged massive parti
les is des
ribed by Newton's and Coulomb's law, in terms of the nonrelativisti potential

$$
V(r) = -G \frac{m_1 m_2}{r} + \frac{1}{4\pi} \frac{e_1 e_2}{r} . \tag{1}
$$

This potential will be modified by relativistic and quantum orre
tions. Radiative orre
tions to the Coulomb potential can be systematically calculated within QED. However, it is well known that general relativity, in
luding scalar  $[1, 2, 3]$  $[1, 2, 3]$  $[1, 2, 3]$  $[1, 2, 3]$ , fermion or photon fields  $[4, 5, 6]$  $[4, 5, 6]$  $[4, 5, 6]$  $[4, 5, 6]$  $[4, 5, 6]$  $[4, 5, 6]$  is not renormalizable. Still, on smooth-enough ba
kground space-time the gravitational field can be quantized consistently  $[1, 2]$  $[1, 2]$ , and as suggested by Donoghue  $[7, 8]$  $[7, 8]$ , one can consider general relativity as an effective quantum field theory in the low-energy limit where renormalizability is no longer an issue.

Within this framework, the one-loop corrections to quantum gravity coupled to a scalar Klein-Gordon field have already been discussed by independent groups, e.g. Donoghue  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$ , Hamber and Liu  $[10]$ , Akhundov et al.  $[11, 12]$  $[11, 12]$ , and Bjerrum-Bohr et al.  $[13, 14, 15]$  $[13, 14, 15]$  $[13, 14, 15]$  $[13, 14, 15]$ , with differing results. The generalization to scalar QED has been first discussed by Bjerrum-Bohr [\[14](#page-13-8)]. Butt [16] has also treated the ase of harged fermions.

In this paper, we are going to reconsider the results for the ase of s
alar QED oupled to gravity (SQED), in order to perform and independent he

. [II](#page-0-1) how to quantize general relativity/SQED with the background field method. In the next section we review how ultraviolet divergen
es from one-loop diagrams an be absorbed into higher-dimensional operators in the effective theory. The definition of the scattering matrix and of the potential for (
harged or neutral) s
alar parti les is given in Se
. [IV.](#page-2-0) In Se
. [V](#page-2-1) we perform the al
ulations of the relevant Feynman diagrams and onstru
t the s
attering potentials at one loop. #### <span id="page-0-1"></span>II. QUANTIZATION OF GENERAL RELATIVITY AND SCALAR QED

The Einstein-Hilbert action for the vacuum is given by

where  $\kappa^2 = 32\pi G$  is the gravitational coupling,  $g_{\mu\nu}$  is the metric tensor with its determinant  $g = \textsf{det} g_{\mu\nu}$ , and  $\mathscr{R} = g^{\mu\nu} \mathcal{R}_{\mu\nu}$  is the curvature scalar. In the following we use the same onvention as Refs. [\[7](#page-13-1), [8](#page-13-2), [9](#page-13-3), [11](#page-13-5), [12](#page-13-6), [13,](#page-13-7) [14,](#page-13-8) [15](#page-13-9), [16](#page-13-10)], with the Minkowski metric  $\eta_{\mu\nu} =$ diag(+1, -1, -1, -1) and  $\hbar = c = 1$ .

luded by adding a ovariant term  $\sqrt{-g} \mathcal{L}_m$  to the action Eq. [\(2\)](#page-0-2),

## A. Ba
kground Field Method

Following Veltman and 't Hooft  $[1, 2]$  $[1, 2]$  we can expand the gravitational field  $g_{\mu\nu}$  into the classical background field  $\bar{g}_{\mu\nu}$  and a small quantum fluctuation  $\kappa h_{\mu\nu}$ :

Here the curvature scalar  $\mathscr R$  and the covariant derivative  $\bar{\mathcal{D}}_{\alpha}$  are evaluated from the background metric  $\bar{g}_{\mu\nu}$ .

In order to quantize gravity we have to fix the gauge and introduce a Faddeev-Popov ghost field. From [1] we take the gauge fixing Lagrangian

with  $\eta^{\nu}$  being the complex Faddeev-Popov ghost field. From this Lagrangian one derives the graviton propagator as quoted in Appendix [A.](#page-8-0)

#### $\mathbf{B}$ . Combining Scalar QED and General Relativity

The generally covariant Lagrangian for scalar QED is [\[14](#page-13-8)]

with the photon field strength  $\mathcal{F}_{\mu\nu} = D_{\mu} \mathcal{A}_{\nu} - D_{\nu} \mathcal{A}_{\mu}$ , and the QED covariant derivative  $D_{\mu} = \partial_{\mu} - ie_{q}A_{\mu}(x)$ , and  $e_q$  being the charge of the scalar particle. In order to get the relevant Feynman rules at one-loop order, we have to expand the Lagrangian  $\mathcal{L}_{SQED}$  to first order in the quantum field h. Using Eqs.  $(5)$ ,  $(7)$  and working with the Lorenz gauge for the photon field,

alars and gravitons an be derived from  $(13)$  and  $(14)$ ,  $[14]$ , and are presented in Appendix [A.](#page-8-0)

# III. GENERAL RELATIVITY AND SCALAR QED AS AN EFFECTIVE FIELD THEORY

The treatment of general relativity as a quantum theory has been dis
ussed in several publi
ations, e.g. [\[1](#page-12-0), [17,](#page-13-11) [18](#page-13-12), [19](#page-13-13), [20,](#page-13-14) [21,](#page-13-15) 22. The standard formalism would start from the action [\(2\)](#page-0-2) and consider the metric as the gravitational field which has to be quantized in the usual way. However, such a theory is not self-contained, since at ea
h order in perturbation theory loop diagrams generate new terms which are not present in the original action  $[1, 2, 3, 23]$  $[1, 2, 3, 23]$  $[1, 2, 3, 23]$  $[1, 2, 3, 23]$  $[1, 2, 3, 23]$  $[1, 2, 3, 23]$ . Because of this renormalization problem, a consistent definition of general relativity as a fundamental quantum theory is unknown so far  $[11]$ .

As mentioned above, the problem can be solved by considering general relativity as an effective quantum field theory at low energies  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$ . In this case, the effective Lagrangian for pure gravity (without a cosmological onstant) has the expansion

Here, the coefficients  $a_1$  and  $a_2$  are energy scale dependent coupling constants in the effective theory which  $-$ 

in principle – could be determined by an experimental measurement. The ellipses denote higher-derivative couplings whi
h are even more suppressed at low energies. Similarly, as shown in [\[14](#page-13-8)] general relativity and scalar QED can be described in the effective-theory framework as well. The 1-loop singularities from graviton and photon ex
hange an be absorbed into the Lagrangian

An explicit discussion of the coefficients  $a_1, a_2, c_1, c_2, d_1$  $a_1, a_2, c_1, c_2, d_1$  $a_1, a_2, c_1, c_2, d_1$ ,  $d_2$  and  $d_3$ , can be found in [\[7](#page-13-1), [8](#page-13-2), [9](#page-13-3), [13](#page-13-7)] and [14].

#### <span id="page-2-0"></span>SCATTERING MATRIX AND POTENTIAL IV.

where the coefficients  $A, B, \ldots \; \text{and} \; \alpha_i, \beta_i$  depend on the particle masses  $m_i$  and charges  $e_i/e$ . The terms with  $A, B, \ldots$  in this equation are analytical in  $q^2$  and correspond to local interactions. They are relevant for large momentum transfer and are also related to the UV renormalization of the theory, but will not be of further interest in this work. Rather, we concentrate on the nonanalytical terms, parametrized by the coefficients  $\alpha_i$  and  $\beta_i$ , which will induce the nonlocal, long-ranged interactions described by the nonrelativistic potential. The nonanalyti
al parts in the s

The nonrelativistic potential will be calculated from the s

### <span id="page-2-1"></span>V. RESULTS FOR THE FEYNMAN DIAGRAMS

In the following section we discuss the calculation of the various Feynman diagrams and their ontribution to the scattering amplitude. At the end of this section, we summarize the one-loop result for the nonrelativistic potential whi
h represents the main result of this paper. Part of the al
ulation for the Feynman diagrams has been done with the help of Mathematica  $5.2^{\text{TM}}[31]$  $5.2^{\text{TM}}[31]$  $5.2^{\text{TM}}[31]$  using the  $Ricci-application(©[32] for tensor calculus. The Fourier$ transformations, necessary to obtain the potential in coordinate spa
e, are listed in Appendix [C.](#page-11-0)

#### $\mathbf{A}$ **Tree Diagrams**

The tree diagrams ontributing to the s
attering ampli-tude are shown in Fig. [1.](#page-2-2) The  $(incoming/outgoing)$  momenta for the first particle are denoted as  $(k/k')$  with the  $(mass/charge)$  being  $(m_1/e_1)$ , and for the second particle as  $(p/p')$  and  $(m_2/e_2)$ , respectively. They have the form

### B. Vertex Corrections

There are two classes of vertex corrections, involving gravitational effects only, as shown in Fig. [2.](#page-3-0) The contri-

### F. Vacuum Polarization Diagram

Treating general relativity as an effective field theory, we have to deal with the vacuum polarization diagrams Fig.  $10(a)-(d)$  $10(a)-(d)$  as well. The graviton self-energy is obtained from the subdiagrams in Fig.  $10(a-b)$  $10(a-b)$ . Furthermore we have to treat the scalar and photon contribution to the graviton self-energy in Figs.  $10(c)$  $10(c)$  and [10\(](#page-6-0)d), respe

al terms and is therefore irrelevant for the calculation of the nonrelativistic potential. If we have  $N$  additional massless (uncharged) scalars in the theory, they would ontribute to the graviton polarization tensor as

We note that the one-loop diagrams in Fig. [12](#page-7-1) only contribute analyti
al terms to the s
attering amplitude and thus do not ontribute to the nonrelativisti potential, see also  $\vert 7, 14 \vert$ .

#### G. Final result for the nonrelativisti potential

In this paragraph we are going to summarize the main result of our paper: the nonrelativistic potential which is obtained from ombining the ontributions of the various diagrams discussed above. Let us first concentrate on the purely gravitational effects, for which we obtain

$$
V_{\text{GR}}(r) = -\frac{G m_1 m_2}{r} \left[ 1 + 3 \frac{G (m_1 + m_2)}{c^2 r} + \frac{131 + 6N}{30 \pi} \frac{G \hbar}{c^3 r^2} \right].
$$
 (66)

Here, we have restored the dependence on  $c$  and  $\hbar$  to distinguish the effects from general relativity and quantum corrections. We recall that N denotes the number of massless (uncharged) scalars, e.g., "scalar neutrinos." When comparing our result  $(66)$  with [\[13](#page-13-7)], we have to take into account that in  $[13]$  $[13]$  the quantum corrections to the graviton propagator from massless s
alar and photon

loops have not been considered. Apart from this, we fully agree with  $[13]$  $[13]$ . The discrepancies between  $[13, 27]$  and the original calculations in  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  $[7, 8, 9]$  and the results of  $[12]$  $[12]$ have already been discussed, and we thus confirm the conclusions of [\[13](#page-13-7)]. Concerning the contributions from massless s
alars to the polarization tensor in [\(57\)](#page-6-1), we disagree with a previous calculation in  $[10]$  $[10]$ . The photon contribution in  $(60)$  coincides with the result in [28].

Including electromagnetic effects in scalar QED, we find

$$
V_{\text{SQED}}(r) = V_{\text{GR}}(r) + \frac{\tilde{\alpha} \mathbf{e}_1 \mathbf{e}_2}{r} \left( 1 + 3 \frac{G (m_1 + m_2)}{c^2 r} + \frac{6}{\pi} \frac{G \hbar}{c^3 r^2} \right) + \frac{1}{2} \frac{(m_1 \mathbf{e}_2^2 + m_2 \mathbf{e}_1^2) G \tilde{\alpha}}{c^2 r^2} - \frac{4}{3\pi} \left( \frac{m_2^2 \mathbf{e}_1^2 + m_1^2 \mathbf{e}_2^2}{m_1 m_2} \right) \frac{G \tilde{\alpha} \hbar}{c^3 r^3} .
$$
 (67)

Here we have introduced  $\tilde{\alpha} = \hbar c/137$  and the charges  $\mathfrak{e}_1$ and  $\mathfrak{e}_2$  are normalized in units of the elementary charge. Again, our result for the potential [\(67\)](#page-7-3) is in agreement with  $[14, 29]$  $[14, 29]$ . [A calculational error in the expression for the box diagrams [\(47\)](#page-5-3) quoted in a previous preprint version of this paper [\[30](#page-13-26)] has been corrected.

#### <span id="page-7-3"></span>VI. SUMMARY

We have calculated the one-loop corrections to the Newtonian and Coulomb potential for massive and electrically harged s
alar parti
les, treating general relativity as an effective quantum field theory. The nonrelativistic potential is obtained from the s
attering amplitude by onsidering the nonanalytic terms in the momentum transfer q 2 . After Fourier transformation, we identify relativistic corrections of order  $Gm/c^2r$  and genuine quantum corrections of order  $G\hbar/c^3r^2$ . Our results for the leading quantum orre
tions to the Newtonian and Coulomb laws are in agreement with  $[13]$  $[13]$  and  $[14, 29]$  $[14, 29]$ . Concerning the quantum orre
tions to the graviton propagator, we reproduced the contribution from the photon loop in [28], but differ for the case of massless scalar loops in [10]. It is straight forward to generalize the effective-theory

e, the ase of massive harged spin- $\frac{1}{2}$  fermions which has been discussed in [\[15](#page-13-9), 16]. In this way one could unambiguously predict the quantum-gravitational orre
tions to low-energy observables within the Standard Model. However, one has to be aware that the size of the calculated corrections is  $-$  of course – extremely small,  $G\hbar/c^3r^2 = 2.6 \cdot 10^{-40} \text{ fm}^2/r^2$ , and it will thus be practically impossible to verify the theoreti
al results by experimental measurements in the foreseeable future  $[9]$ .
