$1+1+2$ gravitational perturbations on LRS class II space-times: GEM scalar harmonic amplitudes

Abstract. This is the third in a series of papers which considers first-order gaugeinvariant and covariant gravitational perturbations to *locally rotationally symmetric* (LRS) class II space-times. In this paper we complete our analysis of the firstorder *gravito-electromagnetic* (GEM) system by showing how to derive three decoupled equations governing the GEM scalar fields. One of these is for the gravito-magnetic scalar, whereas another two arise from the 2-gradient of the gravito-electric scalar.

1. Introduction

Paper I in this series [\[1\]](#page-4-0) uses similar methods that we used to decouple electromagnetic (EM) perturbations [\[2,](#page-4-1) [3\]](#page-4-2) to show how to decouple the gravito-electromagnetic (GEM) 2-tensor harmonic amplitudes. This was followed by Paper II which showed that further decoupling is achieved when the complex GEM 2-vector is combined with the shear 2 tensors describing the 2/3-sheets [\[4\]](#page-4-3). Summarily, from Paper's I and II we have found eight specific combinations that decouple which are

This paper concentrates on decoupling the quantities governing the $1+1+2$ GEM scalars. In Section [2,](#page-1-0) we provide a brief review of the complex GEM system we expressed in Paper II and its dependent variables. Following this in Section [\(3\)](#page-2-0) we show how decouple a combination of the 2-gradient of the gravito-electric scalar with other $1+1+2$ quantities and the gravito-magnetic scalar.

2. Complex 1+1+2 GEM system

The $1+1+2$ complex GEM system was first expressed in Paper I and subsequently new dependent variables were chosen in Paper II and the new GEM system becomes

where the new variables were defined

3. Decoupling Ξ_{μ} and its harmonic amplitudes

In order to decouple Ξ_{μ} , we construct higher-order derivatives by first taking the Lie derivative of [\(3\)](#page-1-1) with respect to u^{μ} and after much manipulation, we find

where the potential and energy-momentum source are

This clearly demonstrates the decoupling of Ξ_{μ} from the remaining first-order quantities. Furthermore, the differential operator in [\(10\)](#page-2-1) is real and thus it is possible to consider the real and imaginary parts separately.

3.1. Harmonic expansion

The dependent variable Ξ_{μ} and the energy-momentum source \mathcal{M}_{μ} are expanded into 2-vector harmonics according to

Therefore, [\(10\)](#page-2-1) naturally decouples into

and the new potential has been defined

Now since the differential operators in [\(14\)](#page-2-2)-[\(15\)](#page-2-2) are purely real, the real and imaginary parts may be considered separately. It is of interest to see how the harmonic amplitudes of Ξ_{μ} are related back to the harmonic amplitudes of the GEM scalars and other 1+1+2 quantities. By using the definition [\(7\)](#page-1-2) it can be shown that

The factors p and r arise from a harmonic expansion of the 2-Laplacian in terms of harmonics and they can be differentiated and factorized if desired. For example, the decouple equation governing \mathcal{H}_s becomes

p\left[\left(\mathcal{L}_u - 2\Sigma + \frac{7}{3}\theta\right)\mathcal{L}_u - \left(\mathcal{L}_n + \mathcal{A} + 3\phi\right)\mathcal{L}_n - V_{\mathcal{H}}\right]\mathcal{H}_\text{S} = \Im[\mathcal{M}_V] \tag{22}
$$

where

V_{\mathcal{H}} := -\frac{k^2}{r^2} + \frac{3}{2}\phi^2 - 6\mathcal{E} - \frac{3}{2}\left(\Sigma - \frac{2}{3}\theta\right)\left(\Sigma + \frac{1}{3}\theta\right).
$$

Thus the three quantities which each decouple are

Decoupled polar perturbations:

\left\{X_V - \frac{3}{2}\mathcal{E}r\left[\phi\zeta_T + \left(\Sigma - \frac{2}{3}\theta\right)\Sigma_T + \Pi_T\right]\right\},\tag{24}
$$

Decoupled axial perturbations:

3.2. Reduction to the covariant Schwarzschild space-times

We now consider the covariant Schwarzschild space-time such that these results may be related to previous work. The only non-vanishing LRS class II scalars for this case are $(\mathcal{A}, \phi, \mathcal{E})$ for which we now have

\Im[\Xi_{\mu}] := (\delta^2 + K)\delta_{\mu}\mathcal{H}_S. \tag{27}

Clarkson and Barret [\[5\]](#page-4-4) showed how to derive a Regge-Wheeler (RW) [\[6\]](#page-4-5) 2-tensor $\mathcal{W}_{\mu\nu}$ in this case and one can show that this tensor is related to [\(26\)](#page-3-0) according to

-\frac{6\mathcal{E}}{r^2}\delta^{\alpha}\mathcal{W}_{\mu\alpha} = \Re[\Xi_{\mu}].

The imaginary part is related to work from the Newman-Penrose formalism in [\[7\]](#page-4-6). The decoupled equation we have derived for \mathcal{H}_S reduces to

p\left[\mathcal{L}_u\mathcal{L}_u - (\mathcal{L}_n + \mathcal{A} + 3\phi)\mathcal{L}_n + \frac{\ell(\ell+1)}{r^2} - \frac{3}{2}\phi^2 + 6\mathcal{E}\right]\mathcal{H}_\text{S} = 0.
$$

A scaling is introduced to facilitate comparison with the work of Price [\[7\]](#page-4-6), $\mathcal{H}_S := r^3 \mathcal{H}_S$,

$$
\frac{p}{r^3} \left(\mathcal{L}_u \mathcal{L}_u - (\mathcal{L}_n + \mathcal{A}) \mathcal{L}_n + \frac{\ell(\ell+1)}{r^2} + 3 \mathcal{E} \right) \mathcal{H}'_{\mathcal{S}} = 0 \tag{30}
$$

We now expand everything in terms of coordinates, transform to the "tortoise" coordinate, $r\star$, and omit the common factor to reveal,

$$
\left(\partial_t^2 - \partial_{r\star}^2 + V_{RW}\right) \mathcal{H}'_S = 0,\tag{31}
$$

where the standard RW potential is

$$
V_{RW} := \left(1 - \frac{2M}{r}\right) \left(\frac{\ell(\ell+1)}{r^2} - \frac{6M}{r^3}\right),\tag{32}
$$

and M is the mass. This corresponds to Price's result that $r^3 \Im[\Psi_0]$ is a RW quantity [\[7\]](#page-4-6) and Ψ_0 is a Newman-Penrose scalar.

4. Summary

We have provided a comprehensive analysis of the first-order $1+1+2$ complex GEM system spanning three papers. This paper delivered the final three decoupled quantities and for completeness, we write the total of 11 decoupled quantities that we have found,
