# **CENTRAL EXTENSIONS OF GERBES**

#### AMNON YEKUTIELI

ABSTRACT. We introduce the notion of central extension of gerbes on a topological space *X*. We show that there are obstruction classes to lifting objects and isomorphisms in a central extension. We also discuss pronilpotent gerbes. These results are used in the paper [\[Ye\]](#page-35-0) to study twisted deformation quantization on algebraic varieties.

### 0. INTRODUCTION

<span id="page-0-0"></span>A *gerbe* **G** on a topological space *X* is the geometric version of a connected nonempty groupoid. Thus **G** associates a groupoid  $\mathcal{G}(U)$  to any open set  $U \subset X$ , and to any inclusion  $V \subset U$  of open sets there is a restriction functor  $\mathcal{G}(U) \to \mathcal{G}(V)$ . These have to satisfy a lot of conditions (for the benefit of the reader we have included a review in Section [2\)](#page-7-0). Gerbes arise in various contexts; but for us the are mainly important as "bookkeeping devices" for certain geometric data. At the end of the introduction we will outline the main application we have in mind.

A key question is to determine if a given gerbe **G** is *trivial*, namely if  $\text{Ob } \mathcal{G}(X) \neq$  $\emptyset$ . When **G** is *abelian*, with band some sheaf N of abelian groups, there is an obstruction class in the Čech cohomology group  $\check{H}^2(X, \mathcal{N})$  that vanishes if and only if **G** is trivial. However for a *nonabelian* gerbe **G** there is no useful obstruction theory, since the structure is too complicated. There is Giraud's nonabelian cohomology theory [\[Gi\]](#page-35-2), but that does not provide an effective answer.

We noticed during our work on deformation quantization that the gerbes occurring there are *pronilpotent* (see explanation below). Such gerbes are composed of central extensions, and for those extensions we can construct useful obstruction classes.

<span id="page-1-0"></span>A *central extension of gerbes* on *X* is a diagram

(0.1) 
$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1,
$$

in which **G** and **H** are gerbes,  $F : \mathcal{G} \to \mathcal{H}$  is a weak epimorphism of gerbes, and  $\mathcal{N} = \text{Ker}(F)$  is a sheaf of abelian groups in the center of **G**. This notion is technically quite complicated (see Definition [3.21\)](#page-18-1), but in principle it is just a generalization of the notion of central extension of sheaves of groups

$$
(0.2) \t 1 \to \mathcal{N} \to \mathcal{G} \to \mathcal{H} \to 1.
$$

Consider a central extension of gerbes  $(0.1)$ . Suppose  $i, j$  are two objects of  $\mathcal{G}(X)$ , and  $h: F(i) \to F(j)$  is an isomorphism if  $\mathcal{H}(X)$ . Then there is obstruction class

$$
\mathrm{cl}_F^1(h) \in \check{\mathrm{H}}^1(X, \mathcal{N}).
$$

The first main result of the paper, Theorem [4.6,](#page-20-0) says that  $\mathrm{cl}_F^1(h)$  vanishes if and only if *h* can be lifted to an isomorphism  $q : i \rightarrow j$  in  $\mathcal{G}(X)$ .

Given an object *j* of  $\mathcal{H}(X)$ , we define (under some hypothesis) an obstruction class

$$
\mathrm{cl}_F^2(j) \in \check{\mathrm{H}}^2(X, \mathcal{N}).
$$

The second main result of the paper, Theorem [4.17,](#page-23-0) says that *j* lifts to an object of  $\mathcal{G}(X)$  if and only if  $\mathrm{cl}_F^2(j) = 1$ .

There are three typical situations where central extensions of gerbes occur. The first is when we are given a central extension of sheaves of groups [\(0.2\)](#page-1-1). This is discussed briefly in Example [3.24.](#page-18-2)

Another situation is when we take any gerbe  $\mathcal{G}$ , and look at  $\mathcal{N} := Z(\mathcal{G})$ , the center of  $\mathcal{G}$ , which is a sheaf of abelian groups. We get a central extension

$$
1 \to \mathrm{Z}(\mathcal{G}) \to \mathcal{G} \xrightarrow{F} \mathcal{G}/\mathrm{Z}(\mathcal{G}) \to 1.
$$

Global objects of  $\mathcal{G}/\mathbb{Z}(\mathcal{G})$  are called *fake global objects of*  $\mathcal{G}$ . See Section [7.](#page-32-0)

The third situation, which is the most important for us, is when the gerbe  $\mathcal{G}$  is pronilpotent, i.e. it is complete with respect to a central filtration  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  (see Definition [6.5\)](#page-29-0). Then for any *p* there is a central extension of gerbes

$$
1\rightarrow {\mathcal N}_p/{\mathcal N}_{p+1}\rightarrow {\mathcal G}/{\mathcal N}_{p+1}\rightarrow {\mathcal G}/{\mathcal N}_p\rightarrow 1.
$$

The obstruction classes can detect whether the groupoid  $(\mathcal{G}/\mathcal{N}_p)(X)$  is nonempty or connected for any  $p$ ; but passing to the limit is more delicate. This is done in the third main result of the paper, namely Theorem [6.10.](#page-30-0)

Presumably our results can be extended, with minor changes, to sites other than a topological space (e.g. the étale site of a scheme). But we did not explore this direction.

Here is an outline of the role gerbes have in our paper [\[Ye\]](#page-35-0). Suppose *X* is a smooth algebraic variety over a field  $\mathbb K$  of characteristic 0. We are interested in *twisted deformations* of  $\mathcal{O}_X$ . A twisted (associative or Poisson) deformation  $\mathcal A$ is a collection of locally defined (associative or Poisson) deformations  $A_i$  of  $\mathcal{O}_X$ , together with a collection of locally defined gauge equivalences  $\mathcal{A}_i \xrightarrow{\simeq} \mathcal{A}_j$  between them. The bookkeeping data of deformations and gauge equivalences are encoded

in the *gauge gerbe*  $\mathcal{G}$  of  $\mathcal{A}$ . Here is just a hint of how this goes – see Remark [7.4](#page-32-1) for a few more details, or the paper [\[Ye\]](#page-35-0) for the full story. Let  $U \subset X$  be an open set. Then to any object *i* in the groupoid  $\mathcal{G}(U)$  we attach a deformation  $A_i$  of  $\mathcal{O}_U$ ; and to any morphism  $g : i \to j$  in  $\mathcal{G}(U)$  we attach a gauge equivalence  $\mathcal{A}(g) : \mathcal{A}_i \xrightarrow{\simeq} \mathcal{A}_j$ . Thus the groupoid  $\mathcal{G}(X)$  carries the information of global deformations: objects of  $\mathcal{G}(X)$  correspond to global deformations of  $\mathcal{O}_X$  belonging to  $\mathcal{A}$ , and isomorphic objects correspond to gauge equivalent deformations. Since the gauge gerbe **G** is pronilpotent, we can often use Theorems [4.6,](#page-20-0) [4.17](#page-23-0) and [6.10](#page-30-0) to figure out how many connected components the groupoid  $\mathcal{G}(X)$  has.

### 1. Recalling some Facts on 2-Categories

<span id="page-2-0"></span>There are several sources in the literature on 2-categories and prestacks, e.g. [\[Be\]](#page-35-3), [\[Gi\]](#page-35-2), [\[Ma\]](#page-35-4), [\[Mo\]](#page-35-5), [\[Le\]](#page-35-6), [\[KS\]](#page-35-7) and [\[Br\]](#page-35-8). Unfortunately there is disagreement on terminology among the sources, and hence we feel it is better to start with an exposition of the conventions we adopted, and a recollection some facts.

First we must establish some set-theoretical background, in order to avoid paradoxical phenomena. Recall that in set theory all mathematical objects and operations are interpreted as sets, with suitable additional properties. Following [\[Ma\]](#page-35-4) we fix a *Grothendieck universe* U, which is a set closed under standard set-theoretical operations, and large enough such that the objects of interest for us (e.g. the topological space *X* in Section [2\)](#page-7-0) are elements of U. We refer to elements of U as *small sets.* A category C such that  $Ob(C) \in U$ , and  $Hom_{C}(C_0, C_1) \in U$  for every pair  $C_0, C_1 \in Ob(\mathsf{C})$ , is called a *small category*.

By Set we refer the category of small sets; thus in effect  $Ob(Set) = U$ . Likewise Grp, Mod *A* etc. refer to the categories of small groups, small *A*-modules (over a small ring *A*) etc. A category C such that  $Ob(C) \subset U$ , and  $Hom_{\mathsf{C}}(C_0, C_1) \in U$  for every pair  $C_0, C_1 \in Ob(\mathbb{C})$ , is called a U-category. Thus Set is a U-category, but it is not small.

Next we introduce a bigger universe  $V$ , such that  $U \in V$ . Then Ob(Set),  $Ob(Grp), \ldots \in V$ . In order to distinguish between them, we call U the small universe, and V is the large universe. The set of all U-categories is denoted by **Cat**. Note that **Cat** is a V-category, but (this is the whole point!) it is not a U-category.

By default sets, groups etc. will be assumed to be small; and categories will be assumed to be U-categories.

A 2*-category* **C** is a "category enriched in categories". (Some authors use the term "strict 2-category".) This means the following. There is a set  $Ob(\mathbf{C})$ , whose elements are called *objects* of **C**. For any pair of objects  $C_0$ ,  $C_1 \in Ob(C)$  there is a category  $\mathbf{C}(\mathsf{C}_0, \mathsf{C}_1)$ . The objects of the category  $\mathbf{C}(\mathsf{C}_0, \mathsf{C}_1)$  are called 1*-morphisms*, and the morphisms of  $\mathbf{C}(C_0, C_1)$  are called 2*-morphisms*. For every triple  $C_0, C_1, C_2 \in$ Ob(**C**) there is a bifunctor

$$
\mathbf{C}(C_0,C_1)\times \mathbf{C}(C_1,C_2)\to \mathbf{C}(C_0,C_2),
$$

called *horizontal composition*. Horizontal composition has to be associative (as bifunctor). For any  $C \in Ob(\mathbb{C})$  there is a distinguished 1-morphism  $1_C \in Ob(\mathbb{C}(C, C)),$ called the identity 1-morphism of C. Horizontal composition with  $\mathbf{1}_{\mathsf{C}}$ , on either side, is required to be the identity functor.

Given a 1-morphism  $F \in Ob(\mathbf{C}(\mathsf{C}_0, \mathsf{C}_1)),$  we write  $F : \mathsf{C}_0 \to \mathsf{C}_1$ . The notation for horizontal composition is  $\circ$ ; so given 1-morphisms  $F_1$  :  $C_0 \to C_1$  and  $F_2$  :  $C_1 \to C_2$ , their composition is  $F_2 \circ F_1 : \mathsf{C}_0 \to \mathsf{C}_2$ . We sometimes denote the set  $Ob(\mathsf{C}(\mathsf{C}_0, \mathsf{C}_1))$ of 1-morphisms  $C_0 \rightarrow C_1$  by  $\text{Hom}_\mathbf{C}(C_0, C_1)$ .

Let  $F, G \in Ob(\mathbf{C}(\mathsf{C}_0, \mathsf{C}_1)),$  and let  $\eta \in Hom_{\mathbf{C}(\mathsf{C}_0, \mathsf{C}_1)}(F, G)$ ; i.e.  $\eta$  is a 2-morphism. We write  $\eta: F \Rightarrow G$ . This data is usually depicted as a diagram:



The composition rule in the category  $C(C_0, C_1)$  is called *vertical composition*, and we denote it by  $*$ . Thus if  $H \in Ob(\mathbf{C}(\mathsf{C}_0, \mathsf{C}_1))$  is another 1-morphism, and  $\zeta : G \Rightarrow H$ is a 2-morphism, then by vertical composition we get  $\zeta * \eta : F \Rightarrow H$ .



Let us denote by  $\mathbf{1}_F$  the identity automorphism of the object  $F$  in the category **C**(C<sub>0</sub>, C<sub>1</sub>). Then  $\mathbf{1}_F * \eta = \eta = \eta * \mathbf{1}_G$ .

The pictorial description of horizontal composition is this: given a diagram



the horizontal composition of the 2-morphisms  $\eta_1$  and  $\eta_2$  is



The horizontal and vertical compositions are required to satisfy the following condition, called the *exchange condition*. Suppose we are given a diagram



in **C**. Then

$$
(\zeta_2 \circ \zeta_1) * (\eta_2 \circ \eta_1) = (\zeta_2 * \eta_2) \circ (\zeta_1 * \eta_1)
$$

as 2-morphisms  $F_2 \circ F_1 \Rightarrow H_2 \circ H_1$ .

Regarding set-theoretical issues, we require that  $Ob(\mathbf{C}) \subset V$ ,  $Ob(\mathbf{C}(C_0, C_1)) \in V$ , and  $\text{Hom}_{\mathbf{C}(\mathsf{C}_0,\mathsf{C}_1)}(F,G) \in \mathsf{U}$ . Note that if we forget the 2-morphisms in **C**, then **C** becomes a V-category.

The basic example of a 2-category is this:

<span id="page-4-0"></span>**Example 1.1.** The 2-category of U-categories, denoted by **Cat**. The set Ob(**Cat**) of all U-categories was already mentioned. The 1-morphisms in  $Cat(C_0, C_1)$  are the functors  $F : \mathsf{C}_0 \to \mathsf{C}_1$  between these categories. And the 2-morphisms  $\eta : F \Rightarrow G$ are the natural transformations. The composition rules are the usual ones.

Here is another example, of a different flavor.

**Example 1.2.** Let K be a commutative ring. The category DGMod K of DG (differential graded) K-modules can be made into a 2-category, as follows. Given  $M, N \in Ob(\mathsf{DGMod}\,\mathbb{K})$ , the 1-morphisms  $F: M \to N$  are the usual morphisms in DGMod K, i.e. K-linear DG module homomorphisms. Now such a homomorphism  $F: M \to N$  can be viewed as a 0-cocycle in the DG module  $\text{Hom}_{\mathbb{K}}(M, N)$ . Given another such homomorphism  $G : M \to N$ , the 2-morphisms  $\eta : F \Rightarrow G$  are by definition the 0-coboundaries  $\eta \in \text{Hom}_{\mathbb{K}}(M, N)$  such that  $G = \eta + F$ . Compositions are obvious.

Suppose  $F, G \in \text{Hom}_{\mathbb{C}}(\mathsf{C}_0, \mathsf{C}_1)$ . We say that *F* and *G* are 2*-isomorphic* if there is some 2-isomorphism  $\eta : F \stackrel{\simeq}{\Longrightarrow} G$  in the category  $\text{Hom}_{\mathbf{C}}(\mathsf{C}_0, \mathsf{C}_1)$ ; we denote this by  $F \stackrel{\simeq}{\Longleftrightarrow} G$ . A diagram (of 1-morphisms)



is *commutative up to 2-isomorphism* if  $E \circ D \stackrel{\simeq}{\Longleftrightarrow} F$ .

There is an intrinsic notion of *equivalence* in a 2-category **C**. A 1-morphism  $F: \mathsf{C} \to \mathsf{D}$  is an called an equivalence if there is a 1-morphism  $G: \mathsf{D} \to \mathsf{C}$  such that  $G \circ F \iff \mathbf{1}_{\mathsf{C}}$  and  $F \circ G \iff \mathbf{1}_{\mathsf{D}}$ . This generalizes the usual notion of equivalence (of categories) in Example [1.1.](#page-4-0)

Suppose **C** and **D** are 2-categories. A 2-functor  $\mathbf{F}: \mathbf{C} \to \mathbf{D}$  is a triple  $\mathbf{F} =$  $(F_0, F_1, F_2)$ , consisting of functions of the following kinds. The function  $F_0$ , called the 0-component of **F**, assigns to each object  $C \in Ob \mathbb{C}$ , an object  $F_0(C) \in Ob \mathbb{D}$ . The function  $F_1$  assigns to each morphism  $G: \mathsf{C}_0 \to \mathsf{C}_1$  in **C**, a 1-morphism

$$
F_1(G): F_0(\mathsf{C}_0) \to F_0(\mathsf{C}_1)
$$

in **D**. And the function  $F_2$  assigns to each 2-morphism  $\eta : G \Rightarrow G'$  in **C**, a 2morphism

$$
F_2(\eta): F_1(G) \Rightarrow F_1(G')
$$

in **D**. The condition is that the functions  $(F_0, F_1, F_2)$  preserve compositions and units. Thus, if we forget 2-morphisms, the pair  $(F_0, F_1)$  is a functor

$$
(F_0,F_1): \mathbf{C} \to \mathbf{D}
$$

between these categories. And for every  $C_0, C_1 \in Ob \mathbb{C}$ , the pair  $(F_1, F_2)$  is a functor

$$
(F_1, F_2): \mathrm{Hom}_{\mathsf{C}}(\mathsf{C}_0, \mathsf{C}_1) \to \mathrm{Hom}_{\mathsf{D}}(F_0(\mathsf{C}_0), F_0(\mathsf{C}_1)).
$$

Let **C** and **D** be 2-categories, and let  $F, G : C \rightarrow D$  be 2-functors, with components

$$
\boldsymbol{F} = (F_0, F_1, F_2), \, \boldsymbol{G} = (G_0, G_1, G_2).
$$

A 1-morphism (sometimes called a 2-natural transformation)  $p : F \to G$  is a function that assigns to each  $C \in Ob \mathbb{C}$  a 1-morphism

$$
\boldsymbol{p}_\mathsf{C}:F_0(\mathsf{C})\to G_0(\mathsf{C})
$$

in **D**, such that for every  $E \in \text{Hom}_{\mathbf{C}}(\mathsf{C}_0, \mathsf{C}_1)$  one has

$$
\mathbf{p}_{\mathsf{C}_1} \circ F_1(E) = G_1(E) \circ \mathbf{p}_{\mathsf{C}_0}
$$

in  $\text{Hom}_{\mathbf{D}}(F_0(\mathsf{C}_0), G_0(\mathsf{C}_1))$ . Given another 2-functor  $\mathbf{H} : \mathbf{C} \to \mathbf{D}$ , and a 1-morphism  $q: G \to H$ , the composition  $q \circ p: F \to H$  is defined in the obvious way.

Now suppose  $p, q: F \to G$  are 1-morphisms between 2-functors  $F, G: C \to D$ as above. A 2-morphism  $\eta: p \to q$  (sometimes called a modification) is a function that assigns to each  $C \in Ob \mathbb{C}$ , a 2-morphism  $\eta_C : p_C \Rightarrow q_C$  in  $\text{Hom}_{\mathbf{D}}(F_0(\mathbb{C}), G_0(\mathbb{C}))$ . The condition is that

$$
\eta_{\mathsf{C}_1}\circ p_{\mathsf{C}_1}\circ F=\eta_{\mathsf{C}_0}\circ q_{\mathsf{C}_0}\circ G,
$$

as functions

$$
\operatorname{Hom}_{\mathsf{C}}(\mathsf{C}_0,\mathsf{C}_1)\to\operatorname{Hom}_{\mathsf{D}}\big(F_0(\mathsf{C}_0),G_0(\mathsf{C}_1)\big)
$$

*.*

If  $r : F \to G$  is yet another 1-morphism, and  $\zeta : q \to r$  is a 2-morphism, then the composition  $\zeta * \eta : p \to r$  is defined in the obvious way. We say that the 2-morphism  $\eta: p \to q$  is a 2-isomorphism if each  $\eta_{\mathsf{C}}$  is a 2-isomorphism.

A 2-functor  $\mathbf{F} : \mathbf{C} \to \mathbf{D}$  is called a 2-*equivalence* if there is a 2-functor  $\mathbf{G} : \mathbf{D} \to \mathbf{C}$ , and 2-isomorphisms  $G \circ F \stackrel{\simeq}{\Longrightarrow} 1_C$  and  $F \circ G \stackrel{\simeq}{\Longrightarrow} 1_D$ . If a 2-equivalence  $C \to D$ exists, then we say that **C** and **D** are 2-equivalent.

One could make the set of all 2-categories, with the operations defined above, into a 2-category, but that would take us outside of the large universe V. Therefore we shall be careful to consider only "small collections" of 2-categories in this paper.

We shall also need to recall what are *pseudofunctors* (sometimes called normalized pseudofunctors, or morphisms of bicategories) from a category N to a 2 category **C**. A pseudofunctor  $\mathbf{F}: \mathbb{N} \to \mathbb{C}$  is a triple  $\mathbf{F} = (F_0, F_1, F_2)$ , consisting of functions of the following kinds. The function  $F_0$ , called the 0-component of  $\bm{F}$ , assigns to each object  $N \in \text{Ob } \mathsf{N}$  an object  $F_0(N) \in \text{Ob } \mathsf{C}$ . The function  $F_1$  assigns to each morphism  $f: N_0 \to N_1$  in N a 1-morphism

$$
F_1(f): F_0(N_0) \to F_0(N_1)
$$

in  $C$ . And the function  $F_2$  assigns to each composable pair of morphisms

$$
N_0 \xrightarrow{f_1} N_1 \xrightarrow{f_2} N_2
$$

in N, a 2-isomorphism

$$
F_2(f_1, f_2) : F_1(f_2) \circ F_1(f_1) \stackrel{\simeq}{\Longrightarrow} F_1(f_2 \circ f_1)
$$

in **C**. Here are the conditions. First,

$$
(1.3) \qquad F_2(f_2 \circ f_1, f_3) * F_2(f_1, f_2) = F_2(f_1, f_3 \circ f_2) * F_2(f_2, f_3)
$$

for any composable triple

$$
N_0 \xrightarrow{f_1} N_1 \xrightarrow{f_2} N_2 \xrightarrow{f_3} N_3
$$

of morphisms in N. Next, for any object  $N \in \mathbb{N}$ , with identity morphism  $\mathbf{1}_N$ , it is required that  $F_1(\mathbf{1}_N) = \mathbf{1}_{F_0(N)}$ , the identity 1-morphism of  $F_0(N)$ . And lastly, the 2-isomorphisms

$$
F_2(\mathbf{1}_{N_0}, f_1): F_1(f_1) \circ \mathbf{1}_{F_0(N_0)} \stackrel{\simeq}{\Longrightarrow} F_1(f_1)
$$

and

$$
F_2(f_1, \mathbf{1}_{N_1}): \mathbf{1}_{F_0(N_1)} \circ F_1(f_1) \stackrel{\simeq}{\Longrightarrow} F_1(f_1)
$$

have to be the identity 2-automorphism of the 1-morphism  $F_1(f_1)$ .

The final abstract 2-categorical fact that we need is that given a small category N and a 2-category **C**, the set of all pseudofunctors  $F : N \to \mathbb{C}$  is itself a 2category. The 1-morphisms are defined as follows. Suppose  $F, G : N \to \mathbb{C}$  are pseudofunctors, with components  $\mathbf{F} = (F_0, F_1, F_2)$  and  $\mathbf{G} = (G_0, G_1, G_2)$ . A 1morphism  $p: \mathbf{F} \to \mathbf{G}$  is a pair  $p = (p_1, p_2)$ , whose 1-component  $p_1$  is a function assigning to any object  $N \in \text{Ob } N$  a 1-morphism

$$
p_1(N): F_0(N) \to G_0(N)
$$

in **C**; and the 2-component  $p_2$  is a function assigning to any morphism  $f: N_0 \to N_1$ in N a 2-isomorphism

$$
p_2(f): p_1(N_1) \circ F_1(f) \stackrel{\simeq}{\Longrightarrow} G_1(f) \circ p_1(N_0)
$$

in **C**. These are required to satisfy the condition

(1.4) 
$$
p_2(f_2 * f_1) * F_2(f_1, f_2) = G_2(f_1, f_2) * p_2(f_1) * p_2(f_2)
$$

in  $\text{Hom}_{\mathbf{C}}(F_0(N_0), G_0(N_1)),$  for any composable pair of morphisms  $N_0 \xrightarrow{f_1} N_1 \xrightarrow{f_2} N_2$ *N*<sup>2</sup> in N.

Horizontal composition of 1-morphisms is defined as follows. Suppose  $H : N \to \mathbb{C}$ is another pseudofunctor, and  $q: G \to H$  is a 1-morphism. Their components are  $H = (H_0, H_1, H_2)$  and  $q = (q_1, q_2)$ . Let

$$
r_1(N): F_0(N) \to H_0(N)
$$

be the 1-morphism

$$
r_1(N) := q_1(N) \circ p_1(N),
$$

and let

$$
r_2(f) : r_1(N_1) \circ F_1(f) \Rightarrow H_1(f) \circ r_1(N_0)
$$

be the 2-morphism

$$
r_2(f) := q_2(f) * p_2(f).
$$

Then we define the 1-morphism

$$
q\circ p:F\to H
$$

to be

$$
\boldsymbol{q}\circ\boldsymbol{p}:=(r_1,r_2).
$$

Next consider 1-morphisms  $p, q : F \to G$ . A 2-morphism  $\eta : p \Rightarrow q$  has only a 2-component  $\eta_2$ , which is a function that assigns to each object  $N \in \text{Ob } N$  a 2-morphism

$$
\eta_2(N): p_1(N) \Rightarrow q_1(N)
$$

in **C**. The condition is that

$$
q_2(f) * \eta_2(N_0) = \eta_2(N_1) * p_2(f)
$$

for any  $f: N_0 \to N_1$  in N. Given yet another 1-morphism  $r: F \to G$ , and a 2-morphism  $\zeta = (\zeta_2) : q \Rightarrow r$ , the vertical composition  $\theta := \zeta * \eta : p \Rightarrow r$  has 2-component

$$
\theta_2(N) := \zeta_2(N) * \eta_2(N).
$$

### 2. Prestacks on a Topological Space

<span id="page-7-0"></span>Let X be a topological space. We need some notation for open coverings. Let *U* ⊂ *X* be an open set, and let  $U = \{U_k\}_{k \in K}$  be an open covering of *U*, i.e.  $U = \bigcup_{k \in K} U_k$ . Given  $k_0, \ldots, k_m \in K$  we write

$$
U_{k_0,\ldots,k_m} := U_{i_0} \cap \cdots \cap U_{k_m}.
$$

Let S be a sheaf of sets on X. For an open set  $U \subset X$  we denote by  $\mathcal{S}(U) =$  $\Gamma(U, \mathcal{S})$  the set of sections of  $\mathcal S$  on  $U$ .

Recall that a *prestack*  $\mathcal{G}$  on  $X$  is the geometrization of the notion of category, in the same way that a presheaf of sets is the geometrization of the notion of a set. Formally speaking a prestack **G** is a pseudofunctor

$$
\mathcal{G} = (\mathcal{G}_0, \mathcal{G}_1, \mathcal{G}_2): (\mathsf{Open}\, X)^\mathrm{op} \to \mathsf{Cat},
$$

where Open *X* is the small category whose objects are the open sets  $U \subset X$ , and the morphisms  $V \to U$  are the inclusions  $V \subset U$ . However we shall make things more explicit here, and introduce some notation, to emphasize the geometry.

Thus a prestack  $\mathcal{G}$  on *X* has the following structure. For any open set  $U \subset X$ there is a category  $\mathcal{G}(U) := \mathcal{G}_0(U)$ . Elements of the set  $\mathrm{Ob}\,\mathcal{G}(U)$  shall be denoted by the letters  $i, j$  etc.; this is because we want to view them as indices. We write

(2.1) 
$$
\mathcal{G}(U)(i,j) := \mathrm{Hom}_{\mathcal{G}(U)}(i,j),
$$

the set of morphisms in the category  $\mathcal{G}(U)$  from *i* to *j*.

There are restriction functors (1-morphisms **Cat**)

$$
\text{rest}_{U_1/U_0}^{\boldsymbol{\mathcal{G}}}:=\boldsymbol{\mathcal{G}}_1(U_1\rightarrow U_0):\boldsymbol{\mathcal{G}}(U_0)\rightarrow\boldsymbol{\mathcal{G}}(U_1)
$$

for any inclusion  $U_1 \subset U_0$  of open sets. And there are composition isomorphisms (2-isomorphisms in **Cat**)

<span id="page-7-1"></span>
$$
\gamma_{U_2/U_1/U_0}^{\mathcal{G}}:=\mathcal{G}_2(U_2\to U_1\to U_0):\mathrm{rest}_{U_2/U_1}^{\mathcal{G}}\circ\mathrm{rest}_{U_1/U_0}^{\mathcal{G}}\stackrel{\cong}{\longrightarrow}\mathrm{rest}_{U_2/U_0}^{\mathcal{G}}
$$

for a double inclusion  $U_2 \subset U_1 \subset U_0$ . Condition [\(1.3\)](#page-5-0) now becomes

(2.2) 
$$
\gamma_{U_3/U_2/U_0}^{\mathcal{G}} * \gamma_{U_2/U_1/U_0}^{\mathcal{G}} = \gamma_{U_3/U_1/U_0}^{\mathcal{G}} * \gamma_{U_3/U_2/U_1}^{\mathcal{G}}
$$

for a triple inclusion  $U_3 \subset U_2 \subset U_1 \subset U_0$ . And there are corresponding conditions for  $U \stackrel{\equiv}{\rightarrow} U$ .

As explained in Section [1,](#page-2-0) the set of prestacks on *X* has a structure of 2-category, which we denote by **PreStack**  $X$ . Again, we want to be more specific. Suppose  $\mathcal{G}$ and **H** are two prestacks on *X*. A morphism of prestacks  $F : \mathcal{G} \to \mathcal{H}$  is a 1morphism between these pseudofunctors. Thus there is a functor

$$
F(U): \mathcal{G}(U) \to \mathcal{H}(U)
$$

for any open set *U*, together with an isomorphism of functors

$$
\psi_{U_1/U_0}^F : F(U_1) \circ \text{rest}_{U_1/U_0}^{\mathcal{G}} \xrightarrow{\simeq} \text{rest}_{U_1/U_0}^{\mathcal{H}} \circ F(U_0)
$$

for any inclusion  $U_1 \subset U_0$  of open sets. These isomorphisms are required to satisfy condition

$$
\psi_{U_2/U_0}^F * \gamma_{U_2/U_1/U_0}^{\mathcal{G}} = \gamma_{U_2/U_1/U_0}^{\mathcal{H}} * \psi_{U_2/U_1}^F * \psi_{U_1/U_0}^F
$$

for a double inclusion  $U_2 \subset U_1 \subset U_0$ .

The composition of morphisms of prestacks  $\mathcal{G} \xrightarrow{F} \mathcal{H} \xrightarrow{E} \mathcal{K}$  is denoted by  $E \circ F$ . Suppose  $D, E, F : \mathcal{G} \to \mathcal{H}$  are morphisms between prestacks. We will denote 2-morphisms between *E* and *F* by  $\eta : E \Rightarrow F$ . And the (vertical) composition with a 2-morphism  $\zeta : D \Rightarrow E$  is denoted by  $\eta * \zeta : D \Rightarrow F$ .

As in any 2-category, we can say when a morphism of prestacks  $F : \mathcal{G} \to \mathcal{H}$  (i.e. a 1-morphism in **PreStack**  $X$ ) is an equivalence. This just means that there is a morphism of prestacks  $E: \mathcal{H} \to \mathcal{G}$ , and 2-isomorphisms  $E \circ F \stackrel{\simeq}{\Longrightarrow} \mathbf{1}_{\mathcal{G}}$  and  $F \circ E \stackrel{\simeq}{\Longrightarrow}$  $1\mu$ . But here there is also a geometric characterization: *F* is an equivalence if and only if for any open set *U* ⊂ *X* the functor  $F(U): \mathcal{G}(U) \to \mathcal{H}(U)$  is an equivalence.

Let **G** be a prestack on X. By a *subprestack* of **G** we mean a prestack  $N$  such that  $\mathcal{N}(U)$  is a subcategory of  $\mathcal{G}(U)$  for every open set U, and such that the restriction functors rest<sup> $N$ </sup><sub>-</sub> $/$ <sub>−</sub> and the composition isomorphisms  $\gamma^N$ <sub>-</sub> $/$ <sub>-</sub> $/$ <sub>−</sub> are the same as those of **G**.

Suppose  $\mathcal{G}$  is a prestack on *X*. Take an open set  $U \subset X$  and two objects  $i, j \in \text{Ob } \mathcal{G}(U)$ . There is a presheaf of sets  $\mathcal{G}(i, j)$  on U, called the *presheaf of morphisms*, defined as follows. For an open set  $V \subset U$  we define the set

$$
\mathcal{G}(i,j)(V) := \mathrm{Hom}_{\mathcal{G}(V)} \big( \mathrm{rest}_{V/U}^{\mathcal{G}}(i), \mathrm{rest}_{V/U}^{\mathcal{G}}(j) \big).
$$

For an inclusion  $V_1 \subset V_0 \subset U$  of open sets, the restriction function

$$
\text{rest}^{\mathcal{G}}(i,j)_{V_1/V_0}: \mathcal{G}(i,j)(V_0) \to \mathcal{G}(i,j)(V_1)
$$

is the composed function

$$
\text{Hom}_{\mathcal{G}(V_0)}\left(\text{rest}_{V_0/U}^{\mathcal{G}}(i),\text{rest}_{V_0/U}^{\mathcal{G}}(j)\right)
$$
\n
$$
\xrightarrow{\text{rest}_{V_1/V_0}} \text{Hom}_{\mathcal{G}(V_0)}\left(\left(\text{rest}_{V_1/V_0}^{\mathcal{G}} \circ \text{rest}_{V_0/U}^{\mathcal{G}}\right)(i),\left(\text{rest}_{V_1/V_0}^{\mathcal{G}} \circ \text{rest}_{V_0/U}^{\mathcal{G}}\right)(j)\right)
$$
\n
$$
\xrightarrow{\gamma_{V_1/V_0/U}^{\mathcal{G}}} \text{Hom}_{\mathcal{G}(V_1)}\left(\text{rest}_{V_1/U}^{\mathcal{G}}(i),\text{rest}_{V_1/U}^{\mathcal{G}}(j)\right).
$$

Condition [\(2.2\)](#page-7-1) ensures that

$$
\text{rest}^{\boldsymbol{\mathcal{G}}}(i,j)_{V_2/V_1} \circ \text{rest}^{\boldsymbol{\mathcal{G}}}(i,j)_{V_1/V_0} = \text{rest}^{\boldsymbol{\mathcal{G}}}(i,j)_{V_2/V_0}
$$

for an inclusion  $V_2 \subset V_1 \subset V_0 \subset U$ . Note that the set of sections of this presheaf is

$$
\Gamma(V, \mathcal{G}(i,j)) = \mathcal{G}(V)(i,j).
$$

From now on we shall usually write  $i|_V$  instead of  $\text{rest}_{V/U}^{\mathcal{G}}(i)$ , for a local object  $i \in$ Ob $\mathcal{G}(U)$ ; and  $g|_{V_1}$  instead rest<sup> $\mathcal{G}(i, j)_{V_1/V_0}(g)$ , for a local morphism  $g \in \mathcal{G}(i, j)(V_0)$ .</sup> Furthermore, we usually omit reference to the restriction functors  $\text{rest} \frac{g}{f}$  altogether.

Another convention that we shall adopt from here on is that we denote the composition in the local categories  $\mathcal{G}(U)$  of a prestack  $\mathcal{G}$  by "∘", and not by "∗" as we did up to here.

Let  $F: \mathcal{G} \to \mathcal{H}$  be a morphism of prestacks. One says that F is a *weak equivalence* if it satisfies these conditions:

- (i) *F* is *locally essentially surjective on objects*. This mean that for any open set *U* ⊂ *X*, object  $j \in Ob$  **H**(*U*) and point  $x \in U$ , there is an open set *V* with  $x \in V \subset U$ , an object  $i \in \text{Ob } \mathcal{G}(V)$ , and an isomorphism  $h : F(i) \xrightarrow{\simeq} j$ in  $\mathcal{H}(V)$ .
- (ii) For any open set *U* and  $i, j \in Ob \mathcal{G}(U)$  the function

$$
F: \mathcal{G}(U)(i,j) \to \mathcal{H}(U)\bigl(F(i), F(j)\bigr)
$$

is bijective. In other words, the functor  $F : \mathcal{G}(U) \to \mathcal{H}(U)$  is fully faithful. A prestack  $\mathcal G$  is called a *stack* if it satisfies these two conditions:

- (a) *Descent for morphisms*. This means that the presheaves of morphisms  $\mathcal{G}(i, j)$  are all sheaves.
- (b) *Descent for objects*. This means that given an open set *U*, an open covering  $U = \bigcup_{k \in K} U_k$ , objects  $i_k \in \text{Ob } \mathcal{G}(U_k)$ , and isomorphisms

$$
g_{k_0,k_1} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0}|_{U_{k_0,k_1}}, i_{k_1}|_{U_{k_0,k_1}})
$$

that satisfy

$$
g_{k_1,k_2}|_{U_{k_0,k_1,k_2}} \circ g_{k_0,k_1}|_{U_{k_0,k_1,k_2}} = g_{k_0,k_2}|_{U_{k_0,k_1,k_2}},
$$

there exists an object  $i \in \mathcal{G}(U)$ , and isomorphisms  $g_k \in \mathcal{G}(U_k)(i|_{U_k}, i_k)$ , such that

$$
g_{k_0,k_1} \circ g_{k_0}|_{U_{k_0,k_1}} = g_{k_1}|_{U_{k_0,k_1}}.
$$

Observe that by condition (a), the object  $i \in \mathcal{G}(U)$  in condition (b) is unique up to a unique isomorphism. A prestack  $\mathcal G$  satisfying condition (a) is sometimes called a *separated prestack*.

We denote by **Stack** *X* the full sub 2-category of **PreStack** *X* gotten by taking all stacks, all 1-morphisms between them, and all 2-morphisms between these 1 morphisms.

It is not hard to see that a morphism of stacks  $F : \mathcal{G} \to \mathcal{H}$  is an equivalence if and only if it is a weak equivalence.

There is a *stackification* operation, which is analogous to sheafification: to any prestack **G** one assigns a stack **G**, with a morphism of prestacks  $F : \mathcal{G} \to \mathcal{G}$ . These have the following universal property: given any stack  $\mathcal{H}$  and morphism  $E: \mathcal{G} \to \mathcal{H}$ , there is a morphism  $\tilde{E}: \tilde{\mathcal{G}} \to \mathcal{H}$ , unique up to 2-isomorphism, such that  $E \stackrel{\simeq}{\Longleftrightarrow} E \circ F$ .

Recall that a *groupoid* is a category G in which all morphisms are isomorphisms. For an object *i* the set  $G(i, i)$  is then a group. If the set  $G(i, j) \neq \emptyset$ , then it is a  $G(j, j)$ - $G(i, i)$ -bitorsor. For  $g \in G(i, j)$  we denote by  $\text{Ad}(g)$  the group isomorphism  $G(i, i) \rightarrow G(j, j)$  given by  $\text{Ad}(g)(h) := g \circ h \circ g^{-1}$ .

By a *prestack of groupoids* on  $X$  we mean a prestack  $\mathcal G$  such that each of the categories  $\mathcal{G}(U)$  is a groupoid. We denote by **PreStGr** *X* the full sub 2-category of **PreStack** *X* gotten by taking all prestacks of groupoids, all 1-morphisms between them, and all 2-morphisms between these 1-morphisms. If **G** is a prestack of groupoids, then the associated stack  $\tilde{G}$  is a stack of groupoids.

We shall be interested in *gerbes*. A gerbe is a stack of groupoids **G** on *X* that has these two properties:

- (†)  $\mathcal{G}$  is *locally nonempty*. What this means is that any point  $x \in X$  has an open neighborhood *U* such that  $Ob \mathcal{G}(U) \neq \emptyset$ .
- (†)  $\mathcal{G}$  is *locally connected*. This says that for any  $i, j \in \mathrm{Ob}\,\mathcal{G}(U)$  and any  $x \in X$ , there is an open set *V* such that  $x \in V \subset U$  and  $\mathcal{G}(V)(i, j) \neq \emptyset$ .

A gerbe **G** is called *trivial* if  $Ob \mathcal{G}(X) \neq \emptyset$ .

Let  $G$  be a sheaf of groups on *X*. By a *left*  $G$ -torsor on *X* we mean a sheaf of sets S, with a left G-action, such that S is locally nonempty (i.e. each point  $x \in X$  has an open neighborhood *U* such that  $\mathcal{S}(U) \neq \emptyset$ , and for any  $s \in \mathcal{S}(U)$  the morphism of sheaves of sets  $\mathcal{G}|_U \to \mathcal{S}|_U$ ,  $q \mapsto q \cdot s$ , is an isomorphism. The torsor S is trivial if  $S(X) \neq \emptyset$ .

Suppose  $\mathcal{G}$  is a gerbe on *X*. Given an open set  $U \subset X$  and  $i \in \mathrm{Ob}\mathcal{G}(U)$ , there is a sheaf of groups  $\mathcal{G}(i, i)$  on *U*. If  $j \in \text{Ob}\mathcal{G}(U)$  is some other object, then the sheaf of sets  $\mathcal{G}(i, j)$  is a  $\mathcal{G}(j, j)$ - $\mathcal{G}(i, i)$ -bitorsor. Namely, forgetting the left action by  $\mathcal{G}(j, j)$ , the sheaf  $\mathcal{G}(i, j)$  is a right  $\mathcal{G}(i, i)$ -torsor; and vice versa.

We denote by **Gerbe**  $X$  the full sub-2-category of **PreStGr**  $X$  gotten by taking all gerbes, all 1-morphisms between gerbes, and all 2-morphisms between these 1-morphisms.

Here are two prototypical examples of gerbes.

<span id="page-10-0"></span>**Example 2.3.** Let I be the groupoid with one object, say 0, and with  $I(0,0) :=$  $\{1<sub>0</sub>\}$ , the trivial group. This groupoid is a terminal object in **Cat**, since any category C admits exactly one functor  $C \rightarrow I$ .

Now take a topological space X, and define a prestack  $\mathcal I$  on it by letting  $\mathcal I(U) := \mathsf I$ for any open set U. Then  $\mathcal I$  is a gerbe. The gerbe  $\mathcal I$  is a terminal object in **PreStack** *X*. Indeed, given any prestack  $\mathcal{G}$  on *X* there is a unique morphism of prestacks  $\mathcal{G} \to \mathcal{I}$ . We call  $\mathcal{I}$  the *terminal gerbe* (because the word "trivial" is over-used in this area).

<span id="page-10-1"></span>**Example 2.4.** Let G be a sheaf of groups on X. For an open set U let  $\text{Tors}(\mathcal{G}|_U)$ be the set of all left  $\mathcal{G}|_U$ -torsors. This is a groupoid. Given  $V \subset U$  there is a functor

$$
\mathsf{Tors}(\mathcal{G}|_U) \to \mathsf{Tors}(\mathcal{G}|_V),
$$

namely  $S \mapsto S|_V$ . Thus we obtain a prestack of groupoids **Tors** G with

$$
(\operatorname{Tors} \mathcal{G})(U) := \operatorname{Tors}(\mathcal{G}|_U).
$$

Since torsors are locally trivial it follows that **Tors** G is a gerbe, called the *gerbe of* G*-torsors*.

**Remark 2.5.** A prestack of groupoids **G** is sometimes called a *category fibered in groupoids* over Open *X*. More precisely, given  $\mathcal{G}$ , we can construct a category  $\mathcal{G}$ , together with a functor  $\Phi : G \to \mathsf{Open} X$  called the fiber functor. The set of objects of G is

Ob 
$$
G := \coprod_{U \in \text{Open } X} \text{Ob } \mathcal{G}(U).
$$

For objects  $i \in \text{Ob } \mathcal{G}(U)$  and  $j \in \text{Ob } \mathcal{G}(V)$  one defines

$$
\operatorname{Hom}_{\mathsf{G}}(i,j) := \operatorname{Hom}_{\mathsf{G}(U)}(i,j|_U)
$$

if  $U \subset V$ ; and  $\text{Hom}_{G}(i, j) := \emptyset$  otherwise. The fiber functor  $\Phi : G \to \text{Open } X$  is  $\Phi(i) := U$  for  $i \in \text{Ob } \mathcal{G}(U)$ , and  $\Phi(g) := (U \to V)$  for  $g \in \text{Hom}_{\mathcal{G}}(i, j)$  as above.

Conversely, the prestack **G** can be recovered from the data  $\Phi : \mathsf{G} \to \mathsf{Open} X$ .

#### 12 AMNON YEKUTIELI

For stacks of groupoids arising from moduli problems it is often more natural to use the fibered category approach (cf. [\[LMB\]](#page-35-9)); but for our applications in [\[Ye\]](#page-35-0), the pseudofunctor approach is more suitable.

### 3. Extensions of Gerbes

<span id="page-11-0"></span>We begin by taking certain basic notions about groups (such as normal subgroup and center) and generalizing them to groupoids. As a matter of convenience we often refer to a functor  $F : G \to H$  between groupoids as a morphism. (Indeed this is a 1-morphism in the 2-category **Groupoid** of groupoids.)

<span id="page-11-1"></span>**Definition 3.1.** Let G be a groupoid. A *normal subgroupoid* of G is a subgroupoid N satisfying the following three conditions.

- (i)  $Ob N = Ob G$ .
- (ii) For every  $i, j \in \text{Ob } \mathsf{G}$  and  $g \in \mathsf{G}(i, j)$  there is equality

 $\mathrm{Ad}(g)(\mathsf{N}(i,i)) = \mathsf{N}(j,j).$ 

(iii) N is totally disconnected, i.e.  $N(i, j) = \emptyset$  for  $i \neq j$ .

In particular for every  $i \in \text{Ob } G$  the group  $\mathsf{N}(i, i)$  is normal subgroup of the automorphism group G(*i, i*).

Note that a normal subgroupoid N is the same as a collection  $\{N_i\}_{i\in Ob\mathsf{G}}$  of subgroups  $N_i \subset G(i, i)$ , satisfying the obvious variant of condition (ii).

The *trivial normal subgroupoid* of G is the normal subgroupoid N for which all the groups  $N(i, i)$  are trivial; namely  $N(i, i) = \{1_i\}.$ 

Let  $F: G \to H$  be a morphism of groupoids. For  $i \in Ob G$  let

$$
Ker(F)(i, i) := Ker(F : G(i, i) \to H(F(i), F(i))).
$$

This is a normal subgroup of  $G(i, i)$ . Moreover, an easy calculation shows that the collection of subgroups  $\{\text{Ker}(F)(i,i)\}_{i\in\text{Ob }G}$  is a normal subgroupoid of G, which we denote by  $\text{Ker}(F)$ .

**Definition 3.2.** Let  $F: G \to H$  be a morphism of groupoids. We say that F is a *weak epimorphism* if it satisfies these conditions:

- (i) *F* is essentially surjective objects. Namely for any  $j \in \text{Ob } H$  there exists some  $i \in \text{Ob } G$  such that  $H(F(i), i) \neq \emptyset$ .
- (ii) *F* is surjective on sets of morphisms. This means that for any  $i, j \in Ob G$ the function

$$
F: \mathsf{G}(i,j) \to \mathsf{H}\bigl(F(i), F(j)\bigr)
$$

is surjective.

Observe that if  $F : G \to H$  is a weak epimorphism whose kernel  $\text{Ker}(F)$  is the trivial normal subgroupoid of G, then *F* is an equivalence.

**Definition 3.3.** By an *extension of groupoids* we mean a diagram of morphisms of groupoids

$$
N \xrightarrow{E} G \xrightarrow{F} H,
$$

such that *F* is a weak epimorphism,  $N = \text{Ker}(F)$ , and  $E : N \to G$  is the inclusion.

<span id="page-12-0"></span>By analogy with the case of groups we often write

(3.4) 
$$
1 \to \mathsf{N} \to \mathsf{G} \xrightarrow{F} \mathsf{H} \to 1
$$

for an extension of groupoids. But this is only a suggestive notation – we do not view the symbols "1" as groupoids. (We could, but then the first 1 has to be replaced by the trivial normal subgroupoid of G, and the second 1 by the terminal groupoid of Example [2.3.](#page-10-0))

Extensions of groupoids behave very much like extensions of groups. Suppose G is a groupoid and  $N \subset G$  is a normal subgroupoid. Then there is an extension of groupoids [\(3.4\)](#page-12-0). The groupoid H in this extension is unique up to equivalence. One could choose H such that the function  $F: Ob G \to Ob H$  is bijective; and that would make H unique up to isomorphism.

Next suppose  $\overline{F}: \overline{G} \to H$ ,  $F': \overline{G}' \to H'$  and  $D: G \to G'$  are morphisms of groupoids, such that  $D(\text{Ker}(F)) \subset \text{Ker}(F')$ . Then there is a morphism of groupoids  $E: H \to H'$ , unique up to 2-isomorphism, such that the diagram



commutes up to 2-isomorphism.

Now consider a groupoid G. For any  $i \in \text{Ob } G$  we have the center  $Z(G(i, i))$  of the automorphism group  $G(i, i)$ . Given any pair of objects  $i, j \in Ob G$ , and any isomorphism  $q \in G(i, j)$ , we have

$$
Ad(g)\big(\mathcal{Z}(\mathsf{G}(i,i))\big) = \mathcal{Z}(\mathsf{G}(j,j)).
$$

Therefore the collection of subgroups  $\{Z(G(i,i))\}_{i\in Ob\,}$  is a normal subgroupoid of G, which we denote by Z(G), and call the *center* of G.

**Definition 3.5.** (1) Let G be a groupoid. A *central subgroupoid* of G is any normal subgroupoid  $N$  that is contained in  $Z(G)$ .

(2) A *central extension of groupoids* is an extension of groupoids [\(3.4\)](#page-12-0) such that N is a central subgroupoid of G.

Suppose G is a nonempty and connected groupoid, and N is a central subgroupoid of G. Take any  $i, j \in$  Ob G and  $g, g' \in G(i, j)$ . Then the group isomorphisms

$$
\mathrm{Ad}(g), \mathrm{Ad}(g') : \mathsf{N}(i,i) \to \mathsf{N}(j,j)
$$

are equal. In this way we can canonically identify the abelian groups  $N(i, i)$ , for  $i \in \text{Ob } G$ , and view them as a single abelian group.

When we are given a central extension of groupoids  $(3.4)$  in which G is nonempty and connected, we can replace the central subgroupoid N by a single abelian group *N* as explained above, and the extension becomes

$$
1 \to N \to \mathsf{G} \xrightarrow{F} \mathsf{H} \to 1.
$$

So far for the discrete situation; now we geometrize. Let *X* be a topological space. Suppose  $\mathcal{G}$  is a gerbe on *X*. By a local object *i* of  $\mathcal{G}$  we mean an object  $i \in \text{Ob } \mathcal{G}(U)$ for some open set  $U \subset X$ . If  $i, j$  are two local objects, defined on open sets  $U, V$ respectively, then by  $\mathcal{G}(i, j)$  we mean the corresponding sheaf of isomorphisms on *U* ∩ *V*. By a local isomorphism *g* : *i*  $\stackrel{\simeq}{\to} j$  we mean an isomorphism *g* ∈  $\mathcal{G}(i, j)(W)$ 

for some open set  $W \subset U \cap V$ . Such g gives rise to an isomorphism of sheaves of groups

$$
\mathrm{Ad}(g): \mathcal{G}(i,i)|_W \xrightarrow{\simeq} \mathcal{G}(j,j)|_W.
$$

<span id="page-13-1"></span>**Definition 3.6.** Let  $\mathcal{G}$  be a gerbe on *X*. A *normal subprestack of groupoids* of  $\mathcal{G}$ is a subprestack  $\mathcal N$  of  $\mathcal G$  with these two properties:

- (i) For every open set *U* the category  $\mathcal{N}(U)$  is a normal subgroupoid of  $\mathcal{G}(U)$ (see Definition [3.1\)](#page-11-1). In particular  $Ob \mathcal{N}(U) = Ob \mathcal{G}(U)$ , and  $\mathcal{N}(U)$  is totally disconnected.
- (ii) For every local object *i* of  $\mathcal N$  the presheaf  $\mathcal N(i, i)$  is a sheaf.

Since the full name is too long, we simply call such  $\mathcal N$  a *normal subgroupoid* of **G**.

Here is what the definition amounts to. For every local object  $i$  of  $\mathcal{G}$  there is a subsheaf of groups  $\mathcal{N}(i, i) \subset \mathcal{G}(i, i)$ . The condition is that for any local objects *i* and *j*, and any local isomorphism  $g : i \rightarrow j$ , one has

$$
Ad(g)(\mathcal{N}(i,i)) = \mathcal{N}(j,j).
$$

Warning: a normal subgroupoid of a gerbe is usually not a gerbe, nor even a stack.

<span id="page-13-0"></span>**Proposition 3.7.** *Given a morphism of gerbes*  $F : \mathcal{G} \to \mathcal{H}$ *, there is a unique normal subgroupoid* **N** *of* **G** *such that*

$$
\mathcal{N}(U) = \text{Ker}\big(F : \mathcal{G}(U) \to \mathcal{H}(U)\big)
$$

*for every open set U.*

*Proof.* The formula defines a subprestack of groupoids  $\mathcal N$  of  $\mathcal G$ . We know that the groupoid  $\mathcal{N}(U)$  is normal in  $\mathcal{G}(U)$ . And for any local object *i* of  $\mathcal{G}$  we have

$$
\mathcal{N}(i,i) = \text{Ker}(F \mathrel{:} \mathcal{G}(i,i) \rightarrow \mathcal{H}(F(i), F(i)))
$$

as presheaves, so  $\mathcal{N}(i, i)$  a sheaf.

**Definition 3.8.** The normal subgroupoid  $\mathcal N$  in the proposition above is called the *kernel* of  $F$ , and it is denoted by  $Ker(F)$ 

**Definition 3.9.** Let  $F : \mathcal{G} \to \mathcal{H}$  be a morphism of gerbes. We say that F is a *weak epimorphism* if it satisfies these conditions:

- (i) *F* is *locally essentially surjective on objects*. Recall that this says that for any open set  $U \subset X$ , object  $j \in Ob \mathcal{H}(U)$  and point  $x \in U$ , there is an open set *V* with  $x \in V \subset U$ , an object  $i \in \text{Ob } \mathcal{G}(V)$ , and an isomorphism  $h: F(i) \xrightarrow{\simeq} j$  in  $\mathcal{H}(V)$ .
- (ii) *F* is *surjective on isomorphism sheaves*. This says that for any  $i, j \in$  $Ob$   $\mathcal{G}(U)$  the map of sheaves of sets

$$
F: \mathcal{G}(i,j) \to \mathcal{H}(F(i), F(j))
$$

is surjective.

Note that if  $F : \mathcal{G} \to \mathcal{H}$  is a weak epimorphism such that  $\text{Ker}(F)$  is the trivial normal subgroupoid of  $\mathcal{G}$ , then  $F$  is a weak equivalence, and hence it is an equivalence.

**Definition 3.10.** An *extension of gerbes* is a diagram

$$
\mathcal{N} \xrightarrow{E} \mathcal{G} \xrightarrow{F} \mathcal{H}
$$

of morphisms in **PreStGr**  $X$ , such that  $\mathcal G$  and  $\mathcal H$  are gerbes,  $F$  is a weak epimorphism,  $\mathcal{N} = \text{Ker}(F)$ , and  $E : \mathcal{N} \to \mathcal{G}$  is the inclusion.

We often use the notation of "exact sequence"

(3.11) 
$$
1 \rightarrow \mathcal{N} \rightarrow \mathcal{G} \xrightarrow{F} \mathcal{H} \rightarrow 1
$$

for an extension of gerbes.

**Definition 3.12.** A *morphism of extensions of gerbes* is a diagram



of morphisms in **PreStGr**  $X$ , where the rows are extensions of gerbes, the square on the right is commutative up to 2-isomorphism, and the square on the left is commutative. We denote this morphism of extensions by (*D, E*).

<span id="page-14-0"></span>**Theorem 3.13.** Let  $\mathcal G$  be a gerbe on  $X$ , and let  $\mathcal N$  be a normal subgroupoid of  $\mathcal G$ . *Then there exists a gerbe*  $\mathcal{G}/\mathcal{N}$ *, and a morphism of gerbes*  $F : \mathcal{G} \to \mathcal{G}/\mathcal{N}$ *, with the following properties:*

(i) *The diagram*

$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{G}/\mathcal{N} \to 1
$$

*is an extension of gerbes.*

(ii) *Suppose*

$$
1\rightarrow \textbf{\textit{N}}^{\prime}\rightarrow \textbf{\textit{G}}^{\prime}\xrightarrow{F^{\prime}}\textbf{\textit{H}}^{\prime}\rightarrow 1
$$

*is an extension of gerbes, and*  $D: \mathcal{G} \to \mathcal{G}'$  *is a morphism of gerbes, such that*  $D(\mathcal{N}) \subset \mathcal{N}'$ . Then there is a morphism gerbes  $E : \mathcal{G}/\mathcal{N} \to \mathcal{H}'$ , *unique up to* 2*-isomorphism, such that the diagram*

$$
1 \longrightarrow \mathcal{N} \longrightarrow \mathcal{G} \longrightarrow \mathcal{G}/\mathcal{N} \longrightarrow 1
$$

$$
\downarrow \qquad D \downarrow \qquad E \downarrow
$$

$$
1 \longrightarrow \mathcal{N}' \longrightarrow \mathcal{G}' \longrightarrow \mathcal{H}' \longrightarrow 1
$$

*is a morphism of extensions.*

(iii) In the situation of property (ii), assume the morphism  $D: \mathcal{G} \to \mathcal{G}'$  is an *equivalence, and the sheaf homomorphisms*

$$
D: \mathcal{N}(i,i) \to \mathcal{N}'(F(i),F(i))
$$

*are isomorphisms for all local objects i of* **G***. Then E is also an equivalence.*

Before giving the proof we need some preliminary work. Let  $U \subset X$  be an open set, and let  $i, j \in \text{Ob } \mathcal{G}(U)$ . The sheaf of sets  $\mathcal{G}(i, j)$  is a right  $\mathcal{G}(i, i)$ -torsor on U, and hence it has a right action by the sheaf of groups  $\mathcal{N}(i, i)$ . Let  $\bar{\mathcal{G}}(i, j)$  be the sheaf of sets on *U* associated to the presheaf

$$
V \mapsto \mathcal{G}(V)(i,j) / \mathcal{N}(V)(i,i).
$$

There is a surjective sheaf morphism  $\mathcal{G}(i, j) \to \bar{\mathcal{G}}(i, j)$ . If  $i = j$  we get a sheaf of groups  $\bar{\mathcal{G}}(i,i)$ .

<span id="page-15-0"></span>**Lemma 3.14.** *There is a unique structure of*  $\bar{G}(j, j)$ *-* $\bar{G}(i, i)$ *-bitorsor on*  $G(i, j)$ *, such that the surjection*  $\mathcal{G}(i, j) \to \bar{\mathcal{G}}(i, j)$  *is*  $\mathcal{G}(j, j) \times \mathcal{G}(i, i)$  *-equivariant.* 

*Proof.* Uniqueness is clear. For existence, we have to exhibit a suitable action of the sheaf of groups  $\mathcal{G}(j, j) \times \mathcal{G}(i, i)$  on the sheaf of sets  $\mathcal{G}(i, j)$ . Because of uniqueness, this is a local question.

Choose an open set  $V \subset X$  that trivializes the bitorsor  $\mathcal{G}(i, j)$ ; namely there is some  $g \in \mathcal{G}(i,j)(V)$ . Then the left action of  $\mathcal{G}(i,j)|_V$  on  $\mathcal{G}(i,j)|_V$  coincides with the right action of  $\mathcal{G}(i,i)|_V$ , via the isomorphism of sheaves of groups

$$
\mathrm{Ad}(g): \mathcal{G}(i,i)|_V \xrightarrow{\simeq} \mathcal{G}(j,j)|_V.
$$

Also we have a torsor isomorphism

$$
\mathcal{G}(i,i)|_V \xrightarrow{\simeq} \mathcal{G}(i,j)|_V, \ f \mapsto g \circ f.
$$

Let  $\bar{q} \in \mathcal{G}(i, j)(V)$  be the image of q. We then have an isomorphism of sheaves of right  $\bar{g}(i, i)|_V$ -sets

$$
\bar{\mathcal{G}}(i,i)|_V \xrightarrow{\simeq} \bar{\mathcal{G}}(i,j)|_V, \ \bar{f} \mapsto \bar{g} \circ \bar{f}.
$$

It follows that  $\mathcal{G}(i, j)|_V$  is a right  $\bar{\mathcal{G}}(i, i)|_V$ -torsor. On the other hand, the isomorphism Ad(*g*) induces an isomorphism of sheaves of groups

$$
\phi: \bar{\mathcal{G}}(i,i)_V \xrightarrow{\simeq} \bar{\mathcal{G}}(j,j)_V.
$$

We conclude that  $\mathcal{G}(i, j)|_V$  is a  $\bar{\mathcal{G}}(j, j)|_V$ - $\bar{\mathcal{G}}(i, i)|_V$ -bitorsor. And for this bitorsor structure, the isomorphism of sheaves of groups is  $\phi = \text{Ad}(\bar{g})$ . An easy calculation shows that the surjection  $\mathbf{G}(i, j)|_V \to \mathbf{G}(i, j)|_V$  is  $\mathbf{G}(j, j)|_V \times \mathbf{G}(i, i)|_V$  -equivariant.  $\Box$ 

*Proof of the theorem.* The proof is divided into several steps.

(a) Define a prestack of groupoids  $\bar{g}$ , and a morphism  $g \to \bar{g}$ , as follows. For an open set  $U \subset X$  the object set is  $\text{Ob } \mathcal{G}(U) := \text{Ob } \mathcal{G}(U)$ . For a pair of objects  $i, j \in$ Ob $\mathcal{G}(U)$  let  $\mathcal{G}(i, j)$  be the sheaf of sets from Lemma [3.14,](#page-15-0) and define  $\mathcal{G}(U)(i, j)$  :=  $\Gamma(U,\bar{\mathcal{G}}(i,j))$ . Next let  $\mathcal{G}/\mathcal{N}$  be the stack associated to  $\bar{\mathcal{G}}$ . So  $\mathcal{G}/\mathcal{N}$  is a gerbe, and there is a weak equivalence of prestacks  $\vec{G} \rightarrow \vec{G}/N$ . It is important to note that even though  $\mathcal{G}/\mathcal{N}$  may have more local objects than  $\bar{\mathcal{G}}$ , the isomorphism sheaves (for local objects of  $\bar{G}$ ) are unchanged.

(b) The morphism of gerbes  $F : \mathcal{G} \to \mathcal{G}/\mathcal{N}$  we get from step (a) is a weak epimorphism, and its kernel in  $\mathcal N$ . This proves property (i).

(c) In this step we prove the existence part of property (ii). Let us define a morphism of prestacks  $\overline{D}$  :  $\overline{G}$   $\rightarrow$   $\mathcal{H}'$  as follows. On objects  $\overline{D}$  is just  $F' \circ D$ . And on isomorphisms, for local objects *i, j* of  $\overline{G}$ , we define

$$
\bar{D} : \bar{\mathbf{G}}(i,j) \to \mathbf{\mathcal{H}}'(D(i),D(j))
$$

to be the unique  $\mathcal{G}(i, i)$ -equivariant sheaf morphism making the diagram



commute. Due to the universal property of stackification,  $\bar{D}$  induces a morphism of gerbes  $E: \mathcal{G}/\mathcal{N} \to \mathcal{H}'$ ; and then  $(D, E)$  is a morphism of extensions.

(d) Now we will prove that the morphism *E* from step (c) is unique up to 2 isomorphism. Suppose  $E': \mathcal{G}/\mathcal{N} \to \mathcal{H}'$  is some other morphism such that  $(D, E')$ is a morphism of extensions. By composing the canonical morphism  $\bar{\mathcal{G}} \to \mathcal{G}/\mathcal{N}$  with  $E'$ , we obtain a morphism  $\bar{D}': \bar{\mathcal{G}} \to \mathcal{H}'$ . We are going to construct a 2-isomorphism  $\bar{\eta}:\bar{D}\stackrel{\simeq}{\Longrightarrow}\bar{D}'.$ 

For a local object  $i \in Ob \mathcal{G}(U) = Ob \overline{\mathcal{G}}(U)$  let  $j := \overline{D}(i) \in Ob \mathcal{H}'(U)$  and  $j' := \bar{D}'(i) \in \text{Ob } H'(U)$ . So  $j = (F' \circ D)(i)$  and  $j' = (E' \circ F)(i)$ . Take any 2isomorphism  $\eta : E' \circ F \stackrel{\simeq}{\Longrightarrow} F' \circ D$ . Then  $\eta$  induces a 2-isomorphism  $\bar{\eta} : \bar{D} \stackrel{\simeq}{\Longrightarrow} \bar{D}',$ which coincides with *η* on objects of  $\bar{g}$ , and is the reduction of *η* modulo **N** on isomorphisms in  $\mathcal{G}$ .

Because  $\mathcal{G}/\mathcal{N}$  is the stackification of  $\bar{\mathcal{G}}$ , and *E*, *E'* are the stackifications of  $\bar{D}, \bar{D}'$ respectively,  $\bar{\eta}$  induces a 2-isomorphism  $E \stackrel{\simeq}{\Longrightarrow} E'$ .

(e) Finally we shall prove property (iii). The morphism  $\bar{D}$  :  $\bar{\mathcal{G}} \to \mathcal{H}'$  is locally surjective on objects. This is because  $\mathcal{G}$  and  $\mathcal{G}$  have the same local objects;  $\mathcal{G} \to \mathcal{G}'$ is locally bijective on objects; and  $\mathcal{G}' \to \mathcal{H}'$  is locally surjective on objects.

By construction, for any pair of local objects  $i, j$  of  $\bar{G}$  we have

$$
\bar{\mathcal{G}}(i,j) = \mathcal{G}(i,j)/\mathcal{N}(i,i)
$$

as sheaves of sets. On the other hand

$$
D: \mathcal{N}(i,i) \to \mathcal{N}'(D(i),D(i))
$$

is an isomorphism of sheaves of groups, and

$$
D: \mathcal{G}(i,j) \to \mathcal{G}'(D(i),D(j))
$$

is an isomorphism of torsors. Since

$$
\mathcal{H}'(E(i), E(j)) \cong \mathcal{G}'(D(i), D(j)) / \mathcal{N}'(D(i), D(i))
$$

we see that  $\bar{D}$  :  $\bar{\mathcal{G}} \to \mathcal{H}'$  is a weak equivalence. Therefore  $E : \mathcal{G}/\mathcal{N} \to \mathcal{H}'$  is an equivalence.

**Corollary 3.15.** *Suppose we are given extensions of gerbes*

$$
1\to \mathcal{N}\to \mathcal{G}\stackrel{F}{\to} \mathcal{H}\to 1
$$

*and*

$$
1 \to \mathcal{N}' \to \mathcal{G}' \xrightarrow{F'} \mathcal{H}' \to 1,
$$

*and a morphism of gerbes*  $D : \mathcal{G} \to \mathcal{G}'$ , such that  $D(\mathcal{N}) \subset \mathcal{N}'$ . Then there is *a* morphism of gerbes  $E : \mathcal{H} \to \mathcal{H}'$ , unique up to 2-isomorphism, such that the *diagram*



*is a morphism of extensions.*

*Proof.* By the theorem we can replace  $\mathcal{H}$  with the equivalent gerbe  $\mathcal{G}/\mathcal{N}$ . Now we can use property (ii) of the theorem.  $\Box$ 

Given a sheaf of groups  $G$  on  $X$  and an open set  $U \subset X$ , we write  $G(U) :=$  $\Gamma(U, \mathcal{G})$ . The center of this group is denoted by  $\mathcal{Z}(\mathcal{G}(U))$ . Since the center is not functorial, one has to be careful what we mean by the center of the sheaf  $\mathcal{G}$ . The correct definition seems to be as follows.

**Definition 3.16.** Let  $\mathcal G$  be a sheaf of groups on *X*. The *center* of  $\mathcal G$  is the sheaf of groups  $Z(\mathcal{G})$  whose group of sections on an open set U is

 $Z(\mathcal{G})(U) := \{ g \in \mathcal{G}(U) \mid g|_V \in Z(\mathcal{G}(V)) \text{ for any } V \subset U \}.$ 

<span id="page-17-0"></span>**Proposition 3.17.** *Given a gerbe*  $\mathcal{G}$ *, there is a unique normal subgroupoid*  $\mathcal{N}$  *of* **G** *such that*

$$
\mathcal{N}(i,i) = \mathrm{Z}(\mathcal{G}(i,i))
$$

*for every local object i of*  $\mathcal{G}$ *.* 

The proof is like that of Proposition [3.7.](#page-13-0)

**Definition 3.18.** Let  $\mathcal{G}$  be a gerbe.

- (1) The normal subgroupoid  $\mathcal N$  in Proposition [3.17](#page-17-0) is called the *center* of  $\mathcal G$ , and it is denoted by  $Z(\mathcal{G})$ .
- (2) A *central subgroupoid* of  $\mathcal{G}$  is a normal subgroupoid  $\mathcal{N}$  of  $\mathcal{G}$  that is contained in  $Z(\mathcal{G})$ .

<span id="page-17-2"></span>**Proposition 3.19.** Let  $N$  be a central subgroupoid of  $G$ . Then there is sheaf of *abelian groups* N, together with an isomorphism of sheaves of groups

$$
(3.20) \t\t\t\t\t\t\chi_i: \mathcal{N}|_U \to \mathcal{N}(i,i)
$$

*for any open set U and object*  $i \in \text{Ob } \mathcal{G}(U)$ *, satisfying this condition:* 

(◇) *Given any*  $i \in \text{Ob } \mathcal{G}(U)$ ,  $j \in \text{Ob } \mathcal{G}(V)$ ,  $W \subset U \cap V$ , and  $g \in \mathcal{G}(i, j)(W)$ , *one has*

<span id="page-17-1"></span>
$$
\chi_j \circ \operatorname{Ad}(g) = \chi_j
$$

as sheaf homomorphisms  $\mathcal{N}|_W \to \mathcal{G}(j, j)|_W$ .

*The sheaf* N *is unique up to a unique isomorphism.*

*Conversely, given a sheaf of abelian groups* N, together with a collection of in*jective sheaf homomorphisms*

$$
\chi_i:\mathcal{N}|_U\to \mathrm{Z}(\mathcal{G}(i,i))
$$

 $for i \in Ob$   $\mathcal{G}(U)$ *, that satisfy condition*  $\langle \diamondsuit \rangle$ *, there exists a unique central subgroupoid* **N** *of* **G** *such that* [\(3.20\)](#page-17-1) *are isomorphisms.*

*Proof.* This is due to the local nature of gerbes; cf. part (a) of the proof of Theorem  $3.13.$ 

The last proposition says that a central subgroupoid  $\mathcal N$  of a gerbe  $\mathcal G$  can be viewed as a single sheaf of abelian groups.

Finally we can explain the title of the paper.

<span id="page-18-1"></span>**Definition 3.21.** A *central extension of gerbes* is an extension of gerbes

$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1
$$

such that  $\mathcal N$  is a central subgroupoid of  $\mathcal G$ .

Using Proposition [3.19](#page-17-2) to replace  $\mathcal N$  with a sheaf of abelian groups  $\mathcal N$ , we can rewrite this central extension as

$$
(3.22) \t 1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1.
$$

Here are a couple of examples of central extensions of gerbes. The first is somewhat tautological.

**Example 3.23.** Suppose  $\mathcal N$  is a central subgroupoid of a gerbe  $\mathcal G$ . Then the extension of gerbes

$$
1\rightarrow \mathcal{N}\rightarrow \mathcal{G}\stackrel{F}{\rightarrow} \mathcal{G}/\mathcal{N}\rightarrow 1
$$

from Theorem [3.13](#page-14-0) is central.

The next example was suggested to us by the referee.

## <span id="page-18-2"></span>**Example 3.24.** Let

<span id="page-18-3"></span>
$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1
$$

be a central extension of sheaves of groups on *X*. Given an open set *U* and a  $\mathcal{G}|_U$ -torsor S, let us denote by  $F(\mathcal{S})$  the induced  $\mathcal{H}|_U$ -torsor. This operation gives rise to a morphism of gerbes

$$
(3.25) \t\t\t F : Tors \mathcal{G} \to Tors \mathcal{H}
$$

(cf. Example [2.4\)](#page-10-1). Since locally any  $H$ -torsor is trivial, it is locally induced from a  $\mathcal{G}\text{-torsor.}$  This says that  $(3.25)$  is locally essentially surjective on objects.

Now for any  $G$ -torsor  $S$ , locally we have a (noncanonical) isomorphism of sheaves of groups

$$
(\text{Tors }\mathcal{G})(\mathcal{S},\mathcal{S})\cong \mathcal{G}^{\mathrm{op}}.
$$

Likewise for  $H$ -torsors. This implies that the morphism of gerbes  $(3.25)$  is surjective on isomorphism sheaves, and its kernel is a central subgroupoid of  $\mathcal{G}$ , isomorphic to the sheaf  $N$ . In this way we get a central extensions of gerbes

<span id="page-18-0"></span>(3.26) 
$$
1 \to \mathcal{N} \to \text{Tors } \mathcal{G} \xrightarrow{F} \text{Tors } \mathcal{H} \to 1.
$$

## <span id="page-18-4"></span>4. Obstruction Classes

We fix a topological space X. Given a sheaf  $N$  of abelian groups on  $X$ , and an open covering  $\boldsymbol{U} = \{U_k\}_{k \in K}$  of X, there are the Čech cohomology groups  $\check{H}^p(\boldsymbol{U}, \mathcal{N})$ for  $p \geq 0$ . Passing to the limit over all such open coverings we obtain the Čech cohomology groups  $\check{H}^p(X, \mathcal{N}).$ 

From here until the end of this section we consider a central extension of gerbes

(4.1) 
$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1
$$

on *X* (see Definition [3.21](#page-18-1) and Proposition [3.19\)](#page-17-2).

<span id="page-19-0"></span>**Construction 4.2.** Let  $i, j \in \text{Ob } \mathcal{G}(X)$ , and let  $h \in \mathcal{H}(X)(F(i), F(j))$ . Since *F* is a weak epimorphism, there exists an open covering  $U = \{U_k\}_{k \in K}$  of X, such that for every  $k \in K$  there is an isomorphism  $g_k \in \mathcal{G}(U_k)(i,j)$  with  $F(g_k) = h$ . For every  $k_0, k_1 \in K$  we define

$$
g_{k_0,k_1} := g_{k_1}^{-1} \circ g_{k_0} \in \mathcal{G}(U_{k_0,k_1})(i,i).
$$

Since  $F(g_{k_0,k_1}) = 1$  we see that in fact  $g_{k_0,k_1} \in \mathcal{N}(U_{k_0,k_1})$ . An easy calculation shows that the collection

$$
(4.3) \t\t c := \{g_{k_0,k_1}\}_{k_0,k_1 \in K}
$$

is a Čech 1-cocycle for the covering  $U$  with values in the sheaf of groups  $\mathcal{N}$ .

**Lemma 4.4.** *Let*  $i, j \in \text{Ob } \mathcal{G}(X)$  *and let*  $h \in \mathcal{H}(X)(F(i), F(j))$ *. Suppose that c and c* ′ *are* 1*-cocycles with values in* N *, for open coverings U and U* ′ *, obtained as in Construction* [4.2](#page-19-0)*, for the same isomorphism h. Then their Čech cohomology classes*  $[c], [c'] \in H^1(X, \mathcal{N})$  *are equal.* 

*Proof.* Say  $U' = \{U'_k\}_{k \in K'}$ . Suppose that in the course of constructing the cocycle  $c'$  we chose, for every  $k \in K'$ , an isomorphism  $g'_k \in \mathcal{G}(U'_k)(i,j)$  with  $F(g'_k) = h$ . So  $g'_{k_0, k_1} = g'_{k_1}^{-1} \circ g'_{k_0}$  and  $c' = \{g'_{k_0, k_1}\}_{k_0, k_1 \in K'}$ .

Take some open covering  $V = \{V_i\}_{i \in L}$  of X which refines both U and U'. Thus there are functions  $\phi: L \to K$  and  $\phi': L \to K'$ , such that  $V_l \subset U_{\phi(l)}$  and  $V_l \subset U'_{\phi'(l)}$ for all  $l \in L$ . We get cocycles

$$
\phi^*(c) := \{ g_{\phi(l_0), \phi(l_1)} \}_{l_0, l_1 \in L}
$$

and

$$
{\phi'}^*(c') := \{g'_{\phi'(l_0), \phi'(l_1)}\}_{l_0, l_1 \in L}.
$$

For any  $l \in L$  let

$$
f_l := g_{\phi(l)}^{-1} \circ g'_{\phi'(l)} \in \mathcal{G}(V_l)(i, i).
$$

Now

$$
F(f_l) = F(g_{\phi(l)})^{-1} \circ F(g'_{\phi'(l)}) = h^{-1} \circ h = 1.
$$

So  $b := \{f_l\}_{l \in L}$  is a 0-cochain with values in N.

Take any  $l_0, l_1 \in L$ . Then

$$
(f_{l_1}^{-1} \circ f_{l_0}) \circ g_{\phi(l_0),\phi(l_1)}
$$
  
=  $(g_{\phi(l_1)}^{-1} \circ g'_{\phi'(l_1)})^{-1} \circ (g_{\phi(l_0)}^{-1} \circ g'_{\phi'(l_0)}) \circ (g_{\phi(l_1)}^{-1} \circ g_{\phi(l_0)})$   
=  $g'_{\phi'(l_1)} \circ g'_{\phi'(l_0)} = g'_{\phi'(l_0),\phi'(l_1)}.$ 

Denoting the Čech coboundary operator by d, we see that

$$
d(b) \cdot \phi^*(c) = {\phi'}^*(c').
$$

 $\Box$ 

In view of this lemma, the following definition makes sense.

**Definition 4.5.** Let  $i, j \in \text{Ob } \mathcal{G}(X)$ , and let  $h \in \mathcal{H}(X)(F(i), F(j))$ . Take any 1-cocycle *c* as in Construction [4.2.](#page-19-0) We define the obstruction class

$$
\mathrm{cl}_F^1(h) := [c] \in \check{\mathrm{H}}^1(X, \mathcal{N}).
$$

<span id="page-20-0"></span>**Theorem 4.6** (Obstruction to lifting isomorphisms)**.** *Consider a central extension of gerbes*

$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1.
$$

*Let*  $i, j \in \text{Ob } \mathcal{G}(X)$ , and let  $h \in \mathcal{H}(X)(F(i), F(j))$ . Then there exists an isomor*phism*  $g \in \mathcal{G}(X)(i, j)$  *satisfying*  $F(g) = h$  *if and only if* 

$$
\mathrm{cl}_F^1(h) = 1.
$$

In other words, the class  $\mathrm{cl}_F^1(h)$  is the obstruction to lifting the isomorphism  $h: F(i) \to F(j)$  to an isomorphism  $g: i \to j$ .

*Proof.* First assume there exists a lifting *g*. We construct a cocycle *c* as follows: for the open covering  $U = \{U_k\}_{k \in K}$  we take  $K := \{0\}$  and  $U_0 := X$ . We then take  $g_0 := g$ . The resulting cocycle is *c* is trivial, and hence  $\mathrm{cl}_F^1(h) = 1$ .

Conversely, assume that  $\mathrm{cl}_{F}^{1}(h) = 1$ . Let  $c' = \{g'_{k_0,k_1}\}_{k_0,k_1 \in K}$  be a 1-cocycle that represents  $\mathrm{cl}_F^1(h)$  on some open covering *U*. Say  $g'_k \in \mathcal{G}(U_k)(i,j)$  are the isomorphisms chosen in the construction of *c*', so that  $g'_{k_0, k_1} = g'^{-1}_{k_1} \circ g'_{k_0}$ .

By replacing  $U$  with a suitable refinement, we can assume that  $c'$  is a coboundary; i.e. there is a 0-cochain  $b := \{f_k\}_{k \in K}$  with values in N such that  $c' = d(b)$ . Define

$$
g_k := g'_k \circ f_k^{-1} \in \mathcal{G}(U_k)(i,j).
$$

A calculation shows that  ${g_k}_{k \in K}$  is a 0-cocycle with values in the sheaf of sets  $\mathcal{G}(i, j)$ . Hence it glues to a global isomorphism  $g \in \mathcal{G}(X)(i, j)$ . And by construction we have  $F(g) = h$ .

**Corollary 4.7.** *Given a central extension of gerbes as above, let*  $i, j \in \text{Ob } \mathcal{G}(X)$ *. Then*  $\mathcal{G}(X)(i,j) \neq \emptyset$  *if and only if there exists some*  $h \in \mathcal{H}(X)(F(i), F(j))$  such *that*  $\mathrm{cl}_{F}^{1}(h) = 1$ *.* 

*Proof.* This is an immediate consequence of the theorem.

$$
\overline{\phantom{0}}
$$

**Remark 4.8.** In an earlier version of this paper we claimed that  $\mathrm{cl}_{F}^{1}(h) = \mathrm{cl}_{F}^{1}(h')$ for any  $h, h' \in \mathcal{H}(X)(F(i), F(j))$ . However the referee discovered a mistake in our proof.

<span id="page-20-1"></span>**Construction 4.9.** Let  $j \in \text{Ob } \mathcal{H}(X)$ . Choose some open covering  $\mathbf{U} = \{U_k\}_{k \in K}$ of *X*. For every  $k \in K$  choose, if possible, an object  $i_k \in Ob \mathcal{G}(U_k)$  and an isomorphism

$$
h_k \in \mathcal{H}(U_k)(F(i_k),j).
$$

For every  $(k_0, k_1) \in K \times K$  define

$$
h_{k_0,k_1} := h_{k_1}^{-1} \circ h_{k_0} \in \mathcal{H}(U_{k_0,k_1})\big(F(i_{k_0}),F(i_{k_1})\big).
$$

Choose, if possible, an isomorphism

$$
g_{k_0,k_1} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0},i_{k_1})
$$

that lifts  $h_{k_0,k_1}$ , i.e.  $F(g_{k_0,k_1}) = h_{k_0,k_1}$ . Define

$$
g_{k_0,k_1,k_2} := g_{k_0,k_2}^{-1} \circ g_{k_1,k_2} \circ g_{k_0,k_1} \in \mathcal{G}(U_{k_0,k_1,k_2})(i_{k_0},i_{k_0}).
$$

Thus we get a collection of elements

$$
(4.10) \t\t c := \{g_{k_0,k_1,k_2}\}_{k_0,k_1,k_2 \in K}.
$$

<span id="page-21-1"></span>**Lemma 4.11.** *The collection c from this construction is a Čech* 2*-cocycle with values in*  $N$ *.* 

*Proof.* Since  $F(g_{k_0,k_1,k_2}) = 1$  it follows that  $g_{k_0,k_1,k_2} \in \mathcal{N}(U_{k_0,k_1,k_2})$ .

Let us now calculate the value of the coboundary of *c* in  $\mathcal{N}(U_{k_0,k_1,k_2,k_3})$ , using the fact that  $\mathcal N$  is central in  $\mathcal G$ :

$$
g_{k_1,k_2,k_3} \circ g_{k_0,k_2,k_3}^{-1} \circ g_{k_0,k_1,k_3} \circ g_{k_0,k_1,k_2}^{-1}
$$
  
\n
$$
= g_{k_1,k_2,k_3} \circ (g_{k_0,k_3}^{-1} \circ g_{k_2,k_3} \circ g_{k_0,k_2})^{-1}
$$
  
\n
$$
\circ (g_{k_0,k_3}^{-1} \circ g_{k_1,k_3} \circ g_{k_0,k_1}) \circ (g_{k_0,k_2}^{-1} \circ g_{k_1,k_2} \circ g_{k_0,k_1})^{-1}
$$
  
\n
$$
= g_{k_1,k_2,k_3} \circ g_{k_0,k_2}^{-1} \circ g_{k_2,k_3}^{-1} \circ g_{k_0,k_3}
$$
  
\n
$$
\circ g_{k_0,k_3}^{-1} \circ g_{k_1,k_3} \circ g_{k_0,k_1} \circ g_{k_0,k_1}^{-1} \circ g_{k_1,k_2}^{-1} \circ g_{k_0,k_2}
$$
  
\n
$$
= g_{k_0,k_2}^{-1} \circ g_{k_2,k_3}^{-1} \circ g_{k_1,k_3} \circ g_{k_1,k_2,k_3} \circ g_{k_1,k_2}^{-1} \circ g_{k_0,k_2}
$$
  
\n
$$
= g_{k_0,k_2}^{-1} \circ g_{k_2,k_3}^{-1} \circ g_{k_1,k_3}
$$
  
\n
$$
\circ (g_{k_1,k_3}^{-1} \circ g_{k_2,k_3} \circ g_{k_1,k_2}) \circ g_{k_1,k_2}^{-1} \circ g_{k_0,k_2}
$$
  
\n
$$
= 1.
$$



<span id="page-21-2"></span>**Lemma 4.12.** *Let*  $j \in \text{Ob } \mathcal{H}(X)$ *. Suppose that c and c*<sup>'</sup> *are* 2*-cocycles with values* in  $N$ , for open coverings  $U$  and  $U'$ , obtained as in Construction [4.9](#page-20-1). Then their  $\check{C}ech \; cohomology \; classes \; [c], [c'] \in \check{H}^{2}(X, \mathcal{N}) \; are \; equal.$ 

*Proof.* The cocycle *c*' is constructed using some open covering  $U' = \{U'_k\}_{k \in K'}$ , objects  $i'_k \in Ob \mathcal{G}(U'_k)$  that lift *j*, isomorphisms  $h'_k \in \mathcal{H}(U'_k)(F(i'_k), j)$ , and isomor- $\mathbf{g}_{k_0,k_1}^{\prime} \in \mathcal{G}(U'_{k_0,k_1})(i'_{k_0}, i'_{k_1})$  that lift  $h'_{k_0,k_1} := h'^{-1}_{k_1} \circ h'_{k_0}$ .

The proof proceeds in four steps, labeled (a)-(d).

(a) Suppose  $\boldsymbol{U}' = \boldsymbol{U}$ ,  $i'_{k} = i_{k}$  and  $h'_{k} = h_{k}$ , but we choose some other lifting  $g'_{k_{0},k_{1}}$ of  $h_{k_0,k_1}$ . The 2-cocycle  $c' = \{g'_{k_0,k_1,k_2}\}\$  is

<span id="page-21-0"></span>
$$
(4.13) \t g'_{k_0,k_1,k_2} := g'^{-1}_{k_0,k_2} \circ g'_{k_1,k_2} \circ g'_{k_0,k_1} \in \mathcal{G}(U_{k_0,k_1,k_2})(i_{k_0},i_{k_0}).
$$

Now there are unique elements

$$
n_{k_0,k_1} \in \mathcal{N}(U_{k_0,k_1})(i_{k_0},i_{k_0})
$$

such that

$$
g'_{k_0,k_1} = n_{k_0,k_1} \circ g_{k_0,k_1}.
$$

Consider the Čech 1-cochain  $b := \{n_{k_0,k_1}\}\$  with values in N. A little calculation shows that

$$
g'_{k_0,k_1,k_2}=g_{k_0,k_1,k_2}\circ (n_{k_0,k_2}^{-1}\circ n_{k_0,k_1}\circ n_{k_1,k_2});
$$

so that  $c' = c \cdot d(b)$ . We see that *c* and *c*<sup>'</sup> have the same cohomology class.

(b) Next suppose  $U' = U$  and  $i'_{k} = i_{k}$ , but we choose other isomorphisms  $h'_{k} \in$  $\mathcal{H}(U_k)(F(i_k), j)$ . Define

$$
h'_{k_0,k_1} := h'^{-1}_{k_1} \circ h'_{k_0} \in \mathcal{H}(U_{k_0,k_1})(F(i_{k_0}),F(i_{k_1})).
$$

Consider the elements

$$
f_k := h_k^{-1} \circ h'_k \in \mathcal{H}(U_k)(F(i_k), F(i_k)).
$$

Take some open covering  $V = \{V_i\}_{i \in L}$  that refines U, with comparison function  $\phi: L \to K$ , such that for every  $l \in L$  the isomorphism  $f_{\phi(l)}$  lifts to some  $g_l \in L$  $\mathcal{G}(V_l)(i_{\phi(l)}, i_{\phi(l)})$ . This is possible since *F* is locally surjective on isomorphism sheaves. By replacing  $U$  with  $V$ , we can now assume that each  $f_k$  lifts to some  $g_k \in \mathcal{G}(U_k)(i_k, i_k).$ 

Now let us define

$$
g''_{k_0,k_1} := g_{k_1}^{-1} \circ g_{k_0,k_1} \circ g_{k_0} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0},i_{k_1}).
$$

Then  $g''_{k_0,k_1}$  is a lifting of  $h'_{k_0,k_1}$ . Proceeding as in equation [\(4.13\)](#page-21-0), we obtain a Čech 2-cocycle  $c'' = \{g''_{k_0, k_1, k_2}\}\$ . However, it is easy to see that

$$
g_{k_0,k_1,k_2}'' = g_{k_0}^{-1} \circ g_{k_0,k_1,k_2} \circ g_{k_0}.
$$

Since  $g_{k_0,k_1,k_2}$  is central in **G** it follows that in fact  $g''_{k_0,k_1,k_2} = g_{k_0,k_1,k_2}$ , so that  $c'' = c$ . On the other hand, from step (a) we see that  $[c''] = [c']$  in  $\check{H}^2(X, \mathcal{N})$ .

(c) Now suppose  $U' = U$ , but we choose another object  $i'_{k} \in Ob \mathcal{G}(U_{k})$  for each  $k$ . Take some open covering  $V = \{V_l\}_{l \in L}$  that refines U, with comparison function  $\phi: L \to K$ , such that for every  $l \in L$  one has

$$
\mathcal{G}(V_l)(i_{\phi(l)}, i'_{\phi(l)}) \neq \emptyset.
$$

This can be done because  $\mathcal{G}$  is locally connected. After replacing  $U$  with  $V$ , we can assume that there is some  $f_k \in \mathcal{G}(U_k)(i_k, i'_k)$  for every  $k \in K$ .

In view of steps (a-b) we might as well take

$$
h'_{k} := h_{k} \circ F(f_{k})^{-1} \in \mathcal{H}(U_{k})(F(i'_{k}), j),
$$

and then lift

(4.14) 
$$
h'_{k_0,k_1} := h'^{-1}_{k_1} \circ h'_{k_0} \in \mathcal{H}(U_{k_0,k_1})(F(i'_{k_0}),F(i'_{k_1}))
$$

to

$$
g'_{k_0,k_1} := f_{k_1} \circ g_{k_0,k_1} \circ f_{k_0}^{-1} \in \mathcal{G}(U_{k_0,k_1})(i'_{k_0},i'_{k_1}).
$$

The resulting 2-cocycle  $c' = \{g'_{k_0, k_1, k_2}\}\$  defined as in [\(4.13\)](#page-21-0) will satisfy

$$
g'_{k_0,k_1,k_2} = f_{k_0}^{-1} \circ g_{k_0,k_1,k_2} \circ f_{k_0}.
$$

Because  $\mathcal N$  is central we get  $c' = c$ .

(d) Finally let's see what happens when we take a new open covering  $U' = \{U_k\}_{k \in K'}$ of *X*, for which we can construct a cocycle *c'*. Let  $\mathbf{V} = \{V_l\}_{l \in L}$  be a common refinement, namely there are functions  $\phi: L \to K$  and  $\phi': L \to K'$ , such that  $V_l \subset U_{\phi(l)}$  and  $V_l \subset U'_{\phi'(l)}$  for all  $l \in L$ . Let  $\phi^*(c)$  and  $\phi'^*(c')$  be the pullback 2cocycles on the open covering *V* . These are both cocycles that are constructed like in Construction [4.9,](#page-20-1) for the obvious choices of objects etc. By steps (a-c) we know that  $[\phi^*(c)] = [\phi'^*(c')]$ . But on the other hand  $[\phi^*(c)] = [c]$  and  $[\phi'^*(c')] = [c']$ .  $\square$ 

The lemma justifies the next definition.

<span id="page-22-0"></span>**Definition 4.15.** Let  $j \in \text{Ob } \mathcal{H}(X)$ . If there exists a 2-cocycle *c* as in Construction [4.9,](#page-20-1) for some open covering *U*, then we define the *obstruction class to lifting objects* to be

$$
\mathrm{cl}_F^2(j) := [c] \in \check{\mathrm{H}}^2(X, \mathcal{N}).
$$

Otherwise we say that this obstruction class is undefined.

In Section [5](#page-24-0) we shall see sufficient conditions for the obstruction class  $\mathrm{cl}_{F}^{2}(j)$  to be defined.

<span id="page-23-1"></span>**Proposition 4.16.** *Let*  $j \in \text{Ob } \mathcal{H}(X)$  *be such that the obstruction class*  $\text{cl}_F^2(j)$  *is defined. Suppose*  $j' \in \text{Ob } \mathcal{H}(X)$  *is such that*  $\mathcal{H}(X)(j, j') \neq \emptyset$ . Then the obstruction  $class \text{ } cl_F^2(j') \text{ is also defined, and moreover}$ 

$$
\mathrm{cl}_F^2(j') = \mathrm{cl}_F^2(j).
$$

What the proposition says is that two isomorphic objects have the same obstruction class.

*Proof.* We want to construct a Čech 2-cocycle  $c'$ , starting with  $j'$  instead of  $j$ . Take any  $f \in \mathcal{H}(X)(j, j')$ . Using this isomorphism we may define

$$
h'_{k} := f \circ h_{k} \in \mathcal{H}(U_{k})(F(i_{k}),j'),
$$

where  $i_k$  is the lifting of *j* that was used in the construction of *c*, and  $h_k \in$  $\mathcal{H}(U_k)(F(i_k), j)$  is the isomorphism that was chosen.

Let

$$
h'_{k_0,k_1} := h'^{-1}_{k_1} \circ h'_{k_0} \in \mathcal{H}(U_{k_0,k_1})(F(i_{k_0}), F(i_{k_1})).
$$

Then  $h'_{k_0,k_1} = h_{k_0,k_1}$ ; so continuing with Construction [4.9](#page-20-1) we get a cocycle  $c'$  that equals  $\overline{c}$ .

<span id="page-23-0"></span>**Theorem 4.17** (Obstruction to lifting objects)**.** *Consider a central extension of gerbes*

$$
1 \to \mathcal{N} \to \mathcal{G} \xrightarrow{F} \mathcal{H} \to 1.
$$

Let  $j \in \text{Ob } \mathcal{H}(X)$  be such that the obstruction class  $\text{cl}_F^2(j)$  is defined. Then there *exists an object*  $i \in \text{Ob } \mathcal{G}(X)$  *with* 

$$
\mathcal{H}(X)(F(i),j) \neq \emptyset
$$

*if and only if*

$$
\mathrm{cl}_F^2(j) = 1.
$$

What the theorem says is that  $\mathrm{cl}_F^2(j)$  is the obstruction to lifting *j* to an object of  $\mathcal{G}(X)$ .

*Proof.* Assume *j* lifts to an object  $i \in Ob \mathcal{G}(X)$ . So there exists some isomorphism  $h \in \mathcal{H}(X)(F(i), j)$ . In Construction [4.9](#page-20-1) we may choose  $i_k := i|_{U_k} \in \text{Ob } \mathcal{G}(U_k)$ . Having done so, we take

$$
h_k := h|_{U_k} \in \mathcal{H}(U_k)(F(i_k), j).
$$

Proceeding with the construction, we get

$$
h_{k_0,k_1} = 1 \in \mathcal{G}(U_{k_0,k_1})(F(i),F(i)),
$$

which can then be lifted to

$$
g_{k_0,k_1} = 1 \in \mathcal{G}(U_{k_0,k_1})(i,i).
$$

The resulting 2-cocycle  $c = \{g_{k_0, k_1, k_2}\}\$ is trivial.

Conversely, suppose  $cl_F^2(j) = 1$ . From construction [4.9](#page-20-1) and the choices made there we get a a 2-cocycle  $c = \{g_{k_0, k_1, k_2}\}\$  with values in  $\mathcal{N}$ , on some open covering *U*. By replacing *U* with a suitable refinement, we may assume it is a coboundary. Namely there is a 1-cochain  $b = \{f_{k_0,k_1}\}\$  with values in  $\mathcal{N}$ , such that  $c = d(b)$ .

Consider the isomorphisms

$$
g'_{k_0,k_1} := g_{k_0,k_1} \circ f_{k_0,k_1}^{-1} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0},i_{k_1}),
$$

where  $g_{k_0,k_1}$  are the isomorphisms chosen when constructing the cocycle  $c$ . Then  ${g'_{k_0,k_1}}$  is a 1-cocycle. Since **G** is a stack, the collection of objects  ${i_k}_{k \in K}$  can be glued. I.e. there is an object  $i \in \text{Ob } \mathcal{G}(X)$ , and isomorphisms  $g'_k \in \mathcal{G}(U_k)(i_k, i)$ , such that

Define

$$
g_{k_1}^{\prime -1} \circ g_{k_0}^{\prime} = g_{k_0,k_1}^{\prime}.
$$

$$
e_k := F(g'_k) \circ h_k^{-1} \in \mathcal{H}(U_k)(j, F(i)).
$$

Then one checks that

$$
e_{k_0}=e_{k_1}\in \mathcal{H}(U_{k_0,k_1})(j,F(i)).
$$

The sheaf property says that these glue to an isomorphism  $e \in \mathcal{H}(X)(j, F(i))$ .  $\Box$ 

**Remark 4.18.** If we were to use open hypercoverings in Construction [4.9,](#page-20-1) then the obstruction class  $\mathrm{cl}_F^2(j)$  would always be defined, as an element of  $\mathrm{H}^2(X,\mathcal{N})$ . However the technicalities involved in proving the corresponding version of Theorem [4.17](#page-23-0) would be enormous. Since Construction [4.9](#page-20-1) works in the cases that interest us, we chose to limit ourselves to this weaker approach.

**Remark 4.19.** L. Breen [private communication] proposed looking at the the central extension of gerbes  $(4.1)$  in the following way: **G** is a gerbe over  $\mathcal{H}$ , with band  $N$ . Perhaps this point of view can yield a stronger version of Theorem [4.17.](#page-23-0)

### <span id="page-24-0"></span>5. Sufficient Conditions for Existence of Obstruction Classes

Let  $\mathcal N$  be a sheaf of abelian groups on a topological space  $X$ . The operation in  $\mathcal N$  is multiplication. We denote by  $\mathrm H^i(X,\mathcal N)$  the derived functor sheaf cohomology. An open set  $U \subset X$  will be called N-acyclic if the sheaf cohomology satisfies  $H^{i}(U, \mathcal{N}) = 1$  for all  $i > 0$ . Now suppose  $U = \{U_{k}\}_{k \in K}$  is a collection of open sets in *X*. We say that the collection *U* is *N*-acyclic if all the open sets  $U_{k_0,\ldots,k_m}$  are  $\mathcal{N}$ -acyclic.

**Definition 5.1.** Let  $\mathcal N$  be a sheaf of abelian groups on  $X$ . We say that *there are enough*  $\mathcal{N}$ *-acyclic open coverings* if for any open set  $U \subset X$ , and any open covering *U* of *U*, there exists an  $N$ -acyclic open covering  $U'$  of *U* which refines  $U$ .

<span id="page-24-1"></span>**Example 5.2.** Suppose *X* is a differentiable (i.e.  $C^{\infty}$ ) manifold, and let  $\mathcal{O}_X$  be the sheaf of  $C^{\infty}$  R-valued functions on it. If N is an  $\mathcal{O}_X$ -module, then any open covering of *X* is  $\mathcal N$ -acyclic. If  $\mathcal K$  is a constant sheaf of abelian groups on *X*, then any open covering  $U = \{U_k\}_{k \in K}$  such that the finite intersections  $U_{k_0,\dots,k_m}$  are contractible, is K-acyclic. There are always enough coverings of this sort.

**Example 5.3.** Suppose *X* is a complex analytic manifold, and let  $\mathcal{O}_X$  be the sheaf of holomorphic C-valued functions on it. If  $\mathcal N$  is a coherent  $\mathcal O_X$ -module, then any open covering of  $X$  by Stein manifolds is  $\mathcal{N}$ -acyclic. There are always enough coverings of this sort. Regarding constant sheaves see the previous example. (Oddly, we do not know if it is possible to find an open covering  $U = \{U_k\}_{k \in K}$  such that the finite intersections  $U_{k_0,\ldots,k_m}$  are both contractible and Stein.)

<span id="page-25-3"></span>**Example 5.4.** Suppose X is an algebraic variety over a field  $\mathbb{K}$  (i.e. a separated integral finite type K-scheme), and let  $\mathcal{O}_X$  be the structure sheaf. If N is a coherent  $\mathcal{O}_X$ -module, then any affine open covering of *X* (i.e. a covering  $\mathbf{U} = \{U_k\}_{k \in K}$  such that the open sets  $U_k$  are all affine) is  $\mathcal{N}$ -acyclic. There are always enough coverings of this sort. If  $K$  is a constant sheaf of abelian groups on  $X$ , then any open covering of X is  $\mathcal K$ -acyclic (since  $\mathcal K$  is a flasque sheaf in the Zariski topology).

Recall that there are canonical group homomorphisms

$$
\check{H}^{i}(X, \mathcal{N}) \to H^{i}(X, \mathcal{N}),
$$

which are bijective for  $i = 0, 1$ ; see [\[Ha,](#page-35-10) Section III.4.].

<span id="page-25-2"></span>**Proposition 5.5.** Let  $N$  be a sheaf of abelian groups on  $X$ .

(1) If  $U$  is an  $N$ -acyclic open covering of X, then the canonical group homo*morphisms*

$$
\check{\mathrm{H}}^i(U,\mathcal{N}) \to \mathrm{H}^i(X,\mathcal{N})
$$

*are bijective for all i.*

(2) *If there are enough* N *-acyclic open coverings, then for any* N *-acyclic open covering U of X, the canonical group homomorphisms*

$$
\check{H}^i(U, \mathcal{N}) \to \check{H}^i(X, \mathcal{N}) \to H^i(X, \mathcal{N})
$$

*are bijective for all i.*

*Proof.* Assertion (1) is [\[Ha,](#page-35-10) Exercise III.4.11]. Assertion (2) follows from (1). See also the original [\[Gr2\]](#page-35-11).  $\Box$ 

From now on in this section, the operation in the group  $\mathcal N$  is multiplication, and the identity element is 1.

<span id="page-25-1"></span>**Proposition 5.6.** *Suppose*

(5.7)  $1 \rightarrow \mathcal{N} \rightarrow \mathcal{G} \rightarrow \mathcal{H} \rightarrow 1$ 

*is an exact sequence of sheaves of groups on X.*

(1) *There is an exact sequence in Čech cohomology*

<span id="page-25-0"></span>
$$
1 \to \mathcal{N}(X) \to \mathcal{G}(X) \to \mathcal{H}(X)
$$

$$
\to \check{H}^1(X, \mathcal{N}) \to \check{H}^1(X, \mathcal{G}) \to \check{H}^1(X, \mathcal{H}).
$$

*Here*  $\check{H}^1(X, -)$  *are pointed sets.* 

(2) *Assume* [\(5.7\)](#page-25-0) *is a central extension, and there are enough* N *-acyclic open coverings. Then the exact sequence of part* (1) *extends to an exact sequence*

$$
\cdots \to \check{H}^1(X, \mathcal{G}) \to \check{H}^1(X, \mathcal{H}) \xrightarrow{\partial} \check{H}^2(X, \mathcal{N}).
$$

*Proof.* (1) This is pretty easy. A readable proof can be found in [\[Gr1,](#page-35-12) Chapter V].

(2) A more general result is [\[Gr2,](#page-35-11) Corollaire to Proposition 3.4.2], where there is no topological assumption of the sheaf  $N$ . However, the precise statement and the proof rely on Godement resolutions, and are hard to follow. Hence we provide a relatively easy proof in the case we need.

Recall that the pointed set  $\check{H}^1(X, \mathcal{H})$  classifies left *H*-torsors on *X*, up to isomorphism. And the function  $\check{H}^1(X, \mathcal{G}) \to \check{H}^1(X, \mathcal{H})$  sends a  $\mathcal{G}\text{-torsor to the induced}$ H-torsor.

Let S be an H-torsor. Choose an N-acyclic open covering  $U = \{U_k\}_{k \in K}$  of X that trivializes S. For any index *k* choose some  $s_k \in S(U_k)$ . For any  $k_0, k_1$  we have an element  $h_{k_0,k_1} \in \mathcal{H}(U_{k_0,k_1})$  such that  $s_{k_1} = h_{k_0,k_1} \cdot s_{k_0}$ . Since  $\check{H}^1(U_{k_0,k_1}, \mathcal{N}) = 1$ , by part (1) we have a surjection of groups  $\mathcal{G}(U_{k_0,k_1}) \to \mathcal{H}(U_{k_0,k_1})$ , and thus we can lift  $h_{k_0, k_1}$  to some  $g_{k_0, k_1} \in \mathcal{G}(U_{k_0, k_1})$ . Define

$$
n_{k_0,k_1,k_2} := g_{k_0,k_2}^{-1} \circ g_{k_1,k_2} \circ g_{k_0,k_1} \in \mathcal{G}(U_{k_0,k_1,k_2}).
$$

Then

$$
c:=\{n_{k_0,k_1,k_2}\}_{k_0,k_1,k_2\in K}
$$

is a Čech 2-cocycle with values in  $\mathcal{N}$ ; cf. Lemma [4.11.](#page-21-1) Let

$$
\partial(\mathcal{S}) := [c] \in \check{H}^2(X, \mathcal{N}).
$$

As in the proof of Lemma [4.12](#page-21-2) we see that the cohomology class  $\partial(\mathcal{S})$  is independent of choices, and thus we get a well defined function

<span id="page-26-1"></span>
$$
\partial: \check{H}^1(X, \mathcal{H}) \to \check{H}^2(X, \mathcal{N}).
$$

And like in the proof of Theorem [4.17](#page-23-0) we see that  $\partial(\mathcal{S}) = 1$  if and only if S comes from a  $\mathcal{G}\text{-torsor.}$ 

Consider a central extension of gerbes

(5.8) 
$$
1 \rightarrow \mathcal{N} \rightarrow \mathcal{G} \xrightarrow{F} \mathcal{H} \rightarrow 1
$$

on *X*.

<span id="page-26-0"></span>**Lemma 5.9.** *Suppose U is an*  $\mathcal{N}$ *-acyclic open set.* Let  $i, j \in \mathrm{Ob}\mathcal{G}(U)$  *be such that*  $\mathcal{G}(U)(i, j) \neq \emptyset$ . Then the function

$$
F: \mathcal{G}(U)(i,j) \to \mathcal{H}(U)\bigl(F(i), F(j)\bigr)
$$

*is surjective.*

*Proof.* Here both torsors  $\mathcal{G}(i, j)$  and  $\mathcal{H}(F(i), F(j))$  are trivial over the respective sheaves of groups  $\mathcal{G}(i, i)$  and  $\mathcal{H}(F(i), F(i))$ ; so we may assume  $i = j$ . Since  $\check{H}^{1}(U, \mathcal{N}) = 1$  the assertion follows from the exact sequence in Proposition [5.6\(](#page-25-1)1), applied to the short exact sequence of sheaves of groups

$$
1 \to \mathcal{N}|_U \to \mathcal{G}(i,i) \xrightarrow{F} \mathcal{H}(i,i) \to 1.
$$

 $\Box$ 

<span id="page-26-2"></span>**Lemma 5.10.** *Suppose U is an*  $N$ -*acyclic open set. Then for any*  $i, j \in \text{Ob } \mathcal{G}(U)$ *the function*

$$
F(i,j): \mathcal{G}(U)(i,j) \to \mathcal{H}(U)\bigl(F(i), F(j)\bigr)
$$

*is surjective.*

*Proof.* If  $\mathcal{H}(U)(F(i), F(j)) = \emptyset$  then there is nothing to prove. So let us assume it is nonempty. We will prove that  $\mathcal{G}(U)(i,j) \neq \emptyset$ ; and then the assertion will follow by Lemma [5.9.](#page-26-0)

Choose some  $h \in \mathcal{H}(U)(F(i), F(j))$ . Let  $\mathbf{U} = \{U_k\}_{k \in K}$  be an open covering of *U*, such that for any *k* there exists an isomorphism  $g_k \in \mathcal{G}(U_k)(i,j)$  lifting *h*. This can be done. Now for  $k_0, k_1 \in K$  define

$$
g_{k_0,k_1} := g_{k_1}^{-1} \circ g_{k_0} \in \mathcal{G}(U_{k_0,k_1})(i,j).
$$

Since  $F(g_{k_0,k_1}) = 1$  we see that in fact

$$
g_{k_0,k_1} \in \mathcal{N}(U_{k_0,k_1}).
$$

An easy calculation shows that the Čech 1-cochain  ${g_{k_0,k_1}}_{k_0,k_1\in K}$  is a cocycle. Since  $\check{H}^1(U, \mathcal{N}) = 1$ , after possibly replacing *U* with a refinement, we can find a 0-cochain  ${f_k}_{k \in K}$  such that  $g_{k_0, k_1} = f_{k_1}^{-1} \circ f_{k_0}$ . Define

$$
g'_k := g_k \circ f_k^{-1} \in \mathcal{G}(U_k)(i,j).
$$

Then the 0-cochain  $\{g'_k\}_{k\in K}$  is a cocycle with values in the sheaf of sets  $\mathcal{G}(i, j)$ . From the sheaf property it follows that there is an element  $g' \in \mathcal{G}(U)(i,j)$  such that  $g'|_{U_k} = g'_k$  for all *k*. We see that  $\mathcal{G}(U)(i,j) \neq \emptyset$ .

<span id="page-27-2"></span>**Theorem 5.11.** *Consider the central extension of gerbes* [\(5.8\)](#page-26-1)*. If there are enough*  $\mathcal{N}$ -acyclic open coverings, then the obstruction class  $\mathrm{cl}_{F}^{2}(j)$  from Definition [4.15](#page-22-0) *exists, for any*  $j \in \text{Ob } \mathcal{H}(X)$ *.* 

*Proof.* Since the morphism of gerbes F is locally surjective on objects, we can find an open covering  $\mathbf{U} = \{U_k\}_{k \in K}$  of X, and objects  $i_k \in \text{Ob } \mathcal{G}(U_k)$  that lift  $j|_{U_k}$ . By refining it we can assume that  $U$  is  $N$ -acyclic. According to Lemma [5.10](#page-26-2) there exist elements  $g_{k_0,k_1}$  that lift the elements  $h_{k_0,k_1}$ , in the notation of Construction [4.9.](#page-20-1)

Now suppose we are given a morphism of central extensions of gerbes

(5.12) 
$$
1 \longrightarrow \mathcal{N} \longrightarrow \mathcal{G} \xrightarrow{F} \mathcal{H} \longrightarrow 1
$$

$$
\downarrow \qquad D \downarrow \qquad E \downarrow
$$

$$
1 \longrightarrow \mathcal{N}' \longrightarrow \mathcal{G}' \xrightarrow{F'} \mathcal{H}' \longrightarrow 1
$$

There is a homomorphism of sheaves of abelian groups  $D: \mathcal{N} \to \mathcal{N}'$ , and an induced homomorphism

<span id="page-27-0"></span>
$$
D: \check{H}^2(X, \mathcal{N}) \to \check{H}^2(X, \mathcal{N}').
$$

<span id="page-27-1"></span>**Proposition 5.13.** *Consider the morphism of central extension of gerbes* [\(5.12\)](#page-27-0)*.*

(1) Let  $j$  ∈ Ob  $\mathcal{H}(X)$  be such that the obstruction class  $cl_F^2(j)$  is defined, and  $let \, j' := E(j) \in Ob \, \mathcal{H}'(X)$ . Then the obstruction class  $\text{cl}_{F'}^2(j')$  is also *defined, and moreover*

$$
\mathrm{cl}_{F'}^2(j') = D\big(\mathrm{cl}_F^2(j)\big)
$$

 $in \ H^2(X, \mathcal{N}')$ .

(2) Let  $i, j \in \text{Ob } \mathcal{G}(X)$  and let  $h \in \mathcal{H}(X)(F(i), F(j))$ . We write  $i' := D(i)$  and  $j' := D(j)$  *for the corresponding objects of*  $\mathcal{G}'(X)$ *, and*  $h' := E(h)$  *for the corresponding isomorphism*  $i' \rightarrow j'$ . Then

$$
\mathrm{cl}_{F'}^1(h') = D\big(\mathrm{cl}_F^1(h)\big)
$$

 $in \ H^1(X, \mathcal{N}')$ .

*Proof.* Take the choices made in constructing the class  $\mathrm{cl}_F^2(j)$  or  $\mathrm{cl}_F^1(h)$ , as the case may be, and use the same open covering, and the images under *D, F* of the elements, to construct the class  $\mathrm{cl}_{F'}^2(j')$  or  $\mathrm{cl}_{F'}^1(h'')$  $\Box$ 

**Corollary 5.14.** *Consider the morphism of central extension of gerbes* [\(5.12\)](#page-27-0)*. Assume that E is an equivalence, and that there are enough*  $N$ *-acyclic open coverings. Then the obstruction class*  $cl_{F'}^2(j')$  *is defined for any*  $j' \in Ob \mathcal{H}'(X)$ .

<span id="page-28-0"></span>*Proof.* There is some  $j \in \mathrm{Ob}\,\mathcal{H}(X)$  such that  $\mathcal{H}'(X)(j', E(j)) \neq \emptyset$ . Now use Propositions [5.13\(](#page-27-1)1) and [4.16.](#page-23-1)

### 6. Pronilpotent Gerbes

Let *X* be a topological space. Recall that given an inverse system  $\{\mathcal{G}_p\}_{p\in\mathbb{N}}$  of sheaves of groups on *X*, its inverse limit is the sheaf of groups  $\lim_{x\to p} \mathcal{G}_p$  whose group of sections on an open set *U* is

$$
\Gamma(U, \lim_{\leftarrow p} \mathcal{G}_p) = \lim_{\leftarrow p} \Gamma(U, \mathcal{G}_p).
$$

<span id="page-28-2"></span>**Definition 6.1.** Let  $\mathcal G$  be a sheaf of groups on  $X$ .

- (1) A *normal filtration* of G is a descending sequence  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  of sheaves of normal subgroups of  $\mathcal{G}$ .
- (2) A *central filtration* of G is a normal filtration  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$ , such that  $\mathcal{N}_0 = \mathcal{G}$ ,  $\bigcap_{p} \mathcal{N}_p = 1$ , and for every *p* the extension of sheaves of groups

$$
1 \to \mathcal{N}_p/\mathcal{N}_{p+1} \to \mathcal{G}/\mathcal{N}_{p+1} \to \mathcal{G}/\mathcal{N}_p \to 1
$$

is central.

(3) Let  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  be a normal filtration of G. We say that G is *complete* with respect to this filtration if the canonical homomorphism of sheaves of groups

$$
\mathcal{G}\to \lim_{\leftarrow p}\,\mathcal{G}/\mathcal{N}_p
$$

is an isomorphism.

(4) If G is complete with respect to some central filtration, then we call it a *pronilpotent sheaf of groups*.

Note that when  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  is a central filtration, then each  $\mathcal{N}_p/\mathcal{N}_{p+1}$  is a sheaf of abelian groups.

<span id="page-28-1"></span>**Definition 6.2.** Let G be a sheaf of groups on X, with central filtration  $\{N_p\}_{p \in \mathbb{N}}$ . An open set  $U \subset X$  is called *acyclic* with respect to  $\{\mathcal{N}_p\}_{p \in \mathbb{N}}$  if the following two conditions hold.

- (i) For every  $p \geq 0$  and  $i > 0$  the sheaf cohomology group  $H^{i}(U, \mathcal{N}_p/\mathcal{N}_{p+1})$  is trivial.
- (ii) For every  $q \geq p \geq 0$  the canonical group homomorphism

$$
\Gamma(U, \mathcal{N}_p) \to \Gamma(U, \mathcal{N}_p/\mathcal{N}_q)
$$

is surjective.

<span id="page-28-3"></span>**Lemma 6.3.** *Let*  $\{N_p\}_{p \in \mathbb{N}}$  *be a central filtration of the sheaf of groups*  $\mathcal{G}$ *. Suppose that* G *is complete with respect to the filtration*  $\{N_p\}_{p \in \mathbb{N}}$ *, and the open set*  $U \subset X$ *is acyclic with respect to*  $\{N_p\}_{p \in \mathbb{N}}$ *. Let*  $G := \Gamma(U, \mathcal{G})$  *and*  $N_p := \Gamma(U, \mathcal{N}_p)$ *. Then*  $G$ *is complete with respect to the filtration*  $\{N_p\}_{p \in \mathbb{N}}$ .

*Proof.* Condition (ii) of Definition [6.2,](#page-28-1) combined with Proposition [5.6\(](#page-25-1)1), say that for every *p* there is an exact sequence of groups

$$
1 \to N_p \to G \to \Gamma(U, \mathcal{G}/\mathcal{N}_p) \to 1.
$$

Now use Definition [6.1\(](#page-28-2)3).  $\Box$

In the situation above the filtration  $\{N_p\}_{p\in\mathbb{N}}$  of *G* is separated. Therefore it defines a metric topology on *G*, say by letting  $N_p \cdot g = g \cdot N_p$  be the ball of radius  $2^{-p}$  around the point *g* ∈ *G* (cf. [\[CA,](#page-35-13) Section III.5]). The condition that  $G \cong \lim_{\leftarrow p} G/N_p$  translates to *G* being a complete metric space.

**Definition 6.4.** Let G be a sheaf of groups on X, with central filtration  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$ .

- (1) A collection  $U = \{U_k\}_{k \in K}$  of open sets of X is called *acyclic* with respect to  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  if every finite intersection  $U_{k_0,\dots,k_m}$  is acyclic with respect to  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$ , in the sense of Definition [6.2.](#page-28-1)
- (2) We say that there are *enough acyclic coverings* with respect to  $\{N_p\}_{p\in\mathbb{N}}$  if every open covering *U* of an open set  $U \subset X$  admits a refinement  $U'$  which is acyclic with respect to  $\{\mathcal{N}_n\}_{n\in\mathbb{N}}$ .

Now we move to gerbes. Let  $\mathcal G$  be a gerbe on  $X$ . The notion of normal subgroupoid  $\mathcal{N} \subset \mathcal{G}$  was introduced in Definition [3.6.](#page-13-1)

<span id="page-29-0"></span>**Definition 6.5.** Let  $\mathcal{G}$  be a gerbe on  $X$ .

- (1) A *normal filtration* of **G** is a descending sequence  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  of normal subgroupoids of **G**.
- (2) A *central filtration* of **G** is a normal filtration  $\{\mathcal{N}_p\}_{p \in \mathbb{N}}$ , such that for every local object *i* of **G**, the filtration  $\{\mathcal{N}_p(i,i)\}_{p \in \mathbb{N}}$  of the sheaf of groups  $\mathcal{G}(i,i)$ is central.
- (3) Let  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  be a normal filtration of **G**. We say that **G** is *complete* with respect to this filtration if for every local object *i* of  $\mathcal{G}$ , the sheaf  $\mathcal{G}(i, i)$  is complete with respect to the filtration  ${\mathcal{N}_p(i,i)}_{p\in\mathbb{N}}$ .
- (4) If **G** is complete with respect to some central filtration, then we call it a *pronilpotent gerbe*.

**Proposition 6.6.** *Suppose*  $\{\mathcal{N}_p\}_{p \in \mathbb{N}}$  *is a central filtration of the gerbe*  $\mathcal{G}$ *. Then for every p there is a central extension of gerbes*

<span id="page-29-1"></span>(6.7) 
$$
1 \rightarrow \mathcal{N}_p/\mathcal{N}_{p+1} \rightarrow \mathcal{G}/\mathcal{N}_{p+1} \stackrel{F}{\rightarrow} \mathcal{G}/\mathcal{N}_p \rightarrow 1.
$$

*Proof.* Use Theorem [3.13.](#page-14-0) □

Observe that  $\mathcal{N}_p/\mathcal{N}_{p+1}$  is a central subgroupoid of the gerbe  $\mathcal{G}/\mathcal{N}_{p+1}$ ; so  $\mathcal{N}_p/\mathcal{N}_{p+1}$  can be regarded as a sheaf of abelian groups on *X*. See Proposition [3.19.](#page-17-2)

**Definition 6.8.** Let **G** be a gerbe on *X*, with central filtration  $\{\mathcal{N}_p\}_{p \in \mathbb{N}}$ . An open set  $U \subset X$  is called *acyclic* with respect to  $\{\mathcal{N}_p\}_{p \in \mathbb{N}}$  if the following two condition hold:

- (i) The groupoid  $\mathcal{G}(U)$  is nonempty.
- (ii) For every  $i \in \text{Ob } \mathcal{G}(U)$ , the set *U* is acyclic with respect to the central filtration  $\{\mathcal{N}_p(i,i)\}_{p\in\mathbb{N}}$  of the sheaf of groups  $\mathcal{G}(i,i)$ .

**Definition 6.9.** Let **G** be a gerbe on *X*, with central filtration  ${\mathcal{N}}_p{}_{p \in \mathbb{N}}$ .

- (1) A collection  $U = \{U_k\}_{k \in K}$  of open sets of X is called *acyclic* with respect to  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$  if every finite intersection  $U_{k_0,\dots,k_m}$  is acyclic with respect to  $\{{\boldsymbol{\mathcal N}}_p\}_{p\in\mathbb N}.$
- (2) We say that there are *enough acyclic coverings* with respect to  ${\{\mathcal{N}_p\}}_{p\in\mathbb{N}}$  if every open covering  $U$  of an open set  $U$  admits a refinement  $U'$  which is acyclic with respect to  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$ .

Suppose **G** is a gerbe, complete with respect to a central filtration  $\{\mathcal{N}_p\}_{p\in\mathbb{N}}$ . Let *U* be an open set of *X* which is acyclic with respect to  ${\{\mathcal{N}_p\}}_{p\in\mathbb{N}}$ , and let *i* be an object of the groupoid  $\mathcal{G}(U)$ . By Lemma [6.3](#page-28-3) the group  $\mathcal{G}(U)(i,i)$  is complete with respect to the filtration  $\{\mathcal{N}_p(U)(i,i)\}_{p \in \mathbb{N}}$ ; so  $\mathcal{G}(U)(i,i)$  is a complete metric space. Now let *j* be another object of  $\mathcal{G}(U)$ , and suppose  $\mathcal{G}(U)(i, j) \neq \emptyset$ . Then the set  $\mathcal{G}(U)(i,j)$  is a  $\mathcal{G}(U)(j,j)$ - $\mathcal{G}(U)(i,i)$ -bitorsor. One can introduce a metric topology on this set, by letting

$$
g \circ \mathcal{N}_p(U)(i,i) = \mathcal{N}_p(U)(j,j) \circ g
$$

be the ball of radius  $2^{-p}$  around  $g \in \mathcal{G}(U)(i, j)$ . For any such g the function  $h \mapsto g \cdot h$ is an isomorphism of metric spaces  $\mathcal{G}(U)(i,i) \stackrel{\simeq}{\to} \mathcal{G}(U)(i,j)$ ; and hence  $\mathcal{G}(U)(i,j)$ is complete.

<span id="page-30-0"></span>**Theorem 6.10.** Let **G** be a gerbe on the topological space X, and let  $\{N_p\}_{p \in \mathbb{N}}$  be *a central filtration on it. Assume that* **G** *is complete with respect to*  $\{N_p\}_{p \in \mathbb{N}}$ *, and that there are enough acyclic coverings with respect to*  ${\mathcal{N}_p}_{p \in \mathbb{N}}$ *. Let U be some open set of X.*

- (1) If  $H^1(U, \mathcal{N}_p/\mathcal{N}_{p+1}) = 1$  for every  $p \geq 0$ , then the groupoid  $\mathcal{G}(U)$  is con*nected.*
- (2) If  $H^2(U, \mathcal{N}_p/\mathcal{N}_{p+1}) = 1$  for every  $p \geq 0$ , then the groupoid  $\mathcal{G}(U)$  is *nonempty.*

*Proof.* (1) This is very similar to Theorem [4.6.](#page-20-0) Given  $i, j \in Ob \mathcal{G}(U)$ , we must show that  $\mathcal{G}(U)(i,j) \neq \emptyset$ .

Since **G** is locally connected, we can find an open covering  $U = \{U_k\}_{k \in K}$  of *U* such that  $\mathcal{G}(U_k)(i,j) \neq \emptyset$  for any  $k \in K$ . By refining *U*, we can assume that it is acyclic with respect to  ${\{\mathcal{N}_p\}}_{p\in\mathbb{N}}$ . For each  $k \in K$  let us choose an element  $g_{k;0} \in \mathcal{G}(U_k)(i,j)$ . We are going to construct new elements  $g_{k;p} \in \mathcal{G}(U_k)(i,j)$ , for all  $k \in K$  and  $p \in \mathbb{N}$ , satisfying these conditions:

- $(g_k, g_{k;p+1} \in g_{k;p} \circ \mathcal{N}_p(U_k)(i,i)).$
- (b)  $g_{k_1,p}^{-1} \circ g_{k_0,p} \in \mathcal{N}_p(U_{k_0,k_1})(i,i)$  for any  $k_0, k_1 \in K$ .

The construction is by recursion on *p*.

For  $p = 0$  the elements  $g_{k,0}$  are already given. So let  $p \ge 0$ , and assume that we have elements  $g_{k;p'}$  for  $p' \leq p$ , satisfying conditions (a)-(b). Let us denote by  $\bar{g}_{k;p} \in (\mathcal{G}/\mathcal{N}_{p+1})(U_k)(i,j)$  the image of  $g_{k;p}$ , and define

$$
\bar{g}_{k_0,k_1;p} := \bar{g}_{k_1;p}^{-1} \circ \bar{g}_{k_0;p} \in (\mathcal{G}/\mathcal{N}_{p+1})(U_{k_0,k_1})(i,i)
$$

for  $k_0, k_1 \in K$ . Consider the central extension of gerbes [\(6.7\)](#page-29-1). By condition (b) we have  $F(\bar{g}_{k_0,k_1;p}) = 1$ ; so

$$
\bar{g}_{k_0,k_1;p}\in (\mathcal{N}_p/\mathcal{N}_{p+1})(U_{k_0,k_1})(i,i).
$$

We get a Čech 1-cocycle  $c := \{\bar{g}_{k_0,k_1;p}\}_{k_0,k_1\in K}$  with values in the sheaf  $\mathcal{N}_p/\mathcal{N}_{p+1}$ . According to the assumptions and Proposition [5.5\(](#page-25-2)1), we have

$$
\check{\mathrm{H}}^1(\boldsymbol{U},\boldsymbol{\mathcal{N}}_p/\boldsymbol{\mathcal{N}}_{p+1})\cong \mathrm{H}^1(U,\boldsymbol{\mathcal{N}}_p/\boldsymbol{\mathcal{N}}_{p+1})=1.
$$

Hence there is a 0-cochain  $b = {\bar{f}_k}_{k \in K}$  such that  $c = d(b)$ , where d is the Čech coboundary. By condition (ii) of Definition [6.2](#page-28-1) the homomorphism

$$
\mathcal{N}_p(U_k)(i,i) \to (\mathcal{N}_p/\mathcal{N}_{p+1})(U_k)(i,i)
$$

is surjective, so we can lift  $\bar{f}_k$  to an element  $f_k \in \mathcal{N}_p(U_k)(i)$ . Let us define

$$
g_{k;p+1} := g_{k;p} \cdot f_k^{-1}.
$$

Then conditions (a)-(b) are satisfied.

We know that the set  $\mathcal{G}(U_k)(i,j)$  is a complete metric space. Condition (a) says that  ${g_{k;p}}_{p \in \mathbb{N}}$  is a Cauchy sequence. Let

$$
g_k := \lim_{p \to \infty} g_{k;p} \in \mathcal{G}(U_k)(i,j).
$$

Condition (b) now says that  ${g_k}_{k \in K}$  is a 1-cocycle. By descent for morphisms there is an element  $g \in \mathcal{G}(U)(i, j)$  such that  $g|_{U_k} = g_k$ .

(2) This is like Theorem [4.17.](#page-23-0) Since  $\mathcal G$  is locally nonempty, there is an open covering  $U = \{U_k\}_{k \in K}$  of *U* such that all the groupoids  $\mathcal{G}(U_k)$  are nonempty. By refining *U* we may assume it is acyclic with respect to  ${\{\mathcal{N}_p\}}_{p \in \mathbb{N}}$ . Let's choose some  $i_k \in$ Ob  $\mathcal{G}(U_k)$ . For any  $k_0, k_1 \in K$ , and any  $p \in \mathbb{N}$ , we have  $H^1(U_{k_0, k_1}, \mathcal{N}_p/\mathcal{N}_{p+1}) = 1$ . According to part (1) of the theorem, applied to the open set  $U_{k_0,k_1}$ , the groupoid  $\mathcal{G}(U_{k_0,k_1})$  is connected. Let us choose some element  $g_{k_0,k_1;0} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0},i_{k_1}).$ 

Using recursion on *p* we shall construct elements  $g_{k_0,k_1;p} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0},i_{k_1})$ satisfying these conditions:

(a) 
$$
g_{k_0,k_1;p+1} \in g_{k_0,k_1;p} \circ \mathcal{N}_p(U_{k_0,k_1})(i_{k_0}, i_{k_0}).
$$
  
\n(b)  $g_{k_0,k_2;p}^{-1} \circ g_{k_1,k_2;p} \circ g_{k_0,k_1;p} \in \mathcal{N}_p(U_{k_0,k_1,k_2})(i_{k_0}, i_{k_0})$  for any  $k_0, k_1, k_2 \in K$ .

For  $p = 0$  the elements  $g_{k_0, k_1;0}$  are already given. So let  $p \ge 0$ , and assume that we have elements  $g_{k_0,k_1;p'}$  for  $p' \leq p$ , satisfying conditions (a)-(b). Let us denote by

$$
\bar{g}_{k_0,k_1;p}\in({\mathcal G}/{\mathcal N}_{p+1})(U_{k_0,k_1})(i_{k_0},i_{k_1})
$$

the image of  $g_{k_0,k_1;p}$ , and define

$$
\bar{g}_{k_0,k_1,k_2;p} := \bar{g}_{k_0,k_2;p}^{-1} \circ \bar{g}_{k_1,k_2;p} \circ \bar{g}_{k_0,k_1;p} \in (\mathcal{G}/\mathcal{N}_{p+1})(U_{k_0,k_1,k_2})(i_{k_0},i_{k_0}).
$$

Consider the central extension of gerbes [\(6.7\)](#page-29-1). By condition (b) we have  $F(\bar{g}_{k_0,k_1,k_2;p}) = 1$ ; so

$$
\bar{g}_{k_0,k_1,k_2;p} \in (\mathcal{N}_p/\mathcal{N}_{p+1})(U_{k_0,k_1,k_2})(i_{k_0},i_{k_0}).
$$

Lemma [4.11](#page-21-1) says that  $c := \{\bar{g}_{k_0, k_1, k_2; p}\}\$  is a Čech 2-cocycle.

According to the assumptions and Proposition [5.5\(](#page-25-2)1), we have

$$
\check{\mathrm{H}}^{2}(\boldsymbol{U},\boldsymbol{\mathcal{N}}_{p}/\boldsymbol{\mathcal{N}}_{p+1})\cong \mathrm{H}^{2}(U,\boldsymbol{\mathcal{N}}_{p}/\boldsymbol{\mathcal{N}}_{p+1})=1.
$$

Hence there is a 1-cochain  $b = \{\bar{f}_{k_0,k_1}\}\$  such that  $c = d(b)$ . As before, we can lift  $\bar{f}_{k_0,k_1}$  to an element  $f_{k_0,k_1} \in \mathcal{N}_p(U_{k_0,k_1})(i_{k_0},i_{k_0})$ . Let us define

$$
g_{k_0,k_1;p+1} := g_{k_0,k_1;p} \circ f_{k_0,k_1}^{-1}.
$$

Then conditions (a)-(b) are satisfied.

As in the proof of part (1), let

$$
g_{k_0,k_1} := \lim_{p \to \infty} g_{k_0,k_1;p} \in \mathcal{G}(U_{k_0,k_1})(i_{k_0},i_{k_1}).
$$

Condition (b) says that  ${g_{k_0, k_1}}_{k_0, k_1 \in K}$  is a 2-cocycle. By descent for objects there is an object  $i \in \text{Ob } \mathcal{G}(U)$ .

#### <span id="page-32-2"></span>7. Fake Global Objects of Gerbes

<span id="page-32-0"></span>In this section  $X$  is some topological space. We will study a gerbe  $\mathcal{G}$  on  $X$ , with center  $Z(\mathcal{G})$ , and the central extension of gerbes

(7.1) 
$$
1 \to Z(\mathcal{G}) \to \mathcal{G} \xrightarrow{F} \mathcal{G}/Z(\mathcal{G}) \to 1.
$$

**Definition 7.2.** An object  $i \in Ob \left( \mathcal{G}/\mathbb{Z}(\mathcal{G}) \right) (X)$  is called a *fake global object of*  $\mathcal{G}$ .

When we need to emphasize that  $i \in \mathrm{Ob}\mathcal{G}(X)$ , as opposed to being in  $\mathrm{Ob}(\mathcal{G}/\mathrm{Z}(\mathcal{G}))(X)$ , we will say that *i* is a *true global object of*  $\mathcal{G}$ .

Note that some fake global objects *i* of **G** will lift to true global objects of **G**, whereas other won't; this is determined by the vanishing of the obstruction class

$$
\mathrm{cl}_F^2(i) \in \check{\mathrm{H}}^2\big(X,\mathrm{Z}(\mathcal{G})\big)
$$

for the central extension of gerbes [\(7.1\)](#page-32-2), if this obstruction class is defined.

Here is an easy example of a fake global object that does not lift.

<span id="page-32-3"></span>**Example 7.3.** Suppose *X* is an algebraic variety over a field, with  $H^2(X, \mathcal{O}_X) \neq 0$ . Choose a nonzero cohomology class  $c \in H^2(X, \mathcal{O}_X)$ . There is an abelian gerbe  $\mathcal G$ corresponding to *c*, and it has no global objects. (This construction is standard; cf. Example [7.7](#page-33-0) below.) Indeed, here the gerbe  $\mathcal{G}/Z(\mathcal{G})$  is equivalent to the gerbe  $\mathcal{I}$ from Example [2.3,](#page-10-0) and hence it has one global object (up to isomorphism), say *j*. We have a central extension of gerbes

$$
1 \to \mathcal{O}_X \to \mathcal{G} \xrightarrow{F} \mathcal{G}/\mathrm{Z}(\mathcal{G}) \to 1,
$$

and the obstruction class to lifting *j* to an object of  $\mathcal{G}(X)$  is  $\text{cl}_{F}^{2}(j) = c$ . We see that  $j$  is a fake global object of  $\mathcal{G}$ , which does not lift to a true global object of  $\mathcal{G}$ .

<span id="page-32-1"></span>**Remark 7.4.** The reason we are interested in fake global objects has to do with *twisted deformations*. Let K be a field of characteristic 0, and consider the ring of formal power series  $\mathbb{K}[[\hbar]]$  in the variable  $\hbar$ . Let  $(X, \mathcal{O}_X)$  be a ringed space over K, as in Examples [5.2-](#page-24-1)[5.4.](#page-25-3) As explained in [\[Ye\]](#page-35-0), a twisted (Poisson or associative)  $\mathbb{K}[[\hbar]]$ -deformation **A** of  $\mathcal{O}_X$  is made up of many locally defined sheaves of (Poisson or associative)  $\mathbb{K}[[\hbar]]$ -algebras  $\mathcal{A}_i$ , that are glued together by isomorphisms  $\text{Ad}(g)$ :  $A_i \stackrel{\simeq}{\to} A_j$ , called *gauge equivalences*. The indices *i, j,...* are local objects of the *gauge gerbe*  $\mathcal{G}$  of  $\mathcal{A}$ , and the isomorphisms  $g$  are local sections of the bitorsors  $\mathcal{G}(i, j)$ . The group  $\mathcal{G}(i, i)$ , for a local object *i*, is by definition  $\exp(\hbar \mathcal{A}_i)$ , where  $\mathcal{A}_i$  is viewed as a pronilpotent  $\mathbb{K}[[\hbar]]$ -linear Lie algebra, with Lie bracket being either its Poisson bracket or the commutator of the associative multiplication. The deformations  $A_i$ , for  $i \in \text{Ob } \mathcal{G}(X)$ , are called *global deformations belonging to* **A**. In case such global deformations do not exist (i.e. the gerbe  $\mathcal G$  is nontrivial), then we say  $\mathcal A$  is *really twisted*. Note that the gerbe  $\mathcal G$  is pronilpotent.

Now consider a global deformation  $A$  of the following sort: there is an open cov- $\lim_{k \to \infty} X = \bigcup_{k \in K} U_k$ , objects  $i_k \in \text{Ob } \mathcal{G}(U_k)$ , and gauge equivalences  $h_k : A|_{U_k} \xrightarrow{\simeq} A$  $A_{i_k}$ , such that

$$
h_{k_1}\circ h_{k_0}^{-1}=\mathrm{Ad}(g_{k_0,k_1})
$$

for some  $g_{k_0,k_1} \in \mathcal{G}(U_k)(i,i)$ . So as gauge equivalences  $\mathcal{A}_{i_{k_0}} \xrightarrow{\simeq} \mathcal{A}_{i_{k_2}}$  we have the equality

$$
Ad(g_{k_0,k_2}) = Ad(g_{k_1,k_2}) \circ Ad(g_{k_0,k_1}).
$$

The local isomorphisms g in the center  $Z(\mathcal{G}(i,i))$  are precisely those such that the gauge equivalences  $\text{Ad}(g)$  are trivial. Hence, going to the extension of gerbes [\(7.1\)](#page-32-2), we have

$$
F(g_{k_0,k_2}) = F(g_{k_1,k_2}) \circ F(g_{k_0,k_1})
$$

in the gerbe  $G/Z(G)$ . This implies that the global deformation A corresponds to an object  $j \in Ob(g/Z(\mathcal{G}))(X)$ , i.e. to a fake global object of  $\mathcal{G}$ . Therefore we call it a *global deformation falsely belonging to* **A**. Observe that the obstruction class  $\mathrm{cl}_F^2(j) \in \check{H}^2(X, \mathrm{Z}(\mathcal{G}))$  is represented by the cocycle

$$
g_{k_0,k_1,k_2} := g_{k_0,k_2}^{-1} \circ g_{k_1,k_2} \circ g_{k_0,k_1}.
$$

If  $\mathrm{cl}_F^2(j) \neq 1$  then the deformation A does not truly belong to  $\mathcal{A}$ .

Next a result.

<span id="page-33-1"></span>**Proposition 7.5.** Let  $\mathcal G$  be a gerbe on  $X$ , and assume there are enough  $Z(\mathcal G)$ *acyclic open coverings.* Let  $\bar{\mathbf{G}} := \mathbf{G}/\mathbf{Z}(\mathbf{G})$ .

- (1) If  $\check{H}^2(X, Z(\mathcal{G})) = 1$ , then the canonical morphism of groupoids  $\mathcal{G}(X) \to$  $\bar{\mathbf{G}}(X)$  is essentially surjective on objects. In particular any fake global object *of* **G** *lifts to a true global object.*
- (2) If moreover  $\check{H}^1(X, Z(\mathcal{G})) = 1$ , then  $\mathcal{G}(X) \to \bar{\mathcal{G}}(X)$  is bijective on isomor*phism classes of objects.*

*Proof.* By Theorem [5.11](#page-27-2) the obstruction classes  $\mathrm{cl}_{F}^{1}(h)$  and  $\mathrm{cl}_{F}^{2}(j)$  are all defined. Assertion (1) is a consequence of Theorem [4.17,](#page-23-0) and assertion (2) is a consequence of Theorem [4.6.](#page-20-0)

<span id="page-33-2"></span>**Example 7.6.** Let K be a smooth algebraic variety over a field K of characteristic 0. Suppose **A** is a twisted (Poisson or associative)  $\mathbb{K}[[\hbar]]$ -deformation of  $\mathcal{O}_X$ which is symplectic. This means that the first order bracket  $\{-,-\}$ **A** on  $\mathcal{O}_X$  is nondegenerate (cf.  $[Ye]$ ). It follows that the center of the gauge gerbe  $\mathcal{G}$  is isomorphic (canonically) to the constant sheaf  $\mathbb{K}[[\hbar]]$ . Now in the Zariski topology constant sheaves have no higher cohomologies; and hence Proposition [7.5](#page-33-1) applies. So there are as many global deformations falsely belonging to **A** there are global deformations truly belonging to **A** in this case.

<span id="page-33-0"></span>**Example 7.7.** Let  $K$  be a smooth algebraic variety over a field  $K$  of characteristic 0, and assume there is a nonzero class  $c \in H^2(X, \mathcal{O}_X)$ . Then there is a twisted associative  $\mathbb{K}[[\hbar]]$ -deformation **A** of  $\mathcal{O}_X$ , which is commutative (i.e. each of the local deformations  $A_i$  belonging to  $A$  is commutative). See [\[Ye,](#page-35-0) Example 6.17] for this construction. The gauge gerbe here is abelian:  $\mathcal{G} \cong \exp(\hbar \mathcal{O}_X[[\hbar]])$ . We filter it by  $\mathcal{N}_p := \exp(\hbar^{p+1}\mathcal{O}_X[[\hbar]])$ . For  $p = 0$  we have a central extension of gerbes

$$
1 \to \mathcal{O}_X \xrightarrow{\hbar} \mathcal{G}/\mathcal{N}_1 \to \mathcal{G}/\mathcal{N}_0 \to 1,
$$

and for the unique (up to isomorphism) global object *j* of the gerbe  $\mathcal{G}/\mathcal{N}_0$ , the obstruction class is  $cl^2(j) = c$  (same as in Example [7.3\)](#page-32-3). Hence  $Ob(\mathcal{G}/\mathcal{N}_1) = \emptyset$ , implying that  $Ob \mathcal{G}(X) = \emptyset$ , so *A* is really twisted.

One of the reasons for introducing the obstruction classes  $\mathrm{cl}_{F}^{2}(j)$  is to address the following question.

<span id="page-34-0"></span>**Question 7.8.** Does there exist an algebraic variety *X*, and a *symplectic* twisted  $\mathbb{K}[[\hbar]]$ -deformation **A** of  $\mathcal{O}_X$ , that is really twisted? We expect the answer to be positive. Indeed, we think this happens when *X* is any abelian surface, and we take any nonzero Poisson bracket on  $\mathcal{O}_X$ , and let  $\mathcal A$  be its canonical quantization (as in [\[Ye,](#page-35-0) Theorem 0.1]), which is a twisted associative  $\mathbb{K}[[\hbar]]$ -deformation of  $\mathcal{O}_X$ .

**Example 7.9.** Let *X* be a complex analytic manifold, and denote by  $\mathcal{O}_X$  the sheaf of holomorphic functions. Let  $A$  be a symplectic (Poisson or associative) twisted  $\mathbb{C}[[\hbar]]$ -deformation of  $\mathcal{O}_X$ . Then the gauge gerbe **G** has a central filtration, with  $\mathcal{N}_p(i) = \exp(\hbar^{p+1}A_i)$  for a local object *i*. And the center of **G** is

$$
\exp(\hbar\mathbb{C}[[\hbar]])=\exp\bigl(\prod\nolimits_{m=1}^\infty \mathbb{C}\hbar^m\bigr)\subset\mathcal{G}.
$$

We put on  $\bar{\mathcal{G}} := \mathcal{G}/\mathbb{Z}(\mathcal{G})$  the induced filtration  $\{\bar{\mathcal{N}}_p\}_{p \in \mathbb{N}}$ . Define a normal subgroupoid

$$
\mathcal{M}_p := \mathcal{N}_{p+1} \cdot \exp\bigl(\prod\nolimits_{m=1}^p \mathbb{C} \hbar^m\bigr) \subset \mathcal{G}.
$$

Then for every  $p \geq 0$  there is a morphism of central extensions of gerbes

$$
1 \longrightarrow \mathcal{O}_X \longrightarrow \mathcal{G}/\mathcal{M}_p \longrightarrow \bar{\mathcal{G}}/\bar{\mathcal{M}}_p \longrightarrow 1
$$
  
\n

1 \longrightarrow \mathcal{O}_X/\mathbb{C} \longrightarrow \bar{\mathcal{G}}/\bar{\mathcal{N}}_{p+1} \xrightarrow{E_p} \bar{\mathcal{G}}/\bar{\mathcal{N}}_p \longrightarrow 1.
$$

We do not know if there are enough acyclic open coverings for the sheaf  $\mathcal{O}_X/\mathbb{C}$ ; but according to Proposition [5.13,](#page-27-1) for any  $j \in \mathrm{Ob}(\bar{\mathcal{G}}/\bar{\mathcal{N}}_p)(X)$  the obstruction class  $\mathrm{cl}_{E_n}^2(j) \in \check{H}^2(X, \mathcal{O}_X/\mathbb{C})$  exists, and moreover it comes from  $\check{H}^2(X, \mathcal{O}_X)$ .

<span id="page-34-1"></span>Now assume that the homomorphism

(7.10)

H^2(X, \mathbb{C}) \to H^2(X, \mathcal{O}_X)
$$

is surjective. This happens when *X* is the analytification of a projective algebraic variety (cf. [\[NT,](#page-35-14) Section 5]). Then  $\mathrm{cl}_{E_n}^2(j) = 1$  for all *p*. Presumably Theorem [6.10](#page-30-0) can be refined to work with vanishing of obstruction classes (rather than vanishing of the whole cohomology groups). This would imply that fake global deformations exist here.

**Example 7.11.** Suppose *X* is a smooth projective algebraic variety over  $\mathbb C$  (with the Zariski topology), and let *X*an be the corresponding complex analytic manifold. Let **A** be a symplectic (Poisson or associative) twisted  $\mathbb{C}[[\hbar]]$ -deformation of  $\mathcal{O}_X$ . There is an induced deformation  $\mathcal{A}_{\text{an}}$  of  $\mathcal{O}_{X_{\text{an}}}$ . As in Example [7.6,](#page-33-2) there are as many global deformations truly belonging to  $A$  as there are global deformations falsely belonging to it. By the GAGA principle we have  $H^p(X, \mathcal{O}_X) = H^p(X_{\text{an}}, \mathcal{O}_{X_{\text{an}}})$  for all  $p$ , and therefore there as many global deformations truly belonging to  $\mathcal A$  as there are global deformations truly belonging to  $A_{an}$ . In particular, there might be none (see Question [7.8\)](#page-34-0). On the other hand, by Hodge Theory the homomorphism [\(7.10\)](#page-34-1) is surjective here (cf. [\[BK,](#page-35-15) Section 1.2]), and therefore (under the caveat of refining Theorem [6.10\)](#page-30-0) there is always some global deformation falsely belonging to  $\mathcal{A}_{an}$ .
