# Analytic Continuation of $q$-Euler numbers and polynomials

#### Abstract

In this paper we study that the $q$-Euler numbers and polynomials are analytically continued to $E_{q}(s)$. A new formula for the Euler's $q$-Zeta function $\zeta_{E, q}(s)$ in terms of nested series of $\zeta_{E, q}(n)$ is derived. Finally we introduce the new concept of the dynamics of analytically continued $q$-Euler numbers and polynomials.

## 1 Introduction

Throughout this paper, $\mathbb{Z}, \mathbb{R}$ and $\mathbb{C}$ will denote the ring of integers, the field of real numbers and the complex numbers, respectively.

When one talks of $q$-extension, $q$ is variously considered as an indeterminate, a complex numbers or $p$-adic numbers. Throughout this paper, we will assume that $q \in \mathbb{C}$ with $|q|<1$. The $q$-symbol $[x]_{q}$ denotes $[x]_{q}=\frac{1-q^{x}}{1-q}$, $($ see $[1-16])$.

In this paper we study that the $q$-Euler numbers and polynomials are analytically continued to $E_{q}(s)$. A new formula for the Euler's $q$-Zeta function $\zeta_{E, q}(s)$ in terms of nested series of $\zeta_{E, q}(n)$ is derived. Finally we introduce the new concept of the dynamics of analytically continued $q$-Euler numbers and polynomials.

## 2 Generating $q$-Euler polynomials and numbers

For $h \in \mathbb{Z}$, the $q$-Euler polynomials were defined as

$$
\begin{equation*}
\sum_{n=0}^{\infty} \frac{E_{n}(x, h \mid q)}{n!} t^{n}=[2]_{q} \sum_{n=0}^{\infty}(-1)^{n} q^{h n} e^{[n+x]_{q} t} \tag{2.1}
\end{equation*}
$$

for $x, q \in \mathbb{C}$, cf. $[1,7]$. In the special case $x=0, E_{n}(0, h \mid q)=E_{n}(h \mid q)$ are called $q$-Euler numbers, cf. $[1,2,3,4]$. By (2.1), we easily see that

$$
\begin{equation*}
E_{n}(x, h \mid q)=\frac{[2]_{q}}{(1-q)^{n}} \sum_{l=0}^{n}\binom{n}{l}(-1)^{l} \frac{1}{1+q^{l+h}} q^{l x}, c f .[7,8] \tag{2.2}
\end{equation*}
$$

where $\binom{n}{j}$ is binomial coefficient. From (2.1), we derive

$$
E_{n, q}(x, h \mid q)=\left(q^{x} E(h \mid q)+[x]_{q}\right)^{n}
$$

with the usual convention of replacing $E^{n}(h \mid q)$ by $E_{n}(h \mid q)$. In the case $h=0$, $E_{n}(x, 0 \mid q)$ will be symbolically written as $E_{n, q}(x)$. Let $G_{q}(x, t)$ be generating function of $q$-Euler polynomials as follows:

$$
\begin{equation*}
G_{q}(x, t)=\sum_{n=0}^{\infty} E_{n, q}(x) \frac{t^{n}}{n!} . \tag{2.3}
\end{equation*}
$$

Then we easily see that

$$
\begin{equation*}
G_{q}(x, t)=[2]_{q} \sum_{k=0}^{\infty}(-1)^{k} e^{[k+x]_{q} t} . \tag{2.4}
\end{equation*}
$$

For $x=0, E_{n, q}=E_{n, q}(0)$ will be called $q$-Euler numbers.
From (2.3), (2.4), we easily derive the following: For $k\left(=\right.$ even) and $n \in \mathbb{Z}_{+}$, we have

$$
\begin{equation*}
E_{n, q}(k)-E_{n, q}=[2]_{q} \sum_{l=0}^{k-1}(-1)^{l}[l]_{q}^{n} . \tag{2.5}
\end{equation*}
$$

For $k(=$ odd $)$ and $n \in \mathbb{Z}_{+}$, we have

$$
\begin{equation*}
E_{n, q}(k)+E_{n, q}=[2]_{q} \sum_{l=0}^{k-1}(-1)^{l}[l]_{q}^{n} . \tag{2.6}
\end{equation*}
$$

By (2.4), we easily see that

$$
\begin{equation*}
E_{m, q}(x)=\sum_{l=0}^{m}\binom{m}{l} q^{x l} E_{l, q}[x]_{q}^{m-l} \tag{2.7}
\end{equation*}
$$

From (2.5), (2.6), and (2.7), we derive

$$
\begin{equation*}
[2]_{q} \sum_{l=0}^{k-1}(-1)^{l-1}[l]_{q}^{n}=\left(q^{k n}-1\right) E_{n, q}+\sum_{l=0}^{k-1}\binom{n}{l} q^{k l} E_{l, q}[k]_{q}^{n-l} \tag{2.8}
\end{equation*}
$$

where $k(=$ even $) \in \mathbb{N}$. For $k(=$ odd $)$ and $n \in \mathbb{Z}_{+}$, we have

$$
\begin{equation*}
[2]_{q} \sum_{l=0}^{k-1}(-1)^{l}[l]_{q}^{n}=\left(q^{k n}+1\right) E_{n, q}+\sum_{l=0}^{k-1}\binom{n}{l} q^{k l} E_{l, q}[k]_{q}^{n-l} . \tag{2.9}
\end{equation*}
$$

## $3 \quad q$-Euler zeta function

It was known that the Euler polynomials are defined as

$$
\begin{equation*}
\frac{2}{e^{t}+1} e^{x t}=\sum_{n=0}^{\infty} \frac{E_{n}(x)}{n!} t^{n}, \quad|t|<\pi, \text { cf. [1-16]. } \tag{3.1}
\end{equation*}
$$

For $s \in \mathbb{C}, x \in \mathbb{R}$ with $0 \leq x<1$, define

$$
\begin{equation*}
\zeta_{E}(s, x)=2 \sum_{n=0}^{\infty} \frac{(-1)^{n}}{(n+x)^{s}}, \text { and } \zeta_{E}(s)=2 \sum_{n=1}^{\infty} \frac{(-1)^{n}}{n^{s}} \tag{3.2}
\end{equation*}
$$

By (3.1) and (3.2) we see that Euler numbers are related to the Euler zeta function as

$$
\zeta_{E}(-n)=E_{n}, \quad \zeta_{E}(-n, x)=E_{n}(x)
$$

For $s, q, h \in \mathbb{C}$ with $|q|<1$, we define $q$-Euler zeta function as follows:

$$
\begin{equation*}
\zeta_{E, q}(s, x \mid h)=[2]_{q} \sum_{n=0}^{\infty} \frac{(-1)^{n} q^{n h}}{[n+x]_{q}^{s}}, \text { and } \zeta_{E, q}(s \mid h)=[2]_{q} \sum_{n=1}^{\infty} \frac{(-1)^{n} q^{n h}}{[n]_{q}^{s}} \tag{3.3}
\end{equation*}
$$

For $k \in \mathbb{N}, h \in \mathbb{Z}$, we have

$$
\zeta_{E, q}(-n \mid h)=E_{n}(h \mid q)
$$

In the special case $h=0, \zeta_{E, q}(s \mid 0)$ will be written as $\zeta_{E, q}(s)$. For $s \in \mathbb{C}$, we note that

$$
\zeta_{E, q}(s)=[2]_{q} \sum_{n=1}^{\infty} \frac{(-1)^{n}}{[n]_{q}^{s}}
$$

We now consider the function $E_{q}(s)$ as the analytic continuation of Euler numbers. All the $q$-Euler numbers $E_{n, q}$ agree with $E_{q}(n)$, the analytic continuation of Euler numbers evaluated at $n$,

$$
E_{q}(n)=E_{n, q} \text { for } n \geq 0
$$

Ordinary Euler numbers are defined by

$$
\begin{equation*}
\frac{2}{e^{t}+1}=\sum_{n=0}^{\infty} E_{n} \frac{t^{n}}{n!}, \quad|t|<\pi \tag{3.4}
\end{equation*}
$$

By (3.4), it is easy to see that

$$
E_{0}=1, \text { and } E_{n}=-\frac{1}{2} \sum_{l=0}^{n-1}\binom{n}{l} E_{l}, n=0,1,2, \cdots
$$

From (2.9) and (3.3), we can consider the $q$-extension of Euler numbers $E_{n}$ as follows:

$$
\begin{equation*}
E_{0, q}=\frac{[2]_{q}}{2}, \text { and } E_{n, q}=-\frac{1}{[2]_{q^{n}}} \sum_{l=0}^{n-1}\binom{n}{l} q^{l} E_{l, q}, n=1,2,3, \cdots \tag{3.5}
\end{equation*}
$$

In fact, we can express $E_{q}^{\prime}(s)$ in terms of $\zeta_{E, q}^{\prime}(s)$, the derivative of $\zeta_{E, q}(s)$.

$$
\begin{equation*}
E_{q}(s)=\zeta_{E, q}(-s), E_{q}^{\prime}(s)=\zeta_{E, q}^{\prime}(-s), E_{q}^{\prime}(2 n+1)=\zeta_{E, q}^{\prime}(-2 n-1) \tag{3.6}
\end{equation*}
$$

for $n \in \mathbb{N} \cup\{0\}$. This is just the differential of the functional equation and so verifies the consistency of $E_{q}(s)$ and $E_{q}^{\prime}(s)$ with $E_{n, q}$ and $\zeta(s)$.

From the above analytic continuation of $q$-Euler numbers, we derive

$$
\begin{align*}
& E_{q}(s)=\zeta_{E, q}(-s), E_{q}(-s)=\zeta_{E, q}(s) \\
& \Rightarrow E_{-n, q}=E_{q}(-n)=\zeta_{E, q}(n), n \in \mathbb{Z}_{+} . \tag{3.7}
\end{align*}
$$

The curve $E_{q}(s)$ runs through the points $E_{-n, q}$ and grows $\sim n$ asymptotically as $(-n) \rightarrow-\infty$. The curve $E_{q}(s)$ runs through the point $E_{q}(-n)$ and $\lim _{n \rightarrow \infty} E_{q}(-n)=\lim _{n \rightarrow \infty} \zeta_{E, q}(n)=-2$. From (3.5), (3.6) and (3.7), we note that

$$
\zeta_{E, q}(-n)=E_{q}(n) \mapsto \zeta_{E, q}(-s)=E_{q}(s)
$$

## 4 Analytic continuation of $q$-Euler polynomials

For consistency with the redefinition of $E_{n, q}=E_{q}(n)$ in (4.5) and (4.6), we have

$$
E_{n, q}(x)=\sum_{k=0}^{n}\binom{n}{k} E_{k, q} q^{k x}[x]_{q}^{n-k}
$$

Let $\Gamma(s)$ be the gamma function. Then the analytic continuation can be obtained as

$$
\begin{aligned}
& n \mapsto s \in \mathbb{R}, x \mapsto w \in \mathbb{C}, \\
& E_{k, q} \mapsto E_{q}(k+s-[s])=\zeta_{E, q}(-(k+(s-[s]))), \\
& \binom{n}{k} \mapsto \frac{\Gamma(1+s)}{\Gamma(1+k+(s-[s])) \Gamma(1+[s]-k)} \\
& \Rightarrow E_{n, q}(s) \mapsto E_{q}(s, w)=\sum_{k=-1}^{[s]} \frac{\Gamma(1+s) E_{q}(k+s-[s]) q^{(k+s-[s]) w}[w]_{q}^{[s]-k}}{\Gamma(1+k+(s-[s])) \Gamma(1+[s]-k)} \\
& =\sum_{k=0}^{[s]+1} \frac{\Gamma(1+s) E_{q}((k-1)+s-[s]) q^{((k-1)+s-[s]) w}[w]_{q}^{[s]+1-k}}{\Gamma(k+(s-[s])) \Gamma(2+[s]-k)},
\end{aligned}
$$

where $[s]$ gives the integer part of $s$, and so $s-[s]$ gives the fractional part.
Deformation of the curve $E_{q}(2, w)$ into the curve of $E_{q}(3, w)$ via the real analytic continuation $E_{q}(s, w), 2 \leq s \leq 3,-0.5 \leq w \leq 0.5$.
