# Decay and Continuity of Boltzmann Equation in Bounded Domains

#### Abstract

Boundaries occur naturally in kinetic equations and boundary effects are crucial for dynamics of dilute gases governed by the Boltzmann equation. We develop a mathematical theory to study the time decay and continuity of Boltzmann solutions for four basic types of boundary conditions: inflow, bounce-back reflection, specular reflection, and diffuse reflection. We establish exponential decay in $L^{\infty}$ norm for hard potentials for general classes of smooth domains near an absolute Maxwellian. Moreover, in convex domains, we also establish continuity for these Boltzmann solutions away from the grazing set of the velocity at the boundary. Our contribution is based on a new $L^{2}$ decay theory and its interplay with delicate $L^{\infty}$ decay analysis for the linearized Boltzmann equation, in the presence of many repeated interactions with the boundary.


## 1 Introduction

Boundary effect plays a crucial role in the dynamics of gases governed by the Boltzmann equation:

$$

where $F(t, x, v)$ is the distribution function for the gas particles at time $t \geq 0$, position $x \in \Omega$, and $v \in \mathbf{R}^{3}$. Throughout this paper, the collision operator takes the form

\equiv & Q_{\text {gain }}\left(F_{1}, F_{2}\right)-Q_{\mathrm{loss}}\left(F_{1}, F_{2}\right) \tag{2}
\end{align*}

where $u^{\prime}=u+(v-u) \cdot \omega, v^{\prime}=v-(v-u) \cdot \omega, \cos \theta=(u-v) \cdot \omega /|u-v|, 0 \leq \gamma \leq 1$ (hard potential) and $0 \leq q_{0}(\theta) \leq C|\cos \theta|$ (angular cutoff). The mathematical study of the particle-boundary interaction in a bounded domain and its effect
on the global dynamics is one of the fundamental problems in the Boltzmann theory. There are four basic types of boundary conditions for $F(t, x, v)$ at the boundary $\partial \Omega:$ (1) In-flow injection: in which the incoming particles are prescribed; (2) bounce-back reflection: in which the particles bounce back at the reverse the velocity; (3) specular reflection: in which the particle bounce back specularly; (4) diffuse reflection (stochastic): in which the incoming particles are a probability average of the outgoing particles. Due to its importance, there have been many contributions in the mathematical study of different aspects of the Boltzmann boundary value problems [A], [AC], [AEMN], [AEP], [AH], [C2], [C3], [CC], [De], [Gui], [H], [LY], [MS], [M], [US], [YZ], among others, see also references in the books [C1], [CIP] and [U1].

According to Grad (p243, [Gr1]), one of the basic problems in the Boltzmann study is to prove existence and uniqueness of its solutions, as well as their time-decay toward an absolute Maxwellian, in the presence of compatible physical boundary conditions in a general domain. In spite of those contributions to the study of Boltzmann boundary problems, there are few mathematical results of uniqueness, regularity, and time decay-rate for Boltzmann solutions toward an Maxwellian. In [SA], it was announced that Boltzmann solutions near a Maxwellian would decay exponentially to it in a smooth bounded convex domain with specular reflection boundary conditions. Unfortunately, we are not aware of any complete proof for such a result over the last thirty years [U2]. Recently, important progress has been made in $[\mathrm{DeV}]$ and $[\mathrm{V}]$ to establish almost exponential decay rate for Boltzmann solutions with large amplitude for general collision kernels and general boundary conditions, provided certain a-priori strong Sobolev estimates can be verified. Even though these estimates had been established for spatially periodic domains [G3-4] near Maxwellians, their validity is completely open for the Boltzmann solutions, even local in time, in a bounded domain. As a matter of fact, such kind of strong Sobolev estimates may not be expected for a general non-convex domain [G4]. This is because even for simplest kinetic equations with the differential operator $v \cdot \nabla_{x}$, the phase boundary $\partial \Omega \times \mathbf{R}^{3}$ is always characteristic but not uniformly characteristic at the grazing set $\gamma_{0}=\{(x, v): x \in \partial \Omega$, and $v \cdot n(x)=0\}$ where $n(x)$ being the outward normal at $x$. Hence it is very challenging and delicate to obtain regularity from general theory of hyperbolic PDE. Moreover, in comparison with the half-space problems studied, for instance in [LY], [YZ], the complication of the geometry makes it difficult to employ spatial Fourier transforms in $x$. There are many cycles (bouncing characteristics) interacting with the boundary repeatedly, and analysis of such cycles is one of the key mathematical difficulties.

The purpose of this article is to develop an unified $L^{2}-L^{\infty}$ theory in the near Maxwellian regime, to establish exponential decay toward a normalized Maxwellian $\mu=e^{-\frac{|v|^{2}}{2}}$, for all four basic types of the boundary conditions and rather general domains. Consequently, uniqueness among these solutions can be obtained. For convex domains, these solutions are shown to be continuous away from the singular grazing set $\gamma_{0}$.

### 1.1 Domain and Characteristics

Throughout this paper, we define $\Omega=\{x: \xi(x)<0\}$ is connected and bounded with $\xi(x)$ being a smooth function. We assume $\nabla \xi(x) \neq 0$ at the boundary $\xi(x)=0$. The outward normal vector at $\partial \Omega$ is given by

and it can be extended smoothly near $\partial \Omega=\{x: \xi(x)=0\}$. We say $\Omega$ is real analytic if $\xi$ is real analytic in $x$. We define $\Omega$ is strictly convex if there exists $c_{\xi}>0$ such that

for all $x$ such that $\xi(x) \leq 0$, and all $\zeta \in \mathbf{R}^{3}$. We say that $\Omega$ has a rotational symmetry, if there are vectors $x_{0}$ and $\varpi$, such that for all $x \in \partial \Omega$

We denote the phase boundary in the space $\Omega \times \mathbf{R}^{3}$ as $\gamma=\partial \Omega \times \mathbf{R}^{3}$, and split it into outgoing boundary $\gamma_{+}$, the incoming boundary $\gamma_{-}$, and the singular boundary $\gamma_{0}$ for grazing velocities:

\gamma_{+} & =\left\{(x, v) \in \partial \Omega \times \mathbf{R}^{3}: n(x) \cdot v>0\right\} \\
\gamma_{-} & =\left\{(x, v) \in \partial \Omega \times \mathbf{R}^{3}: n(x) \cdot v<0\right\} \\
\gamma_{0} & =\left\{(x, v) \in \partial \Omega \times \mathbf{R}^{3}: n(x) \cdot v=0\right\}
\end{aligned}
$$

Given $(t, x, v)$, let $[X(s), V(s)]=[X(s ; t, x, v), V(s ; t, x, v)]=[x+(s-t) v, v]$ be the trajectory (or the characteristics) for the Boltzmann equation (1):

\frac{d X(s)}{d s}=V(s), \quad \frac{d V(s)}{d s}=0 \tag{6}
\end{equation*}
$$

with the initial condition: $[X(t ; t, x, v), V(t ; t, x, v)]=[x, v]$. For any $(x, v)$ such that $x \in \bar{\Omega}, v \neq 0$, we define its backward exit time $t_{\mathbf{b}}(x, v) \geq 0$ to be the the last moment at which the back-time straight line $[X(s ; 0, x, v), V(s ; 0, x, v)]$ remains in $\bar{\Omega}$ :

We therefore have $x-t_{\mathbf{b}} v \in \partial \Omega$ and $\xi\left(x-t_{\mathbf{b}} v\right)=0$. We also define

x_{\mathbf{b}}(x, v)=x\left(t_{\mathbf{b}}\right)=x-t_{\mathbf{b}} v \in \partial \Omega \tag{8}

We always have $v \cdot n\left(x_{\mathbf{b}}\right) \leq 0$.

### 1.2 Boundary Condition and Conservation Laws

In terms of the standard perturbation $f$ such that $F=\mu+\sqrt{\mu} f$, the Boltzmann equation can be rewritten as

\left\{\partial_{t}+v \cdot \nabla+L\right\} f=\Gamma(f, f), \quad f(0, x, v)=f_{0}(x, v)
$$

where the standard linear Boltzmann operator see [G] is given by

$$
\begin{equation*}
L f \equiv \nu f-K f=-\frac{1}{\sqrt{\mu}}\{Q(\mu, \sqrt{\mu} f)+Q(\sqrt{\mu} f, \mu)\} \tag{9}
\end{equation*}

with the collision frequency $\nu(v) \equiv \int|v-u|^{\gamma} \mu(u) q_{0}(\theta) d u d \theta \backsim\{1+|v|\}^{\gamma}$ for $0 \leq \gamma \leq 1$; and

\Gamma\left(f_{1}, f_{2}\right)=\frac{1}{\sqrt{\mu}} Q\left(\sqrt{\mu} f_{1}, \sqrt{\mu} f_{2}\right) \equiv \Gamma_{\text {gain }}\left(f_{1}, f_{2}\right)-\Gamma_{\text {loss }}\left(f_{1}, f_{2}\right) \tag{10}
\end{equation*}

In terms of $f$, we formulate the boundary conditions as
(1) The in-flow boundary condition: for $(x, v) \in \gamma_{-}$

\begin{equation*}
\left.f\right|_{\gamma_{-}}=g(t, x, v) \tag{11}
\end{equation*}
$$

(2) The bounce-back boundary condition: for $x \in \partial \Omega$,

\left.f(t, x, v)\right|_{\gamma_{-}}=f(t, x,-v) \tag{12}
\end{equation*}
$$

(3) Specular reflection: for $x \in \partial \Omega$, let

R(x) v=v-2(n(x) \cdot v) n(x) \tag{13}
\end{equation*}
$$

and

$$
\begin{equation*}
\left.f(t, x, v)\right|_{\gamma_{-}}=f(x, v, v-2(n(x) \cdot v) n(x))=f(x, v, R(x) v) \tag{14}
\end{equation*}
$$

(4) Diffusive reflection: assume the natural normalization,

$$
\begin{equation*}
c_{\mu} \int_{v \cdot n(x)>0} \mu(v)|n(x) \cdot v| d v=1, \tag{15}
\end{equation*}
$$

then for $(x, v) \in \gamma_{-}$,

$$
\begin{equation*}
\left.f(t, x, v)\right|_{\gamma_{-}}=c_{\mu} \sqrt{\mu(v)} \int_{v^{\prime} \cdot n(x)>0} f\left(t, x, v^{\prime}\right) \sqrt{\mu\left(v^{\prime}\right)}\left\{n_{x} \cdot v^{\prime}\right\} d v^{\prime} \tag{16}
\end{equation*}

For both the bounce-back and specular reflection conditions (12) and (14), it is well-known that both mass and energy are conserved for (11). Without loss of generality, we may always assume that the mass-energy conservation laws hold for $t \geq 0$, in terms of the perturbation $f$ :

Moreover, if the domain $\Omega$ has any axis of rotation symmetry (5), then we further assume the corresponding conservation of angular momentum is valid for all $t \geq 0$ :

For the diffuse reflection (16), the mass conservation (17) is assumed to be valid.

### 1.3 Main Results

We introduce the weight function

$$

w(v)=\left(1+\rho|v|^{2}\right)^{\beta} e^{\theta|v|^{2}} \tag{20}
\end{equation*}

where $0 \leq \theta<\frac{1}{4}, \rho>0$ and $\beta \in \mathbf{R}^{1}$.
Theorem 1 Assume $w^{-2}\{1+|v|\}^{3} \in L^{1}$ in (20). There exists $\delta>0$ such that if $F_{0}=\mu+\sqrt{\mu} f_{0} \geq 0$, and

\left\|w f_{0}\right\|_{\infty}+\sup _{0 \leq t \leq \infty} e^{\lambda_{0} t}\|w g(t)\|_{\infty} \leq \delta
$$

with $\lambda_{0}>0$, then there there exists a unique solution $F(t, x, v)=\mu+\sqrt{\mu} f \geq 0$ to the inflow boundary value problem (11) for the Boltzmann equation (1). There exists $0<\lambda<\lambda_{0}$ such that

\sup _{0 \leq t \leq \infty} e^{\lambda t}\|w f(t)\|_{\infty} \leq C\left\{\left\|w f_{0}\right\|_{\infty}+\sup _{0 \leq t \leq \infty} e^{\lambda_{0} t}\|w g(s)\|_{\infty}\right\}
$$

Moreover, if $\Omega$ is strictly convex (4), and if $f_{0}(x, v)$ is continuous except on $\gamma_{0}$, and $g(t, x, v)$ is continuous in $[0, \infty) \times\left\{\partial \Omega \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$ satisfying

f_{0}(x, v)=g(x, v) \quad \text { on } \gamma_{-},
$$

then $f(t, x, v)$ is continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.
Theorem 2 Assume $w^{-2}\{1+|v|\}^{3} \in L^{1}$ in (20). Assume the conservation of mass (17) and energy (18) are valid for $f_{0}$. Then there exists $\delta>0$ such that if $F_{0}(x, v)=\mu+\sqrt{\mu} f_{0}(x, v) \geq 0$ and $\left\|w f_{0}\right\|_{\infty} \leq \delta$, there exists a unique solution $F(t, x, v)=\mu+\sqrt{\mu} f(t, x, v) \geq 0$ to the bounce-back boundary value problem (12) for the Boltzmann equation (1) such that

\sup _{0 \leq t \leq \infty} e^{\lambda t}\|w f(t)\|_{\infty} \leq C\left\|w f_{0}\right\|_{\infty}
$$

Moreover, if $\Omega$ is strictly convex (4), and if initially $f_{0}(x, v)$ is continuous except on $\gamma_{0}$ and

$$
f_{0}(x, v)=f_{0}(x,-v) \text { on } \partial \Omega \times \mathbf{R}^{3} \backslash \gamma_{0}
$$

then $f(t, x, v)$ is continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.

Theorem 3 Assume $w^{-2}\{1+|v|\}^{3} \in L^{1}$ in (20). Assume that $\xi$ is both strictly convex (4) and analytic, and the mass (17) and energy (18) are conserved for $f_{0}$. In the case of $\Omega$ has any rotational symmetry (5), we require that the corresponding angular momentum (19) is conserved for $f_{0}$. Then there exists $\delta>0$ such that if $F_{0}(x, v)=\mu+\sqrt{\mu} f_{0}(x, v) \geq 0$ and $\left\|w f_{0}\right\|_{\infty} \leq \delta$, there exists a unique solution $F(t, x, v)=\mu+\sqrt{\mu} f(t, x, v) \geq 0$ to the specular boundary value problem (14) for the Boltzmann equation (1) such that

\sup _{0 \leq t \leq \infty} e^{\lambda t}\|w f(t)\|_{\infty} \leq C\left\|w f_{0}\right\|_{\infty}
$$

Moreover, if $f_{0}(x, v)$ is continuous except on $\gamma_{0}$ and

$$
f_{0}(x, v)=f_{0}(x, R(x) v) \text { on } \partial \Omega
$$

then $f(t, x, v)$ is continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.
Theorem 4 Assume (15). There is $\theta_{0}\left(\nu_{0}\right)>0$ such that

\theta_{0}\left(\nu_{0}\right)<\theta<\frac{1}{4}, \quad \text { and } \quad \rho \quad \text { is sufficiently small } \tag{21}
\end{equation*}
$$

for weight function $w$ in (20). Assume the mass conservation (17) is valid for $f_{0}$. If $F_{0}(x, v)=\mu+\sqrt{\mu} f_{0}(x, v) \geq 0$ and $\left\|w f_{0}\right\|_{\infty} \leq \delta$ sufficiently small, then there exists a unique solution $F(t, x, v)=\mu+\sqrt{\mu} f(t, x, v) \geq 0$ to the diffuse boundary value problem (16) for the Boltzmann equation (1) such that

\sup _{0 \leq t \leq \infty} e^{\lambda t}\|w f(t)\|_{\infty} \leq C\left\|w f_{0}\right\|_{\infty}
$$

Moreover, if $\xi$ is strictly convex, and if $f_{0}(x, v)$ is continuous except on $\gamma_{0}$ with

$$
\left.f_{0}(x, v)\right|_{\gamma_{-}}=c_{\mu} \sqrt{\mu} \int_{\left\{n_{x} \cdot v^{\prime}>0\right\}} f_{0}\left(x, v^{\prime}\right) \sqrt{\mu\left(v^{\prime}\right)}\left\{n(x) \cdot v^{\prime}\right\} d v^{\prime}
$$

then $f(t, x, v)$ is continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.

### 1.4 Velocity Lemma and Analyticity

In section 2, we first establish some important analytical tools. The first Velocity Lemma 5 plays the most important role in the study of continuity and the cycles (bouncing generalized trajectories) in the specular case. It implies that in a strictly convex domain (4), the singular set $\gamma_{0}$ can not be reached via the trajectory $\frac{d x}{d t}=v, \frac{d v}{d t}=0$ from interior points inside $\Omega$, and hence $\gamma_{0}$ does not really participate or interfere with the interior dynamics. By Lemma 6 no singularity would be created from $\gamma_{0}$ and it is possible to perform calculus for the back-time exit time $t_{\mathbf{b}}(x, v)$. This is the foundation for future regularity study. Moreover, the Velocity Lemma 5 also provides the lower bound away from the singular set $\gamma_{0}$, which leads to the estimates for repeating bounces in
the specular reflection cases. Such a Velocity Lemma 5 was first discovered in [G3-4], in the study of regularity of Vlasov-Poisson (Maxwell) system with flat geometry. It then was generalized in $[\mathrm{HH}]$ for Vlasov-Poisson system in a ball, and it is the starting point for the recent final resolution to the Vlasov-Poisson in a general convex domain [HV] with specular boundary condition.

Lemma 7 gives refined estimates for the operator $K_{w}$ with $w \backsim \mu^{-1 / 2}$. Similar estimates were established in [SG]. Lemma 8 states that the zero set of a analytic function is of measure zero unless such a analytic function is identically zero. This provides a very convenient tool to verify certain geometric conditions of general domains for particularly specular reflections.

## $1.5 \quad L^{2}$ Decay Theory

Since no spatial Fourier transform is available, we first establish linear $L^{2}$ exponential decay estimates in Section 3 via a functional analytical approach. It turns out that it suffices to establish the following finite-time estimate (Proposition (11)

for any solution $f$ to the linear Boltzmann equation

$$
\begin{equation*}
\partial_{t} f+v \cdot \nabla_{x} f+L f=0, \quad f(0, x, v)=f_{0}(x, v) \tag{23}
\end{equation*}
$$

with all four boundary conditions (11), (12), (14) and (16). Here for any fixed $(t, x)$, the standard projection $\mathbf{P}$ onto the hydrodynamic part is given by

$$
\begin{align*}
\mathbf{P} f & =\left\{a(t, x)+b(t, x) \cdot v+c(t, x)|v|^{2}\right\} \sqrt{\mu(v)}  \tag{24}\\
\mathbf{P}_{a} f & =a(t, x) \sqrt{\mu(v)}, \quad \mathbf{P}_{\mathbf{b}} f=b(t, x) v \sqrt{\mu(v)}, \quad \mathbf{P}_{c} f=c(t, x)|v|^{2} \sqrt{\mu(v)}
\end{align*}
$$

and $\|\cdot\|_{\nu}$ is the weighted $L^{2}$ norm with the collision frequency $\nu(v)$.
Similar types of estimates like (22), but with strong Sobolev norms, have been established in recent years [G1] via so-called the macroscopic equations for the coefficients $a, b$ and $c$. The key of the analysis was based on the ellipticity for $b$ which satisfies the Poisson's equation $\Delta b=\partial^{2}\{\mathbf{I}-\mathbf{P}\} f$, where $\partial^{2}$ is some second order differential operators. In the presence of the boundary condition $b \cdot n(x)=0$ (bounce-back and specular) or $b \equiv 0$ (inflow and diffuse) at $\partial \Omega$, such an ellipticity is very difficult to employ for the weak $L^{2}$, instead of $H^{1}$, estimate for $b$ in (22). This is due to lack of regularity of $b$ in (22), even the trace of $b$ is hard to define. Instead, we employ the hyperbolic (transport) feature rather than elliptic feature of the problem to prove (22). By a method of contradiction, we can find $f_{k}$ such that if (22) is not valid, then the normalized $Z_{k}(t, x, v) \equiv \frac{f_{k}(t, x, v)}{\sqrt{\int_{0}^{1}\left\|\mathbf{P} f_{k}(s)\right\|_{\nu}^{2} d s}}$ satisfies $\int_{0}^{1}\left\|\mathbf{P} Z_{k}(s)\right\|_{\nu}^{2} d s \equiv 1$, and

$$
\begin{equation*}
\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s \leq \frac{1}{k} \tag{25}
\end{equation*}
$$

Denote a weak limit of $Z_{k}$ to be $Z$, we expect that $Z=\mathbf{P} Z=0$, by each of the four boundary conditions. The key is to prove that $Z_{k} \rightarrow Z$ strongly to reach a contradiction. By the averaging Lemma [DL2], we know that $Z_{k}(s) \rightarrow Z$ strongly in the interior of $\Omega$. As expected, the most delicate part is to exclude possible concentration near the boundary $\partial \Omega$. Since $Z_{k}$ is a solution to the transport equation, it then follows (Proposition 17) that near $\partial \Omega$, on set of the non-grazing velocity $v \cdot n(x) \neq 0$ can be reached via a trajectory from the interior of $\Omega$, which implies that $Z_{k}$ can be controlled on such non-grazing set with no concentration. On the other hand, over the remaining almost grazing set $v \cdot n(x) \sim 0$, thanks to the fact (25), we know that

$$
Z_{k} \sim \mathbf{P} Z_{k}=\left\{a_{k}(t, x)+b_{k}(t, x) \cdot v+c_{k}(t, x)|v|^{2}\right\} \sqrt{\mu(v)}
$$

We observe that such special form of velocity distribution $\mathbf{P} Z_{k}$ can not have concentration on the almost grazing set $v \cdot n(x) \sim 0$ (Lemma 15), and we therefore conclude (22). Clearly, the hyperbolic or the transport property is crucial to control boundary behaviors via the interior compactness of $Z_{k}$.

## $1.6 \quad L^{\infty}$ Decay Theory

Section 4 is devoted to the study of linear $L^{\infty}$ decay for all four different types of boundary conditions: in-flow, bounceback, specular and diffuse (stochastic) reflection. In order to control the nonlinear term $\Gamma(f, f)$, we need to estimate the weighted $L^{\infty}$ of $w f$. We recall that $L=\nu-K$, and study the $L^{\infty}$ (pointwise) decay of the linear Boltzmann equation (23). We denote a weight function

h(t, x, v)=w(v) f(t, x, v) \tag{26}
\end{equation*}

and study the equivalent linear Boltzmann equation:

$$
\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu-K_{w}\right\} h=0, \quad h(0, x, v)=h_{0}(x, v) \equiv w f_{0} \tag{27}
\end{equation*}
$$

where

$$
\begin{equation*}
K_{w} h=w K\left(\frac{h}{w}\right) \tag{28}
\end{equation*}
$$

together with various boundary conditions (11), (12), (14), or (16). In bounceback, specular, diffuse reflection as well as the inflow case with $g \equiv 0$, we denote the semigroup $U(t) h_{0}$ to be the solution to (27), and the semigroup $G(t) h_{0}$ to be the solution to the simpler transport equation without collision $K_{w}$ :

$$
\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} h=0, \quad h(0, x, v)=h_{0}(x, v)=w f_{0} \tag{29}
\end{equation*}
$$

Notice that neither $G(t)$ nor $U(t)$ is a strongly continuous semigroup in $L^{\infty}$ [U1].

We first obtain explicit representation of $G(t)$ in the presence of various boundary conditions. We then can obtain the explicit exponential decay estimate for $G(t)$. Moreover, we also establish the continuity for $G(t)$ with a forcing
term $q$ if $\Omega$ is strictly convex (4) based on the Velocity Lemma ${ }^{5}$ To study the $L^{\infty}$ decay for $U(t)$, we make use of the Duhamal Principle :

\begin{equation*}
U(t)=G(t)+\int_{0}^{t} G\left(t-s_{1}\right) K_{w} U\left(s_{1}\right) d s_{1} . \tag{30}
\end{equation*}
$$

Following the pioneering work of Vidav [Vi], we iterate (30) back to get:
$U(t)=G(t)+\int_{0}^{t} G\left(t-s_{1}\right) K_{w} G\left(s_{1}\right) d s_{1}+\int_{0}^{t} \int_{0}^{s_{1}} G\left(t-s_{1}\right) K_{w} G\left(s_{1}-s\right) K_{w} U(s) d s d s_{1}$.
The idea is to estimate the last double integral in terms of the $L^{2}$ norm of $f=\frac{h}{w}$, which decays exponential by $L^{2}$ decay theory in Section 2. The key difficulty lies in the presence of different boundary conditions which could lead to complicated bouncing trajectories. Each of the boundary condition presents different difficulties.

Section 4.1 is devoted to the study of inflow boundary condition (11), in which the back-time trajectory is either from the initial plane or from the boundary. Even though when $g \neq 0$, the solution operators for (29) and (27) are not semigroups, for any $(t, x, v)$, a similar representation as $G\left(t-s_{1}\right) K_{w} G\left(s_{1}-\right.$ s) $K_{w} U(s)$ is still possible. With the compact property of $K_{w}$ (Lemma 77), we are led to the main contribution in (31) roughly of the form

\int_{0}^{t} \int_{0}^{s_{1}} \int_{v^{\prime}, v^{\prime \prime} \text { bounded }}\left|h\left(s, X\left(s ; s_{1}, X\left(s_{1} ; t, x, v\right), v^{\prime}\right), v^{\prime \prime}\right)\right| d v^{\prime} d v^{\prime \prime} d s d s_{1} . \tag{32}
\end{equation*}
$$

The $v^{\prime}$ integral is estimated by a change of variable introduced in [Vi], (see also in [LY])

$$
\begin{equation*}
y \equiv X\left(s ; s_{1}, X\left(s_{1} ; t, x, v\right), v^{\prime}\right)=x-\left(t-s_{1}\right) v-\left(s_{1}-s\right) v^{\prime} . \tag{33}
\end{equation*}
$$

Since $\operatorname{det}\left(\frac{d y}{d v^{\prime}}\right) \neq 0$ almost always true, the $v^{\prime}$ and $v^{\prime \prime}$-integration in (32) can be bounded by ( $h=w f$ )

$$
\int_{\Omega, v^{\prime \prime} \text { bounded }}\left|h\left(s, y, v^{\prime \prime}\right)\right| d y d v^{\prime \prime} \leq C\left(\int_{\Omega, v^{\prime \prime} \text { bounded }}\left|f\left(s, y, v^{\prime \prime}\right)\right|^{2} d y d v^{\prime \prime}\right)^{1 / 2}
$$

For bounce-back, specular or diffuse reflections, the characteristic trajectories repeatedly interact with the boundary. Instead of $X(s ; t, x, v)$, we should use the generalized characteristics, defined as cycles, $X_{\text {cl }}(s ; t, x, v)$ in (32) as in Definitions 21, 30 and 36. The key question is wether or not the change of variable

\begin{equation*}
y \equiv X_{\mathbf{c l}}\left(s ; s_{1}, X_{\mathbf{c l}}\left(s_{1} ; t, x, v\right), v^{\prime}\right) \tag{34}
\end{equation*}
$$

is valid, i.e., to determine if it is almost always true

$$
\begin{equation*}
\operatorname{det}\left\{\frac{d X_{\mathbf{c l}}\left(s ; s_{1}, X_{\mathrm{cl}}\left(s_{1} ; t, x, v\right), v^{\prime}\right)}{d v^{\prime}}\right\} \neq 0 . \tag{35}
\end{equation*}
$$

Section 4.2 is devoted to the study of the bounce-back reflection. The bounce-back cycles $X_{\mathbf{c l}}(s ; t, x, v)$ from a given point $(t, x, v)$ is relatively simple, just going back and forth between two fixed points $x_{\mathbf{b}}(x, v)$ and $x_{\mathbf{b}}\left(x_{\mathbf{b}}(x, v),-v\right)$. Now the change of variable (34) and (35) can be established by the study of set $S_{x}(v)$ in Section 4.2.2.

Section 4.3 is devoted to the study of specular reflection. The specular cycles $X_{\mathbf{c l}}(s ; t, x, v)$ reflect repeatedly with the boundary in general, and $\frac{d X_{\mathrm{cl}}\left(s ; s_{1}, X_{\mathrm{cl}}\left(s_{1} ; t, x, v\right), v^{\prime}\right)}{d v^{\prime}}$ is very complicated to compute and (35) is extremely difficult to verify, even in a convex domain. This is in part due to the fact that there is no apparent way to analyze $\frac{d X_{\mathrm{cl}}\left(s ; s_{1} X_{\mathrm{cl}}\left(s_{1} ; t, x, v\right), v^{\prime}\right)}{d v^{\prime}}$ inductively with finite bounces. To overcome such a difficulty, in Section 4.3.2, det $\frac{d v_{k}}{d v_{1}}$ can be computed asymptotically in a delicate iterative fashion for special cycles almost tangential to the boundary, which undergo many small bounces near the boundary. It then follows that $\operatorname{det}\left\{\frac{d X_{\mathrm{cl}}\left(s ; s_{1}, X_{\mathrm{cl}}\left(s_{1} ; t, x, v\right), v^{\prime}\right)}{d v^{\prime}}\right\} \neq 0$ for these special cycles. This crucial observation is then combined with analyticity of $\xi$ and Lemma 8 to conclude that the set of $\operatorname{det}\left\{\frac{d X_{\mathrm{cl}}\left(s ; X_{\mathrm{cl}}\left(s_{1}, x, v\right), v^{\prime}\right)}{d v^{\prime}}\right\}=0$ is arbitrarily small (Lemma 34), and the change of variable (34) is almost always valid. The analyticity plays an important role in our proof.

Section 4.4 is devoted to the study of diffuse reflection. The diffuse cycles $X_{\mathbf{c l}}(s ; t, x, v)$ contain more and more independent variables and (32) involves their integrations. Similar change of variable (33) is expected with respect to one of such independent variables. However, the main difficulty in this case is the $L^{\infty}$ control of $G(t)$ which satisfies (29). The most natural $L^{\infty}$ estimate for $G(t)$ is for the weight $w=\mu^{-\frac{1}{2}}$, in which the diffuse boundary condition takes the form

$$
h(t, x, v)=c_{\mu} \int_{v^{\prime} \cdot n(x)>0} h\left(t, x, v^{\prime}\right) \mu\left(v^{\prime}\right)\left\{v^{\prime} \cdot n(x)\right\} d v^{\prime}
$$

with $c_{\mu} \int_{v^{\prime} \cdot n(x)>0} \mu\left(v^{\prime}\right)\left\{v^{\prime} \cdot n(x)\right\} d v^{\prime}=1$. But such a natural (strong) weight $\mu^{-\frac{1}{2}}$ exactly makes the whole linear Boltzmann theory break down (Lemma 7), so we have to use a weaker weight, which is closer to $\mu^{-\frac{1}{2}}$. This new weight will introduce serious new difficulty since no natural maximum principle is available now from the new boundary condition (184). Moreover, for any $(t, x, v)$, since there are always particles moving almost tangential to the boundary in the bounce-back reflection, it is impossible to reach down the initial plane no matter how many cycles the particles take. In other words, there is no explicit expression for $G(t)$ in terms of initial data completely. To establish the $L^{\infty}$ estimate, we make crucial observation in Lemma 37 that the measure of those particles can not reach initial plane after $k$-bounces is small when $k$ is large. We therefore can obtain an approximate representation formula for $G(t)$ by the initial datum, with only finite number of bounces.

Section 5 is devoted to the proofs of the main nonlinear decay and continuity results of this paper.

Our contribution opens new lines of research about such interesting questions as specular reflections in non-convex domains, decay for the soft potentials,
higher regularity in a convex domain, characterization of propagation of singularity in a non-convex domain, as well as charged particles interacting with fields. Moreover, our new $L^{2}-L^{\infty}$ theory will shed new lights in other investigations of Boltzmann equation, in which regularity of the solutions is difficult to employ [EGM] [GS].

## 2 Preliminary

Lemma 5 Let $\Omega$ be strictly convex defined in (4). Define the functional along the trajectories $\frac{d X(s)}{d s}=V(s), \frac{d V(s)}{d s}=0$ in (6) as:

\alpha(s) \equiv \xi^{2}(X(s))+[V(s) \cdot \nabla \xi(X(s))]^{2}-2\left\{V(s) \cdot \nabla^{2} \xi(X(s)) \cdot V(s)\right\} \xi(X(s)) \tag{36}

Let $X(s) \in \bar{\Omega}$ for $t_{1} \leq s \leq t_{2}$. Then there exists constant $C_{\xi}>0$ such that

e^{C_{\xi}\left(\left|V\left(t_{1}\right)\right|+1\right) t_{1}} \alpha\left(t_{1}\right) & \leq e^{C_{\xi}\left(\left|V\left(t_{1}\right)\right|+1\right) t_{2}} \alpha\left(t_{2}\right)  \tag{37}\\
e^{-C_{\xi}\left(\left|V\left(t_{1}\right)\right|+1\right) t_{1}} \alpha\left(t_{1}\right) & \geq e^{-C_{\xi}\left(\left|V\left(t_{1}\right)\right|+1\right) t_{2}} \alpha\left(t_{2}\right)
\end{align*}
$$

Proof. Under the convexity assumption (4), we notice that $\alpha(s) \geq 0$ for $t_{1} \leq$ $s \leq t_{2}$. Since $\frac{d V(s)}{d s} \equiv 0$ by (6), we compute the derivative of $\alpha(s)$ in (36) as

& -2\left\{V(s) \cdot \nabla^{2} \xi(X(s)) \cdot V(s)\right\}[\nabla \xi(X(s)) \cdot V(s)] \\
& -2\left[V(s) \cdot \nabla^{3} \xi(X(s)) V(s) \cdot V(s)\right] \xi(X(s))
\end{aligned}
$$

Note that the second and the third terms on the right hand side cancel exactly. By the convexity (4), there exists $C_{\xi}>0$ so that we can further bound the last term by $\alpha(s)$ as:

& \left|2\left[V(s) \cdot \nabla^{3} \xi(X(s)) V(s) \cdot V(s)\right] \xi(X(s))\right| \\
\leq & C_{\xi}\left|V\left(t_{1}\right)\right| \times\left|\left\{-2 V(s) \cdot \nabla^{2} \xi(X(s)) \cdot V(s)\right\} \xi(X(s))\right| \\
\leq & C_{\xi}\left|V\left(t_{1}\right)\right| \alpha(s)
\end{aligned}
$$

We therefore have from the definition (36):

\begin{aligned}
\left|\frac{d \alpha(s)}{d s}\right| & \leq \xi^{2}(X(s))+\left[\nabla \xi(X(s) \cdot V(s)]^{2}+C_{\xi}\left|V\left(t_{1}\right)\right| \alpha(s)\right. \\
& \leq\left\{C_{\xi}\left|V\left(t_{1}\right)\right|+1\right\} \alpha(s)
\end{aligned}
$$

Our lemma thus follows from the standard Gronwall inequality.
Lemma 6 Let $(t, x, v)$ be connected with $\left(t-t_{\mathbf{b}}, x_{\mathbf{b}}, v\right)$ backward in time through a trajectory of (6).
(1) The backward exit time $t_{\mathbf{b}}(x, v)$ is lower semicontinuous.
(2) If

\begin{equation*}
v \cdot n\left(x_{\mathbf{b}}\right)=v \cdot \frac{\nabla \xi\left(x_{\mathbf{b}}\right)}{\left|\nabla \xi\left(x_{\mathbf{b}}\right)\right|}<0, \tag{38}

$$

then $\left(t_{\mathbf{b}}(x, v), x_{\mathbf{b}}(x, v)\right)$ are smooth functions of $(x, v)$ so that

\nabla_{x} t_{\mathbf{b}} & =\frac{n\left(x_{\mathbf{b}}\right)}{v \cdot n\left(x_{\mathbf{b}}\right)}, \quad \nabla_{v} t_{\mathbf{b}}=\frac{t_{\mathbf{b}} n\left(x_{\mathbf{b}}\right)}{v \cdot n\left(x_{\mathbf{b}}\right)}, \\
\nabla_{x} x_{\mathbf{b}} & =I+\nabla_{x} t_{\mathbf{b}} \otimes v, \quad \nabla_{v} x_{\mathbf{b}}=t_{\mathbf{b}} I+\nabla_{v} t_{\mathbf{b}} \otimes v . \tag{39}
\end{align*}
$$

Furthermore, if $\xi$ is real analytic, then $\left(t_{\mathbf{b}}(x, v), x_{\mathbf{b}}(x, v)\right)$ are also real analytic.
(3) Let $x_{i} \in \partial \Omega$, for $i=1,2$, and let $\left(t_{1}, x_{1}, v\right)$ and $\left(t_{2}, x_{2}, v\right)$ be connected with the trajectory $\frac{d X(s)}{d s}=V(s), \frac{d V(s)}{d s}=0$ which lies inside $\bar{\Omega}$. Then there exists a constant $C_{\xi}>0$ such that

\left|t_{1}-t_{2}\right| \geq \frac{\left|n\left(x_{1}\right) \cdot v\right|}{C_{\xi}|v|^{2}} . \tag{40}
\end{equation*}

(4) Define the boundary mapping

\Phi_{\mathbf{b}}:(t, x, v) \rightarrow\left(t-t_{\mathbf{b}}, x_{\mathbf{b}}(x, v), v\right) \in \mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{-}\right\} . \tag{41}
\end{equation*}
$$

Then $\Phi_{\mathbf{b}}$ and $\Phi_{\mathbf{b}}^{-1}$ maps zero measure sets to zero-measure sets between either $\{t\} \times \Omega \times \mathbf{R}^{3}$ and $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$or $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\} \rightarrow \mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{-}\right\}$.

Proof. (1): We need to show that the set $\left\{(x, v): x \in \Omega\right.$ and $\left.t_{\mathbf{b}}(x, v)>c\right\}$ is open for all $c \in \mathbf{R}$. Let $t_{\mathbf{b}}\left(x_{0}, v_{0}\right)>c+\varepsilon$, for some $\varepsilon>0$ small. From the definition of $t_{\mathbf{b}}(x, v)$ in (7), $x_{0}-s v_{0} \in \Omega$ for all $0 \leq s \leq c+\varepsilon<t_{\mathbf{b}}\left(x_{0}, v_{0}\right)$. Since $\Omega$ is open, we deduce that for $(x, v)$ close to ( $x_{0}, v_{0}$ ), by continuity, $x-v s \in \Omega$ for all $c \leq s \leq c+\varepsilon$. This implies that $t_{\mathbf{b}}(x, v)>c$. Hence $t_{\mathbf{b}}(x, v)$ is lower semicontinuous.

Proof of (2): Since $x_{\mathbf{b}} \in \partial \Omega, \xi\left(x_{\mathbf{b}}(x, v)\right)=\xi\left(x-t_{\mathbf{b}} v\right)=0$. But from (38) and the fact $\left|\nabla \xi\left(x_{\mathbf{b}}\right)\right| \neq 0$, we have

\left.\partial_{t_{\mathbf{b}}} \xi\left(x-t_{\mathbf{b}} v\right)\right|_{t_{\mathbf{b}}}=-v \cdot \nabla \xi\left(x_{\mathbf{b}}\right)>0 .

Therefore, by the Implicit Function Theorem, we can solve for smooth $t_{\mathbf{b}}(x, v)$ and deduce (39). Furthermore, when $\xi$ is analytic, so are $t_{\mathbf{b}}$ and $x_{\mathbf{b}}$ by Theorem 15.3 in [D].

Proof of (3): Notice that for $x_{1} \in \partial \Omega$,

\lim _{\substack{y \rightarrow x_{1} \\ y \in \partial \Omega}} \frac{\left|\left\{x_{1}-y\right\} \cdot n\left(x_{1}\right)\right|}{\left|x_{1}-y\right|}=0 .
$$

Hence, we have $\left|\left\{x_{1}-y\right\} \cdot n\left(x_{1}\right)\right| \leq C_{\xi}\left|x_{1}-y\right|^{2}$ for all $y \in \partial \Omega$. Taking inner product of $x_{1}-x_{2}=v\left(t_{1}-t_{2}\right)$ with $n\left(x_{1}\right)$, we get

C_{\xi}|v|^{2}\left|t_{1}-t_{2}\right|^{2} \geq C_{\xi}\left|x_{1}-x_{2}\right|^{2} \geq\left|\left\{x_{1}-x_{2}\right\} \cdot n\left(x_{1}\right)\right|=\left|v\left(t_{1}-t_{2}\right) \cdot n\left(x_{1}\right)\right| .
$$

We thus deduce (40) by dividing $\left|t_{1}-t_{2}\right|$.
Proof of (4): We define a map from $\mathbf{R} \times \partial \Omega \times \mathbf{R}^{3}$ to $\{t\} \times \mathbf{R}^{3} \times \mathbf{R}^{3}$ as

Recall the boundary map $\Phi_{\mathbf{b}}(t, x, v)$ in (41). From the definition of $t_{\mathbf{b}}$ in (7), $\Phi_{\mathbf{b}}$ is one to one from either from $\{t\} \times \Omega \times \mathbf{R}^{3}$ or from $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$to $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{-}\right\}$. Denote its inverse by $\Phi_{\mathbf{b}}^{-1}$.

In the case that $v \cdot n\left(x_{\mathbf{b}}\right)=0$, i.e., $\Phi_{\mathbf{b}}(t, x, v) \in \gamma_{0}$, the grazing set, then $(t, x, v) \in \Psi_{t}\left(\gamma_{0}\right)$. In (42), $\gamma_{0}$ is characterized by the five-dimensional space: $x^{\prime} \in \partial \Omega, v^{\prime} \cdot n\left(x^{\prime}\right)=0, t^{\prime} \in \mathbf{R}$. Since $\Psi_{t}$ is a smooth map, $\Psi_{t}\left(\gamma_{0}\right)$ is also a fivedimensional space locally at $\left(x^{\prime}, v^{\prime}, t^{\prime}\right) \in \gamma_{0}$. This implies that $\Phi_{\mathbf{b}}^{-1}\left(\gamma^{0}\right) \subset \Psi_{t}\left(\gamma_{0}\right)$ is a zero-measure set in $\{t\} \times \Omega \times \mathbf{R}^{3}$.

In the case that $v \cdot n\left(x_{\mathbf{b}}\right) \neq 0$, we consider the map $\Psi_{t}$ where $\xi\left(x^{\prime}\right)=0$. We may assume that $\partial_{x_{1}} \xi\left(x^{\prime}\right) \neq 0$, and $x_{1}^{\prime}=\eta\left(x_{2}^{\prime}, x_{3}^{\prime}\right)$ with some smooth function $\eta$. Now $\Psi_{t}=\left(t, \eta\left(x_{2}^{\prime}, x_{3}^{\prime}\right)+v_{1}^{\prime}\left(t-t^{\prime}\right), x_{2}^{\prime}+v_{2}^{\prime}\left(t-t^{\prime}\right), x_{3}^{\prime}+v_{3}^{\prime}\left(t-t^{\prime}\right), v^{\prime}\right)$ and we compute the Jacobian matrix of $\Psi_{t}$ for $\left(t^{\prime}, x_{2}^{\prime}, x_{3}^{\prime}, v^{\prime}\right)$ to get

$$
\left(\begin{array}{cccccc}
-v_{1}^{\prime} & \partial_{x_{2}^{\prime}} \eta & \partial_{x_{3}^{\prime}} \eta & t-t^{\prime} & 0 & 0 \\
-v_{2}^{\prime} & 1 & 0 & 0 & t-t^{\prime} & 0 \\
-v_{3}^{\prime} & 0 & 1 & 0 & 0 & t-t^{\prime} \\
0 & 0 & 0 & 1 & 0 & 0 \\
0 & 0 & 0 & 0 & 1 & 0 \\
0 & 0 & 0 & 0 & 0 & 1
\end{array}\right)
$$

and its determinant is exactly $\pm\left\{v^{\prime} \cdot n\left(x^{\prime}\right)\right\} \sqrt{1+|\nabla \eta|^{2}} \neq 0$ if $\left(x^{\prime}, v^{\prime}\right) \notin \gamma_{0}$. Hence, locally, $\Psi_{t}$ is a smooth homeomorphism preserving zero-measure sets away from $\gamma_{0}$. Notice that from the uniqueness in part (2) of Lemma 6, $\Phi_{\mathbf{b}}^{-1}=\Psi_{t}$ and $\Phi_{\mathbf{b}}=\Psi_{t}^{-1}$ locally if $v \cdot n\left(x_{\mathbf{b}}\right) \neq 0$. Hence, for any $k \geq 1$, by a finite covering for a compact set, $\Phi_{\mathbf{b}}^{-1}$ preserves the zero-measure sets on
$A_{k} \equiv\left\{\left(t^{\prime}, x^{\prime}, v^{\prime}\right)\left|x^{\prime} \in \partial \Omega,\left|v^{\prime} \cdot n\left(x^{\prime}\right)\right| \geq \frac{1}{k},\left|v^{\prime}\right| \leq k,\left|t^{\prime}\right| \leq k\right\} \cap \Phi_{\mathbf{b}}\left(\{t\} \times \Omega \times \mathbf{R}^{3}\right)\right.$.
To prove $\Phi_{\mathbf{b}}$ preserves the zero-measure sets between $\{t\} \times \Omega \times \mathbf{R}^{3}$ and $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$, we take any set $S \in \mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$with $|S|=0$. Clearly, $S=$ $\left\{\mathbf{R} \times \gamma_{0} \cap S\right\} \cup_{k=1}^{\infty}\left\{A_{k} \cap S\right\}$. Therefore, $\Phi_{\mathbf{b}}^{-1}(S) \subset \Psi_{t}\left(\gamma_{0}\right) \cup_{k=1}^{\infty} \Phi_{\mathbf{b}}^{-1}\left(A_{k} \cap S\right)$, and $\left|\Phi_{\mathbf{b}}^{-1}\left(A_{k} \cap S\right)\right|=0$ and $\left|\Psi_{t}\left(\gamma_{0}\right)\right|=0$. On the other hand, if $S \in\{t\} \times \Omega \times \mathbf{R}^{3}$, we have $\Phi_{\mathbf{b}}(S)=\left\{\mathbf{R} \times \gamma_{0} \cap \Phi_{\mathbf{b}}(S)\right\} \cup_{k=1}^{\infty}\left\{A_{k} \cap \Phi_{\mathbf{b}}(S)\right\}$. If $|S|=0$, then $\left|A_{k} \cap \Phi_{\mathbf{b}}(S)\right|=0$, because $\Phi_{\mathbf{b}}^{-1}\left\{A_{k} \cap \Phi_{\mathbf{b}}(S)\right\} \subset S$ has measure zero and $\Phi_{\mathbf{b}}=$ $\Psi_{t}^{-1}$ maps zero-measure sets to zero-measure sets.

To prove $\Phi_{\mathbf{b}}$ preserves the zero-measure sets from $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\} \rightarrow \mathbf{R} \times\left\{\gamma_{0} \cup\right.$ $\left.\gamma_{-}\right\}$, we take $S \in \mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$with $|S|=0$. Consider the set $\Phi_{\mathbf{b}}^{-1}\left\{\Phi_{\mathbf{b}}(S) \backslash \gamma_{0}\right\}$. For any point $(t, x, v) \in \Phi_{\mathbf{b}}^{-1}\left\{\Phi_{\mathbf{b}}(S) \backslash \gamma_{0}\right\}$, we know that $v \cdot n\left(x_{\mathbf{b}}\right) \neq 0$. This implies from (40) that $t_{\mathbf{b}}>0$ and $t-t_{\mathbf{b}}<t$. We can choose a fixed $s$ between $t$ and $t-t_{\mathbf{b}}$. Locally around $(t, x, v)$,

$$
\begin{equation*}
\Phi_{\mathbf{b}}=\Phi_{\mathbf{b}}(s) \circ \Psi_{s} . \tag{43}
\end{equation*}
$$

where $\Psi_{s}$ defined in (42) which maps $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$to the plane $\{s\} \times \Omega \times \mathbf{R}^{3}$, and $\Phi_{\mathbf{b}}(s)$ maps $\{s\} \times \Omega \times \mathbf{R}^{3}$ to $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{-}\right\}$. Since $\Phi_{\mathbf{b}}$ is one to one, we have $\Phi_{\mathbf{b}}^{-1}\left\{\Phi_{\mathbf{b}}(S) \backslash \gamma_{0}\right\} \subset S$, so that $\left|\Phi_{\mathbf{b}}^{-1}\left\{\Phi_{\mathbf{b}}(S) \backslash \gamma_{0}\right\}\right|=0$. Therefore, from previous arguments, $\Psi_{s}$ preserves zero-measure sets from $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$to $\{s\} \times \Omega \times \mathbf{R}^{3}$, while $\Phi_{\mathbf{b}}(s)$ preserves zero-measure sets from $\{s\} \times \Omega \times \mathbf{R}^{3}$ set to $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{-}\right\}$. Hence, by (43), $\left|\Phi_{\mathbf{b}}(S) \backslash \gamma_{0}\right|=\left|\Phi_{\mathbf{b}}(s) \circ \Psi_{s}\left[\Phi_{\mathbf{b}}^{-1}\left\{\Phi_{\mathbf{b}}(S) \backslash \gamma_{0}\right\}\right]\right|=0$. We therefore deduce $\left|\Phi_{\mathbf{b}}(S)\right|=0$, for $S$ inside a neighborhood of $(t, x, v)$.

On the other hand, we take $S \in \mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{-}\right\}$with $|S|=0$ and we need to show $\left|\Phi_{\mathbf{b}}^{-1}(S)\right|=0$. For any point $(t, x, v) \in \Phi_{\mathbf{b}}^{-1}(S) \backslash \gamma_{0}, v \cdot n(x) \neq 0$, so that if $\left(t^{\prime}, x^{\prime}, v\right)=\Phi_{\mathbf{b}}(t, x, v)$, then $t^{\prime}<t$. Hence, we again can find $t^{\prime}<s<t$ such that, near $(t, x, v), \Phi_{\mathbf{b}}^{-1}=\Psi_{s}^{-1} \circ \Phi_{\mathbf{b}}^{-1}(s)$ from (43). Since $\left|\Phi_{\mathbf{b}}\left\{\Phi_{\mathbf{b}}^{-1}(S) \backslash \gamma_{0}\right\}\right| \leq$ $|S|=0$, for $\Phi_{\mathbf{b}}^{-1}(S)$ near $(t, x, v),\left\{\Phi_{\mathbf{b}}^{-1}(S) \backslash \gamma_{0}\right\}=\Psi_{s}^{-1} \circ \Phi_{\mathbf{b}}^{-1}(s)\left[\Phi_{\mathbf{b}}\left\{\Phi_{\mathbf{b}}^{-1}(S) \backslash\right.\right.$ $\left.\gamma_{0}\right\}$ ]. It follows (43) again that $\left|\Phi_{\mathbf{b}}^{-1}(S) \backslash \gamma_{0}\right|=0,\left|\Phi_{\mathbf{b}}^{-1}(S)\right|=0$ for $S$ inside a neighborhood of $\left(t-t_{\mathbf{b}}, x_{\mathbf{b}}, v\right)$. The general case follows from a countable covering for $\mathbf{R} \times\left\{\gamma_{0} \cup \gamma_{+}\right\}$and $\{s\} \times \Omega \times \mathbf{R}^{3}$.

Lemma 7 Recall (9) and the Grad estimate [Gr2] for hard potentials:

\begin{equation*}
\left|K\left(v, v^{\prime}\right)\right| \leq C\left\{\left|v-v^{\prime}\right|+\left|v-v^{\prime}\right|^{-1}\right\} e^{-\frac{1}{8}\left|v-v^{\prime}\right|^{2}-\frac{1}{8} \frac{\|\left. v\right|^{2}-\left.\left|v^{\prime}\right|^{2}\right|^{2}}{\left|v-v^{\prime}\right|^{2}}} \tag{44}
\end{equation*}
$$

Recall $w$ in (20). Then there exists $0 \leq \varepsilon(\theta)<1$ and $C_{\theta}>0$ such that for $0 \leq \varepsilon<\varepsilon(\theta)$,

$$
\begin{equation*}
\int\left\{\left|v-v^{\prime}\right|+\left|v-v^{\prime}\right|^{-1}\right\} e^{-\frac{1-\varepsilon}{8}\left|v-v^{\prime}\right|^{2}-\frac{1-\varepsilon}{8} \frac{\|\left. v\right|^{2}-\left.\left|v^{\prime}\right|^{2}\right|^{2}}{\left|v-v^{\prime}\right|^{2}}} \frac{w(v)}{w\left(v^{\prime}\right)} d v^{\prime} \leq \frac{C}{1+|v|} \tag{45}
\end{equation*}
$$

Proof. By (20), we first notice that for some $C_{\rho, \beta}>0$,

$$
\left|\frac{w(v)}{w\left(v^{\prime}\right)}\right| \leq C\left[1+\left|v-v^{\prime}\right|^{2}\right]^{|\beta|} e^{-\theta\left\{\left|v^{\prime}\right|^{2}-|v|^{2}\right\}}
$$

Let $v-v^{\prime}=\eta$ and $v^{\prime}=v-\eta$ in the integral of (45). By (44), we now compute the total exponent in $K\left(v, v^{\prime}\right) \frac{w(v)}{w\left(v^{\prime}\right)}$ as:

$$
\begin{aligned}
& -\frac{1}{8}|\eta|^{2}-\frac{1}{8} \frac{\|\left.\eta\right|^{2}-\left.2 v \cdot \eta\right|^{2}}{|\eta|^{2}}-\theta\left\{|v-\eta|^{2}-|v|^{2}\right\} \\
= & -\frac{1}{4}|\eta|^{2}+\frac{1}{2} v \cdot \eta-\frac{1}{2} \frac{|v \cdot \eta|^{2}}{|\eta|^{2}}-\theta\left\{|\eta|^{2}-2 v \cdot \eta\right\} \\
= & \left(-\theta-\frac{1}{4}\right)|\eta|^{2}+\left(\frac{1}{2}+2 \theta\right) v \cdot \eta-\frac{1}{2} \frac{\{v \cdot \eta\}^{2}}{|\eta|^{2}} .
\end{aligned}
$$

Since $\theta<\frac{1}{4}$, the discriminant of the above quadratic form of $|\eta|$ and $\frac{v \cdot \eta}{|\eta|}$ is

$$
\Delta=\left(\frac{1}{2}+2 \theta\right)^{2}+2\left(-\theta-\frac{1}{4}\right)=4 \theta^{2}-\frac{1}{4}<0
$$

Hence, the quadratic form is negative definite. We thus have, for $\varepsilon>0$ sufficiently small, there is $C_{\theta}>0$ such that the following perturbed quadratic form is still negative definite

$$
\begin{align*}
& -\frac{1-\varepsilon}{8}|\eta|^{2}-\frac{1-\varepsilon}{8} \frac{\|\left.\eta\right|^{2}-\left.2 v \cdot \eta\right|^{2}}{|\eta|^{2}}-\theta\left\{|\eta|^{2}-2 v \cdot \eta\right\} \\
\leq & -C_{\theta}\left\{|\eta|^{2}+\frac{|v \cdot \eta|^{2}}{|\eta|^{2}}\right\}=-C_{\theta}\left\{\frac{|\eta|^{2}}{2}+\left(\frac{|\eta|^{2}}{2}+\frac{|v \cdot \eta|^{2}}{|\eta|^{2}}\right)\right\} \\
\leq & -C_{\theta}\left\{\frac{|\eta|^{2}}{2}+|v \cdot \eta|\right\} . \tag{46}
\end{align*}
$$

Therefore, for given $|v| \geq 1$, we make another change of variable $\eta_{\| \prime}=\left\{\eta \cdot \frac{v}{|v|}\right\} \frac{v}{|v|}$, and $\eta_{\perp}=\eta-\eta_{\| \mid}$so that $|v \cdot \eta|=|v|\left|\eta_{\| \prime}\right|$ and $\left|v-v^{\prime}\right| \geq\left|\eta_{\perp}\right|$. We can absorb $\left\{1+|\eta|^{2}\right\}^{|\beta|},|\eta|\left\{1+|\eta|^{2}\right\}^{|\beta|}$ by $e^{\frac{C_{\theta}}{4}|\eta|^{2}}$, and bound the integral in (45) by (46):

\begin{aligned}
& C_{\beta} \int_{\mathbf{R}^{2}}\left(\frac{1}{\left|\eta_{\perp}\right|}+1\right) e^{-\frac{C_{\theta}}{4}|\eta|^{2}}\left\{\int_{-\infty}^{\infty} e^{-C_{\theta}|v| \times\left|\eta_{\| \mid}\right|} d\left|\eta_{\| \mid}\right|\right\} d \eta_{\perp} \\
\leq & \frac{C_{\beta}}{|v|} \int_{\mathbf{R}^{2}}\left(\frac{1}{\left|\eta_{\perp}\right|}+1\right) e^{-\frac{C_{\theta}}{4}\left|\eta_{\perp}\right|^{2}}\left\{\int_{-\infty}^{\infty} e^{-C_{\theta}|y|} d y\right\} d \eta_{\perp} \quad\left(y=|v| \times\left|\eta_{\| \mid}\right|\right) .
\end{aligned}
$$

We thus deduce our lemma since both integrals are finite.
Lemma 8 Let $\kappa(y)$ be a real analytic function of $y \in \mathbf{R}^{n}$ in a region such that $\kappa(y)$ is not identically zero. Then the set $\{y: \kappa(y)=0\}$ has zero $n$-dimensional Lebesque measure.

Proof. We use an induction on the dimension $n$. When $n=1$, we assume $\kappa\left(y^{0}\right)=0$. Since $\kappa$ is analytic, for $y$ near $y^{0}$, we have

$$
\kappa(y)=\kappa\left(y^{0}\right)+\sum_{k=1}^{\infty} \frac{\kappa^{(k)}\left(y^{0}\right)}{k!}\left(y-y^{0}\right)^{k} .
$$

Since $\kappa(y)$ is not identically zero, we can always assume a smallest $k_{1}$ such that $\frac{\kappa^{\left(k_{1}\right)}\left(y^{0}\right)}{k_{1}!} \neq 0$. We therefore can rewrite

$$
\kappa(y)=\left(y-y^{0}\right)^{k_{1}} \times\left\{\sum_{k \geq k_{1}}^{\infty} \frac{\kappa^{(k)}\left(y^{0}\right)}{k!}\left(y-y^{0}\right)^{k-k_{1}}\right\} .
$$

Hence $\kappa(y)=0$ for $y-y^{0}$ sufficiently small implies $y=y^{0}$ (an isolated point), which has zero one dimensional measure.

Assume that the lemma is valid for $m$. For $m+1$ dimensional case, we assume $\kappa\left(y^{0}\right)=0$. We first notice that by finite open coverings for any compact subset, it suffices to show that for any $y^{0}$ such that $\kappa\left(y^{0}\right)=0$, then there is a ball $\left\{y:\left|y-y^{0}\right|<\delta\right\}$ such that $\left|\left\{y:\left|y-y^{0}\right|<\delta, \kappa(y)=0\right\}\right|=0$.

Now for any $y \neq y^{0}$ and $\left|y-y^{0}\right|<\delta$, since $\kappa(y)$ is real analytic, we have

$$
\kappa(y)=\kappa\left(y_{0}\right)+\sum_{|k|=1}^{\infty} \frac{\kappa^{(k)}\left(y^{0}\right)}{k!}\left(y-y^{0}\right)^{k}
$$

where the multi-index $k=\left[k_{1}, k_{2}, \ldots, k_{m}\right], k!=k_{1}!k_{2}!\ldots k_{m}!$, while $\left(y-y^{0}\right)^{k}=$ $\Pi_{l=1}^{m}\left(y_{l}-y_{l}^{0}\right)^{k_{l}}$. Since $\kappa(y)$ is not identically zero, there exists $\bar{k}$ such that $\kappa^{(\bar{k})}\left(y^{0}\right) \neq 0$. Without loss of generality, we can further assume that $\bar{k}_{1} \neq 0$, so that $\left(y-y^{0}\right)^{k_{1}}$ contains the factor $\left(y_{1}-y_{1}^{0}\right)^{\bar{k}_{1}}$. Furthermore, we can assume $\bar{k}_{1} \geq 0$ is the smallest among those non-zero terms, so that every term $\left(y-y^{0}\right)^{k}$ contains the common factor $\left(y_{1}-y_{1}^{0}\right)^{\bar{k}_{1}}$. We therefore can rewrite:

$$
\kappa(y)=\left(y_{1}-y_{1}^{0}\right)^{\bar{k}_{1}}\left\{\sum \frac{\kappa^{(k)}\left(y^{0}\right)}{k!}\left(y-y^{0}\right)^{k-\bar{k}_{1}}\right\} .
$$

For $y_{1} \neq y_{1}^{0}, \kappa(y)=0$ implies

$$
\begin{equation*}
\kappa_{1}(y) \equiv \sum \frac{\kappa^{(k)}\left(y^{0}\right)}{k!}\left(y-y^{0}\right)^{k-\bar{k}_{1}}=0 \tag{47}
\end{equation*}
$$

Clearly, for any given $y_{1}, \kappa_{1}\left(y_{1}, y_{2}, \ldots, y_{m+1}\right)$ is an analytical function for $m$ variables $\tilde{y}=\left[y_{2}, \ldots, y_{m+1}\right]$. Therefore, for fixed $y_{1}$, we can expand $\kappa_{1}\left(y_{1}, \tilde{y}\right)$ around $\left[y_{2}^{0}, \ldots, y_{m+1}^{0}\right]$ to get

$$
\kappa_{1}\left(y_{1}, \tilde{y}\right) \equiv \sum_{k=\left[0, k_{2}, k_{3}, \ldots, k_{m+1}\right]} \frac{\kappa_{1}^{(k)}\left(y_{1}, y_{2}^{0}, \ldots, y_{m+1}^{0}\right)}{k!}\left(\tilde{y}-\tilde{y}^{0}\right)^{k}
$$

Since by our choices of $\bar{k}$ and $\bar{k}_{1}$, the multi-index $\bar{k}-\bar{k}_{1}=\left[0, \bar{k}_{2}, \ldots, \bar{k}_{m+1}\right]$, and we can consider the term

$$
\frac{\kappa_{1}^{\left(\bar{k}-\bar{k}_{1}\right)}\left(y_{1}, y_{2}^{0}, \ldots, y_{m+1}^{0}\right)}{\left(\bar{k}-\bar{k}_{1}\right)!}\left(\tilde{y}-\tilde{y}^{0}\right)^{\bar{k}-\bar{k}_{1}}
$$

We compute $\kappa_{1}^{\left(\bar{k}-\bar{k}_{1}\right)}$ from (47) as
$\left.\kappa_{1}^{\left(\bar{k}-\bar{k}_{1}\right)}\left(y_{1}, y_{2}^{0}, \ldots, y_{m+1}^{0}\right)\right|_{y_{1}=y_{1}^{0}}=\sum \frac{\kappa^{(k)}\left(y^{0}\right)}{k!} \partial^{\bar{k}-\bar{k}_{1}}\left\{\left(y-y^{0}\right)^{k-\bar{k}_{1}}\right\}=\frac{\left(\bar{k}-\bar{k}_{1}\right)!\kappa^{(\bar{k})}\left(y^{0}\right)}{\bar{k}!} \neq 0$,
by our choices of $\bar{k}$ and $\bar{k}_{1}$. From the continuity of $\kappa_{1}^{\left(\bar{k}-\bar{k}_{1}\right)}\left(y_{1}, y_{2}^{0}, \ldots, y_{m+1}^{0}\right)$ with respect to $y_{1}$, for $\left|y_{1}-y_{1}^{0}\right|<\delta$ small, we deduce that

$$
\kappa_{1}^{\left(\bar{k}-\bar{k}_{1}\right)}\left(y_{1}, y_{2}^{0}, \ldots, y_{m+1}^{0}\right) \neq 0
$$

Therefore, $\kappa_{1}\left(y_{1}, y_{2}, \ldots, y_{m+1}\right)$ is an analytical function which is not identically zero for all $\left|y-y^{0}\right|<\delta$ sufficiently small. By the induction hypothesis, for
any fixed $y_{1}, \kappa_{1}\left(y_{1}, y_{2}, \ldots, y_{m+1}\right)=0$ is a set of $m$-dimensional Lebesque zero measure set for $y_{2}, y_{3}, \ldots y_{m+1}$. We now apply the Fubini theorem to compute

$$
\begin{aligned}
\mid\left\{\kappa_{1}(y)\right. & \left.=0,\left|y-y^{0}\right|<\delta\right\} \mid=\int_{\mathbf{R}^{m+1}} \mathbf{1}_{\left\{\kappa_{1}(y)=0\right\}}\left(y_{1}, y_{2}, \ldots, y_{m+1}\right) \mathbf{1}_{\left|y-y^{0}\right|<\delta} \\
& =\int_{\mathbf{R}}\left(\int_{\mathbf{R}^{m}} \mathbf{1}_{\left\{\kappa_{1}(y)=0\right\}}\left(y_{1}, y_{2}, \ldots, y_{m+1}\right) \mathbf{1}_{\left|y-y^{0}\right|<\delta} d y_{2} d y_{3} \ldots d y_{m+1}\right) d y_{1} \\
& \leq \int_{\mathbf{R}}\left|\left\{\left(y_{2}, y_{3}, \ldots, y_{m+1}\right): \kappa_{1}\left(y_{1}, y_{2}, \ldots, y_{m+1}\right)=0,\left|y-y^{0}\right|<\delta\right\}\right| d y_{1} \\
& =0
\end{aligned}
$$

Therefore, inside $\left|y-y^{0}\right|<\delta$ for $\delta$ sufficiently small, we have

$$
\{y: \kappa(y)=0\} \subset\left\{y_{1}=y_{1}^{0}\right\} \cup\left\{\kappa_{1}(y)=0\right\}
$$

and both sets have zero $(m+1)$ - dimensional Lebesque measure.
Lemma 9 Recall (20) and (10). We have

$$
\left|w \Gamma\left[g_{1}, g_{2}\right](v)\right| \leq C\left\{w(v)(|v|+1)^{\gamma}\left|g_{1}(v)\right|+\left\|w g_{1}\right\|_{\infty}\right\}\left\|w g_{2}\right\|_{\infty}
$$

Proof. First consider the second term $\Gamma_{\text {loss }}$ in (10). We have

\int_{\mathbf{R}^{3}}|u-v|^{\gamma}\left|\mu^{1 / 2}(u) g_{2}(x, u)\right| d u \leq C\{|v|+1\}^{\gamma}\left\|w g_{2}\right\|_{\infty}
$$

Hence $w \Gamma_{\text {loss }}\left[g_{1}, g_{2}\right]$ is bounded by

$$
w\left|g_{1}\right| \int|u-v|^{\gamma}\left|\mu^{1 / 2}(u) g_{2}(x, u)\right| d u \leq C w(v)\{|v|+1\}^{\gamma}\left|g_{1}(v)\right| \times\left\|w g_{2}\right\|_{\infty}
$$

For $\Gamma_{\text {gain }}$ in (10), by $\left|u^{\prime}\right|^{2}+\left|v^{\prime}\right|^{2}=|u|^{2}+|v|^{2}, w(v) \leq C w\left(v^{\prime}\right) w\left(u^{\prime}\right)$, and

$$
\begin{gathered}
\int q_{0}(\theta)|u-v|^{\gamma} e^{-|u-v|^{2} / 4} w(v)\left|g_{1}\left(u^{\prime}\right) g_{2}\left(v^{\prime}\right)\right| d \omega d u \\
\leq \int q_{0}(\theta)|u-v|^{\gamma} e^{-|u-v|^{2} / 4} w\left(u^{\prime}\right) w\left(v^{\prime}\right)\left|g_{1}\left(u^{\prime}\right) g_{2}\left(v^{\prime}\right)\right| d \omega d u \\
\leq\left\|w g_{1}\right\|_{\infty} \times\left\|w_{2} g_{2}\right\|_{\infty} \int|u-v|^{\gamma} e^{-|u-v|^{2} / 4} d u
\end{gathered}
$$

Since $0 \leq \gamma \leq 1$, this completes the proof.

## $3 \quad L^{2}$ Decay Theory

We define the boundary integration for $g(x, v), x \in \partial \Omega$,

$$
\begin{equation*}
\int_{\gamma_{ \pm}} g d \gamma=\int_{\gamma_{ \pm}} g(x, v)\left|n_{x} \cdot v\right| d S_{x} d v \tag{48}
\end{equation*}
$$

where $d S_{x}$ is the standard surface measure on $\partial \Omega$. We also define $\|h\|_{\gamma}=$ $\|h\|_{\gamma_{+}}+\|h\|_{\gamma_{-}}$to be the $L^{2}(\gamma)$ with respect to the measure $\left|n_{x} \cdot v\right| d S_{x} d v$. For fixed $x \in \partial \Omega$, denote the boundary inner product over $\gamma_{ \pm}$in $v$ as

$$
\left\langle g_{1}, g_{2}\right\rangle_{\gamma_{ \pm}}(t, x)=\int_{ \pm v \cdot n(x)>0} g_{1}(t, x, v) g_{2}(t, x, v)|n(x) \cdot v| d v
$$

By (15), we also define a different $L_{v}^{2}$-projection for any boundary function $g(x, v)$ toward the unit vector $\sqrt{c_{\mu} \mu(v)}$ with respect to $\langle\cdot, \cdot\rangle$ as:

$$
\begin{equation*}
P_{\gamma} g=\left\{\int_{n(x) \cdot v>0} g(t, x, v) \sqrt{\mu(v)} n(x) \cdot v d v\right\} c_{\mu} \sqrt{\mu(v)} \tag{49}
\end{equation*}
$$

Our main theorem of this section is
Theorem 10 Let $f(t, x, v) \in L^{2}$ be the (unique) solution to the linear Boltzmann equation (23) with trace $f_{\gamma} \in L_{l o c}^{2}\left(\mathbf{R}_{+} ; L^{2}(\gamma)\right)$.
(1) If $f$ satisfies the in-flow boundary condition (11), then there exists $\lambda>0$ and $C>0$ such that for all $0 \leq t \leq \infty$,

$$
e^{2 \lambda t}\|f(t)\|^{2} \leq 2\left\{\|f(0)\|^{2}+\int_{0}^{t} e^{2 \lambda s}\|g(s)\|_{\gamma_{-}}^{2} d s\right\}
$$

(2) Let $f$ satisfy the bounce-back boundary condition (12), then there exists $\lambda>0$ and $C>0$ such that $\sup _{0 \leq t \leq \infty}\left\{e^{2 \lambda t}\|f(t)\|^{2}\right\} \leq 2\|f(0)\|^{2}$.
(3) Let $f$ satisfy the specular reflection condition (14), and the mass and energy conservation laws (17) and (18). In the case $\Omega$ has any axis of rotational symmetry (5), we further require that the corresponding conservation of the angular momentum (19). Then there exists $\lambda>0$ and $C>0$ such that $\sup _{0 \leq t \leq \infty}\left\{e^{2 \lambda t}\|f(t)\|^{2}\right\} \leq 2\|f(0)\|^{2}$.
(4) If $f$ satisfies the diffusive boundary condition (16) and the mass conservation (17), then there exists $\lambda>0$ and $C>0$ such that $\sup _{0 \leq t \leq \infty}\left\{e^{2 \lambda t}\|f(t)\|^{2}\right\} \leq$ $2\|f(0)\|^{2}$.

We remark that the existence of such a $L^{2}$ solution $f$ with its trace $f_{\gamma} \in$ $L_{\text {loc }}^{2}\left(\mathbf{R}_{+} ; L^{2}(\gamma)\right)$ (which guarantees the uniqueness) is in general not known for the bounce-back and specular boundary conditions within $L^{2}$ framework. This is due to the possible blow-up of $L_{\mathrm{loc}}^{2}\left(\mathbf{R}_{+} ; L^{2}(\gamma)\right)$ at the grazing set $\gamma_{0}$. See [BP], [CIP] and [U1] for more details. On the other hand, $\int_{0}^{t}\|f(s)\|_{\gamma}^{2} d s<\infty$ will be established by the study of (27) in Theorems 28, 35] and 41 with property $h=w f \in L^{\infty}$ and $h=w f \in L^{\infty}(\gamma)$. We mainly will establish the following:

Proposition 11 (1) There exists $M>0$ such that for any solution $f(t, x, v)$ to the linearized Boltzmann equation (23),

$$
\begin{equation*}
\int_{0}^{1}\|\mathbf{P} f(s)\|_{\nu}^{2} d s \leq M\left\{\int_{0}^{1}\|(\mathbf{I}-\mathbf{P}) f(s)\|_{\nu}^{2} d s+\int_{0}^{1}\|f(s)\|_{\gamma}^{2} d s\right\} \tag{50}
\end{equation*}
$$

(2) There exists $M>0$ such that for any solution $f(t, x, v)$ to the linearized Boltzmann equation (23) satisfying the bounce-back boundary condition (12) and the mass-energy conservation laws (17) and (18), we have

$$
\begin{equation*}
\int_{0}^{1}\|\mathbf{P} f(s)\|_{\nu}^{2} d s \leq M \int_{0}^{1}\|(\mathbf{I}-\mathbf{P}) f(s)\|_{\nu}^{2} d s \tag{51}
\end{equation*}
$$

(3) There exists $M>0$ such that for any solution $f(t, x, v)$ to the linearized Boltzmann equation (23) satisfying the specular reflection condition (14) and the mass-energy conservation laws (17) and (18), (in the case $\Omega$ has any axis of rotational symmetry (5), we further assume conservation of the angular momentum (19)), estimate (51) is valid.
(4) There exists $M>0$ such that for any solution $f(t, x, v)$ solution to the linearized Boltzmann equation (23) satisfying the diffusive boundary condition (16) and the mass conservation (17),

$$
\begin{equation*}
\int_{0}^{1}\|\mathbf{P} f(s)\|_{\nu}^{2} d s \leq M\left\{\int_{0}^{1}\|(\mathbf{I}-\mathbf{P}) f(s)\|_{\nu}^{2} d s+\int_{0}^{1}\left\|\left\{I-P_{\gamma}\right\} f(s)\right\|_{\gamma_{+}}^{2} d s\right\} \tag{52}
\end{equation*}
$$

We first show that Proposition 11 implies Theorem 10
Proof. of Theorem 10, For any solution $f$ to the linear Boltzmann equation (23), $e^{\lambda t} f(t)$ satisfies

$$
\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+L\right\}\left\{e^{\lambda t} f\right\}-\lambda e^{\lambda t} f=0 \tag{53}
\end{equation*}
$$

Let $0 \leq N \leq t \leq N+1, N$ being an integer. We split $[0, t]=[0, N] \cup[N, t]$.
For the time interval $[N, t]$, since $f_{\gamma} \in L_{\text {loc }}^{2}\left(\mathbf{R}_{+} ; L^{2}(\gamma)\right), \int_{N}^{t}\|f(s)\|_{\gamma}^{2} d s<\infty$. We then establish the $L^{2}$ energy estimate for $[N, t]$ as

$$
\begin{equation*}
\|f(t)\|^{2}+\int_{N}^{t}(L f, f) d s+\int_{N}^{t} \int_{\gamma_{+}} f^{2}(s) d \gamma d s=\|f(N)\|^{2}+\int_{N}^{t} \int_{\gamma_{-}} f^{2}(s) d \gamma d s \tag{54}
\end{equation*}
$$

For the time interval $[0, N]$, (we may assume $N \geq 1$ ), since $f_{\gamma} \in L_{\text {loc }}^{2}\left(\mathbf{R}_{+} ; L^{2}(\gamma)\right.$ ), $\int_{0}^{N}\|f(s)\|_{\gamma}^{2} d s<\infty$. We multiply $e^{\lambda t} f$ with (53) and take $L^{2}$ energy estimate over $0 \leq s \leq N$ :

$$
\begin{aligned}
& e^{2 \lambda N}\|f(N)\|^{2}+\int_{0}^{N} e^{2 \lambda s}(L f, f) d s-\lambda \int_{0}^{N} e^{2 \lambda s}\|f(s)\|^{2} d s \\
= & \|f(0)\|^{2}+\int_{0}^{N} \int_{\gamma_{-}} e^{2 \lambda s} f^{2}(s) d \gamma d s-\int_{0}^{N} \int_{\gamma_{+}} e^{2 \lambda s} f^{2}(s) d \gamma d s
\end{aligned}
$$

Dividing the time interval into $\cup_{k=0}^{N-1}[k, k+1)$ and letting $f_{k}(s, x, v) \equiv f(k+$ $s, x, v)$ for $k=0,1,2 \ldots N-1$, we deduce

$$
\begin{align*}
& e^{2 \lambda N}\|f(N)\|^{2}+\sum_{k=0}^{N-1} \int_{0}^{1}\left\{e^{2 \lambda\{k+s\}}\left(L f_{k}, f_{k}\right)-\lambda e^{2 \lambda\{k+s\}}\left\|f_{k}(s)\right\|^{2}\right\} d s  \tag{55}\\
= & \|f(0)\|^{2}+\sum_{k=0}^{N-1}\left\{\int_{0}^{1} \int_{\gamma_{-}} e^{2 \lambda\{k+s\}} f_{k}^{2}(s) d \gamma d s-\int_{0}^{1} \int_{\gamma_{+}} e^{2 \lambda\{k+s\}} f_{k}^{2}(s) d \gamma d s\right\} .
\end{align*}
$$

Notice that $f_{k}(k+s, x, v)$ satisfies the same linearized Boltzmann equation (23) for $0 \leq s \leq 1$.

In-flow boundary condition (11): Multiplying $\delta_{0} e^{2 \lambda k}$ with (50) to each $f_{k}(s, x, v)$ and then summing up over $k$ yields
$\frac{\delta_{0}}{2} \sum_{k=0}^{N-1}\left\{e^{2 \lambda k} \int_{0}^{1}\left\|\{\mathbf{I}-\mathbf{P}\} f_{k}\right\|_{\nu}^{2} d s+e^{2 \lambda k} \int_{0}^{1} \int_{\gamma} f_{k}^{2}(s) d \gamma d s\right\} \geq \frac{\delta_{0}}{2 M} \sum_{k=0}^{N-1} e^{2 \lambda k} \int_{0}^{1}\left\|\mathbf{P} f_{k}\right\|_{\nu}^{2} d s$.
Note that $\int_{\gamma}=\int_{\gamma_{+}}+\int_{\gamma_{-}}$, is the total boundary integration. Since

$$
\left(L f_{k}, f_{k}\right) \geq \delta_{0}\left\|\{\mathbf{I}-\mathbf{P}\} f_{k}\right\|_{\nu}^{2}=\frac{\delta_{0}}{2}\left\|\{\mathbf{I}-\mathbf{P}\} f_{k}\right\|_{\nu}^{2}+\frac{\delta_{0}}{2}\left\|\{\mathbf{I}-\mathbf{P}\} f_{k}\right\|_{\nu}^{2}
$$

and $e^{2 \lambda k s} \geq 1$, we apply (56) to the first copy of $\frac{\delta_{0}}{2}\left\|\{\mathbf{I}-\mathbf{P}\} f_{k}\right\|_{\nu}^{2}$ in (55), and move the boundary integrals in (56) to the right hand side of (55). Hence,

$$
\begin{aligned}
& e^{2 \lambda N}\|f(N)\|^{2}+\frac{\delta_{0}}{2 M} \sum_{k=0}^{N-1} \int_{0}^{1} e^{2 \lambda k}\left\|\mathbf{P} f_{k}\right\|_{\nu}^{2} d s+\frac{\delta_{0}}{2} \sum_{k=0}^{N-1} \int_{0}^{1} e^{2 \lambda k}\left\|\{\mathbf{I}-\mathbf{P}\} f_{k}\right\|_{\nu}^{2} d s \\
& -C_{\nu} \lambda \sum_{k=0}^{N-1} \int_{0}^{1} e^{2 \lambda\{k+s\}}\left\|f_{k}(s)\right\|_{\nu}^{2} d s \\
\leq & \|f(0)\|^{2}+\left(1+\frac{\delta_{0}}{2}\right) \sum_{k=0}^{N-1} \int_{0}^{1} \int_{\gamma_{-}} e^{2 \lambda\{k+s\}} g_{k}^{2}(s) d \gamma d s-\left(1-\frac{\delta_{0}}{2}\right) \sum_{k=0}^{N-1} \int_{0}^{1} \int_{\gamma_{+}} e^{2 \lambda\{k+s\}} f_{k}^{2}(s) d \gamma d s .
\end{aligned}
$$

Here we have used the fact $\|\cdot\| \leq C_{\nu}\|\cdot\|_{\nu}$ for hard potentials, and the in-flow boundary condition $f_{k}=g_{k}$ on $\gamma_{-}$. Combining $\mathbf{P} f_{k}$ with $\{\mathbf{I}-\mathbf{P}\} f_{k}$, and note $e^{2 \lambda k}=e^{2 \lambda\{k+s\}} e^{-2 \lambda s} \geq e^{2 \lambda\{k+s\}} e^{-2 \lambda}$, we obtain a positive lower bound in the left hand side:

$$
\left(\min \left\{\frac{\delta_{0}}{2}, \frac{\delta_{0}}{2 M}\right\} e^{-2 \lambda}-C_{\nu} \lambda\right) \sum_{k=0}^{N-1} \int_{0}^{1} e^{2 \lambda\{k+s\}}\left\|f_{k}(s)\right\|_{\nu}^{2} d s>0
$$

for $C_{\nu} \lambda<\min \left\{\frac{\delta_{0}}{4}, \frac{\delta_{0}}{4 M}\right\} e^{-2 \lambda}$. Changing back to $f_{k}(t)=f(t+k)$ and letting $1-\frac{\delta_{0}}{2}>0$, we deduce

$$
\begin{equation*}
e^{2 \lambda N}\|f(N)\|^{2} \leq\|f(0)\|^{2}+\left(1+\frac{\delta_{0}}{2}\right) \int_{0}^{N} \int_{\gamma_{-}} e^{2 \lambda s} g^{2}(s) d \gamma d s \tag{57}
\end{equation*}
$$

Notice that $e^{2 \lambda t} \leq e^{2 \lambda\{t-N\}} e^{2 \lambda s}$ for $s \geq N$, and since $t \leq N+1$, we can choose for $\delta_{0}$ and $\lambda$ small such that $e^{2 \lambda(t-N)}\left(1+\frac{\delta_{0}}{2}\right) \leq 2$. Hence, multiplying
$e^{2 \lambda t}$ with (54) and combining with (57) yields

$$
\begin{aligned}
& e^{2 \lambda t}\|f(t)\|^{2}+e^{2 \lambda t} \int_{N}^{t} \int_{\gamma_{+}} f^{2}(s) d \gamma d s \leq e^{2 \lambda t}\|f(N)\|^{2}+e^{2 \lambda t} \int_{N}^{t} \int_{\gamma_{-}} g^{2}(s) d \gamma d s \\
\leq & e^{2 \lambda\{t-N\}}\left\{\|f(0)\|^{2}+\left(1+\frac{\delta_{0}}{2}\right) \int_{0}^{N} \int_{\gamma_{-}} e^{2 \lambda s} g^{2}(s) d \gamma d s\right\} \\
& +e^{2 \lambda\{t-N\}} \int_{N}^{t} \int_{\gamma_{-}} e^{2 \lambda s} g^{2}(s) d \gamma d s \\
\leq & 2\left\{\|f(0)\|^{2}+\int_{0}^{t} \int_{\gamma_{-}} e^{2 \lambda s} g^{2}(s) d \gamma d s\right\} .
\end{aligned}
$$

Bounce-back and specular reflections (12) and (14). In both cases, the total boundary contribution in (55) vanishes:

$$
\begin{equation*}
\sum_{k=0}^{N-1} \int_{0}^{1} \int_{\gamma_{-}} e^{2 \lambda\{k+s\}} f_{k}^{2}(s) d \gamma d s-\sum_{k=0}^{N-1} \int_{0}^{1} \int_{\gamma_{+}} e^{2 \lambda\{k+s\}} f_{k}^{2}(s) d \gamma d s=0 \tag{58}
\end{equation*}
$$

For $N \leq t<N+1$, we use the same procedure as in the in-flow case (55) and the positivity (51) to get
$e^{2 \lambda N}\|f(N)\|^{2}+\left(\min \left\{\frac{\delta_{0}}{2}, \frac{\delta_{0}}{2 M}\right\} e^{-2 \lambda}-C_{\nu} \lambda\right) \sum_{k=0}^{N-1} \int_{0}^{1} e^{2 \lambda\{k+s\}}\left\|f_{k}(s)\right\|_{\nu}^{2} d s \leq\|f(0)\|^{2}$.
For $C_{\nu} \lambda=\min \left\{\frac{\delta_{0}}{4}, \frac{\delta_{0}}{4 M}\right\} e^{-2 \lambda}>0$, changing back to the original $f(k+s)$ leads to

$$
\begin{equation*}
e^{2 \lambda N}\|f(N)\|^{2} \leq\|f(0)\|^{2} \tag{59}
\end{equation*}
$$

By (54) and (58), $\|f(t)\| \leq\|f(N)\|$. We deduce if $e^{2 \lambda(t-N)} \leq 2$

$$
e^{2 \lambda t}\|f(t)\|^{2} \leq e^{2 \lambda t}\|f(N)\|^{2} \leq e^{2 \lambda(t-N)}\|f(0)\|^{2} \leq 2\|f(0)\|^{2}
$$

Diffuse boundary reflection (16). We note from (16) and (49) that $\int_{\gamma_{-}} f^{2}(s) d \gamma=\int_{\gamma_{+}}\left[P_{\gamma} f(s)\right]^{2} d \gamma$, so that the boundary contribution in (55) is

$$
\int_{0}^{1} \int_{\gamma_{-}} e^{2 \lambda\{k+s\}} f(s)^{2} d \gamma d s-\int_{0}^{1} \int_{\gamma_{+}} e^{2 \lambda\{k+s\}} f^{2}(s) d \gamma d s=-\int_{0}^{1} \int_{\gamma_{+}} e^{2 \lambda s}\left[\left\{I-P_{\gamma}\right\} f(s)\right]^{2} d \gamma d s
$$

By the same procedure, we obtain from (55) and the positivity (52):

$$
\begin{aligned}
& e^{2 \lambda N}\|f(N)\|^{2}+\left(\min \left\{\frac{\delta_{0}}{2}, \frac{\delta_{0}}{2 M}\right\} e^{-2 \lambda}-C_{\nu} \lambda\right) \sum_{k=0}^{N-1} \int_{0}^{1} e^{2 \lambda\{k+s\}}\left\|f_{k}(s)\right\|_{\nu}^{2} d s \\
\leq & \|f(0)\|^{2}-\left(1-\frac{\delta_{0}}{2}\right) \sum_{k=0}^{N-1} \int_{0}^{1} \int_{\gamma_{+}} e^{2 \lambda\{k+s\}}\left[\left\{I-P_{\gamma}\right\} f(s)\right]^{2} d \gamma d s .
\end{aligned}
$$

For $\frac{\delta_{0}}{2}<1$ and $C_{\nu} \lambda<\min \left\{\frac{\delta_{0}}{4}, \frac{\delta_{0}}{4 M}\right\} e^{-2 \lambda}$, we have

$$
e^{2 \lambda N}\|f(N)\|^{2} \leq\|f(0)\|^{2}
$$

Since for $[N, t]$, we have $\|f(t)\|^{2} \leq\|f(N)\|^{2}$, from (54). We therefore conclude the proposition for $e^{2 \lambda(t-N)} \leq 2$.

### 3.1 Strategy for the Proof of Prop. 11

The rest of this section is devoted entirely to the proof of the crucial Proposition 11. The proof of Proposition 11 is based on a contradiction argument. If Proposition 11 were false, then there are no $M$ exists as in Proposition 11 for every linear Boltzmann solution. Hence, for any $k \geq 1$, there exists a sequence of non-zero solutions $f_{k}(t, x, v)$ to the linearized Boltzmann equation (23) to satisfy one of the following:
(1) In the in-flow case: $f_{k}$ satisfies (11) and

$$
\int_{0}^{1}\left\|\mathbf{P} f_{k}(s)\right\|_{\nu}^{2} d s \geq k\left\{\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) f_{k}(s)\right\|_{\nu}^{2} d s+\int_{0}^{1}\left\|f_{k}(s)\right\|_{\gamma}^{2} d s\right\}
$$

Equivalently, in terms of normalization $Z_{k}(t, x, v) \equiv \frac{f_{k}(t, x, v)}{\sqrt{\int_{0}^{1}\left\|\mathbf{P} f_{k}(s)\right\|_{\nu}^{2} d s}}$, we have

$$
\begin{equation*}
\int_{0}^{1}\left\|\mathbf{P} Z_{k}(s)\right\|_{\nu}^{2} d s \equiv 1 \tag{60}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s+\int_{0}^{1}\left\|Z_{k}(s)\right\|_{\gamma}^{2} d s \leq \frac{1}{k} \tag{61}
\end{equation*}
$$

We also have from $\left[\partial_{t}+v \cdot \nabla_{x}+L\right] f_{k}=0$,

$$
\begin{equation*}
\left[\partial_{t}+v \cdot \nabla_{x}+L\right] Z_{k}=0 \tag{62}
\end{equation*}
$$

(2) In the bounce-back case: $f_{k}$ satisfies (12), the mass-energy conservation laws (17) and (18), and

$$
\begin{equation*}
\int_{0}^{1}\left\|\mathbf{P} f_{k}(s)\right\|^{2} d s \geq k \int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) f_{k}(s)\right\|_{\nu}^{2} d s \tag{63}
\end{equation*}
$$

Hence, the normalized $Z_{k}$ satisfies (60), (62), and

$$
\begin{equation*}
\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s \leq \frac{1}{k} \tag{64}
\end{equation*}
$$

(3) In the specular reflection case: $f_{k}$ satisfies (14), and the mass and energy conservation laws (17), (18). (If the domain $\Omega$ has any axis of rotation symmetry (5) then $f_{k}$ also satisfies (19)). We note that (63), (60), (62) and (64) are all valid for the normalized $Z_{k}$.
(4) In the diffusive reflection case: $f_{k}$ satisfies (16), and the mass conservation (17), (62), and

$$
\begin{equation*}
\int_{0}^{1}\left\|\mathbf{P} f_{k}(s)\right\|_{\nu}^{2} d s \geq k\left\{\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) f_{k}(s)\right\|_{\nu}^{2} d s+\int_{0}^{1}\left\|\left\{I-P_{\gamma}\right\} f_{k}(s)\right\|_{\gamma_{+}}^{2} d s\right\} \tag{65}
\end{equation*}
$$

The normalized $Z_{k}$ satisfies (60) and

$$
\begin{equation*}
\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s+\int_{0}^{1}\left\|\left\{I-P_{\gamma}\right\} Z_{k}(s)\right\|_{\gamma_{+}}^{2} d s \leq \frac{1}{k} \tag{66}
\end{equation*}
$$

In all four cases, there exists $Z(t, x, v)$ such that

$$
Z_{k} \rightarrow Z \text { weakly in } \int_{0}^{1}\|\cdot\|_{\nu}^{2} d s
$$

since $\sup _{k} \int_{0}^{1}\left\|Z_{k}(s)\right\|_{\nu}^{2} d s<+\infty$, and from (61), (64), (66) that

$$
\begin{equation*}
\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s \rightarrow 0 \tag{67}
\end{equation*}
$$

Notice that it is straightforward to verify

$$
\mathbf{P} Z_{k} \rightarrow \mathbf{P} Z \text { weakly in } \int_{0}^{1}\|\cdot\|_{\nu}^{2} d s
$$

Therefore $(\mathbf{I}-\mathbf{P}) Z_{k} \rightarrow(\mathbf{I}-\mathbf{P}) Z$ weakly, and $(\mathbf{I}-\mathbf{P}) Z=0$ from (67) so that

$$
\begin{equation*}
Z(t, x, v)=\left\{a(t, x)+v \cdot b(t, x)+|v|^{2} c(t, x)\right\} \sqrt{\mu} . \tag{68}
\end{equation*}
$$

Note $L Z_{k}=L(\mathbf{I}-\mathbf{P}) Z_{k}$ and $\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s \rightarrow 0$ in four cases. Letting $k \rightarrow \infty$ in (62), we have, in the sense of distributions,

\begin{equation*}
\partial_{t} Z+v \cdot \nabla_{x} Z=0 \tag{69}
\end{equation*}
$$

The main strategy is to show, on the one hand, $Z$ has to be zero from (67) and one of the inherited boundary conditions (11), (12), (14) and (16). On the other hand, $Z_{k}$ will be shown to converge strongly to $Z$ in $\int_{0}^{1}\|\cdot\|^{2} d s$, and $\int_{0}^{1}\|Z\|^{2} d s \neq 0$. This leads to a contradiction.

### 3.2 The Limit Function $Z(t, x, v)$

Lemma 12 There exists constants $a_{0}, c_{1}, c_{2}$, and constant vectors $b_{0}, b_{1}$ and $\varpi$ such that $Z(t, x, v)$ takes the form:

Moreover, these constants are finite:

Proof. We first derive deduce (70). Notice that by plugging (68) into (69) and comparing coefficients in front of $\sqrt{\mu}, v \sqrt{\mu},|v|^{2} \sqrt{\mu}$, we deduce the macroscopic equations with $b=\left(b^{1}, b^{2}, b^{3}\right)$ :

Since $\Omega$ is simply connected, from (72), $c(t, x) \equiv c(t)$. Similarly, from (73),

b^{1}(t, x) & =-\partial_{t} c(t) x_{1}+\tilde{b}^{1}\left(t, x_{2}, x_{3}\right) \\
b^{2}(t, x) & =-\partial_{t} c(t) x_{2}+\tilde{b}^{2}\left(t, x_{1}, x_{3}\right) \\
b^{3}(t, x) & =-\partial_{t} c(t) x_{3}+\tilde{b}^{3}\left(t, x_{1}, x_{2}\right)
\end{aligned}
$$

To determine $\tilde{b}^{1}$, we first make use of (74) to get

Similarly, we also have $\partial_{x_{1}}^{2} \tilde{b}^{2}\left(t, x_{1}, x_{3}\right)=0$ so that

Next, we make use of another equation of (74) to get

with $\partial_{x_{3}} \tilde{b}^{2}\left(t, x_{1}, x_{3}\right)=-\partial_{x_{3}} j^{1}\left(t, x_{3}\right) x_{1}+\partial_{x_{3}} g^{2}\left(t, x_{3}\right)$. From $\partial_{x_{2}}^{2} \tilde{b}^{3}\left(t, x_{1}, x_{2}\right)=0$, we have

so that $-\partial_{x_{3}} j^{1}\left(t, x_{3}\right) x_{1}+\partial_{x_{3}} g^{2}\left(x_{3}\right)+j^{3}\left(t, x_{1}\right) x_{2}=0$. Taking one more $x_{3}$ derivative, we get

so that $\partial_{x_{3}}^{2} j^{1}\left(t, x_{3}\right)=\partial_{x_{3}}^{2} g^{2}\left(t, x_{3}\right) \equiv 0$. Furthermore, taking two more $x_{1}$ derivatives, we have $\partial_{x_{1}}^{2} j^{3}\left(t, x_{1}\right)=0$. Hence $j^{1}$ and $g^{2}$ can be expressed as

\tilde{b}^{2} & =-\left(l^{1}(t) x_{3}+h^{1}(t)\right) x_{1}+h^{2}(t) x_{3}+m^{2}(t)  \tag{80}\\
\tilde{b}^{3} & =l^{1}(t) x_{1} x_{2}-h^{2}(t) x_{2}+g^{3}\left(t, x_{1}\right)
\end{align*}
$$

Finally, from the remaining equation in (74),

\partial_{x_{3}} \tilde{b}^{1}\left(t, x_{1}, x_{3}\right)+\partial_{x_{1}} \tilde{b}^{3}\left(t, x_{1}, x_{2}\right)=0 .

By (80), $l^{1} x_{2}+\partial_{x_{3}} g^{1}\left(t, x_{3}\right)+l^{1} x_{2}+\partial_{x_{1}} g^{3}\left(t, x_{1}\right)=0$. Hence $l^{1} \equiv 0, g^{1}$ is a linear function of $x_{3}$ and $g^{3}$ is a linear function of $x_{1}$ :

Therefore, letting $\varpi(t)=-\left[h^{2}(t), h^{3}(t), h^{1}(t)\right]$ and $m(t)=\left[m^{1}(t), m^{2}(t), m^{3}(t)\right]$, we deduce from a direct computation that

Lastly, to prove (71), we note that for $1 \leq i, j \leq 3$, functions
$|x|^{2} \sqrt{\mu}, x_{i} \sqrt{\mu}, \sqrt{\mu}, t x \cdot v \sqrt{\mu}, x \cdot v \sqrt{\mu}, x \times v \sqrt{\mu}, t v \sqrt{\mu}, v \sqrt{\mu}, t^{2}|v|^{2} \sqrt{\mu}, t|v|^{2} \sqrt{\mu},|v|^{2} \sqrt{\mu}$ are linearly independent. Therefore, their coefficients $c_{0}, c_{1}, c_{2}, a_{0}, b_{0}, b_{1}, \varpi$ are bounded by $C\left\{\int_{0}^{1}\|Z(s)\|^{2} d s\right\}^{1 / 2}$, which is finite.

### 3.3 Interior Compactness

Lemma 13 For any smooth function $\chi(t, x)$ such that $\sup \chi \subset \subset(0,1) \times \Omega$, then up to a subsequence, $\lim _{k \rightarrow \infty} \int_{0}^{1}\left\|\chi\left\{Z_{k}-Z\right\}(s)\right\|^{2} d s=0$.

Proof. We multiply the equation (62) by $\chi$ to get

\left[\partial_{t}+v \cdot \nabla_{x}\right]\left\{\chi Z_{k}\right\}=\left\{\left[\partial_{t}+v \cdot \nabla_{x}\right] \chi\right\} Z_{k}-\chi L Z_{k}

Since $\int_{0}^{1}\left\|Z_{k}(s)\right\|^{2} d s$ is uniformly bounded for the hard potentials, by (60) and (67), we deduce from the Averaging Lemma [DL], $\int \chi(t, x) Z_{k}(v) \chi_{v}(v) d v$ are compact in $L^{2}([0,1] \times \Omega)$ for any smooth cutoff function $\chi_{v}(v)$ (see [G1]). It then follows that

are compact in $L^{2}([0,1] \times \Omega)$. Therefore, up to a subsequence, the macroscopic parts of $Z_{k}$ satisfy $\chi \mathbf{P} Z_{k} \rightarrow \chi \mathbf{P} Z=\chi Z$ strongly in $L^{2}\left([0,1] \times \Omega \times \mathbf{R}^{3}\right)$. Therefore, in light of $\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s \rightarrow 0$ in (67) for all four boundary conditions, the remaining microscopic parts $\chi Z_{k}$ satisfy $\lim _{k \rightarrow \infty} \int_{0}^{1}\left\|\chi\{\mathbf{I}-\mathbf{P}\} Z_{k}(s)\right\|^{2} d s=0$, and our lemma follows.

### 3.4 No Time Concentration

We first establish $L^{\infty}$ in time estimate for $Z_{k}$ to rule out possible concentration in time, near either $t=0$ or $t=1$.

Lemma $14 \sup _{0 \leq t \leq 1, k \geq 1}\left\|Z_{k}(t)\right\|<\infty$.
Proof. Since $\int_{0}^{1}\left\|f_{k}(s)\right\|_{\gamma}^{2}<\infty, \int_{0}^{1}\left\|Z_{k}(s)\right\|_{\gamma}^{2}<\infty$. Therefore, by the standard $L^{2}$ estimate for (62), we obtain for $0 \leq t \leq 1$ :

= & \left\|Z_{k}(0)\right\|^{2}+\int_{0}^{t}\left\|Z_{k}(s)\right\|_{\gamma_{-}}^{2} d s . \tag{81}
\end{align*}

We first derive an upper bound for $Z_{k}(t)$. In the case of in flow case (11), because of (61), (60) and $L \geq 0$, we deduce

$$

Next, we derive an upper bound for $Z_{k}(0)$. We note that

\int_{0}^{1}\left(L Z_{k}(t), Z_{k}(t)\right) d t \leq C \int_{0}^{1}\left\|\{\mathbf{I}-\mathbf{P}\} Z_{k}\right\|_{\nu}^{2} d t \leq \frac{C}{k}

In the case of the in-flow case (11), by (61) and (81),

\left\|Z_{k}(t)\right\|^{2} & \geq\left\|Z_{k}(0)\right\|^{2}-\int_{0}^{1}\left\|Z_{k}(s)\right\|_{\gamma_{+}}^{2} d s-\int_{0}^{1}\left(L Z_{k}, Z_{k}\right)(s) d s \\
& \geq\left\|Z_{k}(0)\right\|^{2}-\frac{C}{k} \tag{83}
\end{align*}
$$

Note that $\int_{0}^{t}\left\|Z_{k}(s)\right\|_{\gamma_{+}}^{2} d s=\int_{0}^{t}\left\|Z_{k}(s)\right\|_{\gamma_{-}}^{2} d s$ for either bounce-back and specular reflection (12) or (14), so that (83) is clearly valid. In the case of diffuse reflection (16), (83) is valid because of (66):

Since $\int_{0}^{1}\left\|Z_{k}(t)\right\|^{2} d t \leq C \int_{0}^{1}\left\|Z_{k}(t)\right\|_{\nu}^{2} d t \leq C\left\{1+\frac{1}{k}\right\}$ for hard potentials, integrating (83) over $0 \leq t \leq 1$ yields

\left\|Z_{k}(0)\right\|^{2} & \leq \int_{0}^{1}\left\|Z_{k}(t)\right\|^{2} d t+\frac{C}{k} \\
& \leq C \int_{0}^{1}\left\|Z_{k}(t)\right\|_{\nu}^{2} d t+\frac{C}{k} \\
& \leq C\left\{1+\frac{1}{k}\right\}+\frac{C}{k}
\end{aligned}
$$

by (60) and (67). Our lemma thus follows from (82).

### 3.5 No Boundary Concentration

The most delicate step is to prove that there is no concentration at the boundary $\partial \Omega$ so that $Z_{k} \rightarrow Z$ strongly in $[0,1] \times \bar{\Omega} \times \mathbf{R}^{3}$. Let

To this end, we will establish a careful energy estimate in the thin shell-like region near the boundary $[0,1] \times\left\{\Omega \backslash \Omega_{\varepsilon^{4}}\right\} \times \mathbf{R}^{3}$.

Recall $n(x)=\frac{\nabla \xi(x)}{|\nabla \xi(x)|} \neq 0$, well-defined and smooth on $\Omega \backslash \Omega_{\varepsilon^{4}}$ for $\varepsilon$ small. For $m>1 / 2$, for any $(x, v)$, we define the outward moving (inward moving) indicator function $\chi_{+}\left(\chi_{-}\right)$as

& \chi_{+}(x, v)=\mathbf{1}_{\Omega \backslash \Omega_{\varepsilon^{4}}}(x) \mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}, n(x) \cdot v>\varepsilon\right\}}(v) \\
& \chi_{-}(x, v)=\mathbf{1}_{\Omega \backslash \Omega_{\varepsilon^{4}}}(x) \mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}, n(x) \cdot v<-\varepsilon\right\}}(v) .
\end{aligned}
$$

Our main strategy is to show that the moving (non-grazing) part $\chi_{ \pm} Z_{k}$ are controlled by the inner boundary values of $Z_{k}$ on $\partial \Omega_{\varepsilon^{4}}=\left\{\xi(x)=-\varepsilon^{4}\right\}$, which are further controlled by the (compact!) interior parts of $Z_{k}$. Hence, no concentration is possible. On the remaining almost grazing part $\left\{1-\chi_{ \pm}\right\} Z_{k}$, thanks to the fact $\int_{0}^{1}\left\|\{\mathbf{I}-\mathbf{P}\} Z_{k}(s)\right\|_{\nu}^{2} d s \rightarrow 0$, no concentration can occur for the small velocity set $\left\{|v| \geq \varepsilon^{-m}\right\} \cup\{|n(x) \cdot v| \leq \varepsilon\}$.

## Lemma 15

$$
\begin{equation*}
\sup _{k \geq 1} \int_{0}^{1} \int_{\Omega \backslash \Omega_{\varepsilon^{4}}} \int_{\substack{|n(x) \cdot v| \leq \varepsilon \\ \text { or }|v| \geq \varepsilon^{-m}}}\left|Z_{k}(s, x, v)\right|^{2} d x d v d s \leq C \varepsilon \tag{84}
\end{equation*}
$$

Proof. Let $\mathbf{P} Z_{k}=\left\{a_{k}(t, x)+v \cdot b_{k}(t, x)+|v|^{2} c_{k}(t, x)\right\} \sqrt{\mu}$. Since $\sup _{k} \int_{0}^{1}\left\|Z_{k}(s)\right\|^{2} d s$ is finite and $\left[1, v,|v|^{2}\right] \sqrt{\mu}$ are linearly independent, there is $C>0$ (independent of $k)$ such that

\int_{0}^{1}\left\|a_{k}(s)\right\|^{2} d s+\int_{0}^{1}\left\|b_{k}(s)\right\|^{2} d s+\int_{0}^{1}\left\|c_{k}(s)\right\|^{2} d s \leq C \int_{0}^{1}\left\|Z_{k}(s)\right\|^{2} d s \leq C \tag{85}
\end{equation*}
$$

By (67), we can split:

& \int_{0}^{1} \int_{\Omega \backslash \Omega_{\varepsilon^{4}}} \int_{\substack{\text { or }|v| \geq \varepsilon^{-m}}}|n(x) \cdot v| \leq \varepsilon \\
& \leq\left.\int_{k}(s, x, v)\right|^{2} d x d v d s \\
&|n(x) \cdot v| \leq \varepsilon \\
& \text { or }|v| \geq \varepsilon^{-m} \\
& \leq\left.P^{\mid} Z_{k}(s, x, v)\right|^{2}+\int_{\substack{|n(x) \cdot v| \leq \varepsilon \\
\text { or }|v| \geq \varepsilon^{-m}}}^{1}\left|\{\mathbf{I}-\mathbf{P}\} Z_{k}(s, x, v)\right|^{2} \\
& \int_{\Omega \backslash \Omega_{\varepsilon^{4}}} \int_{\substack{|n(x) \cdot v| \leq \varepsilon \\
\text { or }|v| \geq \varepsilon^{-m}}}\left|\mathbf{P} Z_{k}(s, x, v)\right|^{2} d x d v d s+\frac{C}{k}
\end{aligned}
$$

Even with an extra weight $\left\{1+|v|^{2}\right\}^{l}(l \geq 0)$, the first term can be bounded by the Fubini Theorem as

\begin{align*}
& \int_{\substack{|n(x) \cdot v| \leq \varepsilon \\
\text { or }|v| \geq \varepsilon^{-m}}}\left\{1+|v|^{2}\right\}^{l}\left|\mathbf{P} Z_{k}(s, x, v)\right|^{2} d x d v d s \\
\leq & \int_{0}^{1} \int_{\Omega \backslash \Omega_{\varepsilon^{4}}}\left\{\left|a_{k}^{2}(s, x)\right|+\left|b_{k}^{2}(s, x)\right|+\left|c_{k}^{2}(s, x)\right|\right\} \times \\
& \times\left\{\int_{\substack{|n(x) \cdot v| \leq \varepsilon \\
\text { or }|v| \geq \varepsilon^{-m}}}\left\{1+|v|^{2}\right\}^{l+2} \mu d v\right\} d x d s . \tag{86}
\end{align*}
$$

We note that the inner $v$-integral above is bounded, uniformly in $x$. In fact, by a change of variable $v_{\|}=\{n(x) \cdot v\} n(x)$, and $v_{\perp}=v-v_{\|}$for $|n(x) \cdot v| \leq \varepsilon$, the
inner integral is bounded by the sum of

& \text { and } \int_{|v| \geq \varepsilon^{-m}}\left\{1+|v|^{2}\right\}^{l+2} \mu d v \leq C \varepsilon
\end{aligned}
$$

Our lemma thus follows from (85).
To study the non-grazing parts $\chi_{ \pm} Z_{k}$, we fix $(x, v) \in\left\{\Omega \backslash \Omega_{\varepsilon^{4}}\right\} \times \mathbf{R}^{3}$ and any moment $s$ such that $\varepsilon \leq s \leq 1-\varepsilon$, and. We define for backward in time $0 \leq t \leq s$ :

\tilde{\chi}_{+}(t, x, v)=\mathbf{1}_{\Omega \backslash \Omega_{\varepsilon^{4}}}(x-v\{t-s\}) \mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}, n(x-v\{t-s\}) \cdot v>\varepsilon\right\}}(v) ; \tag{88}
\end{equation*}
$$

and for forward in time $0 \leq s \leq t$ :

\tilde{\chi}_{-}(t, x, v)=\mathbf{1}_{\Omega \backslash \Omega_{\varepsilon^{4}}}(x-v\{t-s\}) \mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}, n(x-v\{t-s\}) \cdot v<-\varepsilon\right\}}(v) . \tag{89}
\end{equation*}

Both $\tilde{\chi}_{ \pm}$solve the transport equations:

Lemma 16 (1) For $0 \leq s-\varepsilon^{2} \leq t \leq s$, if $\tilde{\chi}_{+}(t, x, v) \neq 0$ then $n(x) \cdot v>\frac{\varepsilon}{2}>0$. Moreover, $\tilde{\chi}_{+}\left(s-\varepsilon^{2}, x, v\right) \equiv 0$, for $x \in \Omega \backslash \Omega_{\varepsilon^{4}}$.
(2) For $s \leq t \leq s+\varepsilon^{2} \leq 1$, if $\tilde{\chi}_{-}(t, x, v) \neq 0$, then $n(x) \cdot v<-\frac{\varepsilon}{2}<0$. Moreover, $\tilde{\chi}_{-}\left(s+\varepsilon^{2}, x, v\right) \equiv 0$, for $x \in \Omega \backslash \Omega_{\varepsilon^{4}}$.

Proof. It suffices to prove (1), the proof for (2) being exactly the same. First of all, by (88), if $\tilde{\chi}_{+}(t, x, v) \neq 0$, then $x-v(t-s) \in \Omega \backslash \Omega_{\varepsilon^{4}}, n(x-v\{t-s\}) \cdot v>\varepsilon$, and $|v| \leq \varepsilon^{-m}$. Hence for $|t-s| \leq \varepsilon^{2}$, for any $0 \leq \theta \leq 1$,

To prove the second assertion, let $x \in \Omega \backslash \Omega_{\varepsilon^{4}}$ so that $-\varepsilon^{4} \leq \xi(x)<0$. If $\tilde{\chi}_{+}\left(s-\varepsilon^{2}, x, v\right)>0$, by (88), $-\varepsilon^{4} \leq \xi\left(x-\varepsilon^{2} v\right)<0$ and $|v| \leq \varepsilon^{-m}$. But

for $2 m<1$, and small $\varepsilon$. This is a contradiction to $-\varepsilon^{4} \leq \xi\left(x-\varepsilon^{2} v\right)<0$.

where at the inner boundary $\gamma^{\varepsilon} \equiv\left\{x: \xi(x)=-\varepsilon^{4}\right\} \times \mathbf{R}^{3}$, its normal vector is $n(x)=\frac{\nabla \xi(x)}{|\nabla \xi(x)|}$. We notice that by Lemma 16, $\tilde{\chi}_{+} \equiv 0$ at $s-\varepsilon^{2}$, while $\tilde{\chi}_{+} \equiv 0$ on $\gamma_{-}$and $\gamma_{-}^{\varepsilon}$, since $n(x) \cdot v>0$ for $\tilde{\chi}_{+}(s, x, v) \neq 0$. From $\int_{0}^{1}\left\|(\mathbf{I}-\mathbf{P}) Z_{k}(s)\right\|_{\nu}^{2} d s \leq \frac{1}{k}$, we get for $k$ large,

We notice that $\tilde{\chi}_{-} \equiv 0$ at $t=s+\varepsilon^{2}$, while $\tilde{\chi}_{-} \equiv 0$ on the incoming part $\gamma_{+}$ and $\gamma_{+}^{\varepsilon}$ by part (2) of Lemma 16. Therefore we deduce from (95)

By Lemma 16, the supports of $\tilde{\chi}_{ \pm} Z_{k}(t)$ on $\gamma_{ \pm}^{\varepsilon}$ are contained in $|n(x) \cdot v| \geq \frac{\varepsilon}{2}$. Combining the $\pm$ cases, we are able to estimate $\tilde{\chi}_{ \pm} Z_{k}$ in terms of the inner boundary contributions as

\leq & \int_{s-\varepsilon^{2}}^{s+\varepsilon^{2}}\left\|\mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}, \text { and }|n(x) \cdot v| \geq \frac{\varepsilon}{2}\right\}} Z_{k}(t)\right\|_{\gamma^{\varepsilon}}^{2} d t+\frac{2 C}{\sqrt{k}} . \tag{96}
\end{align*}

Since the outward normal at $x \in \partial \Omega_{\varepsilon^{4}}$ is $n(x)$, the set $\left\{(x, v): x \in \partial \Omega_{\varepsilon^{4}}, \mid v\right.$. $\left.n(x) \left\lvert\, \geq \frac{\varepsilon}{2}\right.\right\}$ is away from the singular set $\gamma_{0}^{\varepsilon}=\left\{(x, v): x \in \partial \Omega_{\varepsilon^{4}},|v \cdot n(x)|=\right.$ $0\}$. Hence, by (40) in Lemma 6, both the backward or forward trajectories emanating from $\partial \Omega_{\varepsilon^{4}} \times\left\{|v| \leq \varepsilon^{-m},|v \cdot n(x)| \geq \frac{\varepsilon}{2}\right\}$ spend a positive period of time inside $\bar{\Omega}_{\varepsilon^{4}}$. Since

over $\bar{\Omega}_{\varepsilon^{4}}$ to get

\leq & C_{\varepsilon} \int_{\varepsilon}^{1-\varepsilon}\left\{\left\|\mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}\right\}}\left(Z_{k}(t)-Z(t)\right)\right\|_{\Omega_{\varepsilon^{4}} \times \mathbf{R}^{3}}^{2}+\left\|\mathbf{1}_{\left\{|v| \leq \varepsilon^{-m}\right\}}\left\{L\{\mathbf{I}-\mathbf{P}\} Z_{k}(t)\right\}\right\|_{\Omega_{\varepsilon^{4}} \times \mathbf{R}^{3}}^{2}\right\} d t \\
\leq & C_{\varepsilon} \int_{\varepsilon}^{1-\varepsilon}\left\|Z_{k}(t)-Z(t)\right\|_{\Omega_{\varepsilon^{4}} \times \mathbf{R}^{3}}^{2} d t+C_{\varepsilon} \int_{0}^{1}\left\|\{\mathbf{I}-\mathbf{P}\} Z_{k}(t)\right\|_{\nu}^{2} d t \\

& \leq Z(t) \|_{\gamma^{\varepsilon}}^{2} d s .

& +2 \int_{\varepsilon}^{1-\varepsilon} \int_{\Omega \backslash \Omega_{\varepsilon^{4}}} \int|Z(s, x, v)|^{2}+\int_{\varepsilon}^{1-\varepsilon} \iint_{\Omega_{\varepsilon^{4}}}\left|Z_{k}(s, x, v)-Z(s, x, v)\right|^{2} .

Clearly, the first term is bounded by (98), the second term is bounded by $C \varepsilon$ thanks to Lemma 15, by (71), the third term is bounded by

Finally, we study the boundary conditions which $Z$ satisfies. In fact, recalling (97) and $\int_{0}^{1}\left\|Z_{k}(t)-Z(t)\right\|^{2} d t \rightarrow 0$, we use Ukai's trace theorem to conclude, for any fixed $\varepsilon>0$,

& \lim _{k \rightarrow \infty} \int_{0}^{1}\left\|\mathbf{1}_{\left\{|v \cdot n(x)| \geq \frac{\varepsilon}{2},|v| \leq \frac{1}{\varepsilon^{m}}\right\}} Z_{k}(s)-Z(s)\right\|_{\gamma}^{2} d s \\
\leq & C \lim _{k \rightarrow \infty}\left[\int_{0}^{1}\left\|\mathbf{1}_{|v| \leq \frac{1}{\varepsilon^{m}}}\left\{Z_{k}(s)-Z(s)\right\}\right\|^{2} d s+\int_{0}^{1}\left\|\left[\partial_{t}+v \cdot \nabla_{x}\right] \mathbf{1}_{|v| \leq \frac{1}{\varepsilon^{m}}}\left\{Z_{k}(s)-Z(s)\right\}\right\|^{2} d s\right] \\
\leq & C \lim _{k \rightarrow \infty}\left(\int_{0}^{1}\left\|\mathbf{1}_{|v| \leq \frac{1}{\varepsilon^{m m}}}\left\{L\{\mathbf{I}-\mathbf{P}\} Z_{k}(t)\right\}\right\|^{2} d t\right)=0 \tag{99}
\end{align*}
$$

For the in-flow boundary case, by (61) and the continuity of $Z$,

$$
\int_{0}^{1}\left\|\mathbf{1}_{\left\{|v \cdot n(x)| \geq \frac{\varepsilon}{2}\right\}} \mathbf{1}_{|v| \leq \varepsilon^{-m}} Z(s)\right\|_{\gamma}^{2} d s=\lim _{k \rightarrow \infty} \int_{0}^{1}\left\|\mathbf{1}_{\left\{|v \cdot n(x)| \geq \frac{\varepsilon}{2}\right\}} \mathbf{1}_{|v| \leq \varepsilon^{-m}} Z_{k}(s)\right\|_{\gamma}^{2} d s=0
$$

so that $Z \equiv 0$ on $\gamma$.
For the bounce-back and specular reflections, $Z_{k}(t, x, v)=Z_{k}(t, x,-v)$, or $Z_{k}(t, x, v)=Z_{k}(t, x, R(x) v)$. Letting $k \rightarrow \infty$, we deduce that $Z$ satisfies the same relation respectively for $\left\{|v \cdot n(x)| \geq \frac{\varepsilon}{2}\right\}$. Therefore, $Z(t, x, v)=Z(t, x,-v)$ or $Z(t, x, v)=Z(t, x, R(x) v)$ respectively by the continuity of $Z$.

For the diffusive reflection, notice that on $\gamma_{-}$,

Fix $\varepsilon>0$ small and for any $x \in \partial \Omega$, on the set $\{v \cdot n(x)>\varepsilon\}, Z_{k} \rightarrow Z$ in $L^{2}([0,1] \times \gamma)$. This implies that from (99)

\left\{\int_{0}^{1} \int_{\partial \Omega}\left|\bar{a}_{k}(t, x)\right|^{2} \int_{\substack{v \cdot n(x)>\varepsilon \\ \text { and }|v| \geq \varepsilon^{-m}}} c_{\mu} \mu d v\right\} d x d t=\left.\int_{0}^{1}\right|_{\substack{|v \cdot n(x)| \geq \varepsilon \\|v| \geq \varepsilon^{-m}}}\left\{Z_{k}(t)\right\}_{\gamma_{-}} \|^{2} d t<C_{\varepsilon}<\infty
$$

Notice that for $\varepsilon$ small, $\int v \cdot n(x)>\varepsilon \mu d v$ is a finite non-zero constant, indepenand $|v| \geq \varepsilon^{-m}$
dent of $x$. It follows that

$$
\left\{\int_{0}^{1} \int_{\partial \Omega}\left|\bar{a}_{k}(t, x)\right|^{2}\right\} d x d t \leq C_{\varepsilon}<\infty .
$$

This implies that $P_{\gamma}\left\{Z_{k}\right\}_{\gamma_{+}} \equiv \bar{a}_{k}(t, x) \sqrt{c_{\mu} \mu(v)}$ are uniformly bounded in $L^{2}([0,1] \times$ $\gamma_{+}$). But from (66), $\left\{I-P_{\gamma}\right\}\left\{Z_{k}\right\}_{\gamma_{+}} \rightarrow 0$ in $L^{2}\left([0,1] \times \gamma_{+}\right)$, we deduce that $\left\{Z_{k}\right\}_{\gamma_{+}}$are uniformly bounded in $L^{2}\left([0,1] \times \gamma_{+}\right)$with a weak limit. But $\left\{Z_{k}\right\}_{\gamma_{+}} \rightarrow Z$ strongly in $L^{2}\left([0,1] \times\left\{\gamma_{+} \backslash \gamma_{0}\right\}\right)$ by the trace theorem, so that $\left\{Z_{k}\right\}_{\gamma_{+}} \rightarrow Z$ weakly in $L^{2}\left([0,1] \times \gamma_{+}\right)$since $\gamma_{0}$ has zero measure. Hence
$c_{\mu}\left\{\int_{n \cdot v^{\prime}>0} Z_{k}\left(t, x, v^{\prime}\right) \sqrt{\mu} n \cdot v^{\prime} d v^{\prime}\right\} \sqrt{\mu(v)} \rightarrow c_{\mu}\left\{\int_{n \cdot v^{\prime}>0} Z\left(t, x, v^{\prime}\right) \sqrt{\mu} n \cdot v^{\prime} d v^{\prime}\right\} \sqrt{\mu(v)}$
weakly $L^{2}\left([0,1] \times \gamma_{+}\right)$. We then recover (16) by letting $k \rightarrow \infty$ in (100).

### 3.6 Boundary Condition Leads to $Z=0$.

Since $Z$ now satisfies one of the boundary conditions $Z_{\gamma}=0$, (12), (14), and (16), we will show that $Z$ in (70) has to be zero and this leads to a contradiction.

In the case of in-flow boundary (11), since $Z=0$ on $\gamma$, from (70), for any $t$ and $x \in \partial \Omega$, and $v \in \mathbf{R}^{3}$, by comparing the coefficients in front of the polynomials of $v$, we deduce that $\left\{\frac{c_{0} t^{2}}{2}+c_{1} t+c_{2}\right\} \equiv 0$ and

$$
\left\{-c_{0} t x-c_{1} x+\varpi \times x+b_{0} t+b_{1}\right\} \equiv\left\{\frac{c_{0}}{2}|x|^{2}-b_{0} \cdot x+a_{0}\right\} \equiv 0
$$

Therefore $c_{0}=c_{1}=c_{2}=0$, and $b_{0}=0$. Then $a_{0}=0$ and $\varpi \times x+b_{1} \equiv 0$, or

$$
\begin{equation*}
\varpi^{2} x_{3}-\varpi^{3} x_{2}+b_{1}^{1}=-\varpi^{1} x_{3}+\varpi^{3} x_{1}+b_{1}^{2}=\varpi^{1} x_{2}-\varpi^{2} x_{1}+b_{1}^{3} \equiv 0 \tag{101}
\end{equation*}
$$

for all $x \in \partial \Omega$. Notice that since $\xi(x)=0$ is two dimensional, so we may assume that $\left(x_{1}, x_{2}\right)$ are (locally) independent. Hence $\varpi^{1}=\varpi^{2}=b_{1}^{3}=0$ then $\varpi^{3}=b_{1}^{2}=0$, and finally $b_{1}^{1}=0$. Therefore we deduce $Z \equiv 0$.

In the case of the bounce-back case (12), for any fixed $t$, because of (97), we apply Ukai's trace theorem over $[0, t] \times \Omega \times \mathbf{R}^{3}$ to get, for any $0 \leq t \leq 1$,

$$
\begin{equation*}
\lim _{k \rightarrow \infty}\left\|\mathbf{1}_{\left\{|v| \leq \varepsilon^{-1}\right\}}\left\{Z_{k}(t)-Z(t)\right\}\right\|=0 \tag{102}
\end{equation*}
$$

Therefore, by (17) and (18),

$$
\begin{align*}
\int Z(t) \sqrt{\mu} & =\lim _{k \rightarrow \infty} \int_{|v| \leq \frac{1}{\varepsilon}} Z_{k}(t) \sqrt{\mu}+\lim _{k \rightarrow \infty} \int_{|v| \geq \frac{1}{\varepsilon}} Z_{k}(t) \sqrt{\mu} \equiv 0,  \tag{103}\\
\int Z(t)|v|^{2} \sqrt{\mu} & \left.\equiv \lim _{k \rightarrow \infty} \int_{|v| \leq \frac{1}{\varepsilon}}|v|^{2} Z_{k}(t) \sqrt{\mu}+\lim _{k \rightarrow \infty} \int_{|v| \geq \frac{1}{\varepsilon}}|v|^{2} Z_{k}(t) \sqrt{\mu}, 104\right)
\end{align*}
$$

because the integrations over $|v| \geq \frac{1}{\varepsilon}$ are bounded by $C\left|\left|Z_{k}(t)\right|\right| \int_{|v| \geq \frac{1}{\varepsilon}} \mu^{1 / 4}=$ $C \varepsilon$, from the $L^{\infty}$ estimates in Lemma 14 We therefore obtain that for all $t$,

$$
\begin{align*}
\int\left\{\frac{c_{0}}{2}|x|^{2}-b_{0} \cdot x+a_{0}\right\} \sqrt{\mu}+\left\{\frac{c_{0} t^{2}}{2}+c_{1} t+c_{2}\right\}|v|^{2} \sqrt{\mu} & \equiv 0  \tag{105}\\
\int\left\{\frac{c_{0}}{2}|x|^{2}-b_{0} \cdot x+a_{0}\right\}|v|^{2} \sqrt{\mu}+\left\{\frac{c_{0} t^{2}}{2}+c_{1} t+c_{2}\right\}|v|^{4} \sqrt{\mu} & \equiv 0 \tag{106}
\end{align*}
$$

This implies that $c_{0}=c_{1}=0$. Moreover, since from the bounce-back boundary condition $Z(t, x, v)=Z(t, x,-v)$, we must have $b(t, x) \equiv 0$ in (24), or

$$
b(t, x) \equiv \varpi_{2} \times x+b_{0} t+b_{1} \equiv 0
$$

for all $x \in \partial \Omega$. Clearly $b_{0}=0$ as a function of $t$. From the argument after (101), $\varpi_{2}=0=b_{1}$. We therefore deduce that from (105) and (106) that

$$
\int a_{0} \sqrt{\mu} d v+c_{2} \int|v|^{2} \sqrt{\mu} d v \equiv \int a_{0}|v|^{2} \sqrt{\mu}+c_{2} \int|v|^{4} \sqrt{\mu} d v \equiv 0
$$

We thus have $a_{0}=c_{2}=0$, then $Z \equiv 0$ for the bounce-back case.
The specular reflection is more delicate. Using the same mass and conservation laws (105) and (106), we again have $c_{1}=c_{0}=0$ and $b(t, x)=$ $\varpi_{2} \times x+b_{0} t+b_{1}$. Now from the specular reflection, we have for any $x \in \partial \Omega$, $b(t, x) \cdot n \equiv 0$ or

$$
\left\{\varpi \times x+b_{0} t+b_{1}\right\} \cdot n(x) \equiv 0
$$

Hence $b_{0}=0$ for all $x \in \partial \Omega$ and

$$
\begin{equation*}
\{\varpi \times x\} \cdot n(x)+b_{1} \cdot n(x)=0 \tag{107}
\end{equation*}
$$

In the case $\varpi=0$, we have $b_{1} \cdot n(x) \equiv 0$ on $\partial \Omega$. We can choose $x^{\prime} \in \partial \Omega$ such that $b_{1} \| n\left(x^{\prime}\right)$ by taking the minimizer of $\min _{\xi(x)=0} b_{1} \cdot x$. Hence, $b_{1} \cdot n\left(x^{\prime}\right)=0$ and $b_{1}=0$.

For $\varpi \neq 0$, let's decompose $b_{1}=\beta_{1} \frac{\varpi}{|\varpi|}+\beta_{2} \eta$, where $|\eta|=1$ and $\eta \perp \varpi$. Then $\eta=\left\{\frac{\varpi}{|\varpi|} \times \eta\right\} \times \frac{\varpi}{|\varpi|}$. Hence

$$
b_{1}=\beta_{1} \frac{\varpi}{|\varpi|}+\beta_{2} \eta=\beta_{1} \frac{\varpi}{|\varpi|}+\beta_{2}\left\{\frac{\varpi}{|\varpi|^{2}} \times \eta\right\} \times \varpi \equiv \beta_{1} \frac{\varpi}{|\varpi|}-x_{0} \times \varpi .
$$

where $x_{0}=-\frac{\beta_{2}}{|\varpi|^{2}} \varpi \times \eta$. By plugging this back into (107), we get

$$
\beta_{1} \frac{\varpi}{|\varpi|} \cdot n(x)+\varpi \times\left(x-x_{0}\right) \cdot n(x)=0
$$

Once again, we can choose a point $x^{\prime} \in \partial \Omega$ such that $\varpi \| n\left(x^{\prime}\right)$ (e.g., look for minimizer of $\left.\min _{\xi(x)=0} \varpi \cdot x\right)$. We then deduce $\varpi \times\left(x^{\prime}-x_{0}\right) \cdot n\left(x^{\prime}\right)=0$ and hence $\beta_{1}=0$. So

$$
\begin{equation*}
Z=\varpi \times\left(x-x_{0}\right) \cdot v \sqrt{\mu} \tag{108}
\end{equation*}
$$

and $\varpi \times\left(x-x_{0}\right) \cdot n(x) \equiv 0$ for all $x \in \partial \Omega$. If $\Omega$ is not rotational symmetric, there is no non-zero $\varpi$ and $x_{0}$ exist, then we deduce that $Z \equiv 0$ for the specular case.

On the other hand, if $\Omega$ is rotational symmetric, there are such non-zero $\varpi$ and $x_{0}$ for $\Omega$ so that (108) is valid, we then have to use the additional conservation law for angular momentum:

\int \varpi \times\left(x-x_{0}\right) \cdot v Z(t) \sqrt{\mu} d v=0
$$

as $k \rightarrow \infty$ of the same expression for $Z_{k}$ (see the proof for (103)). Therefore, we combine (108) to get

\int\left\{\varpi \times\left(x-x_{0}\right) \cdot v\right\}^{2} \mu d x d v \equiv 0
$$

Therefore $\varpi \times\left(x-x_{0}\right) \cdot v \equiv 0$ and $Z \equiv 0$ from (108).
In the case of diffuse boundary condition (16), because of (17), we have (105) and $c_{1}=c_{0}=0$. Moreover, we have

$$
Z(t, x, v)=c_{\mu}\left\{\int_{n \cdot v^{\prime}>0} Z\left(t, x, v^{\prime}\right) \sqrt{\mu} n \cdot v^{\prime} d v^{\prime}\right\} \sqrt{\mu} .
$$

on $\gamma_{-}$. Since $v \sqrt{\mu}, \sqrt{\mu},|v|^{2} \sqrt{\mu}$ are linearly independent, this implies for all $t$ and $x \in \partial \Omega$,

$$
b(t, x) \equiv \varpi \times x+b_{0} t+b_{1} \equiv 0, \quad \text { and } \quad c_{2} \equiv 0
$$

Therefore, $b_{0}=0$, and $\varpi=b_{1}=0$ as in (101). Therefore, we have from (105) $a_{0} \int \sqrt{\mu} d v=0$. Hence $Z \equiv 0$.

## $4 \quad L^{\infty}$ Decay Theory

## 4.1 $\quad L^{\infty}$ Decay For In-flow Boundary Condition

### 4.1.1 $G(t, 0)$ and Continuity

As outlined in Section 1.6, we study the $L^{\infty}$ (pointwise) decay for the weighted $h=w f$ of the linear Boltzmann equation (27) with the in-flow boundary condition. We first derive explicit formula for solution operator $G(t, 0)$ for the homogenous transport equation (29) with in-flow boundary condition. Note that for non-zero in-flow datum at the boundary, $G(t, 0)$ in general is not a semigroup.

Lemma 18 Let $h_{0}(x, v) \in L^{\infty}$ and $w g \in L^{\infty}$. Let $\left\{G(t, 0) h_{0}\right\}$ be the solution to the transport equation (29)

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} G(t, 0) h_{0}=0, \quad G(0,0) h_{0}=h_{0}, \quad\left\{G(t, 0) h_{0}\right\}_{\gamma_{-}}=w g
$$

For any $(x, v)$, with $x \in \bar{\Omega}$, let $t_{\mathbf{b}}(x, v)$ be its back-time exit time defined in Definition 7 , Then for a.e. $(x, v)$,

$$
\begin{align*}
\left\{G(t, 0) h_{0}\right\}(t, x, v)= & \mathbf{1}_{t-t_{\mathbf{b}} \leq 0} e^{-\nu(v) t} h_{0}(x-t v, v) \\
& +\mathbf{1}_{t-t_{\mathbf{b}}>0} e^{-\nu(v) t_{\mathbf{b}}}\{w g\}\left(t-t_{\mathbf{b}}, x-t_{\mathbf{b}} v, v\right) \tag{109}
\end{align*}
$$

Moreover,

$$
\begin{equation*}
\sup _{t \geq 0} e^{\nu_{0} t}\left\|G(t, 0) h_{0}\right\|_{\infty} \leq\left\|h_{0}\right\|_{\infty}+\sup _{s \geq 0} e^{\nu_{0} s}\|w g(s)\|_{\infty} \tag{110}
\end{equation*}
$$

Proof. For almost every $x, v$, along the characteristic line $\frac{d x}{d \tau}=v, \frac{d v}{d \tau}=0$,

$$
\frac{d}{d \tau}\left\{e^{\nu(v) \tau} G(\tau, 0) h_{0}\right\} \equiv 0
$$

Hence $e^{\nu(v) \tau} G(\tau, 0) h_{0}$ is constant along the characteristic. Choose any point $(t, x, v)$ in $[0, \infty) \times \Omega \times \mathbf{R}^{3}$ with its backward exit point $\left(t-t_{\mathbf{b}}, x_{\mathbf{b}}, v\right)$. If $t-$ $t_{\mathbf{b}}(x, v) \leq 0$, then the backward trajectory first hits on the initial plane $\{t=0\}$. On the other hand, if $t-t_{\mathbf{b}}(x, v)>0$, then the backward trajectory first hits the boundary. Since $\left\{G(\tau, 0) h_{0}\right\}_{\gamma_{-}}=w g$ a.e., from part (4) of Lemma 6, (109) is clearly valid for almost every $x, v, x \in \bar{\Omega}$, and estimate (110) follows immediately from (109) with $t_{\mathbf{b}}=t-\left(t-t_{\mathbf{b}}\right)$.

Lemma 19 Let $\Omega$ be convex as in (4). Let $h_{0}(x, v)$ be continuous in $\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$, $g$ be continuous in $[0, \infty) \times\left\{\partial \Omega \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}, q(t, x, v)$ be continuous in the interior of $[0, \infty) \times \Omega \times \mathbf{R}^{3}$ and $\sup _{[0, \infty) \times \Omega \times \mathbf{R}^{3}}\left|\frac{q(t, x, v)}{\nu(v)}\right|<\infty$. Let $h(t, x, v)$ be the solution of

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} h=q, \quad h(0)=h_{0}, \quad h_{\gamma_{-}}=w g
$$

Assume the compatibility condition on $\gamma_{-}$,

$$
\begin{equation*}
h_{0}(x, v)=\{w g\}(0, x, v) \tag{111}
\end{equation*}
$$

Then $h(t, x, v)$ is continuous on $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.
Proof. Let $(x, v) \notin \gamma_{0}$ and denote its backward exit time $\left[t-t_{\mathbf{b}}, x_{\mathbf{b}}, v\right]$. Since $\frac{d}{d \tau}\left\{e^{\nu(v) \tau} G(\tau, s) h\right\}=q$ along the characteristic $\frac{d x}{d t}=v, \frac{d v}{d t}=0$, for $t-t_{\mathbf{b}} \leq 0$,

$$
\begin{equation*}
h(t, x, v)=e^{-\nu(v) t} h_{0}(x-v t, v)+\int_{0}^{t} e^{-\nu(v)(t-s)} q(s, x-v(t-s), v) d s \tag{112}
\end{equation*}
$$

If $t-t_{\mathbf{b}}>0$, we then have

$$
\begin{equation*}
h(t, x, v)=e^{-\nu(v) t_{\mathbf{b}}}\{w g\}\left(t-t_{\mathbf{b}}, x_{\mathbf{b}}, v\right)+\int_{t-t_{\mathbf{b}}}^{t} e^{-\nu(v)(t-s)} q(s, x-v(t-s), v) d s \tag{113}
\end{equation*}
$$

Since $(x, v) \notin \gamma_{0}$, if $x \notin \partial \Omega$, then $\xi(x)<0$; and if $x \in \partial \Omega$, then $v \cdot \nabla \xi(x) \neq 0$. This implies in (36), $\alpha(t)>0$. Since $\xi$ is convex and $\xi\left(x_{\mathbf{b}}\right)=0$, we now apply Velocity Lemma 5 to get

$$
\begin{equation*}
\alpha\left(t-t_{\mathbf{b}}\right)=\left\{v \cdot \nabla \xi\left(x_{\mathbf{b}}\right)\right\}^{2} \geq c \alpha(t)>0 \tag{114}
\end{equation*}
$$

We thus conclude $v \cdot n\left(x_{\mathbf{b}}\right) \neq 0$ and also $t_{\mathbf{b}}(x, v)>0$ by (40). Therefore, by Lemma $6 t_{\mathbf{b}}(x, v), x_{\mathbf{b}}(x, v)$ are both smooth functions of $(x, v)$.

Now take any point $(\bar{t}, \bar{x}, \bar{v})$ close to $(t, x, v)$ and we separate three cases. If $t-t_{\mathbf{b}}(t, x, v)>0$, when $(\bar{t}, \bar{x}, \bar{v})$ is close to $(t, x, v), \bar{t}-t_{\mathbf{b}}(\bar{x}, \bar{v})>0$ by continuity. Therefore

$$
\begin{equation*}
h(\bar{t}, \bar{x}, \bar{v})=e^{-\nu(\bar{v}) \bar{t}_{\mathbf{b}}}\{w g\}\left(\bar{t}-\bar{t}_{\mathbf{b}}, \bar{x}_{\mathbf{b}}, v\right)+\int_{\bar{t}-\bar{t}_{\mathbf{b}}}^{\bar{t}} e^{-\nu(\bar{v})(\bar{t}-s)} q(s, \bar{x}-\bar{v}(\bar{t}-s), \bar{v}) d s \tag{115}
\end{equation*}
$$

From the continuity of $g$ away from $\gamma_{0}$, the second term above tends to the second term in (113). We split the third term into

$$
\int_{\bar{t}-\bar{t}_{\mathbf{b}}}^{\bar{t}}=\int_{\bar{t}-\varepsilon}^{\bar{t}}+\int_{\bar{t}-\bar{t}_{\mathbf{b}}+\varepsilon}^{\bar{t}-\varepsilon}+\int_{\bar{t}-\bar{t}_{\mathbf{b}}}^{\bar{t}-\bar{t}_{\mathbf{b}}+\varepsilon}
$$

where $\varepsilon>0$ is small. The first and the third parts above are small since $\frac{q}{\nu}$ is bounded, from our assumption. Notice that $x-v(t-s)$ is inside the interior of $\Omega$ for $\bar{t}-\bar{t}_{\mathbf{b}}+\varepsilon \leq s \leq \bar{t}-\varepsilon$, the middle term above tends to $\int_{t-t_{\mathrm{b}}+\varepsilon}^{t-\varepsilon} e^{-\nu(v)(t-s)} q(s, x-v(t-s), v) d s$ in (113), from the interior continuity of $q$. Clearly $|h(t, x, v)-h(\bar{t}, \bar{x}, \bar{v})| \rightarrow 0$ as $(\bar{t}, \bar{x}, \bar{v}) \rightarrow(t, x, v)$ in this case.

In the case $t-t_{\mathbf{b}}(x, v)<0, x-v t \notin \partial \Omega$. Then for $(\bar{t}, \bar{x}, \bar{v})$ close to $(t, x, v)$, we have $\bar{t}-t_{\mathbf{b}}(\bar{x}, \bar{v})<0, \bar{x}-\bar{v} \bar{t} \notin \partial \Omega$, and

Since $h_{0}$ is continuous away from $\gamma_{0}$, and $q$ is continuous and $\frac{q}{\nu}$ is bounded in the interior, we again deduce that $h(\bar{t}, \bar{x}, \bar{v}) \rightarrow h(t, x, v)$ by the same argument as in the first case $t-t_{\mathbf{b}}>0$.

Lastly, if $t-t_{\mathbf{b}}(x, v)=0$ and (112) is valid. By (114), $x_{\mathbf{b}}=x-t_{\mathbf{b}} v=x-t v$, and $(x-t v, v) \notin \gamma_{0}$. Then for any $(\bar{t}, \bar{x}, \bar{v})$ near $(t, x, v), \bar{t}-\bar{t}_{\mathbf{b}}$ could be either $>0$ or $\leq 0$. If $\bar{t}-\bar{t}_{\mathbf{b}} \leq 0$, then $h(\bar{t}, \bar{x}, \bar{v})$ still has the same expression (116) as $h(t, x, v)$ and $h(\bar{t}, \bar{x}, \bar{v}) \rightarrow h(t, x, v)$ as before. On the other hand, if $\bar{t}-\bar{t}_{\mathbf{b}}>0$, $h(\bar{t}, \bar{x}, \bar{v})$ is given by (115). By the Velocity Lemma 5 and Lemma 6, we have that $\left|\bar{t}-\bar{t}_{\mathbf{b}}\right|+\left|\bar{x}_{\mathbf{b}}-x_{\mathbf{b}}\right| \rightarrow 0$, so that by the previous argument,

But $\{w g\}\left(0, x_{\mathbf{b}}, v\right)=h_{0}\left(x_{\mathbf{b}}, v\right)$ by the compatibility condition (111), hence this limit equals to $h(t, x, v)$ given by (112).

### 4.1.2 Decay of In-flow $U(t, 0)$

\leq & \frac{C_{N}}{\varepsilon^{3}} e^{-\lambda t}\left[\|f(0)\|+\left\{\int_{0}^{s} e^{2 \lambda \theta}\|g(\theta)\|_{\gamma_{-}}^{2} d \theta\right\}^{1 / 2}\right]
\end{align*}
$$

where we have used crucially part (1) of Theorem 10 with some $0<\lambda<\frac{\nu_{0}}{2}$ in the last line. Note that since $\{1+|v|\} w^{-2} \in L^{1}\left(\mathbf{R}^{3}\right),\|f(0)\|=\left\|w^{-1} h_{0}\right\| \leq$ $C\left\|h_{0}\right\|_{\infty}$, and $\|g\|_{\gamma_{-}}=\left\|\frac{w}{w} g\right\|_{\gamma_{-}} \leq C\|w g\|_{\infty}$, and $\int_{0}^{s} e^{2\left\{\lambda-\lambda_{0}\right\} \theta} d \theta<\infty$, where $\lambda_{0}$ is in Theorem We can then further bound (126) by

$$
\frac{C_{N, \lambda}}{\varepsilon^{3}} e^{-\lambda t}\left[\left\|h_{0}\right\|_{\infty}+\sup _{0 \leq s \leq \infty} e^{\lambda_{0} s}\|w g(s)\|_{\infty}\right]
$$

In summary, replacing $\nu_{0}, \frac{\nu_{0}}{2}$ by $\lambda$ and combining (118), (123), (119), (122), (125) and (126), we have established, for any $\varepsilon>0$ and large $N>0$,
$\sup _{t \geq 0}\left\{e^{\lambda t}\left\|U(t, 0) h_{0}\right\|_{\infty}\right\} \leq\left\{\varepsilon+\frac{C_{\varepsilon}}{N}\right\} \operatorname{Sup}_{s \geq 0}\left\{e^{\lambda s}\left\|U(s, 0) h_{0}\right\|_{\infty}\right\}+C_{K} \operatorname{Sup}_{0 \leq s} e^{2 \lambda_{0} s}\|w g(s)\|_{\infty}+C_{\varepsilon, N}\left\|h_{0}\right\|_{\infty}$.
First choosing $\varepsilon$ small, then $N$ sufficiently large so that $\left\{\varepsilon+\frac{C_{\varepsilon}}{N}\right\}<\frac{1}{2}$,

$$
\sup _{t \geq 0}\left\{e^{\lambda t}\|U(t, \tau) h\|_{\infty}\right\} \leq 2 C_{K} \sup _{0 \leq s \leq \infty} e^{\lambda_{0} s}\|w g(s)\|_{\infty}+2 C_{\varepsilon, N}\left\|h_{0}\right\|_{\infty}
$$

and we conclude our proof.

## 4.2 $\quad L^{\infty}$ Decay for the Bounce-Back Reflection

### 4.2.1 Bounce-Back Cycles and Continuity of $G(t)$

Definition 21 (Bounce-Back Cycles) Let $(t, x, v) \notin \gamma_{0}$. Let $\left(t_{0}, x_{0}, v_{0}\right)=$ $(t, x, v)$ and inductively define for $k \geq 1$ :

$$
\left(t_{k+1}, x_{k+1}, v_{k+1}\right)=\left(t_{k}-t_{\mathbf{b}}\left(x_{k}, v_{k}\right), x_{\mathbf{b}}\left(x_{k}, v_{k}\right),-v_{k}\right)
$$

We define the back-time cycles as:
$X_{\mathbf{c l}}(s ; t, x, v)=\sum_{k} \mathbf{1}_{\left[t_{k+1}, t_{k}\right)}(s)\left\{x_{k}+\left(s-t_{k}\right) v_{k}\right\}, \quad V_{\mathbf{c l}}(s ; t, x, v)=\sum_{k} \mathbf{1}_{\left[t_{k+1}, t_{k}\right)}(s) v_{k}$.

Remark 22 Clearly, we have $v_{k+1} \equiv(-1)^{k+1} v$, for $k \geq 1$,

$$
\begin{equation*}
x_{k}=\frac{1-(-1)^{k}}{2} x_{1}+\frac{1+(-1)^{k}}{2} x_{2} \tag{128}
\end{equation*}
$$

and let $d=t_{1}-t_{2}$, then for $k \geq 1$,

$$
\begin{equation*}
t_{k}-t_{k+1}=d \geq t-t_{\mathbf{b}}>0 \tag{129}
\end{equation*}
$$

We follow the outline in Section 1.6 and first establish an abstract lemma.
Lemma 23 Let $\mathcal{M}$ be an operator on $L^{\infty}\left(\gamma_{+}\right) \rightarrow L^{\infty}\left(\gamma_{-}\right)$such that $\|\mathcal{M}\|_{\mathcal{L}\left(L^{\infty}, L^{\infty}\right)}=$ 1. Then for any $\varepsilon>0$, there exists $h(t) \in L^{\infty}$ and $h_{\gamma} \in L^{\infty}$ solving

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} h=0, \quad h_{\gamma_{-}}=(1-\varepsilon) M h_{\gamma_{+}}, \quad h(0, x, v)=h_{0} \in L^{\infty}
$$

Proof. Fix $\varepsilon>0$, we construct a solution by the following iteration (with $h_{\gamma_{+}}^{0} \equiv 0$ ) for $k=0,1,2 \ldots$

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} h^{k+1}=0, \quad h_{\gamma_{-}}^{k+1}=(1-\varepsilon) M h_{\gamma_{+}}^{k}, \quad h^{k+1}(0, x, v)=h_{0} .
$$

We now show $h^{k}$ and $h_{\gamma}^{k}$ is a Cauchy sequence. Taking differences, we get

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\}\left\{h^{k+1}-h^{k}\right\}=0, \quad h_{\gamma_{-}}^{k+1}-h_{\gamma_{-}}^{k}=(1-\varepsilon) M\left\{h_{\gamma_{+}}^{k}-h_{\gamma_{+}}^{k-1}\right\},
$$

with zero initial datum $\left\{h^{k+1}-h^{k}\right\}_{t=0}=0$. Note that from Lemma 18

$$
\sup _{s}\left\|h_{\gamma_{+}}^{k+1}(s)-h_{\gamma_{+}}^{k}(s)\right\|_{\infty} \leq(1-\varepsilon) \sup _{s}\left\|h_{\gamma_{+}}^{k}(s)-h_{\gamma_{+}}^{k-1}(s)\right\|_{\infty}
$$

Repeatedly using such inequality for $k=1,2, \ldots$, we obtain

$$
\sup _{s}\left\|h_{\gamma_{+}}^{k+1}(s)-h_{\gamma_{+}}^{k}(s)\right\|_{\infty} \leq(1-\varepsilon)^{k} \sup _{s}\left\|h_{\gamma_{+}}^{1}(s)-h_{\gamma_{+}}^{0}(s)\right\|_{\infty}
$$

Hence $\left\{h_{\gamma_{+}}^{k}\right\}$ is Cauchy in $L^{\infty}\left(\mathbf{R} \times \gamma_{-}\right)$, and then both $\left\{h_{\gamma_{-}}^{k}\right\}$ and $\left\{h^{k}\right\}$ are Cauchy respectively by Lemma 18. We deduce our lemma by letting $k \rightarrow \infty$.

Lemma 24 Let $h_{0} \in L^{\infty}\left(\Omega \times \mathbf{R}^{3}\right)$. There exists a unique solution $G(t) h_{0}$ of

$$
\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\}\left\{G(t) h_{0}\right\}=0, \quad\left\{G(0) h_{0}\right\}=h_{0} \tag{130}
\end{equation*}
$$

with the bounce-back reflection $\left\{G(t) h_{0}\right\}(t, x, v)=\left\{G(t) h_{0}\right\}(t, x,-v)$ for $x \in$ $\partial \Omega$. For almost any $(x, v) \in \bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$,

$$
\begin{equation*}
\left\{G(t) h_{0}\right\}(t, x, v)=\sum_{k} \mathbf{1}_{\left[t_{k+1}, t_{k}\right)}(0) e^{-\nu(v) t} h_{0}\left(X_{\mathbf{c l}}(0), V_{\mathbf{c l}}(0)\right) \tag{131}
\end{equation*}
$$

Moreover, $e^{\nu_{0} t}\left\|G(t) h_{0}\right\|_{\infty} \leq\left\|h_{0}\right\|_{\infty}$.
Proof. For any $\varepsilon>0$, by Lemma 23, there exists a solution $h^{\varepsilon}$ of

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} h^{\varepsilon}=0, \quad h^{\varepsilon}(t, x, v)=(1-\varepsilon) h^{\varepsilon}(t, x,-v), \quad h^{\varepsilon}(0, x, v)=h_{0}
$$

with finite $\left\|h^{\varepsilon}(t, \cdot)\right\|_{\infty}$ and $\sup _{t}\left\|h_{\gamma}^{\varepsilon}(t, \cdot)\right\|_{\infty}$. Such a solution is necessary unique. This is because we can choose $w^{-2}\{1+|v|\} \in L^{1}$ so that $f^{\varepsilon}=\frac{h^{\varepsilon}}{w} \in L^{2}$ is a $L^{2}$ solution to the same equation in (130) with the same boundary condition, with an additional property $\int_{0}^{t}\left\|f^{\varepsilon}(s)\right\|_{\gamma}^{2} d s<\infty$. Then uniqueness follows from the energy identity for $f^{\varepsilon}$.

Given any point $(t, x, v) \notin \gamma^{0}$ and its back-time cycle $\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$. We notice $\left|V_{\mathbf{c l}}(s)\right|=|v|$, for all $s$, and $\frac{d}{d s} G(s) h_{0} \equiv-\nu G(s) h_{0}$ along the back-time cycle $\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$ for $t_{k+1} \leq s<t_{k}$. Together with the boundary condition at $s=t_{k}$, and part (4) of Lemma 6 we deduce that for almost every $(x, v)$, $e^{\nu(v) t} G(s) h_{0}$ is constant along its back-time cycle $\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right.$ ] in (127). If $(x, v) \in \bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$, then $t_{\mathbf{b}}(x, v)>0$, and

$$
h^{\varepsilon}(t, x, v)=\sum_{k} \mathbf{1}_{\left[t_{k+1}, t_{k}\right)}(0)[1-\varepsilon]^{k} e^{-\nu(v) t} h_{0}\left(X_{\mathbf{c l}}(0), V_{\mathbf{c l}}(0)\right)
$$

where the summation over $k$ is finite for finite $t$ by (129). For all $\varepsilon$,

$$
e^{\nu_{0} t}\left\|h^{\varepsilon}(t)\right\|_{\infty} \leq\left\|h_{0}\right\|_{\infty}, \quad \sup _{t \geq s, \gamma_{-}}\left|h^{\varepsilon}(t, x, v)\right| \leq \sup _{t \geq s, \gamma_{+}}\left|h^{\varepsilon}(t, x, v)\right| \leq\left\|h_{0}\right\|_{\infty}
$$

uniformly bounded. We thus can construct the solution $h$ to (130) with the original bounce-back boundary condition by taking $w-* \operatorname{limit}: h(t, x, v)=$ $\lim _{\varepsilon \rightarrow 0} h^{\varepsilon}(t, x, v)$, and $h_{\gamma}(t, x, v)=\lim _{\varepsilon \rightarrow 0} h_{\gamma}^{\varepsilon}(t, x, v)$. We thus deduce our lemma by letting $\varepsilon \rightarrow 0$. Once again, such a solution $h(t, x, v)$ is necessarily unique in the $L^{\infty}$ class because $f_{\gamma}=\frac{h_{\gamma}}{w} \in L_{l o c}^{2}\left(L^{2}(\gamma)\right)$.
Lemma 25 Let $\xi$ be convex as in (4). Let $h_{0}$ be continuous in $\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$ and $q(t, x, v)$ be continuous in the interior of $[0, \infty) \times \Omega \times \mathbf{R}^{3}$ and $\sup _{[0, \infty) \times \Omega \times \mathbf{R}^{3}}\left|\frac{q(t, x, v)}{\nu(v)}\right|<$ $\infty$. Assume the compatibility condition on $\gamma_{-}: h_{0}(x, v)=h_{0}(x,-v)$. Then the solution $h(t, x, v)$ of

$$
\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} h=q, \quad h(0, x, v)=h_{0} \tag{132}
\end{equation*}
$$

with $h(t, x, v)=h(t, x,-v), x \in \partial \Omega$ is continuous on $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.

Proof. Take any point $(t, x, v) \notin[0, \infty) \times \gamma_{0}$ and denote its backward exit point $\left[t_{\mathbf{b}}, x_{\mathbf{b}}, v\right]$ along the trajectory. Recall its back-time cycle and (24). Assume $t_{m+1} \leq 0<t_{m}$. Since $\frac{d}{d \tau}\left\{e^{\nu(v)} h\right\}=q$ along the characteristics, $h(t, x, v)$ takes the form

$$
\begin{align*}
& e^{-\nu(v) t} h_{0}\left(x_{m}-t_{m} v_{m}, v_{m}\right)+  \tag{133}\\
& \sum_{k=0}^{m-1} \int_{t_{k+1}}^{t_{k}} e^{-\nu(v)(t-s)} q\left(s, x_{k}+\left(s-t_{k}\right) v_{k}, v_{k}\right) d s+\int_{0}^{t_{m}} e^{-\nu(v)(t-s)} q\left(s, x_{m}+\left(s-t_{m}\right) v_{m}, v_{m}\right) d s
\end{align*}
$$

Since $\Omega$ is convex and $(x, v) \notin \gamma_{0}$, then from the Velocity Lemma $n\left(x_{1}\right) \cdot v_{1} \neq 0$. Notice that $x_{k} \in \partial \Omega$ and $\xi\left(x_{k}\right)=0$ for $k \geq 1$ so that

$$
\alpha\left(t_{k}\right)=\left(v_{k} \cdot \nabla \xi\left(x_{k}\right)\right)^{2}
$$

We now apply the Velocity Lemma [5 to conclude $\alpha\left(t_{k}\right)>C \alpha(t)>0$ and $v_{k} \cdot n\left(x_{k}\right) \neq 0$ for all $k \geq 1$. By Lemma 6 $t_{k}$, and $x_{k}$ for $1 \leq k \leq n$ are smooth functions of $(t, x, v)$. For any other point $(\bar{t}, \bar{x}, \bar{v})$ which is close to $(t, x, v)$, we deduce that $\bar{t}_{m}>0$.

In the case that $t_{m+1}<0$, or equivalently, $x_{m}-t_{m} x_{m} \in \Omega$, from continuity, $\bar{t}_{m+1}(\bar{t}, \bar{x}, \bar{v})<0$. Therefore, $h(\bar{t}, \bar{x}, \bar{v})$ has the same expression as $h(t, x, v)$ in (133). Therefore, $h(\bar{t}, \bar{x}, \bar{v}) \rightarrow h(t, x, v)$ because $\bar{x}_{k} \rightarrow x_{k}$, and $\bar{t}_{k} \rightarrow t_{k}, \bar{v}_{k} \rightarrow v_{k}$ for $1 \leq k \leq m+1$, as in the proof of Lemma 19 ,

On the other hand, if $t_{m+1}=0$, or equivalently, $x_{m+1}=x_{m}-t_{m} x_{m} \in \partial \Omega$, and $\left(x_{m+1}, v_{m}\right) \notin \gamma_{0}$. Then by continuity, we know that $\bar{t}_{m+1}(\bar{t}, \bar{x}, \bar{v})$ is close to zero. In the case that $\bar{t}_{m+1}(\bar{t}, \bar{x}, \bar{v}) \leq 0$, then (133) is again valid and the continuity follows as before. However, if $\bar{t}_{m+1}(\bar{t}, \bar{x}, \bar{v})>0$, then $\bar{t}_{m+2}(\bar{t}, \bar{x}, \bar{v})<0$ (because $t_{m+2}<0$ ), and we have a different expression for $h(\bar{t}, \bar{x}, \bar{v})$ as:

$$
\begin{align*}
& e^{-\nu(\bar{v}) \bar{t}} h_{0}\left(\bar{x}_{m+1}-\bar{t}_{m+1} \bar{v}_{m+1}, \bar{v}_{m+1}\right)+\sum_{k=0}^{m} \int_{\bar{t}_{k+1}}^{\bar{t}_{k}} e^{-\nu(\bar{v})(\bar{t}-s)} q\left(s, \bar{x}_{k}+\left(s-\bar{t}_{k}\right) \bar{v}_{k}, \bar{v}_{k}\right) d s \\
& +\int_{0}^{\bar{t}_{m+1}} e^{-\nu(\bar{v})(\bar{t}-s)} q\left(s, \bar{x}_{m+1}+\left(s-\bar{t}_{m+1}\right) \bar{v}_{m+1}, \bar{v}_{m+1}\right) d s \tag{134}
\end{align*}
$$

The last term in (134) goes to zero because $\bar{t}_{m+1} \rightarrow 0$, and the second term in (134) tends to the $q$ integration in (133) since $\int_{0}^{t_{m}}=\int_{t_{m+1}}^{t_{m}}$. We now show that the first term (134) tends to the first term in (133) as well. Since $\bar{x}_{m+1}-$ $\bar{t}_{m+1} \bar{v}_{m+1} \rightarrow \bar{x}_{m+1} \rightarrow x_{m+1}=x_{m}-t_{m} v_{m} \in \partial \Omega$, the first term in (134) tends to

$$
h_{0}\left(x_{m}-t_{m} x_{m}, v_{m}\right)=h_{0}\left(x_{m}-t_{m} x_{m},-v_{m}\right),
$$

which is exactly the first term in (133), from the compatibility condition $h_{0}(x, v)=$ $h_{0}(x,-v)$ on $\gamma$. We therefore conclude the continuity.

### 4.2.2 Non-Grazing Condition $\left|S_{x}\right|=0$.

The following lemma is due to Hongjie Dong:

Lemma 26 For any $x \in \bar{\Omega}$, define the set

$$
\begin{equation*}
S_{x}(v)=\left\{v \in \mathbf{R}^{3}: v \cdot n\left(x_{\mathbf{b}}(x, v)\right)=0\right\}=\left\{v \in \mathbf{R}^{3}: v \cdot \nabla \xi\left(x-t_{\mathbf{b}}(x, v) v\right)=0\right\} . \tag{135}
\end{equation*}
$$

If $\partial \Omega$ is $C^{1}$, then $\left|S_{x}(v)\right|=0$, where $|\cdot|$ is the Lebesaue measure.
Proof. We first note that if $v \in S_{x}(v)$, then $k v \in S_{x}(v)$ for all $k>0$. It therefore suffices to show that the surface measure $\left|S_{x}(v) \cap \mathbf{S}^{2}\right|=0$.

We fix $x \in \bar{\Omega}$ and recall $x_{\mathbf{b}}=x-t_{\mathbf{b}} v \in \partial \Omega$. If $x \in \partial \Omega$, we require $v \cdot n(x) \neq 0$ (a zero measure set). Hence $\frac{v}{|v|}=-\frac{x_{\mathbf{b}}-x}{\left|x_{\mathbf{b}}-x\right|}$ and $x_{\mathbf{b}} \neq x$. Our goal is to show that, if $v \in S_{x}(v)$, then $\frac{v}{|v|}$ is a critical value of the mapping from $\partial \Omega \rightarrow \mathbf{S}^{2}$ :

$$
\begin{equation*}
\phi(y)=-\frac{y-x}{|y-x|} \tag{136}
\end{equation*}
$$

at $y=x_{\mathbf{b}}$. Since $\phi(y)$ is smooth for $y \neq x$, by Sard's theorem, $\frac{v}{|v|}$ has zero measure in $\mathbf{S}^{2}$ and our lemma is valid.

Indeed, we assume locally around $x_{\mathbf{b}}, \partial \Omega=\left(y_{1}, y_{2}, \eta\left(y_{1}, y_{2}\right)\right)$ and if $v \in$ $S_{x}(v)$, then at $\left(y_{1}, y_{2}\right)=\left(x_{\mathbf{b} 1}, x_{\mathbf{b} 2}\right)$ :

$$
\begin{equation*}
0=\frac{v}{|v|} \cdot n\left(x_{\mathbf{b}}\right)=\left\{x_{\mathbf{b} 1}-x_{1}\right\} \partial_{1} \eta+\left\{x_{\mathbf{b} 2}-x_{2}\right\} \partial_{1} \eta-\eta\left(x_{\mathbf{b} 1}, x_{\mathbf{b} 2}\right)+x_{3}=0 \tag{137}
\end{equation*}
$$

Clearly, since $x_{\mathbf{b}} \neq x$, from (137), $\left[x_{\mathbf{b} 1}-x_{1}, x_{\mathbf{b} 2}-x_{2}\right] \neq 0$. But $\left[\partial_{y_{1}} \phi, \partial_{y_{2}} \phi\right]=$

$$
\left[\begin{array}{cc}
-\frac{1}{|y-x|}+\frac{\left(y_{1}-x_{1}\right)^{2}+\left(y_{1}-x_{1}\right)\left(\eta-x_{3}\right) \partial_{1} \eta}{|y-x|^{3}} & +\frac{\left(y_{1}-x_{1}\right)\left\{y_{2}-x_{2}+\left(\eta-x_{3}\right) \partial_{2} \eta\right\}}{|y-x|^{3}}  \tag{138}\\
\frac{\left(y_{2}-x_{2}\right)\left\{y_{1}-x_{1}+\left(\eta-x_{3}\right) \partial_{1} \eta\right\}}{|y-x|^{3}} & -\frac{1}{|y-x|}+\frac{\left(y_{2}-x_{2}\right)^{2}+\left(y_{2}-x_{2}\right)\left(\eta-x_{3}\right) \partial_{2} \eta}{|y-x|^{3}} \\
-\frac{\partial_{1} \eta}{|y-x|}+\frac{\left(\eta-x_{3}\right)\left\{y_{1}-x_{1}+\left(\eta-x_{3}\right) \partial_{1} \eta\right\}}{|y-x|^{3}} & -\frac{\partial_{2} \eta}{|y-x|}+\frac{\left(\eta-x_{3}\right)\left\{y_{2}-x_{2}+\left(\eta-x_{3}\right) \partial_{2} \eta\right\}}{|y-x|^{3}}
\end{array}\right],
$$

by (137), a direct comupation yields

$$
\begin{equation*}
\left\{x_{\mathbf{b} 1}-x_{1}\right\} \partial_{y_{1}} \phi+\left\{x_{\mathbf{b} 2}-x_{2}\right\} \partial_{y_{2}} \phi=0 \tag{139}
\end{equation*}
$$

at $\left(y_{1}, y_{2}\right)=\left(x_{\mathbf{b} 1}, x_{\mathbf{b} 2}\right)$. This implies that $\frac{v}{|v|}$ is a critical value of $\phi$.
Lemma 27 Assume $|v| \leq 2 N$. Then for any $\varepsilon>0$, there exist $\delta_{\varepsilon, N}>0$, and $l_{\varepsilon, N, \xi}$ balls $B\left(x_{1} ; r_{1}\right), B\left(x_{2}, r_{2}\right) \ldots, B\left(x_{l} ; r_{l}\right) \subset \bar{\Omega}$, as well as open sets $O_{x_{1}}, O_{x_{2}}, \ldots O_{x_{l}}$ of the velocity $v$ with $\left|O_{x_{i}}\right|<\varepsilon$ for $1 \leq i \leq l$, such that for any $x \in \bar{\Omega}$, there exists $x_{i}$ so that $x \in B\left(x_{i} ; r_{i}\right)$ and for $v \notin O_{x_{i}}$,

$$
\begin{equation*}
\left|v \cdot n\left(x-t_{\mathbf{b}}(x, v) v\right)\right|>\delta_{\varepsilon, N}>0, \quad\left|v \cdot n\left(x+t_{\mathbf{b}}(x,-v) v\right)\right|>\delta_{\varepsilon, N}>0 \tag{140}
\end{equation*}
$$

Proof. Fix $\varepsilon>0$. For any $x \in \bar{\Omega}$, since $\left|S_{x}\right|=0$ by Lemma 26, there exists an open set $O_{x}^{+}$such that $\left|O_{x}^{+}\right|<\varepsilon / 2$, and $\left|v \cdot n\left(x-t_{\mathbf{b}}(x, v) v\right)\right| \neq 0$, for $v \notin O_{x}^{+}$. But from part (2) of Lemma 6, this implies that $v \cdot n\left(x-t_{\mathbf{b}}(x, v) v\right)$ is a smooth function on the compact set $\{|v| \leq 2 N\} \cap\left\{O_{x}^{+}\right\}^{c}$. Hence, there exists $\delta_{x, \varepsilon, N}>0$, such that on the set $\{|v| \leq 2 N\} \cap\left\{O_{x}^{+}\right\}^{c}$,

In particular, for $-v \notin O_{x}^{+}$and $|v| \leq 2 N$, or equivalently, $v \notin-O_{x}^{+} \equiv\left\{-v^{\prime}\right.$ : $\left.v^{\prime} \in O_{x}^{+}\right\},\left|v \cdot n\left(x+t_{\mathbf{b}}(x,-v) v\right)\right|>\delta_{x, \varepsilon, N}>0$. We define $O_{x} \equiv O_{x}^{+} \cup\left\{-O_{x}^{+}\right\}$, clearly $\left|O_{x}\right|<\varepsilon$. But by part (2) of Lemma 6, for such $v \notin O_{x}$, both $t_{\mathbf{b}}(x, v)$ and $t_{\mathbf{b}}(x,-v)$ are smooth functions of both variables $x$ and $v$. In other words, there exists $B\left(x ; r_{x}\right)$ such that if $y \in B\left(x ; r_{x}\right)$ and $v \notin O_{x}$

Now for any $x \in \bar{\Omega}$, all $B\left(x, r_{x}\right)$ form an open covering for the compact set $\bar{\Omega}$, hence there is a finite $l-$ subcovering $B\left(x_{1} ; r_{1}\right), B\left(x_{2}, r_{2}\right) \ldots, B\left(x_{l} ; r_{l}\right)$. From our construction, for any $x \in \bar{\Omega}$, there exists $i$, so that $x \in B\left(x_{i}, r_{i}\right)$ and moreover, $\left|v \cdot \nabla n\left(x \mp t_{\mathbf{b}}( \pm v) v\right)\right|>\delta_{x_{i}, \varepsilon, N} / 2>0$. We conclude our lemma by choosing $\delta_{\varepsilon, N}=\min _{i} \frac{\delta_{x_{i}, \varepsilon, N}}{2}$.

### 4.2.3 $\quad L^{\infty}$ Decay of Bounce-back $U(t)$

Theorem 28 Assume $w^{-2}\{1+|v|\} \in L^{1}$. Let $h_{0}=w f_{0} \in L^{\infty}$. There exits a unique solution $f(t, x, v)$ to the linear Boltzmann equation (23) satisfying $f(0, x, v)=f_{0}$, and $h(t, x, v)=U(t) h_{0}$ to the weighted linear Boltzmann equation (27) satisfying $h(0, x, v)=h_{0}$, both with the bounce-back boundary condition. Then there exist $\lambda>0$ and $C>0$ such that

For the well-posedness for both problems, we know from the Duhamel principle (30), there exists a $L^{\infty}$ solution $h(t)=U(t) h_{0}$ to the weighted linear Boltzamnn equation (27). By Ukai's trace theorem, it follows that $h_{\gamma}$ is also in $L^{\infty}$. Therefore, since $w^{-2}\{1+|v|\} \in L^{1}, f=\frac{h}{w} \in L^{2}$ and $f_{\gamma}=\frac{h_{\gamma}}{w} \in L_{l o c}^{2}\left(L^{2}(\gamma)\right)$ is a solution to the original linear Boltzmann equation (23), which is unique by the standard energy estimate. Based on the $L^{2}$ decay estimate for $f$, to prove the decay estimate, it suffices to establish a finite-time estimate (143).

Lemma 29 Assume that there exists $\lambda>0$ so that the solution $f(t, x, v)$ of (23) satisfies $e^{\lambda t}\|f(t)\| \leq C\left\|f_{0}\right\|$. Let $h_{0}=w f_{0} \in L^{\infty}$ and $h(t)=U(t) h_{0}=w f(t)$ is the solution of (27) where $w^{-2} \in L^{1}$. Assume there exist $T_{0}>0$ and $C_{T_{0}}>0$ such that the satisfies

\leq & e^{-m \lambda T_{0}}\|h(0)\|_{\infty}+C_{T_{0}} \sum_{k=0}^{m-1} e^{-k \lambda T_{0}} \int_{\{m-k-1\} T_{0}}^{\{m-k\} T_{0}}\|f(s)\| d s,
\end{aligned}

where $h(t)=U(t) h_{0}$. Now by the $L^{2}$ decay assumption, in the interval $\{m-$ $k-1\} T_{0} \leq s \leq\{m-k\} T_{0}$, we have $\|f(s)\| \leq e^{-\lambda s}\left\|f_{0}\right\| \leq e^{-\lambda\{m-k-1\} T_{0}}\left\|f_{0}\right\|$. Hence, $\left\|h\left(m T_{0}\right)\right\|_{\infty}$ is further bounded by

\leq & e^{-m \lambda T_{0}}\left\|h_{0}\right\|_{\infty}+C_{T_{0}} e^{\lambda T_{0}} m T_{0} e^{-m \lambda T_{0}}\left\|f_{0}\right\| \\
\leq & C_{T_{0}, \lambda} e^{-\frac{m \lambda T_{0}}{2}}\left\|h_{0}\right\|_{\infty},
\end{aligned}
$$

where by $w^{-2} \in L^{1},\left\|f_{0}\right\|=\left\|w^{-1} h_{0}\right\| \leq C\left\|h_{0}\right\|_{\infty}$ and $m T_{0} e^{-m \lambda T_{0}} \leq e^{-\frac{m \lambda T_{0}}{2}}$. For any $t$, we can find $m$ such that $m T_{0} \leq t \leq\{m+1\} T_{0}$, and

since $e^{-\frac{m \lambda T_{0}}{2}} \leq e^{-\frac{\lambda}{2} t} e^{\frac{\lambda T_{0}}{2}}$.
Proof. of Theorem 28, By Lemma 29, we only need to prove the finite-time estimate (143). We use the double Duhamal Principle (31) for semigroup $U(t)$ and $G(t)$. We first estimate the first term in (31) by Lemma 24,

= & e^{-\nu(v)\left(t-s_{1}\right)} \iint K_{w}\left(V_{\mathbf{c l}}\left(s_{1}\right), v^{\prime}\right) K_{w}\left(V_{\mathbf{c l}}^{\prime}(s), v^{\prime \prime}\right) e^{-\nu\left(v^{\prime}\right)\left(s_{1}-s\right)} h\left(s, X_{\mathbf{c l}}^{\prime}(s), v^{\prime \prime}\right) d v^{\prime} d v^{\prime \prime}
\end{aligned}

where $X_{\mathbf{c l}}^{\prime}(s) \equiv X_{\mathbf{c l}}\left(s ; s_{1}, X_{\mathbf{c l}}\left(s_{1}\right), v^{\prime}\right)$, and $V_{\mathbf{c l}}^{\prime}(s) \equiv V_{\mathbf{c l}}\left(s ; s_{1}, X_{\mathbf{c l}}\left(s_{1}\right), v^{\prime}\right)$. In the case that $|v| \geq N$, we use the same argument in Case 1, (119) in the proof of Theorem 20 to conclude:

Since $\mid \nabla \xi\left(X_{\mathbf{c l}}\left(s_{1}\right)\right)$. $v^{\prime} \mid \geq C_{\xi} \varepsilon$, either $t_{\mathbf{b}}^{\prime}\left(v^{\prime}\right) \geq C_{\xi} \varepsilon$ or $t_{\mathbf{b}}^{\prime}\left(-v^{\prime}\right) \geq C_{\xi} \varepsilon$. But for bounce-back cycles,

We are now ready to estimate (150). By Lemma 27, for the given $\varepsilon>0$, there is $\delta_{\varepsilon, N}>0$, and $\left[B\left(x_{i}, r_{i}\right), O_{x_{i}}\right]$ for $i=1, \ldots, l,\left|O_{x_{i}}\right|<\varepsilon$. For $X_{\mathbf{c l}}\left(s_{1}\right) \in \bar{\Omega}$, there exists $i$ such that $X_{\mathbf{c l}}\left(s_{1}\right) \in B\left(x_{i}, r_{i}\right)$ and for $v^{\prime} \notin O_{x_{i}}$

It thus follows from Lemma 6 that $t_{l}^{\prime}$ and $x_{l}^{\prime}$ are all smooth functions of $v^{\prime} \notin O_{x_{i}}$. We then split $\left\{v^{\prime}:\left|v^{\prime}\right| \leq 2 N\right\}$ into

\leq & C_{N} \sup _{s}\left\{e^{\frac{\nu_{0}}{2} s}\|h(s)\|_{\infty}\right\} \int_{0}^{t} e^{-\nu_{0} t} \int_{v^{\prime} \in O_{x_{i}},\left|v^{\prime \prime}\right| \leq 3 N} \sum_{k} \int_{t_{k+1}^{\prime}}^{t_{k}^{\prime}} e^{\frac{\nu_{0}}{2} s} d s \\
\leq & C_{N}\left|O_{x_{i}}\right| \sup _{s}\left\{e^{\frac{\nu_{0}}{2} s}\|h(s)\|_{\infty}\right\} \int_{0}^{t} \int_{0}^{s_{1}} e^{-\nu_{0} t} e^{\frac{\nu_{0}}{2} s} d s d s_{1} \\
= & C_{N} \varepsilon e^{-\frac{\nu_{0}}{2} t} \times \sup _{s}\left\{e^{\frac{\nu_{0}}{2} s}| | h(s) \|_{\infty}\right\} \tag{154}
\end{align*}

By (151), we therefore only need to consider the second part in (153):

There exists a $\zeta_{\varepsilon, N, T_{0}}>0$ such that

We therefore have a finite covering (depending on $\left.\varepsilon, T_{0}, N\right) O_{s_{m}, v_{m}^{\prime}}$ such that

\leq & C_{N} \int_{0}^{t} e^{-\nu_{0} t} \sum_{k, m} \int_{t_{k+1}^{\prime}(y)}^{t_{k}^{\prime}(y)} \int_{O_{s_{m}, v_{m}^{\prime}}} \int_{\left|v^{\prime \prime}\right| \leq 3 N} \mathbf{1}_{\left[0, s_{1}\right]}(s) e^{\nu_{0} s} h\left(s, y, v^{\prime \prime}\right) \frac{1}{J\left\{\frac{\partial y}{\partial v^{\prime}}\right\}} d y d v^{\prime \prime} d s d s_{1} \\
\leq & C_{N, \varepsilon, T_{0}} \int_{0}^{t} e^{-\nu_{0} t} \int_{0}^{s_{1}} \int_{\left|v^{\prime \prime}\right| \leq 3 N} e^{\nu_{0} s}\left\{\int_{\Omega} h^{2}\left(s, y, v^{\prime \prime}\right) d y\right\}^{1 / 2} d v^{\prime \prime} d s d s_{1} \\
\leq & C_{N}, \varepsilon, T_{0} \int_{0}^{t} e^{-\nu_{0} t} \int_{0}^{s_{1}} e^{\nu_{0} s}\left\{\int_{\Omega \times\left|v^{\prime \prime}\right| \leq 3 N} h^{2}\left(s, y, v^{\prime \prime}\right) d y d v^{\prime \prime}\right\}^{1 / 2} d s d s_{1} \\
\leq & C_{N, \varepsilon, T_{0}} \int_{0}^{t} e^{-\nu_{0} t} \int_{0}^{s_{1}} e^{\nu_{0} s}| | f(s) \| d s d s_{1} \\
\leq & C_{N}, \varepsilon, T_{0} \times \int_{0}^{T_{0}}\|f(s)\| d s,
\end{aligned}
$$

where $k \leq C_{T_{0}, N, \varepsilon}$ and $m \leq C_{T_{0}, N, \varepsilon}$. We thus conclude from (155), (154), (149),
(148), (147), (146), for $t \leq T_{0}, e^{\frac{\nu_{0}}{2} t}\|h(t)\|_{\infty}$ is bounded by

We first choose $T_{0}$ so that $2 C_{K}\left(1+T_{0}\right) e^{-\frac{\nu_{0}}{2} T_{0}}=e^{-\lambda T_{0}}$, next choose $N$ large, then $\varepsilon$ sufficiently small to get $\left(\frac{C_{K}}{N}+C_{N} \varepsilon\right)<\frac{1}{2}$. We therefore conclude

## 4.3 $\quad L^{\infty}$ Decay for Specular Reflection

### 4.3.1 Specular Cycles and Continuity of $G(t)$

Definition 30 Fix any point $(t, x, v) \notin \gamma_{0}$, and define $\left(t_{0}, x_{0}, v_{0}\right)=(t, x, v)$, and for $k \geq 1$

Lemma 31 Let $\Omega$ be convex (4). Let $h_{0} \in L^{\infty}$ and $G(t) h_{0}$ solves (130) with specular boundary condition $h(t, x, v)=h(t, x, R(x) v)$ for $x \in \partial \Omega$. Then for almost all $(x, v) \notin \gamma_{0}$,

And $e^{\nu_{0} t}\left\|G(t) h_{0}\right\|_{\infty} \leq\left\|h_{0}\right\|_{\infty}$.
Proof. The existence and uniqueness of the solution follows exactly the argument in the proof in Lemma 24 with the bounce-back condition replaced by the specular reflection.

If $(x, v) \in \bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$, then $t_{\mathbf{b}}(x, v)>0$. We consider the back-time specular cycles of $(t, x, v)$ as $\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$ as in (157). Clearly, $\left|V_{\mathbf{c l}}(s)\right| \equiv v$. Since $\frac{d}{d s}\left\{e^{-\nu(v)} G(s) h_{0}\right\} \equiv 0$ for $t_{k+1}<s<t_{k}$, any $k$, by part 4 of Lemma 6 and the specular boundary condition at $t_{k+1}$ and $t_{k}$, it follows that $e^{-\nu(v)} G(s) h_{0}$ is a constant along the cycle $\left[X_{\mathbf{c l}}(s), V_{\text {cl }}(s)\right]$.

We now show for fixed $t$, the number of bounces $k$ is finite. Since $(x, v) \in$ $\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$, by (36), $\alpha(t)>0$. By repeatedly applying Velocity Lemma 5 along the back-time cycle $\left[X_{\mathbf{c l}}(s), V_{\text {cl }}(s)\right]$, we have for all $k \geq 1: e^{-C t_{k}} \alpha\left(t_{k}\right) \geq$ $e^{-C t_{k-1}} \alpha\left(t_{k-1}\right) \geq \ldots \geq e^{-C t} \alpha(t)>0$. But $\alpha\left(t_{k}\right)=\left\{v_{k} \cdot \nabla \xi\left(x_{k}\right)\right\}^{2}$, we then have

Lemma 32 Let $\xi$ be convex as in 4). Let $h_{0}$ be continuous in $\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}$ and $q(t, x, v)$ be continuous in the interior of $[0, \infty) \times \Omega \times \mathbf{R}^{3}$ and $\sup _{[0, \infty) \times \Omega \times \mathbf{R}^{3}}\left|\frac{q(t, x, v)}{\nu(v)}\right|<$ $\infty$. Assume that on $\gamma_{-}, h_{0}(x, v)=h_{0}(x, R(x) v)$. Then the specular solution $h(t, x, v)$ to (132) is continuous on $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$.
Proof. We only sketch the proof, which is similar to that for Lemma 25 Take any point $(t, x, v) \notin[0, \infty) \times \gamma_{0}$ and consider its specular back-time cycle $\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$ as in (159). By repeatedly applying the Velocity Lemma 5 and Lemma 6] it follows that $t_{k}(t, x, v), x_{k}(t, x, v)$ and $v_{k}(t, x, v)$ are all smooth functions of $(t, x, v)$. We assume that $t_{m+1} \leq 0<t_{m}$, then $h(t, x, v)$ is given by (133) with specular cycles $\left[t_{k}, x_{k}, v_{k}\right] \in\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$. For any other point $(\bar{t}, \bar{x}, \bar{v})$ which is close to $(t, x, v)$. We now show that $h(\bar{t}, \bar{x}, \bar{v})$ is close to $h(t, x, v)$ by separating two different cases.

In the case that $t_{m+1}<0$, or equivalently, $x_{m}-\left(t_{m}-s\right) v_{m} \in \Omega$, away from the boundary. By continuity, $\bar{t}_{m+1}<0$. Therefore, we have the same expression for $h(\bar{t}, \bar{x}, \bar{v})$ as $h(t, x, v)$ in (133) with $t_{k}, x_{k}, v_{k}$ replaced by $\bar{t}_{k}, \bar{x}_{k}, \bar{v}_{k}$. Therefore, since $\left|v_{l}\right| \equiv|v|, h(\bar{t}, \bar{x}, \bar{v}) \rightarrow h(t, x, v)$ following from the continuity of $\bar{t}_{l} \rightarrow t_{l}$, $\bar{x}_{l} \rightarrow x_{l}, \bar{v}_{l} \rightarrow v_{l}$.

On the other hand, in the case $t_{m+1}=0, x_{m+1}=x_{m}-t_{m} v_{m} \in \partial \Omega$. From (160), $\left(x_{k+1}, v_{k}\right) \notin \gamma_{0}$. Then by continuity, we know that $\bar{t}_{m}>0$, and $\bar{t}_{m+1}$ is close to zero. In the case that $\bar{t}_{m+1}(\bar{t}, \bar{x}, \bar{v})<0$, then (133) is still valid and the continuity follows. However, if $\bar{t}_{m+1}>0$, then $\bar{t}_{m+2}<0$, due to $t_{m+2}<t_{m+1}=$ 0 . Therefore $h(\bar{t}, \bar{x}, \bar{v})$ is given by a different expression (134) with specular cycles $\left[t_{k}, x_{k}, v_{k}\right] \in\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$. We notice that since $\bar{t}_{m+1} \rightarrow 0$, the $q$-integrals in (134) tend to $q$-integrals in (133) because of $\int_{0}^{t_{m}}=\int_{t_{m+1}}^{t_{m}}$. On the other hand, since $\bar{x}_{m+1}-\bar{t}_{m+1} \bar{v}_{m+1} \rightarrow x_{m+1}, \quad \bar{v}_{m+1} \rightarrow v_{m+1}=R\left(x_{m}\right) v_{m}$, the first term in (134) tends to the first term in (133) as

### 4.3.2 $\operatorname{det}\left(\frac{\partial v_{k}}{\partial v_{1}}\right)$ Near $\partial \Omega$

Assume $\Omega$ is convex as in (4). We now compute $\operatorname{det}\left(\frac{\partial v_{k}}{\partial v_{1}}\right)$ for a carefully chosen specular back-time cycle near the boundary $\partial \Omega$. We assume $x_{1} \in \partial \Omega$. Given $\varepsilon_{0}$ small, we choose $v_{1}$ such that

We shall analyze the specular back-time cycle of $\left(0, x_{1}, v_{1}\right):\left(t_{k}, x_{k}, v_{k}\right)$. Letting $s_{k}=t_{\mathbf{b}}\left(x_{k}, v_{k}\right)$, we have $\xi\left(x_{1}-s_{1} v_{1}\right)=0, x_{2}=x_{1}-s_{1} v_{1} \in \partial \Omega$ and for $k \geq 2$ :

where $O$ depends on $k$, and $\zeta$ is defined as $\zeta(1)=0$,

& =\left.\left(\frac{\partial_{m q} \xi}{|\nabla \xi|}-\frac{n^{m} \partial_{o q} \xi n^{o}}{|\nabla \xi|}\right)\right|_{x_{k}} \times\left\{-\sum_{j=1}^{k-1} \partial_{v_{1}^{l}} s_{j} v_{j}^{q}-\sum_{j=1}^{k-1} s_{j} \frac{\partial v_{j}^{q}}{\partial v_{1}^{l}}\right\} \tag{170}
\end{align*}

\end{aligned}
$$

Since $v_{j} \cdot \nabla \xi\left(x_{j+1}\right)=-d_{j+1}$, from (168), $\sum_{o, e} \frac{\partial_{o e} \xi\left(x_{j}\right) s_{j} v_{j}^{e} v_{p}^{o}}{-d_{j+1}}=-2+O\left(\varepsilon_{0}\right)$ and

\partial_{v_{1}^{l}} s_{j}= & \sum_{o} \frac{\partial_{o} \xi\left(x_{j+1}\right)}{d_{j+1}} \frac{\partial v_{j}^{o}}{\partial v_{1}^{l}} s_{j}-\left\{2-O\left(\varepsilon_{0}\right)\right\} \sum_{p=1}^{j-1} \partial_{v_{1}^{l}} s_{p}-\sum_{o, e} \sum_{p=1}^{j-1} \frac{\partial_{o e} \xi\left(x_{j}\right) s_{j} v_{j}^{e}}{d_{j+1}} \frac{\partial v_{p}^{o}}{\partial v_{1}^{l}} s_{p} \\
& +O(1)\left\{\sum_{p=1}^{j-1} \frac{\partial v_{p}^{o}}{\partial v_{1}^{l}} s_{p}+\sum_{p=1}^{j-1} v_{p}^{o} \partial_{v_{1}^{l}} s_{p}\right\} . \tag{171}
\end{align*}
$$

We first claim that for $1 \leq j \leq k$

& =\sum_{p=1}^{j} \sum_{o}(-1)^{j-p} \frac{\partial_{o} \xi\left(x_{p+1}\right)}{d_{p+1}} \frac{\partial v_{p}^{o}}{\partial v_{1}^{l}} s_{p}+O\left(\frac{1}{\varepsilon_{0}}\right) \tag{174}
\end{align*}

we have used the fact by (173), $A_{1}=\partial_{v_{1}^{l}} s_{1}=\sum_{o} \frac{\partial_{o} \xi\left(x_{2}\right)}{d_{2}} \frac{\partial v_{1}^{o}}{\partial v_{1}^{l}} s_{1}$. Now finally we recall (170), $\partial_{v_{1}^{l}} n_{k}^{i}=O\left(\frac{1}{\varepsilon_{0}}\right)$, so that the second term on the right hand side in (169) is of the order $O\left(\varepsilon_{0}\right)$. Hence

= & 2 \frac{v_{1}^{m} \partial_{m q} \xi\left(x_{1}\right) v_{1}^{q}}{\left|\nabla \xi\left(x_{1}\right)\right|} \times\left\{\sum_{j=1}^{k-1} \partial_{v_{1}^{l}} s_{j}\right\} n_{1}^{i}-2\left(\frac{\partial v_{k-1}}{\partial v_{1}^{l}} \cdot n_{1}\right) n_{1}^{i}+O\left(\varepsilon_{0}\right) \text { by (167) } \\
= & 2 \frac{v_{1}^{m} \partial_{m q} \xi\left(x_{1}\right) v_{1}^{q}}{\left|\nabla \xi\left(x_{1}\right)\right|} \times \sum_{j=1}^{k-1}(-1)^{k-p-1} \frac{\partial_{o} \xi\left(x_{p+1}\right)}{d_{p+1}} \frac{\partial v_{p}^{o}}{\partial v_{1}^{l}} s_{p} n_{1}^{i}+O\left(\varepsilon_{0}\right) \text { by (174). }
\end{aligned}
$$

Note $\frac{s_{p}}{d_{p+1}} v_{1}^{m} \partial_{m q} \xi\left(x_{1}\right) v_{1}^{q}=4+O\left(\varepsilon_{0}\right)$ from (164) and (168), we deduce

\end{aligned}

Notice that $\sum_{o} n_{1}^{o} n_{1}^{o}=1$, and splitting $\sum_{j}^{k-1}=\sum_{j}^{k-2}+\sum_{j=k-1}^{k-1}$ and collecting terms, we conclude our proposition.

& +\int_{0}^{t} \int_{0}^{s_{1}} \int e^{-\nu(v)\left(t-s_{1}\right)-\nu\left(v^{\prime}\right)\left(s_{1}-s\right)} K_{w}\left(V_{\mathbf{c l}}\left(s_{1}\right), v^{\prime}\right) K_{w}\left(V_{\mathbf{c l}}^{\prime}(s), v^{\prime \prime}\right) h\left(X_{\mathbf{c l}}^{\prime}(s), v^{\prime \prime}\right)
\end{align*}
$$

where the back-time specular cycle from $\left(s_{1}, X_{\mathbf{c l}}\left(s_{1}\right), v^{\prime}\right)$ is denoted by

Theorem 35 Assume $w^{-2}\{1+|v|\} \in L^{1}$. Assume that $\xi$ is both strictly convex (4) and analytic, and the mass (17) and energy (18) are conserved. In the case of $\Omega$ has rotational symmetry (5), we also assume conservation of corresponding angular momentum (19). Let $h_{0} \in L^{\infty}$. There exits a unique solution to both the (23) and (27) with boundary specular condition, and the exponential decay (142) is valid.

Proof. The well-posedness follows from the exact argument in the proof of Theorem 28. Thanks to Lemma 29] we only need to establish the finite time estimate (143). Recall $A_{\alpha}$ in (179).

STEP 1: Estimate of $h(t, x, v) \mathbf{1}_{A_{\alpha}}$. We first express and estimate the main part $h(t, x, v) \mathbf{1}_{A}$ through (175). As in the case of bounce-back reflection, the first and the second terms in (175) are bounded by (144) and (145a) respectively.

For the third main contribution in (175), notice that along the back-time specular cycles $\left[X_{\mathbf{c l}}(s), V_{\text {cl }}(s)\right]$ and $\left[X_{\text {cl }}^{\prime}(s), V_{\text {cl }}^{\prime}(s)\right]$ in (176), $\left|V_{\text {cl }}\left(s_{1}\right)\right| \equiv|v|$ and $\left|V_{\text {cl }}^{\prime}\left(s_{1}\right)\right| \equiv\left|v^{\prime}\right|$. = & \frac{e^{\nu(v)\left(t_{1}-t\right)}}{\tilde{w}(v)} \int_{\mathcal{V}_{1}} \mathbf{1}_{\left\{t_{1}>s, t_{2} \leq s\right\}} e^{\nu\left(v_{1}\right)\left(s-t_{1}\right)} h\left(s, x_{1}+v_{1}\left(s-t_{1}\right), v_{1}\right) \tilde{w}\left(v_{1}\right) d \sigma_{1} \\
& +\frac{e^{\nu(v)\left(t_{1}-t\right)}}{\tilde{w}(v)} \int_{s}^{t_{1}} \int_{\mathcal{V}_{1}} \mathbf{1}_{\left\{t_{1}>s, t_{2} \leq s\right\}} e^{\nu\left(v_{1}\right)\left(\tau-t_{1}\right)} q\left(\tau, x_{1}+v_{1}\left(\tau-t_{1}\right), v_{1}\right) \tilde{w}\left(v_{1}\right) d \sigma_{1} d \tau \\

Assume $h(0, x, v)=h_{0}(x, v)$, continuous for $(x, v) \notin \gamma_{0}$, and $q(t, x, v)$ is continuous in the interior of $[0, \infty] \times \Omega \times \mathbf{R}^{3}$ with $\sup _{[0, \infty] \times \Omega \times \mathbf{R}^{3}}\left|\frac{q(t, x, v)}{\nu(v)}\right|<\infty$. Assume

Now we take any point $(\bar{t}, \bar{x}, \bar{v})$ near $(t, x, v)$ and evaluate $h(\bar{t}, \bar{x}, \bar{v})$ by (192) with the same number of bounces ( $k$-bounces), and with corresponding $\bar{t}_{l}, \bar{x}_{l}$ and $\overline{\mathcal{V}}_{l}$ and $d \bar{\sigma}_{l}$.

Step 1. Reduction to the approximate of phase spaces. Since $\nu(v) \backsim$ $|v|$ for large $v$ and $\frac{1}{\tilde{w}}$ decays exponentially, by Lemma 39 and the Duhamel principle,

\int \mathbf{1}_{\left\{\bar{t}_{k} \leq 0\right\}} & =\int_{\left\{\text {there exists a } v_{l} \in \overline{\mathcal{V}}_{l} \backslash \overline{\mathcal{V}}_{l}^{\left.\varepsilon_{1}\right\}}\right.} \mathbf{1}_{\left\{\bar{t}_{k} \leq 0\right\}}+\int_{\left\{\text {all } v_{l} \in \overline{\mathcal{V}}_{l}^{\varepsilon_{1}}\right\}} \mathbf{1}_{\left\{\bar{t}_{k} \leq 0\right\}} .
\end{aligned}
$$

Clearly, by (190), $\int_{\mathcal{V}_{l} \backslash \mathcal{V}_{l}^{\varepsilon_{1}}} d \sigma_{l}+\int_{\overline{\mathcal{V}}_{l} \backslash \overline{\mathcal{V}}_{l}^{\varepsilon_{1}}} d \bar{\sigma}_{l} \leq C \varepsilon_{1}$, so that from the boundedness of $h_{0}$ and $\frac{q}{\nu}$, the integrals in (192) over the almost grazing sets are small:

Therefore, it suffices to compare only the integrations over the non-grazing sets $\Pi_{l=1}^{k-1} \mathcal{V}_{l}^{\varepsilon_{1}} \cap\left\{t_{k} \leq 0\right\}$ and $\Pi_{l=1}^{k-1} \overline{\mathcal{V}}_{l}^{\varepsilon_{1}} \cap\left\{\bar{t}_{k} \leq 0\right\}$. For any $1 \leq l \leq k-1$, recalling the back-time diffuse cycle (188), if $\alpha\left(t_{l}\right)=\left\{v_{l} \cdot n\left(x_{l}\right)\right\}^{2} \geq \frac{\varepsilon_{1}}{2}>0$, then from convexity and the Velocity Lemma 5e deduce

Step 2. Continuity of $h(t, x, v)$ over $B$.
Case 1: $t_{1}(t, x, v) \leq 0$. In the case $t_{1}<0$, then $\bar{t}_{1}<0$ by continuity over the set $B$ in (207). Then both $h(t, x, v)$ and $h(\bar{t}, \bar{x}, \bar{v})$ are given by the same formula (191). The continuity now follows from $(\bar{t}, \bar{x}, \bar{v}) \rightarrow(t, x, v)$ and the continuity of $h_{0}$ and $q$. Same argument also applies to the situation $t_{1}=0$ and $t_{1} \leq 0$.

We only need to study the case $t_{1}=0$ but $\bar{t}_{1}>0$ in which $h(\bar{t}, \bar{x}, \bar{v})$ are given by the different expression (192). Over the set $B$, since $\left|\bar{v}_{1} \cdot n\left(\bar{x}_{1}\right)\right| \geq \varepsilon_{1}>0$, from (40) that $\bar{t}_{1}-\bar{t}_{2} \geq \frac{\varepsilon_{1}^{3}}{C_{\xi}}$. But $\bar{t}_{1} \rightarrow t_{1}=0$, we therefore deduce that $\bar{t}_{2}<0$. This implies for $k$ large

### 4.4.3 Decay for Diffuse Reflection $U(t)$

Theorem 41 Let $h_{0} \in L^{\infty}$ and assume (21). There exits a unique solution to both the (23) and (27) with the diffuse boundary condition (184). Let $U(t) h_{0}$ be the solution the the weighted linear Boltzmann equation (27) with the diffuse boundary condition, then there exist $\lambda>0$ and $C>0$ such that the exponential decay (142) is valid.

Proof. Once again, with the $L^{\infty}$ solution $h(t)=U(t) h_{0}$ to the weighted linear Boltzmann equation (27), from Lemma 39 and Duhamel principle (30), we deduce from Ukai's trace theorem, $h_{\gamma} \in L^{\infty}$. So $f=\frac{h}{w}$ satisfies the original linear Boltzmann equation (23) with $f \in L^{2}$ and $\int_{0}^{t}\|f(s)\|_{\gamma}^{2} d s<\infty$. Hence uniqueness follows for $f$ by using the standard $L^{2}$ energy estimate. The well-posedness follows from the exact argument in the proof of Theorem 28, By Lemma 29and the $L^{2}$ decay for the diffuse boundary problem, it suffices to establish the finite time estimate (143).

We apply the double-Duhamel's principle (31). By Lemma 39, the first two terms in (31) are easily bounded by $C_{K}(t+1) e^{-\nu_{0} t}\left\|h_{0}\right\|_{\infty}$.

We concentrate on the third term

& \int_{\left|v_{l^{\prime}}\right| \geq N} \int\left|K_{w}\left(v_{l^{\prime}}, v^{\prime \prime}\right)\right| d v^{\prime \prime} \tilde{w}\left(v_{l^{\prime}}\right) \mu\left(v_{l^{\prime}}\right)\left\{n\left(x_{l^{\prime}}^{\prime}\right) \cdot v_{l^{\prime}}\right\} d v_{l^{\prime}}  \tag{219}\\
\leq & \frac{C_{K}}{N} \int_{\left|v_{l^{\prime}}\right| \geq N} \tilde{w}\left(v_{l^{\prime}}\right) \mu\left(v_{l^{\prime}}\right)\left\{n\left(x_{l^{\prime}}^{\prime}\right) \cdot v_{l^{\prime}}\right\} d v_{l^{\prime}}=\frac{C_{K}}{N}
\end{align*}
$$

By similar arguments as in Case 1 (119), Case 2 (122) in the proof of Theorem 20, we only need to consider the case $|v| \leq N,\left|v^{\prime}\right| \leq 2 N$, and $\left|v_{l^{\prime}}\right| \leq N$ and $\left|v^{\prime \prime}\right| \leq 2 N$, for some large $N$. As in Case 4 in the proof of Theorem 20, we can also use the same approximation (124). Hence, for each fixed $l^{\prime}$, we only need to control:

& \int_{t_{1}}^{t} \int_{\Pi_{j=1}^{l^{\prime}-1} \mathcal{V}_{j}^{\prime}}\left\{\int_{\left|v^{\prime \prime}\right| \leq 2 N,\left|v_{l^{\prime}}\right| \leq N} \int_{t_{l^{\prime}+1}^{\prime}}^{t_{l^{\prime}}^{\prime}} e^{\nu_{0}(s-t)}\left|h\left(s, x_{l^{\prime}}^{\prime}-\left(t_{l^{\prime}}^{\prime}-s\right) v_{l^{\prime}}, v^{\prime \prime}\right)\right| d v^{\prime \prime} d v^{\prime} d v_{l^{\prime}}\right\} \Pi_{j=1}^{l^{\prime}-1} d \sigma_{j}^{\prime} \\
\leq & \int_{t_{l^{\prime}+1}^{\prime}}^{t_{l^{\prime}}^{\prime}} \mathbf{1}_{\left\{t_{l^{\prime}}^{\prime}-s \geq \frac{1}{N}\right\}}+\mathbf{1}_{\left\{t_{l^{\prime}}^{\prime}-s \leq \frac{1}{N}\right\}} \\
\leq & \int_{t_{l^{\prime}+1}^{\prime}}^{t_{l^{\prime}}^{\prime}} \mathbf{1}_{\left\{t_{l^{\prime}}^{\prime}-s \geq \frac{1}{N}\right\}}+\frac{C}{N} \sup _{0 \leq s \leq T_{0}}\left\{e^{-\nu_{0}\left(s-t_{l^{\prime}}^{\prime}\right)}\|h(s)\|_{\infty}\right\} .
\end{aligned}
$$

Here we have used the fact $\int\left\{\prod_{j=l^{\prime}+1}^{k-1} d \sigma_{j}\right\}=1$. Notice that $x_{l^{\prime}}^{\prime}$ and $t_{l^{\prime}}^{\prime}$ depend only on $t, x, v, v_{1}, \ldots v_{l^{\prime}-1}$, not on $v_{l^{\prime}}$. By making a change of variable $y=x_{l^{\prime}}^{\prime}-$ $\left(t_{l^{\prime}}^{\prime}-s\right) v_{l^{\prime}}$, for the first part, we use Fubini's theorem and the fact $\int\left\{\Pi_{j=1}^{l^{\prime}-1} d \sigma_{j}\right\}=$ 1 to majorize it as $\left(f=\frac{h}{w}\right)$ :

C_{N, T_{0}} \int_{0}^{T_{0}}\left\{\int_{y \in \Omega,\left|v^{\prime \prime}\right| \leq 2 N}\left|h\left(s, y, v^{\prime \prime}\right)\right|^{2} d y d v^{\prime \prime}\right\}^{1 / 2}=C_{N, T_{0}, \Omega} \int_{0}^{T_{0}}\|f(s)\| d s \tag{220}
\end{equation*}
$$

For the third term in (218), for fixed $l$, we consider the $v_{l}, v^{\prime}, v^{\prime \prime}$ integration. Recall $d \Sigma_{l}\left(s_{1}\right)=\left\{\Pi_{j=l+1}^{k-1} d \sigma_{j}\right\} e^{\nu\left(v_{l}\right)\left(s_{1}-t_{l}\right)} \tilde{w}\left(v_{l}\right) d \sigma_{l} \Pi_{j=1}^{l-1}\left\{e^{\nu\left(v_{j}\right)\left(t_{j+1}-t_{j}\right)} d \sigma_{j}\right\}$ and the exponential factor is bounded by $e^{\nu_{0}\left(t_{1}-s_{1}\right)}$. Because $\tilde{w}\left(v_{l}\right) \mu\left(v_{l}\right)$ is bounded and integrable, as in (219), we can use the arguments in Case 1 (119), Case 2 (122) in the proof of Theorem 20] to reduce to $\left|v_{l}\right| \leq N,\left|v^{\prime}\right| \leq 2 N$ and $\left|v^{\prime \prime}\right| \leq 3 N$. As in the second term, it then suffices to estimate

e^{-\nu_{0}(t-s)} \int_{\Pi_{j=1}^{l-1} \mathcal{V}_{j}^{\prime}} \int_{t_{l+1}}^{t_{l}} \int_{s}^{s_{1}} \int_{\left|v^{\prime \prime}\right| \leq 2 N,\left|v^{\prime}\right| \leq N}\left|h\left(s, X_{\mathbf{c l}}\left(s_{1}\right)-\left(s_{1}-s\right) v^{\prime}, v^{\prime \prime}\right)\right| d s d s_{1} d v^{\prime \prime} d v^{\prime} \Pi_{j=1}^{l-1} d \sigma_{j}
$$

which is bounded by (220) by the change of variable $y=X_{\mathbf{c l}}\left(s_{1}\right)-\left(s_{1}-s\right) v^{\prime}$.
In the last integral in (218), both back-time diffuse cycles first hit the boundary. For fixed $l$ and $l^{\prime}$, we consider the $v_{l}, v_{l^{\prime}}$ and $v^{\prime}, v^{\prime \prime}$ integration. We again
recall $d \Sigma_{l}$ and $d \Sigma_{l^{\prime}}^{\prime}$ and their exponential factors are bounded by $e^{\nu_{0}\left(t_{1}-s_{1}\right)}$ and $e^{\nu_{0}\left(t_{1}^{\prime}-s\right)}$ respectively. Notice that both $\tilde{w}\left(v_{l}\right) \mu\left(v_{l}\right)$ and $\tilde{w}\left(v_{l^{\prime}}\right) \mu\left(v_{l^{\prime}}\right)$ are bounded and integrable. We use twice (219), and as in the reduction to (220), we can reduce to the case of $\left|v_{l}\right| \leq N,\left|v^{\prime}\right| \leq 2 N$, and $\left|v_{l^{\prime}}\right| \leq N,\left|v^{\prime \prime}\right| \leq 2 N$. Therefore, by using the approximation (124) and $\int\left\{\Pi_{j=l^{\prime}+1}^{k-1} d \sigma_{j}^{\prime}\right\}=1, \int\left\{\Pi_{j=l+1}^{k-1} d \sigma_{j}\right\}=1$, we only need to control:

\int_{\Pi_{j=1}^{l-1} \mathcal{V}_{j}} \int_{\Pi_{j=1}^{l^{\prime}-1} \mathcal{V}_{j}^{\prime}} \int_{t_{l+1}}^{t_{l}} \int_{t_{l^{\prime}+1}^{\prime}}^{t_{l^{\prime}}^{\prime}} \int_{\left|v_{l^{\prime}}\right|,\left|v^{\prime \prime}\right| \leq 2 N} e^{\nu_{0}(s-t)}\left|h\left(s, x_{l^{\prime}}^{\prime}-\left(t_{l^{\prime}}^{\prime}-s\right) v_{l^{\prime}}, v^{\prime \prime}\right)\right| d v^{\prime \prime} d v_{l^{\prime}} d s d s_{1} \mid \Pi_{j=1}^{l^{\prime}-1} d \sigma_{j}^{\prime} \Pi_{j=1}^{l-1} d \sigma_{j}
$$

which is again bounded by (220) by the change of variable $y=x_{l^{\prime}}^{\prime}-\left(t_{l^{\prime}}^{\prime}-s\right) v_{l^{\prime}}$.
Summing over $l, l^{\prime} \leq k-1$, and letting $N$ large, we summarize:

\|h(t)\|_{\infty} \leq C_{K}\{1+t\} e^{-\frac{\nu_{0}}{2} t}\left\|h_{0}\right\|_{\infty}+\varepsilon C_{K} e^{-\frac{\nu_{0}}{8} t} \sup _{0 \leq t \leq T_{0}}\left\{e^{\frac{\nu_{0}}{8} s}\|h(s)\|_{\infty}\right\}+C_{N, T_{0}, \varepsilon} \int_{0}^{T_{0}}\|f(s)\| d s
$$

Choosing $\varepsilon$ small such that $\varepsilon C_{K}=\frac{1}{2}$, and $T_{0}$ large so that $2 C_{K}\left\{1+T_{0}\right\} e^{-\frac{\nu_{0}}{2} T_{0}}=$ $e^{-\lambda T_{0}}$, we deduce (143), and by Lemma 29, we deduce our theorem.

## 5 Nonlinear Exponential Decay

Proof. (of Theorem 1): Step 1. Existence and Continuity: Let $h^{0} \equiv 0$, we use iteration

with $\left.h^{m+1}\right|_{t=0}=h_{0},\left.h^{m+1}\right|_{\gamma^{-}}=w g$. We further split $h^{m+1}=h_{g}^{m+1}+h_{\Gamma}^{m+1}$ for $m \geq 1$, where $h_{g}^{m+1}$ satisfies the homogeneous linear weighted Boltzmann equation (27)

\left\{\partial_{t}+v \cdot \nabla_{x}+\nu-K_{w}\right\} h_{g}^{m+1}=0,\left.\quad h_{g}^{m+1}\right|_{\gamma^{-}}=w g,\left.\quad h_{g}^{m+1}\right|_{t=0}=h_{0}
$$

while $h_{\Gamma}^{m+1}$ satisfies the inhomogeneous linear weighted Boltzmann equation (27) with zero-boundary condition:

$$
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu-K_{w}\right\} h_{\Gamma}^{m+1}=w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right),\left.h_{\Gamma}^{m+1}\right|_{\gamma^{-}}=\left.h_{\Gamma}^{m+1}\right|_{t=0}=0
$$

Clearly, from Theorem 20, for some $0<\lambda<\lambda_{0}$,

$$
\sup _{0 \leq t \leq \infty} e^{\lambda t}\left\|h_{g}^{m+1}(t)\right\|_{\infty} \leq C\left\{\left\|h_{0}\right\|_{\infty}+\sup _{0 \leq t \leq \infty} e^{\lambda_{0} t}\|w g(t)\|_{\infty}\right\}
$$

On the other hand, denote $U_{0}(t, s)$ and $G_{0}(t, s)$ to be solution operators for linear weighted Boltzmann equation (27) and (29) with zero boundary condition
respectively, then $U_{0}(t, s)=U_{0}(t-s, 0)$ and $G_{0}(t, s)=G(t-s, 0)$ are semigroups. Hence, by the Duhamel Principle,

h_{\Gamma}^{m+1}=\int_{0}^{t} U_{0}(t-s) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s \tag{222}
\end{equation*}
$$

To avoid the extra weight function $\nu(v) \sim\{1+|v|\}^{\gamma}$ in Lemma 9, we further use the Duhamal Principle $U_{0}(t-s)=G_{0}(t-s)+\int_{s}^{t} G_{0}\left(t-s_{1}\right) K_{w} U_{0}\left(s_{1}-s\right) d s_{1}$ to bound (222) by
$\left\|\int_{0}^{t} G_{0}(t-s) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s\right\|_{\infty}+\left\|\int_{0}^{t} \int_{s}^{t} G_{0}\left(t-s_{1}\right) K_{w} U_{0}\left(s_{1}-s\right) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s_{1} d s\right\|_{\infty}$.
For any $(t, x, v)$, by Lemma 9

$$
\left|\left\{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)\right\}(s, x-(t-s) v, v)\right| \leq C \nu(v)\left\|h^{m}\right\|_{\infty}^{2}
$$

By the explicit formula (109) with $g=0$, we therefore can bound the first term in (223) as

\begin{align*}
& \left|\int_{0}^{t} e^{-\nu(v)(t-s)} \mathbf{1}_{t-t_{\mathbf{b}}(x, v) \leq s}\left\{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)\right\}(s, x-(t-s) v, v) d s\right| \\
\leq & C \int_{0}^{t} e^{-\nu(v)(t-s)} \nu(v)\left\|h^{m}(s)\right\|_{\infty}^{2} d s \\
\leq & C \int e^{-\frac{\nu(v)}{2}(t-s)} \nu(v) d s \times \sup _{0 \leq s \leq t}\left\{e^{-\frac{\nu_{0}}{2}(t-s)}\left\|h^{m}(s)\right\|_{\infty}^{2}\right\} \\
\leq & C e^{-\frac{\nu_{0}}{2} t} \times \sup _{s}\left\{e^{\frac{\nu_{0}}{2} s}\left\|h^{m}(s)\right\|_{\infty}\right\}^{2} \tag{224}
\end{align*}
$$

Here we have used the fact $\nu(v) \geq \nu_{0}$, and $\int e^{-\frac{\nu(v)}{2}(t-s)} \nu(v) d s<\infty$.
On the other hand, for the second term in (223), let the semigroup $\tilde{U}(t) h_{0}$ solve

\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu-K_{w / \sqrt{1+\rho|v|^{2}}}\right\}\left\{\tilde{U}(t) h_{0}\right\}=0 \tag{225}
\end{equation*}
$$

with $\left.\left\{\tilde{U}(t) \tilde{h}_{0}\right\}\right|_{\gamma-}=0$ and $\tilde{U}(0) \tilde{h}_{0}=\tilde{h}_{0}$. By a direct computation, $\sqrt{1+\rho|v|^{2}} \tilde{U}(t)$ solves the original linear Boltzmann equation (27). By uniqueness in the $L^{\infty}$ class, we deduce

U(t) h_{0} \equiv \sqrt{1+\rho|v|^{2}} \tilde{U}(t)\left\{\frac{h_{0}}{\sqrt{1+\rho|v|^{2}}}\right\} \tag{226}
\end{equation*}
$$

Therefore, we can rewrite $K_{w} U\left(s_{1}, s\right) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)$ to get

\int_{0}^{t} \int_{s}^{t} e^{-\nu_{0}\left(t-s_{1}\right)}\left\|\left\{\int K_{w}\left(v, v^{\prime}\right)\left\{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}\right\}\right\} \tilde{U}\left(s_{1}-s\right)\left\{\frac{w}{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}} \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\}\right\|_{\infty} d s_{1} d s d v^{\prime}
$$

Since $w^{-2}(1+|v|)^{3} \in L^{1}, \quad\left\{\frac{w}{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}}\right\}^{-2}(1+|v|) \in L^{1}$ so that Theorem 20 is valid for $\tilde{U}$. Since $\frac{\nu\left(v^{\prime}\right)}{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}} \leq C_{\rho}$, from the proof of Lemma 9

\begin{equation*}
\int K_{w}\left(v, v^{\prime}\right) \sqrt{1+\rho\left|v^{\prime}\right|^{2}} d v^{\prime} \leq C \int K_{w}\left(v, v^{\prime}\right)\left\{\left|v-v^{\prime}\right|+|v|\right\} d v^{\prime}<+\infty \tag{227}
\end{equation*}
$$

Hence the second term in (223) is bounded

$$
\begin{align*}
& C \int_{0}^{t} \int_{s}^{t} e^{-\nu_{0}\left(t-s_{1}\right)} \tilde{U}\left(s_{1}-s\right)\left\|\left\{\frac{w}{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}} \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\}\right\|_{\infty} d s_{1} d s \\
\leq & C \int_{0}^{t} \int_{s}^{t} e^{-\lambda\left(t-s_{1}\right)}\left\|h^{m}(s)\right\|_{\infty}^{2} d s_{1} d s \\
\leq & C e^{-\frac{\lambda}{2} t} \times\left\{\sup _{0 \leq s \leq \infty} e^{\frac{\lambda}{2} s}\left\|h^{m}(s)\right\|_{\infty}\right\}^{2} \tag{228}
\end{align*}
$$

Collecting terms for both $h_{g}^{m+1}$ and $h_{\Gamma}^{m+1}$, we obtain for $0<\lambda<\lambda_{0}$,

$$
\sup _{m} \sup _{0 \leq t \leq \infty}\left\{e^{\lambda t}\left\|h^{m+1}(t)\right\|_{\infty}\right\} \leq C\left\{\left\|h_{0}\right\|_{\infty}+\sup _{0 \leq s \leq \infty} e^{\lambda_{0} s}\|g(s)\|_{\infty}\right\}
$$

for $\left\|h_{0}\right\|$ sufficiently small. Moreover, subtracting $h^{m+1}-h^{m}$ yields:

\left\{\partial_{t}+v \cdot \nabla_{x}+\nu-K_{w}\right\}\left\{h^{m+1}-h^{m}\right\}=w\left\{\Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)-\Gamma\left(\frac{h^{m-1}}{w}, \frac{h^{m-1}}{w}\right)\right\} \tag{229}
\end{equation*}
$$

with zero initial and boundary value. Therefore, splitting

$$
\Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)-\Gamma\left(\frac{h^{m-1}}{w}, \frac{h^{m-1}}{w}\right)=\Gamma\left(\frac{h^{m}-h^{m-1}}{w}, \frac{h^{m}}{w}\right)-\Gamma\left(\frac{h^{m-1}}{w}, \frac{h^{m-1}-h^{m}}{w}\right)
$$

we can bound $\left\|h^{m+1}(t)-h^{m}(t)\right\|_{\infty}$ as in (224) and (228):

\begin{align*}
& C\left\|\int_{0}^{t} U_{0}(t-s) w \Gamma\left(\frac{h^{m}-h^{m-1}}{w}, \frac{h^{m}}{w}\right)(s) d s\right\|_{\infty}  \tag{230}\\
& +C\left\|\int_{0}^{t} U_{0}(t-s) w \Gamma\left(\frac{h^{m-1}}{w}, \frac{h^{m-1}-h^{m}}{w}\right)(s) d s\right\|_{\infty} \\
\leq & C \sup _{s}\left\{e^{\lambda s}\left\{\left\|h^{m}(s)\right\|_{\infty}+\left\|h^{m-1}(s)\right\|\right\}\right\} \times e^{-\lambda t} \times \sup _{s}\left\{e^{\lambda s}\left\{\left\|h^{m}(s)-h^{m-1}(s)\right\|_{\infty}\right\} .\right.
\end{align*}
$$

Hence $h^{m}$ is a Cauchy sequence and the limit $h$ is a desired unique solution.
Moreover, if $\Omega$ is strictly convex, by Lemma 19, inductively, $h^{m}$ is continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$. It is straightforward and routine to verify that $w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)$ is continuous in the interior of $[0, \infty) \times \Omega \times \mathbf{R}^{3}$. Moreover, from Lemma 9, sup $\left|\frac{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)}{\nu}\right|$ is also finite. We therefore deduce that $h^{m+1}$ and hence $h$ is also continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$ from the uniform convergence.

Step 2. Uniqueness and Positivity. Assume that there is another solution $\tilde{h}$ to the full Boltzmann equation with the same initial and boundary condition as $h$. Assume that $\sup _{0 \leq t \leq T_{0}}\|\tilde{h}(t)\|_{\infty}$ is sufficiently small. Then

so that $\|h(t)-\tilde{h}(t)\|_{\infty}$ is bounded by as in step 1 :

& C\left\|\int_{0}^{t} U_{0}(t-s) w \Gamma\left(\frac{h-\tilde{h}}{w}, \frac{h}{w}\right)(s) d s\right\|_{\infty}+C\left\|\int_{0}^{t} U_{0}(t-s) w \Gamma\left(\frac{\tilde{h}}{w}, \frac{h-\tilde{h}}{w}\right)(s) d s\right\|_{\infty} . \\
& \leq \quad C_{T_{0}} \sup _{0 \leq s \leq T_{0}}\left\{\left\{\|h(s)\|_{\infty}+\|\tilde{h}(s)\|\right\}\right\} \sup _{0 \leq s \leq T_{0}}\left\{\|h(s)-\tilde{h}(s)\|_{\infty}\right.
\end{aligned}
$$

This implies that $\sup _{0 \leq t \leq T_{0}}\|h(t)-\tilde{h}(t)\|_{\infty} \equiv 0$ if $\sup _{0 \leq t \leq T_{0}}\|\tilde{h}(t)\|_{\infty}$ and $\sup _{0 \leq t \leq T_{0}}\|h(t)\|_{\infty}$ sufficiently small.

Finally, we address the positivity of the $F=\mu+\sqrt{\mu} f$. We use a different approximation for the original Boltzmann equation (1)

\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}\right\} F^{m+1}+\nu\left(F^{m}\right) F^{m+1}=Q_{\operatorname{gain}}\left(F^{m}, F^{m}\right) \tag{231}
\end{equation*}
$$

with the inflow boundary condition $\left.F^{m+1}\right|_{\gamma^{-}}=\mu+\sqrt{\mu} g \geq 0$ and $\left.F^{m+1}\right|_{t=0}=$ $\mu+\sqrt{\mu} f_{0}$, starting with $F^{0} \equiv \mu$. Here

$$
\nu\left(F^{m}\right)=\int F^{m}(v)|v-u|^{\gamma} d u d \omega
$$

In terms of $f^{m}=\frac{F^{m}-\mu}{\sqrt{\mu}}$, by (9) and (10), we have

$$
\begin{equation*}
\left\{\partial_{t}+v \cdot \nabla_{x}+\nu\right\} f^{m+1}=K f^{m}+\Gamma_{\text {gain }}\left(f^{m}, f^{m}\right)-\Gamma_{\mathrm{loss}}\left(f^{m}, f^{m+1}\right) \tag{232}
\end{equation*}
$$

It is routine and standard to show that $h^{m}=w f^{m}$ is convergent in $L^{\infty}$, locally in time $\left[0, T_{0}\right]$, where $T_{0}$ depends on $\left\|h_{0}\right\|_{\infty}=\left\|\frac{F_{0}-\mu}{\sqrt{\mu}}\right\|_{\infty}$ and $\sup _{0 \leq t \leq T_{0}}\|g(t)\|_{\infty}$. By induction on $m$, we can show that if $F^{m} \geq 0$, the $Q_{\text {gain }}\left(F^{m}, F^{m}\right) \geq 0$. Denote the integration factor as

$$
\begin{equation*}
I(t, s)=e^{-\int_{s}^{t} \nu\left(F^{m}\right)(\tau, X(\tau), V(\tau)) d \tau} \tag{233}
\end{equation*}
$$

so that $\frac{d}{d s}\left\{I(t, s) F^{m+1}\right\}=I(t, s) Q_{\text {gain }}\left(F^{m}, F^{m}\right)$ almost everywhere along the back-time trajectory $[X(s), V(s)]$ of $t, x, v$, inside $\bar{\Omega}$. As in (109), we express $F^{m+1}(t, x, v)=$

$$
\begin{aligned}
& \mathbf{1}_{t-t_{\mathbf{b}} \leq 0}\left\{I(t, 0) F_{0}(x-v t, v)+\int_{0}^{t} I(t, s) Q_{\text {gain }}\left(F^{m}, F^{m}\right)(X(s), V(s)) d s\right\}+\mathbf{1}_{t-t_{\mathbf{b}}>0} \times \\
& \left.\left\{I\left(t, t-t_{\mathbf{b}}\right)\{\mu+\sqrt{\mu} g\}\left(t-t_{\mathbf{b}}, x-v t_{\mathbf{b}}, v\right)+\int_{t-t_{\mathbf{b}}}^{t} I(t, s) Q_{\text {gain }}\left(F^{m}, F^{m}\right)(X(s), V(s))\right) d s\right\}
\end{aligned}
$$

so that $F^{m+1} \geq 0$ on $\left[0, T_{0}\right]$. This implies that $F \geq 0$ in the limit with $h=$ $\frac{F-\mu}{\sqrt{\mu}} \in L^{\infty}$. By the uniqueness of our solutions with this class, $F$ is the same solution we constructed earlier. We obtain $F \geq 0$ for all time by repeating $\left[0, T_{0}\right],\left[T_{0}, 2 T_{0}\right] \ldots\left[k T_{0},(k+1) T_{0}\right]$, from the uniform bound of $\sup _{t}\|h(t)\|_{\infty}$.
Proof. (of Theorem 2 and Theorem 3): We use the same iteration (221) with either bounce-back or specular reflection for $h^{m+1}$. By the Duhamel Principle,

$$
\begin{equation*}
h^{m+1}=U(t) h_{0}+\int_{0}^{t} U(t-s) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s . \tag{234}
\end{equation*}
$$

Applying either Theorems 28 or 35 respectively, by Lemma 9, we have

$$
\left\|h^{m+1}(t)\right\|_{\infty} \leq C e^{-\lambda t}\left\|h_{0}\right\|_{\infty}+\left\|\int_{0}^{t} U(t-s) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s\right\|_{\infty}
$$

To avoid the extra weight function $\nu(v) \sim\{1+|v|\}^{\gamma}$ in Lemma 9 , we use $U(t-s)=G(t-s)+\int_{s}^{t} G\left(t-s_{1}\right) K_{w} U\left(s_{1}-s\right) d s_{1}$ to estimate the second term above. For any $(t, x, v) \notin \gamma_{0}$, and its back-time cycle $\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right)$, we use (131) and (159) respectively to get

$$
\begin{aligned}
& \left|\int_{0}^{t} G(t-s)\left\{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\} d s\right|=\left|\int_{0}^{t} e^{-\nu(v)(t-s)}\left\{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s, X(s), V(s))\right\} d s\right| \\
\leq & C \left\lvert\, \int_{0}^{t} e^{-\nu(v)(t-s)} \nu(v)\left\|h^{m}(s)\right\|_{\infty}^{2} d s \leq C e^{-\frac{\nu_{0}}{2} t} \times\left\{\sup _{0 \leq s \leq \infty} e^{\frac{\nu_{0}}{2} s}\left\|h^{m}(s)\right\|_{\infty}\right\}^{2}\right.
\end{aligned}
$$

where we have used Lemma 9 and (224).
On the other hand, for the second term, we use $\tilde{U}$ as in (225) with either the bounce-back or specular reflection. Hence (226) still holds. Since $w^{-2}(1+|v|)^{3} \in$ $L^{1}$, Theorems 28 or 35 are valid for $\tilde{U}$, and we get from (228)

$$
\begin{align*}
& \int_{0}^{t} \int_{s}^{t} e^{-\nu_{0}\left(t-s_{1}\right)}\left\|K_{w} U\left(s_{1}-s\right) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\|_{\infty} d s d s_{1} \\
\leq & C \int_{0}^{t} \int_{s}^{t} e^{-\nu_{0}\left(t-s_{1}\right)}\left\{\int K_{w}\left(v, v^{\prime}\right) \sqrt{1+\rho\left|v^{\prime}\right|^{2}} d v^{\prime}\right\} \tilde{U}\left(s_{1}-s\right) \|\left\{\frac{\left.w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\}}{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}} \|_{\infty} d s d s_{1}\right. \\
\leq & C \int_{0}^{t} \int_{s}^{t} e^{-\nu_{0}\left(t-s_{1}\right)} \tilde{U}\left(s_{1}-s\right)\left\|\frac{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)}{\sqrt{1+\rho\left|v^{\prime}\right|^{2}}}\right\|_{\infty} d s d s_{1} \\
\leq & C e^{-\frac{\lambda}{2} t} \times\left\{\sup _{0 \leq s \leq \infty} e^{\frac{\lambda}{2} s}\left\|h^{m}(s)\right\|_{\infty}\right\}^{2} \tag{235}
\end{align*}
$$

by (227). This implies that $\sup _{m} \sup _{0 \leq t \leq \infty}\left\{e^{\frac{\lambda}{2} t}\left\|h^{m+1}(t)\right\|_{\infty}\right\} \leq C\left\|h_{0}\right\|_{\infty}$ for $\left\|h_{0}\right\|$ sufficiently small. Moreover, by subtracting $h^{m+1}-h^{m}$, by (229) and (230), we deduce that $h^{m}$ is a Cauchy sequence and the limit $h$ is the desired unique solution. If $\Omega$ is strictly convex, inductively, by Lemma 25 and 32 respectively, $h^{m}$ is continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$, and $w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)$ is continuous in $[0, \infty) \times \Omega \times \mathbf{R}^{3}$. Moreover, from Lemma 9, sup $\left|\frac{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)}{\nu}\right|$ is also finite. We
therefore deduce that $h$ is also continuous in $[0, \infty) \times\left\{\bar{\Omega} \times \mathbf{R}^{3} \backslash \gamma_{0}\right\}$ from the uniform convergence.

As for the positivity of $F$, we follow the argument in the proof of the inflow case by using a different iterative scheme (231) with either bounce-back or specular reflection boundary conditions, so that $f^{m}=\frac{F^{m}-\mu}{\sqrt{\mu}}$ satisfies (232). Again, it follows from a routine procedure to show that $h^{m}=w f^{m}$ is a Cauchy sequence, local in time $\left[0, T_{0}\right]$. Assume $F^{m} \geq 0$. For any $(t, x, v) \notin \gamma_{0}$, we denote its backtime cycle (either bounceback or specular) as $\left[X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right]$, and $t_{1}, t_{2}, \ldots t_{l}>0$, so that $t_{l+1} \leq 0$. Recall (233), so that $\frac{d}{d s}\left\{I(t, s) F^{m+1}\right\}=I(t, s) Q_{\text {gain }}\left(F^{m}, F^{m}\right)$ almost everywhere along the back-time cycles $[X(s), V(s)]$ of $t, x, v$, inside $\bar{\Omega}$. As in Lemmas 131 and 159, we can express $F^{m+1}(t, x, v)$ as

$$
I\left(t, t_{1}\right) F^{m+1}\left(t_{1}, x_{1}, v_{1}\right)+\int_{t_{1}}^{t} I(s, t) Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s) d s \geq I\left(t, t_{1}\right) F^{m+1}\left(t_{1}, x_{1}, v_{1}\right)\right.
$$

For $1 \leq i \leq l$, similarly,

$$
\begin{aligned}
& F^{m+1}\left(t_{i}, x_{i}, v_{i}\right)=I\left(t_{i}, t_{i+1}\right) F^{m+1}\left(t_{i+1}, x_{i+1}, v_{i+1}\right)+\int_{t_{1}}^{t} I\left(s, t_{i}\right) Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s) d s\right. \\
& F^{m+1}\left(t_{l}, x_{l}, v_{l}\right)=I\left(t_{l}, 0\right) F_{0}\left(X_{\mathbf{c l}}(0), V_{\mathbf{c l}}(0)\right)+\int_{0}^{t_{l}} I(s, 0) Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s) d s \geq 0\right.
\end{aligned}
$$

Hence by an induction over $i, F^{m+1} \geq 0$ and we deduce $F \geq 0$ by the uniqueness as in the proof of the in-flow case.
Proof. of Theorem 4. We use the same iteration (221) together with the diffusive boundary condition (184). By (234), we further bound its last term by the Duhamal principle as before:
$\left\|\int_{0}^{t} G(t-s) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s\right\|_{\infty}+\left\|\int_{0}^{t} \int_{s}^{t} G\left(t-s_{1}\right) K_{w} U\left(s_{1}-s\right) w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s) d s d s_{1}\right\|_{\infty}$.
We estimate the first term above in two parts:

$$
\left|\int_{0}^{t} G(t-s)\left\{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\} d s\right| \leq\left|\int_{t-1}^{t}\right|+\left|\int_{0}^{t-1}\right|
$$

For $\int_{t-1}^{t}$, we use estimate (195) and Lemma 9 to get

$$
\begin{aligned}
& \left|\int_{t-1}^{t} e^{-\nu_{0}(t-s)} \mathbf{1}_{\left\{t_{1} \leq s\right)}\left\{\frac{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)}{\tilde{w}}\right\} d s\right|+\left|\int_{t-1}^{t} e^{-\nu(v)(t-s)} \mathbf{1}_{\left\{t_{1} \leq s\right)}\left\{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\} d s\right| \\
\leq & C \sup \left|\int_{t-1}^{t} e^{-\nu(v)(t-s)} \nu(v) d s\right| \times\left\|h^{m}\right\|_{\infty}^{2}+C e^{-\frac{\nu_{0}}{2} t} \sup \left\{e^{\frac{\nu_{0}}{2} s}| | h(s) \|_{\infty}\right\}^{2} \\
\leq & C e^{-\frac{\nu_{0}}{2} t} \sup \left\{e^{\frac{\nu_{0}}{2} s}| | h(s) \|_{\infty}\right\}^{2} .
\end{aligned}
$$

For $\int_{0}^{t-1}$, we use (196) to get extra decay in $v$ as:

$$
\int_{0}^{t-1} e^{-\frac{\nu_{0}}{2}(t-s)}\left\{\left\|\frac{w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)}{\tilde{w}}\right\|_{\infty}+\left\|e^{-\nu(v)} w \Gamma\left(\frac{h^{m}}{w}, \frac{h^{m}}{w}\right)(s)\right\|_{\infty}\right\} d s \leq C e^{-\frac{\nu_{0}}{2} t} \sup \left\{e^{\frac{\nu_{0}}{2} s}\|h(s)\|_{\infty}\right\}^{2}
$$

We have used the fact $\frac{1}{\tilde{w}}$ decays exponentially by (187).
On the other hand, for the second term, we define $\tilde{U}$ again in (225) with new weight $w_{1}=\frac{w}{\left\{1+\rho|v|^{2}\right\}^{\frac{1}{2}}}$ and the new diffuse boundary condition as

$$
\left.\left\{\tilde{U} \tilde{h}_{0}\right\}(t, x, v)\right|_{\gamma_{-}}=\frac{1}{\tilde{w}_{1}} \int_{v^{\prime} \cdot n(x)>0}\left\{\tilde{U} \tilde{h}_{0}\right\}\left(t, x, v^{\prime}\right) \tilde{w}_{1}\left(v^{\prime}\right) d \sigma .
$$

Hence (226) still holds. By letting $\rho$ further sufficienlty small in (21), we can apply Theorem 41 for the diffusive $\tilde{U}$ exactly as in (235). Hence, $\sup _{m, 0 \leq t \leq \infty}\left\{e^{\lambda t}\left\|h^{m+1}(t)\right\|_{\infty}\right\} \leq$ $C\left\|h_{0}\right\|_{\infty}$ for $\left\|h_{0}\right\|$ sufficiently small. As before, we can construct the desired unique solution and establish continuity when $\Omega$ is convex.

As for the positivity of $F$, we follow use the different iterative scheme (231) with diffuse boundary condition

$$
\left.F^{m+1}(t, x, v)\right|_{\gamma_{-}}=c_{\mu} \mu(v) \int F^{m+1}\left(t, x, v^{\prime}\right)\left\{n \cdot v^{\prime}\right\} d v^{\prime}
$$

and $f^{m}=\frac{F^{m}-\mu}{\sqrt{\mu}}$ satisfies (232). Again, it follows from a routine procedure that $h^{m}=w f^{m}$ is a Cauchy sequence, local in time $\left[0, T_{0}\right]$. Assume $F^{m} \geq 0$ and recall (233) so that $\frac{d}{d s}\left\{I(t, s) F^{m+1}\right\}=I(t, s) Q_{\text {gain }}\left(F^{m}, F^{m}\right)$ almost everywhere along the back-time trajectory $[X(s), V(s)]$ of $t, x, v$, inside $\bar{\Omega}$. Recall (186). For any $(t, x, v)$, consider its back-time diffusive cycle $\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right)$. By a similar derivation as in (192), if $t_{1}(t, x, v) \leq 0$,
$F^{m+1}(t, x, v)=I(t, 0) F_{0}(x-v t, v)+\int_{0}^{t} I(s, 0) Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right) d s \geq 0$.
If $t_{1}(t, x, v)>0$, then for $k \geq 2$,
$F^{m+1}(t, x, v)=\int_{t_{1}}^{t} I\left(s, t_{1}\right) Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right) d s+I\left(t, t_{1}\right) c_{\mu} \mu(v) \int_{\Pi_{j=1}^{k-1} \mathcal{V}_{j}} H^{m}$
where $H^{m}$ is given by

$$
\begin{aligned}
& \sum_{l=1}^{k-1} \mathbf{1}_{\left\{t_{l}>0, t_{l+1} \leq 0\right\}} F_{0}\left(X_{\mathbf{c l}}(0), V_{\mathbf{c l}}(0)\right) d \Sigma_{l}^{m}(0) \\
& +\sum_{l=1}^{k-1} \int_{t_{l+1}}^{t_{l}} \mathbf{1}_{\left\{t_{l+1}>0\right\}} Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right) d \Sigma_{l}^{m}(s) d s \\
& +\sum_{l=1}^{k-1} \int_{s}^{t_{l}} \mathbf{1}_{\left\{t_{l}>0, t_{l+1} \leq 0\right\}} Q_{\text {gain }}\left(F^{m}, F^{m}\right)\left(X_{\mathbf{c l}}(s), V_{\mathbf{c l}}(s)\right) d \Sigma_{l}^{m}(s) d s \\
& +\mathbf{1}_{\left\{t_{k}>0\right\}} F^{m+1}\left(t_{k}, x_{k}, v_{k-1}\right) d \Sigma_{k-1}^{m}\left(t_{k}\right)
\end{aligned}
$$

where $d \Sigma_{l}(s)=\left\{\Pi_{j=l+1}^{k-1} d \sigma_{j}\right\}\left\{I\left(s, t_{l}\right)\left[n\left(x_{l}\right) \cdot v_{l}\right] d v_{l}\right\} \Pi_{j=1}^{l}\left\{I\left(t_{j}, t_{j+1}\right) d \sigma_{j}\right\}$. For any $\varepsilon>0$, by Lemma 37 $\int_{\Pi_{j=1}^{k-2} \mathcal{V}_{j}} \mathbf{1}_{\left\{t_{k-1}>0\right\}} \Pi_{j=1}^{k-2} d \sigma_{j}<\varepsilon$ for $k$ large. Notice that
$\left\{t_{k}>0\right\} \subset\left\{t_{k-1}>0\right\}$, and by (233), $I\left(s, t_{l}\right) \leq C\left(\sup _{m, 0 \leq s \leq T_{0}}\left\|F^{m}(s)\right\|_{\infty}, T_{0}\right)$. Since $F_{0} \geq 0$ and $Q_{\text {gain }}\left(F^{m}, F^{m}\right) \geq 0$, we conclude $F^{m+1}(t, x, v) \geq$

$$
\begin{aligned}
& C\left(\sup _{m, 0 \leq s \leq T_{0}}\left\|F^{m}(s)\right\|_{\infty}, T_{0}\right) \int_{\Pi_{j=1}^{k-1} \mathcal{V}_{j}} \mathbf{1}_{\left\{t_{k}>0\right\}} F^{m+1}\left(t_{k}, x_{k}, v_{k}\right) d v_{k-1} \Pi_{j=1}^{k-2} d \sigma_{j} \\
\geq & -C\left(\sup _{m, 0 \leq s \leq T_{0}}\left\|h^{m}(s)\right\|_{\infty}, T_{0}\right) \int_{\Pi_{j=1}^{k-2} \mathcal{V}_{j}} \mathbf{1}_{\left\{t_{k-1}>0\right\}}\left\{\int_{\mathcal{V}_{k-1}}\left\{\mu+\sqrt{\mu} f^{m+1}\right\}\left(t_{k}, x_{k}, v_{k}\right) d v_{k-1}\right\} \Pi_{j=1}^{k-2} d \sigma_{j} \\
\geq & -C\left(\sup _{m, 0 \leq s \leq T_{0}}\left\|h^{m}(s)\right\|_{\infty}, T_{0}\right) \varepsilon .
\end{aligned}
$$

Since $\varepsilon$ is arbitrary, we deduce that $F^{m+1} \geq 0$ and this conclude the positivity of $F$ over $\left[0, T_{0}\right]$. We then conclude $F \geq 0$ by the uniqueness.
