# ON ASYMPTOTIC STABILITY IN ENERGY SPACE OF GROUND STATES OF NLS IN 2D 

Scipio Cuccagna and Mirko Tarulli


#### Abstract

We transpose work by K.Yajima and by T.Mizumachi to prove dispersive and smoothing estimates for dispersive solutions of the linearization at a ground state of a Nonlinear Schrödinger equation (NLS) in 2D. As an application we extend to dimension 2D a result on asymptotic stability of ground states of NLS proved in the literature for all dimensions different from 2 .


## §1 Introduction

We consider even solutions of a NLS

We assume:
(H1) $\beta(0)=0, \beta \in C^{\infty}(\mathbb{R}, \mathbb{R})$;
(H2) there exists a $p_{0} \in(1, \infty)$ such that for every $k=0,1$,

(H3) there exists an open interval $\mathcal{O}$ such that $\Delta u-\omega u+\beta\left(u^{2}\right) u=0$ admits a $C^{1}$-family of ground states $\phi_{\omega}(x)$ for $\omega \in \mathcal{O}$;
(H4) $\frac{d}{d \omega}\left\|\phi_{\omega}\right\|_{L^{2}(\mathbb{R})}^{2}>0$ for $\omega \in \mathcal{O}$.
(H5) Let $L_{+}=-\Delta+\omega-\beta\left(\phi_{\omega}^{2}\right)-2 \beta^{\prime}\left(\phi_{\omega}^{2}\right) \phi_{\omega}^{2}$ be the operator whose domain is $H_{r a d}^{2}\left(\mathbb{R}^{2}\right)$.
We assume that $L_{+}$has exactly one negative eigenvalue.
By [ShS] the $\omega \rightarrow \phi_{\omega} \in H^{1}(\mathbb{R})$ is $C^{2}$ and by [W1,GSS1-2] (H4-5) yields orbital stability of the ground state $e^{i \omega t} \phi_{\omega}(x)$. Here we investigate asymptotic stability. We need some additional hypotheses.
(H6) For any $x \in \mathbb{R}, u_{0}(x)=u_{0}(-x)$. That is, the initial data $u_{0}$ of (1.1) are even.

Consider the Pauli matrices $\sigma_{j}$ and the linearization $H_{\omega}$ given by:

& H_{\omega}=\sigma_{3}\left[-\Delta+\omega-\beta\left(\phi_{\omega}^{2}\right)-\beta^{\prime}\left(\phi_{\omega}^{2}\right) \phi_{\omega}^{2}\right]+i \beta^{\prime}\left(\phi_{\omega}^{2}\right) \phi_{\omega}^{2} \sigma_{2} .

Then we assume:
(H7) Let $H_{\omega}$ be the linearized operator around $e^{i t \omega} \phi_{\omega}$, see (1.2). $H_{\omega}$ has a positive simple eigenvalue $\lambda(\omega)$ for $\omega \in \mathcal{O}$. There exists an $N \in \mathbb{N}$ such that $N \lambda(\omega)<\omega<$ $(N+1) \lambda(\omega)$.
(H8) The Fermi Golden Rule (FGR) holds (see Hypothesis 4.2 in Section 4).
(H9) The point spectrum of $H_{\omega}$ consists of 0 and $\pm \lambda(\omega)$. The points $\pm \omega$ are not resonances.

Then we prove:
Theorem 1.1. Let $\omega_{0} \in \mathcal{O}$ and $\phi_{\omega_{0}}(x)$ be a ground state in a family of ground states $\phi_{\omega}$. Let $u(t, x)$ be a solution to (1.1). Assume (H1)-(H9). In particular assume the (FGR) in Hypothesis 4.2. Then, if (1.1) is generic, there exist an $\epsilon_{0}>0$ and a $C>0$ such that for any $\epsilon \in\left(0, \epsilon_{0}\right)$ and for any $u_{0}$ with $\left\|u_{0}-e^{i \gamma_{0}} \phi_{\omega_{0}}\right\|_{H^{1}}<\epsilon$, there exist $\omega_{+} \in \mathcal{O}, \theta \in C^{1}(\mathbb{R} ; \mathbb{R})$ and $h_{\infty} \in H^{1}$ with $\left\|h_{\infty}\right\|_{H^{1}}+\left|\omega_{+}-\omega_{0}\right| \leq C \epsilon$ such that

Theorem 1.1 is the two dimensional version of Theorem $1.1[\mathrm{CM}]$. The one dimensional version is in [Cu3]. We recall that results of the sort discussed here were pioneered by Soffer \& Weinstein [SW1], see also [PW], followed by Buslaev \& Perelman [BP1-2], about 15 years ago. In this decade these early works were followed by a number of results [BS,Cu1-2,GNT,M1,CZ,M2,P,RSS,SW1-3,TY1-3,Wd1]. It was heuristically understood that the rate of the leaking of energy from the so called "internal modes" into radiation, is small and decreasing when $N$ increases, producing technical difficulties in the closure of the nonlinear estimates. For this reason prior to Gang Zhou \& Sigal [GS], the literature treated only the case when $N=1$ in (H6). [GS] sheds light for $N>1$. The results in [GS] deal with all spatial dimensions different from 2 under the so called Fermi Golden Rule (FGR) hypothesis. [CM,Cu3] strengthen [GS] by considering initial data in $H^{1}$, by showing that the (FGR) hypothesis is a consequence of what looks generic condition, Hypothesis 4.2 below, if (H8) is assumed. [CM] treats also the case when there are many eigenvalues and Hypothesis 4.2 is replaced by a more stringent hypothesis which is a natural generalization of the (FGR) hypothesis in [GS]. The same result with many eigenvalues case can be proved also here and in [Cu3], but we skip for simplicity the proof. We recall that Mizumachi [M1], resp. [M2], extends to dimension 1, resp 2, the results in [GNT] valid for small solitons obtained by by bifurcation from ground
states of a linear equation, while [CZ] extends in 2D the result in [SW2]. [Cu3] transposes [M1] to the case of large solitons, with the generalizations contained in $[\mathrm{CM}]$. Here we consider the case of dimension 2. Thanks to the work by [M2], it is quite clear how to transpose to dimension 2 the higher dimensional arguments in $[\mathrm{CM}]$. The nonlinear arguments in $[\mathrm{CM}]$ are not sensitive to the dimension except for the lack in 2D of the endpoint Stricharz estimate. Mizumachi [M2] shows how to replace it with an appropriate smoothing estimate of Kato type. The estimate and its proof are suggested by [M2]. In order to complete the proof of Theorem 1.1 we need some dispersive estimates on the linearization $H_{\omega}$ which in spatial dimension 2 are not yet proved in the literature. The main technical task of this paper is the transposition to $H_{\omega}$ of the proof of of $L^{p}$ boundedness of wave operators of Schrödinger operators in dimension 2 due to Yajima [Y2]. We use the following notation. We set $H_{0}(\omega)=\sigma_{3}(-\Delta+\omega)$; given normed spaces $X$ and $Y$ we denote by $B(X, Y)$ the space of operators from $X$ to $Y$ and given $L \in B(X, Y)$ we denote by $\|L\|_{X, Y}$ or by $\|L\|_{B(X, Y)}$ its norm. We prove:

Proposition 1.2. Assume the hypotheses of Theorem 1.1. The following limits are well defined isomorphism, inverse of each other:

For any $p \in(1, \infty)$ and any $k$ the restrictions of $W$ and $Z$ to $L^{2} \cap W^{k, p}$ extend into operators such that for $C(\omega)<\infty$ semicontinuous in $\omega$

with $W_{c}^{k, p}\left(H_{\omega}\right)$ the closure in $W^{k, p}\left(\mathbb{R}^{2}\right)$ of $W^{k, p}\left(\mathbb{R}^{2}\right) \cap L_{c}^{2}\left(H_{\omega}\right)$.
We will set $L^{2, s}$ and $H^{m, s}$

where $m \in \mathbb{N}, s \in \mathbb{R}$ and $\langle x\rangle=\left(1+|x|^{2}\right)^{1 / 2}$. For $f(x)$ and $g(x)$ column vectors, their inner product is $\langle f, g\rangle=\int_{\mathbb{R}^{2}}{ }^{t} f(x) \cdot \overline{g(x)} d x$. The adjoint $H^{*}$ is defined by $\langle H f, g\rangle=\left\langle f, H^{*} g\right\rangle$. Given an operator $H$, its resolvent is $R_{H}(z)=(H-z)^{-1}$. We will write $R_{0}(z)=(-\Delta-z)^{-1}$. We write $\|g(t, x)\|_{L_{t}^{p} L_{x}^{q}}=\| \| g(t, x)\left\|_{L_{x}^{q}}\right\|_{L_{t}^{p}}$ and $\|g(t, x)\|_{L_{t}^{p} L_{x}^{2, s}}=\| \| g(t, x)\left\|_{L_{x}^{2, s}}\right\|_{L_{t}^{p}}$
§2 Linearization, modulation and set up
We will use the following classical result, [We1,GSS1-2], see also [Cu3]:

Theorem 2.1. Suppose that $e^{i \omega t} \phi_{\omega}(x)$ satisfies (H4). Then $\exists \epsilon>0$ and a $A_{0}(\omega)>$ 0 such that for any $\left\|u(0, x)-\phi_{\omega}\right\|_{H^{1}}<\epsilon$ we have for the corresponding solution $\inf \left\{\left\|u(t, x)-e^{i \gamma} \phi_{\omega}\left(x-x_{0}\right)\right\|_{H^{1}\left(x \in \mathbb{R}^{2}\right)}: \gamma \in \mathbb{R} \& x_{0} \in \mathbb{R}\right\}<A_{0}(\omega) \epsilon$.

We can write the ansatz $u(t, x)=e^{i \Theta(t)}\left(\phi_{\omega(t)}(x)+r(t, x)\right), \Theta(t)=\int_{0}^{t} \omega(s) d s+$ $\gamma(t)$. Inserting the ansatz into the equation we get

We set ${ }^{t} R=(r, \bar{r}),{ }^{t} \Phi=\left(\phi_{\omega}, \phi_{\omega}\right)$ and we rewrite the above equation as

Set $H_{0}(\omega)=\sigma_{3}\left(-d^{2} / d x^{2}+\omega\right)$ and $V(\omega)=H_{\omega}-H_{0}(\omega)$. The essential spectrum is

0 is an isolated eigenvalue. Given an operator $L$ we set $N_{g}(L)=\cup_{j \geq 1} \operatorname{ker}\left(L^{j}\right)$. [We2] implies that, if $\{\cdot\}$ means span, $N_{g}\left(H_{\omega}^{*}\right)=\left\{\Phi, \sigma_{3} \partial_{\omega} \Phi\right\} . \lambda(\omega)$ has corresponding real eigenvector $\xi(\omega)$, which can be normalized so that $\left\langle\xi, \sigma_{3} \xi\right\rangle=1$. $\sigma_{1} \xi(\omega)$ generates $\operatorname{ker}\left(H_{\omega}+\lambda(\omega)\right)$. The function $(\omega, x) \in \mathcal{O} \times \mathbb{R} \rightarrow \xi(\omega, x)$ is $C^{2} ;|\xi(\omega, x)|<c e^{-a|x|}$ for fixed $c>0$ and $a>0$ if $\omega \in K \subset \mathcal{O}, K$ compact. $\xi(\omega, x)$ is even in $x$ since by assumption we are restricting ourselves in the category of such functions. We have the $H_{\omega}$ invariant Jordan block decomposition

where we set $L_{c}^{2}\left(H_{\omega}\right)=\left\{N_{g}\left(H_{\omega}^{*}\right) \oplus \oplus_{ \pm} \operatorname{ker}\left(H_{\omega}^{*} \mp \lambda(\omega)\right)\right\}^{\perp}$. We can impose

The following claim admits an elementary proof which we skip:
Lemma 2.2. There is a Taylor expansion at $R=0$ of the nonlinearity $O\left(R^{2}\right)$ in (2.1) with $R_{m, n}(\omega, x)$ and $A_{m, n}(\omega, x)$ real vectors and matrices rapidly decreasing in $x: O\left(R^{2}\right)=$

where by $O_{l o c}$ we mean that the there is a factor $\chi(x)$ rapidly decaying to 0 as $|x| \rightarrow \infty$. By taking inner product of the equation with generators of $N_{g}\left(H_{\omega}^{*}\right)$ and $\operatorname{ker}\left(H_{\omega}^{*}-\lambda\right)$ we obtain modulation and discrete modes equations:

## $\S 3$ Spacetime estimates for $H_{\omega}$

We need analogues of Lemmas 2.1-3 and Corollary 2.1 in [M2]. We call admissible all pairs $(p, q)$ with $1 / p=1 / 2-1 / q$ and $2 \leq q<\infty$. We set $\left(p^{\prime}, q^{\prime}\right)=(p /(p-$ 1), $q /(q-1)$ ). In the lemmas below we assume that the $H_{\omega}$ of the form (1.2) for which hypotheses (H3-5), (H7) and (H9) hold.
Lemma 3.1 (Strichartz estimate). There exists a positive number $C=C(\omega)$ upper semicontinuous in $\omega$ such that for any $k \in[0,2]$ :
(a) for any $f \in L_{c}^{2}(\omega)$ and any admissible all pairs $(p, q)$,

(b) for any $g(t, x) \in S\left(\mathbb{R}^{2}\right)$ and any couple of admissible pairs $\left(p_{1}, q_{1}\right)\left(p_{2}, q_{2}\right)$ we have

Lemma 3.1 follows immediately from Proposition 1.2 since $W$ and $Z$ intertwine $e^{-i t H_{\omega}} P_{c}\left(H_{\omega}\right)$ and $e^{-i t H_{0}}$.

Lemma 3.2. Let $s>1 . \exists C=C(\omega)$ upper semicontinuous in $\omega$ such that:
(a) for any $f \in S\left(\mathbb{R}^{2}\right)$,

Notice that (b) follows from (a) by duality.
Lemma 3.3. Let $s>1$. $\exists C=C(\omega)$ as above such that $\forall g(t, x) \in S\left(\mathbb{R}^{3}\right)$ and $t \in \mathbb{R}$ :

Lemma 3.4. Let $(p, q)$ be an admissible pair and let $s>1 . \exists C=C(\omega)$ as above such that $\forall g(t, x) \in S\left(\mathbb{R}^{3}\right)$ and $t \in \mathbb{R}$ :

Lemma 3.5. Consider the diagonal matrices $E_{+}=\operatorname{diag}(1,0) E_{-}=\operatorname{diag}(0,1)$. Set $P_{ \pm}(\omega)=Z(\omega) E_{ \pm} W(\omega)$ with $Z(\omega)$ and $W(\omega)$ the wave operators associated to $H_{\omega}$. Then we have for $u \in L_{c}^{2}\left(H_{\omega}\right)$

and for any $s_{1}$ and $s_{2}$ and for $C=C\left(s_{1}, s_{2}, \omega\right)$ upper semicontinuous in $\omega$, we have

Proof. Formulas (1) hold with $P_{ \pm}(\omega)$ replaced by $E_{ \pm}$and $H_{\omega}$ replaced by $H_{0}$ and for any $u \in L^{2}\left(\mathbb{R}^{2}\right)$. Applying $W(\omega)$ we get (1) for $H_{\omega}$. Estimate (2) follows by the proof of inequality (3) in Lemma 5.12 [Cu3] which is valid for all dimensions.

## $\S 4$ Proof of Theorem 1.1

We restate Theorem 1.1 in a more precise form:

Corollary 4.8. If Hypothesis 4.2 holds, then $\Gamma(\omega, \omega)>\Gamma$.

The proof that, for ${ }^{t} f_{N}(t)=(h(t), \bar{h}(t)), h(t)$ is asymptotically free for $t \rightarrow \infty$, is similar to the analogous one in $[\mathrm{CM}]$ and we skip it.
$\S 5$ Limiting absorption principle and $L^{2}$ Theory for $H_{\omega}$
In sections $\S 5-\S 7$ we prove Proposition 1.2. We start emphasizing two consequences of hypothesis (H9), in particular (b) clarifies the absence of resonance at $\pm \omega$ :
(a) $H_{\omega}$ has no eigenvalues in $[\omega,+\infty) \cup(-\infty,-\omega]$;
(b) if $g \in W^{2, \infty}\left(\mathbb{R}^{2}, \mathbb{C}^{2}\right)$ satisfies $H_{\omega} g=\omega g$ or $H_{\omega} g=-\omega g$ then $g=0$.

Because of the fact that $H_{\omega}$ is not a symmetric operator, we need some preparatory work to show that in fact $H_{\omega}$ is diagonalizable in the continuous spectrum. This work is done in $\S 5$ which ends with a formula for the wave operator $W$ which is the basis to develop in $\S 6-7$ a transposition of the work of Yajima [Y2].

We first need a preliminary on Schrödinger operators. We will denote by $q(x)$ a real valued function with: $q(x) \geq 0$ with $q(x)>0$ at some points; $q(x) \in C_{0}^{\infty}\left(\mathbb{R}^{2}\right)$. We set $h_{q}=-\Delta+q(x)$. Then we have:

Lemma 5.1. Let $\mathbb{C}_{+}=\{z \in \mathbb{C}: \Im z>0\}$. Suppose $q(x)=0$ for $r \geq r_{0}>0$. Then we have the following facts.
(1) There exists $s_{0}>0$ and $C_{0}>0$ such that for $s \geq s_{0}, R_{h_{q}}(z)$ extends into a function $z \rightarrow R_{h_{q}}^{+}(z)$ which is in $\left(L^{\infty} \cap C^{0}\right)\left(\overline{\mathbb{C}_{+}}, B\left(L^{2, s}, L^{2,-s}\right)\right)$.
(2) For any $n_{0} \in \mathbb{N}$ there exists $s_{0}>0$ such that for any $a_{0}>0$ there is a choice of $C>0$ such that for $n \leq n_{0}$

For $\zeta=r e^{i \theta}$ with $\theta \in(-\pi, \pi)$ let $\sqrt{\zeta}=\sqrt{r} e^{i \theta / 2}$. With this convention for $z \notin[0, \infty)$ for $R_{0}(z)=(-\Delta-z)^{-1}$ we have

We consider now $H_{q}=\sigma_{3}(-\Delta+q+\omega)$ and consider our linearization $H_{\omega}$. Write $H_{\omega}=H_{q}+\left(V_{\omega}-\sigma_{3} q\right)$, and factorize $V_{\omega}-\sigma_{3} q=B^{*} A$ with $A, B$ smooth $\left|\partial_{x}^{\beta} A(x)\right|+$ $\left|\partial_{x}^{\beta} B(x)\right|<C e^{-\alpha|x|} \forall x$, for some $\alpha, C>0$ and for $|\beta| \leq N_{0}, N_{0}$ sufficiently large. We have $\sigma_{1} H_{q}=-H_{q} \sigma_{1}, \sigma_{1} H_{\omega}=-H_{\omega} \sigma_{1}$. We choose the factorization $B^{*} A$ so that $\sigma_{1} B^{*}=-B^{*} \sigma_{1}, \sigma_{1} A=A \sigma_{1}$. By these equalities $\sigma_{1} R_{H_{q}}(z)=-R_{H_{q}}(-z) \sigma_{1}$ and $\sigma_{1} R_{H_{\omega}}(z)=-R_{H_{\omega}}(-z) \sigma_{1}$, so in some of the estimates below it is enough to consider $z \in \overline{\mathbb{C}_{++}}$with $\mathbb{C}_{++}=\{z: \Im z>0, \Re z>0\}$.

Lemma 5.3. For $z \in \overline{\mathbb{C}_{+}}$the function $R_{H_{q}}^{+}(z)$ is well defined and satisfies the following properties:
(1) There exists $s_{0}>0$ and $C_{0}>0$ such that for $s \geq s_{0}$ the function $z \rightarrow R_{H_{q}}^{+}(z)$ is in $\left(L^{\infty} \cap C^{0}\right)\left(\overline{\mathbb{C}_{+}}, B\left(L^{2, s}, L^{2,-s}\right)\right)$.
(2) For any $n_{0} \in \mathbb{N}$ there exists $s_{0}>0$ such that for any $a_{0}>0$ there is a choice of $C>0$ such that for $n \leq n_{0}$ and $\forall z \in \overline{\mathbb{C}_{+}} \cap\left\{z: \operatorname{dist}(z, \pm \omega) \geq a_{0}\right\}$,

This set has 0 measure in $\mathbb{R}$. By Lemma $2.4[\mathrm{CPV}]$ if at some $z \neq \pm \omega$ we have $\operatorname{ker}\left(1+Q_{q}^{+}(z)\right) \neq 0$, then $z$ is an eigenvalue. By hypothesis there are no eigenvalues in $\sigma_{e}\left(H_{\omega}\right)$. Hence we get claim (2).

Lemma 5.5. If $\operatorname{ker}\left(1+Q_{q}^{+}(\omega)\right) \neq 0$ then there exists $g \in W^{2, \infty}\left(\mathbb{R}^{2}\right)$ with $g \neq 0$ such that $H_{\omega} g=\omega g$

Let us assume Lemma 5.5. By hypothesis such $g$ does not exist. This yields (1). By (5), claim (4) Lemma 5.4 and Neumann expansion we get (4). Next, apply (5) to $u \in L_{c}\left(H_{\omega}\right) . A R_{H_{\omega}}(z) u$ is an analytic function in $z$ with values in $L^{2}\left(\mathbb{R}^{2}\right)$ for $z$ near any isolated eigenvalue $z_{0}$ of $H_{\omega}$ because the natural projection of $u$ in $N_{g}\left(H_{\omega}-z_{0}\right)$ is 0 . Away from isolated eigenvalues of $H_{\omega},\left(1+Q_{q}^{+}(z)\right)^{-1}$ is uniformly bounded. Hence (3) in Lemma 5.3 implies (3) in Lemma 5.4.

Proof of Lemma 5.5. Let $0 \neq \widetilde{g} \in \operatorname{ker}\left(1+Q_{q}^{+}(\omega)\right)$. Then

We want now to show that $g \in L^{\infty}\left(\mathbb{R}^{2}\right)$, contrary to the hypotheses. We have ${ }^{t} g=\left(g_{1}, g_{2}\right)$ with $g_{2}=(\Delta-q-2 \omega)^{-1}\left(B^{*} \widetilde{g}\right)_{2}$, where $B^{*} \widetilde{g} \in L^{2, s}\left(\mathbb{R}^{2}\right)$ for any $s$, so $g_{2} \in H^{2}\left(\mathbb{R}^{2}\right)$. We have $g_{1}=R_{h_{q}}^{+}(0)\left(B^{*} \widetilde{g}\right)_{1}$ with $g_{1} \in$ $L^{2,-s}\left(\mathbb{R}^{2}\right)$ for sufficiently large $s$. We split $L^{2, \pm s}=L_{r}^{2, \pm s} \oplus\left(L_{r}^{2, \mp s}\right)^{\perp}$ where $L_{r}^{2, \pm s}$ are the radial functions and we are considering the standard pairing $L^{2, s} \times L^{2,-s} \rightarrow \mathbb{C}$ given by $\int_{\mathbb{R}^{2}} f(x) g(x) d x$. We decompose $g_{1}=g_{1 r}+g_{1 n r}$ with $g_{1 r} \in L_{r}^{2,-s}$ and $g_{1 n r} \in\left(L_{r}^{2, s}\right)^{\perp}$. In $\left(L_{r}^{2,-s}\right)^{\perp} \rightarrow\left(L_{r}^{2, s}\right)^{\perp}$ we have $R_{h_{q}}^{+}(0)=G_{0}-G_{0} q\left(1+Q G_{0} q Q\right)^{-1} G_{0}$ with $Q=1-P$, for $P=P_{0} q_{0}, q_{0}=c_{0}^{-1} q, c_{0}=\int_{\mathbb{R}^{2}} q d x, P_{0} u=\int_{\mathbb{R}^{2}} u d x$. Then

In terms of these two functions the kernel of $R_{h_{q}}^{+}(0)$ in $L^{2}((0, \infty), d r)$ is

Then we conclude that we have a nonzero $g \in H_{l o c}^{2}\left(\mathbb{R}^{2}\right) \cap L^{\infty}\left(\mathbb{R}^{2}\right)$ such that $H_{\omega} g=$ $\omega g$. But this is contrary to the nonresonance hypothesis.

Analogous to Lemma 5.4 is:

For $z \in \mathbb{C}_{+}$the function $B R_{H_{\omega}^{*}}(z) \psi$ extends into a function $B R_{H_{\omega}^{*}}^{+}(z) \psi$ for $z \in \overline{\mathbb{C}_{+}} \backslash \sigma_{d}\left(H_{\omega}\right)$ with the following properties:
(1) For any $a_{0}>0$ there exists $C_{0}>0$ such that $B R_{H_{\omega}^{*}}^{+}(z) \psi \in L^{\infty}\left(X_{a_{0}}, B\left(L^{2}, L^{2}\right)\right)$ where $X_{a_{0}}=\overline{\mathbb{C}_{+}} \cap\left\{z: \operatorname{dist}\left(z, \sigma_{d}\left(H_{\omega}\right)\right) \geq a_{0}\right\}$.
(2) For any $n_{0} \in \mathbb{N}$ there exists $s_{0}>0$ such that for any $a_{0}>0$ there is a choice of $C>0$ such that for $n \leq n_{0}$ and $\forall z \in X_{a_{0}} \cap\left\{z: \operatorname{dist}(z, \pm \omega) \geq a_{0}\right\}$,

Lemma 5.7. There are isomorphisms $\widetilde{W}: L^{2} \rightarrow L_{c}^{2}\left(H_{\omega}\right)$ and $\widetilde{Z}: L_{c}^{2}\left(H_{\omega}\right) \rightarrow L^{2}$, inverses of each other, defined as follows: for $u \in L^{2}, v \in L_{c}^{2}\left(H_{\omega}^{*}\right)$,

We have $H_{\omega} \widetilde{W}=\widetilde{W} H_{q}$ and $H_{q} \widetilde{Z}=\widetilde{Z} H_{\omega}$, $e^{i t H_{\omega}} \widetilde{W}=\widetilde{W} e^{i t H_{q}}$ and $e^{i t H_{q}} \widetilde{Z}=$ $\widetilde{Z} e^{i t H_{\omega}} P_{c}\left(H_{\omega}\right)$. The operators $\widetilde{W}$ and $\widetilde{Z}$ depend continuously on $\widetilde{A}$ and $\widetilde{B}^{*}$ and can be expressed as

Write $H=H_{0}+V_{\omega}, V_{\omega}=B^{*} A$. We have $\sigma_{1} H_{0}=$ $-H_{0} \sigma_{1}, \sigma_{1} H_{\omega}=-H_{\omega} \sigma_{1}$. We choose the factorization of $V_{\omega}$ so that $\sigma_{1} B^{*}=B^{*} \sigma_{1}$, $\sigma_{1} A=-A \sigma_{1}$. By these equalities $\sigma_{1} R_{H_{0}}(z)=-R_{H_{0}}(-z) \sigma_{1}$ and $\sigma_{1} R_{H_{\omega}}(z)=$ $-R_{H_{\omega}}(-z) \sigma_{1}$. We have the following result about existence and completeness of wave operators:

By standard theory $W_{1}$ is an isometric isomorphism of $L^{2}\left(\mathbb{R}^{2}\right)$ into itself with inverse $Z_{1} u=\lim _{t \rightarrow+\infty} e^{i t H_{0}} e^{-i t H_{q}} u$ and by Lemma $5.7 \widetilde{W}$ is an isomorphism $L^{2}\left(\mathbb{R}^{2}\right) \rightarrow$ $L_{c}^{2}\left(H_{\omega}\right)$ with inverse $\widetilde{Z}$. Then by product rule the limit in (2) exists and we have $Z=Z_{1} \circ \widetilde{Z}$ with $Z$ the inverse of $W$.

By the orthogonality in $L^{2}(\mathbb{R})$ of boundary values of Hardy functions in $H^{2}\left(\mathbb{C}_{+}\right)$ and in $H^{2}\left(\mathbb{C}_{-}\right)$we have for $\epsilon>0$

As in $[\mathrm{Y}]$ we deal separately with high,treated in $\S 6$, and low energies, treated in §7. We introduce cut-off functions $\psi_{1}(x) \in C_{0}^{\infty}(\mathbb{R})$, and $\psi_{2}(x) \in C^{\infty}(\mathbb{R})$, with $\psi_{1}(x)+\psi_{2}(x)=1, \psi_{1}(-x)=\psi_{1}(x), \psi_{1}(x)=1$ for $|x| \leq C$ and $\psi_{1}(x)=0$ or $|x|>2 C$ for some $C>\omega$.

## §6 $L^{p}$ BOUNDNESS OF $U$ : HIGH ENERGIES

This part is almost the same of the corresponding part in [Y2]. For $\psi_{1}(x)$ the cutoff function introduced after Lemma 5.11, $\psi_{1}\left(H_{0}\right)$ is a convolution operator with symbol $\psi_{1}\left(|\xi|^{2}+\omega\right)$. Both $\psi_{1}\left(H_{0}\right)$ and $\psi_{2}\left(H_{0}\right)$ are bounded operators in $L^{p}\left(\mathbb{R}^{2}\right)$ for any $p \in[1, \infty]$. In order to estimate the high frequency part (the so called high energy) $U \psi_{2}\left(H_{0}\right)$, we expand $R_{H_{\omega}}^{-}(\lambda)$ into the sum of few terms of Born series

getting by Lemma 5.10 the decomposition $U=U_{1}+U_{2}+U_{3}$ with

Lemma 6.1. The operator $U_{1} \psi_{2}\left(H_{0}\right)$ is bounded in $L^{p}\left(\mathbb{R}^{2}\right)$ for all $1<p<\infty$. Specifically for any $s>1$ there exists a constant $C_{s}>0$ so that for $T=U_{1} \psi_{2}\left(H_{0}\right)$

Let $Q=1-P$ and let $M_{0}=W+A \widetilde{G_{0}} B^{*}$. Then $Q M_{0} Q$ is invertible in $Q L^{2}$ if and only if $\omega$ is not a resonance or an eigenvalue for $H_{\omega}$ and in that case $M^{-1}(k)=$

Using Lemmas 3.2 and 3.3 we get $f:=\int_{\mathbb{R}} d s e^{i s H_{\omega}} P_{c}(\omega) g(s) \in L^{2}(\mathbb{R})$ and that there exists a $C>0$ such that

Proof of inequality (8.1). We consider the operator $h_{q}=-\Delta+q(x)$ introduced in $\S 5$ and $H_{q}=\sigma_{3}\left(h_{q}+\omega\right)$. We claim that

with $C(\Lambda, \omega)$ upper semicontinuous in $\omega$ and in $\Lambda>\omega$.

& \leq\| \| R_{H_{\omega}}^{+}(\lambda) R_{H_{\omega}}^{+}(\Lambda) \widetilde{g}\left(H_{\omega}\right) P_{c}(\omega)\left\|_{L_{x}^{2, s}, L_{x}^{2,-s}}\right\| \widehat{\chi}_{[0,+\infty)} *_{\lambda} \widehat{\varphi}(\lambda, x)\left\|_{L_{x}^{2, s}}\right\|_{L_{\lambda}^{2}} \\
& \leq C(s, a, b, \omega)\|\varphi\|_{L_{x}^{2, s} L_{t}^{2}}
\end{aligned}
$$

by $(\lambda-\Lambda) R_{H_{\omega}}^{+}(\lambda) R_{H_{\omega}}^{+}(\Lambda)=R_{H_{\omega}}^{+}(\lambda)-R_{H_{\omega}}^{+}(\Lambda)$, Lemma 5.4 and $|\lambda-\Lambda| \geq a \wedge b$. We consider now

& e^{-i \Lambda t}\langle x\rangle^{-\gamma} \int_{t}^{+\infty} e^{-i\left(H_{\omega}-\Lambda-i \epsilon\right) s} g\left(H_{\omega}\right) P_{c}\left(H_{\omega}\right) d s\langle y\rangle^{-\gamma}
\end{align*}
$$

We claim the following:

There are functions $u(x, \xi)$ defined for $x \in \mathbb{R}^{2}$ and for $|\xi| \in[a / 2,2 b]$ with values in $\mathbb{C}^{2}$ such that for any $\chi \in C_{0}^{\infty}(a / 2,2 b)$ we have (for ${ }^{t} u \sigma_{3} f$ the product row column and ${ }^{t} u$ the transpose of a column vector)

There are constants $c_{\alpha \beta}$ such that

& \leq\left\|\int_{0}^{t}\langle t-s\rangle^{-2}\right\| \varphi(s, \cdot) d s\left\|_{L_{x}^{2, \gamma}}\right\|_{L_{t}^{2}} \leq C\|\varphi\|_{L_{t}^{2} L_{x}^{2, \gamma}}
\end{aligned}

We need now to prove Lemma 9.1.

## §10 Proof of Lemma 9.1

First of all we explain how to define the $u(x, \xi)$. We set $V_{\omega}=B^{*} A$ with $A(x)$ and $B^{*}(x)$ rapidly decreasing and continuous. Then we have

Proof. $A R_{H_{0}}^{+}(\lambda) B^{*}$ is compact and $\operatorname{ker}\left(1+A R_{H_{0}}^{+}(\lambda) B^{*}\right)=\{0\}$ for $\lambda>\omega$ by [CPV], since in that case $\lambda \notin \sigma_{p}\left(H_{\omega}\right)$. By Fredholm alternative we get existence and uniqueness of $\widetilde{u}(x, \xi)$. Regularity theory and continuity of the coefficients of system (1) with respect to $\xi$ yield (2)

Let now ${ }^{t} e_{1}=(1,0)$ and $G_{0}(|x|, k)=\operatorname{diag}\left(\frac{i}{4} H_{0}^{+}(k|x|),-\frac{1}{2 \pi} K_{0}\left(\sqrt{k^{2}+2 \omega}|x|\right)\right)$ for $k>0$. We have $G_{0}(r, k)=\frac{i \sqrt{2}}{4 \sqrt{i \pi k r}} e^{i k r} e_{1}+O\left(r^{-\frac{3}{2}}\right)$ and $\partial_{r} G_{0}(r, k)=-k \frac{\sqrt{2 k}}{4 \sqrt{i \pi r}} e^{i k r} e_{1}+$ $O\left(r^{-\frac{3}{2}}\right)$. We set

u(x, \xi)=e^{-i \xi \cdot x} e_{1}+v(x, \xi)=e^{-i \xi \cdot x} e_{1}-R_{H_{0}}^{+}(\lambda) B^{*} \widetilde{u}(\cdot, \xi)
$$

Then $\left(H_{\omega}-\lambda\right) u(x, \xi)=B^{*}\left(A e^{-i \xi \cdot x} e_{1}-\widetilde{u}-A R_{H_{0}}^{+}(\lambda) B^{*} \widetilde{u}\right)=0$. Notice $B^{*} \widetilde{u}=V_{\omega} u$ so $v(x, \xi)=e^{-i x \cdot \xi} w(x, \xi)$ where $w(x, \xi)$ is the unique solution in $L_{-s}^{2}, s>1$, of the integral equation

It is elementary to show that, for $|\xi| \in[a, b]$, then $\left|\partial_{x}^{\alpha} \partial_{\xi}^{\beta} F(x, \xi)\right| \leq \tilde{c}_{\alpha \beta}\langle x\rangle^{|\beta|-1 / 2}$. By standard arguments and Lemmas 5.3 and 5.4 we have $\left|\partial_{x}^{\alpha} \partial_{\xi}^{\beta} w(x, \xi)\right| \leq \tilde{c}_{\alpha \beta}\langle x\rangle^{|\beta|}$. This yields (9.3). To get (9.2) we follow the presentation in Chapter 9 [Ta]. We denote by $R_{H_{\omega}}^{ \pm}(x, y, k)$ the kernel of $R_{H_{\omega}}^{ \pm}\left(k^{2}+\omega\right)$. We set

Lemma 10.2. Let $k>0$. For $r \rightarrow \infty$ we have uniform convergence on compact sets of, with $u \cdot(1,0)$ the raw column product between column $u$ and raw $(1,0)$,

For $R_{H_{\omega}}^{-}(x, y, k)$ the asymptotic expansion follows from $R_{H_{\omega}}^{-}(x, y, k)=\overline{R_{H_{\omega}}^{+}}(x, y, k)$.
We write $R_{H_{\omega}}^{+}(x, r \Sigma, k)=G_{0}(|x-r \Sigma|, k)+h(x, r \Sigma, k)$ with

From $v(x, \xi)=-R_{H_{0}}^{+}\left(k^{2}+\omega\right) V_{\omega}(x) e^{-i k \Sigma \cdot x} e_{1}$, with ${ }^{t} e_{1}=(1,0)$ we get $v(x, \xi)^{t} e_{1}=$ $-R_{H_{0}}^{+}\left(k^{2}+\omega\right) V_{\omega}(x) e^{-i k \Sigma \cdot x} \operatorname{diag}(1,0)$. Then we conclude for any $s>1$

\left\|h(x, r \Sigma, k)-\frac{i \sqrt{2}}{4 \sqrt{i \pi k r}} v(x, k \Sigma)^{t} e_{1}\right\|_{L^{2,-s}}=O\left(r^{-3 / 2}\right)
$$

and

$$
\left\|R_{H_{\omega}}^{+}(x, r \Sigma, k)-\frac{i \sqrt{2}}{4 \sqrt{i \pi k r}} u(x, k \Sigma)^{t} e_{1}\right\|_{L^{2,-s}}=O\left(r^{-3 / 2}\right)
$$

Then point wise $h(x, r \Sigma, k+i 0)-\frac{i \sqrt{2}}{4 \sqrt{i \pi k r}} v(x, k \Sigma)^{t} e_{1}=O\left(r^{-3 / 2}\right)$ and

$$
R_{H_{\omega}}^{+}(x, r \Sigma, k)-\frac{i \sqrt{2}}{4 \sqrt{i \pi k r}} u(x, k \Sigma)^{t} e_{1}=O\left(r^{-3 / 2}\right)
$$

This yields (1) in Lemma 10.2. (2) can be obtained with a similar argument. (3) and (4) follow from (1) and (2) by

$$
\sigma_{3} R_{H_{\omega}}^{ \pm}(x, y, k) \sigma_{3}=R_{H_{\omega}^{*}}^{ \pm}(x, y, k)={ }^{t} R_{H_{\omega}}^{\mp}(y, x, k)
$$

By Lemma 3.5 for $v \in L^{2}\left(H_{\omega}\right) \cap C_{0}^{\infty}$ and for $\varphi \in C_{0}^{\infty}(\mathbb{R})$ supported in $(\omega, \infty)$ we have

$$
\varphi\left(H_{\omega}\right) v(x)=\frac{2}{\pi} \int_{0}^{\infty} k d k \int_{\mathbb{R}^{2}} \varphi\left(k^{2}+\omega\right) \Im R_{H_{\omega}}^{+}(x, y, k) v(y) d y .
$$

We prove (here $u^{t} \bar{u}$ is a raw column product between column $u$ and raw ${ }^{t} \bar{u}$ )

$$
\begin{equation*}
\Im R_{H_{\omega}}^{+}(x, y, k)=\frac{1}{8 \pi} \int_{S_{32}^{1}} u(x, k \Sigma)^{t} \bar{u}(y, k \Sigma) \sigma_{3} d \Sigma, \tag{3}
\end{equation*}
$$

where $d \Sigma$ is the standard measure on $S^{1}$. By the Green theorem for $S_{R}=\left\{z \in \mathbb{R}^{2}\right.$ : $|z|=R\},|x|<R,|y|<R$ and $r=|z|$

By Green theorem for $S_{R}=\left\{z \in \mathbb{R}^{2}:|z|=R\right\},|x|<R$ and $|y|<R$,

$$
\begin{aligned}
& \Im R_{H_{\omega}}^{+}(x, y, k)=\frac{1}{2 i} \int_{S_{R}} I(x, y, z, k) d \ell(z) \\
& I(x, y, z, k):=R_{H_{\omega}}^{+}(x, z, k) \sigma_{3} \partial_{|z|} R_{H_{\omega}}^{-}(z, y, k)-\left(\partial_{|z|} R_{H_{\omega}}^{+}(x, z, k)\right) \sigma_{3} R_{H_{\omega}}^{-}(z, y, k)
\end{aligned}
$$

By Lemma 10.2

$$
\begin{aligned}
& \left|\Im R_{H_{\omega}}^{+}(x, y, k)-\frac{1}{8 \pi} \int_{S^{1}} u(x, k \Sigma)^{t} \bar{u}(y, k \Sigma) \sigma_{3} d \Sigma\right|= \\
& \left.=\left|\frac{R}{2 i} \int_{S^{1}} I(x, y, r \Sigma, k)\right|_{r=R^{1}} d \Sigma-\frac{1}{8 \pi} \int_{S^{1}} u(x, k \Sigma)^{t} \bar{u}(y, k \Sigma) \sigma_{3} d \Sigma \right\rvert\, \leq O\left(R^{-\frac{3}{2}}\right)
\end{aligned}
$$

Therefore, taking $R \rightarrow+\infty$, we arrive at (3). Moreover, we obtain

$$
\begin{aligned}
& \varphi\left(H_{\omega}\right) v(x)=\frac{2}{\pi} \int_{0}^{\infty} k d k \int_{\mathbb{R}^{2}} \varphi\left(k^{2}+\omega\right) \Im G(x, y, k) v(y) d y= \\
& =\frac{1}{4 \pi^{2}} \int_{0}^{\infty} k d k \int_{\mathbb{R}^{2}} \int_{S^{1}} u(x, k \Sigma)^{t} \bar{u}(y, k \Sigma) \sigma_{3} v(y) \varphi\left(k^{2}+\omega\right) d \Sigma d y= \\
& =(2 \pi)^{-2} \int_{\mathbb{R}^{4}} u(x, \xi)^{t} \bar{u}(y, \xi) \sigma_{3} v(y) \varphi\left(|\xi|^{2}+\omega\right) d \xi d y,
\end{aligned}
$$

that is the integral representation (9.2). This completes the proof of Lemma 9.1.
