# Quasi-orthogonal subalgebras of matrix algebras@ 

Hiromichi Ohno

## 1 Introduction

In the theory of quantum mechanics, an $n$-level system is described by the algebra $M_{n}=M_{n}(\mathbb{C})$ of $n \times n$ complex matrices. The matrix algebra of a composite system consisting of an $n$-level and an $m$-level system is $M_{n} \otimes M_{m} \simeq M_{n m}$. A subalgebra of $M_{k}$ corresponds to a subsystem of a $k$-level quantum system. In this paper, subalgebras contain the identity and are closed under the adjoint operation of matrices, that is, they are unital $*$-subalgebras. The algebra $M_{n}$ can be endowed by the inner product $\langle A, B\rangle=\operatorname{Tr}\left(A^{*} B\right)$ and it becomes a Hilbert space. Two subalgebras $\mathcal{A}_{1}$ and $\mathcal{A}_{2}$ are called quasi-orthogonal if $\mathcal{A}_{1} \ominus \mathbb{C} I \perp \mathcal{A}_{2} \ominus \mathbb{C} I$.

We consider pairwise quasi-orthogonal subalgebras $\mathcal{A}_{1}, \mathcal{A}_{2}, \ldots, \mathcal{A}_{l}$ in $M_{p^{k n}}$ which are isomorphic to $M_{p^{k}}$ for $k \geq 1, n \geq 2$ and a prime number $p$ with $p \geq 3$. The aim of this paper is to obtain the maximum $l$. The case $p=2, n=2$ and $k=1$ is shown in [3, 6, 8] and the maximum is 4 .

The motivations of this problem are followings. If a total system $M_{n} \otimes M_{m}$ has a statistical operator $\rho$, we can reconstruct the reduced density $\rho_{n}^{(1)}=\operatorname{Tr}_{m} \rho$ in the subsystem $M_{n}$, where $\operatorname{Tr}_{m}$ is a partial trace onto $M_{n}$. In order to get more information, we change the density $\rho$ by an interaction. For a Hamiltonian $H$, the new state is

$$
e^{i H} \rho e^{-i H}=W_{1} \rho W_{1}^{*}
$$

after the interaction. The new reduced density is $\rho_{n}^{(2)}=\operatorname{Tr}_{m} W_{1} \rho W_{1}^{*}$. By using other interactions, we have a sequence of reduced states $\rho_{n}^{(1)}, \rho_{n}^{(2)}, \ldots, \rho_{n}^{(k)}$. We want to determine the minimum $k$ such that this sequence of reduced densities determines $\rho$.

Another reason comes from the relation to the mutually unbiased bases (MUB) problem. Given a orthonormal basis of an $n$-dimensional Hilbert space $\mathcal{H}$, the linear operators diagonal in this basis form a maximal Abelian subalgebra of $M_{n} \simeq \mathcal{B}(\mathcal{H})$. Conversely if $\left|e_{i}\right\rangle\left\langle e_{i}\right|$ are minimal projections in a maximal Abelian subalgebra, then $\left(\left|e_{i}\right\rangle\right)_{i}$ is a orthonormal basis. Two maximal Abelian subalgebras of $M_{n}$ are quasiorthogonal if and only if the two corresponding bases $\left(\xi_{i}\right)$ and $\left(\zeta_{j}\right)$ are mutually unbiased (see Proposition (2.2), that is,

$$
\left|\left\langle\xi_{i}, \zeta_{j}\right\rangle\right|^{2}=\frac{1}{n} \quad(1 \leq i, j \leq n)
$$

Mutually unbiased bases are very interesting from many point of view and the maximal number of such bases is not known for arbitrary $n$. We want to study mutually unbiased bases in terms of quasi-orthogonal subalgebras (see [1, 2, , 4]).

In Section 2, we consider quasi-orthogonal subalgebras in $M_{p^{n}}$ which are isomorphic to $M_{p}$. In Section 3, quasi-orthogonal subalgebras in $M_{p^{k n}}$ which are isomorphic to $M_{p^{k}}$ are investigated.

## 2 Quasi-orthogonal subalgebras in $M_{p^{n}}$

$\mathcal{A}$ is a finite dimensional $C^{*}$-algebra with the usual trace Tr and is considered as a Hilbert space under the inner product

$$
\langle A, B\rangle=\operatorname{Tr}\left(A^{*} B\right)
$$

for any $A, B \in \mathcal{A}$.
Definition 2.1 Two subalgebras $\mathcal{A}_{1}$ and $\mathcal{A}_{2}$ of $\mathcal{A}$ are called quasi-orthogonal if

$$
\mathcal{A}_{1} \ominus \mathbb{C} I \perp \mathcal{A}_{2} \ominus \mathbb{C} I
$$

The equivalent conditions of this definition are followings [5]:
(a) For any $A_{1} \in \mathcal{A}_{1}$ and $A_{2} \in \mathcal{A}_{2}$,

$$
\operatorname{Tr}\left(A_{1} A_{2}\right)=\frac{\operatorname{Tr}\left(A_{1}\right) \operatorname{Tr}\left(A_{2}\right)}{\operatorname{Tr}(I)}
$$

(b) For any $A_{1} \in \mathcal{A}_{1}$ and $A_{2} \in \mathcal{A}_{2}$ with $\operatorname{Tr}\left(A_{1}\right)=\operatorname{Tr}\left(A_{2}\right)=0$,

$$
\operatorname{Tr}\left(A_{1} A_{2}\right)=0
$$

The theory of quasi-orthogonal subalgebras is related to the theory of mutually unbiased bases. This is stated as follows:

Proposition 2.2 The maximal number of mutually unbiased bases in $\mathbb{C}^{d}$ is equal to the maximal number of pairwise quasi-orthogonal subalgebras in $M_{d}$ which are isomorphic to $\mathbb{C}^{d}$.

Proof. For orthonormal bases $\left\{\xi_{i}\right\}_{1 \leq i \leq d}$ and $\left\{\zeta_{j}\right\}_{1 \leq j \leq d}$ of $\mathbb{C}^{d}$, define minimal projections in $M_{d}$ by $P_{i}=\left|\xi_{i}\right\rangle\left\langle\xi_{i}\right|$ and $\bar{Q}_{j}=\left|\zeta_{j}\right\rangle\left\langle\zeta_{j}\right|$. Since $\operatorname{Tr}\left(P_{i} Q_{j}\right)=\left|\left\langle\xi_{i}, \zeta_{j}\right\rangle\right|^{2}$, the condition

$$
\left|\left\langle\xi_{i}, \zeta_{j}\right\rangle\right|^{2}=\frac{1}{d} \quad(1 \leq i, j \leq d)
$$

is equivalent to the condition

$$
\operatorname{Tr}\left(P_{i} Q_{j}\right)=\frac{1}{d}=\frac{\operatorname{Tr}\left(P_{i}\right) \operatorname{Tr}\left(Q_{j}\right)}{\operatorname{Tr}(I)} \quad(1 \leq i, j \leq d)
$$

From (a), we conclude that $\left\{\xi_{i}\right\}$ and $\left\{\zeta_{j}\right\}$ are mutually unbiased bases if and only if the algebras generated by $\left\{P_{i}\right\}$ and $\left\{Q_{j}\right\}$ are quasi-orthogonal. This prove the assertion.

It is known that there exist $d+1$ mutually unbiased bases in $\mathbb{C}^{d}$ if $d$ is a power of a prime number. Therefore there are $d+1$ quasi-orthogonal subalgebras in $M_{d}$ which are isomorphic to $\mathbb{C}^{d}$ if $d$ is a power of a prime number.

Now we consider the quasi-orthogonal subalgebras in $M_{p^{2}}=M_{p} \otimes M_{p}$ which are isomorphic to $M_{p}$, where $p$ is a prime number with $p \geq 3$. We will show that we can construct $p^{2}+1$ pairwise quasi-orthogonal subalgebras.

Define the unitary operators $W$ and $S$ in $M_{p}$ by

$$
W=\left[\begin{array}{ccccc}
1 & 0 & 0 & \cdots & 0 \\
0 & \lambda & 0 & \cdots & 0 \\
0 & 0 & \lambda^{2} & \cdots & 0 \\
\vdots & \vdots & \vdots & \ddots & \vdots \\
0 & 0 & 0 & \cdots & \lambda^{p-1}
\end{array}\right], \quad S=\left[\begin{array}{ccccc}
0 & 0 & \cdots & 0 & 1 \\
1 & 0 & \cdots & 0 & 0 \\
0 & 1 & \cdots & 0 & 0 \\
\vdots & \vdots & \ddots & \vdots & \vdots \\
0 & 0 & \cdots & 1 & 0
\end{array}\right]
$$

where $\lambda=e^{2 \pi i / p}$. Then these two unitary operators have following properties:
i. $S^{p}=W^{p}=I$.
ii. The set $\left\{S^{i} W^{j}\right\}_{0 \leq i, j \leq p-1}$ is a natural orthogonal basis of $M_{p}$.
iii. Since $S W=\lambda^{-1} W S$, we have

$$
\begin{equation*}
S^{k_{1}} W^{l_{1}} S^{k_{2}} W^{l_{2}}=\lambda^{k_{2} l_{1}} S^{k_{1}+k_{2}} W^{l_{1}+l_{2}} \tag{1}
\end{equation*}
$$

iv. From (1), $S^{k_{1}} W^{l_{1}}$ and $S^{k_{2}} W^{l_{2}}$ commute if and only if $k_{1} l_{2}=k_{2} l_{1} \bmod p$.

We consider the commutativity condition iv in the context of a vector space over $Z_{p}$, where $Z_{p}$ is a finite field with $p$ elements. Let $Z_{p}^{4}=\left\{\left(k_{1}, l_{1}, k_{2}, l_{2}\right) \mid k_{1}, l_{1}, k_{2}, l_{2} \in\right.$ $\left.Z_{p}\right\}$ be a vector space over $Z_{p}$ and define a natural homomorphism $\pi$ (up to scalar multiple) from $Z_{p}^{4}$ to $M_{p} \otimes M_{p}$ by

$$
\pi\left(k_{1}, l_{1}, k_{2}, l_{2}\right)=S^{k_{1}} W^{l_{1}} \otimes S^{k_{2}} W^{l_{2}}
$$

We denote a symplectic product by

$$
u \circ u^{\prime}=k_{1} l_{1}^{\prime}-k_{1}^{\prime} l_{1}+k_{2} l_{2}^{\prime}-k_{2}^{\prime} l_{2} \quad \bmod p,
$$

where $u=\left(k_{1}, l_{1}, k_{2}, l_{2}\right)$ and $u^{\prime}=\left(k_{1}^{\prime}, l_{1}^{\prime}, k_{2}^{\prime}, l_{2}^{\prime}\right)$. From (11),

$$
\begin{equation*}
\pi(u) \pi\left(u^{\prime}\right)=\lambda^{-u \circ u^{\prime}} \pi\left(u^{\prime}\right) \pi(u) \tag{2}
\end{equation*}
$$

Hence $\pi(u)$ and $\pi\left(u^{\prime}\right)$ commute if and only if their symplectic product equals zero.
Lemma 2.3 If $\pi(u)$ and $\pi\left(u^{\prime}\right)$ are not commutative for $u=\left(k_{1}, l_{1}, k_{2}, l_{2}\right), u^{\prime}=$ $\left(k_{1}^{\prime}, l_{1}^{\prime}, k_{2}^{\prime}, l_{2}^{\prime}\right) \in Z_{p}^{4}$, then the algebra $\mathcal{A}$ generated by $\pi(u)$ and $\pi\left(u^{\prime}\right)$ is isomorphic to $M_{p}$.

Proof. From the assumption, $u \circ u^{\prime} \neq 0$. Define a map $\rho$ from $\left\{S, W^{u \circ u^{\prime}}\right\}$ to $\mathcal{A}$ by

$$
\rho(S)=\pi(u), \quad \rho\left(W^{u \circ u^{\prime}}\right)=\pi\left(u^{\prime}\right)
$$

From (2) and $S W^{u \circ u^{\prime}}=\lambda^{-u \circ u^{\prime}} W^{u \circ u^{\prime}} S$, the commutativity condition of $\pi(u), \pi\left(u^{\prime}\right)$ and that of $S, W^{u o u^{\prime}}$ are same. Therefore $\rho$ can be extended to an isomorphism from $M_{p}$ generated by $S$ and $W^{u o u^{\prime}}$ to $\mathcal{A}$.

From this lemma, we need to find such $u$ and $u^{\prime}$. Let $D$ be a non-zero integer in $Z^{p}$ with the requirement that $D \neq k^{2} \bmod p$ for all $k$ in $Z_{p}$, i.e., $D$ is not a quadratic residue of $p$. For any $a_{0}, a_{1} \in Z_{p}$, we define a subspace of $Z_{p}^{4}$ by

$$
C_{a_{0}, a_{1}}=\left\{b_{0}\left(1, a_{1}, 0, a_{0}\right)+b_{1}\left(0, a_{0},-1, a_{1} D\right) \mid b_{0}, b_{1} \in Z_{p}\right\},
$$

where scalar multiplication and addition are defined by a natural way. Moreover put

$$
C_{\infty}=\left\{b_{0}(0,1,0,0)+b_{1}(0,0,0,1) \mid b_{0}, b_{1} \in Z_{p}\right\} .
$$

Lemma 2.4 The only vector common to any pair of above subspaces is ( $0,0,0,0$ ). In particular, the subspaces expect $(0,0,0,0)$ partition $Z_{p}^{4} \backslash\{(0,0,0,0)\}$.

Proof. Since there are $p^{2}+1$ subspaces and each subspace has $p^{2}$ elements, it is enough to prove that the intersection of any two subspaces is $\{(0,0,0,0)\}$. It is easy to see $C_{a_{0}, a_{1}} \cap C_{\infty}=\{(0,0,0,0)\}$. Therefore we prove that $C_{a_{0}, a_{1}} \cap C_{a_{0}^{\prime}, a_{1}^{\prime}}=\{(0,0,0,0)\}$ if $a_{0} \neq a_{0}^{\prime}$ or $a_{1} \neq a_{1}^{\prime}$.

Assume $b_{0}\left(1, a_{1}, 0, a_{0}\right)+b_{1}\left(0, a_{0},-1, a_{1} D\right)=b_{0}^{\prime}\left(1, a_{1}^{\prime}, 0, a_{0}^{\prime}\right)+b_{1}^{\prime}\left(0, a_{0}^{\prime},-1, a_{1}^{\prime} D\right)$, then from the first and third components we have $b_{0}=b_{0}^{\prime}$ and $b_{1}=b_{1}^{\prime}$. Similarly, from the second and fourth components we are led to the equations

$$
\begin{aligned}
a_{1} b_{0}+a_{0} b_{1} & =a_{1}^{\prime} b_{0}+a_{0}^{\prime} b_{1} \\
a_{0} b_{0}+a_{1} b_{1} D & =a_{0}^{\prime} b_{0}+a_{1}^{\prime} b_{1} D
\end{aligned}
$$

These equations can be rewritten as a matrix equation

$$
\left[\begin{array}{cc}
b_{1} & b_{0} \\
b_{0} & b_{1} D
\end{array}\right]\left[\begin{array}{c}
a_{0}-a_{0}^{\prime} \\
a_{1}-a_{1}^{\prime}
\end{array}\right]=\left[\begin{array}{l}
0 \\
0
\end{array}\right]
$$

If $b_{0}=b_{1}=0$, then the common element is $(0,0,0,0)$. Therefore we assume $b_{0} \neq 0$ or $b_{1} \neq 0$. Then the above matrix is invertible, indeed

$$
\left[\begin{array}{cc}
b_{1} & b_{0} \\
b_{0} & b_{1} D
\end{array}\right]^{-1}=\left(b_{1}^{2} D-b_{0}^{2}\right)^{-1}\left[\begin{array}{cc}
b_{1} D & -b_{0} \\
-b_{0} & b_{1}
\end{array}\right]
$$

Here we use that $b_{1}^{2} D \neq b_{0}^{2} \bmod p$ from the assumption of $D$. This implies $a_{0}=a_{0}^{\prime}$ and $a_{1}=a_{1}^{\prime}$ which is a contradiction.

Since $\left(1, a_{1}, 0, a_{0}\right) \circ\left(0, a_{0},-1, a_{1} D\right)=2 a_{0}$, if $a_{0} \neq 0$ then the algebra span $\left\{\pi\left(C_{a_{0}, a_{1}}\right)\right\}$ generated by $\pi\left(1, a_{1}, 0, a_{0}\right)$ and $\pi\left(0, a_{0},-1, a_{1} D\right)$ is isomorphic to $M_{p}$ by Lemma 2.3,

But if $a_{0}=0$, then the algebra is commutative and hence $\operatorname{span}\left\{\pi\left(C_{a_{0}, a_{1}}\right)\right\} \simeq \mathbb{C}^{p^{2}}$. Therefore we need to mix the subspaces with $a_{0}=0$.

For any $a \in Z_{p}$, define subspaces by

$$
\begin{aligned}
D_{a} & =\left\{b_{0}(1,1,-a, a D)+b_{1}(1,2,-a, 2 a D) \mid b_{0}, b_{1} \in Z_{p}\right\} \\
D_{\infty} & =\left\{b_{0}(0,0,1,0)+b_{1}(0,0,0,1) \mid b_{0}, b_{1} \in Z_{p}\right\}
\end{aligned}
$$

Lemma 2.5 The only vector common to any pair of above subspaces is ( $0,0,0,0$ ). Moreover we have

$$
\bigcup_{a \in Z_{p}} D_{a} \cup D_{\infty}=\bigcup_{a_{1} \in Z_{p}} C_{0, a_{1}} \cup C_{\infty}
$$

Proof. The proof of the first assertion is same as Lemma 2.4. To show the second assertion, it is enough to prove $D_{a}, D_{\infty} \subset \bigcup_{a_{1} \in Z_{p}} C_{0, a_{1}} \cup C_{\infty}$. Indeed, since each subspaces has $p^{2}$ elements and the intersection is trivial, the numbers of elements in both sets are equal.

First consider a element $\left(0,0, b_{0}, b_{1}\right)$ in $D_{\infty}$. If $b_{0}=0$, then $\left(0,0,0, b_{1}\right) \in C_{\infty}$. If $b_{0} \neq 0$, then

$$
\left(0,0, b_{0}, b_{1}\right)=-b_{0}\left(0,0,-1,-b_{0}^{-1} b_{1} D^{-1} D\right) \in C_{0,-b_{0}^{-1} b_{1} D^{-1}}
$$

Hence $D_{\infty} \subset \bigcup_{a_{1} \in Z_{p}} C_{0, a_{1}} \cup C_{\infty}$. Next consider the element $b_{0}(1,1,-a, a D)+b_{1}(1,2,-a, 2 a D)$ in $D_{a}$. If $b_{0}+b_{1}=0$, then

$$
b_{0}(1,1,-a, a D)+b_{1}(1,2,-a, 2 a D)=\left(0, b_{0}+2 b_{1}, 0, a b_{0} D+2 a b_{1} D\right) \in C_{\infty}
$$

If $b_{0}+b_{1} \neq 0$, then

$$
\begin{aligned}
& b_{0}(1,1,-a, a D)+b_{1}(1,2,-a, 2 a D) \\
= & \left(b_{0}+b_{1}\right)\left(1,\left(b_{0}+b_{1}\right)^{-1}\left(b_{0}+2 b_{1}\right), 0,0\right) \\
& +a\left(b_{0}+b_{1}\right)\left(0,0,-1,\left(b_{0}+b_{1}\right)^{-1}\left(b_{0}+2 b_{1}\right) D\right) \\
\in & C_{0,\left(b_{0}+b_{1}\right)^{-1}\left(b_{0}+2 b_{1}\right)} .
\end{aligned}
$$

Therefore we obtain $D_{a} \subset \bigcup_{a_{1} \in Z_{p}} C_{0, a_{1}} \cup C_{\infty}$.
Since $(1,1,-a, a D) \circ(1,2,-a, 2 a D)=1-a^{2} D \neq 0$ by the assumption of $D$ and $(0,0,1,0) \circ(0,0,0,1)=1$, we obtain

$$
\begin{aligned}
& \operatorname{span}\left\{\pi\left(D_{a}\right)\right\} \simeq M_{p} \\
& \operatorname{span}\left\{\pi\left(D_{\infty}\right)\right\} \simeq M_{p}
\end{aligned}
$$

by Lemma 2.3. Consequently we have the next theorem.
Theorem 2.6 There are $p^{2}+1$ pairwise quasi-orthogonal subalgebras in $M_{p^{2}}$ which are isomorphic to $M_{p}$.

Example 2.7 Consider a 9-level quantum system $M_{3} \otimes M_{3}$. We list 10 pairwise quasi-orthogonal subalgebras in $M_{9}$ which are isomorphic to $M_{3}$ :

\operatorname{span}\left\{\pi\left(C_{1,1}\right)\right\}= & \operatorname{span}\left\{I \otimes I, S W \otimes W, S^{2} W^{2} \otimes W^{2}, W \otimes S^{2} W^{2}, S W^{2} \otimes S^{2},\right. \\
& \left.S^{2} \otimes S^{2} W, W^{2} \otimes S W, S \otimes S W^{2}, S^{2} W \otimes S\right\}, \\
\operatorname{span}\left\{\pi\left(C_{1,2}\right)\right\}= & \operatorname{span}\left\{I \otimes I, S W^{2} \otimes W, S^{2} W \otimes W^{2}, W \otimes S^{2} W, S \otimes S^{2} W^{2},\right. \\
& \left.S^{2} W^{2} \otimes S^{2}, W^{2} \otimes S W^{2}, S W \otimes S, S^{2} \otimes S W\right\} \\
\operatorname{span}\left\{\pi\left(C_{2,0}\right)\right\}= & \operatorname{span}\left\{I \otimes I, S \otimes W^{2}, S^{2} \otimes W, W^{2} \otimes S^{2}, S W^{2} \otimes S^{2} W^{2},\right. \\
& \left.S^{2} W^{2} \otimes S^{2} W, W \otimes S, S W \otimes S W^{2}, S^{2} W \otimes S W\right\}, \\
\operatorname{span}\left\{\pi\left(C_{2,1}\right)\right\}= & \operatorname{span}\left\{I \otimes I, S W \otimes W^{2}, S^{2} W^{2} \otimes W^{2}, W^{2} \otimes S^{2} W^{2}, S \otimes S^{2} W,\right. \\
& \left.S^{2} W \otimes S^{2}, W \otimes S W, S W^{2} \otimes S, S^{2} \otimes S W^{2}\right\}, \\

\operatorname{span}\left\{\pi\left(D_{\infty}\right)\right\}= & \operatorname{span}\left\{I \otimes I, I \otimes S, I \otimes S^{2}, I \otimes W, I \otimes S W,\right. \\
& \left.I \otimes S^{2} W, I \otimes W^{2}, I \otimes S W^{2}, I \otimes S^{2} W^{2}\right\},
\end{aligned}
$$

where we denote $D=2$.
Next, we consider pairwise quasi-orthogonal subalgebras in $M_{p^{n}}$ which are isomorphic to $M_{p}$. The dimensions of $M_{p^{n}} \ominus \mathbb{C} I$ and $M_{p} \ominus \mathbb{C} I$ are $p^{2 n}-1$ and $p^{2}-1$, respectively. Hence such subalgebras are at most $N_{n}:=p^{2 n}-1 / p^{2}-1$. We construct $N_{n}$ pairwise quasi-orthogonal subalgebras.

Theorem 2.8 $M_{p^{n}}$ contains $N_{n}$ pairwise quasi-orthogonal subalgebras which are isomorphic to $M_{p}$.

Proof. The case $n=1$ is trivial and the case $n=2$ is already proven in Theorem [2.6. Assume $M_{p^{n-2}}$ contains $N_{n-2}$ pairwise quasi-orthogonal subalgebras which are isomorphic to $M_{p}$. Let $\mathcal{A} \simeq M_{p} \subset M_{p^{n-2}}$ be one of them. Then we can assume that $\mathcal{A}$ is generated by $W$ and $S$. On the other hand, $M_{p^{2}}$ contains $p^{2}+1$ quasi-orthogonal subalgebras which are isomorphic to $\mathbb{C}^{2 p} \simeq \mathbb{C}^{p} \otimes \mathbb{C}^{p}$ from Proposition 2.2 and the theory of mutually unbiased bases. Let $\mathcal{C} \simeq \mathbb{C}^{p} \otimes \mathbb{C}^{p} \subset M_{p^{2}}$ be one of them. Suppose $\mathcal{C}$ is generated by $W \otimes I$ and $I \otimes W$.

We define a homomorphism $\hat{\pi}$ (up to scalar multiple) from $Z_{p}^{4}$ to $\mathcal{A} \otimes \mathcal{C}$ by

$$
\hat{\pi}\left(k, l, m_{1}, m_{2}\right)=S^{k} W^{l} \otimes W^{m_{1}} \otimes W^{m_{2}}
$$

For any $a_{0}, a_{1} \in \mathbb{Z}_{p}$, let

$$
\hat{C}_{a_{0}, a_{1}}=\left\{b_{0}\left(1,0, a_{0}, a_{1}\right)+b_{1}\left(0,1, a_{1} D, a_{0}\right) \mid b_{0}, b_{1} \in \mathbb{Z}_{p}\right\}
$$

and

$$
\hat{C}_{\infty}=\left\{b_{0}(0,0,1,0)+b_{1}(0,0,0,1) \mid b_{0}, b_{1} \in \mathbb{Z}_{p}\right\}
$$

From a similar method of the proof of Lemma 2.4, the only vector common to any pair of above subspaces is $(0,0,0,0)$. Moreover since $W$ and $S$ satisfy (11) and $\mathcal{C}$ is commutative, we have

$$
\hat{\pi}\left(1,0, a_{0}, a_{1}\right) \hat{\pi}\left(0,1, a_{1} D, a_{0}\right)=\lambda^{-1} \hat{\pi}\left(0,1, a_{1} D, a_{0}\right) \hat{\pi}\left(1,0, a_{0}, a_{1}\right) .
$$

Therefore the algebra span $\left\{\hat{\pi}\left(\hat{C}_{a_{0}, a_{1}}\right)\right\}$ generated by $\hat{\pi}\left(1,0, a_{0}, a_{1}\right)$ and $\hat{\pi}\left(0,1, a_{1} D, a_{0}\right)$ is isomorphic to the algebra generated by $S$ and $W$, that is, $M_{p}$. Furthermore the algebra span $\left\{\hat{\pi}\left(\hat{C}_{\infty}\right)\right\}$ generated by $\hat{\pi}(0,0,1,0)$ and $\hat{\pi}(0,0,0,1)$ is $I \otimes \mathcal{C}$. Consequently $\mathcal{A} \otimes \mathcal{C}$ can be decomposed by $\mathcal{A} \otimes I=\operatorname{span}\left\{\hat{\pi}\left(\hat{C}_{0,0}\right)\right\}, I \otimes \mathcal{C}$ and $p^{2}-1$ pairwise quasiorthogonal subalgebras which are isomorphic to $M_{p}$. We denote the $p^{2}-1$ pairwise quasi-orthogonal subalgebras by $\left\{\mathcal{B}_{\mathcal{A}, \mathcal{C}}^{k}\right\}_{k=1}^{p^{2}-1}$.

Let $\mathcal{A}_{1}, \ldots, \mathcal{A}_{N_{n-2}}$ be pairwise quasi-orthogonal subalgebras in $M_{p^{n-2}}$ which are isomorphic to $M_{p}$ and let $\mathcal{C}_{1}, \ldots, \mathcal{C}_{p^{2}+1}$ be pairwise quasi-orthogonal subalgebras in $M_{p^{2}}$ which are isomorphic to $\mathbb{C}^{p^{2}}$. For each $\mathcal{A}_{i_{1}}, \mathcal{A}_{i_{2}} \subset M_{p^{n-2}}$ and $\mathcal{C}_{j_{1}}, \mathcal{C}_{j_{2}} \subset M_{p^{2}}$ with $i_{1} \neq i_{2}$ or $j_{1} \neq j_{2}$, we have

$$
\left(\mathcal{A}_{i_{1}} \ominus \mathbb{C} I\right) \otimes\left(\mathcal{C}_{j_{1}} \ominus \mathbb{C} I\right) \perp \mathcal{A}_{i_{2}} \otimes \mathcal{C}_{j_{2}}
$$

This implies $\mathcal{B}_{\mathcal{A}_{i_{1}}, \mathcal{C}_{j_{1}}}^{k_{1}} \ominus \mathbb{C} I \perp \mathcal{B}_{\mathcal{A}_{i_{2}}, \mathcal{C}_{j_{2}}}^{k_{2}} \ominus \mathbb{C} I$ if $i_{1} \neq i_{2}$ or $j_{1} \neq j_{2}$ or $k_{1} \neq k_{2}$. Furthermore $\mathcal{B}_{\mathcal{A}_{i_{1}}, \mathcal{C}_{j_{1}}}^{k}$ is quasi-orthogonal with $\mathcal{A}_{i_{2}} \otimes I$ and $I \otimes \mathcal{C}_{j_{2}}$ for all $i_{2}, j_{2}$. In consequence, $M_{p^{n}}$ is decomposed by $M_{p^{n-2}} \otimes I_{M_{p^{2}}}=\operatorname{span}\left\{\mathcal{A}_{i} \otimes I \mid i\right\}$ and $I_{M_{p^{n-2}}} \otimes M_{p^{2}}=\operatorname{span}\left\{I \otimes \mathcal{C}_{j} \mid j\right\}$ and $\left\{\mathcal{B}_{\mathcal{A}_{i}, \mathcal{C}_{j}}^{k}\right\}_{i, j, k}$. From Theorem [2.6, $M_{p^{2}}$ contains $p^{2}+1$ pairwise quasi-orthogonal subalgebras which are isomorphic to $M_{p}$. Therefore we get

$$
N_{n-2}+p^{2}+1+\left(p^{2}-1\right)\left(p^{2}+1\right) N_{n-2}=N_{n}
$$

pairwise quasi-orthogonal subalgebras in $M_{p^{n}}$ which are isomorphic to $M_{p}$.

## 3 Quasi-orthogonal subalgebras in $M_{p^{k n}}$

In this section, we consider quasi-orthogonal subalgebras in $M_{p^{k n}}$ which are isomorphic to $M_{p^{k}}$. First we consider the case $n=2$.
$G F\left(p^{k}\right)$ denotes a finite field with $p^{k}$ elements. Up to isomorphisms, $G F\left(p^{k}\right)$ is unique and is defined using a polynomial

$$
f(x)=c_{0}+\cdots+c_{k-1} x^{k-1}+x^{k}
$$

that is irreducible over the field $Z_{p}$. Then we can write

$$
G F\left(p^{k}\right)=\left\{a(t)=a_{0}+a_{1} t+\cdots+a_{k-1} t^{k-1} \mid a_{i} \in Z_{p}, 0 \leq i \leq k-1\right\}
$$

where $t$ satisfies $f(t)=0$. Let

$$
G F\left(p^{k}\right)^{4}=\left\{a=\left(a^{(1)}(t), a^{(2)}(t), a^{(3)}(t), a^{(4)}(t)\right) \mid a^{(i)}(t) \in G F\left(p^{k}\right), 1 \leq i \leq 4\right\}
$$

and define a symplectic product:

$$
a \circ b=a^{(1)}(t) b^{(2)}(t)-a^{(2)}(t) b^{(1)}(t)+a^{(3)}(t) b^{(4)}(t)-a^{(4)}(t) b^{(3)}(t)
$$

for $a=\left(a^{(1)}(t), a^{(2)}(t), a^{(3)}(t), a^{(4)}(t)\right)$ and $b=\left(b^{(1)}(t), b^{(2)}(t), b^{(3)}(t), b^{(4)}(t)\right)$ in $G F\left(p^{k}\right)^{4}$. Similarly, symplectic product on $Z_{p}^{4 k}$ is denoted by

$$
u \circ v=\sum_{i=1}^{k} u_{i}^{(1)} v_{i}^{(2)}-u_{i}^{(2)} v_{i}^{(1)}+u_{i}^{(3)} v_{i}^{(4)}-u_{i}^{(4)} v_{i}^{(3)}
$$

for $u=\left(u_{i}^{(j)}\right)_{1 \leq i \leq k, 1 \leq j \leq 4}$ and $v=\left(v_{i}^{(j)}\right)_{1 \leq i \leq k, 1 \leq j \leq 4}$ in $Z_{p}^{4 k}=\left(Z_{p}^{k}\right)^{4}$. From [4], there exist a linear functional $\varphi$ on $G F\left(p^{k}\right)$ and a linear isomorphism $\pi_{1}$ from $G F\left(p^{k}\right)^{4}$ to $Z_{p}^{4 k}$ such that

$$
\begin{equation*}
\varphi(a \circ b)=\pi_{1}(a) \circ \pi_{1}(b), \tag{3}
\end{equation*}
$$

where we consider $G F\left(p^{k}\right)^{4}$ and $Z_{p}^{4 k}$ as vector spaces over $Z_{p}$. Define a natural homomorphism (up to scalar multiple) $\pi_{2}$ from $Z_{p}^{4 k}$ to $M_{p^{2 k}}=\bigotimes_{i=1}^{k} M_{p} \otimes \bigotimes_{i=1}^{k} M_{p}$ by

$$
\pi_{2}(u)=\bigotimes_{i=1}^{k} S^{u_{i}^{(1)}} W^{u_{i}^{(2)}} \otimes \bigotimes_{i=1}^{k} S^{u_{i}^{(3)}} W^{u_{i}^{(4)}}
$$

By (1), we have

$$
\pi_{2}(u) \pi_{2}(v)=\lambda^{-u \circ v} \pi_{2}(v) \pi_{2}(u)
$$

Lemma 3.1 If $a \circ b \neq 0$ for $a, b \in G F\left(p^{k}\right)^{4}$, then the algebra $\mathcal{A}$ generated by

$$
\left\{\pi_{2} \pi_{1}(p(t) a), \pi_{2} \pi_{1}(q(t) b) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\}
$$

is isomorphic to $M_{p^{k}}$, where $p(t) a$ is defined by

$$
p(t)\left(a_{1}(t), a_{2}(t), a_{3}(t), a_{4}(t)\right)=\left(p(t) a_{1}(t), p(t) a_{2}(t), p(t) a_{3}(t), p(t) a_{4}(t)\right)
$$

Proof. If $\left\{p(t) a \mid p(t) \in G F\left(p^{k}\right)\right\} \cap\left\{q(t) b \mid q(t) \in G F\left(p^{k}\right)\right\} \neq\{(0,0,0,0)\}$, there exists $r(t) \in G F\left(p^{k}\right)$ such that $a=r(t) b$. This shows $a \circ b=r(t)(b \circ b)=0$. Hence we can assume that $\{p(t) a\} \cap\{q(t) b\}=\{(0,0,0,0)\}$.

For $q(t) \in G F\left(p^{k}\right)$, let $\psi_{q(t)}$ be a functional on $G F\left(p^{k}\right)$ defined by

$$
\psi_{q(t)}(p(t))=\pi_{1}(p(t) a) \circ \pi_{1}(q(t) b),
$$

where we consider $G F\left(p^{k}\right)$ as a vector space over $Z_{p}$. By (3), we have

$$
\psi_{q(t)}(p(t))=\varphi(p(t) a \circ q(t) b)=\varphi(p(t) q(t)(a \circ b)) .
$$

Since $a \circ b \neq 0, \psi_{q^{(1)}(t)}=\psi_{q^{(2)}(t)}$ implies $q^{(1)}(t)=q^{(2)}(t)$. Therefore we obtain $\left\{\psi_{q(t)} \mid q(t) \in G F\left(p^{k}\right)\right\}=G F\left(p^{k}\right)^{*}$, where $G F\left(p^{k}\right)^{*}$ is a dual space of $G F\left(p^{k}\right)$.

Let $\left\{p^{(i)}(t)\right\}_{1 \leq i \leq k}$ be a basis of the vector space $G F\left(p^{k}\right)$. Then there exists a basis $\left\{q^{(j)}\right\}_{1 \leq j \leq k} \subset G \bar{F}\left(p^{k}\right)$ such that

$$
\varphi\left(p^{(i)}(t) a \circ q^{(j)}(t) b\right)=\psi_{q^{(j)}(t)}\left(p^{(i)}(t)\right)=\delta_{i j} .
$$

For $1 \leq i, j \leq k$, let $S_{i}=I^{\otimes i-1} \otimes S \otimes I^{\otimes k-i}$ and $W_{j}=I^{\otimes j-1} \otimes W \otimes I^{\otimes k-j}$ in $M_{p^{k}}=\bigotimes^{k} M_{p}$. We define a map $\rho$ from $\left\{S_{i}, W_{j} \mid 1 \leq i, j \leq k\right\}$ to $\mathcal{A}$ by

$$
\begin{aligned}
\rho\left(S_{i}\right) & =\pi_{2} \pi_{1}\left(p^{(i)}(t) a\right) \\
\rho\left(W_{j}\right) & =\pi_{2} \pi_{1}\left(q^{(j)}(t) b\right)
\end{aligned}
$$

Then the commutativity condition of $\left\{S_{i}, W_{j}\right\}$, that is,

$$
\begin{aligned}
S_{i} W_{j} & =\lambda^{-\delta_{i j}} W_{j} S_{i}, \\
S_{i} S_{j} & =S_{j} S_{i}, \\
W_{i} W_{j} & =W_{j} W_{i}
\end{aligned}
$$

and the commutativity condition of $\left\{\pi_{2} \pi_{1}\left(p^{(i)}(t) a\right), \pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) \mid 1 \leq i, j \leq k\right\}$, that is,

$$
\begin{aligned}
\pi_{2} \pi_{1}\left(p^{(i)}(t) a\right) \cdot \pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) & =\lambda^{-\pi_{1}\left(p^{(i)}(t) a\right) \circ \pi_{1}\left(q^{(j)}(t) b\right)} \cdot \pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) \cdot \pi_{2} \pi_{1}\left(p^{(i)}(t) a\right) \\
& =\lambda^{-\varphi\left(p^{(i)}(t) a \circ q^{(j)}(t) b\right)} \cdot \pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) \cdot \pi_{2} \pi_{1}\left(p^{(i)}(t) a\right) \\
& =\lambda^{-\delta_{i j}} \cdot \pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) \cdot \pi_{2} \pi_{1}\left(p^{(i)}(t) a\right), \\
\pi_{2} \pi_{1}\left(p^{(i)}(t) a\right) \cdot \pi_{2} \pi_{1}\left(p^{(j)}(t) a\right) & =\pi_{2} \pi_{1}\left(p^{(j)}(t) a\right) \cdot \pi_{2} \pi_{1}\left(p^{(i)}(t) a\right), \\
\pi_{2} \pi_{1}\left(q^{(i)}(t) b\right) \cdot \pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) & =\pi_{2} \pi_{1}\left(q^{(j)}(t) b\right) \cdot \pi_{2} \pi_{1}\left(q^{(i)}(t) b\right)
\end{aligned}
$$

are same. Hence $\rho$ can be extended to an isomorphism from $M_{p^{k}}$ generated by $\left\{S_{i}, W_{j}\right\}_{1 \leq i, j \leq k}$ to $\mathcal{A}$.

From this lemma, we need to find such $a$ and $b$. Let $D$ be a non-zero element in $G F\left(p^{k}\right)$ with the requirement that $D \neq p(t)^{2}$ for all $p(t)$ in $G F\left(p^{k}\right)$. For any $a(t), b(t) \in G F\left(p^{k}\right)$, define a subspace of $G F\left(p^{k}\right)^{4}$ by

$$
C_{a(t), b(t)}=\left\{p(t)(1, b(t), 0, a(t))+q(t)(0, a(t),-1, b(t) D) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\}
$$

Moreover, put

$$
C_{\infty}=\left\{p(t)(0,1,0,0)+q(t)(0,0,0,1) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\} .
$$

Lemma 3.2 The only vector common to any pair of above subspaces is ( $0,0,0,0$ ). In particular, the subspaces expect $(0,0,0,0)$ partition $G F\left(p^{k}\right)^{4} \backslash\{(0,0,0,0)\}$.

Proof. This proof is same as Lemma 2.4.
Since $(1, b(t), 0, a(t)) \circ(0, a(t),-1, b(t) D)=2 a(t)$, if $a(t) \neq 0$ then

$$
\operatorname{span}\left\{\pi_{2} \pi_{1}\left(C_{a(t), b(t)}\right)\right\} \simeq M_{p^{k}}
$$

by Lemma 3.1. But if $a(t)=0$, the algebra is commutative and hence $\operatorname{span}\left\{\pi_{2} \pi_{1}\left(C_{a(t), b(t)}\right)\right\} \simeq$ $\mathbb{C}^{p^{2 k}}$. Therefore we need to mix the subspaces with $a(t)=0$.

For any $a(t) \in G F\left(p^{k}\right)$, define subspaces by

$$
\begin{aligned}
D_{a(t)} & =\left\{p(t)(1,1,-a(t), a(t) D)+q(t)(1,2,-a(t), 2 a(t) D) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\} \\
D_{\infty} & =\left\{p(t)(0,0,1,0)+q(t)(0,0,0,1) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\}
\end{aligned}
$$

Lemma 3.3 The only vector common to any pair of above subspaces is ( $0,0,0,0$ ). Moreover we have

$$
\bigcup_{a(t) \in G F\left(p^{k}\right)} D_{a(t)} \cup D_{\infty}=\bigcup_{b(t) \in G F\left(p^{k}\right)} C_{0, b(t)} \cup C_{\infty}
$$

Proof. This proof is same as Lemma 2.5,
Since $(1,1,-a(t), a(t) D) \circ(1,2,-a(t), 2 a(t) D)=1-a(t)^{2} D \neq 0$ by the assumption of $D$ and $(0,0,1,0) \circ(0,0,0,1)=1$, we have

$$
\begin{aligned}
\operatorname{span}\left\{\pi_{2} \pi_{1}\left(D_{a(t)}\right)\right\} & \simeq M_{p^{k}} \\
\operatorname{span}\left\{\pi_{2} \pi_{1}\left(D_{\infty}\right)\right\} & \simeq M_{p^{k}}
\end{aligned}
$$

by Lemma 3.1. Consequently we have the next theorem.
Theorem 3.4 There are $p^{2 k}+1$ pairwise quasi-orthogonal subalgebras in $M_{p^{2 k}}$ which are isomorphic to $M_{p^{k}}$.

Next we consider pairwise quasi-orthogonal subalgebras in $M_{p^{k n}}$ which are isomorphic to $M_{p^{k}}$. The dimensions of $M_{p^{k n}} \ominus \mathbb{C} I$ and $M_{p^{k}} \ominus \mathbb{C} I$ are $p^{2 k n}-1$ and $p^{2 k}-1$, respectively. Hence such subalgebras are at most $N_{(k, n)}=p^{2 k n}-1 / p^{2 k}-1$. We construct $N_{(k, n)}$ pairwise quasi-orthogonal subalgebras.

Theorem 3.5 $M_{p^{k n}}$ contains $N_{(k, n)}$ pairwise quasi-orthogonal subalgebras which are isomorphic to $M_{p^{k}}$.

Proof. The case $n=1$ is trivial and the case $n=2$ is already proven in Theorem 3.4. Assume $M_{p^{k(n-2)}}$ contains $N_{(k, n-2)}$ pairwise quasi-orthogonal subalgebras which are isomorphic to $M_{p^{k}}$. Let $\mathcal{A} \simeq M_{p^{k}} \subset M_{p^{k(n-2)}}$ be one of them. Then we can assume that $\mathcal{A}$ is generated by $\left\{S_{i}, W_{j}\right\}_{1 \leq i, j \leq k}$. On the other hand, $M_{p^{2 k}}$ contains $N_{(k, 2)}=$ $p^{2 k}+1$ quasi-orthogonal subalgebras which are isomorphic to $\mathbb{C}^{p^{2 k}} \simeq \mathbb{C}^{p^{k}} \otimes \mathbb{C}^{p^{k}}$ from Proposition 2.2 and the theory of mutually unbiased bases. Let $\mathcal{C} \simeq \mathbb{C}^{p^{k}} \otimes \mathbb{C}^{p^{k}} \subset M_{p^{2 k}}$ be one of them. Suppose $\mathcal{C}$ is generated by $\left\{W_{i} \otimes I, I \otimes W_{j}\right\}_{1 \leq i, j \leq k}$.

Define a homomorphism $\hat{\pi}_{2}$ (up to scalar multiple) from $Z_{p}^{4 k}$ to $\mathcal{A} \otimes \mathcal{C}$ by

$$
\hat{\pi}_{2}\left(u_{i}^{(j)}\right)=\bigotimes_{i=1}^{k} S^{u_{i}^{(1)}} W^{u_{i}^{(2)}} \otimes \bigotimes_{i=1}^{k} W^{u_{i}^{(3)}} \otimes \bigotimes_{i=1}^{k} W^{u_{i}^{(4)}}
$$

for $\left(u_{i}^{(j)}\right)_{1 \leq i \leq k, 1 \leq j \leq 4} \in Z_{p}^{4 k}$. We denote other symplectic products by

$$
a \hat{o} b=a^{(1)}(t) b^{(2)}(t)-a^{(2)}(t) b^{(1)}(t)
$$

for $a=\left(a^{(1)}(t), a^{(2)}(t), a^{(3)}(t), a^{(4)}(t)\right)$ and $b=\left(b^{(1)}(t), b^{(2)}(t), b^{(3)}(t), b^{(4)}(t)\right)$ in $G F\left(p^{k}\right)^{4}$, and

$$
u \hat{o ̂} v=\sum_{i=1}^{k} u_{i}^{(1)} v_{i}^{(2)}-u_{i}^{(2)} v_{i}^{(1)}
$$

for $u=\left(u_{i}^{(j)}\right)_{1 \leq i \leq k, 1 \leq j \leq 4}$ and $v=\left(v_{i}^{(j)}\right)_{1 \leq i \leq k, 1 \leq j \leq 4}$ in $Z_{p}^{4 k}$. Since $\mathcal{C}$ is commutative, we have

$$
\hat{\pi}_{2}(u) \hat{\pi}_{2}(v)=\lambda^{-u \hat{o} v} \hat{\pi}_{2}(v) \hat{\pi}_{2}(u) .
$$

Moreover from [4], there exists a homomorphism $\hat{\pi}_{1}$ from $G F\left(p^{k}\right)^{4}$ to $Z_{p}^{4 k}$ such that

$$
\varphi(a \hat{o} b)=\hat{\pi}_{1}(a) \hat{o} \hat{\pi}_{1}(b) .
$$

Here for elements $a=\left(a^{(1)}(t), a^{(2)}(t), 0,0\right)$ and $b=\left(0,0, b^{(3)}(t), b^{(4)}(t)\right)$ in $G F\left(p^{k}\right)^{4}$, we can assume

$$
\begin{aligned}
\hat{\pi}_{1}(a) & =\left(\left(u_{i}^{(1)}\right),\left(u_{j}^{(2)}\right), 0,0\right) \\
\hat{\pi}_{1}(b) & =\left(0,0,\left(v_{i}^{(3)}\right),\left(v_{j}^{(4)}\right)\right)
\end{aligned}
$$

for some $\left(u_{i}^{(1)}\right),\left(u_{j}^{(2)}\right),\left(v_{i}^{(3)}\right),\left(v_{j}^{(4)}\right) \in Z_{p}^{k}$. Then we can prove that the algebra generated by $\hat{\pi}_{2} \hat{\pi}_{1}(a)$ and $\hat{\pi}_{2} \hat{\pi}_{1}(b)$ is isomorphic to $M_{p^{k}}$, if $a \hat{o} b \neq 0$, by using a similar proof of Lemma 3.1.

For any $a(t), b(t) \in G F\left(p^{k}\right)$, let

$$
\hat{C}_{a(t), b(t)}=\left\{p(t)(1,0, a(t), b(t))+q(t)(0,1, b(t) D, a(t)) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\}
$$

and

$$
\hat{C}_{\infty}=\left\{p(t)(0,0,1,0)+q(t)(0,0,0,1) \mid p(t), q(t) \in G F\left(p^{k}\right)\right\} .
$$

From the similar method of the proof of Lemma 2.4, the only vector common to any pair of above subspaces is $(0,0,0,0)$. Since $(1,0, a(t), b(t)) \circ(0,1, b(t) D, a(t))=1$, we obtain

$$
\operatorname{span}\left\{\hat{\pi}_{2} \hat{\pi}_{1}\left(\hat{C}_{a(t), b(t)}\right)\right\} \simeq M_{p^{k}}
$$

Moreover we have

$$
\operatorname{span}\left\{\hat{\pi}_{2} \hat{\pi}_{1}\left(\hat{C}_{\infty}\right)\right\}=I \otimes \mathcal{C} \simeq \mathbb{C}^{p^{2 k}}
$$

Consequently $\mathcal{A} \otimes \mathcal{C}$ can be decomposed by $\mathcal{A} \otimes I=\operatorname{span}\left\{\hat{\pi}_{2} \hat{\pi}_{1}\left(\hat{C}_{0,0}\right)\right\}, I \otimes \mathcal{C}=$ $\operatorname{span}\left\{\hat{\pi}_{2} \hat{\pi}_{1}\left(\hat{C}_{\infty}\right)\right\}$ and $p^{2 k}-1$ pairwise quasi-orthogonal subalgebras which are isomorphic to $M_{p^{k}}$. We denote the $p^{2 k}-1$ pairwise quasi-orthogonal subalgebras by $\left\{\mathcal{B}_{\mathcal{A}, \mathcal{C}}^{k}\right\}_{k=1}^{p^{2 k}-1}$.

Let $\mathcal{A}_{1}, \ldots, \mathcal{A}_{N_{(k, n-2)}}$ be pairwise quasi-orthogonal subalgebras in $M_{p^{k(n-2)}}$ which are isomorphic to $M_{p^{k}}$ and let $\mathcal{C}_{1}, \ldots, \mathcal{C}_{N_{(k, 2)}}$ be pairwise quasi-orthogonal subalgebras in $M_{p^{2 k}}$ which are isomorphic to $\mathbb{C}^{p^{2 k}}$. Since

$$
\left(\mathcal{A}_{i_{1}} \ominus \mathbb{C} I\right) \otimes\left(\mathcal{C}_{j_{1}} \ominus \mathbb{C} I\right) \perp \mathcal{A}_{i_{2}} \otimes \mathcal{C}_{j_{2}}
$$

for $i_{1} \neq i_{2}$ or $j_{1} \neq j_{2}, \mathcal{B}_{\mathcal{A}_{i_{1}}, \mathcal{C}_{j_{1}}}^{k_{1}}$ and $\mathcal{B}_{\mathcal{A}_{i_{2}}, \mathcal{C}_{j_{2}}}^{k_{2}}$ are quasi-orthogonal if $i_{1} \neq i_{2}$ or $j_{1} \neq j_{2}$ or $k_{1} \neq k_{2}$. Furthermore, $\mathcal{B}_{\mathcal{A}_{i_{1}}, \mathcal{C}_{j_{1}}}^{k_{1}}$ is quasi-orthogonal with $\mathcal{A}_{i_{2}} \otimes I_{M_{p^{2 k}}}$ and $I_{M_{p^{k(n-2)}}} \otimes \mathcal{C}_{j_{2}}$ for any $i_{2}$ and $j_{2}$. Therefore we can decompose $M_{p^{k n}}$ by $M_{p^{k(n-2)}} \otimes I_{M_{p^{2 k}}}=\operatorname{span}\left\{\mathcal{A}_{i} \otimes\right.$ $I\}, I_{M_{p^{k(n-2)}}} \otimes M_{p^{2 k}}=\operatorname{span}\left\{I \otimes \mathcal{C}_{j}\right\}$ and $\left\{\mathcal{B}_{\mathcal{A}_{i}, \mathcal{C}_{j}}^{k}\right\}_{i, j, k}$. In consequence, we get

$$
N_{(k, n-2)}+N_{(k, 2)}+\left(p^{2 k}-1\right) N_{(k, 2)} N_{(k, n-2)}=N_{(k, n)}
$$

pairwise quasi-orthogonal subalgebras in $M_{p^{k n}}$ which are isomorphic to $M_{p^{k}}$.
