# CLOSED IDEALS IN ANALYTIC WEIGHTED LIPSCHITZ ALGEBRAS.

#### Abstract

We obtain a complete description of closed ideals in weighted Lipschitz algebras $\Lambda_{\omega}$ of analytic functions on the unit disk satisfying the following condition $$
\frac{|f(z)-f(w)|}{\omega(|z-w|)}=o(1) \quad(\text { as }|z-w| \longrightarrow 0),
$$ where $\omega$ is a modulus of continuity satisfying some regularity conditions. In particular the closed ideals of the algebras $\Lambda_{\chi_{\alpha}}$, where $\chi_{\alpha}(t):=\frac{1}{(|\log (t)|+1)^{\alpha}}, \alpha>0$, are standard and this answers Shirokov's question [9, page 587].


## 1. Introduction and statement of main result.

Let $\mathbb{D}$ be the unit disk of the complex plane and $\mathbb{T}$ its boundary. By $\mathcal{A}(\mathbb{D})$ we denote the usual disk algebra of all analytic functions $f$ on $\mathbb{D}$ that are continuous on $\overline{\mathbb{D}}$. We define the weighted Lipschitz algebra $\Lambda_{\omega}(\mathbb{D})=\Lambda_{\omega}$ to be

$$
\Lambda_{\omega}:=\left\{f \in \mathcal{A}(\mathbb{D}): \sup _{z, w \in \mathbb{D}} \frac{|f(z)-f(w)|}{\omega(|z-w|)}=o(1) \quad(\text { as }|z-w| \rightarrow 0)\right\}
$$

where $\omega(t)$ is a modulus of continuity, i.e., a nondecreasing continuous real-valued function on $[0,2]$ with $\omega(0)=0$ and $\omega(t) / t$ is non increasing function such that $\lim _{t \rightarrow 0} \omega(t) / t=\infty$. It is clear that $\Lambda_{\omega}$ is a commutative Banach algebra when equipped with the norm

$$
\|f\|_{\omega}:=\|f\|_{\infty}+\sup _{\substack{z, w \in \overline{\mathbb{D}} \\ z \neq w}} \frac{|f(z)-f(w)|}{\omega(|z-w|)}
$$

with $\|f\|_{\infty}:=\sup _{z \in \mathbb{D}}|f(z)|$. Similarly the weighted Lipschitz algebra $\Lambda_{\omega}(\mathbb{T})$ is defined by

$$
\Lambda_{\omega}(\mathbb{T}):=\left\{f \in \mathcal{A}(\mathbb{D}): \sup _{z, w \in \mathbb{T}} \frac{|f(z)-f(w)|}{\omega(|z-w|)}=o(1) \quad(\text { as }|z-w| \rightarrow 0)\right\} .
$$

Shirokov showed in 10 that $\Lambda_{\omega}$ possesses the so-called F-property (Factorization property), i.e., for every given $f \in \Lambda_{\omega}$ and inner function $U$ such that $f / U$ belongs to the algebra $\mathcal{H}^{\infty}(\mathbb{D})$ of bounded analytic functions, we have $f / U \in \Lambda_{\omega}$ and $\|f / U\|_{\omega} \leq$ $c\|f\|_{\omega}$, for an absolute constant $c$ (see appendix B). Note that Tamrazov [11] proved

that the algebras $\Lambda_{\omega}$ and $\Lambda_{\omega}(\mathbb{T})$ coincide for any arbitrary modulus of continuity $\omega$ (see appendix A).

The structure of closed ideals in the disk algebra is given independently by Beurling and Rudin [4]. They proved that if $\mathcal{I}$ is a closed ideal of $\mathcal{A}(\mathbb{D})$, then there is an inner function $U_{\mathcal{I}}$ (the greatest common divisor of the inner parts of the non-zero functions in $\mathcal{I}$ ) such that $\mathcal{I}=\left\{f \in \mathcal{A}(\mathbb{D}): f_{\mid E_{\mathcal{I}}} \equiv 0\right.$ and $\left.f / U_{\mathcal{I}} \in \mathcal{H}^{\infty}(\mathbb{D})\right\}$, where $E_{\mathcal{I}}:=\{\xi \in \mathbb{T}: f(\xi)=0, \forall f \in \mathcal{I}\}$.
Using Beurling-Carleman-Domar resolvent's method combined with the F-property, we can reduce the problem of characterization of closed ideals, in some algebras of analytic functions, to a problem of approximation of outer functions (see for example [2] and references therein). Korenblum [5] has described the closed ideals of the algebra $H_{1}^{2}$ of analytic functions $f$ such that $f^{\prime}$ is in the Hardy space $H^{2}$. He proved that these ideals are standard (in the sense of Beurling-Rudin characterization of the closed ideals in the disk algebra). Later, this result has been extended to some other Banach algebras of analytic functions. In particular by Matheson 7 and independently by Shamoyan [8] for the algebras $\Lambda_{\varphi_{\alpha}}$, where $\varphi_{\alpha}(t):=t^{\alpha}, 0<\alpha<1$. The resolvent method is described as follows: Define $d(\xi, E)$ to be the distance from $\xi \in \mathbb{T}$ to the closed subset $E$ of $\mathbb{T}$ and let $\mathcal{I}$ be a closed ideal of the algebra $\Lambda_{\varphi_{\alpha}}$.

1. In the first step we give an estimate to the norm of the resolvent $\|(\xi-$ $\pi(z))^{-1} \|_{\Lambda_{\varphi_{\alpha}} / \mathcal{I}}$ in the quotient algebra $\Lambda_{\varphi_{\alpha}} / \mathcal{I}$, where $\pi: \Lambda_{\varphi_{\alpha}} \rightarrow \Lambda_{\varphi_{\alpha}} / \mathcal{I}$ is the canonical quotient map. We obtain $\left\|(\xi-\pi(z))^{-1}\right\|_{\Lambda_{\varphi_{\alpha}} / \mathcal{I}} \leq \frac{c}{d^{4}\left(\xi, E_{\mathcal{I}}\right)}$, where $1 \leq|\xi| \leq 2$ and $c$ is an absolute constant. So, from Cauchy formula on the quotient algebra $\Lambda_{\varphi_{\alpha}} / \mathcal{I}$, we deduce that all functions in $\Lambda_{\varphi_{\alpha}}$ such that $f / U_{\mathcal{I}} \in \mathcal{H}^{\infty}(\mathbb{D})$ and $|f(\xi)| \leq d^{4}\left(\xi, E_{\mathcal{I}}\right), \xi \in \mathbb{T}$, are in $\mathcal{I}$.
2. The second step consists to prove that the space of all functions in $\Lambda_{\varphi_{\alpha}}$ such that $f / U_{\mathcal{I}} \in \mathcal{H}^{\infty}(\mathbb{D})$ and $|f(\xi)| \leq d^{4}\left(\xi, E_{\mathcal{I}}\right), \xi \in \mathbb{T}$, is dense in the standard ideal $\left\{f \in \Lambda_{\varphi_{\alpha}}: f_{\mid E_{\mathcal{I}}} \equiv 0\right.$ and $\left.f / U_{\mathcal{I}} \in \mathcal{H}^{\infty}(\mathbb{D})\right\}$.
A closed subset $E \subset \mathbb{T}$ is called a Carleson set if the Carleson condition is satisfied, to wit

$$
\frac{1}{2 \pi} \int_{0}^{2 \pi} \log \left(\frac{1}{d\left(e^{i t}, E\right)}\right) d t<+\infty
$$

The zeros of each given function in any Banach algebras $H_{1}^{2}, \Lambda_{\varphi_{\alpha}}$ and other ones in which the structure of closed ideals is also studied by using the resolvent method [2, 9], form a Carleson set. For the general case the resolvent method fails to apply, as example we can consider the algebras $\Lambda_{\chi_{\alpha}}$, where $\chi_{\alpha}(t):=\frac{1}{(|\log (t)|+1)^{\alpha}}, \alpha>0$, [9, page 587]. Indeed, let $\mathcal{I}$ be a closed ideal of $\Lambda_{\chi_{\alpha}}$ such that $E_{\mathcal{I}}$ is not a Carleson set. We have $\left\|(\xi-\pi(z))^{-1}\right\|_{\Lambda_{\chi_{\alpha}} / \mathcal{I}} \leq \frac{c}{d^{4}\left(\xi, E_{\mathcal{I}}\right)}$, where $1 \leq|\xi| \leq 2$ and $\pi: \Lambda_{\chi_{\alpha}} \rightarrow \Lambda_{\chi_{\alpha}} / \mathcal{I}$ is the canonical quotient map. It is clear that does not exist any power $M$ such that $\int_{\mathbb{T}} \frac{\left|f^{M}\left(e^{i t}\right)\right|}{d^{4}\left(e^{i t}, E_{\mathcal{I}}\right)} d t<+\infty$ for all functions in $\Lambda_{\chi_{\alpha}}$ vanishing on $E_{\mathcal{I}}$. Therefore we can not conclude the first step of the resolvent method as described above.

From now on, $\omega$ will be a modulus of continuity such that for every $1 \leq \rho \leq 2$ the following condition

$$
\begin{equation*}
\omega\left(t^{\rho}\right) \geq \eta_{\rho} \omega^{\rho}(t) \quad(0 \leq t \leq 2) \tag{1.1}
\end{equation*}
$$

is satisfied, where $\eta_{\rho}>0$ is a constant depending only on $\rho$.
In this work we prove that the closed ideals of the algebras $\Lambda_{\omega}$ are standard. For proving this we use only a special method of approximating outer functions in $\Lambda_{\omega}$ together with the F-property. More precisely, we obtain the following

Theorem 1.1. Let $\omega$ be a modulus of continuity satisfying (1.1). If $\mathcal{I}$ is closed ideal of $\Lambda_{\omega}$, then

$$
\mathcal{I}=\left\{f \in \Lambda_{\omega}: f_{\mid E_{\mathcal{I}}} \equiv 0 \text { and } f / U_{\mathcal{I}} \in \mathcal{H}^{\infty}(\mathbb{D})\right\}
$$

where $E_{\mathcal{I}}:=\{\xi \in \mathbb{T}: f(\xi)=0, \forall f \in \mathcal{I}\}$ and $U_{\mathcal{I}}$ is the greatest common divisor of the inner parts of the non-zero functions in $\mathcal{I}$.

Consequently, we obtain the structure of closed ideals of the particular algebras $\Lambda_{\chi_{\alpha}}$.

## 2. Other results and proof of Theorem 1.1.

We begin by recalling that every function $f$ in the disk algebra has the canonical factorization $f=c_{f} U_{f} O_{f}$, where $c_{f}$ is a constant of modulus $1, U_{f}$ is an inner function (that is $\left|U_{f}\right|=1$ a.e. on $\mathbb{T}$ ) and $O_{f}$ the outer function given by

$$
O_{f}(z)=\exp \left\{\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{e^{i \theta}+z}{e^{i \theta}-z} \log \left|f\left(e^{i \theta}\right)\right| d \theta\right\} \quad(z \in \mathbb{D})
$$

The closed ideal of all functions in $\Lambda_{\omega}$ vanishing on $E$ is designed by $\mathcal{J}_{E}$. In the section 3.2 we give the proof of the following theorem

Theorem 2.1. Let $\omega$ be a modulus of continuity satisfying the following condition

$$
\begin{equation*}
\omega\left(t^{2}\right) \geq \eta_{2} \omega^{2}(t) \quad(0 \leq t \leq 2) \tag{2.1}
\end{equation*}
$$

where $\eta_{2}>0$ is a constant. Let $\mathcal{I}$ be a closed ideal in $\Lambda_{\omega}$ such that $U_{\mathcal{I}} \equiv 1$ and let $g \in \mathcal{J}_{E_{\mathcal{I}}}$ be an outer function. Then $g^{2}$ belongs to $\mathcal{I}$.

Remark 2.2. In the same way, as in Theorem 2.1, we can obtain that if moreover $\omega$ satisfy the following stronger condition

$$
\begin{equation*}
\omega\left(t^{2}\right) \geq \eta \omega(t) \quad(0 \leq t \leq 2) \tag{2.2}
\end{equation*}
$$

then $g$ belongs to $\mathcal{I}$.
In the section 3.3 we prove the following theorem
Theorem 2.3. Let $\omega$ be a modulus of continuity satisfying the condition (1.1). Let $\mathcal{I}$ be a closed ideal in $\Lambda_{\omega}$ and let $g \in \Lambda_{\omega}$ be a function such that $U_{g} O_{g}^{2} \in \mathcal{I}$. Then $g$ belongs to $\mathcal{I}$.

Proof of Theorem 1.1: We have to prove that every closed ideal of $\Lambda_{\omega}$ is standard. For this, let $\mathcal{I}$ be a closed ideal of the algebra $\Lambda_{\omega}$. If $U_{\mathcal{I}} \equiv 1$, let $g$ be a function in $\mathcal{J}_{E_{\mathcal{I}}}$. Hence, making use of the F-property of $\Lambda_{\omega}$, it follows $O_{g} \in \Lambda_{\omega}$, and therefore $O_{g} \in \mathcal{J}_{E_{\mathcal{I}}}$. Thus, according to Theorem 2.1, we deduce $O_{g}^{2} \in \mathcal{I}$ and then $U_{g} O_{g}^{4} \in \mathcal{I}$. Next, by applying Theorem 2.3 two times, we conclude $g \in \mathcal{I}$.
Now if $U_{\mathcal{I}} \not \equiv 1$, we choose $g \in \mathcal{J}_{E_{\mathcal{I}}}$ such that $g / U_{\mathcal{I}} \in \mathcal{H}^{\infty}(\mathbb{D})$. Thus, the associated ideal

$$
\mathcal{K}_{g}:=\left\{f \in \Lambda_{\omega}: f g \in \mathcal{I}\right\}
$$

is closed and by the F-property of $\Lambda_{\omega}$ we see easily that $U_{\mathcal{K}_{g}} \equiv 1$ and then $\mathcal{K}_{g}=\mathcal{J}_{E_{\mathcal{K}_{g}}}$. Now, since $E_{\mathcal{K}_{g}} \subseteq E_{\mathcal{I}}$, then $O_{g} \in \mathcal{K}_{g}$. It follows that $U_{g} O_{g}^{2} \in \mathcal{I}$. So, by Theorem 2.3, $g \in \mathcal{I}$. This completes the proof of the theorem.

## 3. Approximation of functions in $\Lambda_{\omega}$.

In this section we give the proof of Theorem 2.1 and Theorem 2.3. For simplicity we use the following Tamrazov's Theorem (see Appendix A): If $f$ is a function in the disk algebra such that $f \in \Lambda_{\omega}(\mathbb{T})$, then $f \in \Lambda_{\omega}$. We need also the following simple Lemma

Lemma 3.1. Let $f_{n} \in \Lambda_{\omega}$ be a sequence of functions converging uniformly on the closed unit disk to $f \in \Lambda_{\omega}$. If

$$
\frac{\left|f_{n}(z)-f_{n}(w)\right|}{\omega(|z-w|)}=o(1) \quad(\text { as }|z-w| \longrightarrow 0)
$$

uniformly with respect to $n$, then $\lim _{n \rightarrow+\infty}\left\|f_{n}-f\right\|_{\omega}=0$.
3.1. Several technical lemmas. For $f \in \Lambda_{\omega}$, the inner function $U_{f}$ is uniquely factored in the form $U_{f}=B_{f} S_{f}$, where $B_{f}$ is the usual Blashke product associated to $Z_{f} \cap \mathbb{D}, Z_{f}:=\{z \in \overline{\mathbb{D}}: f(z)=0\}$ and the function

$$
S_{f}(z):=\exp \left\{-\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{e^{i \theta}+z}{e^{i \theta}-z} d \mu_{f}(\theta)\right\} \quad(z \in \mathbb{D})
$$

is the singular inner function associated to the singular positive measure $\mu_{f}$. Note that the $\operatorname{support} \operatorname{supp}\left(\mu_{f}\right)$ of the singular measure $\mu_{f}$ is a closed subset of $E_{f}:=$ $\{\xi \in \mathbb{T}: f(\xi)=0\}$. For $a, b \in \mathbb{T}$, we design by $(a, b)$ (resp. $[a, b]$ ) an open arc (resp. closed arc) of $\mathbb{T}$ connecting the points $a$ and $b$.

Lemma 3.2. Let $\omega$ be a modulus of continuity satisfying the condition (2.1). Let $g$ be a function in $\Lambda_{\omega}$ and let $U=B_{U} S_{U} \in \mathcal{H}^{\infty}(\mathbb{D})$ be an inner function such that $B_{g} / B_{U} \in \mathcal{H}^{\infty}(\mathbb{D}), \operatorname{supp}\left(\mu_{U}\right) \subseteq E_{g}$ and $(1 / 2 \pi) \int_{0}^{2 \pi} d \mu_{U}(\theta) \leq M$, where $M$ is a constant. Then $U O_{g}^{2}$ belongs to $\Lambda_{\omega}$ and we have

$$
\begin{equation*}
\frac{\left|U(\xi) O_{g}^{2}(\xi)-U(\zeta) O_{g}^{2}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.1}
\end{equation*}
$$

uniformly with respect to $U$. If moreover $\omega$ satisfy the condition (2.2), then $U O_{g}$ belongs to $\Lambda_{\omega}$ and we have

$$
\begin{equation*}
\frac{\left|U(\xi) O_{g}(\xi)-U(\zeta) O_{g}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(a s|\xi-\zeta| \longrightarrow 0) \tag{3.2}
\end{equation*}
$$

uniformly with respect to $U$.
Proof. Let $\xi, \zeta \in \mathbb{T}$ be two distinct points such that $d\left(\xi, E_{g}\right) \geq d\left(\zeta, E_{g}\right)$. It is clear that

$$
\begin{aligned}
& \frac{\left|U(\xi) O_{g}^{2}(\xi)-U(\zeta) O_{g}^{2}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
\leq & \frac{\left|B_{U}(\xi) O_{g}^{2}(\xi)-B_{U}(\zeta) O_{g}^{2}(\zeta)\right|}{\omega(|\xi-\zeta|)}+\left|O_{g}^{2}(\zeta)\right| \frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{\omega(|\xi-\zeta|)} .
\end{aligned}
$$

By the F-property of $\Lambda_{\omega}$ we have $O_{g} \in \Lambda_{\omega}$ and $B_{U} O_{g}^{2} \in \Lambda_{\omega}$. Then to prove (3.1), it is sufficient to prove that

$$
\begin{equation*}
\left|O_{g}^{2}(\zeta)\right| \frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.3}
\end{equation*}
$$

First we suppose that $|\xi-\zeta| \geq\left(\frac{d\left(\zeta, E_{g}\right)}{2}\right)^{2}$. Then

$$
\begin{align*}
\left|O_{g}^{2}(\zeta)\right| \frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{\omega(|\xi-\zeta|)} & \leq 8 \eta_{2}^{-1}\left(\frac{\left|O_{g}(\zeta)\right|}{\omega\left(d\left(\zeta, E_{g}\right)\right)}\right)^{2} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.4}
\end{align*}
$$

Now, let suppose that $|\xi-\zeta| \leq\left(\frac{d\left(\zeta, E_{g}\right)}{2}\right)^{2}$. Then $[\xi, \zeta] \subset \mathbb{T} \backslash E_{g}$ and therefore $d\left(z, E_{g}\right) \geq d\left(\zeta, E_{g}\right)$, for every $z \in[\xi, \zeta]$. There is $z \in[\xi, \zeta]$ such that

$$
\frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{|\xi-\zeta|}=\left|S_{U}^{\prime}(z)\right| \leq \frac{1}{\pi} \int_{0}^{2 \pi} \frac{1}{\left|e^{i \theta}-z\right|^{2}} d \mu_{U}(\theta) \leq \frac{2 M}{d^{2}\left(z, E_{g}\right)}
$$

It follows

$$
\frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{|\xi-\zeta|} \leq \frac{2 M}{d^{2}\left(\zeta, E_{g}\right)} .
$$

We obtain

$$
\begin{align*}
& \left|O_{g}^{2}(\zeta)\right| \frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
= & \left|O_{g}^{2}(\zeta)\right| \frac{\left|S_{U}(\xi)-S_{U}(\zeta)\right|}{|\xi-\zeta|} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \\
\leq & 2 M \eta_{2}^{-1}\left(\frac{\left|O_{g}(\zeta)\right|}{\omega\left(d\left(\zeta, E_{g}\right)\right)}\right)^{2} \frac{\omega\left(d^{2}\left(\zeta, E_{g}\right)\right)}{d^{2}\left(\zeta, E_{g}\right)} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \\
= & o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) . \tag{3.5}
\end{align*}
$$

So (3.3) follows from (3.4) and (3.5). Consequently $U O_{g}^{2}$ belongs to $\Lambda_{\omega}$. If moreover $\omega$ satisfy the condition (2.2), we can argue similarly to prove (3.2). This finishes the proof of the lemma.

Lemma 3.3. Let $f$ be a function in $\Lambda_{\omega}$. Let $\delta>0, N \in \mathbb{N}$ and $\left\{a_{n}: 0 \leq n \leq N\right\}$ be a finite number of points in $E_{f}$. Then

$$
\lim _{\delta \longrightarrow 0}\left\|\psi_{\delta, N} f-f\right\|_{\omega}=0
$$

where $\psi_{\delta, N}(z):=\prod_{n=0}^{n=N} \frac{z \overline{a_{n}}-1}{z \overline{a_{n}}-1-\delta}, z \in \mathbb{D}$.
Proof. Without loss of the generality we can suppose that $N=0$ and $a_{0}=1$. Set $\psi_{\delta}(z):=\frac{z-1}{z-1-\delta}, z \in \mathbb{D}$, and suppose that $\{1\} \in E_{f}$. We have to show that $\lim _{\delta \rightarrow 0}\left\|\psi_{\delta} f-f\right\|_{\omega}=0$. Let $\xi, \zeta \in \mathbb{T}$ be two distinct points such that $|\xi-1| \geq|\zeta-1|$. We have

$$
\begin{equation*}
\frac{\left|\psi_{\delta}(\xi) f(\xi)-\psi_{\delta}(\zeta) f(\zeta)\right|}{\omega(|\xi-\zeta|)} \leq\left|\psi_{\delta}(\xi)\right| \frac{|f(\xi)-f(\zeta)|}{\omega(|\xi-\zeta|)}+|f(\zeta)| \frac{\left|\psi_{\delta}(\xi)-\psi_{\delta}(\zeta)\right|}{\omega(|\xi-\zeta|)} . \tag{3.6}
\end{equation*}
$$

Suppose first that $|\xi-\zeta| \geq|\zeta-1|$. Then

$$
\begin{align*}
|f(\zeta)| \frac{\left|\psi_{\delta}(\xi)-\psi_{\delta}(\zeta)\right|}{\omega(|\xi-\zeta|)} & \leq 2 \frac{|f(\zeta)|}{\omega(|\zeta-1|)} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.7}
\end{align*}
$$

Now if $|\xi-\zeta| \leq|\zeta-1|$, then $|z-1| \geq|\zeta-1|$ for every $z \in[\xi, \zeta]$. We obtain

$$
\begin{align*}
|f(\zeta)| \frac{\left|\psi_{\delta}(\xi)-\psi_{\delta}(\zeta)\right|}{\omega(|\xi-\zeta|)} & =|f(\zeta)| \frac{\left|\psi_{\delta}(\xi)-\psi_{\delta}(\zeta)\right|}{|\xi-\zeta|} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \\
& =|f(\zeta)|\left|\psi_{\delta}^{\prime}(z)\right| \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \quad(z \in[\xi, \zeta]) \\
& \leq \frac{|f(\zeta)|}{\omega(|\zeta-1|)} \frac{\omega(|\zeta-1|)}{|\zeta-1|} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.8}
\end{align*}
$$

From (3.6), (3.7) and (3.8) we deduce

$$
\frac{\left|\psi_{\delta}(\xi) f(\xi)-\psi_{\delta}(\zeta) f(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0)
$$

uniformly with respect to $\delta>0$. So the result follows by applying Lemma 3.1 to the family of functions $\psi_{\delta} f, \delta>0$. This completes the proof of the lemma.

We denote by $K^{c}$ the complement in $\mathbb{T}$ of the subset $K$ of $\mathbb{T}$. For a closed subset $E$ of $\mathbb{T}$, we have $E^{c}=\bigcup_{n \in \mathbb{N}}\left(a_{n}, b_{n}\right)$, where $\left(a_{n}, b_{n}\right) \subset E^{c}$ and $a_{n}, b_{n} \in E$. We define $\Omega_{E}$ to be the family of all the unions of $\operatorname{arcs}\left(a_{n}, b_{n}\right)$, where $\left(a_{n}, b_{n}\right) \subset E^{c}$ and $a_{n}, b_{n} \in E$. For a given function $f$ in the disk algebra and $\Gamma \in \Omega_{E}(E$ is a closed subset of $\mathbb{T})$, let us define the outer function $f_{\Gamma} \in \mathcal{H}^{\infty}(\mathbb{D})$ associated to the outer factor of $f$ by

$$
f_{\Gamma}(z):=\exp \left\{\frac{1}{2 \pi} \int_{\Gamma} \frac{e^{i \theta}+z}{e^{i \theta}-z} \log \left|f\left(e^{i \theta}\right)\right| d \theta\right\} \quad(z \in \mathbb{D})
$$

Then, we assert

Lemma 3.4. Let $\mathcal{I}$ be a closed ideal of $\Lambda_{\omega}, f \in \Lambda_{\omega}$ an outer function and let $h \in \mathcal{J}_{E_{\mathcal{I}}}$ a function such that $h f \in \mathcal{I}$. Let $\Gamma \in \Omega_{E_{\mathcal{I}}}$ be such that $\mathbb{T} \backslash \bar{\Gamma}$ is union of a finite number of $\operatorname{arcs}(a, b) \subseteq \mathbb{T} \backslash E_{\mathcal{I}}\left(a, b \in E_{\mathcal{I}}\right)$. If $h f_{\Gamma} \in \Lambda_{\omega}$, then $h f_{\Gamma} \in \mathcal{I}$.

Proof. For simplicity we suppose that $\mathbb{T} \backslash \bar{\Gamma}=(a, b):=\gamma$, where $a, b \in E_{\mathcal{I}}$ and $(a, b) \subseteq \mathbb{T} \backslash E_{I}$. Let $\varepsilon>0$ be such that $\gamma_{\varepsilon}:=\left(a e^{i \varepsilon}, b e^{-i \varepsilon}\right) \subset \gamma$. For $\delta>0$, we set

$$
\phi_{\delta, \varepsilon}(z):=\left(\frac{z \bar{a} e^{-i \varepsilon}-1}{z \bar{a} e^{-i \varepsilon}-1-\delta}\right)\left(\frac{z \bar{b} e^{i \varepsilon}-1}{z \bar{b} e^{i \varepsilon}-1-\delta}\right) \quad(z \in \mathbb{D}) .
$$

It is clear that $\phi_{\delta, \varepsilon} \in \Lambda_{\omega}$ and that $\phi_{\delta, \varepsilon}\left(a e^{i \varepsilon}\right)=\phi_{\delta, \varepsilon}\left(b e^{-i \varepsilon}\right)=0$. Then, according to Proposition 3.6-1 (below), we see that the function $f_{\gamma_{\varepsilon}}$ multiplied by the square of $\phi_{\delta, \varepsilon}$ belongs to $\Lambda_{\omega}$, i.e., $\phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}} \in \Lambda_{\omega}$. Similarly, we get $\phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}^{c}} \in \Lambda_{\omega}$. Now, for $\pi: \Lambda_{\omega} \rightarrow \Lambda_{\omega} / \mathcal{I}$ being the canonical quotient map, it follows

0 & =\pi\left(\phi_{\delta, \varepsilon}^{4} h f\right) \\
& =\pi\left(h \phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}^{c}}\right) \pi\left(\phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}}\right) .
\end{aligned}
$$

Since, the function $\phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}}$ is invertible in the quotient algebra $\Lambda_{\omega} / \mathcal{I}$, then

$$
h \phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}^{c}} \in \mathcal{I} \quad(\delta, \varepsilon>0)
$$

Using the fact

$$
\lim _{\varepsilon \longrightarrow 0}\left\|\phi_{\delta, \varepsilon}^{2} f_{\gamma_{\varepsilon}^{c}}-\phi_{\delta, 0}^{2} f_{\Gamma}\right\|_{\omega}=0
$$

we can check

$$
\phi_{\delta, 0}^{2} h f_{\Gamma} \in \mathcal{I} \quad(\delta>0) .
$$

Now, since $h f_{\Gamma} \in \Lambda_{\omega}$ and $h f_{\Gamma}(a)=h f_{\Gamma}(b)=0$, we can deduce from Lemma 3.3 that

\lim _{\delta \rightarrow 0}\left\|\phi_{\delta, 0}^{2} h f_{\Gamma}-h f_{\Gamma}\right\|_{\omega}=0 .
$$

So $h f_{\Gamma} \in \mathcal{I}$. This completes the proof of the lemma.
Let $\mathcal{I}$ be a closed ideal of the algebra $\Lambda_{\omega}$. We have $U_{\mathcal{I}}=B_{\mathcal{I}} S_{\mathcal{I}}$. The inner function $B_{\mathcal{I}}$ is the usual Blashke product associated to the zero set $Z_{\mathcal{I}} \cap \mathbb{D}$, where $Z_{\mathcal{I}}:=\{z \in$ $\overline{\mathbb{D}}: f(z)=0$ for all $f \in \mathcal{I}\}$. The positive singular measure $\mu_{\mathcal{I}}$ associated to the singular inner function $S_{\mathcal{I}}$ is the greatest common divisor of all $\mu_{f}, f \in \mathcal{I}$. Note that $\operatorname{supp}\left(\mu_{\mathcal{I}}\right)$ is included in $E_{\mathcal{I}}$. For a subset $K$ of $T$, we set

$$
\left(S_{f}\right)_{K}(z):=\exp \left\{-\frac{1}{2 \pi} \int_{K} \frac{e^{i \theta}+z}{e^{i \theta}-z} d \mu_{f}(\theta)\right\} \quad(f \in \mathcal{A}(\mathbb{D}))
$$

Lemma 3.5. Let $f$ be a function in a closed ideal $\mathcal{I}$ of the algebra $\Lambda_{\omega}$. Then $B_{\mathcal{I}}\left(S_{f}\right)_{E_{\mathcal{I}}} O_{f}$ belongs to $\mathcal{I}$.
Proof. Let $f \in \mathcal{I}$. Define $B_{f, n}$ and $B_{\mathcal{I}, n}$ to be respectively the Blashke product with zeros $Z_{f} \cap \mathbb{D}_{n}$ and $Z_{\mathcal{I}} \cap \mathbb{D}_{n}$, where $\mathbb{D}_{n}:=\left\{z \in \mathbb{D}:|z|<\frac{n-1}{n}\right.$, $\left.n \in \mathbb{N}\right\}$. Fix $n \in \mathbb{N}$. The function $B_{f, n} / B_{\mathcal{I}, n}$ is invertible in the quotient algebra $\Lambda_{\omega} / \mathcal{J}_{n}$, where
$\mathcal{J}_{n}:=\left\{g \in \Lambda_{\omega}: g B_{\mathcal{I}, n} \in \mathcal{I}\right\}$. Then $f / B_{f, n} \in \mathcal{J}_{n}$. It follows that $B_{\mathcal{I}, n}\left(f / B_{f, n}\right) \in \mathcal{I}$. It is clear that

$$
\lim _{n \longrightarrow+\infty}\left\|B_{\mathcal{I}, n}\left(f / B_{f, n}\right)-B_{\mathcal{I}} S_{f} O_{f}\right\|_{\infty}=0
$$

By using Corollary 5.2 in appendix $B$ (F-property of $\Lambda_{\omega}$ ), we obtain

$$
\lim _{n \longrightarrow+\infty}\left\|B_{\mathcal{I}, n}\left(f / B_{f, n}\right)-B_{\mathcal{I}} S_{f} O_{f}\right\|_{\omega}=0
$$

So, $B_{\mathcal{I}} S_{f} O_{f} \in \mathcal{I}$. Let $\varepsilon>0$ be such that $\gamma_{\varepsilon}:=\left(a e^{i \varepsilon}, b e^{-i \varepsilon}\right) \subset \gamma:=(a, b)$, where $a, b \in E_{\mathcal{I}}$ and $(a, b) \subseteq \mathbb{T} \backslash E_{\mathcal{I}}$. By using the F-property of $\Lambda_{\omega}$, the function $B_{\mathcal{I}}\left(S_{f}\right)_{\gamma_{\varepsilon}^{c}} O_{f}$ belongs to $\Lambda_{\omega}$. We set

$$
\phi_{\varepsilon}(z):=\left(z \bar{a} e^{-i \varepsilon}-1\right)\left(z \bar{b} e^{i \varepsilon}-1\right) \quad(z \in \mathbb{D})
$$

From Proposition 3.6-1 below, the function $g_{\varepsilon}:=\phi_{\varepsilon}^{2} f_{\gamma_{\varepsilon}}$ belongs to $\Lambda_{\omega}$. Since $\operatorname{supp}\left(\mu_{\left(S_{f}\right)_{\gamma_{\varepsilon}}}\right) \subseteq$ $E_{g_{\varepsilon}}$, then we deduce from Lemma 3.2 that $\left(S_{f}\right)_{\gamma_{\varepsilon}} g_{\varepsilon}^{2} \in \Lambda_{\omega}$. We have

$$
0=\pi\left(g_{\varepsilon}^{2} B_{\mathcal{I}} S_{f} O_{f}\right)=\pi\left(\left(S_{f}\right)_{\gamma_{\varepsilon}} g_{\varepsilon}^{2}\right) \times \pi\left(B_{\mathcal{I}}\left(S_{f}\right)_{\gamma_{\varepsilon}^{C}} O_{f}\right)
$$

where $\pi: \Lambda_{\omega} \rightarrow \Lambda_{\omega} / \mathcal{I}$, is the canonical quotient map. The function $\left(S_{f}\right)_{\gamma_{\varepsilon}} g_{\varepsilon}^{2}$ is invertible in the quotient algebra $\Lambda_{\omega} / \mathcal{I}$, then $B_{\mathcal{I}}\left(S_{f}\right)_{\gamma_{\varepsilon}^{c}} O_{f} \in \mathcal{I}$. It is clear that

$$
\lim _{\varepsilon \rightarrow 0}\left\|B_{\mathcal{I}}\left(S_{f}\right)_{\gamma_{\varepsilon}^{c}} O_{f}-B_{\mathcal{I}}\left(S_{f}\right)_{\gamma^{c}} O_{f}\right\|_{\infty}=0 .
$$

Then, using Corollary 5.2 in appendix B, we obtain

$$
\lim _{\varepsilon \longrightarrow 0}\left\|B_{\mathcal{I}}\left(S_{f}\right)_{\gamma_{\varepsilon}^{\varepsilon}} O_{f}-B_{\mathcal{I}}\left(S_{f}\right)_{\gamma^{c}} O_{f}\right\|_{\omega}=0
$$

So $B_{\mathcal{I}}\left(S_{f}\right)_{\gamma^{c}} O_{f} \in \mathcal{I}$. Similarly we can prove that $B_{\mathcal{I}}\left(S_{f}\right)_{\Gamma_{N}^{c}} O_{f} \in \mathcal{I}$, where $\Gamma_{N}:=$ $\bigcup_{n \leq N}\left(a_{n}, b_{n}\right) \in \Omega_{E_{\mathcal{I}}}$. We have

$$
\lim _{N \xrightarrow{+\infty}}\left\|B_{\mathcal{I}}\left(S_{f}\right)_{\Gamma_{N}^{c}} O_{f}-B_{\mathcal{I}}\left(S_{f}\right)_{E_{\mathcal{I}}} O_{f}\right\|_{\infty}=0
$$

Using again Corollary 5.2 we deduce

$$
\lim _{N \longrightarrow+\infty}\left\|B_{\mathcal{I}}\left(S_{f}\right)_{\Gamma_{N}^{c}} O_{f}-B_{\mathcal{I}}\left(S_{f}\right)_{E_{\mathcal{I}}} O_{f}\right\|_{\omega}=0 .
$$

Then $B_{\mathcal{I}}\left(S_{f}\right)_{E_{\mathcal{I}}} O_{f} \in \mathcal{I}$. This proves the lemma.
3.2. Proof of Theorem 2.1, For the proof of Theorem 2.1, we need the following proposition about approximation of functions in $\Lambda_{\omega}$

Proposition 3.6. Let $\omega$ be a modulus of continuity satisfying the condition (2.1). Let $f \in \Lambda_{\omega}$ be a function such that $\|f\|_{\omega} \leq 1$ and $E$ a closed subset of $\mathbb{T}$. Let $g \in \mathcal{J}_{E}$ be an outer function and $S$ singular inner function such that $\operatorname{supp}\left(\mu_{S}\right) \subseteq E_{g}$. Then

1. The functions $S g^{2}$ and $S g^{2} f_{\Gamma_{N}^{c}}$ belong to $\Lambda_{\omega}$, for every $N \in \mathbb{N}$,
2. We have $\lim _{N \longrightarrow+\infty}\left\|S g^{2} f_{\Gamma_{N}^{c}}-S g^{2}\right\|_{\omega}=0$,
where $\Gamma_{N}:=\bigcup_{n \leq N}\left(a_{n}, b_{n}\right) \in \Omega_{E}$. If moreover $\omega$ satisfy the stronger condition (2.2), then

1'. The functions $S g$ and $S g f_{\Gamma_{N}^{c}}$ belong to $\Lambda_{\omega}$, for every $N \in \mathbb{N}$,
$2^{\prime}$. We have $\lim _{N \longrightarrow+\infty}\left\|S g f_{\Gamma_{N}^{c}}-\stackrel{N}{S} g\right\|_{\omega}=0$.
Proof. From Lemma 3.2 we have $S g^{2} \in \Lambda_{\omega}$. It is clear that $\left\{S g^{2} f_{\Gamma_{N}^{c}}\right\}_{N \in \mathbb{N}}$ is a sequence of functions in the disk algebra. Let us note that if

$$
\begin{equation*}
\frac{\left|S(z) g^{2}(z) f_{\Gamma}(z)-S(w) g^{2}(w) f_{\Gamma}(w)\right|}{\omega(|z-w|)}=o(1) \quad(\text { as }|z-w| \rightarrow 0) \tag{3.9}
\end{equation*}
$$

uniformly with respect to $\Gamma \in \Omega_{E}$, then assertion 1 follows immediately. Furthermore, assertion 2 can be deduced by applying Lemma 3.1.
Thus, it suffices to show only (3.9). For this, we fix $\Gamma \in \Omega_{E}$ and we let $\xi$ and $\zeta$ be two distinct points in $\mathbb{T}$ such that $d(\xi, E) \geq d(\zeta, E)$. It is clear that

& \frac{\left|S(\xi) g^{2}(\xi) f_{\Gamma}(\xi)-S(\zeta) g^{2}(\zeta) f_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
\leq & \left|f_{\Gamma}(\xi)\right| \frac{\left|S(\xi) g^{2}(\xi)-S(\zeta) g^{2}(\zeta)\right|}{\omega(|\xi-\zeta|)}+\left|g^{2}(\zeta)\right| \frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} .
\end{aligned}
$$

Since $S g^{2} \in \Lambda_{\omega}$ (by Lemma 3.2), then the proof of (3.9) reduces to

\left|g^{2}(\zeta)\right| \frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.10}
\end{equation*}
$$

Case 1. For $|\xi-\zeta| \geq\left(\frac{d(\zeta, E)}{2}\right)^{2}$, we have

\left|g^{2}(\zeta)\right| \frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} & \leq 2 \frac{\left|g^{2}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
& \leq 8 \eta_{2}^{-1}\left(\frac{|g(\zeta)|}{\omega(d(\zeta, E))}\right)^{2} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.11}
\end{align*}
$$

Case 2. For $|\xi-\zeta| \leq\left(\frac{d(\zeta, E)}{2}\right)^{2}$ with $\zeta \notin \Gamma$. It follows $[\xi, \zeta] \subset(\Gamma \cup E)^{c}$. Then $z \notin \Gamma$ and $d(z, E) \geq d(\zeta, E)$ for every $z \in[\xi, \zeta]$. There is $z \in[\xi, \zeta]$ such that

\frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{|\xi-\zeta|}=\left|f_{\Gamma}^{\prime}(z)\right| \leq \frac{1}{\pi} \int_{\Gamma} \frac{|\log | f\left(e^{i \theta}\right)| |}{\left|e^{i \theta}-z\right|^{2}} d \theta \leq \frac{c_{f}}{d^{2}(z, E)} .
$$

It follows

$$
\frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{|\xi-\zeta|} \leq \frac{c_{f}}{d^{2}(\zeta, E)} .
$$

Therefore, we have

$$
\begin{align*}
\left|g^{2}(\zeta)\right| \frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} & =\frac{\left|g^{2}(\zeta)\right||\xi-\zeta|}{\omega(|\xi-\zeta|)} \frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{|\xi-\zeta|} \\
& \leq c_{f} \frac{\left|g^{2}(\zeta)\right||\xi-\zeta|}{\omega(|\xi-\zeta|) d^{2}(\zeta, E)} \\
& \leq c_{f}\left(\frac{|g(\zeta)|}{\omega(d(\zeta, E))}\right)^{2} \frac{\omega\left(d^{2}(\zeta, E)\right)|\xi-\zeta|}{\omega(|\xi-\zeta|) d^{2}(\zeta, E)} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.12}
\end{align*}
$$

Case 3. In this case let us assume that $|\xi-\zeta| \leq\left(\frac{d(\zeta, E)}{2}\right)^{2}$ and $\zeta \in \Gamma$. It follows that $\xi \in \Gamma$, and therefore $\left|f_{\mathbb{T} \backslash \Gamma}^{-1}(\xi)\right|=\left|f_{\mathbb{T} \backslash \Gamma}^{-1}(\zeta)\right|=1$. From

$$
\begin{align*}
& f_{\Gamma}(\xi)-f_{\Gamma}(\zeta) \\
= & f(\xi) f_{\mathbb{T} \backslash \Gamma}^{-1}(\xi)-f(\zeta) f_{\mathbb{T} \backslash \Gamma}^{-1}(\zeta) \\
= & f_{\mathbb{T}-1}^{-1}(\xi)(f(\xi)-f(\zeta))+f(\zeta)\left(f_{\mathbb{T} \mid \Gamma}^{-1}(\xi)-f_{\mathbb{T} \backslash \Gamma}^{-1}(\zeta)\right) \\
= & f_{\mathbb{T} \backslash \Gamma}^{-1}(\xi)(f(\xi)-f(\zeta)) \\
& -f(\zeta) f_{\mathbb{T} \backslash \Gamma}^{-1}(\xi) f_{\mathbb{T} \backslash \Gamma}^{-1}(\zeta)\left(f_{\mathbb{T} \backslash \Gamma}(\xi)-f_{\mathbb{T} \backslash \Gamma}(\zeta)\right) \tag{3.13}
\end{align*}
$$

combined with (3.12), we deduce

$$
\begin{align*}
& \left|g^{2}(\zeta)\right| \frac{\left|f_{\Gamma}(\xi)-f_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
\leq & \left|g^{2}(\zeta)\right| \frac{|f(\xi)-f(\zeta)|}{\omega(|\xi-\zeta|)}+|f(\zeta)|\left|g^{2}(\zeta)\right| \frac{\left|f_{T \backslash \Gamma}(\xi)-f_{\mathbb{T \backslash \Gamma}}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
= & o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) . \tag{3.14}
\end{align*}
$$

From inequalities (3.11), (3.12) and (3.14), we see that (3.10) holds. If moreover $\omega$ satisfy the condition (2.2), we can deduce similarly the assertions 1' and 2'. This completes the proof of the proposition.

Proof of Theorem 2.1: Let $\mathcal{I}$ be a closed ideal of the algebra $\Lambda_{\omega}$ such that $U_{\mathcal{I}} \equiv$ 1. Let $g$ be an outer function in $\mathcal{J}_{E_{\mathcal{I}}}$ and consider $f \in \mathcal{I}$. From Lemma3.5, we deduce that $\left(S_{f}\right)_{E_{\mathcal{I}}} O_{f} \in \mathcal{I}$. Then, $\left(S_{f}\right)_{E_{\mathcal{I}}} g^{2} O_{f} \in \mathcal{I}$. From Lemma 3.4 and Proposition 3.6-1, we deduce that $\left(S_{f}\right)_{E_{\mathcal{I}}} g^{2} f_{\Gamma_{N}^{c}} \in \mathcal{I}$, for every $N \in \mathbb{N}$, where $\Gamma_{N}:=\bigcup_{n \leq N}\left(a_{n}, b_{n}\right) \in \Omega_{E_{\mathcal{I}}}$. Thus, by Proposition 3.6-2, $\left(S_{f}\right)_{E_{\mathcal{I}}} g^{2} \in \mathcal{I}$. Now choose a sequence of functions $\left\{f_{n}\right\}_{n \in \mathbb{N}} \subset \mathcal{I}$ such that the greatest common divisor of the inner parts of $f_{n}$ is equal to 1 and such that $(1 / 2 \pi) \int_{0}^{2 \pi} d \mu_{f_{n}}(\theta) \leq 1$. This infers that $k_{n}:=\left(S_{f_{n}}\right)_{E_{\mathcal{I}}} g^{2} \in \mathcal{I}$, for every $n \in \mathbb{N}$. By Lemma 3.2 we have

$$
\frac{\left|k_{n}(\xi)-k_{n}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0)
$$

uniformly with respect to $n$. Using the fact

\lim _{n \longrightarrow+\infty}\left\|k_{n}-g^{2}\right\|_{\infty}=0
$$

and Lemma 3.1, we deduce

$$
\lim _{n \longrightarrow+\infty}\left\|k_{n}-g^{2}\right\|_{\omega}=0 .
$$

So $g^{2} \in \mathcal{I}$. This finishes the proof of the theorem.
3.3. Proof of Theorem 2.3. We begin by proving the following proposition

Proposition 3.7. Let $\omega$ be a modulus of continuity satisfying the condition (1.1). Fix $1<\rho \leq 2$. Let $g \in \Lambda_{\omega}$ be a function such that $\|g\|_{\omega} \leq 1$ and let $E$ be a closed subset of $E_{g}$. Then

1. The functions $U_{g} O_{g}^{\rho}$ and $U_{g} O_{g}^{\rho} g_{\Gamma_{N}^{c}}$ belong to $\Lambda_{\omega}$, for every $N \in \mathbb{N}$,
2. We have $\lim _{N \longrightarrow+\infty}\left\|U_{g} O_{g}^{\rho} g_{\Gamma_{N}^{c}}-U_{g} O_{g}^{\rho}\right\|_{\omega}=0$,
where $\Gamma_{N}:=\bigcup_{n \leq N}\left(a_{n}, b_{n}\right) \in \Omega_{E}$.
Proof. By using the F-property of $\Lambda_{\omega}$ and the following

& U_{g}(\xi) O_{g}^{\rho}(\xi)-U_{g}(\zeta) O_{g}^{\rho}(\zeta) \\
= & O_{g}^{\rho-1}(\xi)\left(U_{g}(\xi) O_{g}(\xi)-U_{g}(\zeta) O_{g}(\zeta)\right)-U_{g}(\zeta) O_{g}^{\rho-1}(\xi)\left(O_{g}(\xi)-O_{g}(\zeta)\right) \\
+ & U_{g}(\zeta)\left(O_{g}^{\rho}(\xi)-O_{g}^{\rho}(\zeta)\right) \quad(\xi, \zeta \in \mathbb{T}),
\end{aligned}
$$

the function $U_{g} O_{g}^{\rho}$ belongs to $\Lambda_{\omega}$. It is clear that $\left\{U_{g} O_{g}^{\rho} g_{\Gamma_{N}^{c}}\right\}_{N \in \mathbb{N}}$ is sequence of functions in the disk algebra and

\lim _{N \longrightarrow+\infty}\left\|U_{g} O_{g}^{\rho} g_{\Gamma_{N}^{c}}-U_{g} O_{g}^{\rho}\right\|_{\infty}=0 .
$$

Note that if

\frac{\left|U_{g} O_{g}^{\rho} g_{\Gamma}(\xi)-U_{g} O_{g}^{\rho} g_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \rightarrow 0) \tag{3.15}
\end{equation*}
$$

uniformly with respect to $\Gamma \in \Omega_{E}$, then assertion 1 holds as well as assertion 2, which follows from (3.15) combined with Lemma 3.1.
Below, we have to prove (3.15). Let $\xi, \zeta \in \mathbb{T}$ be two different points such that $d(\xi, E) \geq d(\zeta, E)$. It is clear that

\leq & \left|g_{\Gamma}(\xi)\right| \frac{\left|U_{g}(\xi) O_{g}^{\rho}(\xi)-U_{g}(\zeta) O_{g}^{\rho}(\zeta)\right|}{\omega(|\xi-\zeta|)}+|g(\zeta)|^{\rho} \frac{\left|g_{\mathrm{r}}(\xi)-g_{\mathrm{r}}(\zeta)\right|}{\omega(|\xi-\zeta|)} .
\end{aligned}
$$

Then, to prove (3.15) it is sufficient to prove that

|g(\zeta)|^{\rho} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{3.16}
\end{equation*}
$$

1. We suppose that $|\xi-\zeta| \geq\left(\frac{d(\zeta, E)}{2}\right)^{\rho}$, we obtain

|g(\zeta)|^{\rho} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} & \leq 2 \frac{|g(\zeta)|^{\rho}}{\omega(|\xi-\zeta|)} \\
& \leq 2^{\rho+1} \eta_{\rho}^{-1}\left(\frac{|g(\zeta)|}{\omega(d(\zeta, E))}\right)^{\rho} \\
& =o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) \tag{3.17}
\end{align*}
$$

2. In this case we suppose that $|\xi-\zeta| \leq\left(\frac{d(\zeta, E)}{2}\right)^{\rho}$ and that $\zeta \notin \Gamma$. It follows $[\xi, \zeta] \subset \mathbb{T} \backslash E$. Then $z \notin \Gamma$ and $\left|z-e^{i \theta}\right| \geq \frac{1}{2}\left|\zeta-e^{i \theta}\right|$ for every $z \in[\xi, \zeta]$ and for every $e^{i \theta} \in \Gamma$. There is $z \in[\xi, \zeta]$ such that

& \leq \inf \left\{\eta_{\rho}^{-1}\left(\frac{|g(\zeta)|}{\omega(d(\zeta, E))}\right)^{\rho},\left(\frac{\omega(d(\zeta, E))}{d(\zeta, E)}\right)^{\rho} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\right\} \\
& =o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0)
\end{aligned}
$$

Therefore we obtain,

|g(\zeta)|^{\rho} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} & \leq \frac{|g(\zeta)|^{\rho}|\xi-\zeta|}{\omega(|\xi-\zeta|)} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{|\xi-\zeta|} \\
& \leq 4 \frac{|g(\zeta)|^{\rho}|\xi-\zeta|}{d^{\rho}(\zeta, E) \omega(|\xi-\zeta|)} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) . \tag{3.18}
\end{align*}
$$

2.2. Next we suppose that $a_{\Gamma}(\zeta) \geq \frac{1}{d^{\rho-1}(\zeta, E)|\xi-\zeta|^{1 / \rho}}$. Set $\lambda_{\zeta}:=1-\mid \xi-$ $\left.\zeta\right|^{1 / \rho}$. Then

& \leq \exp \left\{\frac{1}{2 \pi} \int_{\Gamma} \frac{|\xi-\zeta|^{1 / \rho}}{\left|e^{i \theta}-\lambda_{\zeta} \zeta\right|^{2}} \log \left|g\left(e^{i \theta}\right)\right| d \theta\right\} \\
& \leq \exp \left\{-\frac{1}{4}|\xi-\zeta|^{1 / \rho} a_{\Gamma}(\zeta)\right\} \\
& \leq \exp \left\{-\frac{1}{4 d^{\rho-1}(\zeta, E)}\right\}
\end{aligned}
$$

It is clear that $|g(\zeta)|^{\rho} \leq 2^{\rho-1}\left|g(\zeta)-g\left(\lambda_{\zeta} \zeta\right)\right|^{\rho}+2^{\rho-1}\left|g\left(\lambda_{\zeta} \zeta\right)\right|^{\rho}$. We obtain

& |g(\zeta)|^{\rho} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
\leq & 2^{\rho-1} \frac{\left|g(\zeta)-g\left(\lambda_{\zeta} \zeta\right)\right|^{\rho}}{\omega(|\xi-\zeta|)}\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right| \\
& +2^{\rho-1}\left|g\left(\lambda_{\zeta} \zeta\right)\right|^{\rho} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{|\xi-\zeta|} \\
\leq & 2^{\rho} \eta_{\rho}^{-1} o(1) \\
& +2^{\rho-1} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \exp \left\{-\frac{\rho}{4 d^{\rho-1}(\zeta, E)}\right\} \frac{\int_{\mathbb{T}}|\log | g\left(e^{i \theta}\right)| | d \theta}{d^{2}(\zeta, E)} \\
= & o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) . \tag{3.19}
\end{align*}
$$

2.3. Now we suppose that $\frac{1}{d^{\rho}(\zeta, E)} \leq a_{\Gamma}(\zeta) \leq \frac{1}{d^{\rho-1}(\zeta, E)|\xi-\zeta|^{1 / \rho}}$. Set $\mu_{\zeta}:=$

\frac{\omega\left(1-\mu_{\zeta}\right)}{1-\mu_{\zeta}} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\left(\frac{\omega(d(\zeta, E))}{d(\zeta, E)}\right)^{\rho-1} & \leq\left(\frac{\omega\left(1-\mu_{\zeta}\right)}{1-\mu_{\zeta}}\right)^{\rho} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \\
& \leq \eta_{\rho}^{-1}
\end{aligned}
$$

and

\frac{\omega\left(1-\mu_{\zeta}\right)}{1-\mu_{\zeta}} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \leq \eta_{\rho}^{-(1 / \rho)}\left(\frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\right)^{\frac{\rho-1}{\rho}}

& \frac{\omega\left(1-\mu_{\zeta}\right)}{1-\mu_{\zeta}} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\left(\frac{|g(\zeta)|}{d(\zeta, E)}\right)^{\rho-1} \\
\leq & \inf \left\{\eta_{\rho}^{-1}\left(\frac{|g(\zeta)|}{\omega(d(\zeta, E))}\right)^{\rho-1}, \eta_{\rho}^{-(1 / \rho)}\left(\frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\right)^{\frac{\rho-1}{\rho}}\left(\frac{|g(\zeta)|}{d(\zeta, E)}\right)^{\rho-1}\right\} \\
= & o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) .
\end{aligned}
$$

Also we have $\left|g\left(\mu_{\zeta} \zeta\right)\right| \leq \exp \left\{-\frac{1}{4 d^{\rho-1}(\zeta, E)}\right\}$. We obtain

& |g(\zeta)|^{\rho} \frac{\left|g_{\Gamma}(\xi)-g_{\Gamma}(\zeta)\right|}{\omega(|\xi-\zeta|)} \\
\leq & |g(\zeta)|^{\rho} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} a_{\Gamma}(z) \quad(z \in[\xi, \zeta]) \\
\leq & |g(\zeta)|^{\rho-1} \frac{\left|g(\zeta)-g\left(\mu_{\zeta} \zeta\right)\right||\xi-\zeta|}{\left(1-\mu_{\zeta}\right) \omega(|\xi-\zeta|)}\left(1-\mu_{\zeta}\right) a_{\Gamma}(z) \\
& +|g(\zeta)|^{\rho-1}\left|g\left(\mu_{\zeta} \zeta\right)\right| \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} a_{\Gamma}(z) \\
\leq & \frac{\omega\left(1-\mu_{\zeta}\right)}{1-\mu_{\zeta}} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\left(\frac{|g(\zeta)|}{d(\zeta, E)}\right)^{\rho-1} \\
& +\frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \exp \left\{-\frac{1}{4 d^{\rho-1}(\zeta, E)}\right\} \frac{\int_{\mathbb{T}}|\log | g\left(e^{i \theta}\right)| | d \theta}{d^{2}(\zeta, E)} \\
= & o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) . \tag{3.20}
\end{align*}

Consequently, from (3.18), (3.19) and (3.20) we obtain that if $|\xi-\zeta| \leq$ $\left(\frac{d(\zeta, E)}{2}\right)^{\rho}$ and $\zeta \notin \Gamma$, then

3. In this case we suppose that $|\xi-\zeta| \leq\left(\frac{d(\zeta, E)}{2}\right)^{\rho}$ and that $\zeta \in \Gamma$. We use the equality (3.13) to transfer this case into the case $\zeta \notin \Gamma$. Hence we use (3.21) to obtain also in this case that

\end{equation*}

Now (3.16) follows from inequalities (3.17), (3.21) and (3.22). This completes the proof of the proposition.

Proof of Theorem 2.3 : Let $\mathcal{I}$ be a closed ideal in $\Lambda_{\omega}$ and $g$ a function in $\Lambda_{\omega}$. Then $O_{g} \in \Lambda_{\omega}$ and $O_{g}^{\rho} \in \Lambda_{\omega}$, for every $\rho>1$. Suppose that $U_{g} O_{g}^{2} \in \mathcal{I}$. Then $U_{g} O_{g}^{\rho+2} \in \mathcal{I}$, for every $\rho>1$. From Proposition 3.7-1 we have $U_{g} O_{g}^{\rho} g_{\Gamma_{N}^{c}} \in \Lambda_{\omega}$, and hence, $U_{g} O_{g}^{\rho+1} g_{\Gamma_{N}^{c}} \in \Lambda_{\omega}$. It follows, by using Lemma 3.4, that $U_{g} O_{g}^{\rho+1} g_{\Gamma_{N}^{c}} \in \mathcal{I}$, for every $\rho>1$ and for every $N \in \mathbb{N}$. Hence, from Proposition 3.7-2, $U_{g} O_{g}^{\rho+1} \in \mathcal{I}$ for every $\rho>1$. Again we use Lemma 3.4 and Proposition 3.7 to deduce that $U_{g} O_{g}^{\rho} \in \mathcal{I}$ for every $\rho>1$. This infers that $g \in \mathcal{I}$.

## 4. Appendix A. An equivalent norm in $\Lambda_{\omega}$.

In this section we give a simple proof of the following Tamrazov's Theorem [11.
Theorem 4.1. 11] Let $\omega$ be any arbitrary modulus of continuity and let $f$ be a function in $\Lambda_{\omega}(\mathbb{T}) \cap \mathcal{A}(\mathbb{D})$. Then $f$ belongs to $\Lambda_{\omega}$.

We need the following key lemma.
Lemma 4.2. Let $\omega$ be any arbitrary modulus of continuity and let $f \in \Lambda_{\omega}(\mathbb{T}) \cap \mathcal{A}(\mathbb{D})$ be a function such that $\|f\|_{\Lambda_{\omega}(\mathbb{T})} \leq 1$. For every $\delta \geq 0$, we have

$$
\begin{aligned}
& \exp \left\{\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\left|f\left(e^{i \theta}\right)-f(z /|z|)\right|+\delta\right) d \theta\right\} \\
\leq & o(\omega(1-|z|))+A \delta \quad(\text { as }|z| \longrightarrow 1),
\end{aligned}
$$

where $A$ is an absolute constant.
Proof. Let $0<\varepsilon<1$ and $c_{\varepsilon}>0$ such that for any $\xi, \zeta \in \mathbb{T}$ satisfying $|\xi-\zeta| \leq c_{\varepsilon}$, we have $|f(\xi)-f(\zeta)| \leq \varepsilon \omega(|\xi-\zeta|)$. Divide $\mathbb{T}$ into the following three parts

& \Gamma_{1}:=\left\{\xi \in \mathbb{T}:|\xi-z /|z|| \leq 1-|z| \leq c_{\varepsilon}\right\} \\
& \Gamma_{2}:=\left\{\xi \in \mathbb{T}: 1-|z| \leq|\xi-z /|z|| \leq c_{\varepsilon}\right\} \\
& \Gamma_{3}:=\left\{\xi \in \mathbb{T}: c_{\varepsilon} \leq|\xi-z /|z||\right\}
\end{aligned}
$$

We have

& \frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\left|f\left(e^{i \theta}\right)-f(z /|z|)\right|+\delta\right) d \theta \\
\leq & \frac{1}{2 \pi} \int_{\Gamma_{1}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\varepsilon \omega\left(\left|e^{i \theta}-z /|z|\right|\right)+\delta\right) d \theta \\
& +\frac{1}{2 \pi} \int_{\Gamma_{2}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\varepsilon \omega\left(\left|e^{i \theta}-z /|z|\right|\right) \mid+\delta\right) d \theta \\
& +\frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\omega\left(\left|e^{i \theta}-z /|z|\right|\right)+\delta\right) d \theta \\
:= & I_{1}+I_{2}+I_{3} . \tag{4.1}
\end{align*}
$$

I_{1} \leq\left(\frac{1}{2 \pi} \int_{\Gamma_{1}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta\right) \log (\varepsilon \omega(1-|z|)+\delta) \tag{4.2}
\end{equation*}
$$

Next we have

I_{2}= & \frac{1}{2 \pi} \int_{\Gamma_{2}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\varepsilon \omega\left(\left|e^{i \theta}-z /|z|\right|\right)+\delta\right) d \theta \\
\leq & \frac{1}{2 \pi} \int_{\Gamma_{2}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\varepsilon\left|e^{i \theta}-z /|z|\right| \frac{\omega(1-|z|)}{1-|z|}+\delta\right) d \theta \\
\leq & \frac{1}{2 \pi} \int_{\Gamma_{2}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\frac{\left|e^{i \theta}-z /|z|\right|}{1-|z|}(\varepsilon \omega(1-|z|)+\delta)\right) d \theta \\
\leq & \left(\frac{1}{2 \pi} \int_{\Gamma_{2}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta\right) \log (\varepsilon \omega(1-|z|)+\delta) \\
& +c \int_{t \geq 1} \frac{\log (t)}{t^{2}} d t \tag{4.3}
\end{align*}
$$

where $c$ is an absolute constant. Let $c_{\varepsilon}^{\prime}$ be a positif number such that $c_{\varepsilon}^{\prime} \leq c_{\varepsilon}$ and for every $z \in \mathbb{D}$ satisfying $1-|z| \leq c_{\varepsilon}^{\prime}$, we have $\frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta \leq \varepsilon$. Hence, as in (4.3), we obtain

$$
\begin{align*}
I_{3}= & \frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\omega\left(\left|e^{i \theta}-z /|z|\right|\right)+\delta\right) d \theta \\
\leq & \left(\frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta\right) \log (\omega(1-|z|)+\delta)+c \int_{t \geq 1} \frac{\log (t)}{t^{2}} d t \\
= & \left(\frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta\right) \log (\varepsilon \omega(1-|z|)+\delta)+c \int_{t \geq 1} \frac{\log (t)}{t^{2}} d t \\
& +\left(\frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta\right) \log \left(\frac{\omega(1-|z|)+\delta}{\varepsilon \omega(1-|z|)+\delta}\right) \\
\leq & \left(\frac{1}{2 \pi} \int_{\Gamma_{3}} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} d \theta\right) \log (\varepsilon \omega(1-|z|)+\delta)+c \int_{t \geq 1} \frac{\log (t)}{t^{2}} d t \\
& -\varepsilon \log (\varepsilon), \tag{4.4}
\end{align*}
$$

for every $z \in \mathbb{D}$ satisfying $1-|z| \leq c_{\varepsilon}^{\prime}$. From (4.2), (4.3) and (4.4) we obtain

$$
\begin{align*}
& \exp \left\{\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\left|f\left(e^{i \theta}\right)-f(z /|z|)\right|+\delta\right) d \theta\right\} \\
\leq & A\left(\varepsilon \omega(|1-|z|)+\delta) \quad\left(z \in \mathbb{D} \text { and } 1-|z| \leq c_{\varepsilon}^{\prime}\right) .\right. \tag{4.5}
\end{align*}
$$

where $A$ is an absolute constant. This completes the proof of the lemma.

We use lemma 4.2 to prove the following one
Lemma 4.3. Let $\omega$ be any arbitrary modulus of continuity and let $f \in \Lambda_{\omega}(\mathbb{T})$. Then

|f(z)-f(\zeta)|=o(\omega(|z-\zeta|)), \quad(\text { as }|z-\zeta| \longrightarrow 0, z \in \mathbb{D} \text { and } \zeta \in \mathbb{T}) \tag{4.6}

Proof. We can suppose that $\|f\|_{\Lambda_{\omega}(\mathbb{T})} \leq 1$. Let $0<\varepsilon<1$ and $c_{\varepsilon}>0$ be a number such that for any $\xi, \zeta \in \mathbb{T}$ satisfying $|\xi-\zeta| \leq c_{\varepsilon}$, we have $|f(\xi)-f(\zeta)| \leq \varepsilon \omega(|\xi-\zeta|)$. Fix $\zeta \in \mathbb{T}$ and fix $z \in \mathbb{D}$ such that $|z-\zeta| \leq c_{\varepsilon} / 2$ and $|z| \geq 1 / 4$. We have $|z-\zeta|^{2}=$ $(1-|z|)^{2}+|z||z /|z|-\zeta|^{2} \geq \frac{1}{4}|z /|z|-\zeta|^{2}$. Hence $|z /|z|-\zeta| \leq 2|z-\zeta| \leq c_{\varepsilon}$. We obtain

\begin{aligned}
& |f(z)-f(\zeta)| \\
\leq & |f(z)-f(z /|z|)|+|f(z /|z|)-f(\zeta)| \\
\leq & |f(z)-f(z /|z|)|+\varepsilon \omega(|z /|z|-\zeta|) \\
\leq & \exp \left\{\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\left|f\left(e^{i \theta}\right)-f(z /|z|)\right|\right) d \theta\right\}+2 \varepsilon \omega(|z-\zeta|)
\end{aligned}
$$

Now, we use Lemma 4.2 to deduce the result of the lemma.

Proof of Theorem 4.1: Let $0<\varepsilon<1$. From Lemma 4.3 there is $0<c_{\varepsilon}<1 / 2$ such that for every $z \in \overline{\mathbb{D}}$ and for every $\zeta \in \mathbb{T}$ satisfying $|z-\zeta| \leq c_{\varepsilon}$ we have $|f(z)-f(\zeta)| \leq \varepsilon \omega(|z-\zeta|)$. Let $z, w \in \mathbb{D}$ satisfying $|z-w| \leq c_{\varepsilon} / 2$ and $\inf \{|z|,|w|\}=$ $|w| \geq 1-c_{\varepsilon}$. It follows that $|z /|z|-w /|w|| \leq|z w|^{-1 / 2}|z-w| \leq 2|z-w| \leq c_{\varepsilon}$.

1. First we assume that $|z-w| \geq 1-|w|$. We obtain

\leq & |f(z)-f(z /|z|)|+|f(z /|z|)-f(w /|w|)|+|f(w)-f(w /|w|)| \\
\leq & 4 \varepsilon \omega(|z-w|) \tag{4.7}
\end{align*}

2. Now we suppose that $|z-w| \leq 1-|w|$. We apply the maximum principle theorem in $\mathbb{D}$ to the analytic function $z \mapsto \frac{f(z)-f(w)}{z-w}$, we get $\left|\frac{f(z)-f(w)}{z-w}\right| \leq \sup _{\xi \in \mathbb{T}}\left|\frac{f(\xi)-f(w)}{\xi-w}\right|=\frac{\left|f\left(\xi_{w}\right)-f(w)\right|}{\left|\xi_{w}-w\right|} \quad\left(\xi_{w} \in \mathbb{T}\right)$.
2.1. If $\left|\xi_{w}-w\right| \geq c_{\varepsilon}$, then

\begin{align*}
\frac{|f(z)-f(w)|}{\omega(|z-w|)} & =\left|\frac{f(z)-f(w)}{z-w}\right| \frac{|z-w|}{\omega(|z-w|)} \\
& \leq 2 \frac{\|f\|_{\infty}}{c_{\varepsilon}} \frac{|z-w|}{\omega(|z-w|)} \\
& =o(1) \quad(\text { as }|z-w| \longrightarrow 0) \tag{4.8}
\end{align*}
$$

2.2. If $\left|\xi_{w}-w\right| \leq c_{\varepsilon}$, then $\left|f\left(\xi_{w}\right)-f(w)\right| \leq \varepsilon \omega\left(\left|\xi_{w}-w\right|\right)$. It follows that

$$
\begin{align*}
\frac{|f(z)-f(w)|}{\omega(|z-w|)} & =\left|\frac{f(z)-f(w)}{z-w}\right| \frac{|z-w|}{\omega(|z-w|)} \\
& \leq\left|\frac{f\left(\xi_{w}\right)-f(w)}{\xi_{w}-w}\right| \frac{1-|w|}{\omega(1-|w|)} \quad\left(\xi_{w} \in \mathbb{T}\right) \\
& \leq \varepsilon \frac{\omega\left(\left|\xi_{w}-w\right|\right)}{\left|\xi_{w}-w\right|} \frac{1-|w|}{\omega(1-|w|)} \\
& \leq \varepsilon . \tag{4.9}
\end{align*}
$$

From inequalities (4.7), (4.8) and (4.9), there is $c_{\varepsilon}^{\prime}>0$ such that if $|z-w| \leq c_{\varepsilon}^{\prime}$ and $\inf \{|z|,|w|\} \geq 1-c_{\varepsilon}^{\prime}$, then

\begin{equation*}
\frac{|f(z)-f(w)|}{\omega(|z-w|)} \leq \varepsilon \tag{4.10}
\end{equation*}
$$

3. If $z, w \in \mathbb{D}$ are such that $\sup \{|z|,|w|\} \leq 1-c_{\varepsilon}^{\prime}$ we have

$$
\begin{align*}
\frac{|f(z)-f(w)|}{\omega(|z-w|)} & =\left|\frac{f(z)-f(w)}{z-w}\right| \frac{|z-w|}{\omega(|z-w|)} \\
& \leq \sup _{|\zeta| \leq 1-c_{\varepsilon}^{\prime}}\left|f^{\prime}(\zeta)\right| \frac{|z-w|}{\omega(|z-w|)} \\
& =o(1) \quad(\text { as }|z-w| \longrightarrow 0) \tag{4.11}
\end{align*}
$$

From (4.10) and (4.11) we deduce the result. The proof of the theorem is completed.

## 5. Appendix B. Factorization property in $\Lambda_{\omega}$.

The F-property of $\Lambda_{\omega}$, for any arbitrary modulus of continuity $\omega$, is given by Shirokov [10]. For completeness we give here the proof

Theorem 5.1. [10] Let $\omega$ be any arbitrary modulus of continuity. Let $f$ be a function in $\Lambda_{\omega}$ and let $U$ be inner function such that $f / U \in \mathcal{H}^{\infty}(\mathbb{D})$. Then $f / U \in \Lambda_{\omega}$ and

$$
\frac{|f / U(z)-f / U(w)|}{\omega(|z-w|)}=o(1) \quad(\text { as }|z-w| \longrightarrow 0)
$$

uniformly with respect to $U$. Also $\|f / U\|_{\omega} \leq c\|f\|_{\omega}$, where $c$ is an absolute constant.
Corollary 5.2. Let $\omega$ be any arbitrary modulus of continuity. Let $f$ and $g$ be functions in $\Lambda_{\omega}$ and let $\left\{U_{n}\right\}_{n \in \mathbb{N}}$ be sequence of inner functions such that $f / U_{n} \in$ $\mathcal{H}^{\infty}(\mathbb{D})$ for every $n \in \mathbb{N}$. If $\lim _{n \rightarrow+\infty}\left\|f / U_{n}-g\right\|_{\infty}=0$, then $\lim _{n \rightarrow+\infty}\left\|f / U_{n}-g\right\|_{\omega}=0$.
Proof. The proof immediately follows from Theorem 5.1 and Lemma 3.1,
We begin the proof of Theorem 5.1 by establishing several lemmas.
Lemma 5.3. Let $\omega$ be any arbitrary modulus of continuity. Let $f$ be a function in $\Lambda_{\omega}$. Then

\left|O_{f}(z)\right| \leq o(\omega(1-|z|))+A|f(z /|z|)| \quad(\text { as }|z| \longrightarrow 1)
$$

where $A>0$ is an absolute constant.
Proof. For $z \in \mathbb{D}$, we have

& \log \left|O_{f}(z)\right| \\
= & \frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left|f\left(e^{i \theta}\right)\right| d \theta \\
\leq & \frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{1-|z|^{2}}{\left|e^{i \theta}-z\right|^{2}} \log \left(\left|f\left(e^{i \theta}\right)-f(z /|z|)\right|+|f(z /|z|)|\right) d \theta
\end{aligned}
$$

Now, we use Lemma 4.2 to complete the proof of the lemma.
For a function $f \in \mathcal{H}^{\infty}(\mathbb{D})$ we set

$$
a_{f}(\xi):=\sum_{n \geq 0} \frac{1-\left|a_{n}\right|^{2}}{\left|\xi-a_{n}\right|^{2}}+\frac{1}{\pi} \int_{\mathbb{T}} \frac{1}{\left|e^{i \theta}-\xi\right|^{2}} d \mu_{f}(\theta)
$$

where $\left\{a_{n}: n \in \mathbb{N}\right\}=Z_{f} \cap \mathbb{D}$ (for all $n, a_{n}$ is repeated according to it's multiplicity) and $\mu_{f}$ is the positive singular measure associated to the singular factor $S_{f}$ of $f$.
Lemma 5.4. Let $f$ be a function in the disk algebra with inner factor $U_{f} \not \equiv 1$. Let $\xi \in \mathbb{T} \backslash E_{f}$ and let $0<\rho<1$ be such that $1-\rho \leq d\left(\xi, Z_{f}\right)$. Then

\left|U_{f}(\rho \xi)\right| \leq \exp \left\{-\frac{1-\rho}{8} a_{f}(\xi)\right\}
$$

Proof. We have

\begin{align*}
\log \left|S_{f}(\rho \xi)\right| & =-\frac{1}{2 \pi} \int_{\mathbb{T}} \frac{1-|\rho \xi|^{2}}{\left|e^{i \theta}-\rho \xi\right|^{2}} d \mu_{f}(\theta) \\
& \leq-\frac{1}{2 \pi} \int_{\mathbb{T}} \frac{1}{4} \frac{1-\rho}{\left|e^{i \theta}-\xi\right|^{2}} d \mu_{f}(\theta) \\
& =-\frac{1-\rho}{8} \frac{1}{\pi} \int_{\mathbb{T}} \frac{1}{\left|e^{i \theta}-\xi\right|^{2}} d \mu_{f}(\theta) \tag{5.1}
\end{align*}
$$

It is clear that

$$
|z-w|^{2}=\left\|z \left|-\left|w \left\|^{2}+|z|\left|w\|z /|z|-w / \mid w\|^{2} \quad(z, w \in \mathbb{D}) .\right.\right.\right.\right.\right.
$$

Now we estimate $\left|B_{f}(\rho \xi)\right|$. For all $n \in \mathbb{N}$, we have

$$
\begin{aligned}
\left|\frac{\rho \xi-a_{n}}{\xi-\rho a_{n}}\right|^{2} & =\frac{\left(\rho-\left|a_{n}\right|\right)^{2}+\rho\left|a_{n}\right|\left|\xi-a_{n} /\left|a_{n}\right|^{2}\right.}{\left(1-\rho\left|a_{n}\right|\right)^{2}+\rho\left|a_{n}\right|\left|\xi-a_{n} /\left|a_{n}\right|^{2}\right.} \\
& =1-\left(1-\rho^{2}\right) \frac{1-\left|a_{n}\right|^{2}}{\left|\xi-\rho a_{n}\right|^{2}} \\
& \leq 1-\frac{1-\rho}{4} \frac{1-\left|a_{n}\right|^{2}}{\left|\xi-a_{n}\right|^{2}}
\end{aligned}
$$

Hence

$$
\log \left|\frac{\rho \xi-a_{n}}{\xi-\rho a_{n}}\right| \leq-\frac{1-\rho}{8} \frac{1-\left|a_{n}\right|^{2}}{\left|\xi-a_{n}\right|^{2}}
$$

Therefore

$$
\begin{equation*}
\left|B_{f}(\rho \xi)\right| \leq \exp \left\{-\frac{1-\rho}{8} \sum_{n \geq 0} \frac{1-\left|a_{n}\right|^{2}}{\left|\xi-a_{n}\right|^{2}}\right\} \tag{5.2}
\end{equation*}
$$

From (5.1) and (5.2) we obtain

\left|U_{f}(\rho \xi)\right| \leq \exp \left\{-\frac{1-\rho}{8} a_{f}(\xi)\right\}
$$

This proves the lemma.
Lemma 5.5. Let $f$ be a function in $\Lambda_{\omega}$ and let $U$ be an inner function such that $f / U \in \mathcal{H}^{\infty}(\mathbb{D})$. Then

|f(\zeta)|=o\left(\omega\left(\frac{1}{a_{U}(\zeta)}\right)\right) \quad\left(\text { asd } d\left(\zeta, Z_{f}\right) \longrightarrow 0, \zeta \in \mathbb{T} \backslash E_{f}\right)
$$

Proof. Let $\varepsilon>0$. There is $c_{\varepsilon}>0$ such that if $|z-w| \leq c_{\varepsilon}, z, w \in \mathbb{T}$, then we have $|f(z)-f(w)| \leq \varepsilon \omega(|z-w|)$. From Lemma 5.3, there is $0<c_{\varepsilon}^{\prime}<c_{\varepsilon}$ such that if $1-\rho \leq c_{\varepsilon}^{\prime}$, then $\left|O_{f}(\rho \zeta)\right| \leq A(\varepsilon \omega(1-\rho)+|f(\zeta)|)$, where $A \geq 1$ is an absolute constant. Let $\zeta \in \mathbb{T} \backslash E_{f}$ such that $d\left(\zeta, Z_{f}\right) \leq c_{\varepsilon}^{\prime}$.

1. We assume that $a_{U}(\zeta) \leq \frac{8 A}{d\left(\zeta, Z_{f}\right)}$. Then we obtain $|f(\zeta)| \leq \varepsilon \omega\left(d\left(\zeta, Z_{f}\right)\right) \leq$

\varepsilon \omega\left(\frac{8 A}{a_{U}(\zeta)}\right) \leq 8 A \varepsilon \omega\left(\frac{1}{a_{U}(\zeta)}\right)
$$

2. Now assume that $a_{U}(\zeta) \geq \frac{8 A}{d\left(\zeta, Z_{f}\right)}$. Then $1-\rho_{\zeta} \leq d\left(\zeta, Z_{f}\right)$, where $\rho_{\zeta}:=$ $1-\frac{8 A}{a_{U}(\zeta)}$. We have $U_{f} / U \in \mathcal{H}^{\infty}(\mathbb{D})$, then $a_{U}(\zeta) \leq a_{f}(\zeta)$ and by using Lemma 5.4 we obtain
$\left|U_{f}\left(\rho_{\zeta} \zeta\right)\right| \leq \exp \left\{-\frac{1-\rho_{\zeta}}{8} a_{f}(\zeta)\right\} \leq \exp \left\{-\frac{1-\rho_{\zeta}}{8} a_{U}(\zeta)\right\}=\exp \{-A\}$.
Since $d\left(\zeta, Z_{f}\right) \leq c_{\varepsilon}^{\prime}$, then $1-\rho_{\zeta} \leq c_{\varepsilon}^{\prime}$ and we have

|f(\zeta)| & \leq\left|f(\zeta)-f\left(\rho_{\zeta} \zeta\right)\right|+\left|f\left(\rho_{\zeta} \zeta\right)\right| \\
& \leq \varepsilon \omega\left(1-\rho_{\zeta}\right)+A \exp \{-A\}\left(\varepsilon \omega\left(1-\rho_{\zeta}\right)+|f(\zeta)|\right)

It follows that $|f(\zeta)| \leq 3 \varepsilon \omega\left(1-\rho_{\zeta}\right) \leq 24 A \varepsilon \omega\left(\frac{1}{a_{U}(\zeta)}\right)$. This completes the proof of the lemma.

Now, we can deduce the proof of Theorem 5.1 by using Lemma 5.5. Indeed, from Theorem 4.1 it is sufficient to prove that $f / U \in \Lambda_{\omega}(\mathbb{T})$, that is

\frac{|f(\xi) / U(\xi)-f(\zeta) / U(\zeta)|}{\omega(|\xi-\zeta|)} \leq \frac{|f(\xi)-f(\zeta)|}{\omega(|\xi-\zeta|)}+|f(\zeta)| \frac{|U(\xi)-U(\zeta)|}{\omega(|\xi-\zeta|)}
$$

Then it suffices to prove

\begin{equation*}
|f(\zeta)| \frac{|U(\xi)-U(\zeta)|}{\omega(|\xi-\zeta|)}=o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{5.3}
\end{equation*}
$$

1. First we suppose that $|\xi-\zeta| \geq \frac{1}{2} d\left(\zeta, Z_{f}\right)$. Then

\begin{align*}
|f(\zeta)| \frac{|U(\xi)-U(\zeta)|}{\omega(|\xi-\zeta|)} & \leq 2 \frac{|f(\zeta)|}{\omega\left(\frac{1}{2} d\left(\zeta, Z_{f}\right)\right)} \\
& \leq 4 \frac{|f(\zeta)|}{\omega\left(d\left(\zeta, Z_{f}\right)\right)} \\
& =o(1) \quad(\text { as }|\xi-\zeta| \longrightarrow 0) \tag{5.4}
\end{align*}
$$

2. Next we suppose that $|\xi-\zeta| \leq \frac{1}{2} d\left(\zeta, Z_{f}\right)$. Then $[\xi, \zeta] \subset T \backslash E_{f}$. There is $z \in$

& {[\xi, \zeta] \text { such that } \frac{|U(\xi)-U(\zeta)|}{|\xi-\zeta|}=\left|U^{\prime}(z)\right| \leq \sum_{n \geq 0} \frac{1-\left|a_{n}\right|^{2}}{\left|z-a_{n}\right|^{2}}+\frac{1}{\pi} \int_{\mathbb{T}} \frac{1}{\left|e^{i \theta}-z\right|^{2}} d \mu_{f}(\theta):=} \\
& a_{U}(z) \leq 4 a_{U}(\zeta) \leq \frac{c_{f}}{d^{2}\left(\zeta, Z_{f}\right)}
\end{aligned}
$$

2.1. If $a_{U}(\zeta) \leq \frac{1}{|\xi-\zeta|}$. Then, by using Lemma 5.5, we deduce that

|f(\zeta)| a_{U}(\zeta) \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}=o(1) \quad\left(\text { as } d\left(\zeta, Z_{f}\right) \longrightarrow 0\right)
$$

Therefore

& |f(\zeta)| \frac{|U(\xi)-U(\zeta)|}{\omega(|\xi-\zeta|)} \\
\leq & 4|f(\zeta)| a_{U}(\zeta) \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)} \\
\leq & \inf \left\{4|f(\zeta)| a_{U}(\zeta) \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}, \frac{c_{f}\|f\|_{\infty}}{d^{2}\left(\zeta, Z_{f}\right)} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\right\} \\
= & o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) . \tag{5.5}
\end{align*}
$$

2.2. Now assume that $a_{U}(\zeta) \geq \frac{1}{|\xi-\zeta|}$. Then, by Lemma [5.5, we obtain $|f(\zeta)|=o(\omega(|\xi-\zeta|))$, as $d\left(\zeta, Z_{f}\right) \longrightarrow 0$. Therefore

\begin{align*}
|f(\zeta)| \frac{|U(\xi)-U(\zeta)|}{\omega(|\xi-\zeta|)} & \leq \inf \left\{2 \frac{|f(\zeta)|}{\omega(|\xi-\zeta|)}, \frac{c_{f}\|f\|_{\infty}}{d^{2}\left(\zeta, Z_{f}\right)} \frac{|\xi-\zeta|}{\omega(|\xi-\zeta|)}\right\} \\
& =o(1) \quad(\operatorname{as}|\xi-\zeta| \longrightarrow 0) \tag{5.6}
\end{align*}
$$

Consequently (5.3) follows from inequalities (5.4), (5.5) and (5.6). The proof of the theorem is completed.
