HARDY'S UNCERTAINTY PRINCIPLE, CONVEXITY AND SCHRÖDINGER EVOLUTIONS

ABSTRACT. We prove the logarithmic convexity of certain quantities, which measure the quadratic exponential decay at infinity and within two characteristic hyperplanes of solutions of Schrödinger evolutions. As a consequence we obtain some uniqueness results that generalize (a weak form of) Hardy's version of the uncertainty principle. We also obtain corresponding results for heat evolutions.

1. INTRODUCTION

In this paper we continue the study initiated in [11] and [2] on unique continuation properties of solutions of Schrödinger evolutions

(1.1)
$$i\partial_t u + \Delta u = V(x,t)u$$
, in $\mathbb{R}^n \times [0,1]$.

The goal is to obtain sufficient conditions on a solution u, the potential V and the behavior of the solution at two different times, $t_0 = 0$ and $t_1 = 1$, which guarantee that $u \equiv 0$ in $\mathbb{R}^n \times [0, 1]$.

One of our motivations comes from a well known result due to G. H. Hardy [16, pp. 131] (see also [1] for a recent survey on this topic), which concerns the decay of a function f and its Fourier transform,

$$\hat{f}(\xi) = (2\pi)^{-\frac{n}{2}} \int_{\mathbb{R}^n} e^{-i\xi \cdot x} f(x) \, dx,$$

If $f(x) = O(e^{-|x|^2/\beta^2})$, $\hat{f}(\xi) = O(e^{-4|\xi|^2/\alpha^2})$ and $\alpha\beta < 4$, then $f \equiv 0$. Also, if $\alpha\beta = 4$, f is a constant multiple of $e^{-|x|^2/\beta^2}$,

This result can be rewritten in terms of the free solution of the Schrödinger equation in $\mathbb{R}^n \times (0, +\infty)$, $i\partial_t u + \Delta u = 0$, with initial data f,

$$u(x,t) = (4\pi i t)^{-\frac{n}{2}} \int_{\mathbb{R}^n} e^{\frac{i|x-y|^2}{4t}} f(y) \, dy = (2\pi i t)^{-\frac{n}{2}} e^{\frac{i|x|^2}{4t}} \widehat{e^{\frac{i|\cdot|^2}{4t}}} f\left(\frac{x}{2t}\right)$$

in the following way:

If $u(x,0) = O(e^{-|x|^2/\beta^2})$, $u(x,T) = O(e^{-|x|^2/\alpha^2})$ and $\alpha\beta < 4T$, then $u \equiv 0$. Also, if $\alpha\beta = 4T$, u has as initial data a constant multiple of $e^{-(1/\beta^2 + i/4T)|y|^2}$.

The corresponding result in terms of L^2 -norms and established in [15] is the following:

If
$$e^{|x|^2/\beta^2}f$$
, $e^{4|\xi|^2/\alpha^2}\hat{f}$ are in $L^2(\mathbb{R}^n)$ and $\alpha\beta \leq 4$, then $f \equiv 0$.

If
$$e^{|x|^2/\beta^2}u(x,0)$$
, $e^{|\xi|^2/\alpha^2}u(x,T)$ are in $L^2(\mathbb{R}^n)$ and $\alpha\beta \leq 4T$, then $u \equiv 0$.

In our previous paper [2] we proved a uniqueness result in this direction for potentials which satisfy

(1.2)
$$\lim_{R \to +\infty} \int_0^1 \|V(t)\|_{L^{\infty}(\mathbb{R}^n \setminus B_R)} dt = 0.$$

More precisely, we prove that the only solution to (1.1) in $C([0,1], H^2(\mathbb{R}^n))$, which verifies that it and its gradient decay faster than any quadratic exponential at times 0 and 1 is the zero solution, when V is bounded in $\mathbb{R}^n \times [0,1]$, (1.2) holds and $\nabla_x V$ is in $L_t^1 L_x^\infty(\mathbb{R}^n \times [0,1])$. This linear result was then applied to show that two regular solutions u_1 and u_2 of non-linear equations of the type

(1.3)
$$i\partial_t u + \Delta u = F(u, \overline{u}), \text{ in } \mathbb{R}^n \times [0, 1]$$

and for very general non-linearities F, must agree in $\mathbb{R}^n \times [0, 1]$, when $u_1 - u_2$ and its gradient decay faster than any quadratic exponential at times 0 and 1. This replaced the assumption that the solutions coincide on large sub-domains of \mathbb{R}^n at two different times, which was previously studied in [11, 7] and showed that weaker variants of Hardy's Theorem hold even in the context of non-linear Schrödinger evolutions.

Our main result in this paper is the following one.

Theorem 1. Assume that u in $C([0,1]), L^2(\mathbb{R}^n)$ verifies

$$\partial_t u = i \left(\bigtriangleup u + V(x, t) u \right), \text{ in } \mathbb{R}^n \times [0, 1],$$

 α and β are positive, $\alpha\beta < 2$, $\|e^{\frac{\|x\|^2}{\beta^2}}u(0)\|_{L^2(\mathbb{R}^n)}$ and $\|e^{\frac{\|x\|^2}{\alpha^2}}u(1)\|_{L^2(\mathbb{R}^n)}$ are both finite, the potential V is bounded and either, $V(x,t) = V_1(x) + V_2(x,t)$, with V_1 real-valued and

$$\sup_{[0,1]} \|e^{\frac{|x|^2}{(\alpha t + \beta(1-t))^2}} V_2(t)\|_{L^{\infty}(\mathbb{R}^n)} < +\infty$$

or $\lim_{R \to +\infty} \|V\|_{L^1([0,1],L^\infty(\mathbb{R}^n \setminus B_R))} = 0$. Then, $u \equiv 0$.

As a direct consequence of Theorem 1 we get the following straightforward result concerning the uniqueness of solutions for non-linear equations of the form (1.3).

Theorem 2. Let u_1 and u_2 be $C([0,1], H^k(\mathbb{R}^n))$ strong solutions of the equation (1.3) with $k \in \mathbb{Z}^+$, k > n/2, $F : \mathbb{C}^2 \to \mathbb{C}$, $F \in C^k$ and $F(0) = \partial_u F(0) = \partial_{\bar{u}} F(0) = 0$. If there are α and β positive with $\alpha\beta < 2$ such that

$$e^{\frac{|x|^2}{\beta^2}}(u_1(0)-u_2(0))$$
 and $e^{\frac{|x|^2}{\alpha^2}}(u_1(1)-u_2(1))$

are in $L^2(\mathbb{R}^n)$, then $u_1 \equiv u_2$.

Notice that the condition, $\alpha\beta < 2$, is independent of the size of the potential or the dimension and that we do not assume any decay of the gradient neither of the solutions or of time-independent potentials or any regularity of the potentials.

Our improvement for the results of [2] comes from a better understanding of the solutions to (1.1), which have a Gaussian decay. We started the study of this particular type of solutions in our recent work [3], where we consider free waves (i.e. V(x,t) = 0 in (1.1)) and among other results we proved the following:

Assume that u in $C([0,1], L^2(\mathbb{R}^n))$ is a solution of

$$\partial_t u - i \Delta u = 0$$
, in $\mathbb{R}^n \times [0, 1]$,

and that $||e^{\gamma|x|^2}u(0)||$, $||e^{\gamma|x|^2}u(1)||$ are both finite. Set $f = e^{\gamma|x|^2}u$ and H(t) = (f, f). Then, $\log H(t)$ is a convex function.

The proof of Theorem 1 relies first on extending the above convexity properties to the non-free case, and secondly on a modification of the definition of the function H as follows: for $e_1 = (1, 0, ..., 0)$ and R > 0 set

(1.4)
$$f = e^{\mu |x + Re_1 t(1-t)|^2} u,$$

when $0 < \mu < \gamma$ and H(t) = (f, f). Then it is easy to prove at a formal level that

$$\partial_t^2 \log H(t) \ge -\frac{R^2}{4\mu}.$$

Therefore $H(t)e^{-\frac{R^2t(1-t)}{8\mu}}$ is logarithmically convex in [0,1] and

$$H(t) \le H(0)^{1-t} H(1)^t e^{\frac{R^2 t(1-t)}{8\mu}}.$$

Taking $t = \frac{1}{2}$ and letting μ increase towards γ , we have

$$\int e^{2\gamma|x+\frac{Re_1}{4}|^2} |u(\frac{1}{2})|^2 \, dx \le \|e^{\gamma|x|^2} u(0)\| \|e^{\gamma|x|^2} u(1)\| e^{\frac{R^2}{32\gamma}}.$$

Thus,

$$\int_{B_{\frac{\epsilon R}{4}}} |u(\frac{1}{2})|^2 \, dx \le \|e^{\gamma|x|^2} u(0)\| \|e^{\gamma|x|^2} u(1)\| e^{\frac{R^2 \left(1 - 4\gamma^2 (1 - \epsilon)^2\right)}{32\gamma}},$$

when $0 < \epsilon < 1$, which implies that $u \equiv 0$ by letting R tend to infinity, when $\gamma > \frac{1}{2}$.

The path that goes from the formal level to a rigorous one is not an easy one. In fact in section 6 we will give explicit examples of functions H(t) such that log H is formally convex and however the corresponding inequalities lead to false statements. Therefore most of this paper is devoted to make rigorous the above argument. The starting point is to prove similar properties to those obtained in [4] for free solutions. One of the results we get is the following one.

Theorem 3. Assume that u in $C([0,1]), L^2(\mathbb{R}^n)$ verifies

$$\partial_t u = i \left(\triangle u + V(x, t)u \right), \text{ in } \mathbb{R}^n \times [0, 1],$$

 $V = V_1(x) + V_2(x,t)$, V_1 is real-valued, $||V_1||_{\infty} \leq M_1$ and that there are positive numbers α and β such that

$$\|e^{\frac{\|x\|^2}{\beta^2}}u(0)\|$$
, $\|e^{\frac{\|x\|^2}{\alpha^2}}u(1)\|$ and $\sup_{[0,1]}\|e^{\frac{\|x\|^2}{(\alpha t+(1-t)\beta)^2}}V_2(t)\|_{\infty} < +\infty.$

Then, $\|e^{\frac{|x|^2}{(\alpha t+(1-t)\beta)^2}}u(t)\|^{\alpha t+(1-t)\beta}$ is "logarithmically convex" in [0,1] and there is $N = N(\alpha, \beta)$ such that

$$\|e^{\frac{|x|^2}{(\alpha t+(1-t)\beta)^2}}u(t)\| \le e^{N\left(M_1+M_2+M_1^2+M_2^2\right)} \|e^{\frac{|x|^2}{\beta^2}}u(0)\|^{\frac{\beta(1-t)}{\alpha t+\beta(1-t)}} \|e^{\frac{|x|^2}{\alpha^2}}u(1)\|^{\frac{\alpha t}{\alpha t+\beta(1-t)}},$$

when $0 \leq s \leq 1$ and $M_2 = \sup_{[0,1]} \|e^{\frac{|x|^2}{(\alpha t + \beta(1-t))^2}} V_2(t)\|_{\infty} e^{2\sup_{[0,1]} \|\Im V_2(t)\|_{\infty}}$. Moreover,

$$\begin{aligned} \|\sqrt{t(1-t)} e^{\frac{|x|^2}{(\alpha t+(1-t)\beta)^2}} \nabla u\|_{L^2(\mathbb{R}^n \times [0,1])} \\ &\leq N e^{N\left(M_1+M_2+M_1^2+M_2^2\right)} \left[\|e^{\frac{|x|^2}{\beta^2}} u(0)\| + \|e^{\frac{|x|^2}{\alpha^2}} u(1)\| \right]. \end{aligned}$$

In order to prove this theorem we have to approximate the solution using some artificial diffusion. The corresponding results are interesting in themselves and can be found in section 2. As a byproduct we get examples of solutions to (1.1) which have Gaussian decay, when the potential V is time independent. It is enough to consider as initial data the solution, at say time one, of the corresponding heat equation that at time zero is a Gaussian. This property was already established in [4] for free solutions, and it turned out to be a characterization of those Gaussian solutions. It would be interesting to prove similar characterizations for variable coefficient Hamiltonians. Also in section 2 we give an abstract result, Lemma 2, that shows how to get logarithmic convexity properties from the positivity of some specific commutators. It turns out that these commutators are the same as the ones that appear in the proof of the L^2 -Carleman estimates we used in our previous paper [2]. In fact, the weight $\mu |x + Re_1t(1-t)|^2$ that appears in (1.4) is a refinement of the ones used in [2].

We are indebted to E. Zuazua for pointing out the following application of Hardy's uncertainty principle to prove the following optimal decay result for solutions of the free heat equation (See also [10, Section 5]):

If f and
$$e^{\frac{|x|}{\delta^2}}e^{\Delta}f$$
 are in $L^2(\mathbb{R}^n)$ for some $\delta \leq 2$. Then, $f \equiv 0$.

In fact, applying Hardy's uncertainty principle to $e^{\triangle}f$, $e^{\frac{|x|^2}{\delta^2}}e^{\triangle}f$ and $e^{\frac{4|\xi|^2}{2^2}}\widehat{e^{\triangle}f} = \widehat{f}$ would be in $L^2(\mathbb{R}^n)$, and $2\delta \leq 4$ implies $e^{\triangle}f \equiv 0$. Then, backward uniqueness arguments, see for instance [13, Chapter 3, Theorem 11] or [5, Chapter 3], show that $f \equiv 0$. Here, we prove the following weaker extension of this result for parabolic operators with variable coefficientes.

Theorem 4. Let u in $L^{\infty}([0,1]), L^{2}(\mathbb{R}^{n})) \cap L^{2}([0,T], H^{1}(\mathbb{R}^{n}))$ verify

$$\begin{cases} \partial_t u = \Delta u + V(x,t)u, \text{ in } \mathbb{R}^n \times (0,1], \\ u(0) = f, \end{cases}$$

where V is bounded in $\mathbb{R}^n \times [0,1]$ and assume that f and $e^{\frac{|x|^2}{\delta^2}}u(1)$ are in $L^2(\mathbb{R}^n)$ for some $\delta < 1$. Then, $f \equiv 0$ in \mathbb{R}^n .

It is natural to expect that the Hardy uncertainty principle holds on Schrödinger and heat evolutions with bounded potentials and with parameters α , β or δ verifing the condition of the free case.

In the sketch of the proof of Theorem 1 that we have done above we have assumed that $\alpha = \beta$. That one can easily reduce to this case is proved in section 3 using the so called conformal transformation or Appell transform. In section 4 we prove Theorem 3, in section 5 we give the proof of Theorem 1, in section 6 we give some examples of some misleading convex functions and in section 7 we prove Theorem 4.

2. A Few Lemmas

In the sequel

$$(f,g) = \int_{\mathbb{R}^n} f\overline{g} \, dx \, , \, \|f\|^2 = (f,f) \, , \, f^+ = \max\left\{f,0\right\}$$

and $||f||_{\infty}$ denotes the L^{∞} -norm of f over \mathbb{R}^n .

Lemma 1. Assume that u in $L^{\infty}([0,1], L^2(\mathbb{R}^n)) \cap L^2([0,1]), H^1(\mathbb{R}^n))$ satisfies $\partial_t u = (A+iB)(\wedge u + V(x,t)u + F(x,t))$ in $\mathbb{R}^n \times (0,1]$

$$p_t u = (A + iB) \left(\bigtriangleup u + V \left(x, t \right) u + F \left(x, t \right) \right), \text{ in } \mathbb{R}^n \times (0, 1],$$

A > 0 and $B \in \mathbb{R}$. Then,

$$e^{-M_T} \| e^{\frac{\gamma A|x|^2}{A+4\gamma (A^2+B^2)T}} u(T) \| \\ \leq \| e^{\gamma |x|^2} u(0) \| + \sqrt{A^2 + B^2} \| e^{\frac{\gamma A|x|^2}{A+4\gamma (A^2+B^2)t}} F(t) \|_{L^1([0,T], L^2(\mathbb{R}^n))}$$

when $\gamma \ge 0, \ 0 \le T \le 1$ and $M_T = \|A(ReV)^+ - BImV\|_{L^1([0,T],L^\infty(\mathbb{R}^n))}$.

Proof. Write $v = e^{\varphi}u$, where φ is a real-valued function to be chosen later. The function v verifies

$$\partial_t v = \mathbb{S}v + \mathcal{A}v + (A + iB) e^{\varphi} F$$
, in $\mathbb{R}^n \times (0, 1]$,

where the symmetric and skew-symmetric operators S and A are given by

$$\begin{split} & \mathcal{S} = A\left(\triangle + |\nabla\varphi|^2\right) - iB\left(2\nabla\varphi\cdot\nabla + \triangle\varphi\right) + \left(\partial_t\varphi + AReV - BImV\right) \\ & \mathcal{A} = iB\left(\triangle + |\nabla\varphi|^2\right) - A\left(2\nabla\varphi\cdot\nabla + \triangle\varphi\right) + i\left(BReV + AImV\right) \;. \end{split}$$

To prove Lemma 1 we use the energy method and try to keep track of the decay of the $L^2(\mathbb{R}^n)$ -norm of v. Formally,

$$\partial_t \|v\|^2 = 2Re \left(\mathbb{S}v, v \right) + 2Re \left((A + iB) e^{\varphi} F, v \right) \;,$$

when $t \ge 0$. Again, a formal integration by parts gives that

(2.1)
$$Re(Sv, v) = -A \int_{\mathbb{R}^n} |\nabla v|^2 dx + \int_{\mathbb{R}^n} \left(A |\nabla \varphi|^2 + \partial_t \varphi \right) |v|^2 dx + 2B \operatorname{Im} \int_{\mathbb{R}^n} \overline{v} \nabla \varphi \cdot \nabla v \, dx + \int_{\mathbb{R}^n} \left(A Re \, V - B Im \, V \right) |v|^2 dx$$

and the Cauchy-Schwarz's inequality implies that

$$\begin{aligned} \partial_t \|v(t)\|^2 &\leq 2 \|A \left(Re V(t) \right)^+ - BIm V(t)\|_{\infty} \|v(t)\|^2 \\ &+ 2\sqrt{A^2 + B^2} \|e^{\varphi} F(t)\| \|v(t)\| , \end{aligned}$$

when

(2.2)
$$\left(A + \frac{B^2}{A}\right) |\nabla \varphi|^2 + \partial_t \varphi \le 0, \text{ in } \mathbb{R}^{n+1}_+.$$

When $\varphi(x,t) = a(t)\phi(x)$, it suffices that

$$a^{2}(t)\left(A+\frac{B^{2}}{A}\right)|\nabla\phi(x)|^{2}+a'(t)\phi(x)\leq0.$$

At the end we shall require that $\phi(x) = |x|^2$. In that case the latter holds, when

(2.3)
$$\begin{cases} a'(t) = -4\left(A + \frac{B^2}{A}\right)a^2(t), \\ a(0) = \gamma. \end{cases}$$

To formalize the integration by parts and calculations carried out above, given $\gamma > 0$, we truncate $|x|^2$ as

$$\phi_R(x) = \begin{cases} |x|^2, & |x| \le R, \\ R^2, & |x| > R, \end{cases}$$

regularize ϕ_R with a radial mollifier θ_ρ and set

$$\varphi_{\rho,R}(x,t) = a(t) \,\theta_{\rho} * \phi_R(x) \ , \ v_{\rho,R} = e^{\varphi_{\rho,R}} u,$$

where

$$a(t) = \frac{\gamma A}{A + 4\gamma \left(A^2 + B^2\right)t} \; .$$

is the solution to (2.3).

Because the right hand side of (2.1) only involves the first derivatives of φ , ϕ_R is Lipschitz and bounded at infinity,

$$\theta_{\rho} * \phi_R \le \theta_{\rho} * |x|^2 = |x|^2 + C(n)\rho^2$$

and (2.2) holds uniformly in the variables ρ and R, when φ is replaced by $\varphi_{\rho,R}$, it follows (and now rigorously) that the estimate

$$\|v_{\rho,R}(T)\| \le e^{M_T} \left(\|e^{\gamma|x|^2} u(0)\| + \sqrt{A^2 + B^2} \|e^{\varphi_{\rho,R}} F\|_{L^1([0,T],L^2(\mathbb{R}^n))} \right)$$

holds uniformly in ρ and R. Lemma 1 follows after letting ρ tend to zero and R to infinity.

Lemma 2. S is a symmetric operator, A is skew-symmetric, both are allowed to depend on the time variable, G is a positive function, f(x,t) is a reasonable function,

$$H(t) = (f, f)$$
, $D(t) = (Sf, f)$, $\partial_t S = S_t$ and $N(t) = \frac{D(t)}{H(t)}$

Then,

$$(2.4) \quad \partial_t^2 H = 2\partial_t Re \left(\partial_t f - \mathcal{S}f - \mathcal{A}f, f\right) + 2 \left(\mathcal{S}_t f + [\mathcal{S}, \mathcal{A}] f, f\right) \\ + \|\partial_t f - \mathcal{A}f + \mathcal{S}f\|^2 - \|\partial_t f - \mathcal{A}f - \mathcal{S}f\|^2$$

and

$$\dot{N}(t) \ge \left(\mathfrak{S}_t f + \left[\mathfrak{S}, \mathcal{A}\right] f, f\right) / H - \left\|\partial_t f - \mathcal{A}f - \mathfrak{S}f\right\|^2 / \left(2H\right).$$

Moreover, if

(2.5)
$$|\partial_t f - \mathcal{A}f - \mathcal{S}f| \le M_1 |f| + G, \text{ in } \mathbb{R}^n \times [0,1], \quad \mathcal{S}_t + [\mathcal{S},\mathcal{A}] \ge -M_0,$$

and

$$M_2 = \sup_{[0,1]} \|G(t)\| / \|f(t)\|$$

is finite, then $\log H(t)$ is "logarithmically convex" in [0,1] and there is a universal constant N such that

(2.6)
$$H(t) \le e^{N(M_0 + M_1 + M_2 + M_1^2 + M_2^2)} H(0)^{1-t} H(1)^t, \text{ when } 0 \le t \le 1.$$

Proof. Formally,

$$\dot{H}(t) = 2Re\left(\partial_t f, f\right) = 2Re\left(\partial_t f - Sf - Af, f\right) + 2\left(Sf, f\right)$$

and

(2.7)
$$\dot{H}(t) = 2Re\left(\partial_t f - \Im f - \mathcal{A}f, f\right) + 2D(t) .$$

Also,

$$H(t) = Re(\partial_t f + \$f, f) + Re(\partial_t f - \$f, f),$$

$$D(t) = \frac{1}{2}Re(\partial_t f + \$f, f) - \frac{1}{2}Re(\partial_t f - \$f, f)$$

and multiplying the last two formulae,

$$\dot{H}(t)D(t) = \frac{1}{2}\left(Re\left(\partial_t f + \$f, f\right)\right)^2 - \frac{1}{2}\left(Re\left(\partial_t f - \$f, f\right)\right)^2.$$

Adding an antisymmetric operator does not change the real parts, and so

(2.8)
$$\dot{H}(t)D(t) = \frac{1}{2}\left(Re\left(\partial_t f - \mathcal{A}f + \mathcal{S}f, f\right)\right)^2 - \frac{1}{2}\left(Re\left(\partial_t f - \mathcal{A}f - \mathcal{S}f, f\right)\right)^2 \ .$$

Differentiating D(t),

$$\begin{split} \dot{D}(t) &= (\mathfrak{S}_t f, f) + (\mathfrak{S}\partial_t f, f) + (\mathfrak{S}f, \partial_t f) \\ &= (\mathfrak{S}_t f, f) + 2Re\left(\partial_t f, \mathfrak{S}f\right) \\ &= (\mathfrak{S}_t f + [\mathfrak{S}, \mathcal{A}] f, f) + 2Re\left(\partial_t f - \mathcal{A}f, \mathfrak{S}f\right) \end{split}$$

and the polarization identity gives

(2.9)
$$\dot{D}(t) = (\mathfrak{S}_t f + [\mathfrak{S}, \mathcal{A}] f, f) + \frac{1}{2} \|\partial_t f - \mathcal{A}f + \mathfrak{S}f\|^2 - \frac{1}{2} \|\partial_t f - \mathcal{A}f - \mathfrak{S}f\|^2.$$

The formula (2.4) for the second derivative of H follows from (2.7) and (2.9). The identity

$$\dot{N}(t) = \left(\mathfrak{S}_{t}f + [\mathfrak{S},\mathcal{A}]f,f\right)/H$$

$$+ \frac{1}{2}\left[\left\|\partial_{t}f - \mathcal{A}f + \mathfrak{S}f\right\|^{2}\|f\|^{2} - \left(\operatorname{Re}\left(\partial_{t}f - \mathcal{A}f + \mathfrak{S}f,f\right)\right)^{2}\right]/H^{2}$$

$$+ \frac{1}{2}\left[\left(\operatorname{Re}\left(\partial_{t}f - \mathcal{A}f - \mathfrak{S}f,f\right)\right)^{2} - \|\partial_{t}f - \mathcal{A}f - \mathfrak{S}f\|^{2}\|f\|^{2}\right]/H^{2}$$

follows from (2.8) and (2.9). The inequality in Lemma 2 follows from the positiveness of the second line (Cauchy-Schwarz's inequality) and of the fourth term on the right hand side of the previous identity.

When (2.5) holds, the first part in Lemma 2 shows that

$$\dot{N}(t) \ge - \left(M_0 + M_1^2 + M_2^2\right),$$

and from (2.7)

$$\partial_t \left[\log H(t) + \mathcal{O}(1) \right] = 2N(t).$$

All together,

$$\partial_t^2 (\log H(t) + O(1)) \ge 0$$
, when $0 \le t \le 1$,

where O (1) is a function verifying, $|O(1)| \leq N (M_0 + M_1 + M_2 + M_1^2 + M_2^2)$ in [0,1]. The integration of the inequality

$$\partial_s \left(\log H(s) + \mathcal{O}(1) \right) \le \partial_\tau \left(\log H(\tau) + \mathcal{O}(1) \right), \text{ when } 0 \le s \le t \le \tau \le 1,$$

over the intervals, $0 \le s \le t$ and $t \le \tau \le 1$, implies (2.6).

Lemma 3. Assume that u in $L^{\infty}([0,1]), L^{2}(\mathbb{R}^{n})) \cap L^{2}([0,1], H^{1}(\mathbb{R}^{n}))$ verifies

(2.10)
$$\partial_t u = (A+iB)\left(\triangle u + V(x,t)u + F(x,t)\right), \text{ in } \mathbb{R}^n \times [0,1],$$

where $A > 0, B \in \mathbb{R}, V$ is complex-valued, $\gamma > 0$ and $\sup_{[0,1]} \|V(t)\|_{\infty} \leq M_1$. Set

$$M_2 = \sup_{[0,1]} \|e^{\gamma |x|^2} F(t)\| / \|u(t)\|$$

and assume that $||e^{\gamma|x|^2}u(0)||$, $||e^{\gamma|x|^2}u(1)||$ and M_2 are finite. Then, $||e^{\gamma|x|^2}u(t)||$ is "logarithmically convex" in [0, 1] and there is a universal constant N such that

(2.11)
$$||e^{\gamma|x|^2}u(t)|| \leq e^{N[(A^2+B^2)(\gamma M_1^2+M_2^2)+\sqrt{A^2+B^2}(M_1+M_2)]}||e^{\gamma|x|^2}u(0)||^{1-t}||e^{\gamma|x|^2}u(1)||^t,$$

when $0 \leq t \leq 1$.

Proof. Let $f = e^{\gamma \varphi} u$, where $\varphi = \varphi(x, t)$ is to be chosen. The function f verifies (2.12) $\partial_t f = \$f + \mathcal{A}f + (A + iB) (Vf + e^{\gamma \varphi}F)$, in \mathbb{R}^{n+1}_+ ,

with symmetric and skew-symmetric operators ${\mathbb S}$ and ${\mathcal A}$

A calculation shows that,

(2.14)
$$\begin{split} & \mathcal{S}_t + [\mathcal{S}, \mathcal{A}] = \gamma \partial_t^2 \varphi + 4\gamma^2 A \nabla \varphi \cdot \nabla \partial_t \varphi - 2iB\gamma \left(2\nabla \partial_t \varphi \cdot \nabla + \triangle \partial_t \varphi\right) \\ & -\gamma \left(A^2 + B^2\right) \left[4\nabla \cdot \left(D^2 \varphi \nabla\right) - 4\gamma^2 D^2 \varphi \nabla \varphi \cdot \nabla \varphi + \triangle^2 \varphi\right]. \end{split}$$

At the end we shall require that $\varphi(x,t) = |x|^2$, where

$$S_t + [S, \mathcal{A}] = -\gamma \left(A^2 + B^2\right) \left[8 \bigtriangleup - 32\gamma^2 |x|^2\right]$$

and

(2.15)
$$(\mathfrak{S}_t f + [\mathfrak{S}, \mathcal{A}] f, f) = \gamma \left(A^2 + B^2 \right) \int_{\mathbb{R}^n} 8|\nabla f|^2 + 32\gamma^2 |x|^2 |f|^2 \, dx \; .$$

This identity, the boundedness of V and (2.12) imply that

(2.16)
$$|\partial_t f - \mathcal{S}f - \mathcal{A}f| \le \sqrt{A^2 + B^2} \left(M_1 |f| + e^{\gamma \varphi} |F| \right) \quad , \quad \mathcal{S}_t + [\mathcal{S}, \mathcal{A}] \ge 0,$$

and if we knew that the quantities and calculations involved in the proof of Lemma 2 were finite and correct, when $f = e^{\gamma |x|^2} u$, we would have the "logarithmic convexity" of $H(t) = ||e^{\gamma |x|^2} u(t)||^2$ and get (2.11) from Lemma 2.

To justify the validity of the previous arguments, given a and ρ in (0, 1), define

$$\varphi_a(x) = \begin{cases} |x|^2, & |x| < 1 \\ (2|x|^{2-a} - a)/(2-a), & |x| \ge 1 \end{cases}$$

and replace $\varphi = |x|^2$ by $\varphi_{a,\rho} = \theta_{\rho} * \varphi_a$, where θ in $C_0^{\infty}(\mathbb{R}^n)$ is a radial function. Observe that φ_a is a $C^{1,1}(\mathbb{R}^n)$ convex function, $\varphi_{a,\rho} \leq |x|^2 + C(n)\rho^2$, $\varphi_{a,\rho}$ is convex and grows at infinity not faster than $|x|^{2-a}$. At the same time,

$$\triangle \varphi_a(x) = \begin{cases} 2n, & |x| \le 1, \\ 2(n-a)|x|^{-a}, & |x| \ge 1, \end{cases}$$

and the distribution $\partial_j \triangle \varphi_a$, $j = 1, \ldots, n$, is equal to

$$-2ax_j\,d\sigma - 2a(n-a)x_j|x|^{-a-2}\chi_{\mathbb{R}^n\setminus B_1},$$

where $d\sigma$ is surface measure on ∂B_1 . This and the identity

$$\triangle^2 \varphi_{a,\rho} = \sum_{j=1}^n \partial_j \theta_\rho * \partial_j \triangle \varphi_a,$$

show that

(2.17)
$$\|\triangle^2 \varphi_{a,\rho}\|_{\infty} \le C(n,\rho)a.$$

Set then, $f_{a,\rho} = e^{\gamma \varphi_{a,\rho}} u$ and $H_{a,\rho}(t) = ||f_{a,\rho}||^2$ in Lemma 2. The decay bound in Lemma 1 and the interior regularity for solutions of (2.10) (Here we use that A is positive) can now be used qualitatively to make sure that the quantities or calculations involved in the proof of Lemma 2 are finite and correct for $f_{a,\rho}$. In this case, $f_{a,\rho}$ verifies

$$(2.18) \quad \partial_t f_{a,\rho} = \mathbb{S}^{a,\rho} f_{a,\rho} + \mathcal{A}^{a,\rho} f_{a,\rho} + (A+iB) \left(V f_{a,\rho} + e^{\gamma \varphi_{a,\rho}} F \right), \text{ in } \mathbb{R}^n \times [0,1],$$

with symmetric and skew-symmetric operators $S^{a,\rho}$ and $\mathcal{A}^{a,\rho}$ given by (2.13) with φ replaced by $\varphi_{a,\rho}$. The formula for the operator

$$\mathbb{S}_t^{a,\rho} + [\mathbb{S}^{a,\rho}, \mathcal{A}^{a,\rho}]$$

in (2.14), the convexity of $\varphi_{a,\rho}$, the bounds (2.17) and (2.18) imply that the inequalities

$$\begin{aligned} |\partial_t f_{a,\rho} - \mathbb{S}^{a,\rho} f_{a,\rho} - \mathcal{A}^{a,\rho} f_{a,\rho}| &\leq \sqrt{A^2 + B^2} \left(M_1 |f_{a,\rho}| + e^{\gamma \varphi_{a,\rho}} F \right), \\ S_t^{a,\rho} + \left[\mathbb{S}^{a,\rho}, \mathcal{A}^{a,\rho} \right] &\geq 0, \end{aligned}$$

hold and $M_2(a,\rho) \leq e^{C(n)\rho^2} M_2$, when $0 < a, \rho \leq 1$. In particular, $H_{a,\rho}$ is "logarithmically convex" in [0, 1] and

(2.19)
$$H_{a,\rho}(t) \le e^{N\left[\left(A^2 + B^2\right)\left(M_1^2 + M_2^2\right) + \sqrt{A^2 + B^2}(M_1 + M_2)\right]} H_{a,\rho}(0)^{1-t} H_{a,\rho}(1)^t.$$

Then, (2.11) follows after taking first the limit, when a tends to zero in (2.19) and then, when ρ tends to zero.

Lemma 4. Assume that A + iB, u and V are as in Lemma 3 and $\gamma > 0$. Then,

$$(2.20) \quad \|\sqrt{t(1-t)}e^{\gamma|x|^2} \nabla u\|_{L^2(\mathbb{R}^n \times [0,1])} + \|\sqrt{t(1-t)}|x|e^{\gamma|x|^2}u\|_{L^2(\mathbb{R}^n \times [0,1])} \\ \leq N\left[(1+M_1) \sup_{[0,1]} \|e^{\gamma|x|^2}u(t)\| + \sup_{[0,1]} \|e^{\gamma|x|^2}F\|_{L^2(\mathbb{R}^n \times [0,1])} \right],$$

where N remains bounded, when γ and $A^2 + B^2$ are bounded below.

Proof. A formal integration by parts shows that

$$\int_{\mathbb{R}^n} |\nabla f|^2 + 4\gamma^2 |x|^2 |f|^2 \, dx = \int_{\mathbb{R}^n} e^{2\gamma |x|^2} \left(|\nabla u|^2 - 2n\gamma |u|^2 \right) \, dx,$$

when $f = e^{\gamma |x|^2} u$, while either well known properties of Hermite functions [17] or integration by parts, the Cauchy-Schwarz's inequality and the identity, $n = \nabla \cdot x$, give that

$$\int_{\mathbb{R}^n} |\nabla f|^2 + 4\gamma^2 |x|^2 |f|^2 \, dx \ge 2\gamma n \int_{\mathbb{R}^n} |f|^2 \, dx.$$

The sum of the last two formulae gives the inequality

(2.21)
$$2\int_{\mathbb{R}^n} |\nabla f|^2 + 4\gamma^2 |x|^2 |f|^2 \, dx \ge \int_{\mathbb{R}^n} e^{2\gamma |x|^2} |\nabla u|^2 \, dx.$$

Integration over [0, 1] of t(1-t) times the formula (2.4) for the second derivative of $H(t) = ||f(t)||^2$ and integration by parts, shows that in the general framework of Lemma 2

$$(2.22) \quad 2\int_{0}^{1} t(1-t) \left(S_{t}f + [S,\mathcal{A}]f,f \right) dt + 2\int_{0}^{1} H(t) dt \leq H(1) + H(0) \\ + 2\int_{0}^{1} (1-2t)Re\left(\partial_{t}f - Sf - \mathcal{A}f,f\right) dt + \int_{0}^{1} t(1-t) \|\partial_{t}f - \mathcal{A}f - Sf\|^{2} dt.$$

Assuming again that the last two calculations are justified for $f = e^{\gamma |x|^2} u$, (2.22), (2.15), (2.16), (2.21) and the identity, $\nabla f = e^{\gamma |x|^2} (\nabla u + 2\gamma x u)$, imply the Lemma.

The interior regularity of the solutions to (2.10) (Here we use again that A > 0) shows that the calculations leading to (2.21) and (2.22) are justified, when $f = e^{(\gamma-\rho)|x|^2}u$, $0 < \rho < \gamma$, and the right hand side of (2.20) is finite. The Lemma follows letting ρ tend to zero.

3. The conformal or Appell transformation

Lemma 5. Assume that u(y, s) verifies

$$\partial_s u = (A + Bi) \left(\bigtriangleup u + V(y, s)u + F(y, s) \right)$$
, in $\mathbb{R}^n \times [0, 1]$,

 $A + iB \neq 0$, α and β are positive, $\gamma \in \mathbb{R}$ and set

$$\widetilde{u}(x,t) = \left(\frac{\sqrt{\alpha\beta}}{\alpha(1-t)+\beta t}\right)^{\frac{n}{2}} u\left(\frac{\sqrt{\alpha\beta}x}{\alpha(1-t)+\beta t}, \frac{\beta t}{\alpha(1-t)+\beta t}\right) e^{\frac{(\alpha-\beta)|x|^2}{4(A+iB)(\alpha(1-t)+\beta t)}}.$$

Then, \tilde{u} verifies

$$\partial_t \widetilde{u} = (A + Bi) \left(\bigtriangleup \widetilde{u} + \widetilde{V}(x, t) \widetilde{u} + \widetilde{F}(x, t) \right) , \text{ in } \mathbb{R}^n \times [0, 1],$$

with

$$\widetilde{V}(x,t) = \frac{\alpha\beta}{(\alpha(1-t)+\beta t)^2} V\left(\frac{\sqrt{\alpha\beta}x}{\alpha(1-t)+\beta t}, \frac{\beta t}{\alpha(1-t)+\beta t}\right),$$
$$\widetilde{F}(x,t) = \left(\frac{\sqrt{\alpha\beta}}{\alpha(1-t)+\beta t}\right)^{\frac{n}{2}+2} F\left(\frac{\sqrt{\alpha\beta}x}{\alpha(1-t)+\beta t}, \frac{\beta t}{\alpha(1-t)+\beta t}\right) e^{\frac{(\alpha-\beta)|x|^2}{4(A+iB)(\alpha(1-t)+\beta t)}}.$$

Moreover,

$$\|e^{\gamma|x|^2}\widetilde{F}(t)\| = \frac{\alpha\beta}{(\alpha(1-t)+\beta t)^2} \|e^{\left[\frac{\gamma\alpha\beta}{(\alpha s+\beta(1-s))^2} + \frac{(\alpha-\beta)A}{4(A^2+B^2)(\alpha s+\beta(1-s))}\right]|y|^2} F(s)\|$$

and

$$\begin{aligned} \|e^{\gamma|x|^2}\widetilde{u}(t)\| &= \|e^{\left[\frac{\gamma\alpha\beta}{(\alpha s+\beta(1-s))^2} + \frac{(\alpha-\beta)A}{4(A^2+B^2)(\alpha s+\beta(1-s))}\right]|y|^2}u(s)\|, \end{aligned}$$
when $s = \frac{\beta t}{\alpha(1-t)+\beta t}$ and $\gamma \in \mathbb{R}$.

Proof. When u satisfies

(3.1)
$$\partial_s u = (A + Bi) \left(\triangle u + H(y, s) \right) , \text{ in } \mathbb{R}^n \times [0, 1],$$

the function, $u_1(x,t) = u(\sqrt{rx}, rt + \tau)$, verifies

$$\partial_t u_1 = (A + iB) \left(\triangle u_1 + rH(\sqrt{rx}, rt + \tau) \right)$$

and $u_2(x,t) = t^{-\frac{n}{2}} u(x/t, 1/t) e^{\frac{|x|^2}{4(A+iB)t}}$ is a solution to

$$\partial_t u_2 = -(A+Bi)\left(\triangle u_2 + t^{-\frac{n}{2}-2}H(x/t, 1/t)e^{\frac{|x|^2}{4(A+iB)t}}\right).$$

These two facts and the sequel of changes of variables below prove the Lemma, when $\alpha > \beta$:

$$u\left(\sqrt{\frac{\alpha\beta}{\alpha-\beta}}x, \frac{\alpha\beta}{\alpha-\beta}t - \frac{\beta}{\alpha-\beta}\right)$$

is a solution to the same non-homogeneous equation but with right-hand side

$$\frac{\alpha\beta}{\alpha-\beta}H\left(\sqrt{\frac{\alpha\beta}{\alpha-\beta}}\,x,\frac{\alpha\beta}{\alpha-\beta}\,t-\frac{\beta}{\alpha-\beta}\right).$$

The function,

$$\frac{1}{(\alpha-t)^{\frac{n}{2}}} u\left(\frac{\sqrt{\alpha\beta}x}{\sqrt{\alpha-\beta}(\alpha-t)}, \frac{\alpha\beta}{(\alpha-\beta)(\alpha-t)} - \frac{\beta}{\alpha-\beta}\right) e^{\frac{|x|^2}{4(A+iB)(\alpha-t)}}$$

verifies (3.1) with right-hand side

$$\frac{\alpha\beta}{(\alpha-\beta)(\alpha-t)^{\frac{n}{2}+2}}H\left(\frac{\sqrt{\alpha\beta}x}{\sqrt{\alpha-\beta}(\alpha-t)},\frac{\alpha\beta}{(\alpha-\beta)(\alpha-t)}-\frac{\beta}{\alpha-\beta}\right)e^{\frac{|x|^2}{4(A+iB)(\alpha-t)}}.$$

Replacing (x,t) by $(\sqrt{\alpha-\beta}x, (\alpha-\beta)t),$

(3.2)
$$\frac{1}{(\alpha(1-t)+\beta t)^{\frac{n}{2}}} u\left(\frac{\sqrt{\alpha\beta}x}{\alpha(1-t)+\beta t}, \frac{\alpha\beta}{(\alpha-\beta)(\alpha(1-t)+\beta t)} - \frac{\beta}{\alpha-\beta}\right) e^{\frac{(\alpha-\beta)|x|^2}{4(A+iB)(\alpha(1-t)+\beta t)}}$$

is a solution to (3.1) but with right-hand

(3.3)
$$\frac{\alpha\beta}{(\alpha+\beta-\alpha t)^{\frac{n}{2}+2}}H\left(\frac{\sqrt{\alpha\beta}x}{\alpha(1-t)+\beta t},\frac{\alpha\beta}{(\alpha-\beta)(\alpha(1-t)+\beta t)}-\frac{\beta}{\alpha-\beta}\right)e^{\frac{(\alpha-\beta)|x|^2}{4(A+iB)(\alpha(1-t)+\beta t)}}.$$

Finally, observe that

$$s = \frac{\beta t}{\alpha(1-t)+\beta t} = \frac{\alpha\beta}{(\alpha-\beta)(\alpha(1-t)+\beta t)} - \frac{\beta}{\alpha-\beta}$$

and multiply (3.2) and (3.3) by $\left(\sqrt{\alpha\beta}\right)^{\frac{n}{2}}$.

The case $\beta > \alpha$ follows by reversing the time with the changes of variables, s' = 1 - s and t' = 1 - t. The relations between the different norms of \tilde{u} , u, \tilde{F} and F follow undoing the changes of variables and using the identity

$$\frac{\sqrt{\alpha\beta}}{\alpha(1-t)+\beta t} = \frac{\alpha s + \beta(1-s)}{\sqrt{\alpha\beta}} \,.$$

4. VARIABLE COEFFICIENTS. PROOF OF THEOREM 3.

We are ready to prove Theorem 3.

Proof. We may assume that $\alpha \neq \beta$. The case $\alpha = \beta$ follows from the latter by replacing β by $\beta + \delta$, $\delta > 0$, and letting δ tend to zero. We may also assume that $\alpha < \beta$. Otherwise, replace u by $\overline{u}(1-t)$. Set then, $H = \Delta + V_1(x)$ and let $e^{t(A+iB)H}u_0$ denote the $C([0,1], L^2(\mathbb{R}^n))$ -solution to

$$\begin{cases} \partial_t v = (A + iB) \left(\triangle v + V_1(x)v \right), \text{ in } \mathbb{R}^n \times [0, 1], \\ v(0) = u_0, \end{cases}$$

when $\Re(A + iB) \ge 0$. The Duhamel principle shows that

(4.1)
$$u(t) = e^{itH}u(0) + i \int_0^t e^{i(t-s)H} \left(V_2(s)u(s)\right) \, ds \, , \text{ in } \mathbb{R}^n \times [0,1].$$

For $0 \le \epsilon \le 1$, set

(4.2)
$$F_{\epsilon}(t) = \frac{i}{\epsilon+i} e^{\epsilon t H} \left(V_2(t) u(t) \right),$$

and

(4.3)
$$u_{\epsilon}(t) = e^{(\epsilon+i)tH}u(0) + (\epsilon+i)\int_0^t e^{(\epsilon+i)(t-s)H}F_{\epsilon}(s)\,ds$$

Then, u_{ϵ} is in $L^{\infty}([0,1], L^2(\mathbb{R}^n)) \cap L^2([0,1], H^1(\mathbb{R}^n))$ and verifies

$$\begin{cases} \partial_t u_{\epsilon} = (\epsilon + i) \left(H u_{\epsilon} + F_{\epsilon}(t) \right), \text{ in } \mathbb{R}^n \times [0, 1], \\ u_{\epsilon}(0) = u(0). \end{cases}$$

The identities [14]

(4.4)
$$e^{(z_1+z_2)H} = e^{(z_2+z_1)H} = e^{z_1H}e^{z_2H}$$
, when $\Re z_1, \Re z_2 \ge 0$,

(4.1), (4.2) and (4.3) show that

(4.5)
$$u_{\epsilon}(t) = e^{\epsilon t H} u(t) \text{, when } 0 \le t \le 1.$$

In particular,

$$u_{\epsilon}(1) = e^{\epsilon H} u(1)$$

and Lemma 1 with $A + iB = \epsilon$, $\gamma = \frac{1}{\beta^2}$, $F \equiv 0$ and the fact that $u_{\epsilon}(0) = u(0)$ imply that

$$\|e^{\frac{|x|^2}{\beta^2+4\epsilon}}u_{\epsilon}(1)\| \le e^{\epsilon}\|V_1\|_{L^{\infty}(\mathbb{R}^n)} \|e^{\frac{|x|^2}{\beta^2}}u(1)\| \quad , \quad \|e^{\frac{|x|^2}{\alpha^2}}u_{\epsilon}(0)\| = \|e^{\frac{|x|^2}{\alpha^2}}u(0)\|.$$

A second application of Lemma 1 with $A + iB = \epsilon$, $F \equiv 0$, the value of $\gamma = \frac{1}{(\alpha t + \beta(1-t))^2}$ and (4.2) show that

$$\|\epsilon^{\frac{|x|^2}{(\alpha t+\beta(1-t))^2+4\epsilon t}}F_{\epsilon}(t)\| \le e^{\epsilon \|V_1\|_{\infty}} \|\epsilon^{\frac{|x|^2}{(\alpha t+\beta(1-t))^2}}V_2(t)\|_{\infty}\|u(t)\|$$

when $0 \le t \le 1$. Setting, $\alpha_{\epsilon} = \alpha + 2\epsilon$ and $\beta_{\epsilon} = \beta + 2\epsilon$, the last three inequalities give that

(4.6)
$$\|e^{\frac{|x|^2}{\beta_e^2}}u_\epsilon(1)\| \le e^{\epsilon \|V_1\|_{\infty}} \|e^{\frac{|x|^2}{\beta^2}}u(1)\|$$
, $\|e^{\frac{|x|^2}{\alpha_\epsilon^2}}u_\epsilon(0)\| \le \|e^{\frac{|x|^2}{\alpha^2}}u(0)\|$,

(4.7)
$$\|e^{\frac{|x|^2}{(\alpha_{\epsilon}t+\beta_{\epsilon}(1-t))^2}}F_{\epsilon}(t)\| \le e^{\epsilon \|V_1\|_{\infty}} \|e^{\frac{|x|^2}{(\alpha t+\beta(1-t))^2}}V_2(t)\|_{\infty} \|u(t)\|$$

A third application of Lemma 1 with $A + iB = \epsilon$, $F \equiv 0$, $\gamma = 0$, and (4.2), (4.5) implies that

(4.8)
$$||F_{\epsilon}(t)|| \le e^{\epsilon ||V_1||_{\infty}} ||V_2(t)||_{L^{\infty}(\mathbb{R}^n)} ||u(t)|| , ||u_{\epsilon}(t)|| \le e^{\epsilon ||V_1||_{\infty}} ||u(t)||$$

when $0 \le t \le 1$. Set then, $\gamma_{\epsilon} = \frac{1}{\alpha_{\epsilon}\beta_{\epsilon}}$ and let

$$\widetilde{u}_{\epsilon}(x,t) = \left(\frac{\sqrt{\alpha_{\epsilon}\beta_{\epsilon}}}{\alpha_{\epsilon}(1-t) + \beta_{\epsilon}t}\right)^{\frac{n}{2}} u_{\epsilon}\left(\frac{\sqrt{\alpha_{\epsilon}\beta_{\epsilon}}x}{\alpha_{\epsilon}(1-t) + \beta_{\epsilon}t}, \frac{\beta_{\epsilon}t}{\alpha_{\epsilon}(1-t) + \beta_{\epsilon}t}\right) e^{\frac{(\alpha_{\epsilon} - \beta_{\epsilon})|x|^{2}}{4(\epsilon+i)(\alpha_{\epsilon}(1-t) + \beta_{\epsilon}t)}},$$

be the function associated to u_{ϵ} in Lemma 5, when $A + iB = \epsilon + i$ and α , β are replaced respectively by α_{ϵ} and β_{ϵ} . Because $\alpha < \beta$, \tilde{u}_{ϵ} is in $L^{\infty}([0,1]), L^{2}(\mathbb{R}^{n})) \cap L^{2}([0,1], H^{1}(\mathbb{R}^{n}))$ and satisfies

$$\partial_t \widetilde{u}_{\epsilon} = (\epsilon + i) \left(\bigtriangleup \widetilde{u}_{\epsilon} + \widetilde{V}_1^{\epsilon}(x, t) \widetilde{u}_{\epsilon} + \widetilde{F}_{\epsilon}(t) \right), \text{ in } \mathbb{R}^n \times [0, 1],$$

where $\widetilde{V}_1^{\epsilon}$ is real-valued,

(4.9)
$$\widetilde{V}_{1}^{\epsilon}(x,t) = \frac{\alpha_{\epsilon}\beta_{\epsilon}}{(\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t)^{2}} V_{1}\left(\frac{\sqrt{\alpha_{\epsilon}\beta_{\epsilon}}x}{\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t}\right) \quad , \quad \sup_{[0,1]} \|\widetilde{V}_{1}^{\epsilon}(t)\|_{\infty} \le \frac{\beta}{\alpha}M_{1},$$

$$\widetilde{F}_{\epsilon}(x,t) = \left(\frac{\sqrt{\alpha_{\epsilon}\beta_{\epsilon}}}{\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t}\right)^{\frac{1}{2}+2} F_{\epsilon}\left(\frac{\sqrt{\alpha_{\epsilon}\beta_{\epsilon}}x}{\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t}, \frac{\beta_{\epsilon}t}{\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t}\right) e^{\frac{(\alpha_{\epsilon}-\beta_{\epsilon})|x|^{2}}{4(\epsilon+i)(\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t)},$$

(4.10)
$$\|e^{\gamma_{\epsilon}|x|^{2}}\widetilde{F}_{\epsilon}(t)\| \leq \frac{\beta}{\alpha} \|\epsilon^{\frac{|x|^{2}}{(\alpha_{\epsilon}t+\beta_{\epsilon}(1-t))^{2}}}F_{\epsilon}(s)\|, \|\widetilde{F}_{\epsilon}(t)\| \leq \frac{\beta}{\alpha} \|F_{\epsilon}(s)\|,$$

and

(4.11)
$$\|e^{\gamma_{\epsilon}|x|^{2}}\widetilde{u}_{\epsilon}(t)\| = \|e^{\left[\frac{1}{(\alpha_{\epsilon}s+\beta_{\epsilon}(1-s))^{2}} + \frac{(\alpha_{\epsilon}-\beta_{\epsilon})A}{4(A^{2}+B^{2})(\alpha_{\epsilon}s+\beta_{\epsilon}(1-s))}\right]|y|^{2}}u_{\epsilon}(s)\|,$$
$$\|\widetilde{u}_{\epsilon}(t)\| \le \|u_{\epsilon}(s)\|,$$

when $s = \frac{\beta_{\epsilon}t}{\alpha_{\epsilon}(1-t)+\beta_{\epsilon}t}$. The above identity, when t is zero or one and (4.6) shows that

$$\|e^{\gamma_{\epsilon}|x|^{2}}\widetilde{u}_{\epsilon}(0)\| \le \|e^{\frac{|x|^{2}}{\beta^{2}}}u(0)\|, \|e^{\gamma_{\epsilon}|x|^{2}}\widetilde{u}_{\epsilon}(1)\| \le e^{\epsilon\|V^{+}\|_{\infty}}\|e^{\frac{|x|^{2}}{\beta^{2}}}u(1)\|.$$

On the other hand, (4.13)

$$N_1^{-1} \|u(0)\| \le \|u(t)\| \le N_1 \|u(0)\|$$
, when $0 \le t \le 1$, $N_1 = e^{\sup_{[0,1]} \|\Im V_2(t)\|_{\infty}}$,

and the equation satisfied by \tilde{u}_{ϵ} and the energy method imply that

(4.14)
$$\partial_t \|\widetilde{u}_{\epsilon}(t)\|^2 \le 2\epsilon \|\widetilde{V}_1^{\epsilon}(t)\|_{\infty} \|\widetilde{u}_{\epsilon}(t)\|^2 + 2\|\widetilde{F}_{\epsilon}(t)\|\|\widetilde{u}_{\epsilon}(t)\|.$$

Let, $0 = t_0 < t_1 < t_2 < \cdots < t_m = 1$, be a uniformly distributed partition of [0, 1], where *m* will be chosen later. The inequality (4.14), (4.9), the inequality in (4.11), the second inequality in (4.10), (4.8) and (4.13) imply that there is N_2 , which depends on $\frac{\beta}{\alpha}$, $\|V_1\|_{L^{\infty}(\mathbb{R}^n)}$ and $\sup_{[0,1]} \|V_2(t)\|_{\infty}$, such that

(4.15)
$$\|\widetilde{u}_{\epsilon}(t_i)\| \leq e^{\frac{\epsilon\beta}{\alpha}} \|V_1\|_{\infty} \|\widetilde{u}_{\epsilon}(t)\| + N_2 \sqrt{t_i - t_{i-1}} \|u(0)\|,$$

when $t_{i-1} \leq t \leq t_i$, $0 < \epsilon \leq 1$ and $i = 1, \ldots, m$. Choose now m so that

where N_1 was defined in (4.13). Because, $\lim_{\epsilon \to 0^+} \|\widetilde{u}_{\epsilon}(t)\| = \|u(s)\|$, when $s = \frac{\beta t}{\alpha(1-t)+\beta t}$ and (4.13), there is ϵ_0 such that

It is now simple to verify that (4.18), the first inequality in (4.10), (4.7) and (4.13) imply that

$$\sup_{[0,1]} \frac{\|e^{\gamma_{\epsilon}|x|^2} \widetilde{F}_{\epsilon}(t)\|}{\|\widetilde{u}_{\epsilon}(t)\|} \le \frac{4\beta}{\alpha} M_2(\epsilon) , \text{ when } 0 < \epsilon \le \epsilon_0,$$

where

$$M_2(\epsilon) = e^{2\sup_{[0,1]} \|\Im V_2(t)\|_{\infty} + \epsilon \|V_1\|_{\infty}} \sup_{[0,1]} \|e^{\frac{|x|^2}{(\alpha t + \beta(1-t))^2}} V_2(t)\|_{\infty}$$

We can use Lemma 3, (4.12), (4.9) and (4.19) to show that $||e^{\gamma_{\epsilon}|x|^2} \widetilde{u}_{\epsilon}(t)||$ is "logarithmically convex" in [0, 1] and that

(4.20)
$$\|e^{\gamma_{\epsilon}|x|^{2}}\widetilde{u}_{\epsilon}(t)\| \leq e^{N\left(M_{1}+M_{2}(\epsilon)+M_{1}^{2}+M_{2}(\epsilon)^{2}\right)}\|e^{\frac{|x|^{2}}{\beta^{2}}}u(0)\|^{1-t}\|e^{\frac{|x|^{2}}{\alpha^{2}}}u(1)\|^{t},$$

when $0 \le t \le 1$ and $0 < \epsilon \le \epsilon_0$ and with $N = N(\alpha, \beta)$. Then, Lemma 4 gives that

$$\begin{aligned} \|\sqrt{t(1-t)} e^{\gamma_{\epsilon}|x|^{2}} \nabla \widetilde{u}_{\epsilon}\|_{L^{2}(\mathbb{R}^{n}\times[0,1])} + \|\sqrt{t(1-t)} |x| e^{\gamma_{\epsilon}|x|^{2}} \nabla \widetilde{u}_{\epsilon}\|_{L^{2}(\mathbb{R}^{n}\times[0,1])} \\ &\leq N e^{N\left(M_{1}+M_{2}(\epsilon)+M_{1}^{2}+M_{2}(\epsilon)^{2}\right)} \left[\left\|e^{\frac{|x|^{2}}{\beta^{2}}}u(0)\right\| + \left\|e^{\frac{|x|^{2}}{\alpha^{2}}}u(1)\right\| \right], \end{aligned}$$

when $0 < \epsilon \leq \epsilon_0$, and the "logarithmic convexity" and regularity of u follow from the limit of the identity in (4.11), the final limit relation between the variables s and $t, s = \frac{\beta t}{\alpha(1-t)+\beta t}$, and letting ϵ tend to zero in (4.20) and the above inequality. \Box

Remark 1. We thank R. Killip for pointing out the following application of Lemma 1 and the identities (4.4) to generate Gaussian decaying solutions of $\partial_t = iH$, when $H = \triangle + V_1(x)$ and V_1 verify the conditions in Theorem 3. In fact, if $e^{\gamma |x|^2} u_0$ is in $L^2(\mathbb{R}^n)$ and $u(t) = e^{itH} (e^H u_0)$, we have $u(t) = e^{(\frac{1}{t}+i)tH} u_0$ and from Lemma 1

$$\|e^{\frac{\gamma|x|^2}{1+4\gamma(1+t^2)}}u(t)\| \le e^{\|V_1\|_{\infty}}\|e^{\gamma|x|^2}u_0\|$$
, when $t\ge 0$.

Next, we recall the following result established in [11]:

Lemma 6. There are N and $\epsilon_0 > 0$ such that the following holds:

If λ is in \mathbb{R}^n , V is a complex-valued potential, $\|V\|_{L^1([0,1],L^\infty(\mathbb{R}^n))} \leq \epsilon_0$ and $u \in C([0,1], L^2(\mathbb{R}^n))$ satisfies

$$\partial_t u = i \left(\Delta u + V(x,t)u + F(x,t) \right)$$
, in $\mathbb{R}^n \times [0,1]$.

$$\sup_{[0,1]} \|e^{\lambda \cdot x} u(t)\| \le N \left[\|e^{\lambda \cdot x} u(0)\| + \|e^{\lambda \cdot x} u(1)\| + \|e^{\lambda \cdot x} F(t)\|_{L^1([0,1],L^2(\mathbb{R}^n))} \right].$$

Theorem 5. Assume that u in $C([0,1]), L^2(\mathbb{R}^n)$ verifies

where V is in $L^{\infty}(\mathbb{R}^n \times [0,1])$, $\lim_{R \to +\infty} \|V\|_{L^1([0,1],L^{\infty}(\mathbb{R}^n \setminus B_R))} = 0$, α and β are positive and $\|e^{\frac{|x|^2}{\beta^2}}u(0)\|$, $\|e^{\frac{|x|^2}{\alpha^2}}u(1)\|$ are finite. Then, there is $N = N(\alpha,\beta)$ such

that

$$\sup_{[0,1]} \|e^{\frac{|x|^2}{(\alpha t + (1-t)\beta)^2}} u(t)\| + \|\sqrt{t(1-t)}e^{\frac{|x|^2}{(\alpha t + (1-t)\beta)^2}} \nabla u\|_{L^2(\mathbb{R}^n \times [0,1])}$$
$$\leq N e^{N \sup_{[0,1]} \|V(t)\|_{\infty}} \left[\|e^{\frac{|x|^2}{\beta^2}} u(0)\| + \|e^{\frac{|x|^2}{\alpha^2}} u(1)\| + \sup_{[0,1]} \|u(t)\|_{L^2(\mathbb{R}^n \times [0,1])} \right]$$

Proof. Set $\gamma = 1/(\alpha\beta)$ and let

denote the function associated in Lemma 5 to u, when A + iB = i. This function is in $C([0,1], L^2(\mathbb{R}^n))$ and verifies

$$\sup_{[0,1]} \|\widetilde{V}(t)\|_{\infty} \le \max\left\{\frac{\alpha}{\beta}, \frac{\beta}{\alpha}\right\} \sup_{[0,1]} \|V(t)\|_{\infty} , \quad \lim_{R \to +\infty} \|\widetilde{V}\|_{L^{1}([0,1],L^{\infty}(\mathbb{R}^{n} \setminus B_{R}))} = 0$$

and

(4.22)
$$\|e^{\gamma|x|^{2}}\widetilde{u}(t)\| = \|e^{\frac{|x|^{2}}{(\alpha s + \beta(1-s))^{2}}}u(s)\|, \\ \|\widetilde{u}(t)\| = \|u(s)\|, \text{ when } s = \frac{\beta t}{\alpha(1-t) + \beta t}$$

Choose R > 0 such that $\|\widetilde{V}\|_{L^1([0,1],L^{\infty}(\mathbb{R}^n \setminus B_R))} \leq \epsilon_0$. Then,

$$\partial_t \widetilde{u} = i \left(\bigtriangleup \widetilde{u} + \widetilde{V}_R(x, t) \widetilde{u} + \widetilde{F}_R(x, t) \right),$$

with $\widetilde{V}_R(x,t) = \chi_{\mathbb{R}^n \setminus B_R} \widetilde{V}(x,t)$, $\widetilde{F}_R = \chi_{B_R} \widetilde{V}(x,t) \widetilde{u}$, and using Lemma 6 $\sup_{[0,1]} \|e^{\lambda \cdot x} \widetilde{u}(t)\| \le N \left[\|e^{\lambda \cdot x} \widetilde{u}(0)\| + \|e^{\lambda \cdot x} \widetilde{u}(1)\| + e^{|\lambda|R} \sup_{[0,1]} \|\widetilde{V}(t)\|_{\infty} \sup_{[0,1]} \|\widetilde{u}(t)\| \right].$

Replace λ by $\lambda \sqrt{\gamma}$ in the above inequality, square both sides, multiply all by $e^{-|\lambda|^2/2}$ and integrate both sides with respect to λ in \mathbb{R}^n . This and the identity,

$$\int_{\mathbb{R}^n} e^{2\sqrt{\gamma}\,\lambda\cdot x - \frac{|\lambda|^2}{2}} \,d\lambda = (2\pi)^{n/2} e^{2\gamma|x|^2},$$

This inequality and (4.22) imply that (4.23)

$$\sup_{[0,1]} \|e^{\gamma \|x\|^2} \widetilde{u}(t)\| \le N \left[\|e^{\frac{\|x\|^2}{\beta^2}} u(0)\| + \|e^{\frac{\|x\|^2}{\alpha^2}} u(1)\| + \sup_{[0,1]} \|V(t)\|_{\infty} \sup_{[0,1]} \|u(t)\| \right],$$

for some new constant N.

|.

To prove the regularity of u we proceed as in (4.1), (4.2) and (4.3). The Duhamel formula shows that

(4.24)
$$\widetilde{u}(t) = e^{it\Delta}\widetilde{u}(0) + i \int_0^t e^{i(t-s)\Delta} \left(\widetilde{V}(s)\widetilde{u}(s)\right) ds , \text{ in } \mathbb{R}^n \times [0,1].$$

For $0 < \epsilon < 1$, set

$$\widetilde{F}_{\epsilon}(t) = \frac{i}{\epsilon+i} e^{\epsilon t \Delta} \left(\widetilde{V}(t) \widetilde{u}(t) \right)$$

and

(4.26)
$$\widetilde{u}_{\epsilon}(t) = e^{(\epsilon+i)t\Delta}\widetilde{u}(0) + (\epsilon+i)\int_{0}^{t} e^{(\epsilon+i)(t-s)\Delta}\widetilde{F}_{\epsilon}(s)\,ds.$$

The identities [14]

$$e^{(z_1+z_2)\triangle} = e^{(z_2+z_1)\triangle} = e^{z_1\triangle}e^{z_2\triangle}$$
, when $\Re z_1, \Re z_2 \ge 0$,

(4.24), (4.25) and (4.26) show that

(4.27)
$$\widetilde{u}_{\epsilon}(t) = e^{\epsilon t \bigtriangleup} \widetilde{u}(t) , \text{ when } 0 \le t \le 1$$

and from Lemma 1 with $A + iB = \epsilon$, (4.27) and (4.25),

(4.28)
$$\sup_{[0,1]} \|e^{\gamma_{\epsilon}|x|^{2}} \widetilde{u}_{\epsilon}(t)\| \leq \sup_{[0,1]} \|e^{\gamma|x|^{2}} \widetilde{u}(t)\|, \\ \sup_{[0,1]} \|e^{\gamma_{\epsilon}|x|^{2}} \widetilde{F}_{\epsilon}(t)\| \leq e^{\sup_{[0,1]} \|\widetilde{V}(t)\|_{\infty}} \sup_{[0,1]} \|e^{\gamma|x|^{2}} \widetilde{u}(t)\|,$$

when $\gamma_{\epsilon} = \frac{\gamma}{1+4\gamma\epsilon}$. Then, Lemma 4, (4.28) and (4.23) show that

$$\begin{split} \|\sqrt{t(1-t)} e^{\gamma_{\epsilon}|x|^{2}} \nabla \widetilde{u}_{\epsilon}\|_{L^{2}(\mathbb{R}^{n}\times[0,1])} + \|\sqrt{t(1-t)} |x| e^{\gamma_{\epsilon}|x|^{2}} \widetilde{u}_{\epsilon}\|_{L^{2}(\mathbb{R}^{n}\times[0,1])} \\ & \leq N e^{N \sup_{[0,1]} \|V(t)\|_{\infty}} \left[\|e^{\frac{|x|^{2}}{\beta^{2}}} u(0)\| + \|e^{\frac{|x|^{2}}{\alpha^{2}}} u(1)\| + \sup_{[0,1]} \|u(t)\| \right]. \end{split}$$

The Lemma follows from this inequality, (4.22), (4.23), (4.21) and letting ϵ tend to zero.

5. A HARDY TYPE UNCERTAINTY PRINCIPLE. PROOF OF THEOREM 1.

As we mentioned in the introduction, the motivation behind the Carleman inequality in Lemma 7 below is the following monotonicity or frequency function argument related to Lemma 2:

When u in $C([0, 1], L^2(\mathbb{R}^n))$ is a free solution to the free Schrödinger equation

$$\partial_t u - i \Delta u = 0$$
, in $\mathbb{R}^n \times [0, 1]$,

 $||e^{\gamma|x|^2}u(0)||, ||e^{\gamma|x|^2}u(1)||$ are both finite, $f = e^{\mu|x+Rt(1-t)|^2 - \frac{R^2t(1-t)}{8\mu}}u$ and H = (f, f). Then, $\log H$ is logarithmically convex in [0, 1], when $0 < \mu < \gamma$.

The formal application of the above argument to a $C([0,1], L^2(\mathbb{R}^n))$ solution to (5.1) $\partial_t u - i (\Delta u + V(x,t)u) = 0$, in $\mathbb{R}^n \times [0,1]$,

implies a similar result, when V is a bounded potential, though the justification of the correctness of the manipulations involved in the corresponding formal application of Lemma 2 are not obvious to us. In fact, we can only justify these manipulations, when the potential V verifies the first condition in Theorem 1 or when we can obtain the additional regularity of the gradient of u in the strip, as in Theorem 5. Here, we choose to prove Theorem 1 using the Carleman inequality in Lemma 7 in place of the above convexity argument. The reason for our choice is that it is simpler to justify the correctness of the application of the Carleman inequality to a $C([0, 1], L^2(\mathbb{R}^n))$ solution to (5.1) than the corresponding monotonicity or logarithmic convexity of the solution.

Lemma 7. The inequality

$$\begin{split} R\sqrt{\frac{\epsilon}{8\mu}} \, \|e^{\mu|x+Rt(1-t)e_1|^2 - \frac{(1+\epsilon)R^2t(1-t)}{16\mu}}g\|_{L^2(\mathbb{R}^{n+1})} \leq \\ \|e^{\mu|x+Rt(1-t)e_1|^2 - \frac{(1+\epsilon)R^2t(1-t)}{16\mu}} (\partial_t - i\triangle)g\|_{L^2(\mathbb{R}^{n+1})} \end{split}$$

holds, when $\epsilon > 0$, $\mu > 0$, R > 0 and $g \in C_0^{\infty}(\mathbb{R}^{n+1})$.

Proof. Let

and from (2.12), (2.13) and (2.14) with $\gamma = 1, A + iB = i$ and

$$\varphi(x,t) = \mu |x + Rt(1-t)|^2 - \frac{(1+\epsilon)R^2t(1-t)}{16\mu},$$

we have

$$\begin{split} \mathcal{S} &= -4\mu i \left(x + Rt(1-t)e_1 \right) \cdot \nabla - 2\mu n i \\ &\quad + 2\mu R(1-2t) \left(x_1 + Rt(1-t) \right) - \frac{(1+\epsilon)R^2(1-2t)}{16\mu}, \\ \mathcal{A} &= i \triangle + 4\mu^2 i | x + Rt(1-t)e_1 |^2, \\ \mathcal{S}_t &+ [\mathcal{S},\mathcal{A}] = -8\mu \triangle + 32\mu^3 | x + Rt(1-t)e_1 |^2 - 4\mu R \left(x_1 + Rt(1-t) \right) \\ &\quad + 2\mu R^2 (1-2t)^2 + \frac{(1+\epsilon)R^2}{8\mu} - 4i\mu R(1-2t)\partial_{x_1} \end{split}$$

and

(5.2)

$$(\mathfrak{S}_t f + [\mathfrak{S}, \mathcal{A}]f, f) = 32\mu^3 \int |x + Rt(1 - t)e_1 - \frac{R}{16\mu^2}e_1|^2|f|^2 \, dx + \frac{\epsilon R^2}{8\mu} \int |f|^2 \, dx + 8\mu \int |i\partial_{x_1}f - \frac{R(1 - 2t)}{2}f|^2 \, dx \ge \frac{\epsilon R^2}{8\mu} \int |f|^2 \, dx.$$

Following the standard method to handle L^2 -Carleman inequalities [6], the symmetric and skew-symmetric parts of $\partial_t - S - A$, as a space-time operator, are respectively -S and $\partial_t - A$, and its space-time commutator, $[-S, \partial_t - A]$ is $S_t + [S, A]$. Thus,

$$(5.3) \quad \|\partial_t f - \mathbb{S}f - \mathcal{A}f\|_{L^2(\mathbb{R}^{n+1})}^2 = \|\partial_t f - \mathcal{A}f\|_{L^2(\mathbb{R}^{n+1})}^2 + \|\mathbb{S}f\|_{L^2(\mathbb{R}^{n+1})}^2 \\ - 2Re \iint \mathbb{S}f\overline{\partial_t f} - \mathcal{A}f \, dxdt \ge \iint [-\mathbb{S}, \partial_t - \mathcal{A}]f\overline{f} \, dxdt = \int (\mathbb{S}_t f + [\mathbb{S}, \mathcal{A}]f, f) \, dt,$$

and the Lemma 7 follows from (5.3) and (5.2). \Box

Proof of Theorem 1. Let u be as in Theorem 1 and \tilde{u}, \tilde{V} the corresponding functions defined in Lemma 5, when A + iB = i. Then, \tilde{u} is in $C([0, 1], L^2(\mathbb{R}^n))$,

$$\partial_t \widetilde{u} = i \left(\bigtriangleup \widetilde{u} + \widetilde{V}(x,t) \widetilde{u} \right) \ , \ \text{in } \mathbb{R}^n \times [0,1],$$

 $||e^{\gamma|x|^2}\widetilde{u}(0)||$, $||e^{\gamma|x|^2}\widetilde{u}(1)||$ are finite for $\gamma = \frac{1}{\alpha\beta}$ and $\gamma > \frac{1}{2}$. The proofs of Theorem 3 or 5 show that in either case

(5.4)
$$N_{\gamma} = \sup_{[0,1]} \|e^{\gamma|x|^2} \widetilde{u}(t)\| + \|\sqrt{t(1-t)}e^{\gamma|x|^2} \nabla \widetilde{u}\|_{L^2(\mathbb{R}^n \times [0,1])} < +\infty.$$

For given R > 0, choose μ and ϵ such that

(5.5)
$$\frac{(1+\epsilon)^{\frac{\gamma}{2}}}{2(1-\epsilon)^3} < \mu \le \frac{\gamma}{(1+\epsilon)}$$

and let θ_M and η_R be smooth functions verifying, $\theta_M(x) = 1$, when $|x| \leq M$, $\theta_M(x) = 0$, when |x| > 2M, $M \geq R$, $\eta_R \in C_0^{\infty}(0,1)$, $0 \leq \eta_R \leq 1$, $\eta_R(t) = 1$ in $[\frac{1}{R}, 1 - \frac{1}{R}]$ and $\eta_R = 0$ in $[0, \frac{1}{2R}] \cup [1 - \frac{1}{2R}, 1]$. Then,

$$g(x,t) = \theta_M(x)\eta_R(t)\widetilde{u}(x,t),$$

is compactly supported in $\mathbb{R}^n \times (0, 1)$ and

(5.6)
$$\partial_t g - i\left(\triangle g + \widetilde{V}g\right) = \theta_M \eta'_R \widetilde{u} - i(2\nabla \theta_M \cdot \nabla \widetilde{u} + \widetilde{u} \triangle \theta_M) \eta_R.$$

The first term on the right hand side of (5.6) is supported, where

$$\mu |x + Rt(1-t)|^2 \le \mu (1+\epsilon) |x|^2 + \mu \left(1 + \frac{1}{\epsilon}\right) \le \gamma |x|^2 + \frac{\gamma}{\epsilon}$$

and the second, inside $B_{2M} \setminus B_M \times [\frac{1}{2R}, 1 - \frac{1}{2R}]$, where

$$\mu |x + Rt(1-t)e_1|^2 \le \gamma |x|^2 + \frac{\gamma R^2}{\epsilon}$$

Apply now Lemma 7 to g with the values of μ and ϵ chosen in (5.5). This, the bounds for $\mu |x+Rt(1-t)e_1|^2$ in each of the parts of the support of $\partial_t g - i\left(\bigtriangleup g + \widetilde{V}g \right)$ and the natural bounds for $\nabla \theta_M$, $\bigtriangleup \theta_M$ and η'_R show that there is a constant N_{ϵ} such that

$$\begin{aligned} R \| e^{\mu |x + Rt(1-t)e_1|^2 - \frac{(1+\epsilon)R^2t(1-t)}{16\mu}} g \|_{L^{\infty}(\mathbb{R}^n \times [0,1])} &\leq \\ N_{\epsilon} \| \widetilde{V} \|_{L^{\infty}(\mathbb{R}^n \times [0,1])} \| e^{\mu |x + Rt(1-t)e_1|^2 - \frac{(1+\epsilon)R^2t(1-t)}{16\mu}} g \|_{L^2(\mathbb{R}^n \times [0,1])} \\ &+ N_{\epsilon} R e^{\frac{\gamma}{\epsilon}} \sup_{[0,1]} \| e^{\gamma |x|^2} \widetilde{u}(t) \| + N_{\epsilon} M^{-1} e^{\frac{\gamma R^2}{\epsilon}} \| e^{\gamma |x|^2} \left(|\widetilde{u}| + |\nabla \widetilde{u}| \right) \|_{L^2(\mathbb{R}^n \times [\frac{1}{2R}, 1 - \frac{1}{2R}])} \end{aligned}$$

The first term on the right hand side of (5.7) can be hidden in the left hand side, when $R \geq 2N_{\epsilon} \|\widetilde{V}\|_{L^{\infty}(\mathbb{R}^n \times [0,1])}$, while the last tends to zero, when M tends to infinity by (5.4). This and the fact that $g = \widetilde{u}$ in $B_{\frac{\epsilon(1-\epsilon)^2 R}{4}} \times [\frac{1-\epsilon}{2}, \frac{1+\epsilon}{2}]$, where

$$\mu |x + Rt(1-t)e_1|^2 - \frac{(1+\epsilon)R^2t(1-t)}{16\mu} \ge \frac{R^2}{16\mu} \left(4\mu^2(1-\epsilon)^6 - (1+\epsilon)^3\right)$$

and (5.5) show that

(5.8)
$$Re^{C(\gamma,\epsilon)R^2} \|\widetilde{u}\|_{L^2(B_{\frac{R}{8}} \times [\frac{1-\epsilon}{2}, \frac{1+\epsilon}{2}])} \le N_{\gamma,\epsilon}R,$$

when $R \geq 2N_{\epsilon} \|\widetilde{V}\|_{L^{\infty}(\mathbb{R}^n \times [0,1])}$. At the same time,

 $(5.9) \quad N^{-1} \| \widetilde{u}(0) \| \le \| \widetilde{u}(t) \| \le N \| \widetilde{u}(0) \| \ , \ \text{when} \ 0 \le t \le 1 \ , \ N = e^{\sup_{[0,1]} \| \Im \widetilde{V}(t) \|_{\infty}},$

and from (5.4)

(5.10)
$$\|\widetilde{u}(t)\| \le \|\widetilde{u}(t)\|_{L^2(B_{\frac{R}{8}})} + e^{-\frac{\gamma R^2}{64}}N_{\gamma}$$
, when $0 \le t \le 1$.

Then, (5.8), (5.9) and (5.10) show that there is a constant $N_{\gamma,\epsilon,V}$, which depends on N_{γ} , ϵ and the $\sup_{[0,1]} \|V(t)\|_{\infty}$, such that

$$e^{C(\gamma,\epsilon)R^2} \|\widetilde{u}(0)\| \le N_{\gamma,\epsilon,V}.$$

Let then R tend to infinity to derive that $u \equiv 0$.

6. A POSITIVE COMMUTATOR AND A MISLEADING FREQUENCY FUNCTION

When $f = e^{a(t)|x|^2}u$ and u is solution to the free Schrödinger equation in $\mathbb{R} \times [-1,1]$, f verifies $\partial_t f = Sf + Af$, with symmetric and skew-symmetric operators,

$$\mathcal{S} = -4ia\left(x\partial_x + \frac{1}{2}\right) + a'x^2 \quad , \quad \mathcal{A} = i\left(\partial_x^2 + 4a^2x^2\right).$$

In this case (See (2.14))

$$\mathcal{S}_t + [\mathcal{S}, \mathcal{A}] = \frac{2a'}{a}\mathcal{S} - 8a\partial_x^2 + \left(32a^3 + a'' - \frac{2a'^2}{a}\right)x^2,$$

and if a is a positive and even solution of

(6.1)
$$32a^3 + a'' - \frac{2a'^2}{a} = 0$$
, in $[-1, 1]$,

the formal calculations in Lemma 2 show that $H_a(t) = ||e^{a(t)x^2}u(t)||^2$ verifies

$$\partial_t \left(a^{-2} \partial_t \log H_a(t) \right) \ge 0, \text{ in } [-1, 1],$$

and the integration of the inequality

$$a^2(\tau)\partial_s \log H_a(s) \le a^2(s)\partial_\tau \log H_a(s)$$
, when $-1 \le s \le 0 \le \tau \le 1$,

implies that

(6.2)
$$H_a(0) \le H_a(-1)^{\frac{1}{2}} H_a(1)^{\frac{1}{2}}.$$

On the other hand, if a solves

$$\begin{cases} 32a^3 + a'' - \frac{2a'^2}{a} = 0, \\ a(0) = 1, a'(0) = 0, \end{cases}$$

a is positive, even and $\lim_{R\to+\infty} Ra(R) = 0$. Moreover, $a_R(t) = Ra(Rt)$ also solves (6.1), and if the formal calculation is correct for H_{a_R} , (6.2) would imply that

$$\|e^{Rx^2}u(0)\|^2 \le \|e^{Ra(R)x^2}u(-1)\|\|e^{Ra(R)x^2}u(1)\|.$$

In particular, $u \equiv 0$; but

$$u(x,t) = (t-i)^{-\frac{1}{2}} e^{\frac{i|x|^2}{4(t-i)}}$$

contradicts this

This shows that there are functions φ , which make non-negative the commutator of the symmetric and skew-symmetric parts of $e^{\varphi} \left(\partial_t - i\partial_x^2\right) e^{-\varphi}$ and such that it is not possible to plug in or enter in the associated Carleman inequality or frequency function some reasonable solutions of the free Schrödinger equation. It also shows that the rather complex arguments we used to derive the logarithmic convexity of

$$H(t) = \int_{\mathbb{R}^n} e^{2\gamma |x|^2} |u(t)|^2 dx,$$

are in fact necessary, when u in $C([0,1], L^2(\mathbb{R}^n))$ is a solution verifying the conditions in Lemma 3 and as long as a more suitable representation formula for these solutions is not available. By suitable we mean a formula which allows to derive the quadratic exponential decay of the solution in the interior of a time slab from the known decay of the solution at the top and bottom of the slab.

7. PARABOLIC ANALOG. PROOF OF THEOREM 4

Assume that u verifies the conditions in Theorem 4 and let \tilde{u} be the conformal or Appel transformation of u defined in Lemma 5 with A + iB = 1, $\alpha = 1$ and $\beta = 1 + \frac{2}{\delta}$. \tilde{u} is in $L^{\infty}([0,1]), L^{2}(\mathbb{R}^{n})) \cap L^{2}([0,T], H^{1}(\mathbb{R}^{n}))$, verifies

$$\partial_t \widetilde{u} = \Delta \widetilde{u} + \widetilde{V}(x,t)\widetilde{u}, \text{ in } \mathbb{R}^n \times (0,1)$$

with \widetilde{V} a bounded potential in $\mathbb{R}^n \times [0,1]$ and if $\gamma = \frac{1}{2\delta}$, we have

$$||e^{\gamma|x|^2}\widetilde{u}(0)|| = ||u(0)||$$
, $||e^{\gamma|x|^2}\widetilde{u}(1)|| = ||e^{\frac{|x|^2}{\delta^2}}u(1)||$

From Lemma 3 and Lemma 4 with A + iB = 1, we have

(7.1)
$$\sup_{[0,1]} \|e^{\gamma \|x\|^{2}} \widetilde{u}(t)\| + \|\sqrt{t(1-t)}e^{\gamma \|x\|^{2}} \nabla \widetilde{u}\|_{L^{2}(\mathbb{R}^{n} \times [0,1])} \leq e^{N(M_{1}+M_{1}^{2})} \left(\|e^{\gamma \|x\|^{2}} \widetilde{u}(0)\| + \|e^{\gamma \|x\|^{2}} \widetilde{u}(1)\|\right)$$

where $M_1 = \|\widetilde{V}\|_{L^{\infty}(\mathbb{R}^n \times [0,1])}$. The proof is finished by pluging in

$$g(x,t) = \theta_M(x)\eta_R(t)\widetilde{u}(x,t)$$

in the Carleman inequality below and in complete analogy with the argument we used to prove Theorem 1.

Lemma 8. The inequality

$$R\sqrt{\frac{\epsilon}{8\mu}} \|e^{\mu|x+Rt(1-t)e_1|^2 + \frac{R^2t(1-t)(1-2t)}{6} - \frac{(1+\epsilon)R^2t(1-t)}{16\mu}}g\|_{L^2(\mathbb{R}^{n+1})} \le \|e^{\mu|x+Rt(1-t)e_1|^2 + \frac{R^2t(1-t)(1-2t)}{6} - \frac{(1+\epsilon)R^2t(1-t)}{16\mu}}(\partial_t - \Delta)g\|_{L^2(\mathbb{R}^{n+1})}$$

holds, when $\epsilon > 0$, $\mu > 0$, R > 0 and $g \in C_0^{\infty}(\mathbb{R}^{n+1})$.

Proof. Let
$$f = e^{\mu |x + Rt(1-t)e_1|^2 + \frac{R^2 t(1-t)(1-2t)}{6} - \frac{(1+\epsilon)R^2 t(1-t)}{16\mu}} g$$
. Then,
 $\mu |x + Rt(1-t)e_1|^2 + \frac{R^2 t(1-t)(1-2t)}{6} - \frac{(1+\epsilon)R^2 t(1-t)}{16\mu} g$. Then,

 $e^{\mu|x+Rt(1-t)e_1|^2 + \frac{R^2t(1-t)(1-2t)}{6} - \frac{(1+t)(1-t)}{16\mu}} (\partial_t - \Delta) g = \partial_t f - Sf - \mathcal{A}f,$

and from (2.12), (2.13) and (2.14) with
$$\gamma = 1$$
, $A + iB = 1$ and

$$\varphi(x,t) = \mu |x + Rt(1-t)e_1|^2 + \frac{R^2 t(1-t)(1-2t)}{6} - \frac{(1+\epsilon)R^2 t(1-t)}{16\mu} ,$$

we have

$$\begin{split} & \mathcal{S} = \triangle + 4\mu^2 | x + Rt(1-t)e_1 |^2 + 2\mu R(1-2t) \left(x_1 + Rt(1-t) \right) \\ & + \left(t^2 - t + \frac{1}{6} \right) R^2 - \frac{(1+\epsilon)R^2(1-2t)}{16\mu}, \\ & \mathcal{A} = -4\mu \left(x + Rt(1-t)e_1 \right) \cdot \nabla - 2\mu n, \\ & \mathcal{S}_t + [\mathcal{S}, \mathcal{A}] = -8\mu \triangle + 32\mu^3 | x + Rt(1-t)e_1 |^2 + 2\mu R^2(1-2t)^2 \\ & + 4\mu R(4\mu(1-2t)-1)(x_1 + Rt(1-t)) + (2t-1)R^2 + \frac{(1+\epsilon)R^2}{8\mu} \end{split}$$

and

(7.2)
$$(\mathfrak{S}_t f + [\mathfrak{S}, \mathcal{A}]f, f) = 32\mu^3 \int |x + Rt(1-t)e_1 + \frac{(4\mu(1-2t)-1)R}{16\mu^2} e_1|^2 |f|^2 dx \\ + 8\mu \int |\nabla f|^2 dx + \frac{\epsilon R^2}{8\mu} \int |f|^2 dx \ge \frac{\epsilon R^2}{8\mu} \int |f|^2 dx.$$

Finally,

$$\varphi(x, \frac{1}{2}) = \mu |x + \frac{R}{4}e_1|^2 - \frac{(1+\epsilon)R^2}{64\mu} \ge (4\mu^2(1-\epsilon)^2 - (1+\epsilon))\frac{R^2}{64\mu},$$

when $|x| \leq \frac{\epsilon R}{4}$, and it is positive for $\mu > \frac{1}{2}$ and $\epsilon > 0$ small.

Remark 2. (7.1), (7.2) and the interior regularity of parabolic equations show that the formal calculations in Lemma 2 to prove the logarithmic convexity of

$$H_{\mu}(t) = \int_{\mathbb{R}^n} e^{2\mu |x + Rt(1-t)e_1|^2 + \frac{R^2 t(1-t)(1-2t)}{3} - \frac{R^2 t(1-t)}{8\mu}} |\widetilde{u}(t)| \, dx$$

are correct, when $\mu < \gamma$. In particular,

$$H_{\mu}(\frac{1}{2}) \le e^{N(M_1 + M_1^2)} H_{\mu}(0)^{\frac{1}{2}} H_{\mu}(1)^{\frac{1}{2}}$$

and letting μ increase to γ and then R tend to infinity, one also gets that $\tilde{u} \equiv 0$ in $\mathbb{R}^n \times [0, 1]$, when $\gamma > \frac{1}{2}$.
