RENORMALIZATION IN THE HÉNON FAMILY, II: THE HETEROCLINIC WEB

ABSTRACT. We study highly dissipative Hénon maps

$$
F_{c,b}: (x,y) \mapsto (c-x^2 - by, x)
$$

with zero entropy. They form a region Π in the parameter plane bounded on the left by the curve W of infinitely renormalizable maps. We prove that Morse-Smale maps are dense in Π , but there exist infinitely many different topological types of such maps (even away from W). We also prove that in the infinitely renormalizable case, the average Jacobian b_F on the attracting Cantor set \mathcal{O}_F is a topological invariant. These results come from the analysis of the heteroclinic web of the saddle periodic points based on the renormalization theory. Along these lines, we show that the unstable manifolds of the periodic points form a lamination outside \mathcal{O}_F if and only if there are no heteroclinic tangencies.

1. INTRODUCTION

The renormalization theory for the Hénon family began with the works of Collet, Eckman and Koch and Gambaudo, van Strien and Tresser [\[CEK\]](#page-66-1), [\[GST\]](#page-66-2). In this paper we continue our exploration of renormalization of Hénon maps started in [\[CLM\]](#page-66-3). As Part I was mostly concerned with geometric properties of the Cantor attractor \mathcal{O}_F , here we focus on global topological properties of the maps in question that are essentially determined by the structure of the web of the stable/unstable manifolds of saddle periodic points (we call it the "heteroclinic web"). As in Part I, we have encountered here some surprising phenomena.

In the one-dimensional situation, all infinitely renormalizable maps with the same combinatorics are topologically equivalent. It is not anymore the case in the Hénon family; in fact, all infinitely renormalizable Hénon maps near the Feigenbaum point are topologically distinct. More generally, the average Jacobian b_F of a Hénon-like map is a topological invariant: varying b_F leads to bifurcations in the heteroclinic web (§9).

Along these lines, we carry out a detailed analysis of the heteroclinic web. In particular, we show that the unstable manifolds form a lamination (outside the attractor \mathcal{O}_F) if and only if there are no heteroclinic tangencies $(\S_{\frac{1}{2}}, \S_{\frac{1}{2}})$. We also show that the orbit of the "tip" of \mathcal{O}_F (a counterpart of the critical value of one-dimensional maps) is topologically distinguished: it is respected by topological conjugacies $(§5).$

Infinitely renormalizable maps in question separate the regions with regular (zero entropy) and chaotic (positive entropy) dynamics, [\[GST\]](#page-66-2). Because of the Newhouse phenomenon, hyperbolic maps are not dense in the chaotic region. However, it is conceivable that they are dense in the regular region. We confirm this conjecture in a narrow strip to the left of the curve of infinitely renormalizable maps: Morse-Smale maps are dense over there $(\S10)$. However, the situation is quite intricate, as there are infinitely many different types of Morse-Smale maps in this region. In particular, a boundary arc of a Morse-Smale component which is not related to the longest periodic orbit is accumulated by infinitely many different Morse-Smale components.

Remark 1.1. The maps in the region we consider, a narrow strip to the left of the curve of infinitely renormalizable maps, do not have homoclinic intersections. Previous results in [\[PS\]](#page-66-4) and [\[C\]](#page-66-5) imply that maps in this region can be $C¹$ approximated by Morse-Smale maps.

Figure 1.1. Bifurcation pattern

The results of §10 are illustrated in Figure [1.1.](#page-49-0) It shows an artist's impression of parts of the bifurcation pattern of a Hénon family in a neighborhood of W, the curve of infinitely renormalizable maps. The strip I_m consists of the m-times renormalizable maps. The bottom Morse-Smale component M_m is attached to the m-times renormalizable unimodal maps. The curves $\mathcal{K}_{\cdot,\cdot}$ illustrate loci of heteroclinic tangencies.

2. Preliminaries

The precise definitions and proofs of the following statements can be found in part I, see [\[CLM\]](#page-66-3), of this series on renormalization of Hénon maps.

Let $\Omega^h, \Omega^v \subset \mathbb{C}$ be neighborhoods of $[-1, 1] \subset \mathbb{R}$ and $\Omega = \Omega^h \times \Omega^v$. Let $B = [-1, 1] \times [-1, 1]$ and $\bar{\epsilon} > 0$. The set $\mathcal{H}_{\Omega}(\bar{\epsilon})$ consists of maps $F : B \to B$ of the following form.

$$
F(x, y) = (f(x) - \epsilon(x, y), x),
$$

where $f : [-1, 1] \rightarrow [-1, 1]$ is a unimodal map which admits a holomorphic extension to Ω^h and $\epsilon : B \to \mathbb{R}$ admits a holomorphic extension to Ω and finally, $|\epsilon| \leq \overline{\epsilon}$. The critical point c of f is non degenerate, $Df(c) < 0$. A map in $\mathcal{H}_{\Omega}(\bar{\epsilon})$ is called a *Hénon-like* map. Observe that Hénon-like maps map vertical lines to horizontal lines.

A unimodal map $f : [-1,1] \rightarrow [-1,1]$ with critical point $c \in [-1,1]$ is renormalizable if $f^2: [f^2(c), f^4(c)] \to [f^2(c), f^4(c)]$ is unimodal and $[f^2(c), f^4(c)] \cap f([f^2(c), f^4(c)]) = \emptyset$. The renormalization of f is the affine rescaling of f^2 |([$f^2(c)$, $f^4(c)$], denoted by Rf. The domain of Rf is again $[-1, 1]$. The renormalization operator R has a unique fixed point $f_* : [-1,1] \rightarrow [-1,1]$. The introduction of [\[FMP\]](#page-66-6) presents the history of renormalization of unimodal maps and describes the main results.

The *scaling factor* of this fixed point f_* is

$$
\sigma = \frac{|[f_*^2(c), f_*^4(c)]|}{|[-1, 1]|}.
$$

We will also need $\lambda = 1/\sigma = 2.6 \dots$.

A Hénon map is renormalizable if there exists a domain $D \subset B$ such that $F^2: D \to D$. The construction of the domain D is inspired by renormalization of unimodal maps. In particular, it is a topological construction. However, for small $\bar{\epsilon} > 0$ the actual domain $A \subset B$, used to renormalize as was done in [\[CLM\]](#page-66-3), has an analytical definition. The precise definition can be found in §3.5 of part I. If the renormalizable Hénon maps is given by $F(x, y) = (f(x) - \epsilon(x, y))$ then the domain $A \subset B$, an essentially vertical strip, is bounded by two curves of the form

$$
f(x) - \epsilon(x, y) = \text{Const.}
$$

These curves are graphs over the y-axis with a slope of the order $\bar{\epsilon} > 0$. The domain A satisfies similar combinatorial properties as the domain of renormalization of a unimodal map:

$$
F(A) \cap A = \emptyset,
$$

and

$$
F^2(A) \subset A.
$$

Unfortunately, the restriction $F^2|A$ is not a Hénon-like map as it does not map vertical lines into horizontal lines. This is the reason why the coordinated change needed to define the renormalization of F is not an affine map, but it rather has the following form. Let

$$
H(x, y) = (f(x)) - \epsilon(x, y), y)
$$

and

$$
G = H \circ F^2 \circ H^{-1}.
$$

The map H preserves horizontal lines and it is designed in such a way that the map G maps vertical lines into horizontal lines. Moreover, G is well defined on a rectangle $U \times [-1, 1]$ of full height. Here $U \subset [-1, 1]$ is an interval of length $2/|s|$ with $s < -1$. Let us rescale the domain of G by the s-dilation Λ , such that the rescaled domain is of the form $[-1, 1] \times V$, where $V \subset \mathbb{R}$ is an interval of length $2/|s|$. Define the renormalization of F by

$$
RF = \Lambda \circ G \circ \Lambda^{-1}.
$$

Notice that RF is well defined on the rectangle $[-1, 1] \times V$. The coordinate change $\phi = H^{-1} \circ \Lambda^{-1}$ maps this rectangle onto the topological rectangle A of full height.

The set of *n*-times renormalizable maps is denoted by $\mathcal{H}^n_{\Omega}(\overline{\epsilon}) \subset$ $\mathcal{H}_{\Omega}(\overline{\epsilon})$. If $F \in \mathcal{H}_{\Omega}^{n}(\overline{\epsilon})$ we use the notation

$$
F_n = R^n F.
$$

The set of infinitely renormalizable maps is denoted by

$$
\mathcal{I}_\Omega(\overline{\epsilon})=\bigcap_{n\geq 1}\mathcal{H}_\Omega^n(\overline{\epsilon}).
$$

The collection of maps in $\mathcal{H}^n_{\Omega}(\bar{\epsilon})$ which have a periodic attractor of period 2^n is denoted by $\mathcal{I}_{\Omega}^n(\overline{\epsilon})$.

The renormalization operator acting on $\mathcal{H}^1_{\Omega}(\bar{\epsilon}), \bar{\epsilon} > 0$ small enough, has a unique fixed point $F_* \in \mathcal{I}_{\Omega}(\bar{\epsilon})$. It is the degenerate map

$$
F_*(x, y) = (f_*(x), x).
$$

This renormalization fixed point is hyperbolic and the stable manifold has codimension one. Moreover,

$$
W^s(F_*)=\mathcal{I}_{\Omega}(\overline{\epsilon}).
$$

If we want to emphasize that some set, say A , is associated with a certain map F we use notation like $A(F)$.

The coordinate change which conjugates $F_k^2|A(F_k)$ to F_{k+1} is denoted by

(2.1)
$$
\phi_v^k = (\Lambda_k \circ H_k)^{-1} : \text{Dom}(F_{k+1}) \to A(F_k).
$$

Here H_k is the non-affine part of the coordinate change used to define $R^{k+1}F$ and Λ_k is the dilation by $s_k < -1$. Now, for $k < n$, let

$$
(2.2) \qquad \Phi_k^n = \phi_v^k \circ \phi_v^{k+1} \circ \cdots \circ \phi_v^{n-1} : \text{Dom}(F_n) \to A_{n-k}(F_k),
$$

where

$$
A_k(F) = \Phi_0^k(\text{Dom}(F_k)) \cap B.
$$

Notice, that each $A_k \subset B$ is of full height and Φ_0^k conjugates $R^k F$ to $F^{2^k}|A_k$. Furthermore, $A_{k+1} \subset A_k$.

Let $n \geq 1$ and $F \in \mathcal{H}_{\Omega}^{n}(\overline{\epsilon})$. The domain of $R^{n}F$ is

$$
\Omega_n = \Omega_n^h \times \Omega_n^v,
$$

where $[-1, 1] \subset \Omega_n^h$. Furthermore, $R^n F(x, y) = (f_n(x) - \epsilon_n(x, y), x)$.

Lemma 2.1. Given Ω and $\bar{\epsilon} > 0$ small enough, there exist $r > 1$ and $C > 0$ such that for every $F \in \mathcal{H}_{\Omega}^{n}(\overline{\epsilon})$

$$
\text{diam}(\Omega_n) \leq C \cdot r^n.
$$

Proof. Let $k < n$. The maps $f_k | \Omega_k^h$ stay within a compact family and $|\epsilon_k| = O(\bar{\epsilon}^{2^k})$. This is explained in §4 of [\[CLM\]](#page-66-3). Hence, the coordinate changes $\Lambda_k \circ H_k$ used to define $R^{k+1}F$ as a renormalization of R^kF has a uniform bound on its derivative. The Lemma follows.

Remark 2.1. For an infinitely renormalizable map $F \in \mathcal{I}_{\Omega}(\bar{\epsilon})$ the diameters of Ω_n grow exponentially. In particular

$$
\text{diam}(\Omega_n^v) \asymp \lambda^n,
$$

where $\lambda = 1/\sigma = 2.6...$ and σ the scaling factor of the unimodal renormalization fixed point. Let $\Phi_k^{k+1} : \Omega_{k+1} \to \Omega_k$ be the diffeomorphism which conjugates $R^{k+1}F$ to $(R^kF)^2|A(R^kF)$. The inverse of this diffeomorphism was constructed in §3.5 of [\[CLM\]](#page-66-3). In fact,

$$
(\Phi_k^{k+1})^{-1} = \Lambda_k \circ H_k,
$$

where $H_k(x, y) = (f_k(x) - \epsilon_k(x, y), y)$ and Λ_k is a dilation. The scaling factor s_k of Λ_k converges exponentially fast: $s_k \to -\lambda$. This is shown in Lemma 7.4 of [\[CLM\]](#page-66-3). In particular,

$$
diam(\Omega_{k+1}^v) = |s_k| \cdot diam(\Omega_k^v).
$$

Let

$$
B_{v^n} = \Phi_0^n(B).
$$

Notice, for $k < n$

$$
B_{v^{k+1}} \subset B_{v^k}.
$$

An infinitely renormalizable Hénon-like map has an invariant Cantor set:

$$
\mathcal{O}_F = \bigcap_{n \geq 1} \bigcup_{i=0}^{2^n - 1} F^i(B_{v^n}).
$$

Its geometry was discussed in part I. The dynamics on this Cantor set is conjugate to an adding machine. Its unique invariant measure is denoted by μ . The *average Jacobian*

$$
b_F = \exp \int \log \text{Jac } F d\mu
$$

with respect to μ is an important parameter that essentially influences the geometry of \mathcal{O}_F , see [\[CLM\]](#page-66-3).

The critical point (and critical value) of a unimodal map plays a crucial role in its dynamics. The counterpart of the critical value for Hénon-like maps is the tip

$$
\{\tau_F\}=\bigcap_{n\geq 1}B_{v^n}.
$$

The convergence $R^nF \to F_*$ is exponential, $F \in \mathcal{I}_{\Omega}(\overline{\epsilon})$. Theorem 7.9 of [\[CLM\]](#page-66-3) gives a precise asymptotical form of the convergence. Namely,

(2.3)
$$
R^{n} F(x, y) = (f_{n}(x) - b_{F}^{2^{n}} a(x)y(1 + O(\rho^{n})), x).
$$

The analytic function $a(x)$ is universal, independent of F, and positive, and $\rho < 1$. The unimodal part converges exponentially fast: $f_n \to f_*$.

We will use the following general notions and notations throughout the text.

A ball in a metric space of radius $r > 0$ and centered at x is denoted by $B_r(x)$. The diameter of a set is denoted by diam(\cdot). Let π_1 : $X \times Y \to X$ and $\pi_2 : X \times Y \to Y$ be the projections to resp. the first and second factor.

The graph of a function $\phi: X \to Y$ is denoted by graph (ϕ) . The domain of a map F is denoted by $Dom(F)$. The image is denoted by $\text{Im}(F) = F(\text{Dom}(F)).$

The tangent space at a point $x \in W$ of a smooth curve $W \subset \mathbb{R}^2$ is denoted by T_xW . If two submanifolds M_1 and M_2 (of M) are tangent at some point we write

 $M_1 \sqcap \sqcap M_2$.

If we want to specify a point of tangency $x \in M_1 \cap M_2$ we write

$$
M_1 \cap_{x} M_2.
$$

The forward orbit of a point or set is denoted by $Orb(\cdot) = \bigcup_{k \geq 0} f^k(\cdot)$. If a point has also a complete backward orbit then the backward and forward orbit together is denoted by $Orb_{\mathbb{Z}}(\cdot)$. The limit set of a point $x \in \text{Dom}(F)$ is denoted by $\omega(x)$. If a point $x \in \text{Dom}(F)$ has an infinite backward orbit then the limit set of this backward orbit is denoted by $\alpha(x)$. The cycle of a periodic point β , γ etc. will be called β , γ etc. The set of periodic points of a map F is denoted by \mathcal{P}_F . A point $x \in B$ is a wandering point for $F : B \to B$ if there is a neighborhood $x \in U$ such that $F^{n}(U) \cap U = \emptyset$, for $n \geq 1$. Denote the set of nonwandering points of F by Ω_F . Given two points $z, z' \in W^{u/s}(x) \subset B$ in the same connected component of $W^{u/s}(x)$, then the arc in $W^{u/s}(x)$ which connects z with z' is denoted by $[z, z']^{u/s}$. When end points of such an arc are deleted we will denoted the remaining arc by $(z, z')^{u/s}$, $(z, z')^{u/s}$, etc.

 $Q_1 \nightharpoonup Q_2$ means that $C^{-1} \leq Q_1/Q_2 \leq C$, where $C > 0$ is an absolute constant or depending on, say F.

For the reader's convenience, more special notations are collected in the Nomenclature.

3. Local stable manifolds

Lemma 3.1. Let $U, U', V' \subset \Omega_h$ with $\overline{U'} \subset V'$. Assume, $U' \subset \Omega^v$. There exists $C > 0$ such that the following holds. If $F \in \mathcal{H}_{\Omega}(\overline{\epsilon}),$ $F(x, y) = (f(x) - \epsilon(x, y), x), \text{ and } f: V' \to f(V') \text{ is univalent with}$

 $f(U')\supset \overline{U}$

then for every $A > 0$ there exists $\overline{\epsilon} > 0$ such that the following holds. If

 $\phi: \Omega^v \to U$

with

 $|D\phi| \leq A \cdot \overline{\epsilon}$

then the preimage $F^{-1}(\text{graph}(\phi)) \cap (U' \times \Omega^v)$ is the graph of some $\psi : \Omega^v \to U'$ with

$$
|D\psi| \le C \cdot \overline{\epsilon}.
$$

Remark 3.1. The domains Ω^h, Ω^v are neighborhoods of [-1, 1]. In the applications of Lemma [3.1](#page-7-1) the domains U and U' will be small neighborhoods of points in [-1, 1]. Although formally we have that $U' \subset \Omega^h$ we can assume in the applications that $U' \subset \Omega^v$.

Proof. First we will show that for any given $y \in \Omega^v$ there exists a unique $x \in U'$ and $y' \in \Omega^v$ such that

$$
F(x, y) = (\phi(y'), y') \in \text{graph}(\phi).
$$

Finding such an $x \in U'$ is equivalent to solving

(3.1)
$$
\phi(x) = f(x) - \epsilon(x, y) \equiv \phi_y(x).
$$

This equation is consistent because, $U' \subset \Omega^v = \text{Dom}(\phi)$. Now, ϕ is a strong contraction when $\bar{\epsilon}$ is small, $|D\phi| \leq A \cdot \bar{\epsilon}$. The map $f|U'$ is univalent. So, for $\bar{\epsilon}$ small enough, the map

$$
\phi_y: U' \to \phi_y(U') \supset \overline{U}
$$

is univalent and

$$
\phi_y^{-1}\circ\phi:U'\to U'
$$

is a well defined contraction. We used again that $U' \subset \Omega^v = \text{Dom}(\phi)$. The unique fixed point of this map is the point $x \in U'$ which solves the equation [\(3.1\)](#page-8-0). We proved that the set $F^{-1}(\text{graph}(\phi)) \cap (U' \times \Omega^v)$ is the graph of some $\psi : \Omega^v \to U'$.

Left is to estimate the derivative of ψ . Differentiate $\phi(x) = f(x)$ – $\epsilon(x, y)$ with respect to y. This gives the following expression

$$
D\psi(y) = -\frac{\frac{\partial \epsilon}{\partial y}(x, y)}{D\phi(x) - Df(x) + \frac{\partial \epsilon}{\partial x}(x, y)}.
$$

There is a lower bound on $|Df(x)| \ge D > 0$, $x \in U'$. Furthermore, the partial derivatives of ϵ are of the order $\overline{\epsilon}$. So, for $\overline{\epsilon}$ small enough, we get

$$
|D\psi(y)| \leq C \cdot \overline{\epsilon}.
$$

In the sequel of this section we will fix a $F \in \mathcal{H}_{\Omega}^{n}(\overline{\epsilon}), n \geq 1$. The domain of R^nF is

$$
\Omega_n = \Omega_n^h \times \Omega_n^v,
$$

where $[-1, 1] \subset \Omega_n^h$. Furthermore, $R^n F(x, y) = (f_n(x) - \epsilon_n(x, y), x)$.

Let $\hat{\beta}_n \in \Omega_{n-1}$ be the saddle point of $R^{n-1}F$ which is of flip type, it has two negative eigenvalues. The connected component of its stable manifold which contains $\hat{\beta}_n$ is denoted by $W^s_{\text{loc}}(\hat{\beta}_n)$. This set is called the local stable manifold of $\hat{\beta}_n$.

The point $\hat{\beta}_n \in \Omega_n$ corresponds to a periodic point of the original map. Namely, $\beta_n = \Phi_0^n(\hat{\beta}_n) \in \Omega_0$. Objects with a hat are in the domain of a renormalization. The corresponding object in the domain of the original map will have no hat.

Lemma 3.2. For $\bar{\epsilon} > 0$ small enough, the local stable manifold of the point $\hat{\beta}_n$ is the graph of a function $\hat{\psi}_n : \Omega_{n-1}^v \to \Omega_{n-1}^h$ with

$$
|D\hat{\psi}_n| = O(\overline{\epsilon}^{2^{n-1}}).
$$

Proof. The map f_{n-1} lies in a compact family which is determined by Ω. This implies that for some $\delta > 0$ and $D > 0$ we have the following. Let $U'_n = U_n = B_\delta(\pi_1(\hat{\beta}_n))$ and $V_n = B_{2\delta}(\pi_1(\hat{\beta}_n))$. Then

$$
|Df_{n-1}(x)| \ge D > 1,
$$

for $x \in U'_n$.

Consider the family of graphs of the following functions:

$$
\mathcal{G}_K = \{ \phi : \Omega_{n-1}^v \to \Omega_{n-1}^h | \phi(\pi_2(\hat{\beta}_n)) = \pi_1(\hat{\beta}_n), |D\phi| \leq K \cdot \bar{\epsilon}^{2^{n-1}} \}.
$$

Notice, for $\phi \in \mathcal{G}_K$ we have

$$
\phi(\Omega_{n-1}^v) \subset U_n.
$$

This follows from Lemma [2.1.](#page-5-0) Namely,

$$
\operatorname{diam}(\phi(\Omega_{n-1}^v)) \le K \cdot \overline{\epsilon}^{2^{n-1}} \cdot \operatorname{diam}(\Omega_{n-1}^v) \le K \cdot \overline{\epsilon}^{2^{n-1}} \cdot C \cdot r^n < \delta.
$$

We can apply Lemma [3.1](#page-7-1) which says that, for $\bar{\epsilon}$ small enough, the connected component of $(R^{n-1}F)^{-1}(\text{graph}(\phi))$ containing $\hat{\beta}_n$ is the graph of some function ψ . It also says that if we take $K > 0$ large enough we have $\psi \in \mathcal{G}_K$. This observation defines the graph transform $\mathcal{T}: \mathcal{G}_K \to \mathcal{G}_K$ with

 $\mathcal{T} : \phi \mapsto \psi$.

The special form of Hénon-like maps allows us to define the graph transform for (global) graphs of $\phi : \Omega_{n-1}^v \to \Omega_{n-1}^h$. Because $|Df_{n-1}| \geq$ $D > 1$, f_{n-1} is expanding, and $|\epsilon_{n-1}| \leq \bar{\epsilon}^{2^{n-1}}$ we can use the usual technique to show that this graph transform contracts the C^0 distance on \mathcal{G}_K . The unique fixed point is $W^s_{\text{loc}}(\hat{\beta}_n) \in \mathcal{G}_K$. In particular, it is the graph of a function $\hat{\psi}_n \in \mathcal{G}_K$:

$$
|D\hat{\psi}_n| \leq K \cdot \overline{\epsilon}^{2^{n-1}}.
$$

 \Box

The map $R^{n-1}F$ is renormalizable. It has two fixed points: $\hat{\beta}_n =$ $\beta_1(R^{n-1}F)$, which is of flip type, and $\beta_0(R^{n-1}F)$ which has two positive eigenvalues. Let $\hat{p}_0^n \in W^u(\beta_0(R^{n-1}F))$ be such that the curve $[\beta_0(R^{n-1}F), \hat{p}_0^n] \subset W^u(\beta_0(R^{n-1}F))$ intersects $W^s_{\text{loc}}(\hat{\beta}_n)$ only in \hat{p}_0^n . Let $\hat{p}_i^n = (R^{n-1}F)^i(\hat{p}_0^n), i \in \mathbb{Z}.$

The extended local stable manifold of $R^{n-1}F$ consists of four curves contained in $W^s(\hat{\beta}_n)$,

$$
\hat{M}^{n} = [\hat{p}_{0}^{n}, \hat{\beta}_{n}]^{s} \cup (R^{n-1}F)^{-1}([\hat{p}_{0}^{n}, \hat{\beta}_{n}]^{s}) \cup (R^{n-1}F)^{-2}([\hat{p}_{0}^{n}, \hat{\beta}_{n}]^{s}),
$$

where $[\hat{p}_0^n, \hat{\beta}_n]^s \subset W^s(\beta_n)$ is the curve which connects \hat{p}_0^n with $\hat{\beta}_n$. Lemma [3.1](#page-7-1) and Lemma [3.2](#page-9-0) imply:

Lemma 3.3. If $\overline{\varepsilon} > 0$ is small enough then $\hat{M}^n \cap (\Omega_{n-1} \cap \mathbb{R}^2)$ consists of four curves,

(1) $\hat{M}^n_{-2} \ni \hat{p}^n_{-2},$ (2) $\hat{M}_{-1}^n \ni \hat{p}_{-1}^n$, (3) $\hat{M}_0^n = W_{\text{loc}}^s(\hat{\beta}_n) \ni \hat{\beta}_n$, (4) \hat{M}_1^n , $W^u(\beta_0(R^{n-1}F)) \cap \hat{M}_1^n = \emptyset$.

These curves are contained in graphs of functions. These functions, denoted by $\hat{M}_i^n : \Omega_{n-1}^v \to \Omega_{n-1}^h$, have the property that graph $(\hat{M}_i^n) \subset$ $W^s(\hat{\beta}_n)$ and

$$
|D\hat{M}_i^n| = O(\overline{\epsilon}^{2^{n-1}}), \ i = -2, -1, 0, 1.
$$

Remark 3.2. For maps $F \in \mathcal{I}_{\Omega}(\bar{\epsilon})$ the bounds on the derivatives in the previous Lemma can be replaced by $O(b_F^{2^{n-1}})$ $\binom{2^{n-1}}{F}$, where b_F is the average Jacobian.

The map $\Phi_0^n : \Omega_n \to \Omega$ is the coordinate change which conjugates $R^n F$ to $F^{2^n} | A_n$, see Equation [\(2.2\)](#page-5-1). Let

$$
\beta_n = \Phi_0^{n-1}(\hat{\beta}_n) \in \Omega,
$$

\n
$$
p_i^n = \Phi_0^{n-1}(\hat{p}_i^n), i \in \mathbb{Z},
$$

\n
$$
M_i^n = \Phi_0^{n-1}(\hat{M}_i^n), i = -2, -1, 0, 1,
$$

and

$$
M^n = \Phi_0^{n-1}(\hat{M}^n).
$$

Define the domain $D_1 = D_1(F) \subset B$ to be the closed disc bounded by two arcs $\partial^s = \partial^s(F) \subset W^s(\beta_1(F))$ and $\partial^u = \partial^u(F) \subset W^u(\beta_0(F))$ whose boundary points are p_0^n and p_1^n . Let

$$
D_n = \Phi_0^{n-1}(D_1(R^{n-1}F)).
$$

Notice,

$$
F^2(D_1) \subset D_1.
$$

So

$$
F^{2^n}(D_n) \subset D_n.
$$

The map $F^{2^n}|D_n$ is called the *preferred* n^{th} -prerenormalization. Finally,

$$
\partial D_n = \partial_n^s \cup \partial_n^u,
$$

where

$$
\partial_n^{u,s} = \Phi_0^{n-1}(\partial^{u,s}(R^{n-1}F)).
$$

Observe,

$$
\{\tau_F\}=\bigcap_{n\geq 0}D_n,
$$

which holds because $D_n \subset B_{v^n}$.

Remark 3.3. The box A_n , illustrated in Figure [3.1,](#page-49-0) has unit height and exponential small horizontal width: each horizontal slice is proportional to σ^{2n} .

Remark 3.4. The upper index of the points p_i^n and \hat{p}_i^n will be omitted when no ambiguity is possible. See for example Figure [4.1.](#page-49-0)

Lemma 3.4. For every $C > 0$ there exists $K > 0$, independent of $N \geq 1$, such that the following holds. Let $\hat{\phi} : \Omega_n^v \to \Omega_n^h$ with

$$
|D\hat{\phi}| \le C \cdot \overline{\epsilon}^{2^n}.
$$

Then $\Phi_0^n(\text{graph}(\hat{\phi}))$ is the graph of some $\phi : \Omega^v \to \Omega^h$ with

 $|D\phi| \leq K \cdot \overline{\epsilon}.$

Proof. In §2, the preliminaries, we introduced the coordinate change which conjugates $R^n F$ with $F^{2^n} | A_n$. Recall that

$$
\Phi_0^n = \Phi_0^1 \circ \Phi_1^2 \circ \cdots \circ \Phi_{n-1}^n,
$$

where each Φ_k^{k+1} conjugates $R^{k+1}F$ to the restriction $(R^kF)^2|A(R^kF)$. These conjugations were constructed in such a way that they map horizontal lines into horizontal lines. Each map

$$
\pi_2 \circ \Phi_k^{k+1} : \Omega_{k+1} \to \Omega_k^v
$$

is onto. Moreover, $\pi_2 \circ \phi_k^{k+1}$ $k^{+1}(x, y)$ is independent of x and affine in y. This implies that $\Phi_k^n(\text{graph}(\hat{\phi}))$ is the graph of some $\phi_k : \Omega^v \to \Omega^h$. In particular, $\Phi_0^n(\text{graph}(\hat{\phi}))$ is the graph of some $\phi : \Omega^v \to \Omega^h$.

Observe that the graph of ϕ_k stays away from $x = c_k, c_k$ is the critical point of f_k . In particular, there exists $D > 0$ such that

$$
|Df_k(x)| \ge D
$$

for every $(x, y) \in \text{graph}(\phi_k)$.

The coordinate change Φ_k^{k+1} is a composition of two maps, see the preliminaries in §2,

$$
\Lambda_k \circ H_k \equiv (\Phi_k^{k+1})^{-1},
$$

where

$$
H_k(x, y) = (f_k(x) - \epsilon_k(x, y), y).
$$

We will estimate $|D\phi_k|$ inductively. Let $K_k > 0$ be minimal such that $|D\phi_k| \le K_k \cdot \overline{\epsilon}^{2^k}$. In particular, $K_n \le C$. Assume $|D\phi_{k+1}| \le K_{k+1} \cdot \overline{\epsilon}^{2^{k+1}}$. Choose a point $(x, y) \in \text{graph}(\phi_k)$ and let $\Phi_k^{k+1}(x', y') = (x, y)$ with $(x', y') \in \text{graph}(\phi_{k+1})$. Take a tangent vector $(D\phi_k(y)z, z)$ to the graph of ϕ_k . Then

$$
D\Lambda_k \circ DH_k(x,y)(D\phi_k(y)z,z) = (D\phi_{k+1}(y')z',z').
$$

 $D\Lambda_k$ is conformal which implies that for some $s \in \mathbb{R}$ we have $z' = s \cdot z$. Hence,

$$
(Df_k(x) - \frac{\partial \epsilon_k(x, y)}{\partial x}) \cdot D\phi_k(y) - \frac{\partial \epsilon_k(x, y)}{\partial y} = D\phi_{k+1}(y').
$$

Using $|Df_k(x)| \geq D$ and the above equation we get, for $\bar{\epsilon}$ small enough, constants $A_0, A_1 > 0$, independent of N, such that

$$
|D\phi_k| \le A_0 \cdot |D\phi_{k+1}| + A_1 \cdot \overline{\epsilon}^{2^k}.
$$

Hence,

$$
K_k \le A_0 \cdot \overline{\epsilon}^{2^k} \cdot K_{k+1} + A_1.
$$

This implies that there is a uniform bound $K \ge K_k, k \ge 1$.

Proposition 3.5. If $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, then $M^n \cap B$ consists of four curves,

(1) $M_{-2}^n \ni p_{-2}^n$, (2) $M_{-1}^n \ni p_{-1}^n$, (3) $M_0^n = W_{\text{loc}}^s(\beta_n) \ni \beta_n$, (4) M_1^n , $M_1^n \cap W^u(\beta_{n-1}) = \emptyset$.

These curves are contained in graphs of functions. These functions, denoted by $M_i^n : \Omega^v \to \Omega^h$, have the property that $\text{graph}(M_i^n) \subset W^s(\beta_n)$ and satisfy

$$
|DM_{i}^{n}| = O(\overline{\epsilon}),\ i = -2, -1, 0, 1.
$$

Letting z_n be the intersection point of M_1^n with the horizontal line through τ_F , we have: $\pi_1(z_n) > \pi_1(\tau_F)$ and

$$
|z_n - \tau_F| \asymp \sigma^{2n}.
$$

Proof. The first part of the Proposition follows by applying Lemma [3.3](#page-10-0) and Lemma [3.4.](#page-11-0) The second, which describes the distance from τ_F to z_n , is an immediate consequence of the results in §7.2 of [\[CLM\]](#page-66-3). \Box

Let $W_n \subset B$ be the real domain bounded by M_0^n and M_1^n . The domain W_n is a topologically defined variation of A_n (the restriction $F^{2^n}|A_n$ is conjugate to the n^{th} -renormalization of F, see §2). Note,

and

$$
\beta'_n \equiv F^{2^{n-1}}(\beta_n) \in W_{n-1}.
$$

 $\beta_n \in W_n$

The connected component of the stable manifold $W^s(\beta'_n) \cap B$ which contains β'_n is called the *local stable manifold* of β'_n , denoted by $W^s_{\text{loc}}(\beta'_n)$.

Proposition 3.6. For $\bar{\epsilon} > 0$ small enough the local stable manifold $W_{\text{loc}}^{s}(\beta_{n}')$ is the graph of a function $\phi: [-1,1] \rightarrow [-1,1]$ and

$$
|D\phi| = O(\overline{\epsilon}).
$$

Proof. The maximal $k \leq n$ for which $R^k F$ has a periodic point corresponding to β'_n is $k = n - 2$. Namely,

$$
\beta_n' = \Phi_0^{n-2}(R^{n-2}F(\Phi_{n-2}^{n-1}(\hat{\beta}_n))).
$$

Let

$$
G_1 = W_{\text{loc}}^s(\hat{\beta}_n) \subset \text{Dom}(F_{n-1}),
$$

\n
$$
G_2 = W_{\text{loc}}^s(\Phi_{n-2}^{n-1}(\hat{\beta}_n)) \subset \text{Dom}(F_{n-2}),
$$

and

$$
G_3 = W^s_{\rm loc}(F_{n-2}(\Phi_{n-2}^{n-1}(\hat{\beta}_n))) \subset {\rm Dom}(F_{n-2}).
$$

Observe,

$$
W^s_{\rm loc}(\hat{\beta}_n) = \Phi^{n-2}_0(G_3).
$$

Lemma [3.3\(](#page-10-0)3) says that G_1 is the graph of a function with small deriv-ative. Then Lemma [3.4](#page-11-0) implies that also G_2 is the graph of a function with small derivative. Use Lemma [3.1](#page-7-1) to show that G_3 is the graph of a function with small derivative. Finally, we get that $W^s_{\text{loc}}(\beta'_n)$ is the graph of a function with small angle because of Lemma [3.4.](#page-11-0) \Box

Consider an infinitely renormalizable $F \in \mathcal{I}_{\Omega}(\bar{\epsilon})$, with $\bar{\epsilon} > 0$ small enough. Observe, the tip of F satisfies

$$
\tau_F \in W_n,
$$

for all $n \geq 1$. Also, notice that $W_n \subset W_{n-1}$. Let

$$
W^s_{\rm loc}(\tau_F) = \bigcap_{n \ge 1} W_n.
$$

This set is called the *local stable manifold of the tip*.

Proposition 3.7. For $\bar{\epsilon} > 0$ small enough, the local stable manifold $W_{\text{loc}}^{s}(\tau_F)$ is the graph of an analytic function $\phi: [-1,1] \rightarrow [-1,1]$ and

$$
|D\phi| = O(\overline{\epsilon}).
$$

Proof. Let ϕ_n : $\Omega^v \to \Omega^h$ be the function whose graph is $M_0^n =$ $W_{\text{loc}}^s(\beta_n)$. This graph contains the left boundary M_0^n of W_n . According to Proposition [3.5](#page-13-0) we have a uniform bound on $\phi_n : \Omega^v \to \Omega^h$. Normality implies $\phi_n \to \phi$. The analyticity of ϕ follows. The real slice of the graph of ϕ is $W^s_{\text{loc}}(\tau_F)$. $\int_{\text{loc}}^{s}(\tau_F).$

The characteristic exponents of the invariant measure on \mathcal{O}_F are 0 and $\ln b_F$, see Theorem 6.3 of [\[CLM\]](#page-66-3). The next Proposition states that the local stable manifold of the tip is indeed part of its stable manifold. However, we do not know the actual value of the stable exponent at the tip.

Proposition 3.8. For $\bar{\epsilon} > 0$ small enough,

$$
\text{diam}(F^t(W^s_{\text{loc}}(\tau_F))) = O((\sqrt{b_F})^t),
$$

 $t \geq 0$. Also, if $v \in T_{\tau_F} W_{\text{loc}}^s(\tau_F)$ is a non-zero tangent vector then

$$
\limsup_{t \to \infty} \frac{1}{t} \ln |DF^t(\tau_F)v| \le \frac{1}{2} \ln b_F.
$$

Proof. Choose $t \geq 0$ and let $n \geq 0$ be maximal such that

$$
2^n\leq t.
$$

For $t > 0$ large we have a precise description of R^nF , see Theorem 7.9 of [\[CLM\]](#page-66-3) or equation [\(2.3\)](#page-6-0). In particular, by using this result, we get

$$
\text{diam}(R^n F(W^s_{\text{loc}}(\tau_{R^n F}))) = O(b_F^{2^n} \cdot \text{diam}(\Omega_n^v)).
$$

Remark [2.1](#page-5-2) gives

$$
diam(\Omega_n^v)) \asymp \frac{1}{\sigma^n}.
$$

The renormalization microscope described in §5 of [\[CLM\]](#page-66-3) can be used to construct $F^t(W^s_{\text{loc}}(\tau_F))$. Recall,

$$
\phi^k_c = \Phi^{k+1}_k,
$$

and

$$
\phi_v^k = R^k F \circ \Phi_k^{k+1},
$$

with $k \geq 0$. The renormalization microscope was made such that there exists a sequence $\omega_k \in \{v, c\}, k = 1, 2, \ldots, n$, such that

$$
F^t(W^s_{\text{loc}}(\tau_F)) = \phi^1_{\omega_1} \circ \phi^2_{\omega_2} \circ \cdots \circ \phi^n_{\omega_n}(R^n F(W^s_{\text{loc}}(\tau_{R^n F}))).
$$

Lemma 5.1 of [\[CLM\]](#page-66-3) says that each ϕ^k_ω is a contraction. In fact,

$$
|D(\phi_{\omega_1}^1 \circ \phi_{\omega_2}^2 \circ \cdots \circ \phi_{\omega_n}^n)| \leq C\sigma^n.
$$

Hence,

$$
\text{diam}(F^t(W^s_{\text{loc}}(\tau_F))) = O((\sqrt{b_F})^t),
$$

where we used that $2^n > \frac{1}{2}$ $\frac{1}{2}t$. The proof of the infinitesimal version is the same. \Box

4. Laminar structure of the attractor

For a map $F : B \to \mathbb{R}^2$, the set $\bigcap_{k \geq 0} F^k(B)$ is called the global attracting set of F. It is the maximal backward invariant subset of B. For a discussion on the concept of attractor see [\[Mi1\]](#page-66-7) and [\[Mi2\]](#page-66-8).

For an infinitely renormalizable Hénon-like map F , let

$$
\mathcal{A}_F=\mathcal{O}_F\cup \bigcup_{n\geq 0} W^u(\boldsymbol{\beta}_n).
$$

For a map $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, let $B_0 \subset B$ be the connected component of $B \setminus W^s_{loc}(\beta_0)$ which contains β_1 . The set \overline{B}_0 consists of non-escaping points.

Remark 4.1. The set \mathcal{A}_F is backward invariant. It is also essentially forward invariant. Notice,

$$
F(\mathcal{A}_F \cap \overline{B}_0) = \mathcal{A}_F \cap \overline{B}_0.
$$

However, $\mathcal{A}_F \cap (B \setminus \overline{B}_0)$ is a piece of the unstable manifold of β_0 which is mapped strictly over itself with some points outside of $\mathcal{A}_F \cap (B \setminus \overline{B_0})$.

The following result shows that, in fact, this set \mathcal{A}_F is the global attracting set:

Theorem 4.1. Given an infinitely renormalizable Hénon-like map $F \in$ $\mathcal{I}_{\Omega}(\overline{\epsilon})$ with $\overline{\epsilon} > 0$ small enough, we have:

$$
\mathcal{A}_F = \bigcap_{k \ge 0} F^k(B) = \overline{W^u(\beta_0)}.
$$

Furthermore, for every point $x \in B_0$ either $x \in W^s(B_n)$ for some $n \geq 0$ or $\omega(x) = \mathcal{O}_F$. The non-wandering set of F is $\Omega_F = \mathcal{P}_F \cup \mathcal{O}_F$.

The second part of Theorem [4.1,](#page-16-0) concerning the limit sets of points and the non-wandering set, was already proved in [\[GST\]](#page-66-2). The proof of this Theorem needs some preparation. For a map $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, define the nth -trapping region of F as

$$
\mathrm{Trap}_n = \mathrm{Orb}(D_n).
$$

Note that

(4.1)
$$
\mathcal{O}_F \cup \bigcup_{k \geq n} \mathcal{B}_n \subset \text{int}(\text{Trap}_n).
$$

Lemma 4.2. Let $\overline{\varepsilon} > 0$ small enough and $F \in \mathcal{H}_{\Omega}(\overline{\varepsilon})$ be a renormalizable map. For every $x \in B_0$, there exists $k \geq 1$ such that

$$
F^k(x) \in D_1 \subset \text{Trap}_1.
$$

Let $U \supset A_F$ be a neighborhood. Then there exists $k_0 \geq 1$ such that for $k \geq k_0$

$$
F^k(\overline{B_0}) \subset U.
$$

Proof. Let $\overline{\epsilon} > 0$ be small enough such that Proposition [3.5](#page-13-0) applies. Then we can divide the domain B_0 by cutting it using the curves $graph(M_i^1), i = -2, -1, 0, 1$, see Figure [3.1.](#page-49-0) Let

$$
Z_1 \cup Z_2 \cup Z_3 \cup Z_4 \cup Z_5 = B_0 \setminus \bigcup_{i=-2}^1 \text{graph}(M_i^1),
$$

counting the connected components from left to right. In particular $D_1 \subset Z_4$. The curve in $W^u(\beta_0)$ which connects p_{-1}^1 with p_0^1 is denoted by $[p_{-1}^1, p_0^1]^u$. Let

$$
Z_3^+ \cup Z_3^- = Z_3 \setminus [p_{-1}^1, p_0^1]^u,
$$

be the partition by $[p_{-1}^1, p_0^1]^u \subset W^u(\beta_0)$ of Z_3 in the connected components. One easily checks the following properties

(1) $F(Z_3^+) \subset D_1$, (2) $F(Z_3^-) \subset Z_4$, (3) $F(Z_4) \subset Z_3^+,$ (4) $F(Z_2)$ ⊂ Z_3 , (5) $F(Z_5)$ ⊂ $Z_1 \cup Z_2$, (6) for every $x \in Z_1$ there exists $k \geq 1$ such that $F^k(x) \in Z_2$.

The Lemma follows.

Observe, Trap₁ ∩ $W^s(\beta_0) = \emptyset$. This implies the following.

Corollary 4.3. Let $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, then there are no homoclinic orbits connected to β_k ,

$$
W^s(\pmb{\beta}_k)\cap W^u(\pmb{\beta}_k)=\emptyset,
$$

 $k \leq n$.

Let Γ_j , $j \geq 1$, and Γ be smooth curves in the plane. We say that the Γ_i converge to Γ , $\Gamma_j \to \Gamma$, if there are smooth parametrisations of these curves such that the corresponding parametrised curves converge in the C^1 -topology.

Lemma 4.4. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, and $\Gamma \subset$ $W^u(\beta_n)$. Then there are arcs $\Gamma_j \subset W^u(\beta_0)$ and $t_j \to \infty$ such that $F^{t_j}(\Gamma_j) \to \Gamma$.

Proof. Note first that it is sufficient to prove the assertion for some arc $\Gamma \subset W^u(\beta_n)$ containing β_n in its interior (since $\cup_{k\geq 0} F^k(\Gamma) = W^u(\beta_n)$).

The proof goes by induction. For $n = 1$ the Lemma can be proved as follows. As before, let $p_0 = p_0^1$ be the first intersection of $W^u(\beta_0)$ with $W^s_{\text{loc}}(\beta_1)$. The two manifolds intersect transversally. If $\Gamma \subset W^u(\beta_1)$ is a curve containing β_1 then the λ -Lemma (see Chapter 2 Lemma 7.1 of [\[dMP\]](#page-66-9)) allows us to choose arcs

$$
\Gamma_1 \supset \Gamma_2 \supset \Gamma_3 \supset \cdots \ni \{p_0\}
$$

and times $t_j \to \infty$ such that $F^{t_j}(\Gamma_j) \to \Gamma$.

Assume the Lemma holds for $n-1$. Take an arc $\Gamma \subset W^u(\beta_n)$ containing β_n in its interior, say $\Gamma = \Psi_0^{n-1}(\hat{\Gamma})$ with $\hat{\Gamma} \subset W^u(\beta_1(R^{n-1}F)).$ For $\overline{\varepsilon} > 0$ small enough, all the renormalizations $R^k F$, $k \leq n-1$, belong to the class $\mathcal{H}_{\Omega}(\overline{\varepsilon})$ with some $\Omega' \subset \Omega$. In particular, we can apply the base of induction to $\beta_0(R^{n-1}F)$ and $\beta_1(R^{n-1}F)$. This gives a sequence of curves $\hat{\Gamma}_j \subset W^u(\beta_0(R^{n-1}F))$ and $\hat{t}_j \to \infty$ such that

$$
(R^nF)^{\hat{t}_j}(\hat{\Gamma}_j) \to \hat{\Gamma} \subset W^u(\beta_1(R^nF)).
$$

Now, the induction assumption allows us to approximate the curves $\Gamma_j = \Psi_0^n(\hat{\Gamma}_j) \subset W^u(\beta_n)$ by curves from $W^u(\beta_0)$ and the Lemma follows. П

Proof of Theorem [4.1](#page-16-0). First we will prove that every point converges to a periodic point or to the Cantor set. Let $x \in B_0$ be a point that does not converge to any periodic orbit.

According to Lemma [4.2](#page-16-1) there exists $k_1 \geq 1$ such that

$$
F^{k_1}(x) \in D_1(F).
$$

Notice that

$$
D_1(F) \subset B_v^1(F) \subset \operatorname{Im} \phi_v^1,
$$

where the map ϕ_v^1 is defined in [\(2.1\)](#page-4-0). Now

$$
x_1 = (\phi_v^1)^{-1}(F^{k_1}(x)) \in B_0(RF),
$$

because the orbit of x does not converge to the periodic orbit of $\beta_1(F)$. Again, using Lemma [4.2,](#page-16-1) there is $k_2 \geq 1$ such that

$$
F^{k_2}(x_1) \in D_1(RF).
$$

In particular,

Orb
$$
(F^{k_2}(x_1)) \subset
$$
Orb $(D_1(RF))$.

So,

$$
F^{k_1+2k_2}(x) \in D_2 \subset \mathrm{Trap}_2.
$$

Note again that $D_1(RF) \subset \text{Im } \phi_v^2$. Because $R^n F \in \mathcal{H}_{\Omega'}(\bar{\varepsilon})$, we are allowed to repeatedly apply Lemma [4.2.](#page-16-1) Hence for every $n \geq 1$ there exists $k \geq 1$ such that

 $F^k(x) \in \text{Trap}_n$.

Thus

$$
\omega(x) = \mathcal{O}_F.
$$

Obviously, $\mathcal{O}_F \cup \mathcal{P}_F \subset \Omega_F$. Take a point $x \in B$ that does not converge to any periodic orbit and is not in the Cantor set \mathcal{O}_F . The argument above gives for every $n \geq 1$ a neighborhood U of x and $k_0 \geq 1$ such that for $k \geq k_0$

$$
F^k(U) \subset \mathrm{Trap}_n.
$$

For $n \geq 1$ large enough we have $x \notin \text{Trap}_n$. Thus, the point is wandering.

Let us now consider a non-periodic point $x \in W^s(\beta_n)$. According to Lemma [4.2](#page-16-1) there are disjoint neighborhoods U of x and $V \supset \mathcal{A}_F^n$, $n \geq 1$, such that for $k \geq k_0 F^k(U) \subset V$. Thus, the point is wandering. This completes the proof of

$$
\Omega_F=\mathcal{P}_F\cup\mathcal{O}_F.
$$

Since \mathcal{A}_F is backward invariant,

$$
\mathcal{A}_F \subset \bigcap_{k \ge 0} F^k(B).
$$

The opposite inclusion is obtained as follows. Choose a point $x \in$ $\bigcap_{k\geq 0} F^k(B)$. If $x \in \mathcal{O}_F$ we have $x \in \mathcal{A}_F$. Assume $x \notin \mathcal{O}_F$. For every $j \geq 0$ we have $F^{-j}(x)$ exists. Let $\alpha(x) \subset B$ consists of all limits of the negative orbit of x. This is a closed forward and backward invariant set. Choose $n \geq 1$ large enough such that

$$
x \notin \mathrm{Trap}_n.
$$

Because, $F(\text{Trap}_n) \subset \text{Trap}_n$ we have for every $j \geq 0$

 $F^{-j}(x) \notin \text{Trap}_n$.

Observe, $\mathcal{O}_F \subset \text{int}(\text{Trap}_n)$. So

$$
\alpha(x) \cap \mathcal{O}_F = \emptyset.
$$

Now, the orbit of every point not in \mathcal{P}_F converges to \mathcal{O}_F . Hence,

$$
\alpha(x) \subset \mathcal{P}_F.
$$

This in turn implies that $x \in W^u(\mathcal{B}_n)$ for some $n \geq 1$. This completes the proof of

$$
\mathcal{A}_F = \bigcap_{k \ge 0} F^k(B).
$$

The closure of the unstable manifold of β_0 is backward invariant. Hence,

$$
\overline{W^u(\beta_0)} \subset \bigcap_{k \ge 0} F^k(B) = \mathcal{A}_F.
$$

The opposite inclusion is obtained as follows. The stable and unstable manifolds are analytic. This implies that there are only countably many heteroclinic points. In particular, there are points in $W^u(\beta_0)$ which do not converge to any periodic orbit. These points converge to the Cantor set. Hence,

$$
\mathcal{O}_F \subset \overline{W^u(\beta_0)}.
$$

Lemma [4.4](#page-17-0) implies that for every $n \geq 1$

$$
W^u(\beta_n) \subset \overline{W^u(\beta_0)}.
$$

Hence,

$$
\mathcal{A}_F = \overline{W^u(\beta_0)}.
$$

 \Box

The proof of the following Lemma is the same as the part of the proof of Theorem [4.1](#page-16-0) dealing with the non-wandering set and will be omitted.

Lemma 4.5. Let $F \in \mathcal{I}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. Then

 $\Omega_F = \mathcal{P}_F.$

Definition 4.1. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small. A point

$$
z \in W^u(\beta_{k'}) \subset \bigcup_{k \leq l \leq n} W^u(\beta_l)
$$

is laminar if for any sequence $z_m \in W^u(\beta_{k_m})$ with $z_m \to z$ and $k \leq$ $k_m \leq n$ the following holds

$$
T_{z_m}W^u(\beta_{k_m}) \to T_zW^u(\beta_k).
$$

The attractor of $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$ is called *laminar* if every point in

$$
\bigcup_{n\geq 0} W^u(\mathcal{B}_n) = \mathcal{A}(F) \setminus \mathcal{O}(F)
$$

is laminar.

Remark 4.2. If \mathcal{A}_F is laminar then every point of $\mathcal{A}_F \setminus \mathcal{O}_F$ has a neighborhood which is a C^1 -diffeomorphic image of $(-1, 1) \times Q$, where $Q \subset [-1,1]$ is a countable set. It has a local product structure. The set $\mathcal{A}_F \setminus \mathcal{O}_F$ is a *match-box* manifold, see [\[AM\]](#page-66-10).

Indeed, it requires work to show that the neighborhood can be linearized by a $C^{1+\alpha}$ -coordinate change. It relies on the linearizability of saddle points, see [\[H\]](#page-66-11). More on Hölder laminations can be taken from [\[PSW\]](#page-66-12) and references therein.

The transverse sections can be described as follows. Choose a point $x \in W^u(\mathcal{B}_n) \subset \mathcal{A}_F \setminus \mathcal{O}_F$ then

$$
Q = \bigcup_{k=0}^{n} Q_k,
$$

where

- (1) $Q_k \cap Q_l = \emptyset$ when $k \neq l$,
- (2) Q_k is countable and discrete, $k < n$,
- (3) $Q_n = \{x\},\$

(4) for $k < n$

$$
\overline{Q_k} = \bigcup_{l \ge k} Q_l.
$$

Moreover, Q_k accumulates at Q_{k+1} with an asymptotic rate. The rate equals $\mu_{k+1} \in (-1,0)$ which is the stable multiplier of β_{k+1} . More precisely, for each $q \in Q_{k+1}$ there exists a neighborhood $U \ni q$ in Q such that $U \cap Q_k = \{q_i\}_{i \geq 1}$ with

$$
\lim_{i \to \infty} \frac{q - q_i}{\mu_{k+1}^i} = C \neq 0.
$$

Note that the set Q_k accumulates from both sides at $q \in Q_{k+1}$.

 $\text{PString replacement } 4.6.$ The attractor of an infinitely renormalizable Hénon $\overline{map} \ F \in \mathcal{I}_{\Omega}(\overline{\varepsilon}), \ \text{with} \ \overline{\varepsilon} > 0 \ \text{small enough}, \ \text{is laminar if there are no}$ heteroclinic tangencies.

> The proof of this Theorem needs some preparation. Let $n \geq 1$ and $q_1, q_2, q_3 \in W^u(\beta_{n-1})$ be the first three intersections, coming from β_{n-1} along $W^u(\beta_{n-1})$, with $W^s_{\text{loc}}(\beta_{n+1})$, and let $q'_2, q'_3 \in W^u(\beta_{n-1})$ be the second and third intersection with $W^s_{\text{loc}}(\beta'_{n+1})$. Now define the saddle-region T_n of β_n the domain containing β_n which is bounded by the following four arcs, $[q_2, q'_2]^u \subset W^u(\beta_{n-1}), [q_3, q'_3]^u \subset W^u(\beta_{n-1}),$ $[q_2, q_3]^s \subset W^s(\beta_{n+1})$ and $[q'_2, q'_3]^s \subset W^s(\beta'_{n+1}),$ see Figure [4.1.](#page-49-0)

FIGURE 4.1. Saddle-region of β_n

Furthermore, let $p_0, p_1 \in W^u(\beta_{n-1})$ be the first two intersections with $W_{\text{loc}}^{s}(\beta_n)$. The curve $[p_0, p_1]^u \subset W^u(\beta_{n-1})$ is a fundamental domain for F restricted to $W^u(\beta_{n-1})$. Consider the following fundamental domain

$$
K_{n-1}^u = F^{-2^n}([p_0, p_1]^u).
$$

The connected components of $W^u(\beta_n) \cap T_n$ and $W^s(\beta_n) \cap T_n$ (which contain β_n) are denoted by $U_n, S_n \subset T_n$. Notice, $S_n \cap \text{Trap}_{n+1} = \emptyset$.

Lemma 4.7. $W^u(\beta_n)$ and $W^s(\beta_n)$ are (non-compact) one-dimensional embedded manifolds, for each $n \geq 0$.

Proof. For each $n \geq 1$ we have that the fundamental domain of $W^u(\beta_{n-1})$ satisfies $F^{2^n}(K_{n-1}^u) \subset \text{Trap}_n$. Because $K_{n-1}^u \cap \text{Trap}_n = \emptyset$ we have

$$
\overline{\bigcup_{i\neq 0} F^i(K_{n-1}^u) \setminus K_{n-1}^u} \cap \text{int } K_{n-1}^u = \emptyset.
$$

This implies that $W^u(\beta_{n-1})$ does not accumulate at itself, it is a onedimensional manifold.

The proof for the stable manifold is similar, we have to show that $W^s(\beta_n)$ does not accumulate at itself. Suppose it does. Then for some $s \in \text{int } S_n$ there exists a sequence $W^s(\beta_n) \setminus S_n \ni s_k \to s$. We may assume that each $s_k \in T_n$. Apply Lemma [4.2](#page-16-1) to $R^n F$ and we get

$$
\beta_n \in \omega(s_k) \subset \text{Trap}_{n+1} \, .
$$

Contradiction.

Remark 4.3. The unstable manifolds are connected. However, the stable manifold of a periodic points consists of countably many closed curves.

Lemma 4.8. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. Then

$$
W^s(\beta_n) \cap T_n = S_n.
$$

Proof. Let $Z_3 \subset B$ be the open domain bounded by M_{-1}^n and $W_{\text{loc}}^s(\beta_n)$ and $Z_4 \subset B$ be the open domain bounded by M_1^n and $W_{\text{loc}}^s(\beta_n)$, see Figure [3.1.](#page-49-0) Recall,

$$
F^{2^n}(Z_3) \subset Z_4
$$

and

$$
F^{2^n}(Z_4) \subset Z_3.
$$

Hence, no point in $Z_3 \cup Z_4$ will ever enter $W^s_{\text{loc}}(\beta_n)$. This means

$$
W^s(\beta_n) \cap (Z_3 \cup Z_4) = \emptyset.
$$

Finally, observe that $T_n \subset Z_3 \cup W_{\text{loc}}^s \cup Z_4$. The Lemma follows. \Box

Lemma 4.9. Let $F \in \mathcal{H}_{\Omega}^{n+1}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. Then

$$
\overline{W^u(\beta_n)} \setminus W^u(\beta_n) = \overline{W^u(\beta_{n+1})} \cup \overline{W^u(\beta'_{n+1})}.
$$

Proof. Applying Theorem [4.1](#page-16-0) to RF, we obtain:

(4.2)
\n
$$
\mathcal{A}_F \setminus W^u(\beta_0) = \{ (\mathcal{A}_F \cap D_1) \cup (\mathcal{A}_F \cap F(D_1)) \} \setminus W^u(\beta_0)
$$
\n
$$
= \frac{(\overline{W^u(\beta_1)} \cap D_1) \cup F(\overline{W^u(\beta_1)} \cap D_1)
$$
\n
$$
= \overline{W^u(\beta_1)}.
$$

Figure [4.1](#page-49-0) might be useful in the following argument. Apply Theo-rem [4.1](#page-16-0) and equation [\(4.2\)](#page-23-0) to R^nF and we obtain

$$
(\overline{W^u(\beta_n)} \setminus W^u(\beta_n)) \cap D_n = \overline{W^u(\beta_{n+1})}.
$$

Observe that

$$
\overline{W^u(\beta_n)} \subset D_n \cup F^{2^{n-1}}(D_n).
$$

Hence,

$$
\overline{W^u(\beta_n)} \setminus W^u(\beta_n) =
$$

\n
$$
((\overline{W^u(\beta_n)} \setminus W^u(\beta_n)) \cap D_n) \cup ((\overline{W^u(\beta_n)} \setminus W^u(\beta_n)) \cap F^{2^{n-1}}(D_n)) =
$$

\n
$$
((\overline{W^u(\beta_n)} \setminus W^u(\beta_n)) \cap D_n) \cup F^{2^{n-1}}((\overline{W^u(\beta_n)} \setminus W^u(\beta_n) \cap D_n) =
$$

\n
$$
\overline{W^u(\beta_{n+1})} \cup \overline{W^u(\beta_{n+1})}.
$$

Define, for $k < n$,

$$
E_{k,n} = \{ x \in K_k | \exists t > 0 \; \forall j < t \; F^j(x) \notin T_n \text{ and } F^t(x) \in T_n \}.
$$

The time $t > 0$ in the above definition is called the *time of entry* of $x \in E_{k,n}$ into T_n .

Definition 4.2. Let $k < n$. We say that F satisfies the transversality condition $\mathcal{T}_{k,n}$ if the following holds. Let $z_j \in E_{k,n}, j \geq 0$, be a sequence such that

$$
F^{t_j}(z_j) \to s \in S_n,
$$

where $t_j > 0$ is the time of entry of z_j into T_n , then

$$
DF^{t_j}(z_j)(T_{z_j}W^u(\beta_k)) \to T_sW^s(\beta_n).
$$

Definition 4.3. A (k, n) -heteroclinic tangency, $k < n$, for an *n*-times renormalizable Hénon map is a tangency between $W^u(\beta_k)$ and $W^s(\beta_n)$. If there is such a tangency we write

$$
W^u(\beta_k)\top \top W^s(\beta_n).
$$

Let $\mathcal{K}_{k,n}(\overline{\varepsilon}) \subset \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$ consists of the *n*-times renormalizable maps which have a (k, n) −heteroclinic tangency and

$$
\mathcal{UK}_{k,n}(\overline{\varepsilon})=\bigcup_{k\leq k'
$$

Proposition 4.10. Let $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon}), \overline{\varepsilon} > 0$ small enough. Let $k < n$ and suppose that F satisfies

$$
F\notin \mathcal{UK}_{k,n}(\overline{\varepsilon}).
$$

Then $\mathcal{T}_{k,n}$ holds.

Proof. Fix $k < n$ and a sequence $z_j \in E_{k,n}$, $j \geq 0$, with $z_j \to z$ and

$$
F^{t_j}(z_j) \to s \in S_n,
$$

where $t_j > 0$ in the time of entry of z_j into T_n .

If the t_j 's are bounded, say constant $t_j = t$, the absence of heteroclinic tangencies, $F \notin \mathcal{K}_{k,n}(\overline{\varepsilon})$, implies that

$$
DF^{t}(z)(T_{z}W^{u}(\beta_{k})) \neq T_{s}S_{n}.
$$

Hence,

$$
DF^{t_j}(z_j)(T_{z_j}W^u(\beta_k)) \to T_sS_n.
$$

Secondly, we will consider the case when the times t_j of entry are unbounded.

Claim 4.11. There exists $k < m_1 \leq n$ such that $z \in E_{k,m_1} \cap W^s(\boldsymbol{\beta}_{m_1}).$

Proof. Theorem [4.1](#page-16-0) describes the limit behavior of the orbit of z. Assume,

$$
\omega(z) \subset \mathcal{O}(F) \cup \bigcup_{j>n} \beta_j.
$$

Then for some $t > 0$ we have $F^{i}(z) \in \text{int}(T\text{rap}_{n+1})$ whenever $i \geq t$. This means that the orbit of z_j , $j > 0$ large enough, will also enter this trapping region after t steps. For $j > 0$ large enough, $t_j > t$. This contradicts

$$
F^{t_j}(z_j) \to s \notin \text{Trap}_{n+1} .
$$

Denote the time of entry of z into $S_{m_1} \subset T_{m_1}$ by $r_1 > 0$ and let $F^{r_1}(z) = s_1$. We will call r_1 the first transient time. For $j > 0$ large enough, $z_j \in E_{k,m_1}$ with corresponding entry time $t_j^1 = r_1$. Note that $m_1 < n$. Otherwise, the sequence consisting of $t_j = t_j^1 = r_1$ would be bounded. The absence of heteroclinic tangencies, $F \notin \mathcal{K}_{k,m_1}(\overline{\varepsilon}),$ implies that

$$
DF^{r_1}(z)(T_zW^u(\beta_k)) \neq T_{s_1}S_{m_1}.
$$

Hence,

(4.3)
$$
DF^{t_j^1}(z_j)(T_{z_j}W^u(\beta_k)) \to T_{s_1}S_{m_1}.
$$

Let $e_j^1 > 0$ be maximal such that when $r_1 \leq i \leq e_j^1$ we have

$$
F^i(z_j) \in T_{m_1}.
$$

The moment e_j^1 is called the *time of exit* of z_j from T_{m_1} . We may assume that $F^{e_j^1}(z_j) \to u_1 \in U_{m_1}$. Then [\(4.3\)](#page-25-0) implies, use the λ -Lemma from $[dMP]$,

(4.4)
$$
DF^{e_j^1}(z_j)(T_{z_j}W^u(\beta_k)) \to T_{u_1}U_{m_1}.
$$

Now, we can repeat the proof of Claim [4.11](#page-24-0) and obtain $m_1 < m_2 \leq n$ and $r_2 > 0$, the second transient time, such that

$$
F^{r_2}(u_1) = s_2 \in S_{m_2}.
$$

For $j > 0$ large enough we have $z_j \in E_{k,m_2}$. Denote the time of entry of z_j into T_{m_2} by $t_j^2 > 0$ then $t_j^2 = e_j^1 + r_2$. The absence of heteroclinic tangencies, $F \notin \mathcal{K}_{m_1,m_2}(\overline{\varepsilon})$, implies that

$$
DF^{r_2}(u_1)(T_{u_1}W^u(\beta_{m_1})) \neq T_{s_2}S_{m_2}.
$$

Hence, [\(4.4\)](#page-25-1) implies

(4.5)
$$
DF^{t_j^2}(z_j)(T_{z_j}W^u(\beta_k)) \to T_{s_2}S_{m_2}.
$$

Let $e_j^2 > 0$ be maximal such that when $t_j^2 \leq i \leq e_j^2$ we have

 $F^{i}(z_{j}) \in T_{m_{2}}.$

We may assume that $F^{e_j^2}(z_j) \to u_2 \in U_{m_2}$. Then 2

(4.6)
$$
DF^{e_j^2}(z_j)(T_{z_j}W^u(\beta_k)) \to T_{u_2}U_{m_2}.
$$

If $m_2 = n$, statement [\(4.5\)](#page-25-2) proves the transversality property. In the case when $m_2 < n$ we can repeat this construction, and we get a sequence $m_1 < m_2 < m_3 < \cdots < m_g$ together with points $s_l \in S_{m_l}$, $u_l \in U_{m_l}$ and times of entry and exit $t_j^l > 0$ and $e_j^l > 0$ for $z_j \in E_{k,m_l}$ and the corresponding asymptotic expressions [\(4.3\)](#page-25-0) and [\(4.4\)](#page-25-1).

The sequence m_l is strictly increasing. Hence, $m_g = n$ and $t_j = t_j^g$ j for some $g \geq 1$. Now, statement [\(4.3\)](#page-25-0) corresponding to T_{m_g} ,

$$
DF^{t_j}(z_j)(T_{z_j}W^u(\beta_k)) \to T_sS_n
$$

finishes the proof of the Proposition. \Box

Proposition 4.12. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\epsilon})$, with $\overline{\epsilon} > 0$ small enough, and $k < n$. Assume

$$
(4.7) \t\t\t F \notin \mathcal{U}\mathcal{K}_{k+1,n}(\overline{\varepsilon}).
$$

Then

$$
\bigcup_{k\leq j\leq n}W^u(\boldsymbol{\beta}_j)
$$

is laminar.

Proof. Choose $k \leq j \leq n$. To prove that every point in $W^u(\beta_j)$ is laminar it suffices to prove that every point $z \in U_j$ is laminar. According to Lemma [4.9](#page-23-1) $W^u(\beta_j)$ is not accumulated by $W^u(\beta_m)$ with $m > j$. From Lemma [4.7](#page-22-0) we have that $W^u(\beta_j)$ is a one-dimensional embedded manifold. Hence, the only non-trivial accumulation is from $W^u(\beta_l)$ with $k \leq l < j$. Assume that $z \in U_j$ is not a laminar point. Let $k \leq l < j$ and $z_m \in E_{l,j}$ be a sequence with

$$
F^{e_m}(z_m) \to z
$$

but $DF^{e_m}(z_m)(T_{z_m}W^u(\beta_l))$ stays away from T_zU_j . Let $t_m < e_m$ be such that

$$
F^{t_m}(z_m) \to s \in S_j.
$$

Proposition [4.10](#page-24-1) states that $\mathcal{T}_{i,j}$ holds. Hence, for a subsequence, $DF^{t_m}(z_m)(T_{z_m}W^u(\beta_l))$ stays away from T_sS_j . Then again the λ -Lemma implies that for this subsequence

$$
DF^{e_m}(z_m)(T_{z_m}W^u(\beta_l)) \to T_zU_j
$$

.

Contradiction.

Proof of Theorem [4.6.](#page-21-0) Suppose, $x \in W^u(\beta_n)$ is a non-laminar point of \mathcal{A}_F . According to Lemma [4.9](#page-23-1) this implies that this point is actually a non-laminar point of

$$
\bigcup_{j\leq n}W^u(\boldsymbol{\beta}_j).
$$

This contradicts Proposition [4.12.](#page-26-0)

5. Conjugations

The boundary ∂B of the domain of a Hénon-like map $F : B \to B$ does not have dynamical meaning. Even if we restrict the map to B_0 , only an arc of ∂B_0 , namely $W^s_{\text{loc}}(\beta_0)$, is dynamically meaningful. The fact that the boundary is rather arbitrary entails that the notion of topological equivalence defined by conjugations $h : B \to h(B) = B$ is too restrictive. For this reason, below we slightly relax this notion.

A relative neighborhood $U \subset \overline{B}_0$ is an open set in the intrinsic topology of B_0 . A *conjugation* between two Hénon-like maps $F, F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ is a homeomorphism $h: U \to h(U) = \tilde{U}$ such that

- (1) $U \supset \mathcal{A}_F$ and $\tilde{U} \supset \mathcal{A}_{\tilde{F}}$ are relative neighborhoods in the corresponding boxes;
- (2) U and U are forward invariant under the corresponding dynamics;
- (3) $h \circ F = \tilde{F} \circ h$.

Theorem 5.1. Let $h: U \to \tilde{U}$ be a conjugation between two infinitely renormalizable Hénon-like maps $F, \tilde{F} \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. Then

$$
h(\mathrm{Orb}_{\mathbb{Z}}(\tau_F)) = \mathrm{Orb}_{\mathbb{Z}}(\tau_{\tilde{F}}).
$$

The dynamics of $F|O_F$, the adding machine, is homogeneous, in the sense that the group of automorphisms acts transitively on \mathcal{O}_F (here an *automorphism* is a homeomorphism commuting with F). The situation is different when this Cantor set is embedded as the attractor of a Hénon-like map and the automorphism has an extension to a conjugation. Then, as the above Theorem shows, any automorphism has to preserve the orbit of the tip. This easily implies that the automorphism group is reduced to the cyclic group $\mathbb Z$ of the iterates of $F|\mathcal{O}_F$.

The proof of Theorem [5.1](#page-27-1) needs some preparation. A map $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ has exactly two fixed points: β_0 and β_1 . The first has positive eigenvalues and the second one is of flip type, it has negative eigenvalues. The topological difference between the fixed points imply that every conjugation between two maps satisfies

$$
h(\beta_i)=\tilde{\beta}_i,
$$

for $i = 0, 1$. If a Hénon-like map F is renormalizable then there is only one heteroclinic orbit coming from β_0 and going to β_1 :

$$
W^u(\beta_0) \cap W^s(\beta_1) = \{p_i^1\}_{i \in \mathbb{Z}},
$$

with $F(p_i^1) = p_{i+1}^1$. (The topological definition of renormalizable Hénonlike maps is discussed in §3.4 of [\[CLM\]](#page-66-3)). Observe,

$$
p_0^1 \in W^u(\beta_0) \subset U = \text{Dom}(h).
$$

Hence, every conjugation will satisfy

(5.1)
$$
h(p_0^1) = \tilde{p}_m^1,
$$

for some $m \in \mathbb{Z}$.

In $\S3$ $\S3$ the domain D_1 was introduced, the domain of the first prerenormalization $F^2|D_1$. This topological disc is bounded by two curves $\partial^s \subset W^s(\beta_1)$ and $\partial^u \subset W^u(\beta_0)$ whose endpoints are p_0^1 and p_1^1 . The forward images of D_1 , ∂^s , and ∂^u are denoted respectively by $D_1^l =$ $F^l(D₁), \delta_l^s = F^l(\partial^s),$ and $\delta_l^u = F^l(\partial^u), l \ge 0$. The map $F^l : D₁ \rightarrow D₁^l$ is a diffeomorphism.

For $l \geq 0$, the curve $\delta_l^s \subset W^s(\beta_1)$ connects p_l^1 with p_{l+1}^1 . On the other hand, for $l < 0$, and $\overline{\varepsilon} > 0$ small enough, there is no arc in $W^s(\beta_1)$ which connects p_l^1 with p_{l+1}^1 . The connected components of $W^s(\beta₁)$ that contain the points $p_l¹$, $l < 0$, are pairwise disjoint. This is observed in §[3,](#page-7-0) see Figure [3.1,](#page-49-0) and will be useful in what follows.

Lemma 5.2. Let $h: U \to \tilde{U}$ be a conjugation between $F, \tilde{F} \in \mathcal{I}_{\Omega}(\overline{\varepsilon}),$ $\tilde{F} \circ h = h \circ F$. There exists $k, l \geq 0$ and a conjugation

$$
h': V \to \tilde{V},
$$

given by

$$
h' = \tilde{F}^{-l} \circ h \circ F^k
$$

such that

(1) $D_1 \subset V$, $\tilde{D}_1 \subset \tilde{V}$, and

$$
h'(D_1)=\tilde{D}_1,
$$

(2) for every $x \in V$

$$
h'(\text{Orb}(F^l(x))) = h(\text{Orb}(F^k(x))).
$$

Proof. Lemma [4.2](#page-16-1) gives a $k \geq 1$ such that $F^k(\overline{B_0}) \subset U$. Define a conjugation

$$
h_1: B_0 \to h_1(B_0) \subset \tilde{U} \subset B_0,
$$

by $h_1 = h \circ F^k$. Observe that the maps h and h_1 act in the same way on the space of orbits. In particular, equation [\(5.1\)](#page-28-0) gives some $l \in \mathbb{Z}$ such that

$$
h_1(p_0^1) = \tilde{p}_l^1.
$$

The curve $\partial^s \subset W^s(\beta_1)$ connects p_0^1 with p_1^1 . Hence, the points \tilde{p}_l^1 and \tilde{p}_{l+1}^1 are connected by a curve in the stable manifold of $\tilde{\beta}_1$. So, $l \geq 0$. The domain of h_1 , $Dom(h_1) = B$, contains D_1 . Actually, h_1 matches the boundaries $\partial^{u,s}$ of D_1 with the boundaries $\tilde{\delta}^{u,s}$ of \tilde{D}_1^l . Hence,

$$
h_1(D_1)=\tilde{D}_1^l.
$$

As was noticed previously, the map

$$
\tilde{F}^{-l} : \tilde{D}_1^l \cap \mathcal{A}_{\tilde{F}} \to \tilde{D}_1 \cap \mathcal{A}_{\tilde{F}}
$$

is a well-defined homeomorphism because $l \geq 0$. Choose a relatively open \tilde{F} -forward invariant set $\tilde{V}' \subset B_0$ satisfying

$$
\tilde{D}_1^l \cup \mathcal{A}_{\tilde{F}} \subset \tilde{V}' \subset h_1(B_0),
$$

and small enough such that $\tilde{F}^{-l}|\tilde{V}'|$ is a well-defined diffeomorphism. Let

$$
V = h_1^{-1}(\tilde{V}'),
$$

$$
\tilde{V} = \tilde{F}^{-l}(\tilde{V}'),
$$

and let $h': V \to \tilde{V}$ be defined by

$$
h' = \tilde{F}^{-l} \circ h_1 = \tilde{F}^{-l} \circ h \circ F^k.
$$

By construction this conjugation satisfies $h'(D_1) = \tilde{D}$ ¹.

According to the previous Lemma, we can replace any conjugation by another one which matches the first pre-renormalization domains D_1 and D_1 , and coincides with the original conjugation on the space of orbits. The following Proposition will complete the proof of Theorem [5.1.](#page-27-1)

Proposition 5.3. Let $h: U \to \tilde{U}$ be a conjugation between two infinitely renormalizable Hénon-like maps $F, \tilde{F} \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. If $h(D_1) = \tilde{D}_1$ then

 $h(D_n) = \tilde{D}_n$

for all $n \geq 1$. In particular, $h(\tau_F) = \tau_{\tilde{F}}$.

Proof. First notice that for all $n \geq 0$ we have $D_n \subset D_1 \subset \text{Dom}(h)$ and $\tilde{D}_n \subset \tilde{D}_1 \subset \text{Im}(h)$. So, $h(D_n)$ is well defined.

The proof will be by induction. Assume that $h(D_k) = \tilde{D}_k$, for $k \leq n$. There exists a unique periodic point of period 2^{k+1} in D_k . Namely, $\beta_{k+1} \in \text{int}(D_k)$, $k \leq n$. In particular, $h(\beta_k) = \tilde{\beta}_k$, with $k \leq n+1$.

Proposition [3.5](#page-13-0) gives that both components of $W^s_{\text{loc}}(\beta_{n+1}) \setminus {\beta_{n+1}}$ intersect ∂_n^u . Let $x_0, x_1 \in W_{\text{loc}}^s(\beta_{n+1}) \cap \partial_n^u$ be the boundary points of the connected component of $W^s(\beta_{n+1}) \cap D_n$ containing β_{n+1} . Say x_0 is the first and x_1 is the second intersection of $W^u(\beta_{n-1})$ with the connected component of $W^s(\beta_{n+1}) \cap D_n$ which contains β_{n+1} . These

points are topologically defined. As was noticed before, $h(\beta_k) = \tilde{\beta}_k$, with $k = n - 1, n + 1$. Hence, for $i = 0, 1$,

$$
h(x_i) = \tilde{x}_i.
$$

Let $\gamma \subset W^s_{\text{loc}}(\beta_{n+1})$ bounded by x_0 and x_1 . Then

$$
h(\gamma) = \tilde{\gamma}.
$$

Define $E_n \subset D_n$ to be the connected component of $D_n \setminus \gamma$ which does not contain β_n . Then

$$
h(E_n)=\tilde{E}_n.
$$

Observe,

$$
D_{n+1} \subset E_n.
$$

Let $y_0, y_1 \in W^u(\beta_n) \cap \gamma$ be the first and second intersections of $W^u(\beta_n)$ and γ . Then for $i = 0, 1$

$$
h(y_i)=\tilde{y}_i.
$$

Notice, that the arc between y_0 and y_1 in $W^u(\beta_n)$ equals ∂_{n+1}^u . Furthermore, the arc between y_0 and y_1 in $W^s(\beta_{n+1})$ equals ∂_{n+1}^s . Hence, the boundary of D_{n+1} is matched to the boundary of \tilde{D}_{n+1} . This finishes the induction step, $h(D_{n+1}) = \tilde{D}_{n+1}$. $n+1$.

Remark 5.1. Without loss of generality we will only consider conjugations which match the tips of the maps under consideration.

6. Heteroclinic tangencies

If there is a heteroclinic tangency between $W^u(\beta_k)$ and $W^s(\beta_n)$ then $\beta_n \in \mathcal{A}_F$ is not a laminar point. Under this circumstances there will be non-periodic points which are non-laminar. Let $\mathcal{C}_F \subset \mathcal{A}_F$ consists of the non-laminar points. Note, $\mathcal{O}_F \subset \mathcal{C}_F$.

Any map $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, has a unique periodic Any map $P \in \mathcal{P}_{\Omega}(\varepsilon)$, with $\varepsilon > 0$ small enough, has a unique periodic orbit of period 2^{k-1} , it is the orbit of β_k . Let $\lambda_k \in (-1,0]$ and $\mu_k < -1$ be the stable and unstable multiplier. The attractor at the nth -scale is

$$
\mathcal{A}_F^n = \mathrm{Orb}(\Psi_0^n(\mathcal{A}_{R^nF})) \subset \mathcal{A}_F, \quad n \ge 0.
$$

Theorem 6.1. If the infinitely renormalizable Hénon map $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon}),$ with $\overline{\epsilon} > 0$ small enough, has an (k, n) -heteroclinic tangency and

$$
\frac{\ln|\lambda_k|}{\ln|\mu_n|} \notin \mathbb{Q}
$$

then

$$
\mathcal{A}_F^n \subset \mathcal{C}_F.
$$

Proof. We can choose a C^1 -coordinate system for T_n such that U_n and S_n are part of the x-axis and y-axis resp and that F^{2^n} becomes linear with exponents λ_n and μ_n , see [\[H\]](#page-66-11). Consider the fundamental domain $[1, \mu_n^2]^u \subset U_n$. Let $z \in S_n$ be a (k, n) -heteroclinic tangency.

Observe, that there are components of $W_j \subset W^u(\beta_{k-1}) \cap T_k$, $j \geq 1$, which accumulate from both sides and in C^3 sense on U_k and they are dynamically related. Namely,

$$
F^{-2^k}(W_{j+1}) \subset W_j.
$$

This laminar structure of $W^u(\beta_{k-1})$ around U_k will also be visible in a PSfrag replacements of $z \in S_n$. Because of the tangency at $z \in S_n$ there will be a sequence of points $e_j \in W^u(\beta_{k-1})$ with vertical tangent accumulating at $z \in S_n$.

FIGURE 6.1 .

Let x_j be the x-coordinate of e_j . Then there is some $\rho < 1$ and $C > 0$ such that

$$
x_j = C \cdot (1 + O(\rho^j)) \cdot \lambda_k^j.
$$

Notice that accumulation points of $Orb({e_j | j > 0})$ on U_n are nonlaminar points.

For $j > 0$ even, let $s_j > 0$ be the (even) moment when $F^{s_j}(e_j)$ is above $[1, \mu_n^2]^u$,

$$
x_j\cdot \mu_n^{s_j}\in [1,\mu_n^2]^u.
$$

Let $A = \ln C / \ln \mu_n$ then

$$
s_j + j \frac{\ln |\lambda_k|}{\ln |\mu_n|} + O(\rho^j) + A = h_j \in [0, 2].
$$

Hence,

$$
\frac{h_j}{2} = \frac{s_j}{2} + \frac{1}{2} \cdot (j \cdot \frac{\ln |\lambda_k|}{\ln |\mu_n|} + A) + O(\rho^j) \in [0, 1].
$$

Because s_j is even we have

$$
h_j = 2\{\frac{1}{2} \cdot j \cdot \frac{\ln |\lambda_k|}{\ln |\mu_n|} + A\} + O(\rho^j),
$$

where $\{\cdot\}$ stand for the fractional part. The sequence h_j is dense in [0, 2] because $\frac{\ln |\lambda_k|}{\ln |\mu_n|}$ is irrational. Now, let \hat{x}_j be the projection of $F^{s_j}(e_j)$ on U_n . Then

$$
\hat{x}_j = \mu_n^{h_j}
$$

.

We proved that \mathcal{C}_F contains a fundamental domain of $W^u(\beta_n)$. Namely,

$$
[1,\mu_n^2]^u\subset \mathcal{C}_F.
$$

The set \mathcal{C}_F is closed and invariant. Apply Theorem [4.1](#page-16-0) and the proof is finished. \Box

Corollary 6.2. For $\overline{\varepsilon} > 0$ small enough, for every $k < n$ there exists a dense G_{δ} of infinitely renormalizable maps $F \in \mathcal{K}_{k,n}(\overline{\varepsilon}) \cap \mathcal{I}_{\Omega}(\overline{\varepsilon})$ such that

$$
\mathcal{A}_F^n \subset \mathcal{C}_F.
$$

7. LOCATION OF THE TIP

In this section we will give quantitative information on the location of the tip. Let $F \in \mathcal{I}_{\Omega}(\bar{\epsilon}), \bar{\epsilon} > 0$ small enough. The domain bounded by $W_{\text{loc}}^{s}(\beta_2)$ and $W_{\text{loc}}^{s}(\beta_2')$ is called the *extended saddle region* and denoted by $X \subset B$.

Consider the following family W of curves. A curve $\gamma \subset X$ is in W if it is the graph of a C^2 -function, also denoted by γ , with

$$
\gamma : [x'_{\gamma}, x_{\gamma}] \to \mathbb{R},
$$

such that

$$
(x'_\gamma,\gamma(x'_\gamma))\in W^s_{\text{loc}}(\beta'_2)
$$

and

$$
(x_{\gamma}, \gamma(x_{\gamma})) \in W^s_{\text{loc}}(\beta_2).
$$

We will use the notation $\gamma_{\infty} = U_1 \in \mathcal{W}$, (see Figure [4.1](#page-49-0) to recall the definition of $U_1 \subset B$). The distance dist $(\gamma, \gamma_{\infty})$ is the C^2 -norm between the corresponding functions measured on the domain of γ . Note that we can always extend γ_{∞} within $W^u_{\text{loc}}(\beta_1)$ such that the corresponding domain of this extended function contains the domain $[x'_{\gamma}, x_{\gamma}]$ of any function $\gamma \in \mathcal{W}$.

Let $\Gamma = F(\gamma)$, with $\gamma \in \mathcal{W}$. In particular, $\Gamma_{\infty} = F(\gamma_{\infty}) \supset \gamma_{\infty}$. Note that each curve Γ can be described as a graph over the y-axis,

$$
\Gamma : [y'_{\gamma}, y_{\gamma}] \to \mathbb{R}.
$$

This is a consequence of the fact that Henon-like maps map vertical lines to horizontal lines, $y' = x$. Moreover,

$$
(\Gamma(y_\gamma),y_\gamma)\in W^s_{\rm loc}(\beta_2')
$$

and

$$
(\Gamma(y'_\gamma), y'_\gamma) \in W^s_{\text{loc}}(\beta_2).
$$

Indeed, we will consider the curves $\Gamma = F(\gamma)$ as graphs over the y–axis. Note that we can always extend Γ_{∞} within $W^u_{\text{loc}}(\beta_1)$ such that the corresponding domain of the extension contains the domain $[y'_{\gamma}, y_{\gamma}]$ of any function Γ . The distance dist(Γ, Γ_{∞}) is the C^2 -norm between the corresponding functions measured on the domain of Γ.

The map F acts on W as a graph transform. Namely, the curve $W^s_{\text{loc}}(\beta_2)$ divide each Γ into two components. One of which, denoted by $\mathcal{T}_F(\gamma)$, is in \mathcal{W} ,

$$
\mathcal{T}_F: \gamma \mapsto F(\gamma) \cap X.
$$

Proposition 7.1. There exists $C > 0$, such that for all $F \in \mathcal{I}_{\Omega}(\bar{\epsilon})$, $\overline{\epsilon} > 0$ small enough, the following holds:

(7.1)
$$
\text{dist}(\Gamma, \Gamma_{\infty}) \leq C \cdot b_F \cdot \text{dist}(\gamma, \gamma_{\infty})
$$

and

(7.2)
$$
\text{dist}(\mathcal{T}_F(\gamma), \gamma_\infty) \leq C \cdot b_F \cdot \text{dist}(\gamma, \gamma_\infty).
$$

$$
If |\gamma(x) - \gamma_{\infty}(x)| \in [\delta_1, \delta_2] \text{ with } x \in [x'_{\gamma}, x_{\gamma}] \text{ then}
$$

(7.3)
$$
|\mathcal{T}_F(\gamma)(x) - \gamma_{\infty}(x)| \in [\frac{1}{C} \cdot b_F \cdot \delta_1, C \cdot b_F \cdot \delta_2],
$$

for $x \in [x'_{\mathcal{T}_F(\gamma)}, x_{\mathcal{T}_F(\gamma)}]$ and

(7.4)
$$
|\Gamma(y) - \Gamma_{\infty}(y)| \in [\frac{1}{C} \cdot b_F \cdot \delta_1, C \cdot b_F \cdot \delta_2],
$$

for $y \in [y'_\gamma, y_\gamma]$.

Proof. Let $F \in \mathcal{I}_{\Omega}(\overline{\epsilon})$, say $F(x, y) = (f(x) - \epsilon(x, y), x)$. Inspired by Theorem 7.9 from [CLM], we use the following representation

$$
\epsilon(x, y) = b_F a(x) y(1 + m(x, y)).
$$

The correction term m is uniformly bounded for $F \in \mathcal{I}_{\Omega}(\bar{\epsilon})$. The specific form of a Hénon-like map, $F(x, y) = (f(x) - \epsilon(x, y), x)$, implies

$$
\Gamma(y) - \Gamma_{\infty}(y) = -\epsilon(y, \gamma(y)) - \epsilon(y, \gamma_{\infty}(y))
$$

= $-b_F a(y) \cdot (\gamma(y) - \gamma_{\infty}(y)) +$
 $-b_F a(y) \cdot (\gamma(y) - \gamma_{\infty}(y)) \cdot m(y, \gamma(y)) +$
 $-b_F a(y) \cdot \gamma_{\infty}(y) \cdot (m(y, \gamma(y)) - m(y, \gamma_{\infty}(y)).$

The uniform bounds on m and its derivatives give immediately the Properties (7.1) and (7.4) .

Let $\gamma_0 : x \mapsto 0$. The expression $F(x, y) = (f(x) - \epsilon(x, y), x)$ implies that Γ_0 is the graph of the unimodal map f. Let $Y \subset \text{Dom}(\Gamma_0)$ be such that the graph of $\Gamma_0|Y \subset X$, the extended saddle region. The graph of f has its maximum outside the extended saddle region. This implies that

$$
|D\Gamma_0|Y| \ge \delta > 0.
$$

Also

$$
|D\Gamma_{\infty}|Y| \ge \frac{1}{2}\delta > 0,
$$

which holds because of (7.1) :

$$
dist(\Gamma_0, \Gamma_\infty) = O(b_F).
$$

Now, use in the above expression for the difference of $\Gamma(y)$ and $\Gamma_{\infty}(y)$ the fact that the derivative of $\Gamma_{\infty}|Y$ is away from zero: Properties [\(7.2\)](#page-33-1) and (7.3) follow.

Remark 7.1. According to Theorem 7.9 from [\[CLM\]](#page-66-3) the correction term m_n of R^nF decays exponentially.

Let $q'_1, q_1 \in W^u(\beta_0)$ be the the first intersection, coming from β_0 along $W^u(\beta_0)$, with $W^s_{\text{loc}}(\beta_2')$ and $W^s_{\text{loc}}(\beta_2)$, compare Figure [4.1.](#page-49-0) Consider the corresponding curve $\gamma_1 = [q'_1, q_1]^u \subset W^u(\beta_0)$. Note, $\gamma_1 \in \mathcal{W}$. Let

$$
\gamma_i = \mathcal{T}_F^{i-1}(\gamma_1), \ i = 2, 3, \dots
$$

The curves

$$
\Gamma_i = F(\gamma_{i-1}) \supset \gamma_i, \ i = 2, 3, \dots
$$

will be used to locate the tip.

Corollary 7.2. There exists $C > 0$, independent of the particular $F \in$ $\mathcal{I}_{\Omega}(\overline{\epsilon})$, such that for $i \geq 2$

> $dist(\Gamma_i, \Gamma_\infty) \leq C^i \cdot b_F^{i-1}$ F

and

$$
\frac{1}{C^i} \cdot b_F^{i-1} \le |\Gamma_i(y) - \Gamma_\infty(y)| \le C^i \cdot b_F^{i-1},
$$

for $y \in \text{Dom}(\Gamma_i)$.

Lemma 7.3. There exist unique points $v_i \in \Gamma_i$, $i \geq 2$, and $v_{\infty} \in \Gamma_{\infty}$ with a vertical tangent direction. Moreover,

$$
\frac{d\Gamma_i}{dy} \asymp -(y - v_i), \ i = 2, 3, \dots, \infty.
$$

Proof. Let $F(x, y) = (f(x) - \epsilon(x, y), x)$ and $\gamma_0 : x \mapsto 0$. Then $\Gamma_0 =$ $F(\gamma_0)$ is the graph of f over the y−axis. Proposition [7.1](#page-33-2) and Corol-lary [7.2](#page-35-0) imply that in C^2 sense we have

 $dist(\Gamma_0, \Gamma_i) \leq dist(\Gamma_0, \Gamma_{\infty}) + dist(\Gamma_{\infty}, \Gamma_i) \leq C \cdot b_F + C^i \cdot b_F^{i-1} \lt 1,$

for $i = 2, 3, \ldots$ The Lemma follows because f has a non degenerate critical point.

Let a be the intersection point of the horizontal line through $\tau = \tau_F$ and Γ_2 . Note, *a* is to the right of τ . In case we are analyzing these points of the renormalization $R^k F$, we will use the notation $v_i^k \in \Gamma_i^k$, $i = 2, 3, \ldots, \infty$, the points with vertical tangency.

Proposition 7.4. For all $F \in \mathcal{I}_{\Omega}(\bar{\epsilon}), \bar{\epsilon} > 0$ small enough, the following holds.

(1)
$$
|\pi_1(v_2) - \pi_1(a)| = O(b_F^2)
$$
,
\n(2) $|\pi_2(v_2) - \pi_2(a)| = O(b_F)$,
\n(3) $|v_2 - \tau| = O(b_F)$,
\n(4) $|\tau - a| \approx b_F$.

Remark 7.2. The proof of Proposition [7.4](#page-36-0) is illustrated with Figures [7.2](#page-54-0) and [7.3.](#page-59-0) The x-direction has been stretched dramatically.The analysis is done in a small neighborhood of v_{∞}^{k+1} in Figure [7.2](#page-54-0) and around v_{∞} in Figure [7.3.](#page-59-0) So, in the actual picture the curves are essentially straight vertical lines and the difference between the x-coordinates \hat{x}_{k+1}, x_{k+1} , and x'_{k+1} would be invisible.

Proof. Take $k \geq 0$ and consider $R^{k+1}F$. Observe,

$$
v_{\infty}^{k} \in \Phi_k^{k+1}(\Gamma_2^{k+1}) \subset \Phi_k^{k+1}(W^u(\beta_0(R^{k+1}F))).
$$

So, we can choose a point $\hat{v}_{\infty}^{k+1} \in \Gamma_2^{k+1} \subset \Omega_{k+1}$ such that

$$
\Phi_k^{k+1}(\hat{v}_{\infty}^{k+1}) = v_{\infty}^k \in D_2(R^k F).
$$

In coordinates, see Figure [7.2,](#page-54-0)

$$
\hat{v}_{\infty}^{k+1} = (\hat{x}_{k+1}, \hat{y}_{k+1})
$$

and

$$
v_{\infty}^{k+1} = (x_{k+1}, y_{k+1}).
$$

Remember,

$$
\Lambda_k \circ H_k \equiv (\Phi_k^{k+1})^{-1},
$$

with

$$
H_k(x, y) = (f_k(x) - \epsilon_k(x, y), y).
$$

The affine map Λ_k is a dilatation. Consider DH_k and observe that this derivative maps the vertical tangent vector at v_{∞}^{k} to Γ_{∞}^{k} to an almost vertical vector. The angle between the image vector and the vertical is of the order $b_F^{2^k}$ ^{2^k}. Then, because $\hat{v}_{\infty}^{k+1} = \Lambda_k \circ H_k(v_{\infty}^k)$ and $D\Gamma_{\infty}^k(y_k) = 0$, we get

(7.5)
$$
|D\Gamma_2^{k+1}(\hat{y}_{k+1})| = O(b_F^{2^k}).
$$

Let

$$
x'_{k+1} = \pi_1(\Gamma_2^{k+1}(y_{k+1})).
$$

Corollary [7.2](#page-35-0) gives

(7.6)
$$
|x_{k+1} - x'_{k+1}| \asymp b_F^{2^{k+1}}
$$

and

(7.7)
$$
|D\Gamma_2^{k+1}(y_{k+1})| = O(b_F^{2^{k+1}}).
$$

The estimates [\(7.5\)](#page-37-0) and [\(7.7\)](#page-37-1) together with Lemma [7.3](#page-35-1) gives,

(7.8)
$$
|\hat{y}_{k+1} - y_{k+1}| = O(b_F^{2^k}).
$$

The derivative of Γ_2^{k+1} is bounded, see Lemma [7.3.](#page-35-1) Use this and the estimates [\(7.6\)](#page-37-2) and [\(7.8\)](#page-37-3) to get

$$
|\hat{x}_{k+1} - x_{k+1}| \le |\hat{x}_{k+1} - x'_{k+1}| + |x'_{k+1} - x_{k+1}|
$$

\n
$$
\le |\hat{y}_{k+1} - y_{k+1}| \cdot |D\Gamma_2^{k+1}| + O(b_F^{2^{k+1}}) = O(b_F^{2^k}).
$$

This and estimate [\(7.8\)](#page-37-3) implies

$$
|\hat{v}_{\infty}^{k+1} - v_{\infty}^{k+1}| = O(b_F^{2^k}).
$$

The map Φ_k^{k+1} has a uniformly bounded derivative. So

$$
|v_{\infty}^{k} - \Phi_k^{k+1}(v_{\infty}^{k+1})| = O(b_F^{2^k}).
$$

Lemma 5.1 of [\[CLM\]](#page-66-3) gives, for $k \geq 0$,

(7.9)
$$
|\Phi_0^k(v_\infty^k) - \Phi_0^{k+1}(v_\infty^{k+1})| = O(\sigma^k \cdot b_F^{2^k}).
$$

Notice,

$$
\Phi_0^k(v_\infty^k) \in D_k.
$$

This implies

$$
\Phi_0^k(v_\infty^k) \to \tau,
$$

for $k \to \infty$. The estimates [\(7.9\)](#page-38-0) implies

(7.10)
$$
|v_{\infty} - \tau| \leq \sum_{k=0}^{\infty} |\Phi_0^k(v_{\infty}^k) - \Phi_0^{k+1}(v_{\infty}^{k+1})| = O(b_F).
$$

Introduce the following notation, see Figure [7.3,](#page-59-0)

$$
\tau = (x, y),
$$

\n
$$
a = (x_a, y),
$$

\n
$$
v_{\infty} = (u_{\infty}, w_{\infty}),
$$

\n
$$
\Gamma_2(w_{\infty}) = u'_2,
$$

\n
$$
v_2 = (u_2, w_2).
$$

Corollary [7.2](#page-35-0) gives

(7.11) $|u_{\infty} - u'_{2}| \approx b_{F},$

and

$$
|D\Gamma_2(w_\infty) = O(b_F).
$$

By definition,

 $|D\Gamma_2(w_2)=0.$

So, Lemma [7.3](#page-35-1) gives

(7.12)
$$
|w_{\infty} - w_2| = O(b_F).
$$

The second derivative of Γ_2 is bounded, which implies

(7.13) $|u_2 - u'_2| = O(|w_\infty - w_2|^2) = O(b_F^2).$

The estimates in [\(7.10\)](#page-38-1) and [\(7.12\)](#page-38-2) imply

(7.14)
$$
|y - w_2| \le |y - w_{\infty}| + |w_{\infty} - w_2| = O(b_F).
$$

We proved (2). Use estimate [\(7.14\)](#page-38-3) and Lemma [7.3](#page-35-1) to get

(7.15)
$$
|x_a - u_2| = O(|y - w_2|^2) = O(b_F^2).
$$

FIGURE 7.3.

We proved (1). Next we will prove (4). First the upper bound. To do so, use the inequalities (7.10) , (7.11) , (7.13) , and (7.15) to estimate the four term below.

(7.16)
$$
|\tau - a| = |x - x_a|
$$

$$
\leq |x - u_{\infty}| + |u_{\infty} - u'_2| + |u'_2 - u_2| + |u_2 - x_a|
$$

$$
= O(b_F).
$$

The lower bound follows from inequalities [\(7.11\)](#page-38-4), [\(7.13\)](#page-38-5), and [\(7.15\)](#page-38-6):

$$
|\tau - a| \ge |x_a - u_{\infty}|
$$

\n
$$
\ge |u'_2 - u_{\infty}| - |u_2 - u'_2| - |u_2 - x_a|
$$

\n
$$
= O(b_F).
$$

Left is to prove (3) . To do so, use the inequalities (7.16) , (7.15) , and $(7.14):$ $(7.14):$

$$
|\tau - v_2| \le |\tau - a| + \sqrt{|x_a - u_2|^2 + |y - w_2|^2} = O(b_F).
$$

8. The average Jacobian as topological invariant

Fix $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ with $\overline{\varepsilon} > 0$ small enough. Let $M_1^k \subset B$, with $k \geq 1$, be as defined in §[3.](#page-7-0) Let $D^{\tau} \subset D_1$ be the connected component of $D_1 \setminus W^s_{loc}(\tau)$ which does not contain β_1 , see Figure [8.1.](#page-49-0) Define,

$$
\kappa_F = \min\{k \ge 1 | M_1^k \cap D^\tau \ne \emptyset\}.
$$

Lemma 8.1. Let $F, \tilde{F} \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ with $\overline{\varepsilon} > 0$ small enough. If F and \tilde{F} are conjugate then

$$
\kappa_{\tilde{F}}=\kappa_F.
$$

Moreover, if h is a conjugation between F and \tilde{F} with $h(D_1) = \tilde{D}_1$ then

$$
h(D^{\tau} \cap M_1^k) = \tilde{D}^{\tau} \cap \tilde{M}_1^k.
$$

Proof. The curves M_1^k are not topologically determined. However,

$$
M_1^k \subset F^{-2^{k+1}}([p_0^k, p_2^k]^s),
$$

where $[p_0^k, p_2^k]^s \subset W^s(\beta_k)$ is the curve connecting p_0^k with p_2^k , see §[3](#page-7-0) and Figure [3.1.](#page-49-0) Proposition [3.5](#page-13-0) gives

$$
D^{\tau} \cap F^{-2^{k+1}}([p_0^k, p_2^k]^s) = D^{\tau} \cap M_1^k.
$$

We may assume, see Proposition [5.2,](#page-28-1) that we have a conjugation h between F and \tilde{F} with $h(D_1) = \tilde{D}_1$. The set $D^{\tau} \cap F^{-2^{k+1}}([p_0^k, p_2^k]^s)$ is topologically defined. So,

$$
h(D^{\tau} \cap M_1^k) = h(D^{\tau} \cap F^{-2^{k+1}}([p_0^k, p_2^k]^s))
$$

= $\tilde{D}^{\tau} \cap \tilde{F}^{-2^{k+1}}([p_0^k, \tilde{p}_2^k]^s)$
= $\tilde{D}^{\tau} \cap \tilde{M}_1^k$.

This means that κ_F is a topological invariant.

We will suppress the index $F: \kappa = \kappa_F$ and $b = b_F$, etc. The intersection point of M_1^k with the horizontal line through τ is denoted by z_k .

Remark 8.1. The proof of Proposition [8.2](#page-40-0) is illustrated in Figure [8.1.](#page-49-0) Again the horizontal direction has been stretched dramatically.

Proposition 8.2.

$$
|\tau-z_{\kappa}|\asymp b.
$$

Proof. The curves M_1^k are graphs over the y-axis with a slope bounded by

$$
\left|\frac{dM_1^k}{dy}\right| \le K_1 \cdot b.
$$

Consider the curve Γ_2 , as defined in §[7.](#page-32-0) This curve has a definite curvature, see Lemma [7.3.](#page-35-1) This means that there are unique tangent lines L_1 and L_2 to Γ_2 with slopes, as a graph of the y-axis, equal to $-K_1 \cdot b$ and $K_1 \cdot b$. The connected component of $B \setminus (L_1 \cup L_2)$ which

FIGURE 8.1.

contains D_{τ} is called D. The lines L_1 and L_2 intersect the horizontal line L trough τ . Let $A \in L$ be among these intersection points the one furthest to the right, say $A = L \cap L_1$. Denote the tangent points of L_1 by C. Finally, let $(A, \infty) \subset L$ be the connected component of $L \setminus \{A\}$ which does not contain τ .

Observe, every curve intersecting D and (A, ∞) will have somewhere a tangent line with absolute value of the slope, with respect to the yaxis, larger than $K_1 \cdot b$. Hence,

(8.1)
$$
M_1^k \cap D^\tau \neq \emptyset \Rightarrow M_1^k \cap [\tau, A] \neq \emptyset.
$$

The intersection point of Γ_2 with the horizontal line through τ is denoted by a. Then

(8.2)
$$
M_1^k \cap [\tau, a] \neq \emptyset \Rightarrow M_1^k \cap D^{\tau} \neq \emptyset.
$$

The implication [\(8.2\)](#page-41-0) and Proposition [7.4\(](#page-36-0)4) imply

$$
(8.3) \qquad |\tau - z_{\kappa - 1}| \ge |\tau - a| \asymp b.
$$

Proposition [3.5](#page-13-0) states

$$
(8.4) \t\t\t |\tau - z_k| \asymp \sigma^{2k}.
$$

Then inequality [\(8.3\)](#page-41-1) and [\(8.4\)](#page-41-2) give $K_2 > 0$ such that

$$
(8.5) \t\t |\tau - z_{\kappa}| \ge K_2 \cdot b.
$$

An upper bound is given by [\(8.1\)](#page-41-3). Namely,

$$
(8.6) \t\t |\tau - z_{\kappa}| \leq |\tau - A|.
$$

Left is to estimate $|\tau - A|$. According to Lemma [7.3](#page-35-1) and Proposi-tion [7.4\(](#page-36-0)1) and (2) we get

$$
|\pi_2(a) - \pi_2(v_2)| = O(b),
$$

$$
|\pi_1(a) - \pi_1(v_2)| = O(b^2).
$$

Lemma [7.3](#page-35-1) implies

$$
|\pi_2(C) - \pi_2(v_2)| = O(b),
$$

$$
|\pi_1(C) - \pi_1(v_2)| = O(b^2).
$$

Hence,

(8.7)
$$
|\pi_2(C) - \pi_2(a)| = O(b),
$$

$$
|\pi_1(C) - \pi_1(a)| = O(b^2).
$$

The slope of L with the vertical is $\pm K_1 \cdot b$. Hence,

(8.8)
$$
|\pi_1(C) - \pi_1(A)| = O(b^2).
$$

The estimates [\(8.7\)](#page-42-0) and [\(8.8\)](#page-42-1) imply,

$$
|a - A| = O(b^2).
$$

Together with Proposition [7.4\(](#page-36-0)4) we get

$$
|\tau - A| = |\tau - a| + |a - A| \asymp b.
$$

Thus together with [\(8.5\)](#page-42-2) and [\(8.6\)](#page-42-3) we get

$$
|\tau-z_{\kappa}|\asymp b.
$$

 \Box

Theorem 8.3. Let $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. Then

$$
\boldsymbol{\kappa}_{F}=\lim_{n\rightarrow\infty}\frac{\kappa_{R^{n}F}}{2^{n}}=\frac{1}{2}\frac{\ln b_{F}}{\ln\sigma}
$$

exists and is a topological invariant. In particular, b_F is a topological invariant.

Proof. If $F, \tilde{F} \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ are conjugate then there is a conjugation h between them with

$$
h(D_n)=\tilde{D}_n,
$$

 $n \geq 0$. This follows from Lemma [5.2](#page-28-1) and Proposition [5.3.](#page-29-0) This means that the conjugation h induces a conjugation, denoted by h_n , between $F_n = R^n F$ and $\tilde{F}_n = R^n \tilde{F}$. Thus

$$
h_n(F_n^{-2^{k+1}}([p_0^k, p_2^k]^s)) = \tilde{F}_n^{-2^{k+1}}([\tilde{p}_0^k, \tilde{p}_2^k]^s)
$$

and

$$
h_n(D^{\tau}(F_n)) = D^{\tau}(\tilde{F}_n).
$$

This implies

$$
\kappa_{\tilde{F}_n}=\kappa_{F_n}.
$$

The definition of κ_F is topological. Left is to identify its value. Proposition [3.5](#page-13-0) gives

$$
|\tau_{F_n} - z_{\kappa_{F_n}}| \asymp \sigma^{2\kappa_{F_n}}
$$

and Proposition [8.2](#page-40-0) gives

$$
|\tau_{F_n} - z_{\kappa_{F_n}}| \asymp b^{2^n}.
$$

These two estimates imply

$$
\sigma^{2\kappa_{F_n}} \asymp b^{2^n}.
$$

Thus

$$
\boldsymbol{\kappa}_F = \lim_{n \to \infty} \frac{\kappa_{F_n}}{2^n} = \frac{1}{2} \frac{\ln b_F}{\ln \sigma}.
$$

9. The stable lamination

Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. The set \mathcal{P}_F^n consists of the periodic points of period at most 2^{n-1} . Define

$$
\mathcal{F}_n^s = \bigcup_{x \in \mathcal{P}_F^n} W^s(x).
$$

Lemma 9.1. \mathcal{F}_n^s is closed.

Proof. Let $z_j \in \mathcal{F}_n^s$ with $z_j \to z$. We may assume that for all $j \geq 1$ $z_j \in W^s(\beta_k)$ with $k \leq n$. Suppose $z \notin \mathcal{F}_n^s$. According to Theorem [4.1](#page-16-0) we have

$$
\omega(z) \subset \bigcup_{k>n} \beta_k \cup \mathcal{O}_F \subset \mathrm{int}(\mathrm{Trap}_{n+1}).
$$

Trap_{n+1} is forward invariant. Hence, for $j \geq 1$ large enough, we have

$$
\mathcal{B}_k = \omega(z) \subset \text{Trap}_{n+1} \, .
$$

Contradiction, $k \leq n$.

Remark 9.1. For $x \in \mathcal{P}_F^n$

 $\overline{\mathrm{Orb}(W^s(x))} \setminus \mathrm{Orb}(W^s(x)) = \mathcal{F}^s_{n-1}.$

The proof of the fact that the closure is contained in \mathcal{F}_{n-1}^s relies on Lemma [4.7](#page-22-0) and the proof of Lemma [9.1.](#page-43-1) The other inclusion follows from a statement similar to Lemma [4.4](#page-17-0) but discussing stable manifolds.

A point $z \in \mathcal{F}_n^s$ is laminar if for any sequence $z_j \in \mathcal{F}_n^s$ with $z_n \to z$

 $T_{z_j}W^s(z_j) \to T_zW^s(z).$

The set \mathcal{F}_n^s is *laminar* if all its points are laminar.

Theorem 9.2. Let $F \in \mathcal{H}_{\Omega}^{n}(\overline{\epsilon})$, with $\overline{\epsilon} > 0$ small enough. If

$$
F \notin \bigcup_{k' < n' \leq n} \mathcal{K}_{k',n'}
$$

then \mathcal{F}_n^s is laminar.

The proof of this Theorem is similar to the proof of Theorem [4.6](#page-21-0) with some modifications, see the proof of Claim [9.4.](#page-45-0) For completeness we include the proof. Using the notation of §[4](#page-15-0) we will choose the interval

$$
K_n^s = [p_0, p_2]^s \subset W_{\text{loc}}^s(\beta_n),
$$

as a fundamental domain in $W^s(\beta_n)$, see Figure [4.1.](#page-49-0) For $k < n$ define,

$$
E_{n,k}^{s} = \{ x \in K_n^s | \exists t > 0 \; \forall j < t \; F^{-j}(x) \notin T_k \text{ and } F^{-t}(x) \in T_k \}.
$$

The time $t > 0$ in the above definition is called the *time of entry* of $x \in E_{n,k}^s$ into T_k .

Definition 9.1. Let $k < n$. We say that F satisfies the transversality condition $\mathcal{T}_{n,k}^s$ if the following holds. Let $z_j \in E_{n,k}^s, j \geq 0$, be a sequence such that

$$
F^{-t_j}(z_j) \to u \in U_k,
$$

where $t_j > 0$ is the time of entry of z_j into T_k , then

$$
DF^{-t_j}(z_j)(T_{z_j}W^s(\beta_n)) \nrightarrow T_uW^u(\beta_k).
$$

Proposition 9.3. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon}), \overline{\varepsilon} > 0$ small enough. Let $k < n$ and

$$
F \notin \bigcup_{k \le k' < n' \le n} \mathcal{K}_{k',n'}(\overline{\varepsilon})
$$

then $\mathcal{T}_{n,k}^s$ holds.

Proof. Choose a sequence $z_j \in E_{n,k}^s$, $j \geq 0$, with $z_j \to z$ and

 $F^{-t_j}(z_j) \to u \in \text{int}(U_n),$

where $t_j > 0$ is the time of entry of z_j into T_k . If the t_j are bounded, say constant $t_j = t$, the absence of heteroclinic tangencies, $F \notin \mathcal{K}_{k,n}(\overline{\varepsilon}),$ implies that

$$
DF^{-t}(z)(T_zW^s(\beta_k)) \neq T_uU_k.
$$

Hence,

$$
DF^{-t_j}(z_j)(T_{z_j}W^s(\beta_k)) \to T_uU_k.
$$

Let us continue with the case when $t_j \to \infty$.

Claim 9.4. There exists $n > m_1 \geq k$ such that $z \in E^{s}_{n,m_1} \cap W^{u}(\beta_{m_1}).$

Proof. Let $t \geq 0$ be an arbitrary moment of time. Assume

$$
F^{-t}(z) \notin \operatorname{Trap}_k.
$$

This means that for $j \geq 1$ large enough,

$$
F^{-t}(z_j) \notin \text{Trap}_k,
$$

because Trap_k is closed. The invariance $F(\text{Trap}_k) \subset \text{Trap}_k$ implies that for all $j \geq 1$

(9.1)
$$
F^{-t_j}(z_j) \notin \text{Trap}_k.
$$

The construction of Trap_k implies that

(9.2)
$$
F^{2^k}(\text{Trap}_k) \subset \text{int}(\text{Trap}_k).
$$

From (9.1) and (9.2) we get

 $F^{-t_j}(z_j) \to u \notin \text{Trap}_k.$

Contradiction. So for each $t \geq 0$

 $F^{-t}(z) \in \text{Trap}_k.$

This means

(9.3) $\alpha(z) \subset \text{Trap}_k$.

Suppose,

$$
\alpha(z) \cap \text{Trap}_{n+1} \neq \emptyset.
$$

Then [\(9.2\)](#page-45-2) implies that

$$
\alpha(z) \cap \mathrm{int}(\mathrm{Trap}_{n+1}) \neq \emptyset.
$$

So there is a $t > 0$ such that $F^{-t}(z) \in \text{Trap}_{n+1}$. Again, [\(9.2\)](#page-45-2) implies

$$
\mathcal{B}_n = \omega(z) \subset \text{Trap}_{n+1} \, .
$$

Contradiction. Thus

$$
\alpha(z) \cap \text{Trap}_{n+1} = \emptyset.
$$

According to Theorem [4.1](#page-16-0) every non periodic orbit outside Trap_{n+1} will enter Trap_{n+1}. Hence, for some $m_1 \leq n$

$$
\alpha(z)=\boldsymbol{\beta}_{m_1}.
$$

In particular,

$$
z \in W^u(\boldsymbol{\beta}_{m_1}).
$$

There are no homoclinic orbits. Hence, $m_1 < n$.

Left is to show that $k \leq m_1$. Observe, $\alpha(z) \subset \text{Trap}_k$, see [\(9.3\)](#page-45-3), and $\alpha(z) = \boldsymbol{\beta}_{m_1}$. If $m_1 < k$ then $\boldsymbol{\beta}_{m_1} \cap \text{Trap}_k = \emptyset$. So $k \leq m_1 < n$, which finishes the proof of the Claim.

Denote the time of entry of z into $U_{m_1} \subset T_{m_1}$ by $r_1 > 0$ and let $F^{-r_1}(z) = u_1$. We will call r_1 the first transient time. For $j > 0$ large enough, $z_j \in E^{s}_{n,m_1}$ with corresponding time of entry $t_j^1 = r_1$. The absence of heteroclinic tangencies, $F \notin \mathcal{K}_{m_1,n}(\overline{\varepsilon})$, implies that

$$
DF^{-r_1}(z)(T_zW^s(\beta_n)) \neq T_{u_1}U_{m_1}.
$$

Hence,

(9.4)
$$
DF^{-t_j^1}(z_j)(T_{z_j}W^s(\beta_n)) \to T_{u_1}U_{m_1}.
$$

In the case when $m_1 = k$ we proved that the sequence z_j satisfies the transversality condition.

Consider the case when $m_1 > k$. Let $e_j^1 > 0$ be such that for $i =$ $r_1, r_1 + 1, \ldots, e_j^1$

$$
F^{-i}(z_j) \in T_{m_1}
$$

but

$$
F^{-(e_j^1+1)}(z_j) \notin T_{m_1}
$$

The moment e_j^1 is called the *time of exit* of z_j from T_{m_1} . We may assume that $F^{-e_j^1}(z_j) \to s_1 \in S_{m_1}$. Then [\(9.4\)](#page-46-0) implies

(9.5)
$$
DF^{-e_j^1}(z_j)(T_{z_j}W^s(\beta_k)) \to T_{s_1}S_{m_1}.
$$

Now, we can repeat the proof of Claim [9.4](#page-45-0) and obtain $k \leq m_2$ $m_1 < n$ and $r_2 > 0$, the second transient time, such that

$$
F^{-r_2}(s_1) = u_2 \in U_{m_2}.
$$

For $j > 0$ large enough we have $z_j \in E^s_{n,m_2}$. Denote the time of entry of z_j into T_{m_2} by $t_j^2 > 0$ then $t_j^2 = e_j^1 + r_2$. The absence of heteroclinic tangencies, $F \notin \mathcal{K}_{m_2,m_1}(\overline{\varepsilon})$, implies that

$$
DF^{-r_2}(s_1)(T_{s_1}W^s(\beta_{m_1})) \neq T_{u_2}U_{m_2}.
$$

Hence, [\(9.5\)](#page-46-1) implies

(9.6)
$$
DF^{-t_j^2}(z_j)(T_{z_j}W^s(\beta_n)) \to T_{u_2}U_{m_2}.
$$

Let $e_j^2 > 0$ be maximal such that for $i = t_j^2, t_j^2 + 1, \ldots, e_j^2$ $F^{-i}(z_j) \in T_{m_2}.$

but

$$
F^{-(e_j^2+1)}(z_j) \notin T_{m_2}.
$$

We may assume that $F^{-e_j^2}(z_j) \to s_2 \in S_{m_2}$. Then

(9.7)
$$
DF^{-e_j^2}(z_j)(T_{z_j}W^s(\beta_n)) \to T_{s_2}S_{m_2}.
$$

If $m_2 = k$, statement [\(9.6\)](#page-46-2) proves the transversality property. In the case when $m_2 > k$ we can repeat this construction, and we get a sequence $m_1 > m_2 > m_3 > \cdots > m_g$ together with points $u_l \in U_{m_l}$, $s_l \in S_{m_l}$ and entry and exit times $t_j^l > 0$ and $e_j^l > 0$ for $z_j \in E_{n,m_l}^s$ and the corresponding asymptotic expressions [\(9.4\)](#page-46-0) and [\(9.5\)](#page-46-1).

The sequence m_l is strictly decreasing. Hence, $m_g = k$ and $t_j = t_j^g$ j for some $g \geq 1$. Now, statement [\(9.4\)](#page-46-0) corresponding to T_{m_g} ,

$$
DF^{-t_j}(z_j)(T_{z_j}W^s(\beta_k)) \to T_uU_k,
$$

finishes the proof of the Proposition.

Proof of Theorem [9.2.](#page-44-0) Choose $k \leq n$. To prove that every point in $W^s(\beta_k)$ is laminar it suffices to prove that every point $z \in S_k$ is laminar. From Lemma [4.7](#page-22-0) we have that $W^s(\beta_k)$ is an embedded onedimensional manifold. Hence, the only non-trivial accumulation is from $W^u(\beta_{k'})$ with $n \geq k' > k$. Let $k' > k$ and $z_j \in E^s_{k',k}$ be a sequence with

$$
F^{-t_j}(z_j) \to u \in U_k,
$$

and

$$
F^{-e_j}(z_j) \to z \in S_k
$$

with $e_j > t_j$.

Proposition [9.3](#page-44-1) states that $\mathcal{T}_{k',k}^s$ holds. Now $\mathcal{T}_{k',k}^s$ implies that

$$
DF^{-t_j}(z_j)(T_{z_j}W^s(\beta_{k'})) \to T_uU_k.
$$

Hence, according to the λ -Lemma,

$$
DF^{-e_j}(z_j)(T_{z_j}W^s(\beta_{k'})) \to T_zS_k.
$$

 \Box

The proof of the following Theorem is similar to the proof of Theo-rem [6.1.](#page-31-1) We will omit the proof. For a $F \in \mathcal{H}^n_\Omega(\overline{\varepsilon})$ let $\mathcal{C}^s_n \subset \mathcal{F}^s_n$ be the set of non-laminar points of \mathcal{F}_n^s . The stable and unstable eigenvalues of β_k are denoted by λ_k and μ_k , see §[6.](#page-31-0)

Theorem 9.5. If $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, has an (k, n) heteroclinic tangency with $k < n$ and

$$
\frac{\ln|\lambda_k|}{\ln|\mu_n|} \notin \mathbb{Q}
$$

then

$$
\mathcal{F}^s_k \subset \mathcal{C}^s_n.
$$

10. Morse-Smale components

A map $F : B \to B$ is *Morse-Smale* if the non-wandering set Ω_F consists of finitely many periodic points, all hyperbolic, and the stable and unstable manifolds of the periodic points are all transversal to each other. Recall, the collection $\mathcal{I}_{\Omega}^n(\overline{\epsilon})$ consists of the maps which are exactly n-times renormalizable and has a periodic attractor of period $2ⁿ$. According to Lemma [4.5](#page-20-0) the non-wandering set of each map $F \in$ $\mathcal{I}_{\Omega}^{n}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, consists of finitely many periodic points. In particular, a map $F \in \mathcal{I}_{\Omega}^{n}(\overline{\varepsilon})$ is Morse-Smale if all its periodic points are hyperbolic and if for every $x, y \in \mathcal{P}_F = \Omega_F$ there are only transverse intersections of $W^u(x)$ and $W^s(y)$.

Theorem 10.1. Let $\overline{\epsilon} > 0$ be small enough. The Morse-Smale maps form an open and dense subset of any $\mathcal{I}^n_\Omega(\overline{\epsilon})$.

A Morse-Smale component is a connected component of the set of non-degenerate Morse-Smale maps in $\mathcal{H}_{\Omega}(\overline{\varepsilon})$. Morse-Smale maps are structurally stable, see [\[P\]](#page-66-13).

Proposition 10.2. Let $F, \tilde{F} \in \mathcal{I}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, be in the same Morse-Smale component. Then F and \tilde{F} are conjugate.

Two Morse-Smale components in $\mathcal{I}_{\Omega}^{n}(\overline{\varepsilon})$ are of different type if the maps in the first component are not conjugate to the maps in the other.

Remark 10.1. In this discussion we will only consider non-degenerate Hénon maps. Observe, if $F \in \mathcal{I}_{\Omega}^n(\overline{\varepsilon})$ is a unimodal map, it can be of three different topological types depending the relative position of the attracting fixed point p and the critical point c of the unimodal map which describes the n^{th} -renormalization: $p < c$, $p = c$, and $p > c$ c . The non-degenerate Hénon maps in the Morse-Smale component which contains perturbations of the unimodal maps in $F \in \mathcal{I}_{\Omega}^{n}(\overline{\varepsilon})$ are all conjugated. There is no difference in the topology of the periodic attractor anymore.

Theorem 10.3. Let $\overline{\epsilon} > 0$ be small enough. Then for $n \geq 1$ large enough there are countably many Morse-Smale components of different type in $\mathcal{I}_{\Omega}^{n}(\overline{\varepsilon}).$

There are a non-locally finite collections of bifurcation curves in H´enon-families. Some of these collections are constructed in the proof of Theorem [10.3,](#page-49-1) they are illustrated in Figure [10.1.](#page-49-0)

Figure 10.1. Bifurcation pattern

The actual proofs of these Theorems need some preparation. Recall,

$$
\mathcal{U}\mathcal{K}_{k,n}(\overline{\varepsilon})=\bigcup_{k\leq k'
$$

Lemma 10.4. If $k < n$ and $\overline{\epsilon} > 0$ small enough then

$$
\overline{\mathcal{K}_{k,n}(\overline{\varepsilon})}\subset \mathcal{UK}_{k,n}(\overline{\varepsilon}).
$$

In particular, $\mathcal{UK}_{k,n}(\overline{\epsilon})$ is closed.

Proof. It suffices to prove that for each $k < n$

$$
\overline{\mathcal{K}_{k,n}(\overline{\varepsilon})}\subset\mathcal{UK}_{k,n}(\overline{\varepsilon}).
$$

Let $F_j \in \mathcal{K}_{k,n}(\overline{\varepsilon})$ with $F_j \to F \notin \mathcal{UK}_{k,n}(\overline{\varepsilon})$. Let $K_m^{u/s} \subset W_{\text{loc}}^{u/s}(\beta_m)$ be a fundamental domain for F restricted to $W^{u/s}(\boldsymbol{\beta}_n)$. We may assume that $K_m^u \subset \text{int } U_m$ and $K_m^s \subset \text{int } S_m$. Similarly, let $K_m^{u/s}(j) \subset$

 $W^{u/s}_{\text{loc}}(\beta_m(j))$ be a fundamental domain for F_j restricted to $W^{u/s}(\beta_n(j)).$ Construct these fundamental domains in such a way that

$$
K_m^{u/s}(j) \to K_m^{u/s}.
$$

Apply Lemma [4.8](#page-22-1) and we see that $K_m^u(j) \subset \text{int } U_m(j)$ and $K_m^s(j) \subset$ int $S_m(j)$, for $j \ge 1$ large enough. Finally, choose $x_j \in K_k^u(j)$ such that

 $F^{t_j}(x_j) \in K^s_n(j)$

is a heteroclinic tangency and $x_j \to x \in K_k^u$.

Claim 10.5. $\omega(x) \subset \mathcal{O}_F \cup \bigcup_{m>n} \mathcal{B}_m$

Proof. Suppose by contradiction $\omega(x) = \beta_{m_1}$, say

$$
s_1 = F^{r_1}(x) \in K^s_{m_1},
$$

with $m_1 \leq n$. ¿From $F \notin \mathcal{K}_{k,m_1}(\overline{\epsilon})$ we get that

 $T_{s_1}F^{r_1}(K_k^u) \pitchfork T_{s_1}K_{m_1}^s$.

By definition

(10.1) $T_{x_j} K_k^u(j) \to T_x K_k^u.$

This implies

(10.2)
$$
DF_j^{r_1}(x_j)(T_{x_j}K_k^u(j)) \to T_{s_1}K_{m_1}^s.
$$

Now we will prove

$$
(10.3) \t\t m_1 < n.
$$

To do so, assume that $m_1 = n$. Observe, $F^{r_1}(x_j) \in W^s(\mathcal{B}_n(j))$ and this point is also close to $S_n(j)$ because it is close to S_n . Lemma [4.8](#page-22-1) implies

$$
F_j^{r_1}(x_j) \in K_n^s(j).
$$

Hence, $t_j = r_1$. From [\(10.2\)](#page-50-0) we get that at $F_j^{r_1}$ $j^{r_1}(x_j)$ there is no tangency between $F_i^{r_1}$ $j^{r_1}(K_k^u(j))$ and $K_n^s(j)$. Contradiction. We proved that $m_1 <$ n .

Let $e_j^1 > 0$ be maximal such that when $r_1 \leq i \leq e_j^1$ we have

$$
F_j^i(x_j) \in T_{m_1}(j),
$$

where $T_{m_1}(j)$ is the saddle region of $\beta_{m_1}(j)$ of F_j , see Figure [4.1.](#page-49-0) Say

$$
F_j^{e_j^1}(x_j) \to u_1 \in K_{m_1}^u.
$$

Then

(10.4)
$$
DF_j^{e_j^1}(x_j)(T_{x_j}K_k^u(j)) \to T_{u_1}K_{m_1}^u.
$$

Recall, $x_j \in W^s(\beta_n(j))$. Hence,

$$
\omega(u_1) \subset \bigcup_{m \leq n} \beta_m.
$$

Say,

$$
s_2 = F^{r_2}(u_1) \in K^s_{m_2},
$$

with $m_1 < m_2 \leq n$. Because, $F \notin \mathcal{K}_{m_1,m_2}(\overline{\epsilon})$ we get

$$
T_{s_2}F^{r_2}K_{m_1}^u \pitchfork T_{s_2}K_{m_2}^s.
$$

This implies

(10.5)
$$
DF_j^{r_2+e_j^1}(x_j)(T_{x_j}K_k^u(j)) \nrightarrow T_{s_2}K_{m_2}^s.
$$

As before, we conclude

$$
(10.6) \t\t\t m_1 < m_2 < n.
$$

The statements [\(10.5\)](#page-51-0) and [\(10.4\)](#page-50-1) are similar to the statements [\(10.2\)](#page-50-0) and [\(10.1\)](#page-50-2). We can repeat the construction in a similar manner as was done in the proof of Proposition [4.10.](#page-24-1) Properties [\(10.3\)](#page-50-3) and [\(10.6\)](#page-51-1) show that the construction can always be repeated. This is impossible. \Box

The first consequence of the Claim is that

$$
\mathcal{A}_F^{n+1} \neq \emptyset.
$$
 Choose an open neighborhood $U \supset \mathcal{A}_F^{n+1}$ such that
$$
\overline{F(U)} \subset U
$$

and

 $W^s(\beta_n)$.

(10.7)
$$
\overline{U} \cap K_n^s = \emptyset.
$$

There exists $s_0 > 0$ such that $F^s(x) \in U$, $s \geq s_0$. For $j \geq 1$ large enough

$$
\overline{F_j(U)} \subset U.
$$

Hence, for $j \ge 1$ large enough and $s \ge s_0$

$$
F_j^s(x_j) \in U.
$$

From [\(10.7\)](#page-51-2) we get $t_j \leq s_0$. Say, $t_j = t$. Observe,

$$
F^t(x) \leftarrow F^t_j(x_j) \in K^s_n(j) \to K^s_n.
$$

So, $F^t(x) \in K_n^s$. This contradicts Claim [10.5.](#page-50-4)

Consider the set $A_{k,n} \subset K_n^s$ consisting of tangencies of $W^u(\beta_k)$ and

Proposition 10.6. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\epsilon})$, with $\overline{\epsilon} > 0$ small enough, and $k < n$ be such that F has a (k, n) -heteroclinic tangency,

 $F \in \mathcal{K}_{k,n}(\overline{\varepsilon})$

but

$$
(10.8) \t\t\t F \notin \mathcal{UK}_{k+1,n}(\overline{\varepsilon}).
$$

Then $A_{k,n}$ is a finite set.

Proof. Let

$$
W = \bigcup_{j=k}^{n-1} W^u(\beta_j).
$$

Lemma [4.9](#page-23-1) states that the only points in K_n^s on which $W^u(\beta_k)$ can accumulate are points in the unstable manifolds $W^u(\beta_j)$ with $k < j <$ *n*. Hence, if $x \in \overline{A_{k,n}} \setminus A_{k,n}$ then

$$
x \in W^u(\beta_j) \cap W^s(\beta_n)
$$

for some $j > 0$ with $k < j < n$.

Condition [\(10.8\)](#page-52-0) says that $F \notin \mathcal{K}_{j,n}$. So, the intersection at x between $W^u(\beta_j)$ and $W^s(\beta_n)$ is transverse. The point x is accumulated by heteroclinic tangencies. It is not a laminar point of

$$
\bigcup_{k\leq j\leq n}W^u(\boldsymbol{\beta}_j).
$$

This contradicts Proposition [4.12.](#page-26-0)

Remark 10.2. Observe that the intersection $W \cap K_n^s$, used in the previous proof, is closed. However, it is not finite if $k < n-1$. Compare with Lemma [4.9](#page-23-1) .

Choose $F \in \mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough. Fix the fundamental domain $K_n^s = [p_0^n, p_2^n]^s \subset W_{\text{loc}}^s(\beta_n)$ for F restricted to $W^s(\beta_n)$. The points p_0^n, p_2^n are as defined in section §[4,](#page-15-0) see Figure [4.1.](#page-49-0) Similarly, we choose $K_k^u = [p_{-2}^{k+1}, p_{-1}^{k+1}]^u$ as a fundamental domain in $W^u(\boldsymbol{\beta}_k)$ with $k < n$. Given a sequence $F_j \to F$ we will denoted the fundamental domains of F_j by $K_k^{u/s}$ $\binom{u/s}{k}(j)$. The invariant manifolds $W^{u/s}(\beta_k(F_j))$ of F_j will be denoted by $W_k^{u/s}$ $\binom{u/s}{k}(j)$ and $W^{u/s}(\beta_k(F))$ of F will be denoted by $W_k^{u/s}$ $\frac{u}{k}$.

Lemma 10.7. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, and $k < n$ be such that

$$
F \notin \mathcal{U}\mathcal{K}_{k+1,n}(\overline{\varepsilon}) \cup \mathcal{U}\mathcal{K}_{k,n-1}(\overline{\varepsilon}).
$$

There exists $N \geq 1$ such that the following holds. If $F_j \to F$ and there are points

then

 $t_i \leq N$.

s n

Proof. Fix $k \geq 1$. The proof will be given by induction in $n > k$. The definition of renormalization implies that the Lemma holds when $n = k + 1$. In this case there are only two intersections of $W_k^u(j)$ with $K_n^s(j)$ and these intersections are transversal. There is nothing to prove.

Suppose the Lemma holds for all $k + 1 \leq m < n$. Suppose, $F_j \to F$ and this sequence satisfies the conditions $(10.9), \ldots, (10.12)$ $(10.9), \ldots, (10.12)$ of the Lemma but

 $t_i \rightarrow \infty$.

Claim 10.8. There is $k < m < n$ with $\hat{z} \in W_m^u$.

Proof. Suppose the backward orbit of \hat{z} escapes from $\text{Trap}_k(F)$:

 $F^{-t_0}(\hat{z}) \notin \text{Trap}_k(F),$

for some $t_0 > 0$. Observe, $\text{Trap}_k(F)$ is closed and $\text{Trap}_k(F_j)$ is close to $\text{Trap}_k(F)$ for $j \geq 1$ large enough. So for $j \geq 1$ large enough we have

$$
F_j^{-t_0}(\hat{z}(j)) \notin \operatorname{Trap}_k(F_j).
$$

This contradicts, $\hat{z}(j) \in W_k^u(j)$. We showed that the backward orbit of \hat{z} does not escape: for every $t \geq 0$

$$
F^{-t}(\hat{z}) \in \operatorname{Trap}_k(F).
$$

Hence,

$$
\hat{z} \in \bigcup_{k \le m < n} W_m^u.
$$

Suppose, $\hat{z} \in W_k^u$. Choose a neighborhood $U \supset \mathcal{A}_F^{k+1}$ such that $F(U)$ is strictly contained in U and $U \cap [\beta_k, \hat{z}]^u = \emptyset$. For $j \geq \text{large enough}$

we have that F_j also maps U strictly inside U. In particular, $\mathcal{A}_{F_j^{k+1}}$ is strictly contained in U. Hence, for all $l \geq l_0$

$$
F_j^l(u(j)) \in U
$$

PSfrag replacements contradicts

$$
F_j^{t_j}(u(j)) = z(j) \to \hat{z} \notin U
$$

because $t_j \to \infty$.

Let $\hat{z}(j) \in W_m^u(j) \cap K_n^s(j)$ be the perturbation of $\hat{z} \in W_m^u \cap K_n^s$, see Figure [10.2.](#page-54-0) The intersection at \hat{z} of W_m^u with K_n^s is transversal because $F \notin \mathcal{K}_{m,n}$: the perturbation $\hat{z}(j)$ is well defined.

For each $t \geq 1$ define

$$
\hat{z}_t(j) = F_j^{-t}(\hat{z}(j)),
$$

$$
z_t(j) = F_j^{-t}(z(j)),
$$

and

$$
v_t(j) = DF_j^{-t}(v(j)).
$$

From [\(10.12\)](#page-53-1) we get for a given $t \geq 1$

$$
v_t(j) \to T_{\hat{z}_t(j)} W_n^s,
$$

when $j \to \infty$. Given $t \geq 1$ we can apply the λ -Lemma, see [\[dMP\]](#page-66-9), and choose j_t large enough and $a_t \geq 1$ such that

$$
w_t = z_{t+a_t}(j_t) \to w \in K_m^s,
$$

and

$$
v_{t+a_t}(j_t) \to T_w K_m^s.
$$

The time needed to go from $u(j_s)$ to w_s is

$$
b_t = t_{j_t} - (t + a_t).
$$

The induction hypothesis, that is, the Lemma for $k < m < n$ gives a bound $N \geq 1$ such that

$$
b_t < N
$$

for all $t \geq 1$. This implies that $w \in K_m^s$ is a tangency between W_k^u and W_m^s . This is impossible because

$$
F \notin \mathcal{K}_{k,m} \subset \mathcal{UK}_{k,n-1}.
$$

 \Box

Let $F \in \mathcal{H}_\Omega^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, and $k < n$. For $t \geq 1$ define the curve

$$
C_{k,t} \equiv [\beta_k, F^t(p_0^{k+1})]^u,
$$

the intersection point p_0^{k+1} of $W^u(\beta_k)$ with $W^s(\beta_{k+1})$ is defined in §3. See also Figure [4.1.](#page-49-0) The following Theorem is a reformulation of Lemma [10.7.](#page-52-1)

Theorem 10.9. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, and $k < n$ be such that

$$
F \notin \mathcal{U}\mathcal{K}_{k+1,n}(\overline{\varepsilon}) \cup \mathcal{U}\mathcal{K}_{k,n-1}(\overline{\varepsilon}).
$$

There exists $N \geq 1$ and a neighborhood $\mathcal U$ of $F \in \mathcal H^n_\Omega(\overline{\varepsilon})$ such that the following holds. If $\tilde{F} \in \mathcal{U}$ and

$$
W^u(\beta_k(\tilde{F})) \cap_x W^s(\beta_n(\tilde{F}))
$$

with $x \in K_n^s(\tilde{F})$ then

 $x \in C_{k,N}(\tilde{F}).$

Lemma 10.10. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, and $k < n$, be such that F has a (k, n) -heteroclinic tangency,

 $F \in \mathcal{K}_{k,n}(\overline{\varepsilon})$

but

(10.13)
$$
F \notin \mathcal{UK}_{k+1,n}(\overline{\varepsilon}) \cup \mathcal{UK}_{k,n-1}(\overline{\varepsilon}).
$$

Then for every neighborhood $\mathcal{U} \ni F$ there exists an open set $\mathcal{V} \subset \mathcal{U}$ such that

$$
\mathcal{V}\cap\mathcal{UK}_{k,n}(\overline{\varepsilon})=\emptyset.
$$

Proof. The collections $\mathcal{UK}_{k+1,n}$ and $\mathcal{UK}_{k,n-1}$ are closed, see Lemma [10.4.](#page-49-2) Let $U \supset V_0 \ni F$ be a neighborhood with

$$
\mathcal{V}_0\cap(\mathcal{UK}_{k+1,n}\cup\mathcal{UK}_{k,n-1})=\emptyset.
$$

According to Theorem [10.9](#page-55-0) there is $N \geq 1$ and a neighborhood $\mathcal{V}_1 \subset \mathcal{V}_0$ such that for all $F \in \mathcal{V}_1$ all the tangencies between $W^u(\beta_k(\tilde{F}))$ and $W^{s}(\beta_n(\tilde{F}))$ in $K_n^{s}(\tilde{F})$ are in a bounded curve $C_{k,N}(\tilde{F})$. The maps in $\mathcal{H}_{\Omega}^{n}(\overline{\varepsilon})$ are analytic. This allows us to remove all finitely many tangencies and get an open set $V \subset V_1$ such that $V \cap \mathcal{U} \mathcal{K}_{k,n} = \emptyset$.

For $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$ define

$$
\Delta_F^n = \min\{n' - k'| F \in \mathcal{K}_{k',n'}(\overline{\varepsilon}), \ k' < n' \le n\}.
$$

Corollary 10.11. Let $F \in \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough, and $\Delta_F^n < \infty$. Then for every neighborhood $\mathcal{U} \ni F$ there exists an open set $V \subset U$ such that

$$
\Delta_{\tilde{F}}^n > \Delta_F^n
$$

for all $\tilde{F} \in \mathcal{V}$.

Proof. Let

$$
X = \{(k', n') | k' < n' \le n \text{ and } n' - k' < \Delta_F\}
$$

and

$$
Y = \{(k', n') | k' < n' \le n, \ n' - k' = \Delta_F^n, \ F \in \mathcal{K}_{k', n'}(\overline{\varepsilon})\}.
$$

Observe,

$$
F \notin \bigcup_{(k',n') \in X} \mathcal{K}_{k',n'}(\overline{\varepsilon}) = \bigcup_{n'-k' = \Delta_F^n - 1} \mathcal{U} \mathcal{K}_{k',n'}(\overline{\varepsilon})
$$

which is a finite union of closed set, see Lemma [10.4.](#page-49-2) Choose, $F \in$ $U_0 \subset U$ such that

$$
\mathcal{U}_0 \cap \bigcup_{(k',n') \in X} \mathcal{K}_{k',n'}(\overline{\varepsilon}) = \emptyset.
$$

Now apply repeatly Lemma [10.10](#page-55-1) to erase the points $(k', n') \in Y$. We constructed $V \subset \mathcal{U}_0$ such that for $F \in \mathcal{V}$

$$
\Delta_{\tilde{F}} > \Delta_F.
$$

 \Box

Proof of Theorem [10.1.](#page-48-1) Lemma [10.4](#page-49-2) gives $\mathcal{UK}_{0,n}(\overline{\varepsilon})$ is closed. In particular, the maps without heteroclinic tangencies form an open set in $\mathcal{I}_{\Omega}^n(\overline{\varepsilon})$. Let $\mathcal{U} \subset \mathcal{I}_{\Omega}^n(\overline{\varepsilon})$ and assume that every map in \mathcal{U} has a tangency. We have

 $\Delta_F^n \leq n,$

for $F \in \mathcal{U}$. There is an $F_0 \in \mathcal{U}$ which has a tangency and where $\Delta_{F_0}^n$ is maximal. This contradicts Corollary [10.11.](#page-56-0)

The following Lemmas are a preparation for the proof of Theorem [10.3.](#page-49-1)

Lemma 10.12. For $\overline{\epsilon} > 0$ small enough, there exist $n > k \geq 1$ such that for $s \geq 1$ large enough

$$
\mathcal{I}_{\Omega}^{n+s}(\overline{\varepsilon}) \cap \mathcal{K}_{k,n}(\overline{\varepsilon}) \neq \emptyset.
$$

More precisely, there exists an $F \in \mathcal{I}_{\Omega}^{n+s}(\overline{\varepsilon}) \cap \mathcal{K}_{k,n}(\overline{\varepsilon})$ such that $\Gamma_{\infty}(F_{k-1})$ is tangent to $M_1^{n-k+1}(F_{k-1})$ $M_1^{n-k+1}(F_{k-1})$ $M_1^{n-k+1}(F_{k-1})$.¹

Proof. Let $\Omega = \Omega^h \times \Omega^v$ and $\mathcal{W}_{\Omega}^n(\overline{\varepsilon}) \subset \mathcal{H}_{\Omega}^n(\overline{\varepsilon})$ consists of the maps that have a periodic point of period 2^n with multiplier $-1, n \geq 1$. Choose a unimodal family $a \mapsto f_a \in \mathcal{U}_{\Omega^h}$, $a \in (-a_0, a_0)$, which intersects transversally $W^s(f_*)$ at $a=0$. For $a_0>0$ small enough we can consider the family

$$
F_{a,t}(x,y) = (f_a(x) - t \cdot \epsilon(x,y), x) \in \mathcal{H}_{\Omega}(\overline{\epsilon}),
$$

with $a \in (-a_0, a_0)$ and $t \in [0, 1]$. Let

$$
W^n=\{(a,t)|F_{a,t}\in\mathcal{W}^n_\Omega(\overline{\varepsilon})\}
$$

and

$$
W = \{(a, t) | F_{a,t} \in \mathcal{I}_{\Omega}(\overline{\varepsilon})\}.
$$

For $n \geq 1$ large enough and $\overline{\varepsilon} > 0$ small enough W and W^n are graphs of analytic functions $t \mapsto a(t)$ and $t \mapsto a_n(t)$. Moreover, $a_n \to a$ (exponentially fast). Finally, let

(10.14)
$$
I^{n} = \{(a, t) | F_{a,t} \in \mathcal{I}_{\Omega}^{n}(\overline{\varepsilon})\}
$$

$$
= \{(a, t) | a_{n-1}(t) < a < a_{n}(t)\}.
$$

These statements follows from the fact that the family $a \mapsto f_a$ intersects $W^s(f_*)$ transversally and the hyperbolicity of the Hénon-renormalization operator.

Choose $t, \tilde{t} \in [0, 1]$. Consider the maps $F = F_{a(t), t} \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ with average Jacobian $b > 0$ and $\tilde{F} = F_{a(\tilde{t}), \tilde{t}} \in \mathcal{I}_{\Omega}(\overline{\epsilon})$ with average Jacobian

 $\tilde{b} > b$. We will use a short hand notation for the invariants of §[8:](#page-39-0) let $\kappa_n = \kappa_{R^n F}$ and $\tilde{\kappa}_n = \kappa_{R^n \tilde{F}}$. For $n \geq 1$ large enough we have, as a consequence of Theorem [8.3,](#page-42-4)

$$
\kappa_n > 2^n \cdot \left\{ \frac{|\ln b|}{|\ln \sigma^2|} - 1 \right\} > 2^n \cdot \left\{ \frac{|\ln \tilde{b}|}{|\ln \sigma^2|} + 1 \right\} > \tilde{\kappa}_n.
$$

Hence, for $n \geq 1$ large enough we can find $k \geq 1$ such that

 $\kappa_{n+1} > k-1 > \tilde{\kappa}_{n+1}.$

The map F has the property that

$$
M_1^{k-1}(R^{n+1}F) \cap D^{\tau}(R^{n+1}F) = \emptyset.
$$

In other words, see Figure [3.1,](#page-49-0) that

(10.15)
$$
M_1^{n+1+k-1}(F) \cap [p_0^{n+1}, p_1^{n+1}]^u = \emptyset.
$$

The map \tilde{F} has the property that $M_1^{k-1}(R^{n+1}\tilde{F})$ has a nonempty transversal intersection with the boundary of $D^{\tau}(R^{n+1}\tilde{F})$. In particular,

(10.16)
$$
M_1^{n+1+k-1}(\tilde{F}) \cap [\tilde{p}_0^{n+1}, \tilde{p}_1^{n+1}]^u \neq \emptyset,
$$

and consists of transversal intersections. The transversal intersections given in [\(10.15\)](#page-58-0) and [\(10.16\)](#page-58-1) persist locally. Hence, for $s \geq 1$ large enough the set I^{n+k+s} will contain maps with a transverse intersection of type

$$
M_1^{n+1+k-1} \cap [p_0^{n+1},p_1^{n+1}]^u \neq \emptyset,
$$

and also maps without any intersection between $M_1^{n+1+k-1}$ and $[p_0^{n+1}, p_1^{n+1}]^u$. The connectivity of I^{n+k+s} , see [\(10.14\)](#page-57-1), implies that there are maps in I^{n+k+s} for which there is a tangency between $[p_0^{n+1}, p_1^{n+1}]^u$ and M_1^{n+k} . Recall,

$$
[p_0^{n+1}, p_1^{n+1}]^u \subset W^u(\beta_n),
$$

and

$$
M_1^{n+k} \subset W^s(\beta_{n+k}).
$$

Hence,

$$
\Gamma_{\infty}(F_{n-1}) \sqsupset \Gamma M_1^{k+1}(F_{n-1}).
$$

Moreover, for $s \geq 1$ large enough, $\mathcal{I}_{\Omega}^{n+k+s}$ $\mathcal{L}_{\Omega}^{n+k+s}(\overline{\varepsilon}) \cap \mathcal{K}_{n,n+k}(\overline{\varepsilon}) \neq \emptyset.$

The following definition is illustrated by Figure [10.3.](#page-59-0)

Definition 10.1. Given a map $F \in \mathcal{H}^k_{\Omega}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough and $k \geq 1$. If $\Gamma_{\infty}(F) \cap M_1^k(F) = \emptyset$ then define

$$
j_k = j_k(F) = \max\{j \ge 2|\Gamma_j \cap M_1^k \ne \emptyset\}.
$$

 $\overline{\mathrm{PSfrag}}$ replacements 60

Otherwise, if $\Gamma_{\infty} \cap M_1^k \neq \emptyset$ let

 $j_k = j_k(F) = \max\{j \geq 2 | \Gamma_j \cap M_1^k = \emptyset\}.$

FIGURE 10.3.

Lemma 10.13. $j_k(F)$ is a topological invariant.

Proof. Let $x_0 \in W^u(\beta_0)$ be the first intersection, coming from β_0 going along $W^u(\beta_0)$, with $W^s_{\text{loc}}(\beta_2)$, see Figure [10.3.](#page-59-0) Proposition [5.3](#page-29-0) implies that this point is topologically defined. Notice, that

$$
\Gamma_2 = [x_0, F(x_0)]^u \subset W^u(\beta_0).
$$

Thus Γ_2 is topologically defined. Now, assume that

$$
\Gamma_j = [z, x]^u \subset W^u(\beta_0),
$$

is topologically defined, with $z \in W_{\text{loc}}^s(\beta_2')$ and $x \in W_{\text{loc}}^s(\beta_2)$. Then, when $\bar{\varepsilon} > 0$ is small enough, there is a unique intersection point

$$
y \in (z, x)^u \cap W^s_{\text{loc}}(\beta_2).
$$

This point is topologically defined. Now observe that

$$
\Gamma_{j+1} = F([z, y]^u).
$$

We proved that all Γ_j , $j \geq 2$, are topologically defined.

Recall from §[8](#page-39-0) that $D^{\tau} \subset D_1$ is the connected component of $D_1 \setminus$ $W_{\text{loc}}^{s}(\tau)$ which does not contain β_1 , see Figure [8.1](#page-49-0) and that M_1^k is on the right of $W^s_{\text{loc}}(\tau)$. Observe,

$$
M_1^k \cap D_1 = M_1^k \cap D^{\tau}.
$$

According to Lemma [8.1,](#page-40-1) this intersection is a topologically defined set. Furthermore, notice that

$$
\Gamma_j \cap M_1^k \subset D_1.
$$

Hence, the intersections

$$
\Gamma_j\cap M_1^k
$$

are topologically defined. We proved that $j_{k,n}$ is a topological invariant. \Box

Fix a map $F \in \mathcal{I}_{\Omega}^{n+s}(\overline{\varepsilon})$, with $\overline{\varepsilon} > 0$ small enough and $s \geq 1$. We will need the objects defined in §[7.](#page-32-0) In that section we used the graphs $\Gamma_j = \Gamma_j(F_n), j = 2, 3, \ldots$, and $\Gamma_\infty = \Gamma_\infty(F_n)$. Apply Corollary [7.2](#page-35-0) to obtain a $\rho = \rho(F, n) < 1$ such that for $j \geq 2$

(10.17)
$$
|\Gamma_j(y) - \Gamma_\infty(y)| \ge \rho^j,
$$

holds on a neighborhood of F.

Proof of Theorem [10.3](#page-49-1) Apply Lemma [10.12:](#page-57-2) for every $\bar{\varepsilon} > 0$ small enough, there exist $k, n > 0$ such that for every $s \geq 1$ large enough there is a map $F \in \mathcal{I}_{\Omega}^{n+k+s}(\overline{\varepsilon}) \cap \mathcal{K}_{n,n+k}(\overline{\varepsilon})$ such that $\Gamma_{\infty}(F_{n-1})$ is tangent to $M_1^k(F_{n-1})$. Use Theorem [10.1](#page-48-1) to choose a sequence $G_m \in \mathcal{I}_{\Omega}^{n+k+s}(\overline{\varepsilon})$ of Morse-Smale maps converging to F. Now

$$
j_k(R^{n-1}G_m) \to \infty,
$$

for $m \to \infty$. Otherwise, suppose that for a subsequence $j_k(R^{n-1}G_m) \leq$ j stays bounded. Let Γ_j^m and Γ_∞^m be the corresponding graphs of the maps $R^{n-1}G_m$. Then

$$
\min_y |\Gamma^m_{j+1}(y) - \Gamma^m_\infty(y)| \to 0,
$$

for $m \to \infty$. This contradicts inequality [\(10.17\)](#page-60-0). We found countable many Morse-Smale maps of different type accumulating at F . \Box

Remark 10.3. Notice that a map $F \in \mathcal{I}_{\Omega}^n(\overline{\varepsilon})$ might have heteroclinic tangencies in places other then the ones discussed in the proof of Theorem [10.3.](#page-49-1) The proof only describes some particular collection of boundary curves of Morse-Smale components but there might be many more components of other types.

Remark 10.4. Observe that the results of this section also hold when we consider two dimensional analytic families in $\mathcal{H}_{\Omega}(\overline{\varepsilon})$ transverse to $\mathcal{I}_{\Omega}(\overline{\varepsilon}).$

APPENDIX: VARIATION OF THE β_0 -UNSTABLE MANIFOLD

Let us consider a one-parameter real analytic family of Hénon-like maps

(10.18)
$$
F_t(x, y) = (f(x) - t\gamma(x, y) + O(t^2), x)
$$
, where $\gamma \equiv \frac{dF_t}{dt}\Big|_{t=0}$

is the parameter velocity of this family at f .

Let $\beta_t = \beta_0(t)$ be the saddle fixed point of F_t with positive eigenvalues, and let $\lambda_t > 1$ be its repelling eigenvalue. Below we will calculate the first variation of the unstable manifold $W^u(\beta_t)$ at $t=0$. To this end let us linearize $F_t|W^u(\beta_t)$:

$$
\Phi_t : \mathbb{R} \to W^u(\beta_t), \quad \Phi_t(\lambda_t s) = F_t(\Phi_t(s)).
$$

Note that for $t = 0$, $\Phi_0(s) = (\phi_0(s), \phi_0(s/\lambda_0))$, where $\phi_0 : \mathbb{R} \to \mathbb{R}$ is the linearizing map of f at the fixed point β_0 .

Let ϕ_t be the first coordinate of Φ_t . Then

(10.19)
$$
\phi_t(\lambda_t s) = f(\phi_t(s)) - t \gamma(\phi_t(s), \phi_t(s/\lambda_t)) + O(t^2).
$$

Let

(10.20)
$$
\lambda_t = \lambda_0 + \mu t + O(t^2), \quad \phi_t(s) = \phi_0(s) + \psi(s) t + O(t^2).
$$

Plugging it into (10.19) and keeping only linear terms in t, we obtain the following equation:

$$
\phi'_0(\lambda_0 s)\mu s + \psi(\lambda_0 s) = f'(\phi_0(s))\psi(s) - \gamma(\phi_0(s), \phi_0(s/\lambda_0)).
$$

Let us now look what happens when $\phi_0(s_c) = c^2$ $\phi_0(s_c) = c^2$. Letting $s_v = \lambda_0 s_c$, we have $\phi_0(s_v) = v$. Since v is the maximum of ϕ_0 , the first terms in the both sides of the above equation vanish, and we obtain:

(10.21)
$$
\psi(s_v) = -\gamma(c, c_{-1}),
$$

where $c_{-1} = \phi_0(\tau_c/\lambda_0) \in f^{-1}(c)$ is a precritical point (there are infinitely many values of s_c ; they split into two classes corresponding to the upper and lower critical point on the parabola, which correspond to the two precritical points c_{-1}). It allows us to estimate the distance from the turning points of the unstable manifold to the critical value. A turning point of the curve $W^u(\beta_t)$ is a point with vertical tangency.

² recall that c is the critical point and v is the critical value of f.

Lemma 10.14. In the above one-parameter family F_t of Hénon-like maps, the horizontal distance from the first and the third turns of the unstable manifold $W^u(\beta_t)$ to the turning point (v, c) of the parabola $x =$ $f(y)$ is $-\gamma(c, c_{-1})t + O(t^2)$, where we should take the lower precritical point c_{−1} for the first turning point, and the upper precritical point for the second one.

Proof. According to [\(10.21\)](#page-61-3), the horizontal distance from $\phi_t(s_v)$ to $v =$ $\phi_0(s_v)$ is $-\gamma(c, c_{-1})t + O(t^2)$. However, $\Phi_t(s_v)$ is not the turning point (x_t, y_t) of the unstable manifold $W^u(\beta_t)$, so we need to show that $|x_t |\phi_t(s_v)| = O(t^2).$

Let $x_t = \phi_t(s_t)$. Let us estimate $|s_t - s_v|$. Since $\phi'_t(s_t) = 0$, the second equation of [\(10.20\)](#page-61-4) yield:

$$
0 = \phi'_0(s_t) + \psi'(s_t)t + \dots
$$

Linearizing this equation in s near s_v , using that $\phi'_0(s_v) = 0$, we obtain:

$$
\phi_0''(s_v)(s_t - s_v) + (\psi'(s_v) + \psi''(s_v)(s_t - s_v))t + O(t^2) = 0.
$$

Hence,

$$
s_t - s_v = \frac{\psi'(s_v)}{\phi''(s_v)} \cdot t + O(t^2),
$$

provided $\phi''_0(s_v) \neq 0$. But the latter is actually true, which is easily checked by differentiating twice at s_c the linearization equation $\phi_0(\lambda_0 s) = f_0(\phi_0(s))$ (using that the critical point c of f_0 is non-degenerate).

Finally, we conclude:

$$
x_t = \phi_t(s_t)
$$

= $\phi_0(s_t) + \psi(s_t)t + O(t^2)$
= $\phi_0(s_v) + \phi'_0(s_v) \cdot at + \psi(s_v)t + O(t^2)$
= $v + \psi(s_v)t + O(t^2) = \phi_t(s_v) + O(t^2)$.

Note that it is reasonable to assume that $\gamma(c, c_{-1})$ is positive at the upper critical point and negative at the lower one, and has the absolute value of order 1. Then the first turning point of $W^u(\beta_t)$ is on the right from (v, c) (for $t > 0$), while the third one is on the left (as we always draw), and as $t \to 0$, they move toward (v, c) with a speed of order 1.

Let $w(F)$ be the horizontal distance between the first and the third turning points of the unstable manifold $W^u(\beta)$ (which measures the width of the horseshoe near the tip). Let c^+ and c^- denote the upper and the lower precritical points of f respectively.

 \Box

Lemma 10.15. For the family (10.18) ,

$$
\left. \frac{dw(F_t)}{dt} \right|_{t=0} = \int_{c^-}^{c^+} \left. \frac{d \operatorname{Jac} F_t(c, y)}{dt} \right|_{t=0} dy
$$

Proof. According to Lemma [10.14,](#page-62-0)

$$
\frac{dw(F_t)}{dt}\bigg|_{t=0} = \gamma(c, c^+) - \gamma(c, c^-) = \int_{c^-}^{c^+} \frac{\partial \gamma(c, y)}{\partial y} dy
$$

$$
= \int_{c^-}^{c^+} \frac{d \operatorname{Jac} F_t(c, y)}{dt} \bigg|_{t=0} dy.
$$

 \Box

The last formula can also be written in the following form: For a Hénon-like map $F = (f - \varepsilon, x) \in \mathcal{H}_{\Omega}(\bar{\varepsilon}),$

(10.22)
$$
\delta w(f) = \int_{c^-}^{c^+} \delta \operatorname{Jac} F(c, y) dy
$$

Lemma 10.16. For $F(x, y) = (f(x) - ba(x, y), x) \in \mathcal{H}_{\Omega}(\bar{\varepsilon})$, assume $C^{-1} \leq |\partial a/\partial y| \leq C.$

Then $w(F) \approx b$ for $b \leq b_0$, with the constants depending only on Ω , $\overline{\varepsilon}$ and C.

Proof. Consider $b \in [0, b_0]$ as a small parameter. Then by the variational formula [\(10.22\)](#page-63-0)

$$
\left. \frac{dw(F_b)}{db} \right|_{b=0} = \int_{c^-}^{c^+} \frac{\partial a}{\partial y}(c, y) dy \asymp 1.
$$

Moreover, the second derivative $d2w(F_b)/db2$ is bounded on the interval [0, b_0], uniformly over $F \in \mathcal{H}_{\Omega}(\bar{\varepsilon})$ (since $w(F)$ is a C2-smooth, in fact analytic, functional on this space), and the conclusion follows by elementary calculus.

The asymptotic expression for R^nF as given in [\(2.3\)](#page-6-0) implies:

Proposition 10.17. For $F_b \in \mathcal{I}_{\Omega}(\bar{\varepsilon})$, be a family of infinitely renormalizable maps parametrized by the average Jacobian $b = b_{F_b}$. Then

$$
\lim_{b \to 0} \frac{w(R^n F_b)}{b^{2^n}} = a(c) \cdot (c^+ - c^-)
$$

where b is the average Jacobian of F and c^{\pm} are the preimages of the critical point c of f_* . And $x \mapsto a(x)$ the universal function given in [\(2.3\)](#page-6-0).

Appendix: Open Problems

Let us finish with some questions related to the previous discussion.

Problem I:

The following questions are inspired by the results of §9 on stable laminations.

- (1) A wandering domain is an open set in the basin of attraction of \mathcal{O}_F . Do wandering domains exist?
- (2) If a map $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ does not have wandering domains then the union \mathcal{F}^s of all stable manifolds of periodic points are dense in the domain of F. Does there exist $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ such that \mathcal{F}^s is not laminar even if there are no heteroclinic tangencies?
- (3) For $F \in \mathcal{I}_{\Omega}(\overline{\varepsilon})$ let \mathcal{F}_{τ}^s be the union of stable manifolds of the points in the orbit of the tip. Is \mathcal{F}_{τ}^s dense in $Dom(F)$?

Problem II:

It is shown in [\[CLM\]](#page-66-3) that the unique invariant measure on the Cantor attractor \mathcal{O}_F has characteristic exponents 0 and $\ln b_F < 0$. Can the stable characteristic exponent of the tip τ_F differ from $\ln b_F$ (compare Proposition [3.8\)](#page-14-0)?

Problem III:

Can we still speak of rigidity of the Cantor attractor \mathcal{O}_F ?

- (1) Are the Cantor attractors rigid within the topological conjugacy classes?
- (2) Prove or disprove that two Cantor attractors \mathcal{O}_F and $\mathcal{O}_{\tilde{F}}$ are smoothly equivalent if and only if they have the same average Jacobian.

Problem IV:

(1) Can different Morse-Smale components

$$
MS_1, MS_2 \subset \bigcup_{n \geq 0} \mathcal{I}^n_\Omega(\overline{\varepsilon})
$$

have the same type, that is the maps in MS_1 are conjugate to the maps in MS_2 ?

 (2) As we have shown, the Morse-Smale Hénon maps are dense in the zero entropy region with small Jacobian. Are they dense in the full zero entropy region of dissipative Hénon maps? How about other real analytic families of dissipative two dimensional maps?

- (3) The discussion that led to Theorem [10.3](#page-49-1) was based on the renormalization structure. However, the non-locally finiteness of the collection of Morse-Smale components might be a more general phenomenon. Study the combinatorics of Morse-Smale components in other real analytic families of dissipative two dimensional maps.
- (4) Are the real Morse-Smale Hénon maps from Theorem [10.3](#page-49-1) hyperbolic on C 2 ? To what extent determines the topology of the real heteroclinic web the topology of the corresponding Hénon map on \mathbb{C}^2 ?
