# Notes on Algebra and Geometry of Polynomial Representations

#### Abstract

Consider a semi-algebraic set A in  $\mathbb{R}^d$  constructed from the sets which are determined by inequalities  $p_i(x) > 0$ ,  $p_i(x) \ge 0$ , or  $p_i(x) = 0$  for a given list of polynomials  $p_1, \ldots, p_m$ . We prove several statements that fit into the following template. Assume that in a neighborhood of a boundary point the semi-algebraic set  $A$  can be described by an irreducible polynomial f. Then f is a factor of a certain multiplicity of some of the polynomials  $p_1, \ldots, p_m$ . Special cases when A is elementary closed, elementary open, a polygon, or a polytope are considered separately.

# 1 Introduction

In what follows  $x := (x_1, \ldots, x_d)$  is a variable vector in  $\mathbb{R}^d$   $(d \in \mathbb{N})$ . The origin in  $\mathbb{R}^d$  is denoted by *o*. Given  $c \in \mathbb{R}^d$  and  $\rho > 0$  by  $B^d(c, \rho)$  we denote the open Euclidean ball with center *c* and radius  $\rho$ . The abbreviations int and bd stands for the interior and boundary, respectively. By dim we denote the dimension. As usual,  $\mathbb{R}[x] := \mathbb{R}[x_1, \ldots, x_d]$  denotes the ring of polynomials in variables  $x_1, \ldots, x_d$  and coefficients in R. A set  $A \subseteq \mathbb{R}^d$  which can be represented by

$$
A = \bigcup_{i=1}^{k} \left\{ x \in \mathbb{R}^{d} : f_{i,1}(x) > 0, \ldots, f_{i,s_i}(x) > 0, \ g_i(x) = 0 \right\},\,
$$

where  $i \in \{1, \ldots, k\}$ ,  $j \in \{1, \ldots, s_i\}$  and  $f_{i,j}$ ,  $g_i \in \mathbb{R}[x]$ , is called *semi-algebraic*. Information on semi-algebraic sets can be found in  $[1]$ ,  $[7]$ , and  $[5]$ . Obviously, every semi-algebraic set A can be expressed by

A = \left\{ x \in \mathbb{R}^d : \Phi\big((\text{sign } p_1(x) \in E_1), \dots, (\text{sign } p_m(x) \in E_m)\big) \right\},\tag{1.1}
$$

where  $\Phi$  is a boolean formula,  $p_1, \ldots, p_m \in \mathbb{R}[x]$ , and  $E_1, \ldots, E_m$  are non-empty subsets of  $\{0, 1\}$ . Vice versa, every set A given by  $(1.1)$  is semi-algebraic; see [\[7,](#page-10-1) Proposition 2.2.4] and [\[5,](#page-10-2)

Corollary 2.75. We call  $(1.1)$  a *representation* of A by polynomials  $p_1, \ldots, p_m$ . We distinguish several particular types of semi-algebraic sets. Let us introduce the following notations:

$$
(p_1, \ldots, p_m)_{\geq 0} := \left\{ x \in \mathbb{R}^d : p_1(x) \geq 0, \ldots, p_m(x) \geq 0 \right\},\tag{1.2}
$$

$$
(p_1, \ldots, p_s)_{>0} := \left\{ x \in \mathbb{R}^d : p_1(x) > 0, \ldots, p_m(x) > 0 \right\},\tag{1.3}
$$

$$
Z(p_1,\ldots,p_m) := \left\{ x \in \mathbb{R}^d : p_1(x) = 0,\ldots,p_m(x) = 0 \right\}.
$$
 (1.4)

Sets representable by [\(1.2\)](#page-1-0), [\(1.3\)](#page-1-0), and [\(1.4\)](#page-1-0), respectively, are called *elementary closed semialgebraic*, *elementary open semi-algebraic*, and *algebraic*, respectively.

Now we are ready to formulate our main results. First we give an informal interpretation of Theorem [1.1.](#page-1-1) Let f be an irreducible polynomial such that  $Z(f)$  is a  $(d-1)$ -dimensional algebraic surface. Consider a semi-algebraic set  $A$  given by  $(1.1)$ . If the boundary of  $A$  coincides locally with a part of  $Z(f)$ , then f is a factor of some  $p_i$ . If A coincides locally with a part of  $(f)_{\geq 0}$ , then f is an odd-multiplicity factor of some  $p_i$ . Furthermore, if in a neighborhood of a boundary point the set A coincides locally with a part of  $Z(f)$ , then f is a factor of at least two different polynomials  $p_i$  or an even-multiplicity factor of at least one polynomial  $p_i$ .

<span id="page-1-1"></span>Theorem 1.1. *Let* A *be a semi-algebraic set in* R d *given by* [\(1.1\)](#page-0-0) *and let* f *be a polynomial irreducible over* R[x]*. Then the following statements hold true.*

- <span id="page-1-7"></span><span id="page-1-6"></span>*I.* One has bd  $A \subseteq \bigcup_{i=1}^{m} Z(p_i)$ *.*
- *II. If*

$$
\dim(\text{bd } A \cap Z(f)) = d - 1,\tag{1.5}
$$

*then f is a factor of*  $p_i$  *for some*  $i \in \{1, \ldots, m\}$ *.* 

<span id="page-1-4"></span>*III. If there exist*  $a \in Z(f)$  *and*  $\varepsilon > 0$  *such that* 

<span id="page-1-3"></span>
$$
\dim(Z(f) \cap B^d(a,\varepsilon)) = d-1,\tag{1.6}
$$

$$
(f)_{\geq 0} \cap B^d(a,\varepsilon) = A \cap B^d(a,\varepsilon), \tag{1.7}
$$

*then* [\(1.5\)](#page-1-2) *is fulfilled and, moreover,* f *is an odd-multiplicity factor of*  $p_i$  for some  $i \in$  $\{1, \ldots, m\}.$ 

<span id="page-1-5"></span>*IV. If there exist*  $a \in Z(f)$  *and*  $\varepsilon > 0$  *such that* 

$$
\dim(Z(f) \cap B^d(a, \varepsilon)) = d - 1,
$$
  

$$
(f)_{>0} \cap B^d(a, \varepsilon) = A \cap B^d(a, \varepsilon),
$$

*then* [\(1.5\)](#page-1-2) *is fulfilled and, moreover,* f *is an odd-multiplicity factor of*  $p_i$  for some  $i \in$  $\{1, \ldots, m\}.$ 

We remark that [\(1.6\)](#page-1-3) cannot be replaced by the weaker condition dim  $Z(f) = d - 1$  and  $Z(f) \cap B^d(a, \varepsilon) \neq \emptyset$ , since the algebraic set  $Z(f)$  corresponding to an irreducible polynomial f can have "parts" of dimensions strictly smaller than dim  $Z(f)$ . In fact, for  $d = 2$  the irreducible polynomial  $f(x) := x_1^2 + x_2^2 - x_1^3$  generates the cubic curve  $Z(f)$  with isolated point at the origin. For  $d = 3$ , for the irreducible polynomial  $f(x) = x_3^2 x_1 - x_2^2$  the set  $Z(f)$  is the wellknown *Whitney umbrella*, which is a two-dimensional algebraic surface with the one-dimensional "handle"  $Z(x_2, x_3)$ .

The rest of the introduction is devoted to statements for some special semi-algebraic sets (and special representations of semi-algebraic sets).

<span id="page-2-2"></span>Corollary 1.2. *Let* A *be a semi-algebraic set given by*

$$
A = \left\{ x \in \mathbb{R}^d : \Phi((p_1(x) \ge 0), \ldots, (p_m(x) \ge 0)) \right\},\,
$$

<span id="page-2-3"></span>*where*  $\Phi$  *is a boolean formula and*  $p_1, \ldots, p_m \in \mathbb{R}[x] \setminus \{0\}$ *, and let* f *be a polynomial irreducible over*  $\mathbb{R}[x]$ *. Then the following statements hold true.* 

*I. If there exist*  $b \in Z(f)$  *and*  $\varepsilon > 0$  *such that*

$$
\dim(Z(f) \cap B^d(b, \varepsilon)) = d - 1,\tag{1.8}
$$

$$
Z(f) \cap B^d(b, \varepsilon) = A \cap B^d(b, \varepsilon), \tag{1.9}
$$

*then* [\(1.5\)](#page-1-2) *is fulfilled, and furthermore* f *is a factor of*  $p_i$  *and*  $p_j$  for some  $i, j \in \{1, ..., m\}$ *with*  $i \neq j$  *or*  $f$  *is an even-multiplicity factor of*  $p_i$  *for some*  $i \in \{1, ..., m\}$ .

<span id="page-2-4"></span>*II.* If there exist  $a, b \in \mathbb{R}^d$  and  $\varepsilon > 0$  such that equalities [\(1.6\)](#page-1-3), [\(1.7\)](#page-1-3), [\(1.8\)](#page-2-0), and [\(1.9\)](#page-2-0) are *fulfilled, then f is a factor of*  $p_i$  *and an odd-multiplicity factor of*  $p_j$  *for some i, j* ∈  $\{1, \ldots, m\}$  *with*  $i \neq j$ .

 $\Box$ 

<span id="page-2-5"></span>Corollary 1.3. Let  $p_1, \ldots, p_m \in \mathbb{R}[x] \setminus \{0\}$  and  $A := (p_1, \ldots, p_m)_{\geq 0}$ . Let f be a polynomial *irreducible over*  $\mathbb{R}[x]$ . *Assume that there exist*  $b \in Z(f)$  *and*  $\varepsilon > 0$  *such that equalities* [\(1.8\)](#page-2-0) *and* [\(1.9\)](#page-2-0) *are fulfilled and additionally*

<span id="page-2-7"></span>
$$
\dim(\operatorname{int} A \cap Z(f)) = d - 1. \tag{1.10}
$$

*Then f is* a factor of  $p_i$  for some  $i \in \{1, ..., m\}$  and, for every  $i \in \{1, ..., m\}$  such that  $p_i$  is *divisible by* f*, the factor* f *of* p<sup>i</sup> *has even multiplicity.*

<span id="page-2-6"></span>Corollary 1.4. Let  $p_1, \ldots, p_m \in \mathbb{R}[x] \setminus \{0\}$  and  $A := (p_1, \ldots, p_m)_{>0}$ . Let f be a polynomial *irreducible over*  $\mathbb{R}[x]$ . *Assume that there exist*  $b \in Z(f)$  *and*  $\varepsilon > 0$  *such that*

$$
\dim(\text{bd } A \cap Z(f) \cap B^d(b, \varepsilon)) = d - 1,\tag{1.11}
$$

$$
B^{d}(b,\varepsilon) \setminus Z(f) = A \cap B^{d}(b,\varepsilon). \tag{1.12}
$$

*Then f is* a factor of  $p_i$  for some  $i \in \{1, ..., m\}$  and, for every  $i \in \{1, ..., m\}$  such that  $p_i$  is *divisible by* f*, the factor* f *of*  $p_i$  *has even multiplicity.* 

A subset P of  $\mathbb{R}^d$  is said to be a *polytope* if P is the convex hull of a non-empty and finite set of points; see [\[12\]](#page-10-3). It is known that a set P in  $\mathbb{R}^d$  is a polytope if and only if P is non-empty, bounded, and can be represented by  $P = (p_1, \ldots, p_m)_{\geq 0}$ , where  $p_1, \ldots, p_m \in \mathbb{R}[x]$   $(m \in \mathbb{N})$  are of degree one (the so-called *H-representation*). Thus, polytopes are just special elementary closed semi-algebraic sets. The study of polynomial representations of polygons and polytopes was initiated in  $[6]$  and  $[10]$ ; see also the survey  $[11]$ . In  $[10]$  it was noticed that, if a d-dimensional polytope  $P$  is represented by

$$
P = (q_1, \dots, q_m)_{\geq 0} \tag{1.13}
$$

with  $q_1, \ldots, q_m \in \mathbb{R}[x]$ , then  $m \geq d$ . In [\[8\]](#page-10-7) it was conjectured that every d-dimensional polytope in  $\mathbb{R}^d$  can be represented by [\(1.13\)](#page-2-1) with  $m = d$ . This conjecture was confirmed in [\[4\]](#page-10-8) for simple polytopes (see also [\[3\]](#page-10-9) for further generalizations). We recall that a d-dimensional polytope is called *simple* if each of its vertices is contained in precisely d facets. We refer to [\[1,](#page-10-0) Chapter 5] and [\[7,](#page-10-1) §6.5 and §10.4] for results on minimal representations of general elementary semi-algebraic sets. We are able to derive some necessary conditions on representations of polytopes consisting of d polynomials.

<span id="page-3-0"></span>Corollary 1.5. *Let* P *be a* d*-dimensional polytope in* R <sup>d</sup> *with* m *facets such that*

$$
P = (p_1, \ldots, p_m)_{\geq 0} = (q_1, \ldots, q_d)_{\geq 0},
$$

*where*  $p_1, \ldots, p_m, q_1, \ldots, q_d \in \mathbb{R}[x]$  and  $p_1, \ldots, p_m$  are of degree one. Then every  $p_i, i \in$  $\{1, \ldots, m\}$ , *is a factor of precisely one polynomial*  $q_i$  *with*  $j \in \{1, \ldots, d\}$ . *Furthermore, for i and j as above, the factor*  $p_i$  *of*  $p_j$  *is of odd multiplicity.* 

Corollary [1.5](#page-3-0) improves Proposition 2.1(i) from [\[10\]](#page-10-5). In [\[6\]](#page-10-4) it was shown that every convex polygon P in  $\mathbb{R}^2$  can be represented by two polynomials. We are able to determine the precise structure of such minimal representations.

<span id="page-3-1"></span>**Corollary 1.6.** Let P be a convex polygon in  $\mathbb{R}^2$  with  $m \geq 7$  edges and let

$$
P = (p_1, \ldots, p_m)_{\geq 0} = (q_1, q_2)_{\geq 0},
$$

*where*  $p_1, \ldots, p_m, q_1, q_2 \in \mathbb{R}[x]$  *and*  $p_1, \ldots, p_m$  *are of degree one. Then there exist*  $k_1, \ldots, k_m \in \mathbb{N}$ *and*  $g_1, g_2 \in \mathbb{R}[x]$  *such that*  $\{q_1, q_2\} = \{p_1^{k_1}\}$  $i_1^{k_1} \cdot \ldots \cdot p_m^{k_m} g_1, g_2$  *and the following conditions are fulfilled:*

- <span id="page-3-4"></span><span id="page-3-3"></span>*1.*  $k_1, \ldots, k_m$  *are odd*;
- 2.  $g_1, g_2$  are not divisible by  $p_i$  for every  $i \in \{1, \ldots, m\}$ ;
- 3.  $q_2(y) = 0$  *for every vertex* y of P.

 $\Box$ 

It is not hard to see that the the set  $(q_1, q_2)_{\geq 0}$  in Corollary [1.6](#page-3-1) does not depend on the concrete choice of odd numbers  $k_1, \ldots, k_m$ . More precisely, for  $g_1, g_2$  as in Corollary [1.6](#page-3-1) we have  $P = (p_1 \cdots p_m g_1, g_2)_{\geq 0}$ . In [\[6\]](#page-10-4) the polynomials  $q_1, q_2$  representing P were defined in such a way that  $g_1 = 1$  $g_1 = 1$  and  $k_1 = \cdots = k_m = 1$ ; see Fig. 1 for an illustration of this result and Corollary [1.6.](#page-3-1) We also remark that the assumption  $m \geq 7$  cannot be relaxed in general, since Corollary [1.6](#page-3-1) would not hold if  $P$  is a centrally symmetric hexagon. In fact, assume that P is a centrally symmetric hexagon and  $p_1, \ldots, p_6$  are polynomials of degree one such that  $Z(p_1) \cap P, \ldots, Z(p_6) \cap P$  are consecutive edges of P. Then  $P = (q_1, q_2)_{\geq 0}$  for  $q_1 := p_1 p_3 p_5$  and  $q_2 := p_2 p_4 p_6$ ; see Fig. [2.](#page-4-0) It will be seen from the proof of Corollary [1.6](#page-3-1) that the assumption  $m \geq 7$  can be relaxed to  $m \geq 5$  for the case when P does not have parallel edges.

### 2 Examples

We wish to give several examples illustrating the presented results. Each of the examples below is supplied with a figure referring to the case  $d = 2$ . Let

$$
A := \left\{ x \in \mathbb{R}^d : x_d > 0 \text{ and } \left( (x_1 - 1)^2 + x_2^2 + \dots + x_d^2 \le 1 \text{ or } x_1^2 + x_2^2 + \dots + x_d^2 \le 1 \right) \right\},
$$

see Fig. [3.](#page-4-1) By Theorem [1.1,](#page-1-1) if A is given by [\(1.1\)](#page-0-0), then the polynomials  $x_d$ ,  $(x_1-1)^2 + x_2^2 + \cdots$  $x_d^2 - 1$ ,  $(x_1 + 1)^2 + x_2^2 + \cdots + x_d^2 - 1$  are factors of odd multiplicity of some of the polynomials  $p_1, \ldots, p_m$ .

The set

$$
A := \left\{ x \in \mathbb{R}^d : \left( 1 - x_1^2 - \dots - x_d^2 \right) (x_d + 2)^2 \ge 0 \right\},\tag{2.1}
$$

$$
= \{x \in \mathbb{R}^d : (1 - x_1^2 - \dots - x_d^2)(x_d + 2) \ge 0, \ x_d + 2 \ge 0\},\tag{2.2}
$$

depicted in Fig. [4](#page-5-0) is the disjoint unit of a closed unit ball centered at  $o$  and a hyperplane given by the equation  $x_d + 2 = 0$ . By Corollary [1.2\(](#page-2-2)[I\)](#page-2-3), if A is given by [\(1.1\)](#page-0-0), then  $x_d + 2$  is a factor of at least two polynomials  $p_i$  or a factor of even multiplicity of at least one polynomial  $p_1, \ldots, p_m$ . From [\(2.1\)](#page-4-2) and [\(2.2\)](#page-4-3) we see that both of these possibilities are indeed realizable. Fig. [5](#page-5-1) depicts the semi-algebraic set

=

\left\{ x \in \mathbb{R}^2 : x_d \ge 0, \ (1 - x_1^2 - \dots - x_d^2) x_d^2 \ge 0 \right\},
$$
 (2.3)

By Corollary [1.2\(](#page-2-2)[II\)](#page-2-4), if A is given by [\(1.1\)](#page-0-0) with  $E_1 = \ldots = E_m = \{0, 1\}$ , the polynomial  $x_d$  is a factor of at least two polynomials  $p_i$  and an odd-multiplicity factor of at least one polynomial  $p_i$ . By  $(2.3)$  we see that the above conclusion cannot be strengthened. In fact,  $(2.3)$ provides a representation  $A = (p_1, p_2)_{\geq 0}$  such that  $x_d$  is an odd-multiplicity factor of precisely one polynomial  $p_i$ .

Fig. [6](#page-5-2) presents the semi-algebraic set

$$
A := \left\{ x \in \mathbb{R}^d : (1 - x_1^2 - \dots - x_d^2) x_d^2 \ge 0 \right\}.
$$

which serves as an illustration of Corollary [1.3.](#page-2-5) By Corollary [1.3,](#page-2-5) if  $A = (p_1, \ldots, p_m)_{\geq 0}$  for  $p_1, \ldots, p_m \in \mathbb{R}[x]$ , some of these polynomials are divisible by  $x_d$ , and furthermore, if  $p_i$  is divisible by  $x_d$ , the multiplicity of the factor  $x_d$  of  $p_i$  is even. Fig. [7](#page-5-3) depicts the semi-algebraic set

$$
A := \left\{ x \in \mathbb{R}^2 : \left( 1 - x_1^2 - \dots - x_d^2 \right) x_d^2 > 0 \right\}
$$

illustrating Corollary [1.4.](#page-2-6) By Corollary [1.4,](#page-2-6) if  $A = (p_1, \ldots, p_m)_{>0}$  for some polynomials  $p_1, \ldots, p_m \in$  $\mathbb{R}[x]$ , then  $x_d$  is a factor of at least one  $p_i$  and f cannot be a factor of  $p_i$  of odd multiplicity. We notice that Corollary [1.4](#page-2-6) is in a certain sense an analogue of Corollary [1.3](#page-2-5) for elementary open semi-algebraic sets (since the conclusions of both the corollaries are the same).

Finally, we present examples of semi-algebraic sets for which we can verify that they are not elementary semi-algebraic (see also similar examples given in [\[1,](#page-10-0) p. 24]). We define the closed semi-algebraic set

$$
A := \left\{ x \in \mathbb{R}^d : x_d = 0 \text{ or } (x_1 - 3)^2 + x_2^2 + \dots + x_d^2 \le 1 \text{ or } \left( x_1^2 + x_2^2 + \dots + x_d^2 \le 1 \text{ and } x_d \ge 0 \right) \right\},
$$

see Fig. [8.](#page-6-0) We can show that  $A$  is not elementary closed. In fact, let us assume the contrary, that is  $A = (p_1, \ldots, p_m)_{\geq 0}$  for some polynomials  $p_1, \ldots, p_m \in \mathbb{R}[x]$ . Then, by Theorem [1.1\(](#page-1-1)[III\)](#page-1-4) applied for  $a = 0$  and  $0 < \varepsilon < 1$ , we get that  $x_d$  is a factor of odd multiplicity of  $p_i$  for some  $i \in \{1, \ldots, m\}$ . Since [\(1.10\)](#page-2-7) is fulfilled for  $f = x_d$ , we can apply Corollary [1.3](#page-2-5) obtaining that  $x_d$ is a factor of even multiplicity of  $p_i$ , a contradiction. Now we introduce the open semi-algebraic set

$$
A := \left\{ x \in \mathbb{R}^d : x_1^2 + x_2^2 + \dots + x_d^2 < 1 \text{ and } x_d > 0 \text{ or } (x_1 - 3)^2 + x_2^2 + \dots + x_d^2 < 1 \text{ and } x_d \neq 0 \right\},
$$

see Fig. [9.](#page-6-1) By Theorem [1.1\(](#page-1-1)[IV\)](#page-1-5) and Corollary [1.4](#page-2-6) (applied for  $f(x) = x_d$ ) A is not elementary open.

# 3 Preliminaries and auxiliary statements

A polynomial  $f \in \mathbb{R}[x]$  is said to be *irreducible* over  $\mathbb{R}[x]$  if f is non-constant and f cannot be represented as a product of two non-constant polynomials over  $\mathbb{R}[x]$ . A polynomial p is said to be a *factor* of q if  $q = pg$  for some polynomial g. An irreducible factor f of p is said to have *multiplicity*  $k \in \mathbb{N}$  if  $f^k$  is a factor of p but  $f^{k+1}$  is not a factor of p.

Below we give background information on commutative algebra and algebraic geometry; see also [\[2\]](#page-10-10) and [\[9\]](#page-10-11). Let R be a commutative ring. Then a subset I of R is said to be an *ideal* if I is an additive group and for every  $f \in I$  and  $g \in R$  one has  $fg \in I$ . An ideal I of R is said to be *prime* if for every product  $fg \in I$  with  $f, g \in R$ , one has  $f \in I$  or  $g \in I$ . The *(Krull) dimension* of a commutative ring R is the maximal length of a sequence of prime ideals  $I_1, \ldots, I_k$  satisfying  $I_1 \subsetneq I_1 \subsetneq \cdots \subsetneq I_k \subsetneq R$ . The *factor ring*  $R/I$  is defined as the set  $\{x + I : x \in R\}$  with the addition and multiplication induced by R.

<span id="page-6-3"></span>Lemma 3.1. *Let* R *be a commutative ring and* I, J *be ideals in* R *such that* I *is prime and I* ⊆ *J. Then* dim( $R/J$ ) ≤ dim( $R/I$ ) *with equality if and only if*  $I = J$ .

*Proof.* It is known that every ideal X of  $R/J$  has the form  $X = P/J := \{x + I : x \in P\}$ , where P is an ideal in R with  $J \subseteq P$ ; see [\[2,](#page-10-10) p. 9 of Chapter 2]. Furthermore, X is prime in  $R/J$  if and only if P is prime in R. Using this observation we readily get that the dimension of  $R/J$  is the maximal length of sequence of prime ideals  $I_1, \ldots, I_k$  satisfying  $J \subseteq I_1 \subsetneq I_1 \subsetneq \cdots \subsetneq I_k \subsetneq R$ . If I is properly contained in J, then  $I, I_1, \ldots, I_k$  is the chain of prime ideals containing I, and we get that the dimension of  $R/I$  is strictly larger than the dimension of  $R/J$ .  $\Box$ 

An algebraic set  $V \subseteq \mathbb{R}^d$  is said to be *irreducible* if whenever V is represented by  $V = V_1 \cup V_2$ , where  $V_1, V_2 \subseteq \mathbb{R}^d$  are algebraic sets, it follows that  $V_1 = V$  or  $V_2 = V$ . Given a set  $A \subseteq \mathbb{R}^d$ , we introduce the ideal

$$
\mathcal{I}(A) := \{ p \in \mathbb{R}[x] : p(x) = 0 \text{ for all } x \in A \}.
$$

It is known that an algebraic set V in  $\mathbb{R}^d$  is irreducible if and only if the ideal  $\mathcal{I}(V)$  of the ring  $\mathbb{R}[x]$  is prime; see [\[9,](#page-10-11) Proposition 3, p. 195] and [\[7,](#page-10-1) Theorem 2.8.3(ii)]. The notion of dimension of a (semi-algebraic) set can be defined in several equivalent ways; for details see [\[7,](#page-10-1) §2.8]. We shall employ the following algebraic definition. The *dimension* of a semi-algebraic set  $A \subseteq \mathbb{R}^d$ is defined as the dimension of the ring  $\mathbb{R}[x]/\mathcal{I}(A)$ . Let  $A_1, \ldots, A_m$  be semi-algebraic sets in  $\mathbb{R}^d$ . Then

$$
\dim(A_1 \cup \ldots \cup A_m) = \max\{\dim A_i : 1 \le i \le m\},\tag{3.1}
$$

see [\[7,](#page-10-1) Proposition  $2.8.5(i)$ ].

We present several statements devoted to irreducible polynomials over  $\mathbb{R}[x]$  that define  $(d-1)$ dimensional algebraic sets. Given a polynomial  $p \in \mathbb{R}[x]$ , by  $\nabla p$  we denote the gradient of p. The following statement can be found in [\[7,](#page-10-1) Theorem 4.5.1].

<span id="page-6-2"></span>Theorem 3.2. *Let* f *be a polynomial irreducible over* R[x]*. Then the following conditions are equivalent.*



- <span id="page-7-6"></span><span id="page-7-4"></span>*(i)*  $\mathcal{I}(Z(f)) = \{fg : g \in \mathbb{R}[x]\}.$
- *(ii)* The polynomial f has a non-singular zero, *i.e., for some*  $y \in \mathbb{R}^d$  *one* has  $f(y) = 0$  *and*  $\nabla f(y) \neq o.$
- <span id="page-7-3"></span> $(iii)$  dim  $Z(f) = d - 1$ .

<span id="page-7-5"></span><span id="page-7-0"></span>**Lemma 3.3.** Let  $f, p \in \mathbb{R}[x]$ . Let  $f$  be irreducible over  $\mathbb{R}[x]$  and let  $\dim Z(f) = d - 1$ . Then the *following conditions are equivalent.*

- <span id="page-7-1"></span>*(i)* dim( $Z(f) ∩ Z(p) = d - 1$ .
- <span id="page-7-2"></span>*(ii)*  $Z(f)$  ⊂  $Z(p)$ .
- *(iii)* f *is a factor of* p.

*Proof.* It suffices to verify [\(i\)](#page-7-0)  $\Rightarrow$  [\(ii\)](#page-7-1) and [\(ii\)](#page-7-1)  $\Rightarrow$  [\(iii\)](#page-7-2), since the implications [\(iii\)](#page-7-2)  $\Rightarrow$  [\(i\)](#page-7-0) are trivial.

 $(i)$  ⇒  $(ii)$ : Assume that [\(i\)](#page-7-0) is fulfilled. The implication [\(iii\)](#page-7-3) ⇒ (i) of Theorem [3.2](#page-6-2) yields  $\mathcal{I}(Z(f)) = \{fg : g \in \mathbb{R}[x]\}\.$  Consequently, since f is irreducible, the ideal  $\mathcal{I}(Z(f))$  is prime. Obviously,  $\mathcal{I}(Z(f)) \subseteq \mathcal{I}(Z(f,p))$ . Furthermore,

$$
\dim \mathbb{R}[x]/\mathcal{I}(Z(f,p)) = \dim Z(f,p) \stackrel{\text{(i)}}{=} d-1 = \dim Z(f) = \dim \mathbb{R}[x]/\mathcal{I}(Z(f))
$$

and, by Lemma [3.1,](#page-6-3) it follows that  $\mathcal{I}(Z(f)) = \mathcal{I}(Z(f,p))$ . The latter equality yields  $Z(f)$  =  $Z(f, p)$ ; see [\[9,](#page-10-11) Proposition 8, p. 34]. Since  $Z(f, p) = Z(f) \cap Z(p)$ , the statement [\(ii\)](#page-7-1) readily follows.

 $(iii) \Rightarrow (iii)$  $(iii) \Rightarrow (iii)$ *:* Since  $Z(f) \subseteq Z(p)$  it follows that  $\mathcal{I}(Z(p)) \subseteq \mathcal{I}(Z(f))$  and hence  $p \in \mathcal{I}(Z(f))$ *.* But then, by the implication [\(iii\)](#page-7-3)  $\Rightarrow$  [\(i\)](#page-7-4) of Theorem [3.2,](#page-6-2) it follows that f is a factor of p.  $\Box$ 

As a direct consequence of the implication [\(i\)](#page-7-0)  $\Rightarrow$  [\(iii\)](#page-7-2) of Lemma [3.3](#page-7-5) we obtain

<span id="page-7-8"></span>**Lemma 3.4.** Let f and g be polynomials irreducible over  $\mathbb{R}[x]$  and let  $\dim Z(f) = \dim Z(g) =$  $d-1$ . *Then* dim( $Z(f) ∩ Z(g)$ ) =  $d-1$  *if and only if* f and g *coincide up to a constant multiple.*  $\Box$ 

<span id="page-7-7"></span>**Proposition 3.5.** Let f be a polynomial irreducible over  $\mathbb{R}[x]$  and such that  $\dim Z(f) = d - 1$ . *Then*

$$
\dim Z(f, \frac{\partial}{\partial x_1} f, \dots, \frac{\partial}{\partial x_d} f) \leq d - 2.
$$

*Proof.* Even though this statement is known (see [\[7,](#page-10-1) Proposition 3.3.14]), we wish to give a short proof. We assume that  $\dim Z(f, \frac{\partial}{\partial x_1}f, \ldots, \frac{\partial}{\partial x_d}f) = d - 1$ . Then, by Lemma [3.3,](#page-7-5) one has  $Z(f) \subseteq Z(\frac{\partial}{\partial x})$  $\frac{\partial}{\partial x_1} f, \ldots, \frac{\partial}{\partial x_d} f$ , a contradiction to the implication [\(iii\)](#page-7-3)  $\Rightarrow$  [\(ii\)](#page-7-6) of Theorem [3.2.](#page-6-2)  $\Box$ 

#### 4 The proofs

Now we are ready to prove the main result and its corollaries. In the proofs we shall deal with polynomials  $p_1, \ldots, p_m$ . Throughout the proofs  $f_1, \ldots, f_n$  will denote the polynomials irreducible over  $\mathbb{R}[x]$  which are involved in the *prime factorization* of the product  $p_1 \cdot \ldots \cdot p_m$  (see [\[9,](#page-10-11) p. 149]), i.e.

$$
p_1 \cdot \ldots \cdot p_m = f_1^{s_1} \cdot \ldots \cdot f_n^{s_n}
$$

for some  $s_1, \ldots, s_n \in \mathbb{N}$  and for every  $i, j \in \{1, \ldots, n\}$  with  $i \neq j$  the polynomials  $f_i$  and  $f_j$  do not coincide up to a constant multiple.

 $\Box$ 

*Proof of Theorem [1.1.](#page-1-1)* For  $x \in \mathbb{R}^d$  we define

$$
\Psi(x) := \Phi\big((\operatorname{sign} p_1(x) \in E_1), \dots, (\operatorname{sign} p_m(x) \in E_m)\big).
$$

*Part [I:](#page-1-6)* Let  $x_0 \notin \bigcup_{i=1}^m Z(p_i)$ , that is  $p_i(x_0) \neq 0$  for every  $i = 1, \ldots, m$ . Then there exists an  $\varepsilon > 0$  such that the sign of every  $p_i(x), i \in \{1, ..., m\}$ , remains constant on  $B^d(x_0, \varepsilon)$ . It follows that  $\Psi(x)$  is constant for  $x \in B^d(x_0, \varepsilon)$ . Consequently, either  $B^d(x_0, \varepsilon) \subseteq A$  or  $B^d(x_0, \varepsilon) \cap A = \emptyset$ . Hence  $x_0$  is either an interior or an exterior point of A, and we get the conclusion of Part [I.](#page-1-6)

*Part [II:](#page-1-7)* By Part [I](#page-1-6) we have bd  $A \subseteq \bigcup_{i=1}^{n} Z(f_i)$ . Consequently

$$
d-1 \stackrel{(1.5)}{=} \dim(\text{bd } A \cap Z(f)) \le \dim\left(\left(\bigcup_{i=1}^{m} Z(p_i)\right) \cap Z(f)\right)
$$

$$
\stackrel{(3.1)}{=} \max_{1 \le i \le m} \dim(Z(p_i) \cap Z(f)) \le d-1.
$$

Hence dim  $Z(f) = d - 1$  and for some  $i \in \{1, \ldots, m\}$  one has  $\dim(Z(p_i) \cap Z(f)) = d - 1$ . Then Lemma [3.3](#page-7-5) yields the assertion of Part [II.](#page-1-7)

*Part [III:](#page-1-4)* Let  $a \in Z(f)$  and  $\varepsilon > 0$  satisfy [\(1.6\)](#page-1-3) and [\(1.7\)](#page-1-3). From (1.6) it follows that  $\dim Z(f) = d - 1$ . By Proposition [3.5,](#page-7-7) there exists  $a' \in Z(f) \cap B^d(a, \varepsilon)$  such that  $\nabla f(a') \neq o$ . We choose  $\varepsilon' > 0$  such that  $B^d(a', \varepsilon') \subseteq B^d(a, \varepsilon)$  and  $\nabla f(x) \neq o$  for every  $x \in B^d(a', \varepsilon')$ . Let us show that

<span id="page-8-0"></span>
$$
Z(f) \cap B^d(a', \varepsilon') \subseteq \text{bd } A. \tag{4.1}
$$

Consider an arbitrary point  $x \in Z(f) \cap B^d(a', \varepsilon')$ . In view of [\(1.7\)](#page-1-3) we have  $x \in A$ . On the other hand, since  $f(x) = 0$  and  $\nabla f(x) \neq o$ , there exists a sequence  $(x^k)_{k=1}^{+\infty}$  of points from  $B^{d}(a', \varepsilon')$  such that  $f(x^k) < 0$  for every  $k \in \mathbb{N}$  and  $x^k \to x$ , as  $k \to +\infty$ . Since  $x^k \notin (f)_{\geq 0}$  and  $x^k \in B^d(a,\varepsilon)$ , in view of [\(1.7\)](#page-1-3) it follows that  $x^k \notin A$  for every  $k \in \mathbb{N}$ . Hence, x is a point of A and is a limit of a sequence of points lying outside A. The latter implies [\(4.1\)](#page-8-0). Since  $f(a') = 0$ and  $\nabla f(x) \neq o$  for every  $x \in Z(f) \cap B^d(a', \varepsilon')$  it follows that  $Z(f) \cap B^d(a', \varepsilon')$  is an infinitely differentiable manifold of dimension  $d-1$ , where the notion dimension is used in the sense of differential geometry. It is known that in the above case the Krull dimension of  $Z(f) \cap B^d(a', \varepsilon')$ is also equal to  $d-1$ ; see [\[7,](#page-10-1) Proposition 2.8.14]. Consequently, we have

$$
d-1 = \dim(Z(f) \cap B^d(a', \varepsilon')) \stackrel{(4.1)}{=} \dim(Z(f) \cap \text{bd } A \cap B^d(a', \varepsilon'))
$$
  
\$\leq\$ 
$$
\dim(Z(f) \cap \text{bd } A) \leq \dim(Z(f)) = d - 1
$$

Hence  $\dim(Z(f)\cap\mathrm{bd}\,A)=d-1$ . By Part [II,](#page-1-7) it follows that f coincides, up to a constant multiple, with  $f_i$  for some  $i \in \{1, \ldots, n\}$ . Without loss of generality we assume that  $f = f_1$ . By Lemma [3.4,](#page-7-8) we can choose  $a'' \in Z(f) \cap B^d(a', \varepsilon')$  such that  $f_i(a'') \neq 0$  for  $i \in \{2, \ldots, n\}$ . This means the sign of the polynomials  $f_i$ ,  $i = \{2, \ldots, n\}$ , remains constant on  $B^d(a'', \varepsilon'')$ . We prove the statement of Part [III](#page-1-4) by contradiction. Assume that whenever f is factor of  $p_i$ ,  $i \in \{1, \ldots, m\}$ , this factor is of even multiplicity. Since  $\nabla f(a'') \neq o$ , we can choose  $x_0, y_0 \in B^d(a'', \varepsilon'')$  such that  $f(x_0) > 0$  and  $f(y_0) < 0$ . Since the signs of  $f_2, \ldots, f_n$  do not change on  $B^d(a'', \varepsilon'')$  and since  $f_1 = f$  appears with an even multiplicity only, we obtain  $sign p_i(x_0) = sign p_i(y_0)$  for every  $j = 1, \ldots, m$ . Hence  $\Psi(x_0) = \Psi(y_0)$ . But by [\(1.7\)](#page-1-3),  $x_0 \in A$  and  $y_0 \notin A$ , which implies that  $\Psi(x_0) \neq \Psi(y_0)$ , a contradiction.

The proof of Part [IV](#page-1-5) is omitted, since it is analogous to the proof of Part [III.](#page-1-4)

 $\Box$ 

*Proof of Corollary [1.2.](#page-2-2) Part [I:](#page-2-3)* Let  $b \in Z(f)$  and  $\varepsilon > 0$  satisfy [\(1.8\)](#page-2-0) and [\(1.9\)](#page-2-0). From (1.8) it follows that  $\dim Z(f) = d - 1$ . By Proposition [3.5,](#page-7-7) there exists  $b' \in Z(f) \cap B^d(b, \varepsilon)$  such that  $\nabla f(b') \neq o$ . Choose  $\varepsilon' > 0$  such that  $B^d(b', \varepsilon') \subseteq B^d(b, \varepsilon)$  and  $\nabla f(x) \neq o$  for every

 $x \in B^d(b', \varepsilon')$ . Using arguments analogous to those from the proof of Theorem [1.1\(](#page-1-1)[III\)](#page-1-4) we show the inclusion  $Z(f) \cap B^d(b', \varepsilon') \subseteq \text{bd } A$  and [\(1.5\)](#page-1-2). Hence, by Theorem [1.1](#page-1-1)[\(II\)](#page-1-7), f coincides, up to a constant multiple, with  $f_i$  for some  $i \in \{1, \ldots, n\}$ . Without loss of generality we assume that  $f = f_1$ . If f is a factor of  $p_i$  and  $p_j$  for some  $i, j \in \{1, ..., m\}$  with  $i \neq j$ , we are done. We consider the opposite case, that is, for some  $i \in \{1, \ldots, m\}$  the polynomial f is a factor of precisely one polynomial  $p_i$  with  $i \in \{1, \ldots, m\}$ , say  $p_1$ . We show by contradiction that in this case the factor f of  $p_1$  has even multiplicity. Assume the contrary, i.e., the factor f of  $p_1$ has odd multiplicity. Analogously to the arguments from the proof of Theorem [1.1,](#page-1-1) we choose  $b'' \in Z(f)$  and  $\varepsilon'' > 0$  such that  $B^d(b'', \varepsilon'') \subseteq B^d(b', \varepsilon')$  and  $f_i(x) \neq 0$  for every  $i \in \{2, ..., n\}$ and every  $x \in B^d(b'', \varepsilon'')$ . By the choice of b'' and  $\varepsilon''$  we have  $\text{sign } p_i(x) = \text{sign } p_i(b'')$  for all  $i \in \{2,\ldots,m\}$  and  $x \in B^d(b'',\varepsilon'')$ . Since  $\nabla f(b'') \neq o$ , there exist points  $x_0, y_0 \in B^d(b'',\varepsilon'')$  such that  $f(x_0) f(y_0) < 0$ . Then  $p_1(x_0) p_1(y_0) < 0$ . Consequently, either  $p_1(x_0) > 0$  or  $p_1(y_0) > 0$ . Without loss of generality we assume that  $p_1(x_0) > 0$ . It follows that  $(p_i(x_0) \ge 0) \equiv (p_i(b'') \ge 0)$ for  $i = 1, \ldots, m$ . Hence  $x_0 \in A$ . But since  $f(x_0) \neq 0$ , in view of [\(1.9\)](#page-2-0), we get  $x_0 \notin A$ , a contradiction.

*Part [II:](#page-2-4)* By Theorem [1.1\(](#page-1-1)[III\)](#page-1-4) f is a factor of odd multiplicity of some  $p_i$  with  $i \in \{1, \ldots, m\}$ . Furthermore, for some  $j \in \{1, \ldots, m\}$  with  $i \neq j$  the polynomial f is a factor of  $p_j$ , since otherwise we would get a contradiction to Part [I.](#page-2-3)  $\Box$ 

*Proof of Corollary [1.3.](#page-2-5)* By Corollary [1.2\(](#page-2-2)[I\)](#page-2-3), f is a factor of some  $p_i$ , say  $p_1$ . Without loss of generality we assume that  $f_1 = f$ . Let us show that the factor f of  $p_1$  is of even multiplicity. Assume the contrary. In view of Proposition [3.5,](#page-7-7) we can choose  $a' \in \text{int } A \cap Z(f)$  such that  $\nabla f(a') \neq o$ . We fix  $\varepsilon' > 0$  such that  $\nabla f(x) \neq o$  for every  $x \in B^d(a', \varepsilon')$ . By Lemma [3.4](#page-7-8) we can choose  $a'' \in B^d(a', \varepsilon')$  such that  $f_i(a'') \neq 0$  for every  $i \in \{2, ..., n\}$ . Fix  $\varepsilon'' > 0$  such that for every  $i \in \{2, \ldots, n\}$  the sign of  $f_i$  remains constant on  $B^d(a'', \varepsilon'')$ . Since  $\nabla f(a'') \neq o$ , there exist  $x_0$  and  $y_0$  in  $B^d(a'', \varepsilon'')$  with  $f(x_0) f(y_0) < 0$ . Hence  $p_1(x_0) p_1(y_0) < 0$ , and we get that either  $x_0$  or  $y_0$  does not belong to A, a contradiction.  $\Box$ 

*Proof of Corollary [1.4.](#page-2-6)* Equality [\(1.11\)](#page-2-8) implies [\(1.5\)](#page-1-2), and hence, by Theorem [1.1\(](#page-1-1)[II\)](#page-1-7), f is a factor of  $p_i$  for some  $i \in \{1, \ldots, m\}$ . The rest of the proof is analogous to the proof of Corollary [1.3.](#page-2-5)

*Proof of Corollary* [1.5.](#page-3-0) Let us prove the first part of the assertion. Assume the contrary, say  $p_1$ is a factor of both  $q_1$  and  $q_2$ . Then within the  $(d-1)$ -dimensional affine space  $Z(p_1)$  the facet  $P \cap Z(p_1)$  of P is represented by  $d-2$  polynomials  $q_3, \ldots, q_d$  in the following way

$$
P \cap Z(p_1) = \{x \in Z(p_1) : q_3(x) \geq 0, \ldots, q_d(x) \geq 0\}.
$$

This yields a contradiction to the fact that a k-dimensional convex polytope cannot be represented (in the above form) by less than  $k$  polynomials; see [\[10,](#page-10-5) Corollary 2.2]. The second part of the assertion follows directly from Theorem [1.1](#page-1-1)[\(III\)](#page-1-4).  $\Box$ 

*Proof of Corollary* [1.6.](#page-3-1) For  $j \in \{1,2\}$  denote by  $I_j$  the set of indices  $i \in \{1,\ldots,m\}$  for which  $p_i$ is a factor of  $q_j$ . By Corollary [1.3](#page-2-5) it follows that  $I_1 \cup I_2 = \{1, \ldots, m\}$ . Furthermore,  $I_1 \cap I_2 = \emptyset$ , by Corollary [1.5.](#page-3-0) Let us show that either  $I_1$  or  $I_2$  is empty. Assume the contrary. We show that then there exist  $i \in I_1$  and  $j \in I_2$  such that the edges  $Z(p_i) \cap P$  and  $Z(p_j) \cap P$  of P are not adjacent and not parallel. Since  $m \geq 7$ , after possibly exchanging the roles of  $q_1$  and  $q_2$ , we may assume that the cardinality of  $I_2$  is at least four. Let us take an arbitrary  $i \in I_1$ . Then there exist at least two sides of the form  $Z(p_j) \cap P$ ,  $j \in I_2$ , which are not adjacent to  $Z(p_i) \cap P$ . One of these sides is not parallel to  $Z(p_i) \cap P$ . The intersection point y of  $Z(p_i)$  and  $Z(p_j)$  lies outside P and fulfills the equalities  $q_1(y) = q_2(y) = 0$ , a contradiction to the inclusion  $(q_1, q_2)_{\geq 0} \subseteq P$ . Hence  $I_1$  or  $I_2$  is empty. Without loss of generality we assume that  $I_2 = \emptyset$ .

For  $i \in \{1, \ldots, m\}$  let  $k_i$  be the multiplicity of the factor  $p_i$  of  $p_1$ . Then  $q_1 = p_1^{k_1}$  $i_1^{k_1}\cdot\ldots\cdot p_m^{k_m}\,g_1$ for some polynomial  $g_1$ , and Statements [1](#page-3-3) and [2](#page-3-4) follow directly from Theorem [1.1](#page-1-1)[\(III\)](#page-1-4).

It remains to verify Condition [2](#page-3-4) (which involves  $g_2 = q_2$ ). This condition can be deduced from Proposition 2.1(ii) in [\[10\]](#page-10-5), but below we also give a short proof. We argue by contradiction. Let y be a vertex of P with  $g_2(v) > 0$ . Up to reordering the sequence  $p_1, \ldots, p_m$  we may assume that  $p_1(v) = 0$ . Clearly, any point y' lying in  $Z(p_1) \setminus P$  and sufficiently close to y fulfills the conditions  $q_1(y') = 0$  and  $q_2(y') > 0$ . Hence  $y' \in P$ , a contradiction to the inclusion  $(q_1, q_2)_{\geq 0} \subseteq P$ .  $\Box$
