Giant magnons in TsT-transformed $\mathrm{AdS}_5 \times \mathrm{S}^5$

ABSTRACT: We consider giant magnons propagating in a γ -deformed AdS₅ \times S⁵ background obtained from $AdS_5 \times S^5$ by means of a chain of TsT transformations. We point out that in the light-cone gauge and in the infinite J limit the deformed and undeformed string models share the same magnon dispersion relation, the $\mathfrak{su}(2|2) \oplus$ $\mathfrak{su}(2|2)$ -invariant world-sheet S-matrix and the dressing factor. The γ -dependence in the limit is only due to different level-matching conditions. We consider the reduction of the deformed model to $R \times S^3$ and determine the leading γ -dependence of the dispersion relation for a finite J giant magnon.

1. Introduction and summary

An interesting example of the AdS/CFT duality[[1](#page-18-0)] between gauge and string theory models with reduced supersymmetry is provided by an exactly marginal deformation of $\mathcal{N} = 4$ super Yang-Mills theory [\[2](#page-18-0)] and string theory on a deformed $AdS_5 \times S^5$ background suggested in [\[3\]](#page-18-0). The deformed models depend on a continuous complex parameter β , and are often called β -deformed. If $\beta \equiv \gamma$ is real the deformed string background can be derived from $AdS_5 \times S^5$ by using a TsT transformation which is a combination of a T-duality on one angle variable, a shift of another isometry variable, followedby the second T-duality on the first angle $[3, 4]$ $[3, 4]$. Moreover, since S^5 has three isometry directions, a chain of TsT transformations can be used to construct a regular three-parameter deformation of $AdS_5 \times S^5$ dual to a non-supersymmetric deformation of $\mathcal{N} = 4$ SYM [\[4\]](#page-18-0). The Lagrangian of the γ_i -deformed gauge theory can be obtained from the undeformed one by replacing the usual product by the associative \ast -product [[3, 4](#page-18-0), [5](#page-18-0)]. The resulting model is conformal in the planar limit to any order of perturbation theory [\[6](#page-18-0)].

Another important property of a TsT transformation is that it preserves the classical integrability of string theory on $AdS_5 \times S^5$ [\[4](#page-18-0)]. In particular the Lax pair for strings on $AdS_5 \times S^5$ [\[7](#page-18-0)] and a TsT transformation can be used to find a Lax pair for strings on a deformed background[[4, 8](#page-18-0)]. Moreover, the Green-Schwarz action for strings on $AdS_5 \times S^5$ is mapped under a TsT transformation to a string action on the γ -deformed background providing a nontrivial example of non-supersymmetric Green-Schwarz action for strings on RR backgrounds[[8\]](#page-18-0). In fact in the Hamiltonian (first-order) formalism the Green-Schwarz action for strings on the γ -deformed background is canonically equivalent to the action for strings on $AdS_5 \times S^5$ satisfying quasi-periodic or twisted boundary conditions[[4](#page-18-0), [8](#page-18-0)]. The twists however are quite unusual because they depend on charges carried by a string and are given by linear combinations of products of the deformation parameters and $\mathfrak{su}(4)$ charges.

This also implies that in the light-cone gauges of [\[9](#page-18-0), [10\]](#page-18-0) the string dynamics on both the γ -deformed background and $AdS_5 \times S^5$ is described by the same Hamiltonian density. The γ -dependence enters only through the twisted boundary conditions and the level-matching condition which is modified because a closed string in the deformed background in general corresponds to an open string in $AdS_5 \times S^5$. Correspondingly, in the decompactification limit where one of the $\mathfrak{su}(4)$ charges, say J, is sent to infinity while the string tension and the deformation parameters are kept fixed the dependence of the light-cone Hamiltonian on the deformation parameters disappears because in this limit all physical fields must vanish at the space infinity¹. As a result, if one considers the light-cone gauge-fixed string sigma model off-shell, that is if one does not impose the level-matching condition then the deformed string model is indistinguishable from the undeformed one, and they share thesame magnon dispersion relation [[16\]](#page-19-0), the $\mathfrak{su}(2|2)\oplus \mathfrak{su}(2|2)$ -invariant world-sheet S-matrix[[17](#page-19-0), [18](#page-19-0)] and the dressing factor [\[19](#page-19-0)]-[[22](#page-19-0)]. Therefore, the γ -dependence in the decompactification limit is only due to the level-matching condition.

Thus, to see the dependence of the off-shell spectrum of the model on the deformation parameters one should analyze it for finite values of the $\mathfrak{su}(4)$ charges. The leading dependence can then be captured by the asymptotic Bethe ansatz which would differ from the usual one [\[23](#page-19-0)] only by the twists reflecting the non-periodic boundary conditions for finite J. This conclusion is also confirmed by the one-loop considerationsin the γ -deformed gauge theory [[24](#page-19-0), [25](#page-19-0), [5\]](#page-18-0) where it is shown that the one-loopintegrability of $\mathcal{N} = 4$ SYM [[26\]](#page-19-0) is preserved by the deformation, and the corresponding one-loop Bethe ansatz involves the same twists that appear in string theory[[5](#page-18-0)]. In the asymptotic approximation the dispersion relation is not modified and the twists lead to a very mild modification of the string spectrum which basically reduces to γ -dependent shifts of string mode numbers, see [\[3](#page-18-0), [27](#page-19-0), [28](#page-19-0)] for some examples.

¹A γ -dependence remains in the pp-wave [[11\]](#page-18-0) and spinning string [[12\]](#page-18-0) limits because in these limits the effective length $J/\sqrt{\lambda}$ and the twists ~ $\gamma_i J_k$ are kept fixed, and therefore the string sigma model is defined on a circle with fields obeying quasi-periodic boundary conditions. The pp-wave limit of the deformed backgrounds was discussed in[[13,](#page-18-0) [14, 15\]](#page-19-0).

The asymptotic Bethe ansatz is not exact and for finite J one expects to find a non-trivial γ-dependence already in the large string tension limit where classical string considerations can be used. In particular, it is interesting to determine how the dispersion relation for a giant magnon [\[29\]](#page-20-0) depends on the deformation parameters. In the infinite J limit a giant magnon is dual to a gauge theory spin chain magnon, and in the conformal gauge it can be identified with an open string solution of the sigma model reduced to $R \times S^2$. The end-points of the open string move along the equator of S^2 parametrized by an angle ϕ , and the momentum p carried by the dual spin chain magnon is equal to the difference in the angle ϕ between the two endpoints of the string [\[29\]](#page-20-0). On the other hand in a light-cone gauge a giant magnon is identified with a world-sheet soliton and the momentum p is equal to the world-sheet momentum p_{ws} of the soliton [\[30](#page-20-0)]. For finite J the equality between p and p_{ws} holds only in the light-cone gauge $t = \tau$, $p_{\phi} = 1$ [\[30](#page-20-0)].

In this paper we determine the leading γ-dependence of the dispersion relation for a finite J giant magnon. We use the conformal gauge and the string sigma model reduced to $R \times S^3$ which in the deformed case is the smallest consistent reduction due to the twisted boundary conditions. Even for the three-parameter deformation the reduced model depends only on one of the parameters which we denote γ . Since there are two isometry angles ϕ_1 and ϕ_2 a solution of the reduced model can have two non-vanishing charges J_1 and J_2 . A giant magnon is then an open string solution of the model which carries only one charge $J \equiv J_1$. The momentum p of the magnon is correspondingly identified with the difference in the angle ϕ_1 between the two endpoints of the open string because in the light-cone gauge $t = \tau$, $p_{\phi_1} = 1$ it is equal to the world-sheet momentum of a soliton. The second angle ϕ_2 satisfies a twisted boundary condition which can be found by using the general formulas from[[4\]](#page-18-0)

$$
\Delta \phi_2 = 2\pi (n_2 - \gamma J), \quad n_2 \in \mathbf{Z},
$$

where n_2 is an integer winding number of the string in the second isometry direction of the deformed sphere S^3_γ . Collecting all the requirements together, we conclude that a γ -deformed giant magnon can be identified with an open string in $R \times S^3$ satisfying the following conditions

$$
\Delta \phi_1 = p
$$
, $\Delta \phi_2 = 2\pi (n_2 - \gamma J)$, $J_1 = J$, $J_2 = 0$.

We analyze the equations of motion and find that a solution exists only for one integer n_2 which obeys the condition $|n_2 - \gamma J| < \frac{1}{2}$ $\frac{1}{2}$, and therefore there is only one deformation of a giant magnon solution in $R \times S^2$. Then, the leading correction to

the dispersion relation in the large J limit has the following form

$$
E - J = 2g \sin\left(\frac{p}{2}\right) \left(1 - \frac{4}{e^2} \sin^2\left(\frac{p}{2}\right) \cos \Phi \, e^{-\frac{\mathcal{J}}{\sin\left(p/2\right)}} + \dots\right) \,, \quad \Phi = \frac{2\pi (n_2 - \gamma J)}{2^{3/2} \cos^3\left(\frac{p}{4}\right)}
$$

,

where $g = \frac{\sqrt{\lambda}}{2\pi}$ $\frac{\sqrt{\lambda}}{2\pi}$ is the string tension, and $\mathcal{J} = J/g$. The formula reduces in the limit $\gamma \to 0$ $\gamma \to 0$ $\gamma \to 0$ (or $\Phi \to 0$) to the one obtained in [[30](#page-20-0)]. In the large J limit the γ -dependence disappears in agreement with the discussion above, and if γ is kept fixed then the winding number n_2 goes to infinity too.

The deformed theory has less supersymmetry, and one expects that the energy of a γ -deformed magnon would be higher than the energy of the undeformed one with the same momentum and charge. It is indeed the case because $\cos \Phi < 1$.

It would be interesting to understand how to reproduce the dispersion relation by using Lüscher's approach [\[31](#page-20-0)]. This would generalize the computation performed in[[32](#page-20-0)] to the deformed case. The dispersion relation has a peculiar γ -dependence for finite J , and it is not quite clear how such a dependence follows from the S-matrix approach. This would require to generalize Lüscher's formulas to the case of the nontrivial twisted boundary conditions.

Our consideration can be generalized to solutions carrying several spins, see[[33,](#page-20-0) [34](#page-20-0), [35\]](#page-20-0) for recent discussions of the undeformed model. It would be also interesting to compute the one-loop quantum correction generalizing the considerations in [\[36](#page-20-0), [37](#page-20-0)].

In section 2 we discuss possible giant magnon solutions in the deformed background and explain how they can be mapped to open strings in $AdS_5 \times S^5$. In section 3 we sketch the derivation of the leading correction to the dispersion relation in the large J limit and discuss its structure. The details of the derivation can be found in Appendix.

2. The γ -deformed giant magnon

The bosonic part of the Green-Schwarz action for strings on the γ -deformed $AdS_5 \times S^5$ background[[8\]](#page-18-0) reduced to $R \times S^5_\gamma$ can be written in the following form

$$
S = -\frac{g}{2} \int_{-r}^{r} d\sigma d\tau \left[\gamma^{\alpha\beta} \left(-\partial_{\alpha} t \partial_{\beta} t + \partial_{\alpha} \rho_{i} \partial_{\beta} \rho_{i} + G \rho_{i}^{2} \partial_{\alpha} \varphi_{i} \partial_{\beta} \varphi_{i} + G \rho_{1}^{2} \rho_{2}^{2} \rho_{3}^{2} (\hat{\gamma}_{i} \partial_{\alpha} \varphi_{i}) (\hat{\gamma}_{j} \partial_{\beta} \varphi_{j}) \right) - 2 G \epsilon^{\alpha\beta} (\hat{\gamma}_{3} \rho_{1}^{2} \rho_{2}^{2} \partial_{\alpha} \varphi_{1} \partial_{\beta} \varphi_{2} + \hat{\gamma}_{1} \rho_{2}^{2} \rho_{3}^{2} \partial_{\alpha} \varphi_{2} \partial_{\beta} \varphi_{3} + \hat{\gamma}_{2} \rho_{3}^{2} \rho_{1}^{2} \partial_{\alpha} \varphi_{3} \partial_{\beta} \varphi_{1}) \right].
$$
 (2.1)

Here $g = \frac{R^2}{\alpha'} = \frac{\sqrt{\lambda}}{2\pi}$ $\frac{\sqrt{\lambda}}{2\pi}$ is the string tension, and $\gamma^{\alpha\beta} = \sqrt{-h}h^{\alpha\beta}$ where $h^{\alpha\beta}$ is a worldsheet metric with Minkowski signature. The function G is defined as follows

$$
G^{-1} = 1 + \hat{\gamma}_3^2 \rho_1^2 \rho_2^2 + \hat{\gamma}_1^2 \rho_2^2 \rho_3^2 + \hat{\gamma}_2^2 \rho_1^2 \rho_3^2 , \qquad \sum_{i=1}^3 \rho_i^2 = 1 , \qquad (2.2)
$$

and φ_i are the three isometry angles of the deformed S^5_γ . The deformation parameters $\hat{\gamma}_i$ are kept fixed in the string sigma model perturbation theory, and are related to the parameters γ_i which appear in the dual gauge theory as $\hat{\gamma}_i = 2\pi g \gamma_i = \sqrt{\lambda} \gamma_i$. The standard $AdS_5 \times S^5$ background is recovered after setting the deformation parameters $\hat{\gamma}_i$ to zero. For equal $\hat{\gamma}_i = \hat{\gamma}$ this becomes the supersymmetric background of [[3](#page-18-0)], and the deformation parameter γ enters the $\mathcal{N}=1$ SYM superpotential as follows $W = h \operatorname{tr} (e^{i\pi \gamma} \Phi_1 \Phi_2 \Phi_3 - e^{-i\pi \gamma} \Phi_1 \Phi_3 \Phi_2).$

The TsT transformations that map the $AdS_5 \times S^5$ string theory to the γ_i deformed string theory allow one to relate the angle variables ϕ_i of S^5 to the angle variables φ_i of the γ -deformed geometry. The relations take their simplest form being expressedin terms of the momenta p_i and π_i conjugate to ϕ_i and φ_i , respectively [[4\]](#page-18-0)

$$
p_i = \pi_i \,,\tag{2.3}
$$

$$
\rho_i^2 \, \phi_i' = \rho_i^2 (\varphi_i' - \epsilon_{ijk} \gamma_j p_k) \;, \qquad i = 1, 2, 3 \;, \tag{2.4}
$$

where in (2.4) we sum only in j, k. The relation (2.3) implies that the $U(1)$ charges $J_i = \int d\sigma p_i$ are invariant under a TsT transformation.

Assuming that none of the "radii" ρ_i vanish on a string solution, we get

$$
\phi_i' = \varphi_i' - \epsilon_{ijk}\gamma_j p_k \tag{2.5}
$$

Integrating eq.(2.5) and taking into account that

$$
\Delta \varphi_i = \varphi_i(r) - \varphi_i(-r) = 2\pi n_i, n_i \in \mathbb{Z}
$$
\n(2.6)

for a closed string in the γ -deformed background, we obtain the twisted boundary conditions for the angle variables ϕ_i of the original S^5 space

$$
\Delta \phi_i = \phi_i(r) - \phi_i(-r) = 2\pi (n_i - \nu_i), \quad \nu_i = \epsilon_{ijk}\gamma_j J_k, \quad J_i = \int_{-r}^r d\sigma \ p_i. \quad (2.7)
$$

It is clear that if the twists ν_i are not integer then a closed string in the deformed geometry is mapped to an open string in $AdS_5 \times S^5$. A giant magnon solution in this respect does not differ essentially from a closed string in $AdS_5 \times S^5_\gamma$. It corresponds

to an open string in the deformed geometry, and its image in $AdS_5 \times S^5$ is an open string too. The only difference is that not all of the winding numbers n_i are integer for a giant magnon solution. In fact one linear combination of the winding numbers should be identified with the momentum p carried by the giant magnon.

To determine the linear combination we notice that in the infinite $J \equiv J_1 +$ $J_2 + J_3$ limit the end-points of a giant magnon should move with the speed of light along a null geodesic of the background [\[29](#page-20-0)]. In the undeformed case any geodesics is just a big circle of S^5 , and the solution is described by a soliton of the string sigma model reduced to $R \times S^2$. The momentum carried by the soliton is identified with the difference in the angle ϕ between the two end-points of the string where ϕ parametrizes the equator of S^2 [[29](#page-20-0)]. In the light cone gauge $t = \tau$, $p_{\phi} = 1$ the momentum p is equal to the world-sheet momentum of the giant magnon solution and because of that the identification can be also used for finite J [[30\]](#page-20-0).

In the γ -deformed background there are infinitely many inequivalent geodesics which correspond to solutions of the Neumann-Rosochatius integrable system[[28\]](#page-19-0) (which also describes multi-spin string solutions [\[38](#page-20-0), [39](#page-20-0)]), and one should choose only those which give the minimum energy satisfying the BPS condition $E = J$. These geodesics were described in [\[28\]](#page-19-0) where it was shown that for generic values of γ_i there are three BPS states which have only one of the three charges J_i nonvanishing. Choosing for definiteness the nonvanishing charge to be $J_1 = J$, the BPS state corresponds to the geodesics parametrized by the angle φ_1 and having $\rho_1 = 1$, $\rho_2 = \rho_3 = 0$. An infinite J giant magnon with the end-points moving along the geodesics is then a solution of the string sigma model reduced to $R \times S^3_\gamma$ where S^3_γ is obtained from the deformed S^5_γ by setting $\rho_3 = 0$. The momentum p carried by the soliton is identified with the difference $\Delta \varphi_1 = \varphi_1(r) - \varphi_1(-r)$. In fact it is easy to see that the TsT transformation maps the infinite J giant magnon solution of the undeformed model to the γ -deformed giant magnon, and therefore the infinite J dispersion relation is not modified, and has no γ dependence. For finite J however the dispersion relation gets a nontrivial γ -dependence which we determine in the next section. This follows from the fact that for the magnon solution $J_2 = J_3 = 0$, and therefore the twist $\nu_1 = 0$, and the corresponding angles ϕ_1 and ϕ_2 of the undeformed $S³$ satisfy the following twisted boundary conditions

$$
\Delta \phi_1 = \phi_1(r) - \phi_1(-r) = p \,, \quad \Delta \phi_2 = \phi_2(r) - \phi_2(-r) = 2\pi (n_2 - \gamma J) \,, \tag{2.8}
$$

where $\gamma \equiv \gamma_3$, $J \equiv J_1$. As a result the dispersion relation for the finite J γ -deformed giant magnon depends on p, J and $\delta \equiv 2\pi (n_2 - \gamma J)$. To find the dispersion relation one can either use the conformal gauge[[29](#page-20-0)] or the light-cone gauge[[30\]](#page-20-0).

Let us also mention that in the case where the deformation parameters satisfy the relations $\gamma_i = c k_i$ where c is any real number and k_i are arbitrary integers, there is another family of BPS states with the following charges[[28\]](#page-19-0)

$$
J_i = k k_i \sim \gamma_i \,, \tag{2.9}
$$

where (in quantum theory) k is any integer. In particular, in the supersymmetric case $\gamma_i = \gamma$ the BPS states are the states $(J/3, J/3, J/3)$ with three equal charges. Since $J_i \sim \gamma_i$ for these BPS states the twists ν_i vanish and both the γ -deformed giant magnon and its TsT image satisfy the same twisted boundary conditions which take the simplest form in terms of the following new angle variables and their conjugate momenta

$$
\psi_1 = k_1 \phi_1 + k_2 \phi_2 + k_3 \phi_3, \qquad \pi_1 = \frac{p_1 + p_2 + p_3}{k_1 + k_2 + k_3}, \tag{2.10}
$$

$$
\psi_2 = k_1 \phi_1 - (k_1 + k_3)\phi_2 + k_3 \phi_3, \qquad \pi_2 = \frac{k_2 p_1 - k_1 p_2}{k_1 (k_1 + k_2 + k_3)}, \tag{2.11}
$$

$$
\psi_3 = k_1 \phi_1 + k_2 \phi_2 - (k_1 + k_2) \phi_3, \qquad \pi_3 = \frac{k_3 p_1 - k_1 p_3}{k_1 (k_1 + k_2 + k_3)}.
$$
 (2.12)

Then, the giant magnon solution with the charges satisfying (2.9) satisfies the following boundary conditions

$$
\Delta \psi_1 = p, \quad \Delta \psi_2 = 0, \quad \Delta \psi_3 = 0. \tag{2.13}
$$

Since the boundary conditions do not depend on γ_i in the classical theory the dispersion relation for the giant magnon does not depend on the deformation parameters either. A disadvantage of this giant magnon solution is that the corresponding Bethe ansatz is not known.

3. Finite J dispersion relation

To determine the dispersion relation we impose the conformal gauge $\gamma^{\alpha\beta} = \text{diag}(-1, 1)$, set $t = \tau$, and use the following parametrization of S^3

$$
x_i^2 = 1, \ x_1 + ix_2 = \rho_1 e^{i\phi_1}, \ x_3 + ix_4 = \rho_2 e^{i\phi_2}, \ \rho_2^2 = 1 - \rho_1^2 = \chi. \tag{3.1}
$$

Then the sigma model action for strings on $R \times S^3$ takes the following form

$$
S = -\frac{g}{2} \int_{-r}^{r} d\sigma d\tau \left(\frac{\partial_{\alpha} \chi \partial^{\alpha} \chi}{4\chi (1-\chi)} + (1-\chi) \partial_{\alpha} \phi_1 \partial^{\alpha} \phi_1 + \chi \partial_{\alpha} \phi_2 \partial^{\alpha} \phi_2 \right).
$$

and solutions of the equations of motion should also satisfy the Virasoro constraints

$$
\frac{\dot{\chi}^2 + {\chi'}^2}{4\chi(1-\chi)} + (1-\chi)\left(\dot{\phi}_1^2 + \phi_1'^2\right) + \chi\left(\dot{\phi}_2^2 + \phi_2'^2\right) = 1, \tag{3.2}
$$

$$
\frac{\dot{\chi}\chi'}{4\chi(1-\chi)} + (1-\chi)\dot{\phi}_1\phi'_1 + \chi\dot{\phi}_2\phi'_2 = 0.
$$
 (3.3)

Since $t = \tau$ the range of σ is related to the space-time energy E of a solution as follows

$$
2r = \frac{E}{g} \equiv \mathcal{E} \,. \tag{3.4}
$$

The two charges $J_1 \equiv J$ and J_2 corresponding to shifts of ϕ_1 and ϕ_2 are

$$
J = g \int_{-r}^{r} d\sigma (1 - \chi) \dot{\phi}_{1}, \quad J_{2} = g \int_{-r}^{r} d\sigma \chi \dot{\phi}_{2}.
$$
 (3.5)

As was discussed in the previous section, the γ -deformed giant magnon solution has only one nonvanishing charge J, and the angles ϕ_1 and ϕ_2 satisfy the following twisted boundary conditions

$$
\Delta \phi_1 = \phi_1(r) - \phi_1(-r) = p, \quad \Delta \phi_2 = \phi_2(r) - \phi_2(-r) = \delta, \tag{3.6}
$$

where $\delta = 2\pi (n_2 - \gamma J)$, $\gamma = \gamma_3$ and n_2 is the winding number in the φ_2 direction of the deformed S^5_γ . It is worth mentioning that the dependence on γ and n_2 comes only through their linear combination δ which in fact plays the role of the deformation parameter.

The problem of finding a finite J giant magnon solution is thus basically equivalent to the problem of finding a two-spin giant magnon solution discussed in appendix C of [\[30\]](#page-20-0), and can be solved by using a similar ansatz

$$
\phi_1(\sigma,\tau) = \omega\tau + \frac{p}{2r}(\sigma - \nu\tau) + \phi(\sigma - \nu\tau), \qquad (3.7)
$$

$$
\phi_2(\sigma,\tau) = \nu\tau + \frac{\delta}{2r}(\sigma - v\tau) + \alpha(\sigma - v\tau), \qquad (3.8)
$$

$$
\chi(\sigma,\tau) = \chi(\sigma - v\tau),\tag{3.9}
$$

where $\chi(\sigma)$, $\phi(\sigma)$ and $\alpha(\sigma)$ satisfy the periodic boundary conditions.

Substituting the ansatz into the equations of motion, integrating the equations for ϕ and α once, and using the Virasoro constraint (3.2), we get the following three equations

$$
\phi' = f_0 + \frac{f_1}{1 - \chi}, \quad \alpha' = a_0 + \frac{a_1}{\chi}, \tag{3.10}
$$

$$

where the constants in the equations are functions of $\omega, \nu, v, p, \delta$, and $\chi_{\text{neg}}, \chi_{\text{min}}, \chi_{\text{max}}$ are ordered as $\chi_{\text{neg}} \leq 0 \leq \chi_{\text{min}} < \chi_{\text{max}}$. Moreover, giant magnon solutions exist only if $\chi_{\text{max}} \leq 1$ and for these solutions $\chi_{\text{min}} \leq \chi \leq \chi_{\text{max}}$, see Appendix for detail.

If the deformation parameter δ goes to 0 then χ_{neg} , a_0 , a_1 approach 0 too, and we recover the equations of motion for a finite J undeformed giant magnon [\[30](#page-20-0)].

For any value of δ we can always choose the initial conditions so that $\chi(\sigma)$ is an even function and $\phi(\sigma)$ and $\alpha(\sigma)$ are odd functions of σ , and since they are also periodic functions, we can always look for a solution satisfying the following boundary conditions

Due to the conditions we can restrict our attention to the half of the string from $-r$ to 0, and since χ is an increasing function on this interval we can also replace integrals over σ by integrals over χ from χ_{min} to χ_{max} . Then a solution is completely determined by the following five equations which are analyzed in detail in Appendix

The dispersion relation in the γ -deformed model reduces in the limit $\delta \to 0$ (or $\Phi \rightarrow 0$ $\Phi \rightarrow 0$ $\Phi \rightarrow 0$) to the one obtained in [[30](#page-20-0)].

Some remarks are in order.

- 1. We see that in the limit $\mathcal{J} \to \infty$ the dispersion relation is independent of the deformation parameter. This is contrary to papers[[40, 41](#page-20-0)] where it was claimed that the momentum is shifted by the deformation parameter $2\pi\gamma$. As was discussed in the previous section, $2\pi\gamma$ is identified with $\hat{\gamma}/g$, and therefore the shift by γ cannot be seen in classical theory in any case. It would be a one-loop effect, and the discussion in the Introduction indicates that the momentum p is not shifted at one loop at all but one should take into account that in quantum theory magnons carry other charges of order one, and therefore $p = \Delta \phi_1$ is not equal to $p_{ws} = \Delta \varphi_1$. According to [\(2.7](#page-5-0)), if we have several (or just one) magnons with the total charges J_2, J_3 then the momenta are related as $p = p_{\text{ws}} + 2\pi \gamma_3 J_2 - 2\pi \gamma_2 J_3$. If the state is physical then the total world-sheet momentum p_{ws} should vanish leading to the condition $p = 2\pi \gamma_3 J_2 - 2\pi \gamma_2 J_3$ (up to an integer multiple of 2π). This condition is equivalent to the cyclicity constraint in the twisted Bethe ansatz [\[5](#page-18-0)].
- 2. Since $\cos \Phi < 1$ the energy of a γ -deformed magnon is higher than the energy of the undeformed one with the same momentum and charge. That is what one should expect because the deformed theory has less supersymmetry.
- 3. The derivation of the dispersion relation performed in Appendix shows that a giant magnon solution exists only if Φ satisfies the restriction

and therefore if we require a solution to exist for all values of p from $-\pi$ to π the parameter δ must also satisfy the same restriction

We see that for any γJ there is only one integer n_2 which satisfies the condition, and therefore there is only one deformation of a giant magnon solution in $R \times S^2$. If the fractional part of γJ is less than $1/2$ then n_2 is equal to the integer part of γJ , and if the fractional part of γJ is greater than $1/2$ then n_2 is equal to the integer part of $\gamma J + 1$.

4. For small enough values of p however the first-order perturbation theory in $e^{-\frac{J}{\sin(p/2)}}$ allows one to have two or three integers satisfying the restriction [\(3.15](#page-10-0)): n_2 satisfying ([3.16\)](#page-10-0), and $n_2 \pm 1$. We expect that the latter possibilities will be ruled out at higher orders of the perturbation theory. Anyway, according to [\(3.13\)](#page-10-0) their energies would be higher than the energy of the main solution.

We have called the real roots of the equation $\chi_{\text{neg}}, \chi_{\text{min}}, \chi_{\text{max}}$ with the following ordering $\chi_{\text{neg}} \leq 0 \leq \chi_{\text{min}} < \chi_{\text{max}}$. Moreover, for the consistency of our approach we have to require that $\chi_{\text{min}}, \chi_{\text{max}} \in [0, 1)$, which will be justified by the solution. The fact that in the large J expansion one of the roots is negative can be easily proven. Indeed, in the strict $J \to \infty$ limit it follows from the work [\[30](#page-20-0)] that $\omega = 1$, $\nu = 0$, thereforethe leading coefficient κ_3 of the polynomial in the r.h.s. of ([A.7\)](#page-12-0) is negative, and this should remain true for large J. The value of the r.h.s. of [\(A.7\)](#page-12-0) at $\chi = 0$ is $\kappa_0 \leq 0$. These two facts together imply that there's a negative root χ_{neg} . Note also that the value of the r.h.s. of [\(A.7\)](#page-12-0) at $\chi = 1$ is $-v^2 A_1^2 < 0$. ³The purpose of introducing the variable ϵ should be clear — then the moduli of all tori in our expressions become $1 - \epsilon$. The purpose of introducing \tilde{v} is the following: the first parameter of the II-function in (A.26) becomes $\frac{\tilde{v}^2-1}{\tilde{v}^2}(1-\epsilon)$, so that it is in direct correspondence with an analogous parameter in the work[[30\]](#page-20-0).

We substitute (A.27) into our equations and expand these equations in ϵ^m , ignoring terms with logarithms (that is, treating any combination $\left(\sum_{n=1}^{n}$ $_{k=0}$ $a_k(\log \epsilon)^k$ ϵ^m as just ϵ^m). Then we obtain a system of equations for our "coefficient" functions, which, when solved, exhibits the property of these functions mentioned above — that is, they're terminating series in powers of $\log \epsilon$.

In the course of expanding the above written equations we need an expansion for $\Pi(1-\alpha\epsilon, 1-\epsilon)$ as $\epsilon \to 0$ (α fixed and $0 < \alpha < 1$). To find such an expansion we make use of the following textbook identity for elliptic functions:

Accordingto our ansatz ([A.27](#page-15-0)) $\alpha(\epsilon)$ has a finite positive limit smaller than 1 as $\epsilon \to 0$ — this is the only thing, which is important for our expansions to be justified. That is, we plug the expansion of α in (powers and logarithms of) ϵ into the expansion for $\Pi(1 − α ε, 1 − ε)$ obtained at fixed α.

\epsilon(J) = \frac{16}{e^2} e^{-\frac{\mathcal{J}}{\sin\frac{p}{2}}} \left[1 - \frac{8}{e^2} e^{-\frac{\mathcal{J}}{\sin\frac{p}{2}}} \left(1 - \mathcal{J} \frac{2 - 3\sin^2\frac{p}{2}}{2\sin\frac{p}{2}} \cos(\Phi) - \frac{1}{2} \mathcal{J}^2 \cot^2\frac{p}{2} \cos\Phi \right) + \dots \right].
$$

We now write out explicitly the expansions of the parameters entering the equations of motion:

and the solution exists for all $p \in [-\pi, \pi]$ (if and) only if

This means that for the undeformed $AdS_5 \times S^5$, that is $\gamma = 0$, the only possible choiceis $n_2 = 0$, or $\delta = 0$. In this case all formulas reduce to what was found in [[30](#page-20-0)]. To obtain the dispersion relation one should expand [\(A.19](#page-13-0)) with respect to ϵ and thensubstitute the expansion ([A.34\)](#page-16-0) of ϵ in terms of J. The dispersion relation with the first correction has the following form:
