Anisotropic memory effects in confined colloidal diffusion

The motion of an optically trapped sphere constrained by the vicinity of a wall is investigated at times where hydrodynamic memory is significant. First, we quantify, in bulk, the influence of confinement arising from the trapping potential on the sphere's velocity autocorrelation function $C(t)$. Next, we study the splitting of $C(t)$ into $C_{\parallel}(t)$ and $C_{\perp}(t)$, when the sphere is approached towards a surface. Thereby, we monitor the crossover from a slow $t^{-3/2}$ long-time tail, away from the wall, to a faster $t^{-5/2}$ decay, due to the subtle interplay between hydrodynamic backflow and wall effects. Finally, we discuss the resulting asymmetric time-dependent diffusion coefficients.

Understanding and controlling the transport of colloidal microcarriers, such as membrane vesicles, through a fluid is one of the main challenges in cell biology $[1]$, and related lab-on-ahip approa
hes. With the miniaturization of such technologies, particularly microfluidics [2], the colloid's motion is increasingly confined, and the influence of boundaries, e.g. a channel wall, becomes nonnegligible. In particular, in a system as small as a cell, many obstacles will alter the trajectory of a diffusing parti
le. Any deviation from its well-understood free Brownian motion, will give information on the parti
le's surroundings. The reduction of a colloid's mobility close to a wall, also known as 'surface confinement', was already predicted by Lorentz in 1907 $[3, 4]$ $[3, 4]$, and is expected to entail drastic effects on its time-dependent Brownian motion arising from the thermal fluctuations in the system.

Experimental evidences for this wall effect are comparably re
ent, and onsist mostly in measuring hanges in the diffusion coefficient D of a micron-sized sphere approaching a surface $[5, 6, 7]$ $[5, 6, 7]$ $[5, 6, 7]$ $[5, 6, 7]$ or being confined between two walls [8]. Measurements confirm that an interface inreases the steady-state fri
tion, hen
e the vis
ous drag on the particle, slowing down its diffusion as the distance h between the sphere's center and the surface is reduced. The motion becomes anisotropic in the directions parallel and perpendicular to the wall. Conventional data a
quisition and analysis rely on Lorentz's zero-frequency approximation for the mobility, which only takes a viscous contribution from the fluid into acount. However, for a neutrally buoyant sphere, the presen
e of hydrodynami memory due to momentum conservation in the fluid $[9, 10, 11]$ $[9, 10, 11]$ $[9, 10, 11]$ $[9, 10, 11]$ leads to it having a significantly delayed dynamic behavior, at time scales mu
h larger than the parti
le's momentum relaxation time $\tau_{\rm p} = 2a^2 \rho_{\rm p}/9\eta$. This memory has been observed in bulk for colloidal suspensions $[12, 13]$ $[12, 13]$ $[12, 13]$ $[12, 13]$, and, more recently, directly for a single microsphere $[14, 15]$ $[14, 15]$. Its origin

lies in the back-flow that a spherical particle of density $\rho_{\rm p}$ and radius a creates in a fluid of viscosity η and density ρ_f . The long time diffusion of momentum in the viscous fluid leads to an algebraic decay, the so-called long-time tail, in the velocity autocorrelation function (VACF) $C(t) = \langle v(t)v(0) \rangle \simeq D\sqrt{\tau_f/4\pi}t^{-3/2}$ of the fluctuating sphere at times $t \gtrsim \tau_{\rm f} = \rho_{\rm f} a^2/\eta$, the time needed by the perturbed fluid flow field to diffuse over the distan
e of one parti
le radius. Obviously, the presen
e of a wall bounding the fluid will affect the fluid vortex once it has encountered the wall, which will occur at times larger than its propagation time, $\tau_w = h^2 \rho_f / \eta$, from the particle to the boundary [16].

In this Letter, we investigate the effect of hydrodynamic vortex diffusion on the nature of the long-time tail as a function of the wall-particle distance h , by measuring the position fluctuations of a single spherical particle approaching a hard surface. Weak optical trapping [\[17](#page-3-17)] is employed to position a sili
a sphere relative to a plain glass surfa
e, and, at the same time, to tra
k the Brow-nian particle's trajectory interferometrically [\[18](#page-3-18)] with a pre
ision better than 1 nm and a time resolution of 2 µs [14]. The optical trap is created by focusing a $20\times$ expanded Nd-YAG beam ($\lambda = 1064 \text{ nm}$) by a 63 \times waterimmersion objective lens $(NA=1.2)$. The thermal position fluctuations of the sphere in the weak trap are measured with an InGaAs quadrant photodiode, amplified and digitized (12 bits). The position signal is recorded during $t_s = 20$ s with a sampling rate $f_s = 500$ kHz corresponding to $N = 10^7$ data points. The Brownian particle used here is a sili
a sphere of several mi
rometers diameter $(\rho_{\rm p} = 1.96 \,\text{g/cm}^3)$ immersed in water $(\rho_{\rm f} = 1 \,\text{g/cm}^3)$ $\eta = 10^{-3}$ Pa·s). It is gradually approached towards the surface of a 100 µm-sized sphere sandwiched between the two coverslides of a fluid chamber (size $\approx 2 \text{ cm } \times 0.5 \text{ cm}$) and thickness $\approx 100 \text{ µm}$. As illustrated in Fig. 1, the big sphere can be considered as a flat surface on the scale of

our Brownian sphere. Such a configuration circumvents the draw-ba
k of the lower resolution along the opti
al axis z, intrinsic to optical trapping interferometry $[19]$, thereby allowing measurements with comparable accuracy in both directions, parallel and perpendicular to the boundary. The small sili
a spheres are suspended in water at a low enough on
entration to allow trapping and observation of one isolated parti
le. The sample is mounted onto a piezo-stage, and the 100 µm sphere can be positioned at a distance h relative to the trapped parti
le by moving the piezo-stage in all three dimensions with a precision of ≈ 1 nm.

As a first test of the sensitivity of our set-up, we measure the VACF for a microsphere $(a = 2.25 \,\mu\text{m})$. $\tau_{\rm p} = 2.2 \,\text{\upmu s}, \tau_{\rm f} = 5.1 \,\text{\upmu s}$ far away from any boundaries $(h \geq 40 \,\text{\mu m})$. The optical trap is particularly well-suited for the experiment, as its harmoni potential results in a linear force $F = -kx(t)$, which only acts on the particle, but does not confine the surrounding fluid. The spring constant k of the trap gives rise to a new time scale $\tau_{\mathbf{k}} = 6\pi \eta a/k$. A model for the Brownian motion of a particle in a harmonic potential is provided by Clercx and Schramm [\[20](#page-3-20)], who went beyond a simple Stokes approximation by using the time-dependant linearized Navier-Stokes equation to describe the fluid motion. Fig. [2](#page-1-1) shows the measured normalized velocity autocorrelation function $C(t)/C(0)$ for $k = 19 \mu N/m$ and $k = 5 \mu N/m$. In order to ompare data with the theoreti
al urves, the normalization $C(0)$ and k are treated as fit parameters. As can be seen in Fig. [2,](#page-1-1) our data follow the theoretical prediction [\[20](#page-3-20)] over the full time range, down to a noise level of $5 \cdot 10^{-5}$. As was shown earlier [22], an intermediate time window $\tau_f \lesssim t \lesssim \tau_k/20$ opens, where the

le's motion an still be observed, but is free from the influence of the trap and mainly dominated by the fluid's inertia. Hence, in order to minimize influences from the trapping potential on the Brownian motion and resolve hydrodynamic memory effects, we adjust τ_k to be as long as possible. By de
reasing the spring onstant from $\tilde{k} = 19 \mu N/m$ to $k = 5 \mu N/m$, we directly observe the emergence of the long-time anomaly $t^{-3/2}$ (Fig. [2\)](#page-1-1) over two de
ades in signal, whi
h has not been previously reported in the literature. In an in
ompressible liquid, the initial value of the VACF is determined by $C(0) = \langle v(0)v(0) \rangle = k_B T /(\frac{4\pi}{3}a^3(\rho_p + \frac{1}{2}\rho_f))$ [\[21](#page-3-22)], leading

$$
\frac{C(t)}{C(0)} \simeq B\left(\frac{t}{\tau_{\rm f}}\right)^{-3/2}, \qquad t \gtrsim \tau_{\rm f}, \tag{1}
$$

where the amplitude $B = (\rho_p/\rho_f + 1/2)/9\sqrt{\pi}$ depends only on the mass ratio. The value of the prefactor is of the order $B \sim 1/10$ for the colloidal system used here, and can be directly read off the data at $t = \tau_f$ (Fig. [2\)](#page-1-1). At longer times, $t \gg \tau_{k}$ ($t = 22$ ms for $k = 19 \,\text{\textmu N/m}$ and $t = 96$ ms for $k = 5 \,\text{\mu N/m}$, the fluid's inertia is expected to generate a second zero in $C(t)$ followed by a fast $t^{-7/2}$ -tail as $(15B/4)(t/\tau_f)^{-3/2}(t/\tau_k)^{-2}$, which, however remains unobservable due to noise.

Next, we approach the Brownian sphere $(a = 1.5 \,\mu\text{m})$, $\tau_{\rm p} = 1 \,\text{\mu s}, \tau_{\rm f} = 2.25 \,\text{\mu s}$ towards the boundary created by the $100 \,\mu \text{m}$ glass sphere (Fig. [1\)](#page-1-0), and vary h from $37.8 \,\mathrm{\upmu m}$ to 4.8 $\mathrm{\upmu m}$, corresponding to a reduction in τ_{w} from $1400 \,\mu s$ to $23 \,\mu s$. The trap stiffness is minimized to $k \approx 2 \mu N/m$ ($\tau_k = 14 \,\text{ms}$) by lowering the incoming laser power. It is worth noting that decreasing k degrades the signal-to-noise level, as an be seen in the increase of the error bars in Fig. [2.](#page-1-1) As already mentioned above, momentum from the fluid is transferred to the wall at times $t \geq \tau_{w}$. The leading hydrodynamic tail $t^{-3/2}$ in $C(t)$ is then canceled, and $C(t)$ splits into $C_{\parallel}(t)$ for the motion parallel and $C_{\perp}(t)$ for the motion perpendicular to the wall. Recently, Felderhof [16] provided a full analyti
al solution for the motion in both directions. He generalized the frequency-dependent admittance *(i.e.* the frequency-dependent mobility) for the unconstrained motion $\mathcal{Y}_0(\omega)$ [\[11](#page-3-11)] to $\mathcal{Y}_\parallel(\omega)$ and $\mathcal{Y}_\perp(\omega)$ for a point particle moving close to a w**A\$fra&ebplacements** the fluctuation-dissipation theorem $[21]$, he then calculated $C_{\parallel}(t)$ and $C_{\perp}(t)$ via a Fourier-back-transform from $\mathcal{Y}_{\parallel}(\omega)$ and $\mathcal{Y}_{\perp}(\omega)$. For the parallel motion, a more rapid but still algebrai de
ay is predi
ted

$$
\frac{C_{\parallel}(t)}{C_{\parallel}(t)} \simeq \frac{3B}{2} \frac{\tau_{\rm w}}{\tau_{\rm f}} \left(\frac{t}{\tau_{\rm f}}\right)^{-5/2},\qquad (2)
$$

for $t \gtrsim \tau_{\rm w}$, provided that the wall is not too close; $\tau_{\rm w} \gg$ τ_f , τ_p . For the motion perpendicular to the wall, the longtime behavior, $t \geq \tau_{\rm w}$, is predicted, to leading order in a/h , as

$$
\frac{C_{\perp}(t)}{C_{\perp}(0)} \simeq \frac{3B}{2} \left[A_{z3} \left(\frac{t}{\tau_{\rm f}} \right)^{-5/2} + \frac{\tau_{\rm w}^2}{4\tau_{\rm f}^2} \left(\frac{t}{\text{RS}H}\right)^{-7/2} \right] \tag{3}
$$

where $A_{z3} = (2\rho_{\rm p}/\rho_{\rm f} - 5)/9$.

To disentangle surface confinement from the trap constraint, we extend Felderhof's theoretical approach [16], by including the optical trapping force [\[23](#page-3-23)]. In bulk, the harmonic potential modifies $\mathcal{Y}_0(\omega)$ [11] to $\mathcal{Y}_k(\omega)$ = $[\mathcal{Y}_0(\omega)^{-1} - k/\mathrm{i}\omega]^{-1}$ [20]. Accordingly, in the presence of a wall, the admittances $\mathcal{Y}_{\parallel,\perp}(\omega)$ have to be modified to $[\mathcal{Y}_{\parallel,\perp}(\omega)^{-1} - k/\mathrm{i}\omega]^{-1}$, and a suitable Fourier algorithm yields the VACFs in the entire time domain, whi
h is fitted to our data.

Figure [3](#page-2-0) shows the normalized $C_{\parallel}(t)$ and $C_{\perp}(t)$, in the time range $\tau_f < t < \tau_k/20 = 0.7$ ms, at four different distan
es from the wall. Far away from the boundary, at $h = 37.8 \,\mathrm{\upmu m}$, we observe the same $t^{-3/2}$ power-law for both dire
tions (Fig. [3a](#page-2-0)). However, as soon as the sphere reaches the proximity of the wall, and τ_w falls into our window of observation, $C(t)$ splits due to the hydrody-namic interaction with the wall (Fig. [3b](#page-2-0), $h = 9.8 \,\text{\mu m}$, and $\tau_{\rm w} = 96 \,\mu s$. Our data show clearly that the anisotropy increases even more as h is further decreased (Fig. 3c) and d). The higher noise floor at smaller h probably results from s
attering of the highly divergent trapping laser beam by the big sphere. In $C_{\parallel}(t)$, a transition from the free bulk behavior at $h = 37.8 \,\mu \text{m}$, characterized by the $t^{-3/2}$ power-law (Fig. [3a](#page-2-0)), to confined motion, with a steeper, $t^{-5/2}$ power-law arises in the data at $t \simeq \tau_{\rm w}$. The effective amplitude in Eq. [\(2\)](#page-2-1) is reduced

by up to 30% due to the trap. The drop to negative values in $C_{\parallel}(t)$ arises from anticorrelations imposed by the harmonic trapping potential, and can only be captured by our extended theory [23]. As can be inferred from Figs. [3,](#page-2-0) the theoreti
al urves des
ribe the data down to the noise level. For the perpendicular motion, the prefactor A_{z3} of the leading $t^{-5/2}$ -term in Eq. [\(3\)](#page-2-2) depends on the relative densities, and is negative in our experiment, $A_{z3} = -0.12$. Hence, for $k = 0$, a sign change is expected at $t \simeq -\tau_w^2/4\tau_f A_{z3} = 1890, 8.53, 1.96,$ and 0.49 ms. According to Eq. [\(3\)](#page-2-2), a positive tail $t^{-7/2}$ should dominate in the time window $\tau_{w} \lesssim t \ll \tau_{w}^{2}/\tau_{f}$. However, the sign change in $C_{\perp}(t)$ is observed to occur much

earlier, even though the trapping potential is minimal. Nevertheless, for the two closest distances (Fig. 3c and d), the steeper de
ay is ompatible with the intermediate power law $t^{-7/2}$ predicted by Eq. [\(3\)](#page-2-2), but with an amplitude reduced to 50% by the trap. This influence from the trap as well as noise also obs
ure the rossover from the positive $t^{-7/2}$ to the negative $t^{-5/2}$ tail.

In general the fits in Fig. [3](#page-2-0) are not very sensitive to the spring constant k . Therefore, we determine its value by omparing our data to the long-time behavior of the time-dependent diffusion coefficients, $D_{\parallel,\perp}(t)$ = $\int_0^t C_{\parallel,\perp}(t') {\rm d}t'$, shown in Fig. [4.](#page-3-25) As can be inferred from Fig. [4,](#page-3-25) the suppression of diffusion becomes anisotropic and follows the point-particle prediction by Lorentz $[3]$ $[3]$,

$$
D_{\parallel} = D[1 - 9a/16h], \qquad D_{\perp} = D[1 - 9a/8h], \quad (4)
$$

where $D = k_B T / 6\pi \eta a$ is the diffusion constant in bulk. The higher orders in a/h a/h are known to contribute less than 2% for $h/a > 3$ [4], and our data analysis suggests that the point-parti
le limit is also valid for the timedependent motion with similar accuracy. The observed zerorossings in the VACF translate into shallow maxima in the diffusion coefficients. They are still up to 5% below the asymptotic values D_{\parallel} and D_{\perp} , expected for $k = 0$, which exemplifies that free Brownian motion is not attained in optical trapping of micron-sized spheres, even for times $t \lesssim \tau_{k}$. At longer times the trap dominates and reduces the diffusion coefficients to zero (not shown).

In conclusion, we provide high precision experimental data relying on optical trapping interferometry which validate re
ent theoreti
al models. This approa
h gives access to the study of diffusion effects at a boundary, which are particularly relevant in diffusion-mediated interactions. During such processes, structures, like a large protein or membrane, interact with each other. This sear
h for a potential intera
tion partner may be favored by the wall effect described here, as a fairly high mobility is preserved along the boundary, whereas diffusion away from the interaction partner is suppressed $[24]$.
