Fesenko reciprocity map

Abstract

In [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2), Fesenko has defined the non-abelian local reciprocity map for every totally-ramified arithmetically profinite (APF) Galois extension of a given local field K by extending the works of Hazewinkel $[8]$ and Neukirch-Iwasawa [\[15\]](#page-43-4). The theory of Fesenko extends the previous nonabelian generalizations of local class field theory given by Koch-de Shalit [\[13\]](#page-43-5) and by A. Gurevich [\[7\]](#page-43-6). In this paper, which is research-expository in nature, we give a detailed account of Fesenko's work, and include all the proofs that are skipped in [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2).

In a series of very interesting papers [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2), Fesenko has defined the nonabelian local reciprocity map for every totally-ramified arithmetically profinite (APF) Galois extension of a given local field K by extending the works of Hazewinkel [\[8\]](#page-43-3) and Neukirch-Iwasawa [\[15\]](#page-43-4). "Fesenko theory" extends the previous non-abelian generalizations of local class field theory given by Koch and de Shalit in [\[13\]](#page-43-5) and by A. Gurevich in [\[7\]](#page-43-6).

In this paper, which is research-expository in nature, we give a very detailed account of Fesenko's work [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2), thereby complementing them by including all the proofs. Let us describe how our paper is organized: In the first part, we briefly review abelian local class field theory and the construction of the local Artin reciprocity map following Hazewinkel method and Neukirch-Iwasawa method. In parts 3 and 4, following [\[4\]](#page-43-7), [\[5,](#page-43-8) [6\]](#page-43-9), and [\[17\]](#page-44-0), we review the theory of APF -extensions over K, and sketch the construction of Fontaine-Wintenberger's field of norms $\mathbb{X}(L/K)$ attached to an APF-extension L/K . In order to do so, in part 2, we briefly review the ramification theory of K . Finally, in part 5, we give a detailed construction of the Fesenko reciprocity map $\Phi_{L/K}^{(\varphi)}$ defined for any totally-ramified and APF-Galois extension L over K under the assumption that $\mu_p(K^{sep}) \subset K$, where $p = \text{char}(\kappa_K)$, and investigate the functorial and ramification-theoretic properties of the Fesenko reciprocity maps defined for totally-ramified and APF -Galois extensions over K .

In a companion paper [\[10\]](#page-43-10), we shall extend the construction of Fesenko to *any* Galois extension of K (in a fixed K^{sep}), and construct the non-abelian local class field theory. Thus, we feel that, the present paper together with [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2) should be viewed as the technical and theoretical background, an introduction, as well as an appendix to our companion paper [\[10\]](#page-43-10) on "generalized Fesenko theory".

A similar theory has been announced by Laubie in [\[14\]](#page-43-11), which is an extension of the work of Koch and de Shalit [\[13\]](#page-43-5). The relationship of Laubie theory with our generalized Fesenko theory will be investigated in our companion paper as well.

Notation

All through this work, K will denote a local field (a complete discrete valuation field) with finite residue field $O_K/\mathfrak{p}_K =: \kappa_K$ of $q_K = q = p^f$ elements with p a prime number, where O_K denotes the ring of integers in K with the unique maximal ideal \mathfrak{p}_K . Let ν_K denote the corresponding normalized valuation on K (normalized by $\nu_K(K^{\times}) = \mathbb{Z}$), and $\tilde{\nu}$ the unique extension of ν_K to a fixed separable closure K^{sep} of K. For any sub-extension L/K of K^{sep}/K , the normalized form of the valuation $\tilde{\nu}|_L$ on L will be denoted by ν_L . Finally, let G_K denote the absolute Galois group $Gal(K^{sep}/K)$.

1 Abelian local class field theory

Let K be a local field. Fix a separable closure K^{sep} of the local field K. Let G_K denote the absolute Galois group Gal(K^{sep}/K) of K. By the construction of absolute Galois groups, G_K is a pro-finite topological group with respect to the Krull topology. Now let G_K^{ab} denote the maximal abelian Hausdorff quotient group G_K/G'_K of the topological group G_K , where G'_K denotes the closure of the 1st-commutator subgroup $[G_K, G_K]$ of G_K .

Recall that, abelian local class field theory for the local field K establishes a unique natural algebraic and topological isomorphism

$$
\alpha_K : \widehat{K^\times} \xrightarrow{\sim} G_K^{ab},
$$

where the topological group $\widehat{K^{\times}}$ denotes the pro-finite completion of the multiplicative group K^{\times} , satisfying the following conditions

(1) Let W_K denote the Weil group of K. Then

$$
\alpha_K(K^\times) = W_K^{ab};
$$

(2) for every abelian extension L/K (always assumed to be a sub-extension of K^{sep}/K , where a separable closure K^{sep} of K is fixed all through the remainder of the text), the surjective and continuous homomorphism

$$
\alpha_{L/K} : \widehat{K^{\times}} \xrightarrow{\alpha_K} G_K^{ab} \xrightarrow{\text{res}_L} \text{Gal}(L/K)
$$

satisfies

$$
\ker(\alpha_{L/K}) = N_{L/K}(\widehat{L^{\times}}) = \bigcap_{\substack{K \subseteq F \subseteq L \\ \text{finite}}} N_{F/K}(\widehat{F^{\times}}) =: \mathcal{N}_L;
$$

(3) for each abelian extension L/K , the mapping

$$
L\mapsto \mathcal{N}_L
$$

defines a bijective correspondence

$$
\{L/K: \text{abelian}\} \leftrightarrow \{\mathcal{N}: \mathcal{N} \underset{\text{closed}}{\leq} \widehat{K^{\times}}\},
$$

which satisfies the following conditions: for every abelian extension L, L_1 , and L_2 over K ,

- (i) L/K is a finite extension if and only if $\mathcal{N}_L \leq K^{\times}$ (which is equivalent to $(\widehat{K^{\times}} : \mathcal{N}_L) < \infty$;
- (ii) $L_1 \subseteq L_2 \Leftrightarrow \mathcal{N}_{L_1} \supseteq \mathcal{N}_{L_2};$
- (iii) $\mathcal{N}_{L_1L_2} = \mathcal{N}_{L_1} \cap \mathcal{N}_{L_2};$
- (iv) $\mathcal{N}_{L_1 \cap L_2} = \mathcal{N}_{L_1} \mathcal{N}_{L_2}$.
- (4) (Ramification theory)^{[1](#page-2-0)}. Let L/K be an abelian extension. For every integer $0 \leq i \in \mathbb{Z}$ and for every real number $\nu \in (i-1, i],$

$$
x \in U_K^i \mathcal{N}_L \Leftrightarrow \alpha_{L/K}(x) \in \text{Gal}(L/K)^{\nu},
$$

where $x \in \widehat{K^{\times}}$.

- (5) (Functoriality). Let L/K be an abelian extension.
	- (i) For $\gamma \in \text{Aut}(K)$,

$$
\alpha_K(\gamma(x)) = \widetilde{\gamma}\alpha_K(x)\widetilde{\gamma}^{-1},
$$

for every $x \in \widetilde{K}^{\times}$, where $\widetilde{\gamma}: K^{ab} \to K^{ab}$ is any automorphism of the field K^{ab} satisfying $\tilde{\gamma} |_{K} = \gamma$;

(ii) under the condition $[L: K] < \infty$,

$$
\alpha_L(x) \mid_{K^{ab}} = \alpha_K(N_{L/K}(x)),
$$

for every $x \in \widehat{L^{\times}}$;

¹We shall review the higher-ramification subgroups $Gal(L/K)^{\nu}$ of $Gal(L/K)$ (in uppernumbering) in the next section.

(iii) under the condition $[L: K] < \infty$,

$$
\alpha_L(x) = V_{K \to L} (\alpha_K(x)),
$$

for every $x \in \overline{K^{\times}}$, where $V_{K\to L}: G_K^{ab} \to G_L^{ab}$ is the group-theoretic transfer homomorphism (Verlagerung).

This unique algebraic and topological isomorphism $\alpha_K : K^{\times} \to G_K^{ab}$ is called the *local Artin reciprocity map of* K.

There are many constructions of the local Artin reciprocity map of K including the *cohomological* and *analytical* constructions. Now, in the remainder of this section, we shall review the construction of the local Artin reciprocity map $\alpha_K : K^{\times} \to G_K^{ab}$ of K following Hazewinkel ([\[8\]](#page-43-3)) and Iwasawa-Neukirch ([\[12\]](#page-43-12), [\[15\]](#page-43-4)). As usual, let K^{nr} denote the maximal unramified extension of K. It is well-known that K^{nr} is not a complete field with respect to the valuation $\nu_{K^{nr}}$ on K^{nr} induced from the valuation ν_K of K. Let K denotes the completion of K^{nr} with respect to the valuation $\nu_{K^{nr}}$ on K^{nr} . For a Galois extension L/K , let $L^{nr} = LK^{nr}$ and $\tilde{L} = L\tilde{K}$. For each $\tau \in \text{Gal}(L/K)$, choose $\tau^* \in \text{Gal}(L^{nr}/K)$ in such a way that:

- (1) τ^* | $_L = \tau$;
- (2) $\tau^* \mid_{K^{nr}} = \varphi^n$, for some $0 \leq n \in \mathbb{Z}$, where $\varphi \in \text{Gal}(K^{nr}/K)$ denotes the (arithmetic) Frobenius automorphism of K.

Let the fixed-field $(L^{nr})^{\tau^*} = \{x \in L^{nr} : \tau^*(x) = x\}$ of this chosen $\tau^* \in$ $Gal(L^{nr}/K)$ in L^{nr} be denoted by Σ_{τ^*} , which satisfies $[\Sigma_{\tau^*}:K] < \infty$.

The Iwasawa-Neukirch mapping

$$
\iota_{L/K} : \text{Gal}(L/K) \to K^\times / N_{L/K}(L^\times)
$$

is then defined by

$$
\iota_{L/K}: \tau \mapsto N_{\Sigma_{\tau^*}/K}(\pi_{\Sigma_{\tau^*}}) \mod N_{L/K}(L^\times),
$$

for every $\tau \in \text{Gal}(L/K)$, where $\pi_{\Sigma_{\tau^*}}$ denotes any prime element of Σ_{τ^*} .

Suppose now that the Galois extension L/K is furthermore a totally-ramified and finite extension. Let $\widetilde{V}(L/K)$ be the subgroup of the unit group $U_{\widetilde{L}} = O_{\widetilde{L}}^{\times}$ Le of the ring of integers $O_{\widetilde{L}}$ of the local field \widetilde{L} defined by

$$
\widetilde{V}(L/K) = \left\langle u^{\sigma - 1} : u \in U_{\widetilde{L}}, \ \sigma \in \mathrm{Gal}(L/K) \right\rangle.
$$

Then the homomorphism

$$
\theta : \operatorname{Gal}(L/K) \to U_{\widetilde{L}}/V(L/K)
$$

defined by

$$
\theta: \sigma \mapsto \frac{\sigma(\pi_L)}{\pi_L} \mod \widetilde{V}(L/K),
$$

for every $\sigma \in \text{Gal}(L/K)$, makes the following triangle

commutative. The quotient $U_{\tilde{L}}/\tilde{V}(L/K)$ sits in the Serre short exact sequence

$$
1 \to \text{Gal}(L/K)^{ab} \xrightarrow{\theta_o} U_{\widetilde{L}} / \widetilde{V}(L/K) \xrightarrow{N_{\widetilde{L}} / \widetilde{K}} U_{\widetilde{K}} \to 1. \tag{1.1}
$$

Let $V(L/K)$ denote the subgroup of the unit group $U_{L^{nr}}$ of the ring of integers $O_{L^{nr}}$ of the maximal unramified extension L^{nr} of the local field L defined by

$$
V(L/K) = \langle u^{\sigma - 1} : u \in U_{L^{nr}}, \sigma \in \mathrm{Gal}(L/K) \rangle.
$$

The quotient $U_{L^{nr}}/V(L/K)$ sits in the Serre short exact sequence

$$
1 \to \text{Gal}(L/K)^{ab} \xrightarrow{\theta_o} U_{L^{nr}}/V(L/K) \xrightarrow{N_{L^{nr}/K^{nr}}} U_{K^{nr}} \to 1. \tag{1.2}
$$

As before, let $\varphi \in \text{Gal}(K^{nr}/K)$ denote the Frobenius automorphism of K. Fix any extension of the automorphism φ of K^{nr} to an automorphism of L^{nr} , denoted again by φ . Now, for any $u \in U_K$, there exists $v_u \in U_{L^{nr}}$, such that $u = N_{L^{nr}/K^{nr}}(v_u)$. Then, the equality

$$
N_{L^{nr}/K^{nr}}(\varphi(v_u)) = \varphi(N_{L^{nr}/K^{nr}}(v_u)) = \varphi(u) = u,
$$

combined with the Serre short exact sequence, yields the existence of $\sigma_u \in$ $Gal(L/K)^{ab}$ satisfying

$$
\theta_o(\sigma_u) = \frac{\sigma_u(\pi_L)}{\pi_L} = \frac{v_u}{\varphi(v_u)}.
$$

The Hazewinkel mapping

$$
h_{L/K}: U_K/N_{L/K}U_L \to \text{Gal}(L/K)^{ab}
$$

is then defined by

$$
h_{L/K}: u \mapsto \sigma_u,
$$

for every $u \in U_K$.

It turns out that, for L/K totally-ramified and finite Galois extension, the Hazewinkel mapping $h_{L/K}: U_K/N_{L/K}U_L \to \text{Gal}(L/K)^{ab}$ and the Iwasawa-Neukirch mapping $\iota_{L/K} : \text{Gal}(L/K) \to K^{\times}/N_{L/K}(L^{\times})$ are the inverses of each other. Thus, by the uniqueness of the local Artin reciprocity map $\alpha_K : \widehat{K^{\times}} \to$ G_K^{ab} of the local field K, it follows that the Hazewinkel map, the Iwasawa-Neukirch map, and the local Artin map are related with each other as

$$
h_{L/K} = \alpha_{L/K}
$$

and

$$
\iota_{L/K} = \alpha_{L/K}^{-1}.
$$

2 Review of ramification theory

In this section, we shall review the higher-ramification subgroups in uppernumbering of the absolute Galois group G_K of the local field K , which is necessary in the theory of APF -extensions over K. The main reference that we follow for this section is [\[16\]](#page-44-1).

For a finite separable extension L/K , and for any $\sigma \in \text{Hom}_K(L, K^{sep})$, introduce

$$
i_{L/K}(\sigma) := \min_{x \in O_L} \left\{ \nu_L(\sigma(x) - x) \right\},\,
$$

put

$$
\gamma_t := \# \left\{ \sigma \in \text{Hom}_K(L, K^{sep}) : i_{L/K}(\sigma) \ge t + 1 \right\},\
$$

for $-1 \le t \in \mathbb{R}$, and define the function $\varphi_{L/K} : \mathbb{R}_{\ge -1} \to \mathbb{R}_{\ge -1}$, the *Hasse-Herbrand transition function of the extension* L/K, by

$$
\varphi_{L/K}(u) := \begin{cases} \int_0^u \frac{\gamma_t}{\gamma_0} dt, & 0 \le u \in \mathbb{R}, \\ u, & -1 \le u \le 0. \end{cases}
$$

It is well-known that, $\varphi_{L/K} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}$ is a continuous, monotoneincreasing, piecewise linear function, and induces a homeomorphism $\mathbb{R}_{\geq -1} \xrightarrow{\approx}$ $\mathbb{R}_{\geq -1}$. Now, let $\psi_{L/K} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}$ be the mapping inverse to the function $\varphi_{L/K} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}.$

Assume that L is a finite Galois extension over K with Galois group $Gal(L/K) =$: G. The normal subgroup G_u of G defined by

$$
G_u = \{ \sigma \in G : i_{L/K}(\sigma) \ge u + 1 \}
$$

for $-1 \le u \in \mathbb{R}$ is called the u^{th} *ramification group of G in the lower numbering*, and has order γ_u . Note that, there is the inclusion $G_{u'} \subseteq G_u$ for every pair $-1 \leq u, u' \in \mathbb{R}$ satisfying $u \leq u'$. The family $\{G_u\}_{u \in \mathbb{R}_{\geq -1}}$ induces a filtration on G, called the *lower ramification filtration of* G. A *break in the lower ramification* $\text{filtration } \{G_u\}_{u \in \mathbb{R}_{\geq -1}}$ of G is defined to be any number $u \in \mathbb{R}_{\geq -1}$ satisfying $G_u \neq G_{u+\varepsilon}$ for every $0 < \varepsilon \in \mathbb{R}$. The function $\psi_{L/K} = \varphi_{L/K}^{-1} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}$ induces the *upper ramification filtration* $\{G^v\}_{v \in \mathbb{R}_{\geq -1}}$ on G by setting

$$
G^v := G_{\psi_{L/K}(v)},
$$

or equivalently, by setting

$$
G^{\varphi_{L/K}(u)}=G_u
$$

for $-1 \leq v, u \in \mathbb{R}$, where G^v is called the v^{th} *upper ramification group of G*. A *break in the upper filtration* $\{G^v\}_{v \in \mathbb{R}_{\geq -1}}$ of G is defined to be any number $v \in \mathbb{R}_{\ge -1}$ satisfying $G^v \ne G^{v+\varepsilon}$ for every $0 < \varepsilon \in \mathbb{R}$.

Remark 2.1*.* The basic properties of lower and upper ramification filtrations on G are as follows:

In what follows, F/K denotes a sub-extension of L/K and H denotes the Galois group $Gal(L/F)$ corresponding to the extension L/F .

(i) The lower numbering on G passess well to the subgroup H of G in the sense that

$$
H_u = H \cap G_u
$$

for $-1 \leq u \in \mathbb{R}$:

(ii) and if furthermore, $H \triangleleft G$, the upper numbering on G passess well to the quotient G/H as

$$
(G/H)^v = G^v H/H
$$

for $-1 \leq v \in \mathbb{R}$.

(iii) The Hasse-Herbrand function and its inverse satisfy the transitive law

$$
\varphi_{L/K} = \varphi_{F/K} \circ \varphi_{L/F}
$$

and

$$
\psi_{L/K} = \psi_{L/F} \circ \psi_{F/K}.
$$

If L/K is an *infinite* Galois extension with Galois group $Gal(L/K) = G$, which is a topological group under the respective Krull topology, define the upper ramification filtration $\{G^v\}_{v \in \mathbb{R}_{\geq -1}}$ on G by the projective limit

$$
G^v := \lim_{K \subseteq F \subset L} \text{Gal}(F/K)^v \tag{2.1}
$$

defined over the transition morphisms $t_F^{F'}(v)$: $Gal(F/K)^v \rightarrow Gal(F/K)^v$, which are essentially the restriction morphisms from F' to F , defined naturally by the diagram

induced from (ii), as $K \subseteq F \subseteq F' \subseteq L$ runs over all finite Galois extensions F and F' over K inside L. The topological subgroup G^v of G is called the v^{th} *ramification group of* G *in the upper numbering*. Note that, there is the inclusion $G^{v'} \subseteq G^v$ for every pair $-1 \leq v, v' \in \mathbb{R}$ satisfying $v \leq v'$ via the commutativity of the square

$$
\text{Gal}(F/K)^{v} \xleftarrow{t_F^{F'}(v)} \text{Gal}(F'/K)^{v}
$$
\n
$$
\text{in.}\begin{bmatrix}\text{inc.}\\ \text{Gal}(F/K)^{v'} \xleftarrow{t_F^{F'}(v')}\\ \text{Gal}(F'/K)^{v'}\end{bmatrix}\begin{bmatrix}\text{inc.}\\ \text{inc.}\\ \text{Gal}(F'/K)^{v'}\end{bmatrix}
$$
\n(2.3)

for every chain $K \subseteq F \subseteq F' \subseteq L$ of finite Galois extensions F and F' over K inside L. Observe that

- (iv) $G^{-1} = G$ and G^0 is the inertia subgroup of G ;
- $(v) \cap$ $v\in\mathbb{R}_{\geq -1}$ $G^v = \langle 1_G \rangle;$

(vi) G^v is a closed subgroup of G , with respect to the Krull topology, for $-1 \leq v \in \mathbb{R}$.

In this setting, a number $-1 \le v \in \mathbb{R}$ is said to be a *break in the upper ramification filtration* $\{G^v\}_{v \in \mathbb{R}_{> -1}}$ of G, if v is a break in the upper filtration of some finite quotient G/H for some $H \triangleleft G$. Let $\mathcal{B}_{L/K}$ denotes the set of all numbers $v \in \mathbb{R}_{\geq -1}$, which occur as breaks in the upper ramification filtration of G. Then,

- (vii) (Hasse-Arf theorem.) $\mathcal{B}_{K^{ab}/K} \subseteq \mathbb{Z} \cap \mathbb{R}_{\ge-1};$
- (viii) $\mathcal{B}_{K^{sep}/K} \subseteq \mathbb{Q} \cap \mathbb{R}_{>-1}$.

3 *APF*-extensions over K

In this section, we shall briefly review a very important class of algebraic extensions, called the APF -extensions, over a local field K introduced by Fontaine and Wintenberger (cf. [\[5,](#page-43-8) [6\]](#page-43-9) and [\[17\]](#page-44-0)). As in the previous section, let $\{G_K^v\}_{v \in \mathbb{R}_{\geq -1}}$ denote the upper ramification filtration of the absolute Galois group G_K of K , and let R^v denote the fixed field $(K^{sep})^{G_K^v}$ of the v^{th} upper ramification subgroup G_K^v of G_K in K^{sep} for $-1 \le v \in \mathbb{R}$.

Definition 3.1. An extension L/K is called an APF *-extension* (APF is the shortening for "arithmétiquement profinie"), if one of the following equivalent conditions is satisfied:

- (i) $G_K^v G_L$ is open in G_K for every $-1 \le v \in \mathbb{R}$;
- (ii) $(G_K: G_K^v G_L) < \infty$ for every $-1 \le v \in \mathbb{R}$;
- (iii) $L \cap R^v$ is a finite extension over K for every $-1 \le v \in \mathbb{R}$.

Note that, if L/K is an APF-extension, then $|\kappa_L : \kappa_K| < \infty$. Now, let L/K be an APF-extension. Set $G_L^0 = G_L \cap G_K^0$, and define

$$
\varphi_{L/K}(v) = \begin{cases} \int_0^v (G_K^0 : G_L^0 G_K^x) dx, & 0 \le v \in \mathbb{R}; \\ v, & -1 \le v \le 0. \end{cases}
$$
(3.1)

Then the map $v \mapsto \varphi_{L/K}(v)$ for $v \in \mathbb{R}_{\geq -1}$, which is well-defined for the APFextension L/K , defines a continuous, strictly-increasing and piecewise-linear bijection $\varphi_{L/K}: \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}$. We denote the inverse of this mapping by $\psi_{L/K} := \varphi_{L/K}^{-1} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}.$

Thus, if L/K is a (not necessarly finite) Galois APF -extension, then we can define the higher ramification subgroups in lower numbering $Gal(L/K)_u$ of $Gal(L/K)$, for $-1 \leq u \in \mathbb{R}$, by setting

$$
Gal(L/K)_u := Gal(L/K)^{\varphi_{L/K}(u)}.
$$

Remark 3.2*.* Note that,

(i) In case L/K is a finite separable extension, which is clearly an APF -extension by Definition [3.1,](#page-7-0) the function $\varphi_{L/K} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}$ coincides with the Hasse-Herbrand transition function of \overline{L}/K introduced in the previous section;

(ii) if L/K is a finite separable extension and L'/L is an APF -extension, then L'/K is an APF-extension, and the transitivity rules for the functions $\varphi_{L'/K}, \psi_{L'/K} : \mathbb{R}_{\geq -1} \to \mathbb{R}_{\geq -1}$ hold by

$$
\varphi_{L'/K} = \varphi_{L/K} \circ \varphi_{L'/L}
$$

and by

$$
\psi_{L'/K} = \psi_{L'/L} \circ \psi_{L/K}.
$$

The following result will be extremely useful.

Lemma 3.3. *Suppose that* $K \subseteq F \subseteq L \subseteq K^{sep}$ *is a tower of field extensions in* Ksep *over* K*. Then,*

- *(i)* If $[F: K] < \infty$, then L/K is an APF-extension if and only if L/F is an AP F*-extension.*
- *(ii)* If $[L : F] < \infty$, then L/K *is an APF*-extension *if and only if* F/K *is an* AP F*-extension.*
- *(iii)* If L/K *is an APF-extension, then* F/K *is an APF-extension.*

Proof. For a proof, look at Proposition 1.2.3. of [\[17\]](#page-44-0).

\Box

4 Fontaine-Wintenberger fields of norms

Let L/K be an *infinite APF*-extension. Let L_i for $0 \leq i \in \mathbb{Z}$ be an increasing directed-family of sub-extensions in L/K such that:

- (i) $[L_i:K] < \infty$ for every $0 \leq i \in \mathbb{Z}$;
- (ii) \bigcup $\bigcup_{0\leq i\in\mathbb{Z}}L_i=L.$

Let

$$
\mathbb{X}(L/K)^{\times} = \varprojlim_{i} L_{i}^{\times}
$$

be the projective limit of the multiplicative groups L_i^{\times} with respect to the norm homomorphisms ×

$$
N_{L_{i'}/L_i}: L_{i'}^\times \to L_i^\times,
$$

for every $0 \leq i, i' \in \mathbb{Z}$ with $i \leq i'$.

Remark 4.1. The group $X(L/K)^{\times}$ does not depend on the choice of the increasing directed-family of sub-extensions $\{L_i\}_{0\leq i\in\mathbb{Z}}$ in L/K satisfying the conditions (i) and (ii) . Thus,

$$
\mathbb{X}(L/K)^{\times} = \varprojlim_{M \in S_{L/K}} M^{\times},
$$

where $S_{L/K}$ is the partially-ordered family of all finite sub-extensions in L/K , and the projective limit is with respect to the norm

$$
N_{M_2/M_1}:M_2^\times \rightarrow M_1^\times,
$$

for every $M_1, M_2 \in S_{L/K}$ with $M_1 \subseteq M_2$.

Put

$$
\mathbb{X}(L/K) = \mathbb{X}(L/K)^{\times} \cup \{0\},\
$$

where 0 is a fixed symbol, and define the addition

$$
+ : \mathbb{X}(L/K) \times \mathbb{X}(L/K) \to \mathbb{X}(L/K)
$$

by the rule

$$
(\alpha_M)+(\beta_M)=(\gamma_M),
$$

where $\gamma_M \in M$ is defined by the limit

$$
\gamma_M = \lim_{\substack{M \subset M' \in S_{L/K} \\ [M':M] \to \infty}} N_{M'/M}(\alpha_{M'} + \beta_{M'}),\tag{4.1}
$$

which exists in the local field M, for every $M \in S_{L/K}$. *Remark* 4.2. Note that, for (α_M) , $(\beta_M) \in \mathbb{X}(L/K)$, the law of composition

 $((\alpha_M),(\beta_M)) \mapsto (\alpha_M) + (\beta_M) = (\gamma_M)$

given by eq. [\(4.1\)](#page-9-0) is well-defined, since L/K is assumed to be an APF -extension (cf. Theorem 2.1.3. of [\[17\]](#page-44-0)).

It then follows that,

Theorem 4.3 (Fontaine-Wintenberger). Let L/K be an APF-extension. Then X(L/K) *is a field under the addition*

$$
+ : \mathbb{X}(L/K) \times \mathbb{X}(L/K) \to \mathbb{X}(L/K),
$$

defined by eq. [\(4.1\)](#page-9-0), and under the multiplication

$$
\times : \mathbb{X}(L/K) \times \mathbb{X}(L/K) \to \mathbb{X}(L/K)
$$

defined naturally from the componentwise multiplication defined on $\mathbb{X}(L/K)^{\times}$ *. This field* $X(L/K)$ *is called the field of norms corresponding to the APF-extension* L/K*.*

Now, in particular, choose the following specific increasing directed-family of sub-extensions $\{L_i\}_{0 \leq i \in \mathbb{Z}}$ in L/K :

(i) L_0 is the maximal unramified extension of K inside L ;

 \mathbf{Z}

- (ii) L_1 is the maximal tamely ramified extension of K inside L ;
- (iii) choose L_i , for $i \geq 2$, inductively as a finite extension of L_1 inside L with $L_i \subseteq L_{i+1}$ and $\bigcup_{0 \le i \in \mathbb{Z}} L_i = L.$

Note that, L_0/K is a finite sub-extension of L/K and by the definition of tamely ramified extensions, $L_0 \subseteq L_1$, with $[L_1 : K] < \infty$. Thus, for any element $(\alpha_{L_i})_{0 \leq i \in \mathbb{Z}}$ of $\mathbb{X}(L/K)$,

$$
\nu_{L_i}(\alpha_{L_i}) = \nu_{L_0}(\alpha_{L_0}),\tag{4.2}
$$

for every $0 \leq i \in \mathbb{Z}$. Thus, the mapping

$$
\nu_{\mathbb{X}(L/K)}:\mathbb{X}(L/K)\to\mathbb{Z}\cup\{\infty\}
$$

given by

$$
\nu_{\mathbb{X}(L/K)}\left((\alpha_{L_i})_{0\leq i\in\mathbb{Z}}\right)=\nu_{L_0}(\alpha_{L_0}),\tag{4.3}
$$

for $(\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \in \mathbb{X}(L/K)$, is well-defined, and moreover a discrete valuation on $\mathbb{X}(L/K)$, in view of eq. [\(4.2\)](#page-9-1).

Theorem 4.4 (Fontaine-Wintenberger). Let L/K be an APF-extension, and let $X(L/K)$ *be the field of norms attached to* L/K *. Then,*

- *(i)* the field $X(L/K)$ *is complete with respect to the discrete valuation* $\nu_{X(L/K)}$: $\mathbb{X}(L/K) \to \mathbb{Z} \cup {\infty}$ *defined by eq.* [\(4.3\)](#page-10-0);
- *(ii)* the residue class field $\kappa_{\mathbb{X}(L/K)}$ of $\mathbb{X}(L/K)$ satisfies $\kappa_{\mathbb{X}(L/K)} \xrightarrow{\sim} \kappa_L$;
- *(iii) the characteristic of the field* $\mathbb{X}(L/K)$ *is equal to char(* κ_K *).*

Proof. For a proof, look at Theorem 2.1.3 of [\[17\]](#page-44-0).

$$
\qquad \qquad \Box
$$

Remark 4.5. The ring of integers $O_{X(L/K)}$ of the local field (complete discrete valuation field) $\mathbb{X}(L/K)$ is defined as usual by

$$
O_{\mathbb{X}(L/K)} = \left\{ (\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \in \mathbb{X}(L/K) : \boldsymbol{\nu}_{\mathbb{X}(L/K)}\left((\alpha_{L_i})_{0 \le i \in \mathbb{Z}}\right) \ge 0 \right\}.
$$

Thus, by eq.s [\(4.3\)](#page-10-0) and [\(4.2\)](#page-9-1), for $\alpha = (\alpha_{L_i})_{0 \leq i \in \mathbb{Z}} \in \mathbb{X}(L/K)$, the following two conditions are equivalent.

- (i) $(\alpha_{L_i})_{0 \leq i \in \mathbb{Z}} \in O_{\mathbb{X}(L/K)}$;
- (ii) $\alpha_{L_i} \in O_{L_i}$ for every $0 \leq i \in \mathbb{Z}$.

The maximal ideal $\mathfrak{p}_{\mathbb{X}(L/K)}$ of $O_{\mathbb{X}(L/K)}$ is defined by

$$
\mathfrak{p}_{\mathbb{X}(L/K)} = \left\{ (\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \in \mathbb{X}(L/K) : \mathbf{\nu}_{\mathbb{X}(L/K)} \left((\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \right) \ge 0 \right\}.
$$

By eq.s [\(4.3\)](#page-10-0) and [\(4.2\)](#page-9-1), for $\alpha = (\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \in \mathbb{X}(L/K)$, the following two conditions are equivalent.

- (iii) $(\alpha_{L_i})_{0 \leq i \in \mathbb{Z}} \in \mathfrak{p}_{\mathbb{X}(L/K)}$;
- (iv) $\alpha_{L_i} \in \mathfrak{p}_{L_i}$ for every $0 \leq i \in \mathbb{Z}$.

The unit group $U_{\mathbb{X}(L/K)}$ of $O_{\mathbb{X}(L/K)}$ is defined by

$$
U_{\mathbb{X}(L/K)} = \left\{ (\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \in \mathbb{X}(L/K) : \boldsymbol{\nu}_{\mathbb{X}(L/K)}\left((\alpha_{L_i})_{0 \le i \in \mathbb{Z}}\right) = 0 \right\}.
$$

Again by eq.s [\(4.3\)](#page-10-0) and [\(4.2\)](#page-9-1), for $\alpha = (\alpha_{L_i})_{0 \leq i \in \mathbb{Z}} \in \mathbb{X}(L/K)$, the following two conditions are equivalent.

- (v) $(\alpha_{L_i})_{0 \leq i \in \mathbb{Z}} \in U_{\mathbb{X}(L/K)}$;
- (vi) $\alpha_{L_i} \in U_{L_i}$ for every $0 \leq i \in \mathbb{Z}$.

Let L/K be an infinite APF -extension. Consider the following tower

$$
K \subseteq F \subseteq L \subseteq E \subseteq K^{sep}
$$

of extensions over K, where $[F: K] < \infty$ and $[E: L] < \infty$. It then follows, by Lemma [3.3](#page-8-0) parts (i) and (ii), that L/F is an infinite APF -extension satisfying

$$
\mathbb{X}(L/K) = \mathbb{X}(L/F),
$$

by the definition of field of norms, and E/K is an infinite APF -extension satisfying

$$
\mathbb{X}(L/K) \hookrightarrow \mathbb{X}(E/K)
$$

under the injective topological homomorphism

$$
\varepsilon_{L,E}^{(M)}:\mathbb{X}(L/K)\to\mathbb{X}(E/K),
$$

which depends on a finite extension M over K satisfying $LM = E$.

The topological embedding $\varepsilon_{L,E}^{(M)} : \mathbb{X}(L/K) \hookrightarrow \mathbb{X}(E/K)$ is defined as follows. Let ${L_i}_{0 \le i \in \mathbb{Z}}$ be an increasing directed-family of sub-extensions in L/K , such that $[L_i : K] < \infty$, for every $0 \le i \in \mathbb{Z}$, and $\bigcup_{0 \le i \in \mathbb{Z}} L_i = L$. Then, clearly, ${L_iM}_{0 \le i \in \mathbb{Z}}$ is an increasing directed-family of sub-extensions in E/K , such that $[L_i\overline{M}:K]<\infty$, for every $0\leq i\in\mathbb{Z}$, and $\bigcup_{0\leq i\in\mathbb{Z}}L_iM=E$. Given these two directed-families, there exists a large enough positive integer $m = m(M)$, which depends on the choice of M, such that, for $m \leq i \leq j$,

$$
N_{L_jM/L_iM}(x) = N_{L_j/L_i}(x),
$$

for each $x \in L_j$. Now, the topological embedding $\varepsilon_{L,E}^{(M)} : \mathbb{X}(L/K) \hookrightarrow \mathbb{X}(E/K)$ is defined, for every $(\alpha_{L_i})_{0 \leq i \in \mathbb{Z}} \in \mathbb{X}(L/K) - \{0\}$, by

$$
\varepsilon_{L,E}^{(M)} : (\alpha_{L_i})_{0 \le i \in \mathbb{Z}} \mapsto (\alpha_{L_iM}')_{0 \le i \in \mathbb{Z}},
$$

where $\alpha'_{L_iM} \in L_iM$ is defined, for every $0 \leq i \in \mathbb{Z}$, by

$$
\alpha'_{L_iM} = \begin{cases} \alpha_{L_i}, & i \ge m \\ N_{L_mM/L_iM}(\alpha_{L_m}), & i < m. \end{cases}
$$

Thus, under the topological embedding $\varepsilon_{L,E}^{(M)}$: $\mathbb{X}(L/K) \hookrightarrow \mathbb{X}(E/K)$, view $X(E/K)/X(L/K)$ as an extension of complete discrete valuation fields. At this point, the following remark is in order.

Remark 4.6. Let L/K be an infinite APF -extension and E/L a finite extension. Suppose that M and M' are two finite extensions over K, satisfying $LM =$ $LM' = E$. Then the embeddings $\varepsilon_{L,E}^{(M)}$, $\varepsilon_{L,E}^{(M')}$: $\mathbb{X}(L/K) \hookrightarrow \mathbb{X}(E/K)$ are the same. Therefore, as a notation, we shall set $\varepsilon_{L,E}^{(M)} = \varepsilon_{L,E}$.

Now, given an infinite APF -extension L/K , and this time let E be a (not necessarily finite) separable extension of L. Let $S_{E/L}^{sep}$ denote the partiallyordered family of all finite separable sub-extensions in E/L . Then,

Proposition 4.7.

$$
\{\mathbb{X}(E'/K); \varepsilon_{E',E''}: \mathbb{X}(E'/K) \hookrightarrow \mathbb{X}(E''/K)\}_{E',E'' \in S_{E/L}^{sep}}
$$

$$
E' \subseteq E''
$$

is an inductive system under the topological embeddings

$$
\varepsilon_{E',E''}: \mathbb{X}(E'/K) \hookrightarrow \mathbb{X}(E''/K)
$$

for $E', E'' \in S_{E/L}^{sep}$ with $E' \subseteq E''$.

Let $X(E, L/K)$ denote the topological field defined by the inductive limit

$$
\mathbb{X}(E, L/K) = \lim_{E' \in S_{E/L}^{\text{sep}}} \mathbb{X}(E'/K)
$$

defined over the transition morphisms $\varepsilon_{E',E''}$: $\mathbb{X}(E'/K) \hookrightarrow \mathbb{X}(E''/K)$ for $E', E'' \in S_{E/L}^{sep}$ with $E' \subseteq E''$.

The following theorem is central in the theory of fields of norms.

Theorem 4.8 (Fontaine-Wintenberger). Let L/K be an APF-extension and E/L *a Galois extension. Then* $\mathbb{X}(E, L/K)/\mathbb{X}(L/K)$ *is a Galois extension, and*

$$
Gal(\mathbb{X}(E, L/K)/\mathbb{X}(L/K)) \simeq Gal(E/L)
$$

canonically.

An immediate and important consequence of this theorem is the following.

Corollary 4.9. Let L/K be an APF-extension. Then

$$
Gal(\mathbb{X}(L^{sep}, L/K)/\mathbb{X}(L/K)) \simeq Gal(L^{sep}/L)
$$

canonically.

5 Fesenko reciprocity law

In this section, we shall review the Fesenko reciprocity law for the local field K following $[1, 2, 3]$ $[1, 2, 3]$ $[1, 2, 3]$.

Following [\[13\]](#page-43-5), we recall the following definition.

Definition 5.1. Let $\varphi = \varphi_K \in \text{Gal}(K^{nr}/K)$ denote the Frobenius automorphism of K. An automorphism $\xi \in \text{Gal}(K^{sep}/K)$ is called a *Lubin-Tate splitting over* K, if $\xi |_{K^{nr}} = \varphi$.

All through the remainder of the text, we shall fix a Lubin-Tate splitting over the local field K and denote it simply by φ , or by φ_K if there is fear of confusion. Let K_{φ} denote the fixed field $(K^{sep})^{\varphi}$ of $\varphi \in G_K$ in K^{sep} .

Let L/K be a totally-ramified APF -Galois extension satisfying

$$
K \subseteq L \subseteq K_{\varphi}.\tag{5.1}
$$

The field of norms $\mathbb{X}(L/K)$ is a local field by virtue of Theorem [4.4.](#page-10-1) Let $\widetilde{\mathbb{X}}(L/K)$ denote the completion $\widetilde{\mathbb{X}(L/K)}$ of $\mathbb{X}(L/K)^{nr}$ with respect to the valuation $\nu_{\mathbb{X}(L/K)^{nr}}$, which is the unique extension of the valuation $\nu_{\mathbb{X}(L/K)}$ to $\mathbb{X}(L/K)^{nr}$. As usual, we let $U_{\widetilde{\mathbb{X}}(L/K)}$ to denote the unit group of the ring of integers $O_{\widetilde{\mathbb{X}}(L/K)}$ of the complete field $\mathbb{X}(L/K)$. In this case, there exist isomorphisms

$$
\widetilde{\mathbb{X}}(L/K) \simeq \mathbb{F}_p^{sep}((T))
$$

and

$$
U_{\widetilde{\mathbb{X}}(L/K)} \simeq \mathbb{F}_p^{sep}[[T]]^{\times}
$$

defined by the mechanism of Coleman power series (for details, q.v. section 1.4 in [\[13\]](#page-43-5)). Thus, the algebraic structures $\mathbb{X}(L/K)$ and $U_{\mathbb{X}(L/K)}$ initially seems to depend on the ground field K only. However, as we shall state in Corollary [5.7,](#page-15-0) the law of composition on the "class formation", which is a certain sub-quotient of $U_{\widetilde{\mathbb{X}}(L/K)},$ does indeed depend on the $Gal(L/K)$ -module structure of $U_{\widetilde{\mathbb{X}}(L/K)}.$ *Remark* 5.2*.* The problem of removing this dependence on the Galois-module structure of $U_{\widetilde{\mathbb{X}}(L/K)}$ is closely connected with Sen's infinite-dimensional Hodge-Tate theory $([11])$ $([11])$ $([11])$, or more generally with the *p*-adic Langlands program.

As in section 1, let \tilde{K} denote the completion of K^{nr} with respect to the valuation $\nu_{K^{nr}}$ on K^{nr} , and let $\widetilde{L} = L\widetilde{K}$. Then $\widetilde{L}/\widetilde{K}$ is an APF-extension, as L/K is an APF -extension, and the corresponding field of norms satisfy

$$
\mathbb{X}(\widetilde{L}/\widetilde{K}) = \mathbb{X}(L/K). \tag{5.2}
$$

Now, let

$$
\Pr_{\widetilde{K}}: U_{\widetilde{\mathbb{X}}(L/K)} \to U_{\widetilde{K}}
$$
\n(5.3)

denote the projection map on the K-coordinate of $U_{\widetilde{\mathbb{X}}(L/K)}$ under the identifica-tion described in eq. [\(5.2\)](#page-13-0). All through the text, $U^1_{\tilde{X}(L/K)}$ stands for the kernel $\ker(\mathrm{Pr}_{\widetilde{K}})$ of the projection map $\mathrm{Pr}_{\widetilde{K}} : U_{\widetilde{X}(L/K)} \to U_{\widetilde{K}}$.

Definition 5.3. The subgroup

$$
\mathrm{Pr}_{\widetilde{K}}^{-1}(U_K) = \{ U \in U_{\widetilde{\mathbb{X}}(L/K)} : \mathrm{Pr}_{\widetilde{K}}(U) \in U_K \}
$$

of $U_{\widetilde{\mathbb{X}}(L/K)}$ is called the *Fesenko diamond subgroup of* $U_{\widetilde{\mathbb{X}}(L/K)}$, and denoted by $U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}.$

Now, following [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2), choose an ascending chain of field extensions

$$
K = E_o \subset E_1 \subset \cdots \subset E_i \subset \cdots \subset L
$$

in such a way that

- (i) $L = \bigcup_{0 \leq i \in \mathbb{Z}} E_i$;
- (ii) E_i/K is a Galois extension for each $0 \leq i \in \mathbb{Z}$;
- (iii) E_{i+1}/E_i is cyclic of prime degree $[E_{i+1} : E_i] = p = \text{char}(\kappa_K)$ for each $1 \leq i \in \mathbb{Z}$:

(iv) E_1/E_0 is cyclic of degree relatively prime to p.

Such a sequence $(E_i)_{0 \leq i \in \mathbb{Z}}$ exists, as L/K is a solvable Galois extension, and will be called as a *basic ascending chain of sub-extensions in* L/K. Then, we can construct $X(L/K)$ by the basic sequence $(E_i)_{0 \leq i \in \mathbb{Z}}$ and $\widetilde{X}(L/K)$ by $(\widetilde{E_i})_{0 \leq i \in \mathbb{Z}}$. Note that, the Galois group $Gal(L/K)$ corresponding to the extension L/K act continuously on $\mathbb{X}(L/K)$ and on $\mathbb{X}(L/K)$ naturally by defining the Galois-action of $\sigma \in \text{Gal}(L/K)$ on the chain

$$
K = E_o \subset E_1 \subset \dots \subset E_i \subset \dots \subset L,\tag{5.4}
$$

by the action of σ on each E_i for $0 \leq i \in \mathbb{Z}$ as

$$
K = E_o^{\sigma} \subset E_1^{\sigma} = E_1 \subset \cdots \subset E_i^{\sigma} = E_i \subset \cdots \subset L,
$$
\n
$$
(5.5)
$$

and respectively on the chain

$$
\widetilde{K} = \widetilde{K}E_o \subset \widetilde{E}_1 = \widetilde{K}E_1 \subset \cdots \subset \widetilde{E}_i = \widetilde{K}E_i \subset \cdots \subset \widetilde{L} = \widetilde{K}L,\qquad(5.6)
$$

by the action of σ on the "E_i-part" of each \widetilde{E}_i (note that, $E_i \cap K^{nr} = K$)

for $0 \leq i \in \mathbb{Z}$ as

$$
\widetilde{K} = \widetilde{K}E_o^{\sigma} \subset \widetilde{K}E_1^{\sigma} = \widetilde{K}E_1 \subset \cdots \subset \widetilde{K}E_i^{\sigma} = \widetilde{K}E_i \subset \cdots \subset \widetilde{K}L. \tag{5.7}
$$

Therefore, there exist natural continuous actions of $Gal(L/K)$ on $U_{\mathbb{X}(L/K)}$, $U_{\widetilde{\mathbb{X}}(L/K)}$, and on $U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond}$ compatible with the respective topological group structures, so that *we shall always view them as topological Gal*(L/K)*-modules in this text*. Now, recall the following theorem regarding norm compatible sequences of prime elements (cf. [\[13\]](#page-43-5)).

Theorem 5.4 (Koch-de Shalit). *Assume that* $K \subseteq L \subset K_{\varphi}$. *Then for any chain*

$$
K = E_o \subset E_1 \subset \cdots \subset E_i \subset \cdots \subset L,
$$

of finite sub-extensions of L/K*, there exists a unique norm-compatible sequence*

$$
\pi_{E_o}, \pi_{E_1}, \cdots, \pi_{E_i}, \cdots,
$$

where each π_{E_i} *is a prime element of* E_i *, for* $0 \leq i \in \mathbb{Z}$ *.*

In view of the theorem of Koch and de Shalit, define the *natural* prime element $\Pi_{\varphi:L/K}$ of the local field $\mathbb{X}(L/K)$, which depends on the fixed Lubin-Tate splitting φ (cf. [\[13\]](#page-43-5)) as well as the sub-extension L/K of K_{φ}/K , by

$$
\Pi_{\varphi;L/K} = (\pi_{E_i})_{0 \leq i \in \mathbb{Z}}.
$$

Note that, by the theorem of Koch and de Shalit, the prime element $\Pi_{\varphi:L/K}$ of $X(L/K)$ does *not* depend on the choice of a chain $(E_i)_{0 \leq i \in \mathbb{Z}}$ of finite subextensions of L/K .

Theorem 5.5 (Fesenko). *For each* $\sigma \in Gal(L/K)$ *, there exists* $U_{\sigma} \in U_{\tilde{X}(L/K)}^{\circ}$ *which solves the equation*

$$
U^{1-\varphi} = \Pi_{\varphi;L/K}^{\sigma - 1} \tag{5.8}
$$

for U*. Moreover, the solution set of this equation consists of elements from the coset* $U_{\sigma}.U_{\mathbb{X}(L/K)}$ *of* U_{σ} *modulo* $U_{\mathbb{X}(L/K)}$ *.*

In fact, for the most general form of this theorem and its proof, look at [\[9\]](#page-43-14). Now, define the arrow

$$
\phi_{L/K}^{(\varphi)} : \text{Gal}(L/K) \to U_{\mathbb{X}(L/K)}^{\circ} / U_{\mathbb{X}(L/K)} \tag{5.9}
$$

by

$$
\phi_{L/K}^{(\varphi)} : \sigma \mapsto \overline{U}_{\sigma} = U_{\sigma} . U_{\mathbb{X}(L/K)},\tag{5.10}
$$

for every $\sigma \in \text{Gal}(L/K)$.

Theorem 5.6 (Fesenko). *The arrow*

$$
\phi_{L/K}^{(\varphi)} : \text{Gal}(L/K) \to U^{\circ}_{\mathbb{X}(L/K)}/U_{\mathbb{X}(L/K)}
$$

defined for the extension L/K *is injective, and for every* $\sigma, \tau \in Gal(L/K)$ *,*

$$
\phi_{L/K}^{(\varphi)}(\sigma\tau) = \phi_{L/K}^{(\varphi)}(\sigma)\phi_{L/K}^{(\varphi)}(\tau)^{\sigma}
$$
\n(5.11)

co-cycle condition is satisfied.

A natural consequence of this theorem is the following result. Let $\text{im}(\phi_{L/K}^{(\varphi)}) \subseteq$ $U_{\mathbb{X}(L/K)}^{\diamond}$, $U_{\mathbb{X}(L/K)}$ denote the image set of the mapping $\phi_{L/K}^{(\varphi)}$.

Corollary 5.7. *Define a law of composition* $*$ *on im*($\phi_{L/K}^{(\varphi)}$) *by*

 $for\ every\ \overline{U}, \overline{V}\in im(\phi_{L/K}^{(\varphi)}).$ Then $im(\phi_{L/K}^{(\varphi)})$ is a topological group under $*$, and *the map* $\phi_{L/K}^{(\varphi)}$ *induces an isomorphism of topological groups*

$$
\phi_{L/K}^{(\varphi)} : Gal(L/K) \xrightarrow{\sim} im(\phi_{L/K}^{(\varphi)}), \tag{5.13}
$$

where the topological group structure on $\text{im}(\phi_{L/K}^{(\varphi)})$ is defined with respect to the *binary operation* $*$ *defined by eq.* [\(5.12\)](#page-15-1)*.*

Now, for each $0 \leq i \in \mathbb{R}$, consider the i^{th} higher unit group $U^i_{\tilde{\mathbb{X}}(L/K)}$ of the field $\widetilde{X}(L/K)$, and define the group

$$
\left(U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond}\right)^{i} = U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond} \cap U_{\widetilde{\mathbb{X}}(L/K)}^{i}.
$$
\n(5.14)

Theorem 5.8 (Fesenko ramification theorem). *For* $0 \le n \in \mathbb{Z}$, *let* $Gal(L/K)_n$ *denote the* n^{th} *higher ramification subgroup of the Galois group* $Gal(L/K)$ *corresponding to the APF-Galois sub-extension* L/K *of* K_{φ}/K *in the lower numbering. Then, there exists the inclusion*

$$
\phi_{L/K}^{(\varphi)}\left(\text{Gal}(L/K)_n-\text{Gal}(L/K)_{n+1}\right) \subseteq
$$
\n
$$
\left(U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond}\right)^n U_{\mathbb{X}(L/K)}/U_{\mathbb{X}(L/K)} - \left(U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond}\right)^{n+1} U_{\mathbb{X}(L/K)}/U_{\mathbb{X}(L/K)}.
$$

Now, let M/K be a Galois sub-extension of L/K . Thus, there exists the chain of field extensions

$$
K\subseteq M\subseteq L\subseteq K_{\varphi},
$$

where M is a totally-ramified APF -Galois extension over K by Lemma [3.3.](#page-8-0) Let

$$
\phi_{M/K}^{(\varphi)} : \text{Gal}(M/K) \to U^{\circ}_{\mathbb{X}(M/K)}/U_{\mathbb{X}(M/K)}
$$

be the corresponding map defined for the extension M/K .

Now, let

$$
K = E_o \subset E_1 \subset \cdots \subset E_i \subset \cdots \subset L
$$

be an ascending chain satisfying $L = \bigcup_{0 \le i \in \mathbb{Z}} E_i$ and $[E_{i+1} : E_i] < \infty$ for every $0 \leq i \in \mathbb{Z}$. Then

$$
K = E_o \cap M \subseteq E_1 \cap M \subseteq \cdots \subseteq E_i \cap M \subseteq \cdots \subset M
$$

is an ascending chain of field extensions satisfying $M = \bigcup_{0 \leq i \in \mathbb{Z}} (E_i \cap M)$ and $[E_{i+1} \cap M : E_i \cap M] < \infty$ for every $0 \leq i \in \mathbb{Z}$. Thus, we can construct $\mathbb{X}(M/K)$ by the sequence $(E_i \cap M)_{0 \leq i \in \mathbb{Z}}$ and $\mathbb{X}(M/K)$ by the sequence $(E_i \cap M)_{0 \leq i \in \mathbb{Z}}$. Furthermore, the commutative square

$$

for every pair $0 \leq i, i' \in \mathbb{Z}$ satisfying $i \leq i'$, induces a group homomorphism

$$
\widetilde{\mathcal{N}}_{L/M} = \varprojlim_{0 \le i \in \mathbb{Z}} \widetilde{N}_{E_i/E_i \cap M} : \widetilde{\mathbb{X}}(L/K)^{\times} \to \widetilde{\mathbb{X}}(M/K)^{\times}
$$
\n(5.15)

defined by

$$
\widetilde{\mathcal{N}}_{L/M}\left((\alpha_{\widetilde{E}_i})_{0\leq i\in\mathbb{Z}}\right) = \left(\widetilde{N}_{E_i/E_i\cap M}(\alpha_{\widetilde{E}_i})\right)_{0\leq i\in\mathbb{Z}},\tag{5.16}
$$

for every $(\alpha_{\widetilde{E}_i})_{0 \leq i \in \mathbb{Z}} \in \widetilde{\mathbb{X}}(L/K)^{\times}$.

Remark 5.9*.* The group homomorphism

$$
\widetilde{\mathcal{N}}_{L/M} : \widetilde{\mathbb{X}}(L/K)^{\times} \to \widetilde{\mathbb{X}}(M/K)^{\times}
$$

defined by eq.s [\(5.15\)](#page-16-0) and [\(5.16\)](#page-16-1) does *not* depend on the choice of an ascending chain

The basic properties of this group homomorphism are the following.

(i) If $U = (u_{\widetilde{E}_i})_{0 \le i \in \mathbb{Z}} \in U_{\widetilde{\mathfrak{X}}(L/K)},$ then $\mathcal{N}_{L/M}(U) \in U_{\widetilde{\mathfrak{X}}(M/K)}.$

\begin{aligned} \nu_{\widetilde{\mathbb{X}}(M/K)} \left(\widetilde{\mathcal{N}}_{L/M}(U) \right) &= \nu_{\widetilde{\mathbb{X}}(M/K)} \left(\left(\widetilde{N}_{E_i/E_i \cap M}(u_{\widetilde{E}_i}) \right)_{0 \le i \in \mathbb{Z}} \right) \\ &= \nu_{\widetilde{K}}(u_{\widetilde{K}}) \\ &= 0, \end{aligned}
$$

as

$$
\nu_{\widetilde{X}(L/K)}(U) = \nu_{\widetilde{K}}(u_{\widetilde{K}}) = 0,
$$

since $U \in U_{\widetilde{\mathbb{X}}(L/K)}$.

(ii) If
$$
U = (u_{\widetilde{E}_i})_{0 \le i \in \mathbb{Z}} \in U^{\infty}_{\widetilde{\mathbb{X}}(L/K)},
$$
 then $\widetilde{\mathcal{N}}_{L/M}(U) \in U^{\infty}_{\widetilde{\mathbb{X}}(M/K)}.$

Proof. The assertion follows by observing that $Pr_{\tilde{K}}(U) = u_{\tilde{K}}$ and $Pr_{\tilde{K}}\left(\tilde{N}_{L/M}(U)\right) =$ $N_{E_o/E_o \cap M}(u_{\widetilde{E}_o}) = u_{\widetilde{K}} \in U_K.$

(iii) If $U = (u_{E_i})_{0 \le i \in \mathbb{Z}} \in U_{\mathbb{X}(L/K)}$, then $\mathcal{N}_{L/M}(U) \in U_{\mathbb{X}(M/K)}$.

Proof. The assertion follows by the definition eq. [\(5.16\)](#page-16-1) of the homo-morphism eq. [\(5.15\)](#page-16-0) combined with the fact that $N_{E_i/E_i \cap M}(u_{E_i}) =$ $N_{E_i/E_i \cap M}(u_{E_i})$ for every $u_{E_i} \in U_{E_i}$ and for every $0 \leq i \in \mathbb{Z}$. \Box

Thus, the group homomorphism eq. [\(5.15\)](#page-16-0) defined by eq. [\(5.16\)](#page-16-1) induces a group homomorphism, which will be called the *Coleman norm map from* L *to* M,

\widetilde{\mathcal{N}}_{L/M}^{\text{Coleman}}: U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}/U_{\mathbb{X}(L/K)} \to U^{\diamond}_{\widetilde{\mathbb{X}}(M/K)}/U_{\mathbb{X}(M/K)} \tag{5.17}

and defined by

$$
\widetilde{\mathcal{N}}_{L/M}^{\text{Coleman}}(\overline{U}) = \widetilde{\mathcal{N}}_{L/M}(U).U_{\mathbb{X}(M/K)},\tag{5.18}
$$

for every $U \in U^{\circ}_{\mathbb{X}(L/K)}$, where \overline{U} denotes, as before, the coset $U.U_{\mathbb{X}(L/K)}$ in $U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}/U_{\mathbb{X}(L/K)}$.

The following theorem is stated, in the works of Fesenko [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2), without a proof. Thus, for the sake of completeness, we shall supply a proof of this theorem as well.

Theorem 5.10 (Fesenko). *For the Galois sub-extension* M/K *of* L/K*, the square*

where the right-vertical arrow

$$
\widetilde{\mathcal{N}}_{L/M}^{Coleman}: U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}/U_{\mathbb{X}(L/K)} \to U^{\diamond}_{\widetilde{\mathbb{X}}(M/K)}/U_{\mathbb{X}(M/K)}
$$

is the Coleman norm map from L *to* M *defined by eq.s [\(5.17\)](#page-17-0) and [\(5.18\)](#page-17-1), is commutative.*

Proof. For each $\sigma \in \text{Gal}(L/K)$, we have to show that

$$
\widetilde{\mathcal{N}}^{\text{Coleman}}_{L/M}\left(\phi_{L/K}^{(\varphi)}(\sigma)\right) = \phi_{M/K}^{(\varphi)}(\sigma|_M).

Thus, it suffices to prove the congruence

\widetilde{\mathcal{N}}_{L/M}(U_\sigma)\equiv U_{\sigma|_M}\pmod{U_{\mathbb{X}(M/K)}},

or equivalently, it suffices to prove that

Now, without loss of generality, in view of Remark [5.9,](#page-17-2) the ascending chain of extensions

for each $(\alpha_{F_i})_{0 \le i \in \mathbb{Z}} \in \widetilde{\mathbb{X}}(L/F)^{\times}$.

$$

Here, $\Pi_{\varphi;L/F}$ is the norm compatible sequence of primes $(\pi_{F_i})_{0 \leq i \in \mathbb{Z}}$. Now,

$$
\Lambda_{F/K}\left(\frac{U_{\sigma}}{U_{\sigma}^{\varphi}}\right) = \frac{\Lambda_{F/K}(U_{\sigma})}{\Lambda_{F/K}(U_{\sigma}^{\varphi})} = \frac{\Lambda_{F/K}(U_{\sigma})}{\Lambda_{F/K}(U_{\sigma})^{\varphi}}.
$$

On the other hand, $\Lambda_{F/K}(\Pi_{\varphi;L/F}) = \Pi_{\varphi;L/K}$ and $\Lambda_{F/K}(\Pi_{\varphi;L/F}^{\sigma}) = \Pi_{\varphi;L/K}^{\sigma}$. Thus, eq. [\(5.25\)](#page-20-2) yields

$$
\frac{\Lambda_{F/K}(U_{\sigma})}{\Lambda_{F/K}(U_{\sigma})^{\varphi}} = \frac{\Pi^{\sigma}_{\varphi;L/K}}{\Pi_{\varphi;L/K}},
$$

which shows that

$$
\phi_{L/K}^{(\varphi)}(\sigma) = \Lambda_{F/K}(U_{\sigma}).U_{\mathbb{X}(L/K)} = \lambda_{F/K}(\phi_{L/F}^{(\varphi)}(\sigma)),
$$

completing the proof of the commutativity of the square.

If L/K is furthermore a finite extension, then the composition

is the Iwasawa-Neukirch map of the extension L/K . Thus, the mapping $\phi_{L/\beta}^{(\varphi)}$ L/K *defined for* L/K *is the generalization of the Iwasawa-Neukirch map* $\iota_{L/K}$: $Gal(L/K) \rightarrow U_K/N_{L/K}(U_L)$ *for the totally-ramified APF-Galois sub-extensions* L/K of K_{φ}/K .

Likewise, we can extend the definition of the Hazewinkel map $h_{L/K}: U_K/N_{L/K}U_L \rightarrow$ $Gal(L/K)^{ab}$ initially defined for totally-ramified finite Galois extensions L/K to totally-ramified APF-Galois sub-extensions of K_{φ}/K by generalizing Serre short exact sequence introduced in eq.s [\(1.1\)](#page-4-0) and [\(1.2\)](#page-4-1). In order to do so, we first have to assume that the local field K satisfies the condition

$$
\mu_p(K^{sep}) = \{ \alpha \in K^{sep} : \alpha^p = 1 \} \subset K,
$$
\n(5.26)

where $p = \text{char}(\kappa_K)$.

Remark 5.13. If K is a local field of characteristic $p = \text{char}(\kappa_K)$, the assumption (5.26) on K is automatically satisfied. For details on the assumption (5.26) on K , we refer the reader to [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2).

In what follows, as before, let L/K be a totally-ramified APF -Galois extension satisfying eq. [\(5.1\)](#page-12-0). Under this assumption, there exists a topological $\mathrm{Gal}(L/K)\text{-submodule }Y_{L/K}$ of $U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)},$ such that

- (i) $U_{\mathbb{X}(L/K)} \subseteq Y_{L/K};$
- (ii) the composition

$$
\Phi_{L/K}^{(\varphi)} : \text{Gal}(L/K) \xrightarrow{\phi_{L/K}^{(\varphi)}} U_{\mathbb{X}(L/K)}^{\circ} / U_{\mathbb{X}(L/K)} \xrightarrow[\text{canonical}]{c_{L/K}} U_{\mathbb{X}(L/K)}^{\circ} / Y_{L/K}
$$
\n
$$
\xrightarrow[\text{topol. map}]{c_{L/K}} U_{\mathbb{X}(L/K)}^{\circ} / Y_{L/K}
$$

is a bijection with the extended Hazewinkel map $H_{L/K}^{(\varphi)} : U_{\tilde{X}(L/K)}^{\circ/2} / Y_{L/K} \to$ $Gal(L/K)$ as the inverse.

Now, we shall briefly review the constructions of the topological group $Y_{L/K}$ and the extended Hazewinkel map $H_{L/K}^{(\varphi)} : U^{\diamond}_{\tilde{X}(L/K)}/Y_{L/K} \to \text{Gal}(L/K)$. For details, we refer the reader to [\[1,](#page-43-0) [2,](#page-43-1) [3\]](#page-43-2), which we follow closely.

Fix a *basic* ascending chain of sub-extensions in L/K

$$
K = K_o \subset K_1 \subset \cdots \subset K_i \subset \cdots \subset L. \tag{5.27}
$$

once and for all. Now, introduce the following notation. For each $1 \leq i \in \mathbb{Z}$,

- (i) let σ_i denote an element of $Gal(L/K)$ satisfying $< \sigma_i |_{K_i}>= Gal(K_i/K_{i-1});$
- (ii) let $\widetilde{K}_i = K_i \widetilde{K}_i$.

By abelian local class field theory, for each $1 \leq k \in \mathbb{Z}$, there exists an injective homomorphism

$$
\Xi_{K_{k+1}/K_k}: \text{Gal}(K_{k+1}/K_k) \to U_{\widetilde{K}_{k+1}}/U_{\widetilde{K}_{k+1}}^{\sigma_{k+1}-1}
$$
(5.28)

defined by

$$
\Xi_{K_{k+1}/K_k}: \tau \mapsto \pi_{K_{k+1}}^{\tau-1} U_{\tilde{K}_{k+1}}^{\sigma_{k+1}-1},\tag{5.29}
$$

for every $\tau \in \text{Gal}(K_{k+1}/K_k)$. Let $\text{im}(\Xi_{K_{k+1}/K_k}) = T_k^{(L/K)} = T_k$ be the isomorphic copy of $Gal(K_{k+1}/K_k)$ in $U_{\widetilde{K}_{k+1}}^{K_{k+1}-1}$.

Theorem 5.14 (Fesenko). *Fix* $1 \leq k \in \mathbb{Z}$. Let

$$
T_k^{(L/K)'}=T_k'=T_k\cap\left(\prod_{1\leq i\leq k+1}U_{\widetilde{K}_{k+1}}^{\sigma_i-1}\right)/U_{\widetilde{K}_{k+1}}^{\sigma_{k+1}-1}.
$$

Then the exact sequence

$$
\begin{CD} \begin{picture}(1,0) \put(0,0){\dashbox{0.5}(1,0){\dashbox{0.5
$$

splits by a homomorphism

$$
h_k: \prod_{1 \le i \le k} U_{\widetilde{K}_k}^{\sigma_i-1} \to \left(\prod_{1 \le i \le k+1} U_{\widetilde{K}_{k+1}}^{\sigma_i-1}\right) / U_{\widetilde{K}_{k+1}}^{\sigma_{k+1}-1}.
$$

This homomorphism is not unique in general.

For each $1 \leq k \in \mathbb{Z}$, consider any map

$$
g_k^{(L/K)} = g_k : \prod_{1 \le i \le k} U_{\widetilde{K}_k}^{\sigma_i - 1} \to \prod_{1 \le i \le k+1} U_{\widetilde{K}_{k+1}}^{\sigma_i - 1}
$$

which makes the triangle

$$
\Pi_{1 \leq i \leq k+1} U^{\sigma_{i}-1}_{\widetilde{K}_{k+1}}
$$
\n

\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow
$$
\n

\Pi_{1 \leq i \leq k} U^{\sigma_{i}-1}_{\widetilde{K}_{k}} \xrightarrow{h_{k}} \left(\prod_{1 \leq i \leq k+1} U^{\sigma_{i}-1}_{\widetilde{K}_{k+1}} \right) / U^{\sigma_{k+1}-1}_{\widetilde{K}_{k+1}}
$$

commutative. Such a map clearly exists. Now, choose, for every $1 \leq i \in \mathbb{Z}$, a mapping

$$
f_i^{(L/K)} = f_i : U_{\widetilde{K}_i}^{\sigma_i - 1} \to U_{\widetilde{\mathbb{X}}(L/K_i)} \xrightarrow{\Lambda_{K_i/K}} U_{\widetilde{\mathbb{X}}(L/K)}
$$

which satisfies for each $j \in \mathbb{Z}_{>i}$ the equality

$$
\Pr_{\widetilde{K}_j} \circ f_i = (g_{j-1} \circ \cdots \circ g_i) \big|_{U_{\widetilde{K}_i}^{\sigma_i-1}},
$$

where $Pr_{\widetilde{K}_j}: U_{\widetilde{X}(L/K)} \to U_{\widetilde{K}_j}$ denotes the projection on the K_j -coordinate.

Lemma 5.15 (Fesenko). *(i)* Let $z^{(i)} \in im(f_i) = Z_i^{(L/K)}$ for each $1 \leq i \in \mathbb{Z}$. Then the infinite product $\prod_i z^{(i)}$ converges to an element z in $U^{\diamond}_{\tilde{\mathbb{X}}(L/K)}$.

(ii) Let

$$
Z_{L/K}(\lbrace K_i, f_i \rbrace) = \left\{ \prod_{1 \leq i \in \mathbb{Z}} z^{(i)} : z^{(i)} \in im(f_i) \right\}.
$$

Then, $Z_{L/K}(\lbrace K_i, f_i \rbrace)$ *is a topological subgroup of* $U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}$.

Remark 5.16. In fact, $Z_{L/K}(\lbrace K_i, f_i \rbrace)$ is a topological subgroup of $U^1_{\tilde{X}(L/K)}$. Let $z \in Z_{L/K}(\lbrace K_i, f_i \rbrace)$ and choose $z^{(i)} \in \text{im}(f_i) \subset U_{\widetilde{X}(L/K)}$ so that $z = \prod_i z^{(i)}$. It suffices to show that $Pr_{\tilde{K}}(z^{(i)}) = 1_K$. In order to do so, let $\alpha^{(i)} \in U_{\tilde{K}_i}^{\sigma_i-1}$ $\tilde{\tilde{K}}_i^{-1}$ such that $f_i(\alpha^{(i)}) = z^{(i)}$. Thus, $Pr_{\tilde{K}_i}(z^{(i)}) = \alpha^{(i)}$. Now, by Hilbert 90, it follows that, $\widetilde{N}_{K_i/K}(\alpha^{(i)}) = (\widetilde{N}_{K_{i-1}/K} \circ \widetilde{N}_{K_i/K_{i-1}})(\alpha^{(i)}) = 1_K$, which completes the proof.

Lemma 5.17. *For* $1 \leq i \in \mathbb{Z}$, *let* $\sigma = \sigma_i \in \text{Gal}(\widetilde{L}/\widetilde{K})$ *such that* $< \sigma |_{K_i}>=$ $Gal(K_i/K_{i-1})$ *. Let* $\tau \in Gal(L/K)$ *viewed as an element of* $Gal(\widetilde{L}/\widetilde{K})$ *. Then*

$$
\left(U_{\widetilde{K}_{i}}^{\sigma-1}\right)^{\tau}=U_{\widetilde{K}_{i}}^{\sigma-1}.
$$

Proof. Let τ be any element of Gal(L/K). Now consider τ as an element of Gal (L/K) . Then clearly, the conjugate $\tau^{-1}\sigma\tau \in Gal(L/K)$ satisfies < $\tau^{-1}\sigma\tau|_{K_i} = \text{Gal}(K_i/K_{i-1})$ as $(\tau^{-1}\sigma\tau|_{K_i})^n = \text{id}_{K_i}$ yields $(\sigma|_{K_i})^n = \text{id}_{K_i}$. Let $0 < d \in \mathbb{Z}$ such that $\tau^{-1}\sigma\tau \mid_{K_i} = (\sigma \mid_{K_i})^d = (\sigma^d) \mid_{K_i}$. Thus $\tau^{-1}\sigma\tau\sigma^{-d} \in$ $Gal(L/K_i)$ as $K_i = KK_i$. It then follows that

$$
U_{\widetilde{K}_{i}}^{\tau^{-1}\sigma\tau-1} = U_{\widetilde{K}_{i}}^{\sigma^{d}-1}.
$$
 As $U_{\widetilde{K}_{i}}^{\tau^{-1}\sigma\tau-1} = U_{\widetilde{K}_{i}}^{\tau^{-1}(\sigma-1)\tau} = \left(U_{\widetilde{K}_{i}}^{\sigma-1}\right)^{\tau}$, the equality
$$
\left(U_{\widetilde{K}_{i}}^{\sigma-1}\right)^{\tau} = U_{\widetilde{K}_{i}}^{\sigma^{d}-1}
$$

follows as well. Now, the inclusion

$$
U_{\widetilde{K}_{i}}^{\sigma^d-1}\subseteq U_{\widetilde{K}_{i}}^{\sigma-1}
$$

is clear, because, for $u \in U_{\widetilde{K}_i}$,

$$
\frac{u^{\sigma^d}}{u} = \frac{\left(u^{\sigma^{d-1}}\right)^{\sigma}}{u^{\sigma^{d-1}}} \cdots \frac{\left(u^{\sigma}\right)^{\sigma}}{u^{\sigma}} \frac{u^{\sigma}}{u}.
$$

Thus, for $\tau \in \text{Gal}(L/K)$, the inclusion $\left(U_{\widetilde{\kappa}}^{-1}\right)$ K_i $\big)^{\tau} \subseteq U_{\widetilde{\nu}}^{\sigma-1}$ $\overline{\widetilde{K}_{i}}^{\sigma-1}$ follows. Hence, for $\tau \in \mathrm{Gal}(L/K),$

$$
\left(U_{\widetilde{K}_{i}}^{\sigma-1}\right)^{\tau}=U_{\widetilde{K}_{i}}^{\sigma-1}
$$

completing the proof.

Now, let $\tau \in \text{Gal}(L/K)$. Consider the element $\tau^{-1}\sigma_i\tau$ of $\text{Gal}(\widetilde{L}/\widetilde{K})$ for each $1 \leq i \in \mathbb{Z}$. Then clearly, $\langle \tau^{-1} \sigma_i \tau |_{K_i} \rangle = \text{Gal}(K_i/K_{i-1})$. By abelian local class field theory and by Lemma [5.17,](#page-23-0) the square

$$
\operatorname{Gal}(K_i/K_{i-1}) \xrightarrow{\Xi_{K_i/K_{i-1}}} U_{\widetilde{K}_i} / U_{\widetilde{K}_i}^{\sigma_i - 1}
$$
\n
$$
\downarrow^{\tau \text{-conjugation}} \qquad \qquad \downarrow^{\tau}
$$
\n
$$
\operatorname{Gal}(K_i/K_{i-1}) \xrightarrow{\Xi_{K_i/K_{i-1}}} U_{\widetilde{K}_i} / U_{\widetilde{K}_i}^{\sigma_i - 1}
$$

is commutative, where the τ -conjugation map $Gal(K_i/K_{i-1}) \rightarrow Gal(K_i/K_{i-1})$ is defined by $\gamma \mapsto \tau^{-1} \gamma \tau$ for every $\gamma \in \text{Gal}(K_i/K_{i-1})$. Thus, it follows that

$$
\text{im}\left(\Xi_{K_i/K_{i-1}}\right)^{\tau} = \text{im}\left(\Xi_{K_i/K_{i-1}}\right).
$$

Now, following Theorem [5.14,](#page-22-0) for

$$
T_i^{\tau} = T_i = \text{im}(\Xi_{K_{i+1}/K_i})
$$

and

$$
(T_i')^\tau = T_i^\tau \cap \left(\prod_{1 \leq j \leq i+1} U_{\widetilde{K}_{i+1}}^{\tau^{-1} \sigma_j \tau - 1}\right) / U_{\widetilde{K}_{i+1}}^{\tau^{-1} \sigma_{i+1} \tau - 1},
$$

the exact sequence

$$
\begin{aligned}\n & (h_i^{(L/K)})^\tau = h_i^\tau \\
 & 1 \longrightarrow (T_i')^\tau \longrightarrow \left(\prod_{1 \le j \le i+1} U_{\widetilde{K}_{i+1}}^{\tau^{-1} \sigma_j \tau - 1} \right) / U_{\widetilde{K}_{i+1}}^{\tau^{-1} \sigma_{i+1} \tau - \widetilde{Y}_{i+1}/K_i} \n & \prod_{1 \le j \le i} U_{\widetilde{K}_i}^{\tau^{-1} \sigma_j \tau - 1} \longrightarrow 1\n \end{aligned}
$$

splits by a homomorphism

$$
h_i^{\tau} : \prod_{1 \leq j \leq i} U_{\widetilde{K}_i}^{\tau^{-1} \sigma_j \tau - 1} \to \left(\prod_{1 \leq j \leq i+1} U_{\widetilde{K}_{i+1}}^{\tau^{-1} \sigma_j \tau - 1} \right) / U_{\widetilde{K}_{i+1}}^{\tau^{-1} \sigma_{i+1} \tau - 1},
$$

and which furthermore makes the diagram

$$
1 \longrightarrow T'_{i} \longrightarrow \left(\prod_{1 \leq j \leq i+1} U^{\sigma_{j}-1}_{\widetilde{K}_{i+1}}\right) / U^{\sigma_{i+1}-1}_{\widetilde{K}_{i+1}} \xrightarrow{\widetilde{N}_{K_{i+1}/K_{i}}} \prod_{1 \leq j \leq i} U^{\sigma_{j}-1}_{\widetilde{K}_{i}} \longrightarrow 1

$$
1 \longrightarrow (T'_{i})^{\tau} \longrightarrow \left(\prod_{1 \leq j \leq i+1} U^{\tau^{-1} \sigma_{j} \tau-1}_{\widetilde{K}_{i+1}}\right) / U^{\tau^{-1} \sigma_{i+1} \tau-1}_{\widetilde{K}_{i+1}} \xrightarrow{\widetilde{N}_{K_{i+1}/K_{i}}} \prod_{1 \leq j \leq i} U^{\tau^{-1} \sigma_{j} \tau-1}_{\widetilde{K}_{i}} \longrightarrow 1
$$

$$
(h_{i}^{(L/K)})^{\tau} = h_{i}^{\tau}
$$

commutative. Thus, it follows that, there exists a map

$$
g_i^\tau: \prod_{1\leq j\leq i} U_{\widetilde{K}_i}^{\tau^{-1}\sigma_j\tau-1}\to \prod_{1\leq j\leq i+1} U_{\widetilde{K}_{i+1}}^{\tau^{-1}\sigma_j\tau-1}
$$

which makes the following diagram

commutative. Now, for every $1 \leq i \in \mathbb{Z}$, choose a mapping

$$
f_i^{\tau}: U_{\widetilde{K}_i}^{\sigma_i - 1} \to U_{\widetilde{\mathbb{X}}(L/K)}
$$

which satisfies for each $j \in \mathbb{Z}_{>i}$ the equality

$$
\Pr_{\widetilde{K}_j} \circ f_i^{\tau} = (g_{j-1}^{\tau} \circ \cdots \circ g_i^{\tau}) \big|_{U_{\widetilde{K}_i}^{\sigma_i-1}}.
$$

Thus, for $j \in \mathbb{Z}_{>i}$, and for $\alpha \in U_{\widetilde{k}}^{\sigma_i-1}$ $\frac{\sigma_i-1}{\widetilde{K}_i},$

\mathrm{Pr}_{\widetilde{K}_j} \circ f_i^{\tau}(\alpha) = \left(\mathrm{Pr}_{\widetilde{K}_j} \circ f_i(\alpha^{\tau^{-1}})\right)^{\tau},
$$

which yields the following relationship

f_i^{\tau}(\alpha) = f_i \left(\alpha^{\tau^{-1}} \right)^{\tau}, \tag{5.30}
$$

for every $\alpha \in U^{\sigma_i-1}_{\widetilde{\nu}}$ \tilde{K}_{i}^{i-1} . After all these observations, an immediate consequence of Lemma 5.17 is the following corollary.

Corollary 5.18. *For* $\tau \in Gal(L/K)$ *,*

$$
Z_{L/K}(\{K_i, f_i\})^{\tau} = Z_{L/K}(\{K_i, f_i^{\tau}\}).
$$

Proof. Let $z \in Z_{L/K}(\lbrace K_i, f_i \rbrace)$ and choose $z^{(i)} \in \text{im}(f_i) \subset U_{\widetilde{X}(L/K)}$ such that $z = \prod_i z^{(i)}$. By the continuity of the action of $Gal(L/K)$ on $U_{\tilde{X}(L/K)}$, to prove that $z^{\tau} \in Z_{L/K}(\lbrace K_i, f_i^{\tau} \rbrace)$, it suffices to show that $(z^{(i)})^{\tau} \in \text{im}(f_i^{\tau})$. Now, let $\alpha^{(i)} \in U_{\widetilde{\nu}}^{\sigma_i-1}$ $\frac{\sigma_i-1}{\tilde{K}_i}$ such that $f_i(\alpha^{(i)}) = z^{(i)}$. Then, $(z^{(i)})^{\tau} = f_i(\alpha^{(i)})^{\tau} =$ $f_i\left(((\alpha^{(i)})^{\tau})^{\tau^{-1}}\right)^{\tau^{-1}} = f_i^{\tau}\left((\alpha^{(i)})^{\tau}\right)$ by eq. [\(5.30\)](#page-25-0), where by the previous Lemma [5.17,](#page-23-0) $(\alpha^{(i)})^{\tau} \in U_{\widetilde{\nu}}^{\sigma_i-1}$ $\frac{\sigma_i-1}{\tilde{K}_i}$. Thus, $(z^{(i)})^{\tau} \in \text{im}(f_i^{\tau})$.

Remark 5.19. By pp. 71 of [\[2\]](#page-43-1), for $\tau \in \text{Gal}(L/K)$, $Z_{L/K}(\lbrace K_i, f_i \rbrace)$ and $Z_{L/K}(\lbrace K_i, f_i^{\tau} \rbrace)$ are algebraically and topologically isomorphic. Thus, Corollary [5.18](#page-25-1) indeed defines a continuous action of $Gal(L/K)$ on $Z_{L/K}(\lbrace K_i, f_i \rbrace)$.

Now, define the topological subgroup $Y_{L/K}\left(\{K_i,f_i\}\right)=Y_{L/K}$ of $U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}$ to be

 $Y_{L/K} = \left\{ y \in U_{\widetilde{X}(L/K)} : y^{1-\varphi} \in Z_{L/K}(\lbrace K_i, f_i \rbrace) \right\}$ (5.31)

Lemma 5.20. $Y_{L/K}$ is a topological Gal(L/K)-submodule of $U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}$.

Proof. Let $\tau \in \text{Gal}(L/K)$ and $y \in Y_{L/K}$. Note that, $(y^{\tau})^{\varphi} = (y^{\varphi})^{\tau}$, as the action of τ on $y = (u_{\tilde{K}_i})_{0 \leq i \in \mathbb{Z}}$ is defined by the action of τ on the "K_i-part" of $u_{\tilde{K}_i}$ for each $0 \leq i \in \mathbb{Z}$, and the action of φ on $y = (u_{\tilde{K}_i})_{0 \leq i \in \mathbb{Z}}$ is defined by the action of φ on the " \widetilde{K} -part" of $u_{\widetilde{K}_i}$ for each $0 \leq i \in \mathbb{Z}$. Thus, $\frac{y^{\tau}}{(y^{\tau})^{\varphi}} = \frac{y^{\tau}}{(y^{\varphi})^{\tau}}$ $\frac{y}{(y^\varphi)^\tau} =$ $\int^{\tau} \in Z_{L/K}(\lbrace K_i, f_i \rbrace)^{\tau}$. Now, the proof follows from Corollary [5.18](#page-25-1) and by $\left(\frac{y}{y^{\varphi}}\right)$ Remark [5.19.](#page-26-0) \Box

Lemma 5.21 (Fesenko). *The mapping*

$$
\ell_{L/K}^{(\varphi)} : \text{Gal}(L/K) \to U^1_{\tilde{\mathbb{X}}(L/K)}/Z_{L/K}(\lbrace K_i, f_i \rbrace)
$$

defined by

$$
\ell_{L/K}^{(\varphi)} : \sigma \mapsto \Pi_{\varphi; L/K}^{\sigma-1} \cdot Z_{L/K}(\lbrace K_i, f_i \rbrace),
$$

for every $\sigma \in \text{Gal}(L/K)$ *, is a group isomorphism, where the group operation* $*$ *on* $U^1_{\tilde{X}(L/K)}/Z_{L/K}(\lbrace K_i, f_i \rbrace)$ *is defined by*

$$
\overline{U} * \overline{V} = \overline{U} . \overline{V}^{(\ell_{L/K}^{(\varphi)})^{-1}(\overline{U})}
$$

 $for\ every\ \overline{U}=U.Z_{L/K}(\lbrace K_i,f_i\rbrace), \overline{V}=V.Z_{L/K}(\lbrace K_i,f_i\rbrace)\in U^1_{\widetilde{\mathbb{X}}(L/K)}/Z_{L/K}(\lbrace K_i,f_i\rbrace)$ *with* $U, V \in U^1_{\widetilde{\mathbb{X}}(L/K)}$.

Now, introduce the *fundamental exact sequence* as

$$
1 \to \mathrm{Gal}(L/K) \xrightarrow{\ell_{L/K}^{(\varphi)}} U_{\widetilde{\mathbb{X}}(L/K)}/Z_{L/K}(\lbrace K_i, f_i \rbrace) \xrightarrow{\mathrm{Pr}_{\widetilde{K}}} U_{\widetilde{K}} \to 1
$$

as a generalization of Serre short exact sequence (cf. eq.s (1.1) and (1.2)). Thus, for any $U \in U^{\infty}_{\mathbb{X}(L/K)}$, as $U^{1-\varphi} \in U^1_{\mathbb{X}(L/K)}$, there exists a unique $\sigma_U \in \text{Gal}(L/K)$ satisfying

$$
U^{1-\varphi} \, Z_{L/K}(\{K_i, f_i\}) = \ell_{L/K}^{(\varphi)}(\sigma_U),\tag{5.32}
$$

by Lemma [5.21.](#page-26-1) Now, define the arrow

$$
H_{L/K}^{(\varphi)}: U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond} / Y_{L/K} \to \text{Gal}(L/K)
$$
\n(5.33)

by

$$
H_{L/K}^{(\varphi)}: U.Y_{L/K} \mapsto \sigma_U,\tag{5.34}
$$

for every $U \in U^{\diamond}_{\tilde{\mathbb{X}}(L/K)}$. This arrow is clearly a well-defined mapping. In fact, suppose that $U, V \in U^{\infty}_{\widetilde{X}(L/K)}$ satisfy $U \equiv V \pmod{Y_{L/K}}$. Then $\sigma_U = \sigma_V$. In fact, let $Y \in Y_{L/K}$ such that $U = V.Y$. The definition of $Y_{L/K}$ given in eq. [\(5.31\)](#page-26-2) forces that $Y^{1-\varphi} \in Z_{L/K}(\{K_i, f_i\})$. Thus, the equalities $U^{1-\varphi} = (V \cdot Y)^{1-\varphi} =$ $V^{1-\varphi}Y^{1-\varphi}$ yield $U^{1-\varphi}Z_{L/K}(\lbrace K_i,f_i\rbrace) = V^{1-\varphi}Z_{L/K}(\lbrace K_i,f_i\rbrace)$, which shows that $\ell_{L/K}^{(\varphi)}(\sigma_U) = \ell_{L/K}^{(\varphi)}(\sigma_V)$ by eq. [\(5.32\)](#page-26-3). Now, by Lemma [5.21,](#page-26-1) it follows that $\sigma_{U} = \sigma_{V}$.

Lemma 5.22. *Suppose that the local field* K *satisfies the condition given in eq. [\(5.26\)](#page-21-0). The arrow*

H_{L/K}^{(\varphi)} : U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond} / Y_{L/K} \to Gal(L/K)
$$

defined for the extension L/K *is a bijection.*

Proof. Choose $U, V \in U^{\diamond}_{\mathbb{X}(L/K)}$ satisfying $H_{L/K}^{(\varphi)}(U.Y_{L/K}) = H_{L/K}^{(\varphi)}(V.Y_{L/K}).$ Thus, $\sigma_U = \sigma_V$ by the definition eq. [\(5.34\)](#page-26-4) of the arrow given in eq. [\(5.33\)](#page-26-5). Now, eq. [\(5.32\)](#page-26-3) yields

U^{1-\varphi}.Z_{L/K}(\lbrace K_i, f_i \rbrace) = V^{1-\varphi}.Z_{L/K}(\lbrace K_i, f_i \rbrace),
$$

which proves that $(V^{-1}U)^{1-\varphi} \in Z_{L/K}(\lbrace K_i, f_i \rbrace)$. The equality $U.Y_{L/K}$ $V.Y_{L/K}$ follows immediately by eq. [\(5.31\)](#page-26-2). Now, choose any $\sigma \in \text{Gal}(L/K)$. By Theorem [5.5,](#page-15-2) there exists $U \in U^{\infty}_{\widetilde{\mathbb{X}}(L/K)}$ which is unique modulo $U_{\mathbb{X}(L/K)}$ (so unique modulo $Y_{L/K}$ as $U_{\mathbb{X}(L/K)} \subseteq Y_{L/K}$, such that

\Pi_{\varphi;L/K}^{\sigma-1} \cdot Z_{L/K}(\{K_i, f_i\}) = U^{1-\varphi} \cdot Z_{L/K}(\{K_i, f_i\}).
$$

Thus, by Theorem [5.21](#page-26-1) and by eq. [\(5.32\)](#page-26-3),

\ell^{(\varphi)}_{L/K}(\sigma)=\ell^{(\varphi)}_{L/K}(\sigma_U),

which forces the equality $\sigma = \sigma_U$ for $U \in U^{\infty}_{\widetilde{\mathbb{X}}(L/K)}$.

Now, consider the composition of the arrows

 (5.35)

Lemma 5.23. *There are the following equalities.*

$$
(i)\ \ U_{\sigma_U}.Y_{L/K}=U.Y_{L/K}\ for\ every\ U\in U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)};
$$

(ii) $\sigma_{U_{\sigma}} = \sigma$ *for every* $\sigma \in Gal(L/K)$ *.*

Proof. To prove (i), let $U \in U^{\infty}_{\tilde{\mathbb{X}}(L/K)}$. Then, by eq. [\(5.32\)](#page-26-3), there exists a unique $\sigma_U \in \text{Gal}(L/K)$ satisfying

U^{1-\varphi}.Z_{L/K}(\lbrace K_i, f_i \rbrace) = \ell_{L/K}^{(\varphi)}(\sigma_U) = \Pi_{\varphi; L/K}^{\sigma_U - 1}.Z_{L/K}(\lbrace K_i, f_i \rbrace). \tag{5.36}

The equality on the right-hand-side follows from the definition of the mapping $\ell_{L/K}^{(\varphi)}$: Gal $(L/K) \to U^1_{\tilde{X}(L/K)}/Z_{L/K}(\lbrace K_i, f_i \rbrace)$ given in Lemma [5.21.](#page-26-1) Now, by

Lemma [5.5,](#page-15-2) for this $\sigma_U \in \text{Gal}(L/K)$, there exists $U_{\sigma_U} \in U^{\circ}_{\mathbb{X}(L/K)}$, which is unique modulo $U_{\mathbb{X}(L/K)}$, satisfying

$$
U_{\sigma_U}^{1-\varphi} = \Pi_{\varphi;L/K}^{\sigma_U - 1}.
$$

Thus,

$$
U_{\sigma_U}^{1-\varphi} \, . Z_{L/K}(\{K_i, f_i\}) = U^{1-\varphi} \, . Z_{L/K}(\{K_i, f_i\}),
$$

by eq. [\(5.36\)](#page-27-0), which proves that

$$
U_{\sigma_U} Y_{L/K} = U Y_{L/K},\tag{5.37}
$$

by the definition of $Y_{L/K}$ given in eq. [\(5.31\)](#page-26-2). Moreover, as $U_{\mathbb{X}(L/K)} \subseteq Y_{L/K}$, this equality [\(5.37\)](#page-28-0) does not depend on the choice of U_{σ_U} modulo $U_{\mathbb{X}(L/K)}$. Now, for (ii), let $\sigma \in \text{Gal}(L/K)$. By Lemma [5.5,](#page-15-2) there exists $U_{\sigma} \in U^{\diamond}_{\mathbb{X}(L/K)}$, which is unique modulo $U_{\mathbb{X}(L/K)}$, such that

U_{\sigma}^{1-\varphi} = \Pi_{\varphi;L/K}^{\sigma-1}.
$$
\n(5.38)

For any such $U_{\sigma} \in U^{\circ}_{\tilde{\mathbb{X}}(L/K)}$, there exists a unique $\sigma_{U_{\sigma}} \in \text{Gal}(L/K)$ satisfying

$$
U_{\sigma}^{1-\varphi} \cdot Z_{L/K}(\lbrace K_i, f_i \rbrace) = \ell_{L/K}^{(\varphi)}(\sigma_{U_{\sigma}})
$$

by eq. [\(5.32\)](#page-26-3). Thus, by eq. [\(5.38\)](#page-28-1) and Lemma [5.21,](#page-26-1) it follows that

$$
\ell_{L/K}^{(\varphi)}(\sigma_{U_{\sigma}}) = \Pi_{\varphi;L/K}^{\sigma-1} \cdot Z_{L/K}(\lbrace K_i, f_i \rbrace) = \ell_{L/K}^{(\varphi)}(\sigma),

which proves that $\sigma_{U_{\sigma}} = \sigma$.

Lemma [5.23](#page-27-1) immediately yields

The following theorem follows from Lemma [5.22,](#page-27-2) Lemma [5.23,](#page-27-1) Theorem [5.6](#page-15-3) and from the fact that $U_{\mathbb{X}(L/K)}$ is a topological $Gal(L/K)$ -submodule of $Y_{L/K}$.

Theorem 5.24 (Fesenko). *Suppose that the local field* K *satisfies the condition given in eq. [\(5.26\)](#page-21-0). The mapping*

\Phi_{L/K}^{(\varphi)} : \text{Gal}(L/K) \to U_{\widetilde{\mathbb{X}}(L/K)}^{\diamondsuit}/Y_{L/K}
$$

defined for the extension L/K *is a bijection with the inverse*

$$
H_{L/K}^{(\varphi)}: U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond} / Y_{L/K} \to Gal(L/K).
$$

For every $\sigma, \tau \in Gal(L/K)$,

$$
\Phi_{L/K}^{(\varphi)}(\sigma\tau) = \Phi_{L/K}^{(\varphi)}(\sigma)\Phi_{L/K}^{(\varphi)}(\tau)^{\sigma}
$$
\n(5.39)

co-cycle condition is satisfied.

By Corollary [5.7,](#page-15-0) Theorem [5.24](#page-28-2) has the following consequence.

Corollary 5.25. *Define a law of composition* $*$ *on* $U^{\diamond}_{\widetilde{X}(L/K)}/Y_{L/K}$ *by*

\overline{U} * \overline{V} = \overline{U} . \overline{V}^{(\Phi_{L/K}^{(\varphi)})^{-1}(\overline{U})}

 $for\ every\ \overline{U} = U.Y_{L/K}, \overline{V} = V.Y_{L/K} \in U^{\infty}_{\widetilde{\mathbb{X}}(L/K)}/Y_{L/K}$ with $U, V \in U^{\infty}_{\widetilde{\mathbb{X}}(L/K)}$. *Then* $U^{\otimes}_{\mathbb{X}(L/K)}/Y_{L/K}$ *is a topological group under* **, and the map* $\Phi_{L/K}^{(\varphi)}$ *induces an isomorphism of topological groups*

\Phi_{L/K}^{(\varphi)} : \text{Gal}(L/K) \xrightarrow{\sim} U_{\tilde{\mathbb{X}}(L/K)}^{\circ} / Y_{L/K},
$$
\n(5.41)

where the topological group structure on $U^{\infty}_{\tilde{X}(L/K)}/Y_{L/K}$ is defined with respect *to the binary operation* $*$ *defined by eq.* (5.40) *.*

Definition 5.26. Let K be a local field satisfying the condition given in eq. (5.26) . Let L/K be a totally-ramified APF -Galois extension satisfying eq. [\(5.1\)](#page-12-0). The mapping

$$
\Phi_{L/K}^{(\varphi)} : \text{Gal}(L/K) \to U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond} / Y_{L/K},
$$

defined in Theorem [5.24,](#page-28-2) is called the *Fesenko reciprocity map for the extension* L/K .

For each $0 \leq i \in \mathbb{R}$, we have previously introduced the groups $\left(U^{\diamond}_{\mathbb{X}(L/K)}\right)$ $\big)^i$. For $0 \leq n \in \mathbb{Z}$, let

$$
Q_{L/K}^n = c_{L/K} \left(\left(U_{\widetilde{\mathbb{X}}(L/K)}^{\diamond} \right)^n U_{\mathbb{X}(L/K)} / U_{\mathbb{X}(L/K)} \cap \text{im}(\phi_{L/K}^{(\varphi)}) \right), \tag{5.42}
$$

which is a subgroup of $(U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}$ $\int^{n} Y_{L/K}/Y_{L/K}$. Now, Fesenko ramification theorem, stated in Theorem [5.8,](#page-16-2) can be reformulated for the reciprocity map $\Phi_{L/K}^{(\varphi)}$ corresponding to the extension L/K as follows.

Theorem 5.27 (Ramification theorem). *Suppose that the local field* K *satisfies the condition given in eq.* [\(5.26\)](#page-21-0)*.* For $0 \le n \in \mathbb{Z}$, let $Gal(L/K)_n$ denote the n^{th} *higher ramification subgroup of the Galois group Gal*(L/K) *corresponding to the* APF-Galois sub-extension L/K of K_{φ}/K in the lower numbering. Then, there *exists the inclusion*

$$
\Phi^{(\varphi)}_{L/K}\left(\textit{Gal}(L/K)_n-\textit{Gal}(L/K)_{n+1}\right)\subseteq \left(U_{{\mathbb X}(L/K)}^\diamond\right)^n Y_{L/K}/Y_{L/K}-Q_{L/K}^{n+1}.
$$

Proof. Let $\tau \in \text{Gal}(L/K)_n$. The first half of the proof of Proposition 1 in $\int_0^n Y_{L/K}/Y_{L/K}$. Now, let $\overline{U} = U.Y_{L/K}$ [\[2\]](#page-43-1) shows that $\Phi_{L/K}^{(\varphi)}(\tau) \in \left(U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)} \right)$ $Q_{L/K}^{n+1}$, where $U \in U^{\otimes}_{\mathbb{X}(L/K)}$. Then, by the definition of $Q_{L/K}^{n+1}$, there exists $\int_{0}^{n+1} U_{\mathbb{X}(L/K)}$ and $\tau \in \text{Gal}(L/K)$ such that $c_{L/K}(\overline{V}) = \overline{U}$ and $V\,\in\,\left(U^\diamond_{\widetilde{\mathbb{X}}(L/K)}\right)$ $\phi_{L/K}^{(\varphi)}(\tau) = \overline{V}$, where $\overline{V} = V.U_{\mathbb{X}(L/K)}$. So, $\Phi_{L/K}^{(\varphi)}(\tau) = \overline{U}$. The second half of the proof of Proposition 1 in [\[2\]](#page-43-1) now proves that $\tau \in \text{Gal}(L/K)_{n+1}$. \Box

Now, let M/K be a Galois sub-extension of L/K . Thus, there exists the chain of field extensions

K\subseteq M\subseteq L\subseteq K_{\varphi},
$$

where M is a totally-ramified APF -Galois extension over the local field K satisfying the condition given in eq. [\(5.26\)](#page-21-0) by Lemma [3.3.](#page-8-0)

Now, the basic ascending chain of sub-extensions in L/K fixed in eq. [\(5.27\)](#page-21-1) restricted to M

K = K_o \cap M \subseteq K_1 \cap M \subseteq \dots \subseteq K_i \cap M \subseteq \dots \subseteq L \cap M = M \tag{5.43}
$$

is *almost* a basic ascending chain of sub-extensions in M/K (almost in the sense that, there may exist elements $0 \leq i \in \mathbb{Z}$ such that $K_i \cap M = K_{i+1} \cap M$). In fact, for each $0 \leq i \in \mathbb{Z}$, the extension $K_i \cap M/K$ is clearly Galois. For each $0 \leq i \in \mathbb{Z}$, consider the surjective homomorphism

$$
r_{K_{i+1}\cap M}: \mathrm{Gal}(K_{i+1}/K_i)\twoheadrightarrow \mathrm{Gal}(K_{i+1}\cap M/K_i\cap M)
$$

defined by the restriction to $K_{i+1} \cap M$ as

$$
\sigma \mapsto \sigma \mid_{K_{i+1} \cap M}
$$

for every $\sigma \in \text{Gal}(K_{i+1}/K_i)$. As $\text{Gal}(K_{i+1}/K_i)$ is cyclic of prime order $p =$ char(κ_K) (resp. of order relatively prime to p) in case $1 \leq i \in \mathbb{Z}$ (resp. in case $i = 0$), it follows that Gal $(K_{i+1} \cap M/K_i \cap M)$ is cyclic of order p or 1 (resp. of order relatively prime to p) in case $1 \leq i \in \mathbb{Z}$ (resp. in case $i = 0$). Now fix this almost basic ascending chain of sub-extensions in M/K introduced in eq. [\(5.43\)](#page-30-0). Observe that, for each $1 \leq i \in \mathbb{Z}$, $\sigma_i \mid_{\widetilde{M}} \in \text{Gal}(M/K)$ satisfies

$$
\langle \sigma_i |_{\widetilde{M}} \rangle |_{K_i \cap M} = \sigma_i |_{K_i \cap M} = \text{Gal}(K_i \cap M / K_{i-1} \cap M)
$$

as the restriction map $r_{K_i \cap M}$: Gal(K_i/K_{i-1}) \rightarrow Gal($K_i \cap M/K_{i-1} \cap M$) is a surjective homomorphism and $< \sigma_i |_{K_i}>= \text{Gal}(K_i/K_{i-1})$. As usual, we set $\widetilde{K_i \cap M} = (K_i \cap M)\widetilde{K}$. Note that, for each $1 \leq k \in \mathbb{Z}$, the norm map

induces a homomorphism

defined by

\widetilde{N}_{K_{k+1}/K_{k+1}\cap M}^*: u.U_{\widetilde{K}_{k+1}}^{\sigma_{k+1}-1} \mapsto \widetilde{N}_{K_{k+1}/K_{k+1}\cap M}(u).U_{K_{k+1}\cap M}^{\sigma_{k+1}\cap M},
$$

for every $u \in U_{\widetilde{K}_{k+1}}$, as $\widetilde{N}_{K_{k+1}/K_{k+1} \cap M} \left(U_{\widetilde{K}_{k+1}}^{\sigma_{k+1}-1} \right) \subseteq U_{K_{k+1} \cap M}^{\sigma_{k+1} \mid \widetilde{M}}$ $\overbrace{K_{k+1}\cap M}^{C_{k+1}\cap M}$. Thus, the following square, where the upper and lower horizontal arrows are defined by eq.s [\(5.28\)](#page-22-1) and [\(5.29\)](#page-22-2),

\operatorname{Gal}(K_{k+1}/K_k) \xrightarrow{\Xi_{K_{k+1}/K_k}} U_{\widetilde{K}_{k+1}} / U_{\widetilde{K}_{k+1}}^{\sigma_{k+1}-1}

\n
$$
\downarrow^{\tau_{K_{k+1}\cap M}} \qquad \qquad \downarrow^{\tau_{K_{k+1}\cap M}} \qquad \qquad \downarrow^{\widetilde{N}_{K_{k+1}/K_{k+1}\cap M}}
$$
\n
$$
\operatorname{Gal}(K_{k+1}\cap M/K_k\cap M) \xrightarrow{\Xi_{K_k}\uparrow^{\tau_{M}/K_k}} U_{K_{k+1}\cap M}^{\sigma_{k+1}\cap M} / U_{K_{k+1}\cap M}^{\sigma_{k+1}\cap M},
$$

is commutative, as $N_{K_{k+1}/K_{k+1}\cap M}(\pi_{K_{k+1}}) = \pi_{K_{k+1}\cap M}$ by the *norm coherence* of the Lubin-Tate labelling $(\pi_{K'})_K \subseteq K'$ $\subset K_{\varphi}$. Hence,

Now, we shall define an arrow

Let $\{\lambda_j\}$ be a system of topological multiplicative generators of the topological \mathbb{Z}_p -module $\prod_{1\leq i\leq k} U^{\sigma_i-1}_{\widetilde{K}_k}$ $\frac{d\sigma_i-1}{\tilde{K}_k}$ satisfying the following property. Thus, the collection $\{\widetilde{N}_{K_k/K_k \cap M}(\lambda_j)\}\$ is a system of topological multiplicative generators of the topological \mathbb{Z}_p -module $\prod_{1 \le i \le k} U_{\widetilde{K \cap \mathcal{M}}}^{\sigma_i}$ $\overbrace{K_k \cap M}^{0 \, i}$. Moreover, note that $\widetilde{N}_{K_k/K_k \cap M}(\lambda_*)^{p^m} = 1$. Thus, $\widetilde{N}_{K_k/K_k \cap M}(\lambda_*)$ is in the torsion-part $\left(\prod_{1\leq i\leq k} U^{\sigma_i}\right)^{\sigma_i-1}_{\widetilde{K}_i\cap M}$ $\widetilde{K_k \cap M}$ $\overline{ }$. For the remaining λ_j $(j \neq *)$, the collector tion $\left\{ \widetilde{N}_{K_{k}/K_{k}\cap M}(\lambda_{j})\right\}$ is topologically independent over \mathbb{Z}_p . \begin{split} \operatorname{Pr}_{\widetilde{K_{j}\cap M}} \circ f_{i}^{(M/K)}(w) &= \operatorname{Pr}_{\widetilde{K_{j}\cap M}} \circ \widetilde{\mathcal{N}}_{L/M} \left(f_{i}^{(L/K)}(v) \right) \\ &= \widetilde{N}_{K_{j}/K_{j}\cap M} \left(\operatorname{Pr}_{\widetilde{K}_{j}} \circ f_{i}^{(L/K)}(v) \right) \\ &= \widetilde{N}_{K_{j}/K_{j}\cap M} \left((g_{j-1}^{(L/K)} \circ \cdots \circ g_{i}^{(L/K)})(v) \right) \\ &= \left(g_{j-1}^{(M/K)} \circ \cdots \circ g_{i}^{(M/K)} \right) \left(\widetilde{N}_{K_{i}/K_{i}\cap M}(v) \right), \end{split}

Now, let F/K be a finite sub-extension of L/K . Then, as F is *compatible* with (K, φ) , in the sense of [\[13\]](#page-43-5) pp. 89, we may fix the Lubin-Tate splitting over F to be $\varphi_F = \varphi_K = \varphi$. Thus, there exists the chain of field extensions

where L is a totally-ramified APF -Galois extension over F by Lemma [3.3.](#page-8-0) As $\mu_p(K^{sep}) = \mu_p(F^{sep})$, the inclusion $\mu_p(F^{sep}) \subset F$ is satisfied. That is, the local field F satisfies the condition given by eq. [\(5.26\)](#page-21-0).

Now, the basic ascending chain of sub-extensions in L/K fixed in eq. [\(5.27\)](#page-21-1) base changed to F

\begin{matrix} U^{\diamond}_{\widetilde{\mathbb{X}}(L/F)}/U_{\mathbb{X}(L/F)} \xrightarrow{\text{can.}} U^{\diamond}_{\widetilde{\mathbb{X}}(L/F)}/Y_{L/F} \\ \downarrow^{\lambda_{F/K}} & \downarrow^{\lambda_{F/K}} \\ U^{\diamond}_{\mathbb{X}(L/K)}/U_{\mathbb{X}(L/K)} \xrightarrow{\text{can.}} U^{\diamond}_{\widetilde{\mathbb{X}}(L/K)}/Y_{L/K} \end{matrix}

is commutative, which is obvious. Then pasting this square with the square eq. [\(5.24\)](#page-20-3) as

the commutativity of the square eq. [\(5.65\)](#page-42-1) follows.

If L/K is furthermore a finite extension, then the square

commutes. Thus the inverse $H_{L/K}^{(\varphi)} = (\Phi_{L/K}^{(\varphi)})^{-1}$ of the Fesenko reciprocity *map* $\Phi_{L/K}^{(\varphi)}$ *defined for* L/K *is the generalization of the Hazewinkel map for the totally-ramified APF-Galois sub-extensions* L/K *of* K_{φ}/K *under the assumption that the local field* K *satisfies the condition given by eq. [\(5.26\)](#page-21-0)*.
