

# ON FANO THREEFOLDS WITH CANONICAL GORENSTEIN SINGULARITIES

ABSTRACT. We classify three-dimensional Fano varieties with canonical Gorenstein singularities of degree bigger than 64.

## 1. INTRODUCTION

In the present article we study three-dimensional Fano varieties<sup>1</sup> with canonical Gorenstein singularities. We consider such varieties from the view point of the value of their anti-canonical degree.

It follows from the main result in [2] that the anti-canonical degree of Fano threefolds with canonical Gorenstein singularities is bounded. Under the stronger restrictions on singularities there is a precise estimate:

**Theorem 1.1** ([12], [13], [22], [20]). *Let  $X$  be a non-singular Fano threefold. Then  $-K_X^3 \leq 64$  with equality only for  $\mathbb{P}^3$ .*

For Fano threefolds with terminal Gorenstein singularities we have the following result:

**Theorem 1.2** ([23]). *Let  $X$  be a Fano threefold with terminal Gorenstein singularities. Then  $X$  can be deformed to a non-singular Fano threefold. In particular,  $-K_X^3 \leq 64$ .*

Much more general result in the direction of getting a sharp bound for the degree of Fano threefolds with canonical Gorenstein singularities was obtained in [26]:

**Theorem 1.3.** *Let  $X$  be a Fano threefold with canonical Gorenstein singularities. Then  $-K_X^3 \leq 72$  with equality only for  $\mathbb{P}(3, 1, 1, 1)$  and  $\mathbb{P}(6, 4, 1, 1)$ .*

It was conjectured in the paper [26] that for the Fano threefold  $X$  with only cDV singularities the estimate  $-K_X^3 \leq 64$  holds. In the present article we will prove the following

**Theorem 1.4.** *Let  $X$  be a Fano threefold with canonical Gorenstein singularities such that  $64 < -K_X^3 \leq 70$ . Then  $X$  is one of the following:*

- *The image under birational projection of the anti-canonically embedded Fano threefold  $\mathbb{P}(6, 4, 1, 1) \subset \mathbb{P}^{38}$  from a singular point on  $\mathbb{P}(6, 4, 1, 1)$  of type cDV. In this case  $-K_X^3 = 70$  and  $X$  has non-cDV singularities;*
- *The anti-canonical image of the rational scroll  $\text{Proj}(\mathcal{O}_{\mathbb{P}^1}(5) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$ . In this case  $-K_X^3 = 66$  and  $X$  has non-cDV singularities.*

*Remark 1.5.* Threefold  $X$  with  $-K_X^3 = 70$  was found by I. Cheltsov.

It follows easily from the Riemann–Roch formula on the Fano threefold  $X$  that  $-K_X^3$  is an even number. Thus, Theorems 1.3 and 1.4 exhaust all Fano threefolds with canonical Gorenstein singularities of degree bigger than 64. Moreover, since threefolds  $\mathbb{P}(3, 1, 1, 1)$  and  $\mathbb{P}(6, 4, 1, 1)$  have singularities worse than cDV, from Theorems 1.3 and 1.4 we deduce

**Corollary 1.6.** *Let  $X$  be a Fano threefold with only cDV singularities. Then  $-K_X^3 \leq 64$ .*

Corollary 1.6 appears to be a justification for the following conjecture in [26]:

**Conjecture 1.7.** *Let  $X$  be a Fano threefold with only cDV singularities. Then  $X$  has a smoothing by a flat deformation.*

Let us give the following

**Definition 1.8.** Threefold  $U$  with canonical singularities is called a *Fano–Enriques threefold* if  $-K_U$  is not Cartier but  $-K_U \equiv H$  for some ample Cartier divisor  $H$ .

*Remark 1.9.* The study of threefolds possessing an ample Cartier divisor which is a non-singular Enriques surface was initiated by G. Fano in [9] (see also [5] and [6]). It is easy to see (see for example [4]) that if such a threefold has canonical singularities, then it is a Fano–Enriques threefold. On the other hand, according to [25, Proposition 3.1] and [25, Proposition 3.3] general element  $S \in |H|$  on Fano–Enriques threefold  $U$  has only Du Val singularities and the minimal resolution of  $S$  is an Enriques surface. Moreover, if  $U$  has isolated singularities and  $H^3 \neq 2$ , then general element in  $|H|$  is a non-singular Enriques surface (see [25, Corollary 3.7]).

According to [4] the equivalence  $2(K_U + S) \sim 0$  holds. Thus, on  $U$  we have  $-K_U \sim_{\mathbb{Q}} H$ . Moreover, by [3, Proposition 14] if  $-K_U \sim_{\mathbb{Q}} nH'$  for some integer  $n > 0$  and ample Cartier divisor  $H'$ , then  $n = 1$ . In particular,  $\mathbb{Q}$ -Fano threefolds of Fano index 1 form a subclass of Fano–Enriques threefolds.  $\mathbb{Q}$ -Fano threefolds of Fano index 1 with cyclic quotient singularities were classified in [1] and [31].

Let  $U$  be a Fano–Enriques threefold such that  $-K_U \equiv H$  for some Cartier divisor  $H$ . By [25, Lemma 2.2] the value  $g := \frac{1}{2}H^3 + 1$  is an integer number. Let us call it the *genus* of  $U$ . The problem of genus bound for Fano–Enriques threefolds was investigated in [27] and [16]. In [27] the sharp bound  $g \leq 17$  was proved under the assumption that  $U$  has only isolated singularities.

In our setting we have

**Corollary 1.10.** *Let  $U$  be a Fano–Enriques threefold of genus  $g$ . Then  $g \leq 17$ .*

*Proof.* Since  $2(K_U + S) \sim 0$  for  $S \in |H|$  (see Remark 1.9), we can take a global log canonical cover  $\pi : X \rightarrow U$  with respect to  $K_U + S$  (see [15]). Morphism  $\pi$  has degree 2 and the equivalence  $\pi^*(K_U + S) \sim 0$  holds. In particular,  $X$  is a Fano threefold with canonical Gorenstein singularities and degree  $-K_X^3 = 4g - 4$ . Moreover,  $\pi$  is ramified precisely in that points on  $U$  where  $K_U$  is not Cartier. Since  $-K_U \sim_{\mathbb{Q}} S$  and  $S$  is normal, the set of such points is finite. Hence the Galois involution of  $\pi$  induces on  $X$  an automorphism  $\tau$  of order 2 such that  $\tau$  acts freely in codimension 2.

Suppose that  $g > 17$ . Then we get  $-K_X^3 > 64$ . Since  $-K_X^3$  is divisible by 4, from Theorems 1.3 and 1.4 we deduce that  $X = \mathbb{P}(3, 1, 1, 1)$  or  $\mathbb{P}(6, 4, 1, 1)$ .

If  $X = \mathbb{P}(3, 1, 1, 1)$ , then the linear system  $|-\frac{1}{2}K_X|$  gives an embedding of  $X$  in  $\mathbb{P}^{10}$  such that the image of  $X$  is the cone over del Pezzo surface of degree 9. Moreover, since  $|-\frac{1}{2}K_X|$  is  $\tau$ -invariant, there is a  $\tau$ -invariant hyperplane section  $S$  of  $X \subset \mathbb{P}^{10}$  not passing through the vertex. Then  $S \simeq \mathbb{P}^2$  and hence  $\tau$  fixes infinitely many points on  $S$  which is impossible.

Thus,  $X = \mathbb{P}(6, 4, 1, 1)$ . Take weighted projective coordinates  $x_0, x_1, x_2, x_3$  on  $X$  such that  $\deg x_0 = 6, \deg x_1 = 4, \deg x_2 = \deg x_3 = 1$  and  $x_i$  is an eigen function with an eigen value  $\pm 1$  with respect to  $\tau, 1 \leq i \leq 4$ . If both  $x_0, x_1$  ( $x_2, x_3$ , respectively) have the same eigen value, then the curve given by equations  $x_2 = x_3 = 0$  ( $x_0 = x_1 = 0$ , respectively) consists of  $\tau$ -fixed points which is impossible. Thus, we can assume that  $\tau$  is given by the following formula

$$[x_0 : x_1 : x_2 : x_3] \mapsto [x_0 : -x_1 : x_2 : -x_3].$$

But again the curve given by equations  $x_1 = x_3 = 0$  consists of  $\tau$ -fixed points. The obtained contradiction completes the proof of Corollary 1.10.  $\square$

We prove Theorem 1.4 following the ideas of [26]. To be more precise, for the given Fano threefold  $X$  satisfying the conditions of Theorem 1.4 we take a *terminal  $\mathbb{Q}$ -factorial modification*

$\varphi : Y \rightarrow X$ . Here morphism  $\varphi$  is crepant and threefold  $Y$  has terminal factorial singularities. In particular,  $-K_Y^3 = -K_X^3$  and thus all the considerations can be lifted to  $Y$ .

For  $Y$  the complete description of  $K$ -negative extremal contractions can be obtained. With this description at hand in Section 3 we find  $X$  with  $-K_X^3 = 70$  and non-cDV singularities and reduce the proof of Theorem 1.4 to the case when there are no  $K$ -negative extremal contractions of  $Y$  to threefolds with terminal factorial singularities having nef and big anti-canonical divisor. This and results in [26] imply that the initial Fano threefold  $X$  is singular along a line or contains a plane.

In Section 4 following [26] we obtain a Mori fibre space  $W$  with a birational map  $W \dashrightarrow X$  given by the linear subsystem in  $|-K_W|$ . It is straightforward from [26] that  $W$  is not a  $\mathbb{Q}$ -Fano threefold.

In Section 5 for  $W$  a del Pezzo fibration we find  $X$  with  $-K_X^3 = 66$  and non-cDV singularities and reduce the proof of Theorem 1.4 to the case when  $W$  is a conic bundle. Following [26] we will exclude this case in Section 6.

## 2. BASIC NOTIONS AND STATEMENTS

We use standard notions and facts from the Minimal Model Program (see for example [18]). Recall that algebraic variety  $X$  is called a *Fano variety* if divisor  $-K_X$  is an ample  $\mathbb{Q}$ -Cartier divisor. If divisor  $-K_X$  is only nef and big, then  $X$  is called a *weak Fano variety*.

In the present article we consider three-dimensional (weak) Fano varieties only with (no more than) canonical Gorenstein singularities.

Let  $X$  be a Fano threefold. From the Riemann–Roch Formula and Kawamata–Vieweg Vanishing Theorem it is easy to find the dimension of the anti-canonical linear system on  $X$  (see [?]):

$$\dim |-K_X| = -\frac{1}{2}K_X^3 + 2$$

The constant  $-K_X^3$  is called the *degree* of  $X$  and  $g := -\frac{1}{2}K_X^3 + 1$  is the *genus* of  $X$ . Thus,  $\dim |-K_X| = g + 1$  and  $-K_X^3 = 2g - 2$ . In particular,  $-K_X^3$  is an even number and for  $X$  satisfying the conditions of Theorem 1.4 we have  $-K_X^3 \in \{66, 68, 70\}$ .

Furthermore, we have

**Theorem 2.1** ([30]). *A general member  $L \in |-K_X|$  has only Du Val singularities.*

**Proposition 2.2** ([14]). *In the above notation, if  $\text{Bs}|-K_X| \neq \emptyset$ , then  $-K_X^3 \leq 22$ .*

For the movable anti-canonical linear system  $|-K_X|$  let us denote by  $\varphi_{|-K_X|} : X \dashrightarrow \mathbb{P}^{g+1}$  the corresponding rational map.

**Proposition 2.3** ([24, Theorem 1.5]). *In the above notation, if  $\varphi_{|-K_X|}$  is a morphism which is not an embedding, then  $-K_X^3 \leq 40$ .*

**Proposition 2.4** ([24, Theorem 1.6]). *In the above notation, if  $\varphi_{|-K_X|}$  is an embedding and  $\varphi_{|-K_X|}(X)$  is not an intersection of quadrics, then  $-K_X^3 \leq 54$ .*

*Remark 2.5.* From Propositions 2.2–2.4 we deduce that for the given Fano threefold  $X$  with  $-K_X^3 \in \{66, 68, 70\}$  the linear system  $|-K_X|$  is free and determines an embedding  $\varphi_{|-K_X|} : X \rightarrow \mathbb{P}^{g+1}$  with  $g \in \{34, 35, 36\}$  such that  $X_{2g-2} := \varphi_{|-K_X|}(X)$  is an intersection of quadrics.

Now let us consider several birational properties of the given Fano threefold  $X$ .

**Theorem 2.6** ([18]). *Let  $V$  be a threefold with only canonical singularities. Then there exists a threefold  $W$  with only terminal  $\mathbb{Q}$ -factorial singularities and a birational contraction  $\phi : W \rightarrow V$  such that  $K_W = \phi^* K_V$ . Such  $W$  (or  $\phi$ ) is called a terminal  $\mathbb{Q}$ -factorial modification of  $V$ .*

*Remark 2.7.* In the notation of Theorem 2.6, let  $W$  and  $W'$  be two terminal  $\mathbb{Q}$ -factorial modifications of  $V$ . Then  $W$  and  $W'$  are relative minimal models over  $V$  (see [18]). Thus, the birational map  $W \dashrightarrow W'$  is either an isomorphism or a composition of flops over  $V$  (see [17, Theorem 4.3]).

Applying Theorem 2.6 to  $X$  we obtain a birational contraction  $\varphi : Y \rightarrow X$  such that  $K_Y = \varphi^* K_X$  and  $Y$  is a weak Fano threefold with terminal Gorenstein  $\mathbb{Q}$ -factorial singularities and  $-K_Y^3 = -K_X^3$ .

Furthermore, we have

**Lemma 2.8** ([15, Lemma 5.1]). *In the above notation, threefold  $Y$  has factorial singularities.*

*Remark 2.9.* Conversely, for any weak Fano threefold  $Y$  with terminal factorial singularities its multiple anti-canonical image  $X = \varphi_{|-nK_Y|}(Y)$  for some  $n \in \mathbb{N}$  is a Fano threefold such that  $K_Y = \varphi^* K_X$ . In particular,  $X$  has canonical Gorenstein singularities (see [15]).

**Proposition 2.10** ([26, Lemmas 4.2, 4.3]). *In the above notation, the Mori cone  $\overline{NE}(Y)$  is polyhedral and generated by contractible extremal rays (i.e., rays  $R$  for which there exists a contraction  $\varphi_R : Y \rightarrow Y'$  onto the normal variety  $Y'$  such that the image of a curve  $C$  is a point if and only if  $[C] \in R$  for the class of numerical equivalence of  $C$ ).*

*Remark 2.11.* From Theorem 1.2 for the given Fano threefold  $X$  with  $-K_X^3 \in \{66, 68, 70\}$  we deduce that  $X \neq Y$ . In particular, we have  $\rho(Y) > 1$  for the Picard number of  $Y$ . Hence according to Proposition 2.10 the anti-canonical divisor  $-K_Y$  defines a face of the Mori cone  $\overline{NE}(Y)$  and  $\varphi : Y \rightarrow X$  is the contraction of this face.

**Example 2.12.** Let us consider the  $\mathbb{P}^1$ -bundle  $Y = \text{Proj}(\mathcal{O}_{\mathbb{P}^2} \oplus \mathcal{O}_{\mathbb{P}^2}(3))$  over  $\mathbb{P}^2$ . For the tautological line bundle  $\mathcal{O}_Y(1)$  the linear system  $|\mathcal{O}_Y(1)|$  determines a birational contraction  $\varphi : Y \rightarrow X$  of the negative section on  $Y$ . Since  $K_Y \sim \mathcal{O}_Y(2)$ , we have  $K_Y = \varphi^* K_X$ . This implies that  $X$  is a Fano threefold with canonical Gorenstein singularities (see Remark 2.9) and  $Y$  is a terminal  $\mathbb{Q}$ -factorial modification of  $X$ . Moreover, by construction  $X$  has index 2 and degree 72. It then follows from Theorem 1.3 that  $X \simeq \mathbb{P}(3, 1, 1, 1)$ .

*Remark 2.13.* In the notation of Example 2.12,  $\varphi$  is an extremal contraction and  $\varphi$ -exceptional locus is isomorphic to  $\mathbb{P}^2$ . This in particular implies that there are no small  $K$ -trivial extremal contractions on  $Y$ . Then according to Remark 2.7 all terminal  $\mathbb{Q}$ -factorial modifications of  $\mathbb{P}(3, 1, 1, 1)$  are isomorphic to  $Y$ .

**Example 2.14.** Let us consider the weighted projective space  $X = \mathbb{P}(6, 4, 1, 1)$ . The singular locus of  $X$  is a curve  $L \simeq \mathbb{P}^1$  such that for two points  $P$  and  $Q$  on  $L$  singularities  $P \in X$ ,  $Q \in X$  are of types  $\frac{1}{6}(4, 1, 1)$ ,  $\frac{1}{4}(2, 1, 1)$ , respectively, and for every point  $O \in L \setminus \{P, Q\}$  singularity  $O \in X$  is analytically isomorphic to  $(0, o) \in \mathbb{C}^1 \times U$ , where  $o \in U$  is a singularity of type  $\frac{1}{2}(1, 1)$  (see [10, 5.15]). Since  $-K_X \sim \mathcal{O}_X(12)$  is ample, this implies that  $X$  is a Fano threefold with canonical Gorenstein singularities.

Let  $\sigma_1 : Y_1 \rightarrow X$  be the blow up at the point  $P$  with weights  $\frac{1}{6}(4, 1, 1)$ . Then the singular locus of the threefold  $Y_1$  is a curve  $L_1$  such that for two points  $P_1$  and  $Q_1$  on  $L_1$  singularities  $P_1 \in Y_1$ ,  $Q_1 \in Y_1$  are of type  $\frac{1}{4}(2, 1, 1)$  and for every point  $O \in L_1 \setminus \{P_1, Q_1\}$  singularity  $O \in Y_1$  is analytically isomorphic to  $(0, o) \in \mathbb{C}^1 \times U$ , where  $o \in U$  is a singularity of type  $\frac{1}{2}(1, 1)$ .

Let  $\sigma_2 : Y_2 \rightarrow Y_1$  be the blow up at the points  $P_1$  and  $Q_1$  with weights  $\frac{1}{4}(2, 1, 1)$ . Then the singular locus of the threefold  $Y_2$  is a curve  $L_2 \simeq \mathbb{P}^1$  such that for every point  $O$  on  $L_2$  singularity  $O \in Y_2$  is analytically isomorphic to  $(0, o) \in \mathbb{C}^1 \times U$ , where  $o \in U$  is a singularity of type  $\frac{1}{2}(1, 1)$ .

Finally, the blow up  $\sigma_3 : Y \rightarrow Y_2$  of the ideal of the curve  $L_2$  on  $Y_2$  leads to the non-singular threefold  $Y$  and the birational contraction  $\varphi : Y \rightarrow X$ . By construction morphisms  $\sigma_i$  are crepant,  $1 \leq i \leq 3$ , and morphism  $\varphi$  is a composition of  $\sigma_i$ . This implies that  $K_Y = \varphi^* K_X$  and  $Y$  is a terminal  $\mathbb{Q}$ -factorial modification of  $X$ .

*Remark 2.15.* In the notation of Example 2.12,  $\varphi$  is a composition of extremal contractions and  $\varphi$ -exceptional locus is of pure codimension 1. This in particular implies that there are no small  $K$ -trivial extremal contractions on  $Y$ . Then according to Remark 2.7 all terminal  $\mathbb{Q}$ -factorial modifications of  $\mathbb{P}(6, 4, 1, 1)$  are isomorphic to  $Y$ .

In the above notation, let us consider a  $K$ -negative extremal contraction  $f : Y \rightarrow Y'$ . We have

**Proposition 2.16** ([26, Propositions 4.11, 5.2]). *If  $\dim Y' < \dim Y$ , then  $-K_X^3 \notin \{66, 68, 70\}$ .*

Let us assume now that contraction  $f$  is birational. Then by [21, (2.3.2)] morphism  $f$  is divisorial. Let  $E$  be the  $f$ -exceptional divisor.

From the classification of extremal rays on terminal factorial threefolds in [7] we obtain

**Lemma 2.17.** *In the above notation, if  $f(E)$  is a point, then one of the following holds:*

- $Y'$  has only terminal factorial singularities and is a weak Fano threefold with  $-K_{Y'}^3 > -K_Y^3$ ;
- $E \simeq \mathbb{P}^2$ ,  $\mathcal{O}_E(E) \simeq \mathcal{O}_{\mathbb{P}^2}(2)$  and  $f(E) \in Y'$  is a point of type  $\frac{1}{2}(1, 1, 1)$ .

**Corollary 2.18.** *In the assumptions of Lemma 2.17, if  $f(E) \in Y'$  is a point of type  $\frac{1}{2}(1, 1, 1)$ , then  $\varphi(E)$  is a plane on  $X$  (a surface  $\Pi \simeq \mathbb{P}^2$  such that  $K_X^2 \cdot \Pi = 1$ ).*

*Proof.* Since  $E \simeq \mathbb{P}^2$  and  $\mathcal{O}_E(E) \simeq \mathcal{O}_{\mathbb{P}^2}(2)$ , we have

$$K_Y^2 \cdot E = \left( f^* K_{Y'} + \frac{1}{2} E \right)^2 \cdot E = \frac{1}{4} (\mathcal{O}_{\mathbb{P}^2}(2))^2 = 1.$$

This implies that  $\varphi(E)$  is a surface  $\Pi \simeq \mathbb{P}^2$  on  $X$  with  $K_X^2 \cdot \Pi = 1$ . □

**Lemma 2.19.** *In the above notation, if  $f(E)$  is a curve, then  $Y'$  has only terminal factorial singularities and one of the following holds:*

- $Y'$  is a weak Fano threefold with  $-K_{Y'}^3 \geq -K_Y^3$ ;
- For  $C := f(E)$  we have  $K_{Y'} \cdot C > 0$  and  $C$  is the only curve having positive intersection with  $K_{Y'}$ . In this case  $C \simeq \mathbb{P}^1$  and either  $E \simeq \mathbb{P}^1 \times \mathbb{P}^1$  or  $\mathbb{F}_1$ .

*Sketch of the proof.* We use the arguments from the proof of Proposition-definition 4.5 in [26]. According to [7] threefold  $Y'$  is non-singular near  $C$  and  $f$  is the blow up of  $C$ . This in particular implies that  $Y'$  has only terminal factorial singularities.

We have  $K_Y = f^* K_{Y'} + E$  and

$$K_Y^3 = K_{Y'}^3 + 3f^* K_{Y'} \cdot E^2 + E^3.$$

If  $Y'$  is a weak Fano threefold, then

$$0 \leq (-K_Y)^2 \cdot E = 2f^* K_{Y'} \cdot E^2 + E^3, \quad 0 \leq (-K_Y) \cdot (-f^* K_{Y'}) \cdot E = f^* K_{Y'} \cdot E^2.$$

This gives the inequality  $-K_Y^3 \geq -K_{Y'}^3$ .

Now, if  $Y'$  is not a weak Fano threefold, then  $K_{Y'} \cdot Z > 0$  for some irreducible curve  $Z$ . It is easy to see that  $Z = C$ . Then from Lemmas 4.2 and 4.3 in [26] and Corollary 1.3 in [21] we get  $C \simeq \mathbb{P}^1$ .

Thus,  $E \simeq \mathbb{F}_n$  for some  $n \geq 0$ . Since  $-K_Y|_E$  is a section of the fibration  $E \rightarrow C$ , we can write

$$-K_Y|_E \sim h + (n + a)l,$$

where  $h$  is the negative section and  $l$  is a fibre. We have  $a \geq 0$  because  $-K_Y|_E$  is nef.

Thus, we obtain

$$0 > -K_{Y'} \cdot C = K_Y^2 \cdot E - 2 + 2p_a(C) = (-K_Y|_E)^2 - 2 = n + 2a - 2,$$

which implies that  $a = 0$  and  $n \leq 1$ .  $\square$

**Corollary 2.20.** *In the assumptions of Lemma 2.19,*

- *If  $E \simeq \mathbb{P}^1 \times \mathbb{P}^1$ , then  $\varphi(E)$  is a line on  $X$  (a curve  $\Gamma \simeq \mathbb{P}^1$  such that  $-K_X \cdot \Gamma = 1$ ) and  $X$  is singular along  $\varphi(E)$ ;*
- *If  $E \simeq \mathbb{F}_1$ , then  $\varphi(E)$  is a plane on  $X$  (a surface  $\Pi \simeq \mathbb{P}^2$  such that  $K_X^2 \cdot \Pi = 1$ ).*

*Proof.* In the notation from the proof of Lemma 2.19, if  $E \simeq \mathbb{P}^1 \times \mathbb{P}^1$ , then  $-K_Y \cdot h = 0$  and  $-K_Y \cdot l = 1$ . This implies that  $\varphi(E)$  is a curve  $\Gamma \simeq \mathbb{P}^1$  on  $X$  with  $-K_X \cdot \Gamma = 1$ .

If  $E \simeq \mathbb{F}_1$ , then  $-K_Y \cdot h = 0$  and  $h$  is the only curve on  $E$  having zero intersection with  $-K_Y$ . This implies that  $\varphi(E)$  is a surface  $\Pi \simeq \mathbb{P}^2$  on  $X$  with  $K_X^2 \cdot \Pi = K_Y^2 \cdot E = 1$ .  $\square$

Finally, recall that a normal three-dimensional singularity  $o \in V$  is called a *cDV singularity* if it is analytically isomorphic to a hypersurface singularity  $f(x, y, z) + tg(x, y, z) = 0$  in  $\mathbb{C}^4$  with coordinates  $x, y, z, t$ , where  $f(x, y, z) = 0$  is an equation of a Du Val singularity.

**Proposition 2.21** ([28]). *If  $o \in V$  is a cDV point, then the discrepancy of every prime divisor with center at  $o$  is strictly positive.*

**Corollary 2.22.** *If  $o \in V$  is an isolated cDV point, then it is terminal.*

**Proposition 2.23** ([28, Corollary 2.10]). *Suppose that  $V$  is projective. Then  $o \in V$  is a cDV point if and only if for general hyperplane section  $H$  through  $o$  singularity  $o \in H$  is Du Val.*

### 3. BEGINNING OF THE PROOF OF THEOREM 1.4: PRELIMINARY RESULTS

We use the notation and assumptions from Section 2. Let  $X$  be a Fano threefold satisfying the conditions of Theorem 1.4 and  $Y$  be its terminal  $\mathbb{Q}$ -factorial modification.

Fix a  $K$ -negative extremal contraction  $f : Y \rightarrow Y'$ . By Proposition 2.16 and [21, (2.3.2)] morphism  $f$  is birational with exceptional divisor  $E$ .

Throughout this section we will assume that  $Y'$  has terminal factorial singularities and  $-K_{Y'}$  is nef. According to Lemmas 2.17 and 2.19 this in particular implies that  $Y'$  is a weak Fano threefold.

By Remark 2.9  $Y'$  is a terminal  $\mathbb{Q}$ -factorial modification of some Fano threefold  $X'$  with canonical Gorenstein singularities. Let us denote by  $\psi : Y' \rightarrow X'$  the corresponding anti-canonical morphism.

**Lemma 3.1.** *In the above notation, if  $f(E)$  is a point and  $-K_{Y'}^3 = 72$ , then  $-K_Y^3 \notin \{66, 68, 70\}$ .*

*Proof.* By Theorem 1.3 threefold  $Y'$  is a terminal  $\mathbb{Q}$ -factorial modification either of  $\mathbb{P}(3, 1, 1, 1)$  or of  $\mathbb{P}(6, 4, 1, 1)$ . Then by Remarks 2.13 and 2.15  $Y'$  is non-singular.

According to [7] morphism  $f$  is the blow up of the maximal ideal of the point  $f(E) \in Y'$ . Since  $Y'$  is non-singular, this in particular implies that  $K_Y = f^*K_{Y'} + 2E$  and  $E^3 = 1$ . Then we get

$$-K_Y^3 = 72 - 8E^3 = 64.$$

$\square$

**Proposition 3.2.** *In the above notation, if  $f(E)$  is a curve and  $-K_{Y'}^3 = 72$ , then  $-K_Y^3 = 70$  and  $X$  is the image under birational projection of the anti-canonically embedded Fano threefold  $\mathbb{P}(6, 4, 1, 1) \subset \mathbb{P}^{38}$  from a singular point on  $\mathbb{P}(6, 4, 1, 1)$  of type cDV.*

*Proof.* By Theorem 1.3 threefold  $Y'$  is a terminal  $\mathbb{Q}$ -factorial modification either of  $\mathbb{P}(3, 1, 1, 1)$  or of  $\mathbb{P}(6, 4, 1, 1)$ . In particular, either  $X' = \mathbb{P}(3, 1, 1, 1)$  or  $\mathbb{P}(6, 4, 1, 1)$  (see Remark 2.11).

By Remarks 2.13 and 2.15 threefold  $Y'$  is isomorphic to that constructed either in Example 2.12 or in Example 2.14.

Set  $C := f(E)$ . According to [7] morphism  $f$  is the blow up of  $C$ .

**Lemma 3.3.** *In the above notation, we have  $X' \neq \mathbb{P}(3, 1, 1, 1)$ .*

*Proof.* Suppose that  $X' = \mathbb{P}(3, 1, 1, 1)$ . According to Example 2.12 the  $\psi$ -exceptional locus  $E_\psi$  is an irreducible divisor which is contracted to the singular point on  $X'$ .

We have  $E_\psi \cap C = \emptyset$ . Indeed, otherwise, since  $\psi(E_\psi)$  is a point, we can find a curve  $Z \subset Y$  such that  $K_{Y'} \cdot f_*Z = 0$  and  $E \cdot Z > 0$ . Then from the equality

$$K_Y = f^*K_{Y'} + E$$

we get  $K_Y \cdot Z > 0$ . This is impossible because  $-K_Y$  is nef.

Let us consider the following commutative diagram:

$$\begin{array}{ccc} Y & \xrightarrow{f} & Y' \\ \varphi \downarrow & & \downarrow \psi \\ X & \xleftarrow{f'} & X' \end{array}$$

Morphism  $\varphi$  is given by the linear system  $|-K_Y| = |f^*(-K_{Y'}) - E|$ . Hence the map  $\varphi \circ f^{-1}$  is given by the linear system  $|-K_{Y'} - C|$ . Since  $E_\psi \cap C = \emptyset$ , the map  $f'$  is given by the linear system  $|-K_{X'} - \psi(C)|$ . According to Propositions 2.2 and 2.3 threefold  $X'$  is anti-canonically embedded in  $\mathbb{P}^{38}$ . This implies that the curve  $\psi(C)$  is cut out on  $X'$  by some linear subspace  $V \subset \mathbb{P}^{38}$ .

On the other hand,  $X = X_{2g-2} \subset \mathbb{P}^{g+1}$  where  $g \in \{34, 35, 36\}$  (see Remark 2.5). Thus,  $\dim V \leq 2$  and  $-K_{X'} \cdot \psi(C) \leq 2$  because  $X'$  is an intersection of quadrics (see Proposition 2.4).

For  $X' = \mathbb{P}(3, 1, 1, 1)$  we have  $-K_{X'} \sim \mathcal{O}_{X'}(6)$  (see [10]). Hence

$$0 < \mathcal{O}_{X'}(1) \cdot \psi(C) \leq \frac{1}{3}.$$

This implies that the curve  $\psi(C)$  passes through the singular point on  $X'$  which is impossible because  $E_\psi \cap C = \emptyset$ .  $\square$

Thus,  $Y'$  is a terminal  $\mathbb{Q}$ -factorial modification of  $X' = \mathbb{P}(6, 4, 1, 1)$ . Let  $P$  and  $Q$  be two non-cDV points on  $X'$  introduced in Example 2.14.

**Lemma 3.4.** *In the above notation,  $\psi(C)$  is a point distinct from  $P$  and  $Q$ .*

*Proof.* Suppose that  $\psi(C)$  is a curve. Then for the  $\psi$ -exceptional locus  $E_\psi$  we have  $E_\psi \cap C = \emptyset$ . Indeed, otherwise we can find a curve  $Z \subset Y$  such that  $K_{Y'} \cdot f_*Z = 0$  and  $E \cdot Z > 0$ . Then from the equality

$$K_Y = f^*K_{Y'} + E$$

we get  $K_Y \cdot Z > 0$ . This is impossible because  $-K_Y$  is nef.

Now repeating word by word the arguments from the proof of Lemma 3.3 we obtain that  $-K_{X'} \cdot \psi(C) \leq 2$ . For  $X' = \mathbb{P}(6, 4, 1, 1)$  we have  $-K_{X'} \sim \mathcal{O}_{X'}(12)$  (see [10]). Hence

$$0 < \mathcal{O}_{X'}(1) \cdot \psi(C) \leq \frac{1}{6}.$$

This implies that the curve  $\psi(C)$  passes through the singular point on  $X'$  which is impossible because  $E_\psi \cap C = \emptyset$ . The obtained contradiction shows that  $\psi(C)$  is a point.

Now if  $\psi(C)$  is either  $P$  or  $Q$ , then we can find a curve  $Z \subset Y$  such that  $K_{Y'} \cdot f_*Z = 0$  and  $E \cdot Z > 0$ . From the equality

$$K_Y = f^*K_{Y'} + E$$

we get  $K_Y \cdot Z > 0$ . This is impossible because  $-K_Y$  is nef.  $\square$

*Remark 3.5.* Set  $O := \psi(C)$ . According to Example 2.14  $O \in X'$  is a point of type  $cA_1$ . Then Lemma 3.4 in particular implies that  $C = \psi^{-1}(O)$  is an irreducible rational curve.

According to Propositions 2.2 and 2.3 threefold  $X'$  is anti-canonically embedded in  $\mathbb{P}^{38}$ . In what follows, we consider  $X'$  with respect to this embedding. In the notation of Remark 3.5, let us denote by  $\pi$  the projection of the threefold  $X'$  from the point  $O$ .

**Lemma 3.6.**  *$\pi(X')$  is a Fano threefold with canonical Gorenstein singularities and degree 70.*

*Proof.* Let  $\sigma : W \rightarrow X'$  be the blow up of the maximal ideal of the point  $O$ . We get the following commutative diagram:

$$\begin{array}{ccc} & W & \\ \sigma \swarrow & & \searrow \tau \\ X' & \overset{\pi}{\dashrightarrow} & \pi(X') \end{array}$$

The projection  $\pi$  is given by the linear system  $\mathcal{H} \subset |-K_{X'}|$  of all hyperplane sections of  $X'$  passing through  $O$ . Since  $O \in X'$  is a  $cA_1$  point (see Remark 3.5), for general  $H \in \mathcal{H}$  we have

$$\sigma_*^{-1}H = \sigma^*(H) - E_\sigma,$$

where  $E_\sigma$  is the  $\sigma$ -exceptional divisor. On the other hand, by the adjunction formula we have

$$K_W = \sigma^*K_{X'} + E_\sigma.$$

Thus, morphism  $\tau : W \rightarrow \pi(X')$  is given by the linear system  $\sigma_*^{-1}\mathcal{H} \subseteq |-K_W|$ . In particular,  $W$  is a weak Fano threefold and  $\pi(X')$  is a Fano threefold. Moreover, by construction singularities of  $W$  are canonical and Gorenstein. Then, since morphism  $\tau$  is crepant, by [15] singularities of  $\pi(X')$  are also canonical and Gorenstein.

Finally, since  $-K_{X'}^3 = 72$  and  $\text{mult}_O(X') = 2$ , the degree of  $\pi(X')$  equals 70.  $\square$

**Lemma 3.7.** *In the above notation, we have  $X = \pi(X')$ .*

*Proof.* We use the notation from the proof of Lemma 3.6. Let  $L \simeq \mathbb{P}^1$  be the singular locus of  $X'$  (see Example 2.14). The morphism  $\psi$  factors through the blow up of the curve  $L$ . Then by Lemma 3.4, Remark 3.5 and the property of blow ups we obtain the following commutative diagram:

$$\begin{array}{ccc} Y & \xrightarrow{f} & Y' \\ \eta \downarrow & & \downarrow \psi \\ W & \xrightarrow{\sigma} & X' \end{array}$$

where  $\eta$  is the contraction of the proper transform of the  $\psi$ -exceptional divisor  $E_\psi$ . In particular, we have  $K_Y = \eta^*K_W$ .

Since  $\pi(X')$  is the anti-canonical image of  $W$ , this implies that  $Y$  is a terminal  $\mathbb{Q}$ -factorial modification of  $\pi(X')$ . Hence  $X = \pi(X')$  by Remark 2.11.  $\square$

Proposition 3.2 is completely proved.  $\square$

**Proposition 3.8.** *In the assumptions of Proposition 3.2, threefold  $X$  has only one singular point which is non-cDV.*

*Proof.* In the notation of Example 2.14, let  $L$  be the singular locus of  $\mathbb{P} = \mathbb{P}(6, 4, 1, 1)$ .

**Lemma 3.9.** *In the above notation, the curve  $L$  is a line (i.e.  $L \simeq \mathbb{P}^1$  and  $-K_{\mathbb{P}} \cdot L = 1$ ).*



*Proof.* The curve  $L$  is given by the equations  $x_2 = x_3 = 0$  where  $x_0, x_1, x_2, x_3$  are weighted projective coordinates on  $\mathbb{P}$  of weights 6, 4, 1, 1, respectively (see [10, 5.15]). This in particular implies that  $L \simeq \mathbb{P}^1$ . It remains to show that  $-K_{\mathbb{P}} \cdot L = 1$ .

Let  $S$  be the surface in  $\mathbb{P}$  with equation  $x_3 = 0$ . Then  $L \subset S$  and

$$-K_{\mathbb{P}} \cdot L = (-K_{\mathbb{P}|_S} \cdot L).$$

The last intersection is taken on  $S = \mathbb{P}(6, 4, 1) \simeq \mathbb{P}(3, 2, 1)$  (see [10, 5.7]).

Since  $-K_{\mathbb{P}} \sim \mathcal{O}_{\mathbb{P}}(12)$ , general element  $D \in |-K_{\mathbb{P}}|$  is given by the equation

$$a_0 x_0^2 + a_6(x_2, x_3)x_0 + a_2(x_2, x_3)x_0 x_1 + a_4(x_2, x_3)x_1^2 + a_8(x_2, x_3)x_1 + a_{12}(x_2, x_3) = 0,$$

where  $a_i(x_2, x_3)$  are homogeneous polynomials of degree  $i$  on the variables  $x_2, x_3$ .

If  $y_0, y_1, y_2$  are weighted projective coordinates on  $S$  of weights 3, 2, 1, respectively, then  $D|_S$  is given by the equation (see [10, 5.10])

$$b_0 y_0^2 + b_1 y_0 y_3^3 + b_2 y_0 y_1 y_2 + b_3 y_1^3 + b_4 y_1^2 y_2^2 + b_5 y_1 y_2^4 + b_6 y_2^6 = 0$$

on  $S$ , where  $b_i \in \mathbb{C}$ . This implies that  $D|_S \sim \mathcal{O}_S(6)$ . Thus, we have

$$-K_{\mathbb{P}} \cdot L = (-K_{\mathbb{P}|_S} \cdot L) = (\mathcal{O}_S(6) \cdot \mathcal{O}_S(1)) = 1$$

for the last intersection on  $S = \mathbb{P}(3, 2, 1)$  (see [8]).  $\square$

Let  $P$  and  $Q$  be two non-cDV points on  $\mathbb{P} = \mathbb{P}(6, 4, 1, 1)$  introduced in Example 2.14.

**Lemma 3.10.** *In the above notation,  $L$  is the unique line on  $\mathbb{P}$  passing through singular points on  $\mathbb{P}$  distinct from  $P$  and  $Q$ .*

*Proof.* Let  $L_0 \neq L$  be a line on  $\mathbb{P}$  intersecting the line  $L$  at some point other than  $P$  and  $Q$ .

In the notation from the proof of Lemma 3.9, let  $\tau_{\lambda_1, \lambda_2}$ ,  $\lambda_i \in \mathbb{C} \setminus \{0\}$ , be the automorphism of  $\mathbb{P}$  given by the following formula:

$$\tau_{\lambda_1, \lambda_2} : [x_0 : x_1 : x_2 : x_3] \mapsto [\lambda_1 x_0 : \lambda_2 x_1 : x_2 : x_3].$$

The group generated by  $\tau_{\lambda_1, \lambda_2}$  acts transitively on  $L \setminus \{P, Q\}$  (see [10], 5.15).

Apply automorphisms  $\tau_{\lambda_1, \lambda_2}$  to  $L_0$ . We obtain a family of lines  $\{L_t\}$ ,  $t \in L \setminus \{P, Q\}$ , on  $\mathbb{P}$  such that each line  $L_t$  intersects  $L$  at some point  $P_t$  with  $P_t \neq P_{t'}$  for  $t \neq t'$ .

Let  $T$  be the terminal  $\mathbb{Q}$ -factorial modification of  $\mathbb{P}$  and  $\phi : T \rightarrow \mathbb{P}$  the corresponding anti-canonical morphism. Let  $L'_t$  be the proper transform of line  $L_t$  on  $T$ . We have  $-K_T \cdot L'_t = 1$ . Moreover, set  $E_P := \phi^{-1}(P)$ ,  $E_Q := \phi^{-1}(Q)$  and  $E_L := \phi^{-1}(L)$ . Then

$$E_P \cdot L'_t = E_Q \cdot L'_t = 0 \quad \text{and} \quad E_L \cdot L'_t = 1$$

on  $T$ . Since for the  $\phi$ -exceptional locus  $E_\phi$  we have  $E_\phi = E_P \cup E_Q \cup E_L$  (see Example 2.14), the obtained equalities imply that the curves in the family  $\{L'_t\}$  are numerically equivalent.

Furthermore, from the equality  $-K_T \cdot L'_t = 1$  and Proposition 2.10 we deduce that the ray  $R := \mathbb{R}_+[L'_t]$  determines an extremal contraction  $\varphi_R : T \rightarrow T'$ . By Propositions 4.11 and 5.2 in [26] and [21, (2.3.2)] the contraction  $\varphi_R$  is birational and contracts the surface

$$E_R := \bigcup_{t \in L \setminus \{P, Q\}} L'_t$$

to some curve.

If  $T'$  is a weak Fano threefold, then by Lemma 2.19 we have  $-K_{T'}^3 \geq -K_T^3 = 72$ . Thus, by Remark 2.9 and Theorem 1.3 threefold  $T'$  is a terminal  $\mathbb{Q}$ -factorial modification either of  $\mathbb{P}(3, 1, 1, 1)$  or of  $\mathbb{P}(6, 4, 1, 1)$ . By Remarks 2.13 and 2.15 either  $T' \simeq T$  or  $T'$  is that constructed in Example 2.12. This implies that  $\rho(T') = \rho(T) - 1 = 4$  equals either 5 or 2, a contradiction.

Hence by Lemma 2.19 divisor  $-K_{T'}$  is not nef and either  $E_R = \mathbb{F}_1$  or  $\mathbb{P}^1 \times \mathbb{P}^1$ . But according to Corollary 2.20 equality  $E_R = \mathbb{P}^1 \times \mathbb{P}^1$  implies that  $E_R \subset E_\phi$  which is not the case.

Thus, we get  $E_R = \mathbb{F}_1$ . But  $E_P \cap E_R, E_Q \cap E_R \neq \emptyset$  and  $\phi(E_P), \phi(E_Q)$  are two distinct points on  $\mathbb{P}$ . This implies that there are two distinct curves on  $E_R$  having zero intersection with  $K_T$ .

But according to calculations in the proof of Lemma 2.19 the negative section on  $E_R = \mathbb{F}_1$  is the only curve on  $E_R$  having this property. The obtained contradiction completes the proof of Lemma 3.10.  $\square$

We use the notation from the proof of Proposition 3.2. By Lemmas 3.9 and 3.10 morphism  $\tau : W \rightarrow X = \pi(X')$  contracts only the proper transform  $L'$  of the line  $L$  to the unique singular point on  $X$ . Set  $o := \tau(L')$ .

**Lemma 3.11.** *Singularity  $o \in X$  is non-cDV.*

*Proof.* If the point  $o \in X$  is cDV, then  $X$  has terminal Gorenstein singularities by Corollary 2.22. But this contradicts Theorem 1.2 because  $-K_X^3 = 70$ .  $\square$

Proposition 3.8 is completely proved.  $\square$

*Remark 3.12.* From Proposition 3.8 it is not difficult to see that  $\rho(X) = 1$  for Fano threefold  $X$  satisfying the conditions of Proposition 3.2. We will denote this  $X$  by  $X_{70}$ . Furthermore, in the notation from the proof of Lemma 3.10, since the group of automorphisms  $\tau_{\lambda_1, \lambda_2}$  acts transitively on  $L \setminus \{P, Q\}$ , from Lemmas 3.3–3.7 we deduce that the threefold  $X_{70}$  is unique up to isomorphism.

**Lemma 3.13.** *In the above notation, if  $X = X_{70}$ , then every terminal  $\mathbb{Q}$ -factorial modification of  $X$  is non-singular.*

*Proof.* We use the notation from the proof of Proposition 3.2. We have shown that the morphism  $f : Y \rightarrow Y'$  is the blow up of a non-singular curve on a non-singular threefold  $Y'$ . Thus,  $X$  possess a non-singular terminal  $\mathbb{Q}$ -factorial modification.

Now from Theorem 2.4 in [17] and Remark 2.7 we deduce that every terminal  $\mathbb{Q}$ -factorial modification of  $X$  is non-singular.  $\square$

**Corollary 3.14.** *In the above notation, if  $f(E)$  is a point and  $X' = X_{70}$ , then  $-K_Y^3 \notin \{66, 68, 70\}$ .*

*Proof.* By Lemma 3.13 threefold  $Y'$  is non-singular. Then repeating word by word the arguments from the proof of Lemma 3.1 we obtain that  $-K_{Y'}^3 = 62$ .  $\square$

**Corollary 3.15.** *In the above notation, if  $f(E)$  is a curve and  $X' = X_{70}$ , then  $-K_Y^3 \notin \{66, 68, 70\}$ .*

*Proof.* Set  $C := f(E)$ . By Lemma 3.13 threefold  $Y'$  is non-singular and according to [7]  $f$  is the blow up of  $C$ .

If  $\psi(C)$  does not pass through the singular point on  $X'$ , then repeating word by word the arguments from the proof of Lemma 3.3 we get

$$-K_{X'} \cdot \psi(C) \leq 2.$$

By construction of  $X_{70}$  and our assumption  $X'$  is isomorphic to  $\mathbb{P} = \mathbb{P}(6, 4, 1, 1)$  near  $\psi(C)$ . In particular, the image  $C'$  of the curve  $\psi(C)$  on  $\mathbb{P}$  does not pass through the singular points.

On the other hand, we have

$$0 < \mathcal{O}_{\mathbb{P}}(1) \cdot C' = \frac{1}{12}(-K_{X'} \cdot \psi(C)) \leq \frac{1}{6}.$$

This implies that the curve  $C'$  passes through the singular point on  $\mathbb{P}$ , a contradiction.

Thus, we get  $E_\psi \cap C \neq \emptyset$  for the  $\psi$ -exceptional locus  $E_\psi$ . But  $\psi(E_\psi)$  is a point on  $X'$ . Hence we can find a curve  $Z \subset Y$  such that  $K_{Y'} \cdot f_*Z = 0$  and  $E \cdot Z > 0$ . Then from the equality

$$K_Y = f^*K_{Y'} + E$$

we get  $K_Y \cdot Z > 0$ . This is impossible because  $-K_Y$  is nef.  $\square$

*Remark 3.16.* It follows from Lemma 3.1, Propositions 3.2 and 3.8, Corollaries 3.14 and 3.15, the estimates  $\rho(Y') < \rho(Y)$  and  $-K_{Y'}^3 \geq -K_Y^3$  (see Lemmas 2.17 and 2.19) that to complete the proof of Theorem 1.4 it remains to consider the case when there are no  $K$ -negative extremal contractions of  $Y$  on weak Fano threefolds with terminal factorial singularities. Then by Corollaries 2.18 and 2.20 either the corresponding Fano threefold  $X$  is singular along a line or contains a plane.

#### 4. REDUCTION TO THE LOG MORI FIBRATION

In this section we follow §6 in [26]. Let  $X$  be a Fano threefold satisfying the conditions of Theorem 1.4. Recall that by Remark 2.5 threefold  $X = X_{2g-2}$  is anti-canonically embedded in  $\mathbb{P}^{g+1}$  with  $g \in \{34, 35, 36\}$  and  $X_{2g-2}$  is an intersection of quadrics.

According to Remark 3.16 in order to complete the proof of Theorem 1.4 we may assume that either  $X$  is singular along a line  $\Gamma$  or contains a plane  $\Pi$  (cases **A** and **B**, respectively). It is also convenient to distinguish the case **C**: threefold  $X$  has at least one non-cDV point  $O$ .

Set  $\mathcal{L} := |-K_X|$  and consider the following linear systems  $\mathcal{H} \subset \mathcal{L}$ :

$$\mathcal{H} := \{H \in \mathcal{L} | H \supset \Gamma\} \quad \text{in case \mathbf{A};}$$

$$\mathcal{H} := \{H | H + \Pi \in \mathcal{L}\} \quad \text{in case \mathbf{B};}$$

$$\mathcal{H} := \{H \in \mathcal{L} | H \ni O\} \quad \text{in case \mathbf{C}.}$$

Take a terminal  $\mathbb{Q}$ -factorial modification  $\varphi : Y \rightarrow X$  of  $X$ . Let  $\mathcal{L}_Y$  and  $\mathcal{H}_Y$  be the proper transforms on  $Y$  of linear systems  $\mathcal{L}$  and  $\mathcal{H}$ , respectively. We have

$$\varphi^*\mathcal{H} = \mathcal{H}_Y + D_Y$$

where  $D_Y \neq 0$  is an integral effective exceptional divisor.

*Remark 4.1.* According to Corollary 2.14 in [28] all the components of  $D_Y$  are surfaces of negative Kodaira dimension.

Furthermore, we have

$$K_Y + \mathcal{H}_Y + D_Y = \varphi^*(K_X + \mathcal{H}) \sim 0 \quad \text{in cases \mathbf{A} and \mathbf{C};}$$

$$K_Y + \mathcal{H}_Y + D_Y = \varphi^*(K_X + \mathcal{H} + \Pi) \sim 0 \quad \text{in case \mathbf{B}.}$$

**Lemma 4.2** ([26, Lemma 6.5]). *In the above notation, the image of the threefold  $X$  under the map  $\varphi_{\mathcal{H}}$  given by the linear system  $\mathcal{H}$  is of dimension 3.*

**Lemma 4.3** ([26, Lemma 6.8]). *In the above notation, one can take  $Y$  so that*

- the pair  $(Y, \mathcal{H}_Y)$  is canonical;
- the linear system  $\mathcal{H}_Y$  is nef and consists of Cartier divisors.

To the pair  $(Y, \mathcal{H}_Y)$  constructed in Lemma 4.3 let us apply  $(K_Y + \mathcal{H}_Y)$ -Minimal Model Program. Each step preserves the equality  $K + \mathcal{H} \equiv -D$  for some divisor  $D > 0$ . Hence at the end we obtain a pair  $(W, \mathcal{H}_W)$  with  $(K_W + \mathcal{H}_W)$ -negative contraction  $g : W \rightarrow V$  to a lower-dimensional variety  $V$ .

*Remark 4.4.* By [26, Lemma 3.4]  $(K_Y + \mathcal{H}_Y)$ -Minimal Model Program preserves the property of  $\mathcal{H}_Y$  being nef and consisting of Cartier divisors. This implies that  $W$  has only terminal  $\mathbb{Q}$ -factorial singularities. Moreover, let us denote by  $\mathcal{L}_W$  the proper transform on  $W$  of the linear system  $\mathcal{L}_Y$ . Then  $K_W + \mathcal{L}_W \sim 0$  and by Lemma 3.1 in [26] the pair  $(W, \mathcal{L}_W)$  is canonical. In particular, the anti-canonical linear system  $|-K_W|$  does not have fixed components.

*Remark 4.5.* By construction the initial Fano threefold  $X$  is the image of  $W$  under the birational map  $\varphi_{\mathcal{L}_W}$  given by the linear system  $\mathcal{L}_W \subset |-K_W|$ . Furthermore, from Lemma 4.2 we deduce that the linear system  $\mathcal{H}_W$  is ample over  $V$  and does not have fixed components.

We have

$$K_W + \mathcal{H}_W + D_W \sim 0, \quad D_W > 0$$

on  $W$  and the inequalities

$$\dim |-K_W| \geq \dim \mathcal{L}_W = \dim |-K_X|,$$

$$\dim |H| \geq \dim \mathcal{H},$$

where  $H \in \mathcal{H}_W$  is a general divisor.

*Remark 4.6.* By Remark 4.5 we have  $\dim |-K_W| \geq \dim |-K_X|$ . By construction of the linear system  $\mathcal{H}$  we have  $\dim \mathcal{H} \geq \dim |-K_X| - 3$ . Then from the assumption  $-K_X^3 \in \{66, 68, 70\}$  we obtain that  $\dim |-K_W| \geq 35$  and  $\dim |H| \geq 32$ .

By construction variety  $V$  is a point, a curve or a surface. Moreover, when  $V$  is a point by Proposition 7.2 in [26] we have  $\dim |-K_W| \leq 34$  which contradicts the estimate from Remark 4.6.

In what follows we will treat separately the cases when  $V$  is a curve and a surface.

## 5. PROOF OF THEOREM 1.4 IN THE CASE WHEN $V$ IS A CURVE

We use the notation and assumptions from Section 4. From the Leray spectral sequence and Kawamata–Vieweg Vanishing Theorem we deduce that  $H^1(V, \mathcal{O}_V) = H^1(W, \mathcal{O}_W) = 0$ . Thus, we have  $V \simeq \mathbb{P}^1$  in the present case.

General fibre  $W_\eta$  of the contraction  $g : W \rightarrow V$  is a non-singular del Pezzo surface. For  $H \in \mathcal{H}_W$  divisor  $-(K_{W_\eta} + H|_{W_\eta})$  is ample by construction and divisor  $H|_{W_\eta}$  is ample by Remark 4.5. This implies that  $W_\eta \simeq \mathbb{P}^2$  or  $\mathbb{P}^1 \times \mathbb{P}^1$ . Moreover, for  $W_\eta \simeq \mathbb{P}^2$  we have either  $H|_{W_\eta} \simeq \mathcal{O}_{\mathbb{P}^2}(1)$  or  $\mathcal{O}_{\mathbb{P}^2}(2)$ .

**Lemma 5.1.** *In the above notation, if  $W_\eta \simeq \mathbb{P}^2$  and  $H|_{W_\eta} \simeq \mathcal{O}_{\mathbb{P}^2}(1)$ , then  $W$  is a  $\mathbb{P}^2$ -bundle. Moreover, either  $W = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(5) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$  or  $\text{Proj}(\mathcal{O}_{\mathbb{P}^1}(6) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$ .*

*Proof.* It follows at once from Lemma 8.1 and Proposition 8.2 in [26] and Remark 4.4 that  $W = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(d_1) \oplus \mathcal{O}_{\mathbb{P}^1}(d_2) \oplus \mathcal{O}_{\mathbb{P}^1})$  with the following possibilities for  $(d_1, d_2)$ :

$$(1, 1), \quad (2, 1), \quad (2, 2), \quad (3, 1), \quad (3, 2), \quad (4, 1), \quad (4, 2), \quad (5, 2), \quad (6, 2).$$

Except for the last two cases we have  $\dim |-K_W| \leq 33$  (see for example [29, 2.5]). Hence by Remark 4.6 the pair  $(d_1, d_2)$  is either  $(5, 2)$  or  $(6, 2)$ .  $\square$

**Proposition 5.2.** *In the assumptions of Lemma 5.1, if  $W = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(5) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$ , then  $-K_X^3 = 66$  and  $X$  the anti-canonical image of  $W$ .*

*Proof.* For  $W = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(5) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$  we have  $\dim |-K_W| = 35$ . From Remark 4.6 we deduce the equality  $|-K_W| = \mathcal{L}_W$ . In particular, for the initial Fano threefold  $X$  we must have  $-K_X^3 = 66$ . Let us show that this possibility is really obtained.

On  $W$  we have  $-K_W \sim 3M - 5L$  where  $M$  is the tautological line bundle and  $L$  is the fibre of the morphism  $g$  (see for example [29, A.10]). Then the anti-canonical linear system  $|-K_W|$  is generated by (see [29, 2.4])

$$(5.3) \quad g_1 x_2^3, \quad x_1 x_2^2, \quad g_2 x_1 x_2 x_3, \quad g_4 x_1 x_2^2, \quad g_5 x_1^2 x_3, \quad g_7 x_1^2 x_2, \quad g_{10} x_1^3$$

where  $x_1, x_2, x_3$  are projective coordinates on the fibre  $L \simeq \mathbb{P}^2$ ,  $g_i$  is a homogeneous polynomial of degree  $i$  on the projective coordinates  $t_0, t_1$  on the base  $V \simeq \mathbb{P}^1$ . In particular, the base locus of  $|-K_W|$  on  $W$  is a curve  $C_0 \simeq \mathbb{P}^1$  given by equations  $x_1 = x_2 = 0$ .

In order to resolve indeterminacies of the map  $\varphi_{\mathcal{L}_W} : W \dashrightarrow X$  we may set  $t_2 = x_3 = 1$ ,  $x_1 = x$ ,  $x_2 = y$  and  $t_1 = z$ .

Let  $\sigma_1 : W_1 \rightarrow W_0 = W$  be the blow up of the curve  $C_0$  with exceptional divisor  $E_1$ . Threefold  $W_1$  is covered by two affine charts  $U_i^{(1)}$  each isomorphic to  $\mathbb{C}^3$ . We will again denote by  $x, y, z$  the coordinates on each chart  $U_i^{(1)}$ .

The map  $U_1^{(1)} \rightarrow W_0$  is given by

$$(x, y, z) \mapsto (x, xy, z).$$

Then the linear system  $\mathcal{L}_{W_1} = \sigma_{1*}^{-1} \mathcal{L}_W$  is generated by

$$g_1 y^3 x^2, \quad 1, \quad g_2 xy, \quad g_4 x^2 y^2, \quad g_5 x, \quad g_7 x^2 y, \quad g_{10} x^2$$

on  $U_1^{(1)}$  which implies that  $\mathcal{L}_{W_1}$  is free on  $U_1^{(1)}$ .

The map  $U_2^{(1)} \rightarrow W_0$  is given by

$$(x, y, z) \mapsto (xy, y, z).$$

Then the linear system  $\mathcal{L}_{W_1} = \sigma_{1*}^{-1} (\mathcal{L}_W)$  is generated by

$$(5.4) \quad g_1 y^2, \quad x, \quad g_2 xy, \quad g_4 xy^2, \quad g_5 x^2 y, \quad g_7 x^2 y^2, \quad g_{10} x^3 y^2$$

on  $U_2^{(1)}$ . This implies that the base locus of  $\mathcal{L}_{W_1}$  on  $W_1$  is an irreducible rational curve  $C_1 \subset E_1 \cap U_2^{(1)}$  given by equations  $x = y = 0$ .

In order to resolve the indeterminacies of the map  $\varphi_{\mathcal{L}_{W_1}} : W_1 \dashrightarrow X$  we may set  $W_1 = U_2^{(1)}$  with coordinates  $x, y, z$ . Then (5.4) is the set of generators of the linear system  $\mathcal{L}_{W_1}$ .

Let  $\sigma_2 : W_2 \rightarrow W_1$  be the blow up of the curve  $C_1$  with exceptional divisor  $E_2$ . Threefold  $W_2$  is covered by two affine charts  $U_i^{(2)}$  each isomorphic to  $\mathbb{C}^3$ . We will again denote by  $x, y, z$  the coordinates on each chart  $U_i^{(2)}$ .

The map  $U_1^{(2)} \rightarrow W_1$  is given by

$$(x, y, z) \mapsto (x, xy, z)$$

and again the linear system  $\mathcal{L}_{W_2} = \sigma_{2*}^{-1} (\mathcal{L}_{W_1})$  is free on  $U_1^{(2)}$ .

The map  $U_2^{(2)} \rightarrow W_1$  is given by

$$(x, y, z) \mapsto (xy, y, z).$$

Then the linear system  $\mathcal{L}_{W_2} = \sigma_{2*}^{-1} (\mathcal{L}_{W_1})$  is generated by

$$(5.5) \quad g_1 y, \quad x, \quad g_2 xy, \quad g_4 xy^2, \quad g_5 x^2 y^2, \quad g_7 x^2 y^3, \quad g_{10} x^3 y^4$$

on  $U_2^{(2)}$ . This implies that the base locus of  $\mathcal{L}_{W_2}$  on  $W_2$  is an irreducible rational curve  $C_2 \subset E_2 \cap U_2^{(2)}$  given by equations  $x = y = 0$ .

Finally, in order to resolve the indeterminacies of the map  $\varphi_{\mathcal{L}_{W_2}} : W_2 \dashrightarrow X$  we may set  $W_2 = U_2^{(2)}$  with coordinates  $x, y, z$ . Then (5.5) is the set of generators of the linear system  $\mathcal{L}_{W_2}$ .

Let  $\sigma_3 : W_3 \rightarrow W_2$  be the blow up of the curve  $C_2$  with exceptional divisor  $E_3$ . Threefold  $W_3$  is covered by two affine charts  $U_i^{(3)}$  each isomorphic to  $\mathbb{C}^3$ . We will again denote by  $x, y, z$  the coordinates on each chart  $U_i^{(3)}$ .

The map  $U_1^{(3)} \rightarrow W_2$  is given by

$$(x, y, z) \mapsto (x, xy, z)$$

and again the linear system  $\mathcal{L}_{W_3} = \sigma_{3*}^{-1} (\mathcal{L}_{W_2})$  is free on  $U_1^{(3)}$ .

The map  $U_2^{(3)} \rightarrow W_2$  is given by

$$(x, y, z) \mapsto (xy, y, z).$$

Then the linear system  $\mathcal{L}_{W_3}$  is generated by

$$g_1, \quad x, \quad g_2 xy, \quad g_4 xy^2, \quad g_5 x^2 y^3, \quad g_7 x^2 y^4, \quad g_{10} x^3 y^6$$

on  $U_2^{(3)}$ . This implies that the linear system  $\mathcal{L}_{W_3} = \sigma_{3*}^{-1}(\mathcal{L}_{W_2})$  is free on  $U_2^{(3)}$  and hence it is free on  $W_3$ .

**Lemma 5.6.** *In the above notation,  $W_3$  is a non-singular weak Fano threefold such that the morphism  $\varphi_{\mathcal{L}_{W_3}}$  is crepant and the image  $X = \varphi_{\mathcal{L}_{W_3}}(W_3)$  is a Fano threefold with canonical Gorenstein singularities and degree 66.*

*Proof.* In the above notation, for  $1 \leq i \leq 3$  we have

$$K_{W_i} = \sigma_i^* K_{W_{i-1}} + E_i$$

and general element in  $\mathcal{L}_{W_{i-1}}$  is non-singular along the base curve  $C_{i-1}$  (see (5.3)–(5.5)). Since  $\mathcal{L}_{W_0} = |-K_W|$ , this implies that  $\mathcal{L}_{W_i} \subset |-K_{W_i}|$  for all  $1 \leq i \leq 3$ . In particular, divisor  $-K_{W_3}$  is nef because the linear system  $\mathcal{L}_{W_3}$  is free.

Furthermore, the image  $\varphi_{|-K_W|}(W) = \varphi_{\mathcal{L}_{W_3}}(W_3)$  is three-dimensional because  $-K_W$  is big. This implies that divisor  $-K_{W_3}$  is also big.

Thus,  $W_3$  is a weak Fano threefold and morphism  $\varphi_{\mathcal{L}_{W_3}}$  is crepant. Moreover, by construction  $W_3$  is non-singular. Then  $X = \varphi_{\mathcal{L}_{W_3}}(W_3)$  is a Fano threefold with canonical Gorenstein singularities (see [15]).

Finally, we have  $X = X_{2g-2} \subset \mathbb{P}^{g+1}$  for the genus  $g$  of  $X$  equal 34 because  $X = \varphi_{|-K_W|}(W)$  and  $\dim |-K_W| = 35$ .  $\square$

Proposition 5.2 is completely proved.  $\square$

*Remark 5.7.* Obviously, Fano threefold  $X$  from Proposition 5.2 is toric. From the precise view of the fan of  $X$  in the list obtained in [19] it is straightforward that  $X$  is  $\mathbb{Q}$ -factorial and  $\rho(X) = 2$ . We will denote this  $X$  by  $X_{66}$ .

**Proposition 5.8.** *In the above notation, if  $X = X_{66}$ , then singularities of  $X$  are non-cDV.*

*Proof.* We use the notation from the proof of Proposition 5.2. From Lemma 5.6 we deduce that  $\varphi_{\mathcal{L}_{W_3}} : W_3 \rightarrow X$  is a terminal  $\mathbb{Q}$ -factorial modification of  $X$ . In particular, we have  $\mathcal{L}_{W_3} = |-K_{W_3}|$ .

Let  $L_t \subset E_2$  be the fibre  $\sigma_2^{-1}(t)$ ,  $t \in \mathbb{P}^1$ , and  $L'_t$  be its proper transform on  $W_3$ .

**Lemma 5.9.** *On  $W_3$  we have  $K_{W_3} \cdot L'_t = 0$ .*

*Proof.* Set  $E_1^* := (\sigma_2 \circ \sigma_3)^*(E_1)$  and  $E_2^* := \sigma_3^*(E_2)$ . On  $W_3$  we have

$$K_{W_3} = (\sigma_1 \circ \sigma_2 \circ \sigma_3)^*(K_W) + E_1^* + E_2^* + E_3.$$

Furthermore, on  $W_3$  we have

$$E_3 \cdot L'_t = 1, \quad E_2^* \cdot L'_t = E_2 \cdot L_t = -1, \quad E_1^* \cdot L'_t = \sigma_2^*(E_1) \cdot L_t = 0.$$

Thus, we get  $K_{W_3} \cdot L'_t = 0$  on  $W_3$ .  $\square$

Let  $E'_2$  be the proper transform of the surface  $E_2$  on  $W_3$ .

**Lemma 5.10.** *On  $W_3$  we have  $K_{W_3} \cdot E'_2 \cdot E_3 = 0$ .*

*Proof.* In the notation from the proof of Proposition 5.2, let  $\sigma_3 : W_3 \rightarrow W_2$  be the blow up of the curve  $C_2$  with exceptional divisor  $E_3$ . Without loss of generality we may set  $W_2 = U_2^{(2)}$  with coordinates  $x, y, z$ . Then the threefold  $W_3$  is covered by two affine charts  $U_i^{(3)}$  each isomorphic to  $\mathbb{C}^3$ . We will again denote by  $x, y, z$  the coordinates on each chart  $U_i^{(3)}$ .

The map  $U_1^{(3)} \rightarrow W_2$  is given by

$$(x, y, z) \mapsto (x, xy, z).$$

Then general element  $S \in \mathcal{L}_{W_3} = |-K_{W_3}| = \sigma_{3*}^{-1}(\mathcal{L}_{W_2})$  is given by the equation

$$g_1y + g_0 + g_2xy + g_4x^2y^2 + g_5x^3y^2 + g_7x^4y^3 + g_{10}x^6y^4 = 0$$

on  $U_1^{(3)}$  where  $g_0 \in \mathbb{C}$  (see (5.5)). On the other hand, the equation of  $E_3$  on  $U_1^{(3)}$  is  $x = 0$  and the equation of  $E_2$  on  $W_2$  is  $y = 0$ . This implies that

$$S \cap E'_2 \cap E_3 = \emptyset$$

on  $U_1^{(3)}$ .

Furthermore, the map  $U_2^{(3)} \rightarrow W_2$  is given by

$$(x, y, z) \mapsto (xy, y, z)$$

Then  $E'_2 \cap U_2^{(3)} \cap E_3 = \emptyset$  because the equation of  $E_3$  on  $U_2^{(3)}$  is  $y = 0$  and the equation of  $E_2$  on  $W_2$  is  $y = 0$ . This implies that for general element  $S \in \mathcal{L}_{W_3} = |-K_{W_3}|$

$$S \cap E'_2 \cap E_3 = \emptyset$$

on  $U_2^{(3)}$ . Thus, we get  $K_{W_3} \cdot E'_2 \cdot E_3 = 0$  on  $W_3$ .  $\square$

Lemmas 5.9 and 5.10 imply that divisor  $E'_2$  is  $\varphi_{\mathcal{L}_{W_3}}$ -exceptional and  $o := \varphi_{\mathcal{L}_{W_3}}(E'_2)$  is a point on  $X$ . Moreover, since the discrepancy  $a(E'_2, X)$  is zero,  $o \in X$  is a non-cDV singular point by Theorem 2.21. Proposition 5.8 is completely proved.  $\square$

Now we turn to the second case in Lemma 5.1.

**Proposition 5.11.** *In the assumptions of Lemma 5.1, if  $W = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(6) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$ , then  $-K_X^3 = 70$  and  $X = X_{70}$  is that constructed in Proposition 3.2.*

*Proof.* For  $W = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(6) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$  we have  $\varphi_{|-K_W|}(W) = \mathbb{P}(6, 4, 1, 1)$  (see [11, Ch. 4, Remark 4.2]). Then from Remark 4.5 and the assumption  $\dim \mathcal{L}_W \in \{35, 36, 37\}$  we deduce that the initial Fano threefold  $X$  must be an image of  $\mathbb{P}(6, 4, 1, 1) \subset \mathbb{P}^{38}$  under the birational projection from a point, a line or a plane. Let  $\pi : \mathbb{P}(6, 4, 1, 1) \dashrightarrow X$  be this projection.

**Lemma 5.12.** *If  $\pi$  is the projection from a point, then  $X = X_{70}$  is that constructed in Proposition 3.2.*

*Proof.* Let  $O$  be the center of the projection  $\pi$ . Then  $O$  belongs to  $\mathbb{P} = \mathbb{P}(6, 4, 1, 1)$  because otherwise  $\pi$  is an isomorphism which is impossible because  $\mathbb{P} \subset \mathbb{P}^{38}$  is not degenerate. Moreover, if  $O$  is a smooth point on  $\mathbb{P}$ , then  $-K_X^3 = 71$  which is also impossible.

In the notation of Example 2.14, if  $O$  is distinct from  $P$  and  $Q$ , then  $O \in \mathbb{P}$  is a  $cA_1$  point. By Lemma 3.6 we get  $X = X_{70}$ .

Now, if  $O$  is either  $P$  or  $Q$ , then general hyperplane section  $S$  of  $\mathbb{P}$  through  $O$  is a K3 surface with singularities worse than Du Val. Indeed, otherwise either  $P$  or  $Q$  is a cDV point which is impossible (see Proposition 2.23, Example 2.14 and Theorem 2.21). In particular, we have  $\kappa(S) < 0$  for the Kodaira dimension of the surface  $S$ .

On the other hand, the projection  $\pi$  induces a birational map  $S \dashrightarrow S'$  on general surface  $S' \in |-K_X|$ . This implies that  $\kappa(S) = \kappa(S')$ . But  $S'$  is a K3 surface with canonical singularities by Theorem 2.1. Thus, we get  $0 = \kappa(S') = \kappa(S) < 0$ , a contradiction.  $\square$

By Lemma 5.12 it remains to consider the cases when  $\pi$  is either the projection from some line  $\gamma$  or some plane  $\Omega$ . We will show that in each of these cases  $-K_X^3 \notin \{66, 68, 70\}$ .

Let us consider the projection from line  $\gamma$  first. Since  $\mathbb{P} = \mathbb{P}(6, 4, 1, 1)$  is an intersection of quadrics (see Proposition 2.4), its intersection with  $\gamma$  is either a set of  $\leq 2$  points or the whole  $\gamma$ . Note that  $\gamma \cap \mathbb{P} \neq \emptyset$  because  $\mathbb{P} \subset \mathbb{P}^{38}$  is not degenerate.

**Lemma 5.13.** *The line  $\gamma$  is not contained in  $\mathbb{P}$ .*

*Proof.* Suppose that  $\gamma \subset \mathbb{P}$ . Then we have  $-K_{\mathbb{P}} \cdot \gamma = 1$ . On the other hand, on  $\mathbb{P}$  we have  $-K_{\mathbb{P}} \sim \mathcal{O}_{\mathbb{P}}(12)$  (see [10]). Hence

$$\mathcal{O}_{\mathbb{P}}(1) \cdot \gamma = \frac{1}{12}$$

which implies that  $\gamma$  passes through a singular point on  $\mathbb{P}$ .

If  $\gamma$  contains a cDV point, then by Lemma 3.10  $\gamma$  coincides with the singular locus of  $\mathbb{P}$ . As in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $\mathbb{P}$  through  $\gamma$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ , a contradiction. In the same way we obtain a contradiction when  $\gamma$  contains one of the non-cDV points of  $\mathbb{P}$ .  $\square$

Thus,  $\gamma$  intersects  $\mathbb{P}$  at  $\leq 2$  points.

**Lemma 5.14.** *In the above assumptions,  $\gamma$  contains only smooth points of  $\mathbb{P}$ .*

*Proof.* In the notation of Example 2.14, if  $\gamma$  contains a singular point on  $\mathbb{P}$  distinct from  $P$  and  $Q$ , then by Lemma 3.6  $X$  is an image under the birational projection of the threefold  $X_{70}$  from some point  $O$  on  $X_{70}$ .

If  $O$  is a smooth point, then  $-K_X^3 = 69$  which is impossible.

Thus, by Proposition 3.8  $O \in X_{70}$  is the unique non-cDV point. Now, as in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $X_{70}$  through  $O$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ .

The obtained contradiction implies that  $\gamma$  contains only  $P$  and  $Q$ . Again, as in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $\mathbb{P}$  through  $\gamma$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ , a contradiction.  $\square$

Thus,  $\gamma$  intersects  $\mathbb{P}$  at  $\leq 2$  smooth points.

**Lemma 5.15.** *In the above assumptions, we have  $-K_X^3 = 72$ .*

*Proof.* Let  $S$  be a general hyperplane section of  $\mathbb{P}$  through  $\gamma$ . Then  $S$  is a non-singular K3 surface because  $\gamma \cap \mathbb{P}$  consists of  $\leq 2$  smooth points. Furthermore,  $\pi$  induces a birational map  $\chi : S \dashrightarrow S'$  on general surface  $S' \in |-K_X|$  having canonical singularities (see Theorem 2.1). This implies that  $S$  is the minimal resolution of  $S'$  and  $\chi$  is a regular morphism.

Projection  $\pi$  is given by the linear system  $\mathcal{L}$  of all hyperplane sections of  $\mathbb{P}$  through  $\gamma$ . Set  $\mathcal{L}_S := \mathcal{L}|_S$  and  $\mathcal{L}_{S'} := |-K_X||_{S'}$ . Then we have  $\mathcal{L}_S = \chi^* \mathcal{L}_{S'}$  and in particular  $(L)^2 = (L')^2$  for  $L \in \mathcal{L}_S$  and  $L' \in \mathcal{L}_{S'}$ .

On the other hand, we have  $(L')^2 = -K_X^3$  and  $(L)^2 = -K_{\mathbb{P}}^3$ . Thus, we obtain

$$-K_X^3 = (L')^2 = (L)^2 = 72.$$

$\square$

From Lemma 5.15 we get a contradiction with  $-K_X^3 \in \{66, 68, 70\}$ . Now we turn to the final case when  $\pi$  is the projection from plane  $\Omega$ .

**Lemma 5.16.** *The plane  $\Omega$  is not contained in  $\mathbb{P}(6, 4, 1, 1)$ .*

*Proof.* Suppose that  $\Pi \subset \mathbb{P}(6, 4, 1, 1)$ . Then, as in the proof of Lemma 5.13, any line on  $\Pi$  passes through a singular point on  $\mathbb{P}(6, 4, 1, 1)$ . Now repeating word by word the arguments from the proof of Lemma 5.13 we obtain a contradiction.  $\square$

Since  $\mathbb{P} = \mathbb{P}(6, 4, 1, 1)$  is an intersection of quadrics, by Lemma 5.16 the intersection of  $\mathbb{P}$  with  $\Omega$  is either a set of  $\leq 4$  points or a (non-reduced, reduced or irreducible) conic. Again we note that  $\Omega \cap \mathbb{P} \neq \emptyset$  because  $\mathbb{P} \subset \mathbb{P}^{38}$  is not degenerate.

**Lemma 5.17.** *If  $\Omega \cap \mathbb{P}$  is a finite set, then it contains only smooth points of  $\mathbb{P}$ .*

*Proof.* In the notation of Example 2.14, if  $\Omega$  contains a singular point on  $\mathbb{P}$  distinct from  $P$  and  $Q$ , then by Lemma 3.6  $X$  is an image under the birational projection of the threefold  $X_{70}$  from some line  $\gamma'$  which is not contained in  $X_{70}$  and  $\gamma' \cap X_{70} \neq \emptyset$ .

If  $\gamma'$  does not pass through the singular point on  $X_{70}$ , then repeating word by word the arguments from the proof of Lemma 5.15 we obtain that  $-K_X^3 = -K_{X_{70}}^3$ . On the other hand, we must have  $-K_X^3 < -K_{X_{70}}^3$ , since the degree must decrease, a contradiction.



Thus,  $\gamma'$  contains unique singular point  $O$  on  $X_{70}$  (see Proposition 3.8). As in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $X_{70}$  through  $O$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ .

The obtained contradiction implies that  $\Omega$  contains only  $P$  and  $Q$ . Again, as in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $\mathbb{P}$  through  $\Omega$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ , a contradiction.  $\square$

Thus, if  $\Omega$  intersects  $\mathbb{P}$  by  $\leq 4$  points, then by Lemma 5.17 and the arguments from the proof of Lemma 5.15 we obtain that  $-K_X^3 = 72$  which is a contradiction with  $-K_X^3 \in \{66, 68, 70\}$ .

Suppose that  $\Omega$  intersects  $\mathbb{P}$  by some conic  $C$ .

**Lemma 5.18.** *In the above notation, the set  $C \cap \text{Sing}(\mathbb{P})$  is non-empty and consists of  $cA_1$  points.*

*Proof.* Since  $-K_{\mathbb{P}} \cdot C = 2$  and  $-K_{\mathbb{P}} \sim \mathcal{O}_{\mathbb{P}}(12)$ , on  $\mathbb{P}$  we have

$$\mathcal{O}_{\mathbb{P}}(1) \cdot C = \frac{1}{6}.$$

This implies that  $C$  passes through a singular point on  $\mathbb{P}$ .

Furthermore, in the notation of Example 2.14, if  $C$  contains either  $P$  or  $Q$ , then as in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $\mathbb{P}$  through  $\Omega$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ , a contradiction.  $\square$

From Lemmas 5.18 and 3.6 we deduce that  $X$  is an image under the birational projection of the threefold  $X_{70}$  from some line  $\gamma'$  on  $X_{70}$ .

**Lemma 5.19.** *In the above notation, the line  $\gamma'$  passes through the singular point on  $X_{70}$ .*

*Proof.* If  $\gamma'$  does not pass through the singular point on  $X_{70}$ , then by construction  $X_{70}$  is isomorphic to  $\mathbb{P}$  near  $\gamma'$ . This implies that there is a line on  $\mathbb{P}$  not passing through the singular points which is impossible (see the proof of Lemma 5.13).  $\square$

Thus,  $\gamma'$  contains unique singular point  $O$  on  $X_{70}$  (see Proposition 3.8). Then, as in the proof of Lemma 5.12, for general hyperplane section  $S$  of  $X_{70}$  through  $O$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ , a contradiction.

Proposition 5.11 is completely proved.  $\square$

Now, for  $W_{\eta} \simeq \mathbb{P}^2$  and  $H|_{W_{\eta}} \simeq \mathcal{O}_{\mathbb{P}^2}(2)$  according to Proposition 8.7 in [26] there is a  $(K_W + \mathcal{L}_W)$ -crepant birational map  $W \dashrightarrow W_0$  onto a  $\mathbb{P}^2$ -bundle  $W_0$  over  $V$ . Then the pair  $(W_0, \mathcal{L}_0)$  is canonical and the linear system  $\mathcal{L}_0 \subset |-K_{W_0}|$  gives a birational map  $\varphi_{\mathcal{L}_0} : W_0 \dashrightarrow X$  (see Remarks 4.4 and 4.5). Again by Lemma 5.1 either  $W_0 = \text{Proj}(\mathcal{O}_{\mathbb{P}^1}(5) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$  or  $\text{Proj}(\mathcal{O}_{\mathbb{P}^1}(6) \oplus \mathcal{O}_{\mathbb{P}^1}(2) \oplus \mathcal{O}_{\mathbb{P}^1})$  and we repeat the arguments from the proofs of Propositions 5.2 and 5.11 to get that the initial Fano threefold  $X$  is either  $X_{66}$  or  $X_{70}$  (see Remarks 3.12 and 5.7).

Finally, if  $W_{\eta} \simeq \mathbb{P}^1 \times \mathbb{P}^1$ , then Proposition 9.4 in [26] can be applied to the initial Fano threefold  $X$  having  $-K_X^3 \in \{66, 68, 70\}$ . Again there is a  $(K_W + \mathcal{L}_W)$ -crepant birational map  $W \dashrightarrow W_0$  onto a  $\mathbb{P}^2$ -bundle  $W_0$  over  $V$  and the previous arguments work.

Theorem 1.4 is completely proved in the case when  $V$  is a curve.

## 6. PROOF OF THEOREM 1.4 IN THE CASE WHEN $V$ IS A SURFACE

We use notation and assumptions from Section 4. In the present section  $g : W \rightarrow V$  is a  $(K_W + \mathcal{H}_W)$ -negative extremal contraction on the surface  $V$ . Following the lines in the proof of Proposition 10.3 in [26] we will show that this situation is impossible.

**Lemma 6.1** ([26, Lemma 10.1]). *The surface  $V$  is non-singular and the contraction  $g : W \rightarrow V$  is a  $\mathbb{P}^1$ -bundle.*

For the fibre  $F$  of the contraction  $g$  we have  $-K_W \cdot F = 2$ . This and the equivalence

$$K_W + \mathcal{H}_W + D_W \sim 0$$

imply that divisors  $H \in \mathcal{H}_W$  and  $D_W$  are the sections of  $g$ .

Set  $\mathcal{E} := g_*\mathcal{O}_W(H)$ . Then  $\mathcal{E}$  is a rank 2 vector bundle and  $W \simeq \mathbb{P}(\mathcal{E})$ . By Lemma 4.4 in [26] we have

$$(6.2) \quad \dim |H| + 1 = h^0(V, \mathcal{E}) = \chi(V, \mathcal{E}).$$

**Proposition 6.3.** *In the above notation, we have  $\dim |H| \in \{32, 33, 34, 35\}$ .*

*Proof.* According to Remark 4.6 we have  $\dim |H| \geq 32$ .

Suppose that  $\dim |H| \geq 36$ . Then it follows from the proof of Proposition 10.3 in [26] that  $W = \mathbb{P}(\mathcal{O}_{\mathbb{P}^2}(3) \oplus \mathcal{O}_{\mathbb{P}^2}(6))$ . In this case the anti-canonical image of  $W$  is  $\mathbb{P}(3, 1, 1, 1)$  (see Example 2.12).

From Remark 4.5 and the assumption  $\dim \mathcal{L}_W \in \{35, 36, 37\}$  we deduce that the initial Fano threefold  $X$  must be an image of  $\varphi_{|-K_W|}(W) = \mathbb{P}(3, 1, 1, 1) \subset \mathbb{P}^{38}$  under the birational projection from a point, a line or a plane. Let  $\pi : \mathbb{P}(3, 1, 1, 1) \dashrightarrow X$  be this projection.

**Lemma 6.4.** *If  $\pi$  is the projection from a point, then  $K_X^3 \notin \{66, 68, 70\}$ .*

*Proof.* Let  $O$  be the center of the projection  $\pi$ . Then  $O$  belongs to  $\mathbb{P} = \mathbb{P}(3, 1, 1, 1)$  because otherwise  $\pi$  is an isomorphism which is impossible because  $\mathbb{P} \subset \mathbb{P}^{38}$  is not degenerate. If  $O$  is a smooth point on  $\mathbb{P}$ , then  $-K_X^3 = 71$ .

Now let  $O$  be the unique singular point on  $\mathbb{P}$ . Then singularity  $O \in \mathbb{P}$  is non-cDV (see Example 2.12 and Theorem 2.21). This implies that general hyperplane section  $S$  of  $\mathbb{P}$  through  $O$  is a K3 surface with singularities worse than Du Val (see Proposition 2.23). In particular, we have  $\kappa(S) < 0$  for the Kodaira dimension of  $S$ .

On the other hand, the projection  $\pi$  induces a birational map  $S \dashrightarrow S'$  on general surface  $S' \in |-K_X|$ . This implies that  $\kappa(S) = \kappa(S')$ . But the surface  $S'$  has canonical singularities by Theorem 2.1. Thus, we get  $0 = \kappa(S') = \kappa(S) < 0$ , a contradiction.  $\square$

**Lemma 6.5.** *If  $\pi$  is the projection from a line, then  $-K_X^3 \notin \{66, 68, 70\}$ .*

*Proof.* Let  $\gamma$  be the center of the projection  $\pi$ . Then  $\gamma$  must intersect  $\mathbb{P} = \mathbb{P}(3, 1, 1, 1)$  because otherwise  $\pi$  is an isomorphism which is impossible because  $\mathbb{P} \subset \mathbb{P}^{38}$  is not degenerate. Moreover,  $\gamma$  is not contained in  $\mathbb{P}$ , since divisor  $-K_{\mathbb{P}}$  is divisible in  $\text{Pic}(\mathbb{P})$ , and intersects  $\mathbb{P}$  at  $\leq 2$  points because  $\mathbb{P}$  is an intersection of quadrics (see Proposition 2.4).

If  $\gamma$  contains unique singular point on  $\mathbb{P}$ , then as in the proof of Lemma 6.4 for general hyperplane section  $S$  of  $\mathbb{P}$  through  $\gamma$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ . Thus, we get  $0 = \kappa(S') = \kappa(S) < 0$ , a contradiction.

Finally, if  $\gamma$  contains only smooth points on  $\mathbb{P}$ , then general hyperplane section  $S$  of  $\mathbb{P}$  through  $\gamma$  is a non-singular K3 surface. Furthermore, the projection  $\pi$  induces a birational map  $\eta : S \dashrightarrow S'$  on general surface  $S' \in |-K_X|$ . The surface  $S'$  has canonical singularities by Theorem 2.1. This implies that  $S$  is the minimal resolution of  $S'$  and  $\eta$  is a regular morphism.

Projection  $\pi$  is given by the linear system  $\mathcal{L}$  of all hyperplane sections of  $\mathbb{P}$  through  $\gamma$ . Set  $\mathcal{L}_S := \mathcal{L}|_S$  and  $\mathcal{L}_{S'} := |-K_X||_{S'}$ . Then we have  $\mathcal{L}_S = \eta^*\mathcal{L}_{S'}$  and in particular  $(L)^2 = (L')^2$  for  $L \in \mathcal{L}_S$  and  $L' \in \mathcal{L}_{S'}$ .

On the other hand, we have  $(L')^2 = -K_X^3$  and  $(L)^2 = -K_{\mathbb{P}}^3$ . Thus, we get

$$-K_X^3 = (L')^2 = (L)^2 = 72.$$

$\square$

**Lemma 6.6.** *If  $\pi$  is the projection from a plane, then  $-K_X^3 \notin \{66, 68, 70\}$ .*

*Proof.* Let  $\Omega$  be the center of the projection  $\pi$ . Then  $\Omega$  must intersect  $\mathbb{P} = \mathbb{P}(3, 1, 1, 1)$  because otherwise  $\pi$  is an isomorphism which is impossible because  $\mathbb{P} \subset \mathbb{P}^{38}$  is not degenerate. Moreover,  $\Omega$  is not contained in  $\mathbb{P}$ , since divisor  $-K_{\mathbb{P}}$  is divisible in  $\text{Pic}(\mathbb{P})$ . Then by Proposition 2.4  $\Omega$  intersects  $\mathbb{P}$  either at  $\leq 4$  points or a conic.

If  $\Omega$  intersects  $\mathbb{P}$  at  $\leq 4$  points, then we repeat word by word the arguments from the proof of Lemma 6.5 to obtain that  $-K_X^3 = 72$ .

Now let  $\Omega \cap \mathbb{P}$  be a conic  $C$ . Note that  $C$  is reduced and irreducible because divisor  $-K_{\mathbb{P}}$  is divisible in  $\text{Pic}(\mathbb{P})$ . The image of  $\mathbb{P}$  under the isomorphism  $\varphi_{|-\frac{1}{2}K_{\mathbb{P}}|}$  is the cone over del Pezzo surface of degree 9. This implies that  $\varphi_{|-\frac{1}{2}K_{\mathbb{P}}|}(C)$  is the generatrix of this cone.

Hence conic  $C$  contains unique singular point on  $\mathbb{P}$ . Then, as in the proof of Lemma 6.4 for general hyperplane section  $S$  of  $\mathbb{P}$  through  $\Omega$  we have  $\kappa(S) < 0$  and for its birational image  $S'$  on  $X$  we have  $\kappa(S') = 0$ . Thus, we get  $0 = \kappa(S') = \kappa(S) < 0$ , a contradiction.  $\square$

From Lemmas 6.4–6.6 we derive a contradiction with  $\dim |H| \geq 36$ . Proposition 6.3 is completely proved.  $\square$

**Lemma 6.7** ([26]). *In the above notation, the surface  $V$  is rational.*

*Proof.* From the Leray spectral sequence and Kawamata–Vieweg Vanishing Theorem we deduce that  $H^1(V, \mathcal{O}_V) = H^1(W, \mathcal{O}_W) = 0$ .

Furthermore, the surface  $V$  is dominated by an irreducible component of the surface  $D_W$  of negative Kodaira dimension (see Remark 4.1). Since  $V$  is non-singular by Lemma 6.1, this implies that the surface  $V$  is rational.  $\square$

*Remark 6.8.* By [26, Lemma 10.4] and Lemma 6.7 we may assume that either  $V \simeq \mathbb{P}^2$  or  $\mathbb{F}_n$  for some  $n \neq 1$ . Moreover, by [26, Lemma 10.12] in the last case we have  $n \leq 4$ .

Let us denote by  $c_i := c_i(\mathcal{E})$  the  $i$ -th Chern class of the rank 2 vector bundle  $\mathcal{E}$ ,  $i = 1, 2$ . Then by the relative Euler exact sequence we have

$$-K_W \sim 2H + g^*(-K_V - c_1)$$

and by the Hirsh formula

$$H^2 \equiv H \cdot g^*c_1 - c_2, \quad H^3 = c_1^2 - c_2.$$

In particular, we get the following formula:

$$(6.9) \quad -K_W^3 = 6K_V^2 + 2c_1^2 - 8c_2.$$

Recall also the Riemann–Roch formula for rank 2 vector bundles over a rational surface:

$$(6.10) \quad \chi(\mathcal{E}) = \frac{1}{2}(c_1^2 - 2c_2 - K_V \cdot c_1) + 2.$$

We will need the following lemmas:

**Lemma 6.11** ([26]). *In the above notation and assumptions, the inequality*

$$c_1 \cdot B \leq -3K_V \cdot B$$

*holds for every nef divisor  $B$  on  $V$ .*

*Proof.* Since

$$D_W \sim H + g^*(-K_V - c_1),$$

for the nef divisor  $B$  on the surface  $V$  we have

$$0 \leq -K_W \cdot D_W \cdot g^*B = 2H^2 \cdot g^*B + 3(-K_V - c_1) \cdot B = 2c_1 \cdot B + 3(-K_V - c_1) \cdot B = -3K_V \cdot B - c_1 \cdot B.$$

$\square$

**Lemma 6.12** ([26]). *In the above notation and assumptions, let  $B > 0$  be a nef divisor on the surface  $V$  such that  $-K_W \cdot D_W \cdot g^*B = 0$ . Then divisor  $-K_W$  is nef.*

*Proof.* Let  $R$  be a horizontal curve on  $W$  such that  $-K_W \cdot R < 0$ . Then

$$D_W \cdot R = (-K_W - H) \cdot R < 0.$$

This implies that  $R \subseteq L \cap D_W$  for a general surface  $L \in |-K_W|$ . But from the condition of lemma we deduce that the intersection  $L \cap D_W$  is composed of fibres of the morphism  $g$ , a contradiction.  $\square$

**Lemma 6.13.** *In the above notation and assumptions, the class  $-K_V + c_1$  is nef on  $V$ .*

*Proof.* The linear system  $|-K_W|$  does not have fixed components and divisor  $H$  is nef (see Remarks 4.4 and 4.5). Then for every irreducible curve  $C$  on the surface  $V$  we have

$$0 \leq -K_W \cdot H \cdot g^*C = 2H^2 \cdot g^*C + (-K_V - c_1) \cdot C = 2c_1 \cdot C + (-K_V - c_1) \cdot C = (-K_V + c_1) \cdot C.$$

$\square$

**Lemma 6.14** ([26, Lemma 10.6]). *In the above notation and assumptions, let  $Z \subset V$  be an irreducible rational curve such that  $\dim |Z| > 0$  and let  $\mathcal{E}|_Z \simeq \mathcal{O}_{\mathbb{P}^1}(d_1) \oplus \mathcal{O}_{\mathbb{P}^1}(d_2)$ . Then  $|d_1 - d_2| \leq 2 + Z^2$ . Moreover, if  $V \simeq \mathbb{F}_n$ ,  $n \geq 0$ , and  $Z$  is the tautological section on  $V$ , then  $|d_1 - d_2| = c_1(\mathcal{E}) \cdot Z$ .*

*Proof.* Let  $m := |d_1 - d_2|$  and  $G := g^{-1}(Z)$ . Then  $G \simeq \mathbb{F}_m$  and for the negative section  $\Sigma$  on  $G$  we have

$$(6.15) \quad -2 + m = -2 - \Sigma^2 = K_G \cdot \Sigma = K_W \cdot \Sigma + G \cdot \Sigma = K_W \cdot \Sigma + Z^2.$$

Since the linear system  $|-K_W|$  does not have fixed components, we get  $K_W \cdot \Sigma \leq 0$  and hence  $m \leq 2 + Z^2$ .

Moreover, if  $Z$  is the tautological section on  $V \simeq \mathbb{F}_n$ ,  $n \geq 0$ , then  $Z^2 = n$  and

$$K_W \cdot \Sigma = g^*(K_V + c_1(\mathcal{E})) \cdot \Sigma = (K_V + c_1(\mathcal{E})) \cdot Z = -n - 2 + c_1(\mathcal{E}) \cdot Z.$$

From (6.15) we obtain  $m = c_1(\mathcal{E}) \cdot Z$ .  $\square$

Recall that by Remark 6.8 we have either  $V = \mathbb{P}^2$  or  $\mathbb{F}_n$  where  $n \in \{0, 2, 3, 4\}$ . We will show that each of these cases is impossible.

**Proposition 6.16.** *In the above notation and assumptions, we have  $V \neq \mathbb{P}^2$ .*

*Proof.* Suppose that  $V = \mathbb{P}^2$ .

We have  $H^{2i}(\mathbb{P}^2, \mathbb{Z}) \simeq \mathbb{Z}$ ,  $i = 1, 2$ . Hence we may assume that  $c_1$  and  $c_2$  are integers. Then by Lemma 6.11  $0 \leq c_1 \leq 9$ .

**Lemma 6.17.** *In the above notation, the rank 2 vector bundle  $\mathcal{E}$  is not decomposable.*

*Proof.* Suppose that  $\mathcal{E}$  is decomposable. Then  $\mathcal{E} \simeq \mathcal{O}_{\mathbb{P}^2}(a) \oplus \mathcal{O}_{\mathbb{P}^2}(a+b)$  for some  $b \geq 0$ . Since  $H$  is nef we also have  $a \geq 0$ .

Furthermore, we have  $c_1 = 2a + b$  and  $c_2 = a^2 + ab$ . Thus, from (6.10) we get

$$\chi(V, \mathcal{E}) = \frac{1}{2} (2a^2 + 2ab + b^2 + 6a + 3b) + 2.$$

By (6.2) and Lemma 6.3  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ . Then from the previous expression and the estimates  $a, b \geq 0$ ,  $0 \leq c_1 \leq 9$  it is easy to see that the only possibility is  $\chi(V, \mathcal{E}) = 36$  and  $(a, b) = (4, 1)$ .

In particular, we have  $c_1 = -3K_V$ . Then it follows from the proof of Lemma 6.11 that

$$-K_W \cdot D_W \cdot g^*B = 0$$

for every curve  $B$  on the surface  $V$ . From Lemma 6.12 we deduce that  $-K_W$  is nef and hence  $W$  is a weak Fano threefold.

On the other hand, for  $(a, b) = (4, 1)$  we have  $c_2 = 20$ . Then by (6.9)  $-K_W^3 = 56$  and by the Riemann–Roch formula and Kawamata–Vieweg Vanishing Theorem we get

$$\dim | -K_W | = -\frac{1}{2}K_W^3 + 2 = 30.$$

But according to Remark 4.6  $\dim | -K_W | \geq 35$ , a contradiction.  $\square$

*Remark 6.18.* It follows from the arguments in the proof of Proposition 10.3 in [26] that if  $c_1 = 9$ , then  $\mathcal{E}$  is decomposable. Thus, by Lemma 6.17 we have  $0 \leq c_1 \leq 8$ .

**Lemma 6.19.** *The class  $c_1$  is even.*

*Proof.* Suppose that  $c_1$  is odd. Then by Remark 6.18 we have  $c_1 = 2m - 3$  for some  $2 \leq m \leq 5$ . Since by (6.2) and Lemma 6.3 we have  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ , from (6.10) we get  $2m^2 - 3m - c_2 \geq 31$ . Then

$$c_1(\mathcal{E}(-m)) = -3, \quad c_2(\mathcal{E}(-m)) = c_2 - m^2 + 3m \leq m^2 - 31 < 0.$$

By the Riemann–Roch formula and Serre Duality we obtain

$$h^0(\mathcal{E}(-m)) + h^0(\mathcal{E}(-m) \otimes \det \mathcal{E}(-m)^* \otimes \mathcal{O}(-3)) \geq \chi(V, \mathcal{E}(-m)) \geq 1.$$

Thus,  $H^0(\mathcal{E}(-m)) \neq 0$ . Let  $s \in H^0(\mathcal{E}(-m))$  be a nonzero section. If  $s$  does not vanish anywhere, then there is an embedding  $\mathcal{O} \hookrightarrow \mathcal{E}(-m)$  and  $\mathcal{E}(-m)$  is decomposable. This contradicts Lemma 6.17.

Let  $\emptyset \neq Y \subset \mathbb{P}^2$  be the zero locus of  $s$ . Since  $c_2(\mathcal{E}(-m)) < 0$ , we have  $\dim Y = 1$ . Take a general line  $Z \subset \mathbb{P}^2$  and let the intersection  $Z \cap Y$  consists of  $k$  points. Since  $c_1(\mathcal{E}(-m)) = -3$ , we have

$$\mathcal{E}(-m)|_Z = \mathcal{O}_{\mathbb{P}^1}(k) \oplus \mathcal{O}_{\mathbb{P}^1}(-k-3).$$

Then by Lemma 6.14 we get  $2k + 3 \leq 3$ . Hence  $k = 0$  and  $Y = \emptyset$ , a contradiction.  $\square$

From Lemma 6.19 and Remark 6.18 we deduce that  $c_1 = 2m - 2$  for some  $1 \leq m \leq 5$ . Since by (6.2) and Lemma 6.3 we have  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ , from (6.10) we get  $2m^2 - m - c_2 \geq 32$ . Then

$$c_1(\mathcal{E}(-m)) = -2, \quad c_2(\mathcal{E}(-m)) = c_2 - m^2 + 2m \leq m^2 + m - 32 < 0.$$

As in the proof of Lemma 6.19, we obtain  $H^0(\mathcal{E}(-m)) \neq 0$  and a section  $s \in H^0(\mathcal{E}(-m))$  with one-dimensional zero locus  $Y \subset \mathbb{P}^2$ .

Take a general line  $Z \subset \mathbb{P}^2$  and let the intersection  $Z \cap Y$  consists of  $k$  points. Since  $c_1(\mathcal{E}(-m)) = -2$ , we have

$$\mathcal{E}(-m)|_Z = \mathcal{O}_{\mathbb{P}^1}(k) \oplus \mathcal{O}_{\mathbb{P}^1}(-k-2).$$

Then by Lemma 6.14 we get  $2k + 2 \leq 3$ . Hence  $k = 0$  and  $Y = \emptyset$ , a contradiction.  $\square$

Proposition 6.16 is completely proved.  $\square$

**Proposition 6.20.** *In the above notation, we have  $V \neq \mathbb{F}_n$  for  $n \in \{0, 2, 3, 4\}$ .*

*Proof.* Suppose that  $V = \mathbb{F}_n$ ,  $n \in \{0, 2, 3, 4\}$ .

We have  $H^4(\mathbb{F}_n, \mathbb{Z}) \simeq \mathbb{Z}$  and  $H^2(\mathbb{F}_n, \mathbb{Z}) \simeq \mathbb{Z} \cdot h \oplus \mathbb{Z} \cdot l$  where  $h$  is the negative section and  $l$  is a fibre on  $\mathbb{F}_n$ . Set  $c_1 := ah + bl$ ,  $c_2 := c$  where  $a, b, c \in \mathbb{Z}$ . Then by Lemma 6.11 we have

$$(6.21) \quad a = c_1 \cdot l \leq -3K_V \cdot l = 6, \quad b = c_1 \cdot (h + nl) \leq 3(2 + n).$$

Moreover,  $a \geq 0$  and  $b \geq na$  because  $H$  is nef.

Let  $p, q$  be the integers such that  $a = 2p + a'$ ,  $b = 2q + b'$  for some  $a', b' \in \mathbb{Z}$  with  $-2 \leq a', b' \leq -1$ . Consider the twisted bundle  $\mathcal{E}' := \mathcal{E} \otimes \mathcal{O}_{\mathbb{F}_n}(-p - q)$ . Set  $c'_i := c_i(\mathcal{E}')$  to be the  $i$ -th Chern class of  $\mathcal{E}'$ ,  $i = 1, 2$ . We have

$$(6.22) \quad c'_1 = a'h + b'l, \quad c'_2 = c + nap - aq - bp - np^2 + 2pq.$$

Furthermore, from (6.10) we obtain

$$(6.23) \quad \chi(V, \mathcal{E}) = -\frac{1}{2}na(a+1) + ab + a + b - c + 2$$

and

$$(6.24) \quad \chi(V, \mathcal{E}') = (b' - \frac{1}{2}na')(a' + 1) + a' - c'_2 + 2.$$

**Lemma 6.25.** *In the above notation, if  $n = 0$ , then  $c'_2 < 0$  and  $\chi(V, \mathcal{E}') > 0$ .*

*Proof.* By (6.21) we have  $0 \leq a, b \leq 6$ . Furthermore, from (6.22) and (6.23) we get

$$c'_2 = c - aq - bp + 2pq = \frac{1}{2}ab + a + b - \chi(V, \mathcal{E}) + 2 + \frac{1}{2}a'b'.$$

By (6.2) and Lemma 6.3  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ . Then it is easy to see that  $c'_2 < 0$  when either  $a$  or  $b$  is less than 6. Moreover,  $c'_2 < 0$  for all  $0 \leq a, b \leq 6$  and  $\chi(V, \mathcal{E}) \in \{35, 36\}$ .

Suppose that  $a = b = 6$  and  $\chi(V, \mathcal{E}) \in \{33, 34\}$ . In particular, we have  $c_1 = 6h + 6l = -3K_V$ . Then it follows from the proof of Lemma 6.11 that

$$-K_W \cdot D_W \cdot g^*B = 0$$

for every curve  $B$  on the surface  $V$ . From Lemma 6.12 we deduce that  $-K_W$  is nef and hence  $W$  is a weak Fano threefold.

On the other hand, from (6.23) we get

$$\chi(V, \mathcal{E}) = ab + a + b - c + 2$$

Then for  $a = b = 6$  and  $\chi(V, \mathcal{E}) \in \{33, 34\}$  we have  $c \in \{16, 17\}$ . From (6.9) we get  $-K_W^3 \in \{64, 56\}$  and hence by the Riemann–Roch formula and Kawamata–Vieweg Vanishing Theorem

$$\dim | -K_W | = -\frac{1}{2}K_W^3 + 2 \leq 34.$$

But according to Remark 4.6  $\dim | -K_W | \geq 35$ , a contradiction. Thus, we get  $c'_2 < 0$ .

Now, from (6.24) we get

$$\chi(V, \mathcal{E}') = b'(a' + 1) + a' - c'_2 + 2.$$

Since  $-2 \leq a', b' \leq -1$  and  $c'_2 < 0$ , we have  $\chi(V, \mathcal{E}') > 0$ .  $\square$

**Lemma 6.26.** *In the above notation, if  $n = 2$ , then  $c'_2 < 0$  and  $\chi(V, \mathcal{E}') > 0$ .*

*Proof.* By (6.21) we have  $2a \leq b \leq 12$  and  $0 \leq a \leq 6$ . Furthermore, from (6.22) and (6.23) we get

$$c'_2 = c + 2ap - aq - bp - 2p^2 + 2pq = -\frac{1}{2}a^2 + \frac{1}{2}ab + b - \chi(V, \mathcal{E}) + 2 - \frac{1}{2}a'^2 + \frac{1}{2}a'b'.$$

By (6.2) and Lemma 6.3  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ . Then for  $2a \leq b \leq 12$  and  $0 \leq a \leq 6$  we have

$$c'_2 \leq -\frac{1}{2}a^2 + 6a + 14 - \chi(V, \mathcal{E}) - \frac{1}{2}a'^2 - a' \leq 32 - \chi(V, \mathcal{E}) - \frac{1}{2}a'^2 - a' \leq -1 - \frac{1}{2}a'^2 - a' < 0.$$

Finally, from (6.24) we get

$$\chi(V, \mathcal{E}') = (b' - a')(a' + 1) + a' - c'_2 + 2.$$

Then  $\chi(V, \mathcal{E}') \leq 0$  only for  $a' = -2$  and  $b' = -1$  because  $-2 \leq a', b' \leq -1$  and  $c'_2 < 0$ .

But if  $a' = -2$  and  $b' = -1$ , then  $\chi(V, \mathcal{E}') \leq 0$  only for  $c'_2 = -1$ . Moreover, for  $b' = -1$  we have  $b \leq 11$ . Thus, we get

$$-1 = c'_2 \leq -\frac{1}{2}a^2 + \frac{11}{2}a + 12 - \chi(V, \mathcal{E}) < -1,$$

a contradiction. Hence  $\chi(V, \mathcal{E}') > 0$ .  $\square$

**Lemma 6.27.** *In the above notation, if  $n = 3$ , then  $c'_2 < 0$  and  $\chi(V, \mathcal{E}') > 0$ .*

*Proof.* By (6.21) we have  $3a \leq b \leq 15$  and hence  $0 \leq a \leq 5$ . Furthermore, from (6.22) and (6.23) we get

$$c'_2 = c + 3ap - aq - bp - 3p^2 + 2pq = -\frac{3}{4}a^2 + \frac{1}{2}ab - \frac{1}{2}a + b - \chi(V, \mathcal{E}) + 2 - \frac{3}{4}a'^2 + \frac{1}{2}a'b'.$$

By (6.2) and Lemma 6.3  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ . If  $\chi(V, \mathcal{E}) \in \{34, 35, 36\}$ , then for  $3a \leq b \leq 15$  and  $0 \leq a \leq 5$  we have

$$c'_2 \leq -\frac{3}{4}a^2 + 7a + 17 - \chi(V, \mathcal{E}) - \frac{3}{4}a'^2 + \frac{1}{2}a'b' < 33 - \chi(V, \mathcal{E}) - \frac{1}{2}b' \leq 0.$$

If  $\chi(V, \mathcal{E}) = 33$ , then for  $3a \leq b \leq 14$  and  $0 \leq a \leq 5$  we have

$$c'_2 \leq -\frac{3}{4}a^2 + \frac{13}{2}a - 17 - \frac{3}{4}a'^2 + \frac{1}{2}a'b' \leq -\frac{3}{4}a^2 + \frac{13}{2}a - 15 - \frac{3}{4}a'^2 < 0.$$

Furthermore, for  $\chi(V, \mathcal{E}) = 33$ ,  $b = 15$  and  $0 \leq a \leq 4$  we have

$$c'_2 = -\frac{3}{4}a^2 + 7a - 16 - \frac{3}{4}a'^2 - \frac{1}{2}a' < 0.$$

Suppose that  $\chi(V, \mathcal{E}) = 33$ ,  $a = 5$  and  $b = 15$  (note that  $c'_2 = 0$  in this case). Then from (6.21) and the proof of Lemma 6.11 we deduce that

$$-K_W \cdot D_W \cdot g^*B = 0$$

where  $B \sim h + 3l$  on  $V$ . Lemma 6.12 implies that  $-K_W$  is nef and hence  $W$  is a weak Fano threefold.

On the other hand, from (6.23) we get

$$\chi(V, \mathcal{E}) = -\frac{3}{2}a(a+1) + ab + a + b - c + 2.$$

Then for  $\chi(V, \mathcal{E}) = 33$ ,  $a = 5$  and  $b = 15$  we have  $c = 19$ . From (6.9) we get  $-K_W^3 = 46$  and hence by the Riemann–Roch formula and Kawamata–Vieweg Vanishing Theorem

$$\dim | -K_W | = -\frac{1}{2}K_W^3 + 2 = 25.$$

But according to Remark 4.6  $\dim | -K_W | \geq 35$ , a contradiction. Thus, we get  $c'_2 < 0$ .

Now, from (6.24) we get

$$\chi(V, \mathcal{E}') = (b' - \frac{3}{2}a')(a' + 1) + a' - c'_2 + 2.$$

Then  $\chi(V, \mathcal{E}') \leq 0$  only for  $a' = -2$  because  $-2 \leq a', b' \leq -1$  and  $c'_2 < 0$ .

If  $a' = -2$  and  $b' = -1$ , then  $\chi(V, \mathcal{E}') = -2 - c'_2$  and

$$c'_2 = -\frac{3}{4}a^2 + \frac{1}{2}ab - \frac{1}{2}a + b - \chi(V, \mathcal{E}).$$

Since  $a' = -2$ , we get  $0 \leq a \leq 4$ . Then for  $3a \leq b \leq 13$  we have

$$c'_2 \leq -\frac{3}{4}a^2 + 6a + 13 - \chi(V, \mathcal{E}) \leq -\frac{3}{4}a^2 + 6a - 20 < -2.$$

Furthermore, for  $b > 13$  we get  $b = 15$  because  $b' = -1$ . Then for  $0 \leq a \leq 3$  we have

$$c'_2 \leq -\frac{3}{4}a^2 + 7a + 15 - \chi(V, \mathcal{E}) \leq -\frac{3}{4}a^2 + 7a - 18 < -2.$$

Suppose that  $a = 4$  and  $b = 15$  (note that  $c'_2 = -2$  and hence  $\chi(V, \mathcal{E}') = 0$  in this case). Then from (6.21) and the proof of Lemma 6.11 we deduce that

$$-K_W \cdot D_W \cdot g^*B = 0$$

where  $B \sim h + 3l$  on  $V$ . Lemma 6.12 implies that  $-K_W$  is nef and hence  $W$  is a weak Fano threefold. On the other hand, for  $a = 4$  and  $b = 15$  from (6.23) we get  $c = 51 - \chi(V, \mathcal{E})$  and hence  $c \in \{15, 16, 17, 18\}$ . Then by (6.9) we have  $-K_W^3 \in \{48, 56, 64, 72\}$ .

If  $-K_W^3 = 72$ , then from Theorem 1.3, Remarks 2.9, 2.13 and 2.15 we deduce that the threefold  $W$  is isomorphic to that constructed either in Example 2.12 or in Example 2.14. In particular, we have either  $\rho(W) = 2$  or  $5$  which is impossible because  $\rho(W) = 3$ .

Furthermore, for  $-K_W^3 \in \{48, 56, 64\}$  by the Riemann–Roch formula and Kawamata–Vieweg Vanishing Theorem we have

$$\dim | -K_W | = -\frac{1}{2}K_W^3 + 2 \leq 34.$$

But according to Remark 4.6  $\dim | -K_W | \geq 35$ , a contradiction.

Finally, if  $a' = -2$  and  $b' = -2$ , then  $\chi(V, \mathcal{E}') = -1 - c'_2$  and

$$c'_2 = -\frac{3}{4}a^2 + \frac{1}{2}ab - \frac{1}{2}a + b - \chi(V, \mathcal{E}) + 1.$$

We have  $a \leq 4$  and  $3a \leq b \leq 14$ . Then

$$c'_2 \leq -\frac{3}{4}a^2 + \frac{13}{2}a - 18 < -1.$$

Thus, we get  $\chi(V, \mathcal{E}') > 0$ . □

**Lemma 6.28.** *In the above notation, if  $n = 4$ , then  $c'_2 < 0$  and  $\chi(V, \mathcal{E}') > 0$ .*

*Proof.* By (6.21) we have  $4a \leq b \leq 18$  and hence  $0 \leq a \leq 4$ . Furthermore, from (6.22) and (6.23) we get

$$c'_2 = c + 4ap - aq - bp - 4p^2 + 2pq = -a^2 + \frac{1}{2}ab - a + b - \chi(V, \mathcal{E}) + 2 - a'^2 + \frac{1}{2}a'b'.$$

By (6.2) and Lemma 6.3  $\chi(V, \mathcal{E}) \in \{33, 34, 35, 36\}$ . If  $b \leq 17$ , then for  $0 \leq a \leq 4$  we have

$$c'_2 \leq -a^2 + \frac{15}{2}a - 14 - a'^2 + \frac{1}{2}a'b' \leq -a^2 + \frac{15}{2}a - 14 - a'^2 - a' < 0.$$

Suppose that  $b = 18$  and  $\chi(V, \mathcal{E}) \in \{33, 34, 35\}$ . Then  $c'_2 \geq 0$  only for  $a \in \{3, 4\}$ . Furthermore, from (6.21) and the proof of Lemma 6.11 we deduce that

$$-K_W \cdot D_W \cdot g^*B = 0$$

where  $B \sim h + 4l$  on  $V$ . Lemma 6.12 implies that  $-K_W$  is nef and hence  $W$  is a weak Fano threefold.

On the other hand, for  $a \in \{3, 4\}$  and  $b = 18$  from (6.23) we get

$$c = a(17 - 2a) + 20 - \chi(V, \mathcal{E})$$

and hence  $17 \leq c \leq 23$ . Since for  $a \in \{3, 4\}$  and  $b = 18$  we have  $c_1^2 \in \{72, 80\}$ , from (6.9) we get

$$-K_W^3 \in \{192 - 8c, 208 - 8c\}.$$

If  $c = 17$  and  $c_1^2 = 80$ , then  $-K_W^3 = 72$  and from Theorem 1.3, Remarks 2.9, 2.13 and 2.15 we deduce that the threefold  $W$  is isomorphic to that constructed either in Example 2.12 or in Example 2.14. In particular, we have either  $\rho(W) = 2$  or  $5$  which is impossible because  $\rho(W) = 3$ .

Furthermore, for  $18 \leq c \leq 23$  we have

$$-K_W^3 \leq 208 - 8c \leq 64$$

and by the Riemann–Roch formula and Kawamata–Vieweg Vanishing Theorem

$$\dim | -K_W | = -\frac{1}{2}K_W^3 + 2 \leq 34.$$

But according to Remark 4.6  $\dim | -K_W | \geq 35$ , a contradiction.



Suppose that  $b = 18$  and  $\chi(V, \mathcal{E}) = 36$ . Then again  $c'_2 \geq 0$  only for  $a \in \{3, 4\}$ . By the previous arguments  $W$  is a weak Fano threefold such that  $-K_W^3 \leq 56$  and hence  $\dim |-K_W| \leq 30$  which contradicts the estimate in Remark 4.6. Thus, we get  $c'_2 < 0$ .

Now, from (6.24) we obtain

$$\chi(V, \mathcal{E}') = (b' - 2a')(a' + 1) + a' - c'_2 + 2.$$

Then  $\chi(V, \mathcal{E}') \leq 0$  only for  $a' = -2$  because  $-2 \leq a', b' \leq -1$  and  $c'_2 < 0$ .

If  $a' = -2$  and  $b' = -1$ , then  $\chi(V, \mathcal{E}') = -3 - c'_2$  and

$$c'_2 = -a^2 + \frac{1}{2}ab - a + b - \chi(V, \mathcal{E}) - 1.$$

Since  $b' = -1$ , we have  $4a \leq b \leq 17$ . If  $0 \leq a \leq 3$ , then we have

$$c'_2 \leq -a^2 + \frac{15}{2}a - 17 < -3.$$

If  $a = 4$  and  $4a \leq b \leq 16$ , then we have

$$c'_2 \leq -54 + 3b < -3.$$

Suppose that  $a = 4$  and  $b = 17$  (note that  $c'_2 = -3$  and hence  $\chi(V, \mathcal{E}') = 0$  in this case). Then we have  $-K_V + c_1 = 6h + 23l$  which is not nef on  $V$ . This contradicts Lemma 6.13.

Finally, if  $a' = -2$  and  $b' = -2$ , then  $\chi(V, \mathcal{E}') = -2 - c'_2$  and

$$c'_2 = -a^2 + \frac{1}{2}ab - a + b - \chi(V, \mathcal{E}).$$

If  $4a \leq b \leq 16$ , then for  $0 \leq a \leq 4$  we have

$$c'_2 \leq -a^2 + 7a - 17 < -2.$$

Furthermore, for  $b > 16$  we get  $b = 18$  because  $b' = -2$ . Then for  $0 \leq a \leq 3$  we have  $0 \leq a \leq 2$ , since  $a' = -2$ , and

$$c'_2 \leq -a^2 + 8a - 15 < -2.$$

Suppose that  $b = 18$  and  $a = 4$ . Then, as in the proof of the estimate  $c'_2 < 0$ , we get that  $W$  is a weak Fano threefold such that either  $-K_W^3 = 72$  or  $-K_W^3 \leq 64$ . As we have seen this is impossible. Thus, we get  $\chi(V, \mathcal{E}') > 0$ .  $\square$

**Lemma 6.29** ([26, Claim 10.18]). *In the above notation, we have  $H^0(V, \mathcal{E}') \neq 0$ .*

*Proof.* Assume that  $H^0(V, \mathcal{E}') = 0$ . Then by Lemmas 6.25–6.28 we have  $H^2(V, \mathcal{E}') \neq 0$ . Furthermore, by Serre Duality

$$H^2(V, \mathcal{E}')^* \simeq H^0(V, \mathcal{E}'^* \otimes K_V) \simeq H^0(V, \mathcal{E}' \otimes \det \mathcal{E}'^* \otimes K_V).$$

But  $(\det \mathcal{E}'^* \otimes K_V)^* = \mathcal{O}_V((a' + 2)h + (b' + n + 2)l)$  and hence  $H^0(V, (\det \mathcal{E}'^* \otimes K_V)^*) \neq 0$ , a contradiction.  $\square$

Let  $s \in H^0(V, \mathcal{E}')$  be a nonzero section. If  $s$  does not vanish anywhere, then  $\mathcal{E}'$  is an extension of some line bundle  $\mathcal{E}_1$  by  $\mathcal{O}$ . But then  $c'_2 = 0$  which is impossible by Lemmas 6.25–6.28.

Let  $\emptyset \neq Y \subset V$  be the zero locus of  $s$ . Since  $c'_2 < 0$ , we have  $\dim Y = 1$ . Let  $Y \sim q_1h + q_2l$ . Then the restriction of  $\mathcal{E}'$  on general curve  $Z \in |h + nl|$  is

$$\mathcal{E}'|_Z = \mathcal{O}_{\mathbb{P}^1}(q_2) \oplus \mathcal{O}_{\mathbb{P}^1}(b' - q_2).$$

By Lemma 6.14 applied to  $\mathcal{E}'$  we have

$$0 \leq 2q_2 - b' = c'_1 \cdot Z = b' \leq -1,$$

a contradiction. Proposition 6.20 is completely proved.  $\square$

From Propositions 6.16 and 6.20 we derive a contradiction in case when  $V$  is a surface which completes the proof of Theorem 1.4.
