More non-abelian loop Toda solitons

Abstract

We find soliton-like solutions in a particular case of non-abelian loop Toda equations associated with general linear groups. We use the formalism of rational dressing based on appropriate block-matrix representation suggested by the Z-gradation under consideration. We present solutions in a form of a direct matrix generalization of the Hirota's soliton constructions already well-known for the case of abelian loop Toda systems.

1 Introduction: Toda equations

The loop Toda systems associated with complex classical Lie groups, when the corresponding loop Lie algebras are endowed with integrable Z-gradations with finitedimensional grading subspaces, can be given by the equation [\[1,](#page-6-0) [2,](#page-6-1) [3,](#page-6-2) [4,](#page-7-0) [5\]](#page-7-1) (see also [\[6,](#page-7-2) [7,](#page-7-3) [8,](#page-7-4) [9,](#page-7-5) [10\]](#page-7-6) and references therein),

$$
\partial_+(\gamma^{-1}\partial_-\gamma) = [c_-, \gamma^{-1}c_+\gamma],\tag{1}
$$

supplied by the conditions

$$
\partial_+ c_- = 0, \qquad \partial_- c_+ = 0. \tag{2}
$$

Here*,* γ is a mapping of \mathbb{R}^2 to a complex classical Lie group *G* having a block-diagonal form

$$
\gamma = \left(\begin{array}{ccc} \Gamma_1 & & \\ & \Gamma_2 & \\ & & \ddots \\ & & & \Gamma_p \end{array}\right),
$$

so that for each $\alpha~=~1,\ldots,p$ the mapping \varGamma_α is a mapping of \mathbb{R}^2 to the Lie group $GL_{n_{\alpha}}(\mathbb{C})$, or its certain subgroup. The *p* positive integers n_{α} , defining the block-matrix structure, are suggested by the Z-gradation under consideration. Further, c_+ and $c_−$ are mappings of \mathbb{R}^2 to the Lie algebra g of the Lie group *G*. The mapping c_+ has the block-matrix structure

$$
c_{+} = \begin{pmatrix} 0 & C_{+1} & & & \\ & 0 & \ddots & & \\ & & \ddots & \ddots & \\ & & & 0 & C_{+(p-1)} \\ C_{+0} & & & & 0 \end{pmatrix},
$$

where for each $\alpha = 1, \ldots, p - 1$ the mapping $C_{+\alpha}$ is a mapping of \mathbb{R}^2 to the space of $n_{\alpha} \times n_{\alpha+1}$ complex matrices, and C_{+0} is a mapping of \mathbb{R}^2 to the space of $n_p \times n_1$ complex matrices. The mapping *c*− has a similar block-matrix structure,

$$
c_{-} = \left(\begin{array}{cccc} 0 & & & & C_{-0} \\ C_{-1} & 0 & & & \\ & \ddots & \ddots & \ddots & \\ & & \ddots & 0 & \\ & & & C_{-(p-1)} & 0 \end{array}\right),
$$

where for each $\alpha = 1, \ldots, p - 1$ the mapping $C_{-\alpha}$ is a mapping of \mathbb{R}^2 to the space of $n_{\alpha+1} \times n_\alpha$ complex matrices, and C_{-0} is a mapping of \mathbb{R}^2 to the space of $n_1 \times n_p$ complex matrices. The notation *∂*+ and *∂*− is used for the derivatives over the standard coordinates in R² which we denote by *z* ⁺ and *z* −.

In the present paper we consider a particular case of non-abelian loop Toda equations associated with the complex general linear group $GL_n(\mathbb{C})$, where the \mathbb{Z} -gradation of the corresponding loop Lie algebra is generated by an inner automorphism of the initial complex Lie algebra gl*ⁿ* (C), leading to an equal-size block-matrix partition of the algebra and group elements, that is $n_\alpha = n/p = n_*$ for all $\alpha = 1, \ldots, p$. Moreover, we assume for simplicity that all nonzero entries of the block-matrix representation of c_+ and c_- are unit matrices, $C_{\pm\alpha} = I_{n_\alpha}$.

Now, the Toda equation [\(1\)](#page-0-0) can be written as an infinite periodic system,

$$
\partial_{+}(\Gamma_{\alpha}^{-1}\partial_{-}\Gamma_{\alpha}) + \Gamma_{\alpha}^{-1}\Gamma_{\alpha+1} - \Gamma_{\alpha-1}^{-1}\Gamma_{\alpha} = 0, \tag{3}
$$

with Γ_{α} subject to the condition $\Gamma_{\alpha+p} = \Gamma_{\alpha}$. This particular case of Toda systems was introduced in [\[11\]](#page-7-7). The case of $p = 2$ and $n_* = 2$, with certain unitarity constraints, was also treated in [\[12\]](#page-7-8) as a simplest matrix generalization of the sin-Gordon equation. Later on, it was considered in [\[13\]](#page-7-9) as an example of nonlinear integrable systems for which a combination of the notion of quasi-determinants and a Marchenko lemma would allow for constructing certain soliton-like solutions. We will apply to the equations [\(3\)](#page-1-0) the rational dressing method of [\[11\]](#page-7-7) in order to construct soliton solutions for this particular case of non-abelian loop Toda equations. Specifically, we follow our recent consideration presented in [\[14,](#page-7-10) [15\]](#page-7-11).

2 Rational dressing

We see that the constant matrices *c*− and *c*+ commute. Hence, it is obvious that

$$
\gamma = I_n,\tag{4}
$$

where I_n is the $n \times n$ unit matrix, is a solution to the Toda equation [\(1\)](#page-0-0). For the formalism of rational dressing it is crucial that the Toda equation [\(1\)](#page-0-0), [\(2\)](#page-0-1) can be represented as the zero-curvature condition for a flat connection in a trivial principal fiber bundle, satisfying the grading and gauge-fixing conditions, see, for example, the books [\[1,](#page-6-0) [2\]](#page-6-1). Actually, having such a connection we have a solution to the Toda equations [\(1\)](#page-0-0). In our case, the corresponding base manifold is the Euclidean plane \mathbb{R}^2 and the fiber coincides with the untwisted loop group $\mathcal{L}_{a,p}(GL_n(\mathbb{C}))$, where *a* denotes the inner automorphism of $GL_n(\mathbb{C})$ of order p acting on an element $g \in GL_n(\mathbb{C})$ in accordance with the equality

$$
a(g) = hgh^{-1}.
$$

Here *h* is a block-diagonal matrix defined by the relation

$$
h_{\alpha\beta} = \epsilon_p^{p-\alpha+1} I_{n_*} \delta_{\alpha\beta}, \qquad \alpha, \beta = 1, \dots, p,
$$
 (5)

where $\epsilon_p = e^{2\pi i/p}$ is the *p*th principal root of unity.

Using the exponential law [\[16,](#page-7-12) [17\]](#page-7-13), it is convenient to identify the mapping generating a flat connection under consideration with a smooth mapping of $\mathbb{R}^2 \times S^1$ to $GL_n(\widetilde{\mathbb{C}})$ and the connection components with smooth mappings of $\mathbb{R}^2 \times S^1$ to $\mathfrak{gl}_n(\mathbb{C})$. Below we think of the circle S^1 as consisting of complex numbers of modulus one.

Denote the mapping generating the connection corresponding to the solution [\(4\)](#page-2-0) by *ϕ*. For the case under consideration, the rational dressing method consists in finding \tilde{H} mapping ψ of $\mathbb{R}^2\times S^1$ to $\mathrm{GL}_n(\mathbb{C})$, such that the grading and gauge-fixing conditions for the components of the flat connection generated by the mapping *ϕψ* are satisfied. We assume that the analytic extension of the mapping *ψ* from *S* 1 to the whole Riemann sphere is a rational mapping given by the expression

$$
\psi = \left(I_n + \sum_{i=1}^r \sum_{k=1}^p \frac{\lambda}{\lambda - \epsilon_p^k \mu_i} h^k P_i h^{-k}\right) \psi_0.
$$
\n(6)

Here λ is the standard coordinate in $\mathbb C$, ψ_0 is a mapping of $\mathbb R^2$ to the Lie subgroup of $GL_n(\mathbb{C})$ formed by the elements $g \in GL_n(\mathbb{C})$ subject to the equality $hgh^{-1} = g$, and P_i are some smooth mappings of \mathbb{R}^2 to the algebra $\text{Mat}_n(\mathbb{C})$ of $n \times n$ complex matrices. It is also assumed here that $\mu_i \neq 0$, μ_i^p $\begin{array}{c} p \\ i \end{array} \neq \mu_j^p$ j ^{*l*} for all $i \neq j$. The expression [\(6\)](#page-2-1) is obtained from an initial rational mapping by averaging over the action of the inner automorphism *a*, where it was used that $a^p = \mathrm{id}_{\mathrm{GL}(\mathbb{C})}$. Further, we suppose that the analytic extension of the corresponding inverse mapping to the whole Riemann sphere has a similar structure,

$$
\psi^{-1} = \psi_0^{-1} \left(I_n + \sum_{i=1}^r \sum_{k=1}^p \frac{\lambda}{\lambda - \epsilon_p^k v_i} h^k Q_i h^{-k} \right),
$$

with the pole positions satisfying the conditions $\nu_i \neq 0$, ν_i^p $\begin{array}{c} p \\ i \end{array} \neq \nu_j^p$ j^p for all $i \neq j$, and additionally *ν p* $\mu_i^p \neq \mu_j^p$ *f*_{*j*} for any *i* and *j*. Note that the mappings $ψ(λ)$ and $ψ^{-1}(λ)$ are regular at the points $\lambda = 0$ and $\lambda = \infty$.

By definition, the equality

$$
\psi^{-1}\psi=I_n
$$

is valid on S^1 . Since ψ and ψ^{-1} are rational mappings, this equality is valid on the whole Riemann sphere. Therefore, the residues of $\psi^{-1}\psi$ at the points μ_i and ν_i must vanish. This leads to certain relations to be satisfied by the mappings *Pⁱ* and *Qⁱ* . Further, for the components of the flat connection generated by the mapping *ϕψ* we find the expressions

$$
\omega_{-} = \psi^{-1} \partial_{-} \psi + \lambda^{-1} \psi^{-1} c_{-} \psi,
$$

$$
\omega_{+} = \psi^{-1} \partial_{+} \psi + \lambda \psi^{-1} c_{+} \psi.
$$

We see that *ω*[−] is a rational mapping having simple poles at *µⁱ* , *νⁱ* and zero. Similarly, ω_+ is a rational mapping having simple poles at μ_i , ν_i and infinity. We need a connection satisfying the grading and gauge-fixing conditions. The grading condition in our case means that for each point of \mathbb{R}^2 the component ω_- is rational and has the only simple pole at zero, and the component ω_+ is rational and has the only simple pole at infinity. Therefore, we require that the residues of ω _− and ω ₊ at the points μ ^{*i*} and ν ^{*i*} must vanish. And this requirement imposes additional conditions on the mappings *Pⁱ* and *Qⁱ* . Having these and the above mentioned relations fulfilled by *Pⁱ* and *Qⁱ* , and besides assuming that $\psi_0 = I_n$ that resolves the gauge-fixing constraints, we can see that the mapping $\gamma = \psi(\infty)$, with fixed 2r complex numbers μ_i , ν_i , satisfies the Toda equation [\(1\)](#page-0-0). In the block-matrix form we have the expressions

$$
\gamma_{\alpha\beta} = \delta_{\alpha\beta} \left(I_{n_*} + p \sum_{i=1}^r (P_i)_{\alpha\alpha} \right), \qquad \gamma_{\alpha\beta}^{-1} = \delta_{\alpha\beta} \left(I_{n_*} + p \sum_{i=1}^r (Q_i)_{\alpha\alpha} \right), \tag{7}
$$

where $(P_i)_{\alpha\beta}$ and $(Q_i)_{\alpha\beta}$ are $n_*\times n_*$ complex matrices satisfying certain conditions as briefly mentioned above, see [\[14,](#page-7-10) [15\]](#page-7-11).

To make the solution [\(7\)](#page-3-0) explicit we should specify the matrix-valued functions P_i and Q_i . We first note that, if we suppose that the functions P_i and Q_i take values in the space of the matrices of maximum rank, then we come to the trivial solution [\(4\)](#page-2-0). Hence, we assume that the values of the functions P_i and Q_i are not matrices of maximum rank. The case given by matrices of rank one was elaborated in [\[15\]](#page-7-11). Now we consider another interesting case, where the functions P_i and Q_i take values in the space of $n \times n$ matrices of rank n_{*} . Such functions can be represented as

$$
P_i = u_i^{\ t} w_i, \qquad Q_i = x_i^{\ t} y_i, \tag{8}
$$

where *u*, *w*, *x* and *y* are functions on \mathbb{R}^2 taking values in the space of $n \times n_*$ complex matrices of rank *n*∗. The used Z-gradation suggests the most convenient block-matrix representation for the matrices of the form [\(8\)](#page-3-1) as

$$
(P_i)_{\alpha\beta} = u_{i,\alpha}{}^t w_{i,\beta}, \qquad (Q_i)_{\alpha\beta} = x_{i,\alpha}{}^t y_{i,\beta},
$$

where the standard matrix multiplication of the $n_* \times n_*$ matrix-valued functions $u_{i,\alpha}$, $x_{i,a}$ by the $n_* \times n_*$ matrix-valued functions ${}^t w_{i,\beta}$, ${}^t y_{i,\beta}$ is implied.

Then, within the formalism of rational dressing we see that the functions *w* and *x* can be expressed via the functions *y* and *u*, and we find the expressions

$$
(P_i)_{\alpha\beta} = -\frac{1}{p} u_{i,\alpha} \sum_{j=1}^r (R_\beta^{-1})_{ij} t y_{j,\beta}, \qquad (Q_i)_{\alpha\beta} = \frac{1}{p} \sum_{j=1}^r u_{j,\alpha} \frac{1}{\mu_j} (R_{\alpha+1}^{-1})_{ji} v_i t y_{i,\beta},
$$

with $n_*r \times n_*r$ matrix-valued functions R_α defined through its $n_* \times n_*$ blocks as

$$
(R_{\alpha})_{ij} = \frac{1}{\nu_i^p - \mu_j^p} \sum_{\beta=1}^p \nu_i^{p-|\beta-\alpha|_p} \mu_j^{|\beta-\alpha|_p} t_{\mathcal{Y}_i,\beta} u_{j,\beta},
$$

where $|x|_p$ denotes the residue of division of *x* by *p*. Note that, unlike the abelian and non-abelian cases considered in [\[14,](#page-7-10) [15\]](#page-7-11), here $(R_\alpha)_{ii}$ is an $n_* \times n_*$ matrix-valued function for any *i*, *j*.

It is convenient to use quantities defined as $\widetilde{u}_{i,\alpha} = u_{i,\alpha} \mu_i^{\alpha}$ \widetilde{y}_i , $\widetilde{y}_{i,\alpha} = y_{i,\alpha}v_i^{-\alpha}$ $a_i^{-\alpha}$ and $(R_\alpha)_{ij} =$ *ν* −*α* $\int_i^{-\alpha} (R_\alpha)_{ij} \mu_j^\alpha$ $\int\limits_0^\alpha$. For the matrices R_α we have explicitly the relation

$$
(\widetilde{R}_{\alpha})_{ij} = \frac{1}{\nu_i^p - \mu_j^p} \left(\mu_j^p \sum_{\beta=1}^{\alpha-1} {}^t \widetilde{y}_{i,\beta} \widetilde{u}_{j,\beta} + \nu_i^p \sum_{\beta=\alpha}^p {}^t \widetilde{y}_{i,\beta} \widetilde{u}_{j,\beta} \right).
$$

Then, in terms of these quantities, the $n_* \times n_*$ matrix-valued functions Γ_α can be written as

$$
\Gamma_{\alpha} = I_{n_{\alpha}} - \sum_{i,j=1}^{r} \widetilde{u}_{i,\alpha} (\widetilde{R}_{\alpha}^{-1})_{ij} {}^{t} \widetilde{y}_{j,\alpha}.
$$

Similarly, for the corresponding inverse mappings we obtain the expression

$$
\Gamma_{\alpha}^{-1} = I_{n_{\alpha}} + \sum_{i,j=1}^{r} \widetilde{u}_{i,\alpha} (\widetilde{R}_{\alpha+1}^{-1})_{ij} {}^{t} \widetilde{y}_{j,\alpha},
$$

which can be useful for verifying the Toda equations.

To finally satisfy the conditions imposed earlier on the matrix-valued functions *Pⁱ* and *Qⁱ* , we also demand the validity of the equations

$$
\partial_{-}u_{i} = -\mu_{i}^{-1}c_{-}u_{i}, \qquad \partial_{+}u_{i} = -\mu_{i}c_{+}u_{i}
$$
\n(9)

$$
\partial_{-}y_{i} = v_{i}^{-1} {}^{t}c_{-}y_{i}, \qquad \partial_{+}y_{i} = v_{i} {}^{t}c_{+}y_{i}, \qquad (10)
$$

see, for example, [\[15\]](#page-7-11). Using the explicit forms of the matrices c_{\pm} , we write down the general solutions to (9) , (10) as^{[1](#page-4-2)}

$$
u_{i,\beta} = \sum_{\alpha=1}^p \epsilon_p^{\beta \alpha} \exp\left(-\mu_i^{-1} \epsilon_p^{-\alpha} z^{-} - \mu_i \epsilon_p^{\alpha} z^{+}\right) c_{i,\alpha}, \qquad (11)
$$

$$
y_{i,\beta} = \sum_{\alpha=1}^p \epsilon_p^{\beta \alpha} \exp \left(\nu_i^{-1} \epsilon_p^{\alpha} z^{-} + \nu_i \epsilon_p^{-\alpha} z^{+} \right) d_{i,\alpha}, \tag{12}
$$

where $c_{i,\alpha}$ and $d_{i,\alpha}$ are $n_* \times n_*$ complex matrices meaning the initial-value data for the equations [\(9\)](#page-4-0), [\(10\)](#page-4-1). With these solutions we immediately obtain for the blocks of the matrix-valued functions \overline{R}_{α} the following expression:

$$
(\widetilde{R}_{\alpha})_{ij} = \sum_{\beta,\delta=1}^{p} e^{Z_{-\beta}(\nu_i)-Z_{\delta}(\mu_j)} \frac{\epsilon_p^{\alpha(\beta+\delta)}}{1-\mu_j \nu_i^{-1} \epsilon_p^{\beta+\delta}} \nu_i^{-\alpha} ({}^{t}d_{i,\beta}c_{j,\delta}) \mu_j^{\alpha},
$$

where we have introduced the notation $Z_\alpha(\mu_i) = \mu_i^{-1}$ $\int_{i}^{-1} e^{-\alpha} z^{-} + \mu_{i} e^{\alpha}_{p} z^{+}.$

3 Soliton solutions

To construct solutions making sense as *r*-solitons, that is, by the definition we use here, solutions depending on *r* linear combinations of independent variables *z* ⁺ and *z* [−], we assume that for each value of the index $i = 1, \ldots, r$ the initial-value data of the Toda system under consideration are such that matrix-valued coefficients *ci*,*^α* are different from zero for only one value of *α*, which we denote by *Iⁱ* , and that the matrix-valued coefficients $d_{i,\alpha}$ are different from zero for only two values of α , which we denote by J_i and *Kⁱ* . We also use for such non-vanishing initial-data *n*[∗] × *n*[∗] matrices the notation $d_{J_i} = d_{i,J_i}, d_{K_i} = d_{i,K_i}$ and $c_{I_i} = c_{i,I_i}$. For the $n_* \times n_*$ blocks of the matrix-valued functions \widetilde{u}_i and \widetilde{y}_i this assumption gives

$$
\widetilde{u}_{i,\alpha} = \mu_i^{\alpha} \epsilon_p^{\alpha I_i} e^{-Z_{I_i}(\mu_i)} c_{I_i}, \qquad (13)
$$

$$
{}^{t}\tilde{y}_{i,\alpha} = \nu_{i}^{-\alpha} \epsilon_{p}^{\alpha}{}^{j} e^{Z_{-j_{i}}(\nu_{i})}{}^{t} d_{j_{i}} + \nu_{i}^{-\alpha} \epsilon_{p}^{\alpha}{}^{K_{i}} e^{Z_{-K_{i}}(\nu_{i})}{}^{t} d_{K_{i}}.
$$
 (14)

With these relations, we can write the expression for the mappings Γ_α in the form

$$
\Gamma_{\alpha} = I_{n_{\alpha}} - \sum_{i,j=1}^{r} c_{I_i} (\widetilde{R}_{\alpha}^{\prime -1})_{ij} ({}^{t}d_{J_j} + E_{\alpha,j} {}^{t}d_{K_j}), \qquad (15)
$$

where we have used the notation

$$
(\widetilde{R}'_{\alpha})_{ij} = \widetilde{D}_{ij}(J) + E_{\alpha,i}\widetilde{D}_{ij}(K), \qquad E_{\alpha,i} = \epsilon_p^{\alpha\rho_i} e^{Z_i(\zeta)}, \qquad (16)
$$

with the dependence on the variables z^+ and z^- given through the functions

$$
Z_i(\zeta) = \kappa_{\rho_i}(\zeta_i^{-1}z^- + \zeta_i z^+),
$$

and the convenient parameters $\rho_i = K_i - J_i$, $\zeta_i = -i v_i \epsilon_p^{-(K_i+J_i)/2}$, $\kappa_{\rho_i} = 2 \sin(\pi \rho/p)$, and besides *^tdAⁱ*

$$
\widetilde{D}_{ij}(A) = \frac{{}^{t}d_{A_i}c_{I_j}}{1 - \nu_i^{-1}\mu_j \epsilon_p^{A_i + I_j}}, \qquad i, j = 1, ..., r,
$$
\n(17)

for the $n_* \times n_*$ blocks of the $n_* r \times n_* r$ matrices $\widetilde{D}(A)$, $A = J$, *K* already introduced in our previous paper [\[15\]](#page-7-11).

We assume that the *n*[∗] × *n*[∗] matrices *cIⁱ* are non-degenerate. Let us multiply *Γ^α* in [\(15\)](#page-5-0) by c_{I_ℓ} from the right hand side and write

$$
\Gamma_{\alpha} c_{I_{\ell}} = \sum_{i,j=1}^{r} c_{I_{i}} (\widetilde{R}_{\alpha}^{\prime -1})_{ij} [(\widetilde{R}_{\alpha}^{\prime})_{j\ell} - ({}^{t}d_{J_{j}} + E_{\alpha,j}{}^{t}d_{K_{j}}) c_{I_{\ell}}].
$$
\n(18)

It is not difficult to see that

$$
(\widetilde{R}'_{\alpha})_{j\ell}-({}^{t}d_{J_j}+E_{\alpha,j}{}^{t}d_{K_j})c_{I_{\ell}}=v_j^{-1}\epsilon_{p}^{J_j}(\widetilde{R}'_{\alpha+1})_{j\ell}\mu_{\ell}\epsilon_{p}^{I_{\ell}}.
$$

Now, multiplying [\(18\)](#page-5-1) from the right hand side by the inverse matrix c_{L}^{-1} I_{ℓ}^{-1} and summing up over $\ell = 1, \ldots, r$, we obtain the following expression:

$$
\Gamma_{\alpha} = \frac{1}{r} \sum_{i,j,k=1}^r c_{I_i} (\widetilde{R}_{\alpha}^{\prime -1})_{ij} v_j^{-1} \epsilon_p^{J_j} (\widetilde{R}_{\alpha+1}^{\prime})_{jk} \mu_k \epsilon_p^{I_k} c_{I_k}^{-1}.
$$

To give the soliton solutions a final form, it is also convenient to make use of simplest symmetries of the Toda equation. It is clear from the relations [\(3\)](#page-1-0) that the transformations

$$
\Gamma_{\alpha} \to \xi \Gamma_{\alpha}, \qquad \Gamma_{\alpha} \to x^{-1} \Gamma_{\alpha} x \tag{19}
$$

for a nonzero constant ζ and a non-singular constant $n_* \times n_*$ matrix *x* are symmetry transformations of the Toda system under consideration.

In particular, using the symmetry transformations [\(19\)](#page-6-3) with $\xi = \mu^{-1} \nu \epsilon_p^{-(I+I)}$ and $x = c_I$, we can write the one-soliton solution as

$$
\Gamma_{\alpha} = \widetilde{R}_{\alpha}'^{-1} \widetilde{R}_{\alpha+1}' \tag{20}
$$

where the matrices \widetilde{R}'_{α} are explicitly given by the relations [\(16\)](#page-5-2), [\(17\)](#page-5-3). It reproduces exactly the one-soliton solution constructed in [\[13\]](#page-7-9) by means of a different approach.

Also the multi-soliton solutions, $r \geq 2$, can be written in a compact form,

$$
\Gamma_{\alpha} = {}^{T}c_{I}(\widetilde{R}_{\alpha}^{\prime -1})\mathcal{N}_{J}^{-1}(\widetilde{R}_{\alpha+1}^{\prime})\mathcal{M}_{I}c_{I}^{-1}.
$$
\n(21)

Here we use the notation ${}^{T}c_I$ and c_I^{-1} I_I^{-1} for *n*_∗ × *n* and *n* × *n*_∗ matrices, respectively, defined as ${}^{T}c_I = (c_{I_1} \ldots c_{I_r})$ and ${}^{t}c_I^{-1} = ({}^{t}c_{I_1}^{-1})$ $t_{I_1}^{-1}$. . . ${}^t c_{I_r}^{-1}$ $I_{I_r}^{-1}$), and the notation \mathcal{N}_J^{-1} and \mathcal{M}_I for block-diagonal $n_*r \times n_*r$ matrices defined as

$$
\mathcal{N}_J^{-1} = \left(\begin{array}{ccc} \nu_1^{-1} \epsilon_p^{J_1} I_{n_*} & & \\ & \ddots & \\ & & \nu_r^{-1} \epsilon_p^{J_r} I_{n_*} \end{array} \right), \quad \mathcal{M}_I = \left(\begin{array}{ccc} \mu_1 \epsilon_p^{I_1} I_{n_*} & & \\ & \ddots & \\ & & \mu_r \epsilon_p^{I_r} I_{n_*} \end{array} \right).
$$

Putting *n*[∗] = 1 we can recover the abelian case analyzed in [\[14\]](#page-7-10). The solutions [\(20\)](#page-6-4), [\(21\)](#page-6-5) may be regarded as a novel non-abelian generalization, complementary to that of [\[15\]](#page-7-11), of the Hirota's soliton constructions [\[18\]](#page-7-14) successfully used for the abelian loop Toda systems.

To obtain more solutions to these equations, not necessarily soliton-like, one should keep nonzero more initial-value data $c_{i,\alpha}$ and $d_{i,\alpha}$ entering [\(11\)](#page-4-3), [\(12\)](#page-4-4), that leads to a more general expressions for $\widetilde{u}_{i,\alpha}$ and $\widetilde{y}_{i,\alpha}$ than [\(13\)](#page-5-4) and [\(14\)](#page-5-5).
