## LOCALIZATION WITH LESS LARMES: SIMPLY MSA

VICTOR CHULAEVSKY<sup>1</sup>

Abstract. We give a short summary of the fixed-energy Multi-Scale Analysis (MSA) of the Anderson tight binding model in dimension  $d \geq 1$  and show that this technique admits a straightforward extension to multi-particle systems. We hope that this short note may serve as an elementary introduction to the MSA.

### 1. INTRODUCTION.

In this paper<sup>[1](#page-0-0)</sup>, we study spectral properties of random lattice Schrödinger operators at a fixed, but arbitrary, energy  $E \in \mathbb{R}$ , in the framework of the MSA. The idea of the fixed-energy scale induction goes back to  $[9]$ ,  $[7]$  <sup>[2](#page-0-1)</sup> and  $[13]$ . While fixed-energy analysis alone does not allow to prove spectral localization, it provides a valuable information. Besides, from the physical point of view, a sufficiently rapid decay, with probability one, of Green functions in finite volumes, combined with the celebrated Kubo formula for the zero-frequency conductivity  $\sigma(E)$ , shows that  $\sigma(E) = 0$  for the disordered systems in question.

The main motivation for studying in this paper only the fixed-energy properties of random Hamiltonians came from an observation that such analysis can be made very elementary, even for multi-particle systems considered as difficult since quite a long time (cf. recent works [\[3\]](#page-12-3), [\[4\]](#page-12-4), [\[1\]](#page-12-5), [\[5\]](#page-12-6)).

### 2. The models and basic notations

A popular form of a single-particle random Hamiltonian is as follows:

$$
H(\omega) = H^{(1)}(\omega) = -\Delta + gV(x; \omega),
$$

where  $\Delta$  is the nearest-neighbor lattice Laplacian:

$$
(\Delta f)(x) = \sum_{y: \|y - x\| = 1} f(y), \ x, y \in \mathbb{Z}^d,
$$

and  $V(x; \omega)$  acts as a multiplication operator on  $\mathbb{Z}^d$ . For the sake of simplicity, the random field  $\{V(x; \omega), x \in \mathbb{Z}^d\}$  will be assumed IID, although a large class of correlated random fields can also be considered. In this paper, we consider only the case of "large disorder", i.e., we assume that |g| is sufficiently large. An IID random field on  $\mathbb{Z}^d$  is completely determined by its marginal probability distribution at any site  $x \in \mathbb{Z}^d$ , e.g.,

for  $x = 0$ . We assume that the marginal distribution function of potential V (defined by  $F_V(t) = \mathbb{P}\{V(0;\omega) \leq t\}, t \in \mathbb{R}$  is Hölder-continuous:

$$
\forall t \in \mathbb{R}, \forall \epsilon > 0 \ F_V(t + \epsilon) - F_V(t) \leq Const \ \epsilon^b,
$$
\n(2.1)

for some  $b > 0$ .

For  $N > 1$  particles, positions of which will be denoted by  $x_1, \ldots, x_N$ , or, in vector notations,  $\mathbf{x} = (x_1, \dots, x_N) \in \mathbb{Z}^{Nd}$ , we introduce an interaction energy  $U(\mathbf{x})$ . Again, for the sake of simplicity of presentation, we assume that

$$
U(\mathbf{x}) = U(x_1, ..., x_N) = \sum_{1 \leq j < k \leq N} U_2(\|x_j - x_k\|),
$$

where  $U_2(r)$ ,  $r \geq 0$ , is a bounded two-body interaction potential. The N-particle Hamiltonian considered below will have the following form:

$$
H^{(N)}(\omega) = \sum_{j=1}^{N} \left( -\Delta^{(j)} + gV(x_j; \omega) \right) + U(\mathbf{x}).
$$
 (2.2)

Given a lattice subset  $\Lambda \subset \mathbb{Z}^d$ , we will work with subsets thereof called boxes. It is convenient to allow boxes  $\Lambda_{\ell}(u) \subset \Lambda$  of the following form:

$$
\Lambda_{\ell}(u) = \{ x : ||x - u|| \le \ell - 1 \},\
$$

where  $\|\cdot\|$  is the sup-norm:  $\|x\| = \max_{1 \leq j \leq d} |x_j|$ . Further, we introduce a notion of internal and external "boundaries" relative to  $Λ$ :

$$
\partial^{-}\Lambda_{\ell}(u) = \{ x \in \Lambda : ||x - u|| \leq \ell - 1 \},
$$
  

$$
\partial^{+}\Lambda_{\ell}(u) = \{ x \in \Lambda : \text{dist}(x, \Lambda_{\ell}(u)) = 1 \}.
$$

We also define the boundary  $\partial \Lambda_{\ell}(u) \in \Lambda$  by

$$
\partial\Lambda_\ell(u)=\big\{\,(x,x'):\,x\in\partial^-\Lambda_\ell(u),x'\in\partial^+\Lambda_\ell(u),\,\|x-x'\|=1\,\big\}.
$$

Observe now that the the second-order lattice Laplacian has the form

$$
\Delta = \sum_{(x,x'):\,||x-x'||=1} \Gamma_{x,x'}, \ \Gamma_{x,x'} = |\delta_x\rangle\langle\delta_{x'}|,
$$

so that  $(\Gamma_{x,x'}f)(y) = \delta_{x,y}f(x')$ . Given a box  $\Lambda_{\ell}(u) \subset \Lambda$ , the Laplacian  $\Delta_{\Lambda}$  in  $\Lambda$  with Dirichlet boundary conditions on  $\partial^+ \Lambda$  reads as follows:

$$
\Delta_{\Lambda} = (\Delta_{\Lambda_{\ell}(u)} \oplus \Delta_{\Lambda_L(u) \setminus \Lambda_{\ell}(u)}) + \sum_{(x,x') \in \partial \Lambda_{\ell}(u)} (\Gamma_{x,x'} + \Gamma_{x',x}).
$$

Fix a finite subset  $\Lambda$  and a box  $\Lambda_{\ell}(u) \subset \Lambda$ . Then for any point  $y \in (\Lambda \setminus \Lambda_{\ell}(u))$ , by the second resolvent identity combined with the above decomposition, we obtain the so-called Geometric Resolvent Identity,

$$
G(u, y; E) = \sum_{(x,x') \in \partial \Lambda_{\ell}(u)} G(u, x;) G(x', y; E).
$$

yielding the Geometric Resolvent Inequality (GRI):

$$
|G(u,y;E)|\leq \Big(\max_{x\in \partial^-\Lambda_\ell(u)}|G(u,x;E)|\cdot |\partial^+\Lambda_\ell(u)|\;\Big)\cdot \max_{x'\in \partial^+\Lambda_\ell(u)}|G(x',y;E)|.
$$

Throughout this paper, we use a standard notation  $[[a, b]] := [a, b] \cap \mathbb{Z}$ .

## 3. Green functions in a finite volume

**Definition 3.1.** A box  $\Lambda_L(u)$  is called  $(E, m)$ -non-singular  $((E, m)$ -NS) if

$$
\sum_{(y,y')\in \partial \Lambda_L(u)}|G(u,y;E)|\leq e^{-\gamma(m,L)L},
$$

where

<span id="page-2-0"></span>
$$
\gamma(m, L) = m \left( 1 + L^{-1/4} \right). \tag{3.1}
$$

Otherwise, it is called  $(E, m)$ -singular  $((E, m)$ -S).

**Remark.** The function  $\gamma(m, L)$  defined in Eqn [\(3.1\)](#page-2-0) will be often used below. It allows us to avoid a "massive rescaling of the mass", which would, otherwise, inevitably make notations and assertions more cumbersome. Obviously,  $\gamma(m, L) > m$ , and for large values of L,  $\gamma(m, L)/m \approx 1$ .

It is convenient to introduce the following property (or assertion), the validity of which depends upon parameters  $u \in \mathbb{Z}^d, L \in \mathbb{N}^*, m > 0, p > 0$ , as well as upon the probability distribution of the random potential  $\{V(x; \omega), x \in \mathbb{Z}^d\}$ :

$$
(\text{SS}.L, m) \qquad \mathbb{P}\left\{\Lambda_L(u) \text{ is } (E, m)\text{-S}\right\} \le L^{-p}.\tag{3.2}
$$

In order to distinguish between single- and multi-particle models, we will often write  $(SS.L, k, N)$  where  $N \geq 1$  is the number of particles.

**Definition 3.2.** A lattice subset  $\Lambda \subset \mathbb{Z}^d$  of diameter L is called E-non-resonant (E-NR) if  $||G_{\Lambda}(E)|| \le e^{-L^{\beta}}, \ \beta \in (0,1)$ , and E-resonant (E-R), otherwise. It is called  $(E, \ell)$ -completely non-resonant  $((E, \ell)$ -CNR) if it is E-NR and does not contain any E-R cube  $\Lambda'$  of diameter  $\geq 3\ell$ .

**Lemma 3.3.** If the marginal CDF  $F(s) = F_V(s)$  is Hölder-continuous, then

$$
\exists L^* > 0, \beta' \in (0,1): \ \forall L \ge L^* \ \mathbb{P} \left\{ \Lambda_L(u) \ \text{is not} \ (E, L^{2/3}) \text{-} CNR \right\} \le e^{-L^{\beta'}}.
$$

Consider a pair of boxes  $\Lambda_{\ell}(u) \subset \Lambda_L(x)$ . If  $\Lambda_{\ell}(u)$  is  $(E, m)$ -NS, then GRI implies that function  $f(x) = f_y(x) := G(x, y; E)$  satisfies

$$
|f(u)| \le \widetilde{q} \cdot \max_{v: \, ||v-u|| = \ell} |f(v)|,\tag{3.3}
$$

with

$$
\widetilde{q} = \widetilde{q}(d, \ell; E) = 2d\ell^{d-1} e^{-\gamma(m, \ell)\ell}.
$$
\n(3.4)

Now suppose that  $\Lambda_{\ell}(u)$  is  $(E, m)$ -NS, but  $\Lambda_{L}(x)$  is E-CNR and, in addition, for some  $A > 0$  and for any w with  $dist(w, \Lambda_{A\ell}(u)) = \ell$  the box  $\Lambda_{\ell}(w)$  is  $(E, m)$ -NS. Then, by GRI applied twice,

$$
|G(u, y)| \le 2d(6\ell)^{d-1}e^{L^{\beta}} \max_{w: ||w-u|| = (A+1)\ell} |G(w, y; E)|
$$
  
\n
$$
\le 2d(6\ell)^{d-1}e^{L^{\beta}} 2d(2\ell)^{d-1}e^{-\gamma(m,\ell)\ell} \max_{v: ||v-u|| \in [A\ell, (A+2)\ell]} |G(v, y; E)|.
$$

Therefore, with

$$
q(d, \ell, E) := 4d^2 (12\ell^2)^{d-1} e^{L^{\beta}} e^{-\gamma(m, \ell)\ell} > \tilde{q}(d, \ell, E),
$$
\n(3.5)

we obtain

<span id="page-2-2"></span>
$$
|G(u,y)| \le \widetilde{q}(d,\ell,E) \max_{v:||v-u|| \in [A\ell,(A+2)\ell]} |G(v,y;E)|. \tag{3.6}
$$

With these observations in mind, we study in the next section decay properties of functions  $f : \Lambda_L(x) \to \mathbb{C}$  obeying, for any point  $u \in \Lambda_L(x)$ , one of the Eqns [\(3.3\)](#page-2-1), [\(3.6\)](#page-2-2). Observe that we do not require that q and  $\tilde{q}$  be smaller than 1, but, of course, the above bounds are useful only for  $q, \tilde{q} < 1$ . Finally, note that, since  $q < \tilde{q}$ , it will be convenient to replace  $\tilde{q}$  by q in the bound (3.2). With this modification, we see that the only difference between bounds [\(3.3\)](#page-2-1) and [\(3.6\)](#page-2-2) is in the distance  $\|v - u\|$  figuring in these inequalities.

# 4. Radial descent: A few simple lemmas

**Definition 4.1.** Consider a cube  $\Lambda = \Lambda_L(u) \subset \mathbb{Z}^d$  decomposed into complementary subsets  $\mathcal{S}, \mathcal{R} = \Lambda \setminus \mathcal{S},$  and a function  $f : \Lambda \to \mathbb{C}$ . Let  $\ell \in (1, L - 1)$  be an integer and  $q > 0$ . Function f will be called  $(\ell, q, \mathcal{S})$ -subharmonic if for any  $x \notin \mathcal{S}$  with  $dist(x, \partial \Lambda) \geq \ell$ , we have

$$
|f(x)| \le q \max_{y:\,||y-x|| \le \ell} |f(y)| \tag{4.1}
$$

while for any  $x \in \mathcal{S}$  with  $dist(x, \partial \Lambda) \geq \ell^{y: ||y-x|| \leq \ell}$ 

<span id="page-3-2"></span>
$$
|f(x)| \le q \max_{y:\,||x-y|| \le r(x) + \ell} |f(y)|,\tag{4.2}
$$

where

$$
r(x) = \min\{r \in \mathbb{N} : \Lambda_{r+\ell}(x) \setminus \Lambda_{r-\ell}(x) \subset \mathcal{R}\},\tag{4.3}
$$

provided that the set of values  $r$  in the RHS is non-empty. In all other cases, no specific upper bound on  $|f(x)|$  is assumed.

In other words, for a point x in the "singular" subset  $S \subset \Lambda_L(u)$ ,  $r(x)$  is the minimal radius of the "sphere"  $C_r := \{ \|y - x\| = r \}$  centered at x and such that every ball  $\Lambda_{\ell}(y)$  with  $y \in C_r$  is a subset of the "regular" subset  $\mathcal{R} \subset \Lambda_L(u)$ . Clearly, the difference between the upper bounds [\(4.1\)](#page-3-1) and [\(4.2\)](#page-3-2) resides in the shape of the "reference" set used for the calculation of the maximum in the RHS.

Note that, taking into account inequality [\(3.6\)](#page-2-2), one could replace in the RHS of [\(4.2\)](#page-3-2) the ball  $\{y : ||y - x|| \le r(x) + \ell\}$  by a properly chosen annulus; however, this would not improve the final result on subharmonic functions, while making notations more cumbersome.

We will use the notation  $\mathcal{M}(f,\Lambda) := \max_{x \in \Lambda} |f(x)|$ . Our goal is to obtain an upper bound on the value  $f(x)$  exponential in  $L/\ell$ .

<span id="page-3-0"></span>**Lemma 4.2.** Let f be an  $(\ell, q, \mathcal{S})$ -subharmonic function on  $\Lambda = \Lambda_L(x)$ . Suppose that S can be covered by  $K \geq 0$  cubes  $S_1, \ldots, S_K$  with  $\sum_i \text{diam}(S_i) \leq \mathcal{W}(S)$ . Then

$$
|f(x)| \le q^{\left[(L - \mathcal{W}(S))/\ell\right]} \mathcal{M}(f, \Lambda). \tag{4.4}
$$

The proof of Lemma [4.2](#page-3-0) is given in Appendix C.

4.1. From resolvents to subharmonic and monotone functions. Lemma [4.2](#page-3-0) will be applied in a situation where for for any  $E \in I$ , a cube  $\Lambda_L(u)$  does not contain any collection of K (or more)  $(E, m)$ -S cubes  $\Lambda_{\ell}(v^{(i)}, j = 1, ..., K$  which are pairwise  $a\ell$ -distant, with  $a \geq 0$ :

$$
\forall i \neq j \ \operatorname{dist}(\Lambda_{\ell}(v^{(i)}, \Lambda_{\ell}(v^{(j)}) > 2a\ell)
$$

In applications to the single-particle MSA with an IID potential  $V$  it suffices to take  $a = 0$ , while in the multi-particle MSA, or in the case where the potential V has nontrivial but decaying correlations, one may need to use  $a > 0$  or even replace the RHS by  $a\ell^{\delta}$  for some  $1 < \delta < \alpha$ .

<span id="page-4-2"></span>**Lemma 4.3.** Consider a cube  $\Lambda_L(u)$ ,  $L = [\ell^\alpha]$ , and suppose that the random operator  $H_{\Lambda}(\omega)$  fulfills the following conditions:

- (A)  $\Lambda_L(u)$  contains no family of  $K+1$  pairwise al-distant  $(E, m)$ -S cubes of radius  $\ell$ , for some  $a > 0$ ;
- (B)  $\Lambda_L(u)$  is E-CNR;

Then for any  $w \in \partial \Lambda$ , the function

$$
f: \quad \Lambda_L(u) \rightarrow \mathbb{R}
$$
  

$$
x \rightarrow |G_{\Lambda_L(u)}(x, w; E)|
$$
 (4.5)

is  $(\ell, q, S)$ -subharmonic with  $q \leq c(d)(a\ell)^{d-1}e^{-m\ell}$  and the set S contained in a union of  $K' \leq K$  cubes of radius al.

*Proof.* Fix some  $E \in I$  and consider some maximal family of  $(E, m)$ -S cubes  $\Lambda_{\ell}(v^{(i)})$ ,  $i = 1, \ldots, K' \leq K$ ; such a family may not be unique, but the maximal cardinality  $K = K(I)$  is well-defined. By construction, any cube  $\Lambda_{\ell}(y)$  disjoint with the union of cubes  $\Lambda_{a\ell}(v^{(i)})$  is  $(E, m)$ -NS.

Pick a point  $x \in \mathcal{S}$  and consider the minimal cube  $\Lambda_{R(x)}(x)$  such that all cubes  $\Lambda_{\ell}(y)$  with  $y \in \Lambda_{R(x)}(x)$  are  $(E, m)$ -NS. Assume that the cube  $\Lambda_L(u)$  is E-CNR; then  $\Lambda_{R(x)}(x)$  is E-NR, and set  $r(x) = R(x) + \ell$ .

Applying the GRI twice and using the E-NR property of  $\Lambda_{R(x)}(x)$ , we obtain for any w with  $||w - x|| > R(x) + \ell + 1$ :

$$
|G_{\Lambda_L(u)}(x, w; E)|
$$
  
\n
$$
\leq d(2R(x) + 1)^{d-1} e^{(R(x))^{\beta}} \max_{\|y - x\| = R(x) \, |v - y\| = \ell + 1} |G_{\Lambda_L(u)}(v, w; E)|
$$
  
\n
$$
\leq C(d)(a\ell)^{d-1} e^{(a\ell)^{\beta}} e^{-\gamma(m,\ell)\ell} \max_{v : \|v - x\| \leq r(x)} |G_{\Lambda_L(u)}(v, x; E)|.
$$

Therefore, the function f given by  $(4.5)$  is  $(\ell, q, \mathcal{S})$ -subharmonic with

$$
q = C(d)(a\ell)^{d-1} e^{(a\ell)^{\beta}} e^{-\gamma(m,\ell)\ell}
$$
  
\n
$$
S = \bigcup_{i} \Lambda_{a\ell}(v^{(i)}).
$$
\n(4.6)

 $\Box$ 

### 5. Inductive bounds of Green functions

Here we summarize the results of [\[13\]](#page-12-2) presented in a slightly modified form, making use of the notion of  $(\ell, q)$ -subharmonicity. Formally, we will need these results in Section [6,](#page-6-0) in the course of induction on the number of particles N.

<span id="page-4-3"></span>**Lemma 5.1.** Suppose that a box  $\Lambda_L(u)$  is E-NR and does not contain any  $(E, m)$ -S boxe of size  $\ell$ . Then, with q defined in Eqn  $(4.6)$ ,

$$
\max_{y \in \partial^{-1} L(u)} |G_{\Lambda}(u, y; E)| \le q^{\lfloor L/\ell \rfloor} ||G_{\Lambda}(E)||.
$$

In particular, if  $\ell^{-1}$  and  $\ell/L$  are sufficiently small, so that

$$
\ell^{-1/4} - 6\ell L^{-1} \ge L^{-1/4},
$$

then

$$
\sum_{y \in \partial \Lambda_L(u)} |G_\Lambda(u,y;E)| \leq e^{-\gamma(m,L)L} ||G_\Lambda(E)||.
$$

*Proof.* Apply Lemma [4.3.](#page-4-2)

<span id="page-5-0"></span>**Lemma 5.2.** Suppose that a box  $\Lambda_L(u)$  is E-CNR and does not contain any pair of non-overlapping  $(E, m)$ -S boxes of size  $\ell$ . Then

$$
\sum_{y \in \partial \Lambda_L(u)} |G_{\Lambda_L}(u, y)| \le e^{-\gamma(m, L)L}.
$$

*Proof.* If  $\Lambda_L(u)$  contains no  $(E, m)$ -S box  $\Lambda_{\ell}(x)$ , the assertion follows from Lemma [5.1.](#page-4-3) Suppose there exists a box  $\Lambda_{\ell}(x) \subset \Lambda_L(u)$  which is  $(E, m)$ -S. Since all boxes  $\Lambda_{\ell}(w)$ with  $\|w - x\| > 2\ell$  are disjoint with  $\Lambda_{\ell}(x)$ , none of them is  $(E, m)$ -S, by hypotheses of the lemma. Therefore, Lemma [4.2](#page-3-0) applies, giving the required upper bound.  $\square$ 

<span id="page-5-3"></span>**Lemma 5.3.** Suppose that the finite-volume approximations  $H_{\Lambda}(\omega)$ ,  $\Lambda \subset \mathbb{Z}^d$ ,  $|\Lambda| < \infty$ , of random LSO  $H(\omega)$  with IID random potential satisfy the following hypotheses:

- (W)  $\mathbb{P}\left\{\text{dist}\left[E,\Sigma\left(H_{\Lambda}(\omega)\right)\right]\leq e^{-|\Lambda|^{-\beta}}\right\}\leq e^{-|\Lambda|^{-\beta'}}, \text{ for some } \beta,\beta'>0;$
- (S. $\ell$ )  $\mathbb{P} \{\Lambda_{\ell}(v) \text{ is } (E, m)$ -S}  $\leq \ell^{-p}$ .

Set  $L = [\ell^{3/2}]$ . If  $p > 6d$ , then  $H_{\Lambda_L}$  satisfies (SS.L, m, 1) (cf. [\(3.2\)](#page-2-3)).

*Proof.* Consider a box  $\Lambda_L(u)$ . By Lemma [5.2,](#page-5-0) it must be  $(E, m)$ -NS, unless one of the following events occurs:

- $\Lambda_L(u)$  is not E-CNR
- $\Lambda_L(u)$  contains at least two non-overlapping  $(E, m_k)$ -S boxes  $\Lambda_{\ell}(x), \Lambda_{\ell}(y)$ .

The probability of the former event is bounded by  $(W)$ , while by virtue of  $(S.\ell)$ , the probability of the latter event is bounded by

$$
\frac{1}{2}L^{2d} \ell^{-2p} \le \frac{1}{2} L^{-p\left(\frac{2}{3/2} - \frac{2d}{p}\right)} \le L^{-p}.
$$

<span id="page-5-1"></span>Corollary 5.4.  $(SS.L_k, m, 1)$  implies  $(SS.L_{k+1}, m, 1)$  (provided that Wegner-type bound  $(\mathbf{W})$  holds true).

<span id="page-5-2"></span>**Theorem 5.5.** Under the assumption [\(2.1\)](#page-1-0), for any  $m > 0$ ,  $p > 0$  and sufficiently large  $|g| \geq g^*(m, p)$ ,  $(\mathbf{SS}.L_k, m, 1)$  holds true for all  $k \geq 0$ .

*Proof.* It suffices to establish  $(SS.L_0, m, 1)$ . For any fixed  $L_0$  and arbitrarily large  $\eta > 0$ , we have

$$
\mathbb{P}\left\{\exists\,x\in\Lambda_{L_0}(u):\ |gV(x;\omega)-E|\le 2\eta\right\}\le \sum_{x\in\Lambda_{L_0}(u)}\mathbb{P}\left\{|gV(x;\omega)-E|\le 2\eta\right\}\underset{|g|\to\infty}{\longrightarrow}0,
$$

provided that the marginal probability distribution of the potential is continuous. So, for any  $p > 0$  and g large enough, the above probability is bounded by  $L_0^{-p}$ . If  $\eta > ||\Delta||$ , then, by min-max principle,  $dist(E, Spec(H_{\Lambda_{L_0}(u)})) \ge \eta > 0$ , and by Combes–Thomas estimate,

$$
|G_{\Lambda_{L_0}(u)}(x,y)| \leq e^{-M(\eta)||x-y||}, \ M(\eta) \underset{n \to +\infty}{\longrightarrow} +\infty.
$$

This leads to the assertion  $(\mathbf{SS}.L_0, m, 1)$  and, by induction using Corollary [5.4,](#page-5-1) to the assertion of the theorem.  $\Box$ 

Recall Kubo formula for the static conductivity  $\sigma(E)$  at energy E:

$$
\sigma(E) = \lim_{\epsilon \downarrow 0} \epsilon^2 \sum_{x \in \mathbb{Z}^d} ||x||^2 \mathbb{E} [ |G(0, x; E + i\epsilon)|^2 ].
$$

By taking limit  $k \to \infty$ , i.e.,  $L_k \to \infty$ , Theorem [5.5](#page-5-2) implies immediately

**Theorem 5.6.** Under the assumption  $(2.1)$  for an IID random potential, the conductivity in the single-particle Anderson model is zero.

# 6. Simplified multi-particle MSA

<span id="page-6-0"></span>In this section, we study decay properties of Green functions for an N-particle Hamiltonian  $H^{(N)}(\omega)$  defined in Eqn [\(2.2\)](#page-1-1). We stress that estimates given below are far from optimal; they only show that for any given number of particles  $N \geq 1$  and any  $m > 0$ , there exists a threshold  $g_N = g_N(m) > 0$  for the disorder parameter g such that if  $|g| \geq g_N$ , then Green functions in the N-particle model (with a short-range interaction) decay exponentially with rate  $m$ . t is also important to realize that using the MSA, in its traditional form, for an  $N$ -particle system with large  $N$  inevitably requires using large values of  $g_N$ . Indeed, this phenomenon occurs even in the singleparticle MSA in high dimension  $d \gg 1$ : the respective threshold  $g_1 = g_1(m, d) \rightarrow \infty$ as  $d \to \infty$ . A direct inspection of the conventional MSA show that, typically,  $V(\cdot; \omega)$ ,  $g_1(m, d) = O(d).$ 

Given a number  $m > 0$  and an integer  $L_0 > 0$ , we will define a decreasing sequence of decay exponents  $m^{(n)}$ ,  $n \geq 1$  as follows:

$$
m^{(1)} = m; \; m^{(N)} = m^{(N-1)} - L_0^{-1/8}, \; N > 1.
$$

It is clear that in order to have  $m^{(N)} > 0$ , we have to assume that  $m = m^{(1)}$  is sufficiently large (depending on N). In turn, this requires the thresholds  $g_1, \ldots, g_{N-1}$ to be large enough, as explained above.

Compared to the single-particle MSA scheme presented in previous sections, we have to replace the property  $(SS.L, I)$  by a different one,  $(MS.L, I, N)$  given below, and to include in  $(MS.L, I, N)$  the requirement that the decay of Green functions holds for all  $n' < N$ :

 $(MS.L_k, I, N)$ : The property  $(SS.L_k, I, n)$  holds for  $1 \leq n \leq N-1$ ,  $\int$ 

$$
\mathbb{P}\left\{\Lambda_L^{(n)}(\mathbf{u}) \text{ is } (E, m^{(n)})\text{-S}\right\} \le L^{-p(n,g)},
$$

where  $p(n, g) \to \infty$  as  $|g| \to \infty$ ,  $n = 1, \ldots, N - 1$ .

**Remark.** For any  $k = 0$  and any  $n > 1$ , the validity of the above statement is proved exactly in the same way as for  $n = 1$ . Then for  $k > 0$  it is reproduced inductively. Denoting  $P(N-1,g) = \min_{1 \leq n \leq N-1} p(n,g)$ , we see that, under the hypothesis  $(MS.L_k, I, N)$ , we have  $P(N-1, g) \to \infty$  as  $|g| \to \infty$ .

For the sake of notational simplicity, we consider in Lemma [6.1](#page-6-1) below only partitions  $[[1, N]] = \mathcal{J} \coprod \mathcal{J}^c$  of the interval  $[[1, N]]$  into two (non-empty) consecutive sub-intervals,  $\mathcal{J} = [[1, n']]$ ,  $\mathcal{J}^c = [[n' + 1, N]]$ . In other words, we consider a union of two subsystems with particles  $1, \ldots, n'$  and  $n' + 1, \ldots, N$ , respectively.

We introduce the "diagonal" subset of  $\mathbb{Z}^{Nd}$ 

$$
\mathbb{D} := \{ x = (x_1, \dots, x_1), \, x_1 \in \mathbb{Z}^d \}.
$$

<span id="page-6-1"></span>**Lemma 6.1.** Let  $[[1, N]] = \mathcal{J} \cup \mathcal{J}^c$ ,  $\mathcal{J} = [[1, n']]$ ,  $\mathcal{J}^c = [[n' + 1, N]]$  and consider a cube  $\Lambda_L^{(N)}$  $L^{(N)}(u) = \Lambda_L^{(n')}$  $\Lambda_L^{(n')}(u') \times \Lambda_L^{(n'')}$  $\mu_L^{(n')} (u'')$ , with  $u' = (u_1, \ldots, u_{n'})$ ,  $u'' = (u_{n'+1}, \ldots, u_N)$ . Suppose that

(1) the interaction between these two subsystems vanishes:

<span id="page-6-2"></span>
$$
\forall j \in \mathcal{J}, \forall i \in \mathcal{J}^c \ \|u_j - u_i\| > 2(L - 1) + r_0,\tag{6.1}
$$

so that

$$
\forall v_j \in \Lambda_L^{(1)}(u_j), \forall v_i \in \Lambda_L^{(1)}(u_i) \ \ U_2(v_j, v_i) = 0. \tag{6.2}
$$

(2)  $\Lambda_L^{(N)}(\mathbf{u})$  is E-NR;

(3)  $(MS.L_k, I, N)$  holds true;

(4) for any eigenvalue  $\mu$  of  $H_{\Lambda_L^{(n')} (u'')}$ , the box  $\Lambda_L^{(n')}$  $\binom{n}{L}(u')$  is  $(E - \mu, m^{(N-1)})$ -NS;

L

(5) for any eigenvalue  $\lambda$  of  $H_{\Lambda_L^{(n')} (u')}$ , the box  $\Lambda_L^{(n'')}$  $\binom{n^{(n)}}{L}(u'')$  is  $(E - \lambda, m^{(N-1)})$ -NS. Then  $\Lambda_L^{(N)}$  $L^{(N)}(\mathbf{u})$  is  $(E, m^{(N)})$ -NS.

The proof of Lemma [6.1](#page-6-1) is given in Section [7;](#page-8-0) it is fairly straightforward.

**Lemma 6.2.** Under the assumption  $(1)$  and  $(3)$  of Lemma [6.1,](#page-6-1) the assumptions  $(4)$ and (5) hold true with probability  $\geq 1 - 2(2L+1)^{(N-1)d}L^{-p(N-1,g)}$ .

*Proof.* The samples of the potential in the sets  $\Pi \Lambda_L^{(n')}$  $\mathop{\mathrm{L}}\nolimits^{(n')} (u')$  and in  $\Pi \Lambda_L^{(n'')}$  $L^{(n'')}(u'')$  (which are disjoint, owing to [\(6.1\)](#page-6-2)), are independent. Therefore, using the conditioning on the potential in  $\Pi \Lambda_L^{(n')}$  $L^{(n')}(u')$  and the one obtains

$$
\mathbb{P}\left\{\exists \, \lambda \in \Sigma(H_{\Lambda_L^{(n')} (u')}) : \Lambda_L^{(n'')}(u'') \text{ is } (E-\lambda, m^{(N-1)})\text{-S }\right\} \leq |\Lambda_L^{(n')}(u')| \, L^{-p(n,g)},
$$

where  $p(n'', g) \geq p(N - 1, g)$ . Similarly,

$$
\mathbb{P}\left\{\exists \,\mu \in \Sigma(H_{\Lambda_L^{(n'')}(u'')}) : \Lambda_L^{(n')}(u') \text{ is } (E - \lambda, m^{(N-1)})) \text{-S } \right\} \leq |\Lambda_L^{(n'')}(u'')| \, L^{-p(N-1,g)}.
$$

We will call N-particle boxes  $\Lambda_L^{(N)}(u)$  admitting a decomposition described in Lemma [6.1](#page-6-1) decomposable. It is easy to see that an N-particle box  $\Lambda_L^{(N)}(u)$  is non-decomposable if and only if the union of cubes

$$
\bigcup_{j=1}^{N} \Lambda_{L+r_0/2}^{(1)}(u_j) \subset \mathbb{R}^{Nd}
$$

is connected (for this argument, we identify  $\Lambda_{\ell}^{(1)}(u_j)$  with a cube in  $\mathbb{R}^d$  of side  $2(\ell-1)$ with center  $u_i$ , by a slight abuse of notations). In turn, such a union is connected, then

$$
\forall j = 2, ..., N \ \|u_j - u_1\| \leq 2(L - 1) + r_0,
$$

so that

dist
$$
(u, \mathbb{D}) \le ||u - (u_1, \dots, u_1)|| \le 2N(L-1) + Nr_0 =: r_{N,L}.
$$

Clearly, if  $dist(u, \mathbb{D}) > r_{N,L}$ , then  $\Lambda_L^{(N)}(u)$  is decomposable.

<span id="page-7-0"></span>**Lemma 6.3.** Fix an integer  $N > 1$  and suppose that  $(MS.L_k, I, n)$  holds for all  $n < N$ . If an N-particle box  $\Lambda^{(N)}(u)$  is decomposable, then

$$
\mathbb{P}\left\{\Lambda_{L_k}^{(N)}(u) \text{ is } (E,m)-S\right\} \le L_k^{-P(N-1,g)} + e^{-L_k^{\beta}}.
$$

Therefore, for any  $P > 0$  and for all |g|,  $L_0$  large enough, we have

$$
\mathbb{P}\left\{\Lambda_{L_k}^{(N)}(u) \text{ is } (E,m)-\mathcal{S}\right\} \le L_k^{-P}
$$

.

*Proof.* Since  $\Lambda_{L_k}^{(N)}(\mathbf{u})$  is decomposable, operator  $H_{\Lambda_k^{(N)}}^{(N)}$  $\Lambda_{L}^{(N)}(u)$  admits representation (7.1)  $L_k$ for some  $n', n'' < N$ . By Lemma [6.1,](#page-6-1) either the box  $\Lambda_{L_k}^{(N)}(\mathbf{u})$  is E-R, which occurs with probability  $\leq e^{-L_k^{\beta}}$ , or one of the operators  $H_{\lambda(n)}^{(n')}$  $\frac{\Lambda^{(n')}_{L_k}}{\Lambda^{(n')}_{L_k}(u')},\ \frac{H^{(n'')}_{\Lambda^{(n'')}_{L_k}}}{\Lambda^{(n'')}_{L_k}}$  $\Lambda_{L_k}^{(n')}$ <sub>(u'')</sub> is  $(E, m_k)$ -S; the latter event has probability  $\leq L_k^{-P(N-1,g)}$  $\mathbb{R}^{-P(N-1,g)}, \text{ by } (\mathbf{MS}.L_k, I, N-1).$   $\Box$   $\Box$ 

Now we are prepared to give a **half page proof** of the main result of the fixed-energy MSA. For notational simplicity, below we write m instead of  $m^{(N)}$ .

Lemma 6.4. For |g| large enough,  $(MS.L_k, I, N)$  implies  $(MS.L_{k+1}, I, N)$ .

*Proof.* By Wegner bound,  $\mathbb{P} \left\{ \Lambda_{L_{h}}^{(N)} \right\}$  $\begin{bmatrix} (N) \\ L_{k+1} \end{bmatrix}$  is not  $E\text{-CNR}$   $\left\{ \leq e^{-L_{k+1}^{\beta}}$ . Further, set

$$
\mathbf{S} = \left\{ \exists \Lambda_{L_k}(x) \subset \Lambda_{L_{k+1}}(u) \text{ which is } (E, m)\text{-S and } \text{dist}(\Lambda_{L_k}(x), \mathbb{D}) \le r_{N,L} \right\}.
$$

By Lemma [6.3,](#page-7-0) and for |g| large enough,  $\mathbb{P}\{\mathbf{S}\}\leq \frac{1}{2}L_{k+1}^{-p(N,g)}$ . Next, set

$$
\mathbf{B} = \Big\{ \exists \Lambda_{L_k}(x), \Lambda_{L_k}(y) \subset \Lambda_{L_{k+1}}(u) \text{ which are } (E, m)\text{-S and such that}
$$
  

$$
||x - y|| > 9(L_k + r_{N, L_k}), \text{ dist}(\Lambda_{L_k}(x), \mathbb{D}) \le r_{N, L}, \text{ dist}(\Lambda_{L_k}(y), \mathbb{D}) \le r_{N, L} \Big\}.
$$

Fix centers x, y. By Lemma [8.1,](#page-9-0) potential samples in boxes  $\Lambda_{L_k}(x)$ ,  $\Lambda_{L_k}(y)$  close to the "diagonal"  $\mathbb{D}$  are *independent*, so that

$$
\mathbb{P}\left\{\mathbf{B}\right\} \le \frac{1}{2} L_{k+1}^{2d} \left(\max_{v \in \Lambda_{L_{k+1}}(u)} \mathbb{P}\left\{\Lambda_{L_k}(v) \text{ is } (E, m) \text{-S}\right\}\right)^2 < \frac{1}{2} L_{k+1}^{-p(N, g)}.
$$

If neither of events **S**, **B** occurs, then, by Lemma [5.3,](#page-5-3)  $\Lambda_{L_{k+1}}(\mathbf{u})$  is  $(E, m_{k+1})$ -NS. Therefore, with  $p(N, g) \to \infty$  as  $|g| \to \infty$ , we have

$$
\mathbb{P}\left\{\Lambda_{L_{k+1}}^{(N)}(\mathbf{u}) \text{ is } (E,m)\text{-S}\right\} \le \frac{1}{2} L_{k+1}^{-p(N,g)} + \frac{1}{2} L_{k+1}^{-p(N,g)} = L_{k+1}^{-p(N,g)}.
$$

**Theorem 6.5.** Under the assumption  $(2.1)$  for an IID potential, the conductivity in the N-particle Anderson tight binding model is zero.

### 7. Appendix A

<span id="page-8-0"></span>Proof of Lemma [6.1](#page-6-1)

Let  $\{\varphi_a, \lambda_a\}$  be normalized eigenfunctions (EFs) and the respective eigenvalues (EVs) of  $H^{(n')}_{\Lambda^{(n')}(\nu')}$ , and  $\{\psi_b, \mu_b\}$  be normalized EFs and the EVs of  $H^{(n'')}_{\Lambda^{(n')}}$  $\Lambda^{(n')}(\nu'')$ . Due to absence of interaction between configurations  $u'$ ,  $u''$ , we have

$$
H_{\Lambda^{(N)}(\mathbf{u})}^{(N)} = H_{\Lambda^{(n')}(\mathbf{u}')}^{(n')} \otimes \mathbf{1} + \mathbf{1} \otimes H_{\Lambda^{(n'')}(\mathbf{u}'')}^{(n'')}.
$$
(7.1)

Therefore, the EFs  $\Psi_{a,b}$  of operator  $H_{\Lambda(N)}^{(N)}$  $\Lambda^{(N)}(\mathbf{u})$  have the form  $\Psi_{a,b} = \varphi_a \otimes \psi_b$ , and the respective EVs are given by  $E_{a,b} = \lambda_a + \mu_b$ , so that  $E - E_{a,b} = (E - \lambda_a) - \mu_b$ .

Let  $\mathbf{v} \in \partial \mathbf{\Lambda}_L^{(N)}$  $L^{(N)}(u)$ . Then either  $||u' - v'|| = L$ , or  $||u'' - v''|| = L$ . Without loss of generality, assume that  $||u' - v'|| = L$ . Since  $||\varphi_a|| = 1$  and  $n' < N$ , we have

$$
|\mathbf{G}(\mathbf{u}, \mathbf{v}; E)| \leq \sum_{a} |\varphi_a(u')\varphi_a(v')| \left| \sum_{b} \frac{\psi_b(u'')\psi_b(v'')}{(E - \lambda_a) - \mu_b} \right|
$$
  
 
$$
\leq \left| \Lambda_L^{(n')} (u') \right| \max_{\lambda_a} |G_{\Lambda_L^{(n'')} (u'')} (u'', v''; E - \lambda_a)| \leq L^{N-1} e^{-L^{\beta}} e^{-mL}.
$$

# 8. Appendix B

<span id="page-9-0"></span>**Lemma 8.1.** Consider two points  $x, y \in \mathbb{Z}^{Nd}$  and an integer  $L > 0$ . Suppose that  $||x - y|| > AL$  with  $A = 4B + 6$ ,  $B > 0$ , and

<span id="page-9-1"></span>
$$
dist(\Lambda_L^{(N)}(x), \mathbb{D}_0) < BL, \quad dist(\Lambda_L^{(N)}(y), \mathbb{D}_0) < BL. \tag{8.1}
$$

Then for all  $j = 1, ..., N$ , we have  $\Pi_j \Lambda_L^{(N)}$  $L^{(N)}(x) \cap \Pi_j \Lambda_L^{(N)}$  $L^{(N)}(y) = \emptyset.$

*Proof.* (See Fig. 4 illustrating the case  $N = 2$ ,  $d = 1$ .) Eqn [\(8.1\)](#page-9-1) implies that there exist some points  $u = (u_1, \ldots, u_1) \in \mathbb{D}, v = (v_1, \ldots, v_1) \in \mathbb{D}$  such that  $||x - u|| \leq L + BL$ ,  $||y - v|| \leq L + BL$ . Then we have, by triangle inequality,

$$
||x - y|| \le ||x - u|| + ||u - v|| + ||v - y|| \le (2B + 2)L + ||u - v||,
$$

so that

<span id="page-9-2"></span>
$$
||u - v|| \ge ||x - y|| - (2B + 2)L > 2(B + 2)L,
$$
\n(8.2)

and also

$$
\Lambda_L(x) \subset \Lambda_{(B+2)L}(u), \ \Lambda_L(y) \subset \Lambda_{(B+2)L}(v).
$$

Similar inclusions hold true for the projections:

 $\Pi_j\Lambda_L^{(N)}$  $\mathcal{L}_{L}^{(N)}(x) \subset \Pi_j \Lambda_{(B+2)L}(u), \; \Pi_j \Lambda_{L}^{(N)}$  $L^{(N)}(y) \subset \Pi_j \Lambda_{(B+2)L}(v).$  However, Eqn [\(8.2\)](#page-9-2) implies that cubes  $\Lambda_{(B+2)L}(u)$  and  $\Lambda_{(B+2)L}(v)$  are disjoint, and so are, therefore, the projections  $\Pi_j \Lambda_L^{(N)}$  $L^{(N)}(x)$  and  $\Pi_j \Lambda_L^{(N)}$  $L^{(N)}(y).$ 

# 9. Appendix C. Decay of subharmonic functions

9.1. From subharmonic to monotone functions. To emphasize the essentially one-dimensional nature of the argument used in the proof of Lemma [4.2](#page-3-0) and to make notations and calculations less cumbersome, we introduce the 'radial', one-dimensional counterpart of the notion of an  $(\ell, q, \mathcal{S})$ -subharmonic function.

**Definition 9.1.** Consider an interval  $I = [[0, L]]$  decomposed into complementary subsets  $S, \mathcal{R} = I \setminus S$ , and let a number  $q > 0$  and an integer  $\ell \in [1, L/2)$  be given. A non-negative function  $F: I \to \mathbb{R}_+$  will be called  $(\ell, q, \mathcal{S})$ -monotone, if for any  $r \in \mathcal{R} \cap [[0, L - \ell]]$  one has

$$
F(r) \le q\mathcal{M}(F, [[0, r+\ell]]),
$$

while for any  $r \in \mathcal{S} \cap [[0, L - \ell]]$ 

$$
F(r) \le q\mathcal{M}(F, [[0, R(r) + \ell]]),
$$

where  $R(r)$  is defined by

$$
R(r) = \min\{r' \in [[r+1, L]] : [[r' - \ell, r' + \ell]] \subset \mathcal{R}\},\tag{9.1}
$$

in the case where the set of values r' figuring in the RHS is non-empty. In all other cases, no specific upper bound on  $F(r)$  is assumed.

<span id="page-10-0"></span>**Lemma 9.2.** Let  $F : [[0, L]] \to \mathbb{R}_+$  be an  $(\ell, q, \mathcal{S})$ -monotone function. Suppose that S consists of  $K \geq 0$  disjoint intervals of total length  $W = |\mathcal{S}|$ . Then (A)

$$
F(0) \le q^{[(L-W)/\ell]} \mathcal{M}(F, [[0, L]]) \tag{9.2}
$$

(with  $\lceil \cdot \rceil$  in the exponent standing for the integer part); (B) more generally, for any  $0 \le r < L - W - \ell$ ,

$$
\mathcal{M}(F, [[0, r]]) \le q^{[(L-r-W)/\ell]} \mathcal{M}(F, [[0, L]]). \tag{9.3}
$$

*Proof.* First of all, observe that one can replace the interval  $I = [[0, L]]$  by

$$
I' = [[0, \ell + \max\{r \in I : [[r - \ell, r + \ell]] \subset \mathcal{R}]]],
$$

setting also  $S' = S \cap I'$ ,  $\mathcal{R}' = \mathcal{R} \cap I'$ , and restricting F on I'. Indeed, there is no assumption on the function F for the points in  $I \setminus I'$ . Clearly, this gives rise in  $K' \leq K$ and  $|S'| \leq |S|$ . We will assume that this reduction has already been performed.

Next, without loss of generality, assume that S is a union of disjoint intervals  $S_i$ ,  $j = 1, \ldots, K$ , and consider any of these intervals,  $S_j = [[a_j, b_j]]$ . By definition, for any point  $s \in \mathcal{S}_j$  we have

$$
F(s) \le q\mathcal{M}(F, [[0, R(s) + \ell]]),
$$

and  $R(s)$  is constant on the given "singular" interval  $S_i = [[a_i, b_i]]$ ; more precisely,

$$
R : [[a_j - 1, b_j]] \to \{ R(a_j - 1) \}.
$$

It is convenient to set  $R(r) = r$  for all  $r \in \mathcal{R}$ , so that the new function R, defined now on the entire interval  $I$ , is monotone non-decreasing, and strictly increasing at each point  $r \in \mathcal{R}$ . Introduce a mapping  $\mathscr{X} : I \to \mathbb{N}$  by

$$
\mathscr{X}(r) = \text{card}\{[0, r] \cap \mathcal{R}\}
$$

and a new interval  $\tilde{I} = \mathscr{X}(I)$ ; we will consider  $\mathscr{X}$  as a mapping  $\mathscr{X} : I \to \tilde{I}$ . Note that for each singular interval  $S_j = [[a_j, b_j]]$  one has

$$
\mathscr{X} : [[a_j - 1, b_j]] \to \{ \mathscr{X}(a_j - 1) \}.
$$

On the other hand, if  $r' \in \mathcal{R}$  and  $r := \mathcal{X}(r')$ , then  $\mathcal{X}^{-1}(r) = \{r'\}$ . As a result, for any  $r' \in I$ ,  $\mathscr{X}(r'+1) - \mathscr{X}(r') \leq 1$  and, more generally, for any  $s' \leq r'$ ,

<span id="page-11-0"></span>
$$
\mathcal{X}(r') - \mathcal{X}(s') \le r' - s'.\tag{9.4}
$$

Define a function  $\tilde{F}: \tilde{I} \to \mathbb{R}_+$  by

$$
\tilde{F}(r) = \max_{r' \in \mathcal{X}^{-1}(r)} F(r').
$$

Let us show that  $\tilde{F}$  is  $(\ell, q)$ -monotone on  $\tilde{I}$  with the same values of q and  $\ell$  as for the original function F. To this end, consider  $r_0 \in \tilde{I}$  and any point  $r'_0 \in \mathcal{X}^{-1}(r_0)$ . The  $(\ell, q)$ -monotonicity of function F implies that

$$
F(r'_0) \le q\mathcal{M}(F, [[0, R(r'_0) + \ell]]).
$$

Set

$$
r'' = \max_{r \le r_0 + \ell} \, \max\{r' \in \mathcal{X}^{-1}(r)\} \in I.
$$

Then  $r'' \ge r'_0 + \ell$ , since, by Eqn [\(9.4\)](#page-11-0),

$$
r'' - r'_0 \ge \mathcal{X}(r'') - \mathcal{X}(r'_0) = (r_0 + \ell) - r_0 = \ell.
$$

Combining this inequality with  $R(r'_0) \ge r'_0$ , one can write

$$
F(r'_0) \le q\mathcal{M}(F, [[0, R(r'_0) + \ell]])
$$
  
\n
$$
\le q\mathcal{M}(F, [[0, r'_0 + \ell]])
$$
  
\n
$$
\le q\mathcal{M}(F, [[0, r'']]) = q\mathcal{M}(\tilde{F}, [[0, r_0 + \ell]]).
$$

Since this bound is valid for every point  $r'_0 \in \mathcal{X}^{-1}(r_0)$ , we conclude that

$$
\tilde{F}(r_0) \le q \mathcal{M}(\tilde{F}, [[0, r_0 + \ell]]).
$$

For the  $(\ell, q)$ -monotone function  $\tilde{F}: \tilde{I} \to \mathbb{R}_+$ , one easily obtain by induction

$$
\mathcal{M}(\tilde{F},[[0,\mathcal{X}(L)-n\ell]])\leq q^n\mathcal{M}(\tilde{F},[[0,\mathcal{X}(L)]])=q^n\mathcal{M}(F,[[0,L]]),
$$

as long as  $\mathscr{X}(L) - n\ell \geq 0$ . Clearly, the maximal possible value of *n* is given by

$$
n = [\mathcal{X}(L)/\ell] = \left[\frac{L - W}{\ell}\right]
$$

.

This completes the proof of assertion (A).

Assertion (B) follows from (A) applied to the interval  $[[r, L]]$ .

## 9.2. Proof of Lemma [4.2.](#page-3-0)

Introduce the function

$$
F: \quad \Lambda \quad \rightarrow \quad \mathbb{R}_{+} \n x \quad \mapsto \quad \mathcal{M}(|f|, \mathbf{S}_{\|x\|}).
$$

It is not difficult to see that it is  $(\ell, q, \tilde{S})$ -monotone, with

$$
\widetilde{\mathcal{S}} := \{r : \, \mathcal{S}_r \cap \mathcal{S} \neq \varnothing\},\
$$

so that the claim follows from Lemma [9.2.](#page-10-0)
