BACKWARD ERRORS AND LINEARIZATIONS FOR PALINDROMIC MATRIX POLYNOMIALS

Abstract. The paper is devoted to the backward perturbation analysis of palindromic and antipalindromic polynomials. We derive the structured backward error of an approximate eigenpair of these polynomials and characterize the minimal structured perturbations that achieve it. We detect a palindromic /anti-palindromic linearization with a view to minimizing the structured backward error for a given palindromic/anti-palindromic polynomial. We show that there always exists a palindromic /anti-palindromic linearization depending on the attributes of the approximate eigenvalues such that the increment of structured backward error negligible compared to the unstructured backward error for a palindromic /anti-palindromic polynomial.

1. Introduction. In this paper we undertake a detailed backward perturbation analysis of palindromic and anti-palindromic polynomials. These typical polynomials arise mainly in the study of rail traffic noise caused by high speed trains, see [24, 21, 25, 17]. We denote the space of matrix polynomials of degree m by $\mathbb{P}_m(\mathbb{C}^{n \times n})$. Obviously $\mathbb{P}_m(\mathbb{C}^{n \times n})$ is a linear space. A matrix polynomial $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$ is called a palindromic matrix polynomial if $P^*(z) = z^m P(1/z)$ for all $z \in \mathbb{C} \setminus \{0\}$ and an anti-palindromic polynomial if $P^*(z) = z^m P(-1/z)$ for all $z \in \mathbb{C} \setminus \{0\}$, where * is the transpose or conjugate transpose of a matrix and

$$P^*(z) = \sum_{j=0}^m z^j A_j^*$$
 whenever $P(z) = \sum_{j=0}^m z^j A_j$.

We consider only the regular matrix polynomials. We denote S for the space of regular palindromic or anti-palindromic polynomials. It is shown in [24, 21] that eigen-symmetry occurs for palindromic eigenvalue problems. We know that linearization is used to solve a given polynomial eigenvalue problem. It is also well known that an arbitrary linearization destroys the symmetry in the computed eigen-pairs. Therefore, the first step towards solving a palindromic eigenvalue problem is to convert the given polynomial $P \in S$ into a linear polynomial L, call it a structured linearization which has the same eigen-symmetry as that of P. Mackey et al. [24] have shown that a palindromic or anti-palindromic polynomial has palindromic/ and anti-palindromic linearizations which preserve the eigen-symmetry.

These two types of infinite linearizations give rise a problem of choosing a potential linearization among them. Aiming to find a potential structured linearization we follow a similar procedure as discussed in [2]. Indeed, given an approximate eigen-pair, we derive an explicit expression of the structured backward error under structured perturbation of $P \in S$. We mention that the technique used to obtain the structured backward error is just a generalization of the technique used in [1] for structured pencils. Note that, structured backward error is always greater than the unstructured backward error. In contrast, we show that it does not greater much and structured backward error is bounded above by a scalar multiple of the unstructured backward

error for few eigen-pairs. Besides, for each structure, there are certain eigen-pairs for which they are equal.

Then we define the structured backward error of an approximate eigenvalue of a palindromic matrix polynomial and apply it to establish a partial equality between structured and unstructured pseudospectra of H-palindromic / H-anti-palindromic polynomials.

Further using the expression of structured backward error of approximate eigenpair for polynomials, we obtain the structured backward error of the corresponding approximate eigen-pair of the widely varying structured linearizations. The structured backward error expressions of variety of structured pencils also can be found in [1]. Then we find a suitable bound of the ratio of structured backward error for an approximate eigen-pair of the structured linearization and the unstructured backward error of the corresponding approximate eigen-pair of the polynomial. Then analyzing these bounds we identify the *optimal* structured linearizations.

Its evident that structure preserving algorithms are required to produce symmetry in the computed eigenvalues. A few structured preserving algorithms have been proposed in the literature to compute the eigenpair of a polynomial $P \in S$, see [9, 22, 17]. We mention that the computable expressions of structured backward error obtained in this paper is an utilitarian to examine the backward stability of such algorithms.

The paper is organized as follows. In section 2, we first list the eigen-symmetry and backward error of an approximate eigenpair of palindromic polynomials. In section 3, we obtain the expressions of structured backward error of an approximate eigenpair of palindromic polynomials. In section 4 we explain the structured linearizations of structure polynomials and determine the optimal structured linearizations.

2. Eigen-symmetry of palindromic polynomials. A matrix polynomial $P(z) = \sum_{j=0}^{m} z^{j} A_{j} \in \mathbb{P}_{m}(\mathbb{C}^{n \times n})$ is called a *-palindromic or *-anti-palindromic polynomial if

$$P^*(z) = z^m P(1/z)$$
 or $P^*(z) = z^m P(-1/z)$,

respectively, for all $z \in \mathbb{C} \setminus \{0\}$, where $P^*(z) = \sum_{j=0}^m z^j A_j^*$ and $* \in \{T, H\}$. In Table 2.1 we present the eigen-symmetry for palindromic polynomials.

In the following Theorems we show that, for a given (λ, x) and $P \in S$, there always exists a polynomial $\Delta P \in S$ such that $(P(\lambda) + \Delta P(\lambda))x = 0$, that is, (λ, x) is an eigen-pair of $P + \Delta P$. Given an $x \in \mathbb{C}^n$ with $||x||_2 = 1$, we define the projection $P_x := I - xx^H$.

THEOREM 2.1. Let $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$ be a *-palindromic matrix polynomial, where

Then $P(\lambda)x + \triangle P(\lambda)x = 0$ where $\triangle P$ is a *-palindromic polynomial.

Proof. The proof is computational and is easy to check. \square

Next we consider *-anti-palindromic polynomials.

THEOREM 2.2. Let $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$ be a *-anti-palindromic matrix polynomial, where $* \in \{T, H\}$. Suppose $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$ with $||x||_2 = 1$ and set $r := -P(\lambda)x$. Then define

$$\triangle A_j := \begin{cases} -\overline{x}x^T A_j x x^H - \frac{1}{\|\Lambda_m\|_2^2} [\overline{\lambda^{m-j}} \overline{x}r^T P_x - \overline{\lambda^j} P_x^* r x^H], & if * = T, \\ -xx^H A_j x x^H - \frac{1}{\|\Lambda_m\|_2^2} [\lambda^{m-j} x r^H P_x - \overline{\lambda^j} P_x r x^H], & if * = H. \end{cases}$$

$$\triangle A_{m-j} := \begin{cases} -\triangle A_j^*, \ j = 0 : (m-1)/2, & if \ m \ is \ odd, \\ -\triangle A_j^*, \ j = 0 : (m-2)/2, & if \ m \ is \ even. \end{cases}$$

If m is even then define

Then $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\triangle P$ is a *-anti-palindromic polynomial.

Proof. The proof is computational and is easy to check. \Box

3. Structured backward error of approximate eigenpair. In this section we derive the structured backward error of an approximate eigenpair (λ, x) of $P \in S$ whenever λ is finite and $||x||_2 = 1$. Although for *infinity* eigenvalue the structured backward error can be obtained by considering the *reversal* of the polynomial, for details see [2, 5]. Assume that $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$. Then the backward error of (λ, x) is defined as the smallest, in norm, perturbation ΔP of the given P such that (λ, x) is an eigenpair of $P + \Delta P$, that is, $(P(\lambda) + \Delta P(\lambda))x = 0$. We make the convention throughout the paper that, $\Delta P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$ is of the form $\Delta P = \sum_{j=0}^m z^j \Delta A_j$. We equip a norm on $\mathbb{P}_m(\mathbb{C}^{n \times n})$ and make it a normed linear space. We define the Frobenius and the spectral norms on $\mathbb{P}_m(\mathbb{C}^{n \times n})$ as

$$|||\mathbf{P}|||_F := \left(\sum_{j=0}^m ||A_j||_F^2\right)^{1/2} \text{ and } |||\mathbf{P}|||_2 := \left(\sum_{j=0}^m ||A_j||_2^2\right)^{1/2}$$
(3.1)

respectively whenever $P(z) = \sum_{j=0}^{m} z^{j} A_{j}$. Then it is easy to see that, for any $\lambda \in \mathbb{C}, \|P(\lambda)\| \leq \|P\|_{F,2} \|\Lambda_m\|_2$, where $\Lambda_m = [1, \lambda, \dots, \lambda^m]^T$.

By convention, if $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$, then x is assumed to be nonzero, that is, $x \neq 0$. Treating (λ, x) as an approximate eigen-pair of the polynomial $\mathbf{P} \in \mathbb{P}_m(\mathbb{C}^{n \times n})$, we define the backward error of (λ, x) by

$$\begin{split} \eta_F(\lambda, x, \mathbf{P}) &:= \min_{\Delta \mathbf{P} \in \mathbb{P}_m(\mathbb{C}^{n \times n})} \{ \| \Delta \mathbf{P} \|_F : \mathbf{P}(\lambda) x + \Delta \mathbf{P}(\lambda) x = 0 \} \\ \eta_2(\lambda, x, \mathbf{P}) &:= \min_{\Delta \mathbf{P} \in \mathbb{P}_m(\mathbb{C}^{n \times n})} \{ \| \Delta \mathbf{P} \|_2 : \mathbf{P}(\lambda) x + \Delta \mathbf{P}(\lambda) x = 0 \}. \end{split}$$

Setting $r := -\mathbf{P}(\lambda)x$, we have

$$\eta_F(\lambda, x, \mathbf{P}) = \frac{\|r\|_2}{\|x\|_2 \|\Lambda_m\|_2} = \eta_2(\lambda, x, \mathbf{P}), \tag{3.2}$$

for a proof see [2]. Henceforth, we denote the unstructured backward error $\eta(\lambda, x, \mathbf{P})$ corresponding to both Frobenius and spectral norms.

Next assume that $P \in S$. Then we define the structured backward error of (λ, x) by

$$\begin{split} \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) &:= \min_{\Delta \mathbf{P} \in \mathbb{S}} \{ \| \Delta \mathbf{P} \|_F : \mathbf{P}(\lambda) x + \Delta \mathbf{P}(\lambda) x = 0 \} \\ \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) &:= \min_{\Delta \mathbf{P} \in \mathbb{S}} \{ \| \Delta \mathbf{P} \|_2 : \mathbf{P}(\lambda) x + \Delta \mathbf{P}(\lambda) x = 0 \}. \end{split}$$

By Theorem 2.1 and Theorem 2.2 it is obvious to see that $\eta^{\mathbb{S}}(\lambda, x, \mathbf{P}) < \infty$ and $\eta(\lambda, x, \mathbf{P}) \leq \eta^{\mathbb{S}}(\lambda, x, \mathbf{P})$ for both the Frobenius and the spectral norms. To derive the structured backward error for the spectral norm, we employ Davis-Kahan-Weinberger(DKW) Theorem stated as follows.

THEOREM 3.1 (Davis-Kahan-Weinberger, [10]). Let A, B, C satisfy $\left\| \begin{bmatrix} A \\ B \end{bmatrix} \right\|_2 = \mu$ and $\left\| \begin{bmatrix} A & C \end{bmatrix} \right\|_2 = \mu$. Then there exists D such that $\left\| \begin{bmatrix} A & C \\ B & D \end{bmatrix} \right\|_2 = \mu$. Indeed, those D which have this property are exactly those of the form

$$D = -KA^{H}L + \mu(I - KK^{H})^{1/2}Z(I - L^{H}L)^{1/2},$$

where $K^H := (\mu^2 I - A^H A)^{-1/2} B^H$, $L := (\mu^2 I - AA^H)^{-1/2} C$ and Z is an arbitrary contraction, that is, $||Z||_2 \le 1$.

For a structured version of DKW Theorem see [3]. We mention that the minimum backward structured perturbation for spectral norm of a given $P \in S$ is obtained in this paper by setting Z = 0. To make the presentation simple we introduce a projection, call *i*-projection $\pi_i : \mathbb{C}^m \to \mathbb{C}^m$, defined as follows.

$$\pi_i([x_0, x_1, x_1, \dots, x_{m-1}]^T) := [x_0, x_1, x_2, \dots, x_{i-1}, 0, 0, \dots, 0]^T.$$

We denote the flip operator by $R = \begin{bmatrix} & 1 \\ & \ddots & \\ 1 & & \end{bmatrix} \in \mathbb{R}^{m \times m}.$

Note: By an approximate eigen-pair (λ, x) of $P \in S$ we always mean λ is finite and $||x||_2 = 1$ in the rest of the paper.

First we consider *T*-palindromic polynomials.

THEOREM 3.2. Let S be a space of T-palindromic polynomials and $P \in S$. Assume that (λ, x) is an approximate eigen-pair of P and set $r := -P(\lambda)x$. Then we have the following

For j = 0 : (m-1)/2, define

$$\begin{cases} \frac{\lambda^{j}}{\|\Lambda_{m}\|_{2}^{2}} (x^{T}r)\overline{x}x^{H} + \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [\lambda^{j}P_{x}^{T}rx^{H} + \lambda^{m-j}\overline{x}r^{T}P_{x}] - \frac{\lambda^{m-j}}{\|\Lambda_{m}\|_{2}^{2}} \frac{\lambda^{T}rP_{x}^{T}rr^{T}P_{x}}{\|\Lambda_{m}\|_{2}^{2}} \frac{\lambda^{T}rP_{x}^{T}rr^{T}P_{x}}{\|I_{m}\|_{2}^{2}} \frac{\lambda^{T}rP_{x}}{\|I_{m}\|_{2}^{2}} \frac{\lambda^{$$

$$\Delta A_j = \begin{cases} G_j - \frac{(|\lambda^j|^2 \overline{\lambda^{m-j}} + |\lambda^{m-j}|^2 \overline{\lambda^j}) \ \overline{x^T r} \ P_x^T r r^T P_x}{\|\Pi_{(m/2)+1} \Lambda_m + \Pi_{m/2} R \Lambda_m\|_2^2 \ |\lambda^{m-j}|^2 \ (\|r\|_2^2 - |x^T r|^2)}, \qquad if \ |\lambda| > 1 \end{cases}$$

$$\Delta A_{m/2} = \begin{cases} G_j - \frac{(|\lambda^j|^2 \overline{\lambda^{m-j}} + |\lambda^{m-j}|^2 \overline{\lambda^j}) \overline{x^T r} P_x^T r r^T P_x}{\|\Pi_{(m/2)+1} \Lambda_m + \Pi_{m/2} R \Lambda_m\|_2^2 |\lambda^j|^2 (\|r\|_2^2 - |x^T r|^2)}, & if \ |\lambda| \le 1, \lambda \ne \pm 1 \\ \\ \Delta A_{m/2} = \begin{cases} \frac{\lambda^{m/2}}{\|\Lambda_m\|_2^2} \left[(x^T r) \overline{x} x^H + P_x^T r x^H + \overline{x} r^T P_x \right] - \frac{\lambda^{m/2} \overline{x^T r} P_x^T r r^T P_x}{\|\Lambda_m\|_2^2 (\|r\|_2^2 - |x^T r|^2)}, & if \ \lambda = \pm 1 \\ \\ H_{m/2} - \frac{\overline{\lambda^{m/2}} \overline{x^T r} P_x^T r r^T P_x}{\|\Pi_{(m/2)+1} \Lambda_m + \Pi_{m/2} R \Lambda_m\|_2^2 (\|r\|_2^2 - |x^T r|^2)}, & if \ \lambda \ne \pm 1, \end{cases} \end{cases}$$

for j = 0: (m-2)/2 and $\triangle A_{m-j} = \triangle A_j^T$. Then we obtain a $\triangle P \in \mathbb{S}$ such that $P(\lambda)x + \triangle P(\lambda)x = 0$ and $||| \triangle P |||_2 = \eta_2^{\mathbb{S}}(\lambda, x, P)$.

Proof. First consider that m is odd and $P \in S$. By Theorem 2.1 there exists a polynomial $\Delta P \in S$ such that $\Delta P(\lambda)x + P(\lambda)x = 0$. For j = 0 : (m-1)/2, consider

$$\widetilde{\triangle A}_j := Q^T \triangle A Q = \begin{pmatrix} a_{jj} & a_j^T \\ b_j & X_j \end{pmatrix} \text{ and } \triangle A_j^T = \triangle A_{m-j},$$

where $Q := [x, Q_1]$, is a unitary matrix. Now since $\Delta P(\lambda)x + P(\lambda)x = 0$, we have,

$$\left(\begin{array}{c}\sum_{j=0}^{m}\lambda^{j}a_{jj}\\\sum_{j=0}^{(m-1)/2}\lambda^{j}b_{j}+\sum_{j=0}^{(m-1)/2}\lambda^{m-j}a_{j}\end{array}\right)=\left(\begin{array}{c}x^{T}r\\Q_{1}^{T}r\end{array}\right).$$

The minimum norm solution of $\sum_{j=0}^{(m-1)/2} \lambda^j b_j + \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_j = Q_1^T r$ is $b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^T r, a_j = \frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^T r.$

For $\lambda = -1$, we have $x^T r = 0$. Hence the minimum norm solution of $\sum_{j=0}^{m} \lambda^j a_{jj} = x^T r$, is $a_{jj} = 0$. So we have $\triangle A_j$ for j = 0 : m, as follows:

$$\Delta A_j = \overline{Q} \left(\begin{array}{cc} 0 & (\frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^T r)^T \\ \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^T r & X_j \end{array} \right) Q^H, \quad \Delta A_j^T = \Delta A_{m-j}, \ j = 0: (m-1)/2.$$

Setting $X_j = 0, j = 0 : m$, we obtain $\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \frac{\|r\|_2}{\sqrt{m+1}} = \sqrt{2} \eta(\lambda, x, \mathbf{P})$. Simplifying the expressions of $\triangle A_j, j = 0 : m$, we obtain the desired result. Now let $\lambda \neq -1$. Notice that $a_{jj} = a_{m-j,m-j}$, j = 0 : (m-1)/2. Then the minimum norm solution of $\sum_{j=0}^{m} \lambda^j a_{jj} = x^T r$ which implies $\sum_{j=0}^{(m-1)/2} (\lambda^j + \lambda^{m-j}) a_{jj} = x^T r$, is

$$a_{jj} = \frac{\overline{\lambda^j} + \overline{\lambda^{m-j}}}{\|\Pi_{(m+1)/2}(\Lambda_m + R\Lambda_m)\|_2^2} x^T r.$$

Hence we obtain

$$\Delta A_j = \overline{Q} \begin{pmatrix} \frac{\overline{\lambda^j} + \overline{\lambda^{m-j}}}{\|\Pi_{(m+1)/2}(\Lambda_m + R\Lambda_m)\|_2^2} x^T r & (\frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^T r)^T \\ \\ \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^T r & X_j \end{pmatrix} Q^H, \quad j = 0: (m-1)/2$$

$$\Delta A_{m-j} = A_j^T, j = 0: (m-1)/2.$$

Now setting $X_j = 0, j = 0 : (m-1)/2$ we have,

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m + R\Lambda_m)\|_2^2} + \frac{\|r\|_2^2 - |x^T r|^2}{\|\Lambda_m\|_2^2}}$$

Simplifying the expression of $\triangle A_j$, i = 0 : m we obtain the desired result.

In particular, when $\lambda = 1$, we get $\|\Lambda_m\|_2^2 = m+1$ and $\|\Pi_{(m+1)/2}(\Lambda_m + R\Lambda_m)\|_2^2 = 2(m+1)$, which gives,

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{1}{\sqrt{m+1}} \sqrt{2 \|r\|_2^2 - |x^T r|^2}$$

Now we consider spectral norm. For $\lambda = -1$, by DKW Theorem 3.1 we have $\mu_{\triangle A_j} = \frac{\|r\|_2}{\|\Lambda_m\|_2^2}$ and $X_j = 0, j = 0$: (m-1)/2. This gives $\eta_2^{\mathbb{S}}(\lambda, x, \mathbb{P}) = \frac{\|r\|_2}{\sqrt{m+1}} = \eta(\lambda, x, \mathbb{P})$. Simplifying the expressions for $\triangle A_j$, j = 0 : m we obtain the same as we have got for Frobenius norm.

Next let $\lambda \neq -1$. For j = 0 : (m - 1)/2, using DKW Theorem 3.1 we have

$$\mu_{\triangle A_{j}} = \begin{cases} \sqrt{\frac{|\lambda^{j} + \lambda^{m-j}|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m} + R\Lambda_{m})\|_{2}^{4}} |x^{T}r|^{2} + \frac{|\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1\\ \sqrt{\frac{|\lambda^{j} + \lambda^{m-j}|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m} + R\Lambda_{m})\|_{2}^{4}} |x^{T}r|^{2} + \frac{|\lambda^{j}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| \le 1 \end{cases}$$

Consequently, by Theorem 3.1, we have

$$X_{j} = \begin{cases} -\frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} + |\lambda^{m-j}|^{2}\overline{\lambda^{j}}) \overline{x^{T}r}Q_{1}^{T}r(Q_{1}^{T}r)^{T}}{|\lambda^{m-j}|^{2} ||\Pi_{(m+1)/2}(\Lambda_{m} + R\Lambda_{m})||_{2}^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| > 1\\ -\frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} + |\lambda^{m-j}|^{2}\overline{\lambda^{j}}) \overline{x^{T}r}Q_{1}^{T}r(Q_{1}^{T}r)^{T}}{|\lambda^{j}|^{2} ||\Pi_{(m+1)/2}(\Lambda_{m} + R\Lambda_{m})||_{2}^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| \le 1 \end{cases}$$

This gives,

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \begin{cases} \sqrt{2} \sqrt{\frac{|x^{T}r|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m}+R\Lambda_{m})\|_{2}^{2}} + \frac{\|\Pi_{(m+1)/2}R\Lambda_{m}\|_{2}^{2}(\|r\|_{2}^{2}-|x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1\\ \sqrt{2} \sqrt{\frac{|x^{T}r|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m}+R\Lambda_{m})\|_{2}^{2}} + \frac{\|\Pi_{(m+1)/2}\Lambda_{m}\|^{2}(\|r\|_{2}^{2}-|x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| \le 1 \end{cases}$$

Simplifying the expression of $\triangle A_j$, j = 0 : (m-1)/2 we obtain the desired result.

Now if $\lambda = 1$, we have $\|\Lambda_m\|_2^2 = m + 1$ and $\|\Pi_{(m+1)/2}(\Lambda_m + R\Lambda_m)\|_2^2 = 2(m+1)$, which gives,

$$\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{\|r\|_2}{\sqrt{m+1}} = \eta(\lambda, x, \mathbf{P}).$$

Next, consider $P \in S$ and m is even. Note that, $A_{m/2} = A_{m/2}^T$. By Theorem 2.1 we know that there exist a polynomial $\triangle P \in S$ such that $P(\lambda)x + \triangle P(\lambda)x = 0$. Hence we have,

$$\left(\begin{array}{c}\sum_{j=0}^{m}\lambda^{j}a_{jj}\\\sum_{j=0}^{(m-2)/2}\lambda^{j}b_{j}+\sum_{j=0}^{(m-2)/2}\lambda^{m-j}a_{j}+\lambda^{m/2}a_{m/2}\end{array}\right)=\left(\begin{array}{c}x^{T}r\\Q_{1}^{T}r\end{array}\right).$$

The minimum norm solution of $\sum_{j=0}^{(m-2)/2}\lambda^j b_j + \sum_{j=0}^{(m-2)/2}\lambda^{m-j}a_j + \lambda^{m/2}a_{m/2} = Q_1^Tr$ is given by

$$b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^T r, \, a_j = \frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^T r, \, a_{m/2} = \frac{\overline{\lambda^{m/2}}}{\|\Lambda_m\|_2^2} Q_1^T r.$$

For $\lambda = \pm 1$, the minimum norm solution of $\sum_{j=0}^{m} \lambda^j a_{jj} = x^T r$ is $a_{jj} = \frac{\lambda^j}{\|\Lambda_m\|_2^2} x^T r$. Hence we have,

$$\Delta A_j = \overline{Q} \begin{pmatrix} \frac{\lambda^j}{\|\Lambda_m\|_2^2} x^T r & \frac{\lambda^{m-j}}{\|\Lambda_m\|_2^2} (Q_1^T r)^T \\ \frac{\lambda^j}{\|\Lambda_m\|_2^2} Q_1^T r & X_j \end{pmatrix} Q^H, \ \Delta A_{m/2} = \overline{Q} \begin{pmatrix} \frac{\lambda^{m/2}}{\|\Lambda_m\|_2^2} x^T r & \frac{\lambda^{m/2}}{\|\Lambda_m\|_2^2} (Q_1^T r)^T \\ \frac{\lambda^m}{\|\Lambda_m\|_2^2} Q_1^T r & X_m \end{pmatrix} Q^H,$$

and $\triangle A_{m-j} = \triangle A_j^T$, j = 0: (m-2)/2. Setting $X_j = 0$, j = 0: m, we have $\eta_F^{\mathbb{S}}(\lambda, x, \mathbb{P}) = \frac{1}{\sqrt{m+1}} \sqrt{2 ||r||_2^2 - |x^T r|^2}$. Simplifying $\triangle A_j$ s for j = 0: m we obtain the desired result.

Again, if $\lambda \neq \pm 1$, the minimum norm solution of $\sum_{j=0}^{m} \lambda^{j} a_{jj} = x^{T} r$ is

$$a_{jj} = \frac{\overline{\lambda^{j}} + \overline{\lambda^{m-j}}}{\|\Pi_{(m+2)/2}\Lambda_m + \Pi_{m/2}R\Lambda_m\|_2^2} x^T r, \ a_{m/2,m/2} = \frac{\overline{\lambda^{m/2}}}{\|\Pi_{(m+2)/2}\Lambda_m + \Pi_{m/2}R\Lambda_m\|_2^2} x^T r.$$

Hence we have

$$\Delta A_{j} = \overline{Q} \begin{pmatrix} \frac{\overline{\lambda^{j}} + \overline{\lambda^{m-j}}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{2}} x^{T}r & \frac{\overline{\lambda^{m-j}}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{T}r)^{T} \\ \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{T}r & X_{j} \end{pmatrix} Q^{H}, \ j = 0 : (m-2)/2 \\ \Delta A_{m/2} = \overline{Q} \begin{pmatrix} \frac{\overline{\lambda^{m/2}}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{2}} x^{T}r & \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{T}r)^{T} \\ \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{T}r & X_{m/2} \end{pmatrix} Q^{H} \\ \Delta A_{m-j} = \Delta A_{j}^{T}, \ j = 0 : (m-2)/2.$$

Setting $X_j = 0, \ j = 0 : m$, we have

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{\frac{(2\|\Pi_{(m+2)/2}\Lambda_m + \Pi_{m/2}R\Lambda_m\|_2^2 - |\lambda^{m/2}|^2)|x^T r|^2}{\|\Pi_{(m+2)/2}\Lambda_m + \Pi_{m/2}R\Lambda_m\|_2^4}} + 2\frac{\|r\|_2^2 - |x^T r|^2}{\|\Lambda_m\|_2^2}}{\|\Lambda_m\|_2^2}$$

which gives the desired result. Simplifying the expressions of $\triangle A_j$ desired result follow.

Next we consider spectral norm. If $\lambda = \pm 1$, by DKW Theorem 3.1 we have, $\mu_{\triangle A_j} = \frac{\|r\|_2}{\|\Lambda_m\|_2^2}, \ j = 0 : m$. Consequently, we get $\eta^{\mathbb{S}}(\lambda, x, \mathbb{P}) = \frac{\|r\|_2}{\sqrt{m+1}} = \eta(\lambda, x, \mathbb{P})$. Now by Theorem 3.1, we have

$$X_{j} = -\frac{\lambda^{m-j} Q_{1}^{T} r(Q_{1}^{T} r)^{T}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |x^{T} r|^{2})}, \ j = 0: (m-2)/2, \ X_{m/2} = -\frac{\lambda^{m/2} Q_{1}^{T} r(Q_{1}^{T} r)^{T}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |x^{T} r|^{2})}$$

Therefore, we obtain

$$\Delta A_j = \frac{\lambda^j}{\|\Lambda_m\|_2^2} r x^H + \frac{\lambda^{m-j}}{\|\Lambda_m\|_2^2} \overline{x} r^T P_x - \frac{\lambda^{m-j} P_x^T r r^T P_x}{\|\Lambda_m\|_2^2 (\|r\|_2^2 - |x^T r|^2)},$$

$$\Delta A_{m/2} = \frac{\lambda^{m/2}}{\|\Lambda_m\|_2^2} \left[r x^H + \overline{x} r^T P_x \right] - \frac{\lambda^{m/2} P_x^T r r^T P_x}{\|\Lambda_m\|_2^2 (\|r\|_2^2 - |x^T r|^2)}.$$

Again for $\lambda \neq \pm 1$, we have

$$\mu_{\Delta A_{j}} = \begin{cases} \sqrt{\frac{|\lambda^{j} + \lambda^{m-j}|^{2} |x^{T}r|^{2}}{||\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}||_{2}^{4}} + \frac{|\lambda^{m-j}|^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}{||\Lambda_{m}||_{2}^{4}}, & \text{if } |\lambda| > 1\\ \sqrt{\frac{|\lambda^{j} + \lambda^{m-j}|^{2} |x^{T}r|^{2}}{||\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}||_{2}^{4}} + \frac{|\lambda^{j}|^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}{||\Lambda_{m}||_{2}^{4}}, & \text{if } |\lambda| \le 1 \end{cases}$$
$$\mu_{\Delta A_{m/2}} = \sqrt{\frac{|\lambda^{m/2}|^{2} |x^{T}r|^{2}}{||\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}||_{2}^{4}} + \frac{|\lambda^{m/2}|^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}{||\Lambda_{m}||_{2}^{4}}}.$$

Consequently, we have

$$X_{j} = \begin{cases} -\frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} + |\lambda^{m-j}|^{2}\overline{\lambda^{j}}) \overline{x^{Tr}} Q_{1}^{T}r(Q_{1}^{T}r)^{T}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{2} |\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| > 1 \\ -\frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} + |\lambda^{2m-j}|^{2}\overline{\lambda^{j}}) \overline{x^{Tr}} Q_{1}^{T}r(Q_{1}^{T}r)^{T}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{2} |\lambda^{j}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| \le 1; \end{cases}$$
$$X_{m/2} = -\frac{\overline{\lambda^{m/2}} \overline{x^{Tr}} Q_{1}^{T}r(Q_{1}^{T}r)^{T}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}.$$

Hence we obtain

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \begin{cases} \sqrt{\frac{\|\Lambda_{m} + R\Lambda_{m}\|_{2}^{2} - 3|\lambda^{m/2}|^{2}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{4}} |x^{T}r|^{2} + \frac{2\|\Pi_{m/2}R\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, \\ if |\lambda| > 1 \\ \sqrt{\frac{\|\Lambda_{m} + R\Lambda_{m}\|_{2}^{2} - 3|\lambda^{m/2}|^{2}}{\|\Pi_{(m+2)/2}\Lambda_{m} + \Pi_{m/2}R\Lambda_{m}\|_{2}^{4}}} |x^{T}r|^{2} + \frac{2\|\Pi_{m/2}\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, \\ if |\lambda| \le 1. \end{cases}$$

Simplifying the expressions of $\triangle A_i$ s we obtain the desired result.

Note that if $Y \in \mathbb{C}^{n \times n}$ is such that Yx = 0 and $Y^Tx = 0$ then $Y = (I - xx^H)^T Z(I - xx^H)$ for some matrix Z. Hence from the proof of Theorem 3.2, we obtain that if K is a T-palindromic polynomial such that $P(\lambda)x + K(\lambda)x = 0$ then $K(z) = \Delta P(z) + (I - xx^H)^T N(z)(I - xx^H)$ for some T-palindromic polynomial N, where ΔP is given in Theorem 3.2.

REMARK 3.3. If $|x^T r| = ||r||_2$, then $||Q_1^T r||_2 = 0$. In such a case, considering $X_j = 0, j = 0 : m$, we obtain the desired results.

THEOREM 3.4. Let S be a space of T-anti-palindromic polynomials and $P \in S$. Assume that $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$ and set $r := -P(\lambda)x$. Then we have the following.

1. m is odd: we have

$$\begin{split} \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \sqrt{2} \ \eta(\lambda, x, \mathbf{P}), & \text{if } \lambda = 1\\ \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{\|r\|_2^2 - |x^T r|^2}{\|\Lambda_m\|_2^2}}, & \text{if } \lambda \neq 1. \end{cases} \\ \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) & \text{if } \lambda = 1\\ \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{\|\Pi_{(m+1)/2}R\Lambda_m\|_2^2(\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } \lambda = 1\\ \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{\|\Pi_{(m+1)/2}\Lambda_m\|_2^2(\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1, \end{cases} \\ \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{\|\Pi_{(m+1)/2}\Lambda_m\|_2^2(\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}, & \text{if } |\lambda| \le 1. \end{cases} \end{split}$$

Let

$$E_{j} = \frac{\overline{\lambda^{j}} - \overline{\lambda^{m-j}}}{\|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}} (x^{T}r)\overline{x}x^{H} - \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [\overline{\lambda^{m-j}}\overline{x}r^{T}P_{x} - \overline{\lambda^{j}}P_{x}^{T}rx^{H}]$$
$$F_{j} = \frac{\overline{\lambda^{j}} - \overline{\lambda^{m-j}}}{\|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}} (x^{T}r)\overline{x}x^{H} - \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [\overline{\lambda^{m-j}}\overline{x}r^{T}P_{x} - \overline{\lambda^{j}}P_{x}^{T}rx^{H}].$$

For j = 0 : (m - 1)/2, define

$$\triangle A_j = \begin{cases} \frac{1}{\|\Lambda_m\|_2^2} [rx^H - \overline{x}r^T], & \text{if } \lambda = 1\\ E_j, & \lambda \neq 1 \end{cases}$$

and $\triangle A_{m-j} = -A_j^T$ gives the unique polynomial $\triangle P \in \mathbb{S}$ such that $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\|\triangle P\|_F = \eta_F^{\mathbb{S}}(\lambda, x, P)$. Next, define

$$\Delta A_{j} = \begin{cases} \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [rx^{H} - \overline{x}r^{T}], & \text{if } \lambda = 1 \\ E_{j} + \frac{(|\lambda^{j}|^{2} \overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2} \overline{\lambda^{j}}) \overline{x^{T}} r P_{x}^{T} r r^{T} P_{x}}{|\lambda^{m-j}|^{2} \|\Pi_{(m+1)/2} (\Lambda_{m} - R\Lambda_{m})\|_{2}^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| > 1 \\ E_{j} + \frac{(|\lambda^{j}|^{2} \overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2} \overline{\lambda^{j}}) \overline{x^{T}} r P_{x}^{T} r r^{T} P_{x}}{|\lambda^{j}|^{2} |\|\Pi_{(m+1)/2} (\Lambda_{m} - R\Lambda_{m})\|_{2}^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| \le 1, \lambda \neq 1 \end{cases}$$

 $\begin{array}{l} and \ \triangle A_{m-j} = -A_j^T, \ j = 0: (m-1)/2 \ gives \ a \ polynomial \ \triangle \mathbf{P} \in \mathbb{S} \ such \ that \\ \mathbf{P}(\lambda)x + \triangle \mathbf{P}(\lambda)x = 0 \ and \ \|| \triangle \mathbf{P} \||_2 = \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}). \end{array}$

2. m is even:

$$\begin{split} \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} &\sqrt{2} \ \eta(\lambda, x, \mathbf{P}), & \text{if } \lambda = 1 \\ &\sqrt{2} \ \sqrt{\frac{|x^T r|^2}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{\|r\|_2^2 - |x^T r|^2}{\|\Lambda_m\|_2^2}}, & \text{if } \lambda \neq 1. \end{cases} \\ \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} &\eta(\lambda, x, \mathbf{P}), & \text{if } \lambda \neq 1. \\ &\sqrt{\frac{2|x^T r|^2}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{(2\|\Pi_{m/2}R\Lambda_m\|^2 + |\lambda^{m/2}|^2)(\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1, \\ &\sqrt{\frac{2|x^T r|^2}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{(2\|\Pi_{m/2}\Lambda_m\|^2 + |\lambda^{m/2}|^2)(\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1. \end{cases} \end{split}$$

For j = 0 : (m - 2)/2 consider

$$\triangle A_j = \begin{cases} \frac{1}{\|\Lambda_m\|_2^2} [rx^H - \overline{x}r^T], & \text{if } \lambda = 1\\ F_j, & \text{if } \lambda \neq 1 \end{cases}, \ \Delta A_{m/2} = \begin{cases} \frac{1}{\|\Lambda_m\|_2^2} [rx^H - \overline{x}r^T], & \text{if } \lambda = 1\\ \frac{\overline{\lambda^{m/2}}}{\|\Lambda_m\|_2^2} [rx^H - \overline{x}r^T], & \text{if } \lambda \neq 1 \end{cases}$$

and $\triangle A_{m-j} = -A_j^T$, j = 0 : (m-2)/2 gives the unique polynomial $\triangle P \in \mathbb{S}$ such that $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\||\triangle P|||_F = \eta_F^{\mathbb{S}}(\lambda, x, P)$. Next, define

$$\triangle A_{j} = \begin{cases} \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [rx^{H} - \overline{x}r^{T}], & \text{if } \lambda = 1 \\ F_{j} + \frac{(|\lambda^{j}|^{2} \overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2} \overline{\lambda^{j}}) \overline{x^{T}r} P_{x}^{T} rr^{T} P_{x}}{|\lambda^{m-j}|^{2} |\|\Pi_{m/2} (\Lambda_{m} - R\Lambda_{m})\|_{2}^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| > 1 \\ F_{j} + \frac{(|\lambda^{j}|^{2} \overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2} \overline{\lambda^{j}}) \overline{x^{T}r} P_{x}^{T} rr^{T} P_{x}}{|\lambda^{j}|^{2} |\|\Pi_{m/2} (\Lambda_{m} - R\Lambda_{m})\|_{2}^{2} (||r||_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| \le 1, \lambda \neq 1 \end{cases} \\ \triangle A_{m/2} = \begin{cases} \frac{1}{||\Lambda_{m}||_{2}^{2}} [rx^{H} - \overline{x}r^{T}], & \text{if } \lambda = 1 \\ \frac{\lambda^{m/2}}{||\Lambda_{m}||_{2}^{2}} [rx^{H} - \overline{x}r^{T}], & \text{if } \lambda \neq 1 \end{cases} \end{cases}$$

and $\triangle A_{m-j} = -A_j^T$, j = 0 : (m-2)/2 gives a polynomial $\triangle \mathbf{P} \in \mathbb{S}$ such that $\mathbf{P}(\lambda)x + \triangle \mathbf{P}(\lambda)x = 0$ and $||| \triangle \mathbf{P} |||_2 = \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}).$

Proof. First assume that $P \in S$ and m is odd. By Theorem 2.2 there exists $\Delta P \in S$ such that $\Delta P(\lambda)x + P(\lambda)x = 0$. For j = 0 : (m-1)/2, consider

$$\widetilde{\triangle A}_j := Q^T \triangle AQ = \begin{pmatrix} a_{jj} & a_j^T \\ b_j & X_j \end{pmatrix} \text{ and } \triangle A_{m-j} = -\triangle A_j^T, \ j = 0 : (m-1)/2,$$

where $Q = [x, Q_1]$ is a unitary matrix. Since $\triangle P(\lambda)x + P(\lambda)x = 0$, we have,

$$\begin{pmatrix} \sum_{j=0}^{(m-1)/2} \lambda^j a_{jj} - \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_{jj} \\ \sum_{j=0}^{(m-1)/2} \lambda^j b_j - \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_j \end{pmatrix} = \begin{pmatrix} x^T r \\ Q_1^T r \end{pmatrix}.$$

The minimum norm solution of $\sum_{j=0}^{(m-1)/2} \lambda^j b_j - \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_j = Q_1^T r$ is given by $b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^T r$, $a_j = -\frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^T r$, j = 0 : (m-1)/2.

For $\lambda = 1$, we have $x^T r = 0$. Hence the minimum norm solution of $\sum_{j=0}^{m} \lambda^j a_{jj} = x^T r$, is $a_{jj} = 0, j = 0 : m$. Then we have

$$\Delta A_j = \overline{Q} \left(\begin{array}{cc} 0 & -\frac{\overline{\lambda^{m-j}(Q_1^T r)^T}}{\|\Lambda_m\|_2^2} \\ \frac{\overline{\lambda^j}Q_1^T r}{\|\Lambda_m\|_2^2} & X_j \end{array} \right) Q^H, \ A_{m-j} = A_j^T \ j = 0 : (m-1)/2.$$

Setting $X_j = 0, j = 0$: *m* we have the minimum Frobenius norm of $\triangle A_j$. Consequently we obtain,

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \, \frac{\|r\|_2}{\|\Lambda_m\|_2} = \sqrt{2} \, \eta(\lambda, x, \mathbf{P}).$$

Simplifying the expression of $\triangle A_j, j = 0 : m$ we obtain the desired result.

Next suppose that $\lambda \neq 1$. Then the minimum norm solution of $\sum_{j=0}^{(m-1)/2} \lambda^j a_{jj} - \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_{jj} = x^T r$ is

$$a_{jj} = \frac{\overline{\lambda^j} - \overline{\lambda^{m-j}}}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} x^T r, \ j = 0 : (m-1)/2.$$

Therefore we have

$$\triangle A_j = \overline{Q} \begin{pmatrix} \frac{\overline{\lambda^j} - \overline{\lambda^{m-j}}}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} x^T r & -\frac{\overline{\lambda^{m-j}(Q_1^T r)^T}}{\|\Lambda_m\|_2^2} \\ \frac{\overline{\lambda^j} Q_1^T r}{\|\Lambda_m\|_2^2} & X_j \end{pmatrix} Q^H, \ j = 0: (m-1)/2.$$

Taking $X_j = 0$, we obtain the minimum Frobenius norm of $\triangle A_j$ and consequently we have

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \sqrt{\frac{\sum_{j=0}^{(m-1)/2} |\lambda^j - \lambda^{m-j}|^2 |x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^4} + \frac{\sum_{i=0}^{(m-1)/2} (|\lambda^{m-i}|^2 + |\lambda^i|^2) (\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}} = \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{(m+1)/2}(\Lambda_m - R\Lambda_m)\|_2^2} + \frac{\|r\|_2^2 - |x^T r|^2}{\|\Lambda_m\|_2^2}}{\|\Lambda_m\|_2^2}}.$$

Simplifying the expression of ΔA_j for all j = 0: (m-1)/2 we obtain the desired result.

Next we consider the spectral norm. Assume that $\lambda = 1$. By DKW Theorem 3.1 we have $\mu_{\Delta A_j} = \frac{\|r\|_2}{\|\Lambda_m\|_2}$, j = 0: (m-1)/2 and consequently $X_j = 0$. Therefore we have $\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{\|r\|_2}{\|\Lambda_m\|_2} = \eta(\lambda, x, \mathbf{P})$. Simplifying the expression of ΔA_j we obtain $\Delta A_j = -\frac{1}{\|\Lambda_m\|_2^2} [\overline{x}r^T - rx^H]$. Hence the result follows.

Next, suppose that $\lambda \neq 1$. Consider

$$\mu_{\Delta A_{j}} = \begin{cases} \sqrt{\frac{|\lambda^{j} - \lambda^{m-j}|^{2} |x^{T}r|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{4}} + \frac{|\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1 \\ \sqrt{\frac{|\lambda^{j} - \lambda^{m-j}|^{2} |x^{T}r|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{4}} + \frac{|\lambda^{j}|^{2} (\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| \le 1 \end{cases}$$

for j = 0: (m-1)/2. Therefore by Theorem 3.1 we have

$$X_{j} = \begin{cases} \frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2}\overline{\lambda^{j}})\overline{x^{T}r}(Q_{1}^{T}r)(Q_{1}^{T}r)^{T}}{|\lambda^{m-j}|^{2}|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})||_{2}^{2}(||r||_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| > 1, \\ \frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2}\overline{\lambda^{j}})\overline{x^{T}r}(Q_{1}^{T}r)(Q_{1}^{T}r)^{T}}{|\lambda^{j}|^{2}|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})||_{2}^{2}(||r||_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| \le 1, \end{cases}$$

for j = 0 : (m - 1)/2.

Hence we have

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \begin{cases} \sqrt{2} \sqrt{\frac{|x^{T}r|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}} + \frac{\|\Pi_{(m+1)/2}R\Lambda_{m}\|_{2}^{2}(\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1, \\ \sqrt{2} \sqrt{\frac{|x^{T}r|^{2}}{\|\Pi_{(m+1)/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}} + \frac{\|\Pi_{(m+1)/2}\Lambda_{m}\|_{2}^{2}(\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| \le 1. \end{cases}$$

Simplifying the expression of $\triangle A_j$ for j = 0 : (m-1)/2 we obtain the desired result.

Next, assume that $\mathbf{P} \in \mathbb{S}$ and m is even. Note that for given $\mathbf{P}(z) = \sum_{j=0}^{m} z^{j} A_{j} \in$ S, we have $A_{m/2}^T = -A_{m/2}$. By Theorem 2.2 we know that there exists a polynomial $\triangle P \in S$ such that $P(\lambda)x + \triangle P(x) = 0$. This implies,

$$\begin{pmatrix} \sum_{j=0}^{(m-2)/2} \lambda^j a_{jj} - \sum_{j=0}^{(m-2)/2} \lambda^{m-j} a_{jj} \\ \sum_{j=0}^{(m-2)/2} \lambda^j b_j + a_{m/2} \lambda^{m/2} - \sum_{j=0}^{(m-2)/2} \lambda^{m-j} a_j \end{pmatrix} = \begin{pmatrix} x^T r \\ Q_1^T r \end{pmatrix}.$$

Note that $a_{m/2,m/2} = 0$, since $A_{m/2}$ is a skew-symmetric matrix. The minimum norm solution of $\sum_{j=0}^{(m-2)/2} \lambda^j b_j + a_{m/2} \lambda^{m/2} - \sum_{j=0}^{(m-2)/2} \lambda^{m-j} a_j = Q_1^T r$ is given by

$$b_j = \frac{\overline{\lambda^j} Q_1^T r}{\|\Lambda_m\|_2^2}, \ a_j = -\frac{\overline{\lambda^{m-j}} Q_1^T r}{\|\Lambda_m\|_2^2}, \ a_{m/2} = \frac{\overline{\lambda^{m/2}} Q_1^T r}{\|\Lambda_m\|_2^2}, j = 0: (m-2)/2.$$

For $\lambda = 1, x^T r = 0$. Hence the minimum norm solution of $a_{jj} = 0$, when $\lambda = 1$. Consequently, we have,

$$\Delta A_j = \overline{Q} \left(\begin{array}{cc} 0 & -\frac{(Q_1^T r)^T}{\|\Lambda_m\|_2^2} \\ \frac{Q_1^T r}{\|\Lambda_m\|_2^2} & X_j \end{array} \right) Q^H, \ j = 0 : (m-2)/2.$$

Setting $X_j = 0, j = 0$: (m - 2)/2 we obtain the minimum norm of $\triangle A_j$ and consequently we have $\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \eta(\lambda, x, \mathbf{P})$. Simplifying the expressions we obtain the desired result.

Next, suppose that $\lambda \neq 1$. Then the minimum norm solution of

$$\sum_{j=0}^{(m-2)/2} \lambda^j a_{jj} - \sum_{j=0}^{(m-2)/2} \lambda^{m-j} a_{jj} = x^T r$$

is given by

$$a_{jj} = \frac{\overline{\lambda^j} - \overline{\lambda^{m-j}}}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^2} x^T r, \ a_{m/2,m/2} = 0.$$

Consequently, for j = 0 : (m-2)/2, we obtain

$$\begin{split} \triangle A_j = \overline{Q} \left(\begin{array}{cc} \frac{\overline{\lambda^j} - \overline{\lambda^{m-j}}}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^2} x^T r & -\frac{\overline{\lambda^{m-j}}(Q_1^T r)^T}{\|\Lambda_m\|_2^2} \\ \\ \frac{\overline{\lambda^j} Q_1^T r}{\|\Lambda_m\|_2^2} & X_j \end{array} \right) Q^H, \\ \triangle A_{m/2} = \overline{Q} \left(\begin{array}{cc} 0 & -\frac{\overline{\lambda^{m/2}}(Q_1^T r)^T}{\|\Lambda_m\|_2^2} \\ \frac{\overline{\lambda^{m/2}} Q_1^T r}{\|\Lambda_m\|_2^2} & X_{m/2} \end{array} \right) Q^H. \end{split}$$

Setting $X_j = 0 = X_{m/2}$, we get the minimum Frobenius norm of $\triangle A_j$ and $\triangle A_{m/2}$ respectively and these give,

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \sqrt{\frac{|x^T r|^2}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^2}} + \frac{\|r\|_2^2 - |x^T r|^2}{\|\Lambda_m\|_2^2}$$

Simplifying the expressions of $\triangle A_j$ for j = 0 : m/2 we obtain the desired result.

Next consider spectral norm. Suppose that $\lambda = 1$. Consider $\mu_{\triangle A_j} = \frac{\|r\|_2}{\|\Lambda_m\|_2}$ and consequently by DKW Theorem 3.1 we have $X_j = 0$. Therefore we have $\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{\|r\|_2}{\|\Lambda_m\|_2} = \eta(\lambda, x, \mathbf{P})$. Simplifying the expression of $\triangle A_j$ we obtain $\triangle A_j = -\frac{1}{\|\Lambda_m\|_2^2} [\overline{x}r^T - rx^H]$ for j = 0 : m/2. Hence the result follows.

Next, suppose $\lambda \neq 1$. Consider $\mu_{\triangle A_{m/2}} = \sqrt{\frac{|\lambda^m|^2 (\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}$. Then we have $X_{m/2} = 0$. Now for j = 0 : (m - 2)/2 consider

$$\mu_{\triangle A_j} = \begin{cases} \sqrt{\frac{|\lambda^j - \lambda^{m-j}|^2 |x^T r|^2}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^4} + \frac{|\lambda^{m-j}|^2 (\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1, \\ \sqrt{\frac{|\lambda^j - \lambda^{m-j}|^2 |x^T r|^2}{\|\Pi_{m/2}(\Lambda_m - R\Lambda_m)\|_2^4} + \frac{|\lambda^j|^2 (\|r\|_2^2 - |x^T r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| \le 1. \end{cases}$$

Consequently, by DKW Theorem 3.1 we have

$$X_{j} = \begin{cases} \frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2}\overline{\lambda^{j}})\overline{x^{T}r}(Q_{1}^{T}r)(Q_{1}^{T}r)^{T}}{|\lambda^{m-j}|^{2}|\|\mathbf{\Pi}_{m/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}(||\mathbf{r}|\|_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| > 1, \\ \frac{(|\lambda^{j}|^{2}\overline{\lambda^{m-j}} - |\lambda^{m-j}|^{2}\overline{\lambda^{j}})\overline{x^{T}r}(Q_{1}^{T}r)(Q_{1}^{T}r)^{T}}{|\lambda^{j}|^{2}|\|\mathbf{\Pi}_{m/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}(||\mathbf{r}|\|_{2}^{2} - |x^{T}r|^{2})}, & \text{if } |\lambda| \le 1, \end{cases}$$

for j = 0: (m-2)/2. Therefore we obtain,

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \begin{cases} \sqrt{\frac{2|x^{T}r|^{2}}{\|\Pi_{m/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}} + \frac{(2\|\Pi_{m/2}R\Lambda_{m}\|^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1, \\ \sqrt{\frac{2|x^{T}r|^{2}}{\|\Pi_{m/2}(\Lambda_{m} - R\Lambda_{m})\|_{2}^{2}} + \frac{(2\|\Pi_{m/2}\Lambda_{m}\|^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{T}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| \le 1. \end{cases}$$

Simplifying the expressions of $\triangle A_j$ for j = 0 : m/2 we obtain the desired result.

Analogous to the T-palindromic polynomial we can conclude that if K is a Tanti-palindromic polynomial such that $P(\lambda)x + K(\lambda)x = 0$ then $K(z) = \triangle P(z) + (I - z)$ $(xx^H)^T N(z)(I - xx^H)$ for some T-anti-palindromic polynomial N, where ΔP is given in Theorem 3.4.

REMARK 3.5. If $|x^T r| = ||r||_2$, then $||Q_1^T r||_2 = 0$. In such a case, considering $X_i = 0, i = 0 : m$, we obtain the desired results.

Next we consider *H*-palindromic/*H*-anti-palindromic polynomials. To make the presentation simple we introduce the following.

Let $z = a + i b \in \mathbb{C}$. Define a map vec : $\mathbb{C} \to \mathbb{R}^2$ by vec $(z) = \begin{pmatrix} \mathsf{re}(z) \\ \mathsf{im}(z) \end{pmatrix}$. Further

define a map $\mathbb{M} : \mathbb{C} \to \mathbb{R}^{2 \times 2}$ as $\mathbb{M}(z) = \begin{pmatrix} \mathsf{re}(z) & -\mathsf{im}(z) \\ \mathsf{im}(z) & \mathsf{re}(z) \end{pmatrix}$. Then the following hold: • $\operatorname{vec}(\overline{z}) = \Sigma \operatorname{vec}(z)$ where $\Sigma = \begin{pmatrix} 1 & 0 \\ 0 & -1 \end{pmatrix}$.

- $\operatorname{vec}(z_1z_2) = \operatorname{M}(z_1)\operatorname{vec}(z_2), \, z_1, z_2 \in \mathbb{C}$
- $\operatorname{M}(\overline{z}) = \operatorname{M}(z)^T$.

Assume that $\lambda \in \mathbb{C}$, and $a_{jj} \in \mathbb{C}$. Then if we have

$$\sum_{j=0}^{m} \lambda^{i} a_{jj} = x^{H} r \tag{3.3}$$

then applying the map vec both sides we obtain $\operatorname{vec}(\sum_{j=0}^m \lambda^i a_{jj}) = \operatorname{vec}(x^H r) \Rightarrow$ $\sum_{j=0}^{m} \mathbb{M}(\lambda^{i}) \operatorname{vec}(a_{jj}) = \operatorname{vec}(x^{H}r).$

THEOREM 3.6. Let S be the space of H-palindromic polynomials. Assume that $P \in S$ and $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$. Setting $r := -P(\lambda)x$, we have the following.

1. Let m be odd. Then

$$\begin{split} \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \frac{1}{\sqrt{m+1}} \sqrt{2 \|r\|_2^2 - |r^H x|^2}, & \text{if } |\lambda| = 1\\ \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}, & \text{if } |\lambda| \neq 1. \end{cases} \\ \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \eta(\lambda, x, \mathbf{P}), & \text{if } |\lambda| = 1\\ \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|\Pi_{(m+1)/2} R \Lambda_m\|^2 (\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1\\ \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|\Pi_{(m+1)/2} \Lambda_m\|^2 (\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1. \end{cases} \end{split}$$

where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-1)/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$ and

$$H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) \\ \\ \operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) \end{pmatrix}, j = 0 : (m-1)/2.$$

Let $E_j = \frac{1}{\|\Lambda_m\|_2^2} [\lambda^{m-j} x r^H P_x + \overline{\lambda^j} P_x r x^H]$. For j = 0 : (m-1)/2 define

$$\triangle A_j = \begin{cases} \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x r^H x x^H + E_j, & \text{if } |\lambda| = 1\\ e_j^T \widehat{r} x x^H + E_j, & \text{if } |\lambda| \neq 1 \end{cases}$$

and $\triangle A_{m-j} = \triangle A_j^H$. Consider the unique polynomial $\triangle \mathbf{P} \in \mathbb{S}$. Then $\mathbf{P}(\lambda)x + \triangle \mathbf{P}(\lambda)x = 0$ and $\|| \triangle \mathbf{P} \||_F = \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P})$. Next define

$$\Delta A_{j} = \begin{cases} \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} xr^{H} xx^{H} + E_{j} - \frac{x^{H}r \ \lambda^{m-j} P_{x}rr^{H} P_{x}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| = 1 \\ e_{j}^{T} \widehat{r} xx^{H} + E_{j} - \frac{\overline{e_{j}^{T} \widehat{r}} \ \overline{\lambda^{j}} \ \lambda^{m-j} \ P_{x}rr^{H} P_{x}}{|\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| > 1 \\ e_{j}^{T} \widehat{r} xx^{H} + E_{j} - \frac{\overline{e_{j}^{T} \widehat{r}} \ \overline{\lambda^{j}} \ \lambda^{m-j} \ P_{x}rr^{H} P_{x}}{|\lambda^{i}|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| < 1 \end{cases}$$

for j = 0 : (m-1)/2 with $\triangle A_{m-j} = \triangle A_j^H$. Consider the polynomial $\triangle P \in \mathbb{S}$. Then $P(\lambda)x + \triangle P(\lambda)x = 0$ and $||| \triangle P |||_2 = \eta_2^{\mathbb{S}}(\lambda, x, P)$. 2. Let m be even. Then

$$\begin{split} \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \frac{1}{\sqrt{m+1}} \sqrt{2\|r\|_2^2 - |r^H x|^2}, & \text{if } |\lambda| = 1\\ \sqrt{(2\|\hat{r}\|_2^2 - |e_{m/2}^T \hat{r}|^2) + 2\frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}, & \text{if } |\lambda| \neq 1. \end{cases} \\ \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \eta(\lambda, x, \mathbf{P}) & \text{if } |\lambda| = 1\\ \sqrt{(2\|\hat{r}\|_2^2 - |e_{m/2}^T \hat{r}|^2) + \frac{(2\|\Pi_{m/2}R\Lambda_m\|_2^2 + |\lambda^{m/2}|^2)(\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1\\ \sqrt{(2\|\hat{r}\|_2^2 - |e_{m/2}^T \hat{r}|^2) + \frac{(2\|\Pi_{m/2}\Lambda_m\|_2^2 + |\lambda^{m/2}|^2)(\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1 \end{cases} \\ \sqrt{(2\|\hat{r}\|_2^2 - |e_{m/2}^T \hat{r}|^2) + \frac{(2\|\Pi_{m/2}\Lambda_m\|_2^2 + |\lambda^{m/2}|^2)(\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| < 1. \end{cases} \end{split}$$

where
$$\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-2)/2} & H_{m/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$$
 and

$$H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) \\ \operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) \end{pmatrix}, \ j = 0 : (m-2)/2,$$

$$H_{m/2} = \begin{pmatrix} \operatorname{re}(\lambda^{m/2}) \\ \operatorname{im}(\lambda^{m/2}) \end{pmatrix}.$$

 $\begin{array}{l} Let \ F_{j} = \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [\lambda^{m-j} x r^{H} P_{x} + \overline{\lambda^{j}} P_{x} r x^{H}] \ and \ G_{m/2} = \frac{1}{\|\Lambda_{m}\|_{2}^{2}} [\lambda^{m/2} x r^{H} P_{x} + \overline{\lambda^{m/2}} P_{x} r x^{H}]. \ Then \ for \ j = 0: (m-2)/2, \ define \end{array}$

$$\triangle A_j = \begin{cases} \frac{\lambda^j}{\|\Lambda_m\|_2^2} x r^H x x^H + F_j, & \text{if } |\lambda| = 1 \\ e_j^T \hat{r} x x^H + F_j, & \text{if } |\lambda| \neq 1 \end{cases}, \quad \triangle A_{m/2} = \begin{cases} \frac{\lambda^{m/2}}{\|\Lambda_m\|_2^2} x r^H x x^H + G_{m/2}, \\ \text{if } |\lambda| = 1 \\ e_{m/2}^T \hat{r} x x^H + G_{m/2}, \\ \text{if } |\lambda| \neq 1 \end{cases}$$

and $\triangle A_{m-j} = \triangle A_j^H$. Consider the unique polynomial $\triangle \mathbf{P} \in \mathbb{S}$. Then $\mathbf{P}(\lambda)x + \triangle \mathbf{P}(\lambda)x = 0$ and $\||\!| \triangle \mathbf{P} \||_F = \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P})$. Next define

$$\Delta A_{j} = \begin{cases} \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} x x^{H} r x^{H} + F_{j} - \frac{\lambda^{m-j} r^{H} x P_{x} r r^{H} P_{x}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |r^{H} x|^{2})}, & \text{if } |\lambda| = 1 \\ e_{j}^{T} \widehat{r} x x^{H} + F_{j} - \frac{\overline{e_{j}^{T} \widehat{r}} \overline{\lambda^{j}} \lambda^{m-j} P_{x} r r^{H} P_{x}}{|\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{H} r|^{2})}, & \text{if } |\lambda| > 1 \\ e_{j}^{T} \widehat{r} x x^{H} + F_{j} - \frac{\overline{e_{j}^{T} \widehat{r}} \overline{\lambda^{j}} \lambda^{m-j} P_{x} r r^{H} P_{x}}{|\lambda^{i}|^{2} (\|r\|_{2}^{2} - |x^{H} r|^{2})}, & \text{if } |\lambda| < 1 \\ \end{cases} \\ \Delta A_{m/2} = \begin{cases} \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} x x^{H} r x^{H} + G_{m} - \frac{\lambda^{m/2} r^{H} P_{x} r r^{H} P_{x}}{\|\Lambda_{m}\|_{2}^{2} (|r\|_{2}^{2} - |r^{H} x|^{2})}, & \text{if } |\lambda| = 1 \\ e_{m/2}^{T} \widehat{r} x x^{H} + G_{m/2} - \frac{\overline{e_{m/2}^{T} \widehat{r}} P_{x} r r^{H} P_{x}}{(\|r\|_{2}^{2} - |r^{H} x|^{2})}, & \text{if } |\lambda| \neq 1. \end{cases}$$

and $\triangle A_{m-j} = \triangle A_j^H$. Consider the matrix polynomial $\triangle P \in \mathbb{S}$. Then $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\||| \triangle P \||_2 = \eta_2^{\mathbb{S}}(\lambda, x, P)$.

Proof. Assume that $\mathbf{P} \in \mathbb{S}$ given by $\mathbf{P}(z) = \sum_{j=0}^{m} z^{j} A_{j}$. First consider that m is odd. By Theorem 2.2 there exists $\Delta \mathbf{P} \in \mathbb{S}$, such that $\Delta \mathbf{P}(\lambda)x + \mathbf{P}(\lambda)x = 0$. Define

$$\Delta A_j := Q \begin{pmatrix} a_{jj} & a_j^H \\ b_j & X_j \end{pmatrix} Q^H, \quad X_{m-j} = X_j^H, \ j = 0 : (m-1)/2,$$

where $Q = [x, Q_1]$ is a unitary matrix. Since $\triangle P(\lambda)x + P(\lambda)x = 0$, we have

$$\left(\begin{array}{c}\sum_{j=0}^{m}\lambda^{j}a_{jj}\\\sum_{j=0}^{(m-1)/2}\lambda^{j}b_{j}+\sum_{j=0}^{(m-1)/2}\lambda^{m-j}a_{j}\end{array}\right)=\left(\begin{array}{c}x^{H}r\\Q_{1}^{H}r\end{array}\right).$$

Consequently, the minimum norm solution of $\sum_{j=0}^{(m-1)/2} \lambda^j b_j + \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_j = Q_1^H r$ is given by

$$b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^H r, \ a_j = \frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^H r, \ j = 0: (m-1)/2.$$

Note that for $|\lambda| = 1$, we have $\overline{x^H r} = \overline{\lambda^m} x^H r$. Hence the minimum norm solution of $\sum_{j=0}^m \lambda^j a_{jj} = x^H r$ is $a_{jj} = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x^H r$, j = 0 : m. Therefore we have

$$\Delta A_j = Q \begin{pmatrix} \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x^H r & \frac{\lambda^{m-j}}{\|\Lambda_m\|_2^2} (Q_1^H r)^H \\ \\ \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^H r & X_j \end{pmatrix} Q^H, \quad i := 0 : (m-1)/2.$$

$$\Delta A_{m-j} = \Delta A_j^H, \ j = 0 : (m-1)/2$$

which gives, $\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{1}{\sqrt{m+1}} \sqrt{2 \|r\|_2^2 - |r^H x|^2}$ by setting $X_j = 0$. Simplifying the expressions for ΔA_j s we obtain the desired result.

Next, let $|\lambda| \neq 1$. The value of a_{jj} for the equation $\sum_{j=0}^{m} \lambda^j a_{jj} = x^H r$, j = 0: (m-1)/2 is achieved after employing the condition $\overline{a}_{jj} = a_{m-j,m-j} j = 0$: (m-1)/2 in equation (3.3) which becomes

$$\sum_{j=0}^{n-1)/2} (\mathsf{M}(\lambda^j) + \mathsf{M}(\lambda^{m-j})\Sigma) \mathrm{vec}(a_{jj}) = \mathrm{vec}(x^H r)$$

and the solution is given by $a_{jj} = e_j^T \hat{r}$ where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-1)/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$ and

$$H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) \\ \operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) \end{pmatrix}.$$

Thus we obtain,

$$\triangle A_j = Q \begin{pmatrix} e_j^T \hat{r} & \lambda^{m-j} \frac{(Q_1^H r)^H}{\|\Lambda_m\|_2^2} \\ \frac{\overline{\lambda^j} Q_1^H r}{\|\Lambda_m\|_2^2} & X_j \end{pmatrix} Q^H, \quad i := 0 : (m-1)/2.$$

Setting $X_j = 0$, we obtain $\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}$. Simplifying the expressions of $\triangle A_j$ s we obtain the desired result.

Next we consider spectral norm. If $|\lambda| = 1$ by DKW Theorem 3.1 we have $\mu_{\triangle A_j} = \frac{\|r\|_2}{\|\Lambda_m\|_2^2}$. Consequently, we have

$$X_j = -\frac{x^H r \ \lambda^{m-j} Q_1^H r (Q_1^H r)^H}{\|\Lambda_m\|_2^2 (\|r\|_2^2 - |x^H r|^2)}, \ j = 0: (m-1)/2.$$

This gives, $\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{\|r\|_2}{\sqrt{m+1}} = \eta(\lambda, x, \mathbf{P})$. Simplifying the expressions for $\triangle A_j$ s we obtain the desired result.

Further, for $|\lambda| \neq 1$, we consider,

$$\mu_{\triangle A_j} = \begin{cases} \sqrt{|e_j^T \hat{r}|^2 + \frac{|\lambda^{m-j}|^2 (\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1\\ \sqrt{|e_j^T \hat{r}|^2 + \frac{|\lambda^i|^2 (\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| < 1 \end{cases}$$

for j = 0: (m-1)/2. Consequently, we have

$$X_{j} = \begin{cases} -\frac{\overline{e_{j}^{T}\hat{r}} \ \overline{\lambda^{j}} \ \lambda^{m-j} \ Q_{1}^{H} r(Q_{1}^{H} r)^{H}}{|\lambda^{m-j}|^{2} \ (\|r\|_{2}^{2} - |x^{H} r|^{2})}, & \text{if } |\lambda| > 1\\ -\frac{\overline{e_{j}^{T}\hat{r}} \ \overline{\lambda^{j}} \ \lambda^{m-j} \ Q_{1}^{H} r(Q_{1}^{H} r)^{H}}{|\lambda^{i}|^{2} \ (\|r\|_{2}^{2} - |x^{H} r|^{2})}, & \text{if } |\lambda| < 1. \end{cases}$$

This gives

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \begin{cases} \sqrt{2}\sqrt{\|\widehat{r}\|^{2} + \frac{\|\Pi_{(m+1)/2}R\Lambda_{m}\|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}}, & \text{if } |\lambda| > 1\\ \sqrt{2}\sqrt{\|\widehat{r}\|^{2} + \frac{\|\Pi_{(m+1)/2}\Lambda_{m}\|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}}, & \text{if } |\lambda| < 1 \end{cases}$$

Simplifying the expressions of $\triangle A_j$ for all j = 0: (m-1)/2 we obtain the desired result.

Now consider $P \in S$ and *m* is even. Notice that $A_{m/2} = A_{m/2}^H$. By Theorem 2.2 there exists a polynomial $\Delta P \in S$ such that $\Delta P(\lambda)x + P(\lambda)x = 0$. Define

$$\Delta A_j := Q \begin{pmatrix} a_{jj} & a_j^H \\ b_j & X_j \end{pmatrix} Q^H, \quad X_{m-j} = X_j^H, \ j = 0 : (m-2)/2$$
$$\Delta A_{m/2} := Q \begin{pmatrix} a_{m/2,m/2} & a_{m/2}^H \\ a_{m/2} & X_{m/2} \end{pmatrix} Q^H, \quad X_{m/2} = X_{m/2}^H.$$

Since $\triangle P(\lambda)x + P(\lambda)x = 0$, we have

$$\left(\begin{array}{c}\sum_{j=0}^{m}\lambda^{j}a_{jj}\\\sum_{j=0}^{(m-2)/2}\lambda^{j}b_{j}+\sum_{j=0}^{(m-2)/2}\lambda^{m-j}a_{j}+\lambda^{m/2}a_{m/2}\end{array}\right)=\left(\begin{array}{c}x^{H}r\\Q_{1}^{H}r\end{array}\right).$$

The minimum norm solution of $\sum_{j=0}^{(m-2)/2} \lambda^j b_j + \sum_{j=0}^{(m-2)/2} \lambda^{m-j} a_j + \lambda^{m/2} a_{m/2} = Q_1^H r$ is given by

$$b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2}, \ a_j = \frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2}, \ a_{m/2} = \frac{\overline{\lambda^{m/2}}}{\|\Lambda_m\|_2^2}$$

Note that for $|\lambda| = 1$, we have $\overline{x^H r} = \overline{\lambda^m} x^H r$. Hence the minimum norm solution of $\sum_{j=0}^m \lambda^j a_{jj} = x^H r$ is $a_{jj} = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x^H r$, j = 0 : m. Therefore we have

$$\begin{split} \triangle A_{j} &= Q \begin{pmatrix} \frac{\overline{\lambda j}}{\|\Lambda_{m}\|_{2}^{2}} x^{H}r & \frac{\lambda^{m-j}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{H}r)^{H} \\ \frac{\overline{\lambda j}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{j} \end{pmatrix} Q^{H}, \quad i := 0 : (m-2)/2 \\ \triangle A_{m/2} &= Q \begin{pmatrix} \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} x^{H}r & \frac{\lambda^{m/2}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{H}r)^{H} \\ \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{m/2} \end{pmatrix} Q^{H}, \\ \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{m/2} \end{pmatrix} Q^{H}, \\ \triangle A_{m-j} &= \triangle A_{j}^{H}, \ j = 0 : (m-2)/2 \end{split}$$

which gives, $\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{1}{\sqrt{m+1}} \sqrt{2\|r\|_2^2 - |r^H x|^2}$.

Simplifying the expressions of ΔA_j for j = 0 : m/2 we obtain the desired result. Further let $|\lambda| \neq 1$. Then the value of a_{jj} for the equation $\sum_{j=0}^{m} \lambda^j a_{jj} = x^H r, j = 0 : (m-2)/2$ is achieved after employing the condition $\overline{a}_{jj} = a_{m-j,m-j}, j = 0 : (m-2)/2$ and $a_{m/2,m/2} \in \mathbb{R}$ in equation (3.3) which becomes

$$\sum_{j=0}^{(m-2)/2} (\mathsf{M}(\lambda^j) + \mathsf{M}(\lambda^{m-j})\Sigma) \operatorname{vec}(a_{jj}) + \mathsf{M}(\lambda^{m/2}) \operatorname{vec}(a_{m/2,m/2}) = \operatorname{vec}(x^H r)$$

and the solution is given by $a_{jj} = e_j^T \hat{r}, \ j = 0 : m/2$ where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-2)/2} & H_{m/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$ and $H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) \\ \operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) \end{pmatrix}, \ j = 0 : (m-2)/2,$ $H_{m/2} = \begin{pmatrix} \operatorname{re}\lambda^{m/2} \\ \operatorname{im}\lambda^{m/2} \end{pmatrix}.$

Therefore we obtain,

$$\Delta A_{j} = Q \begin{pmatrix} e_{j}^{T} \hat{r} & \lambda^{m-j} \frac{(Q_{1}^{H}r)^{H}}{\|\Lambda_{m}\|_{2}^{2}} \\ \frac{\overline{\lambda^{j}}Q_{1}^{H}r}{\|\Lambda_{m}\|_{2}^{2}} & X_{j} \end{pmatrix} Q^{H}, \quad i := 0 : (m-2)/2$$

$$\Delta A_{m/2} = Q \begin{pmatrix} e_{m/2}^{T} \hat{r} & \lambda^{m/2} \frac{(Q_{1}^{H}r)^{H}}{\|\Lambda_{m}\|_{2}^{2}} \\ \frac{\overline{\lambda^{m/2}}Q_{1}^{H}r}{\|\Lambda_{m}\|_{2}^{2}} & X_{m/2} \end{pmatrix} Q^{H},$$

$$\Delta A_{m-j} = \Delta A_{j}^{H}, \quad j = 0 : (m-2)/2.$$

Setting $X_j = 0 = X_{m/2}, j = 0 : (m-2)/2$ we obtain

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{(2\|\hat{r}\|_2^2 - |e_{m/2}^T \hat{r}|^2) + 2\frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}$$

Simplifying the expressions for $\triangle A_i$ s we obtain the desired result.

Next we consider spectral norm. Note that for $|\lambda| = 1$, we have $\overline{x^H r} = \overline{\lambda^m} x^H r$. Consequently, $\lambda^j r^H x = \overline{\lambda^{m-j}} x^H r$. Consider $\mu_{\Delta A_j} = \frac{\|r\|_2}{\|\Lambda_m\|_2^2}$. By DKW Theorem 3.1 we have

$$X_{j} = -\frac{\lambda^{m-j} r^{H} x Q_{1}^{H} r(Q_{1}^{H} r)^{H}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |r^{H} x|^{2})}, \ X_{m/2} = -\frac{\lambda^{m/2} r^{H} x Q_{1}^{H} r(Q_{1}^{H} r)^{H}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |r^{H} x|^{2})}$$

which gives $\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{\|r\|_2}{\sqrt{m+1}}$. Simplifying the expressions for $\triangle A_j$ s we obtain the desired result.

If $|\lambda| \neq 1$ consider

$$\mu_{\triangle A_j} = \begin{cases} \sqrt{|e_j^T \hat{r}|^2 + \frac{|\lambda^{m-j}|^2 (||r||_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1\\ \sqrt{|e_j^T \hat{r}|^2 + \frac{|\lambda^i|^2 (||r||_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| < 1 \end{cases}$$
$$\mu_{\triangle A_{m/2}} = \sqrt{|e_{m/2}^T \hat{r}|^2 + \frac{|\lambda^m|^2 (||r||_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}$$

for j = 0: (m - 2)/2. Then by DKW Theorem 3.1 we have

$$X_{j} = \begin{cases} -\frac{\overline{e_{j}^{T}\hat{r}} \ \overline{\lambda^{j}} \ \lambda^{m-j} \ Q_{1}^{H}r(Q_{1}^{H}r)^{H}}{|\lambda^{m-j}|^{2} \ (\|r\|_{2}^{2}-|x^{H}r|^{2})}, & \text{if } |\lambda| > 1\\ -\frac{\overline{e_{j}^{T}\hat{r}} \ \overline{\lambda^{j}} \ \lambda^{m-j} \ Q_{1}^{H}r(Q_{1}^{H}r)^{H}}{|\lambda^{i}|^{2} \ (\|r\|_{2}^{2}-|x^{H}r|^{2})}, & \text{if } |\lambda| < 1, \end{cases}$$
$$X_{m/2} = -\frac{\overline{e_{m/2}^{T}\hat{r}} \ Q_{1}^{H}r(Q_{1}^{H}r)^{H}}{(\|r\|_{2}^{2}-|x^{H}r|^{2})}$$

for j = 0 : (m - 2)/2.

This gives

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \begin{cases} \sqrt{(2\|\hat{r}\|_{2}^{2} - |e_{m/2}^{T}\hat{r}|^{2}) + \frac{(2\|\Pi_{m/2}R\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1\\ \sqrt{(2\|\hat{r}\|_{2}^{2} - |e_{m/2}^{T}\hat{r}|^{2}) + \frac{(2\|\Pi_{m/2}\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| < 1. \end{cases}$$

Simplifying the expressions of $\triangle A_j$ s we obtain the desired result.

It is evident from the proof of the above Theorem 3.6 that, if K is a *H*-palindromic polynomial such that $P(\lambda)x + K(\lambda)x = 0$ then $K(z) = \triangle P(z) + (I - xx^H)^T N(z)(I - xx^H)$ for some *H*-palindromic polynomial N, where $\triangle P$ is given in Theorem 3.6.

REMARK 3.7. If $|x^H r| = ||r||_2$, then $||Q_1^H r||_2 = 0$. In such a case, considering $X_j = 0, j = 0 : m$, we obtain the desired results.

THEOREM 3.8. Let S be the space of H-anti-palindromic polynomials. Assume that $P \in S$ and $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$. Setting $r := -P(\lambda)x$, we have the following.

1. m be odd:

$$\begin{split} \eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \frac{1}{\sqrt{m+1}} \sqrt{2\|r\|_2^2 - |r^H x|^2}, & \text{if } |\lambda| = 1\\ \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}, & \text{if } |\lambda| \neq 1. \end{cases} \\ \eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \eta(\lambda, x, \mathbf{P}), & \text{if } |\lambda| = 1\\ \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|\Pi_{(m+1)/2} R \Lambda_m\|^2 (\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1\\ \sqrt{2} \sqrt{\|\hat{r}\|_2^2 + \frac{\|\Pi_{(m+1)/2} \Lambda_m\|^2 (\|r\|_2^2 - |x^H r|^2)}{\|\Lambda_m\|_2^4}}, & \text{if } |\lambda| > 1. \end{cases} \end{split}$$

where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-1)/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$ and

$$H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) - \operatorname{im}(\lambda^{m-j}) \\ \operatorname{im}(\lambda^j) - \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) \end{pmatrix}.$$

Let $E_j = \frac{1}{\|\Lambda_m\|_2^2} [\overline{\lambda^j} P_x r x^H - \lambda^{m-j} x r^H P_x]$. Then for j = 0 : (m-1)/2 define

$$\Delta A_j = \begin{cases} \frac{\overline{\lambda^j}}{\|\Lambda_M\|_2^2} x r^H x x^H + E_j, & \text{if } |\lambda| = 1\\ e_j^T \widehat{r} x x^H + E_j, & \text{if } |\lambda| \neq 1 \end{cases}$$

and $\triangle A_{m-j} = -\triangle A_j^H$. Consider the unique polynomial $\triangle P \in \mathbb{S}$. Then $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\||\triangle P|||_F = \eta_F^{\mathbb{S}}(\lambda, x, P)$. Next define

$$\Delta A_{j} = \begin{cases} \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} xr^{H} xx^{H} + E_{j} + \frac{x^{H}r}{\|\Lambda_{m}\|_{2}^{2}} \frac{\lambda^{m-j}P_{x}rr^{H}P_{x}}{\|\Lambda_{m}\|_{2}^{2}}, & \text{if } |\lambda| = 1 \\ e_{j}^{T} \widehat{r} xx^{H} + E_{j} + \frac{\overline{e_{j}^{T} \widehat{r}} \overline{\lambda^{j}} \lambda^{m-j} P_{x}rr^{H}P_{x}}{|\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| > 1 \\ e_{j}^{T} \widehat{r} xx^{H} + E_{j} + \frac{\overline{e_{j}^{T} \widehat{r}} \overline{\lambda^{j}} \lambda^{m-j} P_{x}rr^{H}P_{x}}{|\lambda^{i}|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| < 1 \end{cases}$$

for j = 0: (m-1)/2 with $\triangle A_{m-j} = -\triangle A_j^H$. Consider the polynomial $\triangle P$. Then $\triangle P \in \mathbb{S}$, $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\|\triangle P\|_2 = \eta_2^{\mathbb{S}}(\lambda, x, P)$.

2. m is even:

$$\begin{split} \eta_{F}^{\mathbb{S}}(\lambda, x, \mathbf{P}) &= \begin{cases} \frac{1}{\sqrt{m+1}} \sqrt{2\|r\|_{2}^{2} - |r^{H}x|^{2}}, & \text{if } |\lambda| = 1\\ \sqrt{(2\|\hat{r}\|_{2}^{2} - |e_{m/2}^{T}\hat{r}|^{2}) + 2\frac{\|r\|_{2}^{2} - |x^{H}r|^{2}}{\|\Lambda_{m}\|_{2}^{2}}}, & \text{if } |\lambda| \neq 1. \end{cases} \\ \eta_{2}^{\mathbb{S}}(\lambda, x, \mathbf{P}) & \text{if } |\lambda| = 1\\ \sqrt{(2\|\hat{r}\|_{2}^{2} - |e_{m/2}^{T}\hat{r}|^{2}) + \frac{(2\|\Pi_{m/2}R\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| = 1\\ \sqrt{(2\|\hat{r}\|_{2}^{2} - |e_{m/2}^{T}\hat{r}|^{2}) + \frac{(2\|\Pi_{m/2}\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| > 1\\ \sqrt{(2\|\hat{r}\|_{2}^{2} - |e_{m/2}^{T}\hat{r}|^{2}) + \frac{(2\|\Pi_{m/2}\Lambda_{m}\|_{2}^{2} + |\lambda^{m/2}|^{2})(\|r\|_{2}^{2} - |x^{H}r|^{2})}{\|\Lambda_{m}\|_{2}^{4}}, & \text{if } |\lambda| < 1 \end{cases} \end{split}$$

where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-2)/2} & H_{m/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$ and $H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) \\ \operatorname{im}(\lambda^j) + \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) \end{pmatrix}, \ j = 0 : (m-2)/2,$ $H_{m/2} = \begin{pmatrix} -\operatorname{im}(\lambda^{m/2}) \\ \operatorname{re}(\lambda^{m/2}) \end{pmatrix}.$

Let $F_j = \frac{1}{\|\Lambda_m\|_2^2} [\overline{\lambda^j} P_x r x^H - \lambda^{m-j} x r^H P_x]$ and $G_{m/2} = \frac{1}{\|\Lambda_m\|_2^2} [\overline{\lambda^{m/2}} P_x r x^H - \lambda^{m/2} x r^H P_x]$. Then for j = 0 : (m-2)/2, define

$$\triangle A_j = \begin{cases} \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x r^H x x^H + F_j, & \text{if } |\lambda| = 1\\ e_j^T \widehat{r} x x^H + F_j, & \text{if } |\lambda| \neq 1 \end{cases}, \ \Delta A_{m/2} = \begin{cases} \frac{\lambda^{m/2}}{\|\Lambda_m\|_2^2} x r^H x x^H + G_{m/2}, & \text{if } |\lambda| = 1\\ i e_{m/2}^T \widehat{r} x x^H + G_{m/2}, & \text{if } |\lambda| \neq 1 \end{cases}$$

and $\triangle A_{m-j} = -\triangle A_j^H$. Consider the unique polynomial $\triangle P$. Then $\triangle P \in S$, $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\||\triangle P|||_F = \eta_F^S(\lambda, x, P)$. Next define

$$\Delta A_{j} = \begin{cases} \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} x x^{H} r x^{H} + F_{j} + \frac{\lambda^{m-j} r^{H} x P_{x} r r^{H} P_{x}}{\|\Lambda_{m}\|_{2}^{2} (\|r\|_{2}^{2} - |r^{H}x|^{2})}, & \text{if } |\lambda| = 1 \\ e_{j}^{T} \hat{r} x x^{H} + F_{j} + \frac{\overline{e_{j}^{T} \hat{r}} \overline{\lambda^{j}} \lambda^{m-j} P_{x} r r^{H} P_{x}}{|\lambda^{m-j}|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| > 1 \\ e_{j}^{T} \hat{r} x x^{H} + F_{j} + \frac{\overline{e_{j}^{T} \hat{r}} \overline{\lambda^{j}} \lambda^{m-j} P_{x} r r^{H} P_{x}}{|\lambda^{i}|^{2} (\|r\|_{2}^{2} - |x^{H}r|^{2})}, & \text{if } |\lambda| < 1 \\ \end{cases} \\ \Delta A_{m/2} = \begin{cases} \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} x x^{H} r x^{H} + G_{m/2} + \frac{\lambda^{m/2} r^{H} x P_{x} r r^{H} P_{x}}{|\Lambda_{m}\|_{2}^{2} (||r\|_{2}^{2} - |r^{H}x|^{2})}, & \text{if } |\lambda| = 1 \\ i e_{m/2}^{T} \hat{r} x x^{H} + G_{m/2} + \frac{\overline{e_{m/2}^{T} \hat{r}} P_{x} r r^{H} P_{x}}{(||r\|_{2}^{2} - |r^{H}x|^{2})}, & \text{if } |\lambda| \neq 1. \end{cases}$$

and $\triangle A_{m-j} = -\triangle A_j^H$ for j = 0 : (m-2)/2. Consider the polynomial $\triangle P$. Then $\triangle P \in \mathbb{S}$, $P(\lambda)x + \triangle P(\lambda)x = 0$ and $\| \triangle P \|_2 = \eta_2^{\mathbb{S}}(\lambda, x, P)$.

Proof. First assume that m is odd. By Theorem 2.2 we know that there exists $\triangle P \in S$, such that $\triangle P(z)x + P(z)x = 0$. Define

$$\Delta A_j := Q \begin{pmatrix} a_{jj} & a_j^H \\ b_j & X_j \end{pmatrix} Q^H, \quad A_{m-j} = -A_j^H, \ j = 0 : (m-1)/2.$$

Since $\triangle P(\lambda)x + P(\lambda)x = 0$, we get

$$\left(\begin{array}{c}\sum_{j=0}^{m}\lambda^{j}a_{jj}\\\sum_{j=0}^{(m-1)/2}\lambda^{j}b_{j}-\sum_{j=0}^{(m-1)/2}\lambda^{j}a_{j}\end{array}\right)=\left(\begin{array}{c}x^{H}r\\Q_{1}^{H}r\end{array}\right).$$

The minimum norm solution of $\sum_{j=0}^{(m-1)/2} \lambda^j b_j - \sum_{j=0}^{(m-1)/2} \lambda^{m-j} a_j = Q_1^H r$ is given by $b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2}, \ a_j = -\frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2}.$

Note that for $|\lambda| = 1$, we have $\overline{x^H r} = -\overline{\lambda^m} x^H r$. Hence the minimum norm solution of $\sum_{j=0}^m \lambda^j a_{jj} = x^H r$ is $a_{jj} = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x^H r$, j = 0 : (m-1)/2. Thus we have

$$\Delta A_j = Q \begin{pmatrix} \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x^H r & -\frac{\lambda^{m-j}}{\|\Lambda_m\|_2^2} (Q_1^H r)^H \\ \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^H r & X_j \end{pmatrix} Q^H, \quad i := 0 : (m-1)/2 \\ \Delta A_{m-j} = -\Delta A_j^H \ j = 0 : (m-1)/2.$$

which gives, $\eta^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{1}{\sqrt{m+1}} \sqrt{2 ||r||_2^2 - |r^H x|^2}$. Simplifying the expressions for $\triangle A_j$ for j = 0: (m-1)/2 we obtain the desired result.

Now suppose that $|\lambda| \neq 1$. The value of a_{jj} from $\sum_{j=0}^{m} \lambda^j a_{jj} = x^H r$, is achieved after employing the condition $\overline{a}_{jj} = -a_{m-j,m-j}$ j = 0 : (m-1)/2 in equation (3.3) which becomes

$$\sum_{j=0}^{m-1)/2} (\mathsf{M}(\lambda^j) - \mathsf{M}(\lambda^{m-j})\Sigma) \mathrm{vec}(a_{jj}) = \mathrm{vec}(x^H r)$$

is given by $a_{jj} = e_j^T \hat{r}, \ j = 0 : (m-1)/2$ where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-1)/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r),$

$$H_j = \begin{pmatrix} \operatorname{re}(\lambda^j) - \operatorname{re}(\lambda^{m-j}) & -\operatorname{im}(\lambda^j) - \operatorname{im}(\lambda^{m-j}) \\ \operatorname{im}(\lambda^j) - \operatorname{im}(\lambda^{m-j}) & \operatorname{re}(\lambda^j) + \operatorname{re}(\lambda^{m-j}) \end{pmatrix}.$$

Consequently we have

(

$$\triangle A_j = Q \begin{pmatrix} e_j^T \hat{r} & -\frac{\lambda^{m-j}}{\|\Lambda_m\|_2^2} (Q_1^H r)^H \\ \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^H r & X_j \end{pmatrix} Q^H, \ \triangle A_{m-j} = -\triangle A_j^H, \ j = 0: (m-1)/2.$$

Setting $X_j = 0$ we obtain the minimum Frobenius norm of $\triangle A_j$ and consequently we obtain

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{2} \sqrt{\|\widehat{r}\|_2^2 + \frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}.$$

Simplifying the expression of A_i s we obtain the desired result.

Next consider spectral norm. From the construction of $\triangle A_j$ it is easily seen that the $\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P})$ will be same as that of the Theorem 3.6 case and desired results follow similarly.

Secondly assume that m is even. By Theorem 2.2 we know that there exists $\triangle P \in S$ such that $\triangle P(\lambda)x + P(\lambda)x = 0$. For j = 0 : (m-2)/2 define

$$\Delta A_j := Q \begin{pmatrix} a_{jj} & a_j^H \\ b_j & X_j \end{pmatrix} Q^H, \ \Delta A_{m/2} = Q \begin{pmatrix} a_{m/2,m/2} & -a_{m/2}^H \\ a_{m/2} & X_{m/2} \end{pmatrix} Q^H.$$

Since $\triangle P(\lambda)x + P(\lambda)x = 0$, we have

$$\left(\begin{array}{c}\sum_{j=0}^{m}\lambda^{j}a_{jj}\\\sum_{j=0}^{(m-2)/2}\lambda^{j}b_{j}-\sum_{j=0}^{(m-2)/2}\lambda^{m-j}a_{j}+\lambda^{m/2}a_{m/2}\end{array}\right)=\left(\begin{array}{c}x^{H}r\\Q_{1}^{H}r\end{array}\right).$$

The minimum norm solution of $\sum_{j=0}^{(m-2)/2}\lambda^j b_j-\sum_{j=0}^{(m-2)/2}\lambda^{m-j}a_j+\lambda^{m/2}a_{m/2}=Q_1^Hr$ is

$$b_j = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} Q_1^H r, \ a_j = -\frac{\overline{\lambda^{m-j}}}{\|\Lambda_m\|_2^2} Q_1^H r, \ a_{m/2} = \frac{\overline{\lambda^{m/2}}}{\|\Lambda_m\|_2^2} Q_1^H r.$$

Note that for $|\lambda| = 1$, we have $\overline{x^H r} = -\overline{\lambda^m} x^H r$. Hence the minimum norm solution of $\sum_{j=0}^m \lambda^j a_{jj} = x^H r$ is $a_{jj} = \frac{\overline{\lambda^j}}{\|\Lambda_m\|_2^2} x^H r$, j = 0 : (m-2)/2. Note that $a_{m/2,m/2} \in i \mathbb{R}$. Thus we have

$$\Delta A_{j} = Q \begin{pmatrix} \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} x^{H}r & -\frac{\lambda^{m-j}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{H}r)^{H} \\ \\ \frac{\overline{\lambda^{j}}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{j} \end{pmatrix} Q^{H}, \quad i := 0 : (m-2)/2.$$

$$\Delta A_{m/2} = Q \begin{pmatrix} \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} x^{H}r & -\frac{\lambda^{m/2}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{H}r)^{H} \\ \\ \frac{\overline{\lambda^{m/2}}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{m/2} \end{pmatrix} Q^{H},$$

$$\Delta A_{j} = -\Delta A_{m-j}^{H}, \quad j = 0 : (m-2)/2,$$

which gives $\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \frac{1}{\sqrt{m+1}} \sqrt{2 \|r\|_2^2 - |r^H x|^2}$ if $|\lambda| = 1$. Simplifying the expressions for $\triangle A_j$ s we we obtain the desired result. Now suppose that $|\lambda| \neq 1$. The value of a_{jj} for the equation $\sum_{j=0}^m \lambda^j a_{jj} = u$

Now suppose that $|\lambda| \neq 1$. The value of a_{jj} for the equation $\sum_{j=0}^{m} \lambda^j a_{jj} = x^H r$, j = 0 : (m-2)/2 is achieved after employing the condition $\overline{a}_{jj} = -a_{m-j,m-j} j = 0 : (m-2)/2$ and $a_{m/2,m/2} \in i \mathbb{R}$ in equation (3.3) is given by $a_{jj} = e_j^T \operatorname{vec}(\hat{r}), j = 0 : m/2$ where $\hat{r} = \begin{bmatrix} H_0 & H_1 & \dots & H_{(m-2)/2} & H_{m/2} \end{bmatrix}^{\dagger} \operatorname{vec}(x^H r)$ and

$$\begin{split} H_j &= \left(\begin{array}{cc} \operatorname{re}\left(\lambda^j\right) + \operatorname{re}\left(\lambda^{m-j}\right) & -\operatorname{im}\left(\lambda^j\right) + \operatorname{im}\left(\lambda^{m-j}\right) \\ \operatorname{im}\left(\lambda^j\right) + \operatorname{im}\left(\lambda^{m-j}\right) & \operatorname{re}\left(\lambda^j\right) - \operatorname{re}\left(\lambda^{m-j}\right) \end{array} \right), \ j = 0: (m-2)/2, \\ H_{m/2} &= \left(\begin{array}{c} -\operatorname{im}\left(\lambda^{m/2}\right) \\ \operatorname{re}\left(\lambda^{m/2}\right) \end{array} \right). \end{split}$$

Consequently we have

$$\Delta A_{j} = Q \begin{pmatrix} e_{j}^{T} \hat{r} & -\frac{\lambda^{m-j}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{H}r)^{H} \\ \frac{\lambda^{j}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{j} \end{pmatrix} Q^{H},$$

$$\Delta A_{m/2} = Q \begin{pmatrix} i e_{m/2}^{T} \hat{r} & -\frac{\lambda^{m/2}}{\|\Lambda_{m}\|_{2}^{2}} (Q_{1}^{H}r)^{H} \\ \frac{\lambda^{m/2}}{\|\Lambda_{m}\|_{2}^{2}} Q_{1}^{H}r & X_{m/2} \end{pmatrix} Q^{H},$$

$$\Delta A_{j} = -\Delta A_{m-j}^{H}, \ j = 0 : (m-2)/2.$$

Setting $X_j = 0 = X_{m/2}$ we obtain

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathbf{P}) = \sqrt{(2\|\hat{r}\|_2^2 - |e_{m/2}^T \hat{r}|^2) + 2\frac{\|r\|_2^2 - |x^H r|^2}{\|\Lambda_m\|_2^2}}.$$

Simplifying the expressions for $\triangle A_j$'s we obtain the desired result.

Next consider spectral norm. From the construction of $\triangle A_j$ it is easily seen that $\eta_2^{\mathbb{S}}(\lambda, x, \mathbf{P})$ will be same as that of Theorem 3.6 and others follow similarly.

It follows from the proof of the above Theorem 3.6 that, if K is a *H*-antipalindromic polynomial such that $P(\lambda)x + K(\lambda)x = 0$ then $K(z) = \triangle P(z) + (I - xx^H)^T N(z)(I - xx^H)$ for some *H*-anti-palindromic polynomial N, where $\triangle P$ is given in Theorem 3.8.

REMARK 3.9. If $|x^H r| = ||r||_2$, then $||Q_1^H r||_2 = 0$. In such a case, considering $X_j = 0, j = 0 : m$, we obtain the desired results.

3.1. Pseudospectra for palindromic polynomials. Let $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$. For $\lambda \in \mathbb{C}$, the backward error of λ as an approximate eigenvalue of P is given by

$$\eta(\lambda, \mathbf{P}) := \min\{\eta(\lambda, x, \mathbf{L}) : x \in \mathbb{C}^n \text{ and } \|x\|_2 = 1\}.$$

Since $\eta(\lambda, x, \mathbf{P}) = \|r\|/\|\Lambda_m\|_2$, it follows that for the spectral as well as for the Frobenius norms on $\mathbb{C}^{n \times n}$, we have $\eta(\lambda, \mathbf{P}) := \sigma_{\min}(\mathbf{P}(\lambda))/\|\Lambda_m\|_2$, where σ_{\min} denotes the minimum singular value. Similarly, we define structured backward error of an approximate eigenvalue λ of $\mathbf{P} \in \mathbb{S}$ by

$$\eta^{\mathbb{S}}(\lambda, \mathbf{P}) := \min\{\eta^{\mathbb{S}}(\lambda, x, \mathbf{P}) : x \in \mathbb{C}^n \text{ and } \|x\|_2 = 1\}.$$
(3.4)

Note that backward errors of approximate eigenvalues and pseudospectra of a polynomial are closely related. For $\epsilon > 0$, the unstructured ϵ -pseudospectrum of P, denoted by $\sigma_{\epsilon}(P)$, is given by [5]

$$\sigma_{\epsilon}(\mathbf{P}) = \bigcup_{\|| \triangle \mathbf{P} \|| \le \epsilon} \sigma(\mathbf{P} + \triangle \mathbf{P})$$

where $\sigma(\mathbf{P}) := \{\lambda \in \mathbb{C} : \det(\mathbf{P}(\lambda)) = 0\}$ is the spectrum of P. Obviously, we have $\sigma_{\epsilon}(\mathbf{P}) = \{z \in \mathbb{C} : \eta(z, \mathbf{P}) \le \epsilon\}$, assuming, for simplicity, that $\infty \notin \sigma_{\epsilon}(\mathbf{P})$.

Similarly, when $P \in S$, we define the structured ϵ -pseudospectrum of P, denoted by $\Lambda_{\epsilon}^{\mathbb{S}}(P)$, by

$$\sigma_{\epsilon}^{\mathbb{S}}(\mathbf{P}) := \bigcup_{\|| \Delta \mathbf{P} \|| \le \epsilon} \{ \Lambda(\mathbf{P} + \Delta \mathbf{P}) : \Delta \mathbf{P} \in \mathbb{S} \}.$$

Then it follows that $\sigma_{\epsilon}^{\mathbb{S}}(\mathbf{P}) = \{z \in \mathbb{C} : \eta^{\mathbb{S}}(\lambda, \mathbf{P}) \leq \epsilon\}$. For further details see [2].

Now we present a Table 3.1 that illustrates the following: for $P \in S$ there always exist certain approximate eigenvalues for which $\eta^{\mathbb{S}}(\lambda, P) \leq \alpha \eta(\lambda, P)$ for some $\alpha \in \mathbb{R}$.

The validity of the Table 3.1 is followed by (3.4), Theorem 3.2, Theorem 3.4, Theorem 3.6 and Theorem 3.8. Let $\mathbb{T} := \{z \in \mathbb{C} : |z| = 1\}$. Then we have the following result.

THEOREM 3.10. Let \mathbb{S} be the space of *H*-palindromic or *H*-antipalindromic matrix polynomials of degree *m* and $P \in \mathbb{S}$. Let $\lambda \in \mathbb{T}$. Then for the spectral and the Frobenius norms on $\mathbb{C}^{n \times n}$, we have $\eta^{\mathbb{S}}(\lambda, P) = \eta(\lambda, P)$ and hence $\sigma_{\epsilon}^{\mathbb{S}}(P) \cap \mathbb{T} = \sigma_{\epsilon}(P) \cap \mathbb{T}$.

Proof. First assume that $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$ be an *H*-palindromic polynomial. Let $\lambda \in \mathbb{T}$. We have $P(\lambda)^H = \overline{\lambda}^m P(\lambda)$. This shows that $P(\lambda)$ is a normal matrix. Let (μ, u) be an eigen-pair of $\overline{\lambda}^m P(\lambda)$ such that $|\mu| = \sigma_{\min}(\overline{\lambda}^m P(\lambda)) = \sigma_{\min}(P(\lambda))$. Define $\triangle A_j := -\frac{1}{2}\lambda^j \mu u u^H$ and consider the polynomial $\triangle P(z) = \sum_{j=0}^m z^j \triangle A_j$. Noting the

fact that $\overline{\lambda}^m P(\lambda)u = \mu u$ and $\overline{\mu}u = (\overline{\lambda}^m P(\lambda))^H u = \mu u$, we have $P(\lambda)u + \Delta P(\lambda)u =$ $\lambda^m \mu u - \lambda^m \mu u = 0$. Further, we have

$$\|\!|\!| \triangle \mathbf{P} \|\!|\!| = \frac{\sigma_{\min}(\mathbf{P}(\lambda))}{\|\Lambda_m\|_2} = \eta(\lambda, \mathbf{P}).$$

Hence the results follow. \Box

4. Comparison of backward error of eigen-pair of a polynomial and its structured linearization. The task of choosing a potential linearization is crucial for palindromic polynomials due to the fact that, an arbitrary linearization destroys the eigen-symmetry of the polynomial. In [24], Mackey et al. showed that, a *palindromic or *-anti-palindromic polynomial P can have both *-palindromic and *-anti-palindromic linearization $L \in L_1(P)$, for * = T/H that preserve the eigensymmetry of P. To be specific, for * = H there always exist a structured linearization and for * = T, it does only when either $1 \notin \sigma(P)$ or $-1 \notin \sigma(P)$.

Since a plenty of palindromic / anti-palindromic linearizations can be constructed for a given $P \in S$, it is necessary to detect those linearizations $L \in L_1(P)$ which will produce much more accurate eigenvalues. That is to say, they will provide the smallest structured backward error for an arbitrary approximate eigenpair, compared to other structured linearizations. Keeping this in mind we first derive the structured backward error of an approximate eigenpair of the possible variety of structured linearizations for a given $P \in S$. Then we compare it with the unstructured backward error of the corresponding eigenpair of the given polynomial, by using the following relation.

THEOREM 4.1. (Eigenvector recovery from pencils in $\mathbb{L}_1(\mathbf{P}), [21]$). Let $\mathbf{P} \in$ $\mathbb{P}_m(\mathbb{C}^{n \times n})$ be a regular matrix polynomial and let $L(\lambda) \in \mathbb{L}_1(\mathbb{P})$ with non-zero right ansatz vector v. Then $x \in \mathbb{C}^n$ is an eigenvector for P corresponding to the finite eigenvalue $\lambda \in \mathbb{C}$ if and only if $\Lambda_{m-1} \otimes x$ is an eigenvector for $L(\lambda)$ corresponding to the eigenvalue λ . In fact, every right eigenvector of L with finite eigenvalue λ is of the form $\Lambda_{m-1} \otimes x$ for some eigenvector x of P. Here $\Lambda_{m-1} = [\lambda^{m-1}, \lambda^{m-2}, \dots, \lambda, 1]^T$.

We use the following Lemma extensively to derive the results in this section.

LEMMA 4.2. Let $L \in L_1(P)$ be a linearization of a polynomial $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$, corresponding to the ansatz vector $v \in \mathbb{C}^m$. Then for any $(\lambda, x) \in \mathbb{C} \times \mathbb{C}^n$, we have the following

1. $\|\mathbf{L}(\lambda)(\Lambda_{m-1}\otimes x)\|_2 = \|v\|_2 \|\mathbf{P}(\lambda)x\|_2.$ 2. $|(\Lambda_{m-1}\otimes x)^T\mathbf{L}(\lambda)(\Lambda_{m-1}\otimes x)| = |\Lambda_{m-1}^Tv| |x^T\mathbf{P}(\lambda)x|.$ 3. $|(\Lambda_{m-1}\otimes x)^H\mathbf{L}(\lambda)(\Lambda_{m-1}\otimes x)| = |\Lambda_{m-1}^Hv| |x^H\mathbf{P}(\lambda)x|.$

Proof. Assume that $L \in L_1(P)$ is a linearization associated to the ansatz vector $v \in \mathbb{C}^m$ of the given polynomial P. Then we have $L(\lambda)(\Lambda_{m-1} \otimes I_n) = v \otimes P(\lambda)$. Postmultiplying both sides by $(1 \otimes x)$ and then applying norm both sides we obtain

$$L(\lambda)(\Lambda_{m-1} \otimes I_n)(1 \otimes x) = (v \otimes P(\lambda))(1 \otimes x)$$

$$\Rightarrow L(\lambda)(\Lambda_{m-1} \otimes x) = v \otimes P(\lambda)x$$

$$\Rightarrow \|L(\lambda)(\Lambda_{m-1} \otimes x)\|_2 = \|v \otimes P(\lambda)x\|_2 = \|v\|_2 \|P(\lambda)x\|_2$$

This proves 1.

Further, by theorem 4.1 we know that if $x \in \mathbb{C}^n$ is a right eigenvector of P corresponding to the eigenvalue λ if and only if $\Lambda_{m-1} \otimes x$ is a right eigenvector of L corresponding to the eigenvalue λ . Therefore we have

$$(\Lambda_{m-1} \otimes x)^T \mathcal{L}(\lambda)(\Lambda_{m-1} \otimes x) = (\Lambda_{m-1} \otimes x)^T (v \otimes \mathcal{P}(\lambda)x)$$
$$= (\Lambda_{m-1}^T \otimes x^T)(v \otimes \mathcal{P}(\lambda)x)$$
$$= \Lambda_{m-1}^T v \otimes x^T \mathcal{P}(\lambda)x = \Lambda_{m-1}^T v \cdot x^T \mathcal{P}(\lambda)x.$$

Now taking modulus in both sides we obtain the desired result 2. In a similar fashion 3 can be proved. \square

It is straightforward to see that

$$\frac{1}{\sqrt{2}} \le \frac{\|\Lambda_m\|_2}{\|\Lambda_{m-1}\|_2 \|(1,\lambda)\|_2} \le 1.$$
(4.1)

Without loss of generality we assume the ansatz vector $v \in \mathbb{C}^m$ is of unit norm, that is, $||v||_2 = 1$. Assuming (λ, x) is an approximate eigen-pair of P we have the following Theorem.

THEOREM 4.3. Let $P \in \mathbb{P}_m(\mathbb{C}^{n \times n})$ be a regular matrix polynomial and $L \in \mathbb{L}_1(P)$ be a linearization of P corresponding to the unit right ansatz vector $v \in \mathbb{C}^m$. Assume that (λ, x) is an approximate eigenpair of P. Then we have

$$\frac{1}{\sqrt{2}} \le \frac{\eta(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}; v)}{\eta(\lambda, x, \mathbf{P})} \le 1$$

where $\eta(\lambda, \Lambda_{m-1} \otimes x; L; v)$ denotes the backward error of $(\lambda, \Lambda_{m-1} \otimes x)$ as an approximate eigenpair of L.

Proof. By (3.2) and Lemma 4.2, we have

$$\eta(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}; v) = \frac{\|\mathbf{L}(\lambda)(\Lambda_{m-1} \otimes x)\|_{2}}{\|(\Lambda_{m-1} \otimes x)\|_{2} \|(\lambda, 1)\|_{2}} = \frac{\|v\|_{2} \|\mathbf{P}(\lambda)x\|_{2}}{\|(\Lambda_{m-1} \otimes x)\|_{2} \|(\lambda, 1)\|_{2}}$$
$$= \frac{\|v\|_{2} \|\Lambda_{m}\|_{2} \|x\|_{2}}{\|(\Lambda_{m-1} \otimes x)\|_{2} \|(\lambda, 1)\|_{2}} \eta(\lambda, x, \mathbf{P})$$
$$= \frac{\|\Lambda_{m}\|_{2}}{\|\Lambda_{m-1}\|_{2} \|(\lambda, 1)\|_{2}} \eta(\lambda, x, \mathbf{P}).$$

Using (4.1) we obtain the desired result.

Now we present the Table 4.1 which describes the possible structured linearizations corresponding to structured ansatz vectors of a given polynomial P, as given in [24].

Assume that L is a structured linearization corresponding to an ansatz vector v of a given $P \in S$. Then for an approximate eigenvalue $\lambda \in \mathbb{C}$ of P we know that

 $\eta(\lambda, x, \mathbf{P}) \leq \eta^{\mathbb{S}}(\lambda, x, \mathbf{P})$ for both Frobenius and spectral norms. Hence for the structured linearization L we have $\eta(\lambda, \Lambda_{m-1} \otimes x, \mathbf{L}; v) \leq \eta^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x, \mathbf{L}; v)$, where the ansatz vector v is of the form as described in the Table 4.1 for different structures. Hence we have the following Lemma.

LEMMA 4.4. Let $P \in S$. Suppose L is a structured linearization of P corresponding to the ansatz vector v. Then for both Frobenius and spectral norms we have

$$\frac{\eta^{\mathbb{S}}(\lambda, \mathbf{L}; v)}{\eta(\lambda, x, \mathbf{P})} \ge \frac{1}{\sqrt{2}}.$$

Proof. By Theorem 4.3 we have $\kappa(\lambda, L; v) \geq \frac{1}{\sqrt{2}}\eta(\lambda, x, P)$. Therefore we obtain

$$\frac{\kappa^{\mathbb{S}}(\lambda,\mathbf{L};v)}{\kappa(\lambda,x,\mathbf{P})} \geq \frac{\eta(\lambda,\mathbf{L};v)}{\kappa(\lambda,x,\mathbf{P})} \geq \frac{1}{\sqrt{2}}.$$

Now we attempt to identify the optimal linearizations for a given $P \in S$. First consider *T*-palindromic / *T*-anti-palindromic polynomials.

THEOREM 4.5. Let S be the space of T-palindromic matrix polynomials. Assume that $P \in S$. Suppose $L_{pal} \in L_1(P)$ and $L_{apal} \in L_1(P)$ are the T-palindromic linearization and T-anti-palindromic linearization of P corresponding to the ansatz Rv = v and Rv = -v respectively, with respect to the ansatz vector v. If (λ, x) is an approximate right eigenpair of P then we have • $\| \cdot \| \equiv \| \cdot \|_F$:

Proof. Assume that L_{pal} is a *T*-palindromic linearization of $P \in S$ corresponding to the ansatz vector $v \in \mathbb{C}^m$. Assume that $re(\lambda) \geq 0$. Then by Theorem 3.2 and Lemma 4.2 we have

$$\eta_{F}^{\mathbb{S}}(\lambda, x, \mathcal{L}_{pal}; v) = \sqrt{2} \frac{\sqrt{\frac{\|\mathcal{L}_{pal}(\lambda)(\Lambda_{m-1}\otimes x)\|_{2}^{2}}{\|(\Lambda_{m-1}\otimes x)\|_{2}^{2}} - 2\frac{\mathsf{re}(\lambda)}{|1+\lambda|^{2}} \frac{|(\Lambda_{m-1}\otimes x)^{T}\mathcal{L}_{pal}(\lambda)(\Lambda_{m-1}\otimes x)|^{2}}{\|(\Lambda_{m-1}\otimes x)\|_{2}^{4}}}{\|(1, \lambda)\|_{2}} = \sqrt{2} \frac{\sqrt{\|\mathcal{P}(\lambda)x\|_{2}^{2} - 2\frac{\mathsf{re}(\lambda)}{|1+\lambda|^{2}} \frac{|\Lambda_{m-1}^{T}v|^{2}}{\|\Lambda_{m-1}\|_{2}^{2}}} |x^{T}\mathcal{P}(\lambda)x|^{2}}{\|(1, \lambda)\|_{2} \|\Lambda_{m-1}\|_{2}}} \leq \frac{\sqrt{2}\|\Lambda_{m}\|_{2}}{\|(\lambda, 1)\|_{2} \|\Lambda_{m-1}\|_{2}} \eta(\lambda, x, \mathcal{P})}$$

Now since $|x^T P(\lambda)x| \leq ||P(\lambda)x||$ we obtain the desired result by (4.1). Further if $|\lambda| > 1$ then by Theorem 3.2 we have

$$\begin{split} \eta_{2}^{\mathbb{S}}(\lambda, x, \mathcal{L}_{pal}; v) &\leq \sqrt{2} \sqrt{\frac{|(\Lambda_{m-1} \otimes x)^{T} \mathcal{L}_{pal}(\lambda)(\Lambda_{m-1} \otimes x)|^{2}}{|1+\lambda|^{2} ||(\Lambda_{m-1} \otimes x)||^{2}} + \frac{|\lambda|^{2} ||\mathcal{L}_{pal}(\lambda)(\Lambda_{m-1} \otimes x)||^{2}_{2}}{||(\Lambda_{m-1} \otimes x)||^{2}_{2} ||(1,\lambda)||^{4}_{2}} \\ &= \sqrt{2} \sqrt{\frac{|\Lambda_{m-1}^{T} v|^{2} |x^{T} \mathcal{P}(\lambda) x|^{2}}{|1+\lambda|^{2} ||\Lambda_{m-1}||^{2}_{2}} + \frac{|\lambda|^{2} ||r||^{2}_{2}}{||\Lambda_{m-1}||^{2} ||(1,\lambda)||^{4}_{2}}} \\ &\leq \frac{\sqrt{2} ||r||_{2}}{||\Lambda_{m-1}||_{2} ||(1,\lambda)||_{2}} \sqrt{\frac{|\Lambda_{m-1}^{T} v|^{2}}{|1+\lambda|^{2} ||\Lambda_{m-1}||^{2}_{2}}} + \frac{|\lambda|^{2}}{||(1,\lambda)||^{2}_{2}}} \\ &\leq \sqrt{2} \sqrt{\frac{|\Lambda_{m-1}^{T} v|^{2}}{|1+\lambda|^{2} ||\Lambda_{m-1}||^{2}_{2}}} + \frac{|\lambda|^{2}}{||(1,\lambda)||^{2}_{2}}} \eta(\lambda, x, \mathcal{P})} \\ &\leq \sqrt{2} \sqrt{1 + \frac{|\Lambda_{m-1}^{T} v|^{2}}{|1+\lambda|^{2} ||\Lambda_{m-1}||^{2}_{2}}} \eta(\lambda, x, \mathcal{P}). \end{split}$$

Similarly for $|\lambda| \leq 1, \lambda \neq -1$ we obtain

$$\eta_2^{\mathbb{S}}(\lambda, x, \mathcal{L}_{pal}; v) \le \sqrt{2} \sqrt{\frac{|\Lambda_{m-1}^T v|^2}{|1+\lambda|^2 ||\Lambda_{m-1}||_2^2} + \frac{1}{||(1,\lambda)||_2^2}} \ \eta(\lambda, x, \mathcal{P}) \le \sqrt{2} \sqrt{1 + \frac{|\Lambda_{m-1}^T v|^2}{|1+\lambda|^2 ||\Lambda_{m-1}||_2^2}} \ \eta(\lambda, x, \mathcal{P}).$$

Next consider L_{apal} is a *T*-anti-palindromic linearization of $P \in S$. Assume that $re(\lambda) \leq 0$. Then by Theorem 3.2 we have

$$\eta_F^{\mathbb{S}}(\lambda, x, \mathcal{L}_{apal}; v) = \sqrt{2} \ \frac{\sqrt{\|\mathcal{P}(\lambda)x\|_2^2 + 2\frac{\mathsf{re}(\lambda)}{|1-\lambda|^2} \frac{|\Lambda_{m-1}^T v|^2}{\|\Lambda_{m-1}\|_2^2} |x^T \mathcal{P}(\lambda)x|^2}}{\|(1, \lambda)\|_2 \|\Lambda_{m-1}\|_2}$$

We obtain the desired result similarly as that is obtained for T-palindromic linearization. Furthermore for the spectral norm we obtain the following in a similar fashion as described for T-palindromic linearization. If $|\lambda| > 1$ then

$$\begin{split} \eta_{2}^{\mathbb{S}}(\lambda, x, \mathcal{L}_{apal}; v) &\leq \sqrt{2} \sqrt{\frac{|\Lambda_{m-1}^{T}v|^{2}}{|1-\lambda|^{2}\|\Lambda_{m-1}\|_{2}^{2}} + \frac{|\lambda|^{2}}{\|(1, \lambda)\|_{2}^{2}}} \eta(\lambda, x, \mathcal{P}) \\ &\leq \sqrt{2} \sqrt{1 + \frac{|\Lambda_{m-1}^{T}v|^{2}}{|1-\lambda|^{2}\|\Lambda_{m-1}\|_{2}^{2}}} \eta(\lambda, x, \mathcal{P}). \end{split}$$

If $|\lambda| \leq 1, \lambda \neq 1$ then

$$\eta_{2}^{\mathbb{S}}(\lambda, x, \mathcal{L}_{apal}; v) \leq \sqrt{2} \sqrt{\frac{|\Lambda_{m-1}^{T}v|^{2}}{|1-\lambda|^{2}\|\Lambda_{m-1}\|_{2}^{2}} + \frac{1}{\|(1, \lambda)\|_{2}^{2}}} \eta(\lambda, x, \mathcal{P})$$
$$\leq \sqrt{2} \sqrt{1 + \frac{|\Lambda_{m-1}^{T}v|^{2}}{|1-\lambda|^{2}\|\Lambda_{m-1}\|_{2}^{2}}} \eta(\lambda, x, \mathcal{P}).$$

Hence the result follows. \square

We mention that the same bounds can be achieved by considering $P \in S$ when S is the space of *T*-anti-palindromic polynomials, L_{pal} is the *T*-palindromic linearization corresponding to the ansatzvector Rv = -v and L_{apal} is the *T*-anti-palindromic linearization corresponding to the ansatzvector Rv = v.

The morale of the Theorem 4.5 is as follows. For $\|\|\cdot\|\| = \|\|\cdot\|\|_F$, choose *T*-palindromic linearization when $\operatorname{re}(\lambda) \ge 0$ and for $\operatorname{re}(\lambda) \le 0$ pick *T*-anti-palindromic linearization. Further notice that $|1 - \lambda| \le |1 + \lambda|$ if $\operatorname{re}(\lambda) \ge 0$ and $|1 + \lambda| \le |1 - \lambda|$ when $\operatorname{re}(\lambda) \le 0$. Therefore the bounds obtained in Theorem 4.5 for $\|\|\cdot\|\| = \|\|\cdot\|\|_2$, advise the same conclusion as that for the Frobenius norm.

Moreover its evident that each linearization for a given polynomial $P \in S$ is sensitive to perturbations in its own way. For computational purposes, it is highly desirable to identify linearizations which are as well-conditioned as the matrix polynomial itself. In a view to minimizing the structured condition number of a simple eigenvalue of a polynomial $P \in S$, a list of optimal structured linearizations is provided in [4]. We see that our choice of structured linearizations is compatible with that given in [4].

Now we consider *H*-palindromic / *H*-anti-palindromic polynomials.

THEOREM 4.6. Let S be the space of H-palindromic matrix polynomials. Assume that $P \in S$. Suppose $L \in L_1(P)$ is the H-palindromic linearization or H-antipalindromic linearization of P with respect to the ansatz vector $Rv = \overline{v}$ or $Rv = -\overline{v}$ respectively. If (λ, x) is an approximate right eigenpair of P then we have the following: if $|\lambda| = 1$ we have

$$\frac{\sqrt{2 - \frac{|\Lambda_{m-1}^H v|^2}{\|\Lambda_{m-1}\|_2^2}}}{\sqrt{2}} \le \frac{\eta_F^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v)}{\eta(\lambda, x, \mathbf{P})} \le \sqrt{2}, \quad \frac{1}{\sqrt{2}} \le \frac{\eta_2^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v)}{\eta(\lambda, x, \mathbf{P})} \le 1.$$

Next assume that $|\lambda| \neq 1$. Then we have

$$\begin{split} \frac{\eta_F^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v)}{\eta(\lambda, x, \mathbf{P})} &\leq \sqrt{2} \sqrt{1 + \frac{\|\widehat{r}\|_2^2}{\|r\|_2^2}} \\ \frac{\eta_2^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v)}{\eta(\lambda, x, \mathbf{P})} &\leq \begin{cases} \sqrt{2} \sqrt{\frac{\|\widehat{r}\|_2^2}{\|r\|_2^2} + \frac{1}{\|(1, \lambda^{-1})\|_2^2}}, & \text{if } |\lambda| > 1 \\ \sqrt{2} \sqrt{\frac{\|\widehat{r}\|_2^2}{\|r\|_2^2} + \frac{1}{\|(1, \lambda)\|_2^2}}, & \text{if } |\lambda| < 1, \end{cases} \end{split}$$

where $\hat{r} := \hat{r}_p = \begin{bmatrix} 1 + \operatorname{re}(\lambda) & \operatorname{im}(\lambda) \\ \operatorname{im}(\lambda) & 1 - \operatorname{re}(\lambda) \end{bmatrix}^{\dagger} \begin{bmatrix} \operatorname{re}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda) x) \\ \operatorname{im}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda) x) \end{bmatrix}$ for *H*-palindromic linearization and $\hat{r} := \hat{r}_{ap} = \begin{bmatrix} 1 - \operatorname{re}(\lambda) & -\operatorname{im}(\lambda) \\ -\operatorname{im}(\lambda) & 1 + \operatorname{re}(\lambda) \end{bmatrix}^{\dagger} \begin{bmatrix} \operatorname{re}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda) x) \\ \operatorname{im}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda) x) \end{bmatrix}$ for *H*-anti-palindromic linearization.

Proof. Assume that L is an H-palindromic or H-anti-palindromic linearization of $P \in S$ corresponding to some ansatz vector $v \in \mathbb{C}^m$. If $|\lambda| = 1$, by Theorem 3.6 and Theorem 3.8 we have the following for $\|\cdot\| = \|\cdot\|_F$:

$$\eta_F^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v) = \frac{1}{\|(1, \lambda)\|_2 \|\Lambda_{m-1}\|_2} \sqrt{2 \|\mathbf{P}(\lambda)x\|_2^2 - \frac{|\Lambda_{m-1}^H v|^2 |x^H \mathbf{P}(\lambda)x|^2}{\|\Lambda_{m-1}\|_2^2}}.$$

Hence by (4.1) we have

$$\frac{\sqrt{2 - \frac{\|\Lambda_{m-1}^H v\|^2}{\|\Lambda_{m-1}\|_2^2}}}{\sqrt{2}} \le \frac{\eta_F^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v)}{\eta(\lambda, x, \mathbf{P})} \le \sqrt{2}.$$

Similarly, for the spectral norm we have $\frac{1}{\sqrt{2}} \leq \frac{\eta_2^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v)}{\eta(\lambda, x, \mathbf{P})} \leq 1.$ Next consider $|\lambda| \neq 1$. Then by Theorem 3.6 and Theorem 3.8, we have the

following for $\|\cdot\| = \|\cdot\|_F$:

$$\eta_{F}^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v) = \sqrt{2} \sqrt{\frac{\|\widehat{r}\|_{2}^{2}}{\|\Lambda_{m-1}\|_{2}^{4}} + \frac{\frac{\|\mathbf{P}(\lambda)x\|_{2}^{2}}{\|\Lambda_{m-1}\|_{2}^{2}} - \frac{|\Lambda_{m-1}^{H}v|^{2}}{\|\Lambda_{m-1}\|_{2}^{4}} |x^{H}\mathbf{P}(\lambda)x|^{2}}{\|(1, \lambda)\|_{2}^{2}}}$$

$$\leq \frac{\sqrt{2}}{\|\Lambda_{m-1}\|_{2}} \sqrt{\frac{\|\widehat{r}\|_{2}^{2}}{\|\Lambda_{m-1}\|_{2}^{2}} + \frac{\|r\|_{2}^{2}}{\|(1, \lambda)\|_{2}^{2}}},$$

$$\leq \frac{\sqrt{2} \|r\|_{2}}{\|\Lambda_{m-1}\|_{2} \|(1, \lambda)\|_{2}} \sqrt{1 + \frac{\|\widehat{r}\|_{2}^{2}}{\|r\|_{2}^{2}}}, \text{ since } \|(1, \lambda)\|_{2} \leq \|\Lambda_{m-1}\|_{2}$$

$$\leq \sqrt{2} \sqrt{1 + \frac{\|\widehat{r}\|_{2}^{2}}{\|r\|_{2}^{2}}} \eta(\lambda, x, \mathbf{P}).$$

Next, for $\|\cdot\| = \|\cdot\|_2$ we have the following by Theorem 3.6 and Theorem 3.8. If $|\lambda| > 1$ we have

$$\eta_{2}^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v) = \sqrt{2} \sqrt{\frac{\|\widehat{r}\|_{2}^{2}}{\|\Lambda_{m-1}\|_{2}^{4}} + \frac{|\lambda|^{2} \|r\|_{2}^{2}}{\|\Lambda_{m-1}\|_{2}^{2} \|(1, \lambda)\|_{2}^{4}}} \\ \leq \frac{\sqrt{2} \|r\|_{2}}{\|\Lambda_{m-1}\|_{2} \|(1, \lambda)\|_{2}^{2}} \sqrt{\frac{\|\widehat{r}\|_{2}^{2}}{\|r\|_{2}^{2}} + \frac{|\lambda|^{2}}{\|(1, \lambda)\|_{2}^{2}}} \\ \leq \sqrt{2} \sqrt{\frac{\|\widehat{r}\|_{2}^{2}}{\|r\|_{2}^{2}} + \frac{|\lambda|^{2}}{\|(1, \lambda)\|_{2}^{2}}} \eta(\lambda, x, \mathbf{P}).$$

Similarly, if $|\lambda| < 1$, we have

$$\eta_2^{\mathbb{S}}(\lambda, \Lambda_{m-1} \otimes x; \mathbf{L}, v) \le \sqrt{2} \sqrt{\frac{\|\widehat{r}\|_2^2}{\|r\|_2^2} + \frac{1}{\|(1,\lambda)\|_2^2}} \eta(\lambda, x, \mathbf{P})$$

where $\hat{r} := \hat{r}_p = \begin{bmatrix} 1 + \operatorname{re}(\lambda) & \operatorname{im}(\lambda) \\ \operatorname{im}(\lambda) & 1 - \operatorname{re}(\lambda) \end{bmatrix}^{\dagger} \begin{bmatrix} \operatorname{re}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda)x) \\ \operatorname{im}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda)x) \end{bmatrix}$ for *H*-palindromic linearization and $\hat{r} := \hat{r}_{ap} = \begin{bmatrix} 1 - \operatorname{re}(\lambda) & -\operatorname{im}(\lambda) \\ -\operatorname{im}(\lambda) & 1 + \operatorname{re}(\lambda) \end{bmatrix}^{\dagger} \begin{bmatrix} \operatorname{re}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda)x) \\ \operatorname{im}(\Lambda_{m-1}^H v \, x^H \mathbf{P}(\lambda)x) \end{bmatrix}$ for *H*-anti-palindromic linearization. Hence the desired results follow. \square

We mention that the same bounds can be achieved by considering $P \in S$ when S is the space of *H*-anti-palindromic polynomials, L is the *H*-palindromic linearization corresponding to the ansatzvector $Rv = -\overline{v}$ or L is the *H*-anti-palindromic linearization corresponding to the ansatzvector $Rv = \overline{v}$.

The morale of the Theorem 4.6 goes as follows. For $|\lambda| = 1$, it does not really make any difference for the choice of *H*-palindromic or *H*-anti-palindromic linearization of a given $P \in S$. In contrast, for $|\lambda| \neq 1$ two cases arise. If $\|\hat{r}_p\|_2 \leq \|\hat{r}_{ap}\|_2$ then it is advisable to choose *H*-palindromic linearization and pick *H*-anti-palindromic linearization otherwise.
