

# Local times for solutions of the complex Ginzburg–Landau equation and the inviscid limit

## Abstract

We consider the behaviour of the distribution for stationary solutions of the complex Ginzburg–Landau equation perturbed by a random force. It was proved in [KS04] that if the random force is proportional to the square root of the viscosity  $\nu > 0$ , then the family of stationary measures possesses an accumulation point as  $\nu \rightarrow 0^+$ . We show that if  $\mu$  is such point, then the distributions of the  $L^2$  norm and of the energy possess a density with respect to the Lebesgue measure. The proofs are based on Itô’s formula and some properties of local time for semimartingales.

## 1 Introduction

Let  $D \subset \mathbb{R}^d$  be a bounded domain with a smooth boundary  $\partial D$ . In what follows, we always assume that  $d \leq 4$ . Consider the complex Ginzburg–Landau equation in  $D$  perturbed by a white noise force smooth in the space variables:

$$\dot{u} - (\nu + i)\Delta u + i\lambda|u|^2u = \sqrt{\nu}\eta(t, x), \quad (1.1)$$

$$u|_{\partial D} = 0. \quad (1.2)$$

Here  $\nu \in (0, 1]$  and  $\lambda > 0$  are some parameters,  $u = u(t, x)$  is a complex-valued unknown function, and  $\eta$  is a random process of the form

$$\eta(t, x) = \frac{\partial}{\partial t}\zeta(t, x), \quad \zeta(t, x) = \sum_{j=1}^{\infty} b_j\beta_j(t)e_j(x), \quad (1.3)$$

where  $\{\beta_j = \beta_j^+ + i\beta_j^-\}$  is a sequence of independent complex-valued Brownian motions,  $\{e_j\}$  is a complete set of normalised eigenfunctions of the Dirichlet Laplacian with eigenvalues  $\alpha_1 < \alpha_2 \leq \alpha_3 \leq \dots$ , and  $b_j \geq 0$  are some constants

going to zero sufficiently fast. Let  $\{\mu_\nu\}$  be a family of stationary measures<sup>1</sup> for the Markov process associated with problem (1.1), (1.2). It was proved in [KS04] that for any sequence  $\hat{\nu}_k \rightarrow 0^+$  the family  $\{\mu_{\hat{\nu}_k}\}$  has at least one accumulation point in the sense of weak convergence of measures on  $L^2(D)$ , and any limiting point  $\mu$  for the family  $\{\mu_\nu\}$  satisfies the relations

$$\mu(H^2) = 1, \quad (1.4)$$

$$\int_{L^2} \|\nabla v\|^2 \mu(dv) = C_1, \quad (1.5)$$

$$\int_{L^2} (\|v\|_{H^2}^2 + \|v\|_{L^4}^4) \mu(dv) \leq C_2, \quad (1.6)$$

where  $C_1$  and  $C_2$  are some constants depending on  $D$  and  $\{b_j\}$ . Moreover, the measure  $\mu$  is the law of a stationary process  $v(t, x)$  whose almost every realisation belongs to the space  $L_{\text{loc}}(\mathbb{R}_+, H^2) \cap W_{\text{loc}}^{1, \frac{4}{3}}(\mathbb{R}_+, L^{\frac{4}{3}})$  and satisfies the nonlinear Schrödinger equation (NLS) obtained from (1.1) by setting  $\nu = 0$ . Let us note that, in view of relation (1.5) and the fact that the only steady state for NLS is the trivial zero solution, the support of  $\mu$  contains infinitely many points. In the case of the 2D Navier–Stokes equations, it was proved by Kuksin [Kuk08] that if the random perturbation is non-degenerate, then the energy and enstrophy of such an inviscid limit have a density with respect to the Lebesgue measure. The present paper is devoted to the proof of similar results for (1.1), (1.2). In particular, we establish the following theorem.

**Main Theorem.** *Under the above hypotheses, the following assertions hold for any family of stationary measures  $\{\mu_\nu\}$  and its limiting points  $\mu$  in the sense of weak convergence.*

- *If  $b_j \neq 0$  for some  $j \geq 1$ , then the projection of  $\mu_\nu$  to the one-dimensional subspace spanned by the  $j^{\text{th}}$  eigenfunction of the Dirichlet Laplacian has a bounded density with respect to the Lebesgue measure. Moreover, the limiting measures  $\mu$  have no atom at  $u = 0$ .*
- *If  $b_j \neq 0$  for all  $j \geq 1$ , then the laws of the functionals*

$$\mathcal{H}_0(u) = \frac{1}{2} \|u\|^2 = \frac{1}{2} \int_D |u(x)|^2 dx,$$

$$\mathcal{H}_1(u) = \int_D \left( \frac{1}{2} |\nabla u(x)|^2 + \frac{\lambda}{4} |u(x)|^4 \right) dx$$

*under the probability distribution  $\mu$  on  $L^2$  possess a density with respect to the Lebesgue measure on the real line.*

We refer the reader to Section 3.1 for a more detailed statement of the results and to Sections 3.2 and 3.3 for the proofs. Note that the second assertion of

the theorem was announced in Kuksin’s paper [KS04]. His proof for the case of the Navier–Stokes equations was based on a construction of an auxiliary stationary process satisfying a  $\nu$ -independent equation and an application of Krylov’s estimate for semimartingales. Here we take a different approach using some properties of local times for the functionals in question. This enables one to simplify the proof and to get somewhat sharper estimates. The drawback of this approach is that it does not allow consideration of vector-valued functionals of solutions.

In conclusion, let us mention that an alternative approach for constructing invariant measures for the Schrödinger equation with defocusing cubic nonlinearity was suggested by Tzvetkov [Tzv08]. His argument inspired by [LRS88] is based on considering renormalized Gibbs measures for finite-dimensional approximations and passing to the limit as the dimension goes to infinity. He proves that the resulting distribution is a non-degenerate Gaussian measure concentrated on radial functions of low regularity.

### Notation

In what follows, we denote by  $D$  a bounded domain with smooth boundary, by  $\mathbb{R}$  the real axis, and by  $\mathbb{Z}_*$  the set of nonzero integers. We always assume that Polish spaces are endowed with their Borel  $\sigma$ -algebra and write  $\ell$  for the Lebesgue measure on  $\mathbb{R}$ . Given any set  $A$ , we denote by  $\mathbb{I}_A$  its indicator function. We shall use the following functional spaces.

$L^q = L^q(D)$  stands for the space of complex-valued measurable functions  $u(x)$  such that

$$\|u\|_{L^q} = \left( \int_D |u(x)|^q dx \right)^{1/q} < \infty.$$

We regard  $L^2$  as a real Hilbert space with the scalar product

$$(u, v) = \operatorname{Re} \int_D u(x) \overline{v(x)} dx$$

and denote by  $\|\cdot\|$  the corresponding norm.

$H^s = H^s(D)$  denotes the Sobolev space of order  $s$  endowed with the usual norm  $\|\cdot\|_s$ .

$\{e_j, j \geq 1\}$  stands for the complete set of normalised eigenfunctions of the Dirichlet Laplacian. We denote  $e_{-j} = ie_j$  for  $j \leq -1$ , so that  $\{e_j, j \in \mathbb{Z}_*\}$  is an orthonormal basis in  $L^2$ .

## 2 Preliminaries

### 2.1 Stationary measures and a priori estimates

In this subsection, we have collected some known facts about the existence of stationary solutions for problem (1.1), (1.2) and a priori estimates for them. We shall assume that the coefficients  $b_j \geq 0$  entering (1.3) satisfy the inequalities<sup>2</sup>

$$B_0 = \sum_{j=1}^{\infty} b_j^2 < \infty, \quad B_1 = \sum_{j=1}^{\infty} \alpha_j b_j^2 < \infty, \quad M = \sup_{x \in D} \sum_{j=1}^{\infty} b_j^2 e_j^2(x) < \infty. \quad (2.1)$$

In this case, it was proved in [KS04] that the Cauchy problem (1.1), (1.2) is well posed in the space  $H_0^1$ , and the corresponding Markov family has at least one stationary distribution for any  $\nu > 0$ . The results listed in the following proposition are either established in the papers [KS04, Oda06, Shi06] or can be proved with the help of the methods used there.

**Proposition 2.1.** *Under the above hypotheses, for any stationary solution  $u(t)$  of (1.1), (1.2) the random processes  $\mathcal{H}_0(u)$  and  $\mathcal{H}_1(u)$  are semimartingales and can be represented in the form*

$$\mathcal{H}_0(u(t)) = \mathcal{H}_0(u(0)) + \nu \int_0^t (B_0 - \|\nabla u(t)\|^2) ds + \sqrt{\nu} \sum_{j \in \mathbb{Z}_*} b_j \int_0^t u_j dw_j, \quad (2.2)$$

$$\begin{aligned} \mathcal{H}_1(u(t)) = & \mathcal{H}_1(u(0)) + \nu \int_0^t \left( B_1 - \|\Delta u\|^2 - 2\lambda(|u|^2, |\nabla u|^2) - \lambda(u^2, (\nabla u)^2) \right. \\ & \left. + 2\lambda \sum_{j=1}^{\infty} b_j^2 (|u|^2, e_j^2) \right) ds + \sqrt{\nu} \sum_{j \in \mathbb{Z}_*} \int_0^t b_j (-\Delta u + \lambda|u|^2 u, e_j) dw_j, \end{aligned} \quad (2.3)$$

where we set  $b_{-j} = b_j$  for  $j \geq 1$ ,  $u_j = (u, e_j)$ , and  $w_j = \beta_j^{\pm}$  for  $\pm j \geq 1$ . Moreover, there is a constant  $C > 0$  not depending  $\nu$  such that

$$\mathbb{E} \|\nabla u\|^2 = B_0, \quad (2.4)$$

$$\mathbb{E} (\|u\|_{L^6}^3 + (|u|^2, |\nabla u|^2) + \|u\|_2^2) \leq C(B_1 + MB_0), \quad (2.5)$$

### 2.2 Local time for semimartingales

Let  $(\Omega, \mathcal{F}, \mathbb{P})$  be a complete probability space with a right-continuous filtration  $\{\mathcal{F}_t, t \geq 0\}$  augmented with respect to  $(\mathcal{F}, \mathbb{P})$ , let  $\{\beta_j\}$  be a sequence of independent Brownian motions with respect to  $\mathcal{F}_t$ , and let  $y_t$  be a scalar semimartingale of the form

$$y_t = y_0 + \int_0^t x_s ds + \sum_{j=1}^{\infty} \int_0^t \theta_s^j d\beta_j, \quad (2.6)$$

where  $x_t$  and  $\theta_t^j$  are  $\mathcal{F}_t$ -adapted processes such that

$$\mathbb{E} \int_0^t \left( x_s^2 + \sum_{j=1}^{\infty} |\theta_s^j|^2 \right) ds < \infty \quad \text{for any } t > 0.$$

The following result is a straightforward consequence of Theorem 7.1 in [KS91, Chapter 3].

**Theorem 2.2.** *Under the above hypotheses, then the random field*

$$\Lambda_t(a, \omega) = |y_t - a| - |y_0 - a| - \sum_{j=1}^{\infty} \int_0^t \mathbb{I}_{(a, \infty)}(y_s) \theta_s^j d\beta_j - \int_0^t \mathbb{I}_{(a, \infty)}(y_s) x_s ds \quad (2.7)$$

defined for  $t \geq 0$  and  $a \in \mathbb{R}$  possesses the following properties hold.

- (i) *The mapping  $(t, a, \omega) \mapsto \Lambda_t(a, \omega)$  is measurable, and for any  $a \in \mathbb{R}$  the process  $t \mapsto \Lambda_t(a, \omega)$  is  $\mathcal{F}_t$ -adapted, continuous and non-decreasing. Moreover, for every  $t \geq 0$  and almost every  $\omega \in \Omega$  the function  $a \mapsto \Lambda_t(a, \omega)$  is right-continuous.*
- (ii) *For any non-negative Borel-measurable function  $h : \mathbb{R} \rightarrow \mathbb{R}$ , with probability 1 we have*

$$2 \int_{-\infty}^{\infty} h(a) \Lambda_t(a, \omega) da = \sum_{j=1}^{\infty} \int_0^t h(y_s) |\theta_s^j|^2 ds, \quad t \geq 0. \quad (2.8)$$

The random field  $\Lambda_t(a, \omega)$  is called a *local time* for  $y_t$ , and (2.7) is usually referred to as the *change of variable formula*.

## 3 Main results

### 3.1 Formulation

The following theorem, which is the main result of this paper, describes some qualitative properties of stationary measures for (1.1).

**Theorem 3.1.** *Assume that the coefficients  $b_j$  entering the definition of the random process  $\zeta$  satisfy inequalities (2.1). Then the following assertions hold for any stationary measure  $\mu_\nu$  of problem (1.1), (1.2) with  $\nu > 0$ .*

- (i) *Let  $b_k \neq 0$  for some  $k \geq 1$  and let  $v \in L^2$  be a function non-orthogonal to  $e_j$ . Then the projection of  $\mu_\nu$  to the vector space spanned by  $v$  has a bounded density with respect to the Lebesgue measure. In particular,  $\mu_\nu$  has no atoms for  $\nu > 0$ .*
- (ii) *Let  $b_k \neq 0$  for some  $k \geq 1$ . Then there is constant  $C > 0$  not depending on the sequence  $\{b_j\}$  and the parameter  $\nu > 0$  such that*

$$\mu_\nu(\{u \in L^2 : \|u\|_{L^2} \leq \delta\}) \leq CB_0^{-1} \sqrt{B_1 + MB_0} \delta \quad \text{for any } \delta \geq 0. \quad (3.1)$$

(iii) Let  $b_j \neq 0$  for all  $j \geq 1$ . Then there is a continuous increasing function  $p(r)$  going to zero with  $r$  such that

$$\mu_\nu(\{u \in L^2 : \mathcal{H}_0(u) \in \Gamma\}) + \mu_\nu(\{u \in L^2 : \mathcal{H}_1(u) \in \Gamma\}) \leq p(\ell(\Gamma)) \quad (3.2)$$

for any Borel subset  $\Gamma \subset \mathbb{R}$ .

Let us emphasize that the stationarity of  $u$  is important for the validity of the conclusions of Theorem 3.1. A counterexample constructed by Fabes and Kenig [FK81] shows that a solution of a one-dimensional SDE with a diffusion term separated from zero may have a singular distribution (see also [Mar00]).

Theorem 3.1 immediately implies the results formulated in the Introduction. Moreover, we have the following corollary.

**Corollary 3.2.** *Under the hypotheses of Theorem 3.1, the following assertions hold for any limiting point  $\mu$  of the family  $\{\mu_\nu, \nu > 0\}$  in the sense of weak convergence on  $L^2$ .*

- Let  $b_k \neq 0$  for some  $k \geq 1$ . Then  $\mu$  has no atom at  $u = 0$  and satisfies inequality (3.1) in which  $\mu_\nu$  is replaced by  $\mu$ .
- Let  $b_j \neq 0$  for all  $j \geq 1$ . Then for any Borel subset  $\Gamma \subset \mathbb{R}$  we have

$$\mu(\{u \in L^2 : \mathcal{H}_0(u) \in \Gamma\}) + \mu(\{u \in L^2 : \mathcal{H}_1(u) \in \Gamma\}) \leq p(\ell(\Gamma)), \quad (3.3)$$

where  $p$  is the function constructed in Theorem 3.1.

*Proof.* We shall confine ourselves to the proof of the second assertion, because the first one can be established by a similar argument. It is well known that if a sequence of measures  $\mu_{\nu_k}$  converges to  $\mu$  weakly on  $L^2$ , then

$$\liminf_{k \rightarrow \infty} \mu_{\nu_k}(G) \leq \mu(G) \quad \text{for any open subset } G \subset L^2.$$

Combining this with (3.1), we see that (3.3) holds for any open subset  $\Gamma \subset \mathbb{R}$ . Now recall that if  $\lambda$  is a Borel measure on  $\mathbb{R}$ , then

$$\lambda(\Gamma) = \inf\{\lambda(G) : G \supset \Gamma, G \text{ is open}\}.$$

Combining this property with the continuity of  $p$ , we conclude that (3.3) is true for any Borel set  $\Gamma \subset \mathbb{R}$ .  $\square$

The proof of Theorem 3.1 is given in Section 3.3. A key ingredient of the proof is the following result established in the next subsection.

**Proposition 3.3.** *Let us assume that the hypotheses of Theorem 3.1 are satisfied and let  $g \in C^2(\mathbb{R})$  be a real-valued function of at most polynomial growth at infinity. Then for any stationary solution  $u(t, x)$  for (1.1), (1.2) and any Borel subset  $\Gamma \subset \mathbb{R}$  we have*

$$\begin{aligned} \mathbb{E} \int_{\Gamma} \mathbb{I}_{(a, \infty)}(g(\|u\|^2)) \left( g'(\|u\|^2)(B_0 - \|\nabla u\|^2) + g''(\|u\|^2) \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \right) da \\ + \sum_{j \in \mathbb{Z}_*} b_j^2 \mathbb{E} \left( \mathbb{I}_{\Gamma}(g(\|u\|^2)) (g'(\|u\|^2) u_j)^2 \right) = 0. \end{aligned} \quad (3.4)$$

### 3.2 Proof of Proposition 3.3

Let us fix any function  $g \in C^2(\mathbb{R})$  and consider the process  $f(t) = g(u(t))$ , where  $u(t)$  is a stationary solution of (1.1), (1.2). It follows from (2.2) that  $f$  is a semimartingale which can be written as

$$f(t) = f(0) + \nu \int_0^t A(s) ds + 2\sqrt{\nu} \sum_{j \in \mathbb{Z}_*} b_j \int_0^t g'(\|u\|^2) u_j dw_j, \quad (3.5)$$

where we set

$$A(t) = 2 \left( g'(\|u\|^2) (B_0 - \|\nabla u\|^2) + g''(\|u\|^2) \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \right).$$

Let  $\Lambda_t(a)$  be the local time for  $f$ . Then, in view of relation (2.8) with  $h = \mathbb{I}_\Gamma$ , we have

$$2 \int_\Gamma \Lambda_t(a) da = 4\nu \sum_{j \in \mathbb{Z}_*} b_j^2 \int_0^t \mathbb{I}_\Gamma(f(s)) (g'(\|u\|^2) u_j)^2 ds. \quad (3.6)$$

Taking the mean value and using the stationarity of  $u$ , we derive

$$\int_\Gamma (\mathbb{E} \Lambda_t(a)) da = 2\nu t \sum_{j \in \mathbb{Z}_*} b_j^2 \mathbb{E} \left( \mathbb{I}_\Gamma(f) (g'(\|u\|^2) u_j)^2 \right). \quad (3.7)$$

On the other hand, by the change of variable formula (2.7), for any  $a \in \mathbb{R}$  we have

$$\begin{aligned} \Lambda_t(a) &= |f(t) - a| - |f(0) - a| - 2\sqrt{\nu} \sum_{j \in \mathbb{Z}_*} b_j \int_0^t \mathbb{I}_{(a, \infty)}(f(s)) g'(\|u\|^2) u_j dw_j \\ &\quad - \nu \int_0^t \mathbb{I}_{(a, \infty)}(f(s)) A(s) ds. \end{aligned}$$

Taking the mean value and using again the stationarity of  $u$ , we derive

$$\mathbb{E} \Lambda_t(a) = -\nu t \mathbb{E} (\mathbb{I}_{(a, \infty)}(f(0)) A(0)).$$

Substituting this into (3.7) and recalling the definition of  $A$ , we arrive at the required relation (3.4).

### 3.3 Proof of Theorem 3.1

*Proof of (i).* We repeat essentially the argument used in the proof of Proposition 3.3. Let  $v \in L^2$  be a function non-orthogonal to  $e_k$  or  $e_{-k}$  and let  $\mu_\nu^v$  be the projection of  $\mu_\nu$  to the vector space spanned by  $v$ . Then, in view of (1.1), the stationary process  $z(t) = (u(t), v)$  is a semimartingale, its law coincides with  $\mu_\nu^v$ , and it can be written in the form

$$z(t) = z(0) + \int_0^t g(s) ds + \sqrt{\nu} \sum_{j \in \mathbb{Z}_*} d_j dw_j,$$

where we set

$$g(t) = ((\nu + i)\Delta u - \lambda|u|^2 u, v), \quad d_j = b_j(v, e_j).$$

Note that either  $d_k \neq 0$  or  $d_{-k} \neq 0$ , whence it follows that

$$D_0 := \sum_{j \in \mathbb{Z}_*} d_j^2 \neq 0.$$

Let  $\Lambda_t^v(a)$  be the local time for  $z$ . Then, by (2.8), for any Borel subset  $\Gamma \subset \mathbb{R}$ , we have

$$2 \int_{\Gamma} \Lambda_t^v(a) da = \sqrt{\nu} D_0 \int_0^t I_{\Gamma}(z(s)) ds, \quad t \geq 0.$$

Taking the mean value and using the stationarity of  $z$ , we see that

$$2 \int_{\Gamma} (\mathbb{E} \Lambda_t^v(a)) da = \sqrt{\nu} t D_0 \mu_{\nu}^v(\Gamma), \quad t \geq 0. \quad (3.8)$$

On the other hand, by the change of variable formula (2.7), we have

$$\begin{aligned} \Lambda_t^v(a) &= |z(t) - a| - |z(0) - a| - \int_0^t \mathbb{I}_{(a, \infty)}(z(s)) g(s) ds \\ &\quad - \sqrt{\nu} \sum_{j \in \mathbb{Z}_*} d_j \int_0^t \mathbb{I}_{(a, \infty)}(z(s)) dw_j. \end{aligned}$$

Taking the mean value and substituting the resulting formula into (3.8), we derive

$$\mathbb{P}(\{z(0) \in \Gamma\}) \leq \frac{2}{\sqrt{\nu} D_0} (\mathbb{E} |g(0)|) \ell(\Gamma). \quad (3.9)$$

Using (2.5), we see that

$$\mathbb{E} |g(0)| \leq C_1 \mathbb{E} (\|u\|_{L^6}^3 + \|u\|_2^2) \leq C_2. \quad (3.10)$$

Since the law of  $z(0)$  coincides with  $\mu_{\nu}^v$ , combining (3.9) and (3.10), we conclude that

$$\mu_{\nu}^v(\Gamma) \leq C_3 \nu^{-1/2} \ell(\Gamma) \quad \text{for any Borel set } \Gamma \subset \mathbb{R}.$$

This inequality implies that  $\mu_{\nu}^v$  has a bounded density with respect to the Lebesgue measure.

*Proof of (ii).* Let us apply relation (3.4) in which  $\Gamma = [\alpha, \beta]$  with  $\alpha > 0$  and  $g \in C^2(\mathbb{R})$  is a function that coincides with  $\sqrt{x}$  for  $x \geq \alpha$ . This results in

$$\begin{aligned} \mathbb{E} \int_{\alpha}^{\beta} \mathbb{I}_{(a, \infty)}(\|u\|) \left( \frac{B_0 - \|\nabla u\|^2}{2\|u\|} - \frac{1}{4\|u\|^3} \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \right) da \\ + \frac{1}{4} \sum_{j \in \mathbb{Z}_*} b_j^2 \mathbb{E} \left( \mathbb{I}_{\Gamma}(\|u\|) \|u\|^{-2} u_j^2 \right) = 0. \end{aligned}$$

It follows that

$$\mathbb{E} \int_{\alpha}^{\beta} \frac{\mathbb{I}_{(a,\infty)}(\|u\|)}{\|u\|^3} \left( 2B_0 \|u\|^2 - \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \right) da \leq 2(\beta - \alpha) \mathbb{E} \left( \frac{\|\nabla u\|^2}{\|u\|} \right). \quad (3.11)$$

Now note that

$$\begin{aligned} 2B_0 \|u\|^2 - \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 &= \sum_{j \in \mathbb{Z}_*} (2B_0 - b_j^2) u_j^2 \geq B_0 \|u\|^2, \\ \mathbb{E} \left( \frac{\|\nabla u\|^2}{\|u\|} \right) &\leq C_4 \mathbb{E} \|\Delta u\| \leq C_5 \sqrt{B_1 + MB_0}, \end{aligned}$$

where we used interpolation and inequality (2.5). Substituting these estimates into (3.11) and passing to the limit as  $\alpha \rightarrow 0^+$ , we derive

$$\mathbb{E} \int_0^{\beta} \mathbb{I}_{(a,\infty)}(\|u\|) \|u\|^{-1} da \leq C_6 B_0^{-1} \sqrt{B_1 + MB_0} \beta. \quad (3.12)$$

We now fix a constant  $\delta > 0$  and note that the left-hand side of (3.12) can be minorised by

$$\begin{aligned} \mathbb{E} \int_0^{\beta} \mathbb{I}_{(a,\delta]}(\|u\|) \|u\|^{-1} da &\geq \delta^{-1} \mathbb{E} \int_0^{\beta} \mathbb{I}_{(a,\delta]}(\|u\|) da \\ &= \delta^{-1} \int_0^{\beta} \mathbb{P}(\{a < \|u\| \leq \delta\}) da. \end{aligned}$$

Substituting this inequality into (3.12), we obtain

$$\frac{1}{\beta} \int_0^{\beta} \mathbb{P}(\{a < \|u\| \leq \delta\}) da \leq C_6 B_0^{-1} \sqrt{B_1 + MB_0} \delta.$$

Passing to the limit as  $\beta \rightarrow 0^+$  and recalling that  $\mu_\nu$  has no atom at  $u = 0$ , we arrive at the required inequality (3.1).

*Proof of (iii).* It suffices to show that each term on the left-hand side of (3.2) can be estimated by  $p(\ell(\Gamma))$ . We begin with the case of the functional  $\mathcal{H}_0(u)$ .

Applying relation (3.4) with  $g(x) = x$  and  $\Gamma$  replaced by  $2\Gamma$ , we obtain

$$\mathbb{E} \left( \mathbb{I}_{\Gamma}(\mathcal{H}_0(u)) \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \right) \leq \int_{2\Gamma} \mathbb{E} \left( \mathbb{I}_{(a,\infty)}(\|u\|^2) \|\nabla u\|^2 \right) da \leq 2B_0 \ell(\Gamma), \quad (3.13)$$

where we used (2.4) to get the second inequality. We wish to estimate the left hand side of this inequality from below. To this end, note that if  $\|u\| \geq \delta$  and  $\|u\|_2 \leq \delta^{-1/2}$ , then for any integer  $N \geq 1$  we have

$$\begin{aligned} \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 &\geq \underline{b}_N^2 \sum_{0 < |j| \leq N} u_j^2 = \underline{b}_N^2 \left( \|u\|^2 - \sum_{|j| > N} u_j^2 \right) \\ &\geq \underline{b}_N^2 \left( \|u\|^2 - \alpha_{N+1}^{-2} \|\Delta u\|^2 \right) \geq \underline{b}_N^2 (\delta^2 - \alpha_{N+1}^{-2} \delta^{-1}), \end{aligned}$$

where  $\underline{b}_N = \min\{b_j, 1 \leq j \leq N\}$ . Choosing  $N = N(\delta)$  sufficiently large, we find an increasing function  $\varepsilon(\delta) > 0$  going to zero with  $\delta$  such that

$$\sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \geq \varepsilon(\delta) \quad \text{for } \|u\| \geq \delta, \|u\|_2 \leq \delta^{-1/2}. \quad (3.14)$$

Define now the event  $G_\delta = \{\|u(0)\| \leq \delta \text{ or } \|u(0)\|_2 \geq \sqrt{\delta}\}$  and note that, in view of (3.1), (2.5), and Chebyshev's inequality, we have

$$\mathbb{P}(G_\delta) \leq \mathbb{P}\{\|u\| \leq \delta\} + \mathbb{P}\{\|u\| \geq \sqrt{\delta}\} \leq C_7 \delta.$$

Combining this with (3.13) and (3.14), we write

$$\begin{aligned} \mathbb{P}\{\mathcal{H}_0(u) \in \Gamma\} &= \mathbb{P}(\{\mathcal{H}_0(u) \in \Gamma\} \cap G_\delta) + \mathbb{P}(\{\mathcal{H}_0(u) \in \Gamma\} \cap G_\delta^c) \\ &\leq C_7 \delta + \varepsilon(\delta)^{-1} \mathbb{E} \left( \mathbb{I}_\Gamma(\mathcal{H}_0(u)) \sum_{j \in \mathbb{Z}_*} b_j^2 u_j^2 \right) \\ &\leq C_7 \delta + C_8 \varepsilon(\delta)^{-1} \ell(\Gamma). \end{aligned}$$

This inequality immediately implies the required result.

To prove the estimate for  $\mathcal{H}_1(u)$ , we use a similar argument; however, the calculations become more involved. A literal repetition of the proof of Proposition 3.3 enables one to show that

$$\begin{aligned} \sum_{j \in \mathbb{Z}_*} b_j^2 \mathbb{E} \left( \mathbb{I}_\Gamma(\mathcal{H}_1(u)) (-\Delta u + \lambda|u|^2 u, e_j)^2 \right) &\leq C_8 \ell(\Gamma) \mathbb{E} \left( \|\Delta u\|^2 + (|u|^2, |\nabla u|^2) \right) \\ &\leq C_9 (B_1 + MB_0) \ell(\Gamma), \end{aligned} \quad (3.15)$$

where we used (2.5) to derive the second inequality. Let us estimate from below the following expression arising in the left-hand side of (3.15):

$$\Xi(u) = \sum_{j \in \mathbb{Z}_*} b_j^2 (-\Delta u + \lambda|u|^2 u, e_j)^2.$$

Denoting by  $A_u$  the operator  $-\Delta + \lambda|u|^2$ , we see that  $(A_u v, v) \geq \alpha_1 \|v\|^2$  for any  $v \in H^2 \cap H_0^1$ . It follows that

$$\sum_{j \in \mathbb{Z}_*} (A_u u, e_j) u_j \geq \alpha_1 \|u\|^2. \quad (3.16)$$

On the other hand, for any integer  $N \geq 1$ , we can write

$$\begin{aligned} \sum_{j \in \mathbb{Z}_*} (A_u u, e_j) u_j &= \sum_{0 < |j| \leq N} (A_u u, e_j) u_j + (A_u u, Q_N u) \\ &\leq \underline{b}_N^{-1} \|u\| \left( \sum_{0 < |j| \leq N} b_j^2 (A_u u, e_j)^2 \right)^{1/2} + \|A_u u\| \|Q_N u\| \\ &\leq \underline{b}_N^{-1} \|u\| \sqrt{\Xi(u)} + \alpha_N^{-1} \|\Delta u\| (\|\Delta u\| + \lambda \|u\|_{L^6}^3), \end{aligned} \quad (3.17)$$

where  $Q_N : L^2 \rightarrow L^2$  stands for the orthogonal projection onto the subspace spanned by  $e_j$ ,  $|j| > N$ , and we used the inequality  $\|Q_N u\| \leq \alpha_N^{-1} \|\Delta u\|$ . Combining (3.16) and (3.17), we see that, if  $\|u\| \geq \delta$  and  $\|\Delta u\| + \|u\|_{L^6}^3 \leq \delta^{-1}$ , then

$$\begin{aligned} \sqrt{\Xi(u)} &\geq \underline{b}_N \left( \alpha_1 \|u\| - \alpha_N^{-1} \|u\|^{-1} \|\Delta u\| (\|\Delta u\| + \lambda \|u\|_{L^6}^3) \right) \\ &\geq \underline{b}_N (\alpha_1 \delta - \alpha_N^{-1} (1 + \lambda) \delta^{-3}). \end{aligned}$$

Choosing  $N = N(\delta)$  sufficiently large, we find an increasing function  $\varepsilon(\delta) > 0$  going to zero with  $\delta > 0$  such that

$$\sum_{j \in \mathbb{Z}_*} b_j^2 (-\Delta u + \lambda |u|^2 u, e_j)^2 \geq \varepsilon(\delta) \quad \text{for } \|u\| \geq \delta, \|\Delta u\| + \|u\|_{L^6}^3 \leq \delta^{-1}.$$

The required upper bound for  $\mathbb{P}\{\mathcal{H}_1(u) \in \Gamma\}$  can now be derived from (3.15) in exactly the same way as for the case of  $\mathcal{H}_0$ . The proof of Theorem 3.1 is complete.
