Timelike Bertrand Curves in Semi-Euclidean Space

Abstract

In this paper, it is proved that, no special timelike Frenet curve is a Bertrand curve in \mathbb{E}_2^4 and also, in \mathbb{E}_{ν}^{n+1} $(n \geq 3)$, such that the notion of Bertrand curve is definite only in \mathbb{E}_1^2 and \mathbb{E}_1^3 . Therefore, a generalization of timelike Bertrand curve is defined and called as timelike (1,3)-Bertrand curve in \mathbb{E}_2^4 . Moreover, the characterization of timelike (1,3)-Bertrand curve is given in \mathbb{E}_2^4 .

1 Introduction

In Euclidean ambient, a curve C is called C^{∞} -special Frenet curve in \mathbb{E}^3 if there exist three C^{∞} –vector fields, that is, the unit vector tangent field **t**, the unit principal normal vector field n and the unit binormal vector field b and two C^{∞} –scalar functions, that is, the curvature function k_1 (> 0) and torsion function $k_2 \neq 0$, [\[6\]](#page-12-0).

In \mathbb{E}^3 , a C^{∞} -special Frenet curve C is called a Bertrand curve if there exist another C^{∞} -special Frenet curve \overline{C} and a C^{∞} -mapping $\varphi : C \to \overline{C}$, such that the principal normal vector fields of C and \overline{C} coincide at the corresponding points, [\[4\]](#page-12-1).

If we focus our attention to timelike curves in three dimensional Minkowski space \mathbb{E}_1^3 , then we can give the well known theorem that a C^{∞} -special timelike Frenet curve is a Bertrand curve if and only if its curvature function k_1 and torsion function k_2 satisfy $ak_1 + bk_2 = 1$ for all $s \in L$, where a and b are constant real numbers. This theorem suffices to define the timelike curve

$$
\mathbf{\bar{c}}\left(\bar{s}\right) = \mathbf{c}\left(\varphi\left(s\right)\right) = \mathbf{c}\left(s\right) + \alpha \mathbf{n}\left(s\right)
$$

then it is immediate that \overline{C} is the timelike Bertrand mate curve of C , [\[1,](#page-12-2) [3\]](#page-12-3). As a result of this theorem, in \mathbb{E}^3_1 every timelike circular helix is an example of timelike Bertrand curve. Moreover, any timelike planar curve is a timelike Bertrand curve whose Bertrand mates are parallel curves of C, [\[1\]](#page-12-2).

In this paper, we prove that there is no C^{∞} –special timelike Frenet curve which is a Bertrand curve in \mathbb{E}_{2}^{4} and also, in $\mathbb{E}_{\nu_{a}}^{n+1}$ $(n \geq 3)$. Thus, the notion of timelike Bertrand curve stands only in \mathbb{E}_1^2 and \mathbb{E}_1^3 . According to this reason, we suggest an idea of generalization of timelike Bertrand curve in \mathbb{E}^4_2 .

2 Preliminaries

To meet the requirements in the next sections, the basic elements of the theory of curves in the semi Euclidean space \mathbb{E}^4_2 are briefly presented in this section. A more complete elementary treatment can be found in [\[5\]](#page-12-4).

Semi-Euclidean space \mathbb{E}_2^4 is an Euclidean space provided with standard flat metric given by

$$
g = -dx_1^2 - dx_2^2 + dx_3^2 + dx_4^2
$$

where (x_1, x_2, x_3, x_4) is a rectangular coordinate system in \mathbb{E}_2^4 . Since g is an indefinite metric, recall that a vector $\mathbf{v} \in \mathbb{E}_2^4$ can have one of three Lorentzian causal characters: it can be spacelike if $g(\mathbf{v}, \mathbf{v}) > 0$ or $\mathbf{v} = 0$, timelike if $g(\mathbf{v}, \mathbf{v}) < 0$ and null (lightlike) if $g(\mathbf{v}, \mathbf{v}) = 0$ and $\mathbf{v} \neq 0$, [\[5\]](#page-12-4).

Similarly, an arbitrary curve $\mathbf{c} = \mathbf{c}(s)$ in \mathbb{E}_2^4 can locally be spacelike, timelike or null (lightlike) if all of its velocity vectors $\mathbf{c}'(s)$ are, respectively, spacelike, timelike or null (lightlike). The norm of $\mathbf{v} \in \mathbb{E}_2^4$ is defined as $\|\mathbf{v}\| = \sqrt{|g(\mathbf{v}, \mathbf{v})|}$. Therefore, **v** is a unit vector if $g(\mathbf{v}, \mathbf{v}) = \pm 1$. Furthermore, vectors **v** and **w** are said to be orthogonal if $g(\mathbf{v}, \mathbf{w}) = 0$. The velocity of the curve C is given by $\|\mathbf{c}'\|$. Thus, a timelike curve C is said to be parametrized by arc length function s if $g(c', c') = -1$, [\[5\]](#page-12-4).

Let $\{t(s), n_1(s), n_2(s), n_3(s)\}\$ denotes the moving Frenet frame along C in the semi-Euclidean space \mathbb{E}_2^4 , then **t**, **n**₁, **n**₂, and **n**₃ are called the tangent, the principal normal, the first binormal, and the second binormal vector fields of C, respectively.

Let C be a C^{∞} -special timelike Frenet curve with timelike principal normal, spacelike first binormal and second binormal vector fields in \mathbb{E}_2^4 , parametrized by arc length function s. Moreover, non-zero C^{∞} –scalar functions k_1, k_2 , and k_3 be the first, second, and third curvatures of C, respectively. Then for the C^{∞} –special timelike Frenet curve C, the following Frenet formula is given by

$$
\begin{bmatrix} \mathbf{t}' \\ \mathbf{n}'_{1} \\ \mathbf{n}'_{2} \\ \mathbf{n}'_{3} \end{bmatrix} = \begin{bmatrix} 0 & -k_{1} & 0 & 0 \\ k_{1} & 0 & k_{2} & 0 \\ 0 & k_{2} & 0 & k_{3} \\ 0 & 0 & -k_{3} & 0 \end{bmatrix} \begin{bmatrix} \mathbf{t} \\ \mathbf{n}_{1} \\ \mathbf{n}_{2} \\ \mathbf{n}_{3} \end{bmatrix}
$$
(2.1)

where t, n_1, n_2, n_3 mutually orthogonal vector fields satisfying

$$
g\left(\mathbf{t},\mathbf{t}\right)=g\left(\mathbf{n}_{1},\mathbf{n}_{1}\right)=-1\quad ,\quad \ g\left(\mathbf{n}_{2},\mathbf{n}_{2}\right)=g\left(\mathbf{n}_{3},\mathbf{n}_{3}\right)=1
$$

(for the semi-Euclidean space \mathbb{E}_{ν}^{n+1} , see [\[2\]](#page-12-5)).

3 Timelike Bertrand Curve in \mathbb{E}^4_2 2

The following two theorems related to Bertrand curves in \mathbb{E}^2_1 and \mathbb{E}^3_1 are well known [\[1,](#page-12-2) [3\]](#page-12-3).

Theorem 3.1 In \mathbb{E}_1^2 , every timelike C^{∞} -planar curve is a Bertrand curve,[\[1\]](#page-12-2).

Theorem 3.2 In \mathbb{E}_1^3 , a C^∞ -special timelike Frenet curve with first and second curvatures k_1 and k_2 is a timelike Bertrand curve if and only if there exist a linear relation $ak_1 + bk_2 = 1$ for all $s \in L$, where a, b are nonzero constant real numbers, [\[1\]](#page-12-2).

Now, let us investigate Bertrand curves in \mathbb{E}_2^4 .

Definition 3.1 A C^{∞} -special timelike Frenet curve C $(C : L \rightarrow \mathbb{E}_2^4)$ is called timelike Bertrand curve if there exist an another ^C∞−special timelike Frenet curve \overline{C} $(\overline{C} : \overline{L} \to \mathbb{E}_2^4)$, distinct from C, and a regular \overline{C}^{∞} - map $\varphi : L \to \overline{L}$, $\left(\bar{s} = \varphi\left(s\right), \frac{d\varphi(s)}{ds} \neq 0 \right)$ for all $s \in L$, such that curve has the same 1-normal line at each pair of corresponding points $\mathbf{c}(s)$ and $\mathbf{\bar{c}}(\bar{s}) = \mathbf{\bar{c}}(\varphi(s))$ under φ . Here, s and \bar{s} are arc length parameters of timelike curves C and \bar{C} , respectively. In this case, \bar{C} is called a timelike Bertrand mate of C.

Theorem 3.3 In \mathbb{E}_2^4 , no C^{∞} -special timelike Frenet curve is a Bertrand curve.

Proof. Let (C, \overline{C}) be a mate of Bertrand curve in \mathbb{E}^4_2 . Also, the pair of $c(s)$ and $\bar{\mathbf{c}}(\bar{s})$ be the corresponding points of C and \bar{C} , respectively. Then for all $s \in L$ the curve \overline{C} is given by

$$
\bar{\mathbf{c}}\left(\bar{s}\right) = \mathbf{c}\left(\varphi\left(s\right)\right) = \mathbf{c}\left(s\right) + \alpha\left(s\right)\mathbf{n}_1\left(s\right) \tag{3.1}
$$

where α is C^{∞} –function on L. By differentiating the equation [\(3.1\)](#page-2-0) with respect to s, then

$$
\varphi'\left(s\right)\left.\frac{d\bar{\mathbf{c}}\left(\bar{s}\right)}{d\bar{s}}\right|_{\bar{s}=\varphi\left(s\right)}=\mathbf{c}'\left(s\right)+\alpha'\left(s\right)\mathbf{n}_{1}\left(s\right)+\alpha\left(s\right)\mathbf{n'}_{1}\left(s\right)
$$

is obtained. Here and hereafter, the subscript prime denotes the differentiation with respect to s. By using the Frenet formulas, it is seen that

$$
\varphi'\left(s\right)\overline{\mathbf{t}}\left(\varphi\left(s\right)\right)=\left(1+\alpha\left(s\right)k_{1}\left(s\right)\right)\mathbf{t}\left(s\right)+\alpha'\left(s\right)\mathbf{n}_{1}\left(s\right)+\alpha\left(s\right)k_{2}\left(s\right)\mathbf{n}_{2}\left(s\right).
$$

Considering $\mathbf{n}_1(s)$ and $\bar{\mathbf{n}}_1(\varphi(s))$ are coincident and $g(\bar{\mathbf{t}}(\varphi(s)), \mathbf{n}_1(s)) = 0$ for all $s \in L$, we get

$$
\alpha'\left(s\right)=0,
$$

that is, α is a constant function on L. Thus, the Bertrand mate of C can be rewritten as

$$
\bar{\mathbf{c}}\left(\bar{s}\right) = \mathbf{c}\left(\varphi\left(s\right)\right) = \mathbf{c}\left(s\right) + \alpha \mathbf{n}_1\left(s\right). \tag{3.2}
$$

The differentiation of this last equation with respect to s is

$$
\varphi'(s)\overline{\mathbf{t}}(\varphi(s)) = (1 + \alpha k_1(s))\mathbf{t}(s) + \alpha k_2(s)\mathbf{n}_2(s)
$$
\n(3.3)

for all $s \in L$.

By the fact that C and C are timelike curves, the tangent vector field of Bertrand mate of C can be given by

$$
\overline{\mathbf{t}}\left(\varphi\left(s\right)\right) = \cosh\theta\left(s\right)\mathbf{t}\left(s\right) + \sinh\theta\left(s\right)\mathbf{n}_{2}\left(s\right),\tag{3.4}
$$

where θ is a hyperbolic angle between the timelike tangent vector fields $\bar{\mathbf{t}}(\varphi(s))$ and $t(s)$. According to the equations [\(3.3\)](#page-3-0) and [\(3.4\)](#page-3-1), the hyperbolic functions are defined by

$$
\cosh\theta\left(s\right) = \left(1 + \alpha k_1\left(s\right)\right) / \varphi'\left(s\right),\tag{3.5}
$$

$$
\sinh \theta \left(s \right) = \alpha k_2 \left(s \right) / \varphi' \left(s \right). \tag{3.6}
$$

By differentiating the equation [\(3.4\)](#page-3-1) and applying Frenet formulas,

$$
-\varphi'(s) \bar{k}_{1} (\varphi(s)) \bar{\mathbf{n}}_{1} (\varphi(s)) = \frac{d(\cosh \theta(s))}{ds} \mathbf{t}(s)
$$

+ $(-k_{1}(s) \cosh \theta(s) + k_{2}(s) \sinh \theta(s)) \mathbf{n}_{1}(s)$
+ $\frac{d(\sinh \theta(s))}{ds} \mathbf{n}_{2}(s) + k_{3}(s) \sinh \theta(s) \mathbf{n}_{3}(s)$

is obtained. Since $\mathbf{n}_1(s)$ is coincident with $\bar{\mathbf{n}}_1(\varphi(s))$, from the above equation, it is seen that

$$
k_3(s)\sinh\theta(s) = 0.
$$

If we notice that k_3 is different from zero, then $\sinh \theta(s) = 0$. Considering the equation [\(3.6\)](#page-3-2) and $k_2 \neq 0$, then $\alpha = 0$. In that time the equation [\(3.2\)](#page-3-3) implies that \overline{C} is coincident with C. This is a contradiction. So, the proof is complete.

Also, in the same way we can generalize this theorem to semi-Euclidean space \mathbb{E}^{n+1}_{ν} ($n \geq 3$) by taking into consideration the Frenet formulas in \mathbb{E}^{n+1}_{ν} . The following result can be easily proved.

Result 3.1 There is no C^{∞} -special Frenet curve which is a Bertrand curve in $\mathbb{E}_{\nu}^{n+1}, (n \geq 3).$

4 Timelike $(1,3)$ – Bertrand Curve in \mathbb{E}_2^4 2

According to previous section, there is no Bertrand curve in semi-Euclidean space. Therefore, let us suggest an idea of a generalization of Bertrand curve in \mathbb{E}_2^4 .

Definition 4.1 Let C and \bar{C} be C^{∞} -special timelike Frenet curves in \mathbb{E}^4_2 and

$$
\varphi: L \to \bar{L} \n s \to \varphi(s) = \bar{s} \qquad \left(\frac{d\varphi(s)}{ds} \neq 0 \quad \text{for all } s \in L \right)
$$

be a regular C^{∞} -map at the corresponding points **c**(s) and **c**(\bar{s}) = **c**(φ (s)) of C and \bar{C} , respectively. If the Frenet (1,3) – normal plane at the each point of C is coincident with the Frenet $(1, 3)$ –normal plane at the corresponding point $\bar{\mathbf{c}}(\bar{s})$ of \bar{C} , then C is called a timelike $(1,3)$ – Bertrand curve in \mathbb{E}^4_2 . Also, \bar{C} is called a timelike $(1, 3)$ – Bertrand mate of C, which is given by

$$
\bar{\mathbf{c}}\left(\bar{s}\right) = \mathbf{c}\left(\varphi\left(s\right)\right) = \mathbf{c}\left(s\right) + \alpha\left(s\right)\mathbf{n}_1\left(s\right) + \beta\left(s\right)\mathbf{n}_3\left(s\right),\tag{4.1}
$$

where α and β are $C^{\infty}-$ functions on L.

The following theorem gives us a characterization of timelike $(1, 3)$ –Bertrand curve in \mathbb{E}_2^4 .

Theorem 4.1 Let C be a C^{∞} -special timelike Frenet curve with non-zero curvatures k_1 , k_2 , and k_3 in \mathbb{E}^4_2 . Then C is a timelike $(1,3)$ – Bertrand curve if and only if there exist the constant real numbers α , β , γ , δ satisfying

i.)
$$
\alpha k_2 (s) - \beta k_3 (s) \neq 0
$$

\nii.) $\gamma (\alpha k_2 (s) - \beta k_3 (s)) - \alpha k_1 (s) = 1$
\niii.) $\delta k_3 (s) = -\gamma k_1 (s) + k_2 (s)$
\niv.) $(\gamma^2 + 1) k_1 (s) k_2 (s) - \gamma (k_1^2 (s) + k_2^2 (s) - k_3^2 (s)) \neq 0$

for all $s \in L$.

Proof. Firstly, let us prove the necessary condition of the theorem. Let C be a timelike $(1,3)$ –Bertrand curve parametrized by arc length s in \mathbb{E}^4_2 . Then the timelike Bertrand mate \overline{C} of C is given by [\(4.1\)](#page-4-0). Substituting the Frenet formulas into the differentiation of the equation (4.1) with respect to s, we get

$$
\varphi'(s) \overline{\mathbf{t}}(\varphi(s)) = (1 + \alpha(s) k_1(s)) \mathbf{t}(s) + \alpha'(s) \mathbf{n}_1(s) + (\alpha(s) k_2(s) - \beta(s) k_3(s)) \mathbf{n}_2(s) + \beta'(s) \mathbf{n}_3(s)
$$

for all $s \in L$.

Since \mathbf{n}_1 and $\mathbf{\bar{n}}_1$ principal normal vector fields of C and C are timelike and the plane spanned by n_1 and n_3 is coincident with the plane spanned by \bar{n}_1 and \bar{n}_3 , then we have

$$
\mathbf{\bar{n}}_{1}\left(\varphi\left(s\right)\right)=\cosh\theta\left(s\right)\mathbf{n}_{1}\left(s\right)+\sinh\theta\left(s\right)\mathbf{n}_{3}\left(s\right) \tag{4.2}
$$

$$
\bar{\mathbf{n}}_{3}\left(\varphi\left(s\right)\right) = \sinh\theta\left(s\right)\mathbf{n}_{1}\left(s\right) + \cosh\theta\left(s\right)\mathbf{n}_{3}\left(s\right) \tag{4.3}
$$

where $\sinh \theta(s) \neq 0$ for all $s \in L$ and θ is a hyperbolic angle between the timelike vector fields n_1 and \bar{n}_1 .

By considering differentiation of the equation [\(4.1\)](#page-4-0) and the last two equations, we see

$$
g(\varphi'(s) \overline{\mathbf{t}}(\varphi(s)), \overline{\mathbf{n}}_1(\varphi(s))) = \alpha'(s) \cosh \theta(s) + \beta'(s) \sinh \theta(s) = 0
$$

$$
g(\varphi'(s) \overline{\mathbf{t}}(\varphi(s)), \overline{\mathbf{n}}_3(\varphi(s))) = \alpha'(s) \sinh \theta(s) + \beta'(s) \cosh \theta(s) = 0
$$

and since $\sinh \theta (s) \neq 0$,

$$
\alpha'(s) = 0 \quad \text{and} \quad \beta'(s) = 0
$$

that is, α and β are constant functions on L. Thus, the equation [\(4.1\)](#page-4-0) is rewritten as

$$
\overline{\mathbf{c}}\left(\overline{s}\right) = \mathbf{c}\left(\varphi\left(s\right)\right) = \mathbf{c}\left(s\right) + \alpha \mathbf{n}_1\left(s\right) + \beta \mathbf{n}_3\left(s\right) \tag{4.4}
$$

and its differentiation with respect to s is

$$
\varphi'(s)\overline{\mathbf{t}}(\varphi(s)) = (1 + \alpha k_1(s))\mathbf{t}(s) + (\alpha k_2(s) - \beta k_3(s))\mathbf{n}_2(s)
$$
 (4.5)

Since $\bar{\mathbf{t}}$ and \mathbf{t} are timelike tangent vector fields of C and \bar{C} , then

$$
-(\varphi'(s))^{2} = -(1 + \alpha k_{1}(s))^{2} + (\alpha k_{2}(s) - \beta k_{3}(s))^{2}. \qquad (4.6)
$$

Thus, we can write

$$
\bar{\mathbf{t}}\left(\varphi\left(s\right)\right) = \cosh\tau\left(s\right)\mathbf{t}\left(s\right) + \sinh\tau\left(s\right)\mathbf{n}_2\left(s\right) \tag{4.7}
$$

and

$$
\cosh \tau (s) = (1 + \alpha k_1 (s))/\varphi'(s),
$$

$$
\sinh \tau (s) = (\alpha k_2 (s) - \beta k_3 (s))/\varphi'(s),
$$

where τ is a hyperbolic angle between the timelike tangent vector fields $\bar{\mathbf{t}}(\varphi(s))$ and $\mathbf{t}(s)$ of C and \overline{C} . By differentiating the equation [\(4.7\)](#page-5-0) with respect to and applying Frenet formulas,

$$
-\varphi'(s)\bar{k}_{1}(\varphi(s))\bar{\mathbf{n}}_{1}(\varphi(s)) = \frac{d(\cosh \tau(s))}{ds}\mathbf{t}(s) + \left(-k_{1}(s)\cosh \tau(s) + k_{2}(s)\sinh \tau(s)\right)\mathbf{n}_{1}(s) + \frac{d(\sinh \tau(s))}{ds}\mathbf{n}_{2}(s) + k_{3}(s)\sinh \tau(s)\mathbf{n}_{3}(s)
$$

is obtained. Since $\bar{\mathbf{n}}_1(\varphi(s))$ is a linear combination $\mathbf{n}_1(s)$ and $\mathbf{n}_3(s)$, it easily seen that

$$
\frac{d(\cosh \tau(s))}{ds} = 0 \quad \text{and} \quad \frac{d(\sinh \tau(s))}{ds} = 0,
$$

that is, τ is a constant function on L with value τ_0 . Thus, we rewrite the equation [\(4.7\)](#page-5-0) as

$$
\bar{\mathbf{t}}\left(\varphi\left(s\right)\right) = \cosh\tau_0 \mathbf{t}\left(s\right) + \sinh\tau_0 \mathbf{n}_2\left(s\right) \tag{4.8}
$$

and

$$
\varphi'(s)\cosh\tau_0 = 1 + \alpha k_1(s), \qquad (4.9)
$$

$$
\varphi'(s)\sinh\tau_0 = \alpha k_2(s) - \beta k_3(s), \qquad (4.10)
$$

for all $s \in L$. According to these last two equations, it is seen that

$$
(1 + \alpha k_1(s)) \sinh \tau_0 = (\alpha k_2(s) - \beta k_3(s)) \cosh \tau_0.
$$
 (4.11)

If sinh $\tau_0 = 0$, then it satisfies $\cosh \tau_0 = 1$ and $\bar{\mathbf{t}}(\varphi(s)) = \mathbf{t}(s)$. The differentiation of this equality with respect to s is

$$
-\bar{k}_{1}(\varphi(s))\varphi'(s)\,\bar{\mathbf{n}}_{1}(\varphi(s))=-k_{1}(s)\,\mathbf{n}_{1}(s),
$$

that is, $n_1(s)$ is linear dependence with $\bar{n}_1(\varphi(s))$. According to Theorem [3.3,](#page-2-1) this is a contradiction. Thus, only the case of $\sinh \tau_0 \neq 0$ must be considered. The equation [\(4.10\)](#page-6-0) satisfies

$$
\alpha k_2\left(s\right) - \beta k_3\left(s\right) \neq 0,
$$

that is, the relation given in i.) is proved. Since $\sinh \tau_0 \neq 0$, the equation [\(4.11\)](#page-6-1) can be rewritten as

$$
\frac{\cosh \tau_0}{\sinh \tau_0} \left(\alpha k_2 \left(s \right) - \beta k_3 \left(s \right) \right) - \alpha k_1 \left(s \right) = 1.
$$

Let us denote the constant value $(\cosh \tau_0) (\sinh \tau_0)^{-1}$ by the constant real number γ , then γ is an element of interval $(-\infty, -1) \cup (1, \infty)$ and

$$
\gamma\left(\alpha k_2\left(s\right)-\beta k_3\left(s\right)\right)-\alpha k_1\left(s\right)=1.
$$

This proves the relation *ii.*) of the theorem.

By differentiating the equation (4.8) with respect to s and applying Frenet formulas, we have

$$
\varphi'(s) \bar{k}_{1} (\varphi(s)) \bar{\mathbf{n}}_{1} (\varphi(s)) = (k_{1} (s) \cosh \tau (s) - k_{2} (s) \sinh \tau (s)) \mathbf{n}_{1} (s) - k_{3} (s) \sinh \tau (s) \mathbf{n}_{3} (s)
$$

for all $s \in L$.

Taking into consideration the equations (4.9) , (4.10) and the relation *ii.*), the above equality satisfy

$$
\left(\varphi'(s)\,\overline{k}_1\left(\varphi(s)\right)\right)^2 = \left(\alpha k_2\left(s\right) - \beta k_3\left(s\right)\right)^2 \left[\left(\gamma k_1\left(s\right) - k_2\left(s\right)\right)^2 - k_3^2\left(s\right)\right] \left(\varphi'\left(s\right)\right)^{-2}
$$

From the equation (4.6) and the relation *ii.*), we get

$$
(\varphi'(s))^{2} = (\gamma^{2} - 1) (\alpha k_{2}(s) - \beta k_{3}(s))^{2}.
$$
 (4.12)

.

Thus, we obtain

$$
(\varphi'(s)\,\bar{k}_1\,(\varphi(s)))^2 = \frac{1}{\gamma^2 - 1} \left((\gamma k_1\,(s) - k_2\,(s))^2 - k_3^2\,(s) \right) \tag{4.13}
$$

where $\gamma \in (-\infty, -1) \cup (1, \infty)$.

From the equations (4.9) , (4.10) and the relation *ii.*), we can give

$$
\bar{\mathbf{n}}_1(\varphi(s)) = \cosh \eta(s) \,\mathbf{n}_1(s) + \sinh \eta(s) \,\mathbf{n}_3(s) \tag{4.14}
$$

where

$$
\cosh \eta (s) = \frac{(\alpha k_2 (s) - \beta k_3 (s)) (\gamma k_1 (s) - k_2 (s))}{\bar{k}_1 (\varphi (s)) (\varphi'(s))^2},
$$
\n(4.15)

$$
\sinh \eta (s) = -\frac{\left(\alpha k_2 (s) - \beta k_3 (s)\right) k_3 (s)}{\bar{k}_1 \left(\varphi (s)\right) \left(\varphi'(s)\right)^2},\tag{4.16}
$$

for all $s \in L$ and $\eta \in C^{\infty}$ -function on L. By differentiating the equation [\(4.14\)](#page-7-0) with respect to s and applying Frenet formulas, we have

$$
\varphi'(s) \overline{k}_1 (\varphi(s)) \overline{\mathbf{t}} (\varphi(s)) \n+ \varphi'(s) \overline{k}_2 (\varphi(s)) \overline{\mathbf{n}}_2 (\varphi(s)) = k_1(s) \cosh \eta(s) \mathbf{t}(s) \n+ \frac{d(\cosh \eta(s))}{ds} \mathbf{n}_1(s) \n+ (k_2(s) \cosh \eta(s) - k_3(s) \sinh \eta(s)) \mathbf{n}_2(s) \n+ \frac{d(\sinh \tau(s))}{ds} \mathbf{n}_3(s)
$$

for all $s \in L$ and this satisfies

$$
\frac{d(\cosh \eta (s))}{ds} = 0 \quad \text{and} \quad \frac{d(\sinh \eta (s))}{ds} = 0,
$$

that is, η is a constant function on L with value η_0 . Let us denote $(\cosh \tau_0) (\sinh \tau_0)^{-1}$ by the constant real number δ , then $\delta \in (-\infty, -1) \cup (1, \infty)$. The ratio of [\(4.15\)](#page-7-1) and [\(4.16\)](#page-7-2) holds

$$
\delta = -\frac{\gamma k_1\left(s\right) - k_2\left(s\right)}{k_3\left(s\right)},
$$

that is,

$$
\delta k_3(s) = -\gamma k_1(s) + k_2(s)
$$

for all $s \in L$ and $\delta \in (-\infty, -1) \cup (1, \infty)$. Thus the relation *iii.*) of the theorem is obtained. Moreover, we can give

$$
\varphi'(s) \bar{k}_{2} (\varphi(s)) \bar{\mathbf{n}}_{2} (\varphi(s)) = -\varphi'(s) \bar{k}_{1} (\varphi(s)) \bar{\mathbf{t}} (\varphi(s)) + k_{1} (s) \cosh \eta (s) \mathbf{t} (s) + (k_{2} (s) \cosh \eta (s) - k_{3} (s) \sinh \eta (s)) \mathbf{n}_{2} (s).
$$

If we substitute the equations (4.5) , (4.15) and (4.16) into the above equality, we obtain

$$
\varphi'(s) \bar{k}_{2} (\varphi(s)) \bar{\mathbf{n}}_{2} (\varphi(s)) = (\varphi'(s))^{-2} (\bar{k}_{1} (\varphi(s)))^{-1} [A(s) \mathbf{t}(s) + B(s) \mathbf{n}_{2}(s)]
$$

where

$$
A(s) = -(\varphi'(s) \bar{k}_1(\varphi(s)))^2 (1 + \alpha k_1(s)) + k_1(s) (\alpha k_2(s) - \beta k_3(s)) (\gamma k_1(s) - k_2(s))
$$

and

$$
B(s) = (\varphi'(s) \bar{k}_1 (\varphi(s)))^2 (\alpha k_2 (s) - \beta k_3 (s)) + (\alpha k_2 (s) - \beta k_3 (s)) (\gamma k_1 (s) - k_2 (s)) k_2 (s) + (\alpha k_2 (s) - \beta k_3 (s)) k_3^2 (s)
$$

for all $s \in L$. By the relation ii.) and the equation [\(4.13\)](#page-7-3), $A(s)$ and $B(s)$ can be rewritten as;

$$
A(s) = (\gamma^2 - 1)^{-1} (\alpha k_2 (s) - \beta k_3 (s)) [(\gamma^2 + 1) k_1 (s) k_2 (s) - \gamma (k_1^2 (s) + k_2^2 (s) - k_3^2 (s))]
$$

and

$$
B(s) = \gamma (\gamma^2 - 1)^{-1} (\alpha k_2 (s) - \beta k_3 (s)) [(\gamma^2 + 1) k_1 (s) k_2 (s) - \gamma (k_1^2 (s) + k_2^2 (s) - k_3^2 (s))]
$$

By the fact that $\varphi'(s)\overline{k}_2(\varphi(s))\overline{n}_2(\varphi(s)) \neq 0$ for all $s \in L$, it is proved that

 $(\gamma^2 + 1) k_1 (s) k_2 (s) - \gamma (k_1^2 (s) + k_2^2 (s) - k_3^2 (s)) \neq 0.$

This is the relation iv.) of theorem.

Now, we will prove the sufficient condition of the theorem.

Thus, we assume that C is a timelike C^{∞} -special Frenet curve in \mathbb{E}^4_2 with curvatures k_1, k_2 and k_3 satisfying the relations *i.*), *ii.*), *iii.*) and *iv.*) for the constant real numbers α , β , γ , and δ . We define a timelike curve \overline{C} by

We define a timelike curve
$$
C
$$
 by

$$
\bar{\mathbf{c}}(s) = \mathbf{c}(s) + \alpha \mathbf{n}_1 \left(s \right) + \beta \mathbf{n}_3 \left(s \right) \tag{4.17}
$$

where s is the arc length parameter of C .

By differentiating the equation (4.17) with respect to s and applying Frenet formulas,

$$
\frac{d\bar{\mathbf{c}}(s)}{ds} = (1 + \alpha k_1(s)) \mathbf{t}(s) + (\alpha k_2(s) - \beta k_3(s)) \mathbf{n}_2(s)
$$

is obtained. Considering the relation ii .), the last equation is rewritten as;

$$
\frac{d\bar{\mathbf{c}}\left(s\right)}{ds} = \left(\alpha k_2\left(s\right) - \beta k_3\left(s\right)\right)\left(\gamma \mathbf{t}\left(s\right) + \mathbf{n}_2\left(s\right)\right)
$$

for all $s \in L$. From the relation i.) it is seen that \overline{C} is regular curve. Thus, arc length parameter of \bar{C} denoted by \overline{s} can be given by

$$
\bar{s} = \varphi(s) = \int_{0}^{s} \left\| \frac{d\bar{\mathbf{c}}(t)}{dt} \right\| dt
$$

where $\varphi:L\to \overline{L}$ is a regular map. The differentiation of φ with respect to s is

$$
\varphi'(s) = \varepsilon \sqrt{\gamma^2 - 1} \left(\alpha k_2 \left(s \right) - \beta k_3 \left(s \right) \right) > 0 \tag{4.18}
$$

where

$$
\varepsilon = \begin{cases} 1, & \alpha k_2(s) - \beta k_3(s) > 0 \\ -1, & \alpha k_2(s) - \beta k_3(s) < 0. \end{cases}
$$

Also, here we notice that $\gamma \in (-\infty, -1) \cup (1, \infty)$ and $\gamma^2 - 1 > 0$. Thus the timelike curve \bar{C} is rewritten as;

$$
\bar{\mathbf{c}}(\bar{s}) = \bar{\mathbf{c}}(\varphi(s)) = \mathbf{c}(s) + \alpha \mathbf{n}_1(s) + \beta \mathbf{n}_3(s)
$$

for all $s \in L$. Differentiating this equation with respect to s, we get

$$
\varphi'(s) \left. \frac{d\bar{\mathbf{c}}\left(\bar{s}\right)}{d\bar{s}}\right|_{\bar{s}=\varphi(s)} = \left(\alpha k_2\left(s\right) - \beta k_3\left(s\right)\right)\left(\gamma \mathbf{t}\left(s\right) + \mathbf{n}_2\left(s\right)\right).
$$

Now, let us define a unit vector field \bar{t} along \bar{C} by $\frac{d\bar{\mathbf{c}}(\bar{s})}{d\bar{s}}$, then

$$
\overline{\mathbf{t}}\left(\varphi\left(s\right)\right) = \varepsilon \left(\gamma^2 - 1\right)^{-1/2} \left(\gamma \mathbf{t}\left(s\right) + \mathbf{n}_2\left(s\right)\right). \tag{4.19}
$$

.

By differentiating the equation (4.19) with respect to s and using Frenet formulas,

$$
\varphi'(s) \frac{d\bar{\mathbf{t}}\left(\varphi(s)\right)}{d\bar{s}}\bigg|_{\bar{s}=\varphi(s)} = \varepsilon \left(\gamma^2 - 1\right)^{-1/2} \left[-\left(\gamma k_1\left(s\right) - k_2\left(s\right)\right) \mathbf{n}_1\left(s\right) + k_3\left(s\right) \mathbf{n}_3\left(s\right)\right]
$$

and

$$
\left\|\varphi'(s)\frac{d\overline{\mathbf{t}}\left(\varphi(s)\right)}{d\overline{s}}\right\|_{\overline{s}=\varphi(s)}\right\| = \frac{\sqrt{\left|-\left(\gamma k_1\left(s\right)-k_2\left(s\right)\right)^2+k_3^2\left(s\right)\right|}}{\varphi'(s)\sqrt{\gamma^2-1}}
$$

By relations iii .), it is seen that

$$
\sqrt{\left| -(\gamma k_1(s) - k_2(s))^2 + k_3^2(s) \right|} = \sqrt{\left| -\delta^2 + 1 \right| k_3^2(s)}
$$

and we notice that $\delta \in (-\infty, -1) \cup (1, \infty)$ and $\gamma^2 - 1 > 0$. Thus, we can write

$$
\left\| \frac{d\overline{\mathbf{t}}\left(\varphi\left(s\right)\right)}{d\overline{s}} \right\|_{\overline{s}=\varphi\left(s\right)} \right\| = \frac{\sqrt{\delta^2 - 1} \, k_3^2\left(s\right)}{\varphi'\left(s\right) \sqrt{\gamma^2 - 1}}.
$$

Since $k_3(s) > 0$ and $\varphi'(s) > 0$ for all $s \in L$, we obtain

$$
\overline{k}_{1}(\varphi(s)) = \left\| \frac{d\overline{\mathbf{t}}(\varphi(s))}{d\overline{s}} \right\|_{\overline{s}=\varphi(s)} \right\| > 0.
$$
\n(4.20)

Thus, \bar{n}_1 timelike unit vector field can be defined by

$$
\begin{array}{lll} \bar{\mathbf{n}}\left(\bar{s}\right) &= \bar{\mathbf{n}}_1\left(\varphi\left(s\right)\right) \\ &= \frac{1}{k_1(\varphi(s))}\bar{\mathbf{t}}\left(\varphi\left(s\right)\right) \\ &= \frac{\left(\gamma k_1(s)-k_2(s)\right)\mathbf{n}_1(s)-k_3(s)\mathbf{n}_3(s)}{\varepsilon\sqrt{(\gamma k_1(s)-k_2(s))^2-k_3^2(s)}} \end{array}
$$

Also, \bar{n}_1 can be given in the form

$$
\bar{\mathbf{n}}_1(\varphi(s)) = \cosh\xi(s)\,\mathbf{n}_1(s) + \sinh\xi(s)\,\mathbf{n}_3(s) \tag{4.21}
$$

.

where

$$
\cosh \xi = \frac{\gamma k_1 (s) - k_2 (s)}{\varepsilon \sqrt{(\gamma k_1 (s) - k_2 (s))^2 - k_3^2 (s)}},
$$
\n(4.22)

$$
\sinh \xi = \frac{-k_3(s)}{\varepsilon \sqrt{(\gamma k_1(s) - k_2(s))^2 - k_3^2(s)}},
$$
\n(4.23)

for all $s \in L$. Here ξ is a C^{∞} -function on L.

By differentiating (4.21) with respect to s and using the Frenet formulas, we get

$$
\left\| \frac{d\bar{\mathbf{n}}_1(\varphi(s))}{d\bar{s}} \right\|_{\bar{s}=\varphi(s)} \right\| = k_1(s) \cosh \xi(s) \mathbf{t}(s) + \frac{d(\cosh \xi(s))}{ds} \mathbf{n}_1(s) + (k_2(s) \cosh \xi(s) - k_3(s) \sinh \xi(s)) \mathbf{n}_2(s) + \frac{d(\sinh \xi(s))}{ds} \mathbf{n}_3(s).
$$

The differentiation of the relation $iii.$) with respect to s is

$$
\left(\gamma k_1'(s) - k_2'(s)\right) k_3(s) + \left(\gamma k_1(s) - k_2(s)\right) k_3'(s) = 0 \tag{4.24}
$$

Substituting the equation [\(4.24\)](#page-10-1), we get

$$
\frac{d(\cosh \xi(s))}{ds} = 0 \quad , \quad \frac{d(\sinh \xi(s))}{ds} = 0,
$$

that is, ξ is a constant function on L with value ξ_0 . Thus, we write

$$
\cosh \xi_0 = \frac{\gamma k_1 (s) - k_2 (s)}{\varepsilon \sqrt{(\gamma k_1 (s) - k_2 (s))^2 - k_3^2 (s)}},
$$
\n(4.25)

$$
\sinh \xi_0 = \frac{-k_3(s)}{\varepsilon \sqrt{(\gamma k_1(s) - k_2(s))^2 - k_3^2(s)}}.
$$
\n(4.26)

Then, from the equation [\(4.2\)](#page-4-1), it satisfies

$$
\bar{\mathbf{n}}_{1}(\varphi(s)) = \cosh \xi_{0}(s) \mathbf{n}_{1}(s) + \sinh \xi_{0}(s) \mathbf{n}_{3}(s).
$$
 (4.27)

By considering the equations [\(4.19\)](#page-9-0) and [\(4.20\)](#page-9-1), we obtain

$$
\overline{k}_{1}\left(\varphi\left(s\right)\right)\overline{\mathbf{t}}\left(\varphi\left(s\right)\right)=\frac{\left(\gamma k_{1}\left(s\right)-k_{2}\left(s\right)\right)^{2}-k_{3}^{2}\left(s\right)}{\varepsilon\varphi'\left(s\right)\left(\gamma^{2}-1\right)\sqrt{\left(\gamma k_{1}\left(s\right)-k_{2}\left(s\right)\right)^{2}-k_{3}^{2}\left(s\right)}}\left(\gamma\mathbf{t}\left(s\right)+\mathbf{n}_{2}\left(s\right)\right).
$$

Also, by substituting the equations [\(4.25\)](#page-10-2) and [\(4.26\)](#page-10-3) into equation [\(4.20\)](#page-9-1), we get

$$
\frac{d\bar{\mathbf{n}}_1(\varphi(s))}{d\bar{s}}\Big|_{\bar{s}=\varphi(s)} = \frac{k_1(s)(\gamma k_1(s)-k_2(s))}{\varepsilon\varphi'(s)(\gamma^2-1)\sqrt{(\gamma k_1(s)-k_2(s))^2-k_3^2(s)}}\mathbf{t}(s) + \frac{k_2(s)(\gamma k_1(s)-k_2(s))+k_3(s)}{\varepsilon\varphi'(s)\sqrt{(\gamma k_1(s)-k_2(s))^2-k_3^2(s)}}\mathbf{n}_2(s)
$$

for $s \in L$. By the last two equations, we obtain

$$
\frac{d\bar{\mathbf{n}}_1(\varphi(s))}{d\bar{s}}\bigg|_{\bar{s}=\varphi(s)} - \overline{k}_1(\varphi(s)) \ \overline{\mathbf{t}}(\varphi(s)) = \frac{P(s)}{R(s)}\mathbf{t}(s) + \frac{Q(s)}{R(s)}\mathbf{n}_2(s)
$$

where

$$
P(s) = (\gamma^{2} + 1) k_{1}(s) k_{2}(s) - \gamma (k_{1}^{2}(s) + k_{2}^{2}(s) - k_{3}^{2}(s)),
$$

\n
$$
Q(s) = \gamma [(\gamma^{2} + 1) k_{1}(s) k_{2}(s) - \gamma (k_{1}^{2}(s) + k_{2}^{2}(s) - k_{3}^{2}(s))] ,
$$

\n
$$
R(s) = \varepsilon \varphi'(s) (\gamma^{2} - 1) \sqrt{(\gamma k_{1}(s) - k_{2}(s))^{2} - k_{3}^{2}(s)} \neq 0.
$$

By the fact that

$$
\overline{k}_{2}(\varphi(s)) = \left\| \frac{d\overline{\mathbf{n}}_{1}(\varphi(s))}{d\overline{s}} \right\|_{\overline{s}=\varphi(s)} - \overline{k}_{1}(\varphi(s)) \overline{\mathbf{t}}(\varphi(s)) \right\| > 0
$$

for all $s \in L$, we see

$$
\overline{k}_{2}(\varphi(s)) = \frac{\left| \left(\gamma^{2} + 1\right) k_{1} \left(s\right) k_{2} \left(s\right) - \gamma \left(k_{1}^{2} \left(s\right) + k_{2}^{2} \left(s\right) - k_{3}^{2} \left(s\right)\right) \right|}{\varphi'\left(s\right) \sqrt{\left(\gamma^{2} - 1\right) \left[\left(\gamma k_{1} \left(s\right) - k_{2} \left(s\right)\right)^{2} - k_{3}^{2} \left(s\right)\right]}}.
$$

Thus, we can define a unit vector field $\bar{\mathbf{n}}_2\left(\bar{s}\right)$ along \overline{C} by

$$
\bar{\mathbf{n}}_2(\bar{s}) = \bar{\mathbf{n}}_2(\varphi(s)) \n= \frac{1}{k_2(\varphi(s))} \left[\frac{d\bar{\mathbf{n}}_1(\varphi(s))}{d\bar{s}} \Big|_{\bar{s}=\varphi(s)} - \overline{k}_1(\varphi(s)) \overline{\mathbf{t}}(\varphi(s)) \right],
$$

such that

$$
\bar{\mathbf{n}}_2\left(\varphi\left(s\right)\right) = \frac{1}{\varepsilon\sqrt{\gamma^2 - 1}}\left(\mathbf{t}\left(s\right) + \gamma \mathbf{n}_2\left(s\right)\right). \tag{4.28}
$$

Also, since $\bar{\mathbf{n}}_3(\varphi(s)) = \sinh \xi_0(s) \mathbf{n}_1(s) + \cosh \xi_0(s) \mathbf{n}_3(s)$ for all $s \in L$, another unit vector field \bar{n}_3 along \overline{C} can

$$
\bar{\mathbf{n}}_{3}(\bar{s}) = \bar{\mathbf{n}}_{3}(\varphi(s))
$$
\n
$$
= \frac{1}{\varepsilon\sqrt{(\gamma k_{1}(s) - k_{2}(s))^{2} - k_{3}^{2}(s)}} \left(-k_{3}(s)\,\mathbf{n}_{1}(s) + (\gamma k_{1}(s) - k_{2}(s))\,\mathbf{n}_{3}(s) \right). \tag{4.29}
$$

Now, from the equations (4.19) , (4.27) , (4.28) and (4.29) , it is seen that

$$
\det \left[\bar{\mathbf{t}} \left(\varphi \left(s \right) \right) , \, \bar{\mathbf{n}}_1 \left(\varphi \left(s \right) \right) , \, \bar{\mathbf{n}}_2 \left(\varphi \left(s \right) \right) , \, \bar{\mathbf{n}}_3 \left(\varphi \left(s \right) \right) \right] = \det \left[\mathbf{t} \left(s \right) , \, \mathbf{n}_1 \left(s \right) , \, \mathbf{n}_2 \left(s \right) , \, \mathbf{n}_3 \left(s \right) \right] = 1.
$$

 \bar{t} , \bar{n}_1 , \bar{n}_2 and \bar{n}_3 are mutually orthogonal vector fields satisfying

$$
g\left(\mathbf{\bar{t}}\left(\varphi\left(s\right)\right),\mathbf{\bar{t}}\left(\varphi\left(s\right)\right)\right)=g\left(\mathbf{\bar{n}}_1\left(\varphi\left(s\right)\right),\mathbf{\bar{n}}_1\left(\varphi\left(s\right)\right)\right)=-1,
$$

$$
g\left(\mathbf{\bar{n}}_2\left(\varphi\left(s\right)\right),\mathbf{\bar{n}}_2\left(\varphi\left(s\right)\right)\right)=g\left(\mathbf{\bar{n}}_3\left(\varphi\left(s\right)\right),\mathbf{\bar{n}}_3\left(\varphi\left(s\right)\right)\right)=1
$$

Thus the tetrahedron ${\{\bar{\mathbf{t}}, \bar{\mathbf{n}}_1, \bar{\mathbf{n}}_2, \bar{\mathbf{n}}_3\}}$ along \overline{C} is an orthonormal frame where $\overline{\mathbf{t}}$ and \bar{n}_1 are timelike vector fields, \bar{n}_2 and \bar{n}_3 are spacelike vector fields. On the other hand, by considering the equations [\(4.29\)](#page-11-1) and the differentiation of the equation [\(4.28\)](#page-11-0), we obtain

$$
\overline{k}_{3}(\varphi(s)) = -\left\langle \frac{d\overline{\mathbf{n}}_{2}(\varphi(s))}{d\overline{s}} \Big|_{\overline{s}=\varphi(s)}, \overline{\mathbf{n}}_{3}(\varphi(s)) \right\rangle
$$

$$
= \frac{\sqrt{\gamma^{2}-1} k_{1}(s) k_{3}(s)}{\varphi'(s) \sqrt{(\gamma k_{1}(s)-k_{2}(s))^{2}-k_{3}^{2}(s)}} > 0
$$

for all $s \in L$. Therefore, \overline{C} is a C^{∞} -special curve in \mathbb{E}_2^4 and the Frenet $(1,3)$ normal plane at the corresponding point $\bar{\mathbf{c}}(\bar{s}) = \bar{\mathbf{c}}(\varphi(s))$ of \overline{C} . Thus, (C, \overline{C}) is a mate of (1,3)-Bertrand curve in \mathbb{E}_2^4 .

Finally, the proof of the theorem is completed. \blacksquare
