THE SOLUTION OF THE GLOBAL RELATION FOR THE DERIVATIVE NONLINEAR SCHRÖDINGER EQUATION ON THE HALF-LINE

Abstract. We consider initial-boundary value problems for the derivative nonlinear Schrödinger (DNLS) equation on the half-line $x > 0$. In a previous work, we showed that the solution $q(x, t)$ can be expressed in terms of the solution of a Riemann-Hilbert problem with jump condition specified by the initial and boundary values of $q(x, t)$. However, for a well-posed problem, only part of the boundary values can be prescribed; the remaining boundary data cannot be independently specified, but are determined by the so-called global relation. In general, an effective solution of the problem therefore requires solving the global relation. Here, we present the solution of the global relation in terms of the solution of a system of nonlinear integral equations. This also provides a construction of the Dirichlet-to-Neumann map for the DNLS equation on the half-line.

1. INTRODUCTION

The derivative nonlinear Schrödinger (DNLS) equation

$$
iq_t + q_{xx} = i\left(|q|^2q\right)_x,\tag{1.1}
$$

where $q(x, t)$ is a complex-valued function, arises in the study of wave propagation in optical fibers $[1]$ and in plasma physics $[6]$ (see $[7]$ for further references). It is an integrable equation and the initial value problem on the line can be analyzed by means of the Inverse Scattering Transform (IST) as demonstrated by Kaup and Newell [\[8\]](#page-18-4). In the last fifteen years, a generalization of the IST to initial-boundary value (IBV) problems developed by Fokas and his collaborators [\[9,](#page-18-5) [10,](#page-18-6) [12\]](#page-18-7), has made it possible to analyze equations such as [\(1.1\)](#page-0-1) on domains involving a boundary. Several of the most well-known integrable PDEs (such as the KdV, modified KdV, nonlinear Schrödinger (NLS), sine-Gordon, and Ernst equations) have been investigated using this approach, see e.g. [\[4,](#page-18-8) [5,](#page-18-9) [13,](#page-18-10) [15,](#page-18-11) [17,](#page-18-12) [18,](#page-18-13) [19,](#page-19-0) [20\]](#page-19-1).

Recently, the Fokas method was implemented to the DNLS equation [\(1.1\)](#page-0-1) posed on the half-line $x > 0$ [\[16\]](#page-18-14).^{[1](#page-1-0)} Provided that the solution exists, it was shown in [16] that the solution $q(x, t)$ can be recovered from the initial and boundary data via the solution of a 2×2 -matrix Riemann–Hilbert (RH) problem. The jump matrix for this RH problem is given explicitly in terms of four spectral functions $a(k)$, $b(k)$, $A(k)$, and $B(k)$, where $k \in \mathbb{C}$ is the spectral parameter of the associated Lax pair. The functions $a(k)$ and $b(k)$ are defined in terms of the initial data $q_0(x) = q(x, 0)$ via a system of linear Volterra integral equations. The functions $A(k)$ and $B(k)$ are defined in terms of the boundary data $g_0(t) = q(0, t)$ and $g_1(t) = q_x(0, t)$ also via a system of linear Volterra integral equations. However, for a well-posed problem, only one of the functions q_0 and q_1 (or a combination of these two functions) can be specified; the remaining boundary data cannot be independently specified, but are determined by the so-called global relation. Thus, before the functions $A(k)$ and $B(k)$ can be constructed from the above linear integral equations, the global relation must first be used to eliminate the unknown boundary data.

The analysis of the global relation can take place in two different domains: in the physical domain or in the spectral domain. Although these two domains are related by a transform, each viewpoint has its own advantages.

In the first part of this paper, we analyze the global relation in the spectral domain. We will show that $A(k)$ and $B(k)$ can be determined via the solution of a system of nonlinear integral equations formulated explicitly in terms of the initial data and the known boundary values.

In the second part of the paper, we analyze the global relation in the physical domain. We use a Gelfand-Levitan-Marchenko (GLM) representation to derive an expression for the generalized Dirichlet-to-Neumann map (i.e. the map which determines the unknown boundary values from the known ones). Once the unknown boundary values have been determined, $A(k)$ and $B(k)$ can be constructed from the linear integral equations mentioned earlier. This representation has the numerical advantage that the system of integral equations is defined on a bounded domain.

In the case of the NLS equation, a construction of the Dirichlet-to-Neumann map was presented in [\[2,](#page-18-15) [11\]](#page-18-16). The Dirichlet-to-Neumann map for the sine-Gordon equation as well as the two versions of mKdV were analyzed in [\[11\]](#page-18-16). The analysis of the KdV equation presents some novel difficulties which were finally overcome in [\[21\]](#page-19-2). Although our approach is inspired by the preceeding references, the analysis here presents a number of novelties: (a) The solution of the global relation presented in section [3](#page-4-0) takes place entirely in the spectral domain. This is in contrast to the approach of [\[11\]](#page-18-16), in which it is necessary to derive a GLM representation for an appropriate eigenfunction of the Lax pair before an analogous result can be obtained. The introduction of a GLM representation amounts to passing from the spectral to the physical plane. Here we remain in the spectral plane throughout the derivation, which simplifies the arguments both on a practical and on a conceptual level. The observation that it is possible to solve the global relation directly in the spectral plane was first made for the NLS equation in [\[14\]](#page-18-17). (b) In the special, but important, case of vanishing initial data $q_0 = 0$, we will show that a further analysis of the global relation can be used to simplify the integral equations derived in the physical plane considerably. In fact, the number of equations reduces from five to two in this

¹Physically, this type of initial-boundary value problem arises naturally. For example, assuming that we can create or measure the waves at some fixed point $x = 0$ in space, we arrive at an initialboundary value problem on the half-line with initial data given by the initial wave profile for $x > 0$ and boundary data provided by the measurements at $x = 0$.

case. The case of vanishing initial data is of special interest in applications, where it can sometimes be assumed that the physical field under consideration is initially at rest before exteriorly created waves enter the domain. This is also the relevant initial condition in the application of the numerical methods based on the so-called "exact nonreflecting boundary conditions" [\[22\]](#page-19-3). A similar simplification for the NLS equation was presented in $[14]$. (c) The Lax pair for equation (1.1) contains terms of higher order in the spectral parameter k than what is the case for the examples above. However, by utilizing additional symmetries, calculations can still be kept at a reasonable length. (d) As noted in [\[16\]](#page-18-14), the definition of eigenfunctions with the appropriate asymptotics of the Lax pair of [\(1.1\)](#page-0-1) naturally leads to the introduction of a certain closed two-form Δ . In order to close the system of integral equations which characterizes the solution of the global relation, the system must be supplemented by an additional (somewhat complicated) equation for the second component of Δ .

The paper is organized as follows: In section [2,](#page-2-0) we recall the Lax pair formulation and the global relation associated with [\(1.1\)](#page-0-1). In sections [3](#page-4-0) and [5,](#page-12-0) the global relation is analyzed in the spectral and physical domains, respectively. In section [4,](#page-9-0) we derive a GLM representation for an appropriate eigenfunction of the Lax pair.

2. A Lax pair and the global relation

Equation [\(1.1\)](#page-0-1) admits the Lax pair [\[8\]](#page-18-4)

where $\sigma_3 = \text{diag}(1, -1)$, $k \in \hat{\mathbb{C}} = \mathbb{C} \cup \{\infty\}$ is a spectral parameter, $\Psi(x, t, k)$ is a 2×2 -matrix valued eigenfunction, and the 2×2 -matrix valued functions $Q(x, t)$ and $\{U_j(x,t,k)\}_{1}^2$ are defined by

Q = \begin{pmatrix} 0 & q \\ \bar{q} & 0 \end{pmatrix}, \qquad U_1 = kQ, \qquad U_2 = 2k^3Q - ik^2Q^2\sigma_3 - ikQ_x\sigma_3 + kQ^3.

Following [\[16\]](#page-18-14), we define a transformed eigenfunction $\mu(x, t, k)$ by

\Psi(x,t,k) = e^{i \int_{(0,0)}^{(x,t)} \Delta \sigma_3} \mu(x,t,k) e^{i \int_{(\infty,0)}^{(0,0)} \Delta \sigma_3},

where $\Delta = \Delta_1 dx + \Delta_2 dt$ is the closed real-valued one-form

\Delta(x,t) = \frac{1}{2}|q|^2 dx + \left(\frac{3}{4}|q|^4 - \frac{i}{2}(\bar{q}_x q - \bar{q}q_x)\right) dt.

We introduce $\mathcal{Q}(x,t)$ and $\mathcal{Q}_1(x,t)$ by

$$
Q = e^{-i \int_{(0,0)}^{(x,t)} \Delta \hat{\sigma}_3} Q, \qquad Q_1 = e^{-i \int_{(0,0)}^{(x,t)} \Delta \hat{\sigma}_3} Q_x,
$$

where $\hat{\sigma}_3$ acts on a 2 × 2 matrix A by $\hat{\sigma}_3 A = [\sigma_3, A]$, i.e. $e^{\hat{\sigma}_3} A = e^{\sigma_3} A e^{-\sigma_3}$. The function μ satisfies the Lax pair

\mu_t + 2ik^4[\sigma_3, \mu] = V_2 \mu,\n\end{cases}

where the 2 \times 2-matrix valued functions $\{V_j(x,t,k)\}^2_1$ are given by

$$
V_1 = k\mathcal{Q} - i\Delta_1\sigma_3, \qquad V_2 = 2k^3\mathcal{Q} - ik^2\mathcal{Q}^2\sigma_3 - ik\mathcal{Q}_1\sigma_3 + k\mathcal{Q}^3 - i\Delta_2\sigma_3. \tag{2.5}

Let $T > 0$ be some given final time; we will assume that $T < \infty$. Assume that $q(x, t)$ is a solution of [\(1.1\)](#page-0-1) with sufficient smoothness in the domain $\{0 < x < \infty, 0 < t < T\}$

and with sufficient decay as $x \to \infty$. We introduce three solutions $\{\mu_j(x, t, k)\}_{1}^3$ of [\(2.4\)](#page-2-1) as the solutions of the following linear Volterra integral equations:

\mu_j(x,t,k) = I + \int_{(x_j,t_j)}^{(x,t)} e^{i[k^2(x'-x) + 2k^4(t'-t)]\hat{\sigma}_3} \left((V_1\mu_j)(x',t',k)dx' + (V_2\mu_j)(x',t',k)dt' \right),\tag{2.6}

where $(x_1, t_1) = (0, T), (x_2, t_2) = (0, 0), (x_3, t_3) = (\infty, t)$, and I denotes the 2×2 identity matrix. The eigenfunctions $\{\mu_j\}_1^3$ satisfy the symmetries

\mu_j(x,t,k) = \sigma_1 \overline{\mu_j(x,t,k)} \sigma_1, \qquad \mu_j(x,t,k) = \sigma_3 \mu_j(x,t,-k) \sigma_3, \qquad j = 1,2,3. \tag{2.7}

The first of these symmetries implies that we can introduce complex-valued functions $a(k), b(k), A(k), B(k), \Phi_1(t, k), \Phi_2(t, k)$ by

\mu_2(0, t, k) = \begin{pmatrix} \overline{\Phi_2(t, \overline{k})} & \Phi_1(t, k)e^{-2i\int_{(0,0)}^{(0, t)} \Delta} \\ \overline{\Phi_1(t, \overline{k})}e^{2i\int_{(0,0)}^{(0, t)} \Delta} & \Phi_2(t, k) \end{pmatrix},
$$
\n(2.8)

where $s(k)$ and $S(k)$ are defined by

$$
s(k) = \mu_3(0, 0, k), \qquad S(k) = [e^{2ik^4T\hat{\sigma}_3}\mu_2(0, T, k)]^{-1}.
$$
 (2.9)

Since $a(k) = a(-k)$, the zeros of $a(k)$ always come in pairs; if k_j is a zero, then so is $-k_i$.

The function $\mu_3(x, 0, k)$, and hence also $s(k)$, can be constructed from the initial data $q_0(x)$ via the linear Volterra integral equation

$$
\mu_3(x,0,k) = I + \int_{\infty}^x e^{ik^2(x'-x)\hat{\sigma}_3}(V_1\mu_3)(x',0,k)dx'. \tag{2.10}
$$

Similarly, $\mu_2(0, t, k)$, and hence also $S(k)$, can be constructed from the boundary values $g_0(t)$ and $g_1(t)$ via the linear Volterra integral equation

$$
\mu_2(0, t, k) = I + \int_0^t e^{2ik^4(t'-t)\hat{\sigma}_3}(V_2\mu_2)(0, t', k)dt'. \tag{2.11}
$$

Defining the sets D_j , $j = 1, \ldots, 4$, by (see figure [1\)](#page-4-1)

$$
D_j = \{(j-1)\pi/2 < \arg(k^2) < j\pi/2\},\,
$$

it follows from [\(2.10\)](#page-3-1)-[\(2.11\)](#page-3-2) that $a(k)$ and $b(k)$ are analytic and bounded in $D_1 \cup D_2$, while $A(k)$ and $B(k)$ are entire functions which are bounded in $D_1 \cup D_3$. The functions $\Phi_1(t, k)$ and $\Phi_2(t, k)$ are entire functions of k which are bounded for $k \in D_2 \cup D_4$.

2.1. The global relation. The eigenfunctions μ_2 and μ_3 are related by

\mu_3(x,t,k) = \mu_2(x,t,k)e^{-i(k^2x + 2k^4t)\hat{\sigma}_3}s(k),\tag{2.12}

where the first and second columns are valid for $k \in \bar{D}_3 \cup \bar{D}_4$ and $k \in \bar{D}_1 \cup \bar{D}_2$, respectively. The relation obtained by evaluating (2.12) at $(0,t)$ is called the *global* relation. It imposes a relation between the Dirichlet and Neumann boundary values of $q(x, t)$. The Dirichlet-to-Neumann map is determined by solving this relation for the unknown boundary values. Defining functions $c(t, k)$ and $d(t, k)$ by

c(t,k) = \frac{e^{2i \int_{(0,0)}^{(0,t)} \Delta} (\mu_3(0,t,k))_{12}}{a(k)} \qquad d(t,k) = \frac{1}{a(k)} (\mu_3(0,t,k))_{22},

we can write the (12) and (22) entries of the global relation as

$$
c(t,k) = \Phi_1(t,k) + e^{2i \int_{(0,0)}^{(0,t)} \Delta} \frac{b(k)}{a(k)} \overline{\Phi_2(t,\bar{k})} e^{-4ik^4t}, \qquad k \in \bar{D}_1 \cup \bar{D}_2,
$$
 (2.13a)

$$
d(t,k) = \Phi_2(t,k) + e^{2i \int_{(0,0)}^{(0,t)} \Delta} \frac{b(k)}{a(k)} \overline{\Phi_1(t,\bar{k})} e^{-4ik^4t}, \qquad k \in \bar{D}_1 \cup \bar{D}_2.
$$

We find from the definition of μ_3 that the functions $c(t, k)$ and $d(t, k)$ are analytic and bounded for $k \in D_1 \cup D_2$ away from the possible zeros of $a(k)$.

3. The solution of the global relation: spectral domain

In this section we analyze the global relation in the spectral plane. For concreteness, we consider the Dirichlet problem; the treatment of the Neumann problem is analogous. The main result is theorem [3.1,](#page-4-2) which expresses the spectral functions $A(k)$ and $B(k)$ in terms of the Dirichlet boundary data and the initial data via the solution of a system of nonlinear integral equations.

For a subset $\Sigma \subset \mathbb{C}$ of the complex k-plane, we let $\partial \Sigma$ denote the boundary of Σ , oriented so that Σ lies to the left of $\partial \Sigma$. We let $D_j^+ = D_j \cap {\{\text{Im } k \geq 0\}}$, $j = 1, ..., 4$. Moreover, we let γ denote the contour ∂D_1^+ and let γ' denote a contour obtained from γ by deforming it so that it does not surround the possible zeros of $a(k)$, see figure [2.](#page-5-0)

Theorem 3.1. Let $T < \infty$. Let $q_0(x)$, $x \ge 0$, be a function of Schwartz class and let $g_0(t)$, $0 \le t < T$, be a sufficiently smooth function. Assume that q_0 and q_0 are compatible at $x = t = 0$ in the sense that $q_0(0) = g_0(0)$. Let $a(k)$ and $b(k)$ be defined for $k \in \bar{D}_1 \cup \bar{D}_2$ by equations [\(2.8\)](#page-3-4)-[\(2.10\)](#page-3-1). Suppose that $a(k)$ has a finite (possibly empty) set of simple zeros. We denote these zeros by $\{k_j, -k_j\}_1^N$ and assume that ${k_j}_{1}^{N} \subset D_1.$

Then the spectral functions $A(k)$ and $B(k)$ defined by [\(2.8\)](#page-3-4)-[\(2.9\)](#page-3-5) are given by

A(k) = \overline{\Phi_2(T,\bar{k})} \qquad B(k) = -\Phi_1(T,k)e^{4ik^4T}e^{-2i\int_0^T \Delta_2(0,t)dt}, \tag{3.1}

where the complex-valued functions $\Phi_1(t, k)$, $\Phi_2(t, k)$ and the real-valued function $\Delta_2(0,t)$ satisfy the following system of nonlinear integral equations:

&+ \int_{0}^{t} \begin{pmatrix} e^{4ik^{4}(t'-t)} \left[(-i|g_{0}|^{2}k^{2}+i\Delta_{2})\Phi_{1}+k\left(|g_{0}|^{2}g_{0}+2k^{2}g_{0}+ig_{1}\right)\Phi_{2}\right](t',k)\\ \left[k\left(|g_{0}|^{2}\bar{g}_{0}+2k^{2}\bar{g}_{0}-i\bar{g}_{1}\right)\Phi_{1}+(i|g_{0}|^{2}k^{2}+i\Delta_{2})\Phi_{2}\right](t',k)\\ \Delta_{2}(0,t) &= \frac{1}{4}|g_{0}(t)|^{4} - 4\text{Im}(\bar{g}_{0}(t)c^{(3)}(t))\\ \n&-2|g_{0}(t)|^{2}\text{Im}\left[\frac{2}{\pi}\int_{\gamma}k\left[\Phi_{2}(t,k)-\Phi_{2}(t,ik)\right]dk\right],\n\end{split} \tag{3.2b}

where the functions $g_1(t)$ and $c^{(3)}(t)$ are given for $0 \le t < T$ by

Proof. Letting $g_1(t) := q_x(0, t)$, equations [\(3.1\)](#page-4-3) and [\(3.2a\)](#page-5-1) follow from the definition of Φ_1 and Φ_2 together with [\(2.4\)](#page-2-1). In order to derive [\(3.3\)](#page-5-2), we substitute the expansion

into [\(2.4\)](#page-2-1) and solve for the $\mu_i^{(n)}$ $j^{(n)}$'s. By the second symmetry in [\(2.7\)](#page-3-6), $\mu_j^{(n)}$ $j^{(n)}$ is a diagonal (off-diagonal) matrix for *n* even (odd). We find (see [\[16\]](#page-18-14) for further details of this type of argument)

Thus, as $k \to \infty$,

e^{2i \int_{(0,0)}^{(x,t)} \Delta} (\mu_j(x,t,k))_{12} = -\frac{iq}{2k} + \frac{1}{k^3} \left(\frac{q_x}{4} - \frac{iq}{2} \int_{(x_j,t_j)}^{(x,t)} \omega - \frac{i}{8} |q|^2 q \right) + O\left(\frac{1}{k^5}\right),

(\mu_j(x,t,k))_{22} = 1 + \frac{1}{k^2} \int_{(x_j,t_j)}^{(x,t)} \omega + O\left(\frac{1}{k^4}\right),

where the closed one-form ω is defined by

\omega = \left(\frac{1}{4}\bar{q}q_x - \frac{i}{8}|q|^4\right)dx - \frac{i}{4}\left(|q|^6 + 3i|q|^2\bar{q}q_x + |q_x|^2 - \bar{q}q_{xx}\right)dt.

The expansions in [\(3.5\)](#page-6-0) are valid for k approaching ∞ within the regions of boundedness of $(\mu_j)_{12}$ and $(\mu_j)_{22}$. Hence,

\Phi_2(t,k) = 1 + \frac{\Phi_2^{(2)}(t)}{k^2} + O\left(\frac{1}{k^4}\right), \qquad k \to \infty, \quad k \in D_2 \cup D_4,

where

c^{(3)}(t) = \frac{g_1}{4} - \frac{ig_0}{2} \int_{(0,0)}^{(0,t)} \omega - \frac{i}{8} |g_0|^2 g_0, \qquad \Phi_2^{(2)}(t) = \int_{(0,0)}^{(0,t)} \omega.
$$

It follows that

g_1(t) = \frac{i}{2}|g_0|^2 g_0 + 4c^{(3)} + 2ig_0 \Phi_2^{(2)}, \qquad 0 \le t < T. \tag{3.7}

The function $\Phi_2(t, k) - \Phi_2(t, ik)$ is an entire function of k and satisfies

Letting C_R , $R > 0$, denote the large arc of radius R which closes D_2^+ at infinity,

A change of variables $k \to ik$ in the part of the integration that runs along the imaginary axis shows that the contour ∂D_2^+ in [\(3.8\)](#page-6-1) can be replaced by $-\gamma$. Thus, equations (3.7) and (3.8) yield (3.3) .

Substituting the expression [\(3.7\)](#page-6-2) for g_1 into the definition [\(2.3\)](#page-2-2) of Δ evaluated at $(0, t)$, we find

Letting $\epsilon \to 0$ and using the global relation [\(2.13a\)](#page-4-4) to eliminate $c(t, k)$ and $c(t, ik)$ from the integrand, we find

The integrand in the first term on the right-hand side is analytic in D_2 and of $O(1/k^3)$ as $k \to \infty$ in D_2 . Thus, the contour of integration $\Gamma = \partial D_1 + \partial D_2$ in this term can be replaced by ∂D_1 . Using the change of variables $k \to -ik$, we find that the second term on the right-hand side of [\(3.10\)](#page-7-0) equals

The symmetry properties (2.7) imply that both integrands in (3.12) are odd functions of k . Thus, we obtain

If $a(k)$ has a finite number of simple zeros $\{k_j, -k_j\}_1^N \subset D_1 \cup D_2$, we replace equation [\(3.9\)](#page-7-3) with

where $c_j(t)$, $j = 1, ..., N$, denotes the residue of $c(t, k)$ at $k = k_j$, i.e.

The contribution to $c^{(3)}$ from the term on the right-hand side of [\(3.13\)](#page-8-0) that involves the residues $\{c_j\}_1^N$ is therefore $2\sum_{j=1}^N c_j k_j^2$. The effect of the term involving the c_j 's on the left-hand side of (3.13) is to add another $2\sum_{j=1}^{N}c_{j}k_{j}^{2}$ to $c^{(3)}(t)$. Finally, when replacing the contour in (3.11) with ∂D_{1} , we now pick up a sum of residues from the zeros of $a(k)$ in D_2 ; this contributes an additional $-4\sum_{k_j\in D_2^+} c_j k_j^2$ to $c^{(3)}$. The total net contribution to $c^{(3)}(t)$ from the residues at the zeros of $a(k)$ is therefore

In [\[16\]](#page-18-14), the solution $q(x, t)$ was presented in terms of the solution of a matrix RH problem with jump condition specified by the spectral functions $a(k)$, $b(k)$, $A(k)$, and $B(k)$. Substitution of the expressions [\(3.3\)](#page-5-2) and [\(3.4\)](#page-5-4) into [\(3.2\)](#page-5-5) yields a system of nonlinear integral equations involving the functions $\Phi_1(t, k)$, $\Phi_2(t, k)$, and $\Delta_2(0, t)$. Assuming that this system has a unique solution, $A(k)$ and $B(k)$ can be determined from [\(3.1\)](#page-4-3).

When $a(k) \neq 0$, the functions $A(k)$ and $B(k)$ only enter the formulation of the RH problem as the combination $A(k)/B(k)$ for $k \in \partial D_3$. Then it is sufficient to consider the system satisfied by $\Phi_1(t, k)$, $\Phi_2(t, k)$, and $\Delta_2(0, t)$ for $0 \leq t < T$ and $k \in \partial D_1 \cup \partial D_3$; the function $A(k)/B(k)$, $k \in \partial D_3$, can be recovered from the solution

of this system. In the case when $a(k)$ has zeros, the residue conditions also need to be taken into account.

Remark 3.2. 1. By replacing in the right-hand side of [\(3.4\)](#page-5-4) the contour γ by the contour γ' which does not surround the zeros of $a(k)$ (see figure [2\)](#page-5-0), the sum over $k_j \in D_1^+$ can be absorbed into the preceding integral.

2. The integrals along γ which appear on the right-hand sides of [\(3.2b\)](#page-5-3)-[\(3.4\)](#page-5-4) are, in general, not absolutely convergent; they are defined as the limits as $R \to \infty$ of the integrals obtained by replacing γ with γ_R , where $\gamma_R = [Re^{\pi i/4}, 0] \cup [0, R]$.

4. The GLM representation

In this section we derive Gelfand-Levitan-Marchenko (GLM) representations for the eigenfunctions $\{\Phi_j\}_1^2$. These representations will be needed in section [5.](#page-12-0)

Proposition 4.1. Suppose $q(x,t)$ is a solution of [\(1.1\)](#page-0-1) with sufficiently smooth boundary data $g_0(t) = q(0,t)$ and $g_1(t) = q_x(0,t)$, $0 \le t < T$. The functions Φ_1 and Φ_2 defined in [\(2.8\)](#page-3-4) can be represented as

The symmetries

suggest that we seek L, \tilde{M} , \tilde{N} , \tilde{J} such that \tilde{J} and \tilde{M} (resp. L and \tilde{N}) are diagonal (resp. off-diagonal) matrices, and such that

In fact, introducing complex-valued functions $\{n(t, s), m(t, s), l(t, s), j(t, s)\}\$

a long computation shows that the two sets of equations [\(4.10\)](#page-11-0) and [\(4.11\)](#page-12-1) are satisfied provided that ${n, m, l, j}$ satisfy the initial conditions [\(4.3\)](#page-9-1) and the ODEs [\(4.4\)](#page-9-2), respectively.

Equations (4.7) , (4.9) , and (4.12) imply that

where $\{I_j\}_0^3$ are given by [\(4.2\)](#page-9-3). The relations

5. The solution of the global relation: physical domain

In this section, we consider the solution of the global relation in the physical domain. Theorems [5.1](#page-13-1) and [5.3](#page-16-1) below lead to expressions for the Dirichlet-to-Neumann map in terms of the solution of a system of nonlinear integral equations. Theorem [5.1](#page-13-1) applies to arbitrary initial data. Theorem [5.3](#page-16-1) provides a more convenient expression for the Dirichlet-to-Neumann map in the special, but important, case of vanishing initial data.

5.1. The general case. For a function $F(t, s)$, $-t < s < t$, we let A denote the Abel transform in the second variable defined by

The inverse \mathcal{A}^{-1} of this transform is given by

(\mathcal{A}^{-1}F)(t,s) = \frac{1}{\pi} \frac{d}{ds} \int_{-t}^{s} \frac{F(t,s')ds'}{\sqrt{s-s'}} = \frac{1}{\pi} \left[\int_{-t}^{s} \frac{\frac{\partial F}{\partial s'}(t,s')ds'}{\sqrt{s-s'}} + \frac{F(t,-t)}{\sqrt{t+s}} \right].
$$

Theorem 5.1. Let $q_0(x)$, $g_0(t)$, $a(k)$, and $b(k)$ be as in theorem [3.1](#page-4-2) and let $\{k_j, -k_j\}_1^N \subset$ $D_1 \cup D_2$ denote the possible simple zeros of $a(k)$. Define functions $f_0(t)$ and $f_2(t)$, $t > 0, by$

where γ' is the contour defined in section [3.](#page-4-0) Let $q(x,t)$, $x > 0$, $0 < t < T$, be a solution of the DNLS equation (1.1) which satisfies

Let $\{n, m, l, j\}$ be the functions in the GLM representation [\(4.1\)](#page-9-4).

Then the Neumann boundary data $g_1(t) := q_x(0, t)$ are given by

where $c_1 \in \mathbb{C}$ is a constant defined by

Proof. Substituting the GLM representation (4.1) into the global relation $(2.13a)$, we find the following equation which is valid for $k \in \bar{D}_1 \cup \bar{D}_2$:

We multiply this equation by $k^2 e^{2ik^4(t-s)}$, $-t < s < t$, and integrate the resulting equation with respect to dk along γ' . This yields

\times \int_{\gamma'} k^2 \frac{b(k)}{a(k)} \left[e^{-2ik^2(t+s)} + \int_{-t}^t \left(\bar{I}_0(t,s') + \bar{I}_2(t,s')k^2 \right) e^{-2ik^4(s'+s)} ds' \right] dk = 0,
$$

where the right-hand side is zero because of Jordan's lemma. Analyticity implies that the contour γ' can be replaced by γ in the first integral in [\(5.4\)](#page-13-2). Using the Fourier inversion identity[2](#page-14-0)

In order to simplify the term in (5.4) involving I_3 , we integrate by parts as follows:

We can now interchange the order of integration in the integral on the right-hand side involving $I_{3s'}$. Using the identity

= $-\frac{1}{2i} \int_{\gamma'} \frac{b(k)}{a(k)} \left[\bar{I}_2(t, t) e^{-2ik^4(t+s)} - \bar{I}_2(t, -t) e^{-2ik^4(-t+s)} - \int_{-t}^t \bar{I}_{2s'}(t, s') e^{-2ik^4(s'+s)} ds' \right] dk.$

Expressing the integrals with respect to dk on the right-hand side in terms of f_0 , we infer that the term in [\(5.4\)](#page-13-2) involving \bar{I}_2 equals

²This identity can be less rigorously expressed as $\int_{\gamma} k^3 e^{2ik^4(s'-s)} dk = \frac{\pi}{4} \delta(s'-s)$.

Using equations (5.6) and $(5.8)-(5.10)$ $(5.8)-(5.10)$, we can write (5.4) as

Recalling the definitions [\(4.2\)](#page-9-3) of $\{I_j\}_0^3$ and the initial conditions [\(4.3\)](#page-9-1), evaluation of this equation as $s \to t$ yields

\frac{\pi}{4} \left(\frac{1}{2} |g_0(t)|^2 g_0(t) + \frac{i}{2} g_1(t) - \frac{i}{2} g_0(t) m(t, t) \right) - \frac{c_1 \pi}{2i} (\mathcal{A}^{-1} n)(t, t) + e^{2i \int_{(0,0)}^{(0,t)} \Delta} \left\{ f_2(2t) + \int_{-t}^{t} \left[\bar{j}(t, s) - \frac{i}{2} g_0(t) \bar{l}(t, s) + \left(\frac{i}{8} |g_0(t)|^2 g_0(t) + \frac{1}{2i} l(t, t) \right) \bar{n}(t, s) \right] f_2(t + s) ds - \frac{1}{2i} \left[\left(\bar{m}(t, t) - \frac{i}{2} |g_0(t)|^2 \right) f_0(2t) + \frac{i}{2} g_0(t) \bar{n}(t, -t) f_0(0) \right] - \int_{-t}^{t} \left(\bar{m}_s(t, s) - \frac{i}{2} g_0(t) \bar{n}_s(t, s) \right) f_0(t + s) ds \right] = 0,
$$
\n(5.11)

Since

$$
\frac{b(k)}{a(k)} = -\frac{iq_0(0)}{2k} + O\left(\frac{1}{k^3}\right), \qquad k \to \infty, \quad k \in D_1 \cup D_2,
$$

we find

$$
f_0(0) = \int_{\gamma'} \frac{b(k)}{a(k)} dk = -\int_{\gamma'} \frac{i q_0(0)}{2k} dk = -\frac{\pi q_0(0)}{8}.
$$
 (5.12)

Solving equation [\(5.11\)](#page-15-0) for $g_1(t)$ and using [\(5.12\)](#page-15-1), we find [\(5.2\)](#page-13-5).

Substitution of the expression [\(5.2\)](#page-13-5) for $q_1(t)$ into [\(4.4\)](#page-9-2) yields a nonlinear system of integro-differential equations involving $\{n, m, l, j\}$ and Δ_2 . Employing the identities

$$
(\partial_t - \partial_s)F(t,s) = f(t,s) \implies F(t,s) = F\left(\frac{t+s}{2}, \frac{t+s}{2}\right) + \int_{\frac{t+s}{2}}^t f(\tau, t+s-\tau) d\tau,
$$
\n(5.13)

$$
(\partial_t + \partial_s)F(t,s) = f(t,s) \implies F(t,s) = F\left(\frac{t-s}{2}, -\frac{t-s}{2}\right) + \int_{\frac{t-s}{2}}^t f(\tau, \tau - t + s)d\tau,
$$

and recalling the initial conditions in [\(4.3\)](#page-9-1), we can convert this into a system of nonlinear integral equations. Supplementing this system with the equation for Δ_2 obtained by substituting the expression (5.2) for $g_1(t)$ into the equation

$$
\Delta_2(0,t) = \frac{3}{4} |g_0|^4 - \frac{i}{2} (\bar{g}_1 g_0 - \bar{g}_0 g_1),
$$

we find a closed system of nonlinear integral equations for the complex-valued functions $\{n(t, s), m(t, s), l(t, s), j(t, s)\}, |s| \le t < T$ and the real-valued function $\Delta_2(0, t)$, $0 < t < T$. This system is formulated explicitly in terms of the initial data $q_0(x)$ and the Dirichlet boundary data $g_0(t)$. Once the solution of this system has been found,^{[3](#page-15-2)} the Neumann data $g_1(t)$ can be determined from [\(5.2\)](#page-13-5). This provides an effective way of computing the Dirichlet-to-Neumann map.

³The problem of rigorously showing existence and uniqueness for this system remains open.

Remark 5.2. The expression [\(5.2\)](#page-13-5) for g_1 in terms of $\{n, m, l, j\}$ can also be derived directly from the expression (3.3) for g_1 given in theorem [3.1.](#page-4-2) Indeed, (3.3) states that g_1 is given by

$$
g_1 = \frac{i}{2}|g_0|^2 g_0 + 4c^{(3)} + 2ig_0 \Phi_2^{(2)},
$$
\n(5.14)

where $c^{(3)}$ is given by (3.4) and

$$
\Phi_2^{(2)} = \frac{2}{\pi i} \int_{\gamma} k[\Phi_2(t, k) - \Phi_2(t, ik)]dk.

Substituting the GLM representation [\(4.1\)](#page-9-4) for Φ_2 into [\(5.15\)](#page-16-2) and using the identity [\(5.5\)](#page-14-4), we conclude that

On the other hand, we can write $c^{(3)}$ as the sum of two terms, $c^{(3)} = c_1^{(3)} + c_2^{(3)}$ $2^{(5)}$, where

Using the identity [\(5.7\)](#page-14-5) and the initial condition $n(t, t) = g_0(t)$, this gives

Finally, simplifying $c_2^{(3)}$ $\binom{3}{2}$ as in the proof of theorem [5.1,](#page-13-1) we deduce that $c_2^{(3)}$ $2^{(3)}$ is given by the terms on the right-hand side of equation [\(5.2\)](#page-13-5) which involve the functions f_0 and f_2 . In summary, after collecting the various contributions, we conclude that (5.2) can be derived from [\(3.3\)](#page-5-2).

5.2. The case of vanishing initial data. With respect to the integral equations derived in the spectral domain (see theorem [3.1\)](#page-4-2), the system of integral equations derived in section [5.1](#page-13-0) has the numerical advantage of being defined on the *bounded* domain $|s| \leq t \leq T$. Nevertheless, the system of section [5.1](#page-13-0) involves five highly nonlinear and rather intricate equations. The next theorem shows that this system can be simplified considerably in the case of vanishing initial data $q_0(x) = 0$.

Theorem 5.3. Suppose that $q_0(x) = 0$, $x \ge 0$. Let $g_0(t)$ and $q(x, t)$ be as in theorem [5.1.](#page-13-1) Then the Neumann boundary data $g_1(t) := q_x(0,t)$ are given by

$$
g_1(t) = i|g_0(t)|^2 g_0(t) - 4c_1(\mathcal{A}^{-1}n)(t, t) + g_0(t)m(t, t),
$$
\n(5.18)

where c_1 is given by [\(5.3\)](#page-13-3) and the functions $\{n(t, s), m(t, s)\}, |s| \le t < T$, satisfy the following system of two nonlinear integral equations:

n(t,s) = g_0\left(\frac{t+s}{2}\right) + \int_{\frac{t+s}{2}}^t \left[\beta_1(\tau)n + \beta_2(\tau)m + \beta_3(\tau)(\mathcal{A}^{-1}m)\right]d\tau, \tag{5.19a}

m(t,s) = \int_{\frac{t-s}{2}}^{t} \left[\beta_4(\tau)m + \beta_5(\tau)n + \beta_6(\tau)(\mathcal{A}^{-1}n) \right] d\tau,

Unless otherwise specified, the functions in [\(5.19a\)](#page-16-4) are evaluated at $(\tau, t + s - \tau)$ and the functions in [\(5.19b\)](#page-16-5) are evaluated at $(\tau, \tau - t + s)$.

Proof. The expression [\(5.18\)](#page-16-6) for $q_1(t)$ is obtained by setting $f_0(k) = f_2(k) = q_0(0) = 0$ in [\(5.2\)](#page-13-5). We will use the global relation to eliminate the functions l and j from the equations [\(4.4\)](#page-9-2) for $\{n, m, l, j\}$; this will lead to [\(5.19\)](#page-16-7).

Substituting the GLM representations [\(4.1\)](#page-9-4) into the global relation [\(2.13\)](#page-4-5) and using that $b(k) = 0$, we find

\int_{-t}^{t} (kI_1 + k^3 I_3) e^{2ik^4(s'-t)} ds' = c(k, t),
$$
\n(5.21a)

$$
\int_{-t}^{t} (I_0 + I_2 k^2) e^{2ik^4(s'-t)} ds' = d(k, t) - 1,
$$
\n(5.21b)

where c and $d-1$ are analytic functions of $k \in D_1 \cup D_2$ and of order $O(1/k)$ as $k \to \infty$.

We first analyze [\(5.21a\)](#page-17-0). We multiply (5.21a) by $e^{2ik^4(t-s)}$ with $-t < s < t$ and integrate the resulting equation with respect to dk along γ . This yields

$$
\int_{\gamma} \int_{-t}^{t} (kI_1 + k^3 I_3)(t, s') e^{2ik^4(s'-s)} ds' dk = 0,
$$
\n(5.22)

where the contribution of the right-hand side vanishes by Jordan's lemma. Using the identities (5.5) and (5.7) , equation (5.22) becomes

$$
c_1(\mathcal{A}I_1)(t,s) + \frac{\pi}{4}I_3(t,s) = 0, \qquad -t < s < t. \tag{5.23}
$$

Applying the inverse Abel transform to (5.23) and using the expressions for I_1 and I_3 given in [\(4.2\)](#page-9-3), we find^{[4](#page-17-3)}

$$
c_1\left[l(t,s) - \frac{i}{2}g_0(t)m(t,s)\right] + \frac{\pi}{4}(\mathcal{A}^{-1}n)(t,s) = 0, \qquad -t < s < t. \tag{5.24}
$$

Similarly, we multiply [\(5.21b\)](#page-17-4) by $ke^{2ik^4(t-s)}$ with $-t < s < t$ and integrate the resulting equation with respect to dk along γ . Steps analogous to those that led to [\(5.24\)](#page-17-5) now yield

$$
c_1\left[j(t,s) + \frac{i}{2}\bar{g}_0(t)l(t,s) + \left(\frac{i}{8}|g_0(t)|^2\bar{g}_0(t) + \frac{1}{4}\bar{g}_1(t)\right)n(t,s)\right] \qquad (5.25)
$$

$$
+\frac{\pi}{4}(\mathcal{A}^{-1}m)(t,s) + \frac{\pi i}{8}\bar{g}_0(t)(\mathcal{A}^{-1}n)(t,s) = 0, \qquad -t < s < t.
$$

⁴In view of [\(4.3\)](#page-9-1), evaluation of [\(5.24\)](#page-17-5) as $s \to t$ yields an alternative derivation of [\(5.18\)](#page-16-6).

We solve the equations [\(5.24\)](#page-17-5) and [\(5.25\)](#page-17-6) for j and l and plug the result into the first two equations of [\(4.4\)](#page-9-2). This yields

$$
\begin{pmatrix} n_t - n_s \\ m_t + m_s \end{pmatrix} = \begin{pmatrix} \beta_1 & \beta_2 + \beta_3 \mathcal{A}^{-1} \\ \beta_5 + \beta_6 \mathcal{A}^{-1} & \beta_4 \end{pmatrix} \begin{pmatrix} n \\ m \end{pmatrix},
$$

where $\{\beta_j\}_1^6$ are given by [\(5.20\)](#page-17-7). Using the identities [\(5.13\)](#page-15-3) and the initial conditions (4.3) , we find (5.19) .

Substitution of the expression [\(5.18\)](#page-16-6) for $q_1(t)$ into [\(5.19\)](#page-16-7) yields a system of nonlinear integral equations for $\{n(t, s), m(t, s)\}\, |s| \leq t < T$, formulated entirely in terms of the known boundary values $g_0(t)$. This system only involves two equations for two unknown functions. This is in contrast to the system derived in section [5.1](#page-13-0) in the case of general initial data, which involves five equations.
