Extension of vertex operator algebra $V_{\widehat{H}_4}(\ell, 0)$

Abstract

We classify the irreducible restricted modules for the affine Nappi-Witten Lie algebra \hat{H}_4 with some natural conditions. It turns out the representation theory of \hat{H}_4 is quite different from the theory of representations of Heisenberg algebras. We also study the extension of the vertex operator algebra $V_{\hat{H}_4}(\ell, 0)$ by the even lattice L. We give the structure of the extension $V_{\hat{H}_4}(\ell, 0) \otimes \mathbb{C}[L]$ and its irreducible modules via irreducible representations of $V_{\hat{H}_4}(\ell, 0)$ viewed as a vertex algebra.

1 Introduction

The Nappi-Witten algebra H_4 is a four-dimensional Lie algebra with the basis $\{a, b, c, d\}$ and the following Lie bracket:

$$[a,b] = c, \quad [d,a] = a, \quad [d,b] = -b, \quad [c,d] = [c,a] = [c,b] = 0.$$

There exists a non-degenerate symmetric bilinear form (,) on H_4 defined by

(a,b) = 1, (c,d) = 1, otherwise, (,) = 0.

The associated affine Nappi-Witten Lie algebra is

$$\widehat{H}_4 = H_4 \otimes \mathbb{C}[t, t^{-1}] \oplus \mathbb{C}\mathbf{k}.$$

The study of the affine Nappi-Witten algebra \widehat{H}_4 was initiated by the theory of Wess-Zumino-Novikov-Witten (WZNW) models based on non-abelian non-semisimple groups [31, 27]. WZNW models corresponding to abelian or compact semisimple groups have been studied extensively. The importance of non-abelian non-semisimple types was first noticed in [8, 27]. It was shown in [27] that the NW model corresponding to a central extension of the two-dimensional Euclidean groups describes the spectrum and scattering of strings moving in a gravitational wave background. In [19], irreducible representations with unitary base for the affine NW algebra were constructed through four free fields.

In [1], Verma type modules for the affine Nappi-Witten algebra \hat{H}_4 were investigated. The associated vertex operator algebra $V_{\hat{H}_4}(\ell, 0)$ for a given complex number ℓ and its representations were also studied in [1]. More results on the NW model can be found in [4, 5, 6, 7].

It is known that every restricted \hat{H}_4 -module of level ℓ carries a unique module structure for the vertex algebra $V_{\hat{H}_4}(\ell, 0)$, extending the action of \hat{H}_4 in a canonical way and that every module of the vertex algebra $V_{\hat{H}_4}(\ell, 0)$ is naturally a restricted \hat{H}_4 -module of level ℓ . This leads us to study restricted modules for the affine Lie algebra \hat{H}_4 . On the other hand, let $L = \mathbb{Z}c \otimes \mathbb{Z}d$, then L is a non-degenerate even lattice. Motivated by [22], [23], [24], [25] and [11], we consider the extension $V_{\hat{H}_4}(\ell, 0)[L]$ of $V_{\hat{H}_4}(\ell, 0)$ by L. Some ideas we use come from these papers. For the simple vertex operator algebra $V_{\hat{\mathfrak{g}}}(\ell, 0)$ and an irreducible highest weight $V_{\hat{\mathfrak{g}}}(\ell, 0)$ -module W with \mathfrak{g} a finite-dimensional simple Lie algebra and ℓ a positive integer, or with \mathfrak{g} abelian and $\ell = 1$, it is known that $W^{(\alpha)}$ is still an irreducible highest weight module for the affine Lie algebra $\hat{\mathfrak{g}}$ (cf. [11], [22], [23], [24], [25]), where $\alpha \in \mathfrak{h}$ such that $\alpha(0)$ acts semisimply on V with integral eigenvalues and \mathfrak{h} is a Cartan subalgebra of \mathfrak{g} . But for $V_{\hat{H}_4}(\ell, 0)$, it turns out it is quite different. For general $\alpha \in L$ and an irreducible highest weight \hat{H}_4 -module W, $W^{(\alpha)}$ is not a highest weight module of \hat{H}_4 anymore. We characterize $W^{(\alpha)}$ for every irreducible highest weight module of \hat{H}_4 .

The paper is organized as follows: In Section 2, we recall the various modules, admissible modules and ordinary modules for a vertex operator algebra. We also give some known related results on the affine Nappi-Witten algebra and the associated vertex operator algebra. In section 3, we characterize three types of restricted \hat{H}_4 -modules and their irreducible quotients. Section 4 is devoted to the extension $V_{\hat{H}_4}(\ell, 0)[L]$ and its irreducible modules.

2 Preliminaries

In this section, we briefly review the definitions of vertex operator algebra and various modules (cf. [3], [9], [12], [16], [36], [20], [35]). We also give some known results related to the Nappi-Witten algebra H_4 .

A vertex operator algebra V is a \mathbb{Z} -graded vector space $V = \bigoplus_{n \in \mathbb{Z}} V_n$ equipped with a linear map $Y : V \to (\operatorname{End} V)[[z, z^{-1}]], a \mapsto Y(a, z) = \sum_{n \in \mathbb{Z}} a_n z^{-n-1}$ for $a \in V$ such that dim V_n is finite for all integer n and that $V_n = 0$ for sufficiently small n (see [16]). There are two distinguished vectors, the vacuum vector $\mathbf{1} \in V_0$ and the Virasoro element $\omega \in V_2$. By definition $Y(\mathbf{1}, z) = \operatorname{id}_V$, and the component operators $\{L(n)|n \in \mathbb{Z}\}$ of $Y(\omega, z) = \sum_{n \in \mathbb{Z}} L(n) z^{-n-2}$ give a representation of the Virasoro algebra on V with central charge c. Each homogeneous subspace V_n $(n \geq 0)$ is an eigenspace for L(0) with eigenvalue n. **Definition 2.1.** A weak V-module is a vector space M equipped with a linear map

$$Y_M: \quad V \to (\operatorname{End} M)[[z, z^{-1}]] \\ v \mapsto Y_M(v, z) = \sum_{n \in \mathbb{Z}} v_n z^{-n-1}, \quad v_n \in \operatorname{End} M$$

satisfying the following conditions:

- 1) $v_n w = 0$ for n >> 0 where $v \in V$ and $w \in M$
- 2) $Y_M(\mathbf{1}, z) = \mathrm{Id}_M$
- 3) The Jacobi identity holds:

$$z_0^{-1}\delta\left(\frac{z_1-z_2}{z_0}\right)Y_M(u,z_1)Y_M(v,z_2) - z_0^{-1}\delta\left(\frac{z_2-z_1}{-z_0}\right)Y_M(v,z_2)Y_M(u,z_1)$$
$$= z_2^{-1}\delta\left(\frac{z_1-z_0}{z_2}\right)Y_M(Y(u,z_0)v,z_2).$$
(2.1)

Definition 2.2. An admissible V-module is a weak V-module which carries a \mathbb{Z}_+ -grading $M = \bigoplus_{n \in \mathbb{Z}_+} M(n)$, such that if $v \in V_r$, then $v_m M(n) \subseteq M(n + r - m - 1)$.

Definition 2.3. An ordinary V-module is a weak V-module which carries a \mathbb{C} -grading $M = \bigoplus M_{\lambda}$, such that:

- $\begin{array}{l} \lambda \in \mathbb{C} \\ 1 \quad dim(M_{\lambda}) < \infty, \end{array}$
- 2) $M_{\lambda+n} = 0$ for fixed λ and $n \ll 0$,

3) $L(0)w = \lambda w = \operatorname{wt}(w)w$ for $w \in M_{\lambda}$, where L(0) is the component operator of $Y_M(\omega, z) = \sum_{n \in \mathbb{Z}} L(n) z^{-n-2}$.

Remark 2.4. It is easy to see that an ordinary V-module is an admissible one. If W is an ordinary V-module, we simply call W a V-module.

We now introduce the Nappi-Witten algebra and some known related results. The Nappi-Witten Lie algebra H_4 is a 4-dimensional vector space

$$H_4 = \mathbb{C}a \oplus \mathbb{C}b \oplus \mathbb{C}c \oplus \mathbb{C}d$$

equipped with the bracket relations

$$[a,b] = c, \quad [d,a] = a, \quad [d,b] = -b, \quad [c,d] = [c,a] = [c,b] = 0.$$

and a non-degenerate symmetric bilinear form (,) on H_4 defined by

$$(a,b) = 1, (c,d) = 1,$$
 otherwise, $(,) = 0.$

The Nappi-Witten algebra H_4 is has the following triangular decomposition:

$$H_4 = H_4^+ \oplus H_4^0 \oplus H_4^- = H_4^{\ge 0} \oplus H_4^-,$$

where

$$H_4^+ = \mathbb{C}a, \quad H_4^0 = \mathbb{C}c \oplus \mathbb{C}d, \quad H_4^- = \mathbb{C}b.$$

For $\lambda \in (H_4^0)^*$, the highest weight module (Verma module) of H_4 is defined by

$$M(\lambda) = U(H_4) \otimes_{U(H_4^{\ge 0})} \mathbb{C}_{\lambda}, \tag{2.2}$$

where \mathbb{C}_{λ} is the 1-dimensional $H_4^{\geq 0}$ -module, on which $h \in H_4^0$ acts as multiplication by $\lambda(h)$ and H_4^+ acts as 0. For convenience, we denote $M(\lambda)$ by M(c, d) when $\lambda(c) = c$ and $\lambda(d) = d$.

We have the following lemma from [28].

Lemma 2.5. For $c, d \in \mathbb{C}$, M(c, d) is irreducible if and only if $c \neq 0$. If c = 0, then the irreducible quotient $L(d) = L(0, d) = \mathbb{C}v_d$ such that

$$av_{\mathrm{d}} = bv_{\mathrm{d}} = cv_{\mathrm{d}} = 0, \quad dv_{\mathrm{d}} = \mathrm{d}v_{\mathrm{d}}. \tag{2.3}$$

Let $M = V(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu})$ for $\tilde{\lambda}, \tilde{\mu}, \tilde{\nu} \in \mathbb{C}$, where $V(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu})$ is the H_4 -module defined as follows: $V(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}) = \bigoplus_{n \in \mathbb{Z}} \mathbb{C}v_n$ such that

$$dv_n = (\tilde{\lambda} + n)v_n, \ cv_n = \tilde{\mu}v_n, \ av_n = -\tilde{\mu}v_{n+1}, \ bv_n = (\tilde{\lambda} + \tilde{\nu} + n)v_{n-1}.$$
 (2.4)

The following result was obtained by M. Willard [30].

Theorem 2.6. All irreducible weight modules of H_4 with finite-dimensional weight spaces can be classified into the following classes:

- (1) Irreducible modules L(d) for $d \in \mathbb{C}$.
- (2) Irreducible highest weight modules $M(\lambda)$ or irreducible lowest weight modules $M^{-}(\mu)$.
- (3) Intermediate series modules $V(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu})$ defined as (2.4) such that $\tilde{\mu} \neq 0$ and $\tilde{\lambda} + \tilde{\nu} \notin \mathbb{Z}$.

To the pair $(H_4, (,))$, let \hat{H}_4 be the associated *affine Nappi-Witten Lie algebra* with the underlying vector space

$$\widehat{H}_4 = H_4 \otimes \mathbb{C}[t, t^{-1}] \oplus \mathbb{C}\mathbf{k}$$
(2.5)

equipped with the bracket relations

$$[h_1 \otimes t^m, h_2 \otimes t^n] = [h_1, h_2] \otimes t^{m+n} + m(h_1, h_2) \delta_{m+n,0} \mathbf{k}, \ [\widehat{H}_4, \mathbf{k}] = 0,$$
(2.6)

for $h_1, h_2 \in H_4$ and $m, n \in \mathbb{Z}$. It is clear that \widehat{H}_4 has the \mathbb{Z} -grading:

$$\widehat{H}_4 = \coprod_{n \in \mathbb{Z}} \widehat{H}_4^{(n)},$$

where

$$\widehat{H}_4^{(0)} = H_4 \oplus \mathbb{C}\mathbf{k}$$
, and $\widehat{H}_4^{(n)} = H_4 \otimes t^n$ for $n \neq 0$.

Then one has the following graded subalgebras of \widehat{H}_4 :

$$\widehat{H}_{4}^{(\pm)} = \prod_{n>0} \widehat{H}_{4}^{(\pm n)}, \quad \widehat{H}_{4}^{(\geq 0)} = \prod_{n\geq 0} \widehat{H}_{4}^{(n)} = \widehat{H}_{4}^{(+)} \oplus H_{4} \oplus \mathbb{C}\mathbf{k}.$$

Let M be an H_4 -module and $\ell \in \mathbb{C}$. Regard M as an $\widehat{H}_4^{(\geq 0)}$ -module with $\widehat{H}_4^{(+)}$ acting trivially and \mathbf{k} as the scalar ℓ . The induced \widehat{H}_4 -module $V_{\widehat{H}_4}(\ell, M)$ is defined by

$$V_{\hat{H}_4}(\ell, M) = \operatorname{Ind}_{\hat{H}_4^{(\geq 0)}}^{\hat{H}_4}(M) = U(\hat{H}_4) \otimes_{U(\hat{H}_4^{(\geq 0)})} M.$$
(2.7)

Let $M = L(d) = \mathbb{C}v_d$ for $d \in \mathbb{C}$ be the one-dimensional irreducible H_4 -module defined as in (2.3). Denote

$$V_{\widehat{H}_4}(\ell, \mathrm{d}) = U(\widehat{H}_4) \otimes_{U(\widehat{H}_4^{(\geq 0)})} \mathbb{C}v_{\mathrm{d}}.$$
(2.8)

We have the following result:

Theorem 2.7 ([1]). For $\ell, d \in \mathbb{C}$, the \widehat{H}_4 -module $V_{\widehat{H}_4}(\ell, d)$ is irreducible if and only if $\ell \neq 0$. Furthermore, if $\ell = 0$, then the irreducible quotient of $V_{\widehat{H}_4}(\ell, d)$ is isomorphic to the one-dimensional \widehat{H}_4 -module $\mathbb{C}v_d$.

For $h \in H_4$, we define the generating function

$$h(x) = \sum_{n \in \mathbb{Z}} (h \otimes t^n) x^{-n-1} \in \widehat{H}_4[[x, x^{-1}]].$$

Then the defining relations (2.6) can be equivalently written as

$$[h_1(x_1), h_2(x_2)] = [h_1, h_2](x_2) x_2^{-1} \delta\left(\frac{x_1}{x_2}\right) - (h_1, h_2) \frac{\partial}{\partial x_1} x_2^{-1} \delta\left(\frac{x_1}{x_2}\right) \mathbf{k}.$$
 (2.9)

Given an \widehat{H}_4 -module W, let h(n) denote the operator on W corresponding to $h \otimes t^n$ for $h \in H_4$ and $n \in \mathbb{Z}$. We shall use the notation for the action of h(x) on W:

$$h_W(x) = \sum_{n \in \mathbb{Z}} h(n) x^{-n-1} \in (\text{End}W)[[x, x^{-1}]].$$
(2.10)

Definition 2.8. Let W be a *restricted* \hat{H}_4 -module in the sense that for every $h \in H_4$ and $w \in W$, h(n)w = 0 for n sufficiently large. We say that the \hat{H}_4 -module W is of level ℓ if the central element \mathbf{k} acts as a scalar ℓ in \mathbb{C} .

Let ℓ be a complex number. Consider the induced module defined as (2.8)(let d = 0):

$$V_{\widehat{H}_4}(\ell,0) = U(\widehat{H}_4) \otimes_{U(\widehat{H}_4^{(\leq 0)})} v_0.$$

Set

$$\mathbf{1} = v_0 \in V_{\widehat{H}_4}(\ell, 0).$$

Then

$$V_{\widehat{H}_4}(\ell, 0) = \prod_{n \ge 0} V_{\widehat{H}_4}(\ell, 0)_{(n)},$$

where $V_{\widehat{H}_4}(\ell, 0)_{(n)}$ is spanned by the vectors

$$h_{-m_1}^{(1)} \cdots h_{-m_r}^{(r)} \mathbf{1}$$

for $r \geq 0$, $h^{(i)} \in H_4$, $m_i \geq 1$, with $n = m_1 + \cdots + m_r$. It is clear that $V_{\hat{H}_4}(\ell, 0)$ is a restricted \hat{H}_4 -module of level ℓ . We can regard H_4 as a subspace of $V_{\hat{H}_4}(\ell, 0)$ through the map

$$H_4 \to V_{\widehat{H}_4}(\ell, 0), \quad h \mapsto h(-1)\mathbf{1}$$

In fact, $H_4 = V_{\widehat{H}_4}(\ell, 0)_{(1)}$.

Theorem 2.9 (cf. [20, 26]). Let ℓ be any complex number. Then there exists a unique vertex algebra structure $(V_{\widehat{H}_4}(\ell, 0), Y, \mathbf{1})$ on $V_{\widehat{H}_4}(\ell, 0)$ such that $\mathbf{1}$ is the vacuum vector and

$$Y(h, x) = h(x) \in (\text{End}V_{\hat{H}_4}(\ell, 0))[[x, x^{-1}]]$$

for $h \in H_4$. For $r \ge 0, h^{(i)} \in H_4, n_i \in \mathbb{Z}_+$, the vertex operator map for this vertex algebra structure is given by

$$Y(h^{(1)}(-n_1)\cdots h^{(r)}(-n_r)\mathbf{1}, x) = {}_{\circ}^{\circ} \partial^{(n_1-1)}h^{(1)}(x)\cdots \partial^{(n_r-1)}h^{(r)}(x) {}_{\circ}^{\circ}\mathbf{1},$$

where

$$\partial^{(n)} = \frac{1}{n!} \left(\frac{d}{dx}\right)^n$$

 $\circ \circ \circ$ is the normal-ordering operation, and 1 is the identity operator on $V_{\widehat{H}_4}(\ell, 0)$.

Proposition 2.10 (cf. [20]). Any module W for the vertex algebra $V_{\hat{H}_4}(\ell, 0)$ is naturally a restricted \hat{H}_4 -module of level ℓ , with $h_W(x) = Y_W(h, x)$ for $h \in H_4$. Conversely, any restricted \hat{H}_4 -module W of level ℓ is naturally a $V_{\hat{H}_4}(\ell, 0)$ -module as vertex algebra with

$$Y_W(h^{(1)}(-n_1)\cdots h^{(r)}(-n_r)\mathbf{1}, x) = {}_{\circ}^{\circ} \partial^{(n_1-1)} h_W^{(1)}(x) \cdots \partial^{(n_r-1)} h_W^{(r)}(x) {}_{\circ}^{\circ} \mathbf{1}_W,$$

for $r \geq 0, h^{(i)} \in \widehat{H}_4, n_i \in \mathbb{Z}_+$. Furthermore, for any $V_{\widehat{H}_4}(\ell, 0)$ -module W, the $V_{\widehat{H}_4}(\ell, 0)$ -submodules of W coincide with the \widehat{H}_4 -submodules of W.

Let ℓ be a non-zero complex number. Set

$$\omega = \frac{1}{\ell} \left(a(-1)b(-1)\mathbf{1} + c(-1)d(-1)\mathbf{1} \right) - \frac{1}{2\ell}c(-2)\mathbf{1} - \frac{1}{2\ell^2}c(-1)c(-1)\mathbf{1} \quad (2.11)$$

and define operators L(n) for $n \in \mathbb{Z}$ by

$$Y(\omega, x) = \sum_{n \in \mathbb{Z}} \omega_n x^{-n-1} = \sum_{n \in \mathbb{Z}} L(n) x^{-n-2}.$$

Then we have the following results from [1].

Theorem 2.11. Let ℓ be a complex number such that $\ell \neq 0$. Then the vertex algebra $V_{\hat{H}_4}(\ell, 0)$ constructed in Theorem 2.9 is a vertex operator algebra of central charge 4 with ω defined in (2.11) as the conformal vector. The \mathbb{Z} -grading on $V_{\hat{H}_4}(\ell, 0)$ is given by L(0)eigenvalues. Moreover, $H_4 = V_{\hat{H}_4}(\ell, 0)_{(1)}$, which generates $V_{\hat{H}_4}(\ell, 0)$ as a vertex algebra, and

$$[h(n), L(m)] = nh(m+n), \text{ for } h \in H_4, m, n \in \mathbb{Z}.$$

Theorem 2.12. For $\ell \neq 0$ and $d \in \mathbb{C}$, the \hat{H}_4 -module $V_{\hat{H}_4}(\ell, d)$ is naturally an irreducible ordinary module for the vertex operator algebra $V_{\hat{H}_4}(\ell, 0)$. Furthermore, the modules $V_{\hat{H}_4}(\ell, d)$ exhaust all the irreducible ordinary $V_{\hat{H}_4}(\ell, 0)$ -modules up to equivalence.

Note that the central charge of the vertex operator algebra $V_{\hat{H}_4}(\ell, 0)$ for $\ell \neq 0$ is independent of ℓ . We have the following result.

Theorem 2.13. Let $\ell \neq 0$ be any nonzero complex number and let $\sqrt{\ell}$ be one of the two square roots of ℓ . Then the vertex operator algebra $V_{\widehat{H}_4}(\ell, 0)$ is isomorphic to $V_{\widehat{H}_4}(1, 0)$ under the following linear map

$$\rho: V_{\widehat{H}_4}(\ell, 0) \to V_{\widehat{H}_4}(1, 0)$$

$$\begin{aligned} d(-m_{41})\cdots d(-m_{4i_4})c(-m_{31})\cdots c(-m_{3i_3}) \\ a(-m_{21})\cdots a(-m_{2i_2})b(-m_{11})\cdots b(-m_{1i_1})\mathbf{1} \\ \to \quad (\sqrt{\ell})^{i_1+i_2}\ell^{i_3}d(-m_{41})\cdots d(-m_{4i_4})c(-m_{31})\cdots c(-m_{3i_3}) \\ a(-m_{21})\cdots a(-m_{2i_2})b(-m_{11})\cdots b(-m_{1i_1})\mathbf{1}, \end{aligned}$$

where $i_k \ge 0$, $m_{kj} \ge 1$, $m_{k1} \le m_{k2} \le \cdots \le m_{ki_k}$, $k = 1, \cdots, 4, j = 1, 2, \cdots, i_k$.

Following Theorem 2.13, for the rest of the paper, we always assume that $\ell = 1$.

3 Restricted modules for the affine Lie algebra \hat{H}_4

In this section, we will discuss the structures of restricted \hat{H}_4 -modules under some conditions which are natural from the point of view of representations of vertex algebras. We first have the following lemma.

Lemma 3.1. Let W be an irreducible \hat{H}_4 -module, then c(0) and k act as scalars on W.

Proof: Note that \widehat{H}_4 has countable basis and W is irreducible. So W is of countable dimension over \mathbb{C} . Then the lemma follows from the fact that c(0) and \mathbf{k} are in the center of \widehat{H}_4 and $\operatorname{Hom}_{\widehat{H}_4}(W, W) = \mathbb{C}$.

Let $\mathfrak{h} = \mathbb{C}c \oplus \mathbb{C}d$ and $\hat{\mathfrak{h}} = \mathfrak{h} \otimes \mathbb{C}[t, t^{-1}] \oplus \mathbb{C}\mathbf{k}$ be the associated subalgebra of the affine Lie algebra \widehat{H}_4 . We now introduce a subalgebra $\widehat{H}_4(m,\epsilon)$ of \widehat{H}_4 for given $m \in \mathbb{Z}$ and $\epsilon \in \{0,1\}$ as follows:

$$\widehat{H}_4(m,\epsilon) = \left(\bigoplus_{n \ge -m} \mathbb{C}a \otimes t^n\right) \bigoplus \left(\bigoplus_{n \ge m+\epsilon} \mathbb{C}b \otimes t^n\right) \bigoplus \left(\left(\mathbb{C}c \bigoplus \mathbb{C}d\right) \otimes \mathbb{C}[t]\right) \bigoplus \mathbb{C}\mathbf{k}.$$
 (3.1)

Let $0 \neq \alpha = dc + cd \in \mathfrak{h}^*$. We define a one-dimensional $\widehat{H}_4(m, \epsilon)$ -module $\mathbb{C}_{\alpha} = \mathbb{C}\mathbf{1}_{\alpha}$ by

$$(a \otimes t^s)\mathbf{1}_{\alpha} = (b \otimes t^r)\mathbf{1}_{\alpha} = (c \otimes t^l)\mathbf{1}_{\alpha} = (d \otimes t^l)\mathbf{1}_{\alpha} = 0, \ s \ge -m, \ r \ge m + \epsilon, \ l \ge 1,$$

$$c\mathbf{1}_{\alpha} = c\mathbf{1}_{\alpha}, \ d\mathbf{1}_{\alpha} = d\mathbf{1}_{\alpha}, \ \mathbf{k}\mathbf{1}_{\alpha} = \mathbf{1}_{\alpha}.$$

Then we get a generalized Verma type module $V_{\hat{H}_4}(1, (m, \epsilon), \mathbf{1}_{\alpha})$ as follows:

$$V_{\widehat{H}_4}(1, (m, \epsilon), \mathbf{1}_{\alpha}) = U(\widehat{H}_4) \otimes_{U(\widehat{H}_4(m, \epsilon))} \mathbb{C}_{\alpha}.$$
(3.2)

If $m = c \in \mathbb{Z}$ and $\epsilon = 0$, we briefly denote $V_{\widehat{H}_4}(1, (m, \epsilon), \mathbf{1}_{\alpha})$ by $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$. Note that

$$V_{\widehat{H}_4}(1,0,\mathbf{1}_{\alpha}) = V_{\widehat{H}_4}(1,\mathbf{d}).$$

We first consider the module $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$ for $c \in \mathbb{Z}$. We give the first main result of this section as follows.

Theorem 3.2. Let $0 \neq \alpha = dc + cd \in \mathfrak{h}^*$ such that $c \in \mathbb{Z}$. Then the generalized Verma type \widehat{H}_4 -module $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$ is irreducible.

Proof: It is clear that $\sigma : \hat{H}_4 \to \hat{H}_4$ defined by $\sigma(a \otimes t^n) = b \otimes t^n$, $\sigma(b \otimes t^n) = a \otimes t^n$, $\sigma(c \otimes t^n) = -c \otimes t^n$, $\sigma(d \otimes t^n) = -d \otimes t^n$, $n \in \mathbb{Z}$, $\sigma(\mathbf{k}) = \mathbf{k}$ is an automorphism of \hat{H}_4 . So we may assume that $c \geq 0$. By PBW theorem and the definition of $V_{\hat{H}_4}(1, c, \mathbf{1}_{\alpha})$,

$$\mathbf{1}_{\alpha}, d(m_{41}) \cdots d(m_{4i_4}) c(m_{31}) \cdots c(m_{3i_3}) a(m_{21}) \cdots a(m_{2i_2}) b(m_{11}) \cdots b(m_{1i_1}) \mathbf{1}_{\alpha},$$

such that $i_k \ge 0, \ m_{k1} \le m_{k2} \le \cdots \le m_{ki_k}, \ m_{4j}, m_{3j} \le -1, \ m_{2j} \le -c - 1, \ m_{1j} \le c - 1, \ k = 1, \cdots, 4, \ j = 1, 2, \cdots, i_k$, is a basis of $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$.

For $n \in \mathbb{Z}_+$, let

$$p_n = c(n), \quad q_n = d(-n).$$

Then

$$[p_m, q_n] = m\delta_{m,n}\mathbf{k}$$

Therefore

$$\mathfrak{s} = \bigoplus_{n \in \mathbb{Z}_+} (\mathbb{C}p_n \oplus \mathbb{C}q_n) \oplus \mathbb{C}\mathbf{k}$$

is a Heisenberg algebra and $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$ is an \mathfrak{s} -module such that \mathbf{k} acts as 1. Since every highest weight \mathfrak{s} -module generated by one element with \mathbf{k} acting as a non-zero scalar is irreducible, it follows that $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$ can be decomposed into a direct sum of irreducible highest weight modules of \mathfrak{s} with the highest weight vectors

$$\mathbf{1}_{\alpha}, c(m_{31}) \cdots c(m_{3i_3}) a(m_{21}) \cdots a(m_{2i_2}) b(m_{11}) \cdots b(m_{1i_1}) \mathbf{1}_{\alpha},$$

such that $i_k \geq 0$, $m_{k1} \leq m_{k2} \leq \cdots \leq m_{ki_k}$, $m_{3j} \leq -1$, $m_{2j} \leq -c - 1$, $m_{1j} \leq c - 1$, $k = 1, 2, 3, j = 1, 2, \cdots, i_k$. For convenience, we denote the set of such highest weight vectors by \mathcal{N} . Set

$$\widehat{H}_4(\mathbf{c},+) = (\bigoplus_{n \ge -\mathbf{c}} \mathbb{C}a \otimes t^n) \bigoplus (\bigoplus_{n \ge \mathbf{c}} \mathbb{C}b \otimes t^n) \bigoplus ((\mathbb{C}c \bigoplus \mathbb{C}d) \otimes \mathbb{C}t[t])$$

Let U be a non-zero submodule of $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$. It suffices to prove that $\mathbf{1}_{\alpha} \in U$. Let u be a non-zero element in U. Since as an \mathfrak{s} -module, U is a direct sum of irreducible highest weight \mathfrak{s} -modules, we may assume that

$$u = \sum_{i=1}^{s} a_i c(m_{31}^{(i)}) \cdots c(m_{3i_3}^{(i)}) a(m_{21}^{(i)}) \cdots a(m_{2i_2}^{(i)}) b(m_{11}^{(i)}) \cdots b(m_{1i_1}^{(i)}) b(n_{i1}) \cdots b(n_{ir_i}) \mathbf{1}_{\alpha},$$

where $0 \neq a_i \in \mathbb{C}, \ i_k \geq 0, \ m_{k1}^{(i)} \leq m_{k2}^{(i)} \leq \cdots \leq m_{ki_k}^{(i)}, \ m_{3j}^{(i)} \leq -1, \ m_{2j}^{(i)} \leq -c - 1, \ m_{1j}^{(i)} \leq -1, \ 0 \leq n_{i1}, \cdots, n_{ir_i} \leq c - 1, \ i = 1, 2, \cdots, s, \ k = 1, 2, 3, \ j = 1, 2, \cdots, i_k, \ \text{and} \ \sum_{j=1}^{1} m_{1j}^{(1)} \leq \sum_{j=1}^{2} m_{1j}^{(2)} \leq \cdots \leq \sum_{j=1}^{s_1} m_{1j}^{(s)}.$ Let

$$u^{(i)} = c(m_{31}^{(i)}) \cdots c(m_{3i_3}^{(i)}) a(m_{21}^{(i)}) \cdots a(m_{2i_2}^{(i)}) b(m_{11}^{(i)}) \cdots b(m_{1i_1}^{(i)}) b(n_{i1}) \cdots b(n_{ir_i}) \mathbf{1}_{\alpha}, \ i = 1, 2, \cdots, s.$$

Note that

$$\begin{aligned} a(-m_{11_1}^{(1)}) \cdots a(-m_{12}^{(1)})a(-m_{11}^{(1)})u^{(1)} \\ &= q \prod_{j=1}^{1_1} (\mathbb{C} - m_{1j}^{(1)})c(m_{31}^{(1)}) \cdots c(m_{31_3}^{(i)})a(m_{21}^{(1)}) \cdots a(m_{21_2}^{(i)})b(n_{i1}) \cdots b(n_{ir_i})\mathbf{1}_{\alpha} \\ &\neq 0, \end{aligned}$$

for some $0 \neq q \in \mathbb{Z}$ and for the case $b(m_{11}^{(i)}) \cdots b(m_{1i_1}^{(i)}) \neq b(m_{11}^{(1)}) \cdots b(m_{1i_1}^{(1)})$, we have

$$a(-m_{11_1}^{(1)})\cdots a(-m_{12}^{(1)})a(-m_{11}^{(1)})u^{(i)} = 0.$$

We may further assume that

$$u = \sum_{i=1}^{s} a_i c(m_{31}^{(i)}) \cdots c(m_{3i_3}^{(i)}) a(m_{21}^{(i)}) \cdots a(m_{2i_2}^{(i)}) b(n_{i1}) \cdots b(n_{ir_i}) \mathbf{1}_{\alpha}$$

and

$$u^{(i)} = c(m_{31}^{(i)}) \cdots c(m_{3i_3}^{(i)}) a(m_{21}^{(i)}) \cdots a(m_{2i_2}^{(i)}) b(n_{i1}) \cdots b(n_{ir_i}) \mathbf{1}_{\alpha}, \ i = 1, 2, \cdots, s,$$

where $0 \neq a_i \in \mathbb{C}$, $i_k \geq 0$, $m_{k1}^{(i)} \leq m_{k2}^{(i)} \leq \cdots \leq m_{ki_k}^{(i)}$, $m_{3j}^{(i)} \leq -1$, $m_{2j}^{(i)} \leq -c - 1$, $0 \leq n_{i1} \leq \cdots \leq n_{ir_i} \leq c - 1$, $i = 1, 2, \cdots, s$, $k = 1, 2, j = 1, 2, \cdots, i_k$ and $\sum_{j=1}^{1_2} m_{2j}^{(1)} \leq c - 1$.

$$\begin{split} \sum_{j=1}^{2_2} m_{2j}^{(2)} &\leq \cdots \leq \sum_{j=1}^{s_2} m_{2j}^{(s)}. \text{ Note also that} \\ b(-m_{21_2}^{(1)}) \cdots b(-m_{22}^{(1)}) b(-m_{21}^{(1)}) u^{(1)} \\ &= q_1 \prod_{j=1}^{1_1} (-\mathfrak{c} - m_{2j}^{(1)}) c(m_{31}^{(1)}) \cdots c(m_{31_3}^{(i)}) b(n_{i1}) \cdots b(n_{ir_i}) \mathbf{1}_{\alpha} \\ &\neq 0, \end{split}$$

for some $0 \neq q_1 \in \mathbb{Z}$ and for the case $a(m_{21}^{(i)}) \cdots a(m_{2i_2}^{(i)}) \neq a(m_{21}^{(1)}) \cdots b(m_{2i_2}^{(1)})$, we have

$$b(-m_{21_2}^{(1)})\cdots b(-m_{22}^{(1)})b(-m_{21}^{(1)})u^{(i)} = 0.$$

We may also assume that

$$u = \sum_{i=1}^{s} a_i c(m_{i1}) \cdots c(m_{ip_i}) b(n_{i1}) \cdots b(n_{ir_i}) \mathbf{1}_{\alpha},$$

where $0 \neq a_i \in \mathbb{C}$, $p_i, r_i \geq 0$, $m_{i1} \leq m_{i2} \leq \cdots \leq m_{ip_i} \leq -1$, $0 \leq n_{i1} \leq \cdots \leq n_{ir_i} \leq c - 1$, $i = 1, 2, \cdots, s$. Note that [d, b] = -b, so we may assume that

$$r_1 = r_2 = \dots = r_s = r.$$

If r = 0, then by the fact that $[c(p), d(q)] = p\delta_{p+q,0}k$, it is easy to see that $\mathbf{1}_{\alpha} \in U$. If $r \neq 0$. Assume that

$$(n_{i1}, n_{i2}, \cdots, n_{ir}) \le (n_{i+1,1}, n_{i+1,2}, \cdots, n_{i+1,r}), \ i = 1, 2, \cdots, r$$

in the sense that

$$n_{i1} \le n_{i2} \le \cdots \le n_{ir},$$

and

$$n_{i1} = n_{i+1,1}, \cdots, n_{ik} = n_{i+1,k}, n_{i,k+1} < n_{i+1,k+1}, \text{ for some } k.$$

Then

$$a(-n_{1r})\cdots a(-n_{11})c(m_{11})\cdots c(m_{1p_1})b(n_{11})\cdots b(n_{1r}) = kc(m_{11})\cdots c(m_{1p_1})\mathbf{1}_{\alpha} \neq 0$$

and for the case that $(n_{11}, \dots, n_{1r}) < (n_{i1}, \dots, n_{ir})$, we have

$$a(-n_{1r})\cdots a(-n_{11})c(m_{i1})\cdots c(m_{ip_i})b(n_{i1})\cdots b(n_{ir})\mathbf{1}_{\alpha}=0.$$

 So

$$a(-n_{1r})\cdots a(-n_{11})u = \sum_{i=1}^{r_1} c_i c(m_{11})\cdots c(m_{1p_1})\mathbf{1}_{\alpha} \in U,$$

for some $r_1 \leq r$ and $c_i \neq 0, i = 1, 2, \cdots, r_1$. From this we deduce that $\mathbf{1}_{\alpha} \in U$.

Next we consider the second class of generalized Verma type module $V_{\hat{H}_4}(1, (m, \epsilon), \mathbf{1}_{\alpha})$ for $\epsilon = 1$. Let $0 \neq \alpha = dc + cd \in \mathfrak{h}^*$, $(m, 1) \in \mathbb{Z}^2$, and let $V_{\hat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ be the generalized Verma type \hat{H}_4 -module defined by (3.2). For $n \in \mathbb{Z}$, define

$$\deg a(-n-m) = n - 1, \ \deg b(-n+m) = n + 1,$$
$$\deg c(-n) = n, \ \deg d(-n) = n, \ \deg \mathbf{k} = 0.$$

Then $U(\hat{H}_4)$ is Z-graded. So we get an N-gradation of $V_{\hat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ by defining deg $\mathbf{1}_{\alpha} = 0$. Let

$$\widehat{H}_4((m,1),+) = (\bigoplus_{n \ge -m} \mathbb{C}a \otimes t^n) \bigoplus (\bigoplus_{n \ge m+1} \mathbb{C}b \otimes t^n) \bigoplus ((\mathbb{C}c \bigoplus \mathbb{C}d) \otimes \mathbb{C}t[t])$$
(3.3)

A homogeneous element u in $V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ is called a homogeneous singular vector if

 $x \cdot u = 0,$

for all $x \in \mathcal{U}(\widehat{H}_4((m, 1), +))$. It is obvious that the module generated by a homogeneous singular vector is a proper submodule. The following is the second main result of this section.

Theorem 3.3. For $0 \neq \alpha = dc + cd \in \mathfrak{h}^*$ and $(m, 1) \in \mathbb{Z}^2$, the \widehat{H}_4 -module $V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ is irreducible if and only if $c \notin \mathbb{Z}$. Furthermore, we have

- (i) If c = m, then $u = b(m)\mathbf{1}_{\alpha}$ is a singular vector and $V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})/\mathcal{U}(\widehat{H}_4)u$ is irreducible and isomorphic to $V_{\widehat{H}_4}(1, c, \mathbf{1}_{\alpha})$.
- (ii) If c + n = m for some $n \in \mathbb{Z}_+ \setminus \{0\}$, then all the linearly independent singular vectors are

$$u^{k} = \left[\sum_{\lambda \in P(n)} (a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i}+m)\right]^{k} \mathbf{1}_{\alpha},$$

for all $k \in \mathbb{Z}_+$, satisfying

$$a_{\lambda}q_{i}\lambda_{i} - b_{\lambda\setminus\lambda_{i},\lambda_{i}} = 0, \ i = 1, 2, \cdots, k_{\lambda},$$
$$b_{\lambda\setminus\lambda_{i},\lambda_{i}}(-n+\lambda_{i}) + \sum_{j=1}^{k_{\lambda}} b_{\lambda\setminus\lambda_{i}\setminus\lambda_{j},\lambda_{i}+\lambda_{j}} = 0;$$

(iii) If c = m + n for some $n \in \mathbb{Z}_+ \setminus \{0\}$, then all the linearly independent singular vectors are

$$u^{k} = \left[\sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_{i}, \lambda_{i}} c(-\lambda \setminus \lambda_{i}) a(-\lambda_{i} - m)\right]^{k} \mathbf{1}_{\alpha},$$

for all $k \in \mathbb{Z}_+$, satisfying

$$q_i\lambda_i c_{\lambda\setminus\lambda_j,\lambda_j} + c_{\lambda\setminus\lambda_i\setminus\lambda_j,\lambda_i+\lambda_j} = 0, \ i, j = 1, 2, \cdots, k_\lambda, i \neq j,$$

$$c_{\lambda\setminus\lambda_i,\lambda_i}(-n+\lambda_i) - \sum_{j=1}^{k_\lambda} c_{\lambda\setminus\lambda_i\setminus\lambda_j,\lambda_i+\lambda_j} = 0, \ i = 1, 2, \cdots, k_\lambda$$

where in (ii) and (iii), P(n) is the set of all partitions of weight n,

$$\lambda^{(k)} = (\lambda, \lambda, \cdots, \lambda) \in \mathbb{Z}_{+}^{k}, \quad \lambda = (\lambda_{1}^{(q_{1})}, \lambda_{2}^{(q_{2})}, \cdots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$$

such that
$$\sum_{i=1}^{k_{\lambda}} q_i \lambda_i = n$$
, and $\lambda \setminus \lambda_i = (\lambda_1^{(q_1)}, \cdots, \lambda_i^{(q_i-1)}, \cdots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$ and if $\lambda = \lambda_i$,
then $c(-\lambda \setminus \lambda_i)b(-\lambda_i + m) = b(-\lambda_i + m)$, $c(-\lambda \setminus \lambda_i)a(-\lambda_i - m) = a(-\lambda_i - m)$.

Proof: If c = m, then it is easy to see that $b(m)\mathbf{1}_{\alpha}$ is a singular vector. Then (i) follows from Theorem 3.2.

We now assume that $c \neq m$.

Let \mathfrak{s} be the infinite-dimensional Heisenberg algebra defined in the proof of Theorem 3.2. Then as an \mathfrak{s} -module, $V_{\hat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ is a direct sum of irreducible highest weight \mathfrak{s} -modules with \mathbf{k} acting as 1 and highest weight vectors in

$$\mathcal{N}_{\alpha} = \{b(m)^{i} \mathbf{1}_{\alpha}, c(-\lambda)a(-\mu)b(-\nu)b(m)^{i} \mathbf{1}_{\alpha}, y_{1}(-\lambda)y_{2}(-\mu)b(m)^{i} \mathbf{1}_{\alpha}, y_{1}(-\lambda)y_{2}(-\mu)b(m)^{i} \mathbf{1}_{\alpha}, y_{1}(-\lambda)y_{2}(-\mu)b(m)^{i} \mathbf{1}_{\alpha}, y_{1}(-\lambda)y_{2}(-\mu)b(m)^{i} \mathbf{1}_{\alpha}, y_{1}(-\lambda)y_{2}(-\mu)b(m)^{i} \mathbf{1}_{\alpha}, y_{2}(-\mu)b(m)^{i} \mathbf{1}_{\alpha}, y_$$

 $x(-\lambda)b(m)^{i}\mathbf{1}_{\alpha} \mid i \ge 0, (y_{1}, y_{2}) \in \{(a, b), (c, a), (c, b)\}, x \in \{a, b, c\}, \lambda, \mu, \nu \in \mathcal{P}\},$

where for a partition $\lambda = (\lambda_1, \cdots, \lambda_r),$

$$d(-\lambda) = d(-\lambda_1)d(-\lambda_2)\cdots d(-\lambda_r),$$

$$c(-\lambda) = c(-\lambda_1)c(-\lambda_2)\cdots c(-\lambda_r),$$

$$a(-\lambda) = a(-\lambda_1 - m)a(-\lambda_2 - m)\cdots a(-\lambda_r - m),$$

$$b(-\lambda) = b(-\lambda_1 + m)b(-\lambda_2 + m)\cdots b(-\lambda_r + m).$$

Suppose that $u \in V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ is a singular vector such that

$$U(\widehat{H}_4^+)u = 0.$$

Since $V_{\hat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$ is a direct sum of irreducible highest weight \mathfrak{s} -modules and u is homogeneous, we may assume that

$$u = \sum_{i=1}^{3} u_i,$$

where

$$u_1 = \sum_{j=1}^{l_1} a_{1j} c(-\lambda^{(1j)}) a(-\mu^{(1j)}) b(-\nu^{(1j)}) b(m)^{k_{1j}} \mathbf{1}_{\alpha},$$

for $(\lambda^{(1j)}, \mu^{(1j)}, \nu^{(1j)}) \succ (\lambda^{(1,j+1)}, \mu^{(1,j+1)}, \nu^{(1,j+1)}), j = 1, \cdots, l_1 - 1,$

$$u_2 = u_{21} + u_{22} + u_{23},$$

where

$$u_{21} = \sum_{j=1}^{l_2} a_{2j} c(-\lambda^{(2j)}) a(-\mu^{(2j)}) b(m)^{k_{2j}} \mathbf{1}_{\alpha}, \ u_{22} = \sum_{j=1}^{l_3} a_{3j} c(-\lambda^{(3j)}) b(-\nu^{(3j)}) b(m)^{k_{3j}} \mathbf{1}_{\alpha},$$
$$u_{23} = \sum_{j=1}^{l_4} a_{4j} a(-\mu^{(4j)}) b(-\nu^{(4j)}) b(m)^{k_{4j}} \mathbf{1}_{\alpha},$$

for $(\lambda^{(2j)}, \mu^{(2j)}) \succ (\lambda^{(2,j+1)}, \mu^{(2,j+1)}), j = 1, \cdots, l_2 - 1; (\lambda^{(3j)}, \nu^{(3j)}) \succ (\lambda^{(3,j+1)}, \mu^{(3,j+1)}), j = 1, \cdots, l_3 - 1; (\mu^{(4j)}, \nu^{(4j)}) \succ (\mu^{(4,j+1)}, \nu^{(4,j+1)}), j = 1, \cdots, l_4 - 1, \text{ and}$

$$u_3 = u_{31} + u_{32} + u_{33},$$

where

$$u_{31} = \sum_{j=1}^{l_5} a_{5j} c(-\lambda^{(5j)}) b(m)^{k_{5j}} \mathbf{1}_{\alpha},$$
$$u_{32} = \sum_{j=1}^{l_6} a_{6j} a(-\mu^{(6j)}) b(m)^{k_{6j}} \mathbf{1}_{\alpha}, \quad u_{33} = \sum_{j=1}^{l_7} a_{7j} b(-\nu^{(7j)}) b(m)^{k_{7j}} \mathbf{1}_{\alpha},$$

Case 1 $c \notin \mathbb{Z}$. One can prove that u = 0 by the same method used in the proof of Theorem 3.2. Therefore $V_{\hat{H}_4}(1, (m, 1), \alpha)$ is irreducible.

Case 2 $c \in \mathbb{Z}$ and $c \neq m$.

Since au = 0, it is easy to see that $k_{ij} = 0$, for i = 4, 6, 7. If $u_{33} \neq 0$, we consider $a(\nu_1^{(71)})u$. Since no monomial of $a(\nu_1^{(71)})u_1$, $a(\nu_1^{(71)})u_2$, $a(\nu_1^{(71)})u_{31}$ and $a(\nu_1^{(71)})u_{32}$ is of the form $b(-\eta)$, where $\eta \in \mathcal{P}$, we deduce that

$$c + \nu_1^{(71)} - m = 0.$$

Similarly, considering $a(\nu_{r_{7p}}^{(7p)})u$, where $\nu_{r_{7p}}^{(7p)} = min\{\nu_{r_{7j}}^{(7j)}, j = 1, 2, \cdots, l_{7}\}$, we have

$$c + \nu_{r_{7p}}^{(7p)} - m = 0$$

Then we deduce that $l_7 = 1$ and $u_{33} = a_{71}(b(-\nu_1^{(71)}))^{k_3} \mathbf{1}_{\alpha}$ such that

$$c + \nu_1^{(71)} - m = 0, \quad k_3(\nu_1^{(71)} + 1) = \deg u.$$

If $u_{32} \neq 0$, then by the fact that $b(\mu_1^{(61)})u = 0$, we have

$$c - (\mu_1^{(61)} + m) = 0.$$

Therefore

$$\mu_1^{(61)} + \nu_1^{(71)} = 0,$$

which is impossible since $\mu_1^{(61)} + \nu_1^{(71)} > 0$. We deduce that $u_{32} = 0$ or $u_{33} = 0$.

Subcase 1 $u_{33} \neq 0, u_{32} = 0.$ By the fact that $b(\mu_1^{(41)})u = b(\mu_1^{(41)})u_{31} = b(\mu_1^{(41)})u_{33} = b(\mu_1^{(41)})u_{22} = 0$, and both $b(\mu_1^{(41)})u_1$ and $b(\mu_1^{(41)})u_{21}$ contain no monomials of the forms $a(-\lambda)b(-\mu)$ and $b(-\mu)$, where $\lambda, \mu \in \mathcal{P}$, we have

$$b(\mu_1^{(41)})u_{23} = \sum_{j=1}^{l_4} a_{4j} \sum_{p=1}^{r_{4j}} \delta_{\mu_1^{(41)}, \mu_p^{(4j)}} (-\mathbb{C} + \mu_1^{(41)} + m)$$
$$\cdot a(-\mu^{(4j)}) \widehat{a(-\mu_p^{(4j)})} b(-\nu^{(4j)}) \mathbf{1}_{\alpha} = 0,$$

where $a(-\mu_p^{(4j)})$ means this factor is deleted. So if $u_{23} \neq 0$, then $-c + \mu_1^{(41)} + m = 0$, which is impossible since $c + \nu_1^{(71)} - m = 0$. This proves that $u_{23} = 0$. Let $Y = b(\mu_1^{(21)})$, then $Yu = Yu_1 + Yu_{21} = 0$. If $u_{21} \neq 0$, comparing Yu_1 and Yu_{21} , we have

$$-c + \mu_1^{(21)} + m = 0,$$

which is not true. So $u_{21} = 0$. Similarly, $u_1 = 0$. Therefore

 $u = u_{22} + u_{31} + u_{33}.$

By the fact that $a(\nu_1^{(31)})u = 0$, we can easily deduce that $\nu^{(3j)} \leq \nu^{(71)}$, $j = 1, \dots, l_3$. Similarly, we have $\lambda^{(3j)} \leq \nu^{(71)}, \lambda^{(5k)} \leq \nu^{(71)}, j = 1, \dots, l_3, k = 1, \dots, l_5$. If $\nu_1^{(71)} = 1$, then $c + 1 - m = 0, u_{33} = a_{71}b(-1)^{k_3}\mathbf{1}_{\alpha}$ and

$$u_{22} = \sum_{j=1}^{l_3} a_{3j} c(-1)^{p_{3j}} b(-1)^{q_{3j}} b(m)^{k_{3j}} \mathbf{1}_{\alpha}, \ u_{31} = \sum_{j=1}^{l_5} a_{5j} c(-1)^{p_{5j}} b(m)^{k_{5j}} \mathbf{1}_{\alpha}.$$

Since d(1)u = 0, we have

$$u_{22} + u_{31} + u_{33} = k \left(\sum_{j=0}^{k_3} C_{k_3}^j c(-1)^{k_3 - j} b(-1 + m)^j b(m)^{k_3 - j} \mathbf{1}_{\alpha}\right),$$

for some $k \in \mathbb{C}$. Let

$$u = \sum_{j=0}^{k_3} C_{k_3}^j c(-1)^{k_3 - j} b(-1 + m)^j b(m)^{k_3 - j} \mathbf{1}_{\alpha} = (c(-1)b(m) + b(-1 + m))^{k_3} \mathbf{1}_{\alpha}.$$

Then we have

$$a(-m)(c(-1)b(m) + b(-1+m)) = (c(-1)b(m) + b(-1+m))a(-m).$$

Thus

$$a(-m)u = 0.$$

It is clear that a(r-m)u = b(r+m+1)u = c(r+1)u = d(r+1)u = 0, for $r \ge 0$. We prove that u is a non-zero singular vector for each $k_3 \in \mathbb{N}$.

Assume that $\nu_1^{(71)} > 1$. If $\nu_1^{(3j)} = 1$ for all $j = 1, 2, \dots, l_3$. Then $\nu_1^{(71)} = 2$. So c + 2 - m = 0. In fact, if $\nu_1^{(71)} > 2$, then $a(\nu_1^{(71)} - 1 - m)u_{22} = a(\nu_1^{(71)} - 1 - m)u_{31} = 0$, $a(\nu_1^{(71)} - 1 - m)u_{33} \neq 0$, a contradiction. If $k_3 > 1$, then $a(1 - m)u_{31} = 0$, and $a(1 - m)u_{33}$ contains factor b(-2 + m), but no monomial of $a(1 - m)u_{22}$ contains factor b(-2 + m). So $u_{33} = u_{22} = 0$. Then $u_{31} = 0$ and we deduce that u = 0. If $k_3 = 1$, then $u_{33} = a_{71}b(-2 + m)\mathbf{1}_{\alpha}$ and one can easily deduce that

$$u = (c(-2)b(m) + c(-1)^{2}b(m) + 2c(-1)b(-1+m) + 2b(-2+m))\mathbf{1}_{\alpha}$$

is a singular vector. Generally, for $\nu_1^{(71)} = 2$, we have c + 2 - m = 0 and

$$u = (c(-2)b(m) + c(-1)^{2}b(m) + 2c(-1)b(-1+m) + 2b(-2+m))^{k}\mathbf{1}_{\alpha}, \quad k \ge 1.$$

Now assume that $\nu_1^{(71)} = n > 2$ and $l(\nu^{(71)}) = 1$. Note that c + n - m = 0. Let $1 \le p \le l_3$ be such that $l(\nu^{(3p)}) = max\{l(\nu^{(3j)}), j = 1, 2, \cdots, l_3\}$ and if $l(\nu^{(3q)}) = l(\nu^{(3p)})$, then $\nu^{(3p)} \succeq \nu^{(3q)}$. If $l(\nu^{(3p)}) > 1$, then $d(\lambda^{(3p)})u \ne 0$, a contradiction. So $l(\nu^{(3j)}) = 1$ for all $j = 1, 2, \cdots, l_3$. It follows that $k_{3j} = 0, j = 1, \cdots, l_3$ since a(-m)u = 0. For $x \in \mathbb{Z}_+, k \in \mathbb{Z}_+$, denote $(x, \cdots, x) \in \mathbb{N}^k$ by $x^{(k)}$. Then

$$u = \sum_{\lambda \in P(n)} [a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i})]\mathbf{1}_{\alpha},$$

where P(n) is the set of all partitions of weight $n, \lambda = (\lambda_1^{(q_1)}, \lambda_2^{(q_2)}, \dots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$ such that $\sum_{i=1}^{k_{\lambda}} q_i \lambda_i = n$, and $\lambda \setminus \lambda_i = (\lambda_1^{(q_1)}, \dots, \lambda_i^{(q_i-1)}, \dots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$ and if $\lambda = \lambda_i$, then $c(-\lambda \setminus \lambda_i)b(-\lambda_i+m) = b(-\lambda_i+m)$. By the fact that d(r+1)u = a(r-m)u = b(r+m+1)u = 0 for $r \in \mathbb{Z}_+$, and c + n - m = 0, we deduce that $a_{\lambda}, b_{\lambda \setminus \lambda_i, \lambda_i}, i = 1, 2, \dots, k_{\lambda}$ are uniquely determined by the following equations up to a non-zero scalar.

$$a_{\lambda}q_{i}\lambda_{i} - b_{\lambda\setminus\lambda_{i},\lambda_{i}} = 0, \ i = 1, 2, \cdots, k_{\lambda}, \tag{3.4}$$

$$b_{\lambda\setminus\lambda_i,\lambda_i}(-n+\lambda_i) + \sum_{j=1}^{k_\lambda} b_{\lambda\setminus\lambda_i\setminus\lambda_j,\lambda_i+\lambda_j} = 0.$$
(3.5)

It is easy to check that the u determined by (3.4) and (3.5) is indeed a non-zero singular vector. Generally

$$u = \left[\sum_{\lambda \in P(n)} (a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i}))\right]^{k} \mathbf{1}_{\alpha}, \ k = 1, 2, \cdots$$

satisfying (3.4) and (3.5) are all the linearly independent singular vectors.

Subcase 2 $u_{33} = 0, u_{32} \neq 0$. Then $-c + \mu_1^{(61)} + m = 0$. Similar to the proof for Subcase 1, we can deduce that $u_1 = u_{22} = u_{23} = 0, l_6 = 1, \mu^{(61)} = (\mu_1^{(61)}, \dots, \mu_1^{(61)})$ and $k_{2i} = k_{5j} = 0, i = 1, 2, \dots, l_2, j = 1, 2, \dots, l_5$.

We first assume that $l(\mu^{(61)}) = 1$ and $\mu_1^{(61)} = n$. Then it is easy to see that $l(\mu^{(2j)}) = 1$, $j = 1, 2, \dots, l_2, u_{21} = 0$. Therefore

$$u = \sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_i, \lambda_i} c(-\lambda \setminus \lambda_i) a(-\lambda_i) \mathbf{1}_{\alpha},$$

where P(n) is the set of all partitions of weight $n, \lambda^{(k)} = (\lambda, \lambda, \dots, \lambda) \in \mathbb{Z}_{+}^{k}, \lambda = (\lambda_{1}^{(q_{1})}, \lambda_{2}^{(q_{2})}, \dots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$ such that $\sum_{i=1}^{k_{\lambda}} q_{i}\lambda_{i} = n$, and $\lambda \setminus \lambda_{i} = (\lambda_{1}^{(q_{1})}, \dots, \lambda_{i}^{(q_{i-1})}, \dots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$. By d(n)u = b(n)u = 0 for $n \geq 1$, we deduce that

$$q_i \lambda_i c_{\lambda \setminus \lambda_j, \lambda_j} + c_{\lambda \setminus \lambda_i \setminus \lambda_j, \lambda_i + \lambda_j} = 0, \ i, j = 1, 2, \cdots, k_\lambda, i \neq j,$$
(3.6)

$$c_{\lambda\setminus\lambda_i,\lambda_i}(-n+\lambda_i) - \sum_{j=1}^{k_\lambda} c_{\lambda\setminus\lambda_i\setminus\lambda_j,\lambda_i+\lambda_j} = 0, \ i = 1, 2, \cdots, k_\lambda.$$
(3.7)

Actually, u is uniquely determined by (3.6) and (3.7).

Next for the case that $l(\mu^{(61)}) > 1$ and $\mu_1^{(61)} = n$, one can easily deduce that

$$u = \left[\sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_{i}, \lambda_{i}} c(-\lambda \setminus \lambda_{i}) a(-\lambda_{i})\right]^{k} \mathbf{1}_{\alpha}, \ k \in \mathbb{Z}_{+}$$

satisfying (3.6) and (3.7) for some $k \in \mathbb{N}$.

Conversely, for $k \in \mathbb{Z}, k \geq 1$, it is easy to check that

$$u = \left[\sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_{i},\lambda_{i}} c(-\lambda \setminus \lambda_{i}) a(-\lambda_{i})\right]^{k} \mathbf{1}_{\alpha}, \ k \in \mathbb{Z}_{+}$$

satisfying (3.6) and (3.7) is a singular vector. The proof of the theorem is complete. \Box Corollary 3.4. (1) If c + n = m for some $n \in \mathbb{Z}_+$, then

$$L_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha}) = V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha}) / U(\widehat{H}_4) u^1$$

is irreducible, where

$$u^{1} = \sum_{\lambda \in P(n)} (a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i}))\mathbf{1}_{\alpha},$$

satisfying (3.4) and (3.5);

(2) If c - n = m for some $n \in \mathbb{Z}_+$, then

$$L_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha}) = V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha}) / U(\widehat{H}_4) u^1$$

is irreducible, where

$$u^{1} = \sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_{i}, \lambda_{i}} c(-\lambda \setminus \lambda_{i}) a(-\lambda_{i}) \mathbf{1}_{\alpha},$$

satisfying (3.6) and (3.7).

Proof: We only prove (1), since the proof of (2) is quite similar. Let

$$V' = U(\widehat{H}_4)u^1.$$

By Theorem 3.3 (ii), all the homogeneous singular vectors

$$u^{k} = \left[\sum_{\lambda \in P(n)} (a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i}))\right]^{k} \mathbf{1}_{\alpha}, \ k = 1, 2, \cdots$$

lie in V'. Now let U/V' be a proper submodule of $V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})/V'$, where U is a proper submodule of $V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})$. Recall that

$$V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha}) = \bigoplus_{j=1}^{\infty} V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})_j$$

Let

$$v = \sum_{i} v_i \in U,$$

where $0 \neq v_i \in V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})_i$, be such that $|v| = \sum_i i$ is the minimal. Then

$$\hat{H}_4((m,1),+)v_i = 0,$$

for each *i*, where $\widehat{H}_4((m, 1), +)$ is the same as (3.3). By Theorem 3.3 (ii), $v_i \in V'$. So U = V'. This proves that $V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\alpha})/V'$ is irreducible. \Box Finally we introduce the so-called third class of generalized Verma type modules of

Finally we introduce the so-called third class of generalized Verma type modules of \widehat{H}_4 . For $m \in \mathbb{Z}$, let $\widehat{H}_4(m, 0)$ be the subalgebra of \widehat{H}_4 defined by (3.1) for the case $\epsilon = 0$, that is,

$$\widehat{H}_4(m,0) = (\bigoplus_{n \ge -m} \mathbb{C}a \otimes t^n) \bigoplus (\bigoplus_{n \ge m} \mathbb{C}b \otimes t^n) \bigoplus ((\mathbb{C}c \bigoplus \mathbb{C}d) \otimes \mathbb{C}[t]) \bigoplus \mathbb{C}\mathbf{k}.$$

Set

$$\widehat{H}_4(m,0)^+ = \left(\bigoplus_{n \ge -m+1} \mathbb{C}a \otimes t^n\right) \bigoplus \left(\bigoplus_{n \ge m+1} \mathbb{C}b \otimes t^n\right) \bigoplus \left(\left(\mathbb{C}c \bigoplus \mathbb{C}d\right) \otimes \mathbb{C}t[t]\right).$$
(3.8)

For $\tilde{\lambda}, \tilde{\mu}, \tilde{\nu} \in \mathbb{C}$, let

$$V(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m) = \bigoplus_{n \in \mathbb{Z}} \mathbb{C} v_n$$

be an infinite dimensional module of $\widehat{H}_4(m,0)$ defined by

$$\begin{aligned} \hat{H}_4(m,0)^+ v_n &= 0, \ \mathbf{k} \cdot v_n = v_n \ n \in \mathbb{Z}, \\ c(0)v_n &= (\tilde{\mu} + m)v_n, \ a(-m)v_n = -\tilde{\mu}v_{n+1}, \\ d(0)v_n &= (\tilde{\lambda} + n)v_n, \ b(m)v_n = (\tilde{\lambda} + \tilde{\nu} + n)v_{n-1}. \end{aligned}$$

The following lemma is obvious.

Lemma 3.5. $V(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m)$ is an irreducible $\widehat{H}_4(m, 0)$ -module if and only if $\tilde{\mu} \neq 0$ and $\tilde{\lambda} + \tilde{\nu} \notin \mathbb{Z}$.

Let

$$V_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m) = U(\widehat{H}_4) \otimes_{U(\widehat{H}_4(m,0))} V(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m)$$

be the induced \widehat{H}_4 -module.

For $n \in \mathbb{Z}$, define

$$\deg a(-n-m) = n, \ \deg b(-n+m) = n,$$
$$\deg c(-n) = n, \ \deg d(-n) = n, \ \deg \mathbf{k} = 0.$$

Then $U(\hat{H}_4)$ is \mathbb{Z} -graded. So we get an \mathbb{N} -gradation of $V_{\hat{H}_4}(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m)$ by defining deg $v_n = 0$ for $n \in \mathbb{Z}$. A homogeneous vector u in $V_{\hat{H}_4}(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m)$ is called a homogeneous singular vector if

$$\hat{H}_4(m,0)^+(u) = 0$$

Similar to Theorem 3.3, we have the following last main result of this section.

Theorem 3.6. Let $\tilde{\lambda}, \tilde{\mu}, \tilde{\nu} \in \mathbb{C}$ be such that $\tilde{\lambda} + \tilde{\nu} \notin \mathbb{Z}$, $\tilde{\mu} \neq 0$. Then the \hat{H}_4 -module $V_{\hat{H}_4}(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m)$ is irreducible if and only if $\tilde{\mu} + n \neq 0$ for all $n \in \mathbb{Z}$. Furthermore, we have

(i) If $\tilde{\mu} + n = 0$ for some $n \in \mathbb{Z}_+$, then all the linearly independent homogeneous singular vectors are

$$u^{(k,j)} = \left[\sum_{\lambda \in P(n)} (a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i}+m))\right]^{k}v_{j}, \ j \in \mathbb{Z}, \ k = 1, 2, \cdots$$

satisfying

$$a_{\lambda}q_{i}\lambda_{i} - b_{\lambda\setminus\lambda_{i},\lambda_{i}} = 0, \ i = 1, 2, \cdots, k_{\lambda},$$

$$(3.9)$$

$$b_{\lambda \setminus \lambda_i, \lambda_i}(\tilde{\mu} + \lambda_i) + \sum_{j=1}^{k_\lambda} b_{\lambda \setminus \lambda_i \setminus \lambda_j, \lambda_i + \lambda_j} = 0; \qquad (3.10)$$

The submodules generated by $u^{(k,i)}$ and $u^{(k,j)}$ for $i, j \in \mathbb{Z}$, $i \neq j$ are isomorphic to each other.

(ii) If $\tilde{\mu} - n = 0$ for some $n \in \mathbb{Z}_+$, then all the homogeneous singular vectors are

$$u^{(k,j)} = \left[\sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_{i},\lambda_{i}} c(-\lambda \setminus \lambda_{i}) a(-\lambda_{i})\right]^{k} v_{j}, \ j \in \mathbb{Z}, \ k = 1, 2, \cdots$$

satisfying

$$q_i \lambda_i c_{\lambda \setminus \lambda_j, \lambda_j} + c_{\lambda \setminus \lambda_i \setminus \lambda_j, \lambda_i + \lambda_j} = 0, \ i, j = 1, 2, \cdots, k_\lambda, i \neq j,$$
(3.11)

$$c_{\lambda\setminus\lambda_i,\lambda_i}(-\tilde{\mu}+\lambda_i) - \sum_{j=1}^{k_\lambda} c_{\lambda\setminus\lambda_j,\lambda_i+\lambda_j} = 0, \ i = 1, 2, \cdots, k_\lambda,$$
(3.12)

and the submodules generated by $u^{(k,i)}$ and $u^{(k,j)}$ for $i, j \in \mathbb{Z}$, $i \neq j$ are isomorphic to each other, where in (i) and (ii), P(n) is the set of all partitions of weight n,

$$\lambda^{(k)} = (\lambda, \lambda, \cdots, \lambda) \in \mathbb{Z}_{+}^{k}, \ \lambda = (\lambda_{1}^{(q_{1})}, \ \lambda_{2}^{(q_{2})}, \cdots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$$

such that $\sum_{i=1}^{k_{\lambda}} q_i \lambda_i = n$, and $\lambda \setminus \lambda_i = (\lambda_1^{(q_1)}, \dots, \lambda_i^{(q_i-1)}, \dots, \lambda_{k_{\lambda}}^{(q_{k_{\lambda}})})$ and if $\lambda = \lambda_i$, then $c(-\lambda \setminus \lambda_i)b(-\lambda_i) = b(-\lambda_i)$, $c(-\lambda \setminus \lambda_i)a(-\lambda_i) = a(-\lambda_i)$.

Corollary 3.7. (1) If $\tilde{\mu} + n = m$ for some $n \in \mathbb{Z}_+$, then

$$L_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m) = V_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m)/U(\widehat{H}_4)u^1$$

is irreducible, where

$$u^{1} = \sum_{\lambda \in P(n)} (a_{\lambda}c(-\lambda)b(m) + \sum_{i=1}^{k_{\lambda}} b_{\lambda \setminus \lambda_{i},\lambda_{i}}c(-\lambda \setminus \lambda_{i})b(-\lambda_{i}))v_{0},$$

satisfying (3.9) and (3.10);

(2) If $\tilde{\mu} - n = m$ for some $n \in \mathbb{Z}_+$, then

$$L_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m) = V_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m)/U(\widehat{H}_4)u^1$$

is irreducible, where

$$u^{1} = \sum_{\lambda \in P(n)} \sum_{i=1}^{k_{\lambda}} c_{\lambda \setminus \lambda_{i}, \lambda_{i}} c(-\lambda \setminus \lambda_{i}) a(-\lambda_{i}) v_{0},$$

satisfying (3.11) and (3.12).

4 Extension of the vertex operator algebra $V_{\widehat{H}_4}(1,0)$

 Set

$$\mathfrak{h} = \mathbb{C}c(-1)\mathbf{1} \oplus \mathbb{C}d(-1)\mathbf{1}.$$

Then

$$L(n)h = \delta_{n,0}h, \quad h(n)h' = (h,h')\delta_{n,1}\mathbf{1} \quad \text{for } n \in \mathbb{Z}_+, \quad h,h' \in \mathfrak{h}$$

and (,) restricted to \mathfrak{h} is a non-degenerate symmetric bilinear form. Thus we can identify \mathfrak{h} with its dual \mathfrak{h}^* . One can easily see that for any $h \in \mathfrak{h}$, h(0) acts semisimply on $V_{\widehat{H}_4}(1, 0)$. So

$$V_{\widehat{H}_4}(1,0) = \bigoplus_{\alpha \in \mathfrak{h}} V_{\widehat{H}_4}(1,0)^{(0,\alpha)},$$

where

$$V_{\widehat{H}_4}(1,0)^{(0,\alpha)} = \{ v \in V_{\widehat{H}_4}(1,0) | h(0)v = (\alpha,h)v \text{ for } h \in \mathfrak{h} \}.$$

 Set

$$P = \{ \alpha \in \mathfrak{h} | V_{\hat{H}_4}(1,0)^{(0,\alpha)} \neq 0 \}$$

According to [22], P equipped with the bilinear form (,) is a lattice. Then

 $P = \mathbb{Z}c$

Set

$$L = \mathbb{Z}c \oplus \mathbb{Z}d$$

Then for any $\alpha \in L$, $\alpha(0)$ acting on $V_{\widehat{H}_4}(1,0)$ has only integral eigenvalues. This amounts to $L \subset P^0$, where

 $P^0 = \{h \in \mathfrak{h} | (h, \alpha) \in \mathbb{Z} \text{ for } \alpha \in P\}$

Let $\epsilon: L \times L \to \{\pm 1\}$ be a 2-cocycle on L such that

$$\epsilon(c,c)=1,\quad \epsilon(c,d)=-1,\quad \epsilon(d,d)=1,$$

and

$$\epsilon(\alpha,\beta)\epsilon(\beta,\alpha)^{-1} = (-1)^{(\alpha,\beta)+(\alpha,\alpha)(\beta,\beta)} = (-1)^{(\alpha,\beta)} \quad \text{for } \alpha,\beta \in L.$$

For $\alpha \in L$, let

$$E^{\pm}(\alpha, z) = exp\left(\sum_{n=1}^{\infty} \frac{\alpha(\pm n)}{\pm n} z^{\mp n}\right), \quad \Delta(\alpha, z) = z^{\alpha(0)} E^{+}(-\alpha, -z).$$

Let $(W, Y(\cdot, z))$ be any (irreducible) weak $V_{\hat{H}_4}(1, 0)$ -module, then by Proposition 2.9 of [22], $(W^{(\alpha)}, Y_{\alpha}(\cdot, z)) = (W, Y(\triangle(\alpha, z) \cdot, z))$ carries the structure of an (irreducible) weak $V_{\hat{H}_4}(1, 0)$ -module. We expand $Y_{\alpha}(u, z)$ for $u \in V_{\hat{H}_4}(1, 0)$ as follows:

$$Y_{\alpha}(u,z)) = \sum_{n \in \mathbb{Z}} u_{(\alpha,n)} z^{-n-1}.$$

We have the following result.

Proposition 4.1. (1) Let $k \in \mathbb{Z}$ and $\alpha = kc \in L$, then $V_{\widehat{H}_4}(1,0)^{(\alpha)} \cong V_{\widehat{H}_4}(1,d)$ with $\mathbf{d} = k \ and \ V_{\widehat{H}_4}(1,0)^{(\alpha)} \ is \ a \ simple \ current \ of \ V_{\widehat{H}_4}(1,0).$

(2) Let $m_1, m_2 \in \mathbb{Z}, m_2 \neq 0$ and $\alpha = m_1 c + m_2 d$. Then $V_{\widehat{H}_4}(1,0)^{(\alpha)}$ is isomorphic to the generalized Verma type module $V_{\widehat{H}_4}(1, m_2, \mathbf{1}_{\alpha})$.

(3) $V_{\widehat{H}_4}(1,0)^{(\alpha)}$ is irreducible for each $\alpha \in L$ and for $\alpha, \beta \in L$, $V_{\widehat{H}_4}(1,0)^{(\alpha)} \cong V_{\widehat{H}_4}(1,0)^{(\beta)}$ if and only if $\alpha = \beta$.

Proof: For $\alpha = kc$, let W be any irreducible weak $V_{\widehat{H}_4}(1,0)$ -module. By Lemma 3.1, c(0) acts as a scalar on W. Then by Theorem 2.15 of [23] (see also Theorem 2.13 of [22]), $V_{\hat{H}_4}(1,0)^{(\alpha)}$ is a simple current of $V_{\hat{H}_4}(1,0)$. By Theorem 2.12, $W \cong V_{\hat{H}_4}(1,d)$ for some $d \in \mathbb{C}$. From the definition of $Y_{\alpha}(\cdot,z) = Y(\Delta(\alpha,z)\cdot,z)$, it is easy to check that $W^{(\alpha)} \cong V_{\widehat{H}_4}(1, d+k)$. Therefore (1) holds.

For (2), by the definition of Y_{α} , we have

$$\begin{split} Y_{\alpha}(a(-1)\mathbf{1},z)\mathbf{1} &= z^{m_2}Y(a(-1)\mathbf{1},z)\mathbf{1}, \quad Y_{\alpha}(b(-1)\mathbf{1},z)\mathbf{1} = z^{-m_2}Y(b(-1)\mathbf{1},z)\mathbf{1}, \\ &Y_{\alpha}(c(-1)\mathbf{1},z)\mathbf{1} = Y(c(-1)\mathbf{1} + z^{-1}m_2\mathbf{1},z)\mathbf{1}, \\ &Y_{\alpha}(d(-1)\mathbf{1},z)\mathbf{1} = Y(d(-1)\mathbf{1} + z^{-1}m_1\mathbf{1},z)\mathbf{1}, \end{split}$$

So we have

$$(a(-1)\mathbf{1})_{(\alpha,n)}\mathbf{1} = 0, \quad (b(-1)\mathbf{1})_{(\alpha,m)}\mathbf{1} = 0, \text{ for } n \ge -m_2, \ m \ge m_2,$$
$$(c(-1)\mathbf{1})_{(\alpha,n)}\mathbf{1} = (d(-1)\mathbf{1})_{(\alpha,n)}\mathbf{1} = 0, \text{ for } n \ge 1,$$
$$(c(-1)\mathbf{1})_{(\alpha,0)}\mathbf{1} = m_2\mathbf{1}, \quad (d(-1)\mathbf{1})_{(\alpha,0)}\mathbf{1} = m_1\mathbf{1}.$$

Therefore as an \widehat{H}_4 -module, $V_{\widehat{H}_4}(1,0)^{(\alpha)}$ is a quotient of the generalized Verma type module $V_{\hat{H}_4}(1, m_2, \mathbf{1}_{\alpha})$. By Theorem 3.2, $V_{\hat{H}_4}(1, 0)^{(\alpha)}$ is isomorphic to $V_{\hat{H}_4}(1, m_2, \mathbf{1}_{\alpha})$.

(3) follows from Theorem 3.2 and (1)-(2).

Furthermore, we have

Proposition 4.2. Let $\alpha = m_1 c + m_2 d \in L$, $\beta = n_1 c + n_2 d \in \mathfrak{h}^*$ and $m \in \mathbb{Z}$. Then (1)(1 (1) + 1) = (0) = 17 (1)

$$V_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\beta})^{(\alpha)} \cong V_{\widehat{H}_4}(1, (m + m_2, 1), \mathbf{1}_{\alpha + \beta}),$$

$$L_{\widehat{H}_4}(1, (m, 1), \mathbf{1}_{\beta})^{(\alpha)} \cong L_{\widehat{H}_4}(1, (m + m_2, 1), \mathbf{1}_{\alpha + \beta}).$$

(2) Let $\tilde{\lambda}, \tilde{\mu}, \tilde{\nu} \in \mathbb{C}$ be such that $\tilde{\lambda} + \tilde{\nu} \notin \mathbb{Z}, \tilde{\mu} \neq 0$. Then

$$V_{\widehat{H}_4}(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m)^{(\alpha)} \cong V_{\widehat{H}_4}(\tilde{\lambda} + m_1, \tilde{\mu}, \tilde{\nu}, m + m_2),$$
$$L_{\widehat{H}_4}(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, m)^{(\alpha)} \cong L_{\widehat{H}_4}(\tilde{\lambda} + m_1, \tilde{\mu}, \tilde{\nu}, m + m_2).$$

For convenience, we give the following definition.

Definition 4.3. Let \mathcal{F} be the category of irreducible restricted \widehat{H}_4 -modules W of level 1 such that d(0) is semisimple, and there exists an integer m such that h(n), a(-m+n) and b(m+n) for $n \ge 1, h \in \mathfrak{h}$ are locally nilpotent on W.

The following lemma is easy to prove.

Lemma 4.4. Let $W \in \mathcal{F}$. Then there exist $m \in \mathbb{Z}$ and a non-zero element w in W such that

$$h(n)w = a(-m+n)w = b(m+n)w = 0, \ \forall \ n \ge 1, \ \forall \ h \in \mathfrak{h}.$$

We are now in a position to state the first main result of this section.

Theorem 4.5. Let $W \in \mathcal{F}$ be such that c(0) acts on W as c. Denote $\alpha = dc + cd$, then W is isomorphic to one of the following irreducible modules:

$$V_{\widehat{H}_{4}}(1,m,\mathbf{1}_{\alpha}), V_{\widehat{H}_{4}}(1,(m,1),\mathbf{1}_{\alpha}), V_{\widehat{H}_{4}}(\lambda,\tilde{\mu},\tilde{\nu},m) L_{\widehat{H}_{4}}(1,(m,1),\mathbf{1}_{\alpha}), L_{\widehat{H}_{4}}(\lambda,\tilde{\mu},\tilde{\nu},m)$$

given in Theorems 3.2, 3.3 and 3.6, Corollary 3.4 and Corollary 3.7 respectively.

Proof: Let $W \in \mathcal{F}$, by the definition of \mathcal{F} and Lemma 4.4, there exist an integer m and a non-zero element u in W such that

$$c(0)u = \mathbf{c}u, \ d(0)u = \mathbf{d}u,$$

for some $d \in \mathbb{C}$, and

$$h(n)u = a(-m+n)u = b(m+n)u = 0, \ \forall \ n \ge 1, \ \ \forall \ h \in \mathfrak{h}.$$

We first assume that m = 0. Then

$$h(n)u = a(n)u = b(n)u = 0, \ \forall \ n \ge 1, \ \forall \ h \in \mathfrak{h}.$$

$$(4.1)$$

Let W^0 be the subspace of W consisting of elements satisfying (4.1). Then W^0 is a module of H_4 . Since W is irreducible, it follows that W^0 is an irreducible H_4 -module. By Theorem 2.6, Theorems 3.2, 3.3 and 3.6, Corollaries 3.4 and 3.7, we have

$$W \cong V_{\widehat{H}_4}(1, \mathrm{d}), \quad \text{if } c = 0,$$
$$W \cong V_{\widehat{H}_4}(1, (0, 1), \mathbf{1}_{\alpha}) \text{ or } V_{\widehat{H}_4}(\tilde{\lambda}, \tilde{\mu}, \tilde{\nu}, 0), \quad \text{if } 0 \neq c \notin \mathbb{Z},$$

 $W \cong L_{\widehat{H}_4}(1, (0, 1), \mathbf{1}_{\alpha}) \text{ or } L_{\widehat{H}_4}(\widetilde{\lambda}, \widetilde{\mu}, \widetilde{\nu}, 0), \text{ if } 0 \neq \mathfrak{c} \in \mathbb{Z}.$

and

Next we assume that $m \neq 0$. Note that W can be viewed as a module for the vertex algebra $V_{\hat{H}_4}(1,0)$. Let (\cdot, z) be the corresponding operator. Let $\beta = -md$. By the proof of Proposition 4.1, $(W^{(\beta)} = W, Y_{\beta}(\cdot, z))$ is a module of $V_{\hat{H}_4}(1,0)$ satisfying

$$(x(-1)\mathbf{1})_{(\beta,n)}u = 0, \ \forall \ x \in H_4, \ \forall \ n \in \mathbb{Z}_+,$$

$$(c(-1)\mathbf{1})_{(\beta,0)}u = (c - m)u, \ (d(-1)\mathbf{1})_{(\beta,0)}u = du.$$

Therefore $W^{(\beta)}$ is isomorphic to one of the following module:

 $V_{\widehat{H}_4}(1,0,\mathbf{1}_{\alpha+\beta}), V_{\widehat{H}_4}(1,(0,1),\mathbf{1}_{\alpha+\beta}), V_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},0), L_{\widehat{H}_4}(1,(0,1),\mathbf{1}_{\alpha+\beta}), L_{\widehat{H}_4}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},0).$ This means that W is isomorphic to one of the irreducible modules:

$$V_{\widehat{H}_{4}}(1,m,\mathbf{1}_{\alpha}), \ V_{\widehat{H}_{4}}(1,(m,1),\mathbf{1}_{\alpha}), \ V_{\widehat{H}_{4}}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m), \ L_{\widehat{H}_{4}}(1,(m,1),\mathbf{1}_{\alpha}), \ L_{\widehat{H}_{4}}(\tilde{\lambda},\tilde{\mu},\tilde{\nu},m).$$

 Set

$$V_{\widehat{H}_4}(1,0)[L] = \mathbb{C}[L] \otimes V_{\widehat{H}_4}(1,0).$$

For $\alpha, \beta \in L$, $u, v \in V_{\widehat{H}_4}(1,0)$, we define a vertex operator map Y on $V_{\widehat{H}_4}(1,0)[L]$ by $Y(e^{\alpha} \otimes u, z)(e^{\beta} \otimes v) = \epsilon(\alpha, \beta)e^{\alpha+\beta} \otimes z^{(\alpha,\beta)}E^{-}(-\alpha, z)Y(\Delta(\beta, z)u, z)E^{+}(-\alpha, z)(-z)^{\alpha(0)}v.$ From [22], we have

Theorem 4.6. $V_{\hat{H}_4}(1,0)[L]$ equipped with the vertex operator map Y is a vertex algebra.

It is easy to see that for each $\alpha \in L$, $\mathbb{C}e^{\alpha} \otimes V_{\widehat{H}_4}(1,0)$ is isomorphic to $V_{\widehat{H}_4}(1,0)^{(\alpha)}$ as $V_{\widehat{H}_4}(1,0)$ -modules. So we also denote

$$V_{\widehat{H}_4}(1,0)^{(\alpha)} = \mathbb{C}e^{\alpha} \otimes V_{\widehat{H}_4}(1,0).$$

It is obvious that L(0) has integral eigenvalues on $V_{\widehat{H}_4}(1,0)[L]$. In fact, for

$$v = e^{k_1 c + k_2 d} \otimes d(-m_{11}) \cdots d(-m_{1i_1}) c(-m_{21}) \cdots c(-m_{2i_2}) a(-m_{31})$$
$$\cdots a(-m_{3i_3}) b(-m_{41}) \cdots b(-m_{4i_4}) \mathbf{1},$$
$$L(0)v = (k_1 k_2 + \sum_{k=1}^{4} \sum_{j=1}^{i_k} m_{kj} + k_2(i_3 - i_4))v.$$

Moreover, the same proof of Theorem 3.5 in [11] gives that for $v \in V_{\widehat{H}_4}(1,0)[L]$,

$$[L(-1), Y(v, z)] = \frac{d}{dz}Y(v, z).$$

Thus $V_{\hat{H}_4}(1,0)[L]$ is a vertex operator algebra except the two grading restrictions.

Theorem 4.7. Let W be a module for the vertex algebra $V_{\widehat{H}_4}(1,0)$ such that for each $\alpha \in L$, $\alpha(0)$ acts on W semisimply with only integral eigenvalues. Set

$$W[L] = \mathbb{C}[L] \otimes W.$$

For $\alpha, \beta \in L$, $v \in V_{\widehat{H}_4}(1,0)$, $w \in W$, we define

$$Y_{W[L]}(e^{\alpha} \otimes v, z)(e^{\beta} \otimes w) = \epsilon(\alpha, \beta)e^{\alpha+\beta} \otimes z^{(\alpha,\beta)}E^{-}(-\alpha, z)Y_{W}(\triangle(\beta, z)v, z)E^{+}(-\alpha, z)(-z)^{\alpha(0)}w.$$

Then W[L] carries the structure of a $V_{\widehat{H}_4}(1,0)[L]$ -module. Furthermore, if W is irreducible, then W[L] is irreducible. In particular, $V_{\widehat{H}_4}(1,0)[L]$ is a simple vertex operator algebra.

Lemma 4.8. Let U be an irreducible $V_{\widehat{H}_4}(1,0)[L]$ -module. Then

(1) There exists an element w in U such that for all $\alpha \in L$ and $n \geq 1$,

$$\alpha(n)w = 0$$

(2) For $\alpha \in L$, $\alpha(0)$ acts on U semisimply with only integral eigenvalues and all $\alpha(n)$ for $n \geq 1$ are locally nilpotent.

Proof: Note that $V_{\hat{H}_4}(1,0)[L]$ contains the lattice vertex algebra V_L and $V_{\hat{H}_4}(1,0)[L]$ is simple. By Lemma 3.15 in [12], there exists an element w in U such that for all $\alpha \in L$, and $n \geq 1$,

$$\alpha(n)w = 0.$$

Let α be any element in L. Since $V_{\hat{H}_4}(1,0)[L]$ is simple, similar to the argument in [9] (see also [25]), from [10], we have $Y(e^{\alpha}, z)w \neq 0$. Then there exists $k \in \mathbb{Z}$ such that $e^{\alpha}(k)w \neq 0$ and $e^{\alpha}(n)w = 0$ for n > k. By the fact that $\frac{d}{dz}Y(e^{\alpha}, z) = \alpha(z)Y(e^{\alpha}, z)$, we have

$$e^{\alpha}(k)\alpha(0)w = (-k-1)e^{\alpha}(k)w.$$

Since

$$[\alpha(n), e^{\beta}(r)] = (\alpha, \beta)e^{\beta}(n+r),$$

we have

$$\alpha(0)e^{\alpha}(k)w = (-k - 1 + (\alpha, \alpha))e^{\alpha}(k)w.$$

Note that $(\alpha, \alpha) \in \mathbb{Z}$, so $-k - 1 + (\alpha, \alpha) \in \mathbb{Z}$. Then (2) follows from Lemma 4.4 and the fact that $e^{\alpha}(k)w$ generates W by operators $x(n), e^{\beta}(n)$, for $x \in H_4, \beta \in L$, and [d, a] = a, [d, b] = -b.

Theorem 4.9. Let W be an irreducible $V_{\hat{H}_4}(1,0)[L]$ -module, then $W \cong \mathbb{C}[L] \otimes U$, where U is an irreducible module of $V_{\hat{H}_4}(1,0)$ such that for $\alpha \in L$, $\alpha(0)$ acts on U semisimply with only integral eigenvalues and all $\alpha(n)$ with $n \geq 1$ are locally nilpotent.

Proof: By Theorem 3.16 of [12], W viewed as a V_L -module is completely reducible and each simple weak module of V_L is $V_{L+\lambda}$, for some $\lambda \in L^\circ$, where L° is the dual of L and V_L is the vertex algebra associated with the even lattice L. Therefore there exist an element $u \in W$ and $\lambda \in L^\circ$ such that for $\alpha \in L$,

$$\alpha(n)u = 0, \ \alpha(0)u = (\alpha, \lambda)u,$$

and

$$e^{\alpha}(-(\alpha,\lambda)-1)u \neq 0, \ e^{\alpha}(-(\alpha,\lambda)-1+n)u = 0,$$

for $n \in \mathbb{Z}_+$. Since

$$[\alpha(n), e^{\beta}(r)] = (\alpha, \beta)e^{\beta}(n+r),$$

it follows that

$$\alpha(n)e^{\alpha}(-(\alpha,\lambda)-1)u = 0$$

for $n \in \mathbb{Z}_+$ and

$$\alpha(0)e^{\alpha}(-(\alpha,\lambda)-1)u = (\alpha,\alpha+\lambda)e^{\alpha}(-(\alpha,\lambda)-1)u$$

Let U be the $V_{\widehat{H}_4}(1,0)$ -module generated by u. Then $\mathbb{C}[L] \otimes U$ is a module of $V_{\widehat{H}_4}(1,0)[L]$. For $\alpha \in L$, let

$$E_{\alpha} = E^{-}(\alpha, z)Y_{W}(e^{\alpha}, z)E^{+}(\alpha, z)(-z)^{-\alpha(0)}$$

Then as the proof of Theorem 3.10 in [25], we have

$$\frac{d}{dz}E_{\alpha} = 0,$$

and

$$E_{\alpha}E_{\beta} = \epsilon(\alpha,\beta)E_{\alpha+\beta}$$

Then it is easy to see that W is linearly spanned by $\{E_{\alpha}w \mid \alpha \in L, w \in U\}$.

Define $\psi \colon \mathbb{C}[L] \otimes U \to W$ by

$$\psi(e^{\alpha} \otimes w) = E_{\alpha} \otimes w,$$

for $\alpha \in L, w \in U$. Quite similar to the proof of Theorem 3.10 in [25], we have

$$\psi(Y_{U[L]}(h(-1)\mathbf{1}, z)(e^{\alpha} \otimes w)) = Y_{W}(h(-1)\mathbf{1}, z)\psi(e^{\alpha} \otimes w),$$
$$\psi(Y_{U[L]}(e^{\alpha}, z)(e^{\beta} \otimes w)) = Y_{W}(e^{\alpha}, z)\psi(e^{\alpha} \otimes w),$$

for $h \in \mathfrak{h}$, $\alpha, \beta \in L$, $w \in U$. Furthermore, for $\alpha = m_1 c + m_2 d \in L$, $w \in U$, we have

$$Y_{U[L]}(a(-1)\mathbf{1}, z)(e^{\alpha} \otimes w) = z^{m_2}e^{\alpha} \otimes Y_{U[L]}(a(-1)\mathbf{1}, z)w,$$

$$Y_W(a(-1)\mathbf{1}, z)E_{\alpha}w = z^{m_2}E_{\alpha}Y_W(a(-1)\mathbf{1}, z)w,$$

$$Y_{U[L]}(b(-1)\mathbf{1}, z)(e^{\alpha} \otimes w) = z^{-m_2}e^{\alpha} \otimes Y_{U[L]}(b(-1)\mathbf{1}, z)w,$$

$$Y_W(b(-1)\mathbf{1}, z)E_{\alpha}w = z^{-m_2}E_{\alpha}Y_W(b(-1)\mathbf{1}, z)w.$$

 So

$$\psi(Y_{U[L]}(a(-1)\mathbf{1},z)(e^{\alpha}\otimes w)) = Y_W(a(-1)\mathbf{1},z)\psi(e^{\alpha}\otimes w),$$

$$\psi(Y_{U[L]}(b(-1)\mathbf{1},z)(e^{\alpha}\otimes w)) = Y_W(b(-1)\mathbf{1},z)\psi(e^{\alpha}\otimes w).$$

This means that ψ is a module isomorphism. Hence $W \cong \mathbb{C}[L] \otimes U$. Since W is irreducible, it follows that U is irreducible. \Box
