Adjusted likelihood inference in an elliptical multivariate errors-in-variables model

Abstract:

In this paper we obtain an adjusted version of the likelihood ratio test for errors-in-variables multivariate linear regression models. The error terms are allowed to follow a multivariate distribution in the class of the elliptical distributions, which has the multivariate normal distribution as a special case. We derive a modified likelihood ratio statistic that follows a chi-squared distribution with a high degree of accuracy. Our results generalize those in Melo & Ferrari (Advances in Statistical Analysis, 2010, 94, 75–87) by allowing the parameter of interest to be vector-valued in the multivariate errors-in-variables model. We report a simulation study which shows that the proposed test displays superior finite sample behavior relative to the standard likelihood ratio test.

Keywords: Elliptical distribution; Measurement error; Modified likelihood ratio statistic; Multivariate errors-in-variables model.

1 Introduction

Statisticians are often faced with the problem of modeling data measured with error. As an example, we refer to Aoki et al. (2001), who compared the effectiveness of two types of toothbrushes in removing dental plaque. One explanatory variable is the dental plaque index before toothbrushing and the response variable is the dental plaque index after brushing, the amount of plaque being imprecisely measured. The authors proposed a null intercept regression model that assumes that this explanatory variable is measured with an additive random error and the measurement error of the response variable is assumed to be absorbed by the error term of the model.

Errors-in-variables models are generalizations of classical regression models. The true (nonobservable) explanatory variables are treated either as random variables, in which case the model is said to be structural, or as unknown parameters, leading to a functional model. Structural models are, in general, non-identifiable, while functional models induce unlimited likelihood functions.

Such difficulties disappear if some variances are assumed to be known (e.g. Chan & Mak (1979) and Wong (1989)) or that the intercept is null (e.g. Aoki et al. (2001)). For details on errors-in-variables models the reader is referred to, for instance, Fuller (1987) and Buonaccorsi (2010).

The most popular errors-in-variables models for continuous outcomes are based on normality assumptions. The family of the elliptical distributions provides a useful alternative to the normal distribution when outlying observations are present in the data. It nests the normal distribution, heavy-tailed distributions, such as the exponential power and the Student-t distributions, and lighttailed distributions. Further information on elliptical distributions can be found in Fang et al. (1990) and Fang and Anderson (1990).

As shown by Melo & Ferrari (2010), statistical inference in errors-in-variables models based on first-order asymptotic approximations can be imprecise for small or moderate sized samples. In particular the type I error of the likelihood ratio test is often larger than the designed level of the test. Skovgaard (2001) proposed a general strategy to adjust the likelihood ratio statistic when interest lies in inference on a vector-valued parameter. The adjustment makes the resulting statistic to follow a chi-squared distribution with a high degree of accuracy. The adjustment is broadly general, but requires either some unusual likelihood quantities or the identification of a suitable ancillary statistic such that, when coupled with the maximum likelihood estimator, constitutes a sufficient statistic for the model. In the present paper, we obtain an appropriate ancilary statistic and derive Skovgaard's adjustment for a structural elliptical multivariate errors-in-variables model.

The paper unfolds as follows. Section 2 introduces the model. Section 3 contains our main results, namely the ancillary statistic and an explicit formula for the modified likelihood ratio test. The finite sample behavior of the likelihood ratio test and its adjusted version is evaluated and discussed in Section 4. Our simulation results clearly show that the likelihood ratio test tends to be oversized and its modified version is much less size-distorted. Finally, Section 5 closes the paper with our conclusions. Technical details are left for three appendices.

2 The model

The $(l+1) \times 1$ random vector \mathbf{Z} is said to have a (l+1)-variate elliptical distribution with location vector $\boldsymbol{\mu}$ ($(l+1) \times 1$), dispersion matrix Σ ($(l+1) \times (l+1)$) and density generating function p_0 , and we write $\mathbf{Z} \sim El_{(l+1)}(\boldsymbol{\mu}, \Sigma; p_0)$, if

$$\boldsymbol{Z} \stackrel{d}{=} \boldsymbol{\mu} + A \boldsymbol{Z}^*,$$

where A is $(l + 1) \times k$ matrix with rank(A) = k, $AA^{\top} = \Sigma$ and \mathbf{Z}^* is a $(l + 1) \times 1$ random vector with density function $p_0(\mathbf{z}^{\top}\mathbf{z})$, for $\mathbf{z} \in \Re^{(l+1)}$. The notation $\mathbf{X} \stackrel{d}{=} \mathbf{Y}$ indicates that \mathbf{X} and \mathbf{Y} have the same distribution. It is assumed that $\int_0^\infty y^{(l+1)/2-1} p_0(y) dy < \infty$. The density function of \mathbf{Z} is

$$p(\boldsymbol{z},\boldsymbol{\mu},\boldsymbol{\Sigma}) = |\boldsymbol{\Sigma}|^{-1/2} p_0 \left((\boldsymbol{z} - \boldsymbol{\mu})^\top \boldsymbol{\Sigma}^{-1} (\boldsymbol{z} - \boldsymbol{\mu}) \right).$$

Some special cases of (1) are the following multivariate distributions: normal, exponential power, Pearson II, Pearson VII, Student-t, generalized Student-t, logistic I, logistic II and Cauchy. The elliptical distributions share many properties with the multivariate normal distribution. In particular, marginal distributions are elliptical. For a full account of the properties of the elliptical distributions, see Fang et al. (1990, Sect. 2.5).

We consider the following model, which consists of p independent errors-in-variables structural models:

$$\mathbf{Y}_{jk} = \boldsymbol{\alpha}_k + \boldsymbol{\beta}_k x_{jk} + \boldsymbol{e}_{jk},$$

$$X_{jk} = x_{jk} + u_{jk},$$
(2)

for $j = 1, 2, ..., n_k$ and k = 1, 2, ..., p, where $\mathbf{Y}_{jk} = (Y_{1jk}, Y_{2jk}, ..., Y_{ljk})$, $\boldsymbol{\alpha}_k = (\alpha_{1k}, \alpha_{2k}, ..., \alpha_{lk})$, $\boldsymbol{\beta}_k = (\beta_{1k}, \beta_{2k}, ..., \beta_{lk})$ and $\boldsymbol{e}_{jk} = (e_{1jk}, e_{2jk}, ..., e_{ljk})^{\top}$. Here, x_{jk} is not observed directly. Instead, we observe X_{jk} , which is viewed as x_{jk} plus a measurement error, u_{jk} . We assume that $\mathbf{E}(\boldsymbol{e}_{jk}) = \mathbf{0}$, $\operatorname{Var}(\boldsymbol{e}_{jk}) = \Sigma_{e_k} = \operatorname{diag} \{\sigma_{e_{1k}}^2, \sigma_{e_{2k}}^2, ..., \sigma_{e_{lk}}^2\}$ and $\operatorname{Cov}(\boldsymbol{e}_{j'k'}, \boldsymbol{e}_{jk}) = 0$; $\mathbf{E}(u_{jk}) = 0$, $\operatorname{Var}(u_{jk}) = \sigma_{u_k}^2$ and $\operatorname{Cov}(u_{j'k'}, u_{jk}) = 0$; $\mathbf{E}(x_{jk}) = \mu_{x_k}$, $\operatorname{Var}(x_{jk}) = \sigma_{x_k}^2$ and $\operatorname{Cov}(x_{j'k'}, x_{jk}) = 0$; $\operatorname{Cov}(x_{j'k'}, u_{jk}) = 0$, with $(j', k') \neq (j, k)$.

Model (2) can be written as

$$\boldsymbol{Z}_{jk} = \boldsymbol{\delta}_k + \Delta_k \boldsymbol{b}_{jk},\tag{3}$$

for $j = 1, 2, ..., n_k$ and k = 1, 2, ..., p, where

$$\boldsymbol{Z}_{jk} = \begin{pmatrix} \boldsymbol{Y}_{jk} \\ X_{jk} \end{pmatrix}, \ \boldsymbol{\delta}_k = \begin{pmatrix} \boldsymbol{\alpha}_k \\ 0 \end{pmatrix}, \ \Delta_k = \begin{pmatrix} \boldsymbol{\beta}_k & I_l & \boldsymbol{0} \\ 1 & \boldsymbol{0} & 1 \end{pmatrix} \ \text{and} \ \boldsymbol{b}_{jk} = \begin{pmatrix} x_{jk} \\ \boldsymbol{e}_{jk} \\ u_{jk} \end{pmatrix},$$

where I_l is the identity matrix of dimension l. We assume that, for each k = 1, 2, ..., p, the errors $\mathbf{b}_{1k}, \mathbf{b}_{2k}, \ldots, \mathbf{b}_{n_k k}$ are independent and $\mathbf{b}_{jk} \sim El_{(l+2)}(\boldsymbol{\eta}_k, \Omega_k; p_0)$, with

$$\boldsymbol{\eta}_{k} = \begin{pmatrix} \mu_{x_{k}} \\ \mathbf{0} \\ 0 \end{pmatrix} \text{ and } \boldsymbol{\Omega}_{k} = \begin{pmatrix} \sigma_{x_{k}}^{2} & \mathbf{0} & 0 \\ \mathbf{0} & \boldsymbol{\Sigma}_{e_{k}} & \mathbf{0} \\ 0 & \mathbf{0} & \sigma_{u_{k}}^{2} \end{pmatrix}$$

Therefore, for each k = 1, 2, ..., p, the random vectors $\mathbf{Z}_{1k}, \mathbf{Z}_{2k}, ..., \mathbf{Z}_{n_k k}$ are independent and $\mathbf{Z}_{jk} \sim El_{l+1}(\boldsymbol{\mu}_k, \Sigma_k; p_0)$, with $\boldsymbol{\mu}_k = \boldsymbol{\delta}_k + \Delta_k \boldsymbol{\eta}_k$ and $\Sigma_k = \Delta_k \Omega_k \Delta_k^{\top}$ (Fang et al. 1990, Sect. 2.5). We can write $\boldsymbol{\mu}_k$ and Σ_k as

$$\boldsymbol{\mu}_{k} = \begin{pmatrix} \boldsymbol{\alpha}_{k} + \boldsymbol{\beta}_{k} \boldsymbol{\mu}_{x_{k}} \\ \boldsymbol{\mu}_{x_{k}} \end{pmatrix} \text{ and } \boldsymbol{\Sigma}_{k} = \begin{pmatrix} \boldsymbol{\beta}_{k} \sigma_{x_{k}}^{2} \boldsymbol{\beta}_{k}^{\top} + \boldsymbol{\Sigma}_{e_{k}} & \boldsymbol{\beta}_{k} \sigma_{x_{k}}^{2} \\ \sigma_{x_{k}}^{2} \boldsymbol{\beta}_{k}^{\top} & \sigma_{x_{k}}^{2} + \sigma_{u_{k}}^{2} \end{pmatrix}.$$

Regression model (2) generalizes the normal structural models proposed by Cox (1976) (l = 1) and Russo et al. (2009) (l = 2), and the elliptical structural model considered in Melo & Ferrari (2010) (l = p = 1); a closely related model is presented by Garcia-Alfaro & Bolfarine (2001). As expected, model (2) is not identifiable because the relation between the parameters of the distribution of \mathbf{Z}_{jk} and $\boldsymbol{\theta}_{(k)} = \left(\boldsymbol{\beta}_{k}^{\top}, \alpha_{k}, \mu_{x_{k}}, \sigma_{x_{k}}^{2}, \sigma_{u_{k}}^{2^{\top}}, \boldsymbol{\sigma}_{e_{k}}^{2^{\top}}\right)^{\top}$ is not unique. Assumptions on $\sigma_{x_{k}}^{2}$ and $\boldsymbol{\sigma}_{e_{k}}^{2}$ are usually imposed to overcome identifiability problems. It is common to assume that the $\lambda_{x_{k}} = \sigma_{x_{k}}^{2}/\sigma_{u_{k}}^{2}$ or $\lambda_{e_{ik}} = \sigma_{e_{ik}}^{2}/\sigma_{u_{k}}^{2}$, for $i = 1, 2, \ldots, l$, is known. An alternative assumption is that the intercept α_{k} is known (see Aoki et al., 2001). Under each of these identifiability assumptions we have:

(i) if λ_{x_k} is known,

$$\boldsymbol{\theta}_{(k)} = \left(\boldsymbol{\beta}_{k}^{\top}, \alpha_{k}, \mu_{x_{k}}, \sigma_{u_{k}}^{2}, \boldsymbol{\sigma}_{e_{k}}^{2^{\top}}\right)^{\top} \text{ and } \boldsymbol{\Sigma}_{k} = \left(\begin{array}{cc} \boldsymbol{\beta}_{k} \boldsymbol{\beta}_{k}^{\top} \lambda_{x_{k}} \sigma_{u_{k}}^{2} + \boldsymbol{\Sigma}_{e_{k}} & \boldsymbol{\beta}_{k} \lambda_{x_{k}} \sigma_{u_{k}}^{2} \\ \lambda_{x_{k}} \sigma_{u_{k}}^{2} \boldsymbol{\beta}_{k}^{\top} & (\lambda_{x_{k}} + 1) \sigma_{u_{k}}^{2} \end{array}\right);$$

(ii) if λ_{e_k} is known,

$$\boldsymbol{\theta}_{(k)} = \begin{pmatrix} \boldsymbol{\beta}_{k}^{\top}, \alpha_{k}, \mu_{x_{k}}, \sigma_{x_{k}}^{2}, \sigma_{u_{k}}^{2} \end{pmatrix}^{\top} \text{ and } \boldsymbol{\Sigma}_{k} = \begin{pmatrix} \boldsymbol{\beta}_{k} \sigma_{x_{k}}^{2} \boldsymbol{\beta}_{k}^{\top} + \lambda_{e_{k}} \sigma_{u_{k}}^{2} & \boldsymbol{\beta}_{k} \sigma_{x_{k}}^{2} \\ \sigma_{x_{k}}^{2} \boldsymbol{\beta}_{k}^{\top} & \sigma_{x_{k}}^{2} + \sigma_{u_{k}}^{2} \end{pmatrix},$$

with $\lambda_{e_{k}} = \text{diag} \left\{ \lambda_{e_{1k}}, \lambda_{e_{2k}}, \dots, \lambda_{e_{lk}} \right\};$

(iii) if α is known,

$$\boldsymbol{\theta}_{(k)} = \begin{pmatrix} \boldsymbol{\beta}_k^{\top}, \mu_{x_k}, \sigma_{x_k}^2, \sigma_{u_k}^2, \boldsymbol{\sigma}_{e_k}^{2^{\top}} \end{pmatrix}^{\top} \text{ and } \boldsymbol{\Sigma}_k = \begin{pmatrix} \boldsymbol{\beta}_k \sigma_{x_k}^2 \boldsymbol{\beta}_k^{\top} + \boldsymbol{\Sigma}_{e_k} & \boldsymbol{\beta}_k \sigma_{x_k}^2 \\ \sigma_{x_k}^2 \boldsymbol{\beta}_k^{\top} & \sigma_{x_k}^2 + \sigma_{u_k}^2 \end{pmatrix}.$$

The independent structural elliptical model can be defined in terms of the density function of $\boldsymbol{Z} = \left(\boldsymbol{Z}_{(1)}^{\top}, \boldsymbol{Z}_{(2)}^{\top}, \dots, \boldsymbol{Z}_{(p)}^{\top}\right)^{\top}$, with $\boldsymbol{Z}_{(k)} = \left(\boldsymbol{Z}_{1k}^{\top}, \boldsymbol{Z}_{2k}^{\top}, \dots, \boldsymbol{Z}_{n_k k}^{\top}\right)^{\top}$, for $k = 1, 2, \dots, p$, which is given by

$$p_{\boldsymbol{Z}}(\boldsymbol{z},\boldsymbol{\theta}) = \prod_{k=1}^{p} \prod_{j=1}^{n_{k}} |\Sigma_{k}|^{-1/2} p_{0}(\boldsymbol{d}_{jk}^{\top} \Sigma_{k}^{-1} \boldsymbol{d}_{jk}),$$

where $d_{jk} = d_{jk}(\boldsymbol{\theta}_{(k)}) = \boldsymbol{z}_{jk} - \boldsymbol{\mu}_k$, for $j = 1, 2, \dots, n_k$, $k = 1, 2, \dots, p$, and $\boldsymbol{\theta} = \left(\boldsymbol{\theta}_{(1)}^{\top}, \boldsymbol{\theta}_{(2)}^{\top}, \dots, \boldsymbol{\theta}_{(p)}^{\top}\right)^{\top}$.

The log-likelihood function for the k-th group, k = 1, 2, ..., p, is given by

$$\ell_k(\boldsymbol{\theta}, \boldsymbol{z}) = -\frac{n_k}{2} \log |\Sigma_k| + \sum_{j=1}^{n_k} \log p_0(\boldsymbol{d}_{jk}^{\top} \Sigma_k^{-1} \boldsymbol{d}_{jk}).$$

For a sample of size $n = \sum_{k=1}^{p} n_k$ and p populations, the log-likelihood function is

$$\ell(\boldsymbol{\theta}, \boldsymbol{z}) = \sum_{k=1}^{p} \ell_k(\boldsymbol{\theta}, \boldsymbol{z}).$$

Maximum likelihood estimation of the parameters can be carried out by numerically maximizing the log-likelihood function (4) through an iterative algorithm such as the Newton-Raphson, the Fisher scoring, EM or BFGS. Our numerical results were obtained using the library function MaxBFGS in the Ox matrix programming language (Doornik 2006).

3 Ancillary statistic and modified likelihood ratio test

The parameter vector $\boldsymbol{\theta}$ is partitioned as $\boldsymbol{\theta} = (\boldsymbol{\psi}^{\top}, \boldsymbol{\omega}^{\top})^{\top}$, with $\boldsymbol{\psi}$ representing the parameter of interest and $\boldsymbol{\omega}$ the nuisance parameter. Our interest lies in testing $\mathcal{H}_0: \boldsymbol{\psi} = \boldsymbol{\psi}^{(0)}$ versus $\mathcal{H}_1: \boldsymbol{\psi} \neq \boldsymbol{\psi}^{(0)}$, where $\boldsymbol{\psi}^{(0)}$ is a *q*-dimensional parameter of known constants. The maximum likelihood estimator of $\boldsymbol{\theta}$ is denoted by $\hat{\boldsymbol{\theta}} = (\hat{\boldsymbol{\psi}}^{\top}, \hat{\boldsymbol{\omega}}^{\top})^{\top}$ and the corresponding estimator obtained under the null hypothesis is $\tilde{\boldsymbol{\theta}} = (\tilde{\boldsymbol{\psi}}^{\top}, \tilde{\boldsymbol{\omega}}^{\top})^{\top}$, where $\tilde{\boldsymbol{\psi}} = \boldsymbol{\psi}^{(0)}$. We use hat and tilde to indicate evaluation at $\hat{\boldsymbol{\theta}}$ and $\tilde{\boldsymbol{\theta}}$, respectively.

The likelihood ratio statistic for testing \mathcal{H}_0 is given by

$$LR = 2 \left\{ \ell(\widehat{\psi}) - \ell(\widetilde{\psi}) \right\}.$$

Under \mathcal{H}_0 , LR converges to a chi-square distribution with q degrees of freedom, where q in the number of restrictions imposed by \mathcal{H}_0 . This approximation can be improved if one applies a suitable adjustment to the test statistic. Skovgaard (2001) proposed two adjusted likelihood ratio statistics that are asymptotically equivalent for testing \mathcal{H}_0 . We shall denote them by LR^* and LR^{**} . The adjustment terms depend on a suitable ancillary statistic and involves derivatives with respect to the sample space. A statistic \boldsymbol{a} is said to be an ancillary statistic if it is distribution constant and, when coupled with the maximum likelihood estimator $\hat{\boldsymbol{\theta}}$, is a minimal sufficient statistic for the model (Barndorff-Nielsen (1986)). If $(\hat{\boldsymbol{\theta}}, \boldsymbol{a})$ is sufficient, but not minimal sufficient, Skovgaard's results still hold; see Severini (2000, Sect. 6.5). In this case, the log-likelihood function depends on the data only through $(\hat{\boldsymbol{\theta}}, \boldsymbol{a})$ and we write $\ell(\boldsymbol{\theta}; \hat{\boldsymbol{\theta}}, \boldsymbol{a})$. The sample space derivatives involved are $\ell' = \partial \ell(\boldsymbol{\theta}; \hat{\boldsymbol{\theta}}, \boldsymbol{a})/\partial \hat{\boldsymbol{\theta}}$ and $U' = \partial^2 \ell(\boldsymbol{\theta}; \hat{\boldsymbol{\theta}}, \boldsymbol{a})/\partial \hat{\boldsymbol{\theta}} \partial \boldsymbol{\theta}^{\mathsf{T}}$. The adjusted statistics are given by

$$LR^* = LR\left(1 - \frac{1}{LR}\log\rho\right)^2\tag{5}$$

and

$$LR^{**} = LR - 2\log\rho,\tag{6}$$

with

$$\rho = |\widehat{J}|^{1/2} |\widetilde{U}'|^{-1} |\widetilde{J}_{\omega\omega}|^{1/2} |\widetilde{\widetilde{J}}_{\omega\omega}|^{-1/2} |\widetilde{\widetilde{J}}|^{1/2} \frac{\{\widetilde{U}^{\top} \widetilde{\widetilde{J}}^{-1} \widetilde{U}\}^{p/2}}{LR^{q/2-1} (\widehat{\ell'} - \widetilde{\ell'})^{\top} (\widetilde{U'})^{-1} \widetilde{U}}.$$

Here $\widetilde{\widetilde{J}}$ equals $\partial^2 \ell(\theta; \widehat{\theta}, a) / \partial \widehat{\theta} \partial \theta^{\top}$ evaluated at $\widehat{\theta} = \widetilde{\theta}$ and $\theta = \widetilde{\theta}$. Also, $\widetilde{\widetilde{J}}_{\omega\omega}$ is the lower right submatrix of $\widetilde{\widetilde{J}}$ that corresponds to the nuisance parameter ω . Both statistics have an approximate \mathcal{X}_q^2 distribution with high degree of accuracy under the null hypothesis (Skovgaard, 2001, p. 7).

Let
$$\boldsymbol{a} = \boldsymbol{a}(\boldsymbol{z}) = \left(\boldsymbol{a}_{(1)}^{\top}(\boldsymbol{z}), \dots, \boldsymbol{a}_{(p)}^{\top}(\boldsymbol{z})\right)^{\top}$$
, where $\boldsymbol{a}_{(k)}^{\top}(\boldsymbol{z}) = \left(\boldsymbol{a}_{1k}^{\top}(\boldsymbol{z}), \dots, \boldsymbol{a}_{n_kk}^{\top}(\boldsymbol{z})\right)^{\top}$, with $\boldsymbol{a}_{jk}(\boldsymbol{z}) = \widehat{P}_k^{-1}(\boldsymbol{z})\left(\boldsymbol{z}_{jk} - \widehat{\boldsymbol{\mu}}_k(\boldsymbol{z})\right)$, $j = 1, 2, \dots, n_k$, $k = 1, 2, \dots, p$, where P_k is a lower triangular matrix such

that $P_k P_k^{\top} = \Sigma_k$ is the Cholesky decomposition. Following Melo & Ferrari (2010) it can be shown that **a** is an ancillary statistic. With this ancillary statistic we can obtain the sample space derivatives which are required for the computation of the adjustment term ρ .

In the following we present some matrices and vectors that form the score U (Appendix A), the observed information matrix J (Appendix A) and the sample space derivatives ℓ' , U' and $\tilde{\widetilde{J}}$ (Appendix B). In matrix notation, we have $U = (U_{(1)}^{\top}, \ldots, U_{(p)}^{\top})^{\top}$, $J = \text{diag}\{J_{(1)}, \ldots, J_{(p)}\}$, $\ell' = (\ell_{(1)}^{\top}, \ldots, \ell_{(p)}^{\top})^{\top}$, $U' = \text{diag}\{U'_{(1)}, \ldots, U'_{(p)}\}$ and $\tilde{\widetilde{J}} = \text{diag}\{\tilde{\widetilde{J}}_{(1)}, \ldots, \tilde{\widetilde{J}}_{(p)}\}$, with $U_{(k)} = -\frac{n_k}{2} \mathbf{n}_{(k)}^* + \mathbf{R}_{(k)}^{\top} \mathbf{h}_{(k)}$, $J_{(k)} = \frac{n_k}{2} T_{(k)} - \mathbf{R}_{(k)}^{\top} \mathbf{M}_{(k)} - \mathbf{V}_{(k)}^{\top} Q_{(k)}$, $\ell'_{(k)} = 2\mathbf{R}_{(k)}^{\top} \mathbf{w}_{(k)}$, $U'_{(k)} = 2(\mathbf{R}_{(k)}^{\top} B_{(k)} + \mathbf{V}_{(k)}^{\top} C_{(k)})$ and $\tilde{\widetilde{J}}_{(k)} = 2(\widehat{\mathbf{R}}_{(k)}^{\top} F_{(k)} + \widehat{V}_{(k)}^{\top} G_{(k)})$. The *i*-th element of $\mathbf{n}_{(k)}^*$ is $\operatorname{tr}(\Sigma_k^{-1} \Sigma_{(k)i})$, for $i = 1, 2, \ldots, s$ and $k = 1, 2, \ldots, p$. Here, s is the total number of parameters in $\boldsymbol{\theta}_{(k)}$. When the ratio λ_{x_k} or the intercept α_k is known, we have s = 2l + 3, and when the ratio λ_{e_k} is known, s = l + 4. The (i, i')-th element of $T_{(k)}$ is

$$t_{(k)ii'} = \operatorname{tr}(\Sigma^{(k)i}\Sigma_{(k)i'}) + \operatorname{tr}(\Sigma_k^{-1}\Sigma_{(k)ii'}),$$

where $\Sigma_{(k)i} = \partial \Sigma_k / \partial \theta_{(k)i}$, $\Sigma_{(k)ii'} = \partial \Sigma_{(k)i} / \partial \theta_{(k)i'}$ and $\Sigma^{(k)i} = \partial \Sigma_k^{-1} / \partial \theta_{(k)i} = -\Sigma_k^{-1} \Sigma_{(k)i} \Sigma_k^{-1}$, for $i, i' = 1, 2, \ldots, s$. Here, $\theta_{(k)i}$ is the *i*-th element of θ_k ; see Appendix C. Also, $R_{(k)}$ and $V_{(k)}$ are block-diagonal matrices given by $R_{(k)} = \text{diag}(\boldsymbol{r}_{(k)}, \boldsymbol{r}_{(k)}, \ldots, \boldsymbol{r}_{(k)})$ and $V_{(k)} = \text{diag}(\boldsymbol{v}_{(k)}, \boldsymbol{v}_{(k)}, \ldots, \boldsymbol{v}_{(k)})$, with dimension $sn_k \times s$, and *j*-th element of the vectors $\boldsymbol{r}_{(k)}$ and $\boldsymbol{v}_{(k)}$ given by $r_{(k)j} = W_{p_0}(\boldsymbol{d}_{jk}^{\top} \Sigma_k^{-1} \boldsymbol{d}_{jk})$ and $v_{(k)j} = W_{p_0}(\boldsymbol{d}_{jk}^{\top} \Sigma_k^{-1} \boldsymbol{d}_{jk})$, respectively. Additionally, we define the column vectors $\boldsymbol{h}_{(k)} = \left(\boldsymbol{h}_{(k)}^{(1)^{\top}}, \ldots, \boldsymbol{h}_{(k)}^{(s)^{\top}}\right)^{\top}$ and $\boldsymbol{w}_{(k)} = \left(\boldsymbol{w}_{(k)}^{(1)^{\top}}, \ldots, \boldsymbol{w}_{(k)}^{(s)^{\top}}\right)^{\top}$, with dimension sn_k , and *j*-th element of the vectors $\boldsymbol{h}_{(k)}$ and $\boldsymbol{w}_{(k)}^{(i)}$, for $i = 1, 2, \ldots, s$, given, respectively, by

and

where $\hat{P}_{(k)i} = \partial \hat{P}_k / \partial \hat{\theta}_{(k)i}$ and $\hat{\mu}_{(k)i} = \partial \hat{\mu}_k / \partial \hat{\theta}_{(k)i}$. The derivative $\hat{P}_{(k)i}$ is obtained through the algorithm proposed by Smith (1995) and the derivative $\hat{\mu}_{(k)i}$ is presented in Appendix C. The block matrices $B_{(k)}$, $C_{(k)}$, $F_{(k)}$, $G_{(k)}$, $M_{(k)}$ and $Q_{(k)}$, with dimension $sn_k \times s$, have the (i, i')-th block given, respectively, by the vectors $\boldsymbol{b}_{(k)}^{ii'}$, $\boldsymbol{c}_{(k)}^{ii'}$, $\boldsymbol{f}_{(k)}^{ii'}$, $\boldsymbol{g}_{(k)}^{ii'}$, $\boldsymbol{m}_{(k)}^{ii'}$ and $\boldsymbol{q}_{(k)}^{ii'}$. The *j*-th elements of these vectors are, respectively,

$$\begin{split} b_{(k)j}^{ii'} &= (\widehat{P}_{(k)i'} \ \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i'})^{\top} \Sigma^{(k)i} (\widehat{P}_{k} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{k} - \boldsymbol{\mu}_{k}) - \boldsymbol{\mu}_{(k)i}^{\top} \Sigma_{k}^{-1} (\widehat{P}_{(k)i'} \ \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i'}), \\ c_{(k)j}^{ii'} &= (\widehat{P}_{(k)i'} \ \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i'})^{\top} \Sigma_{k}^{-1} (\widehat{P}_{k} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{k} - \boldsymbol{\mu}_{k}) \Big[(\widehat{P}_{k} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{k} - \boldsymbol{\mu}_{k})^{\top} \Sigma^{(k)i} (\widehat{P}_{k} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{k} - \boldsymbol{\mu}_{k}) \\ &- 2 \boldsymbol{\mu}_{(k)i}^{\top} \Sigma_{k}^{-1} (\widehat{P}_{k} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{k} - \boldsymbol{\mu}_{k}) \Big], \end{split}$$

$$f_{(k)j}^{ii'} = (\widetilde{P}_{(k)i'} \ \boldsymbol{a}_{jk} + \widetilde{\boldsymbol{\mu}}_{(k)i'})^{\top} \widetilde{\Sigma}^{(k)i} \widetilde{P}_{k} \boldsymbol{a}_{jk} - \widetilde{\boldsymbol{\mu}}_{(k)i}^{\top} \widetilde{\Sigma}_{k}^{-1} (\widetilde{P}_{(k)i'} \ \boldsymbol{a}_{jk} + \widetilde{\boldsymbol{\mu}}_{(k)i'}),$$

$$g_{(k)j}^{ii'} = (\widetilde{P}_{(k)i'} \ \boldsymbol{a}_{jk} + \widetilde{\boldsymbol{\mu}}_{(k)i'})^{\top} \widetilde{\Sigma}_{k}^{-1} \widetilde{P}_{k} \boldsymbol{a}_{jk} \left(\boldsymbol{a}_{jk}^{\top} \widetilde{P}_{k}^{\top} \widetilde{\Sigma}^{(k)i} \widetilde{P}_{k} \boldsymbol{a}_{jk} - 2 \widetilde{\boldsymbol{\mu}}_{(k)i}^{\top} \widetilde{\Sigma}_{k}^{-1} \widetilde{P}_{k} \boldsymbol{a}_{jk} \right),$$

$$m_{(k)j}^{ii'} = \boldsymbol{d}_{jk}^{\top} \Sigma^{(k)ii'} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)i}^{\top} \Sigma^{(k)i'} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)i'}^{\top} \Sigma^{(k)i} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)ii'}^{\top} \Sigma_{k}^{-1} \boldsymbol{d}_{jk} + 2 \boldsymbol{\mu}_{(k)i}^{\top} \Sigma_{k}^{-1} \boldsymbol{\mu}_{(k)i'},$$

$$q_{i}^{(jk)} = \left(\boldsymbol{d}_{jk}^{\top} \Sigma^{(k)i} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)i}^{\top} \Sigma_{k}^{-1} \boldsymbol{d}_{jk} \right) \left(\boldsymbol{d}_{jk}^{\top} \Sigma^{(k)i'} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)i'}^{\top} \Sigma_{k}^{-1} \boldsymbol{d}_{jk} \right),$$

where $\boldsymbol{\mu}_{(k)ii'} = \partial \boldsymbol{\mu}_{(k)i'} \partial \theta_{(k)i'}$ and $\boldsymbol{\Sigma}^{(k)ii'} = \partial \boldsymbol{\Sigma}^{(k)i} / \partial \theta_{(k)i'} = -2\boldsymbol{\Sigma}^{(k)i} \boldsymbol{\Sigma}_{(k)i'} \boldsymbol{\Sigma}_k^{-1} - \boldsymbol{\Sigma}_k^{-1} \boldsymbol{\Sigma}_{(k)ii'} \boldsymbol{\Sigma}_k^{-1}$; see Appendix C.

By replacing \widehat{J} , $\widetilde{J}_{\omega\omega}$, $\widetilde{\widetilde{J}}_{\omega\omega}$, $\widetilde{\widetilde{J}}$, \widetilde{U} , $\widetilde{U'}$, $\widehat{\ell'} - \widetilde{\ell'}$ and the likelihood ratio statistic LR in (7) we obtain ρ , the quantity that is required for computing the adjusted statistic LR^* in (5) and its equivalent version LR^{**} given in (6). Note that ρ depends on \mathbf{Z}_{jk} , $\boldsymbol{\mu}_k$, Σ_k , Σ_k^{-1} , P_k and their first and second derivatives with respect to the parameters. It is worth mentioning that the distribution of \mathbf{Z}_{jk} is only required for obtaining the matrices $R_{(k)}$ and $V_{(k)}$.

As a final remark, we mention the connection between our results and those obtained by Melo & Ferrari (2010). In their paper, the model under study is the special case of model (2) when l = p = 1. The authors obtained the Barndorff-Nielsen (1986) adjustment to the signed likelihood ratio statistic for testing hypotheses on a scalar parameter. The adjustment term, given in eq. (6) of their paper, can be calculated using the quantities obtained in the present paper for the case in which ψ is scalar (q = 1). Therefore, our results enables us to calculate Barndorff-Nielsen's (1986) adjusted signed likelihood ratio statistic in model (2). Hence, our results generalize those in Melo & Ferrari (2010).

4 Simulation study

In this section we present a Monte Carlo simulation study to evaluate the efficacy of the adjustments derived in the previous section. The performances of the tests that use the likelihood ratio statistic (LR), and the adjusted statistics $(LR^* \text{ and } LR^{**})$ will be compared with respect to the type I error probability.

The simulations use model (3) with l = 1 and p = 5. Two different distributions for Z_{jk} are considered, namely a bivariate normal distribution and a bivariate Student-*t* with 3 degrees of freedom ($\nu = 3$). The number of Monte Carlo replications was 10,000, the nominal levels of the tests are $\gamma = 1\%, 5\%$ and 10% and the sample sizes are $n_1 = \ldots = n_p = 10, 20, 30$ and 40. All simulations were performed using the Ox matrix programming language; Doornik (2006).

We consider tests of \mathcal{H}_0 : $\boldsymbol{\psi} = \boldsymbol{\psi}^{(0)}$ versus \mathcal{H}_1 : $\boldsymbol{\psi} \neq \boldsymbol{\psi}^{(0)}$, where $\boldsymbol{\psi} = (\beta_1, \beta_2, \dots, \beta_q)^{\top}$, for q = 2, 3, 4, 5. Also, we consider $\boldsymbol{\psi}^{(0)} = \mathbf{0}$ when λ_{x_k} or λ_{e_k} is known, and $\boldsymbol{\psi}^{(0)} = \mathbf{1}$ when the

intercept is null. The true parameter values are $\alpha_1 = \cdots = \alpha_5 = 0.5$, $\sigma_{x_1}^2 = \cdots = \sigma_{x_5}^2 = 1.5$, $\sigma_{u_1}^2 = \cdots = \sigma_{u_5}^2 = 0.5$, $\sigma_{e_1}^2 = \cdots = \sigma_{e_5}^2 = 2.0$. For λ_{x_k} or λ_{e_k} known, we set $\mu_{x_1} = \cdots = \mu_{x_5} = 0.5$, and when the intercept is null we set $\mu_{x_1} = \cdots = \mu_{x_5} = 5.0$.

Tables 1 and 2 present rejection rates (in percentage) of the three tests for all the scenarios described above. We notice that the likelihood ratio test (LR) is liberal when the sample size is small in all the cases considered here. For instance, when Z_{jk} is normally distributed, q = 3, λ_{e_k} is known and $n_k = 10$, the rejection rates of the test that uses LR are 11.4% ($\gamma = 5\%$) and 19.4% ($\gamma = 10\%$); see Table 1. Under the same scenario, except that Z_{jk} now follows a Student-t distribution, the rejection rates are 10.9% ($\gamma = 5\%$) and 18.6% ($\gamma = 10\%$). The adjusted tests (LR^{*} and LR^{**}), on the other hand, display much better behavior in all cases: they are much less size distorted than the likelihood ratio test. For example, in the normal case with λ_{x_k} known, $n_k = 10$ and $\gamma = 10\%$, the rejection rates are 16.9% (LR), 10.2% (LR^{*}) and 9.8% (LR^{**}) for q = 2, and 18.6% (LR), 10.2% (LR^*) and 9.5% (LR^{**}) for q=3. As a second example, we mention the case in which the underlying distribution is normal, the intercept is null, q = 5, $n_k = 10$ and $\gamma = 5\%$. The rejection rates are 9.3% (LR), 5.2% (LR^{*}) and 5.0% (LR^{**}). Also, for the normal case with λ_{e_k} known, $n_k = 20$ and $\gamma = 1\%$ the rejection rates are 1.9% (*LR*), 1.1% (*LR*^{*}) and 1.0% (*LR*^{**}). It can be noticed that, as the number of parameters under test (q) grows, the likelihood ratio test deteriorates while the behavior of the adjusted tests remains unaltered. See, for example, the figures in Table 1 relative to the Student-t case with λ_{e_k} known, $n_k = 10$ and $\gamma = 10\%$; the rejection rates are 18.4% (q = 2), 18.6% (q = 3), 19.9% (q = 4) and 21.3% (q = 5) for LR, 11.4% (q = 2), 10.4% (q = 3), 10.8% (q = 4)and 11.0% (q = 5) for LR^* , and 10.9% (q = 2), 10.1% (q = 3), 10.2% (q = 4) and 10.1% (q = 5) for $LR^{**}.$

Our numerical results confirm that the adjusted tests are much better behaved than the original likelihood ratio test in small samples. For almost all the cases, the test that uses the LR^{**} displays slightly better performance than its asymptotically equivalent version, LR^{*} .

5 Concluding remarks

In this paper we dealt with the issue of performing hypothesis testing in an elliptical multivariate errors-in-variables model when the sample size is small. We derived modified likelihood ratio statistics that follow very closely a chi-squared distribution under the null hypothesis. Our approach is based on Skovgaard's (2001) proposal, which requires the identification of a suitable ancillary statistic. We obtained the required ancillary and all the needed quantities to explicitly write the correction term. Our simulation results clearly suggested that the adjustment we derived is able to correct the liberal behavior of the likelihood ratio test in small samples.

Appendix A. The observed information matrix

The first derivative of the log-likelihood function for the k-th group, k = 1, 2, ..., p, with respect to the parameters is

for i = 1, 2, ..., s, where $W_{p_0}(u) = \partial \log p_0(u) / \partial u$, $\boldsymbol{\mu}_{(k)i} = \partial \boldsymbol{\mu}_k / \partial \theta_{(k)i}$, $\Sigma_{(k)i} = \partial \Sigma_k / \partial \theta_{(k)i}$ and $\Sigma^{(k)i} = \partial \Sigma_k^{-1} / \partial \theta_{(k)i} = -\Sigma_k^{-1} \Sigma_{(k)i} \Sigma_k^{-1}$. The (i, i')-th element of the observed information matrix for the k-th group, $J_{(k)}$, is given by $J_{(k)ii'} = -\partial^2 \ell_k(\boldsymbol{\theta}) / \partial \theta_{(k)i} \partial \theta_{(k)i'}$, i.e.

$$\begin{split} J_{(k)ii'} &= \frac{n_k}{2} \mathrm{tr} \left(\Sigma^{(k)i} \Sigma_{(k)i'} \right) + \frac{n_k}{2} \mathrm{tr} \left(\Sigma_k^{-1} \Sigma_{(k)ii'} \right) - \sum_{i=1}^{n_k} \left\{ W_{p_0}' \left(\boldsymbol{d}_{jk}^\top \Sigma_k^{-1} \boldsymbol{d}_{jk} \right) \left(\boldsymbol{d}_{jk}^\top \Sigma^{(k)i} \boldsymbol{d}_{jk} \right) \\ &- 2 \boldsymbol{\mu}_{(k)i}^\top \Sigma_k^{-1} \boldsymbol{d}_{jk} \right) \left(\boldsymbol{d}_{jk}^\top \Sigma^{(k)i'} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)i'}^\top \Sigma_k^{-1} \boldsymbol{d}_{jk} \right) + W_{p_0} \left(\boldsymbol{d}_{jk}^\top \Sigma_k^{-1} \boldsymbol{d}_{jk} \right) \left(\boldsymbol{d}_{jk}^\top \Sigma^{(k)ii'} \boldsymbol{d}_{jk} \\ &- 2 \boldsymbol{\mu}_{(k)i}^\top \Sigma^{(k)i'} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)i'}^\top \Sigma^{(k)i} \boldsymbol{d}_{jk} - 2 \boldsymbol{\mu}_{(k)ii'}^\top \Sigma_k^{-1} \boldsymbol{d}_{jk} + 2 \boldsymbol{\mu}_{(k)i}^\top \Sigma_k^{-1} \boldsymbol{\mu}_{(k)i'} \right) \right\}, \end{split}$$

for $i, i' = 1, 2, \ldots, s$ and $k = 1, 2, \ldots, p$, where $W'_{p_0}(u) = \partial W_{p_0}(u) / \partial u$, $\boldsymbol{\mu}_{(k)ii'} = \partial \boldsymbol{\mu}_{(k)i} / \partial \theta_{(k)i'}$, $\Sigma_{(k)ii'} = \partial \Sigma_{(k)i} / \partial \theta_{(k)i'}$ and $\Sigma^{(k)ii'} = \partial \Sigma^{(k)i} / \partial \theta_{(k)i'} = -2\Sigma^{(k)i'} \Sigma_{(k)i} \Sigma_k^{-1} - \Sigma_k^{-1} \Sigma_{(k)ii'} \Sigma_k^{-1}$.

Appendix B. Sample space derivatives $(\ell', U' \text{ and } \widetilde{\widetilde{J}})$

Let \boldsymbol{a} be the ancillary statistic defined in Section 3 and let us write $\boldsymbol{z}_{jk} = \widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k$. Inserting \boldsymbol{z}_{jk} in the log-likelihood function we have

Hence, $\ell' = \partial \ell(\boldsymbol{\theta}; \widehat{\boldsymbol{\theta}}, a) / \partial \widehat{\boldsymbol{\theta}} = \left(\ell_{(1)}^{\prime \top}, \ell_{(2)}^{\prime \top}, \dots, \ell_{(p)}^{\prime \top} \right)^{\top}$, where the *i*-th element of the vector $\ell_{(k)}^{\prime}$ is

$$\ell_{(k)i}' = 2 \sum_{i=1}^{n_k} W_{p_0} \left((\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k)^\top \Sigma_k^{-1} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) \right) (\widehat{P}_{(k)i} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i})^\top \Sigma_k^{-1} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k),$$

for i = 1, 2, ..., s and k = 1, 2, ..., p. Also, we have that $U' = \partial^2 \ell(\boldsymbol{\theta}; \hat{\boldsymbol{\theta}}, \boldsymbol{a}) / \partial \hat{\boldsymbol{\theta}} \partial \boldsymbol{\theta}^\top = \text{diag} \Big\{ U'_{(1)}, U'_{(2)}, ..., U'_{(p)} \Big\}$, where the (i, i')-th element of the matrix $U'_{(k)}$ is given by

$$\begin{split} U'_{(k)ii'} &= 2\sum_{i=1}^{n_k} \left\{ W_{p_0} \left(\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k \right)^\top \Sigma_k^{-1} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) \right) \left((\widehat{P}_{(k)i'} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i'})^\top \Sigma^{(k)i} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) \right) \\ &- \boldsymbol{\mu}_k) - \boldsymbol{\mu}_{(k)i}^\top \Sigma_k^{-1} (\widehat{P}_{(k)i'} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i'}) \right) + W'_{p_0} \left((\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k)^\top \Sigma_k^{-1} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) \right) \\ &(\widehat{P}_{(k)i'} \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_{(k)i'})^\top \Sigma_k^{-1} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) \left((\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k)^\top \Sigma^{(k)i} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) - 2\boldsymbol{\mu}_{(k)i'}^\top \Sigma_k^{-1} (\widehat{P}_k \boldsymbol{a}_{jk} + \widehat{\boldsymbol{\mu}}_k - \boldsymbol{\mu}_k) \right) \right\}, \end{split}$$

where $\hat{P}_{(k)i} = \partial \hat{P}_k / \hat{\theta}_{(k)i}$, for i = 1, 2, ..., s and k = 1, 2, ..., p. We also have that

$$\left. \widetilde{\widetilde{J}} = \frac{\partial^2 \ell(\boldsymbol{\theta}; \widehat{\boldsymbol{\theta}}, \boldsymbol{a})}{\partial \widehat{\boldsymbol{\theta}} \partial \boldsymbol{\theta}^{\top}} \right|_{\widehat{\boldsymbol{\theta}} = \widetilde{\boldsymbol{\theta}}, \ \boldsymbol{\theta} = \widetilde{\boldsymbol{\theta}}} = \operatorname{diag} \Big\{ \left. \widetilde{\widetilde{J}}_{(1)}, \left. \widetilde{\widetilde{J}}_{(2)}, \ldots, \left. \widetilde{\widetilde{J}}_{(p)} \right. \Big\},\right.$$

where the (i,i')-th element of $\widetilde{\widetilde{J}}_{(k)}$ is given by

$$\begin{split} \widetilde{\widetilde{J}}_{(k)ii'} &= 2\sum_{i=1}^{n_k} \left\{ W_{p_0} \left(\widehat{d}_{jk}^\top \widehat{\Sigma}_k^{-1} \widehat{d}_{jk} \right) \left((\widetilde{P}_{(k)i'} a_{jk} + \widetilde{\mu}_{(k)i'})^\top \widetilde{\Sigma}^{(k)i} \widetilde{P}_k a_{jk} - \widetilde{\mu}_{(k)i}^\top \widetilde{\Sigma}_k^{-1} (\widetilde{P}_{(k)i'} a_{jk} + \widetilde{\mu}_{(k)i'}) \right) \\ &+ W_{p_0}' \left(\widehat{d}_{jk}^\top \widehat{\Sigma}_k^{-1} \widehat{d}_{jk} \right) (\widetilde{P}_{(k)i'} a_{jk} + \widetilde{\mu}_{(k)i'})^\top \widetilde{\Sigma}_k^{-1} \widetilde{P}_k a_{jk} \left(a_{jk}^\top \widetilde{P}_k^\top \widetilde{\Sigma}^{(k)i} \widetilde{P}_k a_{jk} - 2 \widetilde{\mu}_{(k)i}^\top \widetilde{\Sigma}_k^{-1} \widetilde{P}_k a_{jk} \right) \right\}. \end{split}$$

In matrix notation we have

$$\ell'_{(k)} = 2R_{(k)}^{\top} \boldsymbol{w}_{(k)}, \quad U'_{(k)} = 2\left(R_{(k)}^{\top} B_{(k)} + V_{(k)}^{\top} C_{(k)}\right) \quad \text{and} \quad \widetilde{\widetilde{J}}_{(k)} = 2\left(\widehat{R}_{(k)}^{\top} F_{(k)} + \widehat{V}_{(k)}^{\top} G_{(k)}\right);$$

the elements of the matrices $B_{(k)}$, $C_{(k)}$, $F_{(k)}$, $G_{(k)}$ and of the vector $\boldsymbol{w}_{(k)}$ are defined in Section 3 for $k = 1, 2, \dots, p$.

Appendix C. Derivatives of the vector μ_k and of the matrix Σ_k with respect to the parameters

When the ratio $\lambda_{x_k} = \sigma_{x_k}^2 / \sigma_{u_k}^2$ is known the first derivative of μ_k has elements

$$\boldsymbol{\mu}_{(k)i} = \begin{cases} (0, \dots, 0, \quad \underline{\mu}_{x_k} \quad , 0, \dots, 0)^\top, & \text{if } i = 1, 2, \dots, l \\ & \text{position } i \\ (\mathbf{1}^\top, 0)^\top, & \text{if } i = l+1 \\ (\boldsymbol{\beta}_k^\top, 1)^\top, & \text{if } i = l+2 \\ \mathbf{0}, & \text{if } i = l+3, l+4, \dots, s. \end{cases}$$
(8)

The first derivative of Σ_k with respect to the parameter vector $\boldsymbol{\theta}_{(k)}$ is now given for $i = 1, 2, \ldots, s$:

- if i = l + 1 or i = l + 2, then $\Sigma_{(k)i}$ is null;
- if i = l + 3, we have $\Sigma_{(k)i} = \begin{pmatrix} \beta_k \beta_k^\top \lambda_{x_k} & \beta_k \lambda_{x_k} \\ \lambda_{x_k} \beta_k^\top & \lambda_{x_k} + 1 \end{pmatrix}$;

- is i = l + 4, l + 5, ..., s, the elements of $\Sigma_{(k)i}$ are null except for the (i l 3, i l 3)-th element, which is given by 1.
- if $i = 1, \ldots, l$, we have

$$\Sigma_{(k)i} = \left\{ \begin{array}{ccccccc} \left(\begin{array}{cccccc} 2\beta_{1k}\lambda_{x_k}\sigma_{u_k}^2 & \beta_{2k}\lambda_{x_k}\sigma_{u_k}^2 & \cdots & \beta_{lk}\lambda_{x_k}\sigma_{u_k}^2 & \lambda_{x_k}\sigma_{u_k}^2 \\ \beta_{2k}\lambda_{x_k}\sigma_{u_k}^2 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{lk}\lambda_{x_k}\sigma_{u_k}^2 & 0 & \cdots & 0 & 0 \\ \lambda_{x_k}\sigma_{u_k}^2 & 0 & \cdots & 0 & 0 \end{array} \right), & \text{if } i = 1 \\ \left\{ \begin{array}{ccccc} 0 & 0 & \cdots & \beta_{1k}\lambda_{x_k}\sigma_{u_k}^2 & 0 \\ 0 & 0 & \cdots & \beta_{2k}\lambda_{x_k}\sigma_{u_k}^2 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{1k}\lambda_{x_k}\sigma_{u_k}^2 & \beta_{2k}\lambda_{x_k}\sigma_{u_k}^2 & \cdots & 2\beta_{lk}\lambda_{x_k}\sigma_{u_k}^2 & \lambda_{x_k}\sigma_{u_k}^2 \\ 0 & 0 & \cdots & \lambda_{x_k}\sigma_{u_k}^2 & 0 \end{array} \right), & \text{if } i = l. \end{array} \right\}$$

The second order derivative of μ_k is

$$\boldsymbol{\mu}_{(k)ii'} = \begin{cases} (0, \dots, 0, \underbrace{1}_{\text{position } i}, 0, \dots, 0)^{\top}, & \text{if } i = 1, 2, \dots, l \text{ and } i' = l+2 \\ \text{position } i \\ (0, \dots, 0, \underbrace{1}_{\text{position } i'}, 0, \dots, 0)^{\top}, & \text{if } i = l+2 \text{ and } i' = 1, 2, \dots, l \\ \text{position } i' \\ \mathbf{0}, & \text{otherwise.} \end{cases}$$
(9)

For i, i' = 1, 2, ..., s, the elements of the matrix $\Sigma_{(k)ii'}$ are null except for the following cases:

- if i = 1, 2, ..., l and i' = 1, 2, ..., l, we have that, i = i', the elements of $\Sigma_{(k)ii}$ are null except the (i, i)-th element, which is equal to $2\lambda_{x_k}\sigma_{u_k}^2$. When $i \neq i'$, the elements of the matrix $\Sigma_{(k)ii'}$ are null, except those in positions (i,i') and (i',i), which are equal to $\lambda_{x_k}\sigma_{u_k}^2$; • if $i = 1, \ldots, l$ and i' = l + 3 we have

$$\Sigma_{(k)ii'} = \Sigma_{(k)i'i} = \begin{cases} 2\beta_{1k}\lambda_{x_k} & \beta_{2k}\lambda_{x_k} & \dots & \beta_{lk}\lambda_{x_k} & \lambda_{x_k} \\ \beta_{2k}\lambda_{x_k} & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{lk}\lambda_{x_k} & 0 & \cdots & 0 & 0 \\ \lambda_{x_k} & 0 & \cdots & 0 & 0 \end{cases} \end{pmatrix}, \quad \text{if } i = 1 \\ \begin{cases} 0 & 0 & \dots & \beta_{1k}\lambda_{x_k} & 0 \\ 0 & 0 & \cdots & \beta_{2k}\lambda_{x_k} & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{1k}\lambda_{x_k} & \beta_{2k}\lambda_{x_k} & \cdots & 2\beta_{lk}\lambda_{x_k} & \lambda_{x_k} \\ 0 & 0 & \cdots & \lambda_{x_k} & 0 \end{pmatrix}, \quad \text{if } i = l. \end{cases}$$

When the ratio λ_{e_k} is known the first and second order derivatives of μ_k are given, respectively, in (8) and (9), with s = l + 4. The derivative of Σ_k with respect to the parameter vector $\boldsymbol{\theta}_{(k)}$ is

• if $i = 1, \ldots, l$ we have

$$\Sigma_{(k)i} = \left\{ \begin{array}{cccccc} 2\beta_{1k}\sigma_{x_k}^2 & \beta_{2k}\sigma_{x_k}^2 & \dots & \beta_{lk}\sigma_{x_k}^2 & \sigma_{x_k}^2 \\ \beta_{2k}\sigma_{x_k}^2 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{lk}\sigma_{x_k}^2 & 0 & \cdots & 0 & 0 \\ \sigma_{x_k}^2 & 0 & \cdots & 0 & 0 \end{array} \right), \quad \text{if } i = 1$$

$$\left\{ \begin{array}{ccccc} & & & & \\ & & & & \\ 0 & 0 & \dots & \beta_{1k}\sigma_{x_k}^2 & 0 \\ \vdots & & & & \vdots & & \\ & & & & \beta_{1k}\sigma_{x_k}^2 & 0 \\ \vdots & & & & \vdots & & \\ \beta_{1k}\sigma_{x_k}^2 & \beta_{2k}\sigma_{x_k}^2 & \cdots & 2\beta_{lk}\sigma_{x_k}^2 & \sigma_{x_k}^2 \\ 0 & 0 & \cdots & \sigma_{x_k}^2 & 0 \end{array} \right), \quad \text{if } i = l;$$

• if i = l + 1 or i = l + 2, the matrix $\Sigma_{(k)i}$ is null;

• if
$$i = l + 3$$
, $\Sigma_{(k)i} = \begin{pmatrix} \beta_k \beta_k^{\dagger} & \beta_k \\ \beta_k^{\dagger} & 1 \end{pmatrix}$;
• if $i = l + 4 = s$, $\Sigma_{(k)i} = \begin{pmatrix} \lambda_{e_k} & \mathbf{0} \\ \mathbf{0} & 1 \end{pmatrix}$.

For i, i' = 1, 2, ..., s, we have that the elements of $\Sigma_{(k)ii'}$ are null except for the cases: • if i = 1, ..., l and i' = l + 3, we have

$$\Sigma_{(k)ii'} = \Sigma_{(k)i'i} = \begin{cases} \begin{pmatrix} 2\beta_{1k} & \beta_{2k} & \dots & \beta_{lk} & 1\\ \beta_{2k} & 0 & \cdots & 0 & 0\\ \vdots & \vdots & \vdots & \vdots & \vdots\\ \beta_{lk} & 0 & \cdots & 0 & 0\\ 1 & 0 & \cdots & 0 & 0 \end{pmatrix}, & \text{if } i = 1\\ \begin{pmatrix} 0 & 0 & \dots & \beta_{1k} & 0\\ 0 & 0 & \cdots & \beta_{2k} & 0\\ \vdots & \vdots & \vdots & \vdots & \vdots\\ \beta_{1k} & \beta_{2k} & \cdots & 2\beta_{lk} & 1\\ 0 & 0 & \cdots & 1 & 0 \end{pmatrix}, & \text{if } i = l; \end{cases}$$

• if i = 1, 2, ..., l and i' = 1, 2, ..., l, we have that, for i = i', the elements of the matrix $\Sigma_{(k)ii}$ are null except the (i, i)-th elements, which is equal to $2\sigma_{x_k}^2$. When $i \neq i'$, the elements of the matrix $\Sigma_{(k)ii'}$ are null except the (i, i')-th and the (i', i)-th elements, which are equal to $\sigma_{x_k}^2$.

When the intercept α_k in known the first order derivative of $\boldsymbol{\mu}_k$ is

$$\boldsymbol{\mu}_{(k)i} = \begin{cases} (0, \dots, 0, \underbrace{\mu_{x_k}}_{\text{position } i}, 0, \dots, 0)^\top, & \text{if } i = 1, 2, \dots, l \\ & \text{position } i \\ (\boldsymbol{\beta}_k^\top, 1)^\top, & \text{if } i = l+1 \\ & \mathbf{0}, & \text{if } i = l+2, l+3, \dots, s. \end{cases}$$

The derivative of Σ_k with respect to $\boldsymbol{\theta}_{(k)}$ is now presented for $i = 1, 2, \ldots, s$. We have

- if i = l + 1, the matrix $\Sigma_{(k)i}$ is null;
- if i = l + 2 we have

$$\Sigma_{(k)i} = \begin{pmatrix} \boldsymbol{\beta}_k \boldsymbol{\beta}_k^\top & \boldsymbol{\beta}_k \\ \boldsymbol{\beta}_k^\top & 1 \end{pmatrix};$$

- if i = l + 3 we have $\Sigma_{(k)i} = \begin{pmatrix} \mathbf{0} & \mathbf{0} \\ \mathbf{0} & 1 \end{pmatrix}$;
- if i = l + 4, l + 5, ..., s, the elements of the matrix $\Sigma_{(k)i}$ is null except for the (i l 3, i l 3)-th element, which equals 1;
- if $i = 1, \ldots, l$, we have

$$\Sigma_{(k)i} = \left\{ \begin{array}{cccccc} \left(\begin{array}{ccccc} 2\beta_{1k}\sigma_{x_k}^2 & \beta_{2k}\sigma_{x_k}^2 & \cdots & \beta_{lk}\sigma_{x_k}^2 & \sigma_{x_k}^2 \\ \beta_{2k}\sigma_{x_k}^2 & 0 & \cdots & 0 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{lk}\sigma_{x_k}^2 & 0 & \cdots & 0 & 0 \\ \sigma_{x_k}^2 & 0 & \cdots & 0 & 0 \end{array} \right), & \text{if } i = 1 \\ \left(\begin{array}{ccccc} 0 & 0 & \cdots & \beta_{1k}\sigma_{x_k}^2 & 0 \\ 0 & 0 & \cdots & \beta_{2k}\sigma_{x_k}^2 & 0 \\ \vdots & \vdots & \vdots & \vdots & \vdots \\ \beta_{1k}\sigma_{x_k}^2 & \beta_{2k}\sigma_{x_k}^2 & \cdots & 2\beta_{lk}\sigma_{x_k}^2 & \sigma_{x_k}^2 \\ 0 & 0 & \cdots & \sigma_{x_k}^2 & 0 \end{array} \right), & \text{if } i = l.$$

The second order derivative of μ_k is

$$\boldsymbol{\mu}_{(k)ii'} = \begin{cases} (0, \dots, 0, \underbrace{1}_{\text{position } i}, 0, \dots, 0)^{\top}, & \text{if } i = 1, 2, \dots, l \text{ and } i' = l+1 \\ \text{position } i \\ (0, \dots, 0, \underbrace{1}_{\text{position } i'}, 0, \dots, 0)^{\top}, & \text{if } i = l+1 \text{ and } i' = 1, 2, \dots, l \\ 0, & \text{otherwise.} \end{cases}$$

For i, i' = 1, 2, ..., s, we have that the elements of $\Sigma_{(k)ii'}$ are null except for the cases:

- if i = 1, 2, ..., l and i' = 1, 2, ..., l, we have that, for i = i', the elements of Σ_{(k)ii} are null except for the (i, i)-th element, which is equal to 2 σ²_{xk}. When i ≠ i', the elements of Σ_{(k)ii'} are null except for those in positions (i, i') and (i', i), which are equal to σ²_{xk};
 if i = 1, ..., l and i' = l + 2, we have

$$\Sigma_{(k)ii'} = \Sigma_{(k)i'i} = \begin{cases} \begin{pmatrix} 2\beta_{1k} & \beta_{2k} & \dots & \beta_{lk} & 1\\ \beta_{2k} & 0 & \cdots & 0 & 0\\ \vdots & \vdots & \vdots & \vdots & \vdots\\ \beta_{lk} & 0 & \cdots & 0 & 0\\ 1 & 0 & \cdots & 0 & 0 \end{pmatrix}, & \text{if } i = 1\\ \begin{pmatrix} 0 & 0 & \dots & \beta_{1k} & 0\\ 0 & 0 & \cdots & \beta_{2k} & 0\\ \vdots & \vdots & \vdots & \vdots & \vdots\\ \beta_{1k} & \beta_{2k} & \cdots & 2\beta_{lk} & 1\\ 0 & 0 & \cdots & 1 & 0 \end{pmatrix}, & \text{if } i = l. \end{cases}$$
