On cohomology of almost complex 4-manifolds *

Abstract Based on recent work of T. Draghici, T.-J. Li and W. Zhang, we further investigate properties of the dimension h_J^- of the *J*-anti-invariant cohomology subgroup H_J^- of a closed almost Hermitian 4-manifold (M, g, J, F) using metric compatible almost complex structures. We prove that $h_J^- = 0$ for generic almost complex structures J on M.

1 Introduction

For an almost complex manifold (M, J), T.-J. Li and W. Zhang [16] introduced subgroups H_J^+ and H_J^- of the real degree 2 de Rham cohomology group $H^2(M, \mathbb{R})$, as the sets of cohomology classes which can be represented by *J*-invariant and *J*anti-invariant real 2-forms, respectively. Let us denote by h_J^+ and h_J^- the dimensions of H_J^+ and H_J^- , respectively.

It is interesting to consider whether or not the subgroups H_J^+ and H_J^- induce a direct sum decomposition of $H^2(M, \mathbb{R})$. In the case of direct sum decomposition, J is said to be C^{∞} pure and full (see Definition 2.2).

This is known to be true for integrable almost complex structures J which admit compatible Kähler metrics on compact manifolds of any dimension. In this case, the induced decomposition is nothing but the classical real Hodge-Dolbeault decomposition of $H^2(M, \mathbb{R})$ (see [4]).

Note that there are topological obstructions to the existence of almost complex structures on an even dimensional manifold. For a closed 4-manifold, a necessary condition is that $1 - b_1 + b^+$ be even [4], where b_1 is the first Betti number and b^+ is the number of positive eigenvalues of the quadratic form on $H^2(M, \mathbb{R})$ defined by the cup product, hence the condition is either b_1 be even and b^+ odd, or b_1 be odd and b^+ even.

It is a well-known fact that any closed complex surface with b^+ odd is Kähler. This was originally obtained from the classification theory, but direct proofs have been given in [5, 12].

In dimension 4, T. Draghici, T.-J. Li and W. Zhang [8] proved that on any closed almost complex 4-manifold (M, J), J is C^{∞} pure and full. Further in [9],

they computed the subgroups H_J^+ and H_J^- and their dimensions h_J^+ and h_J^- for almost complex structures metric related to an integrable one. Using Gauduchon metrics ([10]), they proved that the almost complex structures \tilde{J} with $h_{\tilde{J}}^- = 0$ form an open dense set in the C^{∞} -Fréchet-topology in the space of almost complex structures metric related to an integrable one ([9, Theorem 1.1]). Based on this, they made a conjecture (Conjecture 2.4 in [9]) about the dimension h_J^- of H_J^- on a compact 4-manifold which asserts that h_J^- vanishes for generic almost complex structures J. In particular, they have confirmed their conjecture for 4-manifolds with $b^+ = 1$ ([9, Theorem 3.1]).

In this paper we confirm the conjecture completely (see Theorem 1.1 below) by using g-compatible almost complex structures.

Let \mathcal{J} be the space of all almost complex structures on M and denote by \mathcal{J}_g^c and \mathcal{J}_F^t respectively the spaces of g-compatible and F-tame almost complex structures on M; namely,

$$\begin{split} \mathcal{J}_g^{\mathrm{c}} &= \{J \in \mathcal{J} \mid g(JX, JY) = g(X, Y), \forall X, Y \in TM\}, \\ \mathcal{J}_F^{\mathrm{t}} &= \{J \in \mathcal{J} \mid F(X, JX) > 0, \forall X \in TM, X \neq 0\}. \end{split}$$

It is well known that \mathcal{J}_g^c and \mathcal{J}_F^t are contractible C^{∞} -Fréchet spaces. See [2, 8, 9] for details.

Theorem 1.1. Let M be a closed 4-manifold admitting almost complex structures. Then the set of almost complex structures J on M with $h_J^- = 0$ is an open dense subset of \mathcal{J} in the C^{∞} -topology.

The rest of the paper is organized as follows. In §2 we recall definitions, preliminary results mainly as given in [9], and constructions of g- and F-compatible almost complex structures. Finally in §3 we give the proof of Theorem 1.1.

2 Definitions and Preliminaries

Suppose (M, J) is a closed almost complex 4-manifold. One can construct a *J*-invariant Riemannian metric g on M. Such a metric g is called an almost Hermitian metric for (M, J). This then in turn gives a *J*-compatible non-degenerate 2-form F by F(X, Y) = g(JX, Y), called the fundamental 2-form. Such a quadruple (M, g, J, F) is called a closed almost Hermitian 4-manifold. Thus an almost Hermitian structure on M is a triple (g, J, F). By direct calculation, $F \wedge F = 2d\mu_g$, where $d\mu_g$ is the volume form of M determined by g.

Note that J acts on the space Ω^2 of 2-forms on M as an involution by

$$\alpha \longmapsto \alpha(J \cdot, J \cdot), \quad \alpha \in \Omega^2(M).$$
 (2.1)

This gives the *J*-invariant, *J*-anti-invariant decomposition of 2-forms:

$$\Omega^2 = \Omega_J^+ \oplus \Omega_J^-, \quad \alpha = \alpha_J^+ + \alpha_J^- \tag{2.2}$$

as well as the splitting of corresponding vector bundles

$$\Lambda^2 = \Lambda_J^+ \oplus \Lambda_J^-. \tag{2.3}$$

Remark 2.1. Note that Λ_J^- is a vector bundle of rank two and Λ_J^- inherits an almost complex structure, still denoted by J, defined by

$$(J\alpha)(\cdot, \cdot) = -\alpha(J\cdot, \cdot), \qquad \alpha \in \Lambda_J^-.$$

It is well known that, when J is integrable, $\beta \in \mathbb{Z}_J^-$ if and only if $J\beta \in \mathbb{Z}_J^-$. Conversely, if (M, J) is a connected almost complex 4-manifold and there exists nonzero $\beta \in \mathbb{Z}_J^-$ such that $J\beta \in \mathbb{Z}_J^-$, then J is integrable (see [17]).

Definition 2.2. (cf. [8, 16]) Let \mathcal{Z}^2 denote the space of closed 2-forms on M and set

$$\mathcal{Z}_J^+ := \mathcal{Z}^2 \cap \Omega_J^+, \quad \mathcal{Z}_J^- := \mathcal{Z}^2 \cap \Omega_J^-$$

Define the J-invariant and J-anti-invariant cohomology subgroups H_J^{\pm} by

$$H_J^{\pm} = \{ \mathfrak{a} \in H^2(M; \mathbb{R}) \mid \text{there exists } \alpha \in \mathcal{Z}_J^{\pm} \text{ such that } \mathfrak{a} = [\alpha] \}.$$

We say J is C^{∞} pure if $H_J^+ \cap H_J^- = \{0\}$, C^{∞} full if $H_J^+ + H_J^- = H^2(M; \mathbb{R})$, and J is C^{∞} pure and full if

$$H^2(M;\mathbb{R}) = H^+_I \oplus H^-_I.$$

Proposition 2.3. (cf. [8, Theorem 2.3]) For any closed almost complex 4-manifold (M, J), J is C^{∞} pure and full.

Since (M, g, J, F) is a closed almost Hermitian 4-manifold, the Hodge star operator $*_g$ gives the well-known self-dual, anti-self-dual decomposition of 2-forms as well as the corresponding splitting of the bundle (see [7]):

$$\Omega^2 = \Omega_g^+ \oplus \Omega_g^-, \quad \alpha = \alpha_g^+ + \alpha_g^-; \tag{2.4}$$

$$\Lambda^2 = \Lambda_q^+ \oplus \Lambda_q^-. \tag{2.5}$$

Since the Hodge-de Rham-Laplace operator commutes with $*_g$, the decomposition (2.5) holds for the space \mathcal{H}_g of harmonic 2-forms as well. By Hodge theory, this induces cohomology decomposition by the metric g:

$$H^2(M;\mathbb{R}) = \mathcal{H}_g = \mathcal{H}_g^+ \oplus \mathcal{H}_g^-.$$
(2.6)

Similar to Definition 2.2, one defines

$$H_g^{\pm} = \{ \mathfrak{a} \in H^2(M; \mathbb{R}) \mid \mathfrak{a} = [\alpha] \text{ for some } \alpha \in \mathcal{Z}_g^{\pm} := \mathcal{Z}^2 \cap \Omega_g^{\pm} \}.$$
(2.7)

It is easy to see that

$$H_g^{\pm} = \mathcal{Z}_g^{\pm} = \mathcal{H}_g^{\pm}$$

and (2.6) can be written as

$$H^2(M;\mathbb{R}) = H^+_a \oplus H^-_a. \tag{2.8}$$

There are the following relations between the decompositions (2.3) and (2.5) on an almost Hermitian 4-manifold:

$$\Lambda_J^+ = \mathbb{R}F \oplus \Lambda_q^-, \tag{2.9}$$

$$\Lambda_q^+ = \mathbb{R}F \oplus \Lambda_J^-, \tag{2.10}$$

$$\Lambda_J^+ \cap \Lambda_g^+ = \mathbb{R}F, \quad \Lambda_J^- \cap \Lambda_g^- = \{0\}.$$
(2.11)

See [6] for details. It is easy to see that $H_J^- \subset \mathcal{H}_q^+$ and $\mathcal{H}_q^- \subset H_J^+$.

Let b_2 , b^+ and b^- be the second, the self-dual and the anti-self-dual Betti number of M, respectively. Thus $b_2 = b^+ + b^-$. It is easy to see that, for a closed almost Hermitian 4-manifold (M, g, J, F), there hold (see [8]):

$$H_J^- = \mathcal{Z}_J^-, \quad h_J^+ + h_J^- = b_2, \quad h_J^+ \ge b^-, \quad h_J^- \le b^+.$$
 (2.12)

Lejmi recognizes \mathcal{Z}_{I}^{-} as the kernel of an elliptic operator on Ω_{I}^{-} .

Lemma 2.4. (cf. [14, 15]) Let (M, g, J, F) be a closed almost Hermitian 4-manifold. Let operator $P: \Omega_J^- \to \Omega_J^-$ be defined by

$$P(\psi) = P_J^-(d\delta_g \psi),$$

where $P_J^-: \Omega^2 \to \Omega_J^-$ is the projection, δ_g is the codifferential operator with respect to metric g. Then P is a self-adjoint strongly elliptic linear operator with kernel the g-harmonic J-anti-invariant 2-forms.

Hence one has the decomposition of Ω_I^- :

$$\Omega_I^- = \ker P \oplus P_I^-(d\Omega^1) = H_I^- \oplus P_I^-(d\Omega^1)$$

Let $H_J^{-,\perp}$ denote the subgroup of \mathcal{H}_g^+ which is orthogonal to H_J^- with respect to the cup product; that is,

$$H_J^{-,\perp} := \{ \omega \in \mathcal{Z}_g^+ \mid \int_M \omega \wedge \alpha = 0 \quad \forall \alpha \in \mathcal{Z}_J^- \}.$$
(2.13)

By Lemma 2.4 and the results in [8, Lemmas 2.4 and 2.6], we have the following lemma which will be used in §3.

Lemma 2.5. Let (M,g) be a closed Riemannian 4-manifold. If $\alpha \in \Omega_g^+$ and $\alpha = \alpha_{\rm h} + d\theta + \delta_g \psi$ is its Hodge decomposition, then $P_g^+(d\theta) = P_g^+(\delta_g \psi)$ and $P_g^-(d\theta) = -P_g^-(\delta_g \psi)$, where $P_g^{\pm}: \Omega^2 \to \Omega_g^{\pm}$ are the projections. Moreover, the 2-form $\alpha - 2P_g^+(d\theta) = \alpha_{\rm h}$ is harmonic and $\alpha + 2P_g^-(d\theta) = \alpha_{\rm h} + 2d\theta$. In particular, if (M, g, J, F) is a closed almost Hermitian 4-manifold and if $\alpha \in H_J^{-,\perp}$ is a self-dual harmonic 2-form, then $\alpha = fF + P_J^-(d\theta)$ for some function $f \neq 0$ and $\alpha - d\theta \in Z_J^+$.

Remark 2.6. As direct consequences of Lemmas 2.4 and 2.5, we have decompositions as self-dual harmonic 2-forms and as cohomology classes:

$$\mathcal{H}_q^+ = H_J^- \oplus H_J^{-,\perp}, \qquad H_J^+ = H_J^{-,\perp} \oplus \mathcal{H}_q^-.$$

The almost complex structure J acts on the cotangent bundle T^*M by $(J\alpha)(\cdot) = -\alpha(J\cdot)$, where α is a 1-form. Hence J induces an action $J \otimes J$ on $\otimes^2 T^*M$, still denoted by J. The bundle of 2-forms decomposes under the action of J as

$$\Lambda^2 = \Lambda_J^+ \oplus \Lambda_J^-, \tag{2.14}$$

and the symmetric tensor bundle of type (2,0) decomposes as

$$S^2 = S_J^+ \oplus S_J^-.$$
 (2.15)

Let us construct g-compatible almost complex structures using sections of the bundle of J-anti-invariant 2-forms. Given $\alpha \in \Omega_J^-$, define tensor field K_{α} of type (1,1) by

$$g(X, K_{\alpha}Y) = \alpha(X, Y). \tag{2.16}$$

It can be checked that K_{α} and JK_{α} are skew-adjoint. It follows that Id + JK_{α} is invertible ([13]). Define tensor field J_{α} of type (1, 1) and 2-form F_{α} by

$$J_{\alpha} := (\mathrm{Id} + JK_{\alpha})^{-1} J(\mathrm{Id} + JK_{\alpha}), \quad F_{\alpha} := g(J_{\alpha} \cdot, \cdot).$$
(2.17)

It is easy to see that $J_{\alpha}^2 = -\text{Id}$; hence J_{α} is an almost complex structure.

The J_{α} and F_{α} so defined have the following properties.

Proposition 2.7. ([13, Proposition 1.5]) Given $\alpha \in \Omega_J^-$, we define the norm function $|\alpha| \in C^{\infty}(M)$ of α by $\alpha \wedge \alpha = 2|\alpha|^2 d\mu_a$, i.e.,

$$|\alpha|^2 = (\alpha \wedge \alpha)/(2d\mu_g).$$

Then the J_{α} and F_{α} defined by (2.17) satisfy:

$$\begin{split} g(J_{\alpha}X, J_{\alpha}Y) &= g(X, Y), \\ J_{\alpha} &= \frac{1 - |\alpha|^2}{1 + |\alpha|^2} J - \frac{2}{1 + |\alpha|^2} K_{\alpha}, \\ F_{\alpha} &= \frac{1 - |\alpha|^2}{1 + |\alpha|^2} F + \frac{2}{1 + |\alpha|^2} \alpha. \end{split}$$

Thus the triple $(g, J_{\alpha}, F_{\alpha})$ is an almost Hermitian structure on M.

Remark 2.8. The J_{α} 's are sometimes called *g*-related almost complex structures (cf. [8, 9]). Note that the fibre bundle \mathcal{Z} of all *g*-compatible almost complex structures is called the twistor space of (M, g, J) (see [1]):

$$\mathcal{Z} = \{J \in \mathrm{SO}(TM) \mid J^2 = -\mathrm{id}\} = \mathrm{SO}(TM)/\mathrm{U}(2);$$

so the twistor fibration $\pi : \mathbb{Z} \to M$ is an S^2 bundle. By using g-related almost complex structures one can study the twistor space of Riemannian 4-manifolds, complex structures on Riemannian 4-manifolds, Gromov-Witten invariants for Kähler surfaces and the dimension of J-anti-invariant cohomology of closed almost complex 4-manifolds (cf. [8, 9, 13]).

3 Proof of Theorem 1.1

In this section we prove Theorem 1.1. Let us first describe the C^{∞} -topology on the space \mathcal{J}^{∞} of C^{∞} almost complex structures on M. For $k = 0, 1, 2, \cdots$, the space \mathcal{J}^k of C^k almost complex structures on M has a natural separable Banach manifold structure. The natural C^{∞} -topology on \mathcal{J}^{∞} is induced by the sequence of C^k semi-norms $\|\cdot\|_k$, $k = 0, 1, 2, \cdots$. With this C^{∞} -topology, \mathcal{J}^{∞} is a Fréchet manifold. A complete metric which induces the C^{∞} -topology on \mathcal{J}^{∞} is defined by

$$d(J_1, J_2) = \sum_{k=0}^{\infty} \frac{\|J_1 - J_2\|_k}{2^k (1 + \|J_1 - J_2\|_k)}$$

For details, see [2, 9].

Proof of Theorem 1.1. Let (M, g, J, F) be a closed almost Hermitian 4-manifold. Note that $H_J^- \subset \mathcal{H}_g^+$ and hence $h_J^- \leq b^+$. We assume $b^+ \geq 2$ since the case where $b^+ = 1$ has been proved by Draghici, Li and Zhang (cf. [9, Theorem 3.1]).

To prove the denseness statement, we may consider a family J_t , $t \in (0, 1)$ of almost complex structures on M which is a deformation of J, that is, $J_t \to J$ in the C^{∞} -topology as $t \to 0$.

If $h_J^- = 0$, then as noted in [9], we can establish path-wise semi-continuity property for h_J^{\pm} which follows directly from Lemma 2.4 and a classical result of Kodaira and Morrow ([11, Theorem 4.3]) showing the upper semi-continuity of the kernel of a family of elliptic differential operators. Therefore $h_{J_t}^- = 0$ for small t.

We now assume that $h_J^- \geq 1$. Let us write $m := h_J^-$ and $l := b^+ - m$. We shall construct a family of g-compatible almost complex structures $\{J_c\} \subset \mathcal{J}_g^c$ where care cut-off functions to be chosen such that $h_{J_c}^- = 0$ and $J_c \to J$ in the C^{∞} -topology as $c \to 0$.

First, suppose that $m (= h_J^-) < b^+$. Then $H_J^{-,\perp} \neq \emptyset$ and

$$l = \dim H_J^{-,\perp} = b^+ - m \ge 1.$$
(3.1)

For each nonzero $[\omega] \in H_J^{-,\perp}$ where ω is a self-dual harmonic 2-form, we set

$$f_{\omega} := \langle \omega, F \rangle \in C^{\infty}(M). \tag{3.2}$$

Then, by Lemma 2.5, $f_{\omega} \neq 0$. Set

$$S_J := \{ \omega \in H_J^{-,\perp} \mid \int_M \omega^2 = 1 \}.$$
(3.3)

Then S_J is a sphere of dimension $b^+ - m - 1 = l - 1$. Define a function $V : S_J \to \mathbb{R}$ as follows: for any $\omega \in S_J$,

$$V(\omega) := \operatorname{vol}(M \setminus f_{\omega}^{-1}(0)) = \int_{M \setminus f_{\omega}^{-1}(0)} d\mu_g.$$
(3.4)

Then V is a continuous function on S_J . When $H_J^{-,\perp}$ is non-empty,

$$\delta_J := \inf_{\omega \in S_J} V(\omega) > 0 \tag{3.5}$$

since S_J is compact. Let $\alpha_1, \dots, \alpha_m \in \mathbb{Z}_J^-$ be such that $[\alpha_1], \dots, [\alpha_m]$ is an orthonormal basis of H_J^- with respect to the cup product. Choose

$$[\omega_1], \cdots, [\omega_l] \in H_J^{-,\perp}, \quad l = b^+ - m$$

such that $[\alpha_1], \dots, [\alpha_m], [\omega_1], \dots, [\omega_l]$ form an orthonormal basis of \mathcal{H}_g^+ with respect to the cup product; namely, for $1 \leq i \leq m$ and $1 \leq j \leq l$,

$$\int_M \omega_i^2 = \int_M \alpha_j^2 = 1, \quad \int_M \omega_i \wedge \alpha_j = 0, \tag{3.6}$$

and, for $1 \le i_1 \ne i_2 \le m$ and $1 \le j_1 \ne j_2 \le l$,

$$\int_M \omega_{i_1} \wedge \omega_{i_2} = 0, \int_M \alpha_{j_1} \wedge \alpha_{j_2} = 0.$$
(3.7)

To complete the proof of the denseness statement in Theorem 1.1, we need the following lemma which is a special case of a theorem of C. Bär.

Lemma 3.1. ([3, Main Theorem]) Let M be a closed Riemannian 4-manifold. Then every harmonic 2-form α on M has the unique continuation property. Hence if $\alpha \neq 0$, then its nodal set $\alpha^{-1}(0)$ has empty interior; in fact, $\alpha^{-1}(0)$ has Hausdorff dimension ≤ 2 .

By Lemma 3.1, since $\alpha_1, \dots, \alpha_m \in \mathbb{Z}_J^-$, the set $\bigcup_{i=1}^m \alpha_i^{-1}(0)$ has Hausdorff dimension ≤ 2 . Hence

$$M' := \bigcap_{i=1}^{m} (M \setminus \alpha_i^{-1}(0))$$

is an open submanifold of M of full volume: $\operatorname{vol}(M') = \operatorname{vol}(M)$. Choose an open set $U \subset M'$ such that $\operatorname{vol}(U) < \delta_J$. Then $\alpha_j|_U$, $1 \leq i \leq m$ are nonzero sections of $\Lambda_I^-|_U$.

We now construct a new g-compatible almost complex structure on M (cf. [8, 13]). Choose a cut-off function c_1 such that $\overline{\operatorname{supp} c_1} \subset U$ and

$$|c_1\alpha_1| < 1.$$
 (3.8)

Then, by Proposition 2.7, we get

$$J_{c_1} := J_{c_1\alpha_1} = \frac{1 - |c_1\alpha_1|^2}{1 + |c_1\alpha_1|^2} J - \frac{2}{1 + |c_1\alpha_1|^2} K_{c_1\alpha_1},$$
(3.9)

$$F_{c_1} := F_{c_1\alpha_1} = \frac{1 - |c_1\alpha_1|^2}{1 + |c_1\alpha_1|^2}F + \frac{2}{1 + |c_1\alpha_1|^2}c_1\alpha_1.$$
(3.10)

Thus it is easy to see that, as $c_1 \to 0$,

$$J_{c_1} \to J, \quad F_{c_1} \to F.$$
 (3.11)

Note that $J_{c_1} \in \mathcal{J}_g^c \cap \mathcal{J}_F^t$ and (g, J_{c_1}, F_{c_1}) are a family of almost Hermitian structures on M.

We claim that $H_{J_{c_1}}^- \subset H_J^-$. Since J_{c_1} is g-compatible, we have

$$H_{J_{c_1}}^- \subset \mathcal{H}_g^+ = H_J^- \oplus H_J^{-,\perp}. \tag{3.12}$$

Given any nonzero $\beta \in \mathcal{Z}_{J_{c_i}}^-$, there exist real constants ξ_i and η_j such that

$$\beta = \sum_{i=1}^{l} \xi_i \omega_i + \sum_{j=1}^{m} \eta_j \alpha_j, \qquad (3.13)$$

where $1 \le i \le l$ and $1 \le j \le m$. Without loss of generality, we may assume that

$$\int_M \beta^2 = \sum_{i=1}^l \xi_i^2 + \sum_{j=1}^m \eta_j^2 = 1.$$
(3.14)

Obviously, $\langle \beta, F_{c_1} \rangle = 0$. Restricted to $M \setminus \overline{\operatorname{supp} c_1}$, we have $F_{c_1} = F$. On $M \setminus \overline{\operatorname{supp} c_1}$, we get

$$\langle \beta, F_{c_1} \rangle |_{M \setminus \overline{\operatorname{supp} c_1}} = \sum_{i=1}^l \xi_i \langle \omega_i, F \rangle |_{M \setminus \overline{\operatorname{supp} c_1}} = 0.$$
(3.15)

If $\sum_{i=1}^{l} \xi_i \omega_i \in H_J^{-,\perp}$ is nontrivial, then we put

$$\beta_1 = \frac{\sum_{i=1}^{l} \xi_i \omega_i}{\left(\int_M (\sum_{i=1}^{l} \xi_i \omega_i)^2\right)^{1/2}}.$$
(3.16)

Obviously, $\beta_1 \in S_J$. By (3.15) and (3.16), $f_{\beta_1} = \langle \beta_1, F \rangle \equiv 0$, restricted to $M \setminus \overline{\operatorname{supp} c_1}$. Hence $M \setminus f_{\beta_1}^{-1}(0) \subset \overline{\operatorname{supp} c_1} \subset U$. It follows that

$$V(\beta_1) = \operatorname{vol}(M \setminus f_{\beta_1}^{-1}(0)) \le \operatorname{vol}(U) < \delta_J,$$
(3.17)

contradicting the definition of δ_J (see (3.5)). Therefore $\xi_i = 0$ for $1 \le i \le l$ and $\beta = \sum_{j=1}^m \eta_j \alpha_j$. Thus we have proved that if $H_J^- \ne \emptyset$ then $H_{J_{c_1}}^- \subset H_J^-$.

Remark 3.2. In [9], Draghici, Li and Zhang have considered g-related almost complex structures: if almost complex structures J and \tilde{J} are g-related then $\Lambda_J^- + \Lambda_{\tilde{J}}^- \subset \Lambda_g^+$ and hence $H_J^- + H_{\tilde{J}}^- \subset H_g^+$.

Secondly, if $H_J^- = \mathcal{H}^+$ then we construct any J_{c_1} and F_{c_1} such that $H_{J_{c_1}}^- \subset H_J^-$. In summary, we have obtained the following

Proposition 3.3. Let (M, g, J, F) be a closed almost Hermitian 4-manifold. If $h_J^- \geq 1$, then we can construct a g-compatible almost complex structure J_{c_1} where the volume of supp c_1 is small enough, so that $H_{J_{c_1}}^- \subset H_J^-$.

The following observation is the key for the computation of $h_{J_{cr}}^-$.

Proposition 3.4. ([9, Proposition 3.7]) Suppose J and \tilde{J} are g-related almost complex structures on a closed 4-manifold M, with $\tilde{J} \not\equiv \pm J$. Then

$$\dim\left(H_J^- \cap H_{\tilde{I}}^-\right) \le 1.$$

Let us return to the proof of the denseness statement in Theorem 1.1. By Propositions 3.3 and 3.4, $h_{J_{c_1}}^- = \dim H_{J_{c_1}}^- = \dim (H_{J_{c_1}}^- \cap H_J^-) \leq 1.$

Without loss of generality, we may suppose that $h_{J_{c_1}}^- = 1$. Choose $[\alpha] \in H_{J_{c_1}}^$ such that $\int_M \alpha^2 = 1$. We then have dim $H_{J_{c_1}}^{-,\perp} = b^+ - 1$, and by the same reason as that for (3.5),

$$\delta_{J_{c_1}} := \inf_{\omega \in S_{J_{c_1}}} V(\omega) > 0.$$
(3.18)

Choose a cut-off function c_2 such that $\overline{\operatorname{supp} c_2} \subset M \setminus \alpha^{-1}(0)$ (by Lemma 3.1) and that

$$\operatorname{vol}\left(\operatorname{supp} c_2\right) < \delta_{J_{c_1}}.\tag{3.19}$$

Construct

$$F_{c_2} = f_1 F_{c_1} + c_2 \alpha$$

such that $F_{c_2} \wedge F_{c_2} = 2d\mu_g$. It is easy to see that J and J_{c_2} are both g-compatible (g-related); thus $J_{c_2} \in \mathcal{J}_g^c \cap \mathcal{J}_{F_{c_1}}^t$.

We claim that $h_{J_{c_2}}^- = 0$. Otherwise, there exists nonzero $\beta \in H_{J_{c_2}}^-$. Then, by the above construction and by Proposition 3.3, $H_{J_{c_2}}^- \subset H_{J_{c_1}}^-$; hence $\beta \in H_{J_{c_1}}^-$, $\beta = \eta \alpha$, $\eta \neq 0$, and

$$\langle \beta, F_{c_2} \rangle \equiv 0. \tag{3.20}$$

Restricted to supp c_2 , we have $F_{c_2} = f_1 F_{c_1} + c_2 \alpha$. It follows that

$$0 = \langle \beta, F_{c_2} \rangle |_{\text{supp } c_2} = \langle \eta \alpha, c_2 \alpha \rangle = \eta c_2 |\alpha|^2.$$
(3.21)

Thus $\alpha^{-1}(0) \supset \operatorname{supp} c_2$, contradicting Lemma 3.1. Hence $h_{J_{c_2}}^{-1} = 0$.

This completes the proof of the denseness statement in Theorem 1.1.

It remains to prove the openness statement in Theorem 1.1. Since the case $b^+ = 1$ is proved in [9] by Draghici, Li and Zhang, we consider the case $b^+ \ge 2$. Suppose that $J_k \to J$ in the Fréchet space as $k \to \infty$ and that

$$m_k := h_{J_k}^- \ge 1.$$

We need to prove that $h_J^- \ge 1$. Suppose $h_J^- = 0$. Then $b^+ = h_J^+ - b^-$. Let g be a J-compatible metric and set $F = g(J, \cdot)$. Let $\psi^1, \cdots, \psi^{b^+} \in \mathcal{H}_g^+$ be an orthonormal basis with respect to the cup product, that is,

$$\int_{M} \psi^{i} \wedge \psi^{j} = \delta_{ij}, \quad 1 \le i, j \le b^{+}.$$
(3.22)

Note that $\mathcal{H}_g^+ = H_J^- \oplus H_J^{-,\perp}$. Since $h_J^- = 0$, by Lemma 2.6,

$$\psi^i = f^i F + P_J^- d\theta^i, \qquad (3.23)$$

where $\theta^i \in \Omega^1$. Set

$$g_k = \frac{1}{2}(g(\cdot, \cdot) + g(J_k \cdot, J_k \cdot)), \quad F_k = g_k(J_k \cdot, \cdot).$$

Then $(g_k, J_k, F_k) \to (g, J, F)$ as $k \to \infty$. Since $m_k = h_{J_k}^- \ge 1$, we may choose an orthonormal basis of $\mathcal{H}_{g_k}^+$ with respect to the cup product as follows:

$$\{\omega^{l}(k)\}_{1 \leq l \leq b^{+} - m_{k}} \cup \{\alpha^{l}(k)\}_{b^{+} - m_{k} + 1 \leq l \leq b^{+}},\$$

where $\{\alpha^{l}(k)\}_{b^{+}-m_{k}+1\leq l\leq b^{+}} \subset H_{J_{k}}^{-}$ and $\{\omega^{l}(k)\}_{1\leq l\leq b^{+}-m_{k}} \subset H_{J_{k}}^{-,\perp}$. Denote by $\triangle_{g_{k}}$ the Hodge-de Rham Laplace operator associated to g_{k} and by \mathbb{G}^{k} the Green operator associated to $\triangle_{g_{k}}$. Then, as done in [9, 15],

$$\psi^{i} = (\psi^{i} - \mathbb{G}^{k}(\triangle_{g_{k}}\psi^{i})) + \mathbb{G}^{k}(\triangle_{g_{k}}\psi^{i}) = \psi^{i}_{\mathbf{h},k} + \psi^{i}_{\mathbf{ex},k}, \qquad (3.24)$$

with $\psi_{\mathbf{h},k}^i := \psi^i - \mathbb{G}^k(\triangle_{g_k}\psi^i)$ the g_k -harmonic part and $\psi_{\mathbf{ex},k}^i := \mathbb{G}^k(\triangle_{g_k}\psi^i)$ the g_k -exact part. Thus $\psi_{\mathbf{h},k}^i \to \psi^i$ and $\psi_{\mathbf{ex},k}^i \to 0$ as $k \to \infty$. Moreover, if $(\psi_{\mathbf{h},k}^i)^+$ denotes the g_k -self-dual part of $\psi_{\mathbf{h},k}^i$ and $(\psi_{\mathbf{h},k}^i)^-$ denotes the g_k -anti-self-dual part

of $\psi_{\mathbf{h},k}^{i}$, then we still have $(\psi_{\mathbf{h},k}^{i})^{+} \to \psi^{i}$ as $k \to \infty$ since ψ^{i} is g-self-dual harmonic form and $g_{k} \to g$ as $k \to \infty$. Indeed,

$$\int_{M} \psi^{i} \wedge *_{g_{k}} \psi^{i} = \int_{M} |(\psi^{i}_{\mathbf{h},k})^{+}|^{2}_{g_{k}} d\mu_{g_{k}} + \int_{M} |(\psi^{i}_{\mathbf{h},k})^{-}|^{2}_{g_{k}} d\mu_{g_{k}} + \int_{M} |d\theta^{i}_{k}|^{2}_{g_{k}} d\mu_{g_{k}}$$

$$(3.25)$$

and

$$1 = \int_{M} \psi^{i} \wedge \psi^{i} = \int_{M} \psi^{i} \wedge *_{g} \psi^{i}$$

=
$$\int_{M} |(\psi^{i}_{\mathbf{h},k})^{+}|^{2}_{g_{k}} d\mu_{g_{k}} - \int_{M} |(\psi^{i}_{\mathbf{h},k})^{-}|^{2}_{g_{k}} d\mu_{g_{k}}, \qquad (3.26)$$

where $\psi_{\text{ex},k}^{i} = d\theta_{k}^{i}$. Then, by (3.25) and (3.26),

$$\int_{M} \psi^{i} \wedge *_{g_{k}} \psi^{i} - \int_{M} \psi^{i} \wedge *_{g} \psi^{i}$$

= $2 \int_{M} |(\psi^{i}_{\mathbf{h},k})^{-}|^{2}_{g_{k}} d\mu_{g_{k}} + \int_{M} |d\theta^{i}_{k}|^{2}_{g_{k}} d\mu_{g_{k}}.$ (3.27)

Since $*_{g_k} \to *_g$ and $g_k \to g$ as $k \to \infty$, we obtain that

$$2\int_{M} |(\psi_{\mathbf{h},k}^{i})^{-}|_{g_{k}}^{2} d\mu_{g_{k}} + \int_{M} |d\theta_{k}^{i}|_{g_{k}}^{2} d\mu_{g_{k}} \to 0$$

and

$$2\int_{M} |(\psi_{\mathbf{h},k}^{i})^{-}|_{g}^{2} d\mu_{g} + \int_{M} |d\theta_{k}^{i}|_{g}^{2} d\mu_{g} \to 0$$

as $k \to \infty$. Therefore $(\psi_{\mathbf{h},k}^i)^+ \to \psi^i$, $(\psi_{\mathbf{h},k}^i)^- \to 0$ and $\psi_{\mathbf{ex},k}^i \to 0$ in $L^2(g)$ as $k \to \infty$. Since $(\psi_{\mathbf{h},k}^i)^+ \in \mathcal{H}_{g_k}^+$, there exist $a_l^i(k) \in \mathbb{R}$, $1 \le l \le b^+$ such that

$$(\psi_{\mathbf{h},k}^{i})^{+} = \sum_{l=1}^{b^{+}-m_{k}} a_{l}^{i}(k)\omega^{l}(k) + \sum_{l=b^{+}-m_{k}+1}^{b^{+}} a_{l}^{i}(k)\alpha^{l}(k).$$
(3.28)

We have obtained that $(\psi^i_{\mathbf{h},k})^+ \to \psi^i$ in $L^2(g)$ as $k \to \infty$, so

$$\int_{M} |(\psi_{\mathbf{h},k}^{i})^{+}|_{g_{k}}^{2} d\mu_{g_{k}} \to 1$$

as $k \to \infty$. Then $\{(\psi_{\mathbf{h},k}^i)^+\}$ are bounded in $L^2(g_k)$.

Let us write

$$(\psi_{\mathbf{h},k}^{i})^{+,'} := \sum_{l=1}^{b^{+}-m_{k}} a_{l}^{i}(k)\omega^{l}(k), \quad (\psi_{\mathbf{h},k}^{i})^{+,''} := \sum_{l=b^{+}-m_{k}+1}^{b^{+}} a_{l}^{i}(k)\alpha^{l}(k).$$

It is easy to see that

$$\int_{M} |(\psi_{\mathbf{h},k}^{i})^{+}|_{g_{k}}^{2} d\mu_{g_{k}} = \int_{M} |(\psi_{\mathbf{h},k}^{i})^{+'}|_{g_{k}}^{2} d\mu_{g_{k}} + \int_{M} |(\psi_{\mathbf{h},k}^{i})^{+,''}|_{g_{k}}^{2} d\mu_{g_{k}}.$$

Since $\{(\psi_{\mathbf{h},k}^{i})^{+}\}\$ are bounded in $L^{2}(g_{k})$, we have $\{(\psi_{\mathbf{h},k}^{i})^{+,'}\}\$ and $\{(\psi_{\mathbf{h},k}^{i})^{+,''}\}\$ are bounded in $L^{2}(g_{k})$. As g_{k} -self-dual-harmonic forms, $\{(\psi_{\mathbf{h},k}^{i})^{+,'}\}\$ and $\{(\psi_{\mathbf{h},k}^{i})^{+,''}\}\$ are bounded in $L^{2}_{2}(g_{k})$. It follows that $\{(\psi_{\mathbf{h},k}^{i})^{+,'}\}\$ and $\{(\psi_{\mathbf{h},k}^{i})^{+,''}\}\$ are bounded in $L^{2}_{2}(g)\$ since $g_{k} \to g\$ in the C^{∞} -Fréchet space as $k \to \infty$. Hence we can choose a subsequence $\{(\psi_{\mathbf{h},k}^{i})^{+,''}\}\$ of $\{(\psi_{\mathbf{h},k}^{i})^{+,''}\}\$ such that

$$\Omega^-_{J_{k_1}} \ni (\psi^i_{\mathbf{h},k_1})^{+,''} \to (\psi^i_{h,\infty})^{+,''} \in \Omega^-_J$$

in $L_1^2(g)$ as $k_1 \to \infty$ since $J_{k_1} \to J$ and $\Omega_{J_{k_1}}^- \to \Omega_J^-$. Since $d(\psi_{h,k_1}^i)^{+,''} = 0$, we have $d(\psi_{h,\infty}^i)^{+,''} = 0$. By the assumption that $h_J^- = 0$, we can get $(\psi_{h,\infty}^i)^{+,''} = 0$ by Lemma 2.4. Thus $(\psi_{h,k_1}^i)^{+,''} \to 0$ and $(\psi_{h,k_1}^i)^{+,'} \to \psi^i$ in $L^2(g)$ as $k_1 \to \infty$. Then

$$\int_{M} (\psi_{\mathbf{h},k_{1}}^{i})^{+,'} \wedge (\psi_{\mathbf{h},k_{1}}^{i})^{+,'} \to \int_{M} \psi^{i} \wedge \psi^{i} = 1$$
(3.29)

as $k_1 \to \infty$. On the other hand,

$$(\psi_{\mathbf{h},k_1}^i)^+ = (\psi_{\mathbf{h},k_1}^i)^{+,'} + \sum_{l=b^+ - m_{k_1} + 1}^{b^+} a_l^i(k_1)\alpha^l(k_1).$$
(3.30)

It follows that

$$\begin{split} \int_{M} \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+} \wedge \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+} &= \int_{M} \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+,'} \wedge \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+,'} \\ &+ \int_{M} \sum_{l=b^{+}-m_{k_{1}}+1}^{b^{+}} a_{l}^{i}(k_{1})\alpha^{l}(k_{1}) \wedge \sum_{l=b^{+}-m_{k_{1}}+1}^{b^{+}} a_{l}^{i}(k_{1})\alpha^{l}(k_{1}) \\ &= \int_{M} \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+,'} \wedge \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+,'} + \sum_{l=b^{+}-m_{k_{1}}+1}^{b^{+}} (a_{l}^{i}(k_{1}))^{2} \\ &\geq \int_{M} \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+,'} \wedge \left(\psi_{\mathbf{h},k_{1}}^{i}\right)^{+,'} + (a_{b^{+}}^{i}(k_{1}))^{2}, \end{split}$$

since $h_{J_{k_1}}^- \geq 1$ by the assumption. Note that

$$\int_{M} (\psi_{\mathbf{h},k_{1}}^{i})^{+} \wedge (\psi_{\mathbf{h},k_{1}}^{i})^{+} \to 1, \quad \int_{M} (\psi_{\mathbf{h},k_{1}}^{i})^{+,'} \wedge (\psi_{\mathbf{h},k_{1}}^{i})^{+,'} + \to 1$$

as $k_1 \to \infty$. Hence

$$(a_{b^+}^i(k_1))^2 \to 0 \tag{3.31}$$

as $k_1 \to \infty$. Note that $\int_M \psi^i \wedge \psi^j = \delta_{ij}$ and $(\psi^i_{\mathbf{h},k_1})^+ \to \psi^i$ as $k_1 \to \infty$, for $1 \le i \le b^+$. Thus,

$$\int_{M} (\psi_{\mathbf{h},k_{1}}^{i})^{+} \wedge (\psi_{\mathbf{h},k_{1}}^{j})^{+} = \sum_{l=1}^{b^{+}} a_{l}^{i}(k_{1})a_{l}^{j}(k_{1}) \to \delta_{ij}$$
(3.32)

as $k_1 \to \infty$. Denote by $A(k_1)$ the $b^+ \times b^+$ matrix: $A(k_1) = (a_l^i(k_1))$. Then

$$B(k_1) = A(k_1)A(k_1)^t = \left(\sum_{l=1}^{b^+} a_l^i(k_1)a_l^j(k_1)\right) \to I_{b^+}$$
(3.33)

as $k_1 \to +\infty$. Thus $A(k_1) \to A \in O(b^+)$ as $k_1 \to \infty$. Hence $A^t \in O(b^+)$ and

$$\sum_{i=1}^{b^{+}} a_{l}^{i}(k_{1}) a_{m}^{i}(k_{1}) \to \delta_{lm}$$
(3.34)

as $k_1 \to \infty$. In particular, as $k_1 \to \infty$,

$$\sum_{i=1}^{b^+} a_{b^+}^i (k_1)^2 \to 1.$$
(3.35)

This contradicts (3.31). Thus we get $h_J^- \ge 1$.

Thus the almost complex structures J with $h_J^- = 0$ form an open subset of \mathcal{J} in the Fréchet space. This completes the proof of Theorem 1.1.
