AVERAGED POINTWISE BOUNDS FOR DEFORMATIONS OF SCHRÖDINGER EIGENFUNCTIONS

ABSTRACT. Let (M, g) be an *n*-dimensional, compact Riemannian manifold and $P_0(\hbar) =$ $-\hbar^2 \Delta_q + V(x)$ be a semiclassical Schrödinger operator with $\hbar \in (0, \hbar_0]$. Let $E(\hbar) \in [E - \hbar^2 \Delta_q + V(x)]$ o(1), E + o(1) and $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ be a family of L²-normalized eigenfunctions of $P_0(\hbar)$ with $P_0(\hbar)\varphi_{\hbar} = E(\hbar)\varphi_{\hbar}$. We consider magnetic deformations of $P_0(\hbar)$ of the form $P_u(\hbar) =$ $-\Delta_{\omega_u}(\hbar) + V(x)$, where $\Delta_{\omega_u}(\hbar) = (\hbar d + i\omega_u(x))^*(\hbar d + i\omega_u(x))$. Here, u is a k-dimensional parameter running over $B^k(\varepsilon)$ (the ball of radius ε), and the family of the magnetic potentials $(w_u)_{u\in B^k(\varepsilon)}$ satisfies the admissibility condition given in Definition 1.1. This condition implies that $k \ge n$ and is generic under this assumption.

Consider the corresponding family of deformations of $(\varphi_h)_{h \in (0,h_0]}$, given by $(\varphi_h^u)_{h \in (0,h_0]}$, where

$$\varphi_{\hbar}^{(u)} := e^{-it_0 P_u(\hbar)/\hbar} \varphi_{\hbar}$$

for $|t_0| \in (0, \varepsilon)$; the latter functions are themselves eigenfunctions of the \hbar -elliptic operators $Q_u(\hbar) := e^{-it_0 P_u(\hbar)/\hbar} P_0(\hbar) e^{it_0 P_u(\hbar)/\hbar}$ with eigenvalue $E(\hbar)$ and $Q_0(\hbar) = P_0(\hbar)$. Our main result, Theorem 1.2, states that for $\varepsilon > 0$ small, there are constants $C_j = C_j(M, V, \omega, \varepsilon) > 0$ with j = 1, 2 such that

$$C_1 \leq \int_{\mathcal{B}^k(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^2 \, du \leq C_2,$$

uniformly for $x \in M$ and $\hbar \in (0, h_0]$. We also give an application to eigenfunction restriction bounds in Theorem 1.3.

1. INTRODUCTION

1.1. **Background.** Let (M, g) be an *n*-dimensional, compact Riemannian manifold with Laplace Beltrami operator $-\Delta_g : C^{\infty}(M) \to C^{\infty}(M)$. We let $0 = \lambda_1 \leq \lambda_2 \leq \dots$ be the eigenvalues of $-\Delta_q$ and $\{\varphi_{\lambda_i}\}_{i\in\mathbb{Z}^+}$ be the corresponding L^2 normalized basis eigenfunctions. The relationship between the large λ asymptotics of the φ_{λ} 's and the corresponding dynamics of the geodesic flow $G^t: T^*M \to T^*M$ is a very interesting subject which has been studied a great deal over the past several decades. Nevertheless, many basic questions related to this correspondence are not well understood, especially for eigenfunctions; there are several ways of quantifying this correspondence. One such approach is to classify the possible semiclassical defect measures: Given a pseudodifferential operator of order zero, known in physics as the quantum observable, one studies the possible limit measures $d\mu$ on S^*M satisfying $\lim_{\lambda\to\infty} \langle A\varphi_{\lambda}, \varphi_{\lambda} \rangle = \int_{S^*M} \sigma(A) d\mu$. Recently, there have been important advances in the understanding of defect measures vis-a-vis quantum unique ergodicity [A, H, L].

One important measure of the classical-quantum correspondence, different from that of defect measures, involves computation of L^{∞} bounds, or more generally L^p bounds, of eigenfunctions. The universal estimate $\|\varphi_{\lambda}\|_{L^{\infty}} = \mathcal{O}(\lambda^{\frac{n-1}{2}})$ due to Avakumovic, Hörmander, and Levitan [Av, Ho, Lev] follows from the well-known pointwise asymptotic formula

$$e(x, x, \lambda) = (2\pi)^{-n} \operatorname{vol}(M) \lambda^n + \mathcal{O}(\lambda^{n-1})$$

which is uniform in $x \in M$. Here, $e(x, y, \lambda) := \sum_{\lambda_j \leq \lambda} \varphi_{\lambda_j}(x) \overline{\varphi_{\lambda_j}(y)}$ is the Schwartz kernel of the spectral projector of $-\Delta_g$. The $\mathcal{O}(\lambda^{\frac{n-1}{2}})$ bound is known to be saturated by the zonal harmonics on \mathbb{S}^n at the north and south poles with the round metric. Sogge and Zelditch [SZ] proved that this maximal bound is only attained at points $z \in M$, where $|\mathcal{L}_z| > 0$ where $\mathcal{L}_z := \{\xi \in S_z^*M; \exists T > 0 \text{ such that } \exp_z(T\xi) = z\}$ and |A| denotes the Liouville measure of $A \subset S_z^*M$. The latter theorem is closely related to earlier work of Safarov [Sa] and is the pointwise analogue of a result of Düstermaat and Guillemin [DG] and Ivrii [I] for the Weyl remainder of the integrated spectral function, $N(\lambda) = \int_M e(x, x; \lambda) dvol(x)$. More recently, Sogge, Toth, and Zelditch [STZ] improved these general L^{∞} estimates by replacing the zero-measure looping condition in [SZ] with the weaker assumption of recurrence.

It is difficult to improve the general $\mathcal{O}(\lambda^{\frac{n-1}{2}})$ by polynomial powers of λ and there are few rigorous results along these lines; see [Z] for a thorough overview of known results on eigenfunction bounds. In the quantum completely integrable case, explicit polynomial improvements in the L^{∞} bounds for eigenfunctions are given in [T]. For arithmetic hyperbolic surfaces, polynomial improvements were obtained by Iwaniec and Sarnak [IS]. A conjecture of Sarnak [S] asserts that for hyperbolic surfaces, $\|\varphi_{\lambda}\|_{L^{\infty}} = \mathcal{O}_{\varepsilon}(\lambda^{\varepsilon})$ for any $\varepsilon > 0$. Both numerical evidence and Berry's random wave model [Ber] are consistent with such a bound, but rigorous results at this time remain elusive; see the lecture notes of Sarnak [S] for further details on this conjecture and related topics.

In the more general semiclassical setting, Koch, Tataru and Zworski [KTZ] proved sharp L^p eigenfunction estimates for general semiclassical Schrödinger operators $P(\hbar) = -\hbar^2 \Delta_g + V(x)$, where $\hbar \in (0, \hbar_0]$ is the semiclassical parameter. In particular, they prove that $\|\varphi_{\hbar}\|_{L^{\infty}} = \mathcal{O}(\hbar^{\frac{-n-1}{2}})$ extending the homogeneous Avakumovic-Hörmander-Levitan bound.

One of the main applications of the results in this paper is to eigenfunction restriction bounds; in this case, more is known. Let $H \subset M$ be denote a smooth hypersurface. In the general homogeneous case, Burq, Gerard and Tzvetkov [BGT] gave sharp general upper bounds for $\|\varphi_{\lambda}\|_{L^{p}(H)}$ which depend on geodesic curvature of H; in particular, when H is totally geodesic, the authors show that $\|\varphi_{\lambda}\|_{L^{2}(H)} = \mathcal{O}(\lambda^{\frac{n-1}{4}})$ and if H has strictly positive geodesic curvature this bound improves to $\|\varphi_{\lambda}\|_{L^{2}(H)} = \mathcal{O}(\lambda^{\frac{n-1}{6}})$. Similar results were obtained independently using the analysis of fold and blowdown singularities of Fourier integral operators by Hu [Hu]. Recently, Hassell and Tacy generalized these results to the semiclassical setting [HT].

The article [T2] proved that for generic curves H in the quantum completely integrable case on surfaces, there is a large improvement in the upper bound, explicitly of the form $\|\varphi_{\lambda}\|_{L^{2}(H)} = \mathcal{O}(\sqrt{\log \lambda})$, which is consistent with the random wave model. Here, "genericity" is defined in terms of the associated moment mapping of the integrable system. At the opposite extreme in [TZ1, TZ2], it is proved that for generic hypersurfaces H of manifolds with ergodic geodesic flow, along with quantum ergodic sequences of eigenfunctions, one actually has quantum ergodic restriction in the sense that the asymptotics take the form $\|\varphi_{\lambda}\|_{L^{2}(H)} \sim 1$. We show in Theorem 1.3 that for any submanifold $H \subset M$ there is a natural class of unitary perturbations of Schrödinger eigenfunctions that satisfy the ≈ 1 restriction bound, at least for a positive measure of values of the perturbation parameters. This is consistent with the ergodic case and our results here can be interpreted as further evidence for the efficacy of the random wave model.

1.2. Discussion of Results. We now describe our results in more detail. Let $\mathcal{B}^k(\varepsilon) \subset \mathbb{R}^k$ be the k-ball of radius $\varepsilon > 0$ centered at $0 \in \mathbb{R}^k$. In the following discussion, $(\omega_u)_{u \in \mathcal{B}^k(\varepsilon)}$ denotes a smooth k-parameter family of C^{∞} one-forms on M. In each local coordinate chart $U \subset \mathbb{R}^n$, one can write

$$\omega_u(x) = \sum_{j=1}^n \omega_j(x, u) dx_j \text{ for } \omega_j \in C^\infty(U \times \mathcal{B}^k(\varepsilon)), \ j = 1, ..., n.$$
(1)

Consider the associated gauge-invariant semiclassical differentials

$$d_{\omega_u}(\hbar) := \hbar d + i\omega_u : C^{\infty}(M) \to \Omega^1(M).$$

We assume throughout that $\omega_0 = 0$, $\hbar \in (0, \hbar_0]$ is the semiclassical parameter, and $d_{\omega_u}(\hbar)^*$: $\Omega^1(M) \to C^{\infty}(M)$ is the adjoint induced by the Riemannian metric g. Explicitly, $d_{\omega_u}(\hbar)^* = \hbar d^* + \omega_u$, where $*: \Omega^1(M) \to \Omega^{n-1}(M)$ is the Hodge star operator and for $w \in \Omega^1(M)$, the *codifferential* is given by

$$d^*w = -*d * w = \frac{1}{\sqrt{|g|}} \sum_{i,j} \partial_{x_j} [\sqrt{|g|} g^{ij} w_i].$$

Then, for any given electric potential $V \in C^{\infty}(M)$, we form a family of semiclassical magnetic Schrödinger operators

$$P_u(\hbar) := -d^*_{\omega_u}(\hbar)d_{\omega_u}(\hbar) + V(x).$$
⁽²⁾

For u = 0, we clearly have that $P_0(\hbar) = -\hbar^2 \Delta_g + V(x)$, where $-\Delta_g : C^{\infty}(M) \to C^{\infty}(M)$ is the standard Laplacian. The operator $P_u(\hbar)$ has the principal symbol

$$p_u(x,\xi) = \sum_{i,j=1}^n (\xi_i + \omega_i(x,u)) g^{ij}(x) (\xi_j + \omega_j(x,u)) + V(x),$$
(3)

where the ω_j are the local components of the magnetic potentials in (1). The bicharacteristic flow associated with the Hamiltonian vector field H_{p_u} is denoted by

$$G_u^t: T^*M \to T^*M, \ t \in \mathbb{R}.$$
(4)

Theorem 1.2, the main result of this article, gives an explicit ansatz for mollifying the pointwise behavior of eigenfunctions, on average, by using propagators $e^{it_0P_u(\hbar)/\hbar}$ generated by the magnetic Schrödinger operators (2).

Let (M^n, g) be a compact manifold and $P_0(\hbar) = -\hbar^2 \Delta_g + V(x)$ be a semiclassical Schrödinger operator with $\hbar \in (0, \hbar_0]$ with $E \in \mathbb{R}$ a regular value of $p_0(x, \xi) = |\xi|_g^2 + V(x)$; here, $E(\hbar) \in [E - o(1), E + o(1)]$ and $(\varphi_{\hbar})_{\hbar \in [0, \hbar_0)}$, where $\varphi_{\hbar} \in C^{\infty}(M)$, is an L^2 -normalized family of semiclassical eigenfunctions with $P_0(\hbar)\varphi_{\hbar} = E(\hbar)\varphi_{\hbar}$. We consider magnetic deformations of $P_0(\hbar)$ of the form (2) and assume that the number of deformation parameters $k \geq n = \dim M$. In terms of local coordinates $x = (x_1, ..., x_n)$, we make the following

DEFINITION 1.1. We say that the smooth family of magnetic potentials $(\omega_u)_{u \in \mathcal{B}^k(\varepsilon)}$ with $\omega_u(x) = \sum_{j=1}^n \omega_j(x, u) dx_j \in \Omega^1(M; C^{\infty}(\mathcal{B}^k(\varepsilon)))$ (interchangably, the corresponding operator $P_u(\hbar)$) is admissible provided

- $\omega_0(x) = 0$ for all $x \in M$,
- The family of maps $f_x : \mathcal{B}^k(\varepsilon) \to \mathbb{R}^n$ with $k \ge n$, given by the components

$$f_x(u) = (\omega_1(x, u), ..., \omega_n(x, u)),$$

are submersions for all $x \in M$.

The submersion requirement in Definition (1.1) is clearly a coordinate-independent and generic condition [Mo]. In any local coordinate chart and for $\varepsilon > 0$ small, this amounts to verifying that the first variation

$$\delta\omega(x) := \partial_{u_i}\omega_i(x, u)|_{u=0},$$

for i = 1, ..., n and j = 1, ..., k, is a $n \times k$ matrix of rank n. For $|t_0|$ small, we define the corresponding deformations of the eigenfunctions by

$$\varphi_{\hbar}^{(u)} := e^{-it_0 P_u(\hbar)/\hbar} \varphi_{\hbar}.$$
(5)

Consider the initial-value problem

$$\begin{cases} \hbar D_t \Phi_{\hbar}^{(u)}(t) + P_u(\hbar) \Phi_{\hbar}^{(u)}(t) = 0, \\ \Phi_{\hbar}^{(u)}(0) = \varphi_{\hbar}. \end{cases}$$
(6)

The deformed eigenfunctions (5) are non-stationary solutions of the time-dependent Schrödinger equation (6) evaluated at time $t = t_0$; that is,

$$\Phi_{\hbar}^{(u)}(t_0) = \varphi_{\hbar}^{(u)}$$

It is also useful to note that when viewed as stationary functions, the $\varphi_{\hbar}^{(u)}$ are also L^2 -normalized eigenfunctions of the \hbar -elliptic operators

$$Q_u(\hbar) := e^{-it_0 P_u(\hbar)/\hbar} P_0(\hbar) e^{it_0 P_u(\hbar)/\hbar}$$
(7)

with eigenvalue $E(\hbar)$. The $\varphi_{\hbar}^{(u)}$ are clearly deformations, up to constant multiples of modulus 1, of the eigenfunction φ_{\hbar} with $\varphi_{\hbar}^{(0)} = e^{-it_0 E(\hbar)/\hbar} \varphi_{\hbar}$ and $Q_0(\hbar) = P_0(\hbar)$; note that $|\varphi_{\hbar}^{(0)}| = |\varphi_{\hbar}|$. Our precisely stated main result is

THEOREM 1.2. Let (M^n, g) be a compact Riemannian manifold and $P_u(\hbar) : C^{\infty}(M) \to C^{\infty}(M)$, with $u \in \mathcal{B}^k(\varepsilon) \subset \mathbb{R}^k$ for $k \ge n$, be a family of admissible magnetic Schrödinger operators of the form (2). Then, for $\varepsilon > 0$ and $|t_0| > 0$ sufficiently small,

$$\int_{\mathcal{B}^k(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^2 \, du \asymp 1$$

as $\hbar \to 0^+$, uniformly for $x \in M$.

Remark: Throughout, $f(\hbar) \approx g(\hbar)$ will mean that there are constants $C_j > 0$ for j = 1, 2, such that $C_1 f(\hbar) \leq g(\hbar) \leq C_2 f(\hbar)$ for $\hbar \in (0, \hbar_0]$. The notation $f(\hbar) \gtrsim g(\hbar)$ means that there is a constant C > 0 such that $f(\hbar) \geq Cg(\hbar)$ for $\hbar \in (0, \hbar_0]$. For any Lebesgue measurable $\mathcal{A} \subset \mathbb{R}^k$ we denote its measure by $|\mathcal{A}|$ and similarly, when $A \in GL(n; \mathbb{R})$, we simply write $|\mathcal{A}|$ for $|\det A|$. Finally, C > 0 denotes a constant which can vary from line to line.

One consequence of Theorem 1.2 is the following eigenfunction restriction bound:

THEOREM 1.3. Let $H \subset M$ be a smooth submanifold, $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ be any family of L^2 normalized eigenfunctions of $P_0(\hbar)$ with $P_0(\hbar)\varphi_{\hbar} = E(\hbar)\varphi_{\hbar}$, and $E(\hbar) = E + o(1)$ as above. Then, given any sequence $\Omega(\hbar) = o(1)$ as $h \to 0^+$, there is a measurable subset $\mathcal{A}_{\hbar} \subset \mathcal{B}^k(\varepsilon)$ with $\lim_{\hbar \to 0^+} \frac{|\mathcal{A}_{\hbar}|}{|\mathcal{B}^k(\varepsilon)|} = 1$ such that for $u \in \mathcal{A}_{\hbar}$,

$$\int_{H} |\varphi_{\hbar}^{(u)}|^2 \, d\sigma_H \lessapprox \frac{1}{\Omega(\hbar)}$$

as $\hbar \to 0^+$, with the implied constant depending on H. In general, the set \mathcal{A}_{\hbar} will depend on H, the initial eigenfunctions φ_{\hbar} , and $\Omega(\hbar)$.

Indeed, restricting the upper and lower bounds in Theorem 1.2 to $x \in H$, integrating over H, and applying Fubini's Theorem to interchange the iterated integrals gives

$$\int_{\mathcal{B}^k(\varepsilon)} \left(\int_H |\varphi_{\hbar}^{(u)}|^2 \, d\sigma_H \right) \, du \asymp 1.$$
(8)

Theorem 1.3 then follows from (8) and the Chebyshev inequality. Since $\Omega(\hbar) = o(1)$ is arbitrary, Theorem 1.3 shows that for a generic deformed eigenfunction $\varphi_{\hbar}^{(u)}$, its restriction bounds along any submanifold $H \subset M$ are much smaller than the deterministic universal upper bounds in [BGT, Hu] and are essentially consistent with the ergodic case [TZ1, TZ2].

Roughly speaking, Theorem 1.2 and Theorem 1.3 say that by introducing a generic magnetic potential ω_u and deforming a Schrödinger eigenfunction φ_{\hbar} via the unitary magnetic propagator $e^{-it_0P_u(\hbar)/\hbar}$, pointwise blowup is destroyed on average as one varies over the intensity and orientation of the magnetic field perturbation. This is related to the notion of "fidelity" in nuclear magnetic resonance and has been revived more recently in quantum chaos [C, P]. The quantities studied are the states $e^{itP_u(\hbar)}e^{-itP_0(\hbar)}\psi_0$, where ψ_0 is some initial function or a family of functions depending on \hbar . In the case where $\psi_{0,\hbar}$ are eigenfunctions with $P_0(\hbar)\psi_{0,\hbar} = E(\hbar)\psi_{0,\hbar}$, one has that $e^{itP_u(\hbar)}e^{-itP_0(\hbar)}\psi_{0,\hbar} = e^{-itE(\hbar)/\hbar}e^{itP_u(\hbar)}\psi_{0,\hbar}$, which is a unitary multiple of the family we consider in Theorem 1.2. The magnetic deformation is important here since it satisfies the non-degeneracy condition described in Definition 1.1 which is crucial in Proposition 4.1; at present, we do not know whether or not our methods extend to the case of electric deformations of $P_0(\hbar)$ of the form $P_u(\hbar) = -\hbar^2 \Delta_g + V_u$, where $V_u \in C^{\infty}(M)$ for $u \in \mathcal{B}^k(\varepsilon)$.

The paper is organized as follows: In Section 2 we motivate our general results by discussing the case of a magnetic propagator $e^{it_0P_u(\hbar)/\hbar}$ on \mathbb{R}^n with $P_u(\hbar) = \langle \hbar D_x + u, \hbar D_x + u \rangle$. Section 3 gives background on the semiclassical microlocal analysis that is needed for the proof of our main result. Section 4 contains the proof of Theorem 1.2 and Section 5 gives applications of Theorem 1.2 to quantum ergodic sequences of eigenfunctions; in the latter section, we get asymptotic results (see Theorem 5.1). Finally, in Section 6, two examples with extremal eigenfunction supremum bounds are given to illustrate the main result; these are the ground states of the one-dimensional harmonic oscillator and the zonal spherical harmonics in two dimensions.

Finally, we thank the referee for detailed comments on improving the manuscript. *Remark:* We note that the results here do not give improvements for averaged eigenfunction L^{∞} -bounds but do for restriction bounds on submanifolds. Theorem 1.2 gives $\sup_{x \in M} \int_{\mathcal{B}^k(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^2 du = \mathcal{O}(1)$, however this does not imply a similar bound for $\int_{\mathcal{B}^k(\varepsilon)} \sup_{x \in M} |\varphi_{\hbar}^{(u)}(x)|^2 du$, i.e. the reverse Fatou lemma does not hold in general. Indeed, for both examples discussed in Section 6, $\|\varphi_{\hbar}^{(u)}\|_{L^{\infty}(M)}^2$ is still maximal even after averaging over the magnetic deformations.

2. Motivation: Propagators given by quadratic forms in \mathbb{R}^n .

One of our main motivations here comes from the well-known, explicit Fourier multiplier formulas for non-degenerate quadratic propagators in \mathbb{R}^n (see [Zw, Theorem 4.8]). Let $Q \in GL(n; \mathbb{R})$ be a real-valued nonsingular $n \times n$ matrix and suppose $\{f_{\hbar}\}_{\hbar \in (0,h_0]}$ is a semiclassical family with $f_{\hbar} \in \mathcal{S}(\mathbb{R}^n)$ and $||f_{\hbar}||_{L^2} = 1$ for all $\hbar \in (0, \hbar_0]$. Let $\langle QD, D \rangle$ be the natural inner product where D is the column vector $(D_{x_1}, ..., D_{x_n})$ and $D_{x_k} = \frac{1}{i}\partial_{x_k}$. One has the explicit integral formula

$$e^{\frac{i\hbar}{2}\langle QD,D\rangle}f_{\hbar}(x) = |\det Q|^{-\frac{1}{2}}(2\pi\hbar)^{-\frac{n}{2}}e^{i\frac{\pi}{4}sgnQ}\int_{\mathbb{R}^{n}}e^{-\frac{i}{2\hbar}\langle Q^{-1}y,y\rangle}f_{\hbar}(x+y)\,dy.$$
(9)

We now consider slightly more general quadratic polynomial expressions in the D's; specifically, the case where $\langle QD, D \rangle$ is replaced by the magnetic Schrödinger operator $\langle \hbar D + u, \hbar D + u \rangle$ with constant magnetic potential $u \in \mathbb{R}^n$. It is readily checked that

$$f_{\hbar}^{(u)}(x) := e^{\frac{i}{2\hbar} \langle \hbar D + u, \hbar D + u \rangle} f_{\hbar}(x) = (2\pi\hbar)^{-\frac{n}{2}} e^{\frac{in\pi}{4}} e^{\frac{i|u|^2}{2\hbar}} \int_{\mathbb{R}^n} e^{-\frac{i}{2\hbar}|y-u|^2} f_{\hbar}(x+y) \, dy.$$
(10)

Let $\chi \in C_0^{\infty}(\mathbb{R}^n)$ with $\chi(u) = 1$ when |u| < 1 and $\chi(u) = 0$ for |u| > 2. It follows from (10) that for any $x \in \mathbb{R}^n$,

$$\int_{\mathbb{R}^{n}} |f_{\hbar}^{(u)}(x)|^{2} \chi(u) \, du = (2\pi\hbar)^{-n} \int_{\mathbb{R}^{3n}} e^{\frac{i}{2\hbar}(|y-u|^{2}-|y'-u|^{2})} f_{\hbar}(x+y) \,\overline{f_{\hbar}(x+y')} \,\chi(u) \, dy dy' du$$
$$= (2\pi\hbar)^{-n} \int_{\mathbb{R}^{3n}} e^{\frac{i}{2\hbar}\langle y-y', y+y'-2u\rangle} f_{\hbar}(x+y) \,\overline{f_{\hbar}(x+y')} \,\chi(u) dy dy' du.$$
(11)

Finally, writing $g_{\hbar,x}(y) := f_{\hbar}(x+y)$ and making the change of variables

$$u \mapsto \xi(u; y, y') = \frac{y + y'}{2} - u,$$
 (12)

it follows that the last line in (11) can be rewritten in the form

$$(2\pi\hbar)^{-n} \int_{\mathbb{R}^{3n}} e^{\frac{i\langle y-y',\xi\rangle}{\hbar}} \chi\left(\frac{y+y'}{2}-\xi\right) g_{\hbar,x}(y) \overline{g_{\hbar,x}(y')} \, dy dy' d\xi = \langle Op_{\hbar}^w(a)g_{\hbar,x}, g_{\hbar,x} \rangle_{L^2(\mathbb{R}^n)},$$
(13)

with $a(y,\xi) = \chi(y-\xi) \in S^{0,0}(\mathbb{R}^{2n})$; see (16) for more on symbol classes. By the Calderon-Vaillancourt Theorem (19) and the fact that $\|g_{\hbar,x}\|_{L^2} = \|f_{\hbar}\|_{L^2} = 1$ for any $x \in \mathbb{R}^n$, it follows that for $\hbar \in (0, \hbar_0]$,

$$\sup_{x \in \mathbb{R}^n} \int_{\mathbb{R}^n} |f_{\hbar}^{(u)}(x)|^2 \,\chi(u) \,du \le C_n,\tag{14}$$

with $C_n > 0$ a purely dimensional constant. To carry out the Kuranishi change of variables in (12), we have used that

$$|d_u\xi| = 2^{-n} |d_u d_\xi p_u| \neq 0,$$
(15)

where, $p_u(x,\xi) = |\xi + u|^2$ is the Hamiltonian function. The non-degeneracy of the mixed Hessian on the RHS of (15) is central to the bound in (14) and motivates the notion of admissibility in Definition 1.1. Our main result in Theorem 1.2 extends the analysis above to a wide class of magnetic deformations on arbitrary compact manifolds. The reason we choose magnetic deformations is largely due to the implied non-degeneracy of the mixed Hessian in (15).

3. Semiclassical pseudodifferential and Fourier integral operators

We briefly review the relevant calculus of semiclassical pseudodifferential and Fourier integral operators that will be used in the proof of Theorem 1.2. The reader is referred to [DS, Zw] for further details.

3.1. Semiclassical pseudodifferential operators (\hbar -PsiDOs). The basic semiclassical symbol spaces are

$$S_{cl}^{m,k}(T^*M) := \{a \in C^{\infty}(T^*M \times (0,\hbar_0]); \\ a \sim_{\hbar \to 0} \hbar^{-m} \sum_{j=0}^{\infty} a_j(x,\xi)\hbar^j \text{ with } |\partial_x^{\alpha}\partial_\xi^{\beta}a_j(x,\xi)| \le C_{\alpha,\beta}\langle\xi\rangle^{k-j-|\beta|}\}.$$
(16)

Here, we use the standard notation for $\langle \xi \rangle := \sqrt{1 + |\xi|^2}$. The corresponding space of \hbar -pseudodifferential operators is

$$\Psi_{cl}^{m,k} := \{A_{\hbar} : C^{\infty}(M) \to C^{\infty}(M); A_{\hbar} = Op_{\hbar}(a) \text{ with } a \in S_{cl}^{m,k}(T^*M)\},$$
(17)

where the Schwartz kernels are locally of the form

$$Op_{\hbar}(a)(x,y) = (2\pi\hbar)^{-n} \int_{\mathbb{R}^n} e^{i\langle x-y,\xi\rangle/\hbar} a(x,\xi,\hbar) \,d\xi, \text{ for } a \in S_{cl}^{m,k}.$$

Given $A_{\hbar} \in \Psi_{cl}^{m,k}$, the principal symbol $\sigma(A_{\hbar}) := \hbar^{-m}a_0$ using the notation of (16). It is sometimes convenient to use the \hbar -Weyl quantization with corresponding Schwartz kernel

$$Op_{\hbar}^{w}(a)(x,y) = (2\pi\hbar)^{-n} \int_{\mathbb{R}^{n}} e^{i\langle x-y,\xi\rangle/\hbar} a\left(\frac{x+y}{2},\xi,\hbar\right) d\xi, \text{ for } a \in S_{cl}^{m,k}.$$
 (18)

One useful feature of the latter quantization scheme is that for $a(x,\xi,\hbar)$ real-valued, the corresponding Weyl quantization is formally self-adjoint with $Op_{\hbar}^{w}(a)^{*} = Op_{\hbar}^{w}(a)$. The operators $A_{\hbar} \in \bigcup_{j,k\in\mathbb{Z}} \Psi_{cl}^{j,k}$ form an algebra; in particular, given $A_{\hbar} \in \Psi_{cl}^{m,k}$ and $B_{\hbar} \in \Psi_{cl}^{m',k'}$, the composition $A_{\hbar} \circ B_{\hbar} \in \Psi_{cl}^{m+m',k+k'}$ has the principal symbol $\sigma(A_{\hbar} \circ B_{\hbar})(x;\xi) = \sigma(A_{\hbar})(x,\xi) \cdot \sigma(B_{\hbar})(x,\xi) = \hbar^{-m-m'}a_{0}(x,\xi)b_{0}(x,\xi)$ in terms of the local representation in (17).

3.1.1. Operator $L^2 \to L^2$ bounds. The Calderon-Vaillancourt Theorem [DS, Zw] states that

$$A_{\hbar} \in \Psi_{cl}^{0,0} \Longrightarrow \|A_{\hbar}\|_{L^2 \to L^2} \le C_n \sup_{|\alpha| + |\beta| \le 2n+1} |\partial_x^{\alpha} \partial_{\xi}^{\beta} a(x,\xi;\hbar)|.$$
⁽¹⁹⁾

In addition, one has the weak Garding inequality: For $A_{\hbar} \in \Psi_{cl}^{0,0}$ and $\hbar \in (0, h_0]$, with $\hbar_0 > 0$ sufficiently small,

$$\sigma(A_{\hbar})(x,\xi) \ge \frac{1}{C} > 0 \Longrightarrow A_{\hbar} \ge \frac{1}{2C}I$$
(20)

where I is the identity operator. The results (19) and (20) are used in the proof of Theorem 1.2.

The family of eigenfunctions $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$, and the corresponding deformations $(\varphi_{\hbar}^{(u)})_{\hbar \in (0,\hbar_0]}$, have compact \hbar -wave fronts supported in an arbitrarily small neighborhood of the characteristic variety $\{(x,\xi) \in T^*M; |\xi|_g^2 + V(x) = E\}$ for \hbar sufficiently small; the following section on semiclassical wavefronts provides more details. Hence, we are only interested here in $A_{\hbar} \in \Psi_{cl}^{m,-\infty}$ since all symbols will have compact support in ξ and therefore only the asymptotic behavior in \hbar is relevant.

3.1.2. Semiclassical wavefront sets WF_{\hbar} . Let $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ be a family of tempered L^2 functions on M in the sense that $\|\varphi_{\hbar}\|_{L^2(M)} = \mathcal{O}(\hbar^{-N})$ for some N > 0 as $\hbar \to 0^+$. In the semiclassical case, one is interested in determining decay properties of the family $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$, not just regularity properties as functions on M. This naturally leads one to define the notation of a *semiclassical wave front set*, $WF_{\hbar}(\varphi_{\hbar})$, associated with the family of functions $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$; the reader is referred to [Zw, Chapter 8, Section 4] for further details. As in the homogeneous case, it is more natural to define the complement of the semiclassical wave front of the family $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ with

$$WF_{\hbar}(\varphi_{\hbar})^{c} = \{(x,\xi) \in T^{*}M; \exists a \in S_{cl}^{0,0} \text{ with } a(x,\xi) \neq 0 \\ \text{and } \|Op_{\hbar}(a)\varphi_{\hbar}\|_{L^{2}} = \mathcal{O}(\hbar^{\infty})\|\varphi_{\hbar}\|_{L^{2}}\}.$$

$$(21)$$

3.1.3. Eigenfunction localization. We will use the fact that eigenfunctions φ_{\hbar} and corresponding deformations $\varphi_{\hbar}^{(u)}$ have compact \hbar -wave fronts to simplify expressions $e^{-it_0P_u(\hbar)/\hbar}\varphi_{\hbar}$ by \hbar -microlocaly cutting-off the propagators $e^{-it_0P_u(\hbar)/\hbar}$ near the energy level set $p_0^{-1}(E) = \{(x,\xi) \in T^*M; |\xi|_g^2 + V(x) = E\}$. Such procedures are standard (see [Zw, Chapter 8]) but, for the convenience of the reader, we briefly review the specific case at hand. By assumption $(P_0(\hbar) - E)\varphi_{\hbar} = o(1)$ and $P_0(\hbar) - E = -\hbar^2 \Delta_g + V - E$ is \hbar -elliptic off $p_0^{-1}(E)$. Let $\chi \in C_0^{\infty}(\mathbb{R})$ be a standard cutoff function equal to 1 near the origin and consider the associated cutoff with

$$\chi_E^{(0)}(x,\xi) := \chi(p_0(x,\xi) - E).$$

Set $\chi_E^{(0)}(\hbar) := Op_{\hbar}(\chi_E^{(0)}) \in \Psi_{cl}^{0,-\infty}(M)$ to be the corresponding \hbar -pseudodifferential cutoffs. It now follows by a standard semiclassical parametrix construction, as in [Zw, Theorem 6.4], that $\|\varphi_{\hbar} - Op_{\hbar}(\chi_E^{(0)})\varphi_{\hbar}\|_{L^2} = \mathcal{O}(\hbar^{\infty})$ and so, $WF_{\hbar}(\varphi_{\hbar}) \subset p_0^{-1}(E)$. Replacing φ_{\hbar} with $P_0^k(\hbar)\varphi_{\hbar}$ above, it follows by a Sobolev lemma argument that for all $k \in \mathbb{N}$,

$$\|\varphi_{\hbar} - Op_{\hbar}(\chi_E^{(0)})\varphi_{\hbar}\|_{C^k} = \mathcal{O}_k(\hbar^{\infty}).$$
(22)

For $\varphi_{\hbar}^{(u)}$, one has the analogous equation $(Q(\hbar) - E)\varphi_{\hbar}^{(u)} = 0$ where, by the semiclassical Egorov theorem ([Zw] Theorem 11.1), $Q(\hbar) = e^{-it_0P_u(\hbar)/\hbar}P_0(\hbar)e^{it_0P_u(\hbar)/\hbar} \in Op_{\hbar}(S_{cl}^{0,2})$. Consequently, by a similar parametrix argument as above it follows that, with the cutoff

$$\chi_{E}^{(u)}(x,\xi) = \chi(p_{0}(G_{u}^{t_{0}}(x,\xi)) - E),$$

$$\|\varphi_{\hbar}^{(u)} - Op_{\hbar}(\chi_{E}^{(u)})\varphi_{\hbar}^{(u)}\|_{C^{k}} = \mathcal{O}_{k}(\hbar^{\infty}).$$
 (23)

Thus, from (22) and (23),

$$\varphi_{\hbar}^{(u)} = Op_{\hbar}(\chi_E^{(u)}) e^{-it_0 P_u(\hbar)/\hbar} Op_{\hbar}(\chi_E^{(0)}) \varphi_{\hbar} + \mathcal{O}_{C^k}(\hbar^{\infty}).$$
(24)

We note the cutoff $\chi_E^{(u)}(x,\xi)$ is defined using the magnetic flow $G_u^{t_0}: T^*M \to T^*M$, but $\chi_E^{(u)}(x,\xi) = \chi(p_0(x,\xi) - E + \mathcal{O}(|u|))$ and so, for $u \in \mathcal{B}^k(\varepsilon)$, supp $(\chi_E^{(u)}) \subset \{(x,\xi) \in T^*M; d((x,\xi), p_0^{-1}(E)) \leq C\varepsilon\}$ with appropriate C > 0. Here, $d: T^*M \times T^*M \to \mathbb{R}^+$ is the distance function relative to any Riemannian metric on T^*M . The main point is that, for $\varepsilon > 0$ small, supp $(\chi_E^{(u)})$ remains localized near the hypersurface $p_0^{-1}(E)$ for all $u \in \mathcal{B}^k(\varepsilon)$.

3.2. Semiclassical Fourier integral operators (\hbar -FIOs). Due to the compactness of $WF_{\hbar}(\varphi_{\hbar}^{(u)})$, it suffices here to consider operators F_{\hbar} with Schwartz kernels locally of the form

$$F_{\hbar}(x,y) = (2\pi\hbar)^{-n} \int_{\mathbb{R}^n} e^{i\psi(x,y;\xi)/\hbar} a(x,y;\xi,\hbar) \,d\xi,$$
(25)

for $a(x, y, \xi, \hbar) \in C_0^{\infty}(U \times V \times \mathbb{R}^n \times (0, \hbar_0])$ with $a(x, y, \xi, \hbar) \sim_{\hbar \to 0} \sum_{j=0}^{\infty} a_j(x, y; \xi) \hbar^{j-m}$, $a_j(x, y; \xi) \in C_0^{\infty}(U \times V \times \mathbb{R}^n)$, for some $m \in \mathbb{R}$, with U and V being open subsets of \mathbb{R}^n . We assume that ψ is a non-degenerate phase in the sense of Hörmander [DS], that is, $\{d_{x,y,\xi}(d_{\xi_1}\psi), ..., d_{x,y,\xi}(d_{\xi_n}\psi)\}$ is linearly independent on the critical set C_{ψ} , where

$$C_{\psi} := \{ (x, y, \xi) \in U \times V \times \mathbb{R}^n; d_{\xi} \psi(x, y, \xi) = 0 \}.$$

We use this local formulation to define our operator between compact, *n*-dimensional manifolds M and N. In view of (25), F_{\hbar} can be associated to an immersed Lagrangian manifold $\Gamma \subset T^*M \times T^*N$, where

$$\Gamma = \{(x, d_x\psi; y, -d_y\psi); d_\xi\psi(x, y, \xi) = 0\},\$$

by pushing forward C_{ψ} through the map $i_{\psi} : C_{\psi} \to \Gamma \subset T^*(M \times N)$ given by $(x, y, \xi) \to (x, d_x \psi, y, -d_y \psi)$; the manifold Γ then contains $WF_{\hbar}(F_{\hbar})$. For $\hbar \in (0, \hbar_0]$ small, the operators $F_{\hbar} : C^{\infty}(M) \to C^{\infty}(N)$, with Schwartz kernel locally of the form (25), are called \hbar -Fourier integral operators and we write $F_{\hbar} \in I_{cl}^{m,-\infty}(M \times N; \Gamma)$.

The symbol of a semiclassical Fourier integral operator $F_{\hbar} \in I_{cl}^{m,-\infty}(M \times N, \Gamma)$, where $h \in (0, h_0]$, is a smooth section of $\Omega_{1/2} \otimes L$, that is, the half-density bundle of Γ twisted by the Maslov line bundle. In terms of the semiclassical Fourier integral representation in (25), it is the square root $\sqrt{d_{C_{\psi}}}$ of the delta-function on C_{ψ} defined by $\delta(d_{\xi}\psi)$, transported to its image in $T^*(M \times N)$ under ι_{ψ} . Concretely, if $(\lambda_1, \ldots, \lambda_n)$ are any local coordinates on C_{ψ} , extended as smooth functions in a neighborhood of C_{ψ} , then

$$d_{C_{\psi}} := rac{|d\lambda|}{|\partial(\lambda, d_{\xi}\psi)/\partial(x, y, \xi)|},$$

where $d\lambda$ is the Lebesgue density and $|\partial(\lambda, d_{\xi}\psi)/\partial(x, y, \xi)|$ denotes the determinant of the Jacobian matrix. In the semiclassical Fourier integral representation (25), the symbol is transported from the critical set C_{ψ} by the Lagrangian immersion i_{ψ} to the set Γ . At a point $(x_0, \xi_0, y_0, \eta_0) \in \Gamma$, the principal symbol of F_{\hbar} is defined to be

$$\sigma(F_{\hbar})(x_0,\xi_0,y_0,\eta_0) := \hbar^{-m} i_{\psi}^* a_0 \sqrt{d_{C_{\psi}}}.$$

This formulation gives a coordinate-invariant definition of the principal symbol.

For a more detailed treatment of the compactly-supported \hbar -Fourier integral operators in (25), see [GuSt, Chapter 8] and [Zw, Chapter 10].

3.2.1. Magnetic propagators. Consider the magnetic propagators $W_u(\hbar) : C^{\infty}(M) \to C^{\infty}(M)$, where

$$W_u(\hbar) := \exp(-it_0 P_u(\hbar)/\hbar)$$

with Schwartz kernel $W_u(\hbar)(x, y)$ and $t_0 > 0$ small. The associated evolution operator $W(\hbar): C^{\infty}(M) \to C^{\infty}(M \times \mathcal{B}^k(\varepsilon))$ has Schwartz kernel

$$W(\hbar)((x,u),y); \ (x,u) \in M \times \mathcal{B}^k(\varepsilon), \ y \in M$$

One clearly has

$$W_u(\hbar)(\cdot, \cdot) = W(\hbar)((\cdot, u), \cdot)$$

A key point in our argument is to interchange the roles of $x \in M$ and $u \in \mathcal{B}^k(\varepsilon)$, viewing $u \in \mathcal{B}^k(\varepsilon)$ as range variables and $x \in M$ as parameters. In terms of the evolution operator $W(\hbar)$, we define

$$W_x(\hbar)(\cdot, \cdot) := W(\hbar)((x, \cdot), \cdot).$$

Therefore, one has the identity

$$\tilde{W}_x(\hbar)(u,y) = W_u(\hbar)(x,y), \text{ for } (x,y,u) \in M \times M \times \mathcal{B}^k(\varepsilon),$$
(26)

with corresponding operators

$$\tilde{W}_x(\hbar): C^\infty(M) \longrightarrow C^\infty(\mathcal{B}^k(\varepsilon))$$

depending on the spatial parameters $x \in M$.

We define the family of cut-off propagators $W_{u,E}(\hbar): C^{\infty}(M) \to C^{\infty}(M)$, where

$$W_{u,E}(\hbar) := Op_{\hbar}(\chi_E^{(u)}) e^{-it_0 P_u(\hbar)/\hbar} Op_{\hbar}(\chi_E^{(0)}), \ \hbar \in (0, \hbar_0].$$
(27)

The family of cut-off operators $W_{u,E}(\hbar)$; $\hbar \in (0, \hbar_0]$ are compactly-supported semiclassical Fourier integral operators, with

$$W_{u,E}(\hbar) \in I^{0,-\infty}_{cl}(M \times M; \Lambda_{t_0}),$$

where

$$\Lambda_{t_0} := \{ (x,\xi;y,\eta) \in T^*M \times T^*M; (x,\xi) = G_u^{t_0}(y,\eta), (x,\xi) \in \operatorname{supp}(\chi_E^{(u)}), \\ (y,\eta) \in \operatorname{supp}(\chi_E^{(0)}) \}.$$
(28)

In analogy with (26), we define a family of cut-off operators $\tilde{W}_{x,E}(\hbar) : C^{\infty}(M) \to C^{\infty}(\mathcal{B}^{k}(\varepsilon))$ with Schwartz kernels

$$W_{x,E}(u,y)(\hbar) := W_{u,E}(x,y)(\hbar), \ (x,y,u) \in M \times M \times \mathcal{B}^k(\varepsilon), \ \hbar \in (0,\hbar_0].$$
(29)

Hence, in view of the eigenfunction localization estimates in (22) and (23),

$$\int_{B^{k}(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^{2} du = \int_{B^{k}(\varepsilon)} |W_{u,E}(\hbar)\varphi_{\hbar}(x)|^{2} du + \mathcal{O}(\hbar^{\infty})$$

$$= \int_{B^{k}(\varepsilon)} |\tilde{W}_{x,E}(\hbar)\varphi_{h}(u)|^{2} du + \mathcal{O}(\hbar^{\infty}).$$
(30)

Let $B(x_0, \varepsilon) \subset M$ be a small geodesic ball centered at $x_0 \in M$. Locally, for $x \in B(x_0, \varepsilon) \subset M$, it suffices to assume that k = n (see (31)). In the next section (see Proposition 4.1), we prove that for $t_0, \varepsilon > 0$ sufficiently small, the family of operators

$$\tilde{W}_{x,E}(\hbar) \in I^{0,-\infty}_{cl}(M \times \mathcal{B}^n(\varepsilon);\Gamma_x); \ \hbar \in (0,\hbar_0],$$

Moreover, under the admissibility assumption in Definition 1.1, $\Gamma_x \subset T^*M \times T^*\mathcal{B}^n(\varepsilon)$ are canonical graphs, locally for $x \in B(x_0, \varepsilon)$. It is at this point that we use the specific structure of the magnetic perturbations to show that (1.1) is satisfied which, in turn, implies the graph condition on Γ_x . Then, given the last line in (30), we use a T^*T -argument (also utilized in the proof of Corollary 4.2) with $T = \tilde{W}_{x,E}(\hbar)$, and the L^2 -bounds (19) and (20) locally uniform in $x \in B(x_0, \varepsilon)$, to finish the proof of Theorem 1.2.

4. Proof of Theorem 1.2

4.1. Operator bounds for semiclassical propagators. The proof of our main theorem is based on a well-known L^2 operator bound for non-degenerate \hbar -Fourier integral operators (see [Zw, Chapter 10]). We introduce some notation before proving an important proposition. Fix $x_0 \in M$ and with $0 < \varepsilon < inj(M, g)$ small so that the geodesic ball $B(x_0, \varepsilon)$ is centered at x_0 with radius $\varepsilon > 0$. One can locally write $P_u(\hbar) = Op_\hbar(\sigma_0(P_u) + \hbar i \sigma_{-1}(P_u))$, where the principal symbol

$$\sigma_0(P_u) = p_u(x,\xi) = \sum_{i,j} (\xi_i + \omega_i(x,u)) g^{ij}(x) (\xi_j + \omega_j(x,u)) + V(x).$$

In local coordinates,

$$\sigma_{-1}(P_u)(x,\xi) = \frac{1}{\sqrt{|g|}} \sum_{i,j} \partial_{x_j} [\sqrt{|g|} g^{ij}] \xi_i + \frac{1}{\sqrt{|g|}} \sum_{i,j} \partial_{x_j} [\sqrt{|g|} g^{ij} \omega_i(x,u)].$$

For $x \in B(x_0, \varepsilon)$ with $\varepsilon > 0$ sufficiently small, it follows by the admissibility assumption (1.1) that for some subset $u' = (u_{i_1}, .., u_{i_n}) \in \mathcal{B}^n(\varepsilon)$,

$$\left|\frac{\partial\omega(x, u', u'')}{\partial u'}\right| \ge C_0,\tag{31}$$

uniformly for $(x, u', u'') \in B(x_0, \varepsilon) \times \mathcal{B}^k(\varepsilon)$. Of course, the choice of u' can vary depending on the geodesic ball $B(x_0, \varepsilon)$. The proof of Theorem 1.2 is local in x and so, in view of (31), it suffices to assume that k = n, which also simplifies the statement below of Proposition 4.1. We now introduce some notation in preparation for the statement of Proposition 4.1. Given local coordinate charts $U, V \in \mathbb{R}^n$,

$$\tilde{\varphi}(y, u, \xi; x) := S(t_0, x, \xi; u) - \langle y, \xi \rangle, \tag{32}$$

where $(y, u, \xi; x) \in V \times \mathcal{B}^n(\varepsilon) \times \mathbb{R}^n \times U$ and $S(t, x, \xi; u)$ satisfies the initial-value problem

$$\begin{cases} \partial_t S(t, x, \xi; u) + p_u(x, \partial_x S(t, x, \xi)) = 0, \\ S(0, x, \xi; u) = \langle x, \xi \rangle. \end{cases}$$
(33)

The key technical step in the proof of Theorem 1.2 is the following

PROPOSITION 4.1. Assume that the family $(P_u(\hbar))_{\hbar \in (0,\hbar_0]}$ of magnetic Schrödinger operators satisfies (31) for $(x, u) \in \mathcal{B}(x_0, \varepsilon) \times \mathcal{B}^n(\varepsilon)$. Then, for $\varepsilon, |t_0| > 0$ sufficiently small,

$$\tilde{W}_{x,E}(\hbar) \in I^{0,-\infty}_{cl}(M \times \mathcal{B}^n(\varepsilon);\Gamma_x),$$

and the immersed Lagrangian

$$\Gamma_x = \{(u, d_u \tilde{\varphi}(y, u, \eta; x); y, -d_y \tilde{\varphi}(y, u, \eta; x)), \ d_\eta \tilde{\varphi}(y, u, \eta; x) = 0\} \subset T^* \mathcal{B}^n(\varepsilon) \times T^* M$$

is a canonical graph that is locally parametrized by the phase function $\tilde{\varphi}$ in (32). Moreover, the local formula for the principal symbol of $\tilde{W}_{x,E}(\hbar)$ is

$$\sigma(\tilde{W}_{x,E}(\hbar))(u,\tau,y,\eta) = \chi_E^{(u)}(x,\eta) e^{i \int_0^{t_0} \sigma_{-1}(P_u)(G_u^t(x,\eta))dt}$$
(34)

$$\times \frac{|d_x \pi G_u^{t_0}(x,\eta)|^{1/2}}{|d_u d_\eta \tilde{\varphi}(y,u,\eta;x)|^{1/2}} |dy d\eta|^{\frac{1}{2}}$$
(35)

where $\chi \in C_0^{\infty}(\mathbb{R})$ and $(u, \tau, y, \eta) \in \Gamma_x$. In (35) $\pi : T^*M \to M$ is the canonical projection on the base manifold and we view $u = u(y, \eta)$ as a function of the local cotangent coordinates $(y, \eta) \in T^*M$ parametrizing Γ_x .

Proof. For $|t_0| < \varepsilon_0$ small, the kernel of $W_{u,E}(\hbar)$ can be locally written in the form ([Zw, Chapter 10, Section 2])

$$W_{u,E}(\hbar)(x,y) = (2\pi\hbar)^{-n} \int_{\mathbb{R}^n} e^{i\varphi(x,y,\xi;u)/\hbar} a(x,\xi;\hbar,u) \, d\xi + K_u(\hbar)(x,y) \tag{36}$$

where the amplitude $a(\cdot, u) \sim \sum_{j=0}^{\infty} a_j(\cdot, u)\hbar^j$ with $a_j(\cdot, u) \in C^{\infty}(\mathcal{B}^n(\varepsilon), C_0^{\infty}(U \times \mathbb{R}^n))$ with coordinate charts $U \Subset \mathbb{R}^n$ and has the expansion discussed in the section on \hbar -FIOs. In (36), the operators $K_u(\hbar)$ are *residual* in the sense that

$$\left|\partial_x^{\alpha}\partial_y^{\beta}K_u(\hbar)(x,y)\right| = \mathcal{O}_{\alpha,\beta,\varepsilon}(\hbar^{\infty})$$

uniformly in $(x, y, u) \in U \times V \times \mathcal{B}^n(\varepsilon)$, for $\varepsilon > 0$ small. The phase function is of the form

$$\varphi(x, y, \xi; u) = S(t_0, x, \xi; u) - \langle y, \xi \rangle$$
(37)

Here,

$$p(x,\xi,u) = \sum_{i,j=1}^{n} g^{ij}(x)(\xi_i + \omega_i(x,u))(\xi_j + \omega_j(x,u)) + V(x)$$
(38)

is the principal symbol of the operator $P_u(\hbar)$. In view of (33), by a Taylor expansion of $S(t, x, \xi)$ around t = 0, it follows that for $t = t_0$ small,

$$S(t_0, x, \xi; u) = \langle x, \xi \rangle - t_0 p(x, \xi, u) + \mathcal{O}(t_0^2).$$

$$\tag{39}$$

The remainder in (39) is locally uniform in $(x, \xi, u) \in K \times \mathcal{B}^n(\varepsilon)$ with $K \subset T^*M$ compact and $\varepsilon > 0$ small. By implicit differentiation of (33) in (x, ξ) , it follows that the same is true for derivatives, implying

$$||S(t_0, x, \xi; u) - \langle x, \xi \rangle + t_0 p(x, \xi, u)||_{C^k(K \times \mathcal{B}(\varepsilon))} = \mathcal{O}_k(t_0^2).$$

The key step in the proof of Proposition 4.1 involves interchanging the roles of x and u. Consequently, we now view $u \in \mathcal{B}^n(\varepsilon)$ no longer as parameters, but rather as range variables for the operators $\tilde{W}_{x,E}(\hbar): C^{\infty}(M) \to C^{\infty}(\mathcal{B}^n(\varepsilon))$ in (26) which now depend on the local parameters $x \in B(x_0, \varepsilon)$.

To emphasize this point and following (32), we write

$$\tilde{\varphi}(u, y, \xi; x) = S(t_0, x, \xi; u) - \langle y, \xi \rangle$$

$$= \langle x - y, \xi \rangle - t_0 p(x, \xi, u) + \mathcal{O}(t_0^2)$$

$$= \langle x - y, \xi \rangle - t_0 \sum_{i,j} g^{ij}(x)(\xi_i + \omega_i(x, u))(\xi_j + \omega_j(x, u)) + \mathcal{O}(t_0^2),$$
(40)

where the last line follows from (39). Similarly, we define $\tilde{a}(u,\xi;x,\hbar) := a(t_0,x,\xi;u,\hbar)$. From (36), it follows that $\tilde{W}_{x,E}(\hbar) \in I^{0,-\infty}_{cl}(M \times \mathcal{B}^n(\varepsilon);\Gamma_x)$. It remains to show that Γ_x is a canonical graph and to compute the principal symbol of $W_{x,E}(\hbar)$.

We recall that the admissibility assumption implies that locally, for $x \in B(x_0, \varepsilon)$, we have the invertibility condition (31)

$$|d_u(\omega_1(x, u), ..., \omega_n(x, u))| \ge C > 0$$
(41)

uniformly for $(x, u) \in B(x_0, \varepsilon) \times \mathcal{B}^n(\varepsilon)$ with $\varepsilon > 0$ small.

We compute in geodesic normal coordinates $x = (x_1, ..., x_n)$ on $B(x_0, \varepsilon)$ centered at x_0 (i.e. $x(x_0) = 0$); here onward, for convenience, we abuse notation somewhat by identifying points with the respective coordinate representations. Since $g^{ij}(x) = \delta^i_j + \mathcal{O}(|x|^2)$, a Taylor expansion in the x-variables in (38) around x = 0 gives

$$p(x;\xi,u) = |\xi + \omega(x,u)|^2 (1 + \mathcal{O}(|x|^2)) + V(x);$$
(42)

in view of (40),

$$\tilde{\varphi}(u, y, \xi; x) = \langle x - y, \xi \rangle - t_0(|\xi + \omega(x, u)|^2 (1 + \mathcal{O}(|x|^2)) + V(x)) + \mathcal{O}(t_0^2).$$
(43)

From (43), it follows that the mixed (u,ξ) -Hessian matrix of $\tilde{\varphi}(u,y,\xi;x)$ has entries

$$\partial_{u_i}\partial_{\xi_j}\tilde{\varphi}(u,y,\xi;x) = 2t_0(\partial_{u_i}\omega_j(x,u) + \mathcal{O}(|x|^2) + \mathcal{O}(t_0)) \text{ for } 1 \le i,j \le n.$$
(44)

Consequently, from (41) and (44), the operator $\tilde{W}_{x,E}(\hbar) : C^{\infty}(M) \to C^{\infty}(\mathcal{B}^{n}(\varepsilon))$ has Schwartz kernel

$$\tilde{W}_{x,E}(\hbar)(u',y) = (2\pi\hbar)^{-n} \int_{\mathbb{R}^n} e^{i\tilde{\varphi}(u,y,\xi;x)/\hbar} \tilde{a}(u,\xi;x,\hbar) \, d\xi + R(\hbar)$$

with $R(\hbar)$ residual and for $|t_0|, \varepsilon > 0$ sufficiently small,

$$d_{u}d_{\xi}\tilde{\varphi}(u,y,\xi;x)| = 2^{n}|t_{0}|^{n} \cdot |(\partial_{u_{i}}\omega_{j}(x,u) + \mathcal{O}(|x|^{2}) + \mathcal{O}(t_{0}))_{1 \le i,j \le n}| \ge C|t_{0}|^{n}$$
(45)

locally and uniformly in $(u, y, \xi; x)$. From (45) and the Implicit Function Theorem, we conclude that the canonical relation of $\tilde{W}_{x,E}(\hbar) : C^{\infty}(M) \to C^{\infty}(\mathcal{B}^{n}(\varepsilon))$, given by

$$\Gamma_x = \{ (u, d_u \tilde{\varphi}; y, -d_y \tilde{\varphi}) \in T^*(\mathcal{B}^n(\varepsilon)) \times T^*M; \ d_\xi \tilde{\varphi} = 0 \}$$

= $\{ (u, d_u S; y, \xi) \in T^*(\mathcal{B}^n(\varepsilon)) \times T^*M; \ y = d_\xi S \}$ (46)

is a canonical graph for all $x \in B(x_0, \varepsilon)$ when $|t_0|, \varepsilon > 0$ are sufficiently small. From (46) it is clear that (y, ξ) can be chosen as local parametrizing variables for Γ_x .

Remark: We note that it is at this point that the specific form of the magnetic Hamiltionian $p(x, \xi, u)$ (42) is used to derive the required non-degeneracy of the phase function $\tilde{\varphi}$ in (45).

To determine the principal symbol $\sigma(\tilde{W}_{x,E}(\hbar))$, we compute the leading order term $a_0(u,\xi;x)$ in the amplitude of $\tilde{W}_{x,E}(\hbar)$. Writing $\varphi_t(x,y,\xi;u) = S(t,x,\xi;u) - \langle y,\xi \rangle$, it follows that $a_0(u,\xi;x) = a_{t_0}(x,\xi;u)$, where a_t solves the initial-value problem for the first transport equation

$$\begin{cases} \partial_t a_t - H_{p_u} a_t - \left[\frac{1}{2} \sum_{i,j} \frac{\partial^2 p_u}{\partial \xi_i \partial \xi_j} \cdot \frac{\partial^2 S}{\partial x_i \partial x_j} - i\sigma_{-1}(P_u)\right] a_t = 0\\ a_0 = \chi_E^{(0)} \text{ when } t = 0 \end{cases}$$

$$\tag{47}$$

on the Lagrangian $\Gamma_{\varphi_t} = \operatorname{graph}(G_u^t)$. For $|t_0|$ small, a standard method of characteristics argument gives the solution

$$a_{t_0}(x,\xi;u) = e^{i\int_0^{t_0}\sigma_{-1}(P_u)(G_u^t(x,\xi))dt} \cdot |\det d_x\pi \big(G_u^{t_0}(x,\xi)\big)|^{\frac{1}{2}} \cdot \chi_E^{(u)}(x,\xi),$$
(48)

where $G_u^{t_0}: T^*M \to T^*M$ is the time t_0 bicharacteristic flow generated by the magnetic Hamiltonian p_u and $\chi_E^{(u)}(x,\xi) = \chi_E^{(0)}(G_u^{t_0}(x,\xi))$.

The Leray density on Γ_x is

$$d_{C_{\tilde{\varphi}}} = \frac{|dudyd\xi|}{|d(d_{\xi}\tilde{\varphi})|} = \frac{|dudyd\xi|}{|d(y - d_{\xi}S(u,\xi;x,t_0))|} = |dud\xi|$$

In terms of coordinates $(u, \tau = d_u S(u, \xi; x, t_0))$ that parametrize the canonical graph Γ_x , we have

$$\sigma(\tilde{W}_{x,E}(\hbar))(u,\tau) = a_{t_0}(u,\xi;x) |d_u d_\xi S|^{-\frac{1}{2}} |du d\tau|^{1/2}$$

$$= e^{i \int_0^{t_0} \sigma_{-1}(P_u)(G_u^t(x,\xi))dt} \chi_E^{(u)}(x,\xi) \frac{|d_x \pi G_u^{t_0}(x,\xi)|^{1/2}}{|d_u d_\xi S|^{1/2}} |du d\tau|^{1/2}$$

$$= e^{i \int_0^{t_0} \sigma_{-1}(P_u)(G_u^t(x,\xi))dt} \chi_E^{(u)}(x,\xi) \frac{|d_x \pi G_u^{t_0}(x,\xi)|^{1/2}}{|d_u d_\xi S|^{1/2}} |dy d\xi|^{1/2}$$
(49)

for $(u, \tau; y, \xi) \in \Gamma_x$. The fact $|dyd\xi| = |dud\tau|$, which follows from the map $(y, \xi) \mapsto (u, \tau)$ with $(u, \tau; y, \xi) \in \Gamma_x$ being a symplectomorphism, is used in the last line of (49). We also note that in terms of geodesic normal coordinates in the ball $B(x_0, \varepsilon)$, the Hessian matrix,

$$(d_{u_i}d_{\xi_j}S)_{1 \le i,j \le n} = 2t_0(\partial_{u_i}\omega_j(x,u))_{1 \le i,j \le n} + \mathcal{O}(|x|^2) + \mathcal{O}(t_0)),$$

is non-degenerate for $(x, u) \in B(x_0, \varepsilon) \times \mathcal{B}^n(\varepsilon)$ and $t_0, \varepsilon > 0$ small by the admissibility assumption on the family of magnetic potentials $(\omega_u)_{u \in \mathcal{B}^n(\varepsilon)}$ in Definition 1.1. Hence, $\tilde{W}_{x,E}(\hbar) \in I^{0,-\infty}_{cl}(M \times \mathcal{B}^n(\varepsilon); \Gamma_x).$ The next corollary is an immediate consequence of Proposition 4.1 and the semiclassical Egorov theorem.

COROLLARY 4.2. Given $(x, u) \in B(x_0, \varepsilon) \times \mathcal{B}^n(\varepsilon)$ with $\varepsilon > 0$ small and $\hbar \in (0, \hbar_0]$, the operators

$$A_{x,E}(\hbar) := [\tilde{W}_{x,E}(\hbar)]^* \circ \tilde{W}_{x,E}(\hbar) \in \Psi^{0,-\infty}_{cl}(M),$$
(50)

and have principal symbol

$$\sigma_0(A_{x,E}(\hbar))(y,\eta) = |\chi_E^{(u(y,\eta))}(x,\eta)|^2 \frac{|d_x \pi G_{(u(y,\eta))}^{t_0}(x,\eta)|}{|d_u d_\eta S|}.$$
(51)

Since Γ_x is a canonical graph, we can write the points in (51) as $(u(y,\eta), \tau(y,\eta); y, \eta) \in \Gamma_x$ in terms of the (y,η) parametrizing coordinates.

Moreover, it is clear from the stationary phase argument used in the proof of the \hbar -Egorov theorem that the family of \hbar -pseudodifferential operators $A_{x,E}(\hbar)$ in Corollary 4.2 depends regularly and locally uniformly on the x-parameters in the sense that the total symbol $\sigma(A_{x,E})(y,\eta;\hbar)$ satisfies the local estimates

$$\|\sigma(A_{x,E})\|_{C^k} = \mathcal{O}_k(1) \tag{52}$$

uniformly for $x \in B(x_0, \varepsilon)$ and $\hbar \in (0, \hbar_0]$.

To finish the proof of Theorem 1.2, we note that in view of (5) and Corollary 4.2 with $x \in B(x_0, \varepsilon)$,

$$\int_{\mathcal{B}^{n}(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^{2} du = \int_{\mathcal{B}^{n}(\varepsilon)} |(W_{u,E}(\hbar)\varphi_{\hbar})(x)|^{2} du$$

$$= \langle \tilde{W}_{x,E}(\hbar)\varphi_{\hbar}, \tilde{W}_{x,E}(\hbar)\varphi_{\hbar} \rangle_{L^{2}(\mathcal{B}^{n}(\varepsilon))}$$

$$= \langle A_{x,E}(\hbar)\varphi_{\hbar}, \varphi_{\hbar} \rangle_{L^{2}(M)}.$$
(53)

Since $A_{x,E}(\hbar) \in \Psi_{cl}^{0,-\infty}(M)$ satisfies (52), by L²-boundedness (see (19)),

$$\langle A_{x,E}(\hbar)\varphi_{\hbar},\varphi_{\hbar}\rangle_{L^{2}(M)} \leq C_{\varepsilon}^{\prime\prime} \|\varphi_{\hbar}\|_{L^{2}(M)}^{2} = \mathcal{O}_{\varepsilon}(1)$$
 (54)

uniformly for $x \in B(x_0, \varepsilon)$.

To prove the lower bounds on $\int_{\mathcal{B}^n(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^2 du$, we note that for $|t_0|, \varepsilon > 0$ sufficiently small,

$$\frac{|d_x \pi G_u^{t_0}(x,\xi)|}{|d_u d_\xi S|} |\chi_E^{(u(y,\eta))}(x,\eta)|^2|_{p_0=E} \gtrsim \frac{|d_x \pi G_u^{t_0}(x,\xi)|}{|d_u d_\xi S|}|_{p_0=E} \gtrsim 1$$

Thus, from the symbol formula in (51),

$$\sigma_0(A_{x,E}(\hbar))(x,\xi)|_{p_0=E} \gtrsim 1.$$
(55)

In view of (55), the weak Garding inequality (20), and the mass concentration of the initial Schrödinger eigenfunctions $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ on $\{p_0 = E\}$ (22), we have for all $\hbar \in (0,\hbar_0]$ sufficiently small,

$$\langle A_{x,E}(\hbar)\varphi_{\hbar},\varphi_{\hbar}\rangle \gtrsim 1$$
 (56)

uniformly in $x \in B(x_0, \varepsilon)$. Substitution of (56) into the last line of (53) gives the lower bound in Theorem 1.2 uniformly for $x \in B(x_0, \varepsilon)$.

Since M is compact, we select a cover of finitely many small balls $B_j(x_0, \varepsilon)$ for j = 0, ..., Nand repeat the above analysis above in each ball using the admissibility assumption (1.1) to ensure that we can choose an *n*-tuple $(u_{i_1}, ..., u_{i_n})$ so that the non-degeneracy condition in (31) is satisfied in each ball, B_j . This finishes the proof of Theorem 1.2.

5. The quantum ergodic case

We assume here that (M, g) is a smooth, compact *n*-manifold and that the bicharacteristic flow of $p_0(x,\xi) = |\xi|_q^2 + V(x)$ on $p_0^{-1}(E)$ given by

$$G_0^t = \exp t H_{p_0} : p_0^{-1}(E) \to p_0^{-1}(E)$$

is ergodic. As before, we consider a sequence $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ of L^2 -normalized eigenfunctions of $P_0(\hbar) = -\hbar^2 \Delta_g^2 + V(x)$ with $P_0(\hbar)\varphi_{\hbar} = E(\hbar)\varphi_{\hbar}$ and $E(\hbar) = E + o(1)$ as $\hbar \to 0^+$. We say that the sequence $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ is quantum ergodic if for any $B(\hbar) \in \Psi_{cl}^{0,-\infty}(M)$,

$$\langle B(\hbar)\varphi_{\hbar},\varphi_{\hbar}\rangle_{L^{2}} \sim_{\hbar \to 0} c_{E} \int_{p_{0}^{-1}(E)} \sigma_{0}(B(\hbar))(x,\xi) \, d\omega_{E}$$
(57)

where $d\omega_E$ is Liouville measure and $c_E = (\operatorname{vol}_{\omega_E}(p_0^{-1}(E)))^{-1}$.

In the homogeneous case where $P_0(\hbar) = -\hbar^2 \Delta_g$ and E = 1, it is well-known that [CV, Sch, Z2] (57) is satisfied for a full asymptotic density of eigenfunctions. The question of whether the asymptotic identity in (57) holds for all eigenfunctions is referred to as quantum unique ergodicity [S2].

Let $(\varphi_{\hbar_{j_k}})_{k=1}^{\infty}$ be any subsequence of eigenfunctions with $\hbar_{j_k} \to 0$ and $k \to \infty$. One forms sequence of measures $d\mu_{\hbar_{j_k}} := |\varphi_{\hbar_{j_k}}(x)|^2 dvol(x)$ with the associated microlocal lifts $d\tilde{\mu}_{\hbar_{j_k}}$ defined by

$$d\tilde{\mu}_{\hbar_{j_k}}(a) := \langle Op_{\hbar_{j_k}}^{aw}(a)\varphi_{\hbar_{j_k}}, \varphi_{\hbar_{j_k}}\rangle_{L^2(M)},$$
(58)

where $a \in C^{\infty}(T^*M)$ and $Op_{\hbar}^{aw}(a)$ denotes the non-negative semiclassical anti-Wick quantization [Zw]. If the measures $d\tilde{\mu}_{\hbar_{j_k}}$ converge in the weak-* sense, one forms the associated weak-* limit

$$d\tilde{\mu} := w - \lim_{k \to \infty} d\tilde{\mu}_{\hbar_{j_k}}.$$
(59)

In the quantum ergodic case, our main result in Theorem 1.2 yields averaged pointwise asymptotics for the deformed eigenfunctions. We state the precise result here for future reference. In our case, we use the perturbed eigenfunctions $\varphi_{\hbar}^{(u)}$ to form the microlocally lifted measures

$$d\tilde{\mu}_{\hbar}^{(u)}(a) := \langle Op_{\hbar}^{aw}(a)\varphi_{\hbar}^{(u)}, \varphi_{\hbar}^{(u)}\rangle_{L^{2}(M)}.$$
(60)

The following is local in $x \in B(x_0, \varepsilon) \subset M$ and so, just as in Proposition 4.1, it suffices to assume that k = n.

THEOREM 5.1. Assume that $G_0^t : p_0^{-1}(E) \to p_0^{-1}(E)$ is ergodic and that $(\varphi_{\hbar})_{\hbar \in (0,\hbar_0]}$ is a quantum ergodic sequence of L^2 -normalized eigenfunctions of the Schrödinger operator $P_0(\hbar) = -\hbar^2 \Delta_g + V(x)$ with $P_0(\hbar) \varphi_{\hbar} = E(\hbar) \varphi_{\hbar}$ and $E(\hbar) = E + o(1)$. Then, under the same assumptions as in Theorem 1.2 on the magnetic Schrödinger operators $P_u(\hbar)$, it follows that (i) for all $u \in \mathcal{B}^n(\varepsilon)$ sufficiently small, the sequence $(\varphi_{\hbar}^{(u)})_{\hbar \in [0,\hbar_0]}$ is itself quantum ergodic up to a smooth density; that is,

$$w - \lim_{\hbar \to 0} d\tilde{\mu}_{\hbar}^{(u)} = \rho_u \, d\omega_{E,u},$$

where $d\omega_{E,u} = \frac{dxd\xi}{d(p_u - E)}$ is Liouville measure on $p_u^{-1}(E)$ and we write $d\omega_E = d\omega_{E,0}$ for short. Moreover, the density ρ_u is given by the Jacobian (i.e. the Radon-Nikodym derivative)

$$\frac{d((G_u^{t_0})^*\omega_E)}{d\omega_{E,u}}.$$

(ii) For $x \in B(x_0, \varepsilon)$, one has the averaged pointwise asymptotics

$$\int_{\mathcal{B}^n(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^2 \, du \sim_{\hbar \to 0^+} c_E \, \omega_{\infty}(x),$$

where

$$\omega_{\infty}(x) = \int_{p_0^{-1}(E)} \sigma_0(A_{x,E}(\hbar)) \, d\omega_E,$$

with $\sigma_0(A_{x,E}(\hbar))$ given in Corollary 4.2.

Proof. The proof of (i) is an easy consequence of the semiclassical Egorov theorem. Indeed, for $B(\hbar) \in \Psi_{cl}^{0,-\infty}(M)$ and any quantum ergodic sequence of φ_{\hbar} 's, the \hbar -Egorov theorem gives

$$\langle B(\hbar)\varphi_{\hbar}^{(u)},\varphi_{\hbar}^{(u)}\rangle_{L^{2}(M)} = \langle W_{u,E}(\hbar)^{*}B(\hbar)W_{u,E}(\hbar)\varphi_{\hbar},\varphi_{\hbar}\rangle_{L^{2}(M)}$$

$$\sim_{\hbar\to 0} c_{E} \int_{p_{0}^{-1}(E)} (G_{u}^{t_{0}})^{*}\sigma_{0}(B(\hbar))d\omega_{E}.$$

$$(61)$$

In (61), $G_u^t: T^*M \to T^*M$ denotes the time-*t* bicharacteristic flow of the magnetic Hamiltonian p_u . The flow-out $G_u^{t_0}: p_0^{-1}(E) \to G_u^{t_0}(p_0^{-1}(E))$ is a diffeomorphism onto its image. Moreover, since $dp_u \neq 0$ on the set $\{p_u = E\}$, it follows by Taylor expansion in *u* and the Implicit Function Theorem that for $\varepsilon > 0$ small, $p_u^{-1}(E)$ is diffeomorphic to $p_0^{-1}(E)$. Consequently, $p_u^{-1}(E)$ is diffeomorphic to $G_u^{t_0}(p_0^{-1}(E))$ and so, by (61) and the change of variables formula,

$$\langle B(\hbar)\varphi_{\hbar}^{(u)},\varphi_{\hbar}^{(u)}\rangle_{L^{2}(M)} \sim_{\hbar \to 0^{+}} c_{E} \int_{G_{u}^{t_{0}}(p_{0}^{-1}(E))} \sigma_{0}(B(\hbar)) d((G_{u}^{t_{0}})^{*}\omega_{E})$$

$$= c_{E} \int_{p_{u}^{-1}(E)} \sigma_{0}(B(\hbar)) \frac{d((G_{u}^{t_{0}})^{*}\omega_{E})}{d\omega_{E,u}} d\omega_{E,u}.$$

$$(62)$$

The proof of (ii) follows from Theorem 1.2 and (50), since for the quantum ergodic sequence of eigenfunctions $(\varphi_{\hbar})_{\hbar \in [0,\hbar_0]}$ and all $x \in M$, $A_{x,E}(\hbar) \in \Psi_{cl}^{0,-\infty}(M)$ with uniform symbolic C^k bounds. Consequently,

$$\int_{\mathcal{B}(\varepsilon)} |\varphi_{\hbar}^{(u)}(x)|^2 du = \langle A_{x,E}(\hbar)\varphi_{\hbar}, \varphi_{\hbar} \rangle_{L^2(M)}$$

$$\sim_{\hbar \to 0^+} c_E \int_{p_0^{-1}(E)} \sigma_0(A_{x,E}(\hbar)) d\omega_E.$$
(63)

The ergodic case will be discussed in more detail in [CJT].

6. Some Examples

In this section, we explicitly compute the averaged pointwise bounds in the case of the 1dimensional magnetic harmonic oscillator and the magnetic Laplacian on S^2 . Both examples have worst-case L^{∞} -blowup for the unperturbed eigenfunctions, φ_{\hbar} .

6.1. Harmonic Oscillator. Consider the 1-dimensional harmonic oscillator $P(x, \hbar D_x) = \frac{1}{2}(\hbar^2 D_x^2 + x^2)$ and the associated L^2 -normalized ground state eigenfunction $\varphi_{\hbar}(x) = (\pi \hbar)^{-\frac{1}{4}} e^{-\frac{x^2}{2\hbar}}$ with eigenvalue $\frac{\hbar}{2}$. This eigenfunction \hbar -microlocally concentrates near the critical point $p^{-1}(0) = \{(0,0)\}$. We show that the family of eigenfunctions $(\varphi_{\hbar}^{(u)})_{\hbar \in (0,\hbar_0]}$ corresponding to the magnetic perturbations with

$$P_u(x,\hbar D_x) = P(x,\hbar D_x - u) = \frac{1}{2}[(\hbar D_x - u)^2 + x^2]$$

satisfies the bounds in Theorem 1.2.

Following [GS, page 129] and utilizing the formulas in (48), one easily derives the generalized Mehler formula for the perturbed propagator $e^{-itP_u(\hbar)/\hbar}$ with $P_u(\hbar) = P(x, \hbar D_x - u)$. Explicitly,

$$e^{-itP_u(\hbar)/\hbar}(\varphi_{\hbar})(x) = \frac{1}{(2\pi\hbar)^{1/2}} \int_{\mathbb{R}} e^{i\Phi(t,x;\eta;u)/\hbar} a(t,x;\eta;u) \mathcal{F}_{\hbar}(\varphi_{\hbar})(\eta) d\eta.$$
(64)

Here, $\mathcal{F}_h(\varphi_h)(\eta)$ denotes the semiclassical Fourier transform $\frac{1}{(2\pi\hbar)^{1/2}} \int_{\mathbb{R}} e^{-iy\eta/\hbar} \varphi_{\hbar}(y) dy$ for $\varphi_h \in \mathcal{S}(\mathbb{R})$. The phase function is

$$\Phi(t, x, \eta; u) = -\frac{u^2 \sin t - 2\eta u \sin t + (x^2 + \eta^2) \sin t - 2xu \cos t + 2x(u - \eta)}{2 \cos t}, \qquad (65)$$

and $a(t, x, \eta; u) = |\cos t|^{1/2}$.

When u = 0 and $t \in (0, \pi)$ with $\hbar = 1$, the operators in (64) are elements of the unitary group generated by the standard harmonic oscillator (see [GS, p.129]). Our aim is to compute

$$I(\hbar, t, x) = \int_{-\varepsilon}^{\varepsilon} |e^{-itP_u(\hbar)/\hbar}(\varphi_{\hbar})(x)|^2 \, du,$$
(66)

where we fix $t = t_0 \in (0, \frac{\pi}{2})$ for the remainder of this computation. Since $\mathcal{F}_{\hbar}(\varphi_{\hbar})(\eta) = (\pi \hbar)^{-\frac{1}{4}} e^{-\frac{\eta^2}{2\hbar}}$, substitution in (64) gives

$$e^{-it_0 P_u(\hbar)/\hbar}(\varphi_{\hbar})(x) = \frac{1}{(2\pi\hbar)^{3/4}} \int_{\mathbb{R}} e^{\frac{i}{\hbar}[\Phi(t_0,x;\eta;u) + i\frac{\eta^2}{2}]} a(t_0,x,\eta;u) d\eta.$$
(67)

The solutions $\eta_c = \eta_c(x; u, t_0)$ of the critical point equation

$$d_{\eta}[\Phi + i\frac{\eta^2}{2}] = 0$$

are

$$\eta_c(x; u, t_0) = i(u \sin t_0 + x)e^{-it_0}$$

Since $\text{Im}\left[\Phi(t_0, x, \eta; u) + i\frac{\eta^2}{2}\right] = \frac{\eta^2}{2} \ge 0$, an application of steepest descent in (67) gives an asymptotic formula of the form

$$e^{-it_0 P_u(\hbar)/\hbar}(\varphi_{\hbar})(x) \sim_{\hbar \to 0^+} \hbar^{-\frac{1}{4}} c(t_0) e^{[\Phi_2(x;t_0,u) + i\Phi_1(x;t_0,u)]/\hbar}$$
(68)

where $c(t_0)$ is a non-zero constant depending only on t_0 , Im $\Phi_1 = 0$, and

$$\Phi_{2}(x; u, t_{0}) = -\operatorname{Im}\left(u\eta_{c} \tan t_{0} - \frac{\eta_{c}^{2}}{2} \tan t_{0} - \frac{x\eta_{c}}{\cos t_{0}} + i\frac{\eta_{c}^{2}}{2}\right)$$
$$= -\operatorname{Im}\left(\frac{1}{2}(\tan t_{0} + i)(u\sin t_{0} + x)^{2}\right) = -\frac{1}{2}(u\sin t_{0} + x)^{2}.$$
(69)

There is an analogous formula for Φ_1 , but it is irrelevant for our purposes. We substitute the WKB formula (68) into (66) and square the modulus of the integrand. Since $|e^{i\Phi_1/\hbar}| = 1$, the oscillatory factor in (68) drops out and one simply gets

$$I(\hbar, t_0, x) \sim \hbar^{-\frac{1}{2}} |c(t_0)|^2 \int_{-\varepsilon}^{\varepsilon} e^{-\frac{(u \sin t_0 + x)^2}{2\hbar}} du.$$
(70)

By steepest descent, the Laplace integral in (70) gives an additional factor of $\hbar^{1/2}$ and it follows that

$$I(\hbar, t_0, x) \sim |c(t_0)|^2 |\sin t_0|^{-1} \approx 1,$$
(71)

locally and uniformly in $x \in \mathbb{R}$, and (71) is consistent with Theorem 1.2.

Remark: Let $\mathcal{I} \subset \mathbb{R}$ be any closed interval containing $[-\varepsilon, \varepsilon]$. From (68) it is clear that for each $u \in (-\varepsilon, \varepsilon)$,

$$\sup_{x\in\mathcal{I}} |e^{-it_0 P_u(\hbar)/\hbar} \varphi_{\hbar}(x)| \sim \hbar^{-1/4}.$$

Consequently,

$$\int_{-\varepsilon}^{\varepsilon} \sup_{x \in \mathcal{I}} |e^{-it_0 P_u(\hbar)/\hbar} \varphi_{\hbar}(x)|^2 du \sim \hbar^{-1/2}$$

and so the L^{∞} -bounds of the deformed family of eigenfunctions $(\varphi_{\hbar}^{(u)})_{\hbar \in (0,\hbar_0]}$ are no better than those of the ground state eigenfunctions $\varphi_{\hbar}(x) = (\pi \hbar)^{-1/4} e^{-x^2/2\hbar}$. However, it is immediate from (71) that

$$\sup_{x \in \mathcal{I}} \int_{-\varepsilon}^{\varepsilon} |e^{-itP_u(\hbar)/\hbar} \varphi_{\hbar}(x)|^2 du \asymp 1.$$
(72)

6.2. Zonal harmonics on S^2 . We consider here the semiclassical Laplacian on the sphere $(S^2; round)$ with

$$P_0(\hbar) = -\hbar^2 \Delta_{S^2} = -\hbar^2 \left(\frac{1}{\sin^2(\varphi)} \frac{\partial^2}{\partial \varphi^2} + \frac{\partial^2}{\partial \theta^2}\right) - \hbar^2 \cot(\varphi) \frac{\partial}{\partial \varphi}.$$
(73)

where $(\theta, \varphi) \in [0, 2\pi] \times [0, \pi)$ denote usual spherical polar coordinates chosen so that $(z_1, z_2, z_3) \in S^2$ is given $z_1 = \cos \theta \cos \varphi, z_2 = \sin \theta \cos \varphi, z_3 = \sin \varphi$. Then, $x_1 = \varphi \cos \theta, x_2 = \varphi \sin \theta$ are the geodesic normal coordinates centered at the north pole (0, 0, 1) and we choose $\hbar^{-1} \in \{\sqrt{n(n+1)}\}_{n=1}^{\infty}$. In the following, we continue to denote the geodesic normal coordinates centered at $(0, 0, 1) \in S^2$ by $x = (x_1, x_2)$.

It is well-known that the L^2 -normalized zonal spherical harmonic of degree n is given by the formula

$$Z_n(x) = P_n(\cos|x|) = (2\pi n)^{1/2} \int_{-\pi}^{\pi} (\cos|x| + i\sin|x|\cos\tau)^n d\tau$$
(74)

saturates the maximal Hörmander sup bound at (0, 0, 1). Indeed it is obvious from (74) that $|Z_n(0)| = (2\pi)^{3/2} \sqrt{n} \sim \hbar^{-1/2}$.

The method of steepest descent can be applied in (74) away from the north and south poles, corresponding to $|x| = \varphi$ away from 0 and π , and one easily gets that

$$\sup_{|x|\geq\varepsilon} |Z_{\hbar}(x)| = \mathcal{O}_{\varepsilon}(1) \tag{75}$$

for $\hbar \in (0, \hbar_0]$. Hence, one can ignore this range where the eigenfunction is already uniformlybounded prior to deformation. Let $(Z_{\hbar}^{(u)})_{\hbar \in (0,\hbar_0]} := ((\exp -it_0 P_u(\hbar)/\hbar) Z_{\hbar})_{\hbar \in (0,\hbar_0]}$ be the deformed eigenfunctions where, for simplicity, we choose the (constant field) magnetic Schrödinger operators $P_u(\hbar) : C^{\infty}(S^2) \to C^{\infty}(S^2)$ with

$$P_u(\hbar) = (\hbar d_x + iu)^* (\hbar d_x + iu); \ u = u_1 dx_1 + u_2 dx_2.$$

We verify directly that

$$\int_{\mathcal{B}^2(\varepsilon)} |Z_{\hbar}^{(u)}(x)|^2 du \asymp 1 \tag{76}$$

uniformly for $x \in S^2$. In particular, when x corresponds to (0, 0, 1), the worst case eigenfunction blow-up is destroyed by averaging over the magnetic field $u = u_1 dx_1 + u_2 dx_2 \in \Omega^1(S^2)$. In view of (75) it suffices to assume that |x| = o(1) as $\hbar \to 0$ and we do so from now onward. We split the ball |x| = o(1) around the north pole into two pieces: Fix $\alpha \in (1/2, 1)$ and first suppose $|x| \geq \hbar^{\alpha}$. In that case, an application of steepest descent in (74) gives

$$Z_{\hbar}(x) \sim_{\hbar \to 0} \frac{e^{i|x|/\hbar} + e^{-i|x|/\hbar}}{\sqrt{\sin|x|}} \sim_{\hbar \to 0} \frac{e^{i|x|/\hbar} + e^{-i|x|/\hbar}}{\sqrt{|x|}}.$$
(77)

In the complementary range where $|x| \lesssim \hbar^{\alpha}$, we write the oscillatory integral (74) as

$$Z_{\hbar}(x) = (2\pi\hbar)^{-1/2} \int_{-\pi}^{\pi} \exp[\hbar^{-1}\log(\cos|x| + i\sin|x|\cos\tau)d\tau$$

$$\sim (2\pi\hbar)^{-1/2} \int_{-\pi}^{\pi} e^{i\sin|x|\cos\tau/\hbar}d\tau \sim (2\pi\hbar)^{-1/2} \int_{-\pi}^{\pi} e^{i|x|\cos\tau/\hbar}d\tau.$$
(78)

The last line of (78) follows by Taylor expansion of the phase function $\Phi(\tau; x) := \log(\cos |x| + i \sin |x| \cos \tau)$ around x = 0 using that $\cos |x| = 1 + \mathcal{O}(|x|^2)$ and $|x|^{-1} \sin |x| = 1 + \mathcal{O}(|x|^2)$. The change of variables $\tau \mapsto \tau - x$ in (78) and application of the cosine law implies that when $|x| \leq \hbar^{\alpha}$,

$$Z_{\hbar}(x) \sim (2\pi\hbar)^{-1/2} \int_{S^1} e^{i\langle x,\omega\rangle/\hbar} \, d\omega.$$
(79)

Here we write $d\omega = d\tau$ for arc-length measure. In view of (77), it follows by stationary phase in $\omega \in S^1$ that the same asymptotic formula (79) is also valid when $|x| \geq \hbar^{\alpha}$.

Substitution of (79) and the general formula for the small-time propagator $e^{it_0 P_u(\hbar)/\hbar}$ gives

$$Z_{\hbar}^{(u)}(x) \sim (2\pi\hbar)^{-5/2} \int_{\mathbb{R}^2} \int_{S^1} \int_{|y|<\varepsilon} e^{i\hbar^{-1}[\langle x-y,\xi\rangle-t_0|\xi+u|^2 + \mathcal{O}(t_0^2) + \mathcal{O}(|x|^2) + \langle y,\omega\rangle]} a(x,\xi,t_0) \, dy d\omega d\xi$$

$$= (2\pi\hbar)^{-5/2} \int_{\mathbb{R}^2} \int_{S^1} \int_{|y|<\varepsilon} e^{i\hbar^{-1}[\langle x,\xi\rangle - t_0|\xi + u|^2 + \mathcal{O}(t_0^2) + \mathcal{O}(|x|^2) + \langle y,\omega - \xi\rangle]} a(x,\xi,t_0) \, dy d\omega d\xi.$$
(80)

For $|x|, |t_0|$ sufficiently small, we apply stationary phase in (y, ξ) in (80) and get

$$Z_{\hbar}^{(u)}(x) \sim (2\pi\hbar)^{-1/2} \int_{S^1} e^{i\hbar^{-1}\Phi(x,\omega;t_0)} a(x,\omega,t_0) \, d\omega,$$
(81)

where $a(x, \omega, t_0) \approx 1$ and

$$\Phi(x,\omega,t_0) = \langle x,\omega \rangle - t_0 |\omega + u|^2 + \mathcal{O}(t_0^2 + |x|^2).$$
(82)

From (81), it follows that

$$\int_{\mathcal{B}^{2}(\varepsilon)} |Z_{\hbar}^{(u)}(x)|^{2} du \sim$$

$$(83)$$

$$(2\pi\hbar)^{-1} \int_{\mathcal{B}^{2}(\varepsilon)} \int_{S^{1}} \int_{S^{1}} e^{i\hbar^{-1}[\Phi(x,\omega,t_{0})-\Phi(x,\omega',t_{0})]} a(x,\omega,t_{0})a(x,\omega',t_{0}) d\omega d\omega' du_{1} du_{2}.$$

Writing $\omega = (\cos \tau, \sin \tau)$, the bound in (76) follows from (83) and an application of stationary phase in (u_1, τ) (or alternatively, (u_2, τ) depending on whether or not $\cos \tau = 0$). This is consistent with our main result.

Remark: We note from (81) that at the pole x = 0 itself,

$$Z_{\hbar}^{(u)}(0) \sim (2\pi\hbar)^{-1/2} \int_{S^1} e^{i\hbar^{-1}[-t_0|\omega+u|^2 + \mathcal{O}_u(t_0^2)]} a(0,\omega,t_0) \, d\omega$$
$$\sim (2\pi\hbar)^{-1/2} e^{i\hbar^{-1}t_0(1+|u|^2)} \int_{S^1} e^{-i\hbar^{-1}t_0[\langle\omega,u\rangle + \mathcal{O}_u(t_0)]} a(0,\omega,t_0) \, d\omega$$

Thus, it follows by an application of stationary phase in the last integral that for $|t_0| \ll \varepsilon$ and $\hbar \in (0, \hbar_0(\varepsilon)]$,

$$\sup_{|u| \ge \frac{\varepsilon}{2}} |Z_{\hbar}^{(u)}(0)| = \mathcal{O}_{\varepsilon}(1).$$

By a similar argument, one can show that for $\varepsilon > 0$ small and with large enough constant $C_0 > 0$,

$$\sup_{|x| \le \frac{\varepsilon}{C_0}} \sup_{|u| \ge \frac{\varepsilon}{2}} |Z_{\hbar}^{(u)}(x)| = \mathcal{O}_{\varepsilon}(1).$$
(84)

At present, we do not know whether such deterministic local supremum bounds for the family $(\varphi_{\hbar}^{(u)})_{\hbar \in (0,\hbar_0]}$ hold in greater generality.
