ON THE FOURIER EXPANSION OF WORD MAPS

ORI PARZANCHEVSKI AND GILI SCHUL

ABSTRACT. Frobenius observed that the number of times an element of a finite group is obtained as a commutator is given by a specific combination of the irreducible characters of the group. More generally, for any word w the number of times an element is obtained by substitution in w is a class function. Thus, it has a presentation as a combination of irreducible characters, called its Fourier expansion. In this paper we present formulas regarding the Fourier expansion of words in which some letters appear twice. These formulas give simple proofs for classical results, as well as new ones.

1. INTRODUCTION

Let w be a word in $\mathbf{F}_d = \mathbf{F}(x_1, \ldots, x_d)$, the free group on d generators. Given a finite group G, w induces a word map from $G^d = G \times \cdots \times G$ to G, defined by substitution: if $w = \prod_{j=1}^r x_{i_j}^{\varepsilon_j}$ (where $\varepsilon_j = \pm 1$), then the word map $w : G^d \to G$ is defined by $w(g_1, \ldots, g_d) = \prod_{j=1}^r g_{i_j}^{\varepsilon_j}$. For example, for $w = [x_1, x_2] = x_1 x_2 x_1^{-1} x_2^{-1}$, $w(g, h) = ghg^{-1}h^{-1}$. It is a classical question to understand the distribution which w induces on G, i.e., the function

$$N_{w}(g) = |w^{-1}(g)| = \#\{(g_{1}, \dots, g_{d}) \in G^{d} | w(g_{1}, \dots, g_{d}) = g\}$$

(some authors write $N_{w,G}$ to emphasis that this depends on G). The simple observation that N_w is a class function shows that one can write

$$N_w = \sum_{\chi \in \operatorname{Irr}(G)} N_w^{\chi} \cdot \chi$$

for unique $N_w^{\chi} \in \mathbb{C}$, where Irr (G) are the irreducible characters of G. The coefficients N_w^{χ} are called the *Fourier coefficients* of w with respect to G, and their study goes back to Frobenius [Fro96], who showed that $N_{[x_1,x_2]}^{\chi} = \frac{|G|}{\chi(1)}$ for any G. Since $\chi(1)$ divides |G|, this shows in particular that $N_{[x_1,x_2]}$ is itself a character of G. Several authors have noticed that Frobenius' argument generalizes to $N_{[x_1,y_1]}^{\chi} \cdots [x_k,y_k] = \left(\frac{|G|}{\chi(1)}\right)^{2k-1}$, and the Fourier expansions of other words were studied as well (see [Isa94, chapter 4], and more recent results in [Tam00, AV11]).

If w and w' are equivalent under Aut (\mathbf{F}_d), then $N_w \equiv N_{w'}$ for any G, so that one can always replace $w \in \mathbf{F}_d$ by $\varphi(w)$ for any $\varphi \in \text{Aut}(\mathbf{F}_d)$. If some letter x appears only once in w (either as x or as x^{-1} , but not both), then w is equivalent under Aut (\mathbf{F}_d) to the single letter x, and thus N_w is constant. In this paper we consider the next simplest case, in which some letter appears twice in w, either with the same sign or with different signs.

We say that x is a square in w if x appears twice in it, and x^{-1} does not, or vice versa. We say that x is dismissible in w if both x and x^{-1} appear in w, each of them only once. In this paper we present formulas regarding the Fourier coefficients of words with at least one square

or dismissible letter. The results in [Fro96, Tam00, AV11] are obtained as special cases of these formulas, and further cases and applications are shown in Section 2.

1.1. Statement of the results. It is well known that for any word $w \in \mathbf{F}_d$ and finite group G, the Fourier coefficients of w with respect to G can be obtained by summation over all substitutions of G's elements in w's letters:

$$N_w^{\chi} = \frac{1}{|G|} \sum_{\overline{x} \in G^d} \overline{\chi} \left(w \left(x_1, \dots, x_d \right) \right), \tag{1.1}$$

where \overline{x} stands for (x_1, \ldots, x_d) (for the proof see Proposition 1). We will show the following:

Theorem. Let w be a word in \mathbf{F}_d , G a finite group, and $\chi \in \operatorname{Irr}(G)$.

- (1) There is a formula for N_w^{χ} which involves summation only over the non-dismissible letters of w.
- (2) There is a formula for N_w^{χ} which involves the Frobenius-Schur indicator of χ (1.2), and summation only over the non-dismissible and non-square letters of w.

The Frobenius-Schur indicator of χ is

$$\mathcal{FS}_{\chi} = \begin{cases} 1 & \chi \text{ is afforded by a real representation} \\ -1 & \chi \text{ is real but not afforded by a real representation} \\ 0 & \chi \text{ is not real,} \end{cases}$$
(1.2)

and it is a classical fact that $\mathcal{FS}_{\chi} = N_{x^2}^{\chi}$ (see e.g. [Ser77, Proposition 39]).

The formulas obtained are the following:

(1) **Dismissible letters:** Let $w \in \mathbf{F}(x_1, \ldots, x_d, y_1, \ldots, y_n)$ be a word in which y_1, \ldots, y_n are dismissible letters. Define words $w_0, \ldots, w_{2n} \in \mathbf{F}(x_1, \ldots, x_d)$ by writing w as

$$w = w_0 \cdot y_{i_1}^{\pm 1} \cdot w_1 \cdot y_{i_2}^{\pm 1} \cdot \ldots \cdot w_{2n-1} \cdot y_{i_{2n}}^{\pm 1} \cdot w_{2n},$$

where any w_j may be the empty word 1. We define words $W_i \in \mathbf{F}(x_1, \ldots, x_d)$ as follows. For W_1 , start reading w from w_0 , and upon reaching a dismissible letter, jump to its inverse, and continue reading from there. When reaching the end of w, stop reading the word obtained so far is W_1 . Now, find the first w_j which has not been read yet, and start reading W_2 from it, again jumping from dismissible letters to their inverse. You finish reading W_2 upon reaching your starting point. Continuing in this manner, one obtains W_1, \ldots, W_r (where r = r(w)) - the process stops when all w_j have been read. Our formula then states that the Fourier expansion of w is given by

$$N_{w}^{\chi} = \frac{|G|^{n-1}}{\chi(1)^{n}} \sum_{\overline{x} \in G^{d}} \overline{\chi}(W_{1}(\overline{x})) \cdot \ldots \cdot \overline{\chi}(W_{r}(\overline{x})).$$
(1.3)

It may happen that d = 0 (if all letters are dismissible), in which case the summation is over the empty substitution, and

$$N_w^{\chi} = \frac{|G|^{n-1}}{\chi(1)^{n-r}}.$$
(1.4)

(2) Squares: Let $w = w_1 \cdot y \cdot w_2 \cdot y \cdot w_3 \in \mathbf{F}(x_1, \dots, x_d, y)$ where y does not appear in $w_1, w_2, w_3 \in \mathbf{F}(x_1, \dots, x_d)$. Then

$$N_w^{\chi} = \frac{|G|}{\chi(1)} \mathcal{FS}_{\chi} N_{w_1 w_2^{-1} w_3}^{\chi},$$

where in $N_{w_1w_2^{-1}w_3}^{\chi}$ we refer to $w_1w_2^{-1}w_3$ as a word in $\mathbf{F}(x_1,\ldots,x_d)$.

Example. To demonstrate the formula for dismissible letters, let

$$w = \underbrace{x_1}_{w_0} y_1 \underbrace{x_1 x_2}_{w_1} y_3 \underbrace{x_2 x_1}_{w_2} y_1^{-1} \underbrace{x_1^3}_{w_3} y_2 \underbrace{x_3^{-1}}_{w_4} y_3^{-1} \underbrace{x_3^2}_{w_5} y_2^{-1} \underbrace{x_3}_{w_6}$$

We obtain

$$W_1 = w_0 w_3 w_6 = x_1^4 x_3$$
$$W_2 = w_1 w_5 w_4 w_2 = x_1 x_2 x_3 x_2 x_1.$$

and thus

$$N_{w}^{\chi} = \frac{|G|^{2}}{\chi(1)^{3}} \sum_{x_{1}, x_{2}, x_{3} \in G} \overline{\chi}(x_{1}^{4}x_{3}) \overline{\chi}(x_{1}x_{2}x_{3}x_{2}x_{1}).$$

In the next section we demonstrate some applications of the formulas, including the results referred to earlier. Section 3 presents some preparatory results for the main theorems, which are proved in Section 4.

Remarks.

- (1) The ambient free group of w affects N_w . For example, for $w = xy \in F(x, y)$ we have $N_w \equiv |G|$ (for every finite G), but for $w = xy \in F(x, y, z)$ we have $N_w \equiv |G|^2$.
- (2) For 1 the empty word on zero letters, we have $N_1(g) = \delta_{g,e}$ and thus $N_1^{\chi} = \frac{\chi(1)}{|G|}$.
- (3) In order to keep things tidy we shall occasionally write w for $w(x_1, \ldots, x_d)$, where x_1, \ldots, x_d are elements of G. For example, we write (1.3) as

$$N_w^{\chi} = \frac{|G|^{n-1}}{\chi(1)^n} \sum_{\overline{x} \in G^d} \overline{\chi}(W_1) \cdot \ldots \cdot \overline{\chi}(W_r).$$

2. Corollaries and applications

We give now examples of applications and corollaries of the main formulas.

(1) Frobenius' formula: for the commutator

$$w = [y_1, y_2] = y_1 y_2 y_1^{-1} y_2^{-1} = w_0 y_1 w_1 y_2 w_2 y_1^{-1} w_3 y_2^{-1} w_4$$

we have d = 0, n = 2, and $w_0, ..., w_4 = 1$. This gives $W_1 = w_0 w_3 w_2 w_1 w_4 = 1$, so that r = 1, and thus by (1.4)

$$N_{[y_1,y_2]}^{\chi} = \frac{|G|}{\chi(1)}.$$

More generally, $w = [y_1, y_2] \cdot \ldots \cdot [y_{2k-1}, y_{2k}]$ gives d = 0, n = 2k, r = 1, and $W_1 = 1$, hence 2k - 1

$$N_{[y_1, y_2] \cdot \dots \cdot [y_{2k-1}, y_{2k}]}^{\chi} = \left(\frac{|G|}{\chi(1)}\right)^{2r}$$

(which can also be deduced from (3.1)).

(2) Let w_0, w_1 be words in $\mathbf{F}(x_1, \ldots, x_d)$ (not necessarily disjoint), and observe $w = w_0 y w_1 y^{-1}$. In this case $W_1 = w_0$ and $W_2 = w_1$, which gives

$$N_{w_0yw_1y^{-1}}^{\chi} = \frac{1}{\chi(1)} \sum_{\overline{x} \in G^d} \overline{\chi}(w_0) \overline{\chi}(w_1).$$

(3) For $w \in \mathbf{F}_d$, taking $w_0 = w$, $w_1 = w^{-1}$ in the previous example gives

$$N_{[w,y]}^{\chi} = \frac{1}{\chi(1)} \sum_{\overline{x} \in G^d} \overline{\chi}(w) \chi(w) = \frac{1}{|\chi(1)|} \sum_{g \in G} N_w(g) \overline{\chi}(g) \chi(g)$$
$$= \frac{|G|}{\chi(1)} \langle N_w \chi, \chi \rangle.$$
(2.1)

In terms of the Fourier expansion of N_w , we obtain

$$N_{[w,y]}^{\chi} = \frac{|G|}{\chi(1)} \sum_{\psi \in \operatorname{Irr}(G)} \langle \psi \chi, \chi \rangle N_w^{\psi}$$

which is (roughly) Lemma 4.6 in [AV11]. We shall return to this example in Proposition 2.

(4) Similarly, for $w_0 = w_1 = w$ we obtain

$$N_{wywy^{-1}}^{\chi} = \frac{1}{|\chi(1)|} \sum_{g \in G} N_w(g) \chi(g)^2 = \frac{|G|}{\chi(1)} \langle N_w \chi, \overline{\chi} \rangle.$$

$$(2.2)$$

(5) If $W_1, \ldots, W_r = 1$, then

$$N_w^{\chi} = \frac{|G|^{n-1}}{\chi(1)^n} \sum_{\overline{x} \in G^d} \overline{\chi}(W_1) \cdot \ldots \cdot \overline{\chi}(W_r) = \frac{|G|^{n+d-1}}{\chi(1)^{n-r}}$$
(2.3)

and the only question is what is r. In this case one can show that w is equivalent under Aut (\mathbf{F}_d) to a word w' in which all letters are dismissible (such a word is called *admis*sible). It is a classical observation that admissible words describe a relation defining the fundamental group of an orientable surface. Thus, w' is equivalent under Aut (\mathbf{F}_d) to a product of q disjoint commutators, where q is the genus of the surface it defines. Finding r amounts to finding this genus, as $g = \frac{n-r+1}{2}$. (6) For example, for the admissible words $w = y_1 y_2 \dots y_n y_1^{-1} y_2^{-1} \dots y_n^{-1}$ we obtain a result

from [Tam00]: for n odd we have

$$W_1 = w_0 w_{n+1} w_2 w_{n+3} w_4 \dots w_{n-1} w_{2n} = 1$$
$$W_2 = w_1 w_{n+2} w_3 w_{n+4} \dots w_{n-2} w_{2n-1} w_n = 1$$

so that r = 2 and $N_w^{\chi} = \frac{|G|^{n-1}}{\chi(1)^{n-2}}$. For *n* even,

$$W_1 = w_0 w_{n+1} w_2 w_{n+3} w_4 \dots w_{2n-1} w_n w_1 w_{n+2} w_3 w_{n+4} \dots w_{n-2} w_{2n-1} w_n = 1$$

covers all w_i , hence r = 1 and $N_w^{\chi} = \frac{|G|^{n-1}}{\chi(1)^{n-1}}$. (7) Combining (3) and (1) gives a formula for w = [[x, y], z]:

$$N_{[[x,y],z]}^{\chi} = \frac{|G|}{\chi(1)} \sum_{\psi \in \operatorname{Irr}(G)} \langle \psi \chi, \chi \rangle \, N_{[x,y]}^{\psi} = \frac{|G|^2}{\chi(1)} \sum_{\psi \in \operatorname{Irr}(G)} \frac{\langle \psi \chi, \chi \rangle}{\psi(1)}.$$

This formula was already obtained, using different methods, by Amit & Vishne [AV11]. In particular it implies that knowing the decomposition of tensor product of irreducible representation of G gives the Fourier expansion of [[x, y], z].¹ Continuing by induction gives the coefficients of $[[[x_1, x_2], x_3], \ldots, x_n]$, which can be presented in terms of matrix exponentiation (see [AV11]).

(8) Nested and non-nested squares: if $w = w_1 \cdot x \cdot w_2 \cdot x \cdot w_3 \cdot y \cdot w_4 \cdot y \cdot w_5$ where the w_i do not contain x and y (but are not necessarily disjoint), then

$$N_{w}^{\chi} = \frac{|G|}{\chi(1)} \cdot \mathcal{FS}_{\chi} \cdot N_{w_{1}xw_{2}xw_{3}w_{4}^{-1}w_{5}}^{\chi} = \frac{|G|^{2}}{\chi(1)^{2}} \cdot \mathcal{FS}_{\chi}^{2} \cdot N_{w_{1}w_{2}^{-1}w_{3}w_{4}^{-1}w_{5}}^{\chi}$$
$$= \frac{|G|^{2}}{\chi(1)^{2}} \cdot \delta_{\chi \in \mathbb{R}} \cdot N_{w_{1}w_{2}^{-1}w_{3}w_{4}^{-1}w_{5}}^{\chi}$$

where $\delta_{\chi \in \mathbb{R}}$ is one if χ is real and zero otherwise. For $w' = w_1 \cdot x \cdot w_2 \cdot y \cdot w_3 \cdot x \cdot w_4 \cdot y \cdot w_5$, however, we obtain

$$N_{w'}^{\chi} = \frac{|G|}{\chi(1)} \cdot \mathcal{FS}_{\chi} \cdot N_{w_1 x w_2 w_4^{-1} x^{-1} w_3^{-1} w_5}^{\chi}$$

in which x became dismissible, and by (1.3)

$$N_{w'}^{\chi} = \frac{|G|}{\chi(1)^2} \cdot \mathcal{FS}_{\chi} \sum_{\overline{x} \in G^d} \overline{\chi} \left(w_1 w_3^{-1} w_5 \right) \overline{\chi} \left(w_2 w_4^{-1} \right).$$

Had we taken $w'' = w_1 \cdot x \cdot w_2 \cdot y \cdot w_3 \cdot x^{-1} \cdot w_4 \cdot y \cdot w_5$, we would get

$$N_{w''}^{\chi} = \frac{|G|}{\chi(1)} \cdot \mathcal{FS}_{\chi} \cdot N_{w_1 x w_2 w_4^{-1} x w_3^{-1} w_5}^{\chi},$$

i.e. x became a square, and now

$$N_{w''}^{\chi} = \frac{|G|^2}{\chi(1)^2} \cdot \delta_{\chi \in \mathbb{R}} \cdot N_{w_1 w_4 w_2^{-1} w_3^{-1} w_5}^{\chi}.$$
 (2.4)

Notice that had we applied (1.3) to w'', we would have get

$$N_{w''}^{\chi} = \frac{1}{\chi(1)} \sum_{\substack{\overline{x} \in G^d \\ y \in G}} \overline{\chi}(w_1 w_4 y w_5) \overline{\chi}(w_2 y w_3)$$

which requires summation over more substitutions then (2.4). In general, squares are better taken care of before dismissible letters.

¹If this decomposition is given by $\chi_i \cdot \chi_j = \sum c_{i,j,k} \cdot \chi_k$, then $c_{i,j,k}$ are the Clebsch-Gordan coefficients of G. For $G = S_n$ they are also referred to as Kronecker coefficients, and for $G = \operatorname{GL}_n$ as Littlewood-Richardson coefficients.

(9) Denote $\{x, y\} \stackrel{def}{=} xyxy^{-1}$. By (2.2), or by (2.4), we have $N_{\{x,y\}}^{\chi} = \frac{|G|}{\chi(1)} \cdot \delta_{\chi \in \mathbb{R}}$. Comparing this with $N_{[x,y]}^{\chi} = \frac{|G|}{\chi(1)}$ we see that $N_{\{x,y\}} \equiv N_{[x,y]}$ iff all character of G are real. This happens iff every element of g is conjugate to its inverse, and it is an easy exercise that this in itself is equivalent to $N_{\{x,y\}} \equiv N_{[x,y]}$. However, when considering $w = \prod_{i=1}^{k} [x_i, y_i]$ and $w' = \prod_{i=1}^{k} \{x_i, y_i\}$, we have

$$N_{w}^{\chi} = \left(\frac{|G|}{\chi\left(1\right)}\right)^{2k-1} \qquad \text{and} \qquad N_{w'}^{\chi} = \left(\frac{|G|}{\chi\left(1\right)}\right)^{2k-1} \cdot \delta_{\chi \in \mathbb{R}}$$

(either by computing directly or by (3.1)). This shows that once more $N_w \equiv N_{w'}$ iff all characters are real, and this does not seem to be as simple to show directly.

(10) Similarly, applying (1.3) to $w = [a, b] d[a, c] d^{-1}$ and $w' = \{a, b\} d\{a, c\} d^{-1}$ gives

$$N_{w}^{\chi} = \frac{|G|^{2}}{\chi(1)^{3}} \sum_{g \in G} |\chi(g)|^{4}, \quad N_{w'}^{\chi} = \frac{|G|^{2}}{\chi(1)^{3}} \sum_{g \in G} (\chi(g))^{4}$$

which shows that $N_w \equiv N_{w'}$ iff $\chi(g) \in \mathbb{R} \cup i\mathbb{R}$ for every $\chi \in \operatorname{Irr}(G)$ and $g \in G$. We leave it as an exercise to find, for any $k \in \mathbb{N}$, words w, w' which induce the same distribution on G iff $\chi(g)^k \in \mathbb{R}$ for all $\chi \in \operatorname{Irr}(G)$ and $g \in G$.

(11) For a word with dismissible letters for which r(w) = 1, we obtain

$$N_{w}^{\chi} = \frac{|G|^{n-1}}{\chi(1)^{n}} \sum_{\overline{x} \in G^{d}} \overline{\chi}(W_{1}) = \frac{|G|^{n}}{\chi(1)^{n}} N_{W_{1}}^{\chi}.$$

Since r = 1, n is even (see Theorem 4), and we obtain by (3.1)

$$N_w^{\chi} = N_{[y_1, y_2] \cdot \dots \cdot [y_{n-1}, y_n] \cdot W_1}^{\chi}$$

In fact, one can show that w and $[y_1, y_2] \cdot \ldots \cdot [y_{n-1}, y_n] \cdot W_1$ are equivalent under Aut (\mathbf{F}_d) .

(12) More generally, the formula (1.3) can be interpreted in the context of tuples of word maps, as follows: for $w_1, \ldots, w_r \in \mathbf{F}_d$, we observe the tuple $\vec{\boldsymbol{w}} = (w_1, \ldots, w_r)$ as a word map $\vec{\boldsymbol{w}} : G^d \to G^r$, defined by

$$\vec{\boldsymbol{w}}(x_1,\ldots,x_d) = (w_1(\overline{x}),\ldots,w_r(\overline{x})),$$

and define

$$N_{\overrightarrow{\boldsymbol{w}}}\left(g_{1},\ldots,g_{r}\right) = \left|\left(\overrightarrow{\boldsymbol{w}}\right)^{-1}\left(\overline{g}\right)\right| = \sharp\left\{\overline{x}\in G^{d} \mid \overrightarrow{\boldsymbol{w}}\left(\overline{x}\right) = \overline{g}\right\}.$$

Though $N_{\overrightarrow{\boldsymbol{w}}}$ is not a class function on G^r , we can still observe the "Fourier coefficient" of $\eta \in \operatorname{Irr}(G^r)$,

$$N_{\vec{\boldsymbol{w}}}^{\eta} = \left\langle N_{\vec{\boldsymbol{w}}}, \eta \right\rangle = \frac{1}{\left|G\right|^{r}} \sum_{\overline{g} \in G^{r}} N_{\vec{\boldsymbol{w}}}\left(\overline{g}\right) \overline{\eta}\left(\overline{g}\right).$$

With this notation we find that if the dismissible letter formula for a word w produces W_1, \ldots, W_r , then for every $\chi \in Irr(G)$

$$N_{w}^{\chi} = \frac{|G|^{n-1}}{\chi(1)^{n}} \sum_{\overline{x} \in G^{d}} \overline{\chi}(W_{1}(\overline{x})) \cdot \ldots \cdot \overline{\chi}(W_{r}(\overline{x}))$$
$$= \frac{|G|^{n+r-1}}{\chi(1)^{n}} \cdot \frac{1}{|G|^{r}} \sum_{\overline{g} \in G^{r}} N_{\overrightarrow{\mathbf{W}}}(\overline{g}) \cdot \overline{\chi}(g_{1}) \cdot \ldots \cdot \overline{\chi}(g_{r})$$
$$= \frac{|G|^{n+r-1}}{\chi(1)^{n}} \left\langle N_{\overrightarrow{\mathbf{W}}}, \chi^{\otimes r} \right\rangle$$
$$= \frac{|G|^{n+r-1}}{\chi(1)^{n}} N_{\overrightarrow{\mathbf{W}}}^{\chi^{\otimes r}}.$$

where $\vec{\mathbf{W}} = (W_1, \dots, W_r).$

3. Preliminaries

The following proposition lists some simple facts about the Fourier expansions of word maps.

Proposition 1. Let G be a finite group, $w \in \mathbf{F}_d$, and $\chi \in \operatorname{Irr}(G)$.

(1) The coefficient of χ in N_w is given by

$$N_w^{\chi} = \frac{1}{|G|} \sum_{\overline{x} \in G^d} \overline{\chi}(w) = \frac{1}{|G|} \sum_{\overline{x} \in G^d} \overline{\chi}(w(x_1, \dots, x_d)).$$

- (2) The Fourier expansion of $N_{w^{-1}}$ is given by $N_{w^{-1}}^{\chi} = \overline{N_w^{\chi}}$. (3) If $w_1, w_2 \in \mathbf{F}_d$ are words with disjoint letters then

$$N_{w_1 \cdot w_2}^{\chi} = \frac{|G|}{\chi(1)} N_{w_1}^{\chi} N_{w_2}^{\chi}.$$
(3.1)

Proof.

(1) It is well known that Irr(G) is an orthonormal base for the space of class functions on G, endowed with inner product

$$\langle f_1, f_2 \rangle = \frac{1}{|G|} \sum_{g \in G} f_1(g) \overline{f_2(g)}.$$

Thus,

$$N_{w}^{\chi} = \langle N_{w}, \chi \rangle = \frac{1}{|G|} \sum_{g \in G} N_{w}(g) \overline{\chi}(g)$$
$$= \frac{1}{|G|} \sum_{g \in G} \sum_{\substack{\overline{x} \in G^{d} \text{ s.t.} \\ w(x_{1}, \dots, x_{d}) = g}} \overline{\chi}(g) = \frac{1}{|G|} \sum_{\overline{x} \in G^{d}} \overline{\chi}(w(x_{1}, \dots, x_{d})).$$

(2) This follows from

$$N_{w^{-1}}(g) = \overline{N_{w^{-1}}(g)} = \overline{N_w(g^{-1})} = \sum_{\chi \in \operatorname{Irr}(G)} \overline{N_w^{\chi}\chi(g^{-1})} = \sum_{\chi \in \operatorname{Irr}(G)} \overline{N_w^{\chi}\chi(g)}.$$

(3) We recall that the convolution of two class functions is defined by

$$(f_1 * f_2)(g) = \frac{1}{|G|} \sum_{h \in G} f_1(h) f_2(h^{-1}g)$$

and that for $\chi, \psi \in Irr(G)$

$$\psi * \chi = \frac{\delta_{\psi,\chi}}{\chi(1)} \cdot \chi \tag{3.2}$$

(see e.g. [Fol95, 5.20]). Using this, we see that

$$N_{w_{1} \cdot w_{2}}(g) = \sum_{h \in G} N_{w_{1}}(h) N_{w_{2}}(h^{-1}g)$$

$$= \sum_{h \in G} \left(\sum_{\chi \in \operatorname{Irr}(G)} N_{w_{1}}^{\chi} \cdot \chi(h) \right) \cdot \left(\sum_{\psi \in \operatorname{Irr}(G)} N_{w_{2}}^{\psi} \cdot \psi(h^{-1}g) \right)$$

$$= \sum_{\chi, \psi \in \operatorname{Irr}(G)} N_{w_{1}}^{\chi} \cdot N_{w_{2}}^{\psi} \cdot \left(\sum_{h \in G} \chi(h) \psi(h^{-1}g) \right)$$

$$= \sum_{\chi, \psi \in \operatorname{Irr}(G)} N_{w_{1}}^{\chi} \cdot N_{w_{2}}^{\psi} \cdot |G| \cdot (\chi * \psi) (g)$$

$$= \sum_{\chi, \psi \in \operatorname{Irr}(G)} N_{w_{1}}^{\chi} \cdot N_{w_{2}}^{\psi} \cdot \frac{|G|}{\chi(1)} \cdot \delta_{\chi, \psi} \chi(g)$$

$$= \sum_{\chi \in \operatorname{Irr}(G)} \frac{|G|}{\chi(1)} N_{w_{1}}^{\chi} N_{w_{2}}^{\chi} \chi(g) .$$

The next proposition already appears in [AV11] (as Lemma 4.6), and it was also shown in (2.1) to follow from the formula for dismissible letters (1.3). Nevertheless, we present here two proofs for it. The first is interesting in its own rights, and the second will be generalized to the proof of the formula (1.3), and serves as a warm-up.

Proposition 2. If y is a letter which does not appear in w, then

$$N_{[w,y]}^{\chi} = \frac{|G|}{\chi(1)} \langle N_w \chi, \chi \rangle = \frac{|G|}{\chi(1)} \sum_{\psi \in \operatorname{Irr}(G)} \langle \psi \chi, \chi \rangle N_w^{\psi}.$$

First proof. The column orthogonality of characters states that

$$\sum_{\chi \in \operatorname{Irr}(G)} \chi\left(g\right) \overline{\chi}\left(h\right) = \left|C_G\left(g\right)\right| \delta_{g \sim h} \qquad \text{where} \qquad \delta_{g \sim h} = \begin{cases} 1 & g^G = h^G \\ 0 & \text{else} \end{cases}$$

Thus,

$$\begin{split} N_{[w,y]}\left(g\right) &= \sum_{x \in G} N_w\left(x\right) \cdot \sharp \left\{y \in G | \ [x,y] = g\right\} \\ &= \sum_{x \in G} N_w\left(x\right) \cdot \sharp \left\{y \in G | \ yx^{-1}y^{-1} = x^{-1}g\right\} \\ &= \sum_{x \in G} N_w\left(x\right) \cdot \left|C_G\left(x^{-1}\right)\right| \cdot \delta_{x^{-1} \sim x^{-1}g} \\ &= \sum_{x \in G} N_w\left(x\right) \sum_{\chi \in \operatorname{Irr}(G)} \chi\left(x^{-1}\right) \overline{\chi}\left(x^{-1}g\right) \\ &= \sum_{x \in G} N_w\left(x\right) \sum_{\chi \in \operatorname{Irr}(G)} \overline{\chi}\left(x^{-1}\right) \chi\left(x^{-1}g\right) \quad \left(\operatorname{since} N_{[w,y]}\left(g\right) \in \mathbb{R}\right) \\ &= \sum_{\chi \in \operatorname{Irr}(G)} \sum_{x \in G} N_w\left(x\right) \chi\left(x\right) \chi\left(x^{-1}g\right) \\ &= \left|G\right| \sum_{\chi \in \operatorname{Irr}(G)} \left(N_w \chi * \chi\right)\left(g\right). \end{split}$$

By (3.2) and linearity, any class function f and $\chi \in Irr(G)$ satisfy

$$f * \chi = \frac{\langle f, \chi \rangle}{\chi (1)} \chi,$$

and for $f = N_w \chi$ this gives

$$N_{[w,y]}(g) = \sum_{\chi \in \operatorname{Irr}(G)} \frac{|G|}{\chi(1)} \langle N_w \chi, \chi \rangle \chi(g).$$

Second proof. We shall make use of the following classical theorem about compact groups:

Fact (Peter-Weyl). Let $\{\rho_s\}$ be unitary representatives for the isomorphism classes of the irreducible representations of G. Let $1 \le i, j \le \dim(\rho_s)$ and $1 \le k, l \le \dim(\rho_{s'})$. Then

$$\frac{1}{|G|} \sum_{g \in G} \rho_s \left(g\right)_{i,j} \overline{\rho_{s'}\left(g\right)_{k,l}} = \frac{\delta_{s,s'} \delta_{i,k} \delta_{j,l}}{\dim\left(\rho_s\right)}.$$
(3.3)

We assume $w \in \mathbf{F}_d = \mathbf{F}(x_1, \ldots, x_d)$, $[w, y] \in \mathbf{F}_{d+1} = \mathbf{F}(x_1, \ldots, x_d, y)$. Note that [w, y] and $[w, y]^{-1} = [y, w]$ are equivalent under Aut (\mathbf{F}_{d+1}) , so by Proposition 1 (2) all Fourier coefficients of [w, y] are real. Let ρ be a unitary representation which affords the character χ . By (1.1) we

have

$$\begin{split} N_{[w,y]}^{\chi} &= \overline{N_{[w,y]}^{\chi}} = \frac{1}{|G|} \sum_{\substack{x \in G^{d} \\ y \in G}} \chi \left(wyw^{-1}y^{-1} \right) = \frac{1}{|G|} \sum_{\substack{x \in G^{d} \\ y \in G}} \sum_{i=1}^{\dim \rho} \rho \left(wyw^{-1}y^{-1} \right)_{i,i} \\ &= \frac{1}{|G|} \sum_{\substack{x \in G^{d} \\ y \in G}} \sum_{i,j,k,\ell=1}^{\dim \rho} \rho \left(w \right)_{i,j} \rho \left(y \right)_{j,k} \rho \left(w^{-1} \right)_{k,\ell} \rho \left(y^{-1} \right)_{\ell,i} \\ &= \frac{1}{|G|} \sum_{\substack{x \in G^{d} \\ y \in G}} \sum_{i,j,k,\ell=1}^{\dim \rho} \rho \left(w \right)_{i,j} \rho \left(y \right)_{j,k} \overline{\rho \left(w \right)_{\ell,k} \rho \left(y \right)_{i,\ell}} \\ &\stackrel{(*)}{=} \frac{1}{\dim \rho} \sum_{\substack{x \in G^{d} \\ x \in G^{d}}} \sum_{i,j,k,\ell=1}^{\dim \rho} \rho \left(w \right)_{i,j} \overline{\rho \left(w \right)_{\ell,k}} \delta_{i,j} \delta_{k,\ell} \\ &= \frac{1}{\dim \rho} \sum_{\substack{x \in G^{d} \\ x \in G^{d}}} \sum_{i,k=1}^{\dim \rho} \rho \left(w \right)_{i,i} \overline{\rho \left(w \right)_{k,k}} \\ &= \frac{1}{\chi \left(1 \right)} \sum_{\substack{x \in G^{d} \\ x \in G^{d}}} \chi \left(w \right) \overline{\chi \left(w \right)} \\ &= \frac{1}{\chi \left(1 \right)} \sum_{\substack{x \in G^{d} \\ y \in G}} N_{w} \left(g \right) \chi \left(g \right) \overline{\chi \left(g \right)} \\ &= \frac{|G|}{\chi \left(1 \right)} \left\langle N_{w} \chi, \chi \right\rangle \end{split}$$

where (*) is by Peter-Weyl.

4. Proofs of the formulas

We begin by the formula for square letters.

Theorem 3. Let $w = w_1 y w_2 y w_3 \in \mathbf{F}(x_1, ..., x_d, y)$ with y a square, i.e. $w_1, w_2, w_3 \in \mathbf{F}(x_1, ..., x_d)$. Then

$$N_w^{\chi} = \frac{|G|}{\chi(1)} \mathcal{FS}_{\chi} N_{w_1 w_2^{-1} w_3}^{\chi},$$

where \mathcal{FS}_{χ} is the Frobenius-Schur indicator (1.2).

Proof. First, a word is always equivalent to its cyclic shifts under Aut (\mathbf{F}_d) , so that $N_w \equiv N_{yw_2yw_3w_1}$. Now applying the automorphism $x_i \mapsto x_i, y \mapsto yw_2^{-1}$, we obtain $N_w \equiv N_{y^2w_2^{-1}w_3w_1}$. Using (3.1) we have

$$N_{w}^{\chi} = N_{y^{2}w_{2}^{-1}w_{3}w_{1}}^{\chi} = \frac{|G|}{\chi(1)} N_{y^{2}}^{\chi} N_{w_{2}^{-1}w_{3}w_{1}}^{\chi} = \frac{|G|}{\chi(1)} \mathcal{FS}_{\chi} N_{w_{1}w_{2}^{-1}w_{3}}^{\chi}$$

where we recall that $\mathcal{FS}_{\chi} = N_{y^2}^{\chi}$ [Ser77, Proposition 39].

We move on to the formula for dismissible letters. We take $w \in \mathbf{F}(x_1, \ldots, x_d, y_0, \ldots, y_{n-1})$ to be a word with the y_i dismissible, and assume (by applying a cyclic shift if necessary) that w ends in some y_i^{\pm} .

Theorem 4. Let $w_0, \ldots, w_{2n-1} \in F(x_1, \ldots, x_d)$, and y_0, \ldots, y_{n-1} be new letters. Let z_0, \ldots, z_{2n-1} be a permutation of $y_0, \ldots, y_{n-1}, y_0^{-1}, \ldots, y_{n-1}^{-1}$, and let

$$w = w_0 z_0 w_1 z_1 \cdots w_{2n-1} z_{2n-1}.$$

Define a permutation $\tau \in Sym \{0, \ldots, 2n-1\}$ by $\tau(i) = j$ iff $z_i = z_j^{-1}$, and $\sigma \in Sym\{0, \ldots, 2n-1\}$ by $\sigma = (0 \ 1 \ 2 \ldots \ 2n-1) \circ \tau$ (i.e. $\sigma(k) = \tau(k) + 1 \pmod{2n}$). Let $\sigma = \prod_{s=1}^r \left(\sigma_1^s \sigma_2^s \ldots \sigma_{m_s}^s\right)$ be the decomposition of σ into disjoint cycles. Then $r \not\equiv n \pmod{2}$, and the Fourier expansion of N_w is given by

$$N_w^{\chi} = \frac{|G|^{n-1}}{\chi(1)^n} \sum_{(x_1,\dots,x_d)\in G^d} \left(\prod_{i=1}^r \overline{\chi}\left(\underbrace{\prod_{j=1}^{m_i} w_{\sigma_j^i}}_{W_i}\right)\right).$$

Proof. We strongly advise reading the second proof of Proposition 2 before going any further, as it is much more accessible and contains the main ideas of the proof.

First, we observe that

$$(-1)^r = (-1)^{2n-r} = \operatorname{sgn} \sigma = -\operatorname{sgn} \tau = -(-1)^n$$

and thus $r \not\equiv n \pmod{2}$. We shall write $i \boxplus j$ for $(i+j) \mod 2n$. We shall use the fact, already exploited in the second proof of Proposition 2, that for $\rho \in \widehat{G}$ and $1 \leq i, j, k, l \leq \dim \rho$,

$$\sum_{x \in G} \rho\left(y\right)_{i,j} \rho\left(y^{-1}\right)_{k,l} = \frac{|G|}{\dim \rho} \delta_{i,l} \delta_{j,k},\tag{4.1}$$

(this follows from $\rho(y^{-1})_{k,l} = \overline{\rho(y)_{l,k}}$ and the Peter-Weyl Theorem). By (1.1) we have

$$\begin{split} \overline{N_{w}^{\chi}(g)} &= \frac{1}{|G|} \sum_{\substack{x_{1},\dots,x_{d} \in G \\ y_{0},\dots,y_{n-1} \in G}} \chi\left(\prod_{j=0}^{2n-1} w_{j} z_{j}\right) = \frac{1}{|G|} \sum_{\substack{x_{1},\dots,x_{d} \in G \\ y_{0},\dots,y_{n-1} \in G}} \sum_{i=1}^{\dim \rho} \left(\prod_{j=0}^{2n-1} w_{j} z_{j}\right)_{i,i} = \\ &= \frac{1}{|G|} \sum_{\substack{x_{1},\dots,x_{d} \in G \\ y_{0},\dots,y_{n-1} \in G}} \sum_{\substack{k_{0},\dots,k_{2n-1}=1 \\ l_{0}\dots,l_{2n-1}=1}}^{2n-1} \prod_{j=0}^{2n-1} \rho\left(w_{j}\right)_{l_{j},k_{j}} \prod_{j=0}^{2n-1} \rho\left(z_{j}\right)_{k_{j},l_{j}\boxplus 1} \\ &= \frac{|G|^{n-1}}{\chi\left(1\right)^{n}} \sum_{x_{1},\dots,x_{d} \in G} \sum_{\substack{k_{0},\dots,k_{2n-1}=1 \\ l_{0}\dots,l_{2n-1}=1}}^{\dim \rho} \sum_{j=0}^{2n-1} \rho\left(w_{j}\right)_{l_{j},k_{j}} \prod_{j=0}^{2n-1} \delta_{k_{j},l_{\tau}(j)\boxplus 1} \delta_{l_{j}\boxplus 1,k_{\tau}(j)} \quad (by (4.1)) \\ &= \frac{|G|^{n-1}}{\chi\left(1\right)^{n}} \sum_{x_{1},\dots,x_{d} \in G} \sum_{\substack{k_{0},\dots,k_{2n-1}=1 \\ l_{0}\dots,l_{2n-1}=1}}^{\dim \rho} \sum_{j=0}^{2n-1} \rho\left(w_{j}\right)_{l_{j},k_{j}} \prod_{j=0}^{2n-1} \delta_{k_{j},l_{\sigma}(j)} \quad \left(\begin{array}{c} \operatorname{since} \tau\left(j\right)\boxplus 1 = \sigma\left(j\right) \\ \operatorname{and} \tau = \tau^{-1} \end{array} \right) \\ &= \frac{|G|^{n-1}}{\chi\left(1\right)^{n}} \sum_{x_{1},\dots,x_{d} \in G} \sum_{\substack{k_{0},\dots,k_{2n-1}=1 \\ l_{0}\dots,l_{2n-1}=1}}^{\dim \rho} \sum_{j=0}^{2n-1} \rho\left(w_{j}\right)_{l_{j},k_{j}} \prod_{j=0}^{2n-1} \delta_{k_{j},l_{\sigma}(j)} \quad \left(\begin{array}{c} \operatorname{since} \tau\left(j\right)\boxplus 1 = \sigma\left(j\right) \\ \operatorname{and} \tau = \tau^{-1} \end{array} \right) \\ &= \frac{|G|^{n-1}}{\chi\left(1\right)^{n}} \sum_{x_{1},\dots,x_{d} \in G} \sum_{\substack{k_{0}\dots,k_{2n-1}=1 \\ l_{0}\dots,l_{2n-1}=1}}^{\dim \rho} \rho\left(w_{j}\right)_{l_{j},l_{\sigma}(j)}} \end{array}$$

$$= \frac{|G|^{n-1}}{\chi(1)^n} \sum_{x_1, \dots, x_d \in G} \sum_{l_0, \dots, l_{2n-1}=1}^{\dim \rho} \prod_{s=1}^r \prod_{t=1}^{m_s} \rho\left(w_{\sigma_t^s}\right)_{l_{\sigma_t^s}, l_{\sigma}(\sigma_t^s)} \quad \left(\text{since } \{\sigma_t^s\}_{t=1..m_s}^{s=1..r} = \{1...n\}\right)$$

$$= \frac{|G|^{n-1}}{\chi(1)^n} \sum_{x_1, \dots, x_d \in G} \sum_{l_0, \dots, l_{2n-1}=1}^{\dim \rho} \prod_{s=1}^r \prod_{t=1}^m \rho\left(w_{\sigma_t^s}\right)_{l_{\sigma_t^s}, l_{\sigma_{t+1}(\text{mod } m_s)}}$$

$$= \frac{|G|^{n-1}}{\chi(1)^n} \sum_{x_1, \dots, x_d \in G} \sum_{l_{\sigma_0^1}, l_{\sigma_0^2}, \dots, l_{\sigma_0^n}=1}^r \prod_{s=1}^r \rho\left(\prod_{t=1}^m w_{\sigma_t^s}\right)_{l_{\sigma_0^s}, l_{\sigma_0^s}}$$

$$= \frac{|G|^{n-1}}{\chi(1)^n} \sum_{x_1, \dots, x_d \in G} \prod_{s=1}^r \chi\left(\prod_{t=1}^m w_{\sigma_t^s}\right).$$
