# The dimensions of The homomorphism spaces To INDECOMPOSABLE MODULES OVER THE FOUR SUBSPACE ALGEBRA

#### Abstract

This is the addendum to the paper [3]. We give here the full proof of [3, Proposition 3.3], describing the formulas for the dimensions of the homomorphism spaces to indecomposable modules over the four subspace algebra $\Lambda$. The reader can also find here the full description of indecomposable $\Lambda$-modules.


Introduction and preliminaries. We briefly recall the setting from [3]; for more details we refer to that article and also to $[1,2,4,5]$.

By $k$ we denote the fixed algebraically closed field and by $\mathbb{M}_{n \times m}$, the set of all $(n \times m)$-matrices over $k$, for $n, m \geq 0$ (we also consider the trivial matrices with zero rows or columns). Given $A \in \mathbb{M}_{m \times n}$, we denote by $\mathrm{r}(A)$ the $\operatorname{rank}$ of $A$ and by $\operatorname{cor}(A)=m-\mathrm{r}(A)$ its corank.

Let $Q$ be the quiver

(the set of vertices $\{0,1,2,3,4\}$ we denote by $Q_{0}$ ). The path algebra $\Lambda=k Q$ we call the four subspace algebra. Then any collection of matrices $(A, B, C, D) \in$ $\mathbb{M}_{n_{0} \times n_{1}} \times \mathbb{M}_{n_{0} \times n_{2}} \times \mathbb{M}_{n_{0} \times n_{3}} \times \mathbb{M}_{n_{0} \times n_{4}}, n_{i} \geq 0, i=0, \ldots, 4$, determines $\Lambda$-module (treated as the matrix representation of the quiver $Q$ ) of the form


Further on we will present $\Lambda$-modules as the quadruples $(A, B, C, D)$ as above. For $\Lambda$-module $M$, the dimension vector $\underline{\operatorname{dim}(M) \text { we will present in the form }}$

By $\tau=\tau_{\Lambda}$ we denote the Auslander-Reiten translate in the category $\bmod \Lambda$ of finite-dimensional $\Lambda$-modules.

We recall that all the indecomposable $\Lambda$-modules are divided into the following three families:

- postprojective modules of the form $P(m, j):=\tau^{-m} P(j)$, for all $m \geq 0, j \in$ $Q_{0}$, where $P(i)$ is the indecomposable projective $\Lambda$-module corresponding to the vertex $i$;

[^0]- preinjective modules of the form $I(m, j):=\tau^{m} I(j)$, for all $m \geq 0, j \in Q_{0}$, where $I(i)$ is the indecomposable injective $\Lambda$-module corresponding to the vertex $i$;
- regular modules forming a family of pairwise orthogonal stable standard tubes $\mathcal{T}_{\lambda}$ in Auslaned-Reiten quiver of the category $\bmod \Lambda$, for all $\lambda \epsilon$ $\mathbb{P}^{1}(k)$, where $\mathcal{T}_{0}, \mathcal{T}_{1}, \mathcal{T}_{\infty}$ are the tubes of rank 2 and the remaining are homogeneous. The modules from the tubes $\mathcal{T}_{\lambda}$, for $\lambda \in\{0,1, \infty\}$, are denoted by $R(s, l, \lambda)$, where $s \in \mathbb{Z}_{2}$ is the number of quasi-socle, $l \geq 1$ is quasi-length (that is, $R(s, l, \lambda)$ has quasi-length $l$, its quasi-socle is isomorphic to $R(s, 1, \lambda)$, and moreover $\left.\tau R(s, l, \lambda) \cong R\left(s \oplus_{2} 1, l, \lambda\right)\right)$. The modules from homogeneous tubes $\mathcal{T}_{\lambda}$, for $\lambda \in k \backslash\{0,1\}$, we denote by $R(l, \lambda)$, where $l \geq 1$ is quasi-length (in particular, $\tau R(l, \lambda)=R(l, \lambda))$.

The paper [3] deals with two natural problems: the multiplicity problem (the algorithm determining the multiplicities of all the indecomposables appearing in the indecomposable decomposition of $\Lambda$-module) and the isomorphism problem (the algorithmic criterion for deciding if two $\Lambda$-modules are isomorphic).

In the above considerations the crucial role is played by the direct formulas for computing the dimensions $[M, X]:=\operatorname{dim}_{k}\left(\operatorname{Hom}_{\Lambda}(M, X)\right)$ of homomorphism spaces from given $\Lambda$-module $M$ to arbitrary indecomposable $\Lambda$-module $X$. Such formulas were given in [3, Proposition 3.3]. The aim of this paper is to give the full proof of the proposition, which we recall below in 1 .

In the proof, given in 3, we use the matrix description of the indecomposable $\Lambda$-modules, which we recall in Proposition 2.

1. We recall below the assertion of [3, Proposition 3.3]. First we establish some notation. For the integers $x, y, x^{\prime}, y^{\prime}, u, v, s, t, i \geq 0$ with $u \leq x, v \leq y, y^{\prime}, s \leq x, x^{\prime}$, $t \leq y$ and the matrices $Z \in \mathbb{M}_{x \times y}, Z^{\prime} \in \mathbb{M}_{x^{\prime} \times y^{\prime}}, F \in \mathbb{M}_{u \times v}, E \in \mathbb{M}_{s \times t}$ we define the block matrices $\mathcal{M}_{1}^{i}=\mathcal{M}_{1}\left(Z, Z^{\prime}, F, i\right), \mathcal{M}_{2}^{i}=\mathcal{M}_{2}\left(Z, Z^{\prime}, E, i\right) \in \mathbb{M}_{\left(x^{\prime}+i x\right) \times\left(y^{\prime}+i y\right)}$ and $\mathcal{M}_{3}^{i}=\mathcal{M}_{3}\left(Z, Z^{\prime}, E, i\right) \in \mathbb{M}_{\left(x^{\prime}+i x\right) \times\left(y^{\prime}+(i+1) y\right)}$ as follows:

(the blocks $Z^{\prime}, E^{\prime \prime}, F^{\prime \prime}$ appear only once, the remaining coefficients are zero), where $F^{\prime}=\left[\begin{array}{cc}0 & F \\ 0 & 0\end{array}\right], E^{\prime}=\left[\begin{array}{cc}0 & 0 \\ E & 0\end{array}\right] \in \mathbb{M}_{x \times y}, F^{\prime \prime}=\left[\begin{array}{cc}0 & F \\ 0 & 0\end{array}\right] \in \mathbb{M}_{x \times y^{\prime}}$ and $E^{\prime \prime}=$ $\left[\begin{array}{ll}0 & 0 \\ E & 0\end{array}\right] \in \mathbb{M}_{x^{\prime} \times y}$. In particular, $\mathcal{M}_{1}^{0}=\mathcal{M}_{2}^{0}=Z^{\prime}$ and $\mathcal{M}_{3}^{0}=\left[Z^{\prime} \mid E^{\prime \prime}\right]$.

For $A \in \mathbb{M}_{x \times y}, B \in \mathbb{M}_{z \times t}$, by $A \oplus B$ we mean the matrix $\left[\begin{array}{cc}A & 0 \\ 0 & B\end{array}\right] \in \mathbb{M}_{(x+z) \times(y+t)}$.

Proposition. Let $M=(A, B, C, D)$ be a fixed $\Lambda$-module, with $A \in \mathbb{M}_{n_{0} \times n_{1}}$, $B \in \mathbb{M}_{n_{0} \times n_{2}}, C \in \mathbb{M}_{n_{0} \times n_{3}}, D \in \mathbb{M}_{n_{0} \times n_{4}}$. Then the formulae for the dimension $[M, X]$, for indecomposable $\Lambda$-module $X \in \mathcal{X}$, are given in the following table

In the proof of Proposition 1 we essentially use the matrix description of all the indecomposable modules over the four subspace algebra $\Lambda$, which we recall below (see $[4,5]$; note that in the description of indecomposables from the cited handbooks one can find some number of misprints and little errors, which sometimes caused that presented modules were decomposable; we corrected the description here).

For $m, n \geq 0$, by $0_{m \times n} \in \mathbb{M}_{m \times n}$ or $0_{n} \in \mathbb{M}_{n \times n}$ we denote the zero matrix and by $I_{n} \in \mathbb{M}_{n \times n}$, the identity matrix. Moreover we set

for $n \geq 0, \lambda \in k$, where the remaining coefficients are zero (note that $J_{n}(\lambda)$ is the upper-triangular Jordan block with eigenvalue $\lambda$ ).

Proposition. Let $\Lambda$ be the four subspace algebra. Then the fixed matrix representatives of all the isomorphism classes of indecomposable $\Lambda$-modules and their dimension vectors are given in the following table:

One proves the proposition using the standard arguments as in [5, 4].
Remark. Note that for any $l \geq 1$ we have $R(0,2 l, 0)=R(l, \lambda)$ if we substitute
$\lambda:=0$. One can also easily check that $R(1,2 l, 1)$ is isomorphic to $R(l, \lambda)$ with $\lambda:=1$. Therefore for every $\lambda \in k$ (not only for $\lambda \in k \backslash\{0,1\}$ ), the tube $\mathcal{T}_{\lambda}$ contains the indecomposable module $R(l, \lambda)$, for any $l \geq 1$.
3. Proof of Proposition 1. Let $M=(A, B, C, D)$ be a fixed $\Lambda$-module, with $A \in \mathbb{M}_{n_{0} \times n_{1}}, B \in \mathbb{M}_{n_{0} \times n_{2}}, C \in \mathbb{M}_{n_{0} \times n_{3}}, D \in \mathbb{M}_{n_{0} \times n_{4}}$. Recall [1] that for $\Lambda$-module $X=\left(A^{\prime}, B^{\prime}, C^{\prime}, D^{\prime}\right)$ with $A^{\prime} \in \mathbb{M}_{m_{0} \times m_{1}}, B^{\prime} \in \mathbb{M}_{m_{0} \times m_{2}}, C^{\prime} \in \mathbb{M}_{m_{0} \times m_{3}}, D^{\prime} \in \mathbb{M}_{m_{0} \times m_{4}}$, any $\Lambda$-homomorphism $F: M \rightarrow X$ is the collection $\left(F_{0}, F_{1}, F_{2}, F_{3}, F_{4}\right)$ of $k$ homomorphisms $F_{i}: k^{n_{i}} \rightarrow k^{m_{i}}, i \in Q_{0}$, satisfying the commutativity relations

(we identify $F_{i}$ with its matrix from $\mathbb{M}_{m_{i} \times n_{i}}$ given in the standard bases). So the dimension $[M, X]$ equals the dimension of the solution space of the system $(*)$ of linear equations with the matrices $F_{i}$ treated as variables. We calculate below these dimensions for every indecomposable $\Lambda$-module $X$. We use the description of indecomposables from Proposition 2.

Case 1: $X=P(n, 0) . P(0,0)$ is the projective $\Lambda$-module $P(0)=\left(\varepsilon_{1,0}, \varepsilon_{1,0}, \varepsilon_{1,0}\right.$, $\left.\varepsilon_{1,0}\right)$. So every homomorphism from $M$ to $P(0,0)$ is given by the collection $\left(F_{0}, F_{1}, F_{2}, F_{3}, F_{4}\right)=(y, 0,0,0,0), y \in \mathbb{M}_{1 \times n_{0}}$, such that $y A=0, y B=0, y C=$ $0, y D=0$ that is, satisfying the matrix equation $y\left[\begin{array}{lll}A & B & C\end{array}\right]=0$. Thus $[M, P(0,0)]=\operatorname{cor}([A B C D])$.

Now fix $n \geq 1$. Recall that $P(n, 0)=\left(\left[\begin{array}{c}I_{n} \\ 0_{n+1, n}\end{array}\right],\left[\begin{array}{c}0_{n+1, n} \\ I_{n}\end{array}\right],\left[\begin{array}{c}0_{1, n} \\ I_{n} \\ I_{n}\end{array}\right],\left[\begin{array}{c}I_{n} \\ \bar{I}_{n} \\ 0_{1, n}\end{array}\right]\right)$ (see Proposition 2). Observe that all the variables $s_{i}, t_{i}, u_{i}, w_{i}$ are determined by $y_{1}, \ldots, y_{2 n+1}$, so clearly the dimensions of the solution spaces for $(* *)^{1}$ and

Case 10: $X=I(2 n, i), i \in\{2,3,4\}$. The assertions for this case follow immediately from the case 9 , since the module $I(2 n, i)$, for $i \in\{2,3,4\}$, can be obtained from $I(2 n, i-1)$ after the cyclic permutation $(1,2,3,4)$ of vertices of the quiver $Q$ (see Proposition 2).

Case 11: $X=R(l, \lambda)$. For $l \geq 1$, every homomorphism from $M$ to $R(l, \lambda)$ is given by the collection of matrices $\left(F_{0}, F_{1}, F_{2}, F_{3}, F_{4}\right) \in \mathbb{M}_{2 l \times n_{0}} \times \mathbb{M}_{l \times n_{1}} \times \mathbb{M}_{l \times n_{2}} \times$ $\mathbb{M}_{l \times n_{3}} \times \mathbb{M}_{l \times n_{4}}$ satisfying the commutativity relations
$(*)^{11} \quad F_{0} A=\left[\begin{array}{c}I_{l} \\ 0_{l}\end{array}\right] F_{1}, \quad F_{0} B=\left[\begin{array}{c}0_{l} \\ I_{l}\end{array}\right] F_{2}, \quad F_{0} C=\left[\begin{array}{c}I_{l} \\ I_{l}\end{array}\right] F_{3}, \quad F_{0} D=\left[\begin{array}{c}J_{l}(\lambda) \\ I_{l}\end{array}\right] F_{4}$
(see (*) and Proposition 2). Let us denote by $y_{1}, \ldots, y_{l}, y_{l+1}, \ldots, y_{2 l}, s_{1}, \ldots, s_{l}$, $t_{1}, \ldots, t_{l}, u_{1}, \ldots, u_{l}$ and respectively $w_{1}, \ldots, w_{l}$, the consecutive rows of matrices $F_{0}, F_{1}, F_{2}, F_{3}, F_{4}$. So the system $(*)^{11}$ can be presented in the form

Since again all the variables $s_{i}, t_{i}, u_{i}, w_{i}$ are determined by $x_{1}, \ldots, x_{2 l}$, so clearly the dimensions of the solution spaces for $(* *)^{11}$ and $(* * *)^{11}$

are equal. One easily checks that the system $(* * *)^{11}$ is equivalent to the matrix equation

\end{array} y_{1} y_{l+1}\right] \cdot \mathcal{N}_{l}=0,

where $\mathcal{N}_{l}=\mathcal{M}_{2}\left(Z_{R(l, \lambda)}, Z_{R(l, \lambda)},-D, l-1\right)$ is the matrix from the assertion. Therefore the dimension $[M, R(l, \lambda)]$ is the dimension of the solution space of the above equation which equals $\operatorname{cor}\left(\mathcal{N}_{l}\right)$.

Case 12: $X=R(s, 2 l, \lambda), s \in \mathbb{Z}_{2}, \lambda \in\{0,1, \infty\}$. Observe that for every $l \geq 1$, $R(0,2 l, 0)$ is just the module $R(l, \lambda)$ for $\lambda:=0$ (see Proposition 2). So we obtain the assertion for $R(0,2 l, 0)$ immediately from the assertion for $R(l, \lambda)$ when we substitute $\lambda:=0$ (cf. case 11).

The assertions for the remaining modules in this case follow obviously from the above case of $R(0,2 l, 0)$ since the modules $R(s, 2 l, \lambda)$ can be obtained from $R(0,2 l, 0)$ after suitable permutation of the vertices of quiver $Q$ (see Proposition $2)$.

Case 13: $X=R(0,2 l-1,0)$. For $l \geq 1$, every homomorphism $F: M \rightarrow R(0,2 l-$ $1,0)$ is given by the collection $\left(F_{0}, F_{1}, F_{2}, F_{3}, F_{4}\right) \in \mathbb{M}_{(2 l-1) \times n_{0}} \times \mathbb{M}_{(l-1) \times n_{1}} \times \mathbb{M}_{l \times n_{2}} \times$ $\mathbb{M}_{(l-1) \times n_{3}} \times \mathbb{M}_{l \times n_{4}}$ satisfying the commutativity relations
$(*)^{13} \quad F_{0} A=\left[\begin{array}{c}I_{l-1} \\ 0_{1, l-1} \\ I_{l-1}\end{array}\right] F_{1}, \quad F_{0} B=\left[\begin{array}{c}{ }^{\circ} \pi_{l-1, l} \\ I_{l}\end{array}\right] F_{2}, \quad F_{0} C=\left[\begin{array}{c}I_{l-1} \\ 0_{l, l-1}\end{array}\right] F_{3}, \quad F_{0} D=\left[\begin{array}{c}0_{l-1, l} \\ I_{l}\end{array}\right] F_{4}$
(see ( $*$ ) and Proposition 2). Let us denote by $y_{1}, \ldots, y_{2 l-1}, s_{1}, \ldots, s_{l-1}, t_{1}, \ldots, t_{l}$, $u_{1}, \ldots, u_{l-1}$ and respectively $w_{1}, \ldots, w_{l}$, the consecutive rows of matrices $F_{0}, F_{1}$, $F_{2}, F_{3}, F_{4}$. Similarly as before, the variables $s_{i}, t_{i}, u_{i}, w_{i}$ are determined by $y_{1}, \ldots$, $y_{2 l-1}$, so clearly the dimensions of the solution spaces for $(*)^{13}$ and
$(* *)^{13}\left\{\begin{aligned} & y_{l} A=0 \\ & y_{1} A-y_{l+1} A=0 \\ & y_{2} A-y_{l+2} A=0 \\ & y_{l-1} A-y_{2 l-1} A \vdots \\ &=0\end{aligned} \quad\left\{\begin{array}{l}y_{1} B-y_{l} B=0 \\ y_{2} B-y_{l+1} B \\ =0 \\ y_{l-1} B-y_{2 l-2} B \\ =0\end{array} \quad\left\{\begin{array}{l}y_{l} C=0 \\ y_{l+1} C=0 \\ y_{2 l-1} C=0\end{array} \quad\left\{\begin{array}{r}y_{1} D=0 \\ y_{2} D=0 \\ y_{l-1} D=0\end{array}\right.\right.\right.\right.$
are equal.
One checks that the system $(* *)^{13}$ is equivalent to the matrix equation

$$

y_{l} & y_{1} & y_{l+1} & y_{2} & y_{l+2} & y_{3} & \ldots & y_{2 l-2} & y_{l-1}
\end{array} y_{2 l-1}\right] \cdot \mathcal{N}_{l}=0,

where $\mathcal{N}_{l}=\mathcal{M}_{2}\left(Z_{R(0,2 l-1,0)}, Z_{R(0,2 l-1,0)}^{\prime},-B, l-1\right)$. So the dimension $[M, R(0,2 l, 0)]$ equals $\operatorname{cor}\left(\mathcal{N}_{l}\right)$.

Case 14: $X=R(s, 2 l-1, \lambda), s \in \mathbb{Z}_{2}, \lambda \in\{0,1, \infty\}$ and $(s, \lambda) \neq(0,0)$. The assertions for this case follow immediately from the case 13 since the modules $R(s, 2 l-1, \lambda)$ can be obtained from $R(0,2 l-1,0)$ after suitable permutation of the vertices of quiver $Q$ (see Proposition 2).

We considered above all the cases of the assertion so the proof is finished.
Remark. Observe that all the matrices $\mathcal{M}_{\star}(-,-,-,-)$ appearing in the assertion of Proposition 1 have very specific, "almost block diagonal" shapes, which is essentially used in the paper [3] to decrease the computational complexity of considered algorithms. We obtained those shapes thanks to determining the right orders of the equations and the variables $y_{i}$ in the matrix equations in the proof above. Determining those orders was not always an easy task!
