# Besov regularity of the uniform empirical process

#### Abstract

The paths of Brownian motion have been widely studied in the recent years relatively in Besov spaces $B_{p, \infty}^{\alpha}$. The results are the same as to the Brownian bridge. In fact these regularities properties are established in some sequence spaces $S_{p, \infty}^{\alpha}$ using an isomorphisim between them and $B_{p, \infty}^{\alpha}$. In this note, we are concerned with the regularity of the paths of the continuous version of the uniform empirical process in the space $S_{p, \infty}^{\alpha}$ and in one of his separable sub space $S_{p, \infty}^{\alpha, 0}$ for a suitable choice of $\alpha$ and $p$.

## 1 Introduction

Let $U_{1}, U_{2}, \ldots, U_{n}, \ldots$ be a sequence of i.i.d $\mathcal{U}(0,1)$ random variables. For a fix integer $n \geq 1$ we consider the empirical distribution function $\widetilde{F}_{n}$ of the sample $U_{1}, U_{2}, \ldots, U_{n}$ defined by

$$
\forall 0 \leq s \leq 1, \quad \widetilde{F}_{n}(s)=\frac{1}{n} \sum_{i=1}^{n} 1_{(-\infty, s]}\left(U_{i}\right)
$$

and for $j \geq 0, k=1, \ldots, 2^{j}$ the triangular sequence

$$
\begin{equation*}
\widetilde{\alpha}_{j k}^{n}=2^{j / 2}\left[2 \widetilde{\alpha}_{n}\left(\frac{k-1 / 2}{2^{j}}\right)-\widetilde{\alpha}_{n}\left(\frac{k-1}{2^{j}}\right)-\widetilde{\alpha}_{n}\left(\frac{k}{2^{j}}\right)\right] \tag{1.1}
\end{equation*}
$$

where $\widetilde{\alpha}_{n}$ is the associated empirical process defined by $\widetilde{\alpha}_{n}(s)=\sqrt{n}\left(\widetilde{F}_{n}(s)-s\right), \quad 0 \leq s \leq 1$. Our motivation in the study of this sequence is given by previous works on the regularity of the paths of the Brownian motion in Besov spaces $B_{p, \infty}^{\alpha}$ given by

$$
B_{p, \infty}^{\alpha}=\left\{f \in L^{p}([0,1]): \sup _{t} \frac{w_{p}(f, t)}{t^{\alpha}}<\infty\right\}
$$

where for any $1 \leq p<\infty$,

$$
w_{p}(f, t)=\sup _{|h| \leq t}\left(\int_{I_{h}}|f(x-h)-f(x)|^{p} d x\right)^{1 / p} ; \quad I_{h}=\{x \in[0,1], x-h \in[0,1]\}
$$

The space $B_{p, \infty}^{\alpha}$ endowed with the following norm

$$
\|f\|_{p, \infty}^{\alpha}=\sup \left\{\left|f_{0}\right|,\left|f_{1}\right|, \sup _{j} 2^{-j(1 / 2-\alpha-1 / p)}\left(\sum_{k=1}^{2^{j}}\left|f_{j k}\right|^{p}\right)^{1 / p}\right\}
$$

where

$$
f_{0}=f(0), f_{1}=f(1)-f(0), \quad f_{j k}=2^{j / 2}\left[2 f\left(\frac{k-1 / 2}{2^{j}}\right)-f\left(\frac{k-1}{2^{j}}\right)-f\left(\frac{k}{2^{j}}\right)\right]
$$

is a Banach space.
It is well known thanks to Ciesielski et al [2], that there exists an isomorphism between such spaces and the Banach spaces of sequences $\left(S_{p, \infty}^{\alpha},\|\cdot\|_{p, \infty}^{\alpha}\right)$ defined by

$$
\left\{\mu=\left(\mu_{j k}, j \geq 0, k=1, \ldots, 2^{j}\right) /\|\mu\|_{p, \infty}^{\alpha}<\infty\right\}
$$

where

$$
\|\mu\|_{p, \infty}^{\alpha}=\sup \left\{\left|\mu_{0}\right|,\left|\mu_{1}\right|, \sup _{j} 2^{-j(1 / 2-\alpha-1 / p)}\left(\sum_{k=1}^{2^{j}}\left|\mu_{j k}\right|^{p}\right)^{1 / p}\right\} .
$$

Their subsets $B_{p, \infty}^{\alpha, 0}$ (respectively $S_{p, \infty}^{\alpha, 0}$ ) of functions $f \in B_{p, \infty}^{\alpha}$ (resp of sequences $\left(\mu_{j k}\right) \in S_{p, \infty}^{\alpha}$ ) such that $w_{p}(f, t)=\circ\left(t^{\alpha}\right)$ as $t \longrightarrow 0\left(\operatorname{resp} 2^{-j(1 / 2-\alpha-1 / p)}\left(\sum_{k=1}^{2^{j}}\left|\mu_{j k}\right|^{p}\right)^{1 / p} \longrightarrow 0\right.$ as $\left.j \longrightarrow \infty\right)$ are separable Banach spaces.
Thanks to this isomorphism, Roynette [4] proved that for $p \geq 2$ and $\alpha<1 / 2$, the Brownian path ( $W_{t}, 0 \leq t \leq 1$ ) belongs almost surely in $B_{p, \infty}^{\alpha}$ but not in $B_{p, \infty}^{\alpha, 0}$ by establishing

$$
\sup _{j}\left(2^{-j} \sum_{k=1}^{2^{j}}\left|g_{j k}\right|^{p}\right)^{1 / p}<\infty \text { and } \liminf _{j \rightarrow+\infty}\left(2^{-j} \sum_{k=1}^{2^{j}}\left|g_{j k}\right|^{p}\right)^{1 / p}>0
$$

where for all $j \geq 0$ and $k=1, \ldots, 2^{j}, \quad g_{j k}=2^{j / 2}\left[2 W\left(\frac{k-1 / 2}{2^{j}}\right)-W\left(\frac{k-1}{2^{j}}\right)-W\left(\frac{k}{2^{j}}\right)\right]$.
This result can be extended to the Brownian bridge $b_{t}=W_{t}-t W_{1}, t \in[0,1]$ which is closely related to the uniform empirical process. Moreover Komlós et al [3] show that on a suitable probability space $(, \mathcal{A}, \mathbf{P})$, there exists a sequence of i.i.d. $\mathcal{U}(0,1)$ random variables $U_{1}, U_{2}, \ldots$, and a sequence of Brownian bridges $\left\{b_{n}(t), 0 \leq t \leq 1\right\}$ such that almost surely

$$
\limsup _{n \longrightarrow+\infty} \frac{\sqrt{n}}{\log n} \sup _{0 \leq t \leq 1}\left|\alpha_{n}(t)-b_{n}(t)\right|<\infty
$$

Our aim is to investigate Roynette's result for the Brownian bridge to the continuous version of the empirical process. We successfully get a result for $1 \leq p \leq 2$ and $\alpha=1 / 2$.

## 2 Empirical process and Besov Spaces

In order to face to the lack of smoothness of the classical empirical process, we first recall the following result :

Lemma 2.1 For every $n \geq 1$, the empirical distibution process $\widetilde{\alpha}_{n}$ admits a continuous version $\alpha_{n}$.
Proof : It is well known one can express the distribution empirical function $\widetilde{F}_{n}(\cdot)$ in terms of the order statistics $U_{1}^{(n)} \leq U_{2}^{(n)} \leq \cdots \leq U_{n}^{(n)}$ of the sample $U_{1}, U_{2}, \ldots, U_{n}$ as follows

$$
\widetilde{F}_{n}(s)= \begin{cases}0, & U_{1}^{(n)}>s \\ \frac{k}{n}, & U_{k}^{(n)} \leq s<U_{k+1}^{(n)}, \quad k=1,2, \ldots, n-1 \\ 1, & U_{n}^{(n)} \leq s\end{cases}
$$

Let us consider the function $F_{n}(\cdot)$ defined for every $0 \leq s \leq 1$ by

$$
F_{n}(s)=\widetilde{F}_{n}\left(U_{k}^{(n)}\right)+2\left(s-\frac{U_{k}^{(n)}+U_{k+1}^{(n)}}{2}\right)\left(\frac{\widetilde{F}_{n}\left(U_{k+1}^{(n)}\right)-\widetilde{F}_{n}\left(U_{k}^{(n)}\right)}{U_{k+2}^{(n)}-U_{k}^{(n)}}\right)
$$

if

$$
\frac{U_{k}^{(n)}+U_{k+1}^{(n)}}{2} \leq s \leq \frac{U_{k+1}^{(n)}+U_{k+2}^{(n)}}{2}
$$

It is easy to see that for every $n \geq 1$,

$$
\begin{equation*}
\sup _{0 \leq s \leq 1}\left|F_{n}(s)-\widetilde{F}_{n}(s)\right| \leq \frac{1}{n} \tag{2.1}
\end{equation*}
$$

As a consequence of (2.1), we deduce that $F_{n}$ is a continuous version of $\widetilde{F}_{n}$ and the process $\alpha_{n}(s)=\sqrt{n}\left(F_{n}(s)-s\right), 0 \leq s \leq 1$ is a continuous version of the associated empirical process $\widetilde{\alpha}_{n}(s)=\sqrt{n}\left(\widetilde{F}_{n}(s)-s\right), 0 \leq s \leq 1$.

We are now in position to formulate our main results
Theorem 2.1 For every $n \geq 1$, the process $\alpha_{n}$ satisfy almost surely

$$
\left\{\alpha_{j k}^{n}\right\}_{j, k} \in S_{2, \infty}^{1 / 2} \quad \text { and } \quad\left\{\alpha_{j k}^{n}\right\}_{j, k} \notin S_{2, \infty}^{1 / 2,0}
$$

Proof : Let us consider the triangular sequence given by (1.1) (replacing $\widetilde{\alpha}_{n}$ by $\alpha_{n}$ ), we deduce thanks to the distribution empirical process that

$$
\forall j \geq 0, \forall k=1, \ldots, 2^{j}, \quad \alpha_{j k}^{n}=\frac{2^{j / 2}}{\sqrt{n}} \sum_{i=1}^{n} Z_{j k}(i)
$$

where

$$
\forall i=1, \ldots, n, \quad Z_{j k}(i)=Z_{j k}\left(U_{i}\right)=1_{\left[\frac{k-1}{2 j}, \frac{k-1 / 2}{2 j}[ \right.}\left(U_{i}\right)-1_{\left[\frac{k-1 / 2}{2 j}, \frac{k}{2 j}[ \right.}\left(U_{i}\right)
$$

Notice that for any $i=1, \ldots, n, \quad Z_{j k}(i) \in\{1,0,-1\}$ respectively with probability $\frac{k}{2^{j}}, 0, \frac{k}{2^{j}}$. We deduce that for any $i=1, \ldots, n, Z_{j k}(i)$ is centered random variable with variance $2^{-j}$.
Let us define $G_{j k}=\left|\alpha_{j k}^{n}\right|^{2}=\frac{2^{j}}{n} H_{j k}$ where $H_{j k}=\left(\sum_{i=1}^{n} Z_{j k}(i)\right)^{2}$.

Using the fact that for any fix $k$ and $i \neq h$ the random variables $Z_{j k}(i)$ and $Z_{j k}(h)$ are independent we deduce that

$$
\mathbf{E}\left(H_{j k}\right)=\mathbf{E}\left(\sum_{i=1}^{n} Z_{j k}^{2}(i)+\sum_{i \neq h}^{n} Z_{j k}(i) Z_{j k}(h)\right)=\frac{n}{2^{j}} .
$$

which implies in particular $\mathbf{E}\left(G_{j k}\right)=1$.
Futhermore for any $j \geq 0$ and $k=1, \ldots, 2^{j}$, we have

$$
\begin{aligned}
H_{j k}^{2} & =\left(\sum_{i=1}^{n} Z_{j k}^{2}(i)\right)^{2}+2 \sum_{l=1}^{n} Z_{j k}^{2}(l) \sum_{i \neq h}^{n} Z_{j k}(i) Z_{j k}(h)+\left(\sum_{i \neq h}^{n} Z_{j k}(i) Z_{j k}(h)\right)^{2} \\
& =\sum_{i=1}^{n} Z_{j k}^{4}(i)+2 \sum_{i<h}^{n} Z_{j k}^{2}(i) Z_{j k}^{2}(h)+2 \sum_{i \neq h}^{n} Z_{j k}^{2}(i) Z_{j k}^{2}(h)+A_{j k}^{(1)}+A_{j k}^{(2)}
\end{aligned}
$$

where for every $j \geq 0$ and $k=1, \ldots, 2^{j}$,

$$
A_{j k}^{(1)}=2 \sum_{l=1}^{n} \sum_{i \neq h}^{n} Z_{j k}^{2}(l) Z_{j k}(i) Z_{j k}(h) \text { and } A_{j k}^{(2)}=2 \sum_{l \neq m}^{n} \sum_{i \neq h}^{n} Z_{j k}(i) Z_{j k}(h) Z_{j k}(l) Z_{j k}(m)
$$

It is easy to see that for every $j \geq 0$ and $k=1, \ldots, 2^{j}, A_{j k}^{(1)}$ is a centered random variable and $A_{j k}^{(2)}$ satisfies

$$
\begin{aligned}
A_{j k}^{(2)} & =4 \sum_{i<h}^{n}\left[\sum_{l<m}^{n} Z_{j k}(i) Z_{j k}(h) Z_{j k}(l) Z_{j k}(m)\right] \\
& =4 \sum_{i<h}^{n}\left[\sum_{(l, m)=(i, h)} Z_{j k}(i) Z_{j k}(h) Z_{j k}(l) Z_{j k}(m)\right]+4 \sum_{i<h}^{n}\left[\sum_{(l, m) \neq(i, h)} Z_{j k}(i) Z_{j k}(h) Z_{j k}(l) Z_{j k}(m)\right]
\end{aligned}
$$

The expectation of the last sum vanish thanks to the independence of the random variables. Hence there exists a constant $c>0$ which may change from line to line such that $\mathbf{E}\left(A_{j k}^{(2)}\right)=$ $c \mathbf{E} \sum_{i<h}^{n} Z_{j k}^{2}(i) Z_{j k}^{2}(h)$. We deduce that for every $j \geq 0$ and $k=1, \ldots, 2^{j}$,

$$
\mathbf{E}\left(H_{j k}^{2}\right)=\sum_{i=1}^{n} \mathbf{E}\left(Z_{j k}^{4}(i)\right)+c \mathbf{E} \sum_{i<h}^{n} Z_{j k}^{2}(i) Z_{j k}^{2}(h)=\frac{n}{2^{j}}\left(1+c \frac{n-1}{2^{j}}\right)
$$

which implies in particular for every $j \geq 0$ and $k=1, \ldots, 2^{j}$,

$$
\operatorname{Var}\left(G_{j k}\right)=\frac{2^{j}}{n}\left[1+\frac{n(c-1)-c}{2^{j}}\right] .
$$

Elsewhere we have

$$
\begin{aligned}
\operatorname{Var}\left(\sum_{k=1}^{2^{j}} G_{j k}\right) & =\sum_{k=1}^{2^{j}} \operatorname{Var}\left(G_{j k}\right)+2 \sum_{1=k<k^{\prime} \leq 2^{j}} \frac{2^{2 j}}{n^{2}} \operatorname{cov}\left(H_{j k} H_{j k^{\prime}}\right) \\
H_{j k} H_{j k^{\prime}} & =\left(\sum_{i=1}^{n} Z_{j k}(i) Z_{j k^{\prime}}(i)+\sum_{i \neq h}^{n} Z_{j k}(i) Z_{j k^{\prime}}(h)\right)^{2}
\end{aligned}
$$

Notice that for $k \neq k^{\prime}$, the product $Z_{j k}(i) Z_{j k^{\prime}}(i)$ is null. This implies for every $j \geq 0$ and $k \neq k^{\prime} \in$ $\left\{1, \ldots, 2^{j}\right\}$,

$$
\begin{align*}
H_{j k} H_{j k^{\prime}} & =\left(\sum_{i \neq h}^{n} Z_{j k}(i) Z_{j k^{\prime}}(h)\right)^{2}=\sum_{i \neq h}^{n} \sum_{l \neq m}^{n} Z_{j k}(i) Z_{j k^{\prime}}(h) Z_{j k}(l) Z_{j k^{\prime}}(m)  \tag{2.2}\\
& =\sum_{\operatorname{card}\{i, h\} \cap\{l, m\}=2} Z_{j k}(i) Z_{j k^{\prime}}(h) Z_{j k}(l) Z_{j k^{\prime}}(m) \\
& +\sum_{\operatorname{card}\{i, h\} \cap\{l, m\}<2} Z_{j k}(i) Z_{j k^{\prime}}(h) Z_{j k}(l) Z_{j k^{\prime}}(m)
\end{align*}
$$

So two cases can be investigated :
if $\operatorname{card} d\{, h\} \cap\{l, m\}<2$, extracting one random variable $Z_{j k}(i)$, the expectation of the last term in (2.2) is null.
if $\operatorname{card}\{i, h\} \cap\{l, m\}=2$, we have either $(l=i$ and $m=h)$ or ( $l=h$ and $m=i$ ). In this last case the product is equal to zero. It remains

$$
\begin{aligned}
\mathbf{E}\left(H_{j k} H_{j k^{\prime}}\right) & =\sum_{i \neq h}^{n} \mathbf{E}\left[Z_{j k}^{2}(i) Z_{j k^{\prime}}^{2}(h)\right]=\frac{n(n-1)}{2^{2 j}} \\
\operatorname{Var}\left(\sum_{k=1}^{2^{j}} G_{j k}\right) & =\sum_{k=1}^{2^{j}} \frac{2^{j}}{n}\left(1+\frac{3 n-4}{2^{j}}\right)+2 \sum_{1=k<k^{\prime} \leq 2^{j}} \frac{2^{2 j}}{n^{2}}\left(\frac{n(n-1)}{2^{2 j}}-\left(\frac{n}{2^{j}}\right)^{2}\right) \\
& =2^{2 j} \varepsilon_{n j}, \quad \text { where } \quad \varepsilon_{n j}=\frac{1}{2^{j}}\left(3-\frac{3}{n}\right)
\end{aligned}
$$

Exploiting Bienaymé-Tchébychev inequality, we obtain the following estimate for every $n \in \mathbf{N}$ and

$$
\forall j \geq 0, \quad \mathbf{P}\left(\left.\left|2^{-j} \sum_{k=1}^{2^{j}}\right| \alpha_{j k}^{n}\right|^{2}-1 \left\lvert\, \geq \frac{1}{2}\right.\right) \leq 4 \varepsilon_{n j}
$$

Therefore thanks to Borel-Cantelli lemma, we deduce that for any $n \in \mathbf{N}$

$$
\frac{1}{2} \leq 2^{-j} \sum_{k=1}^{2^{j}}\left|\alpha_{j k}^{n}\right|^{2} \leq \frac{3}{2} \quad p . s, \quad j \text { large enough. }
$$

Hence

$$
\sup _{j}\left(2^{-j} \sum_{k=1}^{2^{j}}\left|\alpha_{j k}^{n}\right|^{2}\right)^{1 / 2}<\infty \quad \text { and } \quad \liminf _{j \longrightarrow+\infty}\left(2^{-j} \sum_{k=1}^{2^{j}}\left|\alpha_{j k}^{n}\right|^{2}\right)^{1 / 2}>0 \text { a.s. }
$$

## Remark:

1. Theses results show that for any $n$, the sequence $\left(\alpha_{j k}^{n}\right), j \geq 0, k=1, \ldots, 2^{j}$ belongs in the space $S_{2, \infty}^{1 / 2}$ and not in $S_{2, \infty}^{1 / 2,0}$ a.s.
2. The first result of our theorem can be extended to $1 \leq p \leq 2$ since the $L^{p}$ norm is incerasing in $p$.
