# Note on divisible difference sets from Galois rings GR(9, n)

#### Abstract

In this note, we give a new construction of divisible difference sets in  $\mathbb{Z}_9^n$  using Galois ring  $GR(3^2, n)$  under the assumption of the existence of skew Hadamard difference sets in  $\mathbb{F}_{3^n}$ .

Keywords: divisible difference set; skew Hadamard difference set

## 1 Introduction

We assume that the reader is familiar with the basic theory of difference sets as can found in [2].

Let G be an group of order v = mn. A k-subset of G is called a *divisible difference set* with parameters  $(m, n, k, \lambda, \mu)$  if the list of differences  $\{xy^{-1} | x, y \in D; x \neq y\}$  covers every element in  $G \setminus N$  exactly  $\mu$  times and the elements in  $N \setminus \{e\}$  exactly  $\lambda$  times, where N is a specified subgroup of G of order n. For detailed descriptions of divisible difference sets, see [13]. Also, for known constructions of divisible difference sets, see [3, 7, 9, 8, 10].

The definition of divisible difference sets immediately yields the group ring equation

$$DD^{(-1)} = k + \lambda(N - e) + \mu(G - N),$$

where  $D = \sum_{x \in D} x \in \mathbb{Z}[G]$  and  $D^{(-1)} = \sum_{x \in D} x^{-1}$ . We now restrict our attention to abelian groups. In this case, it is known [14] that D is a divisible difference set in G with parameters  $(m, n, k, \lambda, \mu)$  if and only if for any nontrivial character  $\chi$  of G

$$|\chi(D)| = \begin{cases} \sqrt{k-\lambda} & \text{if } \chi \text{ is nontrivial on } N; \\ \sqrt{k-\lambda+(\lambda-\mu)n} & \text{if } \chi \text{ is trivial on } N \text{ but nontrivial on } G \end{cases}$$

A difference set D in a group G is called *skew Hadamard* if G is the disjoint union of D,  $D^{(-1)}$ , and  $\{e\}$ . The primary example (and for many years, the only known example in abelian groups) of skew Hadamard difference sets is the classical Paley (quadratic residue) difference set in  $(\mathbb{F}_q, +)$  consisting of the nonzero squares of  $\mathbb{F}_q$ , where  $\mathbb{F}_q$  is the finite field

of order q, a prime power congruent to 3 modulo 4. In the case where G is an (additively written) abelian group of order v, it is known [14] that a subset D such that  $D \cup -D \cup \{0\}$  in G is a skew Hadamard difference set if and only if

$$\chi(D) = \frac{-1 \pm \sqrt{-v}}{2}$$

for any nontrivial character  $\chi$  of G.

Skew Hadamard difference sets are currently under intensive study, see [4, 5, 6, 11, 12, 16, 17]. There was a major conjecture in this area: Up to equivalence the Paley difference sets mentioned above are the only skew Hadamard difference sets in abelian groups. This conjecture turned out to be false: Ding and Yuan [4] constructed a family of skew Hadamard difference sets in ( $\mathbb{F}_{3^m}$ , +), where  $m \geq 3$  is odd, and showed that two examples in the family are inequivalent to the Paley difference sets. Very recently, Muzychuk [11] constructed infinitely many inequivalent skew Hadamard difference sets in an elementary abelian group of order  $q^3$ . Also, the author gave a construction of inequivalent skew Hadamard difference sets in  $\mathbb{F}_q$  using cyclotomic strongly regular graphs [12].

In this note, we give a new construction of divisible difference sets in the 3-groups  $\mathbb{Z}_9^n$  using Galois ring  $GR(3^2, n)$  under the assumption of the existence of skew Hadamard difference sets in  $\mathbb{F}_{3^n}$ .

## **2** Group characters of $GR(p^2, n)$

Let  $\mu_1: \mathbb{Z}/p^2\mathbb{Z} \to \mathbb{Z}/p\mathbb{Z}$  be the reduction map modulo p. We can extend  $\mu_1$  to  $(\mathbb{Z}/p^2\mathbb{Z})[x]$  in the natural way. Let f(x) be a primitive polynomial of degree n over  $\mathbb{F}_p$  and  $g(x) \in \mathbb{Z}/p^2\mathbb{Z}$ be preimage of f(x) under  $\mu_1$ . There is a unique g(x) whose root  $\xi$  satisfies  $\xi^{p^n-1} = 1$ . The ring  $\mathbb{R}_n = (\mathbb{Z}/p^2\mathbb{Z})(\xi)$  is an algebraic extension of  $\mathbb{Z}/p^2\mathbb{Z}$  of degree n, which is called a *Galois ring* and denoted by  $GR(p^2, n)$ . The ring  $GR(p^2, n)$  has the unique maximal ideal  $p\mathbb{R}_n = \{p\xi^i \mid 0 \le i \le p^n - 1\} \cup \{0\}$  and the residue class field  $\mathbb{R}_n/p\mathbb{R}_n$  is isomorphic to  $\mathbb{F}_{p^n}$ . We can take Teichmüller system  $\mathbb{T}_n = \{0, 1, \xi, \dots, \xi^{p^n-2}\}$  as a set of representatives of  $\mathbb{R}_n/p\mathbb{R}_n$ . An arbitrary element  $\alpha \in \mathbb{R}_n$  is uniquely determined by  $\alpha = \alpha_0 + p\alpha_1, \alpha_0, \alpha_1 \in \mathbb{T}_n$ . We denote the set of all invertible elements in  $\mathbb{R}_n$  by  $\mathbb{R}_n^*$ . Every element of  $\mathbb{R}_n^*$  is uniquely represented as  $\alpha_0(1 + p\alpha_1), \alpha_0 \in \mathbb{T}_n \setminus \{0\}, \alpha_1 \in \mathbb{T}_n$ .

The map  $\tau(\alpha) = \alpha_0$  is a homomorphism of  $\mathbb{R}_n$  into the cyclic group  $\mathbb{T}_n \setminus \{0\}$  and  $(\mathbb{P}_n :=) Ker(\tau)$ is the group of principal units, namely elements of the form  $1 + p\alpha_1 \in \mathbb{R}_n^*$ . The  $\tau$  is precisely given by  $\tau = \alpha^{p^n}$ . It is obvious that  $\overline{x} + \overline{y} = \overline{x + y} = \overline{\tau(x + y)}$  and  $\overline{x} \cdot \overline{y} = \overline{xy} = \overline{\tau(xy)}$  for any  $x, y \in \mathbb{R}_n$ , where  $\overline{x}$  means the residue class of  $\mathbb{R}_n / p\mathbb{R}_n$  containing x. The set of principal units has the structure of an elementary abelian group of order  $p^n$  and is isomorphic to the additive group of  $\mathbb{R}_n / p\mathbb{R}_n (\simeq \mathbb{F}_{p^n})$  via the map  $1 + p\alpha_1 \mapsto \overline{\alpha_1}$ . Thus,  $\mathbb{R}_n^*$  is a direct product of a cyclic group of order  $p^n - 1$  and an elementary abelian group of order  $p^n$ . Hereafter, we identify  $\mathbb{R}_n / p\mathbb{R}_n$  with  $\mathbb{F}_q$  and denote each element of  $\mathbb{R}_n / p\mathbb{R}_n$  and  $\mathbb{F}_q$  by  $\overline{a}$  in common.

The Frobenius map f from  $\mathbb{R}_n$  to  $\mathbb{R}_n$  is the ring automorphism  $f : \alpha_0 + p\alpha_1 \to \alpha_0^p + p\alpha_1^p$ ,  $\alpha_0, \alpha_1 \in \mathbb{T}_n$ . The set of elements of  $\mathbb{R}_n$  invariant under f is identical with  $\mathbb{Z}/p^2\mathbb{Z}$ . For  $\alpha \in \mathbb{R}_n$ , the trace function from  $\mathbb{R}_n$  to  $\mathbb{Z}/p^2\mathbb{Z}$  is defined by

$$\operatorname{Tr}_{\mathbb{R}_n}(\alpha) = \sum_{i=0}^{n-1} \alpha^{f^i}.$$

This is a linear function of  $\mathbb{R}_n$  into  $\mathbb{Z}/p^2\mathbb{Z}$ . The additive characters  $\phi_\beta$  of  $\mathbb{R}_n$  can be described by the trace function as follows:

$$\phi_{\beta}(\alpha) = \zeta_{p^2}^{\operatorname{Tr}_{\mathbb{R}_n}(\beta\alpha)} \text{ for any } \alpha \in \mathbb{R}_n,$$

where  $\zeta_k = \exp(\frac{2\pi i}{k})$ . The  $\phi_\beta$ 's for  $\beta \in \mathbb{R}_n$  give all additive characters of  $\mathbb{R}_n$ , see [15] for the proof.

A multiplicative character  $\psi$  of  $\mathbb{R}_n^*$  is defined by

$$\psi(\alpha\beta) = \psi(\alpha)\psi(\beta),$$

and each value of  $\psi(\alpha)$  is a  $p^n(p^n - 1)$ th root of unity. Let  $\psi_P$  denote a multiplicative character of  $\mathbb{R}_n$  trivial on  $\mathbb{T}_n \setminus \{0\}$ , which induces a character of  $\mathbb{P}_n$ . Also, let  $\psi_T$  denote a multiplicative character of  $\mathbb{R}_n$  trivial on  $\mathbb{P}_n$ , which induces a character of  $\mathbb{T}_n \setminus \{0\}$ . It is clear that any multiplicative character of  $\mathbb{R}_n$  is uniquely determined as a product  $\psi_P \psi_T$ . Put  $\alpha = a(1 + pb) \in \mathbb{R}_n^*$ . Obviously, the multiplicative character  $\psi_P = \psi_{P,\ell}$  for  $\ell \in \mathbb{T}_n$  of  $\mathbb{R}_n$  is given by

$$\psi_{P,\ell}(\alpha) = \psi_{P,\ell}(1+pb) = \chi_{\overline{\ell}}(\overline{b}),$$

where  $\chi_{\overline{\ell}}$  is an additive character of  $\mathbb{F}_{p^n}$  defined by

$$\chi_{\overline{\ell}} : \mathbb{F}_q \to \mathbb{C}^*, \quad \chi_{\overline{\ell}}(\overline{x}) = \zeta_p^{\operatorname{Tr}_{\mathbb{F}_q/\mathbb{F}_p}(\overline{\ellx})},$$

where  $\operatorname{Tr}_{q/p}$  is the trace from  $\mathbb{F}_q$  to  $\mathbb{F}_p$ . Also, the multiplicative character  $\psi_T = \psi_{T,m}$  for  $0 \leq m \leq p^n - 2$  of  $\mathbb{R}_n$  is given by

$$\psi_{T,m}(\alpha) = \psi_{T,m}(a) = \lambda_{q-1}^m(\overline{a}),$$

where  $\lambda_{q-1}$  is the multiplicative character of  $\mathbb{F}_{p^n}$  of order q-1 define by

$$\lambda_{q-1}: \mathbb{F}_q^* \to \mathbb{C}^*, \quad \lambda_{q-1}^m(\overline{\xi^s}) = \zeta_{q-1}^{sm}.$$

We extend the domain of  $\psi$  to all elements of  $\mathbb{R}_n$  by defining as  $\psi_{P,\ell}(\alpha) := 0$  for any  $\alpha \in p\mathbb{R}_n$ and any  $\ell \in \mathbb{T}_n$ , and as  $\psi_{T,m}(\alpha) := 0$  for any  $\alpha \in p\mathbb{R}_n$  and any  $1 \leq m \leq p^n - 2$ , and as  $\psi_{T,0}(\alpha) := 1$  for any  $\alpha \in p\mathbb{R}_n$ .

Hereafter, we use the following notations.

- $$\begin{split} \mathbb{R}_n &: \text{ the Galois ring } GR(p^2, n) \\ \mathbb{T}_n &: \text{ the Teichmüller system of } \mathbb{R}_n \\ \phi_1 &: \text{ the canonical additive character of } \mathbb{R}_n \\ \psi &: \text{ a multiplicative character of } \mathbb{R}_n \text{ such that } \psi = \psi_P \psi_T \\ \chi_{\overline{1}} &: \text{ the canonical additive character of } \mathbb{F}_{p^n} \\ \end{pmatrix} \\ & \rightarrow \text{ sumplimization shows that } f \mathbb{F}_n \end{split}$$
  - $\lambda$  : a multiplicative character of  $\mathbb{F}_{p^n}$

Similar to Gauss sums of  $\mathbb{F}_q$  [1], we can define Gauss sums of  $\mathbb{R}_n$ . For a multiplicative character  $\psi = \psi_P \psi_T$  and a nontrivial additive character  $\phi_\beta$  of  $\mathbb{R}_n$ , the sum

$$G(\phi_{\beta},\psi) = \sum_{\alpha \in \mathbb{R}_n} \phi_{\beta}(\alpha)\psi(\alpha)$$

is called a *Gauss sum* of  $GR(p^2, n)$ . Note that  $G(\phi_\beta, \psi) = \sum_{\alpha \in \mathbb{R}^*_n} \phi_\beta(\alpha) \psi(\alpha)$  by the definition of  $\psi$ .

## **3** Divisible difference sets over GR(9, n)

In the following, we compute the exact value of  $G(\phi_1, \psi)$ .

**Lemma 3.1.** Let  $\psi = \psi_{P,\ell}\psi_{T,m}$ . Then it holds that

$$G(\phi_1, \psi) = \begin{cases} 0 & \text{if } \psi_{P,\ell} \text{ is trivial;} \\ p^n \phi_1(c) \psi_{T,m}(c) & \text{otherwise,} \end{cases}$$

where  $c \in \mathbb{T}_n \setminus \{0\}$  is determined by  $\overline{c} = \overline{-\ell}$  in  $\mathbb{F}_{p^n}$ .

**Proof:** By the definition of  $G(\phi_1, \psi)$ , it holds that

$$G(\phi_1, \psi) = \sum_{\alpha = a(1+pb) \in \mathbb{R}_n^*} \phi_1(\alpha)\psi(\alpha)$$
  
= 
$$\sum_{a \in \mathbb{T}_n \setminus \{0\}} \sum_{b \in \mathbb{T}_n} \phi_1(a(1+pb))\psi_{P,\ell}(1+pb)\psi_{T,m}(a)$$

Since

$$\phi_1(a(1+pb)) = \zeta_{p^2}^{\operatorname{Tr}_{\mathbb{R}_n}(a+pab)} = \zeta_{p^2}^{\operatorname{Tr}_{\mathbb{R}_n}(a)} \zeta_{p^2}^{p\operatorname{Tr}_{\mathbb{F}_{p^n}}(ab)} = \phi_1(a)\chi_{\overline{1}}(\overline{ab}),$$

we have

$$G(\phi_1, \psi) = \sum_{a \in \mathbb{T}_n \setminus \{0\}} \sum_{b \in \mathbb{T}_n} \phi_1(a) \chi_{\overline{1}}(\overline{ab}) \chi_{\overline{1}}(\overline{b\ell}) \psi_{T,m}(a)$$
  
$$= \sum_{a \in \mathbb{T}_n \setminus \{0\}} \phi_1(a) \psi_{T,m}(a) \sum_{\overline{b} \in \mathbb{F}_{p^n}} \chi_{\overline{1}}((\overline{a+\ell})\overline{b})$$
  
$$= \begin{cases} 0 & \text{if } \ell = 0; \\ p^n \phi_1(c) \psi_{T,m}(c) & \text{otherwise,} \end{cases}$$

where  $c \in \mathbb{T}_n$  is determined by  $\overline{c} = \overline{-\ell}$  in  $\mathbb{F}_{p^n}$ .

**Theorem 3.2.** Let p = 3 and n be an odd integer. Furthermore, let  $b \in \mathbb{T}_n \setminus \{0\}$  such that  $\operatorname{Tr}_{\mathbb{F}_q/\mathbb{F}_p}(\overline{b}) \neq 0$  and C be a skew Hadamard difference set in  $\mathbb{F}_q$ . Then, the set  $D = \{x(1 + py) \mid \overline{x} \in C, y \in T_{b,0}\} \leq \mathbb{R}_n^*$  forms a  $(3^n, 3^n, \frac{3^{n-1}(3^n-1)}{2}, \frac{3^{n-1}(3^{n-1}-1)}{2}, \frac{3^{n-1}(3^{n-1}-1)}{4})$  divisible difference set in  $\mathbb{R}_n$  relative to  $p\mathbb{R}_n$ , where

$$T_{b,i} = \{ x \in \mathbb{T}_n \, | \, \operatorname{Tr}_{\mathbb{F}_q/\mathbb{F}_p}(\overline{bx}) = i \}.$$

**Proof:** It is clear that the parameters  $v = |\mathbb{R}_n|, n = |p\mathbb{R}_n|, k = \frac{3^{n-1}(3^n-1)}{2}, \mu = \frac{3^{n-1}(3^{n-1}-1)}{2}, \lambda = \frac{3^{n-1}(3^{n-1}-1)}{4}$  satisfy the equation

$$(v-n)\lambda + (n-1)\mu = k(k-1).$$

We prove that

$$|\phi_1(aD)| = \begin{cases} \frac{3^{n-1}\sqrt{1+3^n}}{2} & \text{if } a \in p\mathbb{R}_n^*;\\ 3^{n-1} & \text{if } a \in \mathbb{R}_n^*. \end{cases}$$

(i) For  $a \in p\mathbb{R}_n^*$ , write  $a = p\xi^r$ . Note that  $\phi_1(p\xi^r) = \chi_{\overline{1}}(\overline{\xi^r})$  and  $\sum_{\overline{x}\in C}\chi_{\overline{1}}(\overline{\xi^r x}) = \frac{-1\pm\sqrt{-3^n}}{2}$  by the definition of C. Hence, we have

$$\phi_1(aD) = |T_{b,0}| \cdot \sum_{\overline{x} \in C} \chi_{\overline{1}}(\overline{\xi^r x}) = \frac{3^{n-1}(-1 \pm \sqrt{-3^n})}{2},$$

which implies that  $|\phi_1(aD)| = \frac{3^{n-1}\sqrt{1+3^n}}{2}$ .

(ii) For  $a \in \mathbb{R}_n^*$ , write  $a = \xi^s (1 + p\xi^r)$ . By the orthogonality of characters,

$$\phi_1(aD) = \frac{1}{q(q-1)} \sum_{\psi \in \widehat{\mathbb{R}_n^*}} G(\phi_1, \psi^{-1}) \psi(aD)$$
$$= \frac{1}{3(q-1)} \sum_{\psi \in H} \sum_{x \in D} G(\phi_1, \psi^{-1}) \psi(ax)$$

where H is the subgroup of  $\widehat{\mathbb{R}}_n^*$ , the character group of  $\mathbb{R}_n^*$ , such that each of H is trivial on  $\{a(1+pb) \mid a \in \mathbb{T}_n \setminus \{0\}, b \in T_{b,0}\}$ . The  $\psi(ax)$  for  $\psi \in H$  and  $x = \xi^y(1+p\xi^z) \in D$  can be written as  $\lambda_{q-1}^m(\overline{\xi^s\xi^y})\chi_{\overline{b}}(\overline{c\xi^r})$  for some  $m \in \{0, 1, \ldots, q-2\}$  and  $\overline{c} \in \mathbb{F}_3$ . Hence, by Lemma 3.1, we have

$$|\phi_1(aD)| = \frac{3^{n-1}}{q-1} \cdot \left| \phi_1(1)\chi_{\overline{b}}(\overline{\xi^r}) \left( \sum_{m=0}^{q-2} \lambda_{q-1}^m(\overline{\xi^s}C) \right) + \phi_1(\xi^{\frac{3^n-1}{2}})\chi_{\overline{b}}(\overline{-\xi^r}) \left( \sum_{m=0}^{q-2} \lambda_{q-1}^m(-\overline{\xi^s}C) \right) \right|. \tag{1}$$

Since C is skew Hadamard, either one of  $\sum_{m=0}^{q-2} \lambda_{q-1}^m(\overline{\xi^s}C)$  or  $\sum_{m=0}^{q-2} \lambda_{q-1}^m(-\overline{\xi^s}C)$  is zero and another is q-1, the (1) is equal to  $3^{n-1}$ , which completes the proof.

As described in Introduction, a lot of inequivalent skew Hadamard difference sets in  $\mathbb{F}_q$  were found recently. One may expect that we obtain many inequivalent divisible difference sets in  $\mathbb{Z}_9^n$  applying the construction of Theorem 3.2 to such inequivalent skew Hadamard difference sets. We close this note providing the following open problem.

**Problem 3.3.** Determine whether or not divisible difference sets constructed in Theorem 3.2 are equivalent if the assumed skew Hadamard difference sets are inequivalent.
