# A NOTE ON THE NEUMAN-SÁNDOR MEAN 

TIEHONG ZHAO, YUMING CHU, AND BAOYU LIU


#### Abstract

In this article, we present the best possible upper and lower bounds for the Neuman-Sándor mean in terms of the geometric combinations of harmonic and quadratic means, geometric and quadratic means, harmonic and contra-harmonic means, and geometric and contra-harmonic means.


## 1. Introduction

For $a, b>0$ with $a \neq b$ the Neuman-Sándor mean $M(a, b)[1]$ is defined by

$$
\begin{equation*}
M(a, b)=\frac{a-b}{2 \sinh ^{-1}\left(\frac{a-b}{a+b}\right)} \tag{1.1}
\end{equation*}
$$

where $\sinh ^{-1}(x)=\log \left(x+\sqrt{x^{2}+1}\right)$ is the inverse hyperbolic sine function.
Recently, the Neuman-Sándor mean has been the subject of intensive research. In particular, many remarkable inequalities for the Neuman-Sándor mean $M(a, b)$ can be found in the literature [1, 2].

Let $H(a, b)=2 a b /(a+b), G(a, b)=\sqrt{a b}, L(a, b)=(b-a) /(\log b-\log a), P(a, b)=$ $(a-b) /(4 \arctan \sqrt{a / b}-\pi), A(a, b)=(a+b) / 2, T(a, b)=(a-b) /[2 \arctan ((a-b) /(a+b))]$, $Q(a, b)=\sqrt{\left(a^{2}+b^{2}\right) / 2}$ and $C(a, b)=\left(a^{2}+b^{2}\right) /(a+b)$ be the harmonic, geometric, logarithmic, first Seiffert, arithmetic, second Seiffert, quadratic and contra-harmonic means of $a$ and $b$, respectively. Then it is well-known that the inequalities

H(a, b)<G(a, b)<L(a, b)<P(a, b)<A(a, b)<M(a, b)<T(a, b)<Q(a, b)<C(a, b)
$$

hold true for $a, b>0$ with $a \neq b$.
Neuman and Sándor [1, 2] established that

\begin{gathered}
A(a, b)<M(a, b)<T(a, b), \\
P(a, b) M(a, b)<A^{2}(a, b), \\
A(a, b) T(a, b)<M^{2}(a, b)<\left[A^{2}(a, b)+T^{2}(a, b)\right] / 2
\end{gathered}
$$

hold for all $a, b>0$ with $a \neq b$.
Let $0<a, b<1 / 2$ with $a \neq b, a^{\prime}=1-a$ and $b^{\prime}=1-b$. Then the following Ky Fan inequalities

\frac{G(a, b)}{G\left(a^{\prime}, b^{\prime}\right)}<\frac{L(a, b)}{L\left(a^{\prime}, b^{\prime}\right)}<\frac{P(a, b)}{P\left(a^{\prime}, b^{\prime}\right)}<\frac{A(a, b)}{A\left(a^{\prime}, b^{\prime}\right)}<\frac{M(a, b)}{M\left(a^{\prime}, b^{\prime}\right)}<\frac{T(a, b)}{T\left(a^{\prime}, b^{\prime}\right)}
$$

were presented in [1].
Li et al. [3] showed that the double inequality $L_{p_{0}}(a, b)<M(a, b)<L_{2}(a, b)$ holds for all $a, b>0$ with $a \neq b$, where $L_{p}(a, b)=\left[\left(b^{p+1}-a^{p+1}\right) /((p+1)(b-a))\right]^{1 / p}(p \neq-1,0), L_{0}=$ $1 / e\left(b^{b} / a^{a}\right)^{1 /(b-a)}$ and $L_{-1}(a, b)=(b-a) /(\log b-\log a)$ be the $p-$ th generalized logarithmic mean of $a$ and $b$, and $p_{0}=1.843 \cdots$ is the unique solution of the equation $(p+1)^{1 / p}=$ $2 \log (1+\sqrt{2})$.

In 4], Neuman proved that the double inequalities

Q^{\alpha}(a, b) A^{1-\alpha}(a, b)<M(a, b)<Q^{\beta}(a, b) A^{1-\beta}(a, b)
$$

and

$$
C^{\lambda}(a, b) A^{1-\lambda}(a, b)<M(a, b)<C^{\mu}(a, b) A^{1-\mu}(a, b)
$$

[^0]hold for all $a, b>0$ with $a \neq b$ if and only if $\alpha \leq 1 / 3, \beta \geq 2(\log (2+\sqrt{2})-\log 3) / \log 2=$ $0.373 \cdots, \lambda \leq 1 / 6$ and $\mu \geq(\log (2+\sqrt{2})-\log 3) / \log 2=0.186 \cdots$.

The main purpose of this paper is to find the least values $\alpha_{1}, \alpha_{2}, \alpha_{3}, \alpha_{4}$, and the greatest values $\beta_{1}, \beta_{2}, \beta_{3}, \beta_{4}$ such that the double inequalities

\begin{aligned}
& H^{\alpha_{1}}(a, b) Q^{1-\alpha_{1}}(a, b)<M(a, b)<H^{\beta_{1}}(a, b) Q^{1-\beta_{1}}(a, b), \\
& G^{\alpha_{2}}(a, b) Q^{1-\alpha_{2}}(a, b)<M(a, b)<G^{\beta_{2}}(a, b) Q^{1-\beta_{2}}(a, b), \\
& H^{\alpha_{3}}(a, b) C^{1-\alpha_{3}}(a, b)<M(a, b)<H^{\beta_{3}}(a, b) C^{1-\beta_{3}}(a, b)
\end{aligned}
$$

and

$$
G^{\alpha_{4}}(a, b) C^{1-\alpha_{4}}(a, b)<M(a, b)<G^{\beta_{4}}(a, b) C^{1-\beta_{4}}(a, b)
$$

hold for all $a, b>0$ with $a \neq b$.

## 2. Lemmas

In order to establish our main results we need four lemmas, which we present in this section.
Lemma 2.1. (See [5], Theorem 1.25). For $-\infty<a<b<\infty$, let $f, g:[a, b] \rightarrow \mathbb{R}$ be continuous on $[a, b]$, and be differentiable on $(a, b)$, let $g^{\prime}(x) \neq 0$ on $(a, b)$. If $f^{\prime}(x) / g^{\prime}(x)$ is increasing (decreasing) on $(a, b)$, then so are

\frac{f(x)-f(a)}{g(x)-g(a)} \text { and } \frac{f(x)-f(b)}{g(x)-g(b)} \text {. }
$$

If $f^{\prime}(x) / g^{\prime}(x)$ is strictly monotone, then the monotonicity in the conclusion is also strict.
Lemma 2.2. (See [6], Lemma 1.1). Suppose that the power series $f(x)=\sum_{n=0}^{\infty} a_{n} x^{n}$ and $g(x)=\sum_{n=0}^{\infty} b_{n} x^{n}$ have the radius of convergence $r>0$ and $b_{n}>0$ for all $n \in\{0,1,2, \cdots\}$. Let $h(x)=f(x) / g(x)$, then
(1) If the sequence $\left\{a_{n} / b_{n}\right\}_{n=0}^{\infty}$ is (strictly) increasing (decreasing), then $h(x)$ is also (strictly) increasing (decreasing) on ( $0, r$ );
(2) If the sequence $\left\{a_{n} / b_{n}\right\}$ is (strictly) increasing (decreasing) for $0<n \leq n_{0}$ and (strictly) decreasing (increasing) for $n>n_{0}$, then there exists $x_{0} \in(0, r)$ such that $h(x)$ is (strictly) increasing (decreasing) on $\left(0, x_{0}\right)$ and (strictly) decreasing (increasing) on ( $\left.x_{0}, r\right)$.

Lemma 2.3. Let

$$
\begin{equation*}
\phi(t)=\frac{[3-\cosh (2 t)][\sinh (2 t)-2 t]}{2 t \sinh ^{2}(t)[5+\cosh (2 t)]} \tag{2.1}
\end{equation*}
$$

then $\phi(t)$ is strictly decreasing in $(0, \log (1+\sqrt{2}))$, where $\sinh (t)=\left(e^{t}-e^{-t}\right) / 2$ and $\cosh (t)=$ $\left(e^{t}+e^{-t}\right) / 2$ are respectively the hyperbolic sine and cosine functions.
Proof. Let us denote by $\phi_{1}(t)$ and $\phi_{2}(t)$ respectively the numerator and denominator of (2.1) expand the factor to obtain

\phi_{1}(t)=3 \sinh (2 t)-6 t+2 t \cosh (2 t)-\frac{1}{2} \sinh (4 t)  \tag{2.2}\\
\phi_{2}(t)=\frac{t}{2}[8 \cosh (2 t)+\cosh (4 t)-9] \tag{2.3}
\end{gather*}
$$

Using the power series $\sinh (t)=\sum_{n=0}^{\infty} t^{2 n+1} /(2 n+1)$ ! and $\cosh (t)=\sum_{n=0}^{\infty} t^{2 n} /(2 n)$ !, we can express (2.2) and (2.3) as follows

\begin{gather*}
\phi_{1}(t)=\sum_{n=1}^{\infty} \frac{2^{2 n+1}\left(2 n+4-2^{2 n}\right)}{(2 n+1)!} t^{2 n+1}=t^{3} \sum_{n=0}^{\infty} \frac{2^{2 n+4}\left(n+3-2^{2 n+1}\right)}{(2 n+3)!} t^{2 n}  \tag{2.4}\\
\phi_{2}(t)=\sum_{n=1}^{\infty} \frac{2^{2 n}\left(4+2^{2 n-1}\right)}{(2 n)!} t^{2 n+1}=t^{3} \sum_{n=0}^{\infty} \frac{2^{2 n+4}\left(1+2^{2 n-1}\right)}{(2 n+2)!} t^{2 n} . \tag{2.5}
\end{gather*}
$$

It follows from (2.4) and (2.5) that

$$
\begin{equation*}
\phi(t)=\frac{\sum_{n=0}^{\infty} a_{n} t^{2 n}}{\sum_{n=0}^{\infty} b_{n} t^{2 n}} \tag{2.6}
\end{equation*}
$$

with $a_{n}=2^{2 n+4}\left(n+3-2^{2 n+1}\right) /(2 n+3)$ ! and $b_{n}=2^{2 n+4}\left(1+2^{2 n-1}\right) /(2 n+2)$ !.
Let $c_{n}=a_{n} / b_{n}$, then simple computations lead to

$$
\begin{gather*}
c_{n}=\frac{(n+3)-2^{2 n+1}}{(2 n+3)\left(1+2^{2 n-1}\right)}, \\
c_{0}=\frac{2}{9}>c_{1}=-\frac{4}{15}>c_{2}=-\frac{3}{7}<c_{3}=-\frac{122}{297}  \tag{2.7}\\
c_{n+1}-c_{n}=\frac{2^{4 n+3}-\left(6 n^{2}+57 n+76\right) 2^{2 n-1}-3}{(2 n+3)(2 n+5)\left(1+2^{2 n-1}\right)\left(1+2^{2 n+1}\right)} \\
=\frac{\left[2\left(4^{n}-38\right)+6\left(4^{n}-n^{2}\right)+\left(128 \times 4^{n-2}-57 n\right)\right] 2^{2 n-1}-3}{(2 n+3)(2 n+5)\left(1+2^{2 n-1}\right)\left(1+2^{2 n+1}\right)}>0 \tag{2.8}
\end{gather*}
$$

for all $n>2$.
Inequalities (2.7) and (2.8) implies that the sequence $\left\{a_{n} / b_{n}\right\}$ is strictly decreasing in $0<$ $n \leq 2$ and strictly increasing for $n>2$, then from (2.6) and Lemma 2.2(2) we know that there exists $t_{0}>0$ such that $\phi(t)$ is strictly decreasing on $\left(0, t_{0}\right)$ and strictly increasing in $\left(t_{0}, \infty\right)$.

For convenience, let us denote $t^{\star}=\log (1+\sqrt{2})=0.881 \cdots$, then we have

\begin{gather*}
\sinh \left(t^{*}\right)=1, \quad \sinh \left(2 t^{*}\right)=2 \sqrt{2}, \quad \sinh \left(3 t^{*}\right)=7  \tag{2.9}\\
\cosh \left(t^{*}\right)=\sqrt{2}, \quad \cosh \left(2 t^{*}\right)=3, \quad \cosh \left(3 t^{*}\right)=5 \sqrt{2} \tag{2.10}
\end{gather*}
$$

Differentiating (2.1) yields

$$
\begin{equation*}
\phi^{\prime}(t)=\frac{\phi_{1}{ }^{\prime}(t) \phi_{2}(t)-\phi_{1}(t) \phi_{2}{ }^{\prime}(t)}{\phi_{2}^{2}(t)} \tag{2.11}
\end{equation*}
$$

where

$$
\begin{gather*}
\phi_{1}^{\prime}(t)=8 \sinh (t)\left[t \cosh (t)-2 \sinh ^{3}(t)\right]  \tag{2.12}\\
\phi_{2}^{\prime}(t)=\sinh (t)[20 t \cosh (t)+4 t \cosh (3 t)+9 \sinh (t)+\sinh (3 t)] . \tag{2.13}
\end{gather*}
$$

From (2.2) and (2.3) together with (2.9)-(2.13) we get

$$
\begin{equation*}
\phi^{\prime}\left(t^{*}\right)=-\frac{\sqrt{2}-t^{*}}{\sqrt{2} t^{*}}<0 \tag{2.14}
\end{equation*}
$$

It follows from the piecewise monotonicity of $\phi(t)$ and (2.14) that $t_{0}>t^{*}$. This completes the proof of Lemma 2.3.

Lemma 2.4. Let $p \in[0,1)$, and

$$
\begin{equation*}
\varphi_{p}(t)=\log \left(1+x^{2}\right)-\log \frac{x}{\sinh ^{-1}(x)}+p\left[\frac{1}{2} \log \left(1-x^{2}\right)-\log \left(1+x^{2}\right)\right] \tag{2.15}
\end{equation*}
$$

Then $\varphi_{5 / 9}(x)<0$ and $\varphi_{0}(x)>0$ for all $x \in(0,1)$.
Proof. From (2.15) one has

$$
\begin{gather*}
\varphi_{p}\left(0^{+}\right)=0  \tag{2.16}\\
\varphi_{p}^{\prime}(x)=\frac{\phi_{p}(x)}{x\left(1-x^{4}\right) \sqrt{1+x^{2}} \sinh ^{-1}(x)} \tag{2.17}
\end{gather*}
$$

where

$$
\begin{equation*}
\phi_{p}(x)=x-x^{5}-\left[1+(3 p-2) x^{2}+(1-p) x^{4}\right] \sqrt{1+x^{2}} \sinh ^{-1}(x) \tag{2.18}
\end{equation*}
$$

We divide the proof into two cases.
Case $1 p=5 / 9$. Then (2.18) leads to

$$
\begin{gather*}
\phi_{5 / 9}(0)=0  \tag{2.19}\\
\phi_{5 / 9}^{\prime}(x)=-\frac{x f(x)}{9 \sqrt{1+x^{2}}}, \tag{2.20}
\end{gather*}
$$

where

$$
\begin{gather*}
f(x)=x\left(49 x^{2}-3\right) \sqrt{1+x^{2}}+\left(3+7 x^{2}+20 x^{4}\right) \sinh ^{-1}(x)  \tag{2.21}\\
f(0)=0 . \tag{2.22}
\end{gather*}
$$

Differentiating (2.21) yields

$$
\begin{equation*}
f^{\prime}(x)=\frac{2 x\left[74 x+108 x^{3}+\left(7+40 x^{2}\right) \sqrt{1+x^{2}} \sinh ^{-1}(x)\right]}{\sqrt{1+x^{2}}}>0 \tag{2.23}
\end{equation*}
$$

for $x \in(0,1)$.
Therefore, $\phi_{5 / 9}(x)<0$ for all $x \in(0,1)$ follows easily from (2.19) and (2.20) together with (2.22) and (2.23).

Case $2 p=0$. Then (2.18) yields

\begin{gather*}
\frac{\phi_{0}(x)}{1-x^{2}}=x\left(1+x^{2}\right)-\left(1-x^{2}\right) \sqrt{1+x^{2}} \sinh ^{-1}(x):=g(x)  \tag{2.24}\\
g(0)=0 \tag{2.25}
\end{gather*}
$$

Differentiating (2.24) we get

$$
\begin{equation*}
g^{\prime}(x)=\frac{x\left[4 x \sqrt{1+x^{2}}+\left(1+3 x^{2}\right) \sinh ^{-1}(x)\right]}{\sqrt{1+x^{2}}}>0 \tag{2.26}
\end{equation*}
$$

for $x \in(0,1)$
Therefore, $\varphi_{0}(x)>0$ for $x \in(0,1)$ easily from (2.16) and (2.17) together with (2.24)-(2.26).

## 3. Bounds for the Neuman-SÁndor Mean

In this section we will deal with problems of finding sharp bounds for the Neuman-Sándor Mean $M(a, b)$ in terms of the geometric combinations of harmonic mean $H(a, b)$ and quadratic mean $Q(a, b)$, geometric mean $G(a, b)$ and quadratic mean $Q(a, b)$, harmonic mean $H(a, b)$ and contra-harmonic mean $C(a, b)$, and geometric mean $G(a, b)$ and contra-harmonic mean $C(a, b)$.

Since $H(a, b), G(a, b), M(a, b), Q(a, b)$ and $C(a, b)$ are symmetric and homogeneous of degree 1. Without loss of generality, we assume that $a>b$. For the later use we denote $x=$ $(a-b) /(a+b) \in(0,1)$ and $t=\sinh ^{-1}(x) \in\left(0, t^{*}\right)$ with $t^{*}=\log (1+\sqrt{2})=0.881 \cdots$.

Theorem 3.1. The double inequality

$$
\begin{equation*}
H^{\alpha}(a, b) Q^{1-\alpha}(a, b)<M(a, b)<H^{\beta}(a, b) Q^{1-\beta}(a, b) \tag{3.1}
\end{equation*}
$$

holds true for all $a, b>0$ with $a \neq b$ if and only if $\alpha \geq 2 / 9$ and $\beta \leq 0$.
Proof. First we take the logarithm of each member of (3.1) and next rearrange terms to obtain

$$
\begin{equation*}
\beta<\frac{\log [Q(a, b)]-\log [M(a, b)]}{\log [Q(a, b)]-\log [H(a, b)]}<\alpha \tag{3.2}
\end{equation*}
$$

Note that

$$
\begin{equation*}
\frac{M(a, b)}{A(a, b)}=\frac{x}{\sinh ^{-1}(x)}, \quad \frac{H(a, b)}{A(a, b)}=1-x^{2}, \quad \frac{Q(a, b)}{A(a, b)}=\sqrt{1+x^{2}} \tag{3.3}
\end{equation*}
$$

Use of (3.3) followed by a substitution $x=\sinh (t)\left(0<t<t^{*}\right)$, inequality (3.2) becomes

$$
\begin{equation*}
\beta<f(t)<\alpha \tag{3.4}
\end{equation*}
$$

where

$$
\begin{equation*}
f(t)=\frac{\log [\cosh (t)]-\log [\sinh (t) / t]}{\log [\cosh (t)]-\log \left[1-\sinh ^{2}(t)\right]}:=\frac{f_{1}(t)}{f_{2}(t)} \tag{3.5}
\end{equation*}
$$

In order to use Lemma 2.1, we consider the following

$$
\begin{equation*}
\frac{f_{1}^{\prime}(t)}{f_{2}^{\prime}(t)}=\frac{[3-\cosh (2 t)][\sinh (2 t)-2 t]}{2 t \sinh ^{2}(t)[5+\cosh (2 t)]}:=\phi(t) \tag{3.6}
\end{equation*}
$$

where $\phi(t)$ is defined as in Lemma 2.3.
It follows from Lemmas 2.1 and 2.3 together with (3.6) that

$$
f(t)=\frac{f_{1}(t)}{f_{2}(t)}=\frac{f_{1}(t)-f_{1}\left(0^{+}\right)}{f_{2}(t)-f_{2}(0)}
$$

is strictly decreasing on $\left(0, t^{*}\right)$. This in turn implies that

$$
\begin{equation*}
\lim _{t \rightarrow 0^{+}} f(t)=\frac{2}{9}, \quad \lim _{t \rightarrow t^{*}} f(t)=0 \tag{3.7}
\end{equation*}
$$

Making use of (3.7) and the monotonicity of $\phi(t)$ we conclude that in order for the double inequality (3.1) to be valid it is necessary and sufficient that $\alpha \geq 2 / 9$ and $\beta \leq 0$.

Theorem 3.2. The two-sided inequality

$$
\begin{equation*}
G^{\alpha}(a, b) Q^{1-\alpha}(a, b)<M(a, b)<G^{\beta}(a, b) Q^{1-\beta}(a, b) \tag{3.8}
\end{equation*}
$$

holds true for all $a, b>0$ with $a \neq b$ if and only if $\alpha \geq 1 / 3$ and $\beta \leq 0$.
Proof. We will follows lines introduced in the proof of Theorem 3.1. We take the logarithm of each member of (3.8) and next rearrange terms to get

$$
\begin{equation*}
\beta<\frac{\log [Q(a, b)]-\log [M(a, b)]}{\log [Q(a, b)]-\log [G(a, b)]}<\alpha \tag{3.9}
\end{equation*}
$$

Use of (3.3) and $G(a, b) / A(a, b)=\sqrt{1-x^{2}}$ followed by a substitution $x=\sinh (t)\left(0<t<t^{*}\right)$, inequality (3.9) is equivalent to

$$
\begin{equation*}
\beta<g(t)<\alpha \tag{3.10}
\end{equation*}
$$

where

$$
\begin{equation*}
g(t)=\frac{\log [\cosh (t)]-\log [\sinh (t) / t]}{\log [\cosh (t)]-\log \left[1-\sinh ^{2}(t)\right] / 2}:=\frac{g_{1}(t)}{g_{2}(t)} \tag{3.11}
\end{equation*}
$$

Equation (3.11) leads to

$$
\begin{gather*}
\frac{g_{1}^{\prime}(t)}{g_{2}^{\prime}(t)}=\frac{[3-\cosh (2 t)][\sinh (2 t)-2 t]}{8 t \sinh ^{2}(t)}=\frac{\sum_{n=1}^{\infty}\left[2^{2 n+1}\left(2 n+4-2^{2 n}\right) /(2 n+1)!\right] t^{2 n+1}}{\sum_{n=1}^{\infty}\left[2^{2 n+2} /(2 n)!\right] t^{2 n+1}} \\
=\frac{\sum_{n=0}^{\infty}\left[2^{2 n+4}\left(n+3-2^{2 n+1}\right) /(2 n+3)!\right] t^{2 n}}{\sum_{n=0}^{\infty}\left[2^{2 n+4} /(2 n+2)!\right] t^{2 n}}:=\frac{\sum_{n=0}^{\infty} a_{n}^{\prime} t^{2 n}}{\sum_{n=0}^{\infty} b_{n}^{\prime} t^{2 n}},  \tag{3.12}\\
\frac{a_{n+1}^{\prime}}{b_{n+1}^{\prime}}-\frac{a_{n}^{\prime}}{b_{n}^{\prime}}=-\frac{3+(6 n+7) 2^{2 n+1}}{(2 n+3)(2 n+5)}<0 \tag{3.13}
\end{gather*}
$$

for all $n \in\{0,1,2, \cdots\}$.
It follows from Lemmas $2.1(1)$ and (3.12) together with (3.13) that $g_{1}^{\prime}(t) / g_{2}^{\prime}(t)$ is strictly decreasing on $\left(0, t^{*}\right)$.

From Lemma 2.1 and (3.11) together with $g_{1}\left(0^{+}\right)=g_{2}(0)=0$ and the monotonicity of $g_{1}^{\prime}(t) / g_{2}^{\prime}(t)$ we clearly see that $g(t)$ is strictly decreasing on $\left(0, t^{*}\right)$.

Therefore, Theorem 3.2 follows from the monotonicity of $g(t)$ and (3.10) together with the fact that

\lim _{t \rightarrow 0^{+}} g(t)=\frac{1}{3}, \quad \lim _{t \rightarrow t^{*}} g(t)=0
$$

Theorem 3.3. The following simultaneous inequality

$$
\begin{equation*}
H^{\alpha}(a, b) C^{1-\alpha}(a, b)<M(a, b)<H^{\beta}(a, b) C^{1-\beta}(a, b) \tag{3.14}
\end{equation*}
$$

holds true for all $a, b>0$ with $a \neq b$ if and only if $\alpha \geq 5 / 12$ and $\beta \leq 0$.
Proof. We take the logarithm of each member of (3.14) and next rearrange terms to get

$$
\begin{equation*}
\beta<\frac{\log [C(a, b)]-\log [M(a, b)]}{\log [C(a, b)]-\log [H(a, b)]}<\alpha \tag{3.15}
\end{equation*}
$$

Use of (3.3) and $C(a, b) / A(a, b)=1+x^{2}$ followed by a substitution $x=\sinh (t)\left(0<t<t^{*}\right)$, inequality (3.15) becomes

$$
\begin{equation*}
\beta<h(t)<\alpha \tag{3.16}
\end{equation*}
$$

where

$$
\begin{equation*}
h(t)=\frac{\log [\cosh (t)]-\log [\sinh (t) / t] / 2}{\log [\cosh (t)]-\log \left[1-\sinh ^{2}(t)\right] / 2}:=\frac{h_{1}(t)}{h_{2}(t)} \tag{3.17}
\end{equation*}
$$

Equation (3.17) gives

$$
\begin{aligned}
\frac{h_{1}^{\prime}(t)}{h_{2}^{\prime}(t)} & =\frac{[3-\cosh (2 t)][\sinh (2 t)+t \cosh (2 t)-3 t]}{16 t \sinh ^{2}(t)} \\
& =\frac{\sum_{n=0}^{\infty}\left[2^{2 n+3}\left(\left(3-2^{2 n}\right)(2 n+3)+3-2^{2 n+2}\right) /(2 n+3)!\right] t^{2 n}}{\sum_{n=0}^{\infty}\left[2^{2 n+5} /(2 n+2)!\right] t^{2 n}}:=\frac{\sum_{n=0}^{\infty} c_{n}^{\prime} t^{2 n}}{\sum_{n=0}^{\infty} d_{n}^{\prime} t^{2 n}}
\end{aligned}
$$

$$
\begin{equation*}
\frac{c_{n+1}^{\prime}}{d_{n+1}^{\prime}}-\frac{c_{n}^{\prime}}{d_{n}^{\prime}}=-3 \times 2^{2 n-2}-\frac{3}{2(2 n+3)(2 n+5)}-\frac{(6 n+7) 2^{2 n}}{(2 n+3)(2 n+5)}<0 \tag{3.19}
\end{equation*}
$$

for all $n \in\{0,1,2, \cdots\}$.
It follows from Lemmas 2.2(1) and (3.18) together with (3.19) that $h_{1}^{\prime}(t) / h_{2}^{\prime}(t)$ is strictly decreasing on $\left(0, t^{*}\right)$.

From Lemma 2.1 and (3.17) together with $h_{1}\left(0^{+}\right)=h_{2}(0)=0$ and the monotonicity of $h_{1}^{\prime}(t) / h_{2}^{\prime}(t)$ we clearly see that $h(t)$ is strictly decreasing on $\left(0, t^{*}\right)$.

Therefore, Theorem 3.3 follows from the monotonicity of $h(t)$ and (3.16) together with the fact that

$$
\lim _{t \rightarrow 0^{+}} h(t)=\frac{5}{12}, \quad \lim _{t \rightarrow t^{*}} h(t)=0
$$

Theorem 3.4. The following inequality

$$
\begin{equation*}
G^{\alpha}(a, b) C^{1-\alpha}(a, b)<M(a, b)<G^{\beta}(a, b) C^{1-\beta}(a, b) \tag{3.20}
\end{equation*}
$$

is valid for all $a, b>0$ with $a \neq b$ if and only if $\alpha \geq 5 / 9$ and $\beta \leq 0$.
Proof. Making use of (3.3) and $C(a, b) / A(a, b)=1+x^{2}$ together with $G(a, b) / A(a, b)=\sqrt{1-x^{2}}$ we get

$$
\begin{equation*}
\frac{\log [C(a, b)]-\log [M(a, b)]}{\log [C(a, b)]-\log [G(a, b)]}=\frac{\log \left(1+x^{2}\right)-\log \left[x / \sinh ^{-1}(x)\right]}{\log \left(1+x^{2}\right)-\log \sqrt{1-x^{2}}} \tag{3.21}
\end{equation*}
$$

Elaborated computations lead to

$$
\begin{align*}
& \lim _{x \rightarrow 0^{+}} \frac{\log \left(1+x^{2}\right)-\log \left[x / \sinh ^{-1}(x)\right]}{\log \left(1+x^{2}\right)-\log \sqrt{1-x^{2}}}=\frac{5}{9}  \tag{3.22}\\
& \lim _{x \rightarrow 1^{-}} \frac{\log \left(1+x^{2}\right)-\log \left[x / \sinh ^{-1}(x)\right]}{\log \left(1+x^{2}\right)-\log \sqrt{1-x^{2}}}=0 \tag{3.23}
\end{align*}
$$

Taking the logarithm of (3.20), we consider the difference between the convex combination of $\log G(a, b), \log C(a, b)$ and $\log M(a, b)$ as follows

$$
\begin{align*}
& p \log G(a, b)+(1-p) \log C(a, b)-\log M(a, b) \\
= & p \log \sqrt{1-x^{2}}+(1-p) \log \left(1+x^{2}\right)-\log \frac{x}{\sinh ^{-1}(x)}=\varphi_{p}(x) \tag{3.24}
\end{align*}
$$

where $\varphi_{p}(x)$ is defined as in Lemma 2.4.
Therefore, $G^{5 / 9}(a, b) C^{4 / 9}(a, b)<M(a, b)<C(a, b)$ for all $a, b>0$ with $a \neq b$ follows from (3.24) and Lemma 2.4. This in conjunction with the following statements gives the asserted result.

- If $\alpha<5 / 9$, then equations (3.21) and (3.22) lead to the conclusion that there exists $0<\delta_{1}<1$ such that $M(a, b)<G^{\alpha}(a, b) C^{1-\alpha}(a, b)$ for all $a, b>0$ with $(a-b) /(a+b) \in\left(0, \delta_{1}\right)$.
- If $\beta>0$, then equations (3.21) and (3.23) imply that there exists $0<\delta_{2}<1$ such that $M(a, b)>G^{\beta}(a, b) C^{1-\beta}(a, b)$ for all $a, b>0$ with $(a-b) /(a+b) \in\left(1-\delta_{2}, 1\right)$.
