# Multiplication of conjugacy classes, colligations, and characteristic functions of matrix argument

We extend the classical construction of operator colligations and characteristic functions. Consider the group G of finitary block unitary matrices of size  $\alpha + \infty$  +  $\cdots +\infty$  (*m* times). Consider the subgroup  $K = U(\infty)$ , which consists of block diagonal unitary matrices with a block 1 of size  $\alpha$  and a matrix  $u \in U(\infty)$  repeated m times. It appears that there is a natural multiplication on the conjugacy classes  $G//K$ . We construct 'spectral data' of conjugacy classes, which visualize the multiplication and are sufficient for a reconstruction of a conjugacy class.

# 1 Formulation of the problem

**1.1.** Notation. By  $1 = 1_n$  we denote the unit matrix of order n, by  $A^t$  the transposed matrix. Let  $\text{Mat}(n)$  be the space of complex matrices of size  $n \times n$ ,  $GL(n,\mathbb{C})$  be the group of invertible matrices of order n,  $U(n)$  be the unitary subgroup in  $GL(n,\mathbb{C})$ .

Denote by MAT( $\infty$ ) the space of all infinite matrices g such that  $q-1$  has only finite number of non-zero elements. By  $GL(\infty, \mathbb{C})$ , we denote the group of invertible elements of MAT( $\infty$ ). By U( $\infty$ ) we denote its subgroup consisting of unitary matrices.

Denote  $\text{Mat}(\infty)$  the space of all infinite matrices having only finite number of non-zero matrix elements, i.e.  $g \in Mat(\infty) \Leftrightarrow g + 1 \in MAT(\infty)$ .

Let G be a group,  $H \subset G$  a subgroup. By  $G//H$  we denote the space of conjugacy classes G with respect to H, by  $H \setminus G/H$  the double cosets.

1.2. Colligations. The following objects arose by independent reasons in spectral theory of non-selfadjoint operators, system theory, and representation theory of infinite-dimensional groups (see  $[12]$ ,  $[13]$ ,  $[29]$ ,  $[2]$ ,  $[3]$ ,  $[4]$ ,  $[7]$ ,  $[23]$ ,  $[24], [15]$  $[24], [15]$  $[24], [15]$ .

Fix a non-negative integer  $\alpha$ . Denote by G the group U( $\infty$ ), by K its subgroup consisting of matrices of the form  $\begin{pmatrix} 1_{\alpha} & 0 \\ 0 & b \end{pmatrix}$  $0 \quad h$  $\overline{\phantom{0}}$ . Consider the space  $G//K$ of conjugacy classes of G with respect to  $\overrightarrow{K}$ , i.e., elements of G defined up to the equivalence

$$
\begin{pmatrix} a & b \\ c & d \end{pmatrix} \sim \begin{pmatrix} 1_\alpha & 0 \\ 0 & h \end{pmatrix} \begin{pmatrix} a & b \\ c & d \end{pmatrix} \begin{pmatrix} 1_\alpha & 0 \\ 0 & h \end{pmatrix}^{-1}.
$$

There is a natural multiplication on the set  $G//K$  defined in the following way. Let  $\mathfrak{g}$ ,  $\mathfrak{h}$  be conjugacy classes, let g, h be their representatives, let g, h actually

be contained in  $U(\alpha + N)$ , i.e., they are given by block  $(\alpha + N + \infty)$ -matrices of the form

$$
g = \begin{pmatrix} a_1 & b_1 & 0 \\ c_1 & d_1 & 0 \\ 0 & 0 & 1_{\infty} \end{pmatrix}, \qquad g = \begin{pmatrix} a_2 & b_2 & 0 \\ c_2 & d_2 & 0 \\ 0 & 0 & 1_{\infty} \end{pmatrix}.
$$

We define the product  $\mathfrak{g} \circ \mathfrak{h}$  as the conjugacy class containing

$$
\begin{pmatrix}\na_1 & b_1 & 0 \\
c_1 & d_1 & 0 \\
0 & 0 & 1_\infty\n\end{pmatrix}\n\circ\n\begin{pmatrix}\na_2 & b_2 & 0 \\
c_2 & d_2 & 0 \\
0 & 0 & 1_\infty\n\end{pmatrix} :=\n\begin{pmatrix}\na_1 & b_1 & 0 & 0 \\
c_1 & d_1 & 0 & 0 \\
0 & 0 & 1_N & 0 \\
0 & 0 & 0 & 1_\infty\n\end{pmatrix}\n\begin{pmatrix}\na_2 & 0 & b_2 & 0 \\
0 & 1_N & 0 & 0 \\
c_2 & 0 & d_2 & 0 \\
0 & 0 & 0 & 1_\infty\n\end{pmatrix} =\n\begin{pmatrix}\na_1a_2 & b_1 & a_1b_2 & 0 \\
c_1a_2 & d_1 & c_1b_2 & 0 \\
c_2 & 0 & d_2 & 0 \\
0 & 0 & 0 & 1_\infty\n\end{pmatrix}.
$$
\n(1.1)

This product is a well-defined associative operation on  $G//K$ .

This operation admits the following visualization: To a matrix  $g =$  $\begin{pmatrix} a & b \\ c & d \end{pmatrix}$ we assign the *characteristic function* as a function on  $\mathbb C$  taking values in  $\alpha \times \alpha$ matrices given by

$$
\chi(z) = a + zb(1 - zd)^{-1}c.
$$

This function depends only on a conjugacy class  $\mathfrak g$  and not on a matrix  $g$ , so we can write  $\chi_{\mathfrak{q}}(z)$ .

Next, denote by  $\eta_{\mathfrak{g}}$  the set of eigenvalues of d that are contained in the circle  $|z| = 1.$ 

The following statement is well-known (see, e.g., [\[3\]](#page-17-3), in this work the complete unitary group instead of  $U(\infty)$  is considered).

### **Theorem 1.1** a)  $\chi_{\mathfrak{g} \circ \mathfrak{h}}(z) = \chi_{\mathfrak{g}}(z) \chi_{\mathfrak{h}}(z)$ .

b) If  $|z| \leq 1$ , then  $||\chi(z)|| \leq 1$ ; if  $|z| = 1$ , then  $\chi(z) \in U(n)$ .

c) A conjugacy class g is uniquely determined by the characteristic function  $\chi_{\mathfrak{q}}(z)$  and the set  $\eta_{\mathfrak{q}}$ .

A similar object is a semigroup of conjugacy classes of  $Q := GL(\infty, \mathbb{C})$  by a subgroup H consisting of matrices  $\begin{pmatrix} 1_{\alpha} & 0 \\ 0 & b \end{pmatrix}$  $0 \quad h$ ) , for a further discussion see [\[4\]](#page-17-4), [\[9\]](#page-17-7), [\[14\]](#page-17-8).

The  $\circ$ -multiplication is a representative of a wide class of operations on sets of conjugacy classes and double cosets. Such operations arise in a natural way in representation theory of infinite-dimensional classical groups, see [\[16\]](#page-17-9), [\[17\]](#page-18-3), [\[18\]](#page-18-4). The purpose of this paper is to give a way for a visualization of such operations. We consider a minimal example but our receipt works in the wider generality of [\[17\]](#page-18-3), we explain this in Section 4.

1.3. Product of conjugacy classes. Fix integers  $\alpha \geq 0$  and  $m \geq 1$ . Let  $N > 0$ . Consider the space Mat $(\alpha + mN)$ . We write its elements as block matrices

g = \begin{pmatrix} a & b_1 & \dots & b_m \\ c_1 & d_{11} & \dots & d_{1m} \\ \vdots & \vdots & \ddots & \vdots \\ c_m & d_{m1} & \dots & d_{mm} \end{pmatrix}

of size  $\alpha + N + \cdots + N$ . For an element  $u \in GL(N, \mathbb{C})$  we denote by  $\iota(u)$  the following matrix

$$
\iota(u) = \begin{pmatrix} 1_{\alpha} & 0 & 0 & \dots & 0 \\ 0 & u & 0 & \dots & 0 \\ 0 & 0 & u & \dots & 0 \\ \vdots & \vdots & \vdots & \ddots & \vdots \\ 0 & 0 & 0 & \dots & u \end{pmatrix} .
$$
 (1.3)

Denote by

$$
\mathcal{M}_N = \mathcal{M}_N^{\alpha,m} := \mathrm{Mat}(\alpha + mN)//GL(N,\mathbb{C})
$$

the set of conjugacy classes of  $\text{Mat}(\alpha + mN)$  by  $\text{GL}(N, \mathbb{C})$ , i.e.,

$$
g \sim \iota(u) g \iota(u)^{-1}.
$$
\n

(1.4)
$$

We call elements of this set by colligations.

Usually, we omit superscripts  $\alpha$ , m from  $\mathcal{M}_N^{\alpha,m}$ .

Next, we formulate the definition of a colligation in another form. Consider the space  $V = \mathbb{C}^m$  and  $Z_N = \mathbb{C}^N$ . Then an operator g can be regarded as an operator

$$
\mathbb{C}^{\alpha} \oplus (V \otimes Z_N) \to \mathbb{C}^{\alpha} \oplus (V \otimes Z_N)
$$

defined up to a conjugation by an element of  $GL(N, \mathbb{C})$  acting in  $Z_N$ .

We wish to define a canonical multiplication

$$
\mathcal{M}_{N_1} \times \mathcal{M}_{N_2} \to \mathcal{M}_{N_1 + N_2} \tag{1.5}
$$

 $(\alpha, m \text{ are fixed})$ . First, we consider the case  $m = 2$ . The multiplication is given

$$
g \circ h = \begin{pmatrix} a & b_1 & b_2 \\ c_1 & d_{11} & d_{12} \\ c_2 & d_{21} & d_{22} \end{pmatrix} \circ \begin{pmatrix} p & q_1 & q_2 \\ c_1 & d_{11} & d_{12} \\ c_2 & d_{21} & d_{22} \end{pmatrix} = \begin{pmatrix} a & b_1 & 0 & b_2 & 0 \\ c_1 & d_{11} & 0 & d_{12} & 0 \\ 0 & 0 & 1_{N_2} & 0 & 0 \\ c_2 & d_{21} & 0 & d_{22} & 0 \\ 0 & 0 & 0 & 0 & 1_{N_2} \end{pmatrix} \begin{pmatrix} p & 0 & q_1 & 0 & q_2 \\ 0 & 1_{N_2} & 0 & 0 & 0 \\ c_1 & 0 & d_{11} & 0 & d_{12} \\ 0 & 0 & 0 & 1_{N_2} & 0 \\ c_2 & 0 & d_{21} & 0 & d_{22} \end{pmatrix} = \begin{pmatrix} aa' & | & b_1 & ab'_1 \\ -+ & - & - & - & - \\ -a'_1 & | & d_{11} & c_1b'_1 \\ c'_1 & | & 0 & d'_{11} & 0 \\ c'_2 & | & 0 & d'_{11} & 0 \end{pmatrix} \begin{pmatrix} q_1 & q_2 & q_1 \\ q_2 & q_1 & q_2 \\ q_2 & q_1 & q_2 \end{pmatrix}
$$

and we take the conjugacy class containing the latter matrix.

Pass from  $m = 2$  to an arbitrary m is evident. However we formulate a formal definition, which is valid for all  $m$ . We extend the operator  $g$  to an operator  $\tilde{g}$  in

$$
\mathbb{C}^{\alpha} \oplus (V \otimes Z_{N_1 + N_2}) = \left[\mathbb{C}^{\alpha} \oplus (V \otimes Z_{N_1})\right] \oplus \left[V \otimes Z_{N_2}\right]
$$

This operator acts as g on the first summand and as 1 on the second summand. Next, we extend  $h$  to an operator  $h$  acting in the same way in the space

$$
\mathbb{C}^{\alpha} \oplus (V \otimes Z_{N_1 + N_2}) = \Big[\mathbb{C}^{\alpha} \oplus (V \otimes Z_{N_2})\Big] \oplus \Big[V \otimes Z_{N_1}\Big],
$$

and set

$$
g\circ h:=\widetilde{g}\cdot\widehat{h}.
$$

**Proposition 1.2** The  $\circ$ -multiplication is associative, i.e., for any  $N_1$ ,  $N_2$ ,  $N_3$ and  $g_1 \in \mathcal{M}_{N_1}$ ,  $g_2 \in \mathcal{M}_{N_2}$ ,  $g_3 \in \mathcal{M}_{N_3}$  the following equality holds:

$$
(g_1 \circ g_2) \circ g_3 = g_1 \circ (g_2 \circ g_3).
$$

This is more or less obvious (see also [\[16\]](#page-17-9)).

**1.4. Infinite-dimensional version.** Denote by  $M_{\infty}$  the set of conjugacy classes on MAT(∞) with respect to GL(∞, ℂ). Then  $\mathcal{M}_{\infty}$  is a semigroup with respect to ∘-multiplication.

1.5. Variants. Denote

$$
\mathcal{GL}_N = \mathcal{GL}_N^{\alpha,m} = GL(\alpha + mN, \mathbb{C}) // GL(N, \mathbb{C}) \mathcal{U}_N = \mathcal{U}_N^{\alpha,m} = \mathrm{U}(\alpha + mN) // \mathrm{U}(N),
$$

by

in all cases we consider the equivalence  $(1.4)$ , in the unitary case we suppose that  $u$  is unitary. Thus we get the operations

$$
\begin{aligned} \mathcal{GL}_{N_1}^{\alpha,m}\times\mathcal{GL}_{N_2}^{\alpha,m}&\to\mathcal{GL}_{N_1+N_2}^{\alpha,m};\\ \mathcal{GL}_{\infty}^{\alpha,m}\times\mathcal{GL}_{\infty}^{\alpha,m}&\to\mathcal{GL}_{\infty}^{\alpha,m};\\ \mathcal{U}_{N_1}^{\alpha,m}\times\mathcal{U}_{N_2}^{\alpha,m}&\to\mathcal{U}_{N_1+N_2}^{\alpha,m};\\ \mathcal{U}_{\infty}^{\alpha,m}\times\mathcal{U}_{\infty}^{\alpha,m}&\to\mathcal{U}_{\infty}^{\alpha,m}. \end{aligned}
$$

In this section  $\alpha$ , m are fixed and we will omit upper superscripts.

**1.6.** The origin of  $\circ$ -multiplication. The spaces  $\mathcal{M}_{\infty}^{\alpha,1}$  and  $\mathcal{U}_{\infty}^{\alpha,1}$  were discussed above in Subsection [1.2.](#page-14-0) In 80s a family of operations of this type arose in a natural way in representation theory of infinite-dimensional classical and infinite symmetric groups, see [\[22\]](#page-18-5), [\[23\]](#page-18-1), [\[15\]](#page-17-6), Section IX.4. For instance, there is a semigroup structure on double cosets

$$
\lim_{n \to \infty} \mathcal{O}(n) \setminus \mathcal{U}(\alpha + n) / \mathcal{O}(n).
$$

Moreover, this semigroup acts in the space of  $O(\infty)$ -fixed vectors of unitary representations of U( $\alpha + \infty$ ). Big zoo of operations on  $K \setminus G/K$  (with 'small' sub-groups K) arose in [\[16\]](#page-17-9), [\[17\]](#page-18-3), [\[19\]](#page-18-6), [\[5\]](#page-17-10), [\[21\]](#page-18-7); our  $U(\alpha+m\infty)/U(\infty)$  is inside this zoo. For another explanation, see [\[18\]](#page-18-4) (the ∘-product is an infinite-dimensional limit of convolutions of  $\delta$ -measures on conjugacy classes).

1.7. The purpose of the work. In [\[16\]](#page-17-9) there was obtained an analog of the characteristic function for the semigroup  $\mathcal{U}_{\infty}^{\alpha,m}$  (see also p-adic case in [\[20\]](#page-18-8)). The purpose of this work is to obtain spectral data of matrices visualizing the •-multiplications and separating points of  $\mathcal{U}_{\infty}^{\alpha,m}$  and of  $\mathcal{GL}_{\infty}^{\alpha,m}$ . In fact, for each conjugacy class we assign a rational functions  $\chi^{(j)}$ : Mat $(jm) \to \text{Mat}(j\alpha)$  and a divisors  $\xi^{(j)}$  in Mat $(jm)$ . The main statements are Theorems [2.10,](#page-9-0) [2.11.](#page-10-0)

Notice that the spectral data for collections of matrices were widely discussed, see different approaches in surveys [\[1\]](#page-16-0), [\[10\]](#page-17-11). It seems that our approach produces another kind of spectral data. On the other hand, it extends classical approach of operator theory existing for  $m = 1$ .

1.8. Structure of the paper. Section 2 contains a construction of 'spectral data', and main Theorems [2.10,](#page-9-0) [2.11.](#page-10-0) Proofs are contained in Section 3. Some extensions of our construction are discussed in Section 4.

# 2 Spectral data

**2.1. Categorical quotient.** Notice that the spaces  $\mathcal{M}_N$  are non-Hausdorff. There are many ways to construct Hausdorff spaces from set-theoretical quotients. We will use the following approach (see, e.g., [\[25\]](#page-18-9)).

Let a reductive group  $G$  act on an affine algebraic variety  $X$ . Consider the algebra  $\mathbb{C}[X]^G$  of G-invariant regular functions on X. The *categorical quotient*  $[X/G]$  is the set of maximal ideals of  $\mathbb{C}[X]^G$ .

We consider categorical quotients  $[\mathcal{M}_N]$  of  $\text{Mat}(\alpha + mN)$  by  $\text{GL}(N, \mathbb{C})$  and  $[\mathcal{GL}_N]$  of  $GL(\alpha + mN, \mathbb{C})$  by  $GL(N, \mathbb{C})$ .

<span id="page-5-1"></span>Notice that regular functions on  $\text{Mat}(\alpha+m)$  are polynomials. The algebra of regular functions on  $GL(\alpha+mN, \mathbb{C})$  is generated by polynomials and  $det(g)^{-1}$ .

**Proposition 2.1** a) The natural map  $[\mathcal{M}_N] \to [\mathcal{M}_{N+1}]$  is injective.

b) The natural map  $[\mathcal{GL}_N] \to [\mathcal{GL}_{N+1}]$  is injective, and  $[\mathcal{GL}_N] = [\mathcal{M}_N] \setminus \{g :$  $\det g = 0$ .

c) The natural map  $U_N \rightarrow U_{N+1}$  is injective.

The statement is proved in Subsection [3.4.](#page-12-0)

<span id="page-5-2"></span>This allows to define the infinite-dimensional 'categorical quotient'  $[\mathcal{M}_{\infty}]$  as the inductive limit. On the other hand this shows that the topological quotient  $\mathcal{U}_{\infty}$  is Hausdorff.

Proposition 2.2 The ∘-multiplication determines a map of categorical quotients,

$$
[{\mathcal M}_{N_1}^{\alpha,m}] \times [{\mathcal M}_{N_2}^{\alpha,m}] \rightarrow [{\mathcal M}_{N_1+N_2}^{\alpha,m}].
$$

The statement is proved in Subsection [3.5.](#page-13-0)

**2.2.** Characteristic functions. Fix  $g \in Mat(\alpha + mN)$  given by [\(1.2\)](#page-2-1). Let S range in Mat $(m)$ . We write the following equation:

$$
\begin{pmatrix} q \\ x_1 \\ \vdots \\ x_m \end{pmatrix} = \begin{pmatrix} a & b_1 & \dots & b_m \\ c_1 & d_{11} & \dots & d_{1m} \\ \vdots & \vdots & \ddots & \vdots \\ c_m & d_{m1} & \dots & d_{mm} \end{pmatrix} \begin{pmatrix} p \\ s_{11}x_1 + \dots + s_{1m}x_m \\ \vdots \\ s_{m1}x_1 + \dots + s_{mm}x_m \end{pmatrix} .
$$
 (2.1)

Eliminating variables  $x_1, \ldots, x_m$ , we get a relation

$$
q = \chi_g(S) p,
$$

where  $\chi_g(S)$  is a rational matrix-valued function,  $\text{Mat}(m) \to \text{Mat}(\alpha)$ . We call  $\chi_g$  by the characteristic function of g.

The following statements were obtained in [\[16\]](#page-17-9).

**Proposition 2.3** The characteristic function of g depends only on a  $GL(N, \mathbb{C})$ conjugacy class of g (and not on g itself).

**Proposition 2.4** Consider the natural map  $I_N : \mathcal{M}_N \to \mathcal{M}_{N+1}$ . Then

$$
\chi_{I_N g}(S) = \chi_g(S).
$$

This is obvious.

Theorem 2.5

$$
\chi_{g \circ h}(S) = \chi_g(S) \chi_h(S).
$$

**Theorem 2.6** Let  $g$  be unitary. Then

- a) If  $||S|| \leq 1$ , then  $||\chi_g(S)|| \leq 1$ .
- b) If S is unitary, then  $\chi_g(S)$  is unitary.

REMARK. The space  $B_n$  of  $n \times n$  matrices with norm  $\lt 1$  is a well-known object, it is an Hermitian symmetric space  $U(n, n)/U(n) \times U(n)$ , also they are called homogeneous Cartan domains of the first kind. The unitary group  $U(n)$ is a Shilov boundary of this domain. Characteristic functions are holomorphic maps  $B_m \to B_\alpha$ , which send the Shilov boundary to the Shilov boundary. For  $m = 1$  such functions ('inner functions') are well-known topic of function theory, see [\[6\]](#page-17-12), [\[26\]](#page-18-10).  $\Diamond$ 

Denoting  $\widetilde{S} := S \otimes 1_N$ , we represent [\(2.1\)](#page-5-0) as

$$
q = ap + b\widetilde{S}x
$$

$$
x = cp + d\widetilde{S}x
$$

 $x = (1 - d\widetilde{S})^{-1}cp$ 

Therefore

and

<span id="page-6-1"></span>
$$
\chi_g(S) = a + b\widetilde{S}(1 - d\widetilde{S})^{-1}c.
$$
\n(2.2)

2.3. The language of Grassmannians. Now we reformulate the definition of characteristic function. For a linear space  $W$  denote by  $Gr(W)$  the set of all subspaces in W. For an even-dimensional space denote by  $\text{Gr}^{1/2}(W)$  the set of subspaces having dimension  $\frac{1}{2}$  dim W.

Consider the Grassmannian  $\text{Gr}^{1/2}(V \oplus V)$  in the linear space  $V \oplus V$ . For any  $L \in \text{Gr}^{1/2}(V \oplus V)$  consider the subspace

$$
L\otimes Z_N\subset (V\oplus V)\otimes Z_N=(V\otimes Z_N)\oplus (V\otimes Z_N)
$$

We write the equation

$$
\begin{pmatrix} q \\ x_1 \\ \vdots \\ x_m \end{pmatrix} = \begin{pmatrix} a & b_1 & \dots & b_m \\ c_1 & d_{11} & \dots & d_{1m} \\ \vdots & \vdots & \ddots & \vdots \\ c_m & d_{m1} & \dots & d_{mm} \end{pmatrix} \begin{pmatrix} p \\ y_1 \\ \vdots \\ y_m \end{pmatrix} . \tag{2.3}
$$

Consider the set  $\mathcal{X}_q(L)$  of all  $(q, p)$  such that there are  $(x, y) \in L \otimes Z_N$  satisfying [\(2.3\)](#page-6-0). The set  $\mathcal{X}_g(L)$  is a subspace in  $\mathbb{C}^{\alpha} \oplus \mathbb{C}^{\alpha}$ . The following statement is straightforward.

**Proposition 2.7** Let L be a graph of an operator  $S: V \to V$ . Assume that S is a non-singular point of  $\chi_g$ . Then  $\mathcal{X}_g(L)$  is the graph of the operator  $\chi_g(S)$ :  $\mathbb{C}^{\alpha} \to \mathbb{C}^{\alpha}$ .

Thus  $\mathcal{X}_g$  is a rational map  $\mathrm{Gr}^{1/2}(V \oplus V) \to \mathrm{Gr}^{1/2}(\mathbb{C}^{\alpha} \oplus \mathbb{C}^{\alpha})$ .

2.4. The distinguished divisor. Generally, the characteristic function does not determine an element of  $\mathcal{U}_N$  (and, also of the space  $[\mathcal{M}_N]$ ). Indeed, consider the following matrix of size  $\alpha + (k+l) + (k+l)$ :

$$
\begin{pmatrix} a & b_1 & 0 & b_2 & 0 \ c_1 & d_{11} & 0 & d_{12} & 0 \ 0 & 0 & e_{11} & 0 & e_{12} \ c_2 & d_{21} & 0 & d_{22} & 0 \ 0 & 0 & e_{21} & 0 & e_{22} \end{pmatrix} \in \mathcal{U}_{k+l}^{\alpha,2}.
$$

Then its characteristic functions does not depend on the matrix  $\begin{pmatrix} e_{11} & e_{12} \ e_{21} & e_{22} \end{pmatrix}$ . Therefore additional invariants are necessary.

Let  $g \in \text{Mat}(\alpha + mN)$ . We write the equation

$$
\begin{pmatrix} x_1 \\ \vdots \\ x_m \end{pmatrix} = \begin{pmatrix} d_{11} & \dots & d_{1m} \\ \vdots & \ddots & \vdots \\ d_{m1} & \dots & d_{mm} \end{pmatrix} \begin{pmatrix} s_{11}x_1 + \dots + s_{1m}x_m \\ \vdots \\ s_{m1}x_1 + \dots + s_{mm}x_m \end{pmatrix}
$$
(2.4)

and consider the set  $\xi_g$  of all S such that this equation has a nonzero solution.

Next, we reformulate the definition in a more precise form. Consider the polynomial  $p_g$  on  $\text{Mat}(m)$  determined by the equation

$$
p_g(S) = \det(1 - d\widetilde{S}) =
$$
  
= 
$$
\begin{pmatrix} 1_{mN} - \begin{pmatrix} d_{11} & \cdots & d_{1m} \\ \vdots & \ddots & \vdots \\ d_{m1} & \cdots & d_{mm} \end{pmatrix} \begin{pmatrix} s_{11} \cdot 1_N & \cdots & s_{1m} \cdot 1_N \\ \vdots & \ddots & \vdots \\ s_{m1} \cdot 1_N & \cdots & s_{mm} \cdot 1_N \end{pmatrix} \end{pmatrix}
$$

The set  $\xi_g$  is the set of zeros of the polynomial  $p_g$ . It is more natural to consider the set  $\xi_g$  as a *divisor* (see, e.g. [\[8\]](#page-17-13)), i.e. we decompose  $p_g(S)$  as a product of irreducible factors

$$
p_g(S) = \prod_i h_i(S)^{v_i},
$$

where  $h_i$  are pairwise distinct. Then we consider the collection of hypersurfaces<sup>[2](#page-7-0)</sup>  $h_i(S) = 0$  with assigned multiplicities  $v_i$ .

Evidently,

$$
p_{g \circ h}(S) = p_g(S) p_h(S).
$$

Equivalently,

$$
\xi_{g \circ h} = \xi_g + \xi_h.
$$

The sign  $+$  means that we consider the union of hypersurfaces taking in accounts their multiplicities.

Proposition 2.8 The following identity holds

$$
\det \chi_g(S) = \frac{\det \begin{pmatrix} a & -b\widetilde{S} \\ c & 1 - d\widetilde{S} \end{pmatrix}}{\det(1 - d\widetilde{S})}.
$$
 (2.5)

In particular, the denominator of the rational function  $\det \chi_q(S)$  is a divisor of  $p_q = \det(1 - \widetilde{S}).$ 

PROOF. Applying the formula for the determinant of a block matrix

$$
\det\begin{pmatrix} A & B \\ C & D \end{pmatrix} = \det(D)\det(A - BD^{-1}C),
$$

we get

$$
\det\begin{pmatrix} a & -b\widetilde{S} \\ c & 1 - d\widetilde{S} \end{pmatrix} = \det(1 - d\widetilde{S}) \cdot \det\Big[a + b\widetilde{S}(1 - d\widetilde{S})^{-1}c\Big].
$$

By [\(2.2\)](#page-6-1), the expression in the square brackets is the characteristic function.  $\Box$ 

Let us pass to the language of Grassmannians. Consider another matrix coordinate  $\Lambda = S^{-1}$  on Grassmannian. Then the equation for the divisor passes to the form

$$
\det(d-\Lambda) = \left( \begin{pmatrix} d_{11} & \cdots & d_{1m} \\ \vdots & \ddots & \vdots \\ d_{m1} & \cdots & d_{mm} \end{pmatrix} - \begin{pmatrix} \lambda_{11} & 1_N & \cdots & \lambda_{1m} & 1_N \\ \vdots & \ddots & \vdots \\ \lambda_{m1} & 1_N & \cdots & \lambda_{mm} & 1_N \end{pmatrix} \right) = 0.
$$

Two equations

$$
\det(1 - dS) = 0, \qquad \det(d - \Lambda) = 0
$$

determine a divisor  $\Xi_g$  in  $\text{Gr}^{1/2}(V \oplus V)$ . Indeed, we have two charts in  $\text{Gr}^{1/2}(V \oplus V)$ V), one consists of graphs of operators  $V \oplus 0 \to 0 \oplus V$ , another from graphs of operators  $0 \oplus V \to V \oplus 0$ . These charts do not cover the whole Grassmannian, but the complement of their union has codimension 2. Therefore any hypersurface in  $\text{Gr}^{1/2}(V \oplus V)$  has an intersection with at least one of the charts. In fact, all hypersurfaces in  $\text{Gr}^{1/2}(V \oplus V)$  are observable in the chart S, except the hypersurface det  $\Lambda = 0$  (it is a complement to the chart S).

The degree of the polynomial  $p_g$  for a generic g is mN. If the divisor  $\Xi_g$ contains the component det  $\Lambda = 0$  with multiplicity l, then the degree of  $p_g$  is  $m(N-l).$ 

**2.5.** Characteristic functions for  $\mathcal{M}_{\infty}$ . We have a natural embedding

$$
I_N:\mathcal{M}_N\to \mathcal{M}_{N+1}
$$

induced by the embedding  $Z_N \to Z_{N+1}$ . Evidently,

$$
\chi_{I_N g}(S) = \chi_g(S).
$$

Therefore, we can define a characteristic function for elements of  $\mathcal{M}_{\infty} = \bigcup_N \mathcal{M}_N$ . On the other hand, we can repeat the definition of characteristic function for  $N = \infty$ , this produces the same result.

Next,

 $p_{I_N g}(S) = p_g(S) \cdot \det(1 - S).$ 

Denoting by  $\delta$  the divisor det $(1 - S) = 0$  we get

$$
\Xi_{I_N g} = \Xi_g + \delta.
$$

Thus we can define a 'divisor'  $\Xi_g \subset \text{Gr}^{1/2}(V \oplus V)$  for  $g \in \mathcal{M}_{\infty}$ . Notice that its component  $\delta$  has multiplicity  $\infty$ . Except  $\delta$ , we have finite number of components of finite multiplicity.

REMARK. In the same way,  $\xi_{I_{N}g} = \xi_{g} + \delta$ . We can define  $\xi_{g}$  for  $g \in \mathcal{M}_{\infty}$ . However, acting in this way we loss information concerning the multiplicity of the divisor det  $\Lambda = 0$ .

#### <span id="page-9-3"></span>2.6. Multiple characteristic functions.

**Proposition 2.9** For fixed  $\alpha$ , m and sufficiently large N the Taylor coefficients of the characteristic function  $\chi_{\mathfrak{q}}$  and of the polynomial  $p_{\mathfrak{q}}$  at zero do not generate the algebra of  $GL(N)$ -invariant polynomials on  $Mat(\alpha + mN)$ .

Proof is given in Subsection [3.6.](#page-13-1)

For this reason, we introduce additional invariants. Let  $j = 1, 2, \ldots$  For  $g \in GL(\infty, \mathbb{C})$  we consider the direct sum

$$
g^{[j]} := g \oplus \cdots \oplus g
$$

of  $j$  copies of  $q$ . It acts in the space

$$
\[ \mathbb{C}^{\alpha} \oplus (V \otimes Z_{N}) \] \oplus \cdots \oplus \left[ \mathbb{C}^{\alpha} \oplus (V \otimes Z_{N}) \right] = \mathbb{C}^{j\alpha} \oplus ((V \oplus \cdots \oplus V) \otimes Z_{N}) =
$$
  
=  $\mathbb{C}^{j\alpha} \oplus ((V \otimes \mathbb{C}^{j}) \otimes Z_{N}).$ 

Thus we get an embedding

$$
\mathcal{M}_N^{\alpha,m} \to \mathcal{M}_N^{j\alpha,jm}.
$$

It is compatible with ∘-multiplication.

Now for a given  $g \in \mathcal{M}_N^{\alpha,m}$  we get the collection of characteristic functions

$$
\Xi_g, \Xi_{g^{[2]}}, \Xi_{g^{[3]}}, \dots; \qquad \Xi_{g^{[j]}} \subset \mathrm{Gr}\big((V \otimes \mathbb{C}^j) \oplus (V \otimes \mathbb{C}^j)\big). \tag{2.7}
$$

**Theorem 2.10** a) For any  $\alpha$ ,  $m$ ,  $N$  the characteristic functions [\(2.6\)](#page-9-1) and di-visors [\(2.7\)](#page-9-2) uniquely determine an element of the categorical quotient  $[\mathcal{M}_N^{\alpha,m}]$ 

b) The characteristic functions [\(2.6\)](#page-9-1) and divisors [\(2.7\)](#page-9-2) uniquely determine an element of the categorical quotient  $[\mathcal{G} \mathcal{L}_N^{\alpha,m}]$ 

<span id="page-10-0"></span>Proof is contained in Subsections [3.1](#page-13-2)[–3.2.](#page-14-0)

**Theorem 2.11** a) The characteristic functions  $(2.6)$  and divisors  $(2.7)$  uniquely determine an element of the space  $\mathcal{U}_N^{\alpha,m}$  of conjugacy classes.

b) The characteristic functions [\(2.6\)](#page-9-1) and divisors [\(2.7\)](#page-9-2) uniquely determine an element of the space  $\mathcal{U}_{\infty}^{\alpha,m}$  of conjugacy classes.

Proof is contained in Subsection [3.3.](#page-15-0)

### 3 Invariants

**3.1. Invariants for**  $\mathcal{M}_N^{\alpha,m}$ **.** Denote

$$
a^{[j]} = a \otimes 1_j
$$
,  $b^{[j]} = b \otimes 1_j$ ,  $c^{[j]} = c \otimes 1_j$ ,  $d^{[j]} = d \otimes 1_j$ .

Denote by  $b_{\beta}[k]$  the k-th row of the matrix  $b_{\beta}$ , by  $c_{\gamma}[l]$  the l-th column of the matrix  $c_{\gamma}$ . Let us regard Mat $(\alpha+mN)$  as a linear space with action of GL(N, C). A point of the space is a collection of  $m^2$  matrices  $d_{ij}$ ,  $\alpha m$  vectors  $c_i[l]$ , and  $\alpha m$ of covectors  $b_j[k]$ . Generators of the algebra of invariants are known (see, e.g., [\[28\]](#page-18-11), Section 11.8.1). The algebra is generated by the following polynomials

$$
\operatorname{tr} d_{\varphi_1 \psi_1} d_{\varphi_2 \psi_2} \dots d_{\varphi_n \psi_n},\tag{3.1}
$$

$$
b_{\beta}[k]d_{\varphi_1\psi_1}d_{\varphi_2\psi_2}\dots d_{\varphi_n\psi_n}c_{\gamma}[l],\tag{3.2}
$$

<span id="page-10-3"></span>
$$
a_{\sigma\tau}.\tag{3.3}
$$

We wish to show that all the generators can be expressed in the terms of Taylor coefficients of  $\chi_{g}[j]}(S)$  and  $p_{g}[j]}(S)$  at zero.

First, consider the expression

<span id="page-10-2"></span>
$$
\ln p_{g^{[j]}}(S) = \ln \det(1 - d^{[j]}\widetilde{S}),\tag{3.4}
$$

where S is an operator in  $V \otimes \mathbb{C}^j$ .

It is convenient to think that matrix elements  $s^{\mu\nu}_{\varphi\psi}$  of S depend on 4 indexes: indices  $\varphi, \psi \leq m$  are responsible for an operator in the space  $\mathbb{C}^m$ , and  $\mu, \nu \leq j$ for operators in the space  $\mathbb{C}^j$ . In a neighborhood of  $S=0$  we have the following expansion

$$
\ln \det(1 - d^{[j]}\widetilde{S}) = \sum_{n>0} \frac{(-1)^n}{n} \operatorname{tr}(d^{[j]}\widetilde{S})^n =
$$
\n
$$
= \sum_{\substack{n \geq 0, \\ \mu_1, \dots, \mu_n \leq j}} \frac{(-1)^n}{n} s_{\varphi_1, \psi_1}^{\mu_1, \mu_2} s_{\varphi_2, \psi_2}^{\mu_2, \mu_3} \dots s_{\varphi_n, \psi_n}^{\mu_n, \mu_1} \times
$$
\n
$$
\varphi_1, \dots, \varphi_n, \psi_1, \dots, \psi_n \leq m,
$$
\n
$$
\mu_1, \dots, \mu_n \leq j
$$
\n
$$
\times \operatorname{tr} d_{\psi_1, \varphi_2} d_{\psi_2, \varphi_3} \dots d_{\psi_n, \varphi_1}.
$$
\n(3.5)

Generally, Taylor coefficients (in  $s^{\mu\nu}_{\varphi\psi}$ ) of this series are sums of several traces. However, assume that all elements of the sequence

$$
\mu_1,\ldots,\mu_n
$$

are pairwise distinct. Then the coefficient at

$$
s^{\mu_2,\mu_3}_{\varphi_2,\psi_2}\dots s^{\mu_n,\mu_1}_{\varphi_n,\psi_n}
$$

is

$$
\operatorname{tr} d_{\psi_1, \varphi_2} d_{\psi_2, \varphi_3} \dots d_{\psi_n, \varphi_1}.
$$

We observe that all the invariants  $(3.1)$  are contained in the set of Taylor coefficients of [\(3.4\)](#page-10-2).

Next we consider the characteristic function

$$
\chi_{g^{[j]}}(S) = a^{[j]} + b^{[j]} \widetilde{S} (1 - d^{[j]} \widetilde{S})^{-1} c^{[j]}.
$$

Substituting  $S = 0$ , we get invariants [\(3.3\)](#page-10-3). Next, expand the matrix

$$
X := b^{[j]} \widetilde{S}(1 - d^{[j]} \widetilde{S})^{-1} c^{[j]} = \sum_{n=0}^{\infty} b^{[j]} \widetilde{S}(d^{[j]} \widetilde{S})^n c^{[j]}
$$
(3.6)

in a Taylor series. The operator X acts in  $\mathbb{C}^m \otimes \mathbb{C}^j$ . We enumerate its matrix elements as  $x_{kl}^{\gamma \delta}$ , where k,  $l \leq \alpha$  and  $\gamma$ ,  $\delta \leq \gamma$ . The matrix elements are

x γδ kl = X n > 0 ϕ1, . . . , ϕn+1 6 m ψ1, . . . , ψn+1 6 m µ2, . . . , µ<sup>n</sup> 6 j s γ,µ<sup>2</sup> ϕ1,ψ<sup>1</sup> s µ2,µ<sup>3</sup> ϕ2,ψ<sup>2</sup> . . . s µn,δ ϕn+1,ψn+1 × × bϕ<sup>1</sup> [k]dψ1,ϕ<sup>2</sup> dψ2,ϕ<sup>3</sup> . . . dψn,ϕn+1cψn+1[l]

Again, consider a coefficient of the Taylor series at

$$
s_{\varphi_1,\psi_1}^{\gamma,\mu_2} s_{\varphi_2,\psi_2}^{\mu_2,\mu_3} \dots s_{\varphi_{n+1},\psi_{n+1}}^{\mu_n,\delta}
$$

with pairwise distinct  $\mu_2, \ldots, \mu_n$  that do not equal  $\gamma$ ,  $\delta$ . The factors  $d_{\ldots}$  in the coefficient and their order are are uniquely determined.

This proves Theorem [2.10.](#page-9-0)a.

**3.2.** Invariants for invertible matrices. Now consider the space  $\mathcal{GL}_N^{\alpha,m}$ . Invariant regular functions on this space have the form  $p(g)/\det(g)^k$ , where  $p(g)$ is a polynomial satisfying

$$
p(\iota(u) g \iota(u)^{-1}) = p(g), \quad \text{where } u \in \text{GL}(N, \mathbb{C}),
$$

 $u(u)$  is given by [\(1.3\)](#page-2-2). Thus the algebra of invariant finctions is generated by the same invariants and  $\det(g)^{-1}$ .

3.3. Invariants for unitary group. Consider invariants of  $U(N)$  on  $U(\alpha + mN)$ . Consider the algebra A of functions on  $U(n)$  generated by matrix elements and  $\det(g)^{-1}$ . By the Peter-Weyl theorem it is dense in the algebra of continuous functions.

Consider two orbits  $\mathcal{O}_1, \mathcal{O}_2 \subset U(\alpha + mN)$  of  $U(N)$ , consider an invariant continuous function  $\varphi$  separating these orbits. Consider a function  $\psi \in \mathcal{A}$ approximating  $\varphi$ , it satisfies a condition of the form

$$
\psi\Big|_{\mathcal{O}_1} \leqslant a < b \leqslant \psi\Big|_{\mathcal{O}_2}.
$$

We have

$$
\psi(g) = \frac{p(g)}{(\det g)^k},
$$

where  $p$  is a polynomial. The average

$$
f(g) = \int_{\mathrm{U}(N)} \psi\big(\iota(h)\, g\,\iota(h)^{-1}\big)\, dh
$$

has the same form  $\frac{q(g)}{(\det g)^k}$  with a polynomial q. Therefore f has an invariant regular continuation to the whole group  $GL(\alpha + mN, \mathbb{C})$ . If  $N > \alpha m$ , then all such functions are polynomials in Taylor coefficients of  $\chi_g(S)$  and  $p_g(S)$ .

<span id="page-12-0"></span>**3.4.** Change of N. Next, we wish to show that the map  $I_N : [\mathcal{M}_N^{\alpha,m}] \to$  $[\mathcal{M}_{N+1}^{\alpha,m}]$  is an embedding (Proposition [2.1\)](#page-5-1). The map  $I_N$  replaces

$$

\n

d_{\varphi\varphi} \to \begin{pmatrix} d_{\varphi\varphi} & 0 \\ 0 & 1 \end{pmatrix}.
$$

Restrict generators [\(3.1\)](#page-10-1)–[\(3.3\)](#page-10-3) of invariants on Mat $(\alpha + m(N + 1))$  to Mat $(\alpha +$  $mN$ ). We get the same expressions in all the cases except traces of the form

$$
\operatorname{tr} d_{\varphi_1\varphi_1} d_{\varphi_2\varphi_2} \dots d_{\varphi_n\varphi_n},
$$

they are shifted by 1. Therefore, restricting a collection of generators of  $GL(N +$ 1, C)-invariants of Mat $(\alpha+m(N+1))$  we get a collection of generators for algebra of GL(N, C)-invariants on Mat( $\alpha + mN$ ).

Thus we proved the desired statement.

<span id="page-13-0"></span>3.5. Categorical quotient. Proposition [2.2](#page-5-2) follows from Theorem [2.10](#page-9-0) (invariants of ◦-products are uniquely determined by invariants of factors).

<span id="page-13-1"></span>**3.6. Proof of Proposition [2.9.](#page-9-3)** Consider the algebra of  $U(N)$ -invariants on Mat $(\alpha + mN)$ . The number of the standard generators of the degree l has asymptotics  $\sim$  const  $\cdot$   $(m^2)^l$  as  $l \to \infty$ .

The Taylor coefficients of the characteristic function are polynomials of generators. Number of the Taylor coefficients equals to  $\alpha^2 C_{m^2+l-1}^{l-1}$ , it is a polynomial in  $l$  of degree  $m^2$ .

The minimal (graded) degree of a relation between standard generators [\(3.1\)](#page-10-1) is  $N + 1$ , see [\[27\]](#page-18-12), Theorem 4.3.

It remains to choose a sufficiently large  $N$  such that number of independent monomials of the independent generators [\(3.1\)](#page-10-1) of degree  $\leq N$  is larger than number of monomials of the Taylor coefficients of degree  $\leq N$ .

### 4 Variations

Let  $A_1, \ldots, A_l$  be square matrices. By  $Diag(A_1, \ldots, A_n)$  we denote the blockdiagonal matrix with blocks  $A_1, \ldots, A_l$ .

<span id="page-13-2"></span>4.1. Several matrices determined up to a common conjugation. Let  $G = U(\infty)$ , and K be the stabilizer of the first  $\alpha$  basis vectors as in Subsection [1.2.](#page-14-0) Consider the product  $G^n = G \times \cdots \times G$  of n copies of G and the subgroup K embedded to  $G \times \cdots \times G$  by diagonal,  $h \mapsto (h, \ldots, h)$ . Consider the space  $G<sup>n</sup> // K$  of conjugacy classes

$$
(g_1, \ldots, g_n) \sim (h g_1 h^{-1}, \ldots, h g_n h^{-1}).
$$

It is equipped with the component-wise product

<span id="page-13-3"></span>
$$
(g_1, \ldots, g_n) * (r_1, \ldots, r_n) := (g_1 \circ r_1, \ldots, g_n \circ r_n), \tag{4.1}
$$

where  $\circ$ -multiplication of matrices is given by the formula  $(1.1)$ .

To be definite, set  $n = 2$ . Consider a pair of matrices

$$
\begin{pmatrix} a_1 & b_1 \ c_1 & d_1 \end{pmatrix}, \qquad \begin{pmatrix} a_2 & b_2 \ c_2 & d_2 \end{pmatrix}
$$

determined up to a common conjugation by a matrix  $\begin{pmatrix} 1 & 0 \\ 0 & \cdots \end{pmatrix}$  $0 u$  $\setminus$ . We compose a matrix

$$
\begin{pmatrix} a_1 & 0 & b_1 & 0 \ 0 & a_2 & 0 & b_2 \ c_1 & 0 & d_1 & 0 \ 0 & c_2 & 0 & d_2 \end{pmatrix}.
$$

It is determined up to a conjugation by a matrix

$$
Diag(1_{\alpha}, 1_{\alpha}, u, u) = Diag(1_{2\alpha}, u, u).
$$

Thus we embedded the semigroup  $G^n//K$  to the semigroup  $\mathcal{U}_{\infty}^{\alpha n,n}$ . We know that multiple characteristic functions and distinguished divisors separate elements of  $\mathcal{U}_{\infty}^{\alpha n,n}$  and therefore they separate elements of  $G^{n}/K$ . We get the analog of Theorem [2.11.](#page-10-0) Analog of theorem [2.10](#page-9-0) also holds but it requires a separate proof.

<span id="page-14-0"></span>4.2. Another example with conjugacy classes. Now consider the group  $Q_{\alpha,m,m}$  of finitary unitary matrices of size

$$
\alpha + \underbrace{\infty + \cdots + \infty}_{m \text{ times}} + \underbrace{\infty + \cdots + \infty}_{m \text{ times}}
$$

determined up to conjugations by the group  $H$  of unitary matrices of the form

$$
\overline{\text{Diag}}(1, \underbrace{u, \ldots, u}_{m \text{ times}}, \underbrace{v, \ldots, v}_{m \text{ times}}),
$$

i.e.,  $H \simeq \mathrm{U}(\infty) \times \mathrm{U}(\infty)$ . The formula for multiplication on  $Q_{\alpha,m,m}//H$  is the same as in Subsection [1.3.](#page-15-0)

Now we explain how to obtain a characteristic function. To be definite, set  $m = 2$ . We fix two  $m \times m$  matrices, T, S, set

$$
\Lambda = T^{-1}, \qquad K = S^{-1},
$$

and write the equation

$$
\begin{pmatrix} q \\ x_1 \\ x_2 \\ y_1 \\ y_2 \end{pmatrix} = \begin{pmatrix} a_1 & b_1 & b_2 & b_3 & b_4 \\ c_1 & d_{11} & d_{12} & d_{13} & d_{14} \\ c_2 & d_{21} & d_{22} & d_{23} & d_{24} \\ c_1 & d_{31} & d_{32} & d_{33} & d_{34} \\ c_1 & d_{41} & d_{42} & d_{43} & d_{44} \end{pmatrix} \begin{pmatrix} p \\ s_{11}x_1 + s_{12}x_2 \\ s_{21}x_1 + s_{22}x_2 \\ t_{11}y_1 + t_{12}y_2 \\ t_{21}y_1 + t_{22}y_2 \end{pmatrix}
$$
(4.2)

(big matrix is an element  $g \in Q_{\alpha,m,m}$ ). We eliminate variables  $s_{ij}, t_{ij}$  and get a relation

$$
q = \chi_{\mathfrak{g}}(S, T) p.
$$

Thus we get a rational function  $\text{Mat}(m) \times \text{Mat}(m) \to \text{Mat}(\alpha)$ , it sends  $B_m \times B_m$ to  $B_{\alpha}$  and  $U(m) \times U(m) \rightarrow U(\alpha)$ . As above, a product of conjugacy classes corresponds to a point-wise product of functions. See several proofs of similar statements in [\[16\]](#page-17-9).

We also define a distinguished divisor

$$
\Xi_g \in \text{Gr}^{1/2}(\mathbb{C}^m \oplus \mathbb{C}^m) \times \text{Gr}^{1/2}(\mathbb{C}^m \oplus \mathbb{C}^m).
$$

In the coordinates,  $(T, S) \in Mat(n) \times Mat(n)$  it is determined by the equation

$$
\det\left[1-\begin{pmatrix}d_{11} & d_{12} & d_{13} & d_{14} \\ d_{21} & d_{22} & d_{23} & d_{24} \\ d_{31} & d_{32} & d_{33} & d_{34} \\ d_{41} & d_{42} & d_{43} & d_{44}\end{pmatrix}\begin{pmatrix}s_{11} & s_{12} & 0 & 0 \\ s_{21} & s_{22} & 0 & 0 \\ 0 & 0 & t_{11} & t_{12} \\ 0 & 0 & t_{21} & t_{22}\end{pmatrix}\right]=0.
$$

In coordinates  $(\Lambda, K) \in \text{Mat}(m) \times \text{Mat}(m)$  we get the equation

$$
\det\begin{bmatrix}\begin{pmatrix}\lambda_{11} & \lambda_{12} & 0 & 0\\ \lambda_{21} & \lambda_{22} & 0 & 0\\ 0 & 0 & \varkappa_{11} & \varkappa_{12}\\ 0 & 0 & \varkappa_{21} & \varkappa_{22}\end{pmatrix}-\begin{pmatrix}\nd_{11} & d_{12} & d_{13} & d_{14}\\ d_{21} & d_{22} & d_{23} & d_{24}\\ d_{31} & d_{32} & d_{33} & d_{34}\\ d_{41} & d_{42} & d_{43} & d_{44}\end{pmatrix}\end{bmatrix}=0.
$$

These two charts cover the product of Grassmannians up to a subvariety of codimenion 2. This is sufficient to define a divisor.

As in Subsection [2.6,](#page-13-1) we consider elements

$$
\mathfrak{g}^{[j]} = \underbrace{\mathfrak{g} \oplus \cdots \oplus \mathfrak{g}}_{j \text{ times}} \in Q_{j\alpha, jm, jm}//H.
$$

**Theorem 4.1** The collection of characteristic functions  $\chi_{\mathfrak{g}}[j]}$  and the distinguished divisors  $\Xi_{\frak{gl}}$  uniquely determine a conjugacy class  $\frak g\in Q_{\alpha,m,m}//U(\infty)\times U$  $U(\infty)$ .

A proof repeats considerations of Section 3.

<span id="page-15-0"></span>4.3. Example with double cosets. Consider the group  $G = U(\infty)$  and its subgroup L consisting of matrices  $\begin{pmatrix} 1_{\alpha} & 0 \\ 0 & \alpha \end{pmatrix}$  $0 \quad u$  $\overline{ }$ , where  $u$  is real orthogonal. Consider the group  $G^n = G \times \cdots \times G$  (*n* times) and the subgroup L embedded to  $G^n$  by diagonal. Consider double cosets  $L \setminus G/L$ , i.e., we consider tuples

$$
\left(\begin{pmatrix} a_1 & b_1 \\ c_1 & d_1 \end{pmatrix}, \dots, \begin{pmatrix} a_n & b_n \\ c_n & d_n \end{pmatrix}\right)
$$

up to the equivalence

$$
\left(\begin{pmatrix} a_1 & b_1 \ c_1 & d_1 \end{pmatrix}, \dots, \begin{pmatrix} a_n & b_n \ c_n & d_n \end{pmatrix}\right) \simeq
$$
  
\n
$$
\simeq \left(\begin{pmatrix} 1_\alpha & 0 \ 0 & u \end{pmatrix} \begin{pmatrix} a_1 & b_1 \ c_1 & d_1 \end{pmatrix} \begin{pmatrix} 1_\alpha & 0 \ 0 & v \end{pmatrix}, \dots, \begin{pmatrix} 1_\alpha & 0 \ 0 & u \end{pmatrix} \begin{pmatrix} a_n & b_n \ c_n & d_n \end{pmatrix} \begin{pmatrix} 1_\alpha & 0 \ 0 & v \end{pmatrix} \right),
$$

where  $u, v \in O(\infty)$ . The set  $L \setminus G^n/L$  is equipped with component-wise multiplication as [\(4.1\)](#page-13-3).

Again, set  $n = 2$ . We define a characteristic function as in [\[16\]](#page-17-9). For this purpose, we fix  $2 \times 2$  matrices T, S and write the equation

c_1 & d_1\n\end{pmatrix}^{t-1}\n\begin{pmatrix}\na_2 & b_2 \\
c_2 & d_2\n\end{pmatrix}^{t-1}\n\begin{pmatrix}\na_2 & b_2 \\
c_2 & d_2\n\end{pmatrix}^{t-1}\n\begin{pmatrix}\na_2 & b_2 \\
b_2 & b_2 \\

We eliminate variables  $t_{ij}$ ,  $s_{ij}$  and get the characteristic function

$$
q := \chi(T, S)p,
$$

where p, q are columns,  $q = (p_1^+, p_2^+, p_1^-, p_2^-)^t$ ,  $q = (q_1^+, q_2^+, q_1^-, q_2^-)^t$ .

Then the product in  $L \setminus G/L$  corresponds to the product of characteristic functions (see [\[16\]](#page-17-9)).

Now we write the equation [\(4.3\)](#page-16-1) in the form

The big matrix is determined up to a conjugation by a matrix of the form

$$
Diag(1_{\alpha}, u, 1_{\alpha}, u, 1_{\alpha}, v, 1_{\alpha}, v).
$$

Thus we get an embedding of sets

$$
\iota: L \setminus G^n/L \to Q_{2m\alpha,2m,2m}//H
$$

(this is not a homomorphism of semigroups!). Moreover, characteristic functions of  $\mathfrak{g} \in L \setminus G^n/L$  and of  $\iota(\mathfrak{g})$  coincide (compare [\(4.2\)](#page-14-1) and [\(4.4\)](#page-16-2)). Therefore multiple characteristic functions and multiple distinguished divisors separate double cosets  $L \setminus G^n / L$ .
