Long properly colored cycles in edge colored complete graphs

Abstract

Let K_n^c denote a complete graph on *n* vertices whose edges are colored in an arbitrary way. Let $\Delta^{\text{mon}}(K_n^c)$ denote the maximum number of edges of the same color incident with a vertex of K_n^c . A properly colored cycle (path) in K_n^c is a cycle (path) in which adjacent edges have distinct colors. B. Bollobás and P. Erdös (1976) proposed the following conjecture: if $\Delta^{\text{mon}}(K_n^c) < \lfloor \frac{n}{2} \rfloor$, then K_n^c contains a properly colored Hamiltonian cycle. Li, Wang and Zhou proved that if $\Delta^{\text{mon}}(K_n^c) < \lfloor \frac{n}{2} \rfloor$, then K_n^c contains a properly colored cycle of length at least $\lceil \frac{n+2}{3} \rceil + 1$. In this paper, we improve the bound to $\lceil \frac{n}{2} \rceil + 2$.

1 Introduction

All graphs considered here are finite, undirected, and simple. Let G be a graph with vertex set V and edge set E.

An *edge coloring* of a graph is an assignment of "colors" to the edges of the graph. An *edge colored graph* is a graph with an edge coloring. A cycle (path) in an edge colored graph is *properly colored* if no two adjacent edges in it have the same color.

Grossman and Häggkvist [9] gave a sufficient condition on the existence of a properly colored cycles in edge colored graphs with two colors, and Yeo [17] extended the result to edge colored graph with any number of colors. Given an edge colored graph *G*, let deg^{*c*}(*v*), named the color degree of a vertex *v*, be defined as the maximum number of edges incident to *v* that have distinct colors. The minimum color degree $\delta^c(G)$ is the minimum deg^{*c*}(*v*) over all vertices of *G*. In [12], some minimum color degree conditions for the existence of properly colored cycles are obtained. In particular, they proved that if *G* is an edge colored graph of order *n* satisfying $\delta^c(G) \ge d \ge 2$, then either *G* has a properly colored path of length at least 2*d*, or *G* has a properly colored cycle of length at least $\lceil \frac{2d}{3} \rceil + 1$. In [13], Lo improved the bound $\lceil \frac{2d}{3} \rceil + 1$ to the best possible value d + 1.

Let K_n^c be an edge colored complete graph on *n* vertices, and let c(u, v) be the color assigned to edge *uv*. In [4], Barr gave a simple sufficient condition for the existence of a properly colored Hamiltonian path in K_n^c : K_n^c has no monochromatic triangles. Bang-Jensen, Gutin and Yeo [3] proved that if K_n^c contains a properly colored 2-factor, then it has a properly colored Hamiltonian path. In [7], Feng et al. proved that K_n^c has a properly colored Hamilton path iff K_n^c has a properly colored Hamilton path iff K_n^c has a properly colored almost 2-factor (an almost 2-factor is a spanning subgraph consisting of disjoint cycles and a path).

Bollobás and Erdös [5] proved that if $n \ge 3$ and $\delta^c(K_n^c) \ge \frac{7n}{8}$, then there exists a properly colored Hamiltonian cycle. They also proposed a question: whether the bound $\frac{7n}{8}$ can be improved to $\frac{n+5}{3}$. Fujita and Magnant [8] constructed an edge colored complete graph K_{2m} with $\delta^c(K_{2m}) = m$, which has no

properly colored Hamiltonian cycles. So $\delta^c(K_n) = \lfloor \frac{n}{2} \rfloor$ is not enough. Let $\Delta^{\text{mon}}(K_n^c)$ be the maximum number of edges of the same color incident with a vertex of K_n^c . In the same paper, Bollobás and Erdös proposed the following conjecture.

Conjecture 1 (Bollobás and Erdös [5]). If $\Delta^{\text{mon}}(K_n^c) < \lfloor \frac{n}{2} \rfloor$, then K_n^c has a properly colored Hamiltonian cycle.

Bollobás and Erdös proved that if $\Delta^{\text{mon}}(K_n^c) \leq \frac{n}{69}$ then K_n^c contains a properly colored Hamiltonian cycle. This result was improved by Chen and Daykin [6] and Shearer [15].

As far as we know, the best asymptotic estimate was obtained by Alon and Gutin using the probabilistic method.

Theorem 1.1 (Alon and Gutin [1]). For every positive real number ϵ , there exists $n_0 = n_0(\epsilon)$ so that for every $n > n_0$, if K_n^c satisfies

$$\Delta^{\mathrm{mon}}(K_n^c) \le (1 - \frac{1}{\sqrt{2}} - \epsilon)n,\tag{1}$$

then K_n^c contains a properly colored Hamiltonian cycle.

Li, Wang and Zhou [12] studied long properly colored cycles in edge colored complete graphs and proved that if $\Delta^{\text{mon}}(K_n^c) < \lfloor \frac{n}{2} \rfloor$, then K_n^c contains a properly colored cycle of length at least $\lceil \frac{n+2}{3} \rceil + 1$. For more details concerning properly colored cycles and paths, we refer the reader to [2, 10, 11, 16]. In this paper, we improve the bound on the length of the properly colored cycles and prove the following theorem.

Theorem 1.2. If $\Delta^{\text{mon}}(K_n^c) < \lfloor \frac{n}{2} \rfloor$, then K_n^c contains a properly colored cycle of length at least $\lceil \frac{n}{2} \rceil + 2$.

The main idea is the rotation–extension technique of Pósa [14], which was used on general edge colored graphs in [13].

When *a* and *b* are integers, the notation [a, b] is used to indicate the interval of all integers between *a* and *b*, including both. In particular, [a, a - 1] is an empty set. A properly colored path *P* of length ℓ is viewed as an ℓ -tuple $(v_0, v_1, \ldots, v_\ell)$, which is different from $(v_\ell, v_{\ell-1}, \ldots, v_0)$. For such a properly colored path $P = (v_1, v_2, \ldots, v_\ell)$, denote $\{v \mid c(v_1, v_2) \neq c(v_1, v)\}$ by $N^c(v_1, P)$ and $\{v \mid c(v_\ell, v_{\ell-1}) \neq c(v, v_\ell)\}$ by $N^c(v_\ell, P)$.

2 The Proof of Theorem 1.2

If $3 \le n \le 5$, then K_n^c is a properly colored complete graph, and hence each Hamiltonian cycle is properly colored. Our conclusion holds clearly. So we may assume that $n \ge 6$.

We will prove Theorem 1.2 by contradiction. Suppose that each properly colored cycle is of length at most $\lceil \frac{n}{2} \rceil + 1$. For simplicity, let the vertices of K_n^c be labeled with integers from 1 to *n*. Let P_0 be a longest properly colored path. Without loss of generality, assume that $P_0 = (1, 2, ..., \ell)$.

Put

$$X = \{x_1, x_2, \dots, x_p\} = \{x_i \mid c(1, x_i) \neq c(1, 2)\} = N^c(1, P_0)$$

and

$$Y = \{y_1, y_2, \dots, y_q\} = \{y_i \mid c(y_i, \ell) \neq c(\ell - 1, \ell)\} = N^c(\ell, P_0).$$

Moreover, $x_1, x_2, ..., x_p$ and $y_1, y_2, ..., y_q$ are increasing sequences. Since $\Delta^{\text{mon}}(K_n^c) < \lfloor \frac{n}{2} \rfloor$, we have $\min\{|X|, |Y|\} \ge \lceil \frac{n}{2} \rceil$; consequently, $x_1 < x_p$. Note that $X, Y \subset V(P_0)$ since P_0 is a longest properly colored path. Thus $\ell \ge \lceil \frac{n}{2} \rceil + 2$. Note that either $\ell \notin X$ or $1 \notin Y$; otherwise $(1, 2, ..., \ell, 1)$ is a properly colored cycle of length at least $\lceil \frac{n}{2} \rceil + 2$, which is a contradiction. Hence $\ell \ge \lceil \frac{n}{2} \rceil + 3$.

Let $y_s \in Y$ be the maximum such that $c(\ell, y_i) = c(y_i, y_i + 1)$ for all $y_i \in [y_1, y_s] \cap Y$. Note that y_s is well defined, since $c(\ell, y_1) = c(y_1, y_1 + 1)$; otherwise, $(y_1, y_1 + 1, \dots, \ell, y_1)$ is a properly colored cycle of length at least $\lceil \frac{n}{2} \rceil + 2$. Clearly, $y_s \le \ell - 2$.

Note that $c(1, x_p) = c(x_p - 1, x_p)$ or else $(1, 2, ..., x_p, 1)$ is a properly colored cycle of length at least $\lceil \frac{n}{2} \rceil + 2$, a contradiction. **Claim 1.** $y_s \le x_p - 3$.

Proof of Claim 1. If $x_p = \ell$, then $y_s \le \ell - 3$; otherwise, $(1, 2, \dots, \ell - 2, \ell, 1)$ is a properly colored cycle of length $\ell - 1 \ge \lceil \frac{n}{2} \rceil + 2$, a contradiction. So we may assume that $x_p \le \ell - 1$. Let $y_i \in Y$ be the maximum such that $y_i < x_p$. If $c(y_i, y_i + 1) = c(y_i, \ell)$, then $(1, \dots, y_i, \ell, \ell - 1, \dots, x_p, 1)$ is a properly colored cycle containing $Y \cup \{\ell, \ell - 1\}$, a contradiction. Hence, $c(y_i, y_i + 1) \ne c(y_i, \ell)$, by the definition of y_s , we have $y_s \le x_p - 2$. If $y_s = x_p - 2$, then $(1, \dots, x_p - 2, \ell, \ell - 1, \dots, x_p, 1)$ is a properly colored cycle of length $\ell - 1 \ge \lceil \frac{n}{2} \rceil + 2$, which is a contradiction. Therefore, $y_s \le x_p - 3$.

Claim 2. There exist $u, w \in X$ such that $1 \le y_1 \le y_s < u \le \lceil \frac{n}{2} \rceil + 1$, u < w and the following proposition holds:

- (a) $c(y_i, \ell) = c(y_i, y_i + 1)$ for all $y_i \in [y_1, y_s] \cap Y$;
- (b) $c(1, x_i) = c(x_i, x_i + 1)$ for all $x_i \in [y_1 + 1, u] \cap X$;
- (c) $c(1, w) \neq c(w, w + 1)$ or $w = \ell$;
- (d) if $x_i \in X$ and $x_i < w$, then $x_i \le u$.

Proof of Claim 2. (a) By the definition of y_s , the assertion (a) holds.

(b) First, we show that $c(1, x_i) = c(x_i, x_i + 1)$ for all $x_i \in [y_1 + 1, y_s + 1] \cap X$. Otherwise, if there exists $x_i \in [y_1 + 1, y_s + 1] \cap X$ such that $c(1, x_i) \neq c(x_i, x_i + 1)$, let y_j be the maximum such that $y_j \in [y_1, y_s] \cap Y$ and $y_j < x_i$, then $(1, 2, \dots, y_j, \ell, \ell - 1, \dots, x_i, 1)$ is a properly colored cycle containing $Y \cup \{\ell - 1, \ell\}$, a contradiction.

Next, we show that there exists u such that $c(1, x_i) = c(x_i, x_i + 1)$ for all $x_i \in [y_s + 1, u] \cap X$. Let $x \in X$ be the minimum such that $x > y_s$. Note that x must exist since $x_p > y_s$ by Claim 1. If $x = \ell$, then $y_s \ge y_1 \ge 2$; hence $(1, \ldots, y_s, \ell, 1)$ is a properly colored cycle containing $X \cup \{1, 2\}$, a contradiction, so $x < \ell$. Suppose that $c(1, x) \ne c(x, x + 1)$. If $y_s = 1$, then $(1, \ell, \ell - 1, \ldots, x, 1)$ is a properly colored cycle containing $X \cup \{1, \ell\}$, a contradiction; if $y_s > 1$, then $(1, \ldots, y_s, \ell, \ell - 1, \ldots, x, 1)$ is a properly colored cycle containing $X \cup \{1, \ell\}$, a contradiction. So, we have $x < \ell$ and c(1, x) = c(x, x + 1).

Let *u* be the maximum such that $c(1, x_i) = c(x_i, x_i + 1)$ for all $x_i \in [y_s + 1, u] \cap X$ and $y_s < u < \ell$. By the above argument, *u* is well defined. In particular, c(1, u) = c(u, u + 1), it follows that (1, 2, ..., u, 1) is a properly colored cycle, and hence $u \le \lceil \frac{n}{2} \rceil + 1$.

Let $w \in X$ be the minimum such that w > u. Since $c(1, x_p) = c(x_p - 1, x_p) \neq c(x_p, x_p + 1)$, it follows that the vertex w must exist, and then (c) and (d) hold.

Let $S(P_0) = Y \cap [y_1, y_s]$. Note that y_1, y_s, u, w, S are viewed as functions of longest properly colored paths.

By Claims 2 (a) and 2 (c), $C_0 = (1, \dots, y_s, \ell, \ell - 1, \dots, w, 1)$ is a properly colored cycle; see Fig. 1.

Fig. 1: Cycle $C_0 = (1, ..., y_s, \ell, \ell - 1, ..., w, 1)$

Without loss of generality, assume that P_0 is a longest properly colored path satisfying that $|S(P_0)|$ is maximum over all the longest properly colored paths.

Clearly, $P^* = (y_1 + 1, y_1 + 2, \dots, \ell, y_1, \dots, 1)$ is a longest properly colored path. Note that

$$N^c(1, P^*) = X.$$

Since $c(y_1 + 1, y_1 + 2) \neq c(y_1 + 1, y_1)$, it follows that $y_1 \in N^c(y_1 + 1, P^*)$. Hence P^* is a longest properly colored path.

Claim 3. $|X| = \lceil \frac{n}{2} \rceil$ and $|C_0| = \lceil \frac{n}{2} \rceil + 1$. Moreover, $S(P_0) = [y_1, y_s]$, i.e., it is an integer interval, and

$$X = \begin{cases} [3, y_1] \cup [t, u] \cup [w, \ell] & \text{if } y_1 > 1; \end{cases}$$
(2)

$$[t, u] \cup [w, \ell - 1]$$
 if $y_1 = 1$, (3)

where $|[t, u]| = |[y_1, y_s]|, t \ge \max\{y_1 + 1, 3\}$ and $S(P^*) = [t, u]$.

Proof of Claim 3. By Claim 2 (b), $[y_1 + 1, u] \cap X \subseteq S(P^*)$. Since c(1, u) = c(u, u + 1), it yields that $u \in S(P^*)$. If $w < \ell$, then $c(1, w) \neq c(w, w + 1)$, and then $w \notin S(P^*)$; if $w = \ell$, then $c(1, \ell) \neq c(\ell, y_1)$, and then $w \notin S(P^*)$. Therefore, $S(P^*) = [y_1 + 1, u] \cap X$ and $|[y_1, y_s] \cap Y| \ge |[y_1 + 1, u] \cap X|$ by the maximality of $|S(P_0)|$.

Now

$$\begin{bmatrix} \frac{n}{2} \end{bmatrix} + 1 \ge |C_0| = |[1, y_s] \cap X| + |[w, \ell] \cap X| + |[1, y_s] \setminus X| + |[w, \ell] \setminus X| = |X| - |[y_s + 1, u] \cap X| + |[1, y_s] \setminus X| + |[w, \ell] \setminus X| = |X| - |[y_1 + 1, u] \cap X| + |[y_1 + 1, y_s] \cap X| + |[1, y_s] \setminus X| + |[w, \ell] \setminus X| \ge |X| - |[y_1, y_s] \cap Y| + |[y_1 + 1, y_s]| + |[1, y_1] \setminus X| + |[w, \ell] \setminus X| = |X| - |[y_1, y_s] \cap Y| + |[y_1, y_s]| + |[2, y_1] \setminus X| + |[w, \ell] \setminus X| \ge |X| + |[2, y_1] \setminus X| + |[w, \ell] \setminus X| \ge |X| + 1 \ge \left[\frac{n}{2} \right] + 1.$$

Therefore, all the inequalities become equalities. Then $|C_0| = \lceil \frac{n}{2} \rceil + 1$, $|X| = \lceil \frac{n}{2} \rceil$, $|S(P_0)| = |S(P^*)|$, $S(P_0) = [y_1, y_s]$ and

$$|[2, y_1] \setminus X| + |[w, \ell] \setminus X| = 1.$$
(4)

(4) implies that

$$\begin{cases} [3, y_1] \subseteq X \text{ and } [w, \ell] \subseteq X \quad \text{if } y_1 > 1; \end{cases}$$
(5)

$$(w, \ell) \cap X = [w, \ell - 1] \qquad \text{if } y_1 = 1.$$
(6)

Since $|S(P_0)| = |S(P^*)|$, by the above argument, $S(P^*)$ must be an integer interval, so $S(P^*) = [y_1 + 1, u] \cap X = [t, u]$, clearly $t \ge \max\{y_1 + 1, 3\}$.

Note that *t* is also viewed as a function of the longest properly colored path. **Claim 4.**

- (a) For any $y \in Y \cap [y_s + 1, w 1]$, we have $c(y, y 1) = c(y, \ell)$; $|S(P_0)| \ge |Y \cap [y_s + 1, w 1]|$.
- (b) If $w = x_p$, then $X = [3, \lceil \frac{n}{2} \rceil + 1] \cup \{x_p\}$.

Proof of Claim 4. (a) Since $|C_0| = \lceil \frac{n}{2} \rceil + 1$, we have $c(y, y - 1) = c(y, \ell)$ for any $y \in Y \cap [y_s + 1, w - 1]$; otherwise, $(1, 2, \dots, y, \ell, \ell - 1, \dots, w, 1)$ is a properly colored cycle of length greater than $|C_0|$, a contradiction.

Obviously, $Q = (w - 1, w - 2, ..., 1, w, w + 1, ..., \ell)$ is a longest properly colored path. Note that $N^{c}(\ell, Q) = Y$. We have just proved $Y \cap [y_{s} + 1, w - 1] \subseteq S(Q)$, and hence $|S(P_{0})| \ge |S(Q)| \ge Y \cap [y_{s} + 1, w - 1]$.

(b) Since $w = x_p$, it follows that $u = x_{p-1}$ and $(1, 2, \dots, x_{p-1}, 1)$ is a properly colored cycle containing $\{1, 2, x_1, \dots, x_{p-1}\}$, so $x_{p-1} = \lceil \frac{n}{2} \rceil + 1$. Hence $X = [3, \lceil \frac{n}{2} \rceil + 1] \cup \{x_p\}$.

Claim 5. $|S(P_0)| \ge 3$.

Proof of Claim 5. By way of contradiction, we assume that $|S(P_0)| \le 2$. Without loss of generality, we may assume that $y_1 \ne 1$, otherwise consider the properly colored path $(2, 3, ..., \ell, 1)$ instead. **Case 1:** $w \le \ell - 1$.

Let $P' = (\ell, \ell-1, ..., 1)$, it is a longest properly colored path. If $w \le \ell-1$, then $c(1, \ell) = c(\ell, \ell-1)$ and $c(1, \ell-1) = c(\ell-1, \ell-2)$, so $\ell, \ell-1 \in S(P')$. Hence, $|S(P_0)| = |S(P')| = 2$ and $c(1, \ell-2) \ne c(\ell-2, \ell-3)$. Applying Claim 3 with P', we have $c(\ell, \ell-1) \ne c(\ell, 2)$. Notice that $c(\ell, 2) = c(2, 3)$, for otherwise $(2, 3, ..., \ell, 2)$ is a properly colored cycle of length at least $\lceil \frac{n}{2} \rceil + 2$, a contradiction. So we have that $y_1 = 2$ and $y_s = 3$.

Case 1.1: $w \le \ell - 2$. Then $C_1 = (1, 2, \dots, \ell - 2, 1)$ is a properly colored cycle of length at most $\lceil \frac{n}{2} \rceil + 1$, i.e., $\ell - 2 \le \lceil \frac{n}{2} \rceil + 1$, or $\ell \le \lceil \frac{n}{2} \rceil + 3$. On the other hand, $\ell \ge \lceil \frac{n}{2} \rceil + 3$, and then $\ell = \lceil \frac{n}{2} \rceil + 3$. Moreover, $Y = [2, \ell - 2]$. Since the properly colored cycle $C_0 = (1, 2, 3, \ell, \ell - 1, \dots, w, 1)$ has length $\lceil \frac{n}{2} \rceil + 1$ by Claim 3, we conclude that w = 6. Note that $|X| = \lceil \frac{n}{2} \rceil = |[t, u]| + |[w, \ell]| \ge 5$ implying $n \ge 9$.

If $\ell = n$, then $n - 2 = \ell - 2 = \lceil \frac{n}{2} \rceil + 1$ and $n \in \{6, 7\}$, a contradiction. Then we may assume that there exists a vertex *z* such that it is not on P_0 . The properly colored path $(1, 2, 3, \ell, \ell - 1, \dots, 5, 4)$ is longest, it follows that c(4, 5) = c(4, z); otherwise, $(1, 2, 3, \ell, \ell - 1, \dots, 5, 4, z)$ is a longer properly colored path. By Claim 4(a), we have $c(\ell, 5) = c(5, 4) \neq c(5, 6)$. Therefore, $(\ell - 1, \ell, 5, 6, \dots, \ell - 2, 1, 2, 3, 4, z)$ is a longer properly colored path than P_0 , which is a contradiction.

Case 1.2: $w = \ell - 1$. Then $|X| = \lceil \frac{n}{2} \rceil = |[t, u]| + |[w, \ell]| = 4$, i.e., $n \in \{7, 8\}$. Since $\lceil \frac{n}{2} \rceil + 3 \le \ell \le n, \ell = 7$ or $\ell = 8$.

If t = 3, then c(1, 3) = c(3, 4). Since $y_s = 3$, $c(3, 4) = c(\ell, 3)$. Consider the properly colored path $P'' = (3, 4, ..., \ell, 2, 1)$. By Claim 3, we have $S(P'') = \{3, 4\}$ and $N^c(3, P'') = \{t', t' + 1\} \cup \{\ell, 2\}$, so $c(\ell, 3) \neq c(3, 4)$, a contradiction.

If t = 4, then $X = \{4, 5, \ell - 1, \ell\}$. Define ϕ be the permutation on $[1, \ell]$ such that $(\phi(1), \phi(2), \dots, \phi(\ell)) = (3, 4, \dots, \ell, 2, 1)$. We will show the following propositions for $i \ge 0$ by induction on i.

(a) $P_i = (\phi^i(1), \phi^i(2), \dots, \phi^i(\ell))$ is a longest properly colored path;

(b)
$$S(P_i) = \{\phi^i(2), \phi^i(3)\};$$

(c)
$$N^{c}(\phi^{i}(1), P_{i}) = \{\phi^{i}(j) \mid j \in [4, 5] \cup [\ell - 1, \ell]\}.$$

(d) $c(\phi^i(1), \phi^i(j)) = c(\phi^i(j), \phi^i(j+1))$ for $j \in [4, 5]$.

Clearly, the propositions (a)–(d) hold for i = 0. Assume that $i \ge 1$ and they are true for i - 1. Let j' denote $\phi^{i-1}(j)$. Since $2' \in S(P_{i-1})$, $c(1', 2') \ne c(2', 3') = c(2', \ell')$. Hence, $P_i = (\phi(1'), \phi(2'), \dots, \phi(\ell'))$ is a longest properly colored path. Also, by the definition of $N^c(\phi^{i-1}(1), P_{i-1})$ and $|S(P_i)| = |S(P_0)| = 2$, (b) holds. By Claim 3 and |X| = 4,

$$N^{c}(\phi^{i}(1), P_{i}) = \{\phi^{i}(j) \mid j \in [t_{i}, t_{i} + 1] \cup [\ell - 1, \ell]\},\$$

for some $t_i \in \{3, 4\}$. If $t_i = 3$, we can also get a contradiction as above by taking $P_0 = P_i$. So $t_i = 4$, and thus (c) holds. By Claim 3, (d) also holds.

If $\ell = 7$, then $X = \{4, 5, 6, 7\}$ and $Y = \{2, 3, 4, 5\}$. For the path P_0 , we have c(7, 2) = c(2, 3) and c(7, 3) = c(3, 4). Taking i = 1 in the proposition, consider the longest properly colored path P_1 , i.e., (3, 4, 5, 6, 7, 2, 1). By proposition (c), $c(\phi^1(1), \phi^1(5)) = c(\phi^1(5), \phi^1(6))$, i.e., c(3, 7) = c(7, 2). Therefore, c(2, 3) = c(7, 2) = c(3, 7) = c(3, 4), a contradiction.

If $\ell = 8$, then $X = \{4, 5, 7, 8\}$. Since u = 5, it follows that $c(1, 5) = c(5, 6) \neq c(4, 5)$. Consider the properly colored path $P_5 = (4, 3, 6, 5, 8, 7, 1, 2)$. Since $8 = \phi^5(5)$, by proposition (c) and Claim 2 (b), $c(4, 8) = c(8, 7) \neq c(5, 8)$; moreover, $5 \in N^c(8, P_0)$. Thus c(8, 5) = c(4, 5) by Claim 4. Hence $c(1, 5) = c(5, 6) \neq c(4, 5) = c(5, 8)$. Now, we have a properly colored cycle (1, 2, 3, 4, 8, 5, 1) of length 6, a contradiction.

Case 2: $w = \ell$. Since $|Y \cap [y_s + 1, w - 1]| \le |S(P_0)|$ by Claim 4 (a), it follows that $|Y| = |[y_1, y_s]| + |Y \cap [y_s + 1, w - 1]| \le 2|S(P_0)|$. If $|S(P_0)| = 1$, then $\lceil \frac{n}{2} \rceil \le |Y| \le 2$, and thus $n \le 4$, a contradiction. Hence, $|S(P_0)| = 2$, and $\lceil \frac{n}{2} \rceil \le |Y| \le 4$, so $n \le 8$. By Claim 3, $X = [3, \lceil \frac{n}{2} \rceil + 1] \cup \{\ell\}, u = \lceil \frac{n}{2} \rceil + 1, t = \lceil \frac{n}{2} \rceil$,

 $y_1 = t - 1 = \lceil \frac{n}{2} \rceil - 1$. So $Y \subseteq [\lceil \frac{n}{2} \rceil - 1, \ell - 2]$; hence, $\lfloor \frac{n}{2} \rfloor = n - 2 - (\lceil \frac{n}{2} \rceil - 1) + 1 \ge \ell - 2 - (\lceil \frac{n}{2} \rceil - 1) + 1 \ge |Y| \ge \lceil \frac{n}{2} \rceil$, and then $n = \ell$ is even, $Y = \lfloor \frac{n}{2} - 1, n - 2 \rfloor$ and $|Y| = \frac{n}{2}$. Now, we know that $n \in \{6, 8\}$.

If n = 6, then $X = \{3, 4, 6\}$, $Y = \{2, 3, 4\}$, $y_1 = 2$, $y_s = t = 3$ and u = 4. By Claim 2 (a) and 2 (b), c(1, 3) = c(3, 4) = c(3, 6), which contradicts the fact that $\Delta^{\text{mon}}(K_6^c) < 3$.

If n = 8, then $X = \{3, 4, 5, 8\}$, $Y = \{3, 4, 5, 6\}$, $y_1 = 3$, t = 4 and u = 5. Since $4 \in [y_1 + 1, u] \cap X$, $c(1, 4) = c(4, 5) \neq c(3, 4)$ by Claim 2 (b); by Claim 2 (a), $c(8, 3) = c(3, 4) \neq c(2, 3)$ and $c(8, 4) = c(4, 5) \neq c(3, 4)$. Hence, c(4, 1) = c(4, 5) = c(4, 8). Since $\Delta^{\text{mon}}(K_8^c) < 4$, it follows that $c(4, 7) \neq c(4, 1)$. If $c(4, 7) \neq c(7, 8)$, then (1, 2, 3, 8, 7, 4, 1) is a properly colored cycle of length 6, a contradiction. So $c(4, 7) = c(7, 8) \neq c(7, 6)$. By Claim 4 (a), we have $c(8, 5) = c(4, 5) \neq c(5, 6)$, so $c(8, 5) \neq c(8, 3)$. Now we have a properly colored Hamiltonian cycle (1, 2, 3, 8, 5, 6, 7, 4, 1), a contradiction.

Claim 6. Without loss of generality, we may assume that $t \ge y_1 + 3$.

Proof of the Claim 6. Suppose to the contrary that $t \le y_1 + 2$. Then $t = y_1 + 1$ or $t = y_1 + 2$. Since $|S(P_0)| \ge 3$, we have $t - 1 \in S(P_0)$. Without loss of generality, we may assume that $y_1 = 1$; otherwise, consider the longest properly colored path $(t, t + 1, ..., \ell, t - 1, t - 2, ..., 1)$ instead. By Claim 3, t = 3. Moreover, $X = [3, y_s + 2] \cup [w, \ell - 1]$.

Let ϕ be a permutation on $[1, \ell]$ such that $(\phi(1), \phi(2), \dots, \phi(\ell - 2), \phi(\ell - 1), \phi(\ell)) = (3, 4, \dots, \ell, 2, 1)$. We will show the following statements for $i \ge 0$ by induction.

- (a) $P_i = (\phi^i(1), \phi^i(2), \dots, \phi^i(\ell))$ is a longest properly colored path;
- (b) $S(P_i) = \{\phi^i(j) \mid j \in [1, y_s]\};$
- (c) $N^{c}(\phi^{i}(1), P_{i}) = \{\phi^{i}(j) \mid j \in [3, y_{s} + 2] \cup [w, \ell 1]\};$
- (d) for all $j \in [3, y_s + 2]$, we have $c(\phi^i(1), \phi^i(j)) = c(\phi^i(j), \phi^i(j+1));$
- (e) for all $j \in [4, \lceil \frac{n}{2} \rceil + 2]$, we have $c(\phi^i(2), \phi^i(j)) = c(\phi^i(j), \phi^i(j+1))$.

First, the statements are true for i = 0. Assume that the statements are true for i - 1, where $i \ge 1$. Since $\phi^{i-1}(2) \in S(P_{i-1})$, it follows that $P_i = (\phi^{i-1}(3), \phi^{i-1}(4), \dots, \phi^{i-1}(\ell), \phi^{i-1}(2), \phi^{i-1}(1)) = (\phi^i(1), \phi^i(2), \dots, \phi^i(\ell))$ is a longest properly colored path. Since $|S(P_{i-1})| = |S(P_0)| = |[1, y_s]|$, we have $t(P_{i-1}) = \phi^{i-1}(3)$; by Claim 3, it yields that $S(P_i) = [t(P_{i-1}), u(P_{i-1})] = [\phi^i(1), \phi^i(y_s)]$, and thus $|S(P_i)| = |S(P_0)|$. Hence, by the assumption, we have $N^c(\phi^i(1), P_i) = \{\phi^i(j) \mid j \in [3, y_s + 2] \cup [w, \ell - 1]\}$. By Claim 2 (b), for all $j \in [3, y_s + 2], c(\phi^i(1), \phi^i(j)) = c(\phi^i(j), \phi^i(j + 1))$.

Since $S(P_i) = \{\phi^i(j) \mid j \in [1, y_s]\}$, it follows that $P'_i = (\phi^i(2), \phi^i(3), \dots, \phi^i(\ell), \phi^i(1))$ is a longest properly colored path. By Claim 3, $S(P'_i) = \{\phi^i(j) \mid j \in [3, y_s + 2]\}$. By Claim 2 (a), $c(\phi^i(2), \phi^i(3)) = c(\phi^i(2), \phi^i(\ell))$, so $\phi^i(\ell) \notin N^c(\phi^i(2), P'_i)$; by Claim 3, $N^c(\phi^i(2), P'_i) = \{\phi^i(j) \mid j \in [4, \lceil \frac{n}{2} \rceil + 2] \cup \{1\}\}$. By Claim 2 (b), $c(\phi^i(2), \phi^i(j)) = c(\phi^i(j), \phi^i(j + 1))$ for all $j \in [4, \lceil \frac{n}{2} \rceil + 2]$. This completes the proof of the statements.

Consider the properly colored path P_0 . Since $|S(P_0)| \ge 3$, it follows that $y_s \ge 3$. Thus $5 \in [3, y_s + 2]$. By statement (d), c(1, 5) = c(5, 6).

If ℓ is odd, take $i = \frac{\ell+1}{2}$. It is easy to check that $P_{\frac{\ell+1}{2}} = (1, 4, 3, 6, 5, ...)$. By statement (d), $c(1, 5) \neq c(6, 5)$, a contradiction.

If ℓ is even, take $i = \frac{\ell}{2}$. It is easy to check that $P_{\frac{\ell}{2}} = (2, 1, 4, 3, 6, 5, ...)$. By statement (e), if $\lceil \frac{n}{2} \rceil + 2 \ge 6$, then $c(1, 5) = c(5, 8) \ne c(5, 6)$, a contradiction. So n = 6. Since $3 \in [1, y_s]$, it yields that c(3, 4) = c(3, 6) by Claim 2 (a); by Claim 2 (b), c(1, 3) = c(3, 4). Therefore, c(1, 3) = c(3, 4) = c(3, 6), which contradicts the fact that $\Delta^{\text{mon}}(K_6^c) < \lfloor \frac{6}{2} \rfloor$.

Claim 7. $c(y_1 + 1, y_1 + 3) \notin \{c(y_1 + 1, y_1 + 2), c(y_1 + 3, y_1 + 4)\}.$


Proof of Claim 7. By Claim 3, $S(P^*) = [t, u]$ and $y_1 + 3 \in N^c(y_1 + 1, P^*)$, so $c(y_1 + 1, y_1 + 2) \neq c(y_1 + 1, y_1 + 3)$. For the longest properly colored path $Q^* = (y_1 + 3, y_1 + 4, \dots, \ell, y_1 + 2, y_1 + 1, \dots, 1) = 0$

 $(\psi(1), \psi(2), \dots, \psi(\ell))$, we know that $S(Q^*) = [t, u]$ and $N^c(y_1 + 3, Q^*) = \{\psi(j) \mid j \in A\}$, where

$$A = \begin{cases} [3, y_1''] \cup [t'', u''] \cup [w'', \ell] & \text{if } t > y_1 + 3; \end{cases}$$
(7)

$$([t'', u''] \cup [w'', \ell - 1] if t = y_1 + 3,$$
(8)

for some $2 \le y_1'' < t'' < u'' < w'' \le \ell$. Since $y_1 + 2 \in S(P_0)$, $c(y_1 + 2, y_1 + 3) = c(y_1 + 2, \ell)$. Thus $y_1 + 2 \in \{\psi(j) \mid j \in [w'', \ell - 1]\}$, so $[2, y_1 + 2] \subseteq \{\psi(j) \mid j \in [w'', \ell - 1]\}$. In particular, $y_1 + 1 \in N^c(y_1 + 3, Q^*)$, so $c(y_1 + 1, y_1 + 3) \neq c(y_1 + 3, y_1 + 4)$, which completes the proof of Claim 7.



By Claim 7, note that $(y_1 + 1, y_1 + 2, \ell, \ell - 1, \dots, y_1 + 3, y_1 + 1)$ is a properly colored cycle (see Fig. 2) containing $Y \cup \{\ell - 1, \ell\} \setminus \{y_1\}$, and then its length is exactly $\lceil \frac{n}{2} \rceil + 1$. Moreover, $Y = \lfloor \ell - \lceil \frac{n}{2} \rceil - 1, \ell - 2 \rfloor$. If $\ell = n$, then $Y = \lfloor \lfloor \frac{n}{2} \rfloor - 1, n - 2 \rfloor$ and $y_1 = \lfloor \frac{n}{2} \rfloor - 1$. By Claim 3 and Claim 6, $u \ge y_s + 3$. Now

$$\left\lceil \frac{n}{2} \right\rceil + 1 \ge u \ge y_s + 3 = y_1 + |S(P_0)| + 2 \ge \left\lfloor \frac{n}{2} \right\rfloor + 4, \tag{9}$$

a contradiction.

Then we may assume that $\ell < n$, i.e., there exists a vertex z which is not on P_0 . We know that $c(\ell - 1, \ell) = c(\ell, z)$; otherwise $(1, 2, \dots, \ell, z)$ is a properly colored path which is longer than P_0 . We have known that $(1, 2, \dots, y_1 + 1, \ell, \ell - 1, \dots, y_1 + 2)$ is a longest properly colored path; it yields that $c(y_1 + 2, y_1 + 3) = c(y_1 + 2, z)$ for the same reason. Since $y_1 + 2 \in S(P_0)$, we have $c(y_1 + 2, y_1 + 3) = c(\ell - 1, \ell) = c(\ell, z)$, and hence $c(y_1 + 2, z) \neq c(\ell, z)$. Therefore, $(1, \dots, y_1, \ell, z, y_1 + 2, y_1 + 1, y_1 + 3, \dots, \ell - 1)$ is a properly colored path which is longer than P_0 , a contradiction.
