ON THE UNBOUNDED OF A CLASS OF FOURIER INTEGRAL **OPERATOR ON** $L^2(\mathbb{R}^n)$

ABSTRACT. In this paper, we give an example of Fourier integral operator with a symbol belongs to $\bigcap_{0 < \rho < 1} S^0_{\rho,1}$ that cannot be extended as a bounded operator on $L^2(\mathbb{R}^n)$.

1. INTRODUCTION

A Fourier integral operator is a singular integral operator of the form

$$I(a,\phi) u(x) = \int \int e^{i\phi(x,y,\theta)} a(x,y,\theta) u(y) \, dy d\theta$$

defined under certain assumptions on the regularity and asymptotic properties of the phase function ϕ and the amplitude function a. Here θ plays the role of the covariable.

Fourier integral operators are more general than pseudodifferantial operators, where the phase function is of the form $\langle x - y, \theta \rangle$.

Let us denote by $S_{\rho,\delta}^m \left(\mathbb{R}^{n_1} \times \mathbb{R}^{n_2} \times \mathbb{R}^N \right)$ the space of $a\left(x, y, \theta\right) \in C^{\infty} \left(\mathbb{R}^{n_1} \times \mathbb{R}^{n_2} \times \mathbb{R}^N \right)$, satisfying

$$\left|\partial_x^{\alpha}\partial_y^{\beta}\partial_\theta^{\gamma}a(x,y,\theta)\right| \leq C_{\alpha,\beta,\gamma}\lambda^{m-\rho|\gamma|+\delta(|\alpha|+|\beta|)}(\theta), \;\forall \, (\alpha,\beta,\gamma) \in \mathbb{N}^{n_1} \times \mathbb{N}^{n_2} \times \mathbb{N}^N,$$

where $\lambda(\theta) = (1 + |\theta|)$.

The phase function $\phi(x, y, \theta)$ is assumed to be a- $C^{\infty}(\mathbb{R}^{n_1} \times \mathbb{R}^{n_2} \times \mathbb{R}^N, \mathbb{R})$ real function, homogeneous in θ of degree 1.

Since 1970, many efforts have been made by several authors in order to study this type of operators (see, e.g., [1, 3, 6, 7, 8]).

For the Fourier integral operators, an interesting question is under which conditions on a and ϕ these operators are bounded on L^2 or on the Sobolev spaces H^s .

It was proved in [10] that all pseudodifferential operators with symbol in $S^0_{\rho,\delta}$ are bounded on L^2 if $\delta < \rho$. When $0 < \delta = \rho < 1$, Calderon and Vaillancourt [2] have proved that all pseudodifferantial operators with symbol in $S^0_{\rho,\rho}$ are bounded on L^2 . On the other hand, Kumano-Go [11] has given a pseudodifferential operator with symbol belonging to $\bigcap_{0 < \rho < 1} S^0_{\rho,1}$ which is not bounded on $L^2(\mathbb{R})$.

For Fourier integral operators, it has been proved in [1] that the operator $I(a,\phi): L^2 \longrightarrow L^2$ is bounded if $\delta = m = \rho = 0$. Recently, M. Hasanov [6] constructed a class of unbounded Fourier integral operators on $L^{2}(\mathbb{R})$ with an amplitude in $S_{1,1}^0$.

For $u \in C_0^{\infty}(\mathbb{R}^n)$, the integral operators

(1.1)
$$I(a,S)\varphi(x) = \int e^{iS(x,\theta)}a(x,y,\theta) \mathcal{F}\varphi(\theta) d\theta$$

appear naturally in the expression of the solutions of hyperbolic partial differential equations (see [4, 5, 12]).

If we write formally the expression of the Fourier transformation $\mathcal{F}u(\theta)$ in (1.1), we obtain the following Fourier integral operators

(1.2)
$$I(a,S) u(x) = \iint e^{i(S(x,\theta) - y\theta)} a(x,y,\theta) u(y) dy d\theta$$

in which the phase function has the form $\phi(x, y, \theta) = S(x, \theta) - y\theta$. We note that in [13], we have studied the L^2 -boundedness and L^2 -compactness of a class of Fourier integral operator of the form (1.2).

In this article we give an example of a Fourier integral operator, in higher dimension, of the form (1.1) with symbol $a(x,\theta) \in \bigcap_{0 < \rho < 1} S^0_{\rho,1}$ independent on y, that cannot be extended to a bounded operator in $L^{2}(\mathbb{R}^{n}), n \geq 1$. Here we take the phase function in the form of separate variable $S(x, \theta) = \varphi(x) \psi(\theta)$.

2. The boundedness on $C_0^{\infty}(\mathbb{R}^n)$ and on $D'(\mathbb{R}^n)$

If $\varphi \in C_0^{\infty}(\mathbb{R}^n)$, we consider the following integral transformations

(2.3)
$$(I(a,S)\varphi)(x) = \int_{\mathbb{R}^N} e^{iS(x,\theta)} a(x,\theta) \mathcal{F}\varphi(\theta) d\theta$$
$$= \int_{\mathbb{R}^N \times \mathbb{R}^n} e^{i(S(x,\theta) - y\theta)} a(x,\theta) \varphi(y) d\theta dy$$

for $x \in \mathbb{R}^n$ and $N \in \mathbb{N}$.

In general the integral (2.3) is not absolutely convergent, so we use the technique of the oscillatory integral developed by L.Hörmander in [8]. The phase function Sand the amplitude a are assumed to satisfy the hypothesis

- (H1) $\hat{S} \in C^{\infty} \left(\mathbb{R}^n_x \times \mathbb{R}^N_{\theta}, \mathbb{R} \right)$ (S real function) (H2) $\forall \beta \in \mathbb{N}^N, \exists C_{\beta} > 0;$

$$\left|\partial_{\theta}^{\beta}S(x,\theta)\right| \leq C_{\beta}(x)\,\lambda^{(1-|\beta|)_{+}}(\theta) \ ,\,\forall\,(x,\theta)\in\mathbb{R}_{x}^{n}\times\mathbb{R}_{\theta}^{N}$$

where $\lambda(\theta) = (1 + |\theta|)$ and $(1 - |\beta|)_{+} = \max(1 - |\beta|, 0)$. (H3) S satisfies

$$\left(\frac{\partial S}{\partial x}, \frac{\partial S}{\partial \theta} - y\right) \neq 0, \ \forall (x, \theta) \in \mathbb{R}^n_x \times \left(\mathbb{R}^N_\theta \setminus \{0\}\right).$$

Remark 2.1. If the phase function $S(x,\theta)$ is homogeneous in θ of degree 1, then it satisfies (H2).

For any open Ω of $\mathbb{R}^n_x \times \mathbb{R}^N_\theta$, $m \in \mathbb{R}$, $\rho > 0$ and $\delta \ge 0$ we set

$$S_{\rho,\delta}^{m}\left(\Omega\right) = \left\{ \begin{array}{cc} a \in C^{\infty}\left(\Omega\right); & \forall (\alpha,\beta) \in \mathbb{N}^{n} \times \mathbb{N}^{N}, \quad \exists C_{\alpha,\beta} > 0; \\ \left|\partial_{x}^{\alpha}\partial_{\theta}^{\beta}a(x,\theta)\right| \leq & C_{\alpha,\beta}\lambda^{m-\rho|\beta|+\delta|\alpha|}(\theta). \end{array} \right\}$$

Theorem 2.2. If S satisfies (H1), (H2), (H3) and if $a \in S^m_{\rho,\delta}(\mathbb{R}^n_x \times \mathbb{R}^N_{\theta})$, then $I(a, \phi)$ is a continuous operator from $C^{\infty}_0(\mathbb{R}^n)$ to $C^{\infty}(\mathbb{R}^n)$ and from $\mathcal{E}'(\mathbb{R}^n)$ to $D'(\mathbb{R}^n)$, where $\rho > 0$ and $\delta < 1$.

Proof. See [6], [4, pages 50-51].

Corollary 2.3. Let $\varphi(x), \psi(\theta) \in C^{\infty}(\mathbb{R}^n, \mathbb{R})$ two functions, $\psi(\theta)$ is homogeneous of degree 1 ($\psi(\theta) \neq 0$) and $\varphi(x)$ satisfies

(2.4)
$$\varphi'(x) \neq 0, \ \forall x \in \mathbb{R}^n.$$

Then the operator

(2.5)
$$(Fu)(x) = \int_{\mathbb{R}^n} e^{i\varphi(x)\psi(\theta)} a(x,\theta) \mathcal{F}u(\theta) d\theta, \quad u \in \mathcal{S}(\mathbb{R}^n)$$

maps continuously $C_0^{\infty}(\mathbb{R}^n)$ to $C^{\infty}(\mathbb{R}^n)$ and $\mathcal{E}'(\mathbb{R}^n)$ to $D'(\mathbb{R}^n)$ for every $a \in S^m_{\rho,\delta}(\mathbb{R}_x \times \mathbb{R}_{\theta})$, where $\rho > 0$ and $\delta < 1$.

Proof. For the phase function $S(x, \theta) = \varphi(x) \psi(\theta)$, (H1), (H2) and (H3) are satisfied.

3. The unboundedness of the operator F on $L^{2}(\mathbb{R}^{n})$

In this section we shall construct a symbol $a(x,\theta)$ in the Hörmander space $\bigcap_{0 < \rho < 1} S^0_{\rho,1}(\mathbb{R}^n_x \times \mathbb{R}^n_{\theta})$, such that the Fourier integral operator F can not be extended as a bounded operator in $L^2(\mathbb{R}^n)$.

as a bounded operator in $L^{-}(\mathbb{R}^{n})$.

Lemma 3.1. (Kumano-Go [11]). Let $f_0(t)$ be a continuous function on [0, 1] such that

(3.1)
$$f_0(0) = 0, \ f_0(t) > 0 \ in \]0,1].$$

Then, there exists a continuous function b(t) on [0,1] such that b(t) satisfies the conditions

(3.2)
$$\begin{cases} f_0(t) \le b(t) \quad on \ [0,1], \\ b \in C^{\infty}([0,1]), \ b(0) = 0, \ b'(t) > 0 \ in \ [0,1], \\ |b^{(n)}(t)| \le C_n t^{-n} \ in \ [0,1], \ n \in \mathbb{N}^*, \ C_n > 0. \end{cases}$$

Definition 3.2. It is obvious that an operator A is extended as a bounded operator in $L^2(\mathbb{R}^n)$ if and only if there exists a constant C > 0 such that

$$\|Au\|_{L^2} \le C \|u\|_{L^2} \text{ for any } u \in \mathcal{S}(\mathbb{R}^n)$$

Theorem 3.3. Let A be an operator, given at least for $x \in [0, \beta[^n (\beta < 1), by]$

$$(Au)(x) = \int_{\mathbb{R}^n} u(g(x)z) \mathcal{F}\Psi(z) dz, \quad u \in \mathcal{S}(\mathbb{R}^n),$$

we denote here by $]0, \beta[^n = \prod_{j=1}^n]0, \beta[.$

$$If \Psi \in \mathcal{S}(\mathbb{R}^n), \Psi(0) = 1 \text{ and the function } g \in C^0([0,\beta[^n,\mathbb{R}_+) \text{ satisfies})$$

$$(3.4) \begin{cases} \lim_{|x|\to 0^+} \frac{g(x)}{|x|} = 0, \\ \forall i \in \{1,...,n\}; x_i \longrightarrow g(x_1,..,x_i,...,x_n) \text{ is increasing on } [0,\beta[.$$

Then the operator A cannot be extended to a bounded operator in $L^2(\mathbb{R}^n)$.

Proof. Using the Fourier inversion formula in $\mathcal{S}(\mathbb{R}^n)$, we have

$$(Au)(x) = \int_{\mathbb{R}^n} u(g(x)z) \mathcal{F}\Psi(z) dz, \quad u \in \mathcal{S}(\mathbb{R}^n).$$

Then there exists a constant $N_0 > 0$ such that

(3.5)
$$\left| (2\pi)^{-\frac{n}{2}} \int_{[-N,N]^n} \mathcal{F}\Psi(z) \, dz \right| \ge \beta \quad \text{for any } N \ge N_0.$$

Setting for $\varepsilon > 0$

 $\mathbf{I}_{n}^{(1)} = \mathbf{O}(\mathbf{T}_{n}^{(1)}) = \mathbf{I}_{n}(\mathbf{O})$

$$u_{\varepsilon}(z) = \begin{cases} (2\pi)^{-\frac{n}{2}}, \text{ for } z \in [-\varepsilon, \varepsilon]^n \\ 0, \text{ for } z \notin [-\varepsilon, \varepsilon]^n \end{cases}$$

Then, using the density of $\mathcal{S}(\mathbb{R}^n)$ in $L^2(\mathbb{R}^n)$, we see that $(Au_{\varepsilon})(x)$ must be

(3.6)
$$(Au_{\varepsilon})(x) = (2\pi)^{-\frac{n}{2}} \int_{\left[-\frac{\varepsilon}{g(x)}, \frac{\varepsilon}{g(x)}\right]^n} \mathcal{F}\Psi(z) dz \text{ for } x \in \left]0, \beta\right[^n.$$

By (3.4) for any $p \in \mathbb{N}^*$ there exists a small $\varepsilon_p \ge 0$ such that

$$\frac{\varepsilon_p}{g\left(p\varepsilon_p,...,p\varepsilon_p\right)} \ge N_0 \text{ and } p\varepsilon_p \le \beta.$$

It follows from the condition (3.4) that

$$\frac{\varepsilon_p}{g(x)} \ge \frac{\varepsilon_p}{g(p\varepsilon_p, ..., p\varepsilon_p)} \ge N_0, \text{ holds for } x \in \left]0, p\varepsilon_p\right]^n,$$

so that, using (3.5) and (3.6), we have

(3.7)
$$\left\|Au_{\varepsilon_p}\right\|_{L^2}^2 = \int_{\mathbb{R}^n} \left|Au_{\varepsilon_p}\left(x\right)\right|^2 dx \ge \int_{[0,p\varepsilon_p]^n} \left|Au_{\varepsilon_p}\left(x\right)\right|^2 dx \ge \beta^2 \left(p\varepsilon_p\right)^n.$$

Assume that A is bounded on $L^2(\mathbb{R}^n)$. According to (3.3) there exists C > 0 such that:

$$\beta^2 (p\varepsilon_p)^n \le \left\| Au_{\varepsilon_p} \right\|_{L^2}^2 \le C^2 (2\varepsilon_p)^n \text{ for any } p$$

Which is a contradiction.

Let K(t) be a function from $\mathcal{S}(\mathbb{R})$ such that K(t) = 1 on $[-\delta, \delta]$ $(\delta < 1), b(t) \in$ $C^{0}([0,1])$ be a continuous function satisfying conditions (3.2) and $\varphi(x), \psi(\theta) \in$ $C^{\infty}(\mathbb{R}^n,\mathbb{R})$ with $\psi(\theta)$ homogeneous of degree 1 ($\psi(\theta) \neq 0$). We assume that $\varphi(x)$ satisfies

(3.8)
$$|\varphi(x)| \le C |x| \text{ for } |x| \le 1.$$

We remark that if the function $\varphi(x)$ is homogeneous of degree 1, then it satisfies (3.8).

For
$$x = (x_1, ..., x_n), \theta = (\theta_1, ..., \theta_n) \in \mathbb{R}^n$$
, set
$$q(x, \theta) = e^{-i\varphi(x)\psi(\theta)} \prod_{j=1}^n K(b(|x|) |x| |\theta_j)$$

Lemma 3.4. The function $q \in C^{\infty}([-1,1]^n \times \mathbb{R}^n_{\theta})$ and the following estimate holds:

$$\forall (\alpha, \beta) \in \mathbb{N}^n \times \mathbb{N}^n, \ \exists C_{\alpha, \beta} > 0;$$

(3.9)
$$\left|\partial_x^{\alpha}\partial_{\theta}^{\beta}q(x,\theta)\right| \leq C_{\alpha,\beta}\lambda^{|\alpha|-|\beta|}\left(\theta\right)\left\{b\left(\lambda^{-1}\left(\theta\right)\right)\right\}^{-|\beta|} on \left[-1,1\right]^n \times \mathbb{R}^n_{\theta}.$$

Proof. We adopt here the same strategy of Kumano-Go [11] lemma 2.

Since $\psi(\theta)$ is homogeneous of degree 1 ($\psi(\theta) \neq 0$), it will be sufficient to check the estimate for n = 1 on $[-1, 1] \times \mathbb{R}_{\theta}$, i.e.

(3.10)
$$\forall (j,k) \in \mathbb{N} \times \mathbb{N}, \ \exists C_{j,k} > 0; \\ \left| \partial_x^j \partial_\theta^k \left[e^{-i\varphi(x)\theta} K\left(b\left(|x|\right) x\theta \right) \right] \right| \le C_{j,k} \lambda^{j-k} \left(\theta \right) \left\{ b\left(\lambda^{-1}\left(\theta \right) \right) \right\}^{-k}.$$

Since $K(t) \in \mathcal{S}(\mathbb{R})$ and $K^{(n)}(t) = 0$ on $[-\delta, \delta]$, $n \in \mathbb{N}^*$, then

$$(3.11) $|t^l K(t)| \leq C_l, \ \forall l \in \mathbb{N}$$$

(3.12)
$$\left| t^{l} K^{(n)}(t) \right| \leq C_{l,n}, \ \forall n \in \mathbb{N}^{*}, \forall l \in \mathbb{Z}.$$

By Leibnitz's formula we have

$$\partial_x^j \partial_\theta^k \left[e^{-i\varphi(x)\theta} K\left(b\left(|x|\right)x\theta\right) \right] = \sum_{\substack{j_1+j_2=j\\k_1+k_2=k}} C_{j_1,j_2,k_1,k_2}^{j,k} \partial_x^{j_1} \left[K^{(k_1)}\left(b\left(|x|\right)x\theta\right)\left(b\left(|x|\right)x\right)^{k_1} \right] \partial_x^{j_2} \left[\left(-i\varphi\left(x\right)\right)^{k_2} e^{-i\varphi(x)\theta} \right],$$

where $C_{j_1,j_2,k_1,k_2}^{j,k} = \frac{j!k!}{j_1!j_2!k_1!k_2!}$. Then, by means of (3.8) and (3.2), we have for constants $C'_{j,k}$

$$\left| \partial_x^j \partial_\theta^k \left[e^{-i\varphi(x)\theta} K\left(b\left(|x|\right)x\theta\right) \right] \right| \le C'_{j,k} K_{j+k} \left(b\left(|x|\right)x\theta\right)$$

$$(3.13) \quad \sum_{\substack{j_1+j_2=j\\k_1+k_2=k}} \max_{\substack{s_1+s_2+s_3=j_1\\s_3\le k_1}} \left\{ |\theta|^{s_1} |x|^{-s_2} \left(b\left(|x|\right)x\right)^{k_1-s_3} \right\} \max_{\substack{l_1+l_2=j_2\\l_2\le k_2}} \left\{ |\theta|^{l_1} |x|^{k_2-l_2} \right\},$$

where $K_{p}(t), p \in \mathbb{N}$ are defined by

$$K_{0}(t) = |K(t)|, \ K_{p}(t) = \max_{1 \le p' \le p} \left| K^{(p')}(t) \right|, \ p \in \mathbb{N}^{*}.$$

Writing $|b(|x|) x| = |b(|x|) x\theta | |\theta|^{-1}$ and $|x|^{-1} = |b(|x|) x\theta |^{-1} b(|x|) |\theta|$, then there exists a constant C,

(3.14)
$$\begin{cases} |b(|x|) x| \leq C\lambda \left(b(|x|) x\theta \right) \lambda^{-1}(\theta), \\ |x|^{-1} \leq C |b(|x|) x\theta|^{-1} \lambda(\theta) \end{cases} \text{ on } [-1,1] \times \mathbb{R}_{\theta}.$$

We have $b^{-1}(|x|) \leq b^{-1}(\lambda^{-1}(\theta))$ when $|x| \geq \lambda^{-1}(\theta)$ (because b is increasing). Then,

$$|x| = |b(|x|) x\theta | (b(|x|) |\theta|)^{-1} \le |b(|x|) x\theta | |\theta|^{-1} b^{-1} (\lambda^{-1} (\theta))$$

$$\le C\lambda (b(|x|) x\theta) \lambda^{-1} (\theta) b^{-1} (\lambda^{-1} (\theta)).$$

Bearing in mind the other case when $|x| \le \lambda^{-1}(\theta)$, we obtain for a constant \widetilde{C} (3.15) $|x| \le \widetilde{C} \lambda (h(|x|) x \theta) \lambda^{-1}(\theta) h^{-1}(\lambda^{-1}(\theta))$

$$|x| \le C \wedge (0 ||x|) \times (0 + 0) \wedge (0 + 0) = (0 + 1) + (0$$

Finally from (3.11) to (3.15), we obtain (3.10).

Lemma 3.5. For any continuous function $b_0(t)$ on $[1, +\infty]$ such that

(3.16)
$$b_0(t) > 0, \quad \lim_{t \to +\infty} b_0(t) = +\infty,$$

then there exists a continuous function b(t) on [0,1] witch satisfies conditions (3.2) such that we have on $[-1,1]^n \times \mathbb{R}^n_{\theta}$

(3.17)
$$\left|\partial_x^{\alpha}\partial_{\theta}^{\beta}q(x,\theta)\right| \leq C_{\alpha,\beta}\lambda^{|\alpha|-|\beta|}\left(\theta\right)\left\{b_0\left(\lambda\left(\theta\right)\right)\right\}^{|\beta|}, \ \alpha,\beta\in\mathbb{N}^n.$$

Proof. Setting

 $\mathbf{6}$

$$\begin{cases} f_0(t) = \left\{ b_0(t^{-1}) \right\}^{-1} \text{ on } [0,1] \\ f_0(0) = 0, \end{cases}$$

then f_0 is a continuous function on [0, 1] which verifies condition (3.1). Then, by lemma 3.1, there exists a continuous function b(t) which satisfies (3.2). Noting that

$$\left\{b\left(\lambda^{-1}\left(\theta\right)\right)\right\}^{-1} \leq \left\{f_{0}\left(\lambda^{-1}\left(\theta\right)\right)\right\}^{-1} = b_{0}\left(\lambda\left(\theta\right)\right)$$

this gives (3.17).

Lemma 3.6. Let $\{b_l(t)\}_{l \in \mathbb{N}^*}$ be a sequence of continuous functions on $[1, +\infty[$ which satisfy (3.16). Then, there exists a continuous function $b_0(t)$ verifying (3.16), such that, for any l_0 ,

$$b_{l}(t) \geq b_{0}(t) \ on \ [t_{l_{0}}, +\infty[, \ l=1, ..., l_{0}]$$

Finally, our but is to give an unbounded Fourier integral operator of the form (2.5) with symbol in $\bigcap_{0 < \rho < 1} S^0_{\rho,1} (\mathbb{R}^n_x \times \mathbb{R}^n_{\theta})$.

Theorem 3.7. There exist a Fourier integral operator F of the form (2.5), with symbol $a \in \bigcap_{0 < \rho < 1} S^0_{\rho,1}(\mathbb{R}^n_x \times \mathbb{R}^n_{\theta})$, which cannot be extended to be a bounded operator on $L^2(\mathbb{R}^n)$.

Proof. Let $\phi(s)$ be a- $C_0^{\infty}(\mathbb{R})$ function such that

$$\begin{cases} \phi(s) = 1 \text{ on } [-\beta, \beta] & (\beta < 1) \\ \operatorname{supp} \phi \subset [-1, 1]. \end{cases}$$

Define a C^{∞} -symbol $a(x, \theta)$ by

$$a(x,\theta) = e^{-i\varphi(x)\psi(\theta)} \prod_{j=1}^{n} \phi(x_j) K(b(|x|) |x| \theta_j) \text{ in } \mathbb{R}^n_x \times \mathbb{R}^n_\theta$$

where K(t) and b(t) are the functions of lemma 3.4. Let $b_l(t) = \overline{\log \ldots \log (C_l + t)}$ defined on $[1, +\infty[$ and C_l some large constant, then by lemmas 3.5 and 3.6 we have $\forall (\alpha, \gamma) \in \mathbb{N}^n \times \mathbb{N}^n, \forall l \in \mathbb{N}^*$

$$(3.18) \qquad |\partial_x^{\alpha} \partial_{\theta}^{\gamma} a(x,\theta)| \le C_{\alpha,\gamma,l} \lambda^{|\alpha|-|\gamma|}(\theta) \left\{ b_l(\lambda(\theta)) \right\}^{|\gamma|},$$

 $C_{\alpha,\gamma,l}$ are constants, so that $a(x,\theta) \in \bigcap_{0 < \rho < 1} S^0_{\rho,1}(\mathbb{R}^n_x \times \mathbb{R}^n_\theta)$. Furthermore the corresponding Fourier integral F is

$$(Fu)(x) = \int_{\mathbb{R}^n_{\theta}} e^{i\varphi(x)\psi(\theta)} a(x,\theta) \mathcal{F}u(\theta) d\theta$$

(3.19)
$$= \prod_{j=1}^n \phi(x_j) \int_{\mathbb{R}^n_{\theta}} \prod_{j=1}^n K(b(|x|) |x| \theta_j) \mathcal{F}u(\theta) d\theta, \quad u \in \mathcal{S}(\mathbb{R}^n).$$

We consider (Fu)(x) in $[0,\beta]^n$. Then, using an adequate change of variable in the integral (3.19), we have

$$(Fu)(x) = \int_{\mathbb{R}_{z}^{n}} u(b(|x|)|x|z) \prod_{j=1}^{n} \mathcal{F}K(z_{j}) dz$$

which has the form of A in theorem 3.3. In addition the function g(x) = b(|x|) |x| satisfies (3.4). Consequently the operator F cannot be extended as a bounded operator on $L^2(\mathbb{R}^n)$.
