# ABOUT BREZIS-MERLE PROBLEM WITH HOLDERIAN CONDITION: THE CASE OF ONE OR TWO BLOW-UP POINTS.

Abstract. We consider the following problem on open set $\Omega$ of $\mathbb{R}^{2}$ :

$$
\left\{\begin{aligned}
-\Delta u_{i} & =V_{i} e^{u_{i}} & & \text { in } \Omega \subset \mathbb{R}^{2}, \\
u_{i} & =0 & & \text { in } \partial \Omega
\end{aligned}\right.
$$

We give a quantization analysis of the previous problem under the conditions:

$$
0 \leq V_{i} \leq b<+\infty, \text { and } \int_{\Omega} e^{u_{i}} d y \leq C
$$

On the other hand, if we assume that

$$
\int_{\Omega} V_{i} e^{u_{i}} d y \leq 4 \pi
$$

or, $V_{i} s$-holderian with $1 / 2<s \leq 1$, and,

$$
\int_{\Omega} V_{i} e^{u_{i}} d y \leq 24 \pi-\epsilon, \epsilon>0
$$

then we have a compactness result, namely:

$$
\sup _{\Omega} u_{i} \leq c=c(b, C, A, s, \epsilon, \Omega) .
$$

where $A$ is the holderian constant of $V_{i}$.

## 1. Introduction and Main Results

We set $\Delta=\partial_{11}+\partial_{22}$ on open set $\Omega$ of $\mathbb{R}^{2}$ with a smooth boundary.
We consider the following problem on $\Omega \subset \mathbb{R}^{2}$ :

(P)\left\{\begin{aligned}
-\Delta u_{i} & =V_{i} e^{u_{i}} & & \text { in } \Omega \subset \mathbb{R}^{2}, \\
u_{i} & =0 & & \text { in } \partial \Omega .
\end{aligned}\right.
$$

We assume that,

$$
\int_{\Omega} e^{u_{i}} d y \leq C
$$

and,

$$
0 \leq V_{i} \leq b<+\infty
$$

The above equation is called, the Prescribed Scalar Curvature equation, in relation with conformal change of metrics. The function $V_{i}$ is the prescribed curvature.

Here, we try to find some a priori estimates for sequences of the previous problem.
Equations of this type were studied by many authors, see [1-26]. One can see in [8] different results for the solutions of those type of equations with or without boundaries conditions and, with minimal conditions on $V$, for example we suppose $V_{i} \geq 0$ and $V_{i} \in L^{p}(\Omega)$ or $V_{i} e^{u_{i}} \in$ $L^{p}(\Omega)$ with $p \in[1,+\infty]$.

Among other results, we can see in [8], the following important Theorem,
Theorem $\mathbf{A}$ (Brezis-Merle [8]).If $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$ are two sequences of functions relatively to the previous problem $(P)$ with, $0<a \leq V_{i} \leq b<+\infty$, then, for all compact set $K$ of $\Omega$,

$$
\sup _{K} u_{i} \leq c=c(a, b, K, \Omega) .
$$

We can find in [8] an interior estimate if we assume $a=0$, but we need an assumption on the integral of $e^{u_{i}}$. We have in [8]:

Theorem B (Brezis-Merle [8]).If $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$ are two sequences of functions relatively to the previous problem $(P)$ with, $0 \leq V_{i} \leq b<+\infty$, and,

$$
\int_{\Omega} e^{u_{i}} d y \leq C
$$

then, for all compact set $K$ of $\Omega$,

$$
\sup _{K} u_{i} \leq c=c(b, C, K, \Omega) .
$$

If, we assume $V$ with more regularity, we can have another type of estimates, sup +inf. It was proved, by Shafrir, see [23], that, if $\left(u_{i}\right)_{i},\left(V_{i}\right)_{i}$ are two sequences of functions solutions of the previous equation without assumption on the boundary and, $0<a \leq V_{i} \leq b<+\infty$, then we have the following interior estimate:

$$
C\left(\frac{a}{b}\right) \sup _{K} u_{i}+\inf _{\Omega} u_{i} \leq c=c(a, b, K, \Omega)
$$

One can see in [12], an explicit value of $C\left(\frac{a}{b}\right)=\sqrt{\frac{a}{b}}$. In his proof, Shafrir has used a blowup function, the Stokes formula and an isoperimetric inequality, see [6]. For Chen-Lin, they have used the blow-up analysis combined with some geometric type inequality for the integral curvature.

Now, if we suppose $\left(V_{i}\right)_{i}$ uniformly Lipschitzian with $A$ the Lipschitz constant, then, $C(a / b)=$ 1 and $c=c(a, b, A, K, \Omega)$, see Brezis-Li-Shafrir [7]. This result was extended for Hölderian sequences $\left(V_{i}\right)_{i}$ by Chen-Lin, see [12]. Also, we have in [18] an extension of the Brezis-LiShafrir result to compact Riemann surface without boundary. We have in [19] explicit form, ( $8 \pi m, m \in \mathbb{N}^{*}$ exactly), for the numbers in front of the Dirac masses, when the solutions blowup. Here, the notion of isolated blow-up point is used. Also, we have in [13] and [26] refined estimates near the isolated blow-up points and the bubbling behavior of the blow-up sequences.

In [8], Brezis and Merle proposed the following Problem:
Problem (Brezis-Merle [8]).If $\left(u_{i}\right)_{i}$ and $\left(V_{i}\right)_{i}$ are two sequences of functions relatively to the previous problem $(P)$ with,

\begin{gathered}
0 \leq V_{i} \rightarrow V \text { in } C^{0}(\bar{\Omega}) . \\
\int_{\Omega} e^{u_{i}} d y \leq C,
\end{gathered}
$$

Is it possible to prove that:

$$
\sup _{\Omega} u_{i} \leq c=c(C, V, \Omega) ?
$$

Here, we assume more regularity on $V_{i}$, we suppose that $V_{i} \geq 0$ is $C^{s}$ (s-holderian) $1 / 2<$ $s \leq 1)$. We give the answer where $b C<24 \pi$.

On other hand, in our work we give a complete caracterization of the blow-up analysis on the boundary.

In the similar way, we have in dimension $n \geq 3$, with different methods, some a priori estimates of the type sup $\times$ inf for equation of the type:

$$
-\Delta u+\frac{n-2}{4(n-1)} R_{g}(x) u=V(x) u^{(n+2) /(n-2)} \text { on } M
$$

where $R_{g}$ is the scalar curvature of a riemannian manifold $M$, and $V$ is a function. The operator $\Delta=\nabla^{i}\left(\nabla_{i}\right)$ is the Laplace-Beltrami operator on $M$.

When $V \equiv 1$ and $M$ compact, the previous equation is the Yamabe equation. T. Aubin and R. Scheon solved the Yamabe problem, see for example [1]. Also, we can have an idea on the Yamabe Problem in [16]. If $V$ is not a constant function, the previous equation is called a prescribing curvature equation, we have many existence results see also [1].

Now, if we look at the problem of a priori bound for the previous equation, we can see in $[2,3,4,5,11,17,21]$ some results concerning the sup $\times$ inf type of inequalities when the manifold $M$ is the sphere or more generality a locally conformally flat manifold. For these results, the moving-plane was used, we refer to $[9,14,20]$ to have an idea on this method and some applications of this method.

Also, there are similar problems defined on complex manifolds for the Complex MongeAmpere equation, see [24, 25], with various inequalitites of type sup + inf.

Our main results are:
Theorem 1.1. Assume $\Omega=B_{1}(0)$, and,

$$
u_{i}\left(x_{i}\right)=\sup _{B_{1}(0)} u_{i} \rightarrow+\infty
$$

There is a finite number of sequences $\left(x_{i}^{k}\right)_{i},\left(\delta_{i}^{k}\right), 0 \leq k \leq m$, such that:

$$
\left(x_{i}^{0}\right)_{i} \equiv\left(x_{i}\right)_{i}, \delta_{i}^{0}=\delta_{i}=d\left(x_{i}, \partial B_{1}(0)\right) \rightarrow 0
$$

and each $\delta_{i}^{k}$ is of order $d\left(x_{i}^{k}, \partial B_{1}(0)\right)$.
and,

$$
\begin{gathered}
u_{i}\left(x_{i}^{k}\right)=\sup _{B_{1}(0)-\cup_{j=0}^{k-1} B\left(x_{i}^{j}, \delta_{i}^{j} \epsilon\right)} u_{i} \rightarrow+\infty, \\
u_{i}\left(x_{i}^{k}\right)+2 \log \delta_{i}^{k} \rightarrow+\infty, \\
\forall \epsilon>0, \sup _{B_{1}(0)-\cup_{j=0}^{m} B\left(x_{i}^{j}, \delta_{i}^{j} \epsilon\right)} u_{i} \leq C_{\epsilon} \\
\forall \epsilon>0, \limsup _{i \rightarrow+\infty} \int_{B\left(x_{i}^{k}, \delta_{i}^{k} \epsilon\right)} V_{i} e^{u_{i}} d y \geq 4 \pi>0 .
\end{gathered}
$$

If we assume:

$$
V_{i} \rightarrow V \text { in } C^{0}\left(\bar{B}_{1}(0)\right),
$$

then,

$$
\forall \epsilon>0, \limsup _{i \rightarrow+\infty} \int_{B\left(x_{i}^{k}, \delta_{i}^{k} \epsilon\right)} V_{i} e^{u_{i}} d y=8 \pi m_{k}, m_{k} \in \mathbb{N}^{*}
$$

And, thus, we have the following convergence in the sense of distributions:

$$
\int_{B_{1}(0)} V_{i} e^{u_{i}} d y \rightarrow \int_{B_{1}(0)} V e^{u} d y+\sum_{k=0}^{m} 8 \pi m_{k}^{\prime} \delta_{x_{0}^{k}}, m_{k}^{\prime} \in \mathbb{N}^{*}, x_{0}^{k} \in \partial B_{1}(0) .
$$

Theorem 1.2. Assume that:

$$
\int_{B_{1}(0)} V_{i} e^{u_{i}} d y \leq 4 \pi
$$

Then,

$$
u_{i}\left(x_{i}\right)=\sup _{B_{1}(0)} u_{i} \leq c=c(b, C)
$$

Theorem 1.3. Assume that, $V_{i}$ is uniformly s-holderian with $1 / 2<s \leq 1$, and,

$$
\int_{B_{1}(0)} V_{i} e^{u_{i}} d y \leq 24 \pi-\epsilon, \epsilon>0
$$

then we have:

$$
\sup _{\Omega} u_{i} \leq c=c(b, C, A, s, \epsilon, \Omega) .
$$

where $A$ is the holderian constant of $V_{i}$.
Question 1: (a Bartolucci type result; one holderian singularity): with the same technique, assume that:

$$
V_{i}(x)=\left(1+x_{1}^{s}\right) W_{i}(x) \text { for example and } 0 \in \partial \Omega
$$

with $W_{i}$ uniformly lipschitzian and, $0<s \leq 1$, can one conclude with the Pohozaev identity that the sequence is compact ? here we extend the case $0<s \leq 1 / 2$.

Question 2: (the limit case $s=1 / 2$ ) assume that $V_{i}$ is uniformly $1 / 2$ - holderian with $A_{i}$ the holderian constant and suppose that $A_{i} \rightarrow 0$, can one conclude with the blow-up technique that the sequence of the solutions $u_{i}$ is compact?

## 2. Proofs of the results

## Proofs of the theorems:

Without loss of generality, we can assume that $\Omega=B_{1}(0)$ the unit ball centered on the origin. We assume that:

$$
u_{i} \in W_{0}^{1,1}(\Omega)
$$

According to the work of Brezis-Merle, $e^{k u_{i}} \in L^{1}$ for all $k>2$ and the elliptic estimates and the Sobolev embedding gives:

$$
u_{i} \in W^{2, k}(\Omega) \cap C^{1, \epsilon}(\bar{\Omega})
$$

Here, $G$ is the Green function of the Laplacian with Dirichlet condition on $B_{1}(0)$. We have (in complex notation):

$$
G(x, y)=\frac{1}{2 \pi} \log \frac{|1-\bar{x} y|}{|x-y|}
$$

we can write:

$$
v_{i}(x)=\int_{B_{1}(0)} G(x, y) V_{i}(y) e^{u_{i}(y)} d y
$$

Remark that, we can write:

$$
F(x)=\int_{B_{1}(0)}-\frac{1}{2 \pi} \log |x-y| V_{i}(y) e^{u_{i}(y)} d y
$$

By a result in Gilbarg-Trudinger (cahpter 4, Newtonnian potential), we have $F \in C^{1}(\bar{\Omega})$
Also, we have:

$$
G(x)=\int_{B_{1}(0)}-\frac{1}{2 \pi} \log |1-\bar{x} y| V_{i}(y) e^{u_{i}(y)} d y
$$

For $x$ near $0, G$ is smooth by the usuual differentability theorem. For $x \neq 0$, we can write:
$K(x)=F(1 / \bar{x})$ which is $C^{1}$ by a result of Gilbarg-Trudinger. Combining the two last results, we have $v_{i}$ is $C^{1}$ and by the maximum principle we have $v_{i} \equiv u_{i}$. We use the fact that $G$ is real to write $\partial_{x} G=\bar{\partial}_{x} \bar{G}=\bar{\partial}_{\bar{x}} G$ to have the dirivative of $u_{i}$.

$$
G(x, y)=\frac{1}{2 \pi} \log \frac{|1-\bar{x} y|}{|x-y|}
$$

we can write:

$$
u_{i}(x)=\int_{B_{1}(0)} G(x, y) V_{i}(y) e^{u_{i}(y)} d y
$$

We can compute (in complex notation) $\partial_{x} G$ and $\partial_{x} u_{i}$ :

$$
\begin{gathered}
\partial_{x} G(x, y)=\frac{1-|y|^{2}}{(x-y)(x \bar{y}-1)} \\
\partial_{x} u_{i}(x)=\int_{B_{1}(0)} \partial_{x} G(x, y) V_{i}(y) e^{u_{i}(y)} d y=\int_{B_{1}(0)} \frac{1-|y|^{2}}{(x-y)(x \bar{y}-1)} V_{i}(y) e^{u_{i}(y)} d y
\end{gathered}
$$

we write,
$u_{i}\left(x_{i}\right)=\int_{\Omega} G\left(x_{i}, y\right) V_{i}(y) e^{u_{i}(y)} d x=\int_{\Omega-B\left(x_{i}, \delta_{i} / 2\right)} G\left(x_{i}, y\right) V_{i} e^{u_{i}(y)} d y+\int_{B\left(x_{i}, \delta_{i} / 2\right)} G\left(x_{i}, y\right) V_{i} e^{u_{i}(y)} d y$
According to the maximum principle, the harmonic function $G\left(x_{i},.\right)$ on $\Omega-B\left(x_{i}, \delta_{i} / 2\right)$ take its maximum on the boundary of $B\left(x_{i}, \delta_{i} / 2\right)$, we can compute this maximum:
$G\left(x_{i}, y_{i}\right)=\frac{1}{2 \pi} \log \frac{\left|1-\bar{x}_{i} y_{i}\right|}{\left|x_{i}-y_{i}\right|}=\frac{1}{2 \pi} \log \frac{\left|1-\bar{x}_{i}\left(x_{i}+\delta_{i} \theta_{i}\right)\right|}{\left|\delta_{i} / 2\right|}=\frac{1}{2 \pi} \log 2\left(\left|\left(1+\left|x_{i}\right|\right)+\bar{x}_{i} \theta_{i}\right|\right)<+\infty$ with $\left|\theta_{i}\right|=1 / 2$.
Thus,

$$
u_{i}\left(x_{i}\right) \leq C+\int_{B\left(x_{i}, \delta_{i} / 2\right)} G\left(x_{i}, y\right) V_{i} e^{u_{i}(y)} d y \leq C+e^{u_{i}\left(x_{i}\right)} \int_{B\left(x_{i}, \delta_{i} / 2\right)} G\left(x_{i}, y\right) d y
$$

Now, we compute $\int_{B\left(x_{i}, \delta_{i} / 2\right)} G\left(x_{i}, y\right) d y$
we set in polar coordinates,

$$
y=x_{i}+\delta_{i} t \theta
$$

we find:
$\int_{B\left(x_{i}, \delta_{i} / 2\right)} G\left(x_{i}, y\right) d y=\int_{B\left(x_{i}, \delta_{i} / 2\right)} \frac{1}{2 \pi} \log \frac{\left|1-\bar{x}_{i} y\right|}{\left|x_{i}-y\right|}=\frac{1}{2 \pi} \int_{0}^{2 \pi} \int_{0}^{1 / 2} \delta_{i}^{2} \log \frac{\left|1-\bar{x}_{i}\left(x_{i}+\delta_{i} \theta\right)\right|}{\left(\delta_{i} t\right) / 2} t d t d \theta=$

$$
=\frac{1}{2 \pi} \int_{0}^{2 \pi} \int_{0}^{1 / 2} \delta_{i}^{2}\left(\log 2\left(\left|1+\left|x_{i}\right|+t \bar{x}_{i} \theta\right|\right)-\log t\right) t d t d \theta \leq C \delta_{i}^{2}
$$

Thus,

$$
u_{i}\left(x_{i}\right) \leq C+C \delta_{i}^{2} e^{u_{i}\left(x_{i}\right)}
$$

which we can write, because $u_{i}\left(x_{i}\right) \rightarrow+\infty$,

$$
u_{i}\left(x_{i}\right) \leq C^{\prime} \delta_{i}^{2} e^{u_{i}\left(x_{i}\right)}
$$

We can conclude that:

$$
u_{i}\left(x_{i}\right)+2 \log \delta_{i} \rightarrow+\infty
$$

Now, consider the following function :

$$
v_{i}(y)=u_{i}\left(x_{i}+\delta_{i} y\right)+2 \log \delta_{i}, \quad y \in B(0,1 / 2)
$$

The function satisfies all conditions of the Brezis-Merle hypothesis, we can conclude that, on each compact set:

$$
v_{i} \rightarrow-\infty
$$

we can assume, without loss of generality that for $1 / 2>\epsilon>0$, we have:

$$
v_{i} \rightarrow-\infty, \quad y \in B(0,2 \epsilon)-B(0, \epsilon)
$$

Lemma 2.1. For all $1 / 4>\epsilon>0$, we have:

$$
\sup _{B\left(x_{i},(3 / 2) \delta_{i} \epsilon\right)-B\left(x_{i}, \delta_{i} \epsilon\right)} u_{i} \leq C_{\epsilon} .
$$

## Proof of the lemma

Let $t_{i}^{\prime}$ and $t_{i}$ the points of $B\left(x_{i}, 2 \delta_{i} \epsilon\right)-B\left(x_{i},(1 / 2) \delta_{i} \epsilon\right)$ and $B\left(x_{i},(3 / 2) \delta_{i} \epsilon\right)-B\left(x_{i}, \delta_{i} \epsilon\right)$ respectively where $u_{i}$ takes its maximum.

According to the Brezis-Merle work, we have:

$$
u_{i}\left(t_{i}^{\prime}\right)+2 \log \delta_{i} \rightarrow-\infty
$$

We write,

$$
\begin{gathered}
u_{i}\left(t_{i}\right)=\int_{\Omega} G\left(t_{i}, y\right) V_{i}(y) e^{u_{i}(y)} d x=\int_{\Omega-B\left(x_{i}, 2 \delta_{i} \epsilon\right)} G\left(t_{i}, y\right) V_{i} e^{u_{i}(y)} d y+ \\
+\int_{B\left(x_{i}, 2 \delta_{i} \epsilon\right)-B\left(x_{i},(1 / 2) \delta_{i} \epsilon\right)} G\left(t_{i}, y\right) V_{i} e^{u_{i}(y)} d y+ \\
\quad+\int_{B\left(x_{i},(1 / 2) \delta_{i} \epsilon\right)} G\left(t_{i}, y\right) V_{i} e^{u_{i}(y)} d y
\end{gathered}
$$

But, in the first and the third integrale, the point $t_{i}$ is far from the singularity $x_{i}$ and we know that the Green function is bounded. For the second integrale, after a change of variable, we can see that this integale is bounded by (we take the supremum in the annulus and use Brezis-Merle theorem)

$$
\delta_{i}^{2} e^{u_{i}\left(t_{i}^{\prime}\right)} \times I_{j}
$$

where $I_{j}$ is a Jensen integrale (of the form $\int_{0}^{1} \int_{0}^{2 \pi}\left(\log \left(\left|1+\left|x_{i}\right|+t \theta\right|\right)-\log \left|\theta_{i}-t \theta\right|\right) t d t d \theta$ which is bounded).
we conclude the lemma.
From the lemma, we see that far from the singularity the sequence is bounded, thus if we take the supremum on the set $B_{1}(0)-B\left(x_{i}, \delta_{i} \epsilon\right)$ we can see that this supremum is bounded and thus the sequence of functions is uniformly bounded or tends to infinity and we use the same arguments as for $x_{i}$ to conclude that around this point and far from the singularity, the seqence is bounded.

The process will be finished, because, according to Brezis-Merle estimate, around each supremum constructed and tending to infinity, we have:

$$
\forall \epsilon>0, \limsup _{i \rightarrow+\infty} \int_{B\left(x_{i}, \delta_{i} \epsilon\right)} V_{i} e^{u_{i}} d y \geq 4 \pi>0
$$

Finaly, with this construction, we have a finite number of "exterior "blow-up points and outside the singularities the sequence is bounded uniformly, for example, in the case of one "exterior" blow-up point, we have:

$$
\begin{gathered}
u_{i}\left(x_{i}\right) \rightarrow+\infty \\
\forall \epsilon>0, \sup _{B_{1}(0)-B\left(x_{i}, \delta_{i} \epsilon\right)} u_{i} \leq C_{\epsilon} \\
\forall \epsilon>0, \limsup _{i \rightarrow+\infty} \int_{B\left(x_{i}, \delta_{i} \epsilon\right)} V_{i} e^{u_{i}} d y \geq 4 \pi>0 . \\
x_{i} \rightarrow x_{0} \in \partial B_{1}(0) .
\end{gathered}
$$

We have the following lemma:

Lemma 2.2. Each $\delta_{i}^{k}$ is of order $d\left(x_{i}^{k}, \partial B_{1}(0)\right)$. Namely: there is a positive constant $C>0$ such that for $\epsilon>0$ small enough:

$$
\delta_{i}^{k} \leq d\left(x_{i}^{k}, \partial B_{1}(0)\right) \leq\left(2+\frac{C}{\epsilon}\right) \delta_{i}^{k}
$$

## Proof of the lemma

Now, if we suppose that there is another "exterior" blow-up $\left(t_{i}\right)_{i}$, we have, because $\left(u_{i}\right)_{i}$ is uniformly bounded in a neighborhood of $\partial B\left(x_{i}, \delta_{i} \epsilon\right)$, we have :

$$
d\left(t_{i}, \partial B\left(x_{i}, \delta_{i} \epsilon\right)\right) \geq \delta_{i} \epsilon
$$

If we set,

$$
\delta_{i}^{\prime}=d\left(t_{i}, \partial\left(B_{1}(0)-B\left(x_{i}, \delta_{i} \epsilon\right)\right)\right)=\inf \left\{d\left(t_{i}, \partial B\left(x_{i}, \delta_{i} \epsilon\right)\right), d\left(t_{i}, \partial\left(B_{1}(0)\right)\right)\right\}
$$

then, $\delta_{i}^{\prime}$ is of order $d\left(t_{i}, \partial B_{1}(0)\right)$. To see this, we write:

$$
d\left(t_{i}, \partial B_{1}(0)\right) \leq d\left(t_{i}, \partial B\left(x_{i}, \delta_{i} \epsilon\right)\right)+d\left(\partial B\left(x_{i}, \delta_{i} \epsilon\right), x_{i}\right)+d\left(x_{i}, \partial B_{1}(0)\right)
$$

Thus,

$$
\frac{d\left(t_{i}, \partial B_{1}(0)\right)}{d\left(t_{i}, \partial B\left(x_{i}, \delta_{i} \epsilon\right)\right)} \leq 2+\frac{1}{\epsilon},
$$

Thus,

$$
\delta_{i}^{\prime} \leq d\left(t_{i}, \partial B_{1}(0)\right) \leq \delta_{i}^{\prime}\left(2+\frac{1}{\epsilon}\right)
$$

Now, the general case follow by induction. We use the same argument for three, four,..., $n$ blow-up points.

We have, by induction and, here we use the fact that $u_{i}$ is uniformly bounded outside a small ball centered at $x_{i}^{j}, j=0, \ldots, k-1$ :

$$
\begin{gathered}

## The work of YY.Li-I.Shafrir

With the previous method, we have a finite number of "exterior" blow-up points (perhaps the same) and the sequences tend to the boundary. With the aid of proposition 1 of the paper of Li-Shafrir, we see that around each exterior blow-up, we have a finite number of "interior" blow-ups. Around, each exterior blow-up, we have after rescaling with $\delta_{i}^{k}$, the same situation as around a fixed ball with positive radius. If we assume:

Also, we set $x_{i}$ the blow-up point and $x_{i}^{2}=\left(0, x_{i}^{2}\right)$ and $x_{i}^{1}=\left(x_{i}^{1}, 0\right)$ respectevely the second and the first part of $x_{i}$. Let $\partial B^{+}$the part of the boundary for which $u_{i}$ and its derivatives are uniformly bounded and thus converge to the corresponding function.

Remark that, here, because we have the two conditions on $d\left(x_{i}, t_{i}\right)$ and $\delta_{i}, \delta_{i}^{\prime}$, the mediatrice of $\left[x_{i}, t_{i}\right]$ is close to a fixed segment $\left[0, x_{0}\right]$. (use angles for this fact).

By a conformal map, it is sufficient to prove that the corresponding integral on the unit ball on $D_{i}$ tends to 0 . \left|\partial_{x} u_{i}(x)\right| \leq C^{\prime}+C \frac{\delta_{i}}{\left|x_{i}-t_{i}\right|} \frac{1}{\left|x-t_{0}^{i}\right|}=C^{\prime}+\frac{o(1)}{\left|x-t_{0}^{i}\right|}
$$

with, $o(1) \rightarrow 0$ as $i \rightarrow+\infty$.
Case 2: $\left|x-t_{0}^{i}\right|<((1 / 2)-\tilde{\epsilon})\left|x_{i}-t_{i}\right|:$
In this case, we have:

$$
1-|y|^{2}=1-\left|x_{i}+\delta_{i} z\right|^{2}=\delta_{i}(2+o(1))
$$

and,

$$
|x-y|=\left|x-t_{0}^{i}+t_{0}^{i}-y_{i}-\delta_{i} z\right| \geq(\tilde{\epsilon} / 2)\left|x_{i}-t_{i}\right|
$$

and,

$$
|x \bar{y}-1|=\left|\left(\left(x-t_{0}^{i}+t_{0}^{i}-x_{i}\right)+x_{i}\right)\left(\bar{x}_{i}+\delta_{i} \bar{z}\right)-1\right| \geq(\tilde{\epsilon} / 2)\left|x_{i}-t_{0}^{i}\right|,
$$

Thus,

$$
\left|\partial_{x} u_{i}(x)\right| \leq C^{\prime}+C \frac{\delta_{i}}{\left|x_{i}-t_{i}\right|} \frac{1}{\left|x_{i}-t_{0}^{i}\right|}=C^{\prime}+\frac{o(1)}{\left|x_{i}-t_{0}^{i}\right|}
$$

with, $o(1) \rightarrow 0$ as $i \rightarrow+\infty$.

## Case 3: $((1 / 2)-\tilde{\epsilon})\left|x_{i}-t_{i}\right|<\left|x-t_{0}^{i}\right|<((1 / 2)+\tilde{\epsilon})\left|x_{i}-t_{i}\right|:$

Let $\tilde{t}_{0}^{i}$ the point of $D_{i}$ such that $\left|\tilde{t}_{0}^{i}-t_{0}^{i}\right|=1 / 2\left(\left|x_{i}-t_{i}\right|\right)$. We use the fact that the function:

$$
v_{i}(t)=u_{i}\left(\tilde{t_{0}^{i}}+\left(\left|x_{i}-t_{0}^{i}\right| / 4\right) t\right)
$$

is uniformly bounded for $|t| \leq 1$ and is a solution of PDE which is uniformly bounded on $|t| \leq 1$. By the elliptic estimates we have:

$$
\left|x_{i}-t_{i}\right|\left|\nabla u_{i}\right|_{L^{\infty}\left(D_{i} \cap\left\{((1 / 2)-\tilde{\epsilon})\left|x_{i}-t_{i}\right| \leq\left|x-t_{0}^{i}\right| \leq((1 / 2)+\tilde{\epsilon})\left|x_{i}-t_{i}\right|\right\}\right.} \leq C .
$$

Thus, we use the previous cases to compute the following integral:

$$
\int_{D_{i}}<\left(x_{2}^{i}-t_{2}^{i}\right)\left|\nabla u_{i}><\nu\right| \nabla u_{i}>d \sigma+\int_{D_{i}}<\left(x_{2}^{i}-t_{2}^{i}\right)\left|\nu>\left|\nabla u_{i}\right|^{2} d \sigma=o(1)\right.
$$

and, thus,

$$
\int_{D_{i}^{\prime}}<\left(x_{2}^{i}-t_{2}^{i}\right)\left|\nabla u_{i}><\nu\right| \nabla u_{i}>d \sigma+\int_{D_{i}^{\prime}}<\left(x_{2}^{i}-t_{2}^{i}\right)\left|\nu>\left|\nabla u_{i}\right|^{2} d \sigma=o(1)\right.
$$

here, we used the previous estimates with $i \rightarrow+\infty$ and $\tilde{\epsilon} \rightarrow 0$ (for the previous case 3 ).
