# Spectral analysis on interior transmission eigenvalues

#### Abstract

In this paper we prove some results on interior transmission eigenvalues. First, under reasonable assumptions, we prove that the spectrum is a discrete countable set and the generalized eigenfunctions spanned a dense space in the range of resolvent. This is a consequence of spectral theory of Hilbert-Schmidt operators. The main ingredient is to prove a smoothing property of resolvent. This allows to prove that a power of the resolvent is Hilbert-Schmidt. We obtain an estimate of the number of eigenvalues, counting with multiplicities, with modulus less than $t^{2}$ when $t$ is large. We prove also some estimate on the resolvent near the real axe when the square of the index of refraction is not real. Under some assumptions we obtain lower bound on the resolvent using the results obtained by Dencker, Sjöstrand and Zworski on the pseudospectra.

## 1 Introduction

In this paper we prove existence of infinite number of interior transmission eigenvalues under some condition on the index of refraction. Remind the problem. Let $\Omega$ a smooth bounded domain in $\mathbb{R}^{n}$. Let $n(x)$ a smooth function defined in $\bar{\Omega}$, called the index of refraction. The problem is to find $k$ and $(w, v)$ such that

\Delta v+k^{2} v=0 \text { in } \Omega \\
w=v \text { on } \partial \Omega \\
\partial_{\nu} w=\partial_{\nu} v \text { on } \partial \Omega
\end{array}\right.
$$

where $\partial_{\nu}$ is the exterior normal derivative to $\partial \Omega$. We consider here the function $n(x)$ complex valued. In the physical models, we have $n(x)=n_{1}(x)+i n_{2}(x) / k$ where $n_{j}$ are real valued. Taking $u=w-v$ and $\tilde{v}=k^{2} v$, we obtain the following equivalent system

u=\partial_{\nu} u=0 \text { on } \partial \Omega
\end{array}\right.
$$

where, for simplicity, we have replaced $\tilde{v}$ by $v$ and $n$ by $1+m$.
Under some assumptions on $n(x)$, for instance our results apply for $n(x)=n_{1}(x)+i n_{2}(x) / k$ where $n_{j}$ are real valued, we prove that the associated resolvent is compact on $H^{2}(\Omega) \oplus L^{2}(\Omega)$ (see Theorem 2) and we have a countable set of $k_{j}^{2}$ and generalized finite dimensional eigenspace $E_{j}$ such that $\cup_{j \in \mathbb{N}} E_{j}$ spanned a dense space in the range of the resolvent (see Theorem 3). When $n(x)$ is real, Päivärinta ans Sylvester [22] have proved that there exist interior transmission eigenvalues, Cakoni, Gintides and Haddar [5] proved that the set of $k_{j}^{2}$ is infinite and discrete. For $n(x)$ complex valued Sylvester [23] proved that this set is discrete finite or infinite. The case where $n(x)=1$ in a part of $\Omega$ that is the presence of cavities in $\Omega$ was considered by Cakoni, Çayören and Colton [3], Cakoni, Colton and Haddar [4]. Here maybe because we use pseudo-differential calculus we do not have problems with cavities. In [13, 14] Hitrik, Krupchyk, Ola and Päivärinta studied same type of problems where the Laplacian is replaced by an elliptic operator with constant coefficients of order $m \geq 2$. They proved in some cases, existence of interior transmission eigenvalue and the generalized eigenfunctions span a dense space. The proof uses the property of trace class operators and requires that $m>n$. Here as we consider the power of resolvent we have not this restriction and we consider the Laplacian for seek of simplicity but we can replace the Laplacian by a general elliptic operator of order 2 with real coefficients.

We can complete this result giving a weak version of Weyl law. If we denote by $N(t)$ the number of $\left|k_{j}\right|$, counting with multiplicities, smaller than $t$, we prove that $N(t) \leq C t^{n+4}$ (see Theorem 4). In [16], [17] and [18], Lakshtanov and Vainberg study a problem as the (1) where the boundary condition $\partial_{\nu} w=\partial_{\nu} v$ is replaced by $\partial_{\nu} w=a(x) \partial_{\nu} v$ where $a(x) \neq 1$ for all $x \in \partial \Omega$. In this case the problem is elliptic in the sense that if $(f, g) \in L^{2}(\Omega)$ then $(w, v) \in H^{2} \Omega$ ) (see (5) for the definition of the system with force terms). In [19] they prove an lower bound on the counting function $N(t)$, if $n(x)$ is real and for the problem (1). To be precise they prove $N(t) \geq C t^{n}$ where $C>0$. Actually they consider only the real eigenvalues but it is not clear that the bound is sharp even for real eigenvalues.

In [8] Colton and Kress prove that if $\operatorname{Im} n(x) \geq 0$ for all $x \in \bar{\Omega}$ and $\operatorname{Im} n \neq 0$ then $k^{2}$ is not real. Here we give an estimate on the resolvent for $k^{2} \in \mathbb{R}$ (see Theorem 5). This result is based on the Carleman estimates and following the same way as in the context of control theory, stabilization, scattering (see for instance [20], [21], [10]).

In some case (see Theorem 6) we can give lower bound on the resolvent using the result obtained by Dencker, Sjöstrand and Zworski [12] on the pseudospectra. Even if the bounds obtained by Carleman's method and by the pseudospectra results have the same size, we cannot apply both methods in the same situation.

The interest of the problem (1) is related with the Theorem 8.9 in Colton and Kress [8] first proved by Colton, Kirsch and Päivärinta [7]. Here we give a quick survey of this result. Let $n(x)$ defined in $\Omega$ as the one in (1) and by 1 in $\mathbb{R}^{n} \backslash \Omega$. We assume $n(x) \neq 1$ in $\Omega$. For $k \in \mathbb{R}$, let $u$ the
solution of the following problem

u=u^{i}+u^{s}, \\
\lim _{r \rightarrow+\infty} r^{(n-1) / 2}\left(\frac{\partial u^{s}}{\partial r}-i k u^{s}\right)=0
\end{array}\right.
$$

where $u^{i}$ is a solution to $\Delta u^{i}+k^{2} u^{i}=0$ in $\mathbb{R}^{n}$, and $r=|x|$. We have $u^{s}(x)=\frac{e^{i k|x|}}{|x|^{(n-1) / 2}} u_{\infty}(\hat{x})+$ $O\left(\frac{1}{|x|^{(n+1) / 2}}\right)$, where $\hat{x}=x /|x|$.

If $u^{i}(x)=e^{i k x d}$, where $d \in \mathbb{S}^{n-1}$ we denote the corresponding $u_{\infty}$ by $u_{\infty}(\hat{x}, d)$. If we assume that $\Omega$ is connected and contains 0 , the space spanned by $u_{\infty}(\hat{x}, d)$ for $d \in \mathbb{S}^{n-1}$ is dense in $L^{2}\left(\mathbb{S}^{n-1}\right)$ if and only if the space of solution of (1) is reduced to 0 . This problem can be interpreted as follow, $u^{i}$ is a incident plane wave and $u_{\infty}$ is the first relevant term of $u$ created by the perturbation $n$ localized in $\Omega$. This kind of result is interesting in the field of inverse scattering problem. I let the reader interested by this field to find more information in [8] and in the recent survey given by Cakoni and Haddar [6].

### 1.1 Results

Let $\Omega$ a $\mathscr{C}^{\infty}$ bounded domain in $\mathbb{R}^{n}$. Let $n(x) \in \mathscr{C}^{\infty}(\bar{\Omega})$ complex valued. We denote by $m(x)=$ $n(x)-1$. We consider also the case where $n(x)=n_{1}(x)+i n_{2}(x) / k$ where $n_{j}$ are real valued. We assume that for all $x \in \bar{\Omega}, n(x) \neq 0$, or $n_{1}(x) \neq 0$ or equivalently $m(x) \neq-1$. We assume there exists a neighborhood $W$ of $\partial \Omega$ such that for $x \in \bar{W}, n(x) \neq 1$ or $n_{1}(x) \neq 1$ or equivalently $m(x) \neq 0$. Actually if $n(x) \neq 1$ for all $x \in \partial \Omega$, such a neighborhood $W$ exists.

Let $C_{e}$ the cone in $\mathbb{C}$ defined by

C_{e}=\{z \in \mathbb{C}, \exists x \in \bar{\Omega}, \exists \lambda \geq 0, \text { such that } z=-\lambda(1+\bar{m}(x))\} \tag{3}
\end{equation*}

In the case where $n=n_{1}+i n_{2} / k, C_{e}=(-\infty, 0]$ if $n_{1}(x)>-1$ for all $x \in \bar{\Omega}$, and $C_{e}=[0,+\infty)$ if $n_{1}(x)<-1$ for all $x \in \bar{\Omega}$.

Our regularity result will be given in the Sobolev spaces. We use the following notations. The $L^{2}(\Omega)$-norm will be denoted by $\|\cdot\|$. For $s \in \mathbb{R}$, we denote the usual $H^{s}$ norm in $\mathbb{R}^{n}$ by $\|w\|_{H^{s}}^{2}=$ $\int\left(1+|\xi|^{2}\right)^{s}|\hat{u}(\xi)|^{2} d \xi$ where $\hat{u}$ is the classical Fourier transform. The $H^{s}$ space on $\Omega$ will be denoted by $\bar{H}^{s}(\Omega)$ and we say that $w$ a distribution in $\Omega$ is in $\bar{H}^{s}(\Omega)$ if there exists $\beta \in H^{s}$ such that $\beta_{\mid \Omega}=w$. The norm is given by $\|w\|_{\bar{H}^{s}(\Omega)}=\inf \left\{\|\beta\|_{H^{s}}\right.$, where $\left.\beta_{\mid \Omega}=w\right\}$. For $q \in \mathbb{N}$ it is classical that $\|w\|_{\bar{H}^{q}(\Omega)}^{2}$ is equivalent to $\sum_{|\alpha| \leq q}\left\|\partial_{x}^{\alpha} w\right\|^{2}$ (see for instance [15, Vol. 3, Corollary B.2.5]).

We denote by $B_{z}(u, v)=(f, g)$ the mapping defined from $H_{0}^{2}(\Omega) \oplus\left\{v \in L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$ to $L^{2}(\Omega) \oplus L^{2}(\Omega)$ by

\left(\frac{1}{1+m} \Delta-z\right) u+\frac{m}{1+m} v=f \text { in } \Omega  \tag{4}\\
(\Delta-z) v=g \text { in } \Omega
\end{array}\right.
$$

Theorem 1. Assume $C_{e} \neq \mathbb{C}$, then there exists $z \in \mathbb{C}$ such that $B_{z}$ is bijective from $H_{0}^{2}(\Omega) \oplus\{v \in$ $\left.L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$ to $L^{2}(\Omega) \oplus L^{2}(\Omega)$.

If for $z \in \mathbb{C}$ the solution $B_{z}(u, v)=(f, g)$ exists we denote by $R_{z}(f, g)=(u, v)$.
Theorem 2. Assume $C_{e} \neq \mathbb{C}$, there exists $z \in \mathbb{C}$ such that the resolvent $R_{z}$ from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself is compact.

In particular, we can apply the Riesz theory, the spectrum is finite or a discrete countable set. If $\lambda \neq 0$ is in the spectrum, $\lambda$ is a eigenvalue with finite dimensional associated generalized eigenspace.

Remark 1. This result improves the Sylvester's theorem [23, theorem 2] with respect the geometrical assumption on $m$. Nevertheless, here the regularity assumption on $m$ is stronger than the assumption given in [23].

Remark 2. Actually if $z_{0} \notin C_{e} \cup(-\infty, 0]$ for all $\lambda$ large enough we can take $z=\lambda z_{0}$ in the Theorems 1 and 2.

Remark 3. Actually we can also consider $R_{z}$ on $L^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself. The range is in $H_{0}^{2}(\Omega) \oplus$ $L^{2}(\Omega)$. Then with our regularity results we can prove that $R_{z}^{2}$ is a mapping from $L^{2}(\Omega) \oplus L^{2}(\Omega)$ to $\bar{H}^{4}(\Omega) \oplus \bar{H}^{2}(\Omega)$. In particular $R_{z}^{2}$ is compact from $L^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself and we can deduce the same properties on the spectrum of $R_{z}$ as in Theorem 2 .

In general for a non self-adjoint problem, we cannot claim that the spectrum is non empty. In the following theorem, with a stronger assumption on $C_{e}$, we can prove that the spectrum is non empty.

We say that $C_{e}$ is contained in a sector with angle less than $\theta$ if there exist $\theta_{1}<\theta_{2}$, such that $C_{e} \subset\left\{z \in \mathbb{C}, z=0\right.$ or $\frac{z}{|z|}=e^{i \varphi}$, where $\left.\theta_{1} \leq \varphi \leq \theta_{2}\right\}$, and $\theta_{2}-\theta_{1} \leq \theta$.

Theorem 3. Assume that $C_{e}$ is contained in a sector with angle less than $\theta$ with $\theta<2 \pi / p$ and $\theta<\pi / 2$ where $4 p>n$. Then there exists $z$ such that the spectrum of $R_{z}$ is infinite and the space spanned by the generalized eigenspaces is dense in $H_{0}^{2}(\Omega) \oplus\left\{v \in L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$.

Remark 4. This result is based on the theory given in Agmon [1] and using the spectral results on Hilbert-Schmidt operators. In this theory we deduce that the spectrum is infinite from the proof that the generalized eigenspaces is dense in the closure of the range of $R_{z}$. Here we prove that $R_{z}^{p}$ is a Hilbert-Schmidt operator if $4 p>n$. We can deduce the spectral decomposition of $R_{z}$ from the one of $R_{z}^{p}$.

We can prove a weak Weyl law. Let $z_{j}$ the elements of the spectrum of $R_{z}$ and $E_{j}$ the generalized associated eigenspace. We denote by $N(t)=\sum_{\left|z_{j}\right|^{-1} \leq t^{2}} \operatorname{dim} E_{j}$.

Theorem 4. Under the same assumption as in Theorem 3, then there exists $C>0$ such that $N(t) \leq C t^{4+n}$.

Remark 5. I do not know if this result is optimal. The estimate is lower than the usual Weyl law which is in $t^{n}$. This is due to the estimates obtained on the resolvent which are different than the one used to prove the usual Weyl law.

Here we give some ideas to obtain the Theorems 3 and 4 using the method given in Agmon [1]. First we prove a regularity result, that is we consider the iterate of $R_{z}$, we have $R_{z}^{k}$ is bounded from $H^{2} \oplus L^{2}$ to $H^{2 k+2} \oplus H^{2 k}$. This implies that $R_{z}^{k}$ is an Hilbert-Schmidt operator if $k$ is large enough and we can use the spectral theory for this operator class. The main problem to prove the regularity result is at the boundary. To do this we reduce the problem to the boundary by using the pseudo-differential calculus. It is well-known that for an elliptic problem, we can find a relation between the two traces of a solution. These two relations, for $u$ and $v$ in (4) and the assumption on the two traces of $u$ allows to compute the trace of $v$ by the data. Actually the coupling is very weak because it involves a lower order term, consequently we obtain a weak estimate.

In the context of stabilization or control for wave equation, there are a lot of results on decreasing of energy obtained by Carleman estimates (see for instance [20, 21, 10]). This method allows to give quantitative results related with uniqueness result. We use here the same method to prove an estimate on the resolvent near the real axe for a complex index of refraction. The theorem below is an quantitative version of the Theorem 8.12 given by Colton and Kress [8]. Here it is more convenient to use the variables introduce in (1). Let $(w, v)$ solutions of

w=v \text { on } \partial \Omega \\
\partial_{\nu} w=\partial_{\nu} v \text { on } \partial \Omega
\end{array}\right.
$$

where $(f, g) \in L^{2}(\Omega) \oplus L^{2}(\Omega)$. We denote $\tilde{R}_{k^{2}}(f, g)=(w, v)$. Remark that $\tilde{R}_{k^{2}}$ exists except for a discrete set of $k^{2}$. Indeed we can check that $R_{-k^{2}}\left(f-g, k^{2} g\right)=\left(w-v, k^{2} v\right)$ this gives $(w, v)$ if $\left(-k^{2}\right)^{-1}$ is not in the spectrum of $R_{0}$.

Theorem 5. We assume that $\operatorname{Im} n \geq 0$ and $\operatorname{Im} n \not \equiv 0$ or if $n(x)=n_{1}(x)+i n_{2}(x) / k, n_{2}(x) \geq 0$ and $n_{2} \not \equiv 0$. Then there exist $C_{1}>0$ and $C_{2}>0$ such that $\left\|\tilde{R}_{k^{2}}\right\| \leq C_{1} e^{C_{2}|k|}$ for all $k \in \mathbb{R}$. Here $\|\cdot\|$ denote the norm of the operator from $L^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself.

Remark 6. We have the same result if we assume $\operatorname{Im} n \leq 0$ and $\operatorname{Im} n \not \equiv 0$ or if $n(x)=n_{1}(x)+$ $i n_{2}(x) / k, n_{2}(x) \leq 0$ and $n_{2} \not \equiv 0$.

In the context of non self-adjoint operator, the spectrum is not the most relevant notion. Actually Davies [11] introduced the notion of the pseudospectrum. Roughly speaking this set is defined by the points $z$ where the resolvent is large. This notion is related with the notion of ill-conditioned for the matrix. Here we use the result proved by Dencker, Sjöstrand and Zworski [12] to obtain a lower bound on the norm of resolvent.

Theorem 6. Assume there exist $\xi_{0} \in \mathbb{R}^{n}$ and $x_{0} \in \Omega$ such that $\operatorname{Im}\left(\left(\bar{n}\left(x_{0}\right)\right)\left\langle\xi_{0}, \partial_{x} n\left(x_{0}\right)\right\rangle\right) \neq 0$. Then for all $N>0$, $\sup \left\{|k|^{-N}\left\|\tilde{R}_{k^{2}}\right\|, k^{2}=r\left(n\left(x_{0}\right)\right)^{-1}, r>0\right\}=+\infty$. Moreover if $n$ is an analytic function in a neighborhood of $x_{0}$ there exists $C>0$ such that $\sup \left\{e^{-C|k|}\left\|\tilde{R}_{k^{2}}\right\|, k^{2}=r\left(n\left(x_{0}\right)\right)^{-1}, r>0\right\}=+\infty$.

Remark 7. Even if the lower bound, in analytic case, is of the same type of the upper bound obtained in Theorem 5, we cannot apply both theorems for the same direction $z$. Actually $k^{2}$ is in general in $\mathbb{C}$, if we want apply the Theorem 5 we need $n\left(x_{0}\right) \in \mathbb{R}$, that is $\operatorname{Im} n\left(x_{0}\right)=0$, as $\operatorname{Im} n(x) \geq 0$ then we cannot have $\operatorname{Im} \partial_{x} n\left(x_{0}\right) \neq 0$ to apply the Theorem 6 .

### 1.2 Ouline

In the Section 2 we prove the main technical results. Roughly speaking if the data $(f, g)$ are more regular in $H^{s}$ norm we prove that the solution $(u, v)$ is also more regular. More precisely, we prove for $p \geq 0$, that if $(f, g) \in \bar{H}^{2 p+2}(\Omega) \oplus \bar{H}^{2 p}(\Omega)$ then $R_{z}(f, g)=(u, v) \in \bar{H}^{2 p+4}(\Omega) \oplus \bar{H}^{2 p+2}(\Omega)$. This proves first that $R_{z}$ is compact as an operator from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself and $R_{z}^{p}$ is an operator from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ to $\bar{H}^{2 p+2}(\Omega) \oplus \bar{H}^{2 p}(\Omega)$. This implies that $R_{z}^{p}$ is an Hilbert-Schmidt operator on $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ if $4 p>n$. To prove the regularity result, first we prove an estimate on $u$ in the subsection 2.1. It is an easy estimate to obtain as $u_{\mid \partial \Omega}=0, u$ satisfies a classical Dirichlet problem. Second we prove in Subsection 2.2 the regularity of $v$ in all compact in $\Omega$. As $v$ satisfies an elliptic equation, far away the boundary of $\Omega$ it is a classical result. In the third Subsection 2.3 we prove the regularity result on $v$ in a neighborhood of $\partial \Omega$. The idea to do this is to explain $v$ by the unknown traces of $v$. This description allows to obtain a relation between $v_{\mid \partial \Omega}$ and $\partial_{n} v_{\mid \partial \Omega}$. Then we can use this formula on $v$ in the equation on $u$. The fact that $u_{\mid \partial \Omega}=0$ and $\partial_{n} u_{\mid \partial \Omega}=0$ gives another relation between $v_{\mid \partial \Omega}$ and $\partial_{n} v_{\mid \partial \Omega}$. These relations allow to determine $v_{\mid \partial \Omega}$ and $\partial_{n} v_{\mid \partial \Omega}$ with $(f, g)$. This explicit formula, in sense of pseudo-differential calculus, allows to prove the regularity result. We need also following the same way to prove an estimate of the $L^{2}$ norm of $v$ by the $L^{2}$ norm of $f$. This implies a weak convergence result. Actually the problem is that $v$ has the same regularity than $f$. In particular if we consider the resolvent as a operator from $L^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself, we cannot prove that the resolvent is compact. Here we avoid this problem by the assumption that $f \in \bar{H}^{2}(\Omega)$.

In the Section 4 we recall some result proved in Agmon [1] and we apply this to prove the Theorems 2, 3 and 4.

In the Section 5 we prove some a priori bound on the resolvent. In Subsection 5.1 we prove an upper bound on the resolvent near the real axe when the imaginary part of the refraction index have a sign and is not identically null. The main tool is to use the interpolation estimate obtained from the Carleman estimate. In the Subsection 5.2 we use the result obtained by Dencker, Sjöstrand and Zworski [12] on the pseudospectra to obtain lower bound on the resolvent. Roughly speaking this result says that when the operator is not elliptic in the semi-classical sense, even if a point is not in the spectrum, the resolvent is generically large.

As we use deeply the semi-classical pseudo-differential calculus in the Section 2, in the Appendix A we fix the notation used in the rest of paper, we recall the classical results used, we give some ideas of proof on the action of the pseudo-differential operators on $\bar{H}^{s}(\Omega)$ spaces, we give some computations on integrals to obtain some explicit formulae used in Subsection 2.3. This allows to give the explicit first term of the resolvent in sense of the semi-classical pseudo-differential calculus.

## 2 Regularity results

We describe now the idea of the proof. As we want prove an estimate when $|z|$ is large we will compute the resolvent in semi-classical framework. We multiply the Equations (4) by $h^{2}$, we denote by $\mu=-h^{2} z$ where $\mu$ belongs to a bounded domain of $\mathbb{C}, a=1 /(1+m)$ and $V=m /(1+m)$. We change $(f, g)$ in $(-f,-g)$.

Remind the assumption on $m$, we have $m(x) \neq-1$ for all $x \in \bar{\Omega}$ and $m(x) \neq 0$ for $x$ in a neighborhood of $\partial \Omega$.

Thus following (4), we obtain the system

\left(-h^{2} \Delta-\mu\right) v=h^{2} g \text { in } \Omega \\
u=\partial_{\nu} u=0 \text { on } \partial \Omega
\end{array}\right.
$$

The goal of this section is to prove the following estimates if $s \geq 0$. The result is given using the semi-classical $H^{s}$ norm, see Appendix A for the definition of these spaces.

Theorem 7. We assume that for all $x \in \bar{\Omega}$, and all $\xi \in \mathbb{R}^{n}$, $a(x)|\xi|^{2}-\mu \neq 0$ and $|\xi|^{2}-\mu \neq 0$. Let $s \geq 0$, there exists $h_{0}>0$ such that for $f \in \bar{H}_{s c}^{2+s}(\Omega), g \in \bar{H}_{s c}^{s}(\Omega), u \in \bar{H}_{s c}^{1+s}(\Omega) \cap H_{0}^{2}(\Omega)$ and $v \in \bar{H}_{s c}^{s}(\Omega)$ solutions of system (6) then $u \in \bar{H}_{s c}^{4+s}(\Omega), v \in \bar{H}_{s c}^{2+s}(W)$ and for $h \in\left(0, h_{0}\right)$ we have,

\|u\|_{\bar{H}_{s c}^{4+s}(\Omega)} & \lesssim h^{2}\|f\|_{\bar{H}_{s c}^{2+s}(\Omega)}+h^{4}\|g\|_{\bar{H}_{s c}^{s}(\Omega)}  \tag{7}\\
\|v\|_{\bar{H}_{s c}^{2+s}(\Omega)} & \lesssim\|f\|_{\bar{H}_{s c}^{2 s}(\Omega)}+h^{2}\|g\|_{\bar{H}_{s c}^{s}(\Omega)} . \tag{8}
\end{align*}
$$

First we prove an estimate on $u$. For this, we work globally in $\Omega$. The estimate on $v$ is more difficult to obtain. In a first step we prove an estimate in the interior by usual pseudo-differential tools. In a second step we prove the estimate in a neighborhood of the boundary $\partial \Omega$ and we finish the proof. This will be do in the following three sections.

In the proof we use semi-classical pseudo-differential calculus. We give in Appendix A, the results used, trace formula, action of pseudo-differential operators on Sobolev space, the parametrices.

### 2.1 Estimate on $u$

The goal of this section is to proof a weak version of (7).
Lemma 2.1. We assume that for all $x \in \bar{\Omega}$, and all $\xi \in \mathbb{R}^{n}$, $a(x)|\xi|^{2}-\mu \neq 0$. There exists $h_{0}>0$ such that for $s \geq 0$, for all $f \in \bar{H}_{s c}^{s}(\Omega), v \in \bar{H}_{s c}^{s}(\Omega)$, and $u \in H_{0}^{2}(\Omega)$ solution of

u=\partial_{\nu} u=0 \text { on } \partial \Omega

then $u \in \bar{H}_{s c}^{2+s}(\Omega)$ and for $h \in\left(0, h_{0}\right)$,

\|u\|_{\bar{H}_{s c}^{2+s}(\Omega)} \lesssim h^{2}\|f\|_{\bar{H}_{s c}^{s}(\Omega)}+h^{2}\|v\|_{\bar{H}_{s c}^{s}(\Omega)} . \tag{9}
\end{equation*}
$$

Proof. As $u \in H_{0}^{2}(\Omega)$, we can extend $u$ by 0 in the exterior of $\Omega$ and $u$ satisfied the same equation in the whole space. Here we extend also $v$ and $f$ by 0 , this makes sense at least in $L^{2}$. We have

where we denote, for $w \in L^{2}(\Omega)$, by

Let $N \geq s+2$, we take a parametrix $Q$ of $-a h^{2} \Delta-\mu$, this is possible because we assume for all $x \in \bar{\Omega}, a(x)|\xi|^{2}-\mu \neq 0$. We have $Q\left(-a h^{2} \Delta-\mu\right)=\chi+h K$ where $\chi \in \mathscr{C}_{0}^{\infty}\left(\mathbb{R}^{n}\right), \chi=1$ in a neighborhood of $\Omega, K$ is of order $-N$ and $Q$ is of order -2 .

Applying $Q$ to Equation (10) we obtain,

As $Q$ is a mapping on the Sobolev spaces (see (56)) we obtain,

We can absorb the term $h\|u\|_{L^{2}(\Omega)}$ by the left hand side and this imply (9).

### 2.2 Estimate on $v$ in interior of $\Omega$

To prove an estimate on $v$ in interior of $\Omega$ we follow essentially the same way than in the proof of the estimate on $u$ given in the previous section except that we cannot extend $v$ in exterior of $\Omega$ but we use semi-classical pseudo-differential calculus in open relatively compact in $\Omega$. The estimate proved is given in the following lemma.

Lemma 2.2. We assume for all $\xi \in \mathbb{R}^{n}$, we have $|\xi|^{2}-\mu \neq 0$. Let $\chi \in \mathscr{C}_{0}^{\infty}\left(\mathbb{R}^{n}\right)$ supported in $W$ relatively compact in $\Omega$, and $s \geq 0$, there exists $h_{0}>0$ such that for $g \in \bar{H}_{s c}^{s}(\Omega)$ and $v \in \bar{H}_{s c}^{s+1}(\Omega)$ solution of

\left(-h^{2} \Delta-\mu\right) v=h^{2} g \text { in } \Omega
$$

then $v \in \bar{H}_{s c}^{2+s}(W)$ and for $h \in\left(0, h_{0}\right)$ we have,

\|\chi v\|_{H_{s c}^{2+s}} \lesssim h\|v\|_{\bar{H}_{s c}^{s+1}(\Omega)}+h^{2}\|g\|_{\bar{H}_{s c}^{s}(\Omega)} \tag{11}

Proof. In the sequel we can take $\chi$ supported in $W$ or $\chi=1$ on $W$ and supported in a compact of $\Omega$. We can essentially repeat the proof of Lemma 2.1 given to estimate $u$.

As we have assumed that $|\xi|^{2}-\mu \neq 0$, we can take a parametrix $\tilde{Q}$ of $\left(-h^{2} \Delta-\mu\right)$ defined globally in $\mathbb{R}^{n}$, such that we have $\tilde{Q}\left(-h^{2} \Delta-\mu\right)=\chi+h K$ where $K$ is of order $-1, \tilde{Q}$ is of order -2 . Let $\chi_{j} \in \mathscr{C}_{0}^{\infty}\left(\mathbb{R}^{n}\right), j=1,2$ supported in a compact of $\Omega$ where $\chi_{1}=1$ on the support of $\chi$ and $\chi_{2}=1$ on support of $\chi_{1}$. By pseudo-differential calculus we have $\tilde{Q} \chi_{1}\left(-h^{2} \Delta-\mu\right)=\chi+h K_{-1}$ where $K_{-1}$ is of order -1 . Now we have $\tilde{Q} \chi_{1}\left(-h^{2} \Delta-\mu\right) \chi_{2}=\chi_{\tilde{Q}}+h K_{-1} \chi_{2}$. We can localized the equation on $v$ and we have $\chi_{1}\left(-h^{2} \Delta-\mu\right) \chi_{2} v=h^{2} \chi_{1} g$. Applying $\tilde{Q}$ to this equation we obtain

Taking the $H_{s c}^{2+s}$ norm of $\chi v$ we obtain (11).

### 2.3 Estimate on $v$ in a neighborhood of the boundary

## Proof of Theorem 7.

Taking account the Lemma 2.1 and 2.2, to acheive the proof, we need an estimate on $v$ near the boundary $\partial \Omega$. It is well-known that we can find in a neighborhood $W$ of the boundary $\partial \Omega$ a system of coordinates such that the Laplacian can be written $\partial_{x_{n}}^{2}+R\left(x, \partial_{x^{\prime}}\right)+\alpha(x) \partial_{x_{n}}$, where $x^{\prime}$ are the coordinates on the manifold $\partial \Omega, x_{n} \in(0, \varepsilon), \Psi(W)=\partial \Omega \times(0, \varepsilon), \Psi$ is the change of coordinates and $R$ is a differential operator on $\partial \Omega$ of order 2 depending of the parameter $x_{n}$.

We keep the notation $u, v, a$ in the coordinates $x$ instead of $u \circ \Psi$, etc. The Equations (6) become

\left(D_{x_{n}}^{2}+R\left(x, D^{\prime}\right)+h \alpha D_{x_{n}}-\mu\right) v=h^{2} g \text { in } \partial D \times(0, \varepsilon) \\
u=\partial_{\nu} u=0 \text { on } \partial \Omega \times\{0\}
\end{array}\right.
$$

We have taken the semi-classical notations, $D_{x_{j}}=\frac{h}{i} \partial_{x_{j}}, D^{\prime}=\left(D_{x_{1}}, \cdots, D_{x_{n-1}}\right)$. Actually $R$ and $V$ may depend explicitly of $h$ but this introduces no problem in the estimates, if $V_{\mid h=0} \neq 0$, this is the case if $n=n_{1}+i n_{2} / k$, we have $V_{\mid h=0}(x)=\left(1-n_{1}\right) / n_{1} \neq 0$ by assumption.

Let $w \in L^{2}\left(x_{n}>0\right)$, we denote by

\underline{w}=1_{x_{n}>0} w=\left\{\begin{array}{l}
w \text { if } x_{n}>0  \tag{14}\\
0 \text { if } x_{n}<0
\end{array}\right.
$$

Usually we use $\underline{w}$ but some time it is more convenient to use $1_{x_{n}>0} w$. We have

& D_{x_{n}}^{2} \underline{w}=1_{x_{n}>0} D_{x_{n}}^{2} w+\frac{h}{i} D_{x_{n}} w_{\mid x_{n}=0} \otimes \delta_{x_{n}=0}+\frac{h}{i} w_{\mid x_{n}=0} \otimes D_{x_{n}} \delta_{x_{n}=0}
\end{aligned}
$$

Here and in the sequel, for simplicity we denote by $w_{\mid x_{n}=0}$ the limit, when $x_{n}$ goes to 0 with $x_{n}>0$, of $w\left(x^{\prime}, x_{n}\right)$, if the limit exists. Here the distributions $u$ and $v$ are solutions of elliptic equations then the limits exist in a space of distributions.

From (13), we obtain

\left(D_{x_{n}}^{2}+R\left(x, D^{\prime}\right)+h \alpha D_{x_{n}}-\mu\right) \underline{v}=h^{2} \underline{g}+\frac{h}{i} \gamma_{0} \otimes \delta_{x_{n}=0}+\frac{h}{i} \gamma_{1} \otimes D_{x_{n}} \delta_{x_{n}=0} \text { in } \partial \Omega \times(-\varepsilon, \varepsilon),
\end{array}\right.
$$

where $\gamma_{0}=D_{x_{n}} v_{\mid x_{n}=0}+\alpha h v_{\mid x_{n}=0}$ and $\gamma_{1}=v_{\mid x_{n}=0}$. We can consider these equations for $x_{n} \in(-\varepsilon, \varepsilon)$ indeed the coefficients of $R$ are smooth up the boundary, and we can extend $R$ in a neighborhood of the boundary for $x_{n}<0$. The functions $\underline{u}$ and $\underline{v}$ are null for $x_{n}<0$ so the equations are relevant only to take account the boundary terms. Remark, in the first equation because the traces of $u$ are null, they are not boundary terms.

The main goal of this section, is to obtain estimates on $\gamma_{0}$ and $\gamma_{1}$.
Now we search, using the equations (15), two relations between the traces of $v$. First we localize $v$ in a neighborhood of the boundary. We denote by $w=\chi_{0} v$ where $\chi_{0} \in \mathscr{C}^{\infty}(\mathbb{R}), \chi_{0}\left(x_{n}\right)=1$ in a neighborhood of boundary, for instance if $\left|x_{n}\right| \leq \varepsilon / 4$ and $\chi_{0}\left(x_{n}\right)=0$ if $\left|x_{n}\right| \geq \varepsilon / 2$. From the second equation of (15) we obtain

where $K$ is a first order differential operator coming from the commutator between $D_{x_{n}}^{2}$ or $D_{x_{n}}$ and $\chi_{0}$.

Let $\chi_{1} \in \mathscr{C}^{\infty}(\mathbb{R})$ such that $\chi_{1} \chi_{0}=\chi_{0}$ for instance $\chi_{1}\left(x_{n}\right)=1$ if $\left|x_{n}\right| \leq \varepsilon / 2$ and $\chi_{0}\left(x_{n}\right)=0$ if $\left|x_{n}\right| \geq 3 \varepsilon / 4$. By assumption we have $\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)-\mu \neq 0$ then by semi-classical pseudo-differential calculus there exists $\tilde{Q}$ of order -2 such that $\tilde{Q}\left(D_{x_{n}}^{2}+R\left(x, D^{\prime}\right)+h \alpha D_{x_{n}}-\mu\right)=\chi_{1}+h \tilde{K}$ where $\tilde{K}$ is of order $-N$ where $N \geq s+2$. Applying $\tilde{Q}$ to (16), we obtain

where $g_{1}=-h \tilde{K} \underline{w}+h^{2} \tilde{Q}\left(\chi_{0} \underline{g}\right)+h \tilde{Q} K \underline{v}$ thus

actually we can estimate $\tilde{K} \underline{w}$ because $\underline{w} \in L^{2}\left(\mathbb{R}^{n}\right)$ and $\tilde{K}$ is smoothing. By this trick we have not to verify that $\tilde{\tilde{Q}}$ is a mapping on the $\overline{\bar{H}}_{s}^{s} s c$. In appendix A, Estimate (56), we have proved that a parametrix as $\tilde{Q}$ is a mapping on the $\bar{H}_{s c}^{s}(\Omega)$.

By ellipticity assumption on $\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)-\mu$, there exist $\rho_{1}\left(x, \xi^{\prime}\right)$ and $\rho_{2}\left(x, \xi^{\prime}\right)$ with $\operatorname{Im} \rho_{1}>0$ and $\operatorname{Im} \rho_{2}<0$ such that $\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)-\mu=\left(\xi_{n}-\rho_{1}\left(x, \xi^{\prime}\right)\right)\left(\xi_{n}-\rho_{2}\left(x, \xi^{\prime}\right)\right)$ (see A.2).

From (59) and Lemma A. 1 we have

where we denote here and in the sequel by $r_{j}$ an operator of order $j$.
From Lemma A. 2 we obtain if we restrict (17) on $\left\{x_{n}=0\right\}$ and as $\underline{w}_{\mid x_{n}=0}=\gamma_{1}$,

Then applying $\operatorname{op}\left(\rho_{2}-\rho_{1}\right)$ on both sides of (21), using estimate (17) to estimate $g_{1}$, trace formula and by pseudo-differential calculus we obtain

& \text { and }\left|g_{2}\right|_{H_{s c}^{s+1 / 2}(\partial \Omega)} \lesssim h^{1 / 2}\|v\|_{\bar{H}_{s c}^{s+1}(\Omega)}+h^{3 / 2}\|g\|_{\bar{H}_{s c}^{s}(\Omega)}+h\left|\gamma_{0}\right|_{H_{s c}^{s-1 / 2}(\partial \Omega)}+h\left|\gamma_{1}\right|_{H_{s c}^{s+1 / 2}(\partial \Omega)} \tag{22}
\end{align*}

To obtain a second equation on the traces, we use the first equation of (15). As before there exist $Q$ of order $-2, K$ of order $-N-4, \chi_{2}$ such that $\chi_{2} \chi_{0}=\chi_{0}$ and such that $Q\left(a\left(D_{x_{n}}^{2}+R+h \alpha D_{x_{n}}\right)-\mu\right)=$ $\chi_{2}+h K$.

We apply $Q$ to the first equation of (15), we obtain

Using Lemma 2.2 we can estimate the term $\left(1-\chi_{0}\right) \underline{v}$, using the Lemma 2.1 we can estimate $\|u\|_{\bar{H}_{s c}^{s+2}(\Omega)}$ and we obtain,

As $a(x)\left(\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)\right)-\mu$ is elliptic, the polynomial in $\xi_{n}$ has two roots $\lambda_{j}$ one satisfies $\operatorname{Im} \lambda_{1}>0$ and the other $\operatorname{Im} \lambda_{2}<0$ (see section A.2). We have $a(x)\left(\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)\right)-\mu=a\left(\xi_{n}-\lambda_{1}\right)\left(\xi_{n}-\lambda_{2}\right)$. The principal symbol of $Q$ is $\frac{\chi_{2}}{a\left(\xi_{n}-\lambda_{1}\right)\left(\xi_{n}-\lambda_{2}\right)}$. The principal symbol of $Q V \tilde{Q}$ is $\frac{\left.1 \xi_{n}-\lambda_{1}\right)\left(\xi_{n}-\lambda_{2}\right)\left(\xi_{n}-\rho_{1}\right)\left(\xi_{n}-\rho_{2}\right)}{a\left(\xi_{n}\right)}$.

The estimate proved above are not enough on $v$ with respect $f$. For the sequel we need to estimate $v$ by $f$ in $H^{s}$ norm.

Proposition 2.3. We assume that for all $x \in \bar{\Omega}$, and all $\xi \in \mathbb{R}^{n}$, $a(x)|\xi|^{2}-\mu \neq 0$ and $|\xi|^{2}-\mu \neq 0$. There exist $h_{0}>0$ and $C>0$ and for all $\delta>0$, let $\chi_{\delta} \in \mathscr{C}^{\infty}$ supported in a $\delta$-neighborhood of $\partial \Omega$, there exists $C_{\delta}>0$ such that for $h \in\left(0, h_{0}\right), f \in \bar{H}_{s c}^{s}(\Omega), g=0, u \in \bar{H}_{s c}^{s+1}(\Omega) \cap H_{0}^{2}(\Omega), v \in \bar{H}_{s c}^{s}(\Omega)$ and $\Delta v \in L^{2}(\Omega)$, solutions of system (4) we have the estimate,

## 3 Existence and compactness

In this section we prove the Theorems 1 and 2.

### 3.1 Proof of Theorem 1

Proof. We follow the proof given by Sylvester [23, Proposition 10], we prove that le range of $B_{z}$ is closed and dense.

To prove the range is closed we apply the a priori estimates prove in section 2 . We recall that $a=1 /(1+m)$ and $V=m /(1+m)$.

We remark that if we have $C_{e} \neq \mathbb{C}$ then $C_{e} \cup(-\infty, 0] \neq \mathbb{C}$. Indeed, as $\bar{\Omega}$ is compact, $C_{e}$ is closed. If $C_{e} \cup(-\infty, 0]=\mathbb{C}$ then $C_{e} \backslash(-\infty, 0]=\mathbb{C} \backslash(-\infty, 0]$ as $\mathbb{C} \backslash(-\infty, 0]$ is dense in $\mathbb{C}$, we have $C_{e}=\mathbb{C}$. Let $z_{0}$ such that $z_{0} \notin C_{e} \cup(-\infty, 0]$, we can choose $\left|z_{0}\right|=1$, let $z=h^{-2} z_{0}$ we have $\mu=-z_{0}$. First we can estimate $\|v\|_{L^{2}(\Omega)}$ by Proposition 2.3 with $s=0$ and $\delta$ fixed if $g=0$ and by Theorem 7 if $f=0$. There exists $C>0$ such that for all $|z|$ large enough,

Clearly these estimates prove that the range of $B_{z}$ is closed where the norm on the domain of the operator is given by the $H^{2}$ norm for $u$ and by $\|v\|+\|\Delta v\|$ for $v$.

To prove the density of the range of $B_{z}$ we prove that the orthogonal of the range is $\{0\}$. We recall the Green formula, if $v$ and $q$ are smooth functions in $\bar{\Omega}$ we have

\begin{equation*}
(v \mid \Delta q)-(\Delta v \mid q)=\left(v \mid \partial_{\nu} q\right)_{0}-\left(\partial_{\nu} v \mid q\right)_{0} \tag{37}
\end{equation*}
$$

where $(\cdot \mid \cdot)$ is the inner product in $\Omega,(\cdot \mid \cdot)_{0}$ is the inner product on $\partial \Omega$ and $\partial_{\nu}$ is the exterior normal derivative on $\partial \Omega$. Actually (37) is true if $v$ smooth, $q \in L^{2}(\Omega)$ and $\Delta q \in L^{2}(\Omega)$. Indeed, in this case it is well known that $q_{\mid \partial \Omega} \in H^{-1 / 2}(\partial \Omega)$ and $\partial_{\nu} q_{\mid \partial \Omega} \in H^{-3 / 2}(\partial \Omega)$ then we can find $f_{n}$ and $g_{n}$ smooth functions such that $f_{n}$ goes to $\Delta q$ in $L^{2}(\Omega)$ and $g_{n}$ goes to $q_{\mid \partial \Omega}$. Let $q_{n}$ the solution of $\Delta q_{n}=f_{n}$ in $\Omega$ and $\left(q_{n}\right)_{\mid \partial \Omega}=g_{n}, q_{n}$ is a smooth function and by continuity $\left(\partial_{\nu} q_{n}\right)_{\mid \partial \Omega}$ goes to $\partial_{\nu} q_{\partial \Omega}$ in $H^{-3 / 2}(\partial \Omega)$. Then we can pass to the limit in (37).

Let $p, q \in L^{2}(\Omega)$ and $u, v$ smooth functions in $\Omega$, if $(p, q)$ is in the orthogonal of the range we have

$$
\begin{equation*}
(\Delta u-z(1+m) u+m v \mid p)+(\Delta v-z v \mid q)=0 . \tag{38}
\end{equation*}
$$

We take $u, v \in \mathscr{C}_{0}^{\infty}(\Omega)$ in (38), by integrating by part in distribution sense we have

$$
\begin{array}{r}
\Delta p-\bar{z}(1+\bar{m}) p=0 \text { in } \Omega \\
\Delta q-\bar{z} q+\bar{m} p=0 \text { in } \Omega . \tag{40}
\end{array}
$$

In particular $\Delta p$ and $\Delta q$ are in $L^{2}(\Omega)$, then we can apply (37) to integrate by part in (38) if now $u, v$ are smooth functions up the boundary with $u_{\mid \partial \Omega}=\partial_{\nu} u_{\mid \partial \Omega}=0$. Using (39) and (40) we have

$$
\left(v \mid \partial_{\nu} q\right)_{0}-\left(\partial_{\nu} v \mid q\right)_{0}=0
$$

As $v_{\mid \partial \Omega}$ and $\partial_{\nu} v_{\mid \partial \Omega}$ are arbitrary, we obtain $q_{\mid \partial \Omega}=\partial_{\nu} q_{\mid \partial \Omega}=0$. By (40), $q$ satisfies a Dirichlet boundary value problem and $\partial_{\nu} q_{\mid \partial \Omega}=0$, then $q \in \bar{H}_{0}^{2}(\Omega)$. By (39), $\Delta p \in L^{2}(\Omega)$ and $p \in L^{2}(\Omega)$. We deduce that $(q, p) \in H_{0}^{2}(\Omega) \oplus\left\{v \in L^{2}(\Omega), \Delta v \in L^{2}(\Omega\}\right.$ satisfies the same kind of equation as $(u, v)$. Then the inequalities (35) and (36) prove that $p=q=0$. This acheives the proof of Theorem 1.

### 3.2 Proof of Theorem 2

Proof. We take the same $z$ as in the proof of Theorem 1. We can apply Theorem 7 with $s=0$, we obtain in classical norm

\begin{align*}
& |z|^{2}\|u\|_{L^{2}(\Omega)}+|z|\|u\|_{\bar{H}^{1}(\Omega)}+\|u\|_{\bar{H}^{2}(\Omega)}+\frac{1}{|z|}\|u\|_{\bar{H}^{3}(\Omega)}+\frac{1}{|z|^{2}}\|u\|_{\bar{H}^{4}(\Omega)} \leq C\|f\|_{\bar{H}^{2}(\Omega)}+\frac{C}{|z|^{2}}\|g\|_{L^{2}(\Omega)}, \\
& \|v\|_{L^{2}(\Omega)}+\frac{C}{|z|}\|v\|_{\bar{H}^{1}(\Omega)}+\frac{1}{|z|^{2}}\|v\|_{\bar{H}^{2}(\Omega)} \leq C\|f\|_{\bar{H}^{2}(\Omega)}+\frac{C}{|z|^{2}}\|g\|_{L^{2}(\Omega)} . \tag{41}
\end{align*}
$$

This proves that $R_{z}: \bar{H}^{2}(\Omega) \oplus L^{2}(\Omega) \rightarrow \bar{H}^{4}(\Omega) \oplus \bar{H}^{2}(\Omega)$, then $R_{z}$ is compact from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself. We can apply the Riesz theory.

## 4 Spectral results

Here we prove how the regularity results obtained in the section 2 allow to prove the spectral results. Actually the result obtained in Theorem 2 is not enough to prove that the spectrum is a countable set. The theory given in Agmon [1] is based on the spectral decomposition of Hilbert-Schmidt operators. We adapt two results given in Agmon to our case, the Lemma 4.1 and the Proposition 4.2. Following these results we will prove the Theorems 3 and 4.

Let $T$ an Hilbert-Schmidt operator from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself. We denote by $\||T|\|$ the HilbertSchmidt norm. Let $\left(\phi_{j}\right)_{j \in \mathbb{N}}$ a Hilbert basis on $\bar{H}^{2}(\Omega)$ and $\left(\psi_{k}\right)_{k \in \mathbb{N}}$ a Hilbert basis on $L^{2}(\Omega)$, then $\left(\left(\phi_{j}, 0\right)\right)_{j \in \mathbb{N}},\left(\left(0, \psi_{k}\right)\right)_{k \in \mathbb{N}}$ is a Hilbert basis on $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$. Let $T\left(\phi_{j}, 0\right)=u_{j}=\left(u_{j}^{0}, u_{j}^{1}\right)$ and $T\left(0, \psi_{k}\right)=v_{k}=\left(v_{k}^{0}, v_{k}^{1}\right)$. With these notations, we have $\|T\| \|^{2}=\sum_{j=0}^{\infty}\left(\left\|u_{j}^{0}\right\|_{\bar{H}^{2}(\Omega)}^{2}+\left\|v_{j}^{0}\right\|_{H^{2}(\Omega)}^{2}+\right.$ $\left.\left\|u_{j}^{1}\right\|_{L^{2}(\Omega)}^{2}+\left\|v_{j}^{1}\right\|_{L^{2}(\Omega)}^{2}\right)$.

We denote by $\|T\|_{j}$ the operator norm from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega) \rightarrow \bar{H}^{j+2}(\Omega) \oplus \bar{H}^{j}(\Omega)$, where $\bar{H}^{0}(\Omega)=$ $L^{2}(\Omega)$.

Lemma 4.1. Let $m>n / 2$, there exists $C>0$ such that if $T$ is a bounded operator from $\bar{H}^{2}(\Omega) \oplus$ $L^{2}(\Omega) \rightarrow \bar{H}^{m+2}(\Omega) \oplus \bar{H}^{m}(\Omega)$, then $T$ is a Hilbert-Schmidt operator and

$$
\|T\| \leq \leq\|T\|_{m}^{n /(2 m)}\|T\|_{0}^{1-n /(2 m)}
$$

Proof. We follow the proof given by Agmon [1, Theorem 13.5].
Let $u=T\left(\sum_{j=0}^{N} a_{j}\left(\phi_{j}, 0\right)\right)+T\left(\sum_{j=0}^{N} b_{j}\left(0, \psi_{j}\right)\right)=\sum_{j=0}^{N} a_{j} u_{j}+\sum_{j=0}^{N} b_{j} v_{j}=\left(u^{0}, u^{1}\right)$. We have $u_{j}=\left(u_{j}^{0}, u_{j}^{1}\right)$ and $v_{j}=\left(v_{j}^{0}, v_{j}^{1}\right)$. We treat the term $u^{0}$.

If $m>n / 2, \bar{H}^{m}(\Omega) \subset L^{\infty}(\Omega)$ and (see [1, Lemma 13.2]), for $\alpha \in \mathbb{N}^{n},|\alpha| \leq 2$, there exists $C>0$ such that

$$
\left\|\partial^{\alpha} v\right\|_{L^{\infty}(\Omega)} \leq C\|v\|_{\bar{H}^{m+|\alpha|}(\Omega)}^{n /(2 m)}\|v\|_{\bar{H}^{\alpha \alpha \mid}(\Omega)}^{1-n /(2 m)}
$$

By the property on $T$, we have

$$
\left\|u^{0}\right\|_{\bar{H}^{m+2}(\Omega)}^{2} \leq C\|T\|_{m}^{2} \sum_{j=0}^{N}\left(\left|a_{j}\right|^{2}+\left|b_{j}\right|^{2}\right) \text { and }\left\|u^{0}\right\|_{\bar{H}^{2}(\Omega)}^{2} \leq C\|T\|_{0}^{2} \sum_{j=0}^{N}\left(\left|a_{j}\right|^{2}+\left|b_{j}\right|^{2}\right)
$$

Let $K=\|T\|_{m}^{n /(2 m)}\|T\|_{0}^{1-n /(2 m)}$ thus we have for $x \in \Omega$, and for $\alpha \in \mathbb{N}^{n},|\alpha| \leq 2,\left|\partial^{\alpha} u^{0}(x)\right|^{2} \leq$ $C K^{2} \sum_{j=0}^{N}\left(\left|a_{j}\right|^{2}+\left|b_{j}\right|^{2}\right)$. We have $\partial^{\alpha} u^{0}(x)=\sum_{j=0}^{N}\left(a_{j} \partial^{\alpha} u_{j}^{0}(x)+b_{j} \partial^{\alpha} v_{j}^{0}(x)\right)$, we take in the previous inequality $a_{j}=\partial^{\alpha} \bar{u}_{j}^{0}(x)$ and $b_{j}=\partial^{\alpha} \bar{v}_{j}^{0}(x)$, we sum on $\alpha$, we obtain for all $x \in \bar{\Omega}$,

$$
\sum_{|\alpha| \leq 2}\left(\sum_{j=0}^{N}\left(\left|\partial^{\alpha} u_{j}^{0}(x)\right|^{2}+\left|\partial^{\alpha} v_{j}^{0}(x)\right|^{2}\right)\right)^{2} \leq C K^{2} \sum_{|\alpha| \leq 2} \sum_{j=0}^{N}\left(\left|\partial^{\alpha} u_{j}^{0}(x)\right|^{2}+\left|\partial^{\alpha} v_{j}^{0}(x)\right|^{2}\right)
$$

Thus $\left.\sum_{|\alpha| \leq 2}\left(\left|\partial^{\alpha} u_{j}^{0}(x)\right|^{2}+\left|\partial^{\alpha} v_{j}^{0}(x)\right|^{2}\right)\right) \leq C K^{2}$, integrating this on $\Omega$ (which is bounded) we find $\sum_{j=0}^{N}\left(\left\|u_{j}^{0}\right\|_{H^{2}(\Omega)}^{2}+\left\|v_{j}^{0}\right\|_{H^{2}(\Omega)}^{2}\right) \leq C K^{2}$. As the right hand side does not depend on $N$ we can let $N$ goes to infinity. We can treat by the same method the terms $\sum_{j=0}^{N}\left(\left\|u_{j}^{1}\right\|_{L^{2}(\Omega)}^{2}+\left\|v_{j}^{1}\right\|_{L^{2}(\Omega)}^{2}\right)$, it suffices to repeat the previous proof without the derivative terms. This means that $\||T|\|$ is bounded by $C K=C\|T\|_{m}^{n /(2 m)}\|T\|_{0}^{1-n /(2 m)}$.

We give here a small improvement of the Theorem 16.4 in [1].
We introduce some notations. The inner product in $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ will be denoted by $(\cdot \mid \cdot)$. Let $T$ an operator from $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ to itself, if $\lambda^{-1}$ is in the resolvent set of $T$, we set $T_{\lambda}=T(I-\lambda T)^{-1}$. We remark that if $T$ is the resolvent of $P$, that is $P T=I$, then $T_{\lambda}$ is the resolvent of $P-\lambda I$. Indeed,

$$
(P-\lambda I) T_{\lambda}=(P-\lambda I) T(I-\lambda T)^{-1}=(I-\lambda T)^{-1}-\lambda T(I-\lambda T)^{-1}=(I-\lambda T)^{-1}(I-\lambda T)=I
$$

Proposition 4.2. Let $T$ a Hilbert-Schmidt operator on $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$. We assume that there exists $0 \leq \theta_{1}<\theta_{2}<\cdots<\theta_{N}<2 \pi$ such that $\theta_{k}-\theta_{k-1}<\pi / 2$ for $k=2, \cdots, N$ and $2 \pi-\theta_{N}+\theta_{1}<\pi / 2$ satisfying there exist $r_{0}>0, C>0$ such that $\sup _{r \geq r_{0}}\left\|T_{r e^{i \theta_{k}}}\right\|_{0} \leq C$, for $k=1, \cdots, N$. Moreover we assume there exists $\left(\lambda_{j}\right)$ such that $\left|\lambda_{j}\right| \rightarrow+\infty$ and for all $f$ and $g$ in $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega),\left(T_{\lambda_{j}} f \mid g\right) \rightarrow 0$. Then the space spanned by the non zero generalized eigenfunctions of $T$ is dense in the adherence of the range of $T$.

Proof. As in Agmon [1, page 284] we define $F(\lambda)=\left(T_{\lambda} f \mid g\right)$ where $g$ is orthogonal to the generalized eigenfunctions. The goal is to prove that $F(0)=0$. As in Agmon we can prove that $F(\lambda)$ is analytic in $\mathbb{C}$ and bounded. Then $F(\lambda)$ is constant by Liouville theorem and as $\left(T_{\lambda_{j}} f \mid g\right) \rightarrow 0$ this implies that $F(\lambda)=0$.

## Proof of Theorem 3.

Before the proof we give some results on the links between the spectral decomposition of $S$ and $S^{p}$, where $S$ is an bounded operator on $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$.

Let $\omega_{j}$ for $j=1, \cdots, p$, the roots of $z^{p}=1$. We have $z^{p}-1=\prod_{j=1}^{p}\left(z-\omega_{j}\right)$, in particular for $z=0$ we have $-1=\prod_{j=1}^{p}\left(-\omega_{j}\right)$. Thus we have

$$
\begin{equation*}
z^{p}-1=\prod_{j=1}^{p}\left(z-\omega_{j}\right)=\prod_{j=1}^{p}\left(-\omega_{j}\right) \prod_{j=1}^{p}\left(1-\omega_{j}^{-1} z\right)=-\prod_{j=1}^{p}\left(1-\omega_{j} z\right) \tag{42}
\end{equation*}
$$

as we have $\left\{\omega_{j}, j=1, \cdots, p\right\}=\left\{\omega_{j}^{-1}, j=1, \cdots, p\right\}$.
Applying (42) to $z S$, we obtain

$$
\begin{equation*}
\left(1-z^{p} S^{p}\right)=\prod_{j=1}^{p}\left(1-\omega_{j} z S\right) \tag{43}
\end{equation*}
$$

If $\left(I-\omega_{j} z S\right)$ is invertible for all $j$, this implies that $\left(I-z^{p} S^{p}\right)$ is invertible. If for a fixed $j,\left(I-\omega_{j} z S\right)$ is not invertible, either $\operatorname{ker}\left(I-\omega_{j} z S\right) \neq\{0\}$ this implies $\operatorname{ker}\left(I-z^{p} S^{p}\right) \neq\{0\}$ or the range is not $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ this implies that the range of $\left(I-z^{p} S^{p}\right)$ is not $\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$. We deduce that

$$
I-\omega_{j} z S \text { is invertible for all } j \Leftrightarrow I-z^{p} S^{p} \text { is invertible. }
$$

If $S^{p}$ is compact and $I-z^{p} S^{p}$ is not invertible then by the Riesz theorem $z^{-p}$ is an eigenvalue of $S^{p}$ and there exists $k$ such that $\operatorname{ker}\left(I-z^{p} S^{p}\right)^{k-1} \neq \operatorname{ker}\left(I-z^{p} S^{p}\right)^{k}=\operatorname{ker}\left(I-z^{p} S^{p}\right)^{k+1}$ and the dimension of $\operatorname{ker}\left(I-z^{p} S^{p}\right)^{k}$ is finite.

We will prove that all the eigenvalues of $S$ have the form $\omega_{j} z^{-1}$. Indeed $S$ is a operator on $\operatorname{ker}\left(I-z^{p} S^{p}\right)^{k}$, then $S$ admits a spectral decomposition on $\operatorname{ker}\left(I-z^{p} S^{p}\right)^{k}$. Let $u \neq 0$ and $\lambda$ such that $u=\lambda S u$ then $z^{p} u=(\lambda z S)^{p} u$ thus $\lambda^{k p}\left(I-z^{p} S^{p}\right)^{k} u=\left(\lambda^{p}-z^{p}\right)^{k} u$ and $\lambda^{p}=z^{p}$ this implies $\lambda=\omega_{j} z$.

Now we prove that $\operatorname{ker}\left(I-\omega_{j} z S\right)^{k}=\operatorname{ker}\left(I-\omega_{j} z S\right)^{k+1}$. From (43), we have

$$
u \in \operatorname{ker}\left(I-\omega_{j} z S\right)^{k+1} \subset \operatorname{ker}\left(I-z^{p} S^{p}\right)^{k+1}=\operatorname{ker}\left(I-z^{p} S^{p}\right)^{k}
$$

We have

$$
\begin{aligned}
\left(I-z^{p} S^{p}\right)^{k} & =\left(I-\left(I-\left(I-z \omega_{j} S\right)\right)^{p}\right)^{k}=\left(p\left(I-z \omega_{j} S\right)+\sum_{\mu=2}^{p} C_{\mu}\left(I-z \omega_{j} S\right)^{\mu}\right)^{k} \\
& =p^{k}\left(I-z \omega_{j} S\right)^{k}\left(I+\sum_{\mu=1}^{p-1} C_{\mu}^{\prime}\left(I-z \omega_{j} S\right)^{\mu}\right)^{k}
\end{aligned}
$$

this implies $\left(I-z^{p} S^{p}\right)^{k} u=p^{k}\left(I-z \omega_{j} S\right)^{k} u=0$, which is the claim.
Obviously we can find the spectral decomposition of $S^{p}$ from the one of $S$. This proves that there exists $j$ such that $\operatorname{ker}\left(I-\omega_{j} z S\right)^{k-1} \neq \operatorname{ker}\left(I-\omega_{j} z S\right)^{k}=\operatorname{ker}\left(I-\omega_{j} z S\right)^{k+1}$.

To prove the Theorem 3, we fix $z$ as in the proof of Theorem 1, we denote by $S=R_{z}$ and we apply Proposition 4.2 to $T=S^{p}=R_{z}^{p}$, By Theorem 7 and Lemma 4.1, $T: \bar{H}^{2}(\Omega) \oplus L^{2}(\Omega) \rightarrow$ $H^{2+2 p}(\Omega) \oplus H^{2 p}(\Omega)$ then $T$ is an Hilbert-Schmidt operator as $p>n / 4$. We remark that

$$
\begin{equation*}
S_{\lambda}=\left(R_{z}\right)_{\lambda}=R_{z}\left(I-\lambda R_{z}\right)^{-1}=\left(R_{z}^{-1}-\lambda\right)^{-1}=\left(B_{z}-\lambda\right)^{-1}=\left(B_{0}-z-\lambda\right)^{-1}=R_{z+\lambda} \tag{44}
\end{equation*}
$$

As $C_{e}$ is a closed cone, if $r e^{i \theta}$ is not in $C_{e}$ for all $r$ large enough, then $z+r e^{i \theta}$ is not in $C_{e}$ for all $r$ large enough (see (3) for the notation $C_{e}$ ).

Using the previous remark and the estimate (41) we have that $\left\|S_{r e^{i \theta}}\right\|=\left\|R_{z+r e^{i \theta}}\right\|_{0}$ is bounded uniformly with respect $r$ large enough, if $\theta \neq 0$ and $r e^{i \theta} \notin C_{e}$.

We prove the following formula

$$
\begin{equation*}
p z^{p-1} T_{z^{p}}=\sum_{k=1}^{p} \omega_{k} S_{\omega_{k} z} \tag{45}
\end{equation*}
$$

Indeed we take the inverse of (43) when the formula make sense, we have

$$
\begin{equation*}
\left(1-z^{p} S^{p}\right)^{-1}=\prod_{j=1}^{p}\left(1-\omega_{j} z S\right)^{-1} \tag{46}
\end{equation*}
$$

Derivate (42) with respect $z$, we obtain

$$
p z^{p-1}=\sum_{k=1}^{p} \omega_{k} \prod_{j=1, j \neq k}^{p}\left(1-\omega_{j} z\right) .
$$

We apply this formula to $z S$, we obtain

$$
\begin{equation*}
p z^{p-1} S^{p-1}=\sum_{k=1}^{p} \omega_{k} \prod_{j=1, j \neq k}^{p}\left(1-\omega_{j} z S\right) . \tag{47}
\end{equation*}
$$

We multiply term by term (47) and (46), multiplying the result by $S$, we obtain (45).
If $S_{\omega_{k} z}$ is bounded uniformly for $r$ large enough and for all $k$, by (45) we have $\left\|T_{z^{p}}\right\|_{0} \leq \frac{C}{|z|^{p-1}}$. If we assume that $C_{e}$ is contained in a sector less than $\theta$ with $\theta<\pi / 2$ and $\theta<2 \pi / p$, the union of $C_{e}$ and $C_{e}$ rotated by angle $2 k \pi / p$ does not give $\mathbb{C}$ and the Formula (45) proves that we can find the $\theta_{j}$ 's satisfying the assumption of Proposition 4.2. If $p \geq 2$ the estimate on $\left\|T_{z^{p}}\right\|_{0}$ is stronger than the weak convergence. In case $p=1$, we have by the Theorem 7 and Proposition 2.3 with the notation $f=\left(f_{1}, f_{2}\right)$,

$$
\left\|R_{z} f\right\|_{\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)} \leq C\left\|\chi_{\delta} f_{1}\right\|_{L^{2}(\Omega)}+C_{\delta}|z|^{-1}\left\|f_{1}\right\|_{\bar{H}^{2}(\Omega)}+C|z|^{-2}\left\|f_{2}\right\|_{L^{2}(\Omega)},
$$

if $|z|$ is large enough and $z \notin C_{e}$. For $f_{1}$ and $\varepsilon>0$ fixed we can choose $\delta>0$ such that $C\left\|\chi_{\delta} f_{1}\right\|_{L^{2}(\Omega)} \leq \varepsilon$. Then it is easy to prove that if $z_{j}$ is on a line such that $z_{j}=r_{j} e^{i \theta}$ with $r_{j} \rightarrow+\infty$, we have limsup $\left\|R_{z_{j}} f\right\|_{\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)} \leq \varepsilon$. This prove that $\left\|R_{z_{j}} f\right\|_{\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)} \rightarrow 0$ thus $\left\|S_{z_{j}-z} f\right\|_{\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)} \rightarrow 0$.

Now we prove that the adherence of $R_{z}\left(\bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)\right)$ is $H_{0}^{2}(\Omega) \oplus\left\{v \in L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$. Let $(u, v) \in H_{0}^{2}(\Omega) \oplus\left\{v \in L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$ we have $B_{z}(u, v)=(f, g) \in L^{2}(\Omega) \oplus L^{2}(\Omega)$. Let $\left(f_{n}, g_{n}\right) \in \bar{H}^{2}(\Omega) \oplus L^{2}(\Omega)$ such that $\left(f_{n}, g_{n}\right) \rightarrow(f, g)$ in $L^{2}(\Omega) \oplus L^{2}(\Omega)$. We can take for instance $f_{n}$ and $g_{n}$ in $\mathscr{C}_{0}^{\infty}(\Omega)$. We have by continuity $R_{z}\left(f_{n}, g_{n}\right) \rightarrow R_{z}(f, g)=(u, v)$ in $H_{0}^{2}(\Omega) \oplus\{v \in$ $\left.L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$ with the norm defined by $\|v\|_{L^{2}(\Omega)}+\|\Delta v\|_{L^{2}(\Omega)}$ on $\left\{v \in L^{2}(\Omega), \Delta v \in L^{2}(\Omega)\right\}$ and the usual norm on $H_{0}^{2}(\Omega)$.

Proof of Theorem 4. Using (44) as $z$ is fixed, to estimate the number of eigenvalues less than $t^{2}$ is equivalent to estimate the number of eigenvalues $\lambda$ such that $z+\lambda$ is less than $t^{2}$. That is in the sequel we estimate the number of $\lambda$ less than $t^{2}$ such that $\lambda^{-1}$ is a eigenvalue of $S=R_{z}$.

We have shown in the proof of Theorem 3 that $\left\|T_{z^{p}}\right\|_{0} \leq \frac{C}{|z|^{p-1}}$ if $\omega_{k} z$ is on a line $d\left(r_{0}, \theta\right)=\{z \in$ $\left.\mathbb{C}, z=r e^{i \theta}, r \geq r_{0}\right\} \subset C_{e}$. As $\left(1-z^{p} T\right)^{-1}=1+z^{p} T_{z^{p}}$, we obtain for $|z| \geq 1,\left\|\left(1-z^{p} T\right)^{-1}\right\|_{0} \leq$ $1+|z|^{p}\left\|T_{z^{p}}\right\|_{0} \leq C|z|$.

We have, by $\left\|T_{z^{p}}\right\|_{2 p} \leq\|T\|_{2 p}\left\|\left(1-z^{p} T\right)^{-1}\right\|_{0} \leq C|z|$. We obtain from Lemma 4.1

\left\|\left|\left\|T_{z^{p}}\right\|\right| \leq C\right\| T_{z^{p}}\left\|_{2 p}^{n /(4 p)}\right\| T_{z^{p}} \|_{0}^{1-n /(4 p)} \leq C|z|^{1-p+n / 4}
$$

We remind [1, Theorem 12.14] if $T$ is Hilbert-Schmidt, we have $\sum\left|\mu_{i}\right|^{2} \leq\left\|\left||T| \|^{2}\right.\right.$ where $\mu_{j} \neq 0$ are the eigenvalues counted with multiplicities.

Let $\lambda_{j}$ such that $\lambda_{j}^{-1}$ is a eigenvalue of $S$, we find that $\frac{1}{\lambda_{j}^{p}-z^{p}}$ is a eigenvalue of $T_{z^{p}}$. We obtain

\sum_{j} \frac{1}{\left|\lambda_{j}^{p}-z^{p}\right|^{2}} \leq\left\|\left.\left|\left|T_{z^{p}}\right| \|^{2} \leq C\right| z\right|^{2-2 p+n / 2}\right.
$$

If $\left|\lambda_{j}\right| \leq t^{2}$ and taking $z \in d\left(r_{0}, \theta\right)$ satisfying $|z|=t^{2}$, we have $\left|\lambda_{j}^{p}-z^{p}\right| \leq 2 t^{2 p}$. Then we have

$$
\sum_{\left|\lambda_{j}\right| \leq t^{2}} \frac{1}{4 t^{4 p}} \leq \sum_{j} \frac{1}{\left|\lambda_{j}^{p}-z^{p}\right|^{2}} \leq\left\|\mid T_{z^{p}}\right\| \|^{2} \leq C t^{4-4 p+n}
$$

Then we obtain that $N(t) \leq C t^{4+n}$.

## 5 Estimate on the resolvent

### 5.1 Upper bound

In this section we prove the Theorem 5. We recall the well-known Green's formula. For regular functions $u$ and $v$, we have

\int_{\Omega}(u \Delta v-v \Delta u) d x=\int_{\partial \Omega}\left(u \partial_{\nu} v-v \partial_{\nu} u\right) d s
$$

where $\partial_{\nu}$ is the exterior normal derivative on $\partial \Omega$ and $d s$ is the surface measure on $\partial \Omega$. Here we work with smooth functions. As the problem is well-posed by Theorem 1 we can apply the estimate for non smooth functions by passing to the limit in the estimate.

$$
\left\{\begin{array}{l}
\Delta w+k^{2} n(x) w=f \text { in } \Omega  \tag{48}\\
\Delta v+k^{2} v=g \text { in } \Omega \\
w=v \text { on } \partial \Omega \\
\partial_{\nu} w=\partial_{\nu} v \text { on } \partial \Omega
\end{array}\right.
$$

By Green's formula and (48) we have

$$
\begin{aligned}
\int_{\Omega}(w \Delta \bar{w}-\bar{w} \Delta w) d x & =\int_{\partial_{\Omega}}\left(w \partial_{\nu} \bar{w}-\bar{w} \partial_{\nu} w\right) d s \\
& =\int_{\Omega}\left[w\left(\bar{f}-k^{2} \bar{n} \bar{w}\right)-\bar{w}\left(f-k^{2} n w\right)\right] d x \\
& =\int_{\Omega}\left[w \bar{f}-\bar{w} f-2 i k^{2} \operatorname{Im} n|w|^{2}\right] d x
\end{aligned}
$$

and

$$
\begin{aligned}
\int_{\Omega}(v \Delta \bar{v}-\bar{v} \Delta v) d x & =\int_{\partial_{\Omega}}\left(v \partial_{\nu} \bar{v}-\bar{v} \partial_{\nu} v\right) d s \\
& =\int_{\Omega}\left[v\left(\bar{g}-k^{2} \bar{v}\right)-\bar{v}\left(g-k^{2} v\right)\right] d x \\
& =\int_{\Omega}[v \bar{g}-\bar{v} g] d x
\end{aligned}
$$

Using the boundary condition in (48), we obtain,

$$
\int_{\Omega}(w \bar{f}-\bar{w} f) d x-\int_{\Omega}(v \bar{g}-\bar{v} g) d x=2 i \int_{\Omega} k^{2}|w|^{2} \operatorname{Im} n d x .
$$

Thus we deduce,

\begin{equation*}
\delta \int_{\omega} k^{2}|w|^{2} \leq\|v\|\|g\|+\|w\|\|f\| \tag{49}
\end{equation*}
$$

where $\omega=\{x \in \Omega, \operatorname{Im} n(x) \geq \delta\}$.
Remark 9. In the case where $n=n_{1}+i n_{2} / k$ we have $\operatorname{Im} n=n_{2} / k$, and in the previous computations we must change the left hand side of (49) by $\delta \int_{\omega} k|w|^{2}$ where $\omega=\left\{x \in \Omega, n_{2}(x) \geq \delta\right\}$. We let to the reader to check that the rest of the proof does not change with this new estimate. Indeed the powers of $k$ do not play any role with respect the estimates by $e^{C k}$.

We recall the interpolation estimate. We can find this type of estimate in $[20$, Section 3, Formulas (1) and (2)], [21, Theorem 3], [10, Proposition 1.2]. The estimate (50) does not appear in this literature, but we can prove it following the same ways. Indeed in the Carleman estimate used
to prove the interpolation estimates, we estimates also the boundary terms but in the previous mentioned paper we did not need the boundary term in the interpolation estimates.

Let $X=(-3,3) \times \Omega, Y=(-2,2) \times \Omega$, and $\mathcal{O}=(-1,1) \times \omega$. We denote by $\partial Y=(-2,2) \times \partial \Omega$. Then there exist $\delta>0$ and $C>0$ such that for all $W \in \bar{H}^{1}(X)$ such that $\partial_{s}^{2} W+\Delta W \in L^{2}(X)$, $W_{\mid \partial Y} \in H^{1}(\partial Y), \partial_{\nu} W_{\mid \partial Y} \in L^{2}(\partial Y)$, we have

$$
\begin{align*}
& \|W\|_{\bar{H}^{1}(Y)}+\left|W_{\mid \partial Y}\right|_{H^{1}(\partial Y)}+\left|\partial_{\nu} W_{\mid \partial Y}\right|_{L^{2}(\partial Y)} \leq C\left(\left\|\partial_{s}^{2} W+\Delta W\right\|_{L^{2}(X)}+\|W\|_{L^{2}(\mathcal{O})}\right)^{\delta}\|W\|_{\bar{H}^{1}(X)}^{1-\delta}  \tag{50}\\
& \|W\|_{\bar{H}^{1}(Y)} \leq C\left(\left\|\partial_{s}^{2} W+\Delta W\right\|_{L^{2}(X)}+\left|W_{\mid \partial Y}\right|_{H^{1}(\partial Y)}+\left|\partial_{\nu} W_{\mid \partial Y}\right|_{L^{2}(\partial Y)}\right)^{\delta}\|W\|_{\bar{H}^{1}(X)}^{1-\delta} \tag{51}
\end{align*}
$$

where $s$ is an additional variable. This variable allows us to give an estimate uniform with respect the large parameter $k$. We shall see that in the sequel.

Let $W(s, x)=e^{s k} w(x)$ where $\Delta w+k^{2} w=f$ in $\Omega$. We have $\partial_{s}^{2} W+\Delta W=e^{s k} f$ and we can obtain the following estimates for a $C>0$,

& \|w\|_{\bar{H}^{1}(\Omega)} \leq C\|W\|_{\bar{H}^{1}(Y)} \\
& \left|w_{\mid \partial \Omega}\right|_{H^{1}(\partial \Omega)} \leq C\left|W_{\mid \partial Y}\right|_{\bar{H}^{1}(\partial Y)} \\
& \left|\partial_{\nu} w_{\mid \partial \Omega}\right|_{L^{2}(\partial \Omega)} \leq C\left|\partial_{\nu} W_{\mid \partial Y}\right|_{L^{2}(\partial Y)} \\
& \left\|\partial_{s}^{2} W+\Delta W\right\|_{L^{2}(X)} \leq C e^{3 k}\|f\|_{L^{2}(\Omega)} \\
& \|W\|_{L^{2}(\mathcal{O})} \leq C e^{k}\|w\|_{L^{2}(\omega)} \\
& \|W\|_{\bar{H}^{1}(X)} \leq C e^{4 k}\|w\|_{\bar{H}^{1}(\Omega)}
\end{aligned}
$$

By the interpolation estimate (50), there exists $C>0$ such that for all $w \in \bar{H}^{1}(\Omega)$, satisfying $\partial_{\nu} w_{\mid \partial \Omega} \in L^{2}(\partial \Omega)$ and $w_{\mid \partial \Omega} \in H^{1}(\partial \Omega)$ solution of $\Delta w+k^{2} w=f$ in $\Omega$, we have

$$
\begin{equation*}
\left|\left(\partial_{\nu} w\right)_{\mid \partial \Omega}\right|_{L^{2}(\partial \Omega)}+\left|w_{\mid \partial \Omega}\right|_{H^{1}(\partial \Omega)}+\|w\|_{\bar{H}^{1}(\Omega)} \leq C e^{C k}\left(\|w\|_{L^{2}(\omega)}+\|f\|\right) \tag{52}
\end{equation*}
$$

Using (49), (52) and $C e^{C k}\|w\|\|f\| \leq(1 / 2)\|w\|^{2}+C^{2} e^{2 C k}\|f\|^{2}$, we have for a $C>0$

$$
\begin{equation*}
\|w\|_{\bar{H}^{1}(\Omega)}^{2} \leq C e^{C k}\left(\|f\|^{2}+\|v\|\|g\|\right) \tag{53}
\end{equation*}
$$

Following the same way, we denote by $W(s, x)=e^{s k} v(x)$ and we apply the interpolation estimate (51), we obtain on $v$ the estimate

$$
\|v\|_{\bar{H}^{1}(\Omega)} \leq C e^{C k}\left(\|g\|+\left|v_{\mid \partial \Omega}\right|_{H^{1}(\partial \Omega)}+\left|\partial_{\nu} v_{\mid \partial \Omega}\right|_{L^{2}(\partial \Omega)}\right)
$$

Taking account the boundary condition in (48) and (52) we have

\begin{aligned}
\|v\|_{H^{1}(\Omega)}^{2} & \leq C e^{C k}\left(\|g\|^{2}+\left|w_{\mid \partial \Omega}\right|_{H^{1}(\partial \Omega)}^{2}+\left|\partial_{\nu} w_{\partial \Omega}\right|_{L^{2}(\partial \Omega)}^{2}\right) \\
& \leq C e^{C k}\left(\|g\|^{2}+\|f\|^{2}+\|w\|_{L^{2}(\omega)}^{2}\right) \\
& \leq C e^{C k}\left(\|g\|^{2}+\|f\|^{2}+\|v\|\|g\|+\|w\|\|f\|\right) \text { by }(49)
\end{aligned}
$$

This estimate and (53) give

$$
\|v\|_{\bar{H}^{1}(\Omega)}+\|w\|_{\bar{H}^{1}(\Omega)} \leq C e^{C k}(\|f\|+\|g\|)
$$

This implies the estimate on the $L^{2}$ norm on $v$ and $w$, which gives the Theorem 5 by density.

### 5.2 Lower bound

Here we use the results proved first by Davies [11] in one dimension, by Zworski [24] for Schrödinger operators in $n$ dimension and by Dencker, Sjöstrand and Zworski [12] for more general sub-elliptic operators. This allows to obtain a lower bound on the resolvent.

We recall here the theorem given by Dencker, Sjöstrand and Zworski.

Theorem 8 (Theorem $1.1[12]$ ). Let $V \in \mathscr{C}^{\infty}\left(\mathbb{R}^{n}\right)$. Then, for any $z \in\left\{\xi^{2}+V(x),(x, \xi) \in \mathbb{R}^{n}\right.$, $\left.\operatorname{Im}\left\langle\xi, \partial_{x} V(x)\right\rangle \neq 0\right\}$, there exists $h_{0}>0$ such that for all $h \in\left(0, h_{0}\right)$, there exists $u(h) \in L^{2}\left(\mathbb{R}^{n}\right)$ with the property

$$
\left\|\left(-h^{2} \Delta+V(x)-z\right) u(h)\right\|=\mathcal{O}\left(h^{\infty}\right)\|u(h)\|
$$

In addition, $u(h)$ is localized to a point $\left(x_{0}, \xi_{0}\right)$ in phase with $\xi_{0}^{2}+V\left(x_{0}\right)=z$.
More precisely, $W F_{h}(u)=\left\{\left(x_{0}, \xi_{0}\right)\right\}$, where $W F_{h}(u)$ is the semi-classical wave front set.
If the potential is real analytic, then we can replace $h^{\infty}$ by $\exp (-1 / C h)$.
A consequence of the microlocal localization of $u$, we can cut-off $u$ such that its support is in a neighborhood of $x_{0}$. The Theorem 8 implies that if $z$ is in the resolvent set, $\left\|\left(-h^{2} \Delta+V(x)-z\right)^{-1}\right\| \geq$ $C_{N} h^{-N}$ for all $N$, in $\mathscr{C}^{\infty}$ case and $\left\|\left(-h^{2} \Delta+V(x)-z\right)^{-1}\right\| \geq C \exp (C / h)$ in analytic case.

Proof of Theorem 6. We set $z_{0}=-\left(1+m\left(x_{0}\right)\right)^{-1}\left|\xi_{0}\right|^{2}$, we set $V(x)=z_{0}(1+m(x))$. We have $\left|\xi_{0}\right|^{2}+V\left(x_{0}\right)=0$ and

$$
\begin{aligned}
\operatorname{Im}\left(\xi_{0} \partial_{x} V\left(x_{0}\right)\right) & =\operatorname{Im}\left(z_{0} \xi_{0} \partial_{x} m\left(x_{0}\right)\right)=-\left|1+m\left(x_{0}\right)\right|^{-2}\left|\xi_{0}\right|^{2} \operatorname{Im}\left(\left(1+\bar{m}\left(x_{0}\right)\right) \xi_{0} \partial_{x} m\left(x_{0}\right)\right) \\
& =-\left|1+m\left(x_{0}\right)\right|^{-2}\left|\xi_{0}\right|^{2} \operatorname{Im}\left(\bar{n}\left(x_{0}\right) \xi_{0} \partial_{x} n\left(x_{0}\right)\right) \neq 0
\end{aligned}
$$

by assumption. By Theorem 8 there exists $u(h)$ such that $\left\|\left(-h^{2} \Delta+V(x)\right) u(h)\right\|=\mathcal{O}\left(h^{\infty}\right)\|u(h)\|$ $\underset{\sim}{\mathrm{R}}=\mathcal{O}\left(e^{-C / h)}\|u(h)\|\right.$ if $m$ is analytic. Define by $f=\Delta u(h)-h^{-2} z_{0}(1+m(x)) u(h)$, we have $\tilde{R}_{k^{2}}(f, 0)=(u(h), 0)$ with $k^{2}=-h^{-2} z_{0}$. We remark that $u(h)$ is localized in a neighborhood of $x_{0}$, in particular $u(h)$ is null in a neighborhood of $\partial \Omega$, then $(u(h), 0)$ satisfies the boundary conditions. This implies the Theorem 6.

## A Notation and recall on pseudo-differential calculus

## A. 1 Sobolev spaces and pseudo-differential operators

We introduce some notation for the Sobolev spaces.
We denote the semi-classical $H^{s}$ norm by $\|w\|_{H_{s c}^{s}}^{2}=\int\left(1+h^{2}|\xi|^{2}\right)^{s}|\hat{u}(\xi)|^{2} d \xi$. On a compact manifold we define the semi-classical $H^{s}$ using local coordinates. To distinguish norm on spaces of dimension $n$ and dimension $n-1$, we denote the semi-classical $H^{s}$ norm on $\partial \Omega$ by $|\cdot|_{H_{s c}^{s}(\partial \Omega)}$. Let $w$ a distribution on $\Omega$, we denote by $\|w\|_{\bar{H}_{s c}^{s}(\Omega)}=\inf \left\{\|\beta\|_{H_{s c}^{s}}\right.$, where $\left.\beta_{\mid \Omega}=w\right\}$. We recall that we denote by $D=(h / i) \partial$, and if $s$ is an integer the quantity $\sum_{|\alpha| \leq s}\left\|D^{\alpha} w\right\|_{L^{2}(\Omega)}^{2}$ is equivalent uniformly with respect $h$ to $\|w\|_{\frac{2}{H_{s c}^{s}(\Omega)}}$.

In the context of semi-classical $H^{s}$ space we have the following trace formula, for $s>0$, for all $w \in \bar{H}_{s c}^{s+1 / 2}(\Omega)$ we have

$$
\left|w_{\mid \partial \Omega}\right|_{H_{s c}^{s}(\partial \Omega)} \lesssim h^{-1 / 2}\|w\|_{\bar{H}_{s c}^{s+1 / 2}(\Omega)},
$$

where $w_{\mid \partial \Omega}\left(x_{0}\right)$ means the limit of $w(x)$ when $x \in \Omega$ goes to $x_{0}$.
We recall the pseudo-differential tools. Let $a(x, \xi)$ in $\mathscr{C}^{\infty}\left(\mathbb{R}^{n} \times \mathbb{R}^{n}\right)$ we say that $a$ is a symbol of order $m$ if for all $\alpha, \beta \in \mathbb{N}^{n}$, there exist $C_{\alpha, \beta}>0$, such that

$$
\left|\partial_{x}^{\alpha} \partial_{\xi}^{\beta} a(x, \xi)\right| \leq C_{\alpha, \beta}\langle\xi\rangle^{m-|\beta|}
$$

where $\langle\xi\rangle^{2}=1+|\xi|^{2}$. In particular a polynomial in $\xi$ of order $m$ with coefficients in $\mathscr{C}^{\infty}\left(\mathbb{R}^{n}\right)$ with all bounded derivatives, is a symbol of order $m$.

To a symbol we can associate an semi-classical operator by the following formula

$$
\operatorname{Op}(a) u=a(x, D) u=\frac{1}{(2 \pi)^{n}} \int e^{i x \xi} a(x, h \xi) \hat{u}(\xi) d \xi=\frac{1}{(2 h \pi)^{n}} \int e^{i x \xi / h} a(x, \xi) \hat{u}(\xi / h) d \xi
$$

This formula makes sense for $u \in \mathscr{S}\left(\mathbb{R}^{n}\right)$ and we can extend to $u \in H^{s}$. For $a$, a symbol of order $m$, there exists $C>0$ such that for all $u \in H^{s}$,

$$
\|a(x, D) u\|_{H_{s c}^{s-m}} \leq C\|u\|_{H_{s c}^{s}}
$$

We can compose the pseudo-differential operators, and we have the following result. Let $a$ a symbol of order $m$ and $b$ a symbol of order $k$, there exists $c$ a symbol of order $m+k$ such that $a(x, D) \circ b(x, D)=c(x, D)$. Moreover there exists a symbol $d$ of order $m+k-1$ such that $c(x, D)=$ $(a b)(x, D)+h d(x, D)$. This means that up $h$ the composition of two operators is the operators associated with the product of symbols.

We can inverse the elliptic symbol, more precisely, let $a$ a symbol of order $m$ satisfying there exists $C>0$ such that for all $(x, \xi) \in \mathbb{R}^{n} \times \mathbb{R}^{n}$ we have $|a(x, \xi)| \geq C\langle\xi\rangle^{m}$. Then for all $N>0$ there exist $b$ a symbol of order $-m$ and $r$ a symbol of order $-N$ such that $b(x, D) \circ a(x, D)=I+h r(x, D)$. We can localized this result. Let $K$ a closed set of $\mathbb{R}^{n}$, we assume that there exists $C>0$ such that for all $(x, \xi) \in K \times \mathbb{R}^{n},|a(x, \xi)| \geq C\langle\xi\rangle^{m}$ for all $\chi \in \mathscr{C}_{0}^{\infty}\left(\mathbb{R}^{n}\right)$ supported in $K$, there exists $b$ a symbol of order $-m$ and $r$ a symbol of order $-N$ such that $b(x, D) \circ a(x, D)=\chi(x)+h r(x, D)$. In both cases we say that $b$ is a parametrix for $a$.

We can also define pseudo-differential on a smooth compact manifold without boundary. We shall use freely the result on $\mathbb{R}^{n}$ in the context of manifolds. To distinguish both cases we denote by $\mathrm{Op} a$ the operators on $\mathbb{R}^{n}$ and by op $a$ the operators on a manifold of dimension $n-1$ or on $\mathbb{R}^{n-1} \cong\left\{x \in \mathbb{R}^{n}, x_{n}=0\right\}$.

We use also spaces $\bar{H}_{s c}^{s}$ and the pseudo-differential calculus on these spaces. In general that requires introduction of the delicate notion of "transmission condition" (see Boutet de Monvel [2]), to avoid that we follow the Hörmander's strategy (see [15, Appendix B]) adapted for the parametrices which are particular cases of operators satisfying the "transmission condition". We recall some results proved by Hörmander in the context of classical $\bar{H}^{s}$ spaces. The adaptation to the $\bar{H}_{s c}^{s}$ spaces is easy and we give here only the results and some ideas of proof. Here we give the result in a half space $\mathbb{R}_{+}^{n}=\left\{x \in \mathbb{R}^{n}, x_{n}>0\right\}$. For simplicity we denote by $\bar{H}_{s c}^{s}=\bar{H}_{s c}^{s}\left(\mathbb{R}_{+}^{n}\right)$. In the proof we need introduce a space $\bar{H}_{s c}^{m, s}$. First we say that $u \in H_{s c}^{m, s}\left(\mathbb{R}^{n}\right)=H_{s c}^{m, s}$ if $\|u\|_{H_{s c}^{m, s}}^{2}=$ $\int\langle h \xi\rangle^{2 m}\left\langle h \xi^{\prime}\right\rangle^{2 s}|u(\xi)|^{2} d \xi<\infty$ where $\xi=\left(\xi^{\prime}, \xi_{n}\right)$. As for the $H^{s}$ space we say that $u \in \bar{H}_{s c}^{m, s}$ where $u$ is a distribution in $\mathscr{D}^{\prime}\left(\mathbb{R}_{+}^{n}\right)$ if there exists $v \in H_{s c}^{m, s}$ such that $u=v_{\mid x_{n}>0}$ and we denote $\|u\|_{\bar{H}_{s c}^{m, s}}=\inf \left\{\|v\|_{H_{s c}^{m, s}}\right.$, where $v \in H^{m, s}$, such that $\left.v_{\mid x_{n}>0}=u\right\}$.

We can easily see that if $u \in \bar{H}_{s c}^{0, s}$ then $\underline{u} \in H_{s c}^{0, s}$ and $\|u\|_{\bar{H}_{s c}^{0, s}}=\|\underline{u}\|_{H_{s c}^{0, s}}$, (see (14) for the definition of $\underline{u}$ ).

We can extend the Theorem B.2.3 given by Hörmander [15]

$$
\begin{align*}
u \in \bar{H}_{s c}^{m, s} & \Leftrightarrow D_{x_{n}} u \in \bar{H}_{s c}^{m-1, s} \text { and } u \in \bar{H}_{s c}^{m-1, s+1} \\
& \Leftrightarrow D_{x_{n}}^{2} u \in \bar{H}_{s c}^{m-2, s}, D_{x_{n}} u \in \bar{H}_{s c}^{m-2, s+1} \text { and } u \in \bar{H}_{s c}^{m-2, s+2} \tag{54}
\end{align*}
$$

Of course the natural norms on these spaces are equivalent.
We can use the Theorem B.2.9 from [15] in the following form adapted to our context. We denote by $P=D_{x_{n}}^{2}+R\left(x, D^{\prime}\right)+\alpha(x) D_{x_{n}}$ a differential operator of second order. We have for all $k \in \mathbb{R}$,

$$
\begin{equation*}
u \in \bar{H}_{s c}^{m-k, s+k} \text { and } P u \in \bar{H}_{s c}^{m-2, s} \Rightarrow u \in \bar{H}_{s c}^{m, s} \tag{55}
\end{equation*}
$$

Of course this is trivial if $k \leq 0$. For $k>0$ we can prove this by recurrence on $k$. The idea is the following, we can write $D_{x_{n}}^{2} u=P u-R\left(x, D^{\prime}\right) u-\alpha D_{x_{n}} u$ and for $k=1$ this formula implies that $D_{x_{n}}^{2} u \in \bar{H}_{s c}^{m-2, s}$. Then we can apply (54) to obtain the result in this case. The recurrence is easy.

The previous results are useful to prove that the parametrix of a elliptic operator is a mapping on the $\bar{H}^{s}$ space.

Let $P$ a differential operator of second order, elliptic, i.e. there exists $C>0$ such that $\forall x \in \mathbb{R}^{n}$, $\forall \xi \in \mathbb{R}^{n},|p(x, \xi)| \geq C\langle\xi\rangle^{2}$, and let $Q$ a parametrix such that $Q P=I d+h K$ where $K$ is of order
 is given by the formula $r Q \underline{u}$ which make sense if $\underline{u}$ make sense (it is the case for if $u \in L^{2}(\Omega)$ ). We have the following result. If $s \in[0, N]$, there exists $C>0$ such that for all $u \in \bar{H}_{s c}^{s}$, we have

$$
\begin{equation*}
\|r Q \underline{u}\|_{\bar{H}_{s c}^{s+2}} \leq C\|u\|_{\bar{H}_{s c}^{s}} . \tag{56}
\end{equation*}
$$

Remark, here $\underline{u}$ is at least in $L^{2}$ so $r Q \underline{u}$ make sense. First we prove that $r Q \underline{u} \in \bar{H}_{s c}^{s+2-k, k}$ where $k \geq s$. It is enough to prove that for all $\alpha \in \mathbb{N}^{n-1},|\alpha| \leq k, D^{\prime \alpha} Q u \in \bar{H}_{s c}^{s+2-k}$. By pseudo-differential calculus we have $D^{\prime \alpha} Q=\sum_{|\beta| \leq|\alpha|} Q_{\beta} D^{\prime \beta}$, where $Q_{\beta}$ is of order -2 . We have

$$
\begin{aligned}
\left\|r D^{\prime \alpha} Q \underline{u}\right\|_{\bar{H}_{s c}^{s+2-k}} & \leq \sum_{|\beta| \leq|\alpha|}\left\|Q_{\beta} D^{\prime \beta} \underline{u}\right\|_{H_{s c}^{s+2-k}} \leq C \sum_{|\beta| \leq|\alpha|}\left\|D^{\prime \beta} \underline{u}\right\|_{H_{s c}^{s-k}} \leq C\|\underline{u}\|_{H_{s c}^{s-k, k}} \\
& \leq C\|\underline{u}\|_{H_{s c}^{0, s}} \leq C\|u\|_{\bar{H}_{s c}^{0, s}} \leq C\|u\|_{\bar{H}_{s c}^{s}}
\end{aligned}
$$

It is well-known that we have also $P Q=I d+h \tilde{K}$ where $\tilde{K}$ is of order $-N$. Indeed there exists a $\tilde{Q}$ such that $P \tilde{Q}=I d+h \tilde{K}$ where $\tilde{K}$ is of order $-N$ and it is easy to prove that $Q=\tilde{Q}+h K^{\prime}$ where $K^{\prime}$ is of order $-N \underset{\tilde{K}}{-2}$. Thus we have, as $P$ is a differential operator, $\operatorname{Pr} Q \underline{u}=r P Q \underline{u}=r \underline{u}+h r \tilde{K} \underline{u}=$ $u+h r \tilde{K} \underline{u}$. As $\|\tilde{K} \underline{u}\|_{H^{N}} \leq C\|\underline{u}\|_{L^{2}} \leq\|u\|_{\bar{H}_{s c}^{s}}$, we obtain for $s \in[0, N],\|\operatorname{Pr} Q \underline{u}\|_{\bar{H}_{s c}^{s}} \leq C\|u\|_{\bar{H}_{s c}^{s}}$. Then we have $r Q \underline{u} \in \bar{H}_{s c}^{s+2-k, k}$ and $\operatorname{Pr} Q \underline{u} \in \bar{H}_{s c}^{s}$ then from (55) this implies $\|r Q \underline{u}\|_{\bar{H}_{s c}^{s+2}} \leq C\|u\|_{\bar{H}_{s c}^{s}}$.

We need also regularity results for $r Q\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)$, where $\gamma \in H_{s c}^{s}\left(\mathbb{R}^{n-1}\right)$. First we remark $\int h^{2 k}\left|\xi_{n}\right|^{2 k}\left(1+h^{2}\left|\xi_{n}\right|^{2}+\left|\xi^{\prime}\right|^{2}\right)^{\nu} d \xi_{n} \leq C\left\langle\xi^{\prime}\right\rangle^{2 k+2 \nu+1} / h$ if $\nu+k<-1 / 2$, then by direct computation we have for all $\gamma \in H^{s}\left(\mathbb{R}^{n-1}\right),\left\|\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right\|_{H^{\nu-k-1 / 2, s-\nu}} \leq \frac{C}{\sqrt{h}}|\gamma|_{H^{s}\left(\mathbb{R}^{n-1}\right)}$, if $\nu<k$. For $j \in \mathbb{N}$, we have if $s-k<j$, following the same computation as for computing $r Q \underline{u}$,

$$
\left\|Q\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)\right\|_{H^{s-j-k+3 / 2, j}} \leq C\left\|\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right\|_{H^{s-j-k-1 / 2, j}} \leq \frac{C}{\sqrt{h}}|\gamma|_{H^{s}\left(\mathbb{R}^{n-1}\right)}
$$

As $r\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)=0$ we have $\operatorname{Pr} Q\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)=h r K\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)$. We deduce,

$$
\left\|\operatorname{Pr} Q\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)\right\|_{\bar{H}_{s c}^{s-k-1 / 2}} \leq C\left\|\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right\|_{H_{s c}^{s-k-N-1 / 2}} \leq \frac{C}{\sqrt{h}}|\gamma|_{H^{s}\left(\mathbb{R}^{n-1}\right)}
$$

if $s-k<N$. Thus from (55) we obtain if $s-k<N$,

$$
\begin{equation*}
\left\|r Q\left(\gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)\right\|_{\bar{H}^{s-k+3 / 2}\left(\mathbb{R}_{+}^{n}\right)} \leq \frac{C}{\sqrt{h}}|\gamma|_{H^{s}\left(\mathbb{R}^{n-1}\right)} \tag{57}
\end{equation*}
$$

Remark 10. In the section 2.3 we apply the previous result to a local parametrix. Indeed we can construct the local parametrix with a global parametrix. We can extend $P$ to have a global elliptic operator $\tilde{P}$ such that $\tilde{P}=P$ in a domain $W$ where $P$ is elliptic. Let $Q$ a parametrix of $\tilde{P}$ such that $Q \tilde{P}=I d+h K$ where $K$ is an operator of order $-N$. Let $\chi_{1}$ and $\chi_{2}$ functions in $\mathscr{C} \infty$ compactly supported in $W$ such that $\chi_{2}=1$ on the support of $\chi_{1}$. By pseudo-differential calculus, we have $\chi_{1} Q \chi_{2}=\chi_{1} Q+h K^{\prime}$ where $K^{\prime}$ is an operator of order $-N-2$. Then we have $\chi_{1} Q \tilde{P}=\chi_{1}+h \chi_{1} K$ and $\chi_{1} Q \tilde{P}=\chi_{1} Q \chi_{2} \tilde{P}-h K^{\prime} \tilde{P}$. As $\tilde{P}=P$ on the support of $\chi_{2}$ we have $\chi_{1} Q \chi_{2} P=\chi_{1}+h K^{\prime \prime}$ where $K^{\prime \prime}$ is an operator of order $-N$. Then $\chi_{1} Q \chi_{2}$ is a local parametrix of $P$. It is easy to see that we can replace $Q$ by $\chi_{1} Q \chi_{2}$ in (56) and in (57).

## A. 2 Properties on the roots and parametrices

We use some properties of the roots of $\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)-\mu$ and $a\left(\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)\right)-\mu$. By assumption these polynomials have not real roots and it is easy to see that for $\xi^{\prime}$ large enough the imaginary parts have different signs. In particular the roots are simple thus smooth and the roots are symbols of order 1 . Actually, for instance for $\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)-\mu$, (the proof for $a\left(\xi_{n}^{2}+R\left(x, \xi^{\prime}\right)\right)-\mu$ is similar and left to the reader) the roots have, for $\left|\xi^{\prime}\right|$ large enough, the following form $\pm i \sqrt{R\left(x, \xi^{\prime}\right)}+z_{ \pm}\left(\mu, 1 / \sqrt{R\left(x, \xi^{\prime}\right)}\right)$, where $z_{ \pm}$is a solution to $z_{ \pm} \mp i z_{ \pm}^{2} s / 2+i \mu s / 2=0$ in a neighborhood of $s=0$. This expression implies that the roots are symbols of order 1.

The parametrices used, denoted by $Q$ and $\tilde{Q}$ have a particular structure we give here. The symbol of $P$ is a polynomial having the following form, $p_{2}+h p_{1}$ where $p_{j}$ are polynomial of degree $j$. We
seek a parametrix with symbol given formally by $q=q_{-2}+h q_{-3}+h^{2} q_{-4}+\cdots$, where $q_{j}$ are symbol of order $j$. If we denote by $q \circ p$ the asymptotic expansion of the symbol of $\operatorname{Op}(q) \operatorname{Op}(p)$, we have,

$$
q \circ p=q_{-2} p_{2}+\sum \frac{h^{k-j+|\alpha|}}{\alpha!i^{|\alpha|}} \partial_{\xi}^{\alpha} q_{-k} \partial_{x}^{\alpha} p_{j}
$$

where in the sum we have $j=2$ or $1, k \geq 2, \alpha \in \mathbb{N}^{n}$ and, $|\alpha| \geq 1$ or $j=1$. In particular we have $k-j+|\alpha| \geq 1$. We choose $q_{-2}=1 / p_{2}$, and to cancel the terms with the same power in $h$ we have

$$
\begin{equation*}
q_{-\nu-2}=\frac{1}{p_{2}} \sum \frac{1}{\alpha!i^{|\alpha|}} \partial_{\xi}^{\alpha} q_{-k} \partial_{x}^{\alpha} p_{j} \tag{58}
\end{equation*}
$$

where $\nu \geq 1, k-j+|\alpha|=\nu, j=2,1, k \geq 2, \alpha \in \mathbb{N}^{n},|\alpha| \geq 1$ or $j=1$. In particular the sum is finite and $k \leq \nu+1$. We claim now that

$$
q_{-\nu}=\frac{S_{3 \nu-6}}{p_{2}^{2 \nu-3}} \text { for } \nu \geq 2
$$

where $S_{\mu}$ is a polynomial of degree $\mu$.
Clearly this is true for $\nu=2$. We verify that for $k \leq \nu+1, \partial_{\xi}^{\alpha} q_{-k}=\frac{\tilde{S}_{3 k-6+|\alpha|}^{p_{2}^{k-3+|\alpha|}} \text {, where } \tilde{S}_{\mu} \text { is a }}{2}$ polynomial of degree $\mu$. The parameters satisfy $j \leq 2, k-j+|\alpha|=\nu$ and $k \leq \nu+1$, then the power of $p_{2}$ in (58) is $2 k-2+|\alpha|=\nu+k+j-2 \leq 2 \nu+j-1 \leq 2 \nu+1=2(\nu+2)-3$. The degree of the numerator is $3 k-6+|\alpha|+2 j=\nu+2 k-6+2 j \leq 3 \nu-4+2 j \leq 3 \nu=3(\nu+2)-6$. This gives the claim.

We need to compute for $\gamma\left(x^{\prime}\right)$,

$$
\begin{equation*}
\left[Q\left(\frac{h}{i} \gamma \otimes D_{x_{n}}^{k} \delta_{x_{n}=0}\right)\right]_{\mid x_{n}=0}=\frac{1}{(2 h \pi)^{n-1}} \int e^{i x^{\prime} \xi^{\prime} / h} \tilde{q}\left(x^{\prime}, \xi^{\prime}\right) \hat{\gamma}\left(\xi^{\prime} / h\right) d \xi^{\prime} \tag{59}
\end{equation*}
$$

where formally $\tilde{q}\left(x^{\prime}, \xi^{\prime}\right)=\left(\frac{1}{2 i \pi} \int_{\mathbb{R}} e^{i x_{n} \xi_{n} / h} q(x, \xi) \xi_{n}^{k} d \xi_{n}\right)_{\mid x_{n}=0}$. It is not clear that $\tilde{q}$ is well defined in general but in the following lemma we prove this is true if $q$ is a rational function, and in this case (59) make sense.
Lemma A.1. Let $\nu \in \mathbb{N}^{*}$, let $S_{\nu}(x, \xi)$ a polynomial of order $\nu$ with respect $\xi_{n}$ and we assume that the coefficient of $\xi_{n}^{j}$ is a symbol in $\xi^{\prime}$ of order $\nu-j$. Let $p$ a polynomial of degree $d$ in $\xi$ and a symbol of order $d$. We assume that $p(x, \xi)=\xi_{n}^{d}+\sum_{j=0}^{d-1} \xi_{n}^{j} a_{d-j}\left(x, \xi^{\prime}\right)$ where $a_{d-j}$ are polynomials of order $d-j$. Moreover we assume there exists $\delta>0$ such that $\forall x \in \mathbb{R}^{n}, \forall \xi \in \mathbb{R}^{n},|p(x, \xi)| \geq \delta\langle\xi\rangle^{d}$. Then

$$
\left(\int_{\mathbb{R}} e^{i \frac{x_{n}}{h} \xi_{n}} \frac{S_{\nu}(x, \xi)}{p(x, \xi)} d \xi_{n}\right)_{\mid x_{n}=0}
$$

is a symbol of order $\nu-d+1$.
Proof. The integral $\int_{\mathbb{R}} e^{i \frac{x_{n}}{h} \xi_{n}} \frac{S_{\nu}(x, \xi)}{p(x, \xi)} d \xi_{n}$ converges for $x_{n}>0$. For $\left(x, \xi^{\prime}\right)$ fixed, we can change the integration contour by $\Gamma=\left[-D\left\langle\xi^{\prime}\right\rangle D\left\langle\xi^{\prime}\right\rangle\right] \cup\left\{z \in \mathbb{C},|z|=D\left\langle\xi^{\prime}\right\rangle, \operatorname{Im} z>0\right\}$, where $D$ will be chosen later. Indeed the integral does not depend of $D$ if $D$ large enough and the integral on $\left\{z \in \mathbb{C},|z|=D\left\langle\xi^{\prime}\right\rangle, \operatorname{Im} z>0\right\}$ goes to 0 if $D$ goes to $+\infty$. Now we integrate on a compact set and we can take the limit when $x_{n}$ goes to $0^{+}$. We have the following quantity to control.

$$
A=\left(\int_{\Gamma} \frac{S_{\nu}\left(0, x^{\prime}, \xi\right)}{p\left(0, x^{\prime}, \xi\right)} d \xi_{n}\right) .
$$

On $\Gamma$ we have $\left|S_{\nu}\left(0, x^{\prime}, \xi\right)\right| \leq C\left\langle\xi^{\prime}\right\rangle^{\nu}$. For $\xi_{n} \in\left\{z \in \mathbb{C},|z|=D\left\langle\xi^{\prime}\right\rangle, \operatorname{Im} z>0\right\}$ we have $\left|p\left(0, x^{\prime}, \xi\right)\right| \geq\left|\xi_{n}\right|^{d}-\sum_{j=0}^{d-1}\left|\xi_{n}\right|^{j}\left|a_{d-j}\left(0, x^{\prime}, \xi^{\prime}\right)\right| \geq D^{d}\left\langle\xi^{\prime}\right\rangle^{d}\left(1-d D^{-1} C\right) \geq\left\langle\xi^{\prime}\right\rangle^{d} D^{d} / 2$, where we have $\left|a_{d-j}\left(0, x^{\prime}, \xi^{\prime}\right)\right| \leq C\left\langle\xi^{\prime}\right\rangle^{d-j}$ and chosen $D$ such that $D \geq \max (1,2 d C)$. Then by assumption for all $\xi_{n} \in \Gamma$ we have $\left|p\left(0, x^{\prime}, \xi\right)\right| \geq \delta^{\prime}\left\langle\xi^{\prime}\right\rangle$. As the length of $\gamma$ is less than $K\left\langle\xi^{\prime}\right\rangle$ we obtain $A \leq K^{\prime}\left\langle\xi^{\prime}\right\rangle^{\nu-d+1}$. We can obtain the estimates on the derivative by the same way because we can derive $A$ and we obtain the same type of quantities to estimate.

Now we compute the boundary symbol obtained in (21) and (24).

Lemma A.2. Let $k=0,1$ and $\operatorname{Im} \rho_{1}>0$, $\operatorname{Im} \rho_{2}<0$, we have

$$
\left(\int_{\mathbb{R}} e^{i \frac{x_{n}}{h} \xi_{n}} \frac{\xi_{n}^{k}}{\left(\xi_{n}-\rho_{1}\right)\left(\xi_{n}-\rho_{2}\right)} d \xi_{n}\right)_{\mid x_{n}=0}=2 i \pi \frac{\rho_{1}^{k}}{\rho_{1}-\rho_{2}}
$$

Proof. As in the proof of Lemma A.1, we can integrate on $\Gamma$ and this integral is equal to $2 i \pi$ times the residu at $\rho_{1}$. It is easy to see that the residu is $\frac{\rho_{1}^{k}}{\rho_{1}-\rho_{2}}$.
Lemma A.3. Let $k=0,1$ and $\operatorname{Im} \lambda_{1}>0, \operatorname{Im} \lambda_{2}<0, \operatorname{Im} \rho_{1}>0, \operatorname{Im} \rho_{2}<0$, we have

$$
\left(\int_{\mathbb{R}} e^{i \frac{x_{n}}{h} \xi_{n}} \frac{\xi_{n}^{k}}{\left(\xi_{n}-\lambda_{1}\right)\left(\xi_{n}-\lambda_{2}\right)\left(\xi_{n}-\rho_{1}\right)\left(\xi_{n}-\rho_{2}\right)} d \xi_{n}\right)_{\mid x_{n}=0}=2 i \pi A_{k}
$$

where

$$
A_{k}= \begin{cases}\frac{\rho_{2}-\rho_{1}+\lambda_{2}-\lambda_{1}}{\left(\lambda_{1}-\lambda_{2}\right)\left(\lambda_{1}-\rho_{2}\right)\left(\rho_{1}-\lambda_{2}\right)\left(\rho_{1}-\rho_{2}\right)} & \text { if } k=0 \\ \frac{\lambda_{2} \rho_{2}-\lambda_{1} \rho_{1}}{\left(\lambda_{1}-\lambda_{2}\right)\left(\lambda_{1}-\rho_{2}\right)\left(\rho_{1}-\lambda_{2}\right)\left(\rho_{1}-\rho_{2}\right)} & \text { if } k=1\end{cases}
$$

Proof. Clearly both sides of the equality are continuous with respect $\left(\lambda_{1}, \rho_{1}\right)$ then it is sufficient to prove the case $\lambda_{1} \neq \rho_{1}$.

As in the proof of Lemma A.1, we can integrate on $\Gamma$ and the result is $2 i \pi$ times the sum of the residues in half plane $\operatorname{Im} z>0$. We obtain

$$
\begin{aligned}
&\left.\frac{\lambda_{1}^{k}}{\left(\lambda_{1}-\lambda_{2}\right)\left(\lambda_{1}-\rho_{1}\right)\left(\lambda_{1}-\rho_{2}\right)}+\frac{\rho_{1}^{k}}{\left(\rho_{1}-\right.} \lambda_{1}\right)\left(\rho_{1}-\lambda_{2}\right)\left(\rho_{1}-\rho_{2}\right) \\
&=\frac{\lambda_{1}^{k}\left(\rho_{1}-\lambda_{2}\right)\left(\rho_{1}-\rho_{2}\right)-\rho_{1}^{k}\left(\lambda_{1}-\lambda_{2}\right)\left(\lambda_{1}-\rho_{2}\right)}{\left(\lambda_{1}-\lambda_{2}\right)\left(\lambda_{1}-\rho_{1}\right)\left(\lambda_{1}-\rho_{2}\right)\left(\rho_{1}-\lambda_{2}\right)\left(\rho_{1}-\rho_{2}\right)} .
\end{aligned}
$$

Clearly the numerator is null if $\rho_{1}=\lambda_{1}$. By a straightforward computation, if $k=0$ the numerator is $\left(\lambda_{1}-\rho_{1}\right)\left(\rho_{2}-\rho_{1}+\lambda_{2}-\lambda_{1}\right)$. If $k=1$ the numerator is $\left(\lambda_{1}-\rho_{1}\right)\left(\lambda_{2} \rho_{2}-\lambda_{1} \rho_{1}\right)$. This gives the Lemma.
