#### Conditional G-expectation in $\mathbb{L}^p$ and Related Itô's Calculus

In this paper, we define a dynamically consistent conditional G-expectation in space  $\mathbb{L}^p$ , and give the related stochastic calculus of Itô's type, especially get Itô's formula for a general  $C^{1,2}$ -function.

Keywords conditional G-expectation, Itô's integral, stopping times, Itô's formula

### 1 Introduction

The notion of G-expectation, which is a typical nonlinear expectation, was proposed by Peng [5], [6], and [7]. It can be regarded as a nonlinear generalization of Wiener probability space  $(\Omega, \mathcal{F}, P)$ , where  $\Omega = C([0, \infty), \mathbb{R}^d)$ ,  $\mathcal{F} = \mathcal{B}(\Omega)$ , and P is a Wiener probability measure defined on  $(\Omega, \mathcal{F})$ . On the same canonical space  $\Omega$ , G-expectation is a sublinear expectation, such that the same canonical process  $B_t(\omega) := \omega_t, t \geq 0$  is a G-Brownian motion, i.e., it is a continuous process with stable and independent increments. One important feature of G-expectation is its time consistency. To be precise, let  $\xi$  be a random variable and  $Y_t := \mathbb{E}_t^G[\xi]$  be the conditional G-expectation , then one has  $\mathbb{E}_s^G[\xi] = \mathbb{E}_s^G[\mathbb{E}_t^G[\xi]]$  for any s < t. For this reason, the conditional G-expectation is called a G-martingale, or a martingale under G-expectation.

A well-known and fundamentally important fact in probability theory is that the linear space  $L_P^1$  coincides with the  $E_P[|\cdot|]$ -norm completion of the space of bounded and  $\mathcal{F}$ -measurable functions  $B_b(\Omega)$ , or bounded and continuous functions  $C_b(\Omega)$ , or even smaller one, the space  $Lip_{b.cyl}(\Omega) \subset C_b(\Omega)$  of bounded and Lipschitz cylinder functions. While in the theory of G-expectation, Denis, et al.[1] proved that the  $\mathbb{E}[|\cdot|]$ -norm completion of  $Lip_{b.cyl}(\Omega)$  and  $C_b(\Omega)$  are the same space  $L_G^1(\Omega)$ , the random variables  $X = X(\omega)$  which are quasi-continuous with respect to the natural Choquet capacity  $c(A) := \mathbb{E}^G[\mathbf{I}_A]$ ,  $A \in \mathcal{B}(\Omega)$ , but they are strict subspace of the  $\mathbb{E}[|\cdot|]$ -norm completion of  $B_b(\Omega)$ . Moreover the latter one is, again, a strict subspace of  $\mathbb{L}^1$ , the space of all  $\mathcal{F}$ -measurable random variables X such that  $\mathbb{E}[|X|] < \infty$ .

In Peng [5], [6], and [7], G-expectation and the related Itô's calculus are mainly based on space  $L_G^1(\Omega)$ . Then Li and Peng [4] extend the Itô's integral to space without the quasi-continuity, obtain Itô's integral on stopping time interval, and get Itô's formula for a general  $C^{1,2}$ -function, which generalizes the previous results of Peng [5], [6], and [7] and its improved version of Gao [2] and Zhang et al. [8].

But in Li and Peng [4], the conditional G-expectation has not been defined, so whether the martingale properties still hold for the stochastic integral  $(\int_0^t \eta_s dB_s)_{0 \le t \le T}$  and the conditional G-expectation of random variables without quasi-continuous condition is open.

This paper is organized as follows. In section 2, we give the definition of conditional G-expectation of random variables in space  $\mathbb{L}^1$ . In section 3, we define the related Itô's integral in space  $\mathbb{M}^2(0,T)$ . In section 4, we prove the Itô's formula for general  $C^{1,2}$  function.

## 2 Conditional G-expectation in $\mathbb{L}^p$

#### 2.1 G-Brownian motion and G-expectation

We first present some preliminaries in the theory of G-expectation and the related space of random variables. More relevant details can be found in Peng [5], [6], [7].

Let  $\Omega$  be a given set and let  $\mathcal{H}$  be a linear space of real functions defined on  $\Omega$  such that  $c \in \mathcal{H}$  for each constant c and  $|X| \in \mathcal{H}$  if  $X \in \mathcal{H}$ . A sublinear expectation  $\mathbb{E}$  on  $\mathcal{H}$  is a functional  $\mathbb{E} : \mathcal{H} \to \mathbb{R}$  satisfying the following properties: for all  $X, Y \in \mathcal{H}$ ,

- (a) Monotonicity: If  $X \ge Y$  then  $\mathbb{E}[X] \ge \mathbb{E}[Y]$ .
- (b) Constant preserving:  $\mathbb{E}[c] = c$ .
- (c) Sub-additivity:  $\mathbb{E}[X + Y] \leq \mathbb{E}[X] + \mathbb{E}[Y]$ .
- (d) Positive homogeneity:  $\mathbb{E}[\lambda X] = \lambda \mathbb{E}[X], \forall \lambda > 0$ .

The triple  $(\Omega, \mathcal{H}, \mathbb{E})$  is called a sublinear expectation space. In the literature, for technical convenience,  $\mathcal{H}$  is taken as the space satisfying that if  $X_1, \ldots, X_n \in \mathcal{H}$  then  $\varphi(X_1, \ldots, X_n) \in \mathcal{H}$  for each  $\varphi \in C_{l,Lip}(\mathbb{R}^n)$  where  $C_{l,Lip}(\mathbb{R}^n)$  denotes the linear space of (local Lipschitz) functions  $\varphi$  satisfying

$$|\varphi(x) - \varphi(y)| \le C(1 + |x|^m + |y|^m) |x - y|, \forall x, y \in \mathbb{R}^n,$$

for some  $C > 0, m \in \mathbb{N}$  depending on  $\varphi$ . The linear space  $C_{l,Lip}(\mathbb{R}^n)$  can be replaced by  $\mathbb{L}^{\infty}(\mathbb{R}^n), C_b(\mathbb{R}^n), C_b(\mathbb{R}^n), C_{unif}(\mathbb{R}^n), C_{b,Lip}(\mathbb{R}^n)$ , and  $L^0(\mathbb{R}^n)$ . In this case  $X = (X_1, \ldots, X_n)$  is called an n-dimensional random vector, denoted by  $X \in \mathcal{H}^n$ .

**DEFINITION 2.1.** In a nonlinear expectation space  $(\Omega, \mathcal{H}, \mathbb{E})$ , a random vector  $Y \in \mathcal{H}^n$  is said to be independent from another random vector  $X \in \mathcal{H}^n$  under  $\mathbb{E}[\cdot]$  if for each test function  $\varphi \in C_{l.L_{ip}}(\mathbb{R}^{m+n})$  we have

$$\mathbb{E}[\varphi(X,Y)] = \mathbb{E}[\mathbb{E}[\varphi(x,Y)]_{x=X}].$$

Let  $\Omega = C_0^d(\mathbb{R}^+)$  be the space of all  $\mathbb{R}^d$ -valued continuous paths  $(\omega_t)_{t \in \mathbb{R}^+}$ , with  $\omega_0 = 0$ , equipped with the distance

$$\rho(\omega^1, \omega^2) := \sum_{i=1}^{\infty} 2^{-i} [(\max_{t \in [0,i]} |\omega_t^1 - \omega_t^2|) \wedge 1].$$

For each fixed  $T \in [0, \infty)$ , we set  $\Omega_T := \{\omega_{\cdot \wedge T} : \omega \in \Omega\}$ .

Let

$$L_{ip}(\Omega_T) := \{ \phi(B_{t_1 \wedge T}, \cdots, B_{t_n \wedge T}) : n \in \mathbb{N}, t_1, \cdots, t_n \in [0, \infty), \phi \in C_{l,Lip}(\mathbb{R}^{d \times n}) \}$$

with  $B_t = \omega_t, t \in [0, \infty)$  for  $\omega \in \Omega$ , and

$$L_{ip}(\Omega) := \bigcup_{n=1}^{\infty} L_{ip}(\Omega_n).$$

Let  $(\xi_i)_{i=1}^{\infty}$  be a sequence of d-dimensional random vectors on a sublinear expectation space  $(\tilde{\Omega}, \tilde{\mathcal{H}}, \tilde{E})$  such that  $\xi_i$  is G-normal distributed and  $\xi_{i+1}$  is independent from  $(\xi_1, \dots, \xi_i)$  for each  $i = 1, 2, \dots$ . For each  $X \in L_{ip}(\Omega)$  with

$$X = \phi(B_{t_1} - B_{t_0}, B_{t_2} - B_{t_1}, \cdots, B_{t_n} - B_{t_{n-1}}),$$

some  $\phi \in C_{l,Lip}(\mathbb{R}^{d \times n})$  and  $0 = t_0 < t_1 < \dots < t_n < \infty$ , define G-expectation  $\hat{\mathbb{E}}[\cdot]$  as

$$\hat{\mathbb{E}}[\phi(B_{t_1} - B_{t_0}, B_{t_2} - B_{t_1}, \cdots, B_{t_n} - B_{t_{n-1}})] := \tilde{\mathbb{E}}[\phi(\sqrt{t_1 - t_0}\xi_1, \cdots, \sqrt{t_n - t_{n-1}}\xi_n)].$$

And the related conditional G-expectation of

$$X = \phi(B_{t_1}, B_{t_2} - B_{t_1}, \cdots, B_{t_n} - B_{t_{n-1}})$$

under  $\Omega_{t_i}$  is defined by

$$\hat{\mathbb{E}}[X|\Omega_{t_i}] := \psi(B_{t_1}, \cdots, B_{t_i} - B_{t_{i-1}}),$$

where

$$\psi(x_1, \dots, x_j) = \tilde{\mathbb{E}}[\phi(x_1, \dots, x_j, \sqrt{t_{j+1} - t_j} \xi_{j+1}, \dots, \sqrt{t_n - t_{n-1}} \xi_n)].$$

 $\hat{\mathbb{E}}[\cdot]$  consistently defines a sublinear expectation on  $L_{ip}(\Omega)$  and  $(B_t)_{t\geq 0}$  is a G-Brownian motion.

The sublinear expectation  $\hat{\mathbb{E}}[\cdot]: L_{ip}(\Omega) \to \mathbb{R}$  defined through the above procedure is called a G-expectation. The corresponding canonical process  $(B_t)_{t\geq 0}$  on the sublinear expectation space  $(\Omega, L_{ip}(\Omega), \hat{\mathbb{E}})$  is called a G-Brownian motion.

Let  $L_G^p(\Omega_T), p \geq 1$ , denotes the completion of

$$L_{ip}(\Omega_T) := \{ \varphi(B_{t_1 \wedge T}, \cdots, B_{t_n \wedge T}) : n \in \mathbb{N}, t_1, \cdots, t_n \in [0, \infty), \varphi \in C_{l, Lip}(\mathbb{R}^{d \times n}) \}$$

under the norm  $||X||_p := (\hat{\mathbb{E}}[|X|^p])^{\frac{1}{p}}$ . And set  $L_{ip}(\Omega) := \bigcup_{n=1}^{\infty} L_{ip}(\Omega_n)$ . The definition of G-expectation and conditional G-expectation can be extended to space  $L_G^p(\Omega)$ .

#### 2.2 Conditional G-expectation in $\mathbb{L}^p$

Let  $\mathcal{M}$  be the collection of all probability measures on  $(\Omega, \mathcal{B}(\Omega))$ , and

 $L^0(\Omega)$ : the space of all  $\mathcal{B}(\Omega)$ -measurable real functions;

 $L^0(\Omega_t)$ : the space of all  $\mathcal{B}(\Omega_t)$ -measurable real functions;

 $B_b(\Omega)$ : all bounded elements in  $L^0(\Omega)$ ;  $B_b(\Omega_t)$ : all bounded elements in  $L^0(\Omega_t)$ ;

 $C_b(\Omega)$ : all bounded and continuous elements in  $L^0(\Omega)$ ;  $C_b(\Omega_t)$ : all bounded and continuous elements in  $L^0(\Omega_t)$ .

**THEOREM 2.2.** (Denis, et al.[1]) There exists a weakly compact subset  $\mathscr{P} \subseteq \mathcal{M}$ , such that

$$\hat{\mathbb{E}}[\xi] = \sup_{P \in \mathscr{P}} E_P[\xi], \forall \xi \in L_G^1(\Omega).$$

 $\mathscr{P}$  is called a set that represents  $\hat{\mathbb{E}}$ .

The upper expectation of probability measure set  $\mathscr{P}$  is defined in Huber and Strassen [3]: For each  $X \in L^0(\Omega)$  such that  $E_P[X]$  exists for each  $P \in \mathscr{P}$ , the upper expectation about  $\mathscr{P}$  is defined as

$$\mathbb{E}[X] = \mathbb{E}^{\mathscr{P}}[X] := \sup_{P \in \mathscr{P}} E_P[X].$$

Denote

$$c(A) = \sup_{P \in \mathscr{P}} P(A), A \in \mathcal{B}(\Omega).$$

Then  $c(\cdot)$  is a Choquet capacity. A set A is called polar if c(A) = 0, and a property holds "quasi-surely" (q.s.) if it holds outside a polar set. Let

$$\begin{split} \mathcal{L}^p &:= \{X \in L^0(\Omega) : \mathbb{E}[|X|^p] < \infty\}, 0 < p < \infty, \\ \mathcal{L}^\infty &:= \{X \in L^0(\Omega) : \exists \text{ a constant } M, s.t. |X| \leq M, q.s.\}, \\ \mathcal{N} &:= \{X \in L^0(\Omega) : X = 0, c - q.s.\}, \\ \mathbb{L}^p &:= \mathcal{L}^p/\mathcal{N}. \end{split}$$

Then for  $0 , <math>\mathbb{L}^p$  is a complete metric space under the distance  $d(X,Y) := \mathbb{E}[|X-Y|^p]$ , and for  $1 \le p < \infty$ ,  $\mathbb{L}^p$  is a Banach space under the norm  $\|X\|_p := (\mathbb{E}[|X|^p])^{\frac{1}{p}}$ .

Similarly, we can define space  $\mathbb{L}^p(\Omega_t)$ . And we denote by  $\mathbb{L}^p_b(\Omega_t)$  the completion of  $B_b(\Omega_t)$  and  $\mathbb{L}^p_c(\Omega_t)$  the completion of  $C_b(\Omega_t)$  under norm  $\|\cdot\|_p = \mathbb{E}[|\cdot|^p]$ ,  $0 \le t \le \infty$ .

Denis, et al.[1] proved that  $\mathbb{L}^1_c(\Omega_t) = L^1_G(\Omega_t) \subset \mathbb{L}^1_b(\Omega_t)$ .

 $\mathbb{L}^{\infty} := \mathcal{L}^{\infty}/\mathcal{N}$  is a Banach space under the norm

$$||X||_{\infty} := \inf\{M \ge 0 : |X| \le M, q.s.\}.$$

**LEMMA 2.3.** If for any p > 0,  $X \in \mathbb{L}^p$ , then  $c(|X| = \infty) = 0$ , that is  $|X| < \infty$ , q.s.

Proof. Otherwise,  $c(|X| = \infty) > 0$ , then

$$\mathbb{E}[|X|^p] \ge \mathbb{E}[|X|^p \mathbf{I}_{\{|X|=\infty\}}] = \infty,$$

which means  $X \notin \mathbb{L}^p$ .

Denote

$$\mathbb{L}_{S}(\Omega_{s,t}) := \{ \eta = \sum_{j=1}^{N} \mathbf{I}_{A^{j}} \eta^{j}, \text{ where } \{A^{j}\}_{j=1}^{N} \text{ is an } \mathcal{F}_{s} - \text{partition of } \Omega,$$
 and  $\eta^{j}, j = 1, \dots, N \text{ are } \mathcal{F}_{t}^{s} - \text{measurable } \}.$ 

**DEFINITION 2.4.** We define a mapping,  $\mathbb{E}_s[\cdot] : \mathbb{L}_S(\Omega_{s,t}) \to \mathbb{L}_S(\Omega_{s,s})$  which has the following properties,

- (i) if  $\xi \geq \eta$ , then  $\mathbb{E}_s[\xi] \geq \mathbb{E}_s[\eta]$ .
- (ii)  $\mathbb{E}_s[\eta] = \eta$ , if  $\eta \in \mathbb{L}_S(\Omega_{s,s})$ .
- (iii)  $\mathbb{E}_s[\xi] \mathbb{E}_s[\eta] \le \mathbb{E}_s[\xi \eta].$
- (iv)  $\mathbb{E}_s[\eta \xi] = \eta^+ \mathbb{E}_s[\xi] + \eta^- \mathbb{E}_s[-\xi]$ , if  $\eta \in \mathbb{L}_S(\Omega_{s,s})$ .
- (v)  $\mathbb{E}_s[\eta] = \mathbb{E}[\eta]$ , if  $\eta$  is independent from  $\mathcal{F}_s$ .

Then for any  $\eta \in \mathbb{L}_S(\Omega_{s,t})$ , we have

$$\mathbf{I}_{A^j}\mathbb{E}_s[\eta] = \mathbb{E}_s[\mathbf{I}_{A^j}\sum_{j=1}^N \mathbf{I}_{A^j}\eta^j] = \mathbb{E}_s[\mathbf{I}_{A^j}\eta^j] = \mathbf{I}_{A^j}\mathbb{E}[\eta^j].$$

Summarizing over j, we have

$$\mathbb{E}_s[\eta] = \sum_{j=1}^N \mathbf{I}_{A^j} \mathbb{E}[\eta^j].$$

So we can define the conditional G-expectation of  $\eta$  as

$$\mathbb{E}_s[\eta] := \mathbb{E}[\eta \mid \mathcal{F}_s] = \sum_{j=1}^N \mathbf{I}_{A^j} \mathbb{E}[\eta^j].$$

Denote

$$\mathbb{L}_{S}(\Omega_{s,r,t}) := \{ \eta = \sum_{j=1}^{N} \mathbf{I}_{A_{s}^{j}} \eta_{s,r}^{j} \eta_{r,t}^{j}, \text{ where } \{A_{s}^{j}\}_{j=1}^{N} \text{ is an } \mathcal{F}_{s} - \text{partition of } \Omega,$$

 $\eta_{s,r}^j, j = 1, \dots, N$  are  $\mathcal{F}_r^s$  – measurable,  $\eta_{r,t}^j, j = 1, \dots, N$  are  $\mathcal{F}_t^r$  – measurable  $\}$ .

**PROPOSITION 2.5.**  $\mathbb{E}_s[\cdot] : \mathbb{L}_S(\Omega_{s,r,t}) \to \mathbb{L}_S(\Omega_{s,s})$  is dynamically consistent.

Proof. For any random variable  $\eta \in \mathbb{L}_S(\Omega_{s,r,t})$ , we have

$$\mathbb{E}_{s}[\eta] = \sum_{j=1}^{N} \mathbf{I}_{A_{s}^{j}} \mathbb{E}[\eta_{s,r}^{j} \eta_{r,t}^{j}] = \sum_{j=1}^{N} \mathbf{I}_{A_{s}^{j}} \mathbb{E}[\mathbb{E}[x \eta_{r,t}^{j}]_{x=\eta_{s,r}^{j}}]$$
$$= \sum_{j=1}^{N} \mathbf{I}_{A_{s}^{j}} \mathbb{E}[\eta_{s,r}^{j}] \mathbb{E}[\eta_{r,t}^{j}].$$

And

$$\mathbf{I}_{A_s^j} \mathbb{E}_r[\eta] = \mathbb{E}_r[\mathbf{I}_{A_s^j} \eta_{s,r}^j \eta_{r,t}^j] = \mathbf{I}_{A_s^j} \eta_{s,r}^j \mathbb{E}[\eta_{r,t}^j],$$

Summarizing over j, we have

$$\mathbb{E}_r[\eta] = \sum_{j=1}^N \mathbf{I}_{A_s^j} \eta_{s,r}^j \mathbb{E}[\eta_{r,t}^j].$$

Hence

$$\mathbb{E}_s[\mathbb{E}_r[\eta]] = \mathbb{E}_s[\sum_{i=1}^N \mathbf{I}_{A_s^j} \eta_{s,r}^j \mathbb{E}[\eta_{r,t}^j]] = \sum_{i=1}^N \mathbf{I}_{A_s^j} \mathbb{E}[\eta_{s,r}^j] \mathbb{E}[\eta_{r,t}^j].$$

So  $\mathbb{E}_s[\cdot]$  is dynamically consistent.

By the proof of lemma 43 of Denis, et al.[1], "the collection of processes  $(\theta_t)_{t \in [s,T]}$  with  $\{\theta_t = \sum I_{A_j} \theta_t^j : \{A_j\}_{j=1}^N \text{ is an } \mathcal{F}_s \text{ partition of } \Omega, \, \theta^j \text{ is } (\mathbb{F}^s)\text{-adapted}\}$  is dense in  $\mathcal{A}_{s,T}^{\Theta}$ ". So for any indicator function  $\mathbf{I}_A \in \mathcal{F}_t$ , there exist sequence  $\zeta^i = \sum_{j=1}^{N_1^i} \mathbf{I}_{A_1^{ij}} \eta^{ij}, i = 1, \ldots$ , where for every i,  $\{A_1^{ij}\}_{j=1}^{N_1^i}$  is an  $\mathcal{F}_s$ -partition of  $\Omega$  and  $\eta^{ij}$  are  $\mathcal{F}_t^s$ -measuable, such that  $\zeta^i \to \mathbf{I}_A, i \to \infty$ .

While for any  $\mathcal{F}_t$ -measurable random variable  $\eta$ , there exists simple function sequence  $\xi^i = \sum_{j=1}^{N_2^i} \mathbf{I}_{A^{ij}} \eta^{ij}, i = 1, 2, \ldots$  where  $\{A^{ij}\}_{j=1}^{N_2^i}$  is an  $\mathcal{F}_t$ -partition of  $\Omega$ , and  $\eta^{ij}$  are constants, such that  $\xi^i \to \eta, i \to \infty$ .

So  $\mathbb{L}_S(\Omega_{s,t})$  is dense in  $L^0(\Omega_t)$ , and  $\mathbb{L}_S(\Omega_{s,r,t})$  is dense in  $\mathbb{L}_S(\Omega_{s,t})$  as well as in  $L^0(\Omega_t)$ .

Hence for any  $\eta \in \mathbb{L}^1(\Omega_t)$ , there exists  $\eta^i \in \mathbb{L}_S(\Omega_{s,t})$  such that  $\eta^i \to \eta, i \to \infty$ . We define the conditional G-expectation of  $\eta$  as

$$\mathbb{E}_s[\eta] = \lim_{i \to \infty} \mathbb{E}_s[\eta^i]. \tag{2.1}$$

The conditional G-expectation  $\mathbb{E}_s[\cdot]: \mathbb{L}^1(\Omega_t) \to \mathbb{L}^1(\Omega_s)$  defined in (2.1) has the following properties.

**PROPOSITION 2.6.** For each  $X, Y \in \mathbb{L}^1(\Omega)$ ,

- (i) if  $X \geq Y$ , then  $\mathbb{E}_s[X] \geq \mathbb{E}_s[Y]$ .
- (ii)  $\mathbb{E}_s[\eta] = \eta$ , if  $\eta \in \mathbb{L}^1(\Omega_s)$ .
- (iii)  $\mathbb{E}_s[X] \mathbb{E}_s[Y] \le \mathbb{E}_s[X Y].$
- (iv)  $\mathbb{E}_s[\eta X] = \eta^+ \mathbb{E}_s[X] + \eta^- \mathbb{E}_s[-X]$  for each bounded  $\eta \in \mathbb{L}^1(\Omega_s)$ .
- (v)  $\mathbb{E}_s[\mathbb{E}_t[X]] = \mathbb{E}_{t \wedge s}[X]$ , in particular,  $\mathbb{E}[\mathbb{E}_s[X]] = \mathbb{E}[X]$ .

# 3 Itô's integral in $\mathbb{M}^2(0,T)$

For  $T \in \mathbb{R}^+$ , a partition  $\pi_T$  of [0,T] is a finite ordered subset  $\pi_T = \{t_0, t_1, \ldots, t_N\}$  such that  $0 = t_0 < t_1 < \ldots < t_N = T$ . Let  $\mu(\pi_T) := \max\{|t_{i+1} - t_i| : i = 0, 1, \ldots, N-1\}$ , and use  $\pi_T^N = \{t_0^N, t_1^N, \ldots, t_N^N\}$  to denote a sequence of partitions of [0,T] such that  $\lim_{N \to \infty} \mu(\pi_T^N) = 0$ .

Let  $p \geq 1$  be fixed. We consider the following type of simple processes: for a given partition  $\pi_T = \{t_0, t_1, \dots, t_N\}$  of [0, T] we set

$$\eta_t(\omega) = \sum_{k=0}^{N-1} \xi_k(\omega) \mathbf{I}_{[t_k, t_{k+1})}(t),$$

where  $\xi_k \in \mathbb{L}^p(\Omega_{t_k})$ ,  $k = 0, 1, 2, \dots, N-1$  are given. The collection of these processes is denoted by  $\mathbb{M}^{p,0}(0,T)$ .

**DEFINITION 3.1.** For each  $p \ge 1$ , we denote by  $\mathbb{M}^p(0,T)$  the completion of  $\mathbb{M}^{p,0}(0,T)$  under the norm

$$\parallel \eta \parallel_{\mathbb{M}^p(0,T)} := \left\{ \mathbb{E} \left[ \int_0^T |\eta_t|^p dt \right] \right\}^{\frac{1}{p}}.$$

It is clear that  $\mathbb{M}^p(0,T) \supset \mathbb{M}^q(0,T)$  for  $1 \leq p \leq q$ .

**DEFINITION 3.2.** For an  $\eta \in \mathbb{M}^{p,0}(0,T)$  with  $\eta_t(\omega) = \sum_{k=0}^{N-1} \xi_k(\omega) \mathbf{I}_{[t_k,t_{k+1})}(t)$ , the related Bochner integral is

$$\int_0^T \eta_t(\omega) dt := \sum_{k=0}^{N-1} \xi_k(\omega) (t_{k+1} - t_k).$$

For each  $\eta \in \mathbb{M}^{p,0}(0,T)$ , set

$$\widetilde{\mathbb{E}}_T[\eta] := \frac{1}{T} \mathbb{E}[\int_0^T \eta_t(\omega) dt].$$

 $\tilde{\mathbb{E}}_T : \mathbb{M}^{p,0}(0,T) \to \mathbb{R}$  forms a sublinear expectation, so under the natural norm  $\| \eta \|_{\mathbb{M}^p(0,T)}$ , the Bochner integral can be extended from  $\mathbb{M}^{p,0}(0,T)$  to  $\mathbb{M}^p(0,T)$ 

We now introduce the definition of Itô's integral. For simplicity, we first introduce Itô's integral with respect to 1-dimensional G-Brownian motion.

Let  $(B_t)_{t\geq 0}$  be a 1-dimensional G-Brownian motion with  $G(\alpha) = \frac{1}{2}(\bar{\sigma}^2\alpha^+ - \underline{\sigma}^2\alpha^-)$ , where  $0 \leq \underline{\sigma} \leq \bar{\sigma} < \infty$ .

**DEFINITION 3.3.** For each  $\eta \in \mathbb{M}^{2,0}(0,T)$  with  $\eta_t(\omega) = \sum_{k=0}^{N-1} \xi_k(\omega) \mathbf{I}_{[t_k,t_{k+1})}(t)$ , define

$$I(\eta) = \int_0^T \eta_t dB_t := \sum_{k=0}^{N-1} \xi_k (B_{t_{k+1}} - B_{t_k}).$$

**LEMMA 3.4.** The mapping  $I: \mathbb{M}^{2,0}(0,T) \to \mathbb{L}^2(\Omega_T)$  is a continuous linear mapping and thus can be continuously extended to  $I: \mathbb{M}^2(0,T) \to \mathbb{L}^2(\Omega_T)$ , and we have

$$\mathbb{E}\left[\int_0^T \eta_t dB_t\right] = 0,\tag{3.1}$$

$$\mathbb{E}\left[\left(\int_{0}^{T} \eta_t dB_t\right)^2\right] \le \bar{\sigma}^2 \mathbb{E}\left[\int_{0}^{T} \eta_t^2 dt\right]. \tag{3.2}$$

Proof. Notice that  $B_{t_{i+1}} - B_{t_i}$  is independent of  $\mathcal{F}_{t_i}$ , so for  $\xi_i \in \mathbb{L}^1(\Omega_{t_i})$ , we have

$$\mathbb{E}[\xi_i(B_{t_{i+1}} - B_{t_i})] = \mathbb{E}[-\xi_i(B_{t_{i+1}} - B_{t_i})] = 0, \tag{3.3}$$

and

$$\mathbb{E}[\xi_i^2(B_{t_{i+1}} - B_{t_i})^2 - \bar{\sigma}^2 \xi_i^2(t_{i+1} - t_i)] = \mathbb{E}[\mathbb{E}_t[\xi_i^2(B_{t_{i+1}} - B_{t_i})^2 - \bar{\sigma}^2 \xi_i^2(t_{i+1} - t_i)]] = 0. \quad (3.4)$$

Hence we get (3.1) and (3.2) by the same procedure as Peng [7].

**DEFINITION 3.5.** We define, for a fixed  $\eta \in \mathbb{M}^2(0,T)$ , the stochastic integral

$$\int_0^T \eta_t dB_t := I(\eta).$$

It is clear (3.1) and (3.2) still holds for  $\eta \in \mathbb{M}^2(0,T)$ .

The Itô's integral has the following properties,

**PROPOSITION 3.6.** Let  $\xi, \eta \in \mathbb{M}^2(0,T)$ , and let  $0 \le s \le r \le t \le T$ . Then we have

$$(i) \int_{s}^{t} \eta_{u} dB_{u} = \int_{s}^{r} \eta_{u} dB_{u} + \int_{r}^{t} \eta_{u} dB_{u}, q.s.,$$

$$(ii) \int_{s}^{t} (\alpha \eta_{u} + \theta_{u}) dB_{u} = \alpha \int_{s}^{t} \eta_{u} dB_{u} + \int_{s}^{t} \theta_{u} dB_{u}, \text{ if } \alpha \in \mathbb{L}^{2}(\Omega_{s}),$$

$$(iii) \mathbb{E}[X + \int_{s}^{T} \eta_{u} dB_{u} \mid \Omega_{s}] = \mathbb{E}[X \mid \Omega_{s}], \text{ for } X \in \mathbb{L}^{1}(\Omega).$$

For the multi-dimensional case. Let  $G(\cdot): \mathbb{S}(d) \to \mathbb{R}$  be a given monotonic and sublinear function and let  $(B_t)_{t\geq 0}$  be a d-dimensional G-Brownian motion. For each fixed  $a \in \mathbb{R}^d$ , we use  $B_t^a := \langle a, B_t \rangle$ . Then  $(B_t^a)_{t\geq 0}$  is a 1-dimensional  $G_a$ -Brownian motion with  $G_a(\alpha) = \frac{1}{2}(\sigma_{aa^T}^2\alpha^+ - \sigma_{-aa^T}^2\alpha^-)$ , where  $\sigma_{aa^T}^2 = 2G(aa^T)$  and  $\sigma_{-aa^T}^2 = -2G(-aa^T)$ . Similar to 1-dimensional case, we can define Itô's integral by

$$I(\eta) := \int_0^T \eta_t dB_t^a$$
, for  $\eta \in \mathbb{M}^2(0,T)$ .

and have (3.1), (3.2) and Proposition 3.6.

Let  $(\langle B \rangle_t)_{t \geq 0}$  be the quadratic variation process of 1-dimensional G-Brownian motion.

Define a mapping:

$$Q_{0,T}(\eta) = \int_0^T \eta_t d\langle B \rangle_t := \sum_{j=0}^{N-1} \xi_j (\langle B \rangle_{t_{j+1}} - \langle B \rangle_{t_j}) : \mathbb{M}^{1,0}(0,T) \to \mathbb{L}^1(\Omega_T).$$

We have the following lemma.

**LEMMA 3.7.** For each  $\eta \in \mathbb{M}^{1,0}(0,T)$ ,

$$\mathbb{E}[|Q_{0,T}(\eta)|] \le \bar{\sigma}^2 \mathbb{E}\left[\int_0^T |\eta_t| dt\right]. \tag{3.5}$$

Thus  $Q_{0,T}: \mathbb{M}^{1,0}(0,T) \to \mathbb{L}^1(\Omega_T)$  is a continuous linear mapping. Consequently,  $Q_{0,T}$  can be uniquely extended to  $\mathbb{M}^1(0,T)$ , and we have

$$\mathbb{E}[|\int_0^T \eta_t d\langle B \rangle_t|] \le \bar{\sigma}^2 \mathbb{E}[\int_0^T |\eta_t| dt], \forall \eta \in \mathbb{M}^1(0, T).$$
(3.6)

Proof. Notice that  $\mathbb{E}[|\xi_j|(\langle B\rangle_{t_{j+1}} - \langle B\rangle_{t_j}) - \bar{\sigma}^2|\xi_j|(t_{j+1} - t_j)] = 0$ . Then it is easy to check that (3.5) as well as (3.6)holds.

**PROPOSITION 3.8.** For any  $\eta \in \mathbb{M}^2(0,T)$ , we have

$$\mathbb{E}\left[\left(\int_0^t \eta_s dB_s\right)^2\right] = \mathbb{E}\left[\int_0^T \eta_s^2 d\langle B\rangle_s\right]. \tag{3.7}$$

Proof. For  $\eta \in \mathbb{M}^{2,0}(0,T)$ , it is easy to check that (3.7) holds. We can continuously extend the above equality to the case  $\eta \in \mathbb{M}^2(0,T)$  and get (3.7).

Similar to Li and Peng(2011), we can prove the following proposition.

**PROPOSITION 3.9.** For any  $\xi \in \mathbb{M}^1(0,T)$ ,  $\eta \in \mathbb{M}^2(0,T)$ , and  $0 \leq t \leq T$ ,  $\int_0^t \xi_s ds$ ,  $\int_0^t \eta_s dB_s$ , and  $\int_0^t \xi_s d\langle B \rangle_s$  are well defined processes which are continuous in t quasi-surely.

A stopping time  $\tau$  with respect to filtration  $(\mathcal{F}_t)$  is a mapping  $\tau: \Omega \to [0, T]$  such that for every t,  $\{\omega: \tau(\omega) \leq t\} \in \mathcal{F}_t$ .

**LEMMA 3.10.** For each stopping time  $\tau$  and  $\eta \in \mathbb{M}^p(0,T)$ , we have  $\mathbf{I}_{[0,\tau)}, \mathbf{I}_{[0,\tau)} \eta \in \mathbb{M}^p(0,T)$ .

Proof. For a given stopping time  $\tau$ , let

$$\tau_n = \sum_{k=1}^n t_k^n \mathbf{I}_{[t_{k-1}^n < \tau \le t_k^n)} + T \mathbf{I}_{[\tau > T]}.$$

Then

$$\begin{split} \mathbf{I}_{[\tau_{n},T)}(t) = & \mathbf{I}_{[\sum_{l=1}^{n} t_{l}^{n} \mathbf{I}_{[t_{l-1}^{n} < \tau \leq t_{l}^{n})} + T \mathbf{I}_{[\tau > T]},T)}(t) \\ = & \sum_{l=1}^{n} \mathbf{I}_{[t_{l}^{n},T)}(t) \mathbf{I}_{[t_{l-1}^{n} < \tau \leq t_{l}^{n})} \\ = & \sum_{l=1}^{n} \sum_{k=l}^{n-1} \mathbf{I}_{[t_{k}^{n},t_{k+1}^{n})}(t) \mathbf{I}_{[t_{l-1}^{n} < \tau \leq t_{l}^{n})} \\ = & \sum_{k=1}^{n-1} \left( \sum_{l=1}^{k} \mathbf{I}_{[t_{l-1}^{n} < \tau \leq t_{l}^{n})} \right) \mathbf{I}_{[t_{k}^{n},t_{k+1}^{n})}(t). \end{split}$$

Since  $\sum_{l=1}^k \mathbf{I}_{[t_{l-1}^n < \tau \le t_l^n)} \in \mathbb{L}^p(\Omega_{t_k^n})$ , we have  $\mathbf{I}_{[\tau_n,T)} \in \mathbb{M}^{p,0}(0,T)$ .

For any  $\eta \in \mathbb{M}^p(0,T)$ , there exists a sequence of simple processes  $\eta^i_t = \sum_k \xi^i_k \mathbf{I}_{[t^i_k,t^i_{k+1})}(t)$  with  $\xi^i_k \in \mathbb{L}^p(\Omega_{t^i_k})$  such that  $\eta^i \to \eta, i \to \infty$  in  $\mathbb{M}^p(0,T)$ . Obviously,  $\mathbf{I}_{[\tau_n,T)}\eta^i \in \mathbb{M}^{p,0}(0,T)$ .

It is easy to check that  $\mathbf{I}_{[\tau_n,T)}\eta^i \to \mathbf{I}_{[\tau_n,T)}\eta$ ,  $i \to \infty$  in  $\mathbb{M}^p(0,T)$ , which means that  $\mathbf{I}_{[\tau_n,T)}\eta \in \mathbb{M}^p(0,T)$ .

Now we prove  $\mathbf{I}_{[\tau_n,T)}\eta \to \mathbf{I}_{[\tau,T)}\eta$  in  $\mathbb{M}^p(0,T)$ . We have

$$\begin{split} & \mathbb{E}\left[\int_{0}^{T}|\mathbf{I}_{[\tau_{n},T)}(t)\eta_{t}-\mathbf{I}_{[\tau,T)}(t)\eta_{t}|^{p}dt\right] \\ \leq & C\mathbb{E}\left[\int_{0}^{T}|\mathbf{I}_{[\tau_{n},T)}(t)\eta_{t}-\mathbf{I}_{[\tau_{n},T)}(t)\eta_{t}^{i}|^{p}dt\right] + C\mathbb{E}\left[\int_{0}^{T}|\mathbf{I}_{[\tau_{n},T)}(t)\eta_{t}^{i}-\mathbf{I}_{[\tau,T)}(t)\eta_{t}^{i}|^{p}dt\right] \\ & + C\mathbb{E}\left[\int_{0}^{T}|\mathbf{I}_{[\tau,T)}(t)\eta_{t}^{i}-\mathbf{I}_{[\tau,T)}(t)\eta_{t}|^{p}dt\right]. \end{split}$$

Since  $\eta^i \to \eta, i \to \infty$  in  $\mathbb{M}^p(0,T)$ , for any  $\epsilon > 0$ , there exists I such that when  $i \geq I$ ,  $\mathbb{E}\left[\int_0^T |\eta_t^i - \eta_t|^p dt\right] < \frac{\epsilon}{3}$ . Hence for some fixed  $i \geq I$ , we have

$$C\mathbb{E}\left[\int_0^T |\mathbf{I}_{[\tau_n,T)}(t)\eta_t - \mathbf{I}_{[\tau_n,T)}(t)\eta_t^i|^p dt\right] < \frac{\epsilon}{3},$$

$$C\mathbb{E}\left[\int_0^T |\mathbf{I}_{[\tau,T)}(t)\eta_t^i - \mathbf{I}_{[\tau,T)}(t)\eta_t|^p dt\right] < \frac{\epsilon}{3},$$

and

$$C\mathbb{E}\left[\int_0^T |\mathbf{I}_{[\tau_n,T)}(t)\eta_t^i - \mathbf{I}_{[\tau,T)}(t)\eta_t^i|^p dt\right] \leq \sum_k |\xi_k^i|^p \mu(\pi_T^n) < \frac{\epsilon}{3}, \text{ for some fixed } i \geq I \text{ and n large enough }.$$

So  $\mathbf{I}_{[\tau_n,T)}\eta \to \mathbf{I}_{[\tau,T)}\eta$  in  $\mathbb{M}^p(0,T)$ , which means  $\mathbf{I}_{[\tau,T)}\eta \in \mathbb{M}^p(0,T)$ , and consequently  $\mathbf{I}_{[0,\tau_n)}\eta \to \mathbf{I}_{[0,\tau)}\eta$  in  $\mathbb{M}^p(0,T)$ . As a special case,  $\mathbf{I}_{[0,\tau)} \in \mathbb{M}^p(0,T)$ .

By lemma 3.10, the integral  $\int_0^t \mathbf{I}_{[0,\tau]}(s) dB_s$  and  $\int_0^t \mathbf{I}_{[0,\tau]}(s) \eta_s dB_s$  for  $\eta \in \mathbb{M}^2(0,T)$  is well defined.

**LEMMA 3.11.** For each stopping time  $\tau$  and  $\eta \in \mathbb{M}^p(0,T)$ , we have

$$\int_0^{t\wedge\tau} \eta_s dB_s = \int_0^t \mathbf{I}_{[0,\tau)} \eta_s dB_s, q.s. \tag{3.8}$$

Proof. Let

$$\tau_n = \sum_{k=1}^n t_k^n \mathbf{I}_{[t_{k-1}^n < \tau \le t_k^n)} + T \mathbf{I}_{[\tau > T]} = \sum_{k=1}^n \mathbf{I}_{A_n^{k-1}} t_k^n,$$

with  $A_n^{k-1}=[t_{k-1}^n< au\leq t_k^n),$  and  $A_n^n=[ au>T].$ 

For any  $\eta \in \mathbb{M}^p(0,T)$ , we have

$$\int_0^{\tau_n} \eta_s dB_s = \int_0^{\sum_{k=1}^n \mathbf{I}_{A_n^{k-1}} t_k^n} \eta_s dB_s = \sum_{k=1}^n \mathbf{I}_{A_n^{k-1}} \int_0^{t_k^n} \eta_s dB_s = \int_0^t \sum_{k=1}^n \mathbf{I}_{[0,t_k^n)}(s) \mathbf{I}_{A_n^{k-1}} \eta_s dB_s.$$

Thus we have

$$\int_{0}^{\tau_{n}} \eta_{s} dB_{s} = \int_{0}^{t} \mathbf{I}_{[0,\tau_{n})}(s) \eta_{s} dB_{s}, \tag{3.9}$$

and

$$\int_{\tau_n}^{t \wedge \tau} \eta_s dB_s = \int_0^t \mathbf{I}_{[\tau_n, t \wedge \tau)}(s) \eta_s dB_s \to 0,$$

by the continuity of  $\int_0^t \eta_s dB_s$ . Hence

$$\lim_{n \to \infty} \int_0^{\tau_n} \eta_s dB_s = \int_0^{t \wedge \tau} \eta_s dB_s - \lim_{n \to \infty} \int_{\tau_n}^{t \wedge \tau} \mathbf{I}_{[0, t \wedge \tau)}(s) \eta_s dB_s \to \int_0^{t \wedge \tau} \eta_s dB_s. \tag{3.10}$$

By the proof of lemma 3.8,  $\mathbf{I}_{[0,\tau_n)}\eta \to \mathbf{I}_{[0,\tau)}\eta, n \to \infty$ , in  $\mathbb{M}^p(0,T)$ , so we have

$$\int_0^t \mathbf{I}_{[0,\tau_n)}(s) \eta_s dB_s \to \int_0^t \mathbf{I}_{[0,\tau)}(s) \eta_s dB_s, \text{ in } \mathbb{L}^2(\Omega_t).$$

By Denis, Hu and Peng(2011) proposition 17, there exists a subsequence  $\int_0^t \mathbf{I}_{[0,\tau_{n_k}]}(s) \eta_s dB_s$  such that

$$\int_0^t \mathbf{I}_{[0,\tau_{n_k})}(s) \eta_s dB_s \to \int_0^t \mathbf{I}_{[0,\tau)}(s) \eta_s dB_s, q.s., \text{ as } k \to \infty,.$$

$$(3.11)$$

From (3.9), (3.10), and (3.11), (3.8) holds.

**LEMMA 3.12.** For  $\eta \in \mathbb{M}^2(s,t)$  with s < t, we have

$$\mathbb{E}_s[|\int_s^t \eta_u du|^2] \le (t-s)\mathbb{E}_s[\int_s^t \eta_u^2 du],\tag{3.12}$$

$$\mathbb{E}_s[|\int_s^t \eta_u d\langle B \rangle_u|^2] \le \bar{\sigma}^4(t-s)\mathbb{E}_s[\int_s^t \eta_u^2 du]. \tag{3.13}$$

Proof. For each fixed  $\omega \in \Omega$ ,  $\eta_u(\omega)$  is a measurable function on [s,t]. By lemma 2.3,  $\int_s^t \eta_u^2 du < \infty$ , q.s.. So for fixed  $\omega \in \Omega$  such that  $\int_s^t \eta_u^2(\omega) du < \infty$ , we have

$$\left| \int_{s}^{t} \eta_{u}(\omega) du \right|^{2} \le \left( \int_{s}^{t} |\eta_{u}(\omega)| du \right)^{2} \le (t - s) \int_{s}^{t} |\eta_{u}(\omega)|^{2} du. \tag{3.14}$$

Then we have

$$\mathbb{E}_s[|\int_s^t \eta_u dt|^2] \le (t-s)\mathbb{E}_s[\int_s^t |\eta_u|^2 dt]. \tag{3.15}$$

Now we prove (3.13). For  $\eta_u^n = \sum_{i=0}^{n-1} \eta_{t_i}^n \mathbf{I}_{[t_i, t_{i+1}]}(t) \in \mathbb{M}^{2,0}(0, T)$ ,

$$\mathbb{E}_{s}\left[\left|\int_{s}^{t} \eta_{u}^{n} d\langle B \rangle_{u}\right|^{2}\right] \\
= \mathbb{E}_{s}\left[\left|\sum_{i=0}^{n-1} \eta_{t_{i}}^{n} (\langle B \rangle_{t_{i+1}} - \langle B \rangle_{t_{i}})\right|^{2}\right] \\
= \mathbb{E}_{s}\left[\sum_{i,j=0}^{n-1} |\eta_{t_{i}}^{n} \eta_{t_{j}}^{n}| (\langle B \rangle_{t_{i+1}} - \langle B \rangle_{t_{i}}) (\langle B \rangle_{t_{j+1}} - \langle B \rangle_{t_{j}})\right] \\
\leq \bar{\sigma}^{4} \mathbb{E}_{s}\left[\sum_{i,j=0}^{n-1} |\eta_{t_{i}}^{n} \eta_{t_{j}}^{n}| (t_{i+1} - t_{i}) (t_{j+1} - t_{j})\right] \\
= \bar{\sigma}^{4} \mathbb{E}_{s}\left[\left(\int_{s}^{t} \eta_{u}^{n} dt\right)^{2}\right] \\
\leq \bar{\sigma}^{4} (t - s) \mathbb{E}_{s}\left[\int_{s}^{t} |\eta_{u}^{n}|^{2} dt\right]. \tag{3.16}$$

Thus (3.13) holds for  $\eta^n \in \mathbb{M}^{2,0}(0,T)$ . We can continuously extend the above equality to the case  $\eta \in \mathbb{M}^2(0,T)$  and get (3.13).

### 4 Itô's Formula

**LEMMA 4.1.** Let  $\varphi \in C^{1,2}([0,T] \times \mathbb{R}^n)$  with  $\partial_t \varphi, \partial_{x^{\nu}} \varphi, \partial_{x^{\mu} x^{\nu}}^2 \varphi \in C_{b,L_{ip}}([0,T] \times \mathbb{R}^n)$  for  $\mu, \nu = 1, \ldots, n$ . Let  $s \in [0,T]$  be fixed and  $X = (X^1, \ldots, X^n)^T$  be an n-dimensional process on [s,T] of the form

$$X_t^{\nu} = X_s^{\nu} + \alpha^{\nu}(t-s) + \eta^{\nu ij}(\langle B^i, B^j \rangle_t - \langle B^i, B^j \rangle_s) + \beta^{\nu j}(B_t^j - B_s^j),$$

where for  $\nu = 1, ..., n$ , i, j = 1, ..., d,  $\alpha^{\nu}, \eta^{\nu i j} \in \mathbb{L}^4(\Omega_s)$ ,  $\beta^{\nu j} \in \mathbb{L}^8(\Omega_s)$  and  $X_s = (X_s^1, ..., X_s^n)^T$  is a given random vector in  $\mathbb{L}^2(\Omega_s)$ . Then for each  $t \geq s$ , we have, in  $\mathbb{L}^2(\Omega_t)$ ,

$$\varphi(t, X_t) - \varphi(s, X_s) = \int_s^t [\partial_t \varphi(u, X_u) + \partial_{x^{\nu}} \varphi(u, X_u) \alpha^{\nu}] du + \int_s^t \partial_{x^{\nu}} \varphi(u, X_u) \beta^{\nu j} dB_u^j$$

$$+ \int_s^t [\partial_{x^{\nu}} \varphi(u, X_u) \eta^{\nu i j} + \frac{1}{2} \partial_{x^{\mu} x^{\nu}}^2 \varphi(u, X_u) \beta^{\mu i} \beta^{\nu j}] d\langle B^i, B^j \rangle_u.$$

$$(4.1)$$

Here we use the above repeated indices  $\mu, \nu, i$  and j imply the summation.

Proof. For each positive integer N, we set  $\delta_N = (t - s)/N$  and take the partition

where C is a constant independent of k.

$$\mathbb{E} \int_{s}^{T} |X_{t} - X_{t}^{m}|^{4} dt \leq C \int_{s}^{T} \mathbb{E} [\sup_{s < t < T} |X_{t} - X_{t}^{m}|^{4}] dt \to 0.$$

Then

$$\begin{split} & \mathbb{E}[\int_{0}^{T} |\partial_{x^{\nu}}\varphi(u,X_{u}^{m})\alpha_{u}^{m,\nu} - \partial_{x^{\nu}}\varphi(u,X_{u})\alpha_{u}^{\nu}|^{2}du] \\ \leq & 2\{\mathbb{E}[\int_{0}^{T} (\partial_{x^{\nu}}\varphi(u,X_{u}^{m}) - \partial_{x^{\nu}}\varphi(u,X_{u}))^{2} |\alpha_{u}^{m,\nu}|^{2}du] + \mathbb{E}[\int_{0}^{T} (\partial_{x^{\nu}}\varphi(u,X_{u}))^{2} |\alpha_{u}^{m,\nu} - \alpha_{u}|^{2}du]\}\} \\ \leq & 2C\{\mathbb{E}[\int_{0}^{T} |X_{u}^{m} - X_{u}|^{2} |\alpha_{u}^{m,\nu}|^{2}du + \mathbb{E}[\int_{0}^{T} |\alpha_{u}^{m,\nu} - \alpha_{u}^{\nu}|^{2}du]\} \\ \leq & 2C\{\mathbb{E}[\int_{0}^{T} |X_{u}^{m} - X_{u}|^{4}du]\mathbb{E}[\int_{0}^{T} |\alpha_{u}^{m,\nu}|^{4}du]\}^{\frac{1}{2}} + C\mathbb{E}[\int_{0}^{T} |\alpha_{u}^{m,\nu} - \alpha_{u}^{\nu}|^{2}du] \\ \to & 0, \end{split}$$

where C is a constant. Then we have proved  $\partial_{x^{\nu}}\varphi(\cdot,X_{\cdot}^{m})\alpha_{\cdot}^{m,\nu} \to \partial_{x^{\nu}}\varphi(\cdot,X_{\cdot})\alpha_{\cdot}^{\nu}$  in  $\mathbb{M}^{2}(0,T)$ . Similarly, we can prove that in  $\mathbb{M}^{2}(0,T)$ ,

$$\begin{split} &\partial_{\cdot}\varphi(\cdot,X_{\cdot}^{m})\rightarrow\partial_{\cdot}\varphi(\cdot,X_{\cdot}),\\ &\partial_{x^{\nu}}\varphi(\cdot,X_{\cdot}^{m})\eta_{\cdot}^{m,\nu ij}\rightarrow\partial_{x^{\nu}}\varphi(\cdot,X_{\cdot})\eta_{\cdot}^{\nu ij},\\ &\partial_{x^{\nu}}\varphi(\cdot,X_{\cdot}^{m})\beta_{\cdot}^{m,\nu j}\rightarrow\partial_{x^{\nu}}\varphi(\cdot,X_{\cdot})\beta_{\cdot}^{\nu j},\\ &\partial_{x^{\mu}x^{\nu}}\varphi(\cdot,X_{\cdot}^{m})\beta_{\cdot}^{m,\mu i}\beta_{\cdot}^{m,\nu j}\rightarrow\partial_{x^{\mu}x^{\nu}}\varphi(\cdot,X_{\cdot})\beta_{\cdot}^{\mu i}\beta_{\cdot}^{\nu,j}. \end{split}$$

We then pass to limit as  $m \to \infty$  in both sides of (4.9) to get (4.8).

**LEMMA 4.3.** Let  $\varphi \in C^{1,2}([0,T] \times \mathbb{R}^n)$  such that  $\varphi, \partial_t \varphi, \partial_{x^{\mu}} \varphi, \partial_{xx}^2 \varphi$  are bounded and uniformly continuous on  $[0,T] \times \mathbb{R}^n$ . Let  $X = (X^1, \dots, X^n)$  and

$$X_t = X_s + \int_s^t \alpha_u^{\nu} du + \int_s^t \eta_u^{\nu ij} d\langle B^i, B^j \rangle_u + \int_s^t \beta_u^{\nu j} dB_u^j,$$

where  $\alpha^{\nu}$ ,  $\eta^{\nu ij} \in \mathbb{M}^4(0,T)$  and  $\beta^{\nu j} \in \mathbb{M}^8(0,T)$ . Then for each  $t \geq s$ , we have, in  $\mathbb{L}^2(\Omega_t)$ ,

$$\varphi(t, X_t) - \varphi(s, X_s) = \int_0^t \left[ \partial_t \varphi(u, X_u) + \partial_{x^{\nu}} \varphi(u, X_u) \alpha_u^{\nu i j} \right] du + \int_0^t \partial_{x^{\nu}} \varphi(u, X_u) \beta_u^{\nu j} dB_u^j$$

$$+ \int_0^t \left[ \partial_{x^{\nu}} \varphi(u, X_u) \eta_u^{\nu i j} + \frac{1}{2} \partial_{x^{\mu} x^{\nu}}^2 \varphi(u, X_u) \beta_u^{\mu i} \beta_u^{\nu j} \right] d\langle B^i, B^j \rangle_u.$$

$$(4.10)$$

Proof. We take  $\{\varphi_m\}_{m=1}^{\infty}$  such that, for each m,  $\varphi_m$  and all its first order and second order derivatives are in  $C_{b,L_{ip}}([0,T]\times\mathbb{R}^n)$  and such that, as  $m\to\infty$ ,  $\varphi_m$ ,  $\partial_t\varphi_m$ ,  $\partial_{x^{\nu}}\varphi_m$ , and  $\partial_{x^{\mu}x^{\nu}}^2\varphi_m$  converge respectively to  $\varphi$ ,  $\partial_t\varphi$ ,  $\partial_x^2\varphi$ , and  $\partial_{x^{\mu}x^{\nu}}^2\varphi$  uniformly on  $[0,T]\times\mathbb{R}^n$ . We then use the Itô's formula (4.8) to  $\varphi_m(t,X_t)$ , i.e.,

$$\varphi_{m}(t,X_{t}) - \varphi_{m}(s,X_{s}) = \int_{0}^{t} [\partial_{t}\varphi_{m}(u,X_{u}) + \partial^{x^{\nu}}\varphi_{m}(u,X_{u})\alpha_{u}^{\nu ij}]du + \int_{0}^{t} \partial_{x^{\nu}}\varphi_{m}(u,X_{u})\beta_{u}^{\nu j}dB_{u}^{j} + \int_{0}^{t} [\partial_{x^{\nu}}\varphi_{m}(u,X_{u})\eta_{u}^{\nu ij} + \frac{1}{2}\partial_{x^{\mu}x^{\nu}}^{2}\varphi_{m}(u,X_{u})\beta_{u}^{\mu i}\beta_{u}^{\nu j}d\langle B^{i},B^{j}\rangle_{u}.$$

Passing to the limit as  $m \to \infty$ , we get (4.10).

**THEOREM 4.4.** Let  $\varphi \in C^{1,2}([0,T] \times \mathbb{R}^n)$  and  $X = (X^1, \dots, X^n)$  with

$$X_t = X_0 + \int_0^t \alpha_u^{\nu} du + \int_0^t \eta_u^{\nu ij} d\langle B^i, B^j \rangle_u + \int_0^t \beta_u^{\nu j} dB_u^j,$$

where  $\alpha^{\nu}$ ,  $\eta^{\nu ij} \in \mathbb{M}^4(0,T)$  and  $\beta^{\nu j} \in \mathbb{M}^8(0,T)$ . Then for each  $t \geq s$ , we have, in  $\mathbb{L}^2(\Omega_t)$ ,

$$\varphi(t, X_t) - \varphi(s, X_s) = \int_0^t \left[ \partial_t \varphi(u, X_u) + \partial_{x^{\nu}} \varphi(u, X_u) \alpha_u^{\nu i j} \right] du + \int_0^t \partial_{x^{\nu}} \varphi(u, X_u) \beta_u^{\nu j} dB_u^j 
+ \int_0^t \left[ \partial_{x^{\nu}} \varphi(u, X_u) \eta_u^{\nu i j} + \frac{1}{2} \partial_{x^{\mu} x^{\nu}}^2 \varphi(u, X_u) \beta_u^{\mu i} \beta_u^{\nu j} \right] d\langle B^i, B^j \rangle_u.$$
(4.11)

Proof. For simplicity, we only prove the case of n = d = 1. We set

$$\gamma_t = |X_t| + \int_0^t (|\beta_u|^8 + |\beta_u|^4 + |\beta_u|^4) du,$$

and for  $k = 1, 2, ..., \tau_k = \inf\{t \geq 0; \gamma_t \geq k\}$ . Let  $\varphi_k \in C^{1,2}([0,T] \times \mathbb{R}^n)$ , such that  $\partial_t \varphi_k, \partial_{x^{\mu} x^{\nu}} \varphi_k$  are bounded and uniformly continuous and  $\varphi_k = \varphi$ , for  $|x| \leq 2k$  and  $t \in [0,T]$ . By lemma 3.10,  $\mathbf{I}_{[0,\tau_k]} \alpha, \mathbf{I}_{[0,\tau_k]} \eta, \mathbf{I}_{[0,\tau_k]} \beta \in \mathbb{M}^2(0,T)$ , so we have

$$X_{t \wedge \tau_k} = X_0 + \int_0^t \mathbf{I}_{[0,\tau_k]} \alpha_u du + \int_0^t \mathbf{I}_{[0,\tau_k]} \eta_u d\langle B^i, B^j \rangle_u + \int_0^t \mathbf{I}_{[0,\tau_k]} \beta_u dB_u^j,$$

Then we can apply the Itô's formula (4.10) to  $\varphi_k(t, X_{t \wedge \tau_k})$  to obtain

$$\varphi_{k}(t, X_{t \wedge \tau_{k}}) - \varphi_{k}(s, X_{s}) = \int_{0}^{t} [\partial_{t} \varphi_{k}(u, X_{u}) + \partial_{x} \varphi_{k}(u, X_{u}) \alpha_{u}] \mathbf{I}_{[0, \tau_{k}]} du 
+ \int_{0}^{t} \partial_{x} \varphi_{k}(u, X_{u}) \beta_{u} \mathbf{I}_{[0, \tau_{k}]} dB_{u}^{j} 
+ \int_{0}^{t} [\partial_{x} \varphi_{k}(u, X_{u}) \eta_{u} + \frac{1}{2} \partial_{xx}^{2} \varphi_{k}(u, X_{u}) \beta_{u}^{2}] \mathbf{I}_{[0, \tau_{k}]} d\langle B^{i}, B^{j} \rangle_{u}.$$

Passing to the limit as  $k \to \infty$ , we get (4.11).
