# Characterizations of 2-Colorable (Bipartite) and 3-Colorable Graphs

#### Abstract

A directional labeling of an edge $u v$ in a graph $G=(V, E)$ by an ordered pair $a b$ is a labeling of the edge $u v$ such that the label on $u v$ in the direction from $u$ to $v$ is $\ell(u v)=a b$, and $\ell(v u)=b a$. New characterizations of 2-colorable (bipartite) and 3-colorable graphs are obtained in terms of directional labeling of edges of a graph by ordered pairs $a b$ and $b a$. In addition we obtain characterizations of 2 -colorable and 3-colorable graphs in terms of matrices called directional adjacency matrices.


Keywords: Uniform directional labeling, uniform adjacency and uniform adjacency matrix.

## 1 Introduction

For any definition on graphs we refer the book [1].
An edge $u v$ in a graph $G=(V, E)$ is directionally labeled by an ordered pair $a b$ if the label $\ell(u v)$ on $u v$ is $a b$ in the direction from $u$ to $v$, and $\ell(v u)=b a$. Let $u u_{i}, 1 \leq i \leq k$, be the edges at a vertex $u$ in $G$. If $\ell\left(u u_{i}\right)=a b$ for $1 \leq i \leq k$, we say that the labelings of the edges at $u$ is directionally uniform, and we denote this fact by $\ell_{e}(u)=a b$.

Definition 1. A graph $G=(V, E)$ admits a directionally uniform edge labeling by ordered pairs $a b$ and $b a$ if for any two adjacent vertices $v_{1}$ and $v_{2}$ in $G, \ell_{e}\left(v_{1}\right)=a b \Longleftrightarrow \ell_{e}\left(v_{2}\right)=b a$.

For example, the graphs in Figure 1 admit such edge labelings.
One can easily verify that an odd cycle does not admit such an edge labeling.
A graph $G=(V, E)$ is bipartite if $V$ can be partitioned into two sets $V_{1}$ and $V_{2}$ such that every edge in $G$ joins a vertex in $V_{1}$ and a vertex in $V_{2}$.

The following is a new characterization of bipartite graphs.
Theorem 1. For a graph $G=(V, E)$ the following statements are equivalent.
(i) $G$ is bipartite.
(ii) $G$ admits a uniform directional labeling of its edges by ordered pairs ab and $b a$.

Proof. (i) $\Rightarrow$ (ii). Since $G$ is bipartite, there exists a partition $V=V_{1} \cup V_{2}$ of $V$ such that every edge in $G$ joins a vertex of $V_{1}$ and a vertex of $V_{2}$. Directionally label all its edges going from $V_{1}$ to $V_{2}$ by the ordered pair $a b$. Then for any edge $u v$ going from $V_{1}$ to $V_{2}, \ell_{e}(u)=a b$ and $\ell_{e}(v)=b a$. This implies that $G$ admits a directional labeling of its edges by the ordered pairs $a b$ and $b a$.
(ii) $\Rightarrow$ (i). Suppose there exists such a labeling of the edges of $G$ by ordered pairs $a b$ and $b a$. Let $V_{1}=\left\{u \in V: \ell_{e}(u)=a b\right\}$, and $V_{2}=\left\{v \in V: \ell_{e}(v)=\right.$ $b a\}$. Since for an two adjacent vertices $v_{1}$ and $v_{2}, \ell_{e}\left(v_{1}\right) \neq \ell_{e}\left(v_{2}\right)$, it follows that $V_{1}$ as well as $V_{2}$ are independent, and every edge in $G$ joins a vertex of $V_{1}$ and a vertex of $V_{2}$. Hence, $G$ is bipartite.

## 2 (1,2)-Uniform directional labeling of the edges of a graph by ordered pairs $a b$ and $b a$

2-uniform directional labeling of the edges incident at a vertex.

Let $v v_{i}, 1 \leq i \leq k$ be the edges incident to a vertex $v$ in a graph $G=(V, E)$.

If for some edges $v v_{i}, 1 \leq i \leq k, \ell\left(v v_{j}\right)=a b$, and some other edges $v v_{j}, 1 \leq j \leq k, \ell\left(v v_{j}\right)=b a$, we say that the directional labeling of the edges at $v$ by the ordered pairs $a b$ and $b a$ is 2 -uniform. We denote this fact by $\ell_{e}(v)=\{a b, b a\}$.

Definition 2. A graph $G=(V, E)$ admits a (1,2)-uniform directional labeling of its edges by ordered pairs $a b$ and $b a$ if for any two adjacent vertices $v_{1}$ and $v_{2}$ one of the following holds:
(i) $\ell_{e}\left(v_{1}\right)=a b, \ell_{e}\left(v_{2}\right)=b a$
(ii) $\ell_{e}\left(v_{1}\right)=a b, \ell_{e}\left(v_{2}\right)=\{a b, b a\}$
(iii) $\ell_{e}\left(v_{1}\right)=b a, \ell_{e}\left(v_{2}\right)=\{a b, b a\}$.

## 3 3-Colorable Graphs

A graph $G=(V, E)$ is 3 -colorable if we can color its vertices with 3 colors such that no two adjacent vertices receive the same color, and this is not possible with 2-colors.

The following is a characterization of 3 -colorable graphs.

Theorem 2. For a graph $G=(V, E)$ the following statements are equivalent.
(i) $G$ is 3-colorable.
(ii) $G$ admits a (1,2)-uniform directional edge labeling by ordered pairs ab and $b a$.

Proof. $(i) \Rightarrow(i i)$. Suppose $G$ is 3 -colorable. Then we can partition $V=$ $V_{1} \cup V_{2} \cup V_{3}$ into three independent sets, where say, vertices in $V_{i}, 1 \leq i \leq 3$ are colored $i, 1 \leq i \leq 3$. Without loss of generality, we can assume that every vertex in $V_{3}$ has degree at least 2. For, suppose for a vertex $v$ in $V_{3}$, $d e g v=1$, and $v v_{i}$ is an edge, and $v_{i}$ is colored $i, 1 \leq i \leq 2$. Then we can recolor $v$ with 1 or 2 according as $v_{i}$ is colored 2 or 1 . This implies that we can shift $v$ to $V_{1}$ or $V_{2}$.
First, label all the edges going out of $V_{1}$ directionally by $a b$. Then all the edges going out from $V_{2}$ to $V_{1}$ are directionally labeled by $b a$. Now, label all the unlabeled edges going out from $V_{2}$ to $V_{3}$ by $b a$. We find that for any $u \in V_{1}, v \in V_{2}$ and $w \in V_{3}, \ell_{e}(u)=a b, \ell_{e}(v)=b a, \ell_{e}(w)=\{a b, b a\}$. This implies (ii).
(ii) $\Rightarrow$ (i). Suppose (ii) holds. Let $V_{1}=\left\{u: \ell_{e}(u)=a b\right\}, V_{2}=\left\{v: \ell_{e}(v)=\right.$ $b a\}, V_{3}=\left\{w: \ell_{e}(w)=a b, b a\right\}$. Since for any two adjacent vertices $v_{1}$ and $v_{2}, \ell_{e}\left(v_{1}\right) \neq \ell_{e}\left(v_{2}\right)$, we see that the sets $V_{1}, V_{2}$ and $V_{3}$ are independent, and hence $G$ is 3-colorable.

## 4 Directional adjacency

The directional labeling of an edge in a graph by an ordered pair $a b$ can also be considered as directional adjacency as follows.

Let $G=(V, E)$ be a graph and $u v$ be an edge in $G$. Sometimes it may be necessary to distinguish the adjacency between $u$ and $v$ in the directions from $u$ to $v$ and from $v$ to $u$. For example, we can consider the adjacency from $u$ to $v$ as positive, and that from $v$ to $u$ as negative. This is denoted by $d a(u v)=1$, and $d a(v u)=-1$.

Suppose

- $A, B$ are two persons,
(a) $A$ is talking to $B$.
(b) $A$ is a boss and $B$ is a subordinate of $A$.
- $A, B$ are nodes in an electrical network, and current is flowing from $A$ to $B$.
- $A$ is a transmitter and $B$ is a receiver.

In all the above cases, we can consider the adjacency from $A$ to $B$ as positive and that from $B$ to $A$ as negative.

## 5 Uniform directional adjacency(u.d.adjacency)

As in the case of uniform directional labeling of edges at a vertex, we define u.d.adjacency at a vertex as follows.

Let $u u_{i}, 1 \leq i \leq k$ be edges at a vertex $u$ in $G$. We say that directional adjacency is uniform at $u$ if $d a\left(u u_{i}\right)=1$ or -1 , for $1 \leq i \leq k$.

If the directional adjacency is uniform at $u$, we denote this fact by $d a(u)=1$ or $d a(u)=-1$, accordingly.

A graph $G$ is said to have u.d.adjacency if it has such an adjacency at each of its vertices.

One can easily verify the following:

Proposition 3. A graph $G$ has u.d.adjacency if, and only if, for any two adjacent vertices $u$ and $v d a(u)=1 \Longleftrightarrow d a(v)=-1$. Note that not all graphs have u.d.adjacency.

For example, consider $K_{3}$ in Figure 3.

Suppose it has u.d.adjacency. Then say $d a\left(v_{1}\right)=1$. This implies $d a\left(v_{2}\right)=-1, d a\left(v_{3}\right)=1$ and $d a\left(v_{1}\right)=-1$, which is a contradiction.

## 6 Directional Adjacency Matrix of a Graph

Let $G=(V, E)$ be graph of order $p$, and $V=\left\{v_{1}, v_{2}, \ldots, v_{p}\right\}$. A directional adjacency matrix (d.a.matrix) $M=\left[a_{i j}\right]$ of $G$ is a matrix of order $p$ whose entries $a_{i j}$ are defined as follows: For any two vertices $v_{i}, v_{j}$ in $G$.

If $v_{i} v_{j}$ is an edge then $a_{i j}=1$ or -1 . If $v_{i} v_{j}$ is an edge, then the directional adjacency from $v_{i}$ to $v_{j}$ is said to be positive or negative according as $a_{i j}=1$ or -1 . The directional adjacency between $v_{i}$ and $v_{j}$ is symmetric if $a_{i j}=a_{j i}=1$ or -1 . Further, the directional adjacency between $v_{i}$ and $v_{j}$ is antisymmetric if $a_{i j}=1 \Longleftrightarrow a_{j i}=-1$. If $v_{i}, v_{j}$ are not adjacent $a_{i j}=0$.
Let $v_{i} v_{1}, v_{i} v_{2}, \ldots, v_{i} v_{k}$ be the edges at a vertex $v_{i}$. Then the directional adjacency at a vertex $v_{i}$ is said to be uniform if $a_{i i_{1}}=a_{i i_{2}}=\ldots=a_{i i_{k}}=1$ or -1 . Note that the directional adjacency at $v_{i}$ is uniform if, and only if, all the non zero entries in the $i^{\text {th }}$ row of the d.a.matrix $M$ are either 1 or -1 .
For example, the d.a. matrix $M$ of the tree $T$ in Figure 4 is the uniform d.a.matrix of $T$.

We can now restate the Proposition 4 as follows involving uniform d.a.matrix.

Proposition 4. For a graph $G$ the following statements are equivalent.
(i) $G$ is bipartite.
(ii)G has a uniform d.a. matrix.

## 7 (1,2)-Uniform Directional adjacency Matrix of a Graph

Let $V=\left\{v_{1}, v_{2}, \ldots, v_{p}\right\}$ be the vertex set of a graph $G=(V, E)$, and $M=\left[a_{i j}\right]$ be a directional adjacency matrix of $G$.

If all nonzero entries in the $i^{\text {th }}$ row of $M$ are 1 or -1 , we indicate this by $r_{M}(i)=1$ or -1 accordingly. It may happen that in an $i^{t h}$ row, the nonzero entries may contain both 1 and -1 . In this case we denote this fact by $r_{M}(i)=\{1,-1\}$. A d.a.matrix $M=\left[a_{i j}\right]$ of $G$ is called (1,2)-uniform if for any two adjacent vertices $v_{i}$ and $v_{j}$, one of the following holds:
(i) $r_{M}(i)=1, r_{M}(j)=-1$
(ii) $r_{M}(i)=1, r_{M}(j)=\{1,-1\}$
(iii) $r_{M}(i)=-1, r_{M}(j)=\{1,-1\}$.

For example, the d.a.matrix of $K_{3}$ and the graph $G$ in Figure 5 are (1,2)uniform.

Note:If $M$ is a $(1,2)$-uniform directional adjacency matrix of a graph $G$, then for any two adjacent vertices $v_{i}$ and $v_{j}, r_{M}(i) \neq r_{M}(j)$. One can restate Proposition 5 as follows involving (1,2)-uniform d.a.matrix.

Proposition 5. For a graph $G$ the following statements are equivalent.
(i) $G$ is 3-colorable.
(ii) $G$ has a (1,2)-uniform d.a.matrix.
