# Symbol calculus on a projective space

#### Abstract

In this article, we introduce symbol calculus on a projective scheme. Using holomorphic Poisson structures, we construct deformations of ring structures for structure sheaves on projective spaces $\mathbb{C P}^{n}$ 's. ## 1 Introduction

The terminology "symbol calculus" is used in Fourier analysis and pseudo-differential operator in order to study partial differential equations. Especially, symbol calculus of pseudo-differential operator with respect to elliptic operator gives fruitful contribution to the index theorem, i.e. an important role is played by pseudo-differential operator in the index theory for elliptic operators appearing geometry, where pseudo-differential operators are used to extend the class of possible deformation of an elliptic operator which has essential topological datas of the base manifold.

In this article, using holomorphic Poisson structures, we consider symbol calculus on a projective scheme. Especially, we give concrete examples using $\mathbb{C P}^{n}$. As mentioned above, structure sheaves on algebraic varieties have important and essential feature which plays crucial role to analyze their fundamental properties with respect to the base varieties. Using a holomorphic Poisson structure on the base variety, we construct symbol calculus on the structure sheaf. We here state the main theorems of the present article.

Theorem 1.1 Assume that $Z=\left[z_{0}: z_{1}: \ldots: z_{n}\right]$ is the homogeneous coordinate system of $\mathbb{C P}^{n}$, and $\Lambda=\sum_{\alpha, \beta} \partial_{Z_{\alpha}}^{\leftarrow} \Lambda^{\alpha, \beta} \overrightarrow{\partial_{Z_{\beta}}}$ defines a holomorphic skew-symmetric biderivation ${ }^{1}$ of order zero acting on the structure sheaf $\mathcal{O}_{\mathbb{C P}}$ satisfying the Jacobi rule $2^{2}$ and an assumption below:

Then, for any point "p" and germs $[f(Z)]$., $[g(Z)]$ - of the stalk $\mathcal{O}_{\mathbb{C P}^{n}, p}[[6]] 3^{3}$,

defines a non-commutative and associative ring structure, where $\mu$ is a formal parameter.

We also have
Theorem 1.2 Under the same assumptions and notations of Theorem 1.1, the product \# induces globally defined non-commutative, associative product on the sheafcohomology space $\sum_{k=0}^{\infty} H^{0}\left(\mathbb{C P}^{n}, \mathcal{O}_{\mathbb{C P}^{n}}(k)\right)[[4]]$ where $\mu$ can be specialized a scalar (for example $\mu=1$ ).

Using the product \#, we also have
Theorem 1.3 Suppose that the same assumptions of Theorem 1.1. Let $A[Z]:=Z A^{t} Z$ be a quadratic form with homogeneous degree 2. Then we have

## 2 Outlines of Proofs of Theorems 1.1, 1.2 and 1.3

In this section we give outline of proofs of our main theorems (cf. [18]). Before giving proofs, we recall fundamentals of projective scheme. In fact, we need a slight modification of the standard theory of scheme.

Let $S=\oplus_{n=0}^{\infty} S_{n}$ be a graded commutative ring. Then, $S_{0}$ is obviously commutative and $S$ is an $S_{0}$-algebra. It is well-known that the homogeneous ideal $S_{+}:=\oplus_{n=1}^{\infty} S_{n}$ is called the irrelevant ideal. And the following is well-known:

Proposition 2.1 A graded commutative ring $S$ is noetherian if and only if $S_{0}$ is noetherian and $S$ is finitely generated by $S_{1}$ as an $S_{0}$-algebra.

It is also well-known that a projective shceme

admits the canonical scheme structure in the following way: Set

[^1]for any homogeneous element $f \in S_{d}$ with degree $d$, then the family $\left\{D_{+}(f)\right\}_{f \in S_{d}}, d \in \mathbb{Z}_{>0}$ forms a basis of open sets. Hence it gives the canonical topology $\mathfrak{O}_{\operatorname{Proj}(S)}$ (that is, the Zariski topology) for $\operatorname{Proj}(S)$. Note that $\neg(f \in \mathfrak{p})$ means $f\left(\right.$ point $\left._{\mathfrak{p}}\right) \neq 0$, intuitively. We also set

The functor above is well-known as the structure sheaf. We remark that when $g \in S_{0}$, we easily see that $g / 1=f g / f\left(f g \in S_{d}\right)$. Hence we may consider $g / f^{m}(m \geq 1)$ instead of $g / f^{m}(m \geq 0)$. We obtain that R.H.S. of (4) is a part of degree 0 of localization $S_{f}$ of $S$ by a product closed set $\left\{f^{\ell}\right\}_{\ell=0,1,2, \ldots}$. We denote it by $\left(S_{f}\right)_{0}$ or $S_{(f)}$. Strictly speaking, for any homogeneous element $f$ with $\operatorname{deg}(f)=d$,

Hence we proved that
Proposition 2.2 As for $D_{+}(f)$,

Thus, $\operatorname{Proj}(S)$ is obtained by glueing of affine schemes. It indicates that $\left(\operatorname{Proj}(S), \mathcal{O}_{\operatorname{Proj}(S)}\right)$ is a scheme in the genuin sense.

Next we consider cohomology of quasi-coherent sheaf over $\operatorname{Proj}(S)$. Assume that a graded ring $S$ is generated by $S_{1}$ as an $S_{0}$-algebra. For instance

As for a quasi-coherent sheaf $\mathcal{F}$, we set

and define

Then we see that $\Gamma_{*}(\mathcal{F}[[4]])$ is a graded $\Gamma\left(\mathcal{O}_{\operatorname{Proj}(S)}[[6]]\right)$-module. For any element $f \in S_{d}$, we set $\alpha_{d}(f):=a / 1$. Then it is well-known that
Proposition 2.3 The map $\alpha_{d}$ obtained above defines a homomorphism

A family $\left\{\alpha_{d}(f)\right\}_{f: \text { :homogeneous }}$ induces a module homomorphism

Hence, using the module homomorphisms $\left\{\alpha_{d}\right\}$, a graded ring homomorphism

can be defined for any quasi-coherent sheaf $\mathcal{F}$. Thus, $\Gamma\left(\operatorname{Proj}(S), \mathcal{O}_{\operatorname{Proj}(S)}[[\measuredangle]]\right)$ admits a graded $S[[6]]$-module structure.

[^2]Definition 2.4 We denote the pair $\left(\operatorname{Proj}(S), \mathcal{O}_{\operatorname{Proj}(S)}[[6]]\right)$ by $\operatorname{Proj}(S)[[\zeta]]$.
We are also interested in $\Gamma_{*}(\mathcal{F}[[\measuredangle]])_{(f)}$. As for any element $f \in S_{d}$, and $x \in \Gamma(\operatorname{Proj}(S), \mathcal{F}[[\lfloor ]])$, we see $x / f^{n} \in \Gamma_{*}(\operatorname{Proj}(S), \mathcal{F}[[\boxed{L}]])_{(f)}$. We denote the restriction of $x$ to $D_{+}(f)$ by $\left.x\right|_{D_{+}(f)}$. Then matching the degrees of $\left.x\right|_{D_{+}(f)}$ and $\left(\left.a_{d}(f)\right|_{D_{+}(f)}\right)^{n}$ we get $\left.\left.x\right|_{D_{+}(f)} /\left(\left.a_{d}(f)\right|_{D_{+}(f)}\right)\right)^{n}$.

As similarly for $\alpha$, for any homogeneous element $g \in S_{e}$, we obtain a diagram:


By a similar argment as above, we define an $\operatorname{Proj}(S)[[t]]$-module homomorphism

Proposition 2.5 Assume that a graded ring $S$ is generated by $S_{1}=\left\{f_{1}, f_{2}, \ldots, f_{\ell}\right\}(\exists \ell \in$ $\left.\mathbf{Z}_{\geq 0}\right)$ as $S_{0}$-algebra. Then we see
(i) If $S$ is a domain then the map $\alpha$ induced in (9) is injective.
(ii) If $\left(f_{i}\right)_{(i=1,2, \ldots, \ell)}$ are all prime ideals, then the map $\alpha$ is an isomorphism.
(iii) When $S=k\left[z_{0}, z_{1}, z_{2}, \ldots, z_{n}\right]$, then the map $\alpha$ is an isomorphism.

We also have the following:
Proposition 2.6 Assume that $\mathcal{F}[[]]$ is a quasi-coherent sheaf $\operatorname{Proj}(S)[[6]]$-module. Then the homomorphism $\beta_{\mathcal{F}}$ induced in (9) is an isomorphism. Furthermore, via (8), we see

Definition 2.7 Assume that $\Lambda$ is a holomorphic skew-biderivation satisfying Jacobi rule. Then, \# is called symbol calculus on $\operatorname{Proj}(S)$ if $(\operatorname{Proj}(S)[[4]]$, \#) has an associative algebra sheaf structure such that

Proof of Theorem 1.1 Under the assumption (11), it is easy to check

& f(Z) \sum_{k=0}^{\infty} \frac{1}{k!}\left(\frac{\mu}{2}\right)^{k}\left(\partial_{Z_{\alpha_{1}}}^{\leftarrow} \Lambda^{\alpha_{1}, \beta_{1}} \partial_{Z_{\beta_{1}}}\right) \cdots\left(\partial_{Z_{\alpha_{k}}}^{\leftarrow} \Lambda^{\alpha_{k}, \beta_{k}} \overrightarrow{\partial_{\beta_{\beta_{k}}}}\right) g(Z) \\
& =\sum_{k=0}^{\infty} \frac{1}{k!}\left(\frac{\mu}{2}\right)^{k} \Lambda^{\alpha_{1} \beta_{1}} \Lambda^{\alpha_{2} \beta_{2}} \cdots \Lambda^{\alpha_{k} \beta_{k}} \partial_{Z_{\alpha_{1}}} \partial_{Z_{\alpha_{2}}} \cdots \partial_{Z_{\alpha_{k}}} f(Z) \partial_{Z_{\beta_{1}}} \partial_{Z_{\beta_{2}}} \cdots \partial_{Z_{\beta_{k}}} g(Z) . \tag{13}
\end{align*}

Then the right hand side of (13) coincides with the asymptotic expansion formula for product of the Weyl type pseudo-differential operators. Thus, it completes the proof.

Proof of Theorem 1.2 As seen in the previous argument, as for sheaf cohomology of projective space, we obtain that

\sum_{k=0}^{\infty} H^{0}\left(\mathbb{C P}^{n}, \mathcal{O}_{\mathbb{C P}^{n}}(k)\right) \cong \sum_{k=0}^{\infty} \mathbb{C}[Z]_{k}, \tag{14}
\end{equation*}
$$

where $\mathbb{C}[Z]_{k}$ stands for the space of homogeneous polynomials of degree $k \in \mathbf{Z}_{\geq 0}$. Then a direct computation using (13) shows that $\mu$ can be specialized a scalar.

Proof of Theorem 1.3 We would like to compute exponentials having the following form $f(Z)=g(t) e^{\frac{1}{\mu} Q[Z](t)}$ with respect to \# for quadratic polynomials under a quite general setting.

Let $Z=\left[z^{1}: \ldots: z^{n}\right], A[Z]:=Z A^{t} Z$, where $A \in \operatorname{Sym}(n, \mathbb{C})$, i.e. $A$ is an $n \times n$ complex symmetric matrix. In order to compute the exponential $F(t):=e_{\#}^{t \frac{1}{\mu} A[Z]}$ with respect to the Wyel type product formula, we treat the following evolution equation:

with an initial condition

where $B \in \operatorname{Sym}(n, \mathbb{C})$.
As seen above, our setting is rather different from the situations considered in the article 12 and in 21, 22, 24. See also 25. However, to compute exponentials, we can use similar methods employed in the articles above, as will be seen below:

Under the assumption $F(t)=g \cdot e^{\frac{1}{\mu} Q[Z]}(g=g(t), Q=Q(t))$, we would like to find a solution of the equations (15) and (16).

Direct computations give

[^3]where $A=\left(A_{i j}\right), \Lambda=\left(\Lambda^{i j}\right)$ and $Q=\left(Q_{i j}\right)$. Comparing the coefficient of $\mu^{-1}$ gives

Applying $\Lambda$ by left and setting $q:=\Lambda Q$ and $a:=\Lambda A$, we easily obtain

In order to solve the equations (21) and (22), we now recall the "Cayley transform."

2. $C^{-1}(g)=\frac{1-g}{1+g}$, (the 'inverse Cayley transform").
3. $e^{2 \sqrt{-1} a}=c(-\sqrt{-1} \tan (a))$.
4. $\log a=2 \sqrt{-1} \arctan \left(\sqrt{-1} C^{-1}(g)\right)$.
5. $\partial_{t} q=(1+q) a(1-q) \Longleftrightarrow \partial_{t} C(q)=-2 a C(q)$.

Solving the above equation 5 in Proposition 2.9, we have

C(q)=e^{-2 a t} C(b),
$$

where $b=\Lambda B$ and then

q=C^{-1}\left(e^{-2 a t} \cdot C(b)\right)=C^{-1}(C(-\sqrt{-1} \tan (\sqrt{-1} a t)) \cdot C(b))
$$

Hence, according to the inverse Cayley transform, we can get $Q$ in the following way.

Proposition 2.10

$$
\begin{equation*}
Q=-\Lambda \cdot C^{-1}(C(-\sqrt{-1} \tan (\sqrt{-1} \Lambda A t)) \cdot C(\Lambda B)) \tag{24}
\end{equation*}
$$

Next we compute the amplitude coefficient part $g$. Solving

$$
\begin{equation*}
g^{\prime}=-\frac{1}{2} \operatorname{tr}(a q) \cdot g \tag{25}
\end{equation*}
$$

gives
Proposition 2.11

$$
\begin{equation*}
g=\operatorname{det}^{-\frac{1}{2}}\left(\frac{e^{a t}(1+b)+e^{-a t}(1-b)}{2}\right) \tag{26}
\end{equation*}
$$

Setting $t=1, a=\Lambda A$ and $b=0$, we get
Theorem 2.12

$$
\begin{equation*}
e_{\#}^{\frac{1}{\mu} A[Z]}=\operatorname{det}^{-\frac{1}{2}}\left(\frac{e^{\Lambda A}+e^{-\Lambda A}}{2}\right) \cdot e^{\frac{1}{\mu}\left(\frac{\Lambda^{-1}}{\sqrt{-1}} \tan (\sqrt{-1} \Lambda A)\right)[Z]} . \tag{27}
\end{equation*}
$$

As usual, using the Čech resolution, we can compute the sheaf-cohomology $\left.\sum_{k=0}^{\infty} H^{0}\left(\mathbb{C P}^{n}, \mathcal{O}_{\mathbb{C P}^{n}}\left[\mu, \mu^{-1}\right]\right]\right)$. Combining it with Theorems 2.12 we see

$$
\left.e_{\#}^{\frac{1}{\mu} A[Z]} \in \sum_{k=0}^{\infty} H^{0}\left(\mathbb{C P}^{n}, \mathcal{O}_{\mathbb{C P}^{n}}\left[\mu, \mu^{-1}\right]\right]\right) .
$$

This completes the proof of Theorem $1.3 \square$

## 3 Remarks

Consider the following diagram:

$$
\left(\left(x^{\alpha, \dot{\alpha}}\right),\left[\pi_{1}: \pi_{2}\right]\right) \in M:=\mathbb{C}^{4} \times \mathbb{C P}^{1}
$$



$$
\left(\left[z_{1}: \ldots: z_{4}\right]\right) \in \mathbb{C P}^{3}
$$

$$
\left(x^{\alpha, \dot{\alpha}}\right) \in \mathbb{C}^{4}
$$

where $x^{\alpha, \dot{\alpha}}$ are even variables, we set

$$
\begin{aligned}
& \left(x^{\alpha, \dot{\alpha}}\right):=\left(x^{1, \dot{\mathrm{i}}}, x^{1, \dot{\dot{2}}}, x^{2, \mathrm{i}}, x^{2, \dot{2}}\right) \\
& \left(\left[z_{1}: \ldots: z_{4}\right]\right):=\left(\left[x^{\alpha, \mathrm{i}} \pi_{\alpha}: x^{\alpha, \dot{2}} \pi_{\alpha}: \pi_{1}: \pi_{2}\right]\right) .
\end{aligned}
$$

Here we use Einstein's convention (we will often omit $\sum$ unless there is a danger of confusion). We call ([ $\left.\left.z_{1}: \ldots: z_{4}\right]\right)$ the homogeneous coordinate system of $\mathbb{C P}^{3}$.

1. The relation: ${ }^{6}(\dot{\alpha}, \dot{\beta}=\dot{1}, \dot{2})$

$$
\begin{equation*}
\left[z^{\dot{\alpha}}, z^{\dot{\beta}}\right]=\hbar D^{\alpha \dot{\alpha}, \beta \dot{\beta}} \pi_{\alpha} \pi_{\beta} \tag{28}
\end{equation*}
$$

where $z^{\dot{1}}:=z_{1}, z^{\dot{2}}:=z_{2}$, give a globally defined non-commutative associative product $\#$ on $\mathbb{C P}^{3}$, where $\left(D^{\alpha \dot{\alpha}, \beta \dot{\beta}}\right)$ is a skew symmetric matrix.
2. Let $A[Z]$ be a homogeneous polynomial of $z^{\dot{1}}=z_{1}=x^{\alpha, \dot{1}} \pi_{\alpha}, z^{\dot{2}}=z_{2}=x^{\alpha, \dot{2}} \pi_{\alpha}$ with degree 2. Then a star exponential function $e_{\#}^{\frac{1}{\mu} A[Z]}$ gives a "function" on $\mathbb{C P}^{3}$.
More precisely,
Theorem 3.1 Assume that $\Lambda:=\hat{\Lambda}$ and $A[Z]$ a homogeneous polynomial of $z^{i}=$ $x^{\alpha, \dot{1}} \pi_{\alpha}, z^{\dot{2}}=x^{\alpha, \dot{2}} \pi_{\alpha}$ with degree 2. Then a star exponential function $e_{\#}^{\frac{1}{\mu} A[Z]}$ gives a cohomology class of $\mathbb{C P}^{3}$ with coefficients in the sheaf $\sum_{k=0}^{\infty} \mathcal{O}_{\mathbb{C P}^{3}}(k)$.


$$
\mathbb{C}^{4 \mid 2 N} \times \mathbb{C P}^{1}
$$


$\mathbb{C P}^{3 \mid N}$

$\mathbb{C}^{4 \mid 2 N}$
where $\Pi$ denotes the chiral projection, we can consider non-anti-commutative deformation of super twistor space.

In order to give a brief explanation, we recall the definition of super twistor manifold (10, 30, 31).

Definition 3.2 (3|N)-dimensional complex super manifold $Z$ is said to be a super twistor space if the following conditions (1) - (3) are satisfied.

[^4](1) $p: Z \longrightarrow \mathbb{C P}^{1}$ is a holomorphic fiber bundle.
(2) $Z$ has a family of holomorphic section of $p$ whose normal bundle is isomorphic to $\mathcal{O}_{\mathbb{C P}^{1}}(1) \oplus \mathcal{O}_{\mathbb{C P}^{1}}(1) \oplus C^{N} \otimes \Pi \mathcal{O}_{\mathbb{C P}^{1}}(1)$.
(3) $Z$ has an anti-holomorphic involution $\sigma$ being compatible with (1), (2) and $\sigma$ has no fixed point.

We define $\mathbb{C P}_{*_{\alpha^{\prime}}}^{3 \mid N}=\left(\mathbb{C} P^{3 \mid N}, \mathcal{O}_{\mathbb{C P}^{3 \mid N}, *_{\alpha}^{\prime}}\right)$.
Let $f\left(z \mid \xi ; \alpha^{\prime}\right)$ be a local section defined in the following manner:

$$
\begin{equation*}
f\left(z \mid \xi ; \alpha^{\prime}\right)=\sum_{k=0}^{N} \sum_{1 \leq i_{1} \leq i_{2} \leq \cdots \leq i_{k} \leq N} f_{i_{1} i_{2} \ldots i_{k}}(z) \xi^{i_{1}} \xi^{i_{2}} \cdots \xi^{i_{k}} \tag{29}
\end{equation*}
$$

where $f_{i_{1} \ldots i_{k}}(z)$ is a homogeneous element of $z=\left[z_{1}: z_{2}: z_{3}: z_{4}\right]$ with homogeneous degree $(-k)$ on $\mathbb{C P}^{3}$. Then we can introduce a structure sheaf $\mathcal{O}_{\mathbb{C P}^{3} \mid N, * \alpha^{\prime}}$ whose local section is given by $f\left(z \mid \xi ; \alpha^{\prime}\right)$.

Under these notations, we can introduce a ringed space denoted by $\mathbb{C P}_{* \alpha^{\prime}}^{3 \mid N}=$ $\left(\mathbb{C P}^{3}, \mathcal{O}_{\mathbb{C P}^{3} \mid N,{ }^{\prime}{ }_{\alpha^{\prime}}}\right)$. We shall call it non-anti-commutative complex projective super space.

As for the non-anti-commutative deformed product $*$ aassociated with the non-anti-commutative complex projective super space, we have commutation relations of local coordinate functions:
(1) Let $\left(z_{1}, z_{2}, \pi_{1}, \pi_{2} \mid \xi^{1}, \ldots, \xi^{N}\right)$ be a local coordinate system of $\mathcal{P}^{3 \mid N}$, where $\mathcal{P}^{3 \mid N}$ denotes the non-anti-commutative open super twistor space. Then

$$
\left\{\xi^{i}, \xi^{j}\right\}_{*}=\alpha^{\prime} C^{i \alpha, j \beta} \pi_{\alpha} \pi_{\beta}, \quad \text { (0 o.w.) }
$$

(2) A local coordinate system $\left(z_{1}, z_{2}, \pi_{1}, \pi_{2} \mid \xi^{1}, \ldots, \xi^{N}\right)$ of $\mathbb{C P}^{3 \mid N}$ satisfies

$$
\left\{\xi^{i}, \xi^{j}\right\}_{*}=\alpha^{\prime} C^{i \alpha, j \beta} \pi_{\alpha} \pi_{\beta}, \quad \text { (0 o.w.) }
$$

Here we do not explain more the notion and notations which appeared above and do not give the proof of them. For details, see 30 .
