# The characterization of Hermitian surfaces by the number of points

#### Abstract

The nonsingular Hermitian surface of degree $\sqrt{q}+1$ is characterized by its number of $\mathbb{F}_{q}$-points among the surfaces over $\mathbb{F}_{q}$ of degree $\sqrt{q}+1$ in the projective 3 -space without $\mathbb{F}_{q}$-plane components. ## 1 Introduction

Hermitian varieties are known as ones having particular properties over finite fields. Throughout this paper, except Section $3, q$ is an even power of a prime number $p$. A Hermitian variety over $\mathbb{F}_{q}$ is a hypersurface in $\mathbb{P}^{n}$ defined by

$$
\begin{equation*}
\left(X_{0}^{\sqrt{q}}, \ldots, X_{n}^{\sqrt{q}}\right) A^{t}\left(X_{0}, \ldots, X_{n}\right)=0 \tag{1}
\end{equation*}
$$

where $A$ is a square matrix of order $n+1$ whose entries are in $\mathbb{F}_{q}$ with the property ${ }^{t} A=A^{(\sqrt{q})}$; here $A^{(\sqrt{q})}$ means taking entry-wise the $\sqrt{q}$-th power, and ${ }^{t} A$ is the transposed matrix of $A$. We refer this kind of polynomial as a Hermitian polynomial over $\mathbb{F}_{q}$. For a homogeneous polynomial $F$ of degree $\sqrt{q}+1$ whose coefficients are

[^0]in $\mathbb{F}_{q}$, the hypersurface given by $F=0$ is Hermitian if and only if there is an element $\rho \in \mathbb{F}_{q}^{*}$ such that $\rho F$ is a Hermitian polynomial. The family of Hermitian polynomials over $\mathbb{F}_{q}$ forms an $\mathbb{F}_{\sqrt{q}}$ vector space. It is obvious that the Hermitian polynomial (1) defines a nonsingular Hermitian variety if and only if $\operatorname{det} A \neq 0$. By the standard argument, a nonsingular Hermitian variety is projectively equivalent to the variety

H_{n-1}: X_{0}^{\sqrt{q}+1}+X_{1}^{\sqrt{q}+1}+\cdots+X_{n}^{\sqrt{q}+1}=0 \tag{2}
\end{equation*}
$$

\]

over $\mathbb{F}_{q}$.
The number $N_{q}\left(H_{n-1}\right)$ of $\mathbb{F}_{q}$-points of $H_{n-1}$ is

$$
\begin{equation*}
N_{q}\left(H_{n-1}\right)=\left(\sqrt{q}^{n+1}+(-1)^{n}\right)\left(\sqrt{q}^{n}+(-1)^{n-1}\right) /(q-1), \tag{3}
\end{equation*}
$$

which is due to [1].
This number is remarkable in the following sense. The Weil conjecture [15] established by Deligne [2] implies that the number $N$ of $\mathbb{F}_{q}$-points of a nonsingular hypersurface of degree $d$ in $\mathbb{P}^{n}$ defined over $\mathbb{F}_{q}$ is bounded by

$$
\begin{equation*}
N \leq \frac{q^{n}-1}{q-1}+\frac{d-1}{d}\left((d-1)^{n}-(-1)^{n}\right) \sqrt{q}^{n-1} . \tag{4}
\end{equation*}
$$

Furthermore, if equality holds in (4) for a certain nonsingular hypersurface of degree $d$, then $d \leq \sqrt{q}+1$.

As for this additional claim, see [12, Corollary 2.2] or [8, Corollary 4.3]. The number $N_{q}\left(H_{n-1}\right)$ achieves the equality in (4) for $d=\sqrt{q}+1$.

There is a characterization of the Hermitian curve among the family of plane curves over $\mathbb{F}_{q}$ of degree $\sqrt{q}+1$ without $\mathbb{F}_{q}$-line components [3]. Note that $N_{q}\left(H_{1}\right)=$ $\sqrt{q}^{3}+1$.

Theorem 1.1 (Hirschfeld-Storme-Thas-Voloch) Suppose that $q \neq 4$. Let $C$ be a plane curve over $\mathbb{F}_{q}$ of degree $\sqrt{q}+1$ without $\mathbb{F}_{q}$-line components. If $C$ has $\sqrt{q}^{3}+1$ points over $\mathbb{F}_{q}$, then $C$ is a Hermitian curve.

The purpose of this paper is to show a similar fact for surfaces in $\mathbb{P}^{3}$.
Theorem 1.2 Let $S$ be a surface in $\mathbb{P}^{3}$ defined over $\mathbb{F}_{q}$ without $\mathbb{F}_{q}$-plane components. If the degree of $S$ is $\sqrt{q}+1$ and $N_{q}(S)=\left(\sqrt{q}^{3}+1\right)(q+1)$, then $S$ is a nonsingular Hermitian surface over $\mathbb{F}_{q}$.

After Hirschfeld-Storme-Thas-Voloch's characterization of the Hermitian curve established, Rück-Stichtenoth gave another characterization of the Hermitian curve among the family of nonsingular curves defined over $\mathbb{F}_{q}$ of genus $\frac{\sqrt{q}(\sqrt{q}-1)}{2}$ [10]. A connection of those two characterization will be mentioned in Appendix.

Notation - When $X$ is an algebraic set in $\mathbb{P}^{n}$ defined by equations over $\mathbb{F}_{q}$, the set of $\mathbb{F}_{q}$-points in $X$ is denoted by $X\left(\mathbb{F}_{q}\right)$, and the cardinality of $X\left(\mathbb{F}_{q}\right)$ by $N_{q}(X)$.

- When coordinates $X_{0}, \ldots, X_{n}$ of $\mathbb{P}^{n}$ are given, for a homogeneous polynomial $h$ in those variables, $\{h=0\}$ means the hypersurface defined by $h=0$.
- Let $D$ and $E$ are curves in $\mathbb{P}^{2}$ without common components. For a point $Q \in D \cap E, i(D . E ; Q)$ denotes the local intersection multiplicity of $D$ and $E$ at $Q$, and $(D . E)=\sum_{Q \in D \cap E} i(D . E ; Q)$.
- For a plane curve $C \subset \mathbb{P}^{2}$ and a nonsingular point $P \in C, T_{P}(C)$ denotes the embedded tangent line to $C$ at $P$.
- The multiplicative set $\mathbb{F}_{q} \backslash\{0\}$ is denoted by $\mathbb{F}_{q}^{*}$.
- For a finite set $Y,{ }^{\#} Y$ denotes the number of elements of $Y$.


## 2 Plane curves

For a plane curve $C$ over $\mathbb{F}_{q}$, we proved a simple bound for $N_{q}(C)$ in a series of papers [5, 6, 7], which had been originally conjectured by Sziklai [13].

Theorem 2.1 (Sziklai bound) Let $d$ be an integer with $2 \leq d \leq q+2$, and $C$ a curve of degree d in $\mathbb{P}^{2}$ defined over $\mathbb{F}_{q}$ without $\mathbb{F}_{q}$-linear components. Then

$$
\begin{equation*}
N_{q}(C) \leq(d-1) q+1 \tag{5}
\end{equation*}
$$

except for curves over $\mathbb{F}_{4}$ which are projectively equivalent to the curve defined by

$$
K:\left(X_{0}+X_{1}+X_{2}\right)^{4}+\left(X_{0} X_{1}+X_{1} X_{2}+X_{2} X_{0}\right)^{2}+X_{0} X_{1} X_{2}\left(X_{0}+X_{1}+X_{2}\right)=0 .
$$

For the exceptional curve $K$ above, $N_{4}(K)=14$.
The number $N_{q}\left(H_{1}\right)$ attains the equality of the Sziklai bound too.
This bound implies a sufficient condition on a plane curve over $\mathbb{F}_{q}$ to be absolutely irreducible.

Corollary 2.2 Let $C$ be a curve over $\mathbb{F}_{q}$ of degree $d$ in $\mathbb{P}^{2}$ without $\mathbb{F}_{q}$-linear components. If $N_{q}(C) \geq(d-2) q+3$, then $C$ is absolutely irreducible.

Proof. First note that the range of $d$ is $2 \leq d \leq q+2$ by assumptions.
(Step 1) Suppose $C$ is decomposed into two curves $C_{1}$ and $C_{2}$ over $\mathbb{F}_{q}$. For each $i=1,2$, let $d_{i}$ be the degree of $C_{i}$. If either " $q \neq 4$ " or " $q=4$ and none of the $C_{i}$ 's is projectively equivalent to $K$," then

$$
N_{q}(C) \leq N_{q}\left(C_{1}\right)+N_{q}\left(C_{2}\right) \leq\left(\left(d_{1}-1\right) q+1\right)+\left(\left(d_{2}-1\right) q+1\right) \leq(d-2) q+2 .
$$

We consider the exceptional case, namely " $q=4$ and one of the $C_{i}$ 's is projectively equivalent to $K$ oner $\mathbb{F}_{4}$." Applying an $\mathbb{F}_{4}$-linear transformation if necessary, we may assume that $C_{1}=K$. Then $d=6$ and $d_{2}=2$, because $2 \leq d \leq 6$ and $C$
has no $\mathbb{F}_{4}$-linear components. Since $C_{2}$ is $\mathbb{F}_{4}$-irreducible of degree $2, N_{4}\left(C_{2}\right)=5$ or 1. When $N_{4}\left(C_{2}\right)=1, N_{4}(C) \leq 14+1<(6-2) 4+3$. If $C_{2}$ is an absolutely irreducible conic, then $\#\left(C_{2} \cap \mathbb{P}^{2}\left(\mathbb{F}_{2}\right)\right) \leq 4$, because the maximum length of $\mathbb{F}_{2}$-arc is 4. Since $K\left(\mathbb{F}_{4}\right)=\mathbb{P}^{2}\left(\mathbb{F}_{4}\right) \backslash \mathbb{P}^{2}\left(\mathbb{F}_{2}\right)($ see $[5, \S 3])$, $\#\left(K\left(\mathbb{F}_{4}\right) \cap C_{2}\left(\mathbb{F}_{4}\right)\right) \geq 1$. Hence $N_{q}(C) \leq 14+5-1=(6-2) 4+2$.

Therefore $C$ is irreducible over $\mathbb{F}_{q}$.
(Step 2) Suppose that the $\mathbb{F}_{q^{-}}$-irreducible curve $C$ is not absolutely irreducible. Let $D$ be an irreducible component of $C$. Then $D$ is defined over an extension $\mathbb{F}_{q^{t}}$ of $\mathbb{F}_{q}$ with $t \geq 2$, and $C=D \cup D^{(q)} \cup \cdots \cup D^{\left(q^{t-1}\right)}$, where $D^{(q)}, \ldots, D^{\left(q^{t-1}\right)}$ are conjugates of $D$ over $\mathbb{F}_{q}$. Hence $C\left(\mathbb{F}_{q}\right) \subset D \cap D^{(q)}$ and $\operatorname{deg} D=\operatorname{deg} D^{(q)} \leq \frac{d}{2}$. Hence $N_{q}(C) \leq\left(\frac{d}{2}\right)^{2}$. Since $2 \leq d \leq q+2$, we have $\left(\frac{d}{2}\right)^{2}<(d-2) q+3$. Indeed, consider the quadratic $P(d)=\left(\frac{d}{2}\right)^{2}-(d-2) q-3$. Then $P(2)<0$ and $P(q+2)<0$, which implies $P(d)<0$ for any $d$ with $2 \leq d \leq q+2$.

Therefore the curve $C$ is absolutely irreducible too.
An important step of the proof of Theorem 1.2 is to study plane sections of $S$ and to apply the Hirschfeld-Storme-Thas-Voloch theorem to some of them, but the exception in the assertion of this theorem harms this step for $q=4$. So we take a detour in this case.

Lemma 2.3 Let $C$ be a plane curve of degree 3 over $\mathbb{F}_{4}$ without $\mathbb{F}_{4}$-linear components. Suppose $N_{4}(C)=9$. Then $C$ is absolutely irreducible and all $\mathbb{F}_{4}$-points are nonsingular. In addition, suppose that all $\mathbb{F}_{4}$-points are flexes, i.e., $i\left(T_{p}(C) . C ; P\right)=$ 3 for any $P \in C\left(\mathbb{F}_{4}\right)$. Then $C$ is a Hermitian curve.

Proof. From (2.2), $C$ is absolutely irreducible. Let $P \in C\left(\mathbb{F}_{4}\right)$. Assume that $P$ is a singular point. Then for any $\mathbb{F}_{4}$-line passing through $P$, $\#\left(l\left(\mathbb{F}_{4}\right) \cap C \backslash\{P\}\right) \leq 1$ because $(l . C)=3$ and $i(l . C ; P) \geq 2$. Hence $N_{4}(C) \leq 6$ because $C\left(\mathbb{F}_{4}\right)=\cup_{l \in \check{P}}\left(l\left(\mathbb{F}_{4}\right) \cap\right.$ $C$ ), which contradicts to the assumption $N_{4}(C)=9$. Hence all $\mathbb{F}_{4}$-points are nonsingular.

Next we show the additional statement. Since $\operatorname{deg} C=3$ and $i\left(T_{p}(C) . C ; P\right)=3$ for any $P \in C\left(\mathbb{F}_{4}\right)$, a line joining two $\mathbb{F}_{4}$-points of $C$ meets with $C$ at the third $\mathbb{F}_{4}$-point. Hence the $9 \mathbb{F}_{4}$-points $C\left(\mathbb{F}_{4}\right)$ can be divided three triples

$$
\left\{P_{01}, P_{02}, P_{03}\right\}\left\{P_{11}, P_{12}, P_{13}\right\}\left\{P_{21}, P_{22}, P_{23}\right\}
$$

such that three points of each triple are collinear. Let $l_{i}$ be the line on which $P_{i 1}, P_{i 2}$ and $P_{i 3}$ lie, and $l_{i}\left(\mathbb{F}_{4}\right)=\left\{P_{i 1}, P_{i 2}, P_{i 3}, Q_{i}, R_{i}\right\}$. Assume that $l_{0}, l_{1}$ and $l_{2}$ are concurrent. We may assume that $Q_{0}=Q_{1}=Q_{2}$. Hence $T_{P_{0 \mu}} \cap l_{1}$ must be $R_{1}$ for any $\mu=1,2,3$, and also $T_{P_{2 \nu}} \cap l_{1}=R_{1}$ for any $\nu=1,2,3$ because $P_{i \alpha}(i, \alpha=1,2,3)$ are flexes. But, since the number of $\mathbb{F}_{4}$-lines passing through $R_{1}$ is 5 and $T_{P_{i \mu}} \neq T_{P_{j \nu}}$ for any pair ( $P_{i \mu}, P_{j \nu}$ ), it is impossible.

Therefore $\left\{l_{0}, l_{1}, l_{2}\right\}$ forms a frame of $\mathbb{P}^{2}$, that is, we may assume that $l_{i}=\left\{X_{i}=\right.$ $0\}$, where $X_{0}, X_{1}, X_{2}$ are coordinates of $\mathbb{P}^{2}$. Let $C=\left\{F\left(X_{0}, X_{1}, X_{2}\right)=0\right\}$. Since

$$
\begin{array}{ll}
F\left(X_{0}, X_{1}, 0\right)=c_{2}\left(X_{0}^{3}+X_{1}^{3}\right) & \left(c_{2} \in \mathbb{F}_{4}^{*}\right) \\
F\left(X_{0}, 0, X_{2}\right)=c_{1}\left(X_{0}^{3}+X_{2}^{3}\right) & \left(c_{1} \in \mathbb{F}_{4}^{*}\right) \\
F\left(0, X_{1}, X_{2}\right)=c_{0}\left(X_{1}^{3}+X_{2}^{3}\right) & \left(c_{0} \in \mathbb{F}_{4}^{*}\right)
\end{array}
$$

we have $F\left(X_{0}, X_{1}, X_{2}\right)=c\left(X_{0}^{3}+X_{1}^{3}+X_{2}^{3}\right)+\gamma X_{0} X_{1} X_{2}$ with $c \in \mathbb{F}_{4}^{*}$ and $\gamma \in \mathbb{F}_{4}$. If $\gamma \neq 0$, then $\left(1,1, \frac{c}{\gamma}\right)$ is also an $\mathbb{F}_{4}$-point of $C$, which is not any of the $P_{i, \alpha}$ 's. This is a contradiction. Hence $\gamma=0$, that is, $C$ is Hermitian.

We close this section with a remark on plane curves that are used in the proof of the main theorem.

Lemma 2.4 (Segre) Let $d$ be an integer with $1 \leq d \leq q+1$, and $C$ be a curve of degree d in $\mathbb{P}^{2}$ defined over $\mathbb{F}_{q}$, which may have $\mathbb{F}_{q}$-linear components. Then $N_{q}(C) \leq d q+1$, and equality holds if and only if $C$ is a pencil of $d \mathbb{F}_{q}$-lines.
Proof. See Segre [11, II, $\S 6$ Observation IV ] or Homma-Kim [5, Remark 1.2].

## 3 An elementary bound

In this section, $q$ is simply a power of $p$, that is, it need not be an even power of $p$.
In [8], we established an upper bound for $N_{q}(X)$ of a hypersurface $X$ over $\mathbb{F}_{q}$ without $\mathbb{F}_{q}$-linear components, particularly a surface in $\mathbb{P}^{3}$ without $\mathbb{F}_{q}$-plane components.

Theorem 3.1 Let $S$ be a surface of degree d in $\mathbb{P}^{3}$ defined over $\mathbb{F}_{q}$ without $\mathbb{F}_{q}$-plane components. Then

$$
\begin{equation*}
N_{q}(S) \leq(d-1) q^{2}+d q+1 \tag{6}
\end{equation*}
$$

We refer the bound (6) as the elementary bound. When $d=\sqrt{q}+1$, the WeilDeligne bound (4) for $n=3$ agrees with the elementary bound. In this section, we investigate the geometry of a surface in $\mathbb{P}^{3}$ whose number of $\mathbb{F}_{q}$-points achieves the bound (6). There are at least two examples other than the Hermitian surface each of which attains the equality in (6) ${ }^{1}$.

From now on, we keep the following setup until the end of this section.
Setup 3.2 Let $d$ be an integer with $2 \leq d \leq q+1$. Let $S$ be a surface of degree $d$ in $\mathbb{P}^{3}$ defined over $\mathbb{F}_{q}$ without $\mathbb{F}_{q}$-plane components. Furthermore we suppose that $N_{q}(S)$ achieves the equality in (6).

[^1]Lemma 3.3 The surface $S$ contains an $\mathbb{F}_{q}$-line.
Proof. Suppose $S$ does not contain any $\mathbb{F}_{q}$-lines. Let $H$ be any $\mathbb{F}_{q}$-plane in $\mathbb{P}^{3}$. Then $S \cap H$ is a plane curve of degree $d$ over $\mathbb{F}_{q}$ in $H=\mathbb{P}^{2}$, and has no $\mathbb{F}_{q}$-line as a component. Hence

$$
N_{q}(S \cap H) \leq\left\{\begin{array}{cl}
(d-1) q+1 & \text { if }(d, q) \neq(4,4)  \tag{7}\\
14 & \text { if }(d, q)=(4,4)
\end{array}\right.
$$

by Lemma 2.1. In a term of [4], defining the $s$-degree $\delta$ of $S\left(\mathbb{F}_{q}\right)$ by

$$
\delta=\max \left\{N_{q}(S \cap H) \mid H \text { is an } \mathbb{F}_{q} \text {-plane }\right\}
$$

we have

$$
N_{q}(S) \leq(\delta-1) q+1+\left\lfloor\frac{\delta-1}{q+1}\right\rfloor
$$

by [4, Proposition 2.2]. Hence if $(d, q) \neq(4,4)$, then

$$
\begin{aligned}
N_{q}(S) & \leq(d-1) q^{2}+1+\left\lfloor\frac{(d-1) q}{q+1}\right\rfloor \\
& =(d-1) q^{2}+1+\left\lfloor\frac{(d-2)(q+1)+q+2-d}{q+1}\right\rfloor \\
& =(d-1)\left(q^{2}+1\right)
\end{aligned}
$$

and if $(d, q)=(4,4)$, then $N_{q}(S) \leq 55$. In either case, $N_{q}(S)$ can't be $(d-1) q^{2}+d q+1$.

Definition 3.4 Let $l_{1}, \ldots, l_{d}$ be $\mathbb{F}_{q}$-lines in $\mathbb{P}^{3}$ with $d \geq 2$. The union of those $d$ lines $Z=\cup_{i=1}^{d} l_{i}$ is called a planar $\mathbb{F}_{q}$-pencil of degree $d$ if those $d$-lines lie on a plane simultaneously and $l_{1} \cap \cdots \cap l_{d} \neq \emptyset$. The $\mathbb{F}_{q}$-point $\left\{v_{Z}\right\}=l_{1} \cap \cdots \cap l_{d}$ is called the vertex of $Z$.

Notation 3.5 For an $\mathbb{F}_{q}$-line $l$ of $\mathbb{P}^{3}$, the set of $\mathbb{F}_{q}$-planes containing the line $l$ is denoted by $\check{l}\left(\mathbb{F}_{q}\right)$.

Lemma 3.6 Let $l$ be an $\mathbb{F}_{q}$-line on the surface $S$.
(i) If an $\mathbb{F}_{q}$-plane $H$ contains $l$, then $S \cap H$ is a planar $\mathbb{F}_{q}$-pencil of degree $d$.
(ii) The map $\check{l}\left(\mathbb{F}_{q}\right) \ni H \mapsto v_{S \cap H} \in l\left(\mathbb{F}_{q}\right)$ is bijective.

Proof. (i) Since $S$ has no $\mathbb{F}_{q}$-plane components, $S \cap H$ is a plane curve of degree $d$ in $H$, and $N_{q}(S \cap H) \leq d q+1$ by Lemma 2.4. Counting the cardinality of $S\left(\mathbb{F}_{q}\right)$ by the decomposition

$$
S\left(\mathbb{F}_{q}\right)=\cup_{H \in \check{l}\left(\mathbb{F}_{q}\right)}\left((S \cap H)\left(\mathbb{F}_{q}\right) \backslash l\left(\mathbb{F}_{q}\right)\right) \bigcup l\left(\mathbb{F}_{q}\right)
$$

we have

$$
\begin{aligned}
(d-1) q^{2}+d q+1=N_{q}(S) & \leq(q+1)(d q+1-(q+1))+(q+1) \\
& =(d-1) q^{2}+d q+1 .
\end{aligned}
$$

Hence $N_{q}(S \cap H)=d q+1$. So $S \cap H$ is a planar $\mathbb{F}_{q}$-pencil of degree $d$ by the latter part of Lemma 2.4.
(ii) Let $\check{l}\left(\mathbb{F}_{q}\right)=\left\{H_{1}, H_{2}, \ldots, H_{q+1}\right\}$. Since $S \cap H_{i}$ is a planar $\mathbb{F}_{q}$-pencil and has the line $l$ as a component, we may set notations as

$$
S \cap H_{i}=l \cup l_{i, 1} \cup \cdots \cup l_{i, d-1}
$$

and

$$
v_{i}=v_{S \cap H_{i}} .
$$

It is obvious that $v_{i} \in l\left(\mathbb{F}_{q}\right)$. Since $\check{l}\left(\mathbb{F}_{q}\right)$ and $l\left(\mathbb{F}_{q}\right)$ have the same cardinality, it is enough to show that the map $\check{l}\left(\mathbb{F}_{q}\right) \ni H_{i} \mapsto v_{i} \in l\left(\mathbb{F}_{q}\right)$ is surjective.

Contrary, suppose this map is not surjective. Pick a point $Q \in l\left(\mathbb{F}_{q}\right) \backslash\left\{v_{1}, \ldots, v_{q+1}\right\}$, and choose an $\mathbb{F}_{q}$-plane $K$ such that $K \ni Q$ and $K \not \supset l$. Then we face two consequences:
( $\alpha$ ) $S \cap K$ does not contain any $\mathbb{F}_{q}$-line;
( $\beta$ ) $N_{q}(S \cap K) \geq(d-1) q+d$,
as we verify them below. Since $S \cap K$ is a plane curve of degree $d$ in $K$, those two conditions are incompatible each other by Lemma 2.1.

The verification of $(\alpha)$. If $S \cap K$ contains an $\mathbb{F}_{q}$-line, then it must be a planar $\mathbb{F}_{q}$-pencil by (i). Since $Q$ is a point of $S$, there is an $\mathbb{F}_{q^{\prime}}$-line $m$ passing through $Q$ among $d$ lines of $S \cap K$. Hence $l$ and $m$ spans an $\mathbb{F}_{q}$-plane which is one of the $H_{i}$ 's, say $H_{i}$. Then $v_{i} \in l \cap m=\{Q\}$, which contradicts to the choice of $Q$.

The verification of $(\beta)$. Let $Q_{i, j}$ be the intersection point of $l_{i, j}$ with $K$. Then the plane containing $l$ and $Q_{i, j}$ is $H_{i}$ and the line containing $v_{i}$ and $Q_{i, j}$ is $l_{i, j}$. Hence $Q_{i, j}=Q_{i^{\prime}, j^{\prime}}$ implies $(i, j)=\left(i^{\prime}, j^{\prime}\right)$. Since

$$
(S \cap K)\left(\mathbb{F}_{q}\right) \supset\left\{Q_{i, j} \mid 1 \leq i \leq q+1,1 \leq j \leq d-1\right\} \cup\{Q\},
$$

we have $N_{q}(S \cap K) \geq(d-1)(q+1)+1$.
Lemma 3.7 Let $H$ be an $\mathbb{F}_{q}$-plane such that $S \cap H$ is a planar $\mathbb{F}_{q}$-pencil of degree d. If an $\mathbb{F}_{q}$-line $l \subset S$ passes through $v_{S \cap H}$, then $l$ is a component of $S \cap H$.

Proof. Since $d \geq 2$, there are two distinct components $l_{1}$ and $l_{2}$ of $S \cap H$. Suppose that $l$ is not contained in $H$. Then $l$ and $l_{i}$ span an $\mathbb{F}_{q}$-plane, say $H_{i}$. Hence $S \cap H_{i}$ is also a planar $\mathbb{F}_{q}$-pencil of degree $d$ by Lemma 3.6 (i). By the construction of $H_{1}$ and $H_{2}$,

$$
v_{S \cap H_{1}}=l \cap l_{1}=v_{S \cap H}=l \cap l_{2}=v_{S \cap H_{2}},
$$

which contradicts (ii) of Lemma 3.6. Hence $l$ is contained in $H$, and hence it is a component of $S \cap H$.

Corollary 3.8 For any $\mathbb{F}_{q}$-point $P$ of $S$, there is a unique $\mathbb{F}_{q}$-plane $H$ such that $S \cap H$ is a planar $\mathbb{F}_{q}$-pencil of degree $d$ with $v_{S \cap H}=P$.

Proof. From Lemma 3.3 and Lemma 3.6 (i), there is a line $l$ on $S$ containing $P$. Indeed the existence of an $\mathbb{F}_{q}$-line $l^{\prime}$ on $S$ is guaranteed by Lemma 3.3; if the point $P$ in question lies on $l^{\prime}$, there is nothing to do; when $P \notin l^{\prime}$, consider the $\mathbb{F}_{q}$-plane $H^{\prime}$ containing $l^{\prime}$ and $P$, then $S \cap H^{\prime}$ is a planar $\mathbb{F}_{q}$-pencil by Lemma 3.6 (i), which contains $P$; hence there is a line $l$ on $S$ containing $P$. Hence, by (ii) of Lemma 3.6 there is a desired $\mathbb{F}_{q}$-plane, and such a plane is uniquely determined by $P$.

## 4 A characterization of Hermitian surfaces

In this section, $q$ is assumed to be an even power of a prime number $p$ again, and $S$ is a surface in $\mathbb{P}^{3}$ of degree $\sqrt{q}+1$ defined over $\mathbb{F}_{q}$ without $\mathbb{F}_{q}$-plane components such that $N_{q}(S)=\left(\sqrt{q}^{3}+1\right)(q+1)$. Note that this number $N_{q}(S)$ achieves both the Weil-Deligne bound (4) for $n=3$ and the elementary bound (6).

Proposition 4.1 With the above situation, let $H$ be an $\mathbb{F}_{q}$-plane of $\mathbb{P}^{3}$. Then either
(1) $S \cap H$ is a planar $\mathbb{F}_{q}$-pencil of degree $\sqrt{q}+1$, or
(2) $S \cap H$ is a nonsingular Hermitian curve of degree $\sqrt{q}+1$ over $\mathbb{F}_{q}$.

Furthermore, let $\nu_{1}$ denote the number of $\mathbb{F}_{q}$-planes having the property (1) above, and $\nu_{2}$ the property (2). Then

$$
\left\{\begin{array}{l}
\nu_{1}=N_{q}(S)=\left(\sqrt{q}^{3}+1\right)(q+1) \\
\nu_{2}=\sqrt{q}^{3}(q+1)(\sqrt{q}-1)
\end{array}\right.
$$

Proof. Let $\check{\mathbb{P}}^{3}\left(\mathbb{F}_{q}\right)$ denote the set of $\mathbb{F}_{q}$-planes of $\mathbb{P}^{3}$, and $\mathcal{P}_{1}$ the set of $\mathbb{F}_{q}$-planes having the property (1). The map $\mathcal{P}_{1} \ni H \mapsto v_{S \cap H} \in S\left(\mathbb{F}_{q}\right)$ is bijective by Corollary 3.8. Hence $\nu_{1}=N_{q}(S)$. Let $\mathcal{P}_{2}=\check{\mathbb{P}}^{3}\left(\mathbb{F}_{q}\right) \backslash \mathcal{P}_{1}$. Note that if $H \in \mathcal{P}_{2}$, then $S \cap H$ has no $\mathbb{F}_{q}$-liner components by Lemma 3.6 (i). Consider the correspondence

$$
\mathcal{A}=\{(P, H) \mid P \in H\} \subset S\left(\mathbb{F}_{q}\right) \times \check{\mathbb{P}}^{3}\left(\mathbb{F}_{q}\right)
$$

with two projections $\pi_{1}: \mathcal{A} \rightarrow S\left(\mathbb{F}_{q}\right)$ and $\pi_{2}: \mathcal{A} \rightarrow \check{\mathbb{P}}^{3}\left(\mathbb{F}_{q}\right)$. Counting the cardinality of $\mathcal{A}$ by $\pi_{1}$, we have

$$
\#_{\mathcal{A}}=N_{q}(S) \cdot\left(q^{2}+q+1\right)
$$

If $H \in \mathcal{P}_{1}$, then ${ }^{\#} \pi_{2}^{-1}(H)=N_{q}(S \cap H)=\sqrt{q}^{3}+q+1$, and if $H \in \mathcal{P}_{2}$, then $\# \pi_{2}^{-1}(H)=N_{q}(S \cap H) \leq \sqrt{q}^{3}+1$ by (2.1). Hence, counting the cardinality of $\mathcal{A}$ by $\pi_{2}$, we have

$$
\begin{aligned}
\#_{\mathcal{A}} & \leq N_{q}(S) \cdot\left(\sqrt{q}^{3}+q+1\right)+\left(\frac{q^{4}-1}{q-1}-N_{q}(S)\right)\left(\sqrt{q}^{3}+1\right) \\
& =N_{q}(S) \cdot\left(q^{2}+q+1\right)
\end{aligned}
$$

Therefore, if $H \in \mathcal{P}_{2}$, then $N_{q}(S \cap H)=\sqrt{q}^{3}+1$. Furthermore, when $H \in \mathcal{P}_{2}$, since $S \cap H$ has no $\mathbb{F}_{q}$-line as a component, $S \cap H$ is a nonsingular Hermitian curve by (1.1) if $q \neq 4$.

We need a little more argument if $q=4$. We want to apply Lemma 2.3. If an $\mathbb{F}_{4}$-point is not a flex of $S \cap H$, i.e., $i\left(T_{P}(S \cap H) . S \cap H ; P\right)=2$, then $T_{P}(S \cap H)$ meets with $S \cap H$ at exactly two $\mathbb{F}_{4}$-points, because $\operatorname{deg} S \cap H=3$. Consider all $\mathbb{F}_{4}$-planes $\left\{H_{\lambda}\right\}$ in $\mathbb{P}^{3}$ such that $H_{\lambda} \supset T_{P}\left(S \cap H_{\lambda}\right)$. Let $a=\#\left\{\lambda \mid H_{\lambda} \in \mathcal{P}_{1}\right\}$. Then $\#\left\{\lambda \mid H_{\lambda} \in \mathcal{P}_{2}\right\}=5-a$. Since $N_{4}\left(S \cap H_{\lambda}\right)$ is either 13 or 9 , we have $45=(13-2) a+(9-2)(5-a)+2$. Hence there is an $\mathbb{F}_{4}$-plane $H_{\lambda}$ such that $S \cap H_{\lambda}$ is a planar $\mathbb{F}_{4}$-pencil of degree 3 , and the line $T_{P}(S \cap H)$ lies on $H_{\lambda}$. But it is impossible, because any $\mathbb{F}_{4}$-line on $H_{\lambda}$ meets with the planar pencil at either 1 , or 3 , or 5 points.

Last Step of the Proof of Theorem 1.2. From Proposition 4.1, there is an $\mathbb{F}_{q}$-plane $H_{\infty} \subset \mathbb{P}^{3}$ such that $S \cap H_{\infty}$ is a nonsingular Hermitian curve. Choose a system of homogeneous coordinates $X_{0}, X_{1}, X_{2}, X_{3}$ of $\mathbb{P}^{3}$ such that
(i) $H_{\infty}$ is given by $X_{0}=0$; and
(ii) the plane curve $S \cap H_{\infty}$ in $H_{\infty}=\mathbb{P}^{2}$ is given by

$$
\bar{X}_{1} \bar{X}_{2}^{\sqrt{q}}+\bar{X}_{1}^{\sqrt{q}} \bar{X}_{2}+\bar{X}_{3}^{\sqrt{q}+1}=0
$$

where $\bar{X}_{1}, \bar{X}_{2}, \bar{X}_{3}$ are coordinates on $H_{\infty}$ induced by $X_{1}, X_{2}, X_{3}$ respectively.
Let $P_{1}=(0,0,1,0)$ and $P_{2}=(0,1,0,0)$, both of which are points on $S \cap H_{\infty}$. For $\alpha=1,2$, the tangent line $L_{\alpha}$ at $P_{\alpha}$ to $S \cap H_{\infty}$ in $H_{\infty}=\mathbb{P}^{2}$ is given by $\bar{X}_{\alpha}=0$. It is easy to see that $S \cap L_{\alpha}=\left\{P_{\alpha}\right\}$. Hence for an $\mathbb{F}_{q}$-plane $H \supset L_{\alpha}$,

$$
\#\left(S\left(\mathbb{F}_{q}\right) \cap\left(H \backslash L_{\alpha}\right)\right)=\left\{\begin{array}{cl}
\sqrt{q}^{3}+1-1 & \text { if } S \cap H \text { is Hermitian } \\
\sqrt{q}^{3}+q+1-1 & \text { if } S \cap H \text { is an } \mathbb{F}_{q} \text {-pencil. }
\end{array}\right.
$$

Counting the number $N_{q}(S)-1$ by using all $\mathbb{F}_{q}$-planes containing $L_{\alpha}$, we know that there is a unique plane $H_{\alpha, 0} \supset L_{\alpha}$ such that $S \cap H_{\alpha, 0}$ is a planar $\mathbb{F}_{q}$-pencil of degree $\sqrt{q}+1$; and $S \cap H_{\alpha, \lambda}$ is a nonsingular Hermitian curve for other plane $H_{\alpha, \lambda} \supset L_{\alpha}$. By changing coordinates of type

$$
\left\{\begin{array}{lll}
X_{1} & \mapsto & X_{1}+a X_{0} \\
X_{2} & \mapsto & X_{2}+b X_{0}
\end{array}\right.
$$

if necessary, we may suppose that $H_{\alpha, 0}$ is defined by $X_{\alpha}=0$ for $\alpha=1$ and 2 respectively. But the situation on $H_{\infty}$ never change.

Summing up, $S$ is defined by

$$
F\left(X_{0}, \ldots, X_{3}\right)=X_{0} f\left(X_{0}, \ldots, X_{3}\right)+h\left(X_{1}, X_{2}, X_{3}\right)=0
$$

where

$$
h\left(X_{1}, X_{2}, X_{3}\right)=X_{1} X_{2}^{\sqrt{q}}+X_{1}^{\sqrt{q}} X_{2}+X_{3}^{\sqrt{q}+1}
$$

and $\operatorname{deg} f=\sqrt{q}$.
Since $S \cap H_{1,0}=S \cap\left\{X_{1}=0\right\}$ is a planar $\mathbb{F}_{q}$-pencil with the vertex $P_{1}=$ $(0,0,1,0)$,

$$
F\left(X_{0}, 0, X_{2}, X_{3}\right)=X_{0} f\left(X_{0}, 0, X_{2}, X_{3}\right)+X_{3}^{\sqrt{q}+1}
$$

does not contain $X_{2}$, because this polynomial must have the form $c \prod_{j}\left(X_{0}+\gamma_{j} X_{3}\right)$, with $c \in \mathbb{F}_{q}^{*}$. Hence, in $F\left(X_{0}, X_{1}, X_{2}, X_{3}\right)$, any monomial containing $X_{2}$ also contains $X_{1}$. By the same argument on $S \cap H_{2,0}=S \cap\left\{X_{2}=0\right\}$, any monomial containing $X_{1}$ also contains $X_{2}$. Therefore $f\left(X_{0}, X_{1}, X_{2}, X_{3}\right)$ is written as

$$
f\left(X_{0}, X_{1}, X_{2}, X_{3}\right)=g_{1}\left(X_{0}, X_{3}\right)+g_{2}\left(X_{0}, \ldots, X_{3}\right) X_{1} X_{2},
$$

where $\operatorname{deg} g_{1}=\sqrt{q}$ and $\operatorname{deg} g_{2}=\sqrt{q}-2$.
For the plane $H_{1, \lambda}=\left\{X_{0}=\lambda X_{1}\right\}\left(\lambda \in \mathbb{F}_{q}^{*}\right)$, since $S \cap\left\{X_{0}=\lambda X_{1}\right\}$ is a Hermitian curve,

$$
\begin{align*}
& \rho F\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right)= \\
& \quad \rho\left(\lambda X_{1}\left(g_{1}\left(\lambda X_{1}, X_{3}\right)+g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right) X_{1} X_{2}\right)+h\left(X_{1}, X_{2}, X_{3}\right)\right) \tag{8}
\end{align*}
$$

is a Hermitian polynomial for some $\rho \in \mathbb{F}_{q}^{*}$. Since $X_{3}^{\sqrt{q}+1}$ appears only in $h\left(X_{1}, X_{2}, X_{3}\right)$, the constant $\rho$ must be an element of $\mathbb{F}_{\sqrt{q}}^{*}$. Hence (88) is a Hermitian polynomial even if $\rho=1$. Since $h$ itself Hermitian,

$$
\lambda g_{1}\left(\lambda X_{1}, X_{3}\right) X_{1}+\lambda g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right) X_{1}^{2} X_{2}
$$

must be Hermitian.
Any monomial in $g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right) X_{1}^{2} X_{2}$ never appear in $g_{1}\left(\lambda X_{1}, X_{3}\right) X_{1}$. So $\left.g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right)\right) X_{1}^{2} X_{2}$ contains the monomials only of types $X_{i}^{\sqrt{q}+1}$ or $X_{i}^{\sqrt{q}} X_{j}$. Hence

$$
g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right) X_{1}^{2} X_{2}=\mu X_{1}^{\sqrt{q}} X_{2}\left(\mu \in \mathbb{F}_{q}\right) .
$$

But the monomial $X_{1} X_{2}^{\sqrt{q}+1}$ can't appear in

$$
g_{1}\left(\lambda X_{1}, X_{3}\right) X_{1}+g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right) X_{1}^{2} X_{2} .
$$

Hence $g_{2}\left(\lambda X_{1}, X_{1}, X_{2}, X_{3}\right)=0$, that is, $X_{0}-\lambda X_{1}$ is a factor of $g_{2}\left(X_{0}, X_{1}, X_{2}, X_{3}\right)$ for any $\lambda \in \mathbb{F}_{q}^{*}$. But $\operatorname{deg} g_{2}=\sqrt{q}-2(<q-1)$, it is impossible. Therefore $g_{2}\left(X_{0}, X_{1}, X_{2}, X_{3}\right)=0$ and $\lambda g_{1}\left(\lambda X_{1}, X_{3}\right) X_{1}$ is Hermitian.

Let

$$
g_{1}\left(X_{0}, X_{3}\right)=\sum_{i=0}^{\sqrt{q}} a_{i} X_{0}^{i} X_{3}^{\sqrt{q}-i} .
$$

Then

$$
\lambda g_{1}\left(\lambda X_{1}, X_{3}\right) X_{1}=\sum_{i=0}^{\sqrt{q}} a_{i} \lambda^{i+1} X_{1}^{i+1} X_{3}^{\sqrt{q}-i},
$$

which is Hermitian．Hence $a_{i}=0$ for $i \neq 0, \sqrt{q}-1, \sqrt{q}$ ；and also $a_{0}^{\sqrt{q}}=a_{\sqrt{q}-1}$ and $a_{\sqrt{q}} \in \mathbb{F}_{\sqrt{q}}$ ，that is，

$$
g_{1}\left(X_{0}, X_{3}\right)=a_{0} X_{3}^{\sqrt{q}}+a_{0}^{\sqrt{q}} X_{0}^{\sqrt{q}-1} X_{3}+a_{\sqrt{q}} X_{0}^{\sqrt{q}} \text { with } a_{\sqrt{q}} \in \mathbb{F}_{\sqrt{q}} .
$$

Hence

$$
F\left(X_{0}, \ldots, X_{3}\right)=a_{0} X_{0} X_{3}^{\sqrt{q}}+a_{0}^{\sqrt{q}} X_{0}^{\sqrt{q}} X_{3}+a_{\sqrt{q}} X_{0}^{\sqrt{q}+1}+h\left(X_{1}, X_{2}, X_{3}\right),
$$

which is Hermitian．If $a_{\sqrt{q}}=0$ ，then the surface is a cone of a nonsingular Hermitian curve with vertex $(1,0,0,0)$ ，and then $N_{q}(S)=\left(\sqrt{q}^{3}+1\right) q+1$ ，which is not the given number．So $a_{\sqrt{q}} \in \mathbb{F}_{\sqrt{q}}^{*}$ ，and hence $S$ is a nonsingular Hermitian surface．

## Appendix

In this appendix，we consider a possibility of generalizing Rück－Stichtenoth＇s characterization of the Hermitian curve to the Hermitian surface．

Theorem A． 1 （Rück－Stichtenoth）Let $C$ be a nonsingular curve of genus $g=$ $\frac{1}{2} \sqrt{q}(\sqrt{q}-1)$ defined over $\mathbb{F}_{q}$ ．If $N_{q}(C)=\sqrt{q}^{3}+1$ ，then the function field $\mathbb{F}_{q}(C)$ of $C$ coincides with that of the Hermitian curve over $\mathbb{F}_{q}$ ．

Remark A． 2 If one considers only nonsingular plane curves，Rück－Stichtenoth＇s characterization implies Hirschfeld et al．＇s，because the linear system $g_{\sqrt{q}+1}^{2}$ is unique if $g=\frac{1}{2} \sqrt{q}(\sqrt{q}-1)>1$ ．When $q=4$ ，the genus in question is 1 ．As was mentioned in［3］，the plane curve $\left\{X_{0}+\omega X_{1}+\omega^{2} X_{2}=0\right\}$ over $\mathbb{F}_{4}$ is not Hermitian，but has 9 $\mathbb{F}_{4}$－points，where $\mathbb{F}_{4}=\left\{0,1, \omega, \omega^{2}\right\}$ ．However the function field of this curve over $\mathbb{F}_{4}$ coincides with that of the Hermitian curve over $\mathbb{F}_{4}$ ．

As has been remarked above，the Rück－Stichtenoth theorem gives a characteri－ zation of the Hermitian curve in wider family than the plane curves if one considers only nonsingular curves，namely among the family of nonsingular curves with the same＂topological＂invariant as the Hermitian curve．Since the number $\sqrt{q}^{3}+1$ achieves the Weil bound for $g=\frac{1}{2} \sqrt{q}(\sqrt{q}-1)$ ，the zeta function of the nonsingular curve $C$ in（A【位）is $\frac{(1+\sqrt{q} t)^{2 g}}{(1-t)(1-q t)}$ ．So Theorem A【 $\mathbb{1}$ can be interpreted as：

Theorem A． 3 （Rück－Stichtenoth）Let $C$ be a nonsingular curve of genus $g=$ $\frac{1}{2} \sqrt{q}(\sqrt{q}-1)>1$ defined over $\mathbb{F}_{q}$ whose zeta function is $\frac{(1+\sqrt{q})^{2 g}}{(1-t)(1-q t)}$ ．Then $C$ is the Hermitian curve．

On the other hand，the number of $\mathbb{F}_{q}$－points of the Hermitian surface attains the Weil－Deligne bound，and its zeta function is：

$$
\begin{equation*}
\frac{1}{(1-t)(1-q t)^{b_{2}}\left(1-q^{2} t\right)} \quad\left(b_{2}=q \sqrt{q}-q+\sqrt{q}+1\right) . \tag{9}
\end{equation*}
$$

It is natural to ask whether a nonsingular surface over $\mathbb{F}_{q}$ with the zeta function (9) is Hermitian or not. The example below shows the answer of this question is negative.

From now on, when $X$ is a nonsingular surface over $\mathbb{F}_{q}, Z_{X}(t)$ denotes the zeta function of $X$.

Lemma A. 4 Let $\tilde{X}$ be a blowing-up of a nonsingular surface $X$ over $\mathbb{F}_{q}$ with center an $\mathbb{F}_{q}$-point of $X$. Then $Z_{\tilde{X}}(t)=Z_{X}(t) \frac{1}{(1-q t)}$.

Proof. Let $N_{m}(X)$ and $N_{m}(\tilde{X})$ denote the number of $\mathbb{F}_{q^{m-p}}$ points of $X$ and $\tilde{X}$ respectively. Then $N_{m}(\tilde{X})=N_{m}(X)+q^{m}$. Hence

$$
\begin{aligned}
Z_{\tilde{X}}(t) & =\exp \left(\sum_{m=1}^{\infty}\left(N_{m}(X)+q^{m}\right) \frac{t^{m}}{m}\right) \\
& =\exp \left(\sum_{m=1}^{\infty} N_{m}(X) \frac{t^{m}}{m}\right) \exp \left(\sum_{m=1}^{\infty} q^{m} \frac{t^{m}}{m}\right) \\
& =Z_{X}(t) \frac{1}{(1-q t)}
\end{aligned}
$$

Example A. 5 Let $X_{1}=\mathbb{P}^{2}$ over $\mathbb{F}_{q}$. It is obvious that $Z_{X_{1}}(t)=\frac{1}{(1-t)(1-q t)\left(1-q^{2} t\right)}$. Define a nonsingular surface $X_{n}$ over $\mathbb{F}_{q}$ by a blowing-up of $X_{n-1}$ with center an $\mathbb{F}_{q^{-}}$ point, successively. Then the zeta function of $X_{b_{2}}$ is the same as Hermitian surface's. However, if $\sqrt{q}+1 \geq 4$, the Hermitian surface of degree $\sqrt{q}+1$ is not rational. So, if $q>2^{2}$, then the function field of $X_{b_{2}}$ does not coincides with that of the Hermitian surface over $\mathbb{F}_{q}$.
