ON THE EXTENSION TO MEAN CURVATURE FLOW IN LOWER DIMENSION

ABSTRACT. In this paper, we prove that if $M_t \subset \mathbb{R}^{n+1}$, $2 \le n \le 6$, is the *n*dimensional closed embedded F −stable solution to mean curvature flow with mean curvature of M_t is uniformly bounded on [0, *T*) for $T < \infty$, then the flow can be smoothly extended over time *T*.

1. Introduction

Let $X_0: M \to \mathbb{R}^{n+1}$ be the *n*-dimensional closed embedded submanifold of \mathbb{R}^{n+1} with $M_0 = X_0(M^n)$. Consider the mean curvature flow

$$
\frac{\partial X(p,t)}{\partial t} = -H(p,t)v(p,t),
$$

satisfying $X(\cdot, t) = X_0(t)$. Here $H(p, t)$ and $v(p, t)$ are the mean curvature and the outer unit normal at $X(p, t)$. We denote $A = (h_{ij})$ be the second fundamental form.

A natural question in the study of mean curvature flow is that what are the optimal conditions to guarantee the existence of a smooth solution to mean curvature flow? First, Huisken proved the following theorem:

Theorem 1.1 (Huisken [\[12\]](#page-5-0))**.** *Let M^t be a smooth closed solution to mean curvature flow for t* \in [0, *T*) *with* $T < \infty$ *. If the second fundamental form of Mt is uniformly bounded on* [0, *T*)*, then the flow can be smoothly extended over time T.*

So a natural question is that whether the mean curvature flow could be smoothly extended if we only give the assumptions on the mean curvature? In [\[8\]](#page-5-1) and [\[9\]](#page-5-2), Le and Sesum showed that if $M_t^n \subset \mathbb{R}^{n+1}$ is the closed mean convex or Type I solution to mean curvature flow with $||H||_{L^{\alpha}(M\times[0,T))} < \infty$ for $\alpha \geq \frac{n-2}{2}$ $\frac{-2}{2}$, then the flow can be smoothly extended over time *T*. Cooper [\[3\]](#page-5-3) also proved that if the close mean curvature flow with bounded mean curvature satisfying $|A|^p(T - t) \leq C$ for $p \in (1, 2]$, then the flow can be smoothly extended over time *T*. For this topic, one may see [\[8\]](#page-5-1) and [\[10\]](#page-5-4) the references therein for more information. It is also conjectured (see [\[10\]](#page-5-4)) that

the mean curvature flow for the hypersurfaces of Euclidean space with its dimension less or equal to 7 can be smoothly extended if the mean curvature stays bounded.

In this paper, we prove that this conjecture for the $\mathcal F$ -stable embedded hypersurfaces of Euclidean space with its dimension less or equal to 7. Recall that, in the beautiful paper [\[4\]](#page-5-5), Colding and Minicozzi studied the entropy stability of self-shrinkers in the mean curvature flow. The main tool for Colding and Minicozzi's work is the following $\mathcal F$ -functional

$$
F_{y_0,t}(M) = \int_M (4\pi t)^{-\frac{n}{2}} e^{-\frac{|x-y_0|^2}{4t}} d\mu(x), \ t \in (0,+\infty), \ y_0 \in \mathbb{R}^{n+m}, \qquad (1.1)
$$

which can be traced back to Huiskens monotonicity formula [\[13\]](#page-5-6). A selfshrinker is called $\mathcal F$ -stable if it is a local minimum for the $\mathcal F$ -functional. One is more interested in the $\mathcal F$ -stable self-shrinkers since the unstable ones could be perturbed away thus may not represent generic singularities. Colding and Minicozzi [\[4\]](#page-5-5) proved the self-shrinkers are the critical points of the $\mathcal F$ -functional and the spheres, cylinders and planes are the only $\mathcal F$ -stable self-shrinkers.

The following theorem is main result of this paper.

Theorem 1.2. *Let* M_t ⊂ \mathbb{R}^{n+1} *be a smooth closed embedded* $\mathcal{F}-stable$ *solution to mean curvature flow for* $t \in [0, T)$ *with* $T < \infty$ *, where n is the dimension of* M_t . If $2 \leq n \leq 6$ *and mean curvature of* M_t *is uniformly bounded on* [0, *T*)*, then the flow can be smoothly extended over time T.*

The organization of the paper is as follows. In section 2, we recall some basic properties for the mean curvature flow. In section 3, we give the proof of Theorem [1.2.](#page-1-0)

2. preliminaries

In this section, we recall some basic properties for the mean curvature flow.

In [\[13\]](#page-5-6), Huisken introduced his entropy which becomes one of powerful tools for studying mean curvature flow. Huisken's entropy enjoys very nice analytic and geometric properties, including in particular the monotonicity of the entropy. The Huisken's entropy is defined as the integral of backward heat kernel:

$$
\theta(M,T,y_0)=\int_M [4\pi(T-t)]^{-\frac{n}{2}}e^{-\frac{|x-y_0|^2}{4(T-t)}}d\mu(x),\ t\in(-\infty,T),\ y_0\in\mathbb{R}^n.\tag{2.1}
$$

Huisken [\[13\]](#page-5-6) proved his entropy [\(2.1\)](#page-1-1) is monotone non-increasing in *t* under the mean curvature flow.

Recall the definition of a tangent flow at a point (y_0, T) in space-time of a mean curvature flow. First translate the closed mean curvature flow *M^t* in

space-time to move (y_0, T) to $(0, 0)$ and then take a sequence of parabolic dilations $(x, t) \rightarrow (\lambda_j x, \lambda_j^2 t)$ with $\lambda_j \rightarrow \infty$ to get a sequence of mean curvature flow

$$
M_t^j = \lambda_j (M_{\lambda_j^{-2}t + T} - y_0).
$$
 (2.2)

Using Huisken's monotonicity formula [\[13\]](#page-5-6), and Brakke's compactness the-orem [\[1\]](#page-5-7), Ilmanen [\[14\]](#page-5-8) and White [\[18\]](#page-5-9) show that a subsequence of M_t^j $t \nvert t$ converges weakly to a limit flow T_t whch is called the tangent flow at (y_0, T) . The tangent flow achieve equality in Huisken's monotonicity formula and, thus, must be a self-shrinker in weak sense. Precisely,

Theorem 2.1. [\[14\]](#page-5-8) [\[18\]](#page-5-9) *For any rescaled mean curvature flow [\(2.2\)](#page-2-0), any point* (y_0, T) *, there exists a subsequence which we still denote by* λ_i *and a limiting Brakke flow* v_t *such that* $\mu_t^{\lambda_j} \rightharpoonup v_t$ *in the sense of Radon measures* for all t, where $\mu_t^{\lambda_j}$ *t is the area measure of M*^λ*^j t . Moreover,* ν[−]¹ *satisfies*

$$
\mathbf{H}_{\infty}(x) + \frac{S(x)^{\perp} \cdot x}{2} = 0, \quad v_{-1} - a.e.x,
$$

where \mathbf{H}_{∞} ∈ $L^1_{loc}(v_{-1})$ *is the mean curvature vector of* v_{-1} *in weak sense, and S* (*x*) *denotes the the projection onto the tangent space.*

In [\[4\]](#page-5-5), Colding and Minicozzi proved the following

Theorem 2.2. [\[4\]](#page-5-5) *Let T^t be a tangent flow of a mean curvature flow at a smooth closed embedded hypersurface in* \mathbb{R}^{n+1} *. If the regular part of* T_{-1} *is orientale and* F −*stable and the singular set has finite* (*n* − 2)*-dimensional Hausdorff measure and n* \leq 6, then T_{-1} *is either a round sphere or a hyperplane.*

Next we recall White's regularity theorem for the mean curvature flow.

Theorem 2.3. [\[17\]](#page-5-10) *There are numbers* $\epsilon = \epsilon(n) > 0$ *and* $C = C(n) < \infty$ *with the following property. If M^t is an n-dimensional smooth, proper embedded mean curvature flow in an open subset U of the spacetime* $\mathbb{R}^n \times \mathbb{R}$ and *if* $\theta(M, T, y_0)$ *of* M_t *are bounded above by* $1 + \epsilon$ *, then at each spacetime point* $X = (x, t)$ *of* M , the norm of the second fundamental form of M_t is *bounded by* $\frac{C}{\delta(X,U)}$, where $\delta(X,U)$ *is the infimum of* $||X-Y||$ *among all points Y* = (*y*, *s*) ∈ *U*^{*c*} *with s* ≤ *t*, *where* $\| \cdot \|$ *is the parabolic distance.*

Finally, we need the following pseudolocality theorem of the mean curvature flow due to B.L.Chen and Y.Le [\[2\]](#page-5-11).

Theorem 2.4. [\[2\]](#page-5-11) Let \overline{M} be an N-dimensional complete manifold satisfying \sum 3 *i*=0 $|\bar{\nabla}\bar{Rm}| \leq c_0^2$ $\frac{2}{0}$ and in $j(\bar{M}) \ge i_0 > 0$. Let $X_0 : M \to \bar{M}$ be an n-dimensional *properly embedded submanifold with bounded second fundamental form*

 $|A| \leq c_0$ *in* \overline{M} . We assume $M_0 = X_0(M)$ *is uniform graphic with some* $r > 0$ *. Suppose* $X(x, t)$ *is a smooth solution to the mean curvature flow on* $M \times [0, T_0]$ *with* X_0 *as initial data. Then there is* $T_1 > 0$ *depending on c*0, *i*0,*r and the dimension N such that*

$$
|A|(x,t) \le 2c_0
$$

for all $x \in M$, $0 \le t \le \min\{T_0, T_1\}$.

3. proof of Theorem [1.2](#page-1-0)

Before presenting the proof of Theorem [1.2,](#page-1-0) we need the following lemma.

Lemma 3.1. *Let* $M_t \subset \mathbb{R}^{n+1}$ *be a smooth closed embedded solution to mean curvature flow for t* \in [0, *T*) *with* $T < \infty$ *is the first singularity time. Then the hyperplane cannot arise as a tangent flow to this mean curvature flow.*

Proof. We argue by contradiction. Rescale the flow parabolically at (y_0, T) as following

$$
M_t^{\lambda_j} = \lambda_j (M_{T+\lambda_j^{-2}t} - y_0),
$$

for $\lambda_j \to \infty$. Assume T_t is the tangent flow of M_t at (y_0, T) , which is the hyperplane. By Theorem [2.1,](#page-2-1)there exists a subsequence which we still denote it by λ_j and a limiting Brakke flow v_t such that $\mu_t^{\lambda_j} \to v_t$, where $\mu_t^{\lambda_j}$ *t* is the area measure of $M_t^{\lambda_j}$ $\partial_t^{\lambda_j}$. It follows that $\theta(M_t^{\lambda_j})$ $t_1^{A_j}, 0, o) \to \theta(T_t, 0, o) = 1$ for $t < 0$. By Theorem [2.3,](#page-2-2) there exists $j_0 > 0$ such that $|A_j|$ is uniformly bounded for $j \ge j_0$ and $t < 0$, where A_j the second fundamental form of $M_t^{\lambda_j}$ t^{λ_j} . So there exists a subsequence of $M_t^{\lambda_j}$ which we still denote it by $M_t^{\lambda_j}$ *t* such that $M_t^{\lambda_j}$ $t_t^{\lambda_j}$ converges to M_t^{∞} smoothly.

We fix *j* sufficient large such that $M_T^{\lambda_j}$ T ^{*T*} T ₀ satisfies the conditions of Theo-rem [2.4](#page-2-3) and max $|A_j| \leq c_0$. Then we have

$$
M_{T-T_0}^{\lambda_j}
$$

$$
\max_{M_t^{\lambda_j}} |A_j| \le 2c_0,
$$
\n(3.1)

for $T - T_0 \le t < T$.

By the Lemma 1.2 in [\[13\]](#page-5-6), we have

$$
\max_{M_t} |A| \ge \frac{1}{2(T-t)}
$$

if the mean curvature flow blow-up at finite time *T*, where *A* is the second fundamental form of M_t . Then there exists blow-up sequence (p_i, t_i) with $p_i \rightarrow p$ such that

$$
|A|(p_i,t_i) \geq \frac{1}{2(T-t_i)}.
$$

It follows that

$$
|A_j|(p_i, \lambda_j(t_i-T)) \ge \frac{1}{2\lambda_j(T-t_i)}.
$$

For *i* large enough, this contradicts to (3.1) .

Now we give the proof of Theorem [1.2.](#page-1-0)

Proof of Theorem [1.2.](#page-1-0) We argue by contradiction. Suppose that there exists a mean curvature flow blows up at finite time and satisfying the condi-tions of Theorem [1.2.](#page-1-0) Rescale the flow parabolically at (y_0, T) as following

$$
M_t^{\lambda_j} = \lambda_j (M_{T+\lambda_j^{-2}t} - y_0),
$$

for $\lambda_j \to \infty$. Assume T_t is the tangent flow of M_t at (y_0, T) . By Theorem [2.1,](#page-2-1) there exists a subsequence which we still denote it by λ_i and a limiting Brakke flow v_t such that $\mu_t^{\lambda_j} \to v_t$, where $\mu_t^{\lambda_j}$ λ_j ^{*t*} is the area measure of $M_t^{\lambda_j}$ *t* . Moreover, v_{-1} satisfies

$$
\mathbf{H}_{\infty}(x) + \frac{S(x)^{\perp} \cdot x}{2} = 0, \quad v_{-1} - a.e.x,
$$

where \mathbf{H}_{∞} ∈ $L^1_{loc}(v_{-1})$ is the mean curvature vector of v_{-1} in weak sense, and $S(x)$ denotes the the projection onto the tangent space. Since mean curvature of M_t is uniformly bounded, $\mathbf{H}_{\infty} \equiv 0$ *a.e.* It follows that the tangent flow T_t is the minimal cone and the conditions of Theorem [2.2](#page-2-4) are satisfied. By Theorem [2.2,](#page-2-4) we conclude that *T*[−]¹ is either a round sphere or a hyperplane. This contradicts to Lemma [3.1](#page-3-1) and \mathbf{H}_{∞} ≡ 0. \Box

Remark 3.2. We remark that the condition $|H| \leq C$ on $[0, T)$ in Theorem [1.2](#page-1-0) can be replaced by the weak condition $||H||_{L^{\alpha}(M_t \times [0,T))} < \infty$ for $\alpha \ge \frac{n+2}{2}$ $\frac{+2}{2}$, where $H(\cdot, t)$ is the mean curvature of M_t . The reason is as follows. We still rescale the flow parabolically at (y_0, T) as following

$$
M_t^{\lambda_j} = \lambda_j (M_{T+\lambda_j^{-2}t} - y_0),
$$

for $\lambda_j \to \infty$ and denote $H_j(\cdot, t)$ be the mean curvature of $M_t^{\lambda_j}$ $T_t^{\lambda_j}$. Assume T_t is the tangent flow of M_t at (y_0, T) and $H_\infty(\cdot, t)$ is the mean curvature of T_t . We calculate

$$
\int_{-2}^{-1} \int_{B(o,R)\cap T_t} |H_{\infty}|^{\frac{n+2}{2}} d\nu_t dt \leq \lim_{j\to\infty} \int_{-2}^{-1} \int_{B(o,R)\cap M_t^j} |H_j|^{\frac{n+2}{2}} d\mu_t^j dt
$$

\n
$$
= \lim_{j\to\infty} \int_{T-2(\lambda_j)^{-1}}^{T-(\lambda_j)^{-1}} \int_{B(y_0,\lambda_j^{-\frac{1}{2}})\cap M_t} |H|^{\frac{n+2}{2}} d\mu_t dt
$$

\n
$$
\leq \lim_{j\to\infty} \int_{T-2(\lambda_j)^{-1}}^{T-(\lambda_j)^{-1}} \int_{M_t} |H|^{\frac{n+2}{2}} d\mu_t dt
$$

\n
$$
= 0.
$$

The last equality holds, since $\int_0^T \int_{M_t} |H|^{\frac{n+2}{2}} d\mu dt < \infty$. Then we conclude that $H_{\infty} \equiv 0$ a.e. Then we still can argue by the same way as the the proof of Theorem [1.2.](#page-1-0)
