# POWER SERIES DETERMINED BY AN EXPERIMENT ON THE UNIT INTERVAL

### Abstract

We consider the linear combinations of elements of two sequences: the first one a priory given nonnegative sequence and the second random sequence from the unit interval. We investigate the expected value of the smallest natural number such that the value of these linear combinations exceed a positive number. After very clear geometrical conclusions, we find the function which expresses the expected value. Here, we recognize a few known results like the special cases.

## 1 Introduction

The well known number  $e \approx 2.71818...$  appeared like an expected value in a trial problem by Putnam [\[1\]](#page-8-0) in 1958. This wonderful, riddle-like problem motivated others to solve it in various ways [\[4\]](#page-8-1). Even more, B. Curgus and ´ R.I. Jewetts [\[2\]](#page-8-2) have considered like a function of upper bound which should be exceed. In that manner, they have got the exponential function.

In this paper, we will expose our generalization of this problem. Namely, consider the next experiment.

#### Procedure.

Let  $a = \{a_k\}_{k \in \mathbb{N}}$  be a given positive nondecreasing sequence, i.e.

$$
0 < a_1 \le a_2 \le a_3 \le \dots \le a_k \le a_{k+1} \le \dots \tag{1}
$$

To any random sequence  $x = \{x_n\}$   $(x_n \in [0,1], \forall n \in \mathbb{N})$ , we can join the finite sequence of weighted partial sums

$$
S_{k,m}(a,x) = a_k x_k + a_2 x_2 + \cdots + a_m x_m.
$$

Take  $t > 0$ .

Step 1. Take a random number  $x_1$  from the interval [0, 1] and denote  $n = 1$ . Step 2. If  $S_{1,n}(x, a) > t$ , then memorize the value *n* and stop.

Step 3. If  $S_{1,n}(x, a) \leq t$ , then increase n into  $n + 1$ , take the next random number  $x_n$  from [0, 1] and return to Step 2.

Repeat this procedure enough times. What is the expected value for  $n$ ? We are looking for the expectation

$$
f(t,a) = E\{n \in \mathbb{N} : S_{1,n-1}(x,a) \le t < S_{1,n}(x,a)\}.\tag{2}
$$

Denote with  $p_m(t)$  the following function

$$
p_m = \mu(P_m)
$$
, where  $P_m = \{x \in [0,1]^m : S_{1,m}(a,x) \le t\}$ . (3)

Here,  $\mu$  is the Euclidean measure in  $\mathbb{R}^m$ .

The expected value for  $n$  is

$$
f(t, a) = \sum_{m=0}^{\infty} m(p_{m-1} - p_m).
$$

If it is fulfilled

$$
\lim_{m \to \infty} m p_m = 0,\t\t(4)
$$

then

$$
f(t,a) = \sum_{n=0}^{\infty} p_n.
$$
 (5)

Also, we will use notation

$$
(t)_{+} = \begin{cases} t, & t > 0, \\ 0, & t \le 0, \end{cases} \qquad f_{+}(t) = \begin{cases} f(t), & f(t) > 0, \\ 0, & f(t) \le 0. \end{cases}
$$

## 2 The geometrical approach

Here, we will expose cases which can be illustrated by one, two and three dimensional figures.

We accept  $p_0 = 1$ .

In one dimensional space, there are 2 cases:

(1.1) For  $0 \le t \le a_1$ , i.e., when is valid  $t/a_1 \le 1$ , the border point is  $X_1(t/a_1)$ . Hence  $P_1 = X_1 O$ , and the measure is

$$
p_1 = \mu(P_1) = \frac{t}{a_1} \; .
$$

(1.2) For  $a_1 < t$ , it is  $P_1 = [0, 1]$ , and  $p_1 = 1$ .

In two dimensional space, the line  $a_1x_1 + a_2x_2 = t$  passes through the points  $X_1(t/a_1, 0), X_2(0, t/a_2).$ 

(2.1) For  $0 \le t \le a_1$ , the whole segment  $X_2X_1$  belongs to the square  $[0,1]^2$ . Hence  $P_2$  is the interior of the triangle  $X_2X_1O$  and the measure is

$$
p_2 = \mu(X_2 X_1 O) = \int_0^{t/a_1} dx_1 \int_0^{(t-a_1 x_1)/a_2} dx_2 = \frac{1}{2} \frac{t}{a_1} \frac{t}{a_2}.
$$

(2.2) Let  $a_1 < t \le a_2$ . This condition guarantees that the points  $O(0,0)$  and  $S(1,1)$  are from the different sides of the line  $a_1x_1 + a_2x_2 = t$ . That is why it exists the cutting segment of this line and the unit square. Since  $t - a_1 > 0$ , or equivalently  $1 < t/a_1$ , the point  $X_1$  is outside the unit square, like on the Figure 3a. Hence

$$
p_2 = \frac{t^2 - (t - a_1)^2}{2a_1a_2}.
$$

(2.3) Let  $a_2 < t \le a_1 + a_2$ . In that case (see Figure 3b), the segment  $X_1 X_2$ contains the points  $B(1,(t-a_1)/a_2)$  and  $C((t-a_2)/a_1, 1)$ . This line divides the square  $[0,1]^2$  into 2 pieces. Hence

$$
P_2 = \overline{OS_{1,0}BCS_{0,1}} = \overline{X_2X_1O} \setminus (\overline{X_1S_{1,0}B} \cup \overline{X_2CS_{0,1}}),
$$

wherefrom

$$
p_2 = \mu(P_2) = \frac{1}{2} \frac{t}{a_1} \frac{t}{a_2} - \frac{1}{2} \left( \frac{t}{a_1} - 1 \right) \frac{t - a_1}{a_2} - \frac{1}{2} \left( \frac{t}{a_2} - 1 \right) \frac{t - a_2}{a_1},
$$

i.e.

$$
p_2 = \frac{t^2 - (t - a_1)^2 - (t - a_2)^2}{2a_1a_2}.
$$

We can unify (2.1-3) into one formula:

$$
p_2(t) = \frac{1}{2a_1a_2} \left(t^2 - \sum_{k=1}^2 (t - a_k)^2\right) \qquad (0 \le t \le a_1 + a_2).
$$

 $(2.4)$  For  $a_1 + a_2 < t$ , it is valid

$$
a_1x_1 + a_2x_2 \le a_1 + a_2 < t \quad (\forall x_1, x_2 \in [0, 1])
$$

Hence  $P_2 = [0, 1]^2$ , and  $p_2 = 1$ .

For arbitrary dimensional space, the hyper-plane  $a_1x_1 + \cdots + a_mx_m = t$ passes through the points

$$
X_1(t/a_1, 0, 0, \ldots, 0), X_2(0, t/a_2, 0, \ldots, 0), \ldots, X_m(0, 0, \ldots, 0, t/a_m).
$$

For  $0 \leq t \leq a_1$ , the measure of the *m*-dimensional solid between this hyperplane and coordinate hyper-planes is

$$
\mu(X_m \dots X_1 O) = \int_0^{\frac{t}{a_1}} dx_1 \int_0^{\frac{t - a_1 x_1}{a_2}} dx_2 \cdots \int_0^{\frac{t - a_1 x_1 - \cdots - a_{m-1} x_{m-1}}{a_m}} dx_m,
$$

i.e.,

$$
\mu(X_m \dots X_1 O) = \frac{t^m}{m! \prod_{j=1}^m a_j}
$$

Applying the formula [\(5\)](#page-1-0), we get

$$
f_0(t; a_1) = \sum_{m=0}^{\infty} \frac{t^m}{m! \prod_{j=1}^m a_j} \qquad (t \in [0, a_1]).
$$
 (6)

.

## 3 The analytical approach

Let us denote by

$$
f_n(t; a_k) = \sum_{i=n}^{\infty} \frac{t^i}{i! \prod_{j=k}^{i+k-1} a_j} \qquad (t \in [0, a_k]) (n \in \mathbb{N}_0; k \in \mathbb{N}).
$$
 (7)

We accept  $f_n(t; a_k) \equiv 0$   $(t < 0)$ .

It is important to note that the functions  $f_n(t; a_k)$  are defined for every  $t > 0$ according to D'Alambert criteria and the the fact  $\inf\{a_i\} = a_1 > 0$ .

**Lemma 3.1** *The next relations are true for all*  $k, n \in \mathbb{N}$ *:*

$$
f_n(t; a_k) = \frac{t^n}{n! \prod_{i=k}^{n+k-1} a_i} + f_{n+1}(t; a_k),
$$
  
\n
$$
f'_0(t; a_k) = \frac{1}{a_k} f_0(t; a_{k+1}),
$$
  
\n
$$
f'_n(t; a_k) = \frac{1}{a_k} f_{n-1}(t; a_{k+1})
$$
  
\n
$$
f_0(t; a_{k+n}) = f_0^{(n)}(t; a_k) \prod_{\substack{i=k \ i \neq k}}^{k+n-1} a_i
$$
  
\n
$$
f_0(t; a_{n+1}) = f_n^{(n)}(t; a_1) \prod_{i=1}^n a_i.
$$
\n(8)

The function  $f(t, a)$  is known on  $(0, a_1)$ . It is

$$
f(t, a) = f_0(t; a_1).
$$

<span id="page-4-0"></span>Lemma 3.2 *It is valid*

$$
f(t,a) = 1 + f_{1,+}(t;a_1) - f_{1,+}(t-a_1;a_1) \qquad (a_1 < t \le a_2).
$$

*Proof.* If we take  $a_1 < t \le a_2$ , and a number  $x_1 \in [0, 1]$ , then

$$
f(t-a_1x_1,a)=E\{m\in\mathbb{N}:S_{2,m-1}\leq t-a_1x_1
$$

Including the average of  $f_{0,+}(t - a_1x_1; a_2)$  when  $x_1 \in [0, 1]$ , we have

$$
f(t,a) = 1 + \int_0^1 f_{0,+}(t - a_1 x_1; a_2) dx_1 \qquad (a_1 < t \le a_2).
$$
 (9)

By change  $z = t - a_1 x_1$ , and the fact  $f_{0,+}(z; a_2) = a_1 f'_{1,+}(z; a_1)$ , yield

$$
f(t,a) = 1 + \frac{1}{a_1} \int_{t-a_1}^t f_{0,+}(z;a_2) dz = 1 + \int_{t-a_1}^t f'_{1,+}(z;a_1) dz,
$$

<span id="page-4-1"></span>what finishes the proof.  $\Box$ 

**Lemma 3.3** *If*  $a_2 < t \le a_3$ *, then* 

$$
f(t,a) = 2 + f_{2,+}(t;a_1) - \sum_{k=1}^{2} f_{2,+}(t-a_k;a_1) + f_{2,+}(t-a_1-a_2;a_1).
$$

*Proof.* If we take two numbers  $x_1, x_2 \in [0, 1]$ , then

$$
f(t-a_1x_1-a_2x_2, a) = E\{m \in \mathbb{N} : S_{3,m-1} \le t-a_1x_1-a_2x_2 < S_{3,m}\},
$$

i.e.,

$$
f(t - a_1x_1 - a_2x_2, a) = f_{0,+}(t - a_1x_1 - a_2x_2; a_3).
$$

Including the average of  $f_{0,+}(t - a_1x_1 - a_2x_2; a_3)$  when  $x_1, x_2 \in [0, 1]$ , we have

$$
f(t,a) = 2 + \int_0^1 dx_1 \int_0^1 f_{0,+}(t - a_1 x_1 - a_2 x_2; a_3) dx_2 \qquad (a_1 + a_2 < t \le a_3). \tag{10}
$$

By change  $z = t - a_1x_1 - a_2x_2$ , we yield

$$
f(t,a) = 2 + \frac{1}{a_2} \int_0^1 dx_1 \int_{t-a_1x_1-a_2}^{t-a_1x_1} f_{0,+}(z;a_3) dz.
$$

Since

$$
f_{0,+}(z;a_3) = a_2 f'_{1,+}(z;a_2) = a_1 a_2 f''_{2,+}(z;a_1),
$$

we have

$$
f(t,a) = 2 + \int_0^1 f'_{2,+}(t-a_1x_1; a_1)dx_1 - \int_0^1 f'_{2,+}(t-a_2-a_1x_1; a_1)dx_1.
$$

Applying the Lemma [3.2,](#page-4-0) we finish the proof.  $\Box$ 

Notice that the conclusions from the previous lemmas can be written in the following forms:

$$
f(t, a) = 1 + \sum_{k=0}^{1} (-1)^k \sum_{0 \le i_0 < l_1 \le 1} f_{1,+} \left( t - \sum_{j=1}^k a_{i_j}; a_1 \right) \qquad (a_1 < t \le a_2)
$$
\n
$$
f(t, a) = 2 + \sum_{k=0}^{2} (-1)^k \sum_{0 \le i_0 < l_1 < i_2 \le 2} f_{2,+} \left( t - \sum_{j=1}^k a_{i_j}; a_1 \right) \qquad (a_2 < t \le a_3)
$$

**Theorem 3.4** *If*  $a_n < t < a_{n+1}$ *, it is valid* 

<span id="page-5-0"></span>
$$
f(t,a) = n + \sum_{k=0}^{n} (-1)^k \sum_{0 \le i_0 < \dots < i_k \le k} f_{n,+} \left( t - \sum_{j=1}^{k} a_{i_j}; a_1 \right) \tag{11}
$$

*Proof.* We will prove by mathematical induction. For  $n = 1$  it is proven in Lemma [3.2.](#page-4-0) Also, for  $n = 2$  it is proven in Lemma [3.3.](#page-4-1)

Let us suppose that the formula  $(11)$  is true for *n*. If we take numbers  $x_1, x_2, \ldots, x_{n+1} \in [0, 1]$ , then

$$
f(t-S_{1,n+1},a) = E\{m \in \mathbb{N} : S_{n+2,m-1} \le t - S_{1,n+1} < S_{n+2,m}\},
$$

i.e.,

$$
f(t - S_{1,n+1}, a) = f_{0,+}(t - S_{1,n+1}; a_{n+2}) \qquad (n+1 < m).
$$

Including the average of  $f_{0,+}(t - S_{1,n+1}; a_{n+2})$  when  $x_1, x_2, \ldots, x_{n+1} \in [0,1],$ we have

$$
f(t,a) = n+1+\int_0^1 dx_1 \cdots \int_0^1 dx_n \int_0^1 f_{0,+}(t-a_1x_1-\cdots-a_{n+1}x_{n+1};a_{n+2})dx_{n+1},
$$

By change  $z = t - a_1 x_1 - \cdots - a_{n+1} x_{n+1}$ , we yield

$$
f(t, a) = n + 1 +
$$
  

$$
\frac{1}{a_{n+1}} \int_0^1 dx_1 \cdots \int_0^1 dx_n \int_{t-a_1x_1-\cdots-a_nx_n-a_{n+1}}^{t-a_1x_1-\cdots-a_nx_n} f_{0,+}(z; a_{n+2}) dz,
$$

Applying the relations [\(8\)](#page-3-0), we have

$$
f_{0,+}(z; a_{n+2}) = f_{n+1,+}^{(n+1)}(z; a_1) \prod_{i=1}^{n+1} a_i,
$$

wherefrom

$$
f(t, a) = n + 1
$$
  
+ 
$$
\prod_{i=1}^{n} a_i \left( \int_0^1 dx_1 \cdots \int_0^1 dx_{n-1} \int_0^1 f_{n+1,+}^{(n)}(t - a_1 x_1 - \cdots - a_n x_n; a_1) dx_n - \int_0^1 dx_1 \cdots \int_0^1 dx_{n-1} \int_0^1 f_{n+1,+}^{(n)}(t - a_{n+1} - a_1 x_1 - \cdots - a_n x_n; a_1) dx_n \right)
$$

.

The integrals are average values for the functions  $f_{n+1,+}(t-a_1x_1-\cdots-a_nx_n; a_1)$ and  $f_{n+1,+}(t - a_{n+1} - a_1x_1 - \cdots - a_nx_n; a_1)$  when  $x_1, x_2, \ldots, x_n \in [0,1]$ . That is why we can apply inductional assumption. Hence

$$
f(t, a) = n + 1 + \left(n - 1 + \sum_{k=0}^{n-1} (-1)^k \sum_{0 \le i_0 < \dots < i_k \le k} f_{n+1,+}\left(t - \sum_{j=1}^k a_{i_j}; a_1\right)\right)
$$

$$
- \left(n - 1 + \sum_{k=0}^{n-1} (-1)^k \sum_{0 \le i_0 < \dots < i_k \le k} f_{n+1,+}\left(t - a_{n+1} - \sum_{j=1}^k a_{i_j}; a_1\right)\right).
$$

By simplifying, we get the formula [\(11\)](#page-5-0) for  $n + 1$ , what finishes the proof.  $\Box$ 

## 4 Examples

We prepared the programs in the software *Mathematica* to test our conclusions. We used the function RandomReal [0,1, WorkingPrecision->32]. Blue points are provided on the next figures in this way every after 500 random chosen numbers.

### 4.1 The Laguerre-type exponential function

The *Laguerre-type exponential function* were introduced by G. Dattoli [\[3\]](#page-8-3):

$$
e_s(t) = \sum_{n=0}^{\infty} \frac{t^n}{(n!)^{s+1}} \quad (0 \le t \le 1)(s \in \mathbb{N}_0).
$$

From the previous consideration, we cane establish the next statement.

**Corollary 4.1** When  $a_k = k^s$   $(k \in \mathbb{N})(s \ge 0)$ *, it is valid* 

$$
f(t,a) = \begin{cases} e_s(t), & (0 \le t \le 1) \\ e_s(t) - e_s(t-1) + 1, & (1 < t \le 2^s). \end{cases}
$$

*In general, in the formula [\(11\)](#page-5-0) appears the next fuction*

$$
f_{n,+}(t) = e_s(t) - \sum_{k=0}^{n-1} \frac{t^i}{(i!)^{s+1}}.
$$

**Remark 4.1** The case  $s = 0$  was examined in [\[2\]](#page-8-2). Since  $a = \{1\}$ , we easily find that  $f(t, a) = e^t$  for  $0 \le t \le 1$ , but our approach can not give  $f(t, a)$  for  $t > 1$ .



## 4.2 The Laguerre-type  $q$ -exponential function

Another theoretically interesting example is the case

$$
a_k = 1 - q^k \qquad (0 \le q < 1) \ (k \in \mathbb{N}).
$$

It is leading to a *Laguerre type* q*–exponential function*[\[5\]](#page-8-4)

$$
e_{1,q}(t) = \sum_{n=0}^{\infty} \frac{t^n}{n!(q;q)_n} \quad (0 < t \le 1 - q).
$$

Here

$$
(q;q)_0 = 1,
$$
  $(q;q)_n = \prod_{k=1}^n (1-q^k) \quad (n \in \mathbb{N}).$
