# A continuous/discontinuous Galerkin method and a priori error estimates for the biharmonic problem on surfaces

#### Abstract

We present a continuous/discontinuous Galerkin method for approximating solutions to a fourth order elliptic PDE on a surface embedded in  $\mathbb{R}^3$ . A priori error estimates, taking both the approximation of the surface and the approximation of surface differential operators into account, are proven in a discrete energy norm and in  $L^2$  norm. This can be seen as an extension of the formalism and method originally used by Dziuk [\[14\]](#page-40-0) for approximating solutions to the Laplace–Beltrami problem, and within this setting this is the first analysis of a surface finite element method formulated using higher order surface differential operators. Using a polygonal approximation  $\Gamma_h$  of an implicitly defined surface  $\Gamma$  we employ continuous piecewise quadratic finite elements to approximate solutions to the biharmonic equation on Γ. Numerical examples on the sphere and on the torus confirm the convergence rate implied by our estimates.

### 1 Introduction

#### 1.1 Model problem and earlier work

Numerical solutions to fourth order PDE on surfaces have several applications, for example thin shells [\[7\]](#page-39-0), the Cahn–Hilliard equations [\[6\]](#page-39-1), or lubrication modeling [\[24\]](#page-40-1). In this paper we for purposes of method development and analysis consider the following fourth order model problem. Let  $\Gamma$  be a smooth two-dimensional surface without boundary embedded in  $\mathbb{R}^3$ . For f satisfying  $\int_{\Gamma} f ds = 0$ , find u satisfying  $\int_{\Gamma} u ds = 0$  such that

\Delta_{\Gamma}^2 u = f \quad \text{on } \Gamma \tag{1.1}
$$

where  $\Delta_{\Gamma}^2 u := \Delta_{\Gamma}(\Delta_{\Gamma} u)$  and  $\Delta_{\Gamma}$  is the Laplace–Beltrami operator. We call this the biharmonic equation on the surface  $\Gamma$ .

We follow the formalism first used in [\[14\]](#page-40-0) for solving the Laplace–Beltrami problem where  $\Gamma$  is implicitly defined using an oriented distance function and the surface differential operators are constructed using the tangential gradient  $\nabla_{\Gamma} := P \nabla$ , i.e. the projection of the Cartesian gradient onto the tangential plane. These initial results have since been extended in various ways and for various problems formulated using the second order Laplace–Beltrami operator, yielding weak formulations with terms of the form  $\int_{\Gamma} \nabla_{\Gamma} u \cdot \nabla_{\Gamma} v \, ds$  (cf. [\[5,](#page-39-2)[11](#page-39-3)[–13,](#page-40-2)[16,](#page-40-3)[19,](#page-40-4)[23\]](#page-40-5)). By employing a second order splitting method [\[16\]](#page-40-3) also consider fourth order linear diffusion and the Cahn–Hilliard equation in the same framework yielding two coupled systems of equations. In this paper we however develop a method and analysis based on a more direct approach for the fourth order surface bi-Laplacian  $\Delta_{\Gamma}^2$ . We propose and implement a continuous/discontinuous Galerkin (c/dG) method [\[18\]](#page-40-6) for the biharmonic equation on a surface and extend the analysis in [\[14\]](#page-40-0) to cover this method. For the second order Laplace–Beltrami problem discontinuous Galerkin methods was considered in [\[1,](#page-39-4) [9\]](#page-39-5).

The advantages of using implicitly defined surfaces rather than global or local parameterizations are several. As can be seen in [\[14\]](#page-40-0) implementation and analysis becomes fairly straightforward. The formalism is also suitable for problems where parameterization is unavailable, as may be the case in problems on evolving surfaces (cf. [\[15,](#page-40-7)[23\]](#page-40-5)). For a more thorough review of finite element methods for various surface PDE we refer to [\[17\]](#page-40-8).

#### 1.2 Main contributions

To our knowledge, this paper is the first paper presenting an analysis of a surface finite element method formulated using higher order surface differential operators, i.e. operators other than  $\nabla_{\Gamma}$ , in the framework introduced in [\[14\]](#page-40-0). The formalism and tools in the framework is extended which will be valuable in future analysis of both conforming and non-conforming finite element methods for higher order PDE on surfaces. In particular, higher order tangential derivatives in the embedded setting are carefully defined such that they are independent of artificial out-of-plane components in lower order derivatives. From this follows clearly formulated surface Sobolev spaces of arbitrary order. Further, the proof of the  $L^2$  estimate requires a more refined approach, compared to the case of the Laplace–Beltrami operator, which utilizes the high regularity of the exact solution and the solution to the dual problem.

In the remainder of this section we summarize the main contributions of the paper. For increased readability this summary is written in an informal fashion and we leave technicalities such as formally defining operations on functions defined on different domains for Section [3.](#page-5-0)

Higher order differential operators on surfaces: As the first surface finite element method in the framework of [\[14\]](#page-40-0) formulated using higher order differential operators, a number of definitions and technical results are needed for implementation and analysis. Especially, we give the following contributions.

• Definitions of higher order surface differential operators (other than the Laplace– Beltrami operator) and higher order surface Sobolev spaces in a tangential calculus setting, see §[3.4.](#page-9-0)

• Lemma [3.3](#page-9-1) for Sobolev norm comparison between the exact and approximate surface, is a substantial extension of results in [\[14,](#page-40-0) Lemma 3.1] and [\[11\]](#page-39-3). In particular, the addition of estimate [\(3.34\)](#page-9-2) greatly augment the use of this lemma when working with higher order Sobolev spaces.

A priori energy error estimate: Let  $u<sub>h</sub>$  be the finite element solution to the method: Find  $u_h \in W_h$  such that  $a_h(u_h, v_h) = l_h(v_h)$  for all  $v_h \in W_h$ , where  $W_h$  is the finite element space based on continuous piecewise quadratic interpolation over  $\Gamma_h$ . Here  $a_h(\cdot, \cdot)$  is the symmetric bilinear form of the continuous/discontinuous Galerkin (c/dG) method formulated using approximate surface differential operators based on  $\Gamma_h$ . Also, both  $a_h(\cdot, \cdot)$  and the linear functional  $l_h(\cdot)$  are integrated over  $\Gamma_h$ . Based on the exact geometry Γ we have the corresponding bilinear form  $a(·, ·)$  and linear functional  $l(·)$  for which  $a(u, v) = l(v)$  for all  $v \in H^4(\Gamma) + W_h$  where u is the exact solution to [\(1.1\)](#page-0-0). The following error estimate (see Theorem [5.10\)](#page-22-0) holds

||u - u_h||_{\Gamma} \le Ch ||f||_{L^2(\Gamma)} \tag{1.2}

where C is a mesh independent constant and  $\|\cdot\|_{\Gamma}$  is the energy norm. The proof of this estimate follows from the first Strang lemma and we derive estimates for the following three terms

$$
|\|u - u_h\|_{\Gamma} \lesssim \|\|u - \pi u\|_{\Gamma} + \sup_{w_h \in W_h} \frac{|a(\pi u, w_h) - a_h(\pi u, w_h)|}{\|w_h\|_{\Gamma}}

\sup_{w_h \in W_h} \frac{|l(w_h) - l_h(w_h)|}{\|w_h\|_{\Gamma}}

where  $\pi : H^4(\Gamma) + W_h \to W_h$  is an interpolant. As this is a fourth order problem the first term above, i.e. the interpolation error in energy norm, will be  $\mathcal{O}(h)$  as  $W_h$  is based on quadratic interpolation. While increasing the order of geometry approximation from linear (facets) to piecewise quadratic would improve the estimates for the two last terms in [\(1.3\)](#page-2-0), i.e. the quadrature error, it would not affect the interpolation term. Thus, only increasing the order of geometry interpolation would not increase the order of convergence in this method.

Non-standard analysis for the  $L^2$  estimate: As Galerkin orthogonality doesn't hold due to geometry approximation, i.e. for  $v \in W_h$  we typically have  $a(u - u_h, v) \neq 0$ , we will get a remainder term when using a duality argument (Aubin–Nitsche's trick) to derive an  $L^2$  estimate (see Theorem [5.11\)](#page-23-0). In particular, letting  $\phi \in H^4(\Gamma)$  be the solution to a dual problem, we similarly to the Strang lemma get the following expression in the proof of Theorem [5.11](#page-23-0)

$$
||u - u_h||_{L^2(\Gamma)/\mathbb{R}}^2 = a(u - u_h, \phi - \pi\phi) + a(u - u_h, \pi\phi)
$$
\n(1.4)

where the first term is  $\mathcal{O}(h^2)$  due to the error and interpolation estimates in energy norm, and the second term is also  $\mathcal{O}(h^2)$ , see [\(5.57\)](#page-19-0). However, for the third term using the same estimates as in the energy norm estimate only gives  $\mathcal{O}(h)$ , see [\(5.58\)](#page-19-1), which is not sharp enough. This estimate can be improved as follows. By adding and subtracting terms, and using error and interpolation energy norm estimates, the problem of estimating the third term is transformed into estimating

where it is important to note that  $u, \phi \in H^4(\Gamma)$  by elliptic regularity. The regularity of u and  $\phi$  is then utilized in the following results:

- Lemma [3.2](#page-8-0) is a non-standard geometry approximation result for  $P_h \cdot n$ , the exact normal projected onto the approximate tangential plane, where we instead of using max-norm estimates prove an estimate for  $(P_h \cdot n) \cdot \chi$  integrated over  $\Gamma_h$  where  $\chi$  is a sufficiently regular vector valued function. The resulting estimate is of one order higher than the max-norm estimate for  $P_h \cdot n$ .
- In estimate [\(5.59\)](#page-19-2) in Lemma [5.7](#page-19-3) we prove that the expression in [\(1.6\)](#page-3-0) is  $\mathcal{O}(h^2)$ . For all non-zero terms in [\(1.6\)](#page-3-0) we employ Lemma [3.2](#page-8-0) to obtain the correct order.

An increase in geometry interpolation to continuous piecewise quadratics would not improve the order of convergence for the  $L^2$  estimate either as the first term in  $(1.5)$  would still only be  $\mathcal{O}(h^2)$  by the error and interpolation estimates in energy norm. However, in this case the estimate of the third term can be done using standard techniques. We finally remark that in the case of the Laplace–Beltrami operator the corresponding estimate of the third term is  $\mathcal{O}(h^2)$  and can be derived using standard techniques.

#### 1.3 Outline

The remainder of this paper is dispositioned as follows. In §[2](#page-4-0) we introduce the geometric description of the surface Γ and define tangential derivatives of arbitrary order which we use to define the surface differential operators. Using the tangential derivatives we define suitable Sobolev spaces of any order on curved surfaces. In §[3](#page-5-0) we provide assumptions and geometry approximation results for a triangulation  $\Gamma_h$  of the exact surface  $\Gamma$ . By extending the domain of functions defined on either  $\Gamma$  and  $\Gamma_h$  to a volumetric neighborhood to Γ we also provide comparisons of functions in surface Sobolev norms on Γ and  $\Gamma_h$ . In §[4](#page-10-0) we begin by introducing the biharmonic problem on surfaces and derive a broken weak formulation of the problem with bilinear form  $a(\cdot, \cdot)$  and linear functional  $l(\cdot)$ . A continuous/discontinuous Galerkin method is then formulated using surface differential operators and integration based on the approximate surface  $\Gamma_h$  rendering an approximate bilinear form  $a_h(\cdot, \cdot)$  and linear functional  $l_h(\cdot)$ . As approximation space we choose the space of continuous piecewise quadratic functions over  $\Gamma_h$ . We derive a priori error esti-mates for this method in §[5,](#page-13-0) both in a discrete energy norm and in  $L^2$  norms on  $\Gamma$  and  $\Gamma_h$ . Finally, to support our theoretical findings we in §[6](#page-25-0) give numerical results for two model problems with known analytical solutions.

### <span id="page-4-0"></span>2 Surface geometry and differential operators

Let  $\Gamma$  be a smooth two-dimensional surface without boundary embedded in  $\mathbb{R}^3$ . Assuming that Γ is represented by an oriented distance function  $d(x)$ , giving positive values on the exterior of  $\Gamma$ , we have an outward pointing unit normal given by  $n(x) = \nabla d(x) \in \mathbb{R}^3$ and extended Weingarten map given by  $H(x) = \nabla^2 d \in \mathbb{R}^{3 \times 3}$ . The eigenvalues of H are  $\{\kappa_1(x), \kappa_2(x), 0\}$  with corresponding orthogonal eigenvectors where the eigenvector corresponding to the zero eigenvalue is in the normal direction  $n(x)$ . For  $x \in \Gamma$ ,  $\{\kappa_i\}$  are the principal curvatures of  $\Gamma$  and thus tr( $H$ ) = 2N, where N is the mean curvature.

We now turn to introducing the differential operators used to describe our equations on Γ and we also introduce the appropriate Sobolev spaces.

#### 2.1 Tangential differential calculus

As in [\[14\]](#page-40-0) we define the operators using tangential differential calculus [\[10\]](#page-39-6), avoiding the need for local coordinates and Christoffel symbols. The tangential projection along  $\Gamma$  is given by  $P = I - n \otimes n$  and we use this projection to define differential operators on the surface expressed in the global Cartesian coordinate system.

In any of the literature cited in the introduction we have not found any explicit definition, or reference to such, of surface differential operators  $D_{\Gamma}^k w$  for  $k \geq 2$  in an embedded setting such that these only contain tangential derivatives of order k. For example, as noted in [\[10\]](#page-39-6), the Hessian  $\nabla_{\Gamma} \otimes \nabla_{\Gamma} w$  will be unsymmetric and contain outof-plane components. We therefore provide an effort in this paper to explicitly define higher order surface differential operators and surface Sobolev spaces in an embedded setting.

#### <span id="page-4-2"></span>2.2 Surface Sobolev spaces

Let  $L^2(\Gamma)$  be the usual  $L^2$ -space on  $\Gamma$  with norm  $||T||_{L^2(\Gamma)} := (\int_{\Gamma} T : T ds)^{1/2}$  where  $T$  is a tensor (in the sense of a multi-linear array) and : denotes contraction in every tensorial dimension. Further, let  $H^m(\Gamma)$ ,  $m \in \mathbb{N}_0^+$ , be Sobolev spaces on  $\Gamma$  with norm and semi-norm

$$
||w||_{H^m(\Gamma)}^2 := \sum_{k=0}^m |w|_{H^k(\Gamma)}^2 \quad \text{and} \quad |w|_{H^k(\Gamma)} := ||D_{\Gamma}^k w||_{L^2(\Gamma)} \tag{2.1}
$$

respectively, where  $D_{\Gamma}^{k}w$  is the tensor of order k tangential derivatives defined by

D_{\Gamma}^{k} w := \begin{cases} w & \text{for } k = 0\\ \left\lfloor \left( D_{\Gamma}^{k-1} w \right) \otimes \nabla \right\rfloor_{P} & \text{for } k \ge 1 \end{cases}

Here the arrow over the gradient indicates that  $\overleftarrow{\nabla}$  operates to the left and  $\lfloor \cdot \rfloor_P$  denotes the projection onto the tangent space in each tensorial dimension. To express this projection more formally we use the *n*-mode product denoted  $\times_n$  which for a k:th order tensor  $T \in \mathbb{R}^{3 \times \cdots \times 3}$  and a matrix  $A \in \mathbb{R}^{3 \times 3}$  componentwise is defined as

$$
(T \times_n A)_{i_1 i_2 \cdots i_k} = \sum_{j=1}^3 T_{i_1 \cdots i_{n-1} j i_{n+1} \cdots i_k} A_{i_n j} \qquad \text{for } i_1, \cdots, i_k \in \{1, 2, 3\} \tag{2.3}
$$

see eg. [\[21,](#page-40-9) Sect. 2.5]. For example, for two matrices  $A, B \in \mathbb{R}^{3\times3}$ ,  $AB = B \times_1 A =$  $A \times_2 B^T$ . In this notation the projection of a k:th order tensor T is written  $[T]_P =$  $T \times_1 P \times_2 P... \times_k P$  and we remark that this expression is independent of the order in which the n-mode products are evaluated. Note that the projection will ensure that no out-of-plane components exist and in turn the inductive definition [\(2.2\)](#page-4-1) ensures that higher order derivatives are not affected by artificial out-of-plane components (derivatives of out-of-plane components may of course be tangential). We will also use the following notation for tangential derivatives of a tensor T

and we note that  $D_{\Gamma}^k w = D_{\Gamma} D_{\Gamma} \cdots D_{\Gamma}$  $\overline{k}$  copies  $\omega$ .

In terms of the tangential gradient  $\nabla_{\Gamma} := P \nabla$  we may explicitly state the first two tensors of tangential derivatives

$$
D_{\Gamma}^1 w = \left[ w \otimes \overleftarrow{\nabla} \right]_P = \left[ \nabla w \right]_P = (\nabla w)_{\leftarrow} \times_1 P = P \nabla w = \nabla_{\Gamma} w \tag{2.5}

and we note that the Laplace–Beltrami operator is  $\Delta_{\Gamma} w := \nabla_{\Gamma} \cdot \nabla_{\Gamma} w = \text{tr}(D_{\Gamma}^2 w)$ .

### <span id="page-5-0"></span>3 Geometry approximation

We define a volumetric neighborhood U to  $\Gamma$  by  $U = \{x \in \mathbb{R}^3 \mid \text{dist}(x, \Gamma) < \delta\}$  where  $\delta$ is small enough such that the closest point mapping  $p: U \to \Gamma$  defined by

is unique and there exists a constant C such that

$$
||D^{\alpha}d||_{L^{\infty}(U)} \leq C \qquad \text{for } 0 \leq |\alpha| \leq k+1 \tag{3.2}
$$

where  $\alpha$  is a multi-index,  $\{D^{\alpha}d\}$  is the set of all Cartesian partial derivatives of order |a| and  $\|\cdot\|_{L^\infty(U)} := \sup_{x \in U} |\cdot|$ . The minimum value of k in [\(3.2\)](#page-5-1) is determined by the highest order of Sobolev norm approximation needed when using Lemma [3.3,](#page-9-1) so for the purposes of the analysis in this paper we assume  $k = 3$ .

Throughout this paper we will use assumptions and approximation results from [\[11,](#page-39-3) [12,](#page-40-10) [14\]](#page-40-0) which we present in this section. While we try to provide complete proofs for the approximation results we especially recommend reviewing [\[11\]](#page-39-3) for more general results.

#### 3.1 Approximate surface  $\Gamma_h$  and partitioning of Γ

As an approximation to Γ we consider a discrete polygonal surface  $\Gamma_h \subset U$  with triangular faces whose vertices lie on Γ. Further, let the triangle faces be shape regular and quasi-uniform of diameter h, cf. [\[22\]](#page-40-11), and denote the set of triangle faces  $\mathcal{K} = \{K\}$ . Let  $\mathcal{E} = \{E\}$  be the set of edges in K. The face normal on each face K is denoted by  $n_h$  and the conormal to K is denoted by  $n_{\partial K}$ . Thus, the projection onto the tangent space of the approximate surface is given by  $P_h = I - n_h \otimes n_h$ . Further, on the exact surface Γ we let K and E implicitly define a partitioning through the closest point mapping  $(3.1)$ such that the curved triangles are given by  $K^{\ell} = \{p(x) : x \in K\}$  and the curved edges between the curved triangles are given by  $E^{\ell} = \{p(x) : x \in E\}$ . To denote the domain consisting of all triangle edges on  $\Gamma_h$  respectively on  $\Gamma$  we use the notations

$$
\mathcal{E}_h := \bigcup_{E \in \mathcal{E}} E \qquad \text{and} \qquad \mathcal{E}_\Gamma := \bigcup_{E \in \mathcal{E}} E^\ell \tag{3.3}
$$

We denote the conormal to the curved triangle  $K^{\ell}$  by  $n_{\partial K^{\ell}}$ . An illustration of a curved triangle with its facet approximation and their respective conormals is given in Figure [1.](#page-6-0)

For each edge  $E \in \mathcal{E}$  between two neighboring triangles we name one triangle  $K_{+}$  and the other K−. On edges we denote the conormals to these triangles, i.e. the outward pointing normals to  $\partial K_{+/-}$ , by  $n^+_{\partial K}$  and  $n^-_{\partial K}$ , respectively. Analogously, we on each curved edge  $E^{\ell}$  between curved triangles  $K^{\ell}{}_{+\!/-}$  denote the conormals by  $n_{\partial K}^{+/-}$  $\overline{\partial K^{\ell}}$ . Note that  $n_{\partial K^{\ell}}^{+} + n_{\partial K^{\ell}}^{-} = 0$  as  $(K^{\ell}_{+} \cup K^{\ell}_{-}) \subset \Gamma$  which is smooth.

### 3.2 Mapping between  $\Gamma$  and  $\Gamma_h$

To map functions between the approximate and exact surfaces we extend functions to U such that they are constant in the normal direction  $n$ . We denote extended functions by superscript  $\ell$ . More formally, for a function w defined on the exact surface  $\Gamma$  we define the extension to  $U$  by

$$
w^{\ell}(x) = w \circ p \qquad \text{for } x \in U \tag{3.4}
$$

For a function w defined on the approximate surface  $\Gamma_h$  we first define its lifting onto Γ by

\widetilde{w}(x) = w \circ x_h \tag{3.5}
$$

where  $x_h(x)$  is the unique solution to  $p(x_h) = x$  for  $x_h \in \Gamma_h$ , i.e. the solution to

$$
x_h = x + d(x_h)n(x) \qquad \text{where } x_h \in \Gamma_h \text{ and } x \in \Gamma \tag{3.6}
$$

Analogously to [\(3.4\)](#page-6-1), we then for a function w defined on  $\Gamma_h$  define the extension to U by

w^{\ell}(x) = \tilde{w} \circ p \qquad \text{for } x \in U \tag{3.7}
$$

Throughout the remainder of the paper we for clarity of notation let it be implied that functions defined on  $\Gamma$  and  $\Gamma_h$  are extended to U by [\(3.4\)](#page-6-1) and [\(3.7\)](#page-7-0), respectively, and only use the superscript  $\ell$  notation when necessary or for emphasis.

#### <span id="page-7-9"></span>3.3 Geometry approximation results

In the following lemma we collect a number of approximation results for quantities defined by  $\Gamma$  and  $\Gamma_h$ . Note that even though we here do not explicitly denote geometrical quantities on  $\Gamma$  by superscript  $\ell$  these are assumed extended to U by [\(3.4\)](#page-6-1). Further, in this lemma and throughout the paper we will for inequalities use the notation  $a \leq b$  by which we mean that there exists a constant  $c$  independent of the mesh size parameter  $h$ such that  $a \leq cb$ .

<span id="page-7-4"></span>**Lemma 3.1** (Geometry approximation). Let  $\{\Gamma_h\}$  be a family of polygonal approximations to Γ with  $\Gamma_h \in U$  and mesh size parameter  $0 < h < h_0$ . For sufficiently small  $h_0$ the following estimates hold

with constants depending on derivatives of d.

Proof. We prove this lemma in Appendix [A.](#page-29-0)

Let ds and  $ds_h$  be the surface measures of  $\Gamma$  and  $\Gamma_h$ , respectively. For  $x \in \Gamma_h$  we let  $\mu_h$  satisfy  $\mu_h(x)ds_h(x) = ds \circ p(x)$  and by results in [\[11,](#page-39-3) [12\]](#page-40-10) we have

$$
\mu_h(x) = (n \cdot n_h)(1 - d(x)\kappa_1(x))(1 - d(x)\kappa_2(x))
$$
\n(3.14)

where

$$
\kappa_i(x) = \frac{\kappa_i(p(x))}{1 + d(x)\kappa_i(p(x))}
$$
\n(3.15)

Further, we will need the following non-standard geometry approximation result for an integrated quantity. Note that the  $L^1(\Gamma_h)$  and  $W_1^1(\Gamma_h)$  norms are defined by

$$
\| \cdot \|_{L^1(\Gamma_h)} := \sum_{K \in \mathcal{K}} \int_K \| \cdot \| ds \qquad \| \cdot \|_{W_1^1(\Gamma_h)} := \| \cdot \|_{L^1(\Gamma_h)} + \| \cdot \otimes \overleftarrow{\nabla} \|_{L^1(\Gamma_h)} \tag{3.17}
$$

where  $||T|| := \sqrt{T : T}$  for a tensor T, i.e.  $|| \cdot ||$  is the absolute value for a scalar, the Euclidean norm for a vector and the Frobenius norm for a matrix.

<span id="page-8-0"></span>**Lemma 3.2** ( $P_h n$  lemma). For  $\chi \in [W_1^1(\Gamma_h)]^3$  it holds

$$
\left| \int_{\Gamma_h} (P_h \cdot n) \cdot \chi \, ds \right| \lesssim h^2 \| \chi \|_{W_1^1(\Gamma_h)} \tag{3.18}

where  $\{\Gamma_h\}$  fulfills the requirements of Lemma [3.1.](#page-7-4)

where  $\llbracket n_{\partial K} \rrbracket = n_{\partial K}^+ + n_{\partial K}^-$ . Term I: We have estimates

|I| \lesssim ||d||_{L^{\infty}(\Gamma_h)} (||\nabla \cdot n_h||_{L^{\infty}(\Gamma_h)} ||n_h \cdot \chi||_{L^1(\Gamma_h)} + ||\nabla \cdot \chi||_{L^1(\Gamma_h)})
$$
(3.21)  

$$
\lesssim h^2 ||\chi||_{W_1^1(\Gamma_h)}
$$
(3.22)

where we used Hölder's inequality and the bound  $(3.8)$  for d.

Term II: For the second term we have

$$
|II| := \left| \int_{\mathcal{E}_h} d\left[ n_{\partial K} \right] \cdot \chi \, dl \right| \tag{3.23}
$$

$$
\lesssim \|d\|_{L^{\infty}(\mathcal{E}_h)} \|\llbracket n_{\partial K} \rrbracket \|_{L^{\infty}(\mathcal{E}_h)} \|\chi\|_{L^1(\mathcal{E}_h)}
$$
\n

\lesssim \|d\|_{L^1(\mathcal{E}_h)}
$$
\n
$$
\lesssim \|d\|_{

\lesssim \|d\|_{L^{\infty}(\Gamma_h)} \|\llbracket n_{\partial K} \rrbracket \|_{L^{\infty}(\mathcal{E}_h)} \left( h^{-1} \|\chi\|_{L^1(\Gamma_h)} + \|\chi \otimes \nabla_{\Gamma_h} \|_{L^1(\Gamma_h)} \right) \tag{3.25}
$$

$$
\lesssim h^2 \left( \|\chi\|_{L^1(\Gamma_h)} + h\|\chi \otimes \nabla_{\Gamma_h}\|_{L^1(\Gamma_h)} \right) \tag{3.26}
$$

$$
\lesssim h^2 \|\chi\|_{W_1^1(\Gamma_h)}\tag{3.27}
$$

where we use Hölder's inequality, a trace inequality, the bound  $(3.8)$  for d and the following estimate for the jump in the conormal  $\|\llbracket n_{\partial K} \rrbracket \|_{L^{\infty}(\mathcal{E}_h)} \leq \| n_{\partial K}^+ - n_{\partial K^{\ell}}^+ \|_{L^{\infty}(\mathcal{E}_h)} + \| n_{\partial K}^- - n_{\partial K^{\ell}}^- \|_{L^{\infty}(\mathcal{E}_h)}$  $n_{\partial K^{\ell}}^-$ || $_{L^{\infty}(\mathcal{E}_h)} \lesssim h$ .

Remark. The foundation of this proof is independent of the order of geometry approxi-mation. By using bounds on d for higher order geometry approximations (see eg. [\[11\]](#page-39-3)) we yield an estimate on the form

$$
\left| \int_{\Gamma_h^k} (P_h \cdot n) \cdot \chi \, ds \right| \lesssim h^{1+k} \| \chi \|_{W_1^1(\Gamma_h^k)} \tag{3.28}
$$

where  $k$  is the polynomial order of the continuous piecewise polynomial geometry approximation  $\Gamma_h^k$ .

#### <span id="page-9-0"></span>3.4 Sobolev norm approximation

As  $\Gamma_h$  is piecewise smooth we on each triangle face define tensors of tangential derivatives analogously to [\(2.2\)](#page-4-1), i.e.

D_{\Gamma_h}^k w := \begin{cases} w & \text{for } k = 0\\ \left\lfloor \left( D_{\Gamma_h}^{k-1} w \right) \otimes \tilde{\nabla} \right\rfloor_{P_h} & \text{for } k \ge 1 \end{cases} \tag{3.29}
$$

and we denote the approximate surface differential operators by subscript  $\Gamma_h$ , for example  $\nabla_{\Gamma_h}$  and  $\Delta_{\Gamma_h}$ .

As a consequence of  $\Gamma_h$  being only piecewise smooth the natural Sobolev spaces on  $\Gamma_h$  are broken, which we indicate on Sobolev spaces by subscript h, and we introduce the following semi-norms for the broken Sobolev spaces on the approximate and exact surfaces

$$
|v|_{H_h^k(\Gamma_h)} := \left(\sum_{K \in \mathcal{K}} |v|_{H^k(K)}^2\right)^{\frac{1}{2}} \qquad |v|_{H_h^k(\Gamma)} := \left(\sum_{K \in \mathcal{K}} |v|_{H^k(K^{\ell})}^2\right)^{\frac{1}{2}} \qquad (3.30)
$$

To compare functions in these norms on the exact and approximate surfaces we now present the following results from [\[11,](#page-39-3)[14\]](#page-40-0), which we extend with estimate [\(3.34\)](#page-9-2) and prove in Appendix [B.](#page-30-0)

<span id="page-9-1"></span>**Lemma 3.3** (Sobolev norm equivalence). Let  $v \in \{w^{\ell} : w \in H_h^k(\Gamma) \cap C^0(\Gamma) \}$  or  $v \in \{w^{\ell} : w \in H_h^k(\Gamma) \cap C^0(\Gamma) \}$  $w \in H_h^k(\Gamma_h) \cap C^0(\Gamma_h)$  for an integer  $k \geq 1$  and mesh size parameter  $0 < h < h_0$ . For sufficiently small  $h_0$  the following inequalities hold

||v||_{L^{2}(\Gamma)} \lesssim ||v||_{L^{2}(\Gamma_h)} \lesssim ||v||_{L^{2}(\Gamma)}
$$
\n(3.31)

$$
|v|_{H^1(\Gamma)} \lesssim |v|_{H^1(\Gamma_h)} \lesssim |v|_{H^1(\Gamma)} \tag{3.32}
$$

$$
|v|_{H_h^k(\Gamma_h)} \lesssim \sum_{m=1}^k |v|_{H_h^m(\Gamma)} \tag{3.33}
$$

$$
|v|_{H_h^k(\Gamma)} \lesssim \sum_{m=1}^k |v|_{H_h^m(\Gamma_h)}
$$
\n(3.34)

with constants depending on derivatives of the distance function d.

Proof. We prove this lemma in Appendix [B.](#page-30-0)

Remark. A consequence of this lemma is that if  $v \in H^k(\Gamma)$  then  $v^{\ell}|_{\Gamma_h} \in H^k_h(\Gamma_h)$ , and likewise if  $v_h \in H_h^k(\Gamma_h)$  then  $v_h^{\ell}|_{\Gamma} \in H_h^k(\Gamma)$ .

### <span id="page-10-0"></span>4 The continuous/discontinuous Galerkin method

In this section we present the biharmonic problem on a surface  $\Gamma$  and derive a weak formulation of the problem suitable for our purposes. To deal with the  $H^2(\Gamma)$  conformity requirement of the biharmonic problem we present a continuous/discontinuous Galerkin (c/dG) method [\[18\]](#page-40-6). The method is formulated on the approximate surface  $\Gamma_h$  with surface differential operators also based on  $\Gamma_h$ .

#### 4.1 Notation

For elements f, g in an inner product space with inner product  $\langle \cdot, \cdot \rangle$  we let  $(f, g)_{\Omega}$  denote integration over  $\Omega$  such that  $(f, g)_{\Omega} := \int_{\Omega} \langle f, g \rangle ds$ . On an edge  $E = \partial K_+ \cap \partial K_-$  we define the jump and average by

$$
[\![g]\!] := \lim_{c \to 0+} \left( g(x - c n_{\partial K}^+) - g(x - c n_{\partial K}^-) \right) \tag{4.1}
$$

$$
\{g\} := \lim_{c \to 0+} \frac{1}{2} \left( g(x - cn_{\partial K}^+) + g(x - cn_{\partial K}^-) \right) \tag{4.2}
$$

respectively, and on the exact surface we define the jump and average over  $E^{\ell}$  analogously using the conormals  $n_{\text{av}}^{+/-}$  $\frac{\tau / -}{\partial K^\ell}$ .

#### 4.2 The biharmonic problem

We consider the following model problem: Given  $f \in L^2(\Gamma)$  with  $(f, 1)$ <sub> $\Gamma$ </sub> = 0, find u such that

<span id="page-10-2"></span><span id="page-10-1"></span>
$$
\Delta_{\Gamma}^2 u = f \qquad \text{on } \Gamma \tag{4.3}
$$

<span id="page-10-3"></span>
$$
(u,1)_{\Gamma} = 0 \tag{4.4}
$$

where  $\Delta_{\Gamma}^2 u := \Delta_{\Gamma}(\Delta_{\Gamma} u)$ . As we consider surfaces  $\Gamma$  without boundary, i.e. closed manifolds, we include the criterion [\(4.4\)](#page-10-1) to make the problem well posed. This is more easily seen for [\(4.3\)](#page-10-2) in weak form: Given  $f \in L^2(\Gamma)$ , find  $u \in H^2(\Gamma)$  such that

$$
(\Delta_{\Gamma} u, \Delta_{\Gamma} v)_{\Gamma} = (f, v)_{\Gamma} \qquad \text{for all } v \in H^2(\Gamma) \tag{4.5}
$$

The nullspace of  $\Delta_{\Gamma}$  on a closed manifold is the space of constant functions, and then by [\(4.4\)](#page-10-1) the only function in the nullspace is the zero function.

For smooth surfaces  $\Gamma$  without boundary we have the following elliptic regularity estimate

<span id="page-10-4"></span>
$$
||u||_{H^{4}(\Gamma)} \lesssim ||f||_{L^{2}(\Gamma)}
$$
\n(4.6)

under the restriction of [\(4.4\)](#page-10-1), see [\[3,](#page-39-7) Th. 27].

#### 4.3 Green's formula on curved surfaces

Consider a smooth surface  $\Sigma$  with piecewise smooth boundary  $\partial \Sigma$  and surface normal n. For functions  $v : \mathbb{R}^3 \to \mathbb{R}^3$  and  $w : \mathbb{R}^3 \to \mathbb{R}$  the Green's formula on  $\Sigma$  reads  $(\nabla \cdot v, w)_{\Sigma} = (n_{\partial \Sigma} \cdot v, w)_{\partial \Sigma} - (v, \nabla w)_{\Sigma}$  where  $n_{\partial \Sigma}$  is the outward pointing normal to  $\partial \Sigma$ . Using the definition of the tangential gradient we may instead write a Green's formula with tangential operators

<span id="page-11-0"></span>
$$
(\nabla_{\Sigma} \cdot v, w)_{\Sigma} = (n_{\partial \Sigma} \cdot v, w)_{\partial \Sigma} - (v, \nabla_{\Sigma} w)_{\Sigma} + (\text{tr}(H)n \cdot v, w)_{\Sigma}
$$
(4.7)

where we note that we get an additional term which includes the mean curvature of the surface. In the next section we will however notice that for the weak formulation of the biharmonic problem on a curved surface all curvature terms vanish as the vector  $v$  will always be a tangent vector and thus  $n \cdot v = 0$ .

#### 4.4 Broken weak formulation

The requirement on a conformal method based on [\(4.5\)](#page-10-3) in practice means defining an approximation space which is  $C^1(\Gamma)$ . Due to the intricacies involved of defining such approximation spaces we instead aim for a continuous/discontinuous Galerkin method where the approximation space rather is in the broken space  $H_h^4(\Gamma) \cap C^0(\Gamma)$ . Multiplying the biharmonic equation on a curved surface [\(4.3\)](#page-10-2) by  $v \in H_h^4(\Gamma) \cap C^0(\Gamma)$ , integrating over Γ and applying Green's formula two times gives

$$
(f, v)_{\Gamma} = (\Delta_{\Gamma}^2 u, v)_{\Gamma} = -(\nabla_{\Gamma} \Delta_{\Gamma} u, \nabla_{\Gamma} v)_{\Gamma} = -\sum_{K \in \mathcal{K}} (\nabla_{\Gamma} \Delta_{\Gamma} u, \nabla_{\Gamma} v)_{K^{\ell}} \tag{4.8}
$$

$$
= \sum_{K \in \mathcal{K}} \left( \left( \Delta_{\Gamma} u, \Delta_{\Gamma} v \right)_{K^{\ell}} - \left( \Delta_{\Gamma} u, n_{\partial K^{\ell}} \cdot \nabla_{\Gamma} v \right)_{\partial K^{\ell}} \right) \tag{4.9}
$$

where  $n_{\partial K^{\ell}}$  is the conormal to  $K^{\ell}$ , i.e. the outward pointing normal to  $\partial K^{\ell}$ , and the curvature terms in the Green's formula [\(4.7\)](#page-11-0) vanish as  $n \cdot \nabla_{\Gamma} = 0$ . Introducing the notation  $n_{E^{\ell}} = [n_{\partial K^{\ell}}]/2 = n_{\partial K^{\ell}}^+$  and summing over K we get the weak formulation: Find<br> $\mathcal{L} \subset H^4(\Gamma)$  satisfying  $(\mathcal{L} \cup \Gamma) = 0$  such that  $u \in H^4(\Gamma)$  satisfying  $(u,1)_{\Gamma} = 0$  such that

$$
(f, v)_{\Gamma} = \sum_{K \in \mathcal{K}} (\Delta_{\Gamma} u, \Delta_{\Gamma} v)_{K^{\ell}} - \sum_{E \in \mathcal{E}} (\Delta_{\Gamma} u, n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} v]\!])_{E^{\ell}} \tag{4.10}
$$

for all  $v \in H_h^4(\Gamma) \cap C^0(\Gamma)$ . For a function  $u \in H_h^4(\Gamma) \cap C^0(\Gamma)$  the term  $\Delta_{\Gamma} u$  is undefined on interior edges  $E^{\ell}$  and we therefore extend [\(4.10\)](#page-11-1) by defining

$$
\Delta_{\Gamma} u := \{ \Delta_{\Gamma} u \} - \beta h^{-1} n_{E^{\ell}} \cdot [\![ \nabla_{\Gamma} u ]\!] \qquad \text{on } E^{\ell} \tag{4.11}
$$

where  $\beta$  is a positive parameter needed to achieve stability for the method, see Lemma [5.6.](#page-19-4) To make the bilinear form symmetric we also add the term

<span id="page-11-1"></span>
$$
-\sum_{E \in \mathcal{E}} \left( n_{E^{\ell}} \cdot \left[ \nabla_{\Gamma} u \right], \left\{ \Delta_{\Gamma} v \right\} \right)_{E^{\ell}} \tag{4.12}
$$

Note that the above modifications does not affect the consistency of the method as  ${\{\Delta_{\Gamma} u\}} = {\Delta_{\Gamma}} u$  and  $n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} u]\!] = 0$  on  $E^{\ell}$  for  $u \in H^{4}(\Gamma)$  due to the Sobolev embedding<br> $H^{4}(\Gamma) \leftrightarrow C^{2}(\Gamma)$  see [2, Thm. 2.20]. To allow for a more abstract presentation we let  $H^4(\Gamma) \hookrightarrow C^2(\Gamma)$ , see [\[2,](#page-39-8) Thm. 2.20]. To allow for a more abstract presentation we let the bilinear form  $a(\cdot, \cdot)$  be given by

$$
a(u, v) := \sum_{K \in \mathcal{K}} (\Delta_{\Gamma} u, \Delta_{\Gamma} v)_{K^{\ell}} - \sum_{E \in \mathcal{E}} \left( (\{\Delta_{\Gamma} u\}, n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} v]\!])_{E^{\ell}} + (n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} u]\!], \{\Delta_{\Gamma} v\} )_{E^{\ell}} \right) + \sum_{E \in \mathcal{E}} \beta \left( h^{-1} n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} u]\!], n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} v]\!])_{E^{\ell}} \right)
$$
(4.13)

and linear functional  $l(\cdot)$  be given by

<span id="page-12-0"></span>
$$
l(v) := (f, v)_{\Gamma} \tag{4.14}
$$

We now introduce the following function spaces extended to  $U$  using  $(3.4)$ 

$$
V := \{ w^{\ell} : w \in H^{4}(\Gamma) \} \qquad W := \{ w^{\ell} : w \in H^{4}_{h}(\Gamma) \cap C^{0}(\Gamma) \} \qquad (4.15)
$$

where we note that  $V \subset W$ , and that  $a(u, v)$  and  $l(v)$  clearly are defined for  $u, v \in W$ . The weak formulation of our continuous problem thus reads: Find  $u \in V$  satisfying  $(u, 1)$ <sub>Γ</sub> = 0 such that

$$
a(u, v) = l(v) \qquad \text{for all } v \in W \tag{4.16}
$$

Both  $a(\cdot, \cdot)$  and  $l(\cdot)$  are formulated using the exact surface and the exact differential operators, i.e. using information that in practice may be unavailable. It would thus be impractical to directly formulate our method based on [\(4.16\)](#page-12-0) and we therefore in the next section formulate our method using approximations to  $a(\cdot, \cdot)$  and  $l(\cdot)$  based on  $\Gamma_h$ .

#### 4.5 The continuous/discontinuous Galerkin method

On each facet edge E we define an approximation to the element boundary normal  $n_{E^{\ell}}$ by

$$
n_E := \frac{n_{\partial K}^+ - n_{\partial K}^-}{1 - n_{\partial K}^+ \cdot n_{\partial K}^-}
$$
\n
$$
(4.17)
$$

and note that this definition has the property

$$
n_E \cdot \[\nabla_{\Gamma_h} w\] = n_{\partial K}^+ \cdot \nabla_{\Gamma_h} w^+ + n_{\partial K}^- \cdot \nabla_{\Gamma_h} w^- \tag{4.18}
$$

which will simplify the analysis. In [\[9\]](#page-39-5) numerical experiments using variations for the definition of  $n<sub>E</sub>$  in a dG method for the Laplace–Beltrami problem yield the conclusion that [\(4.17\)](#page-12-1) is preferred.

By simply replacing the various terms by its discrete analogs the resulting approximate bilinear form  $a_h(\cdot, \cdot)$  on the discrete surface  $\Gamma_h$  reads

$$
a_h(u_h, v) := \sum_{K \in \mathcal{K}} (\Delta_{\Gamma_h} u_h, \Delta_{\Gamma_h} v)_K
$$
  
- 
$$
\sum_{E \in \mathcal{E}} \left( (\{\Delta_{\Gamma_h} u_h\}, n_E \cdot [\nabla_{\Gamma_h} v]])_E + (n_E \cdot [\nabla_{\Gamma_h} u_h], \{\Delta_{\Gamma_h} v\})_E \right)
$$
  
+ 
$$
\sum_{E \in \mathcal{E}} \beta (h^{-1} n_E \cdot [\nabla_{\Gamma_h} u_h]], n_E \cdot [\nabla_{\Gamma_h} v]]_E \quad (4.19)
$$

and the approximate linear functional  $l_h(\cdot)$  is given by

$$
l_h(v) := (f_h, v)_{\Gamma_h} \tag{4.20}
$$

where we as in [\[14\]](#page-40-0) define

$$
f_h := f - |\Gamma_h|^{-1} (f, 1)_{\Gamma_h}
$$
\n(4.21)

and note that  $(f_h, 1)_{\Gamma_h} = 0$ . Clearly, both  $a_h(u, v)$  and  $l_h(v)$  are defined for functions  $u, v \in W$ .

We choose our finite element space  $W_h$  as the space of continuous, piecewise quadratic polynomials on the approximate surface  $\Gamma_h$ , which we after extending to U via [\(3.7\)](#page-7-0) express as

$$
W_h := \left\{ w^\ell \in C^0(U) \; : \; w \in \bigoplus_{K \in \mathcal{K}} \mathcal{P}_2(K) \right\} \tag{4.22}
$$

and note that  $W_h \subset W$  by Lemma [3.3,](#page-9-1) but  $W_h \not\subset V$ . We now formulate our continuous/discontinuous Galerkin method: Find  $u_h \in W_h$  such that

$$
a_h(u_h, v) = l_h(v) \qquad \text{for all } v \in W_h \tag{4.23}
$$

(u_h, 1)_{\Gamma_h} = 0 \tag{4.24}
$$

In the next section we turn to the theoretical analysis of this method.

### <span id="page-13-0"></span>5 A priori error estimates

We will now prove error estimates for our method in energy and  $L^2$  norms using assumptions and approximation properties presented and proved in §[3.](#page-5-0) We begin by defining the norms we will work with in the next section. Then we establish a number of preliminary lemmas in §[5.2](#page-15-0) which we use in the proofs of our main theorems in §[5.3.](#page-22-1)

#### 5.1 Energy norms and definitions

We equip  $W$  with the following discrete energy norm.

$$
\|w\|_{\Gamma_h}^2 := \sum_{K \in \mathcal{K}} \|\Delta_{\Gamma_h} w\|_{L^2(K)}^2 + h\| \{\Delta_{\Gamma_h} w\} \|_{L^2(\partial K)}^2 + h^{-1} \|n_E \cdot \|\nabla_{\Gamma_h} w\| \|_{L^2(\partial K)}^2 \tag{5.1}
$$

Note that  $\|\cdot\|_{\Gamma_h}$  is indeed a norm on W since if  $\|w\|_{\Gamma_h} = 0$  then w must be the solution to the problem

-\Delta_{\Gamma_h} w = 0 \quad \text{on } \mathcal{K}_h \tag{5.2}

Weakly formulating  $(5.2)$  and choosing w as test function gives

$$
\sum_{K \in \mathcal{K}} (-\Delta_{\Gamma_h} w, w)_K = \sum_{K \in \mathcal{K}} (\nabla_{\Gamma_h} w, \nabla_{\Gamma_h} w)_K - (n_{\partial K} \cdot \nabla_{\Gamma_h} w, w)_{\partial K}
$$
(5.4)

$$
= \sum_{K \in \mathcal{K}} (\nabla_{\Gamma_h} w, \nabla_{\Gamma_h} w)_K - \sum_{E \in \mathcal{E}} (n_E \cdot [\![\nabla_{\Gamma_h} w]\!], w)_E = 0 \tag{5.5}
$$

where we use [\(4.18\)](#page-12-2) in the second equality. By [\(5.3\)](#page-14-1) we then have  $\|\nabla_{\Gamma_h} w\|_{L^2(\mathcal{K})}^2 = 0$ , and thus w must be a constant function over  $\Gamma_h$  and through the extension to U also be constant in  $U$ . Due to the criteria  $(4.4)$  and  $(4.24)$ , w must then be the zero function.

Further, we will also need the following energy norm corresponding to [\(5.1\)](#page-13-2) albeit with exact differential operators and integration over the exact surface

$$
\|\|w\|\|_{\Gamma}^2 := \sum_{K \in \mathcal{K}} \|\Delta_{\Gamma} w\|_{L^2(K^{\ell})}^2 + h\| \{\Delta_{\Gamma} w\} \|_{L^2(\partial K^{\ell})}^2 + h^{-1} \|n_{E^{\ell}} \cdot \|\nabla_{\Gamma} w\| \|_{L^2(\partial K^{\ell})}^2 \tag{5.6}
$$

By arguments analogous to the above  $\|\cdot\|_{\Gamma}$  is also a norm on W. We will later prove that these two norms are actually equivalent for functions in  $W_h$  (see Lemma [5.8\)](#page-21-0).

As a technical tool in the proof we will also use the following norm

$$
||v||_{H_h^*(\Gamma)} := |||v||_{\Gamma} + |v|_{H^1(\Gamma)} + h|v|_{H_h^2(\Gamma)} + h^2|v|_{H_h^3(\Gamma)}\tag{5.7}
$$

<span id="page-14-2"></span>**Definition 5.1.** Let  $\pi_2$  be the standard continuous piecewise quadratic Lagrange interpolation operator on  $\Gamma_h$ . The interpolation operator  $\pi : W \to W_h$  is given by

\pi w := (\pi_2 w)^{\ell} \tag{5.8}

Remark. This interpolation can be viewed as defining the nodal values on  $\Gamma_h$  by fetching values on  $\Gamma$  by the closest point mapping  $p(x)$ .

**Definition 5.2.** For any domain  $\Sigma$  let  $\mathcal{P}_0^{\Sigma}: L^1(\Sigma) \to \mathbb{R}$  be the projection onto the space of constants such that  $\mathcal{P}_0^{\Sigma} w = |\Sigma|^{-1} (w, 1)_{\Sigma}$  for  $w \in L^1(\Sigma)$ .

Remark. This projection gives the average over the domain and note that it may be used for defining the quotient space  $||w||_{L^2(\Sigma)/\mathbb{R}} := ||w - \mathcal{P}_0^{\Sigma} w||_{L^2(\Sigma)}$ .

In the next section we establish a number of lemmas needed for the proofs of the main a priori error estimates in Section [5.3.](#page-22-1)

#### <span id="page-15-0"></span>5.2 Prerequisite lemmas

**Lemma 5.1** (Trace inequalities). For  $v \in W$  the following trace inequalities hold

*Proof. Inequality [\(5.9\)](#page-15-1):* This well known trace inequality follows by affinely mapping K to a reference element  $K_{\text{ref}}$ , applying the trace inequality 2<br>  $L^2(\partial K_{\text{ref}})$  $\lesssim ||v||_{L^2(K_{\text{ref}})} ||v||_{H^1(K_{\text{ref}})} \lesssim ||v||_{H^1(K_{\text{ref}})}^2$  (see [\[4\]](#page-39-9)), and mapping back to K.

*Inequality [\(5.10\)](#page-15-2)*: Due to the extension in W, clearly  $||v||_{L^2(\partial K^{\ell})} \lesssim ||v||_{L^2(\partial K)}$ . Applying the original trace inequality [\(5.9\)](#page-15-1) and Lemma [3.3,](#page-9-1) the trace inequality on curved elements [\(5.10\)](#page-15-2) immediately follows.  $\Box$ 

Throughout the various parts of the analysis we will make frequent use of the following lemma which gives control over discrete functions  $w_h$  in  $H^1(\Gamma)$  norm using a duality argument.

*Proof.* We introduce the dual problem  $\Delta_{\Gamma}^2 \phi = \psi$  with  $(\phi, 1)_{\Gamma} = 0$ , where  $\psi \in L^2(\Gamma)$  with  $(\psi, 1)$ <sub>Γ</sub> = 0, and for which the stability estimate [\(4.6\)](#page-10-4) holds, i.e.

= -(\nabla_{\Gamma}\psi, \nabla_{\Gamma}\Delta_{\Gamma}\phi)_{\Gamma} + \sum_{K \in \mathcal{K}} (\nabla_{\Gamma}\psi, \nabla_{\Gamma}\psi)_{K^{\ell}} \tag{5.15}
$$

$$
= \sum_{K \in \mathcal{K}} (\Delta_{\Gamma} \psi, \Delta_{\Gamma} \phi)_{K^{\ell}} - \sum_{E \in \mathcal{E}} (\llbracket n_{E^{\ell}} \cdot \nabla_{\Gamma} \psi \rrbracket, \Delta_{\Gamma} \phi)_{E^{\ell}} \tag{5.16}
$$

$$
- \sum_{K \in \mathcal{K}} (\psi, \Delta_{\Gamma} \psi)_{K^{\ell}} - \sum_{E \in \mathcal{E}} (\llbracket n_{E^{\ell}} \cdot \nabla_{\Gamma} \psi \rrbracket, \psi)_{E^{\ell}}
$$

$$
\lesssim \left( \|\Delta_{\Gamma} \psi\|_{L^{2}(\Gamma)}^{2} + h^{-1} \|\llbracket n_{E^{\ell}} \cdot \nabla_{\Gamma} \psi \rrbracket \|_{L^{2}(\mathcal{E}^{\ell})}^{2} \right)^{1/2}
$$
(5.17)

$$
\cdot \left( \|\Delta_{\Gamma}\phi\|_{H^1(\Gamma)} + \|\psi\|_{H^1(\Gamma)} \right)
$$
\n
$$
\|\phi\|_{H^1(\Gamma)} \left( \|\Delta_{\phi}\phi\|_{H^1(\Gamma)} + \|\phi\|_{H^1(\Gamma)} \right) \tag{5.18}
$$

$$
\lesssim \|\|\psi\||_{\Gamma} \left( \|\Delta_{\Gamma}\phi\|_{H^1(\Gamma)} + \|\psi\|_{H^1(\Gamma)} \right) \tag{5.18}
$$

where we use the trace inequality  $(5.10)$  in  $(5.17)$ . By  $(5.12)$  we then have

$$
\left( \|\Delta_{\Gamma}\phi\|_{H^1(\Gamma)} + \|\psi\|_{H^1(\Gamma)} \right) \lesssim \left( \|\phi\|_{H^3(\Gamma)} + \|\psi\|_{H^1(\Gamma)} \right) \tag{5.19}
$$

Clearly, for  $w_h \in W_h$  we have  $w_h|_{\Gamma} \in H_h^4(\Gamma) \cap C^0(\Gamma) \subset L^2(\Gamma)$  and thus we can choose  $\psi = w_h|_{\Gamma} - \mathcal{P}_0^{\Gamma} w_h$  where  $w_h \in W_h$  which concludes the proof.  $\Box$ 

<span id="page-16-9"></span>**Lemma 5.3** (Interpolation estimates). Let  $u \in V$  and  $\pi : W \to W_h$  constructed as in Definition [5.1.](#page-14-2) The following interpolation estimates then hold

for  $h < h_0$ , with  $h_0$  sufficiently small.

Proof. Throughout this proof we will repeatedly use the following standard interpolation estimate

$$
|u - \pi u|_{H^k(K)} \lesssim h^{3-k} |u|_{H^3(K)} \qquad \text{for } k = 1, 2, 3
$$
 (5.24)

with mesh independent constants, cf. [\[20\]](#page-40-12). On curved elements we will also need the corresponding interpolation estimate

$$
|u - \pi u|_{H^k(K^\ell)} \lesssim \sum_{m=1}^k h^{3-m} |u|_{H^3(K)} \lesssim h^{3-k} |u|_{H^3(K)} \qquad \text{for } k = 1, 2, 3 \tag{5.25}
$$

which directly follows from Lemma [3.3](#page-9-1) and [\(5.24\)](#page-16-0).

Estimate [\(5.21\)](#page-16-1): Establishing estimates

\sum_{K \in \mathcal{K}} h \| \left\{ \Delta_{\Gamma_h}(u - \pi u) \right\} \|_{L^2(\partial K)}^2 \lesssim h^2 |u|_{H^3(\Gamma_h)}^2 \tag{5.27}

\sum_{K \in \mathcal{K}} h^{-1} \| n_E \cdot \[\nabla_{\Gamma_h} (u - \pi u) \]\|_{L^2(\partial K)}^2 \lesssim h^2 |u|_{H^3(\Gamma_h)}^2 \tag{5.28}

and applying Lemma [3.3](#page-9-1) will yield the desired interpolation estimate. to prove estimates  $(5.27)$  and  $(5.28)$ . Using  $(5.9)$  we get

$$
h \|\Delta_{\Gamma_h}(u - \pi u)\|_{\partial K}^2 \lesssim \|\Delta_{\Gamma_h}(u - \pi u)\|_{K}^2 + h^2 \|\nabla_{\Gamma_h}\Delta_{\Gamma_h}(u - \pi u)\|_{K}^2 \tag{5.31}

where we used [\(5.24\)](#page-16-0) and that  $\Delta_{\Gamma_h}(\pi u)$  is constant. To show [\(5.30\)](#page-16-5) we again apply the trace inequality [\(5.9\)](#page-15-1) and interpolation estimate [\(5.24\)](#page-16-0)

\lesssim h^{-2} \|\nabla_{\Gamma_h}(u - \pi u)\|_{L^2(K)}^2 + |\nabla_{\Gamma_h}(u - \pi u)|_{H^1(K)}^2 \tag{5.34}
$$

$$
\lesssim h^{-2}|u - \pi u|_{H^1(K)}^2 + |u - \pi u|_{H^2(K)}^2 \lesssim h^2 |u|_{H^3(K)}^2 \quad (5.35)
$$

Estimates  $(5.26)$ – $(5.28)$  are thereby established which concludes the proof of estimate [\(5.21\)](#page-16-1).

Estimate [\(5.22\)](#page-16-6): This estimate follows by calculations analogous to those in the proof above for the interpolation estimate on a flat element [\(5.21\)](#page-16-1), albeit using the trace inequality [\(5.10\)](#page-15-2) and interpolation estimate [\(5.25\)](#page-16-7) for curved triangles.

*Estimate*  $(5.23)$ : This estimate directly follows from  $(5.22)$  and  $(5.25)$ .  $\Box$ 

**Lemma 5.4** (Inverse estimates). For  $v_h \in W_h$  and  $k = 1, 2, \ldots$  the following inverse estimates hold

h\sum_{K\in\mathcal{K}} \|\left\{\Delta_{\Gamma_h} v_h\right\}\|_{L^2(\partial K)}^2 \lesssim \sum_{K\in\mathcal{K}} \|\Delta_{\Gamma_h} v_h\|_{L^2(K)}^2 \tag{5.37}

h\sum_{K\in\mathcal{K}} \|\left\{\Delta_{\Gamma}v_h\right\}\|_{L^2(\partial K^{\ell})}^2 \lesssim \sum_{K\in\mathcal{K}} \left(\|\Delta_{\Gamma}v_h\|_{L^2(K^{\ell})}^2 + h|v_h|_{H^1(K^{\ell})}^2\right) \tag{5.38}

with constants independent of the meshsize h and the parameter  $\beta$ .

*Proof. Estimate [\(5.36\)](#page-17-0):* By Lemma [3.3](#page-9-1) we have  $|v_h|_{H_h^k(\Gamma)} \leq \sum_{m=1}^k |v_h|_{H_h^m(\Gamma_h)}$  and thus, as  $v_h$  is continuous, the estimate follows from establishing the elementwise estimate

$$
h^{k-1}|v_h|_{H^k(K)} \lesssim |v_h|_{H^1(K)}\tag{5.39}

and again applying Lemma [3.3.](#page-9-1) To show estimate [\(5.39\)](#page-17-1) we first note that  $v_h|_K \in \mathcal{P}_2(K)$ . Affinely mapping to a reference triangle  $K_{\text{ref}}$  yields a mapped function  $\widehat{v}_h \in \mathcal{P}_2(K_{\text{ref}})$ . On the reference triangle we now establish the inequality  $|\hat{v}_h|_{H^k(K_{\text{ref}})} \lesssim |\hat{v}_h|_{H^1(K_{\text{ref}})}$  holds. If the right hand side is zero then  $\hat{v}_h$  must be a constant function and in turn the left hand side must also be zero. Due to the finite dimensionality of  $\mathcal{P}_2(K_{\text{ref}})$  the inequality on the reference domain follows. Affinely mapping back to  $K$  yields [\(5.39\)](#page-17-1) and in turn estimate [\(5.36\)](#page-17-0).

*Estimate*  $(5.37)$ : Applying the triangle inequality to each average term and then the trace inequality [\(5.9\)](#page-15-1) this inverse estimate follows as  $v_h \in \mathcal{P}_2(K)$ .

Estimate [\(5.38\)](#page-17-3): We apply the triangle inequality on the average and note that  $\|\Delta_{\Gamma}v_h\|_{L^2(\partial K^{\ell})} \leq \|(\Delta_{\Gamma}v_h)^{\ell}\|_{L^2(\partial K)}$ . In Appendix [C](#page-34-0) we in [\(C.3\)](#page-34-1) express  $\Delta_{\Gamma_h}v_h$  for an extended function  $v_h$  in terms of the exact operators acting on  $v_h$  evaluated at the exact surface. Reviewing how the terms in this expression scale with  $h$ , isolating the appropriate term, squaring both sides and applying the elementary inequality  $(a_1 + \cdots + a_n)^2 \le$  $n(a_1^2 + \cdots + a_n^2)$ , the following pointwise estimates follow

$$
\left( \left( \Delta_{\Gamma} v_h \right)^{\ell} \right)^2 \lesssim \left( \Delta_{\Gamma_h} v_h \right)^2 + h^2 \left( \left( D_{\Gamma} v_h \right)^{\ell} \right)^2 + h^4 \left( \left( D_{\Gamma}^2 v_h \right)^{\ell} \right)^2 \tag{5.40}
$$

$$
\left(\Delta_{\Gamma_h} v_h\right)^2 \lesssim \left(\left(\Delta_{\Gamma} v_h\right)^{\ell}\right)^2 + h^2 \left(\left(D_{\Gamma} v_h\right)^{\ell}\right)^2 + h^4 \left(\left(D_{\Gamma}^2 v_h\right)^{\ell}\right)^2 \tag{5.41}
$$

Integrating [\(5.40\)](#page-18-0) over a curved element boundary  $\partial K^{\ell}$  and applying the trace inequality [\(5.10\)](#page-15-2) on non-Laplacian terms yield

$$
\|\Delta_{\Gamma}v_{h}\|_{L^{2}(\partial K^{\ell})}^{2} \lesssim \|\Delta_{\Gamma_{h}}v_{h}\|_{L^{2}(\partial K)}^{2} + h^{2}\|D_{\Gamma}v_{h}\|_{L^{2}(\partial K^{\ell})}^{2} + h^{4}\|D_{\Gamma}^{2}v_{h}\|_{L^{2}(\partial K^{\ell})}^{2} \tag{5.42}
$$

$$
\lesssim \|\Delta_{\Gamma_{h}}v_{h}\|_{L^{2}(\partial K)}^{2} + h|v_{h}|_{H^{1}(K^{\ell})}^{2} \tag{5.43}
$$

<span id="page-18-1"></span><span id="page-18-0"></span>
$$
\|\Delta_{\Gamma_h} v_h\|_{L^2(\partial K)}^2 + h|v_h|_{H^1(K^\ell)}^2 + h^3|v_h|_{H^2(K^\ell)}^2 + h^5|v_h|_{H^3(K^\ell)}^2
$$
\n(5.43)

$$
\lesssim \|\Delta_{\Gamma_h} v_h\|_{L^2(\partial K)}^2 + h|v_h|_{H^1(K^{\ell})}^2
$$
\n(5.44)

where we use  $(5.36)$  in the last inequality. To deal with the first term we establish the elementwise inequality

$$
\|\Delta_{\Gamma_h} v_h\|_{L^2(\partial K)}^2 \lesssim h^{-1} \|\Delta_{\Gamma_h} v_h\|_{L^2(K)}^2 \tag{5.45}
$$

by mapping to a reference triangle  $K_{\text{ref}}$ , noting that the inequality on the reference domain holds due to the finite dimensionality of  $\mathcal{P}_2(K)$ , and mapping back to K. From [\(5.41\)](#page-18-1) we deduce

\lesssim h^{-1} \|\Delta_{\Gamma} v_h\|_{L^2(K^{\ell})}^2 + |v_h|_{H^1(K^{\ell})}^2 \tag{5.47}

where we again use  $(5.36)$  in the last inequality. Combining the above results and summing over all elements give estimate [\(5.38\)](#page-17-3).  $\Box$

\|\|v\|\|_{\Gamma} \le \|v\|_{H_h^*(\Gamma)} \lesssim \|v\|_{H^3(\Gamma)} \qquad \text{for all } v \in V \tag{5.49}
$$

where  $\|\cdot\|_{H_h^*(\Gamma)}$  and  $\|\cdot\|_{\Gamma}$  are defined in [\(5.7\)](#page-14-3) and [\(5.6\)](#page-14-4), respectively.

*Proof.* By [\(5.7\)](#page-14-3) we have  $||v||_{H_h^*(\Gamma)} := |||v||_{\Gamma} + |v|_{H^1(\Gamma)} + h|v|_{H_h^2(\Gamma)} + h^2|v|_{H_h^3(\Gamma)}$ . For the first estimate we need to limit the last three terms by  $||v||_p$ . This is established by applying [\(5.36\)](#page-17-0) and Lemma [5.2.](#page-15-5)

In the second estimate the first inequality follows trivially from the definition of  $||v||_{H_h^*(\Gamma)}$  and the second inequality from using the trace inequality [\(5.10\)](#page-15-2) on the term  $h \| \{\tilde{\Delta}_{\Gamma_h} v\} \|_{L^2(\partial K)}^2$  in [\(5.6\)](#page-14-4).  $\Box$ 

In the following lemma we collect two basic results on continuity and coercivity for the method.

<span id="page-19-4"></span>Lemma 5.6 (Continuity and coercivity of the method). 1. There are constants which are independent of h but in general depend on  $\beta$ , such that

2. For  $\beta$  sufficiently large the coercivity estimates

hold for all  $v_h \in W_h$ , with positive constants independent of h and  $\beta$ .

*Proof. Part 1:* Using the Cauchy–Schwarz inequality on each term in  $a(v, w)$  and  $a_h(v_h, w_h)$ , respectively, the inequalities readily follow.

Part 2: For estimate  $(5.53)$  we have

$$
a_h(v_h, v_h) = \sum_{K \in \mathcal{K}} \|\Delta_{\Gamma_h} v_h\|_{L^2(K)}^2 - 2 \sum_{E \in \mathcal{E}} \left( \{\Delta_{\Gamma_h} v_h\}, \left[n_E \cdot \nabla_{\Gamma_h} v_h\right]\right)_E
$$

$$
+ \sum_{E \in \mathcal{E}} \beta \left(h^{-1} \left[n_E \cdot \nabla_{\Gamma_h} v_h\right]\right), \left[n_E \cdot \nabla_{\Gamma_h} v_h\right]\right)_E \quad (5.54)
$$

Using the Cauchy–Schwarz inequality followed by the standard inequality  $2ab < \epsilon a^2 +$  $\epsilon^{-1}b^2$ , for any positive  $\epsilon$ , and finally the inverse inequality [\(5.37\)](#page-17-2) we obtain

$$
-2\sum_{E\in\mathcal{E}} (\{\Delta_{\Gamma_h} v_h\}, [\![n_E \cdot \nabla_{\Gamma_h} v_h]\!])_E \ge

\sum_{K\in\mathcal{K}} -\epsilon C \|\Delta_{\Gamma_h} v_h\|_{L^2(K)}^2 - \epsilon^{-1} h^{-1} \|\![n_E \cdot \nabla_{\Gamma_h} v_h]\!]\|_{L^2(\partial K)}^2
$$
\n(5.55)

Given c, with  $0 < c < 1$ , we choose  $\epsilon C = (1 - c)/3$  and take  $\beta \geq c + \epsilon^{-1}$  we obtain the coercivity estimate

c\|v_h\|_{\Gamma_h}^2 \le a_h(v_h, v_h) \qquad \text{for all } v_h \in W_h \tag{5.56}

Coercivity estimate [\(5.52\)](#page-19-6) follows by analogous arguments and the inverse inequality [\(5.38\)](#page-17-3) in combination with Lemma [5.2.](#page-15-5)  $\Box$ 

Next we turn to estimating the difference between the exact and approximate bilinear and linear forms for discrete functions and introduce the following lemma.

<span id="page-19-3"></span>Lemma 5.7. The following estimates hold for the approximation errors of the approximate linear functional  $l_h(\cdot)$  and approximate bilinear form  $a_h(\cdot, \cdot)$

|a(v, w) - a_h(u, w)| \lesssim h \|v\|_{H_h^*(\Gamma)} \|w\|_{H_h^*(\Gamma)} \qquad \text{for } v, w \in W \tag{5.58}
$$

$$
|a(\omega,\phi) - a_h(\omega,\phi)| \lesssim h^2 \|\omega\|_{H^4(\Gamma)} \|\phi\|_{H^4(\Gamma)} \qquad \text{for } \omega,\phi \in V \tag{5.59}
$$

for  $h < h_0$ , with  $h_0$  sufficiently small.

Remark. While the estimate for the consistency error in bilinear forms [\(5.58\)](#page-19-1) is sufficient for proving the correct order of convergence in energy norm, it is insufficient for proving the correct convergence in  $L^2$  norm. For this reason we also include estimate [\(5.59\)](#page-19-2) for smooth functions, which we utilize in the proof of the  $L^2$  estimate as we therein consider approximations to functions in  $V$ . In the proof of  $(5.59)$  it no longer suffices to only compare terms elementwise, but we also need to consider complete integral expressions where we utilize the high regularity of functions in  $V$  and Lemma [3.2.](#page-8-0)

Proof. We here prove each estimate but give some of the details in Appendix [C.](#page-34-0)

*Estimate* [\(5.57\)](#page-19-0): As  $0 = (1, f)_{\Gamma} = (\mu_h, f^{\ell})_{\Gamma_h}$  we by the Cauchy–Schwarz inequality have

$$
(1, f^{\ell})_{\Gamma_h} = (1 - \mu_h, f^{\ell})_{\Gamma_h} \leq |\Gamma_h|^{1/2} \|1 - \mu_h\|_{L^{\infty}(\Gamma_h)} \|f^{\ell}\|_{L^2(\Gamma_h)}

By definition  $f_h := f^{\ell} - \mathcal{P}_0^{\Gamma_h} f^{\ell}$ . Using  $(f, 1)_{\Gamma} = (f_h, 1)_{\Gamma_h} = 0$ , estimate [\(3.16\)](#page-8-1), and the Cauchy–Schwarz inequality we get

|l(w_h) - l_h(w_h)| = |(f, w_h)_{\Gamma} - (f_h, w_h)_{\Gamma_h}|

= \left| (f, w_h - \mathcal{P}_0^{\Gamma} w_h)_{\Gamma} - (f_h, w_h - \mathcal{P}_0^{\Gamma} w_h)_{\Gamma_h} \right| \tag{5.62}

$$
\leq \left| \left( (\mu_h - 1) f^{\ell}, w_h - \mathcal{P}_0^{\Gamma} w_h \right)_{\Gamma_h} \right| + \left| \left( \mathcal{P}_0^{\Gamma_h} f^{\ell}, w_h - \mathcal{P}_0^{\Gamma} w_h \right)_{\Gamma_h} \right| \tag{5.63}
$$

$$
\lesssim \|1 - \mu_h\|_{L^{\infty}(\Gamma_h)} \|f^{\ell}\|_{L^2(\Gamma_h)} \|w_h - \mathcal{P}_0^{\Gamma} w_h\|_{L^2(\Gamma_h)}
$$
(5.64)

$$
\lesssim h^2 \| f^{\ell} \|_{L^2(\Gamma_h)} \| w_h - \mathcal{P}_0^{\Gamma} w_h^{\ell} \|_{L^2(\Gamma_h)} \tag{5.65}
$$

$$
\lesssim h^2 \|f\|_{L^2(\Gamma)} \|w_h^{\ell}\|_{L^2(\Gamma)/\mathbb{R}} \tag{5.66}
$$

$$
\lesssim h^2 \|f\|_{L^2(\Gamma)} \|\langle w_h^\ell | \rangle\|_{\Gamma} \tag{5.67}
$$

where we use Lemma [3.3](#page-9-1) in [\(5.66\)](#page-20-0) and Lemma [5.2](#page-15-5) in the last inequality.

*Estimate* [\(5.58\)](#page-19-1): All terms in  $a(v, w) - a_h(v, w)$  can be paired and rewritten as

where  $\Omega_{\Gamma}, \Omega_{h}$  are either  $\Gamma, \Gamma_{h}$  or  $\mathcal{E}_{\Gamma}, \mathcal{E}_{h}$  depending on the term,  $\mathcal{A}, \mathcal{B}$  are the differential operators in the term, and  $A_h$ ,  $B_h$  are the corresponding approximate operators. For the first term in [\(5.68\)](#page-20-1) we change the integration domain to the approximate surface. Adding and subtracting terms then yields

$$
(\mathcal{A}v, \mathcal{B}w)_{\Omega_{\Gamma}} = (\mu_h(\mathcal{A}v)^{\ell}, (\mathcal{B}w)^{\ell})_{\Omega_h}
$$
\n(5.69)

$$
= ((\mu_h - 1)(\mathcal{A}v)^{\ell}, (\mathcal{B}w)^{\ell})_{\Omega_h} + ((\mathcal{A}v)^{\ell}, (\mathcal{B}w)^{\ell})_{\Omega_h}
$$
(5.70)

By further adding and subtracting terms, may express [\(5.68\)](#page-20-1) as

$$
(\mathcal{A}v, \mathcal{B}w)_{\Omega_{\Gamma}} - (\mathcal{A}_hv, \mathcal{B}_hw)_{\Omega_h} = ((\mu_h - 1)(\mathcal{A}v)^{\ell}, (\mathcal{B}w)^{\ell})_{\Omega_h}
$$
  
+  $((\mathcal{A}v)^{\ell} - \mathcal{A}_hv, (\mathcal{B}w)^{\ell})_{\Omega_h}$   
+  $((\mathcal{A}v)^{\ell}, (\mathcal{B}w)^{\ell} - \mathcal{B}_hw)_{\Omega_h}$   
-  $((\mathcal{A}v)^{\ell} - \mathcal{A}_hv, (\mathcal{B}w)^{\ell} - \mathcal{B}_hw)_{\Omega_h}$   
=  $I + II + III + IV$  (5.72)

Clearly, due to the bound [\(3.16\)](#page-8-1) on  $(1 - \mu_h)$  and that all terms with  $(\mathcal{A}w)^{\ell}$  and  $(\mathcal{B}w)^{\ell}$ are included in  $\|w\|_{\Gamma}$ , we by the Cauchy–Schwarz inequality have

$$
\sum_{K \in \mathcal{K}} |I| \lesssim h^2 |||v|||_{\Gamma} |||w|||_{\Gamma} \le h^2 ||v||_{H_h^*(\Gamma)} ||w||_{H_h^*(\Gamma)}
$$
(5.73)

For the remaining three terms; II, III and IV, it suffices to prove that for  $v \in W$  we have

<span id="page-21-1"></span>
$$
\|(\mathcal{A}v)^{\ell} - \mathcal{A}_h v\|_{L^2(\Omega_h)} \lesssim h \|v\|_{H_h^*(\Gamma)}\tag{5.74}
$$

for all operator and domain pairs  $\{\mathcal{A}_h, \Omega_h\}$  present in  $a_h(\cdot, \cdot)$ . We collect and prove this inequality for all operator and domain pairs in Lemma [C.1.](#page-34-2) By the Cauchy–Schwarz inequality it then follows that

$$
\sum_{K \in \mathcal{K}} |II| + |III| \lesssim h \|v\|_{H_h^*(\Gamma)} \|w\|_{H_h^*(\Gamma)} \qquad \text{for all } v, w \in W \tag{5.75}
$$

$$
\sum_{K \in \mathcal{K}} |IV| \lesssim h^2 ||v||_{H_h^*(\Gamma)} ||w||_{H_h^*(\Gamma)} \qquad \text{for all } v, w \in W \tag{5.76}
$$

From  $(5.73)$ ,  $(5.75)$  and  $(5.76)$  we now conclude that estimate  $(5.58)$  holds.

*Estimate* [\(5.59\)](#page-19-2): As our functions  $\eta, \phi \in V \subset W$  we use [\(5.73\)](#page-21-1) and [\(5.76\)](#page-21-3) from the proof of the previous estimate in combination with Lemma [5.5](#page-18-2) to prove

$$
\sum_{K \in \mathcal{K}} |I| + |IV| \lesssim h^2 \|\eta\|_{H^3(\Gamma)} \|\phi\|_{H^3(\Gamma)} \qquad \text{for all } \eta, \phi \in V \tag{5.77}
$$

It remains to prove bounds of the same order for terms II and III. Due to the Sobolev embedding  $H^3(\Gamma) \hookrightarrow C^1(\Gamma)$  [\[2,](#page-39-8) Thm. 2.20] we have  $n_{E^{\ell}} \cdot [\![\nabla_{\Gamma} \phi]\!])^{\ell} = 0$ , and the only remaining estimates are remaining estimates are

$$
((\Delta_{\Gamma}\eta)^{\ell},(\Delta_{\Gamma}\phi)^{\ell}-\Delta_{\Gamma_h}\phi^{\ell})_{\Gamma_h}\lesssim h^2\|\eta\|_{H^3(\Gamma)}\|\phi\|_{H^3(\Gamma)}\tag{5.78}
$$

$$
\left( (\{\Delta_{\Gamma}\eta\})^{\ell}, (n_{E^{\ell}} \cdot \llbracket \nabla_{\Gamma}\phi \rrbracket)^{\ell} - n_E \cdot \llbracket \nabla_{\Gamma_h}\phi^{\ell} \rrbracket \right)_{\mathcal{E}_h} \lesssim h^2 \|\eta\|_{H^4(\Gamma)} \|\phi\|_{H^4(\Gamma)} \tag{5.79}
$$

which are proven in Lemma [C.2.](#page-36-0) This completes the proof.

A consequence of the above proof is that for functions in  $W_h$  the norm  $\|\cdot\|_{\Gamma}$ , using the exact differential operators [\(5.6\)](#page-14-4), is equivalent to the norm  $\|\cdot\|_{\Gamma_h}$ , using approximate operators [\(5.1\)](#page-13-2). We formulate this in the next lemma.

<span id="page-21-0"></span>**Lemma 5.8.** (Equivalence of norms) For  $w_h \in W_h$  the norms  $|||w_h|||_{\Gamma}$  and  $|||w_h|||_{\Gamma_h}$  are equivalent, i.e.

\| |w_h\|_{\Gamma_h} \lesssim \| |w_h\|_{\Gamma} \lesssim \| |w_h\|_{\Gamma_h}

\n(5.80)

for  $h < h_0$ , with  $h_0$  sufficiently small.

Proof. The left inequality follows from coercivity [\(5.53\)](#page-19-5), Lemma [5.7,](#page-19-3) Lemma [5.5,](#page-18-2) and continuity [\(5.50\)](#page-19-7)

\| |w_h\|_{\Gamma_h}^2 \lesssim a_h(w_h, w_h) \tag{5.81}
$$

$$
= a_h(w_h, w_h) - a(w_h, w_h) + a(w_h, w_h) \lesssim h||w_h||^2_{\Gamma} + ||w_h||^2_{\Gamma}
$$
 (5.82)

for h smaller than some  $h_0$ . By coercivity [\(5.52\)](#page-19-6), Lemma [5.7,](#page-19-3) Lemma [5.5,](#page-18-2) and continuity  $(5.51)$  we have

$$
\|\|w_h\|\|_{\Gamma}^2 \lesssim a(w_h, w_h) \tag{5.83}
$$

$$
= a(w_h, w_h) - a_h(w_h, w_h) + a_h(w_h, w_h) \lesssim h||w_h||_{\Gamma}^2 + ||w_h||_{\Gamma_h}^2 \tag{5.84}
$$

and by a simple kick-back argument the right inequality follows for  $h$  smaller than some  $h_0$ .  $\Box$ 

#### <span id="page-22-1"></span>5.3 Main theorems

The foundation of the main proof is the first Strang lemma as given in [\[8\]](#page-39-10).

Lemma 5.9 (First Strang lemma). Consider a family of discrete problems for which the associated approximate bilinear forms are uniformly  $W_h$ -elliptic. Then there exists a constant independent of the space  $W_h$  such that

$$
\| |u - u_h\|_{\Gamma} \lesssim \left( \inf_{v_h \in W_h} \left( \| |u - v_h\|_{\Gamma} + \sup_{w_h \in W_h} \frac{|a(v_h, w_h) - a_h(v_h, w_h)|}{\|w_h\|_{\Gamma}} \right) + \sup_{w_h \in W_h} \frac{|l(w_h) - l_h(w_h)|}{\|w_h\|_{\Gamma}} \right)
$$
(5.85)

We now turn to presenting our main a priori error estimate.

<span id="page-22-0"></span>**Theorem 5.10** (Error estimate in energy norm). Let u be the exact solution to  $a(u, v) =$  $l(v)$  and let  $u_h$  be the finite element solution to the approximate problem  $a_h(u_h, v_h) =$  $l_h(v_h)$  where  $\beta$  in  $a_h(\cdot, \cdot)$  is chosen sufficiently large for coercivity to hold (see Lemma [5.6\)](#page-19-4). For  $h < h_0$ , with  $h_0$  small enough, the following error estimate holds

$$
\| |u - u_h||_{\Gamma} \lesssim h \|f\|_{L^2(\Gamma)} \tag{5.86}
$$

*Proof.* By coercivity  $(5.52)$ , continuity  $(5.50)$ , weak formulation  $(4.16)$ , and method for-mulation [\(4.23\)](#page-13-3) the first Strang lemma above holds in our setting. Choosing  $v_h = \pi u$  to handle the infimum yields an inequality with three independent terms

$$
\|u - u_h\|_{\Gamma} \lesssim I + II + III \tag{5.87}
$$

where we will show that there exists constants independent of the meshsize  $h$  such that the following estimates hold

$$
I := \| |u - \pi u\|_{\Gamma} \lesssim h \|u\|_{H^3(\Gamma)} \tag{5.88}
$$

$$
II := \sup_{w_h \in W_h} \frac{|a(\pi u, w_h) - a_h(\pi u, w_h)|}{\| \|w_h\|_{\Gamma}} \lesssim h \|u\|_{H^3(\Gamma)} \tag{5.89}
$$

$$
III := \sup_{w_h \in W_h} \frac{|l(w_h) - l_h(w_h)|}{\| \|w_h\| \|_{\Gamma}} \lesssim h^2 \|f\|_{L^2(\Gamma)} \tag{5.90}
$$

and recall that  $||u||_{H^4(\Gamma)} \lesssim ||f||_{L^2(\Gamma)}$  by the stability estimate [\(4.6\)](#page-10-4).

Term I: This estimate directly follows from Lemma [5.3](#page-16-9) (interpolation).

Term II: By Lemma [5.7](#page-19-3) and Lemma [5.5](#page-18-2) we have  $|a(\pi u, w_h) - a_h(\pi u, w_h)|$  $\lesssim h \|\|\pi u\||_{\Gamma} \|\|w_h\||_{\Gamma}$  yielding

$$
II \lesssim \frac{h \|\|\pi u\|_{\Gamma} \|\|w_h\|\|_{\Gamma}}{\|\|w_h\|\|_{\Gamma}} \lesssim h \|\pi u\|_{\Gamma} \le h \left(\|\|u - \pi u\|\|_{\Gamma} + \|\|u\|\|_{\Gamma}\right) \lesssim h \|u\|_{H^3(\Gamma)} \tag{5.91}
$$

where we use the triangle inequality, interpolation  $(5.22)$ , and Lemma [5.5.](#page-18-2)

Term III: This estimate directly follows from Lemma [5.7.](#page-19-3)

Next we prove an a priori estimate in  $L^2$  norm using a duality argument (Aubin– Nitsche's trick). We assume that for all  $\psi \in W$  with  $(\psi, 1)_{\Gamma} = 0$  there is a  $\phi \in V$  with  $(\phi, 1)$ <sub>Γ</sub> = 0 such that

$$
a(v, \phi) = (v, \psi)_{\Gamma} \qquad \text{for all } v \in W \tag{5.92}
$$

for which the stability estimate [\(4.6\)](#page-10-4) holds, i.e.

$$
\|\phi\|_{H^4(\Gamma)} \lesssim \|\psi\|_{L^2(\Gamma)}\tag{5.93}
$$

<span id="page-23-0"></span>**Theorem 5.11** (Error estimate in  $L^2$  norm). Given the assumptions of Theorem [5.10](#page-22-0) and that the stability estimate [\(5.93\)](#page-23-1) holds we for  $h < h_0$ , with  $h_0$  small enough, have the following error estimate

$$
||u - u_h||_{L^2(\Gamma)/\mathbb{R}} \lesssim h^2 ||f||_{L^2(\Gamma)} \tag{5.94}
$$

*Proof.* Let  $v = \psi = u - u_h - \mathcal{P}_0^{\Gamma}(u - u_h)$ . By [\(5.92\)](#page-23-2) we then have

$$
||u - u_h||_{L^2(\Gamma)/\mathbb{R}}^2 = a(u - u_h, \phi) = a(u - u_h, \phi - \pi\phi) + a(u - u_h, \pi\phi)
$$
(5.95)

where the first term by continuity  $(5.50)$ , Theorem [5.10,](#page-22-0) and interpolation  $(5.22)$  is limited by

$$
a(u - u_h, \phi - \pi \phi) \le ||u - u_h||_{\Gamma} ||\phi - \pi \phi||_{\Gamma} \lesssim h^2 ||f||_{L^2(\Gamma)} ||\phi||_{H^3(\Gamma)} \tag{5.96}
$$

For the second term in [\(5.95\)](#page-23-3) we by [\(4.16\)](#page-12-0), [\(4.23\)](#page-13-3), and adding and subtracting terms have

$$
a(u - u_h, \pi \phi) = l(\pi \phi) - a(u_h, \pi \phi) \tag{5.97}
$$

$$
= (l(\pi\phi) - l_h(\pi\phi)) + (a_h(u_h, \pi\phi) - a(u_h, \pi\phi))
$$
\n(5.98)

where we note that

$$
l(\pi\phi) - l_h(\pi\phi) \lesssim h^2 \|f\|_{L^2(\Gamma)} \|\pi\phi\|_{\Gamma}
$$
\n(5.99)

<span id="page-23-4"></span>
$$
\leq h^2 \|f\|_{L^2(\Gamma)} \left( \|\|\phi\|_{\Gamma} + \|\|\phi - \pi\phi\|\|_{\Gamma} \right) \tag{5.100}
$$

 $\lesssim h^2 \|f\|_{L^2(\Gamma)} \|\phi\|_{H^3(\Gamma)}$  (5.101)

through Lemma [5.7,](#page-19-3) the triangle inequality and interpolation [\(5.22\)](#page-16-6). Directly applying  $(5.58)$  of Lemma [5.7](#page-19-3) also to the second term of  $(5.98)$  only yields  $\mathcal{O}(h)$  which is insufficient to prove this theorem. Instead we shall utilize that  $u_h$  and  $\pi\phi$  are approximations to functions u and  $\phi$ , both encompassing high regularity. By adding and subtracting terms we rewrite the second term of [\(5.98\)](#page-23-4) as the sum of three terms

$$

We now introduce the corresponding  $L^2$  estimate on  $\Gamma_h$  which is more practical as the exact surface may be unknown or not easily integrated.

where we use  $1 - \frac{|\Gamma|}{|\Gamma_h|} = (1 - \mu_h, 1)_{\Gamma_h}$ ,  $|\Gamma_h| \leq |\Gamma|$ , and the bound [\(3.16\)](#page-8-1) for  $1 - \mu_h$  in the last inequality. Choosing  $w = u - u_h$  gives by the triangle inequality,  $\mathcal{P}_0^{\Gamma_h} u_h = 0$ , and Lemma [3.3](#page-9-1) that

We now turn to our numerical experiments where we present convergence studies in  $L^2(\Gamma_h)$  norm to confirm the estimate given by Corollary [5.11.1.](#page-25-1)

### <span id="page-25-0"></span>6 Numerical results

#### 6.1 Model problems

For the numerical results we consider two problems with the same geometries and solutions as the model problems considered in [\[23\]](#page-40-5) for the Laplace–Beltrami-problem. The two geometries and solutions are illustrated in Figure [2.](#page-26-0) We analytically calculate the appropriate load functions for the biharmonic problem by inserting the prescribed solutions into the equation.

In the first model problem we consider a sphere with radius  $r = 1$ . The spherical coordinates  $\{\theta, \phi\}$  for the sphere surface are defined such that the corresponding Cartesian coordinates are expressed

with  $0 \leq \theta < \pi$  and  $0 \leq \phi \leq 2\pi$ . Given  $f = -12r^{-2} \sin(\phi) \sin(\theta)^3 (4\sin(\phi)^2 - 3)$  we then have the analytical solution  $u = r^{-3}(3x^2y - y^3)$ . In the second model problem we consider a torus with  $R = 1, r = 0.6$ , with toroidal coordinates  $\{\theta, \phi\}$  for the torus surface defined such that the corresponding Cartesian coordinates are given by

$$
\{x = (R + r\cos(\theta))\cos(\phi), y = (R + r\cos(\theta))\sin(\phi), z = r\sin(\theta)\}\
$$
 (6.2)

with  $0 \leq \theta < 2\pi$  and  $0 \leq \phi < 2\pi$ . Using f defined through the MATLAB-code in Appendix [D](#page-38-0) we have the analytical solution  $u = \sin(3\phi) \cos(3\theta + \phi)$ .

#### 6.2 Convergence

For the convergence study on both model problems we used structured meshes illustrated in Figure [3](#page-27-0) and unstructured meshes illustrated in Figure [4.](#page-27-1) The unstructured meshed were created by random perturbation of the vertices in the structured meshes. Using a penalty parameter  $\beta = 10$ , a choice which we motivate in the next section, we in Figure [5](#page-28-0) present the results from our convergence study in  $L^2(\Gamma_h)$  norm for the two model problems on the structured meshes and in Figure [6](#page-28-1) the corresponing results on the unstructured meshes. The number of degrees of freedom in this study range from 0.8k to 190k in the sphere model problem and from 1.6k to 340k in the torus model problem, and the number of elements are approximately half of those numbers.

The results in figures [5](#page-28-0) and [6](#page-28-1) indicate that the order of convergence is 2 in  $L^2(\Gamma_h)$ norm which gives confirmation to the sharpness of the  $L^2(\Gamma_h)$  estimate presented in Corollary [5.11.1.](#page-25-1) We note more fluctuations in the torus model problem which we assume are due to the more complex geometry to approximate and also a more complicated load function and analytical solution as suggested by the illustrations of the solutions in Figure [2.](#page-26-0)

#### 6.3 Choice of penalty parameter  $\beta$

In Figure [7](#page-29-1) we study how the choice of the penalty parameter  $\beta$  affects the convergence in the two model problems on unstructured meshes. The numerical study indicates that  $\beta = 10$  is a good choice. From the analysis we have that we must choose  $\beta$  large enough for the error estimate to hold, and we also notice some instability for small  $\beta$  in the numerical study. On the other hand, choosing  $\beta$  too large will delay the asymptotic regime which is also seen in the numerical study.

By reviewing the analysis we also note that the proof of coercivity for the method (Lemma [5.6\)](#page-19-4) does not depend on the local curvature of the surface as it is based on an inverse estimate [\(5.37\)](#page-17-2) on the discrete surface  $\Gamma_h$ , which is locally flat. Thus, the choice of  $\beta$  does not directly depend on the local curvature of the problem.

### <span id="page-29-0"></span>A Proof of Lemma [3.1](#page-7-4)

*Proof.* Estimate  $(3.8)$  follows from the definition of d and a standard interpolation estimate

Now estimate [\(3.10\)](#page-7-6) readily follows as  $||n_h - (n \cdot n_h)n||_{L^{\infty}(\Gamma_h)} \leq 2||n - n_h||_{L^{\infty}(\Gamma_h)}$  and analogously so does estimate [\(3.11\)](#page-7-7). Using the *n*-mode product  $[21, Sect. 2.5]$  briefly presented for tensor-matrix multiplications in Section [2.2](#page-4-2) we may also express tensor-vector multiplications. Componentwise

the *n*-mode multiplication between a *k*:th order tensor  $T \in \mathbb{R}^{3 \times \cdots \times 3}$  and a vector  $a \in \mathbb{R}^{3}$ is defined as

and we will now handle the resulting two terms separately.

Noting that  $||d||_{L^{\infty}(\mathcal{E}_{\Gamma})} \leq ||d||_{L^{\infty}(\Gamma)}$ , using bounds [\(3.8\)](#page-7-2) and [\(3.13\)](#page-7-8), and finally applying the trace inequality  $(5.10)$  yields the last inequality. For term II we again use [\(4.18\)](#page-12-2) and then the divergence theorem to write

where  $Z := ((D_{\Gamma}(\chi_{\Gamma}))^{\ell} \times_2 H + ((P \otimes \overleftarrow{\nabla})^{\ell} \times_2 \chi_{\Gamma}^{\ell}) \times_2 H)$  and we note that  $\chi_{\Gamma}^{\ell} \otimes \overleftarrow{\nabla}$  is tangential in the second tensorial dimension, i.e.  $\chi_{\Gamma}^{\ell} \otimes \overleftrightarrow{\nabla} = (\chi_{\Gamma}^{\ell} \otimes \overleftrightarrow{\nabla})P = \chi_{\Gamma}^{\ell} \otimes \overleftrightarrow{\nabla}_{\Gamma}$ . Thus, the divergence on the approximate surface of  $\chi_{\Gamma}^{\ell}$  can be written

The second inequality then follows from the bound [\(3.16\)](#page-8-1) on  $1-\mu_h$  and Lemma [3.2](#page-8-0) applied to the last term in [\(C.50\)](#page-38-3). Finally, the last inequality follows by the same motivation as [\(C.25\)](#page-36-3). This concludes the proof of the estimate and the lemma.  $\Box$
