# PRESCRIBING THE BINARY DIGITS OF THE PRIMES, II 

JEAN BOURGAIN


#### Abstract

We obtain the expected asymptotic formula for the number of primes $p<N=2^{n}$ with $r$ prescribed (arbitrary placed) binary digits, provided $r<c n$ for a suitable constant $c>0$. This result improves on our earlier result where $r$ was assumed to satisfy $r<c\left(\frac{n}{\log n}\right)^{4 / 7}$.


## 1. Summary

This paper is a follow up on [B1]. We establish the following stronger statement.

Theorem. Let $N=2^{n}$, $n$ large enough, and $A \subset\{1, \ldots, n-1\}$ such that

(c a suitable constant). Then, considering binary expansions
$x=\sum_{j<n} x_{j} 2^{j}\left(x_{0}=1\right.$ and $x_{j}=0,1$ for $\left.1 \leq j<n\right)$ and assignments $\alpha_{j}$ for $j \in A$, we have

In [B1], the corresponding result was proven under the more restrictive condition

\end{equation*}

We also refer the reader to [B1], B2] for some background and motivation. In particular the paper of Harman and Katai [ $\mathrm{H}-\mathrm{K}$ ] and complexity issues for the Moebius function and the primes, raised by G. Kalai, were seminal to those investigations.

The strategy followed here is roughly similar to the one in [B1], except for the fact that the additive Fourier spectrum (together with Vinogradov's estimate) is only used to bound the contribution of the minor arcs. In the treatment of the major arcs, we switch immediately to multiplicative characters (see (3.8) below) and are led to study correlations of both the

von Mangoldt function $\Lambda$ and the given function $f=1_{\left[x<N ; x_{j}=\alpha_{j}\right.}$ for $\left.j \in A\right]$ with multiplicative characters. This issue for $\Lambda$ is classical and depends on Dirichlet $L$-function theory. We rely here on the same basic facts that were used in [B1]. As in [B1], we subdivide primitive characters $\mathcal{X}$ into two classes $\mathcal{G}$ and $\mathcal{B}$ ('good' and 'bad') depending on the zero-free region of $L(s, \mathcal{X})$. It turns out that non-trivial bounds on the multiplicative spectrum of $f$ are only required if $\mathcal{X} \in \mathcal{B}$ (which is a small set of characters). Here, we are again invoking the Gallagher-Iwaniec estimate on the improved zerofree region of $L(s, \mathcal{X})$ for $\mathcal{X}(\bmod q)$ with $q$ a power of 2 , though the precise quantitative form of $[I]$ (which was responsible for the condition (1.3)) is no longer relevant here. Basically any statement that for $q$ as above, $L(s, \mathcal{X})$ has a zero-free region $1-\sigma<c \frac{\log \log q T}{\log q T},|\gamma|<T$, where $\rho=\sigma+i \gamma$, would suffice for our purpose. This fact ensures then that no character $\mathcal{X} \in \mathcal{B}$ has conductor which is a power of 2 , which is essential to our analysis. Note that possible Siegel zero's in any case forces us to introduce the class $\mathcal{B}$, even if $r$ were further reduced. As in [B1], one needs to evaluate sums of the form

with $I \subset\{1, \ldots, N\}$ intervals of a certain size and $\mathcal{X} \in \mathcal{B}, \mathcal{X}(\bmod q)$, $\left(q, q_{0}\right)=1$. The main technical innovation compared with B1] is a more efficient strategy to estimate these sums, leading to the required information under less restrictive hypothesis on $r$.

The above theorem may be seen as a relative of Linnik's result on the least prime in an arithmetic progression. One key difference is that possible Siegel zero's do not affect the final statement (though they play technically a role in the argument).

Our presentation is completely self-contained, apart from basic number theoretic results and we will not refer to (B1].

## 2. Preliminaries

For $x \in\left\{1,2, \ldots, 2^{n}-1\right\}$, write $x=\sum_{0 \leq j<n} x_{j} 2^{j}$ with $x_{j}=0,1$.
Let

f(x)=1_{\left[x<2^{n} ; x_{j}=\alpha_{j} \text { for } j \in A\right]} \text { and } N=2^{n}
$$

where

A=\left\{0=j_{0}<j_{1}<\ldots<j_{r}\right\} \subset\{0,1, \ldots, n-1\}
$$

We assume

r+1=|A|=\rho n \tag{2.1}
\end{equation*}
$$

with $\rho>0$ bounded by a sufficiently small constant $c>0$.
For $\lambda \in \mathbb{R}$, denote

\hat{f}(\lambda)=2^{-n} \sum_{x=0}^{2^{n}-1} e^{2 \pi i \lambda x} f(x)=2^{-|A|} \prod_{j \in A} e^{2 \pi i \lambda \alpha_{j} 2^{j}} \prod_{\substack{1 \leq j<n \\ j \notin A}} \frac{1+e^{i \pi \lambda 2^{j+1}}}{2} .
$$

Thus

|\hat{f}(\lambda)|=2^{-|A|} \prod_{\substack{1 \leq j<n \\ j \notin A}}\left|\cos \pi \lambda 2^{j}\right| . \tag{2.2}
\end{equation*}
$$

Lemma 1.

2^{r+1} \sum_{k=0}^{2^{n}-1}\left|\hat{f}\left(\frac{k}{2^{n}}\right)\right|<2^{C \rho\left(\log \frac{1}{\rho}\right) n} \tag{2.3}
\end{equation*}
$$

for some constant $C$.

Proof. By (2.2), the left side of (2.3) equals

\sum_{k=0}^{2^{n}-1} \prod_{\substack{1 \leq j<n \\ j \notin A}}\left|\cos \pi \frac{k}{2^{n-j}}\right| . \tag{2.4}
\end{equation*}

Writing $k=k^{\prime}+2^{n-j_{1}} \ell, 0 \leq k^{\prime}<2^{n-j_{1}}, 0 \leq \ell<2^{j_{1}}$, we get

\text { (2.4) }=\sum_{k^{\prime}<2^{n-j_{1}}} \sum_{\ell<2^{j_{1}}} \prod_{j=1}^{j_{1}-1}\left|\cos \pi\left(\frac{k^{\prime}}{2^{n-j}}+\frac{\ell}{2^{j_{1}-j}}\right)\right| \prod_{\substack{j_{1}<j<n \\ j \notin A}}\left|\cos \pi \frac{k^{\prime}}{2^{n-j}}\right| .
$$

Evaluate the inner sum with fixed $k^{\prime}$ as

& \max _{\theta} \sum_{\ell<2^{j_{1}}} \prod_{j=1}^{j_{1}-1}\left|\cos \pi \frac{2^{j}(\ell+\theta)}{2^{j_{1}}}\right|= \\
& \max _{\theta}\left\{\sum_{\ell<2^{j_{1}}} 2^{-j_{1}}\left|\sum_{x=0}^{2^{j_{1}}-1} e^{2 \pi i x 2^{-j_{1}}(\ell+0)}\right|\right\} \leq \\
& \max _{\theta}\left\{\sum_{\ell<2^{j_{1}}} \frac{4}{2^{j_{1}}\left\|\frac{\ell+\theta}{2^{j_{1}}}\right\|+1}\right\}<C j_{1}
\end{aligned}
$$

for some constant $C$. Hence

$$
\text { (2.4) }<C\left(j_{1}-j_{0}\right) \sum_{k^{\prime}<2^{n-j_{1}}} \prod_{\substack{j_{1}<j<n \\ j \notin A}}\left|\cos \pi \frac{k^{\prime}}{2^{n-j}}\right|
$$

and we repeat the process with the $k^{\prime}$-sum, replacing $n$ by $n-j_{1}, j_{1}$ by $j_{2}-j_{1}$ etc. It follows that

\end{equation*}

where we have set $j_{r+1}=n$. Since $u \leq \frac{1}{\theta} 2^{\theta u}$ for $u \geq 0, \theta \geq 0$,

\text { (2.5) }<\left(\frac{C}{\theta}\right)^{r} 2^{\theta n}=\left(\left(\frac{C}{\theta}\right)^{\rho} 2^{\theta}\right)^{n}<2^{C \rho\left(\log \frac{1}{\rho}\right) n}

for an appropriate choice of $\theta$, proving (2.3).

## Lemma 2.

2^{r} \int_{0}^{1}|\hat{f}(\theta)| d \theta<2^{C \rho\left(\log \frac{1}{\rho}\right) n-n} \tag{2.6}
\end{equation*}

Proof.
Since $\hat{f}(\theta)$ is a trigonometric polynomial with spectrum in $\left\{0,1, \ldots, 2^{n}-1\right\}$,

\hat{f}(\theta)=2^{-n} \sum_{k=0}^{2^{n}-1} \hat{f}\left(\frac{k}{2^{n}}\right) D\left(\theta-\frac{k}{2^{n}}\right)
$$

with $D(\theta)=\sum_{k=0}^{2^{n}-1} e^{2 \pi i k \theta}$ the Dirichlet kernel. It follows from Lemma 1 that

2^{r} \int_{0}^{1}|\hat{f}(\theta)| d \theta \leq\|D\|_{1} 2^{C \rho\left(\log \frac{1}{\rho}\right) n-n} \lesssim n 2^{C \rho\left(\log \frac{1}{\rho}\right) n-n}

proving (2.6).

Lemma 3. Let $Q<2^{n / 100}$. Then

Proof. Take $m$ such that

Clearly there is $0<j_{*}<n-2 m$ so that the interval $I=\left\{j_{*}, \ldots, j_{*}+m-1\right\}$ satisfies

We note that

2^{r}\left|\hat{f}\left(\frac{a}{q}\right)\right| \leq \prod_{j \in I \backslash A^{\prime}}\left|\cos \frac{\pi a 2^{j}}{q}\right|=2^{r^{\prime}}\left|\hat{g}\left(\frac{a 2^{j_{*}}}{q}\right)\right|
$$

where

\left.g=1_{\left[x<2^{m} ; x_{j}=\alpha_{j+j_{*}}\right.} \text { for } j \in A^{\prime}-j_{*}\right]
$$

It follows then from $(2.6),(2.8)$ that

2^{r^{\prime}} \int_{0}^{1}|\hat{g}(\theta)| d \theta<2^{C \rho\left(\log \frac{1}{\rho}\right) m-m} \tag{2.9}
\end{equation*}
$$

The set of points $\mathcal{F}=\left\{\frac{a 2^{j *}}{q}(\bmod 1) ; q<Q, q\right.$ odd, $\left.(a, q)=1\right\}$ are clearly pairwise $2^{-m}$-separated. Write for $\xi \in \mathcal{F}$

|\hat{g}(\xi)| \leq 2^{m} \int_{|\theta-\xi|<2^{-m-1}}|\hat{g}(\theta)| d \theta+2^{m} \int_{|\theta-\xi|<2^{-m-1}}|\hat{g}(\theta)-\hat{g}(\xi)| d \theta
$$

and

\sum_{\xi \in \mathcal{F}}|\hat{g}(\xi)| & \leq 2^{m} \int_{0}^{1}|\hat{g}|+\int_{0}^{1}\left|(\hat{g})^{\prime}\right| \\
2^{r^{\prime}} \sum_{\xi \in \mathcal{F}}|\hat{g}(\xi)| & \lesssim 2^{m+r^{\prime}} \int_{0}^{1}|\hat{g}|<2^{C \rho\left(\log \frac{1}{\rho}\right) m}<Q^{2 C \rho \log \frac{1}{\rho}}
\end{aligned}
$$

where we used Bernstein's inequality and (2.9). This proves (2.7)

For small $q$, there is the following individual bond.
Lemma 4. Let $1<q<n^{\frac{1}{10_{\rho}}}$ and odd, $(a, q)=1$. Then

\end{equation*}
$$

where $\gamma$ is an upper bound on

\prod_{\substack{0 \leq j<\ell \\ j \notin E}}\left|\cos \pi 2^{j} \frac{a^{\prime}}{q}\right| \tag{2.12}
\end{equation*}
$$

where $\left(a^{\prime}, q\right)=1$ and $E \subset\{0,1, \ldots, \ell-1\}$ satisfies $|E|<2 \rho \ell$.
Take $0 \leq j_{*} \leq 2 \rho \ell$ such that $j_{*} \notin E$ and set $2^{-\ell^{\prime}-1} \leq\left\|2^{j_{*} \frac{a^{\prime}}{q}}\right\|<2^{-\ell^{\prime}}$, $0 \leq \ell^{\prime} \leq \ell$.

Then

\left\|2^{j} \frac{a^{\prime}}{q}\right\| \sim 2^{j-j_{*}-\ell^{\prime}} \text { for } 0 \leq j-j_{*}<\ell^{\prime}-1
$$

If $\ell^{\prime}>10+2 \rho \ell$, we can find $j$ such that $\ell^{\prime}-2 \rho \ell \leq j-j_{*}<\ell^{\prime}-1$ and $j \notin E$.
Then $\left\|2^{j} \frac{a^{\prime}}{q}\right\| \gtrsim 2^{-2 \rho \ell}$. Hence, in either case we find some $0 \leq j<\ell$, $j \notin E$, such that $\left\|2^{j} \frac{a^{\prime}}{q}\right\| \gtrsim 2^{-2 \rho \ell} \gtrsim q^{-2 \rho}$. It follows that

(2.12) \leq\left|\cos \pi 2^{j} \frac{a^{\prime}}{q}\right|<1-\frac{1}{2}\left\|\frac{2^{j} a^{\prime}}{q}\right\|^{2}<1-c q^{-4 \rho}
$$

Substituting in (2.11) gives the bound $e^{-\frac{c n}{q^{4 \rho} \log q}}$ and the Lemma follows.

## 3. Minor Arcs contribution

Let $N=2^{n}$. Write

\end{equation*}

denoting

\end{equation*}
$$

and

S_{f}(\alpha)=\sum f(k) e(k \alpha)=N \hat{f}(\alpha) \tag{3.3}
\end{equation*}
$$

We assume $f(k)=0$ for $k$ even, since obviously $k \equiv 1(\bmod 2)$ is a necessary condition for $f$ to capture primes.

We fix a parameter $B=B(n)$ which will be specified later, $B$ at most a small power of $N$.

The major arcs are defined by

\end{equation*}

Given $\alpha$, there is $q<\frac{N}{B}$ such that

\left|\alpha-\frac{a}{q}\right|<\frac{B}{q N}<\frac{1}{q^{2}}
$$

From Vinogradov's estimate (Theorem 13.6 in [I-K])

|S(\alpha)| & <\left(q^{\frac{1}{2}} N^{\frac{1}{2}}+q^{-\frac{1}{2}} N+N^{\frac{4}{5}}\right)(\log N)^{3} \\
& \ll\left(\frac{N}{\sqrt{B}}+\frac{N}{\sqrt{q}}+N^{4 / 5}\right)(\log N)^{3} \tag{3.5}
\end{align*}
$$

Hence if $q \geq B$,

|S(\alpha)| \ll \frac{N}{\sqrt{B}}(\log N)^{3} \tag{3.6}
\end{equation*}
$$

Thus the minor arcs contribution in (3.1) is at most

\end{equation*}

Since by (2.16)

\end{equation*}
$$

we take

\end{equation*}

which takes care of the minor arcs contribution.

## 4. Major arcs analysis

Next, we analyze the major arcs contributions ( $q<B$ )

\sum_{(a, q)=1} \int_{\left|\alpha-\frac{a}{q}\right|<\frac{B}{q N}} S(\alpha) \bar{S}_{f}(\alpha) d \alpha \tag{4.1}
\end{equation*}

Write $\alpha=\frac{a}{q}+\beta$. Defining

\tau(\chi)=\sum_{m=1}^{q} \chi(m) e_{q}(m)
$$

we have (see [D], p. 147)

S(\alpha)=\frac{1}{\phi(q)} \sum_{\chi} \tau(\bar{\chi}) \chi(a)\left[\sum_{k \leq N} \chi(k) \Lambda(k) e(k \beta)\right]+O\left((\log N)^{2}\right) \tag{4.2}
\end{equation*}
$$

Assume $\chi$ is inducted by $\chi_{1}$ which is primitive $\left(\bmod q_{1}\right), q_{1} \mid q$. Then from [D], p. 67

\tau(\bar{\chi})=\mu\left(\frac{q}{q_{1}}\right) \bar{\chi}_{1}\left(\frac{q}{q_{1}}\right) \tau\left(\bar{\chi}_{1}\right) \tag{4.3}
\end{equation*}

which vanishes, unless $q_{2}=\frac{q}{q_{1}}$ is square free with $\left(q_{1}, q_{2}\right)=1$.
The contribution of $\chi$ in (4.1) equals

\frac{\tau(\bar{\chi})}{\phi(q)} \int_{|\beta|<\frac{B}{q N}}\left[\sum_{k \leq N} \chi(k) \Lambda(k) e(k \beta)\right]\left[\sum_{k<N} f(k)\left(\sum_{a=1}^{q} \chi(a) e_{q}(-a k)\right) e(-k \beta)\right] d \beta . \tag{4.4}
\end{equation*}
$$

We have

\sum_{a=1}^{q} e_{q}(a k) \chi(a)=\sum_{(a, q)=1} e_{q}(a k) \chi_{1}(a)
$$

$$
\begin{align*}
& =\left[\sum_{\left(a_{1}, q_{1}\right)=1} e_{q_{1}}\left(a_{1} k\right) \chi_{1}\left(a_{1}\right)\right]\left[\sum_{\left(a_{2}, q_{2}\right)=1} e_{q_{2}}\left(a_{2} k\right)\right] \mathcal{X}_{1}\left(q_{2}\right) \\
& =\overline{\chi_{1}}(k) \tau\left(\chi_{1}\right) c_{q_{2}}(k) \mathcal{X}_{1}\left(q_{2}\right) \tag{4.5}
\end{align*}
$$

where

\begin{equation*}
c_{q_{2}}(k)=\frac{\mu\left(\frac{q_{2}}{\left(q_{2}, k\right)}\right) \phi\left(q_{2}\right)}{\phi\left(\frac{q_{2}}{\left(q_{2}, k\right)}\right)} . \tag{4.6}
\end{equation*}

From (4.3), (4.5), (4.6)

\frac{\tau(\bar{\chi})}{\phi(q)}\left[\sum_{a=1}^{q} \chi(a) e_{q}(-a k)\right] & =\frac{\left|\tau\left(\chi_{1}\right)\right|^{2}}{\phi\left(q_{1}\right)} \frac{1}{\phi\left(\frac{q_{2}}{\left(q_{2}, k\right)}\right)} \mu\left(\left(q_{2}, k\right)\right) \overline{\chi_{1}}(k) \\
& =\frac{q_{1}}{\phi\left(q_{1}\right)} \frac{1}{\phi\left(\frac{q_{2}}{\left(q_{2}, k\right)}\right)} \mu\left(\left(q_{2}, k\right)\right) \overline{\chi_{1}}(k) \tag{4.7}
\end{align*}
$$

Returning to (4.2), rather than integrating in $\beta$ over the interval $|\beta|<\frac{B}{q N}$, we introduce a weight function

w\left(\frac{q N}{B} \beta\right)
$$

where $0 \leq w \leq 1$ is a smooth bumpfunction on $\mathbb{R}$ such that $w=1$ on $[-1,1]$, $\operatorname{supp} w \subset[-2,2]$ and

|\hat{w}(y)|<C e^{-|y|^{1 / 2}} .
$$

(Note that this operation creates in (4.1) an error term that is captured by the minor arcs contribution (3.7)).

Hence, substituting (4.7), (4.4) becomes

\frac{q_{1}}{\phi\left(q_{1}\right)} \frac{B}{q N} \sum_{k_{1}, k_{2}<N} \hat{w}\left(\frac{B}{q N}\left(k_{1}-k_{2}\right)\right) \mathcal{X}\left(k_{1}\right) \Lambda\left(k_{1}\right) f\left(k_{2}\right) \frac{\mu\left(\left(q_{2}, k_{2}\right)\right)}{\phi\left(\frac{q_{2}}{\left(q_{2}, k_{2}\right)}\right)} \overline{\mathcal{X}_{1}}\left(k_{2}\right) \tag{4.8}
\end{equation*}
$$

and we observe that by our assumption on $\hat{w}$ the $k_{1}, k_{2}$ summation in (4.8) is restricted to $\left|k_{1}-k_{2}\right|<\frac{q N}{B} n^{3}$, up to a negligible error.

We first examine the contribution of the principal characters.
For $\mathcal{X}=\mathcal{X}_{0}, q_{1}=1$ and (4.8) becomes

\end{equation*}

Fixing $k_{2}$, perform the $k_{1}$-summation in (4.9). Writing

where $I$ runs over a partition in intervals of size $\sim \frac{N}{B^{3}}$.

q_{2}^{\prime} \text { odd }}} \frac{1}{\phi\left(\frac{q_{2}}{q_{2}}\right)} \sum_{\substack{q_{2}^{\prime \prime} \left\lvert\, \frac{q_{2}}{q_{2}}\right., q_{2}^{\prime \prime} \text { odd }}} \alpha\left(q_{1}, q_{2}^{\prime} q_{2}^{\prime \prime}\right)
\end{aligned}
$$

and summation over sf $q_{2}<B$ gives

It is important to note that for this choice of $\eta_{*}$, no $\mathcal{X}_{1} \in \mathcal{B}$ has a conductor $q_{1}$ which is a power of 2 . Indeed, recalling the Gallagher-Iwaniec result (see $[\mathrm{H}-\mathrm{K}]$, Lemma 5 ), if $\mathcal{X}_{1}$ is primitive $\left(\bmod 2^{m}\right)$, we obtain the following improved zero-free region

## 5. Further estimates

It remains to obtain suitable bounds on $\kappa(q)$ and $\alpha\left(q_{1}, q_{0}\right)$ introduced in Assumptions A and B.

Write for $q<B, q$ sf and odd

Consider dyadic ranges $q \sim Q<B$. Lemma 3 provides an estimate $Q^{C \rho\left(\log \frac{1}{\rho}\right)-1}$ $<Q^{-\frac{1}{2}}$ (for $\rho$ small enough) for the corresponding contribution to the sum in the r.h.s. of (5.2), while, for $Q<n^{\frac{1}{10 \rho}}$, Lemma 4 gives an estimate $Q 2^{-\sqrt{n}}$. It follows that

\hat{\mathcal{X}}_{1}\left(a_{1}\right)=\frac{1}{q_{1}} \sum_{x=0}^{q_{1}-1} \mathcal{X}_{1}(x) e\left(-\frac{x a_{1}}{q}\right) .

Hence

and summing over $1 \leq q_{0}<B, q_{0}$ sf, odd, $\left(q_{0}, q_{1}\right)=1$, we obtain a bound

\frac{N}{\sqrt{q_{1}}} \log B \sum_{\substack{1 \leq q_{0}<B, q_{0} \text { sf, odd, }\left(q_{0}, q_{1}\right)=1 \\
\left(a_{0}, q_{0}\right)=1,\left(a_{1}, q_{1}\right)=1}} \frac{1}{q_{0}}\left|\hat{f}\left(\frac{a_{0}}{q_{0}}+\frac{a_{1}}{q_{1}}\right)\right| \\
\leq N . n \sum_{\substack{1<q<B^{2}, q \text { sf, odd } \\
(a, q)=1}} \frac{1}{\sqrt{q}}\left|\hat{f}\left(\frac{a}{q}\right)\right| . \tag{5.7}
\end{gather*}
$$

By a similar estimate as used for (5.2), we get for $\rho$ small enough

Write $k=z+2^{\nu} x$ with $z \in\left\{0,1, \ldots, 2^{\nu}-1\right\}, x<2^{n-\nu}$ and

|(5.9)| \leq \sum_{z=0}^{2^{\nu}-1} \max _{b^{\prime}}\left|\sum_{\substack{x<2^{n-\nu} \\ x+b^{\prime} \equiv 0\left(\bmod q_{0}\right)}} \mathcal{X}_{1}\left(b^{\prime}+x\right) f_{z}(x)\right| . \tag{5.11}
\end{equation*}
$$

Estimate the inner sum in (5.11) similarly to (5.5), with $f$ replaced by $f_{z}, q_{1}$ by $q_{1}^{\prime}, N$ by $2^{-\nu} N$. This gives a bound

$$
\begin{equation*}
2^{n-\nu} \mathbb{E}\left[f_{z}\right] \cdot(n-\nu)^{-\frac{1}{30 \rho}+1} \tag{5.12}
\end{equation*}
$$

Summation of (5.12) over $z<2^{\nu}$ implies that

$$
\text { (5.11) } \lesssim n^{-\frac{1}{30 \rho}+1} N 2^{-r}
$$

so that (5.8) holds in general.
Summarizing, we proved that

$$
\begin{equation*}
\sum_{\substack{q<B \\ q \text { sf, odd }}} \kappa(q) \lesssim n^{-\frac{1}{20 \rho}+1} \tag{5.13}
\end{equation*}
$$

and also

$$
\begin{equation*}
\sum_{\substack{q_{0}<B, q_{0} \text { sf, odd } \\\left(q_{0}, q_{1}\right)=1}} \alpha\left(q_{1}, q_{0}\right) \lesssim n^{-\frac{1}{30 \rho}+1} \tag{5.14}
\end{equation*}
$$

## 6. Conclusion

Recalling (4.20), (4.23), (4.29), (4.34) and inserting the estimates (5.13), (5.14), we find that

$$
\begin{align*}
& \sum_{x<N} \Lambda(x) f(x)=2 \mathbb{E}[f] N+ \\
& N \mathbb{E}[f] O\left(n^{-\frac{1}{20 \rho}+3}+n^{2} e^{-\sqrt{n}}+2^{r} B^{-1}+n^{3} N^{-\frac{1}{2} \eta_{*}}+n^{5} B^{-1}+n^{-\frac{1}{30 \rho}+3} B^{48 \eta_{*}}\right) \tag{6.1}
\end{align*}
$$

Recall also conditions (3.9), (4.11) on $B$.
It remains to choose $\eta_{*} \sim \frac{\log n}{n}$ appropriately and let $\rho$ be small enough to conclude the Theorem.
