# ANDRÉ-QUILLEN HOMOLOGY AND COMPLETE INTERSECTION FLAT DIMENSION

ABSTRACT. We study the relation between the vanishing of André-Quillen homology and complete intersection flat dimension and we extend some of the existing results in the literature.

# 1. INTRODUCTION

**Convention.** In this paper, rings are commutative, noetherian, and local with identity. In the entire paper,  $(R, \mathfrak{m}, k)$ ,  $(S, \mathfrak{n}, \ell)$ , and  $(T, \mathfrak{r}, v)$  are local rings where S and T are complete. When it is convenient,  $\varphi \colon R \to S$  and  $\sigma \colon S \to T$  will denote local ring homomorphisms.

Over forty years ago, André [1, 2] and Quillen [22, 23] introduced a homology theory for commutative algebras that is known as André-Quillen (or cotangent) homology. The *n*-th André-Quillen homology of the *R*-algebra *S* with coefficients in an *S*-module *N*, denoted  $D_n(S | R, N)$ , is the *n*-th homology module of  $\mathcal{L}_{\varphi} \otimes_S N$ , where  $\mathcal{L}_{\varphi}$  is the cotangent complex of  $\varphi$ , uniquely defined in the derived category of the category of *S*-modules. The vanishing of André-Quillen homology characterizes important classes of rings and ring homomorphisms; see; [1, 3, 6, 9, 10, 12, 22, 23].

To study the relation between the vanishing of André-Quillen homology and the structure of a local ring homomorphism  $\varphi$ , Avramov and Iyengar [10] introduced the notion of André-Quillen dimension of the *R*-algebra *S*, denoted AQ-dim<sub>R</sub> *S*, that is

$$\operatorname{AQ-dim}_{R} S := \sup\{n \in \mathbb{N} \mid \operatorname{D}_{n}(S \mid R, -) \neq 0\};$$

in particular, AQ-dim<sub>R</sub>  $S = -\infty$  if and only if  $D_n(S \mid R, -) = 0$  for all integers n.

In this paper, we investigate the relation between the vanishing of André-Quillen homology and complete intersection flat dimension. As the first application of this study, we prove the following theorem which is one of our main results in this paper; see 3.2 for the proof.

**Theorem A.** Assume that  $\sigma$  is surjective,  $\sigma \varphi$  is complete intersection at  $\mathfrak{r}$ , and AQ-dim<sub>S</sub>  $T < \infty$ . Then CI-dim<sub>S</sub>  $T < \infty$ .

It is worth mentioning that the surjectivity condition in this theorem can be removed if one can give an affirmative answer to a question posed by Foxby; see Remark 3.6.

The second main result of this paper is the following theorem, which extends a result of Soto [27, Proposition 12] and of Avramov, Henriques, and Şega [9, (2.5)(3)]; see 3.5 for the proof. Here,  $H_1(K.(\varphi))$ , denotes the first Koszul homology of  $\varphi$ ; see Definition 2.8

**Theorem B.** Assume that  $\varphi$  is essentially of finite type and  $\operatorname{CI-fd}_R S < \infty$ . Then  $\operatorname{AQ-dim}_R S \leq 2$  if and only if  $\operatorname{H}_1(K.(\varphi))$  is a free S-module.

# 2. Some Background Material

This section lists important foundational material for use in this paper. We use the notations  $\mu_R(M)$  and  $\operatorname{edim}(R)$  for the minimal number of generators of a finitely generated *R*-module *M* and the embedding dimension of the ring *R*, respectively.

The objects defined in the next definition are from the work of Avramov, Foxby, and B. Herzog [7].

**2.1.** A regular factorization of  $\varphi$  is a diagram of local ring homomorphisms  $R \xrightarrow{\varphi} R' \xrightarrow{\varphi'} S$  such that  $\varphi = \varphi' \dot{\varphi}$ , the map  $\dot{\varphi}$  is flat, the closed fibre  $R'/\mathfrak{m}R'$  is regular, and  $\varphi'$  is surjective. A Cohen factorization of  $\varphi$  is a regular factorization  $R \xrightarrow{\varphi} R' \xrightarrow{\varphi'} S$  of  $\varphi$  such that R' is complete. Since we assumed that S is complete, existence of a Cohen factorization of  $\varphi$  is guaranteed by [7, Theorem (1.1)].

**2.2.** The local ring homomorphism  $\varphi$  is called *complete intersection at*  $\mathfrak{n}$  if in a given Cohen factorization  $R \to R' \xrightarrow{\varphi'} S$  of  $\varphi$  the ideal Ker  $\varphi'$  is generated by an R'-regular sequence. The complete intersection property for  $\varphi$  is independent of the choice of Cohen factorization by [6, Remark (3.3)]. Also  $\varphi$  is called *locally complete intersection* if for each  $\mathfrak{q} \in \operatorname{Spec}(S)$ , the local homomorphism  $\varphi_{\mathfrak{q}} : R_{\mathfrak{p}} \to S_{\mathfrak{q}}$ , in which  $\mathfrak{p} = \mathfrak{q} \cap R$ , is complete intersection at  $\mathfrak{q}S_{\mathfrak{q}}$ .

We proceed with introducing the complete intersection flat dimension as defined by Sather-Wagstaff [25].

**2.3.** Fix a an arbitrary R-module M. Define

$$\operatorname{CI-fd}_R M := \inf \left\{ \operatorname{fd}_Q(R' \otimes_R M) - \operatorname{pd}_Q(R') \middle| \begin{array}{c} R \to R' \leftarrow Q \text{ is a} \\ \operatorname{quasi-deformation} \end{array} \right\}.$$

Recall that a diagram  $R \to R' \leftarrow Q$  of local ring homomorphisms is a *quasi*deformation of R if  $R \to R'$  is flat and  $R' \leftarrow Q$  is surjective with kernel generated by a Q-regular sequence. It is clear that if M is finitely generated then  $\operatorname{CI-dim}_R M = \operatorname{CI-fd}_R M$ .

**2.4.** Here, we recall some notions from [10, 20].

Let  $\overline{\varphi} \colon k \to \ell$  be the induced map between the residue fields. Then  $\varphi$  is called *almost small* if the kernel of the homomorphism

$$\operatorname{Tor}_{*}^{\varphi}(\overline{\varphi}, \ell) \colon \operatorname{Tor}_{*}^{R}(k, \ell) \to \operatorname{Tor}_{*}^{S}(\ell, \ell)$$

of graded algebras is generated by elements of degree 1. Assuming  $k = \ell$ , the homomorphism  $\varphi$  is called *large* if  $\operatorname{Tor}_*^{\varphi}(\overline{\varphi}, k)$  is surjective.

The next definition originates with work of Gulliksen and Levin [15]; see [5, §6] for details. It involves a different type of algebra extensions introduced by Tate [28]; see [5, 15] for details.

**2.5.** Let A be a DG R-algebra, and assume that  $\varphi$  is surjective. Let  $A\langle Y \rangle$  denote a DG R-algebra obtained from A by adjunctions of sets of exterior variables of positive odd degrees and of divided power variables of positive even degrees. Then a factorization  $R \longrightarrow R\langle Y \rangle \xrightarrow{\simeq} S$  of  $\varphi$  is called an *acyclic closure of*  $\varphi$  if  $\partial(Y_1)$ minimally generates Ker  $\varphi$ , and  $\{\operatorname{cls}(\partial(y)) \mid y \in Y_{n+1}\}$  is a minimal generating set of  $\operatorname{H}_n(R\langle Y_{\leq n} \rangle))$  for all  $n \geq 1$ .

**Fact 2.6.** If J = (x) = (y) is an ideal of R, such that x and y are two minimal set of generators for J, then the Koszul complexes associated to (x) and (y) are isomorphic, see [14], and hence homology isomorphism. Thus we define the Koszul complex,  $K.^{R}(J)$ , to be the Koszul complex associated to an arbitrary minimal set of generators for ideal J.

Fact 2.7. Let  $R \xrightarrow{\varphi_j} R_j \xrightarrow{\varphi_j} S$ , with  $J_j = \operatorname{Ker} \varphi_j$ , for j = 1, 2, be two arbitrary Cohen factorization of  $\varphi$ . From [7, (1.2)] it follows that they have a common deformation  $R \to R' \xrightarrow{\varphi'} S$ , with  $J' = \operatorname{Ker} \varphi'$  such that  $R_j = R'/I'_j$  and  $J_j = J'/I'_j$ , for j = 1, 2, where  $I'_j$  is an ideal generated by an R'-regular sequence that extends to a minimal set of generators for J'. Let  $\underline{\mathbf{x}}_j$  be a minimal set of generators for  $I'_j$ , which can be extended to a minimal set of generators  $\underline{\mathbf{x}}_j, \underline{\mathbf{y}}_j$  for J'. Then the residues  $\underline{\mathbf{y}}'_j$  of  $\underline{\mathbf{y}}_j$  in  $R_j$  form a minimal set of generators for  $J_j$ , by Nakayama's lemma. Now from the above fact we have

$$K^{R'}(J') \cong K^{R'}(\underline{\mathbf{x}}_j) \otimes_{R'} K^{R'}(\underline{\mathbf{y}}_j) \simeq R_j \otimes_{R'} K^{R'}(\underline{\mathbf{y}}_j) \cong K^{R_j}(\underline{\mathbf{y}}_j) \cong K^{R_j}(J_j).$$

Thus  $K.^{R'}(J') \simeq K.^{R_j}(J_j)$ , as R'-complexes, for j = 1, 2. Since  $J' \operatorname{H}(K.^{R'}(J')) = 0$ , we get  $\operatorname{H}(K.^{R'}(J')) \cong \operatorname{H}(K.^{R_j}(J_j))$ , as S-modules, for j = 1, 2.

By the above fact, we can give the following definition.

**Definition 2.8.** Let  $R \to R' \xrightarrow{\varphi'} S$  be a Cohen factorizations of  $\varphi$ , with  $J' = \text{Ker } \varphi'$ . We define the *n*th Koszul homology of  $\varphi$ , denoted by  $H_n(K.(\varphi))$ , to be  $H_n(K.^{R'}(J'))$ .

Indeed, we can consider  $H(K.(\varphi))$ , as an invariant of the local homomorphism  $\varphi$ .

**Lemma 2.9.** Let  $R \to R' \xrightarrow{\varphi'} S$  be a Cohen factorization of  $\varphi$ . If E is the Koszul complex associated to an arbitrary set of generators  $\underline{v}$  for  $J' := \text{Ker } \varphi'$ . Then  $H_1(E)$  is a free S-module if and only if  $H_1(K.(\varphi))$  is a free S-module.

*Proof.* Let  $\underline{\mathbf{v}} = x_1, ..., x_p, x_{p+1}, ..., x_n$ , in which  $\underline{\mathbf{w}} = x_1, ..., x_p$  is a minimal set of generators for J'. Then from [14, (1.6.21)] and Fact 2.6, we get

$$\mathrm{H}_{1}(E) \cong \mathrm{H}_{1}(K.^{R'}(\underline{\mathbf{w}})) \oplus S^{\oplus(n-p)} \cong \mathrm{H}_{1}(K.^{R'}(J')) \oplus S^{\oplus(n-p)}.$$

Now from the above fact, assertion holds.

**2.10.** Let M be a finitely generated R-module. The complexity of M over R, denoted by  $cx_R M$ , is the number

 $\operatorname{cx}_R M := \inf \{ d \in \mathbb{N} \mid \text{there exists } \gamma \in \mathbb{R} \text{ such that } \beta_n^R(M) \leqslant \gamma n^{d-1} \text{ for all } n \gg 0 \}$ where  $\beta_n^R(M) := \operatorname{rank}_k(\operatorname{Tor}_n^R(M,k))$  is the *n*-th *Betti number* of *M*.

#### 3. Main results

This section contains the proofs of Theorems A and B. We begin by a construction used by Iyengar and Sather-Wagstaff [19], essentially given by Avramov, Foxby, and B. Herzog [7]. We use this construction in the proof of Theorem A and in Remark 3.6.

**Construction 3.1.** Let  $R \xrightarrow{\dot{\varphi}} R' \xrightarrow{\varphi'} S$  and  $R' \xrightarrow{\dot{\rho}} R'' \xrightarrow{\rho'} T$  be Cohen factorizations of  $\varphi$  and  $\sigma \varphi'$ , respectively. Then  $\rho'$  factors through the tensor product  $S' = R'' \otimes_{R'} S$  and gives the following commutative diagram of local ring homomorphisms



in which  $\dot{\sigma}$  and  $\varphi''$  are the natural maps to the tensor product and the diagrams  $S \to S' \to T, R \to R'' \to T$ , and  $R' \to R'' \to S'$  are Cohen factorizations.

Here is the proof of Theorem A.

**3.2** (Proof of Theorem A). We use the notation from Construction 3.1. Since  $\sigma$  is surjective, we get the following diagram

$$R' \xrightarrow{\varphi'} S \xrightarrow{\sigma} T \tag{3.2.1}$$

of surjective local ring homomorphisms such that  $R \xrightarrow{\varphi} R' \xrightarrow{\sigma\varphi'} T$  is a Cohen factorization. Since  $\sigma\varphi$  is complete intersection at  $\mathfrak{r}$ , from [6, (1.7), (1.8)] we get that  $\sigma\varphi'$  is also complete intersection at  $\mathfrak{r}$ . Hence, by [10, Corollary (4.9)] we conclude that  $\varphi'$  is an almost small ring homomorphism. Since  $D_n(T \mid S, v) = 0$ for all  $n \gg 0$ , from the Jacobi-Zariski exact sequence arising from diagram (3.2.1), we find that  $D_n(S \mid R', v) = 0$  for all  $n \gg 0$ . Since  $\varphi'$  is almost small, it follows from [10, (6.4)] that  $\varphi'$  is complete intersection at  $\mathfrak{r}$ . Thus, Ker  $\varphi'$  is generated by an R'-regular sequence, and the diagram  $S \xrightarrow{\mathrm{id}} S \xleftarrow{\varphi'} R'$  of local ring homomorphisms, is a quasi-deformation. Hence, we conclude that  $\mathrm{pd}_{R'}(T \otimes_S S) = \mathrm{pd}_{R'} T < \infty$ .

The following lemma is an extension of [24, Lemma 1(2)]. This lemma is well-known; see [4]. For convenience of the reader we give a proof based on the Cohen factorization.

**Lemma 3.3.** If  $\operatorname{fd}_R S < \infty$ , then the homomorphism  $\operatorname{D}_2(S \mid R, \ell) \xrightarrow{\theta} \operatorname{D}_2(\ell \mid R, \ell)$  is trivial.

*Proof.* Let  $R \xrightarrow{\dot{\varphi}} R' \xrightarrow{\varphi'} S$  be a Cohen factorization of  $\varphi$ , and consider the following commutative diagram of local ring homomorphisms



where  $\pi$  is the natural surjection. This diagram induces a commutative diagram

of  $\ell$ -vector spaces.

Setting  $\overline{R'} := R'/\mathfrak{m}R'$ , from the Jacobi-Zariski exact sequence of  $k \to \overline{R'} \to \ell$  we get the following exact sequence:

$$D_{n+1}(\ell \mid \overline{R'}, \ell) \to D_n(\overline{R'} \mid k, \ell) \to D_n(\ell \mid k, \ell)$$
(3.3.2)

From [6, (1.6)(2)-(3)] we get  $D_n(\ell \mid k, \ell) = 0$  for all  $n \ge 2$ , and  $D_{n+1}(\ell \mid \overline{R'}, \ell) = 0$  for all  $n \ge 2$ . Hence, by (3.3.2) we conclude that  $D_n(\overline{R'} \mid k, \ell) = 0$  for all  $n \ge 2$ . On the other hand, by flat base change we have  $D_n(\overline{R'} \mid k, \ell) \cong D_n(R' \mid R, \ell)$  for all integers n; see [2, 4.54]. Therefore,  $D_n(R' \mid R, \ell) = 0$  for all  $n \ge 2$ . Now, the Jacobi-Zariski exact sequence arising from  $R \to R' \to \ell$  implies that  $\eta$  (from diagram (3.3.1)) is injective.

From [7, (3.2) Lemma] and our assumption, we have  $\operatorname{pd}_{R'} S < \infty$ . Hence by [24, Lemma 1(2)] we get that  $\alpha$  (from diagram (3.3.1)) is trivial. Therefore, commutativity of diagram (3.3.1) and the fact that  $\eta$  is injective imply that  $\theta$  is trivial.  $\Box$ 

**Lemma 3.4.** If AQ-dim<sub>R</sub>  $S \leq 2$ , then  $H_1(K.(\varphi))$  is a free S-module.

Proof. Let  $R \xrightarrow{\dot{\varphi}} R' \xrightarrow{\varphi'} S$  be a Cohen factorization of  $\varphi$ , and let  $J' := \operatorname{Ker} \varphi'$ . By assumption we get  $D_n(S \mid R, \ell) = 0$  for all  $n \ge 3$ . Hence,  $D_n(S \mid R', \ell) = 0$  for all  $n \ge 3$  by [6, Lemma (1.7)]. This implies that  $D_n(S \mid R', -) = 0$  for all  $n \ge 3$ . Now [13, Corollary 3] implies that  $H_1(E')$ , in which E' is the Koszul complex associated to an arbitrary set of generators for J', is a free S-module. The assertion now follows from Lemma 2.9.

Here is the proof of Theorem B.

**3.5** (Proof of Theorem B). Since  $\varphi$  is essentially of finite type, it admits a regular factorization  $R \to R[X]_{\mathfrak{M}} \to S$ , in which  $R[X] := R[x_1, x_2, ..., x_n]$ , for some  $n \ge 1$ , and  $\mathfrak{M}$  is a prime ideal of R[X] lying over  $\mathfrak{m}$ . Since  $\operatorname{CI-fd}_R S < \infty$ , there is a quasideformation  $R \to R'' \xleftarrow{\eta} Q$  of R such that  $\operatorname{fd}_Q(S \otimes_R R'') < \infty$ . Set  $R' := R[X]_{\mathfrak{M}}$ ,  $P := R' \otimes_R R'', U := S \otimes_R R''$ , and consider the diagram  $Q \xrightarrow{\alpha} P \xrightarrow{\beta} U$  of natural

ring homomorphisms, in which  $\beta$  is surjective. Let  $\mathfrak{u} \in \operatorname{Spec}(U)$ , and set  $\mathfrak{p} := \beta^{-1}(\mathfrak{u})$ and  $\mathfrak{q} := \alpha^{-1}(\mathfrak{p})$ . Then we have the diagram

$$Q_{\mathfrak{q}} \xrightarrow{\alpha_{\mathfrak{q}}} P_{\mathfrak{p}} \xrightarrow{\beta_{\mathfrak{p}}} U_{\mathfrak{u}}$$
(3.5.1)

of local ring homomorphisms that gives us the commutative diagram



of local ring homomorphisms. This diagram induces the following commutative diagram of  $k(\mathfrak{u})$ -vector spaces

Since  $\operatorname{fd}_{Q_{\mathfrak{q}}} U_{\mathfrak{u}} < \infty$ , it follows from Lemma 3.3 that  $\theta$  is trivial and hence g is surjective, and since  $\operatorname{H}_1(K.(\varphi))$  is a free S-module, we can see that  $\operatorname{H}_1(E)$  is a free  $U_{\mathfrak{u}}$ -module, where E is the Koszul complex associated to the set of generators for the ideal Ker  $\beta_{\mathfrak{p}}$  of  $P_{\mathfrak{p}}$  arising from a set of generators for Ker $\beta$ . Now from [14, (1.6.21)] it follows that  $\operatorname{H}_1(K.^{P_{\mathfrak{p}}}(\operatorname{Ker}(\beta_{\mathfrak{p}})))$  is a free  $U_{\mathfrak{u}}$ -module. Thus, from [?, Theorem 1] we conclude that f is trivial. Since  $\operatorname{D}_n(R[X] \mid R, -) = 0$  for all  $n \ge 1$ , we get  $\operatorname{D}_n(R' \mid R, -) = 0$  for all  $n \ge 1$ . The faithful flatness of R'' over R also yields  $\operatorname{D}_n(P \mid R'', -) = 0$  for all  $n \ge 1$ . Hence, setting  $\mathfrak{p}'' := \mathfrak{p} \cap R''$ , we get  $\operatorname{D}_n(P_{\mathfrak{p}} \mid R''_{\mathfrak{p}''}, k(\mathfrak{p})) = 0$  for all  $n \ge 1$ .

Consider the diagram  $Q_{\mathfrak{q}} \xrightarrow{\eta_{\mathfrak{q}}} R_{\mathfrak{p}''}' \to P_{\mathfrak{p}}$  of local ring homomorphisms. Since Ker  $\eta_{\mathfrak{q}}$  is generated by a  $Q_{\mathfrak{q}}$ -regular sequence, from the Jacobi-Zariski exact sequence we get  $D_n(P_{\mathfrak{p}} \mid Q_{\mathfrak{q}}, k(\mathfrak{p})) = 0$  for all  $n \ge 2$ . Thus, h in diagram (3.5.2) is injective. Commutativity of diagram (3.5.2) implies that  $D_2(U_{\mathfrak{u}} \mid Q_{\mathfrak{q}}, k(\mathfrak{u})) = 0$ . Hence, by [6, Proposition (1.8)] we get  $D_n(U_{\mathfrak{u}} \mid Q_{\mathfrak{q}}, k(\mathfrak{u})) = 0$  for all  $n \ge 2$ . Now, from the Jacobi-Zariski exact sequence of diagram (3.5.1) we conclude that  $D_n(U_{\mathfrak{u}} \mid P_{\mathfrak{p}}, k(\mathfrak{u})) = 0$  for all  $n \ge 3$ . Since  $\mathfrak{u}$  was an arbitrary prime ideal of U, we conclude that  $D_n(U \mid P, -) = 0$  for all  $n \ge 3$ ; see [2]. Now, faithful flatness of R'' over R implies that  $D_n(S \mid R', -) = 0$  for all  $n \ge 3$ . Thus, from [6, Lemma (1.7)] we have  $D_n(S \mid R, \ell) = 0$  for all  $n \ge 3$ . Since  $\varphi$  is essentially of finite type, from [18, Lemma 8.7] we conclude that AQ-dim\_R  $S \le 2$ .

The converse follows immediately from Lemma 3.4.

Foxby asked the following question in his personal communications.

**Foxby's Question**. Let  $R \xrightarrow{\dot{\varphi}} R' \xrightarrow{\varphi'} S$  be a Cohen factorization of  $\varphi$ , and let M be a finitely generated S-module. Do the following inequalities hold?

$$\operatorname{CI-fd}_R M \leq \operatorname{CI-dim}_{R'} M \leq \operatorname{CI-fd}_R N + \operatorname{edim}(R'/\mathfrak{m}R')$$

In the next remark, we show that an affirmative answer to this question helps us to generalize Theorem A. In fact, validity of the left inequality of Foxby's Question enables us to remove the hypothesis " $\sigma$  is surjective" in Theorem A; see (3.6.1). Also, we show that an affirmative answer to the right inequality in Foxby's Question provides a much shorter proof for Theorem B, without the assumption of finiteness of  $\varphi$ ; see (3.6.2).

**Remark 3.6.** (3.6.1) Using the notation from Construction 3.1, there exists a diagram  $R'' \xrightarrow{\varphi''} S' \xrightarrow{\sigma'} T$  of surjective local ring homomorphisms. Since  $\sigma\varphi$  is complete intersection at  $\mathfrak{r}$ , from [6, (1.7), (1.8)] we get that  $\sigma'\varphi''$  is also complete intersection at  $\mathfrak{r}$ . Now a similar argument as in the proof of Theorem A, yields CI-dim<sub>S'</sub>  $T < \infty$ . Then the left inequality of Foxby's Question implies that CI-fd<sub>S</sub>  $T < \infty$ , as desired.

(3.6.2) Let  $R \xrightarrow{\dot{\varphi}} R' \xrightarrow{\varphi'} S$  be a Cohen factorization of  $\varphi$ . From the right inequality in Foxby's Question, we get  $\operatorname{CI-dim}_{R'} S < \infty$ . Since  $\operatorname{H}_1(K.(\varphi))$  is a free *S*-module, from Lemma 2.9 and [27, Proposition 12] we conclude that  $D_n(S \mid R', \ell) = 0$  for all  $n \geq 3$ . Now, the assertion follows from [6, Lemma (1.7)] and [18, Lemma 8.7].

The next corollary of Soto [27, Proposition 12] and of Avramov, Henriques, and Sega [9, (2.5)(3)] follows from Theorem B and Lemma 2.9.

**Corollary 3.7.** Assume that  $\varphi$  is surjective, and let  $H_1(E)$  be the first homology of the Koszul complex E associated to an arbitrary set of generators for  $J := \text{Ker } \varphi$ . If CI-dim<sub>R</sub>  $S < \infty$  and  $H_1(E)$  is a free S-module, then AQ-dim<sub>R</sub>  $S \leq 2$ .

Using Theorem A, Lemma 3.4 and Corollary 3.7 we have the next result due to Soto [27, Proposition 23 (i) $\iff$ (ii)]. Recall that S is called an *algebra retract of* R if there exists a local ring homomorphism  $\psi \colon S \to R$  such that  $\varphi \psi = \operatorname{id}_S$ .

**Corollary 3.8.** Let S be an algebra retract of R and let  $H_1(E)$  be the first homology of the Koszul complex E associated to an arbitrary set of generators for  $J := \text{Ker } \varphi$ . Then AQ-dim<sub>B</sub>  $S \leq 2$  if and only if CI-dim<sub>R</sub>  $S < \infty$  and  $H_1(E)$  is a free S-module.

**Fact 3.9.** Let *S* be an algebra retract of *R* and  $\operatorname{cx}_R S < \infty$ . If  $\operatorname{char}(k) = 0$  then *S* contains the rational numbers. On the other hand  $\varphi \colon R \to S$  is a large homomorphism. Let  $R\langle U \rangle$  be the acyclic closure of  $\varphi$ , which is a minimal free resolution for *S* as an *R*-module by [11, Corollary (2.7)]. Since  $\operatorname{cx}_R S < \infty$ , it follows from [27, Lemma 16] that  $D_{2n}(S \mid R, -) = 0$  for all  $n \gg 0$ . Now from [10, Theorem (7.5)(iv) $\Longrightarrow$ (ii)] we have AQ-dim<sub>R</sub>  $S \leq 2$ . Thus by Corollary 3.8, CI-dim<sub>R</sub>  $S < \infty$ .

The above fact answers Soto's Problem 24 in [27] when char(k) = 0. As an application of this fact we also have the following result.

**Corollary 3.10.** Let  $A := S \otimes_R S$ , and assume that  $\varphi$  is a local flat homomorphism essentially of finite type. Let  $\omega : A \to S$  be the natural surjection and  $\mathfrak{q} = \omega^{-1}(\mathfrak{n})$ . If char $(\ell) = 0$  and  $\operatorname{cx}_{A_{\mathfrak{q}}} S < \infty$ , then  $\varphi$  is locally complete intersection.

Proof. Consider the algebra retract  $S \to A_q \to S$ . Fact 3.9 implies that AQ-dim<sub> $A_q$ </sub>  $S \leq 2$ . Using Jacobi-Zariski exact sequence arising from  $A \to A_q \to S$  and the localization property, we have AQ-dim<sub>A</sub>  $S \leq 2$ . Now Jacobi-Zariski exact sequence arising from the natural diagram  $S \to A \to S$ , and the flat base change imply that  $D_n(S \mid R, -) = 0$ , for  $n \geq 2$ . Thus  $\varphi$  is locally complete intersection by [6, Theorem (1.2)].

**Remark 3.11.** At this time, we do not know if the assumption char(k) = 0 is necessary in Fact 3.9. However, as we will see in Proposition 3.13, when we work with R as an algebra retract of its trivial extension by an R-module M with  $Ann_R(M) = 0$ , we are able to remove this assumption. This can be done using a result of Herzog.

Recall that the trivial extension of R by an R-module M, denoted  $R \ltimes M$ , is the underlying R-module  $R \oplus M$  equipped with a ring structure given by the multiplication rule  $(r, m) \cdot (r', m') = (rr', rm' + r'm)$ . There are ring homomorphisms  $\rho: R \to R \ltimes M$  with  $\rho(r) = (r, 0)$  and  $\pi: R \ltimes M \to R$  with  $\pi(r, m) = r$ . Note that the composition  $\pi\rho$  is the identity on R, that is, R is an algebra retract of  $R \ltimes M$ .

**Lemma 3.12.** Let M be a finitely generated R-module. Then for each non-negative integer i we have  $(\mu_R(M))^i \leq \beta_i^{R \ltimes M}(R)$ .

Proof. By [17, Corollary 1] we have  $P_R^{R \ltimes M}(t) = 1 + t P_R^{R \ltimes M}(t) P_M^R(t)$ . Hence, by induction on *i*, there exists a sequence  $\{\gamma_i\}$  of natural numbers such that  $\beta_i^{R \ltimes M}(R) = \gamma_i + (\mu_R(M))^i$ . Therefore,  $(\mu_R(M))^i \leq \beta_i^{R \ltimes M}(R)$ .

The following result gives a characterization of local rings admitting non-trivial semidualizing modules. Recall that a finitely generated R-module C is called *semidualizing* if  $R \cong \operatorname{Hom}_R(C, C)$  and  $\operatorname{Ext}_R^i(C, C) = 0$  for all i > 0. For instance, every finitely generated projective R-module of rank 1 is semidualizing. Also, every dualizing module is semidualizing with finite injective dimension.

**Proposition 3.13.** Let M be a finitely generated R-module with  $Ann_R(M) = 0$ . Then the following conditions are equivalent:

- (i)  $M \cong R$ .
- (ii) AQ-dim<sub> $R \ltimes M$ </sub> R = 2.
- (iii) CI-dim\_{R \ltimes M} R < \infty.
- (iv)  $\operatorname{cx}_{R\ltimes M} R < \infty$ .

If one of the above conditions holds, then  $\operatorname{CI-dim}_{R \ltimes M} R = 0$  and  $\operatorname{cx}_{R \ltimes M} R = 1$ .

*Proof.* (i)  $\implies$  (ii) Assume that  $M \cong R$ . It is straightforward to see that Ker  $\pi = (x)$ , where x is an exact zero divisor in the sense of [16], that is,  $\operatorname{Ann}_{R \ltimes M}(x) \cong (R \ltimes M)/x(R \ltimes M)$ . Hence,  $\operatorname{AQ-dim}_{R \ltimes M} R = 2$  by [9, 1.7, 3.1].

- (ii)  $\implies$  (iii) follows from Theorem A.
- (iii)  $\implies$  (iv) follows from [8, Theorem (5.3)].

(iv)  $\implies$  (i) Assume that  $\operatorname{cx}_{R \ltimes M} R < \infty$ . Hence, the sequence of the Betti numbers of R over  $R \ltimes M$  has polynomial growth. Since, by Lemma 3.12, for each non-negative integer i we have  $(\mu_R(M))^i \leq \beta_i^{R \ltimes M}(R)$ , we conclude that  $\mu_R(M) = 1$ , which implies that  $M \cong R$ .

Note that when  $\operatorname{CI-dim}_{R \ltimes M} R < \infty$ , then  $\operatorname{CI-dim}_{R \ltimes M} R = 0$  by [26, Lemma 3.14]. Note also that when  $M \cong R$ ,  $\operatorname{Ker} \pi$  is generated by an exact zero divisor x. Therefore,

$$\cdots \xrightarrow{x} R \ltimes R \xrightarrow{x} R \ltimes R \xrightarrow{\pi} R \to 0$$

is a free resolution of R over  $R \ltimes R$ , that is,  $\operatorname{cx}_{R \ltimes R} R = 1$ .

The following is an application of Proposition 3.13 in a concrete case.

**Example 3.14.** Let  $S = R[\underline{\mathbf{x}}]/J$ , where  $\underline{\mathbf{x}} = x_1, \dots, x_n$  for some integer  $n \ge 1$ , and  $J = \langle x_i^{n_i} x_j^{n_j} | n_i + n_j = 2$ , and  $1 \le i \le j \le n \rangle$ . Then one of the integers  $\operatorname{cx}_S R$ , CI-dim<sub>S</sub> R, or AQ-dim<sub>S</sub> R is finite if and only if n = 1. In this case we have  $\operatorname{cx}_S R = 1$ , CI-dim<sub>S</sub> R = 0, and AQ-dim<sub>S</sub> R = 2.
