# On the extremal values of the number of vertices with an interval spectrum on the set of proper edge colorings of the graph of the $n$-dimensional cube

#### Abstract

For an undirected, simple, finite, connected graph $G$, we denote by $V(G)$ and $E(G)$ the sets of its vertices and edges, respectively. A function $\varphi: E(G) \rightarrow\{1, \ldots, t\}$ is called a proper edge $t$-coloring of a graph $G$, if adjacent edges are colored differently and each of $t$ colors is used. The least value of $t$ for which there exists a proper edge $t$-coloring of a graph $G$ is denoted by $\chi^{\prime}(G)$. For any graph $G$, and for any integer $t$ satisfying the inequality $\chi^{\prime}(G) \leq t \leq|E(G)|$, we denote by $\alpha(G, t)$ the set of all proper edge $t$-colorings of $G$. Let us also define a set $\alpha(G)$ of all proper edge colorings of a graph $G$ :

\alpha(G) \equiv \bigcup_{t=\chi^{\prime}(G)}^{|E(G)|} \alpha(G, t)
$$

An arbitrary nonempty finite subset of consecutive integers is called an interval. If $\varphi \in$ $\alpha(G)$ and $x \in V(G)$, then the set of colors of edges of $G$ which are incident with $x$ is denoted by $S_{G}(x, \varphi)$ and is called a spectrum of the vertex $x$ of the graph $G$ at the proper edge coloring $\varphi$. If $G$ is a graph and $\varphi \in \alpha(G)$, then define $f_{G}(\varphi) \equiv \mid\left\{x \in V(G) / S_{G}(x, \varphi)\right.$ is an interval $\} \mid$.

For a graph $G$ and any integer $t$, satisfying the inequality $\chi^{\prime}(G) \leq t \leq|E(G)|$, we define:

\mu_{1}(G, t) \equiv \min _{\varphi \in \alpha(G, t)} f_{G}(\varphi), \quad \mu_{2}(G, t) \equiv \max _{\varphi \in \alpha(G, t)} f_{G}(\varphi)
$$

For any graph $G$, we set:

\mu_{11}(G) \equiv \min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t), & \mu_{12}(G) \equiv \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t) \\
\mu_{21}(G) \equiv \min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t), & \mu_{22}(G) \equiv \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t)
\end{array}
$$

For any positive integer $n$, the exact values of the parameters $\mu_{11}, \mu_{12}, \mu_{21}$ and $\mu_{22}$ are found for the graph of the $n$-dimensional cube.

We consider finite, undirected, connected graphs without loops and multiple edges containing at least one edge. For any graph $G$, we denote by $V(G)$ and $E(G)$ the sets of vertices and edges of $G$, respectively. For any $x \in V(G), d_{G}(x)$ denotes the degree of the vertex $x$ in $G$. For a graph $G$, $\delta(G)$ and $\Delta(G)$ denote the minimum and maximum degrees of vertices in $G$, respectively. For a graph $G$, and for any $V_{0} \subseteq V(G)$, we denote by $G\left[V_{0}\right]$ the subgraph of the graph $G$ induced [1] by the subset $V_{0}$ of its vertices. For arbitrary graphs $G$ and $H, G \square H$ denotes their cartesian product [1].

For any positive integer $n$, we denote by $Q_{n}$ the graph of the $n$-dimensional cube [2]. Clearly, for any positive integer $n, Q_{n}$ is a regular bipartite graph with $\left|V\left(Q_{n}\right)\right|=2^{n},\left|E\left(Q_{n}\right)\right|=n \cdot 2^{n-1}$, $\Delta\left(Q_{n}\right)=n$.

An arbitrary nonempty finite subset of consecutive integers is called an interval. An interval with the minimum element $p$ and the maximum element $q$ is denoted by $[p, q]$.

A function $\varphi: E(G) \rightarrow[1, t]$ is called a proper edge $t$-coloring of a graph $G$, if each of $t$ colors is used, and adjacent edges are colored differently.

The minimum value of $t$ for which there exists a proper edge $t$-coloring of a graph $G$ is denoted by $\chi^{\prime}(G)$ [3].

For any graph $G$, and for any $t \in\left[\chi^{\prime}(G),|E(G)|\right]$, we denote by $\alpha(G, t)$ the set of all proper edge $t$-colorings of $G$.

Let us also define a set $\alpha(G)$ of all proper edge colorings of a graph $G$ :

\alpha(G) \equiv \bigcup_{t=\chi^{\prime}(G)}^{|E(G)|} \alpha(G, t)
$$

If $\varphi \in \alpha(G)$ and $x \in V(G)$, then the set $\{\varphi(e) / e \in E(G), e$ is incident with $x\}$ is called a spectrum of the vertex $x$ of the graph $G$ at the proper edge coloring $\varphi$ and is denoted by $S_{G}(x, \varphi)$; if $S_{G}(x, \varphi)$ is an interval, we say that $\varphi$ is interval in $x$.

If $G$ is a graph, $\varphi \in \alpha(G), R \subseteq V(G)$, then we say, that $\varphi$ is interval on $R$ iff for $\forall x \in R, \varphi$ is interval in $x$. We say, that a subset $R$ of vertices of a graph $G$ has an $i$-property iff there exists $\varphi \in \alpha(G)$ interval on $R$. If $G$ is a graph, and a subset $R$ of its vertices has an $i$-property, we denote by $w_{R}(G)$ and $W_{R}(G)$ (omiting the index in these notations in the peculiar case of $R=V(G)$ ) the minimum and the maximum value of $t$, respectively, for which $\exists \varphi \in \alpha(G, t)$ interval on $R$ [4, 5, [6] (see also [20]).

If $G$ is a graph, $\varphi \in \alpha(G)$, then set $V_{\text {int }}(G, \varphi) \equiv\left\{x \in V(G) / S_{G}(x, \varphi)\right.$ is an interval $\}$ and $f_{G}(\varphi) \equiv\left|V_{\text {int }}(G, \varphi)\right|$. A proper edge coloring $\varphi \in \alpha(G)$ is called an interval edge coloring [4, 5, 6] of the graph $G$ iff $f_{G}(\varphi)=|V(G)|$. The set of all graphs having an interval edge coloring is denoted by $\mathfrak{N}$. The simplest example of the graph which doesn't belong to $\mathfrak{N}$ is $K_{3}$. The terms and concepts which are not defined can be found in [1].

For a graph $G$, and for any $t \in\left[\chi^{\prime}(G),|E(G)|\right]$, we set [7]:

\mu_{1}(G, t) \equiv \min _{\varphi \in \alpha(G, t)} f_{G}(\varphi), \quad \mu_{2}(G, t) \equiv \max _{\varphi \in \alpha(G, t)} f_{G}(\varphi)
$$

For any graph $G$, we set [7]:

\mu_{11}(G) \equiv \min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t), & \mu_{12}(G) \equiv \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t), \\
\mu_{21}(G) \equiv \min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t), & \mu_{22}(G) \equiv \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t) .
\end{array}
$$

Clearly, the parameters $\mu_{11}, \mu_{12}, \mu_{21}$ and $\mu_{22}$ are correctly defined for an arbitrary graph.
Let us note that exact values of the parameters $\mu_{12}$ and $\mu_{21}$ have certain game interpretations. Suppose that all edges of a graph $G$ are colored in the game of Alice and Bob with antagonistic interests and asymmetric distribution of roles. Alice determines the number $t$ of colors in the future proper edge coloring $\varphi$ of the graph $G$, satisfying the condition $t \in\left[\chi^{\prime}(G),|E(G)|\right]$, Bob colors edges of $G$ with $t$ colors.

When Alice aspires to maximize, Bob aspires to minimize the value of the function $f_{G}(\varphi)$, and both players choose their best strategies, then at the finish of the game exactly $\mu_{12}(G)$ vertices of $G$ will receive an interval spectrum.

When Alice aspires to minimize, Bob aspires to maximize the value of the function $f_{G}(\varphi)$, and both players choose their best strategies, then at the finish of the game exactly $\mu_{21}(G)$ vertices of $G$ will receive an interval spectrum.

The exact values of the parameters $\mu_{11}, \mu_{12}, \mu_{21}$ and $\mu_{22}$ are found for simple paths, simple cycles and simple cycles with a chord [8, 9], "Möbius ladders" [7, 22], complete graphs [11], complete bipartite graphs [12, 13], prisms [14, 22], $n$-dimensional cubes [14, 15] and the Petersen graph [23]. The exact values of $\mu_{11}$ and $\mu_{22}$ for trees are found in [16. The exact value of $\mu_{12}$ for an arbitrary tree is found in [17] (see also [18, 19]).

In this paper, for any positive integer $n$, we determine the exact values of the parameters $\mu_{11}$, $\mu_{12}, \mu_{21}$ and $\mu_{22}$ for the graph $Q_{n}$.

First we recall some known results.
Lemma 1. [4, 5, [6] If $G \in \mathfrak{N}$, then $\chi^{\prime}(G)=\Delta(G)$.
Corollary 1. If $G \in \mathfrak{N}$, then $\Delta(G)=\chi^{\prime}(G) \leq w(G) \leq W(G) \leq|E(G)|$.
Corollary 2. If $G$ is a regular graph, then $G \in \mathfrak{N}$ iff $\chi^{\prime}(G)=\Delta(G)$.
Corollary 3. If $G$ is a regular graph with $\chi^{\prime}(G)=\Delta(G)$, then $G \in \mathfrak{N}$ and $w(G)=\chi^{\prime}(G)=\Delta(G)$.
Corollary 4. If $G$ is a regular bipartite graph, then $G \in \mathfrak{N}$ and $w(G)=\chi^{\prime}(G)=\Delta(G)$.
Corollary 5. If $G \in \mathfrak{N}$, and a subset $R \subseteq V(G)$ has an i-property, then $\Delta(G)=\chi^{\prime}(G) \leq w_{R}(G) \leq$ $w(G) \leq W(G) \leq W_{R}(G) \leq|E(G)|$.

Lemma 2. [4, 5, 6] If $R$ is the set of all vertices of an arbitrary part of a bipartite graph $G$, then:

1) $R$ has an i-property,
2) $W_{R}(G)=|E(G)|$,
3) for any $t \in\left[w_{R}(G), W_{R}(G)\right]$, there exists $\varphi_{t} \in \alpha(G, t)$ interval on $R$.

Corollary 6. If $R$ is the set of all vertices of an arbitrary part of a regular bipartite graph $G$, then:

1) $R$ has an i-property,
2) $W_{R}(G)=|E(G)|$,
3) $w_{R}(G)=\Delta(G)$,
4) for any $t \in\left[w_{R}(G), W_{R}(G)\right]$, there exists $\varphi_{t} \in \alpha(G, t)$ interval on $R$.

Lemma 3. [21] If $G$ is a graph with $\delta(G) \geq 2, \varphi \in \alpha(G,|E(G)|), V_{\text {int }}(G, \varphi) \neq \emptyset$, then $G\left[V_{\text {int }}(G, \varphi)\right]$ is a forest each connected component of which is a simple path.

Lemma 4. [8, [9] If $G$ is a regular graph with $\chi^{\prime}(G)=\Delta(G)$, then $\mu_{12}(G)=|V(G)|$.
Proof. Let us note that for an arbitrary $\varphi \in \alpha(G, \Delta(G)), f_{G}(\varphi)=|V(G)|$. Consequently, $|V(G)|=\mu_{1}(G, \Delta(G)) \leq \max _{\left.t \in\left[\chi^{\prime}(G), \mid E(G)\right]\right]} \mu_{1}(G, t)=\mu_{12}(G) \leq|V(G)|$. Hence, $\mu_{12}(G)=|V(G)|$.

## The Lemma is proved.

Lemma 5. [8, [9] For an arbitrary graph $G$, the following inequalities hold: $\mu_{11}(G) \leq \mu_{12}(G) \leq$ $\mu_{22}(G), \mu_{11}(G) \leq \mu_{21}(G) \leq \mu_{22}(G)$.

Proof. Clearly,

$$
\mu_{11}(G)=\min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t) \leq \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t)=\mu_{12}(G) .
$$

and

$$
\mu_{21}(G)=\min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t) \leq \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t)=\mu_{22}(G)
$$

The inequality $\mu_{12}(G) \leq \mu_{22}(G)$ is provided by the existence of an integer $t^{\prime} \in\left[\chi^{\prime}(G),|E(G)|\right]$, for which the relation

& \mu_{12}(G)=\max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t)=\mu_{1}\left(G, t^{\prime}\right)=\min _{\varphi \in \alpha\left(G, t^{\prime}\right)} f_{G}(\varphi) \leq \\
& \leq \max _{\varphi \in \alpha\left(G, t^{\prime}\right)} f_{G}(\varphi)=\mu_{2}\left(G, t^{\prime}\right) \leq \max _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t)=\mu_{22}(G)
\end{aligned}
$$

is true.
The inequality $\mu_{11}(G) \leq \mu_{21}(G)$ is provided by the existence of an integer $t^{\prime \prime} \in\left[\chi^{\prime}(G),|E(G)|\right]$, for which the relation

\begin{aligned}
& \mu_{21}(G)=\min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{2}(G, t)=\mu_{2}\left(G, t^{\prime \prime}\right)=\max _{\varphi \in \alpha\left(G, t^{\prime \prime}\right)} f_{G}(\varphi) \geq \\
& \geq \min _{\varphi \in \alpha\left(G, t^{\prime \prime}\right)} f_{G}(\varphi)=\mu_{1}\left(G, t^{\prime \prime}\right) \geq \min _{\chi^{\prime}(G) \leq t \leq|E(G)|} \mu_{1}(G, t)=\mu_{11}(G)
\end{aligned}
$$

is true.

## The Lemma is proved.

Remark 1. [8, 9] There are graphs $G$ with $\mu_{21}(G)<\mu_{12}(G)$. There are graphs $G$ with $\mu_{12}(G)<$ $\mu_{21}(G)$.

Lemma 6. [10, 24] If a subset $V_{0}$ of the set of vertices of the graph $Q_{3}$ contains at least 6 vertices, then at least one of the following two statements is true:

1) there exist such vertices $x_{1}, x_{2}, x_{3}, x_{4}$ in $V_{0}$ that $Q_{3}\left[\left\{x_{1}, x_{2}, x_{3}, x_{4}\right\}\right] \cong K_{3,1}$,
2) there exist such vertices $y_{1}, y_{2}, y_{3}, y_{4}, y_{5}, y_{6}$ in $V_{0}$ that $Q_{3}\left[\left\{y_{1}, y_{2}, y_{3}, y_{4}, y_{5}, y_{6}\right\}\right] \cong C_{6}$.

Lemma 7. [10, 24] If a subset $V_{0}$ of the set of vertices of the graph $Q_{n}(n \geq 4)$ contains at least $2^{n-1}+1$ vertices, then at least one of the following two statements is true:

1) there exist such vertices $x_{1}, x_{2}, x_{3}, x_{4}$ in $V_{0}$ that $Q_{n}\left[\left\{x_{1}, x_{2}, x_{3}, x_{4}\right\}\right] \cong K_{3,1}$,
2) there exist such vertices $y_{1}, y_{2}, y_{3}, y_{4}, y_{5}, y_{6}, y_{7}, y_{8}$ in $V_{0}$ that $Q_{n}\left[\left\{y_{1}, y_{2}, y_{3}, y_{4}, y_{5}, y_{6}, y_{7}, y_{8}\right\}\right] \cong$ $C_{8}$.

If $G$ is a graph with $\chi^{\prime}(G)=\Delta(G), t \in[\Delta(G),|E(G)|], \xi \in \alpha(G, t)$, then for any $j \in[1, t]$, we denote by $E(G, \xi, j)$ the set of all edges of $G$ colored by the color $j$ at the proper edge $t$-coloring $\xi ; \xi$ is called a harmonic [12] edge $t$-coloring of the graph $G$, if for any $i \in[1, \Delta(G)]$, the set

\bigcup_{1 \leq j \leq t, j \equiv i(\bmod (\Delta(G)))} E(G, \xi, j)
$$

is a matching in $G$.
Suppose that $G$ is a graph with $\chi^{\prime}(G)=\Delta(G), t \in[\Delta(G),|E(G)|], \xi$ is a harmonic edge $t$-coloring of $G$. Let us define a sequence $\xi_{0}^{*}, \xi_{1}^{*}, \ldots, \xi_{t-\chi^{\prime}(G)}^{*}$ of proper edge colorings of the graph $G$.

Set $\xi_{0}^{*} \equiv \xi$.
Case 1. $t=\chi^{\prime}(G)$. The desired sequence mentioned above is already constructed.
Case 2. $t \in\left[\chi^{\prime}(G)+1,|E(G)|\right]$. Suppose that $j \in\left[1, t-\chi^{\prime}(G)\right]$, and the proper edge colorings $\xi_{0}^{*}, \ldots, \xi_{j-1}^{*}$ of the graph $G$ are already constructed. Let us define $\xi_{j}^{*}$. For an arbitrary $e \in E(G)$, set:

\xi_{j}^{*}(e) \equiv \begin{cases}\xi_{j-1}^{*}(e), & \text { if } \xi_{j-1}^{*}(e) \neq \max \left(\left\{\xi_{j-1}^{*}(e) / e \in E(G)\right\}\right) \\ \xi_{j-1}^{*}(e)-\Delta(G), & \text { if } \xi_{j-1}^{*}(e)=\max \left(\left\{\xi_{j-1}^{*}(e) / e \in E(G)\right\}\right)\end{cases}
$$

Remark 2. Suppose that $G$ is a graph with $\chi^{\prime}(G)=\Delta(G), t \in[\Delta(G),|E(G)|]$, $\xi$ is a harmonic edge $t$-coloring of $G$. All proper edge colorings $\xi_{0}^{*}, \xi_{1}^{*}, \ldots, \xi_{t-\chi^{\prime}(G)}^{*}$ of the graph $G$ are determined definitely.

Remark 3. Suppose that $G$ is a graph with $\chi^{\prime}(G)=\Delta(G)<|E(G)|, t \in\left[1+\chi^{\prime}(G),|E(G)|\right]$, $\xi$ is a harmonic edge $t$-coloring of $G$. It is not difficult to see, that for any $j \in\left[1, t-\chi^{\prime}(G)\right]$, $\xi_{j}^{*}$ is a harmonic edge $(t-j)$-coloring of the graph $G$.

Remark 4. Suppose that $G$ is a graph with $\chi^{\prime}(G)=\Delta(G)<|E(G)|, t \in\left[1+\chi^{\prime}(G),|E(G)|\right]$, $\xi$ is a harmonic edge $t$-coloring of $G$. Assume that $\xi$ is interval in some vertex $z_{0} \in V(G)$ with $d_{G}\left(z_{0}\right)=\Delta(G)$. Then, for any $j \in\left[1, t-\chi^{\prime}(G)\right]$, $\xi_{j}^{*}$ is interval in $z_{0}$.

From results of [8, 9] we have
Proposition 1. $\mu_{11}\left(Q_{1}\right)=2, \mu_{11}\left(Q_{2}\right)=1, \mu_{21}\left(Q_{1}\right)=2$, $\mu_{21}\left(Q_{2}\right)=3$.
Lemma 8. If an r-regular $(r \geq 3)$ graph $G$ has $\varphi \in \alpha(G, r+1)$ with $f_{G}(\varphi)=0$, then the graph $G \square K_{2}$ has $\psi \in \alpha\left(G \square K_{2}, r+2\right)$ with $f_{G \square K_{2}}(\psi)=0$.

Proof is evident.
Lemma 9. There exists $\varphi \in \alpha\left(Q_{3}, 4\right)$ with $f_{Q_{3}}(\varphi)=0$. There exists $\psi \in \alpha\left(Q_{3}, 12\right)$ with $f_{Q_{3}}(\psi)=$ 5.

Proof. Let $V\left(Q_{3}\right)=\left\{x_{1}, x_{2}, x_{3}, x_{4}, y_{1}, y_{2}, y_{3}, y_{4}\right\}, E\left(Q_{3}\right)=\left\{\left(x_{1}, x_{2}\right),\left(x_{2}, x_{3}\right),\left(x_{3}, x_{4}\right),\left(x_{1}, x_{4}\right)\right.$, $\left.\left(y_{1}, y_{2}\right),\left(y_{2}, y_{3}\right),\left(y_{3}, y_{4}\right),\left(y_{1}, y_{4}\right),\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right),\left(x_{3}, y_{3}\right),\left(x_{4}, y_{4}\right)\right\}$.

Set: $\varphi\left(\left(x_{1}, x_{2}\right)\right)=\varphi\left(\left(x_{3}, x_{4}\right)\right)=\varphi\left(\left(y_{1}, y_{2}\right)\right)=\varphi\left(\left(y_{3}, y_{4}\right)\right)=1, \varphi\left(\left(x_{1}, x_{4}\right)\right)=\varphi\left(\left(x_{2}, x_{3}\right)\right)=2$, $\varphi\left(\left(y_{1}, y_{4}\right)\right)=\varphi\left(\left(y_{2}, y_{3}\right)\right)=3, \varphi\left(\left(x_{1}, y_{1}\right)\right)=\varphi\left(\left(x_{2}, y_{2}\right)\right)=\varphi\left(\left(x_{3}, y_{3}\right)\right)=\varphi\left(\left(x_{4}, y_{4}\right)\right)=4$.

It is not difficult to see that $\varphi \in \alpha\left(Q_{3}, 4\right)$ and $f_{Q_{3}}(\varphi)=0$.

Set: $\psi\left(\left(x_{1}, y_{1}\right)\right)=1, \psi\left(\left(y_{1}, y_{2}\right)\right)=2, \psi\left(\left(y_{1}, y_{4}\right)\right)=3, \psi\left(\left(y_{3}, y_{4}\right)\right)=4, \psi\left(\left(x_{4}, y_{4}\right)\right)=5$, $\psi\left(\left(x_{1}, x_{4}\right)\right)=6, \psi\left(\left(x_{3}, x_{4}\right)\right)=7, \psi\left(\left(x_{3}, y_{3}\right)\right)=8, \psi\left(\left(x_{2}, x_{3}\right)\right)=9, \psi\left(\left(x_{2}, y_{2}\right)\right)=10, \psi\left(\left(x_{1}, x_{2}\right)\right)=$ 11, $\psi\left(\left(y_{2}, y_{3}\right)\right)=12$.

It is not difficult to see that $\psi \in \alpha\left(Q_{3}, 12\right)$ and $f_{Q_{3}}(\psi)=5$.

## The Lemma is proved.

From Lemmas 8 and 9 we obtain
Proposition 2. For any integer $n \geq 3, \mu_{11}\left(Q_{n}\right)=0$.
From Propositions 1 and 2 we obtain
Proposition 3. For any positive integer $n, \mu_{11}\left(Q_{n}\right)=3-\min \{3, n\}$.
From Lemma 4 we obtain
Proposition 4. For any positive integer $n$, $\mu_{12}\left(Q_{n}\right)=2^{n}$.
From Proposition 4 and Lemma 5 we obtain
Proposition 5. For any positive integer $n$, $\mu_{22}\left(Q_{n}\right)=2^{n}$.
Lemma 10. For any integer $n \geq 4, \mu_{2}\left(Q_{n}, n \cdot 2^{n-1}\right) \geq 2^{n-1}$.
Proof follows from Lemma 2,
Lemma 11. For any integer $n \geq 4, \mu_{2}\left(Q_{n}, n \cdot 2^{n-1}\right) \leq 2^{n-1}$.
Proof. Assume the contrary. Then there exist an integer $n_{0} \geq 4$ and $\varphi_{0} \in \alpha\left(Q_{n_{0}}, n_{0} \cdot 2^{n_{0}-1}\right)$, for which $f_{Q_{n_{0}}}\left(\varphi_{0}\right) \geq 2^{n_{0}-1}+1$. By Lemma 3, $Q_{n_{0}}\left[V_{\text {int }}\left(Q_{n_{0}}, \varphi_{0}\right)\right]$ is a forest, each connected component of which is a simple path. But it is incompatible with Lemma 7.

## The Lemma is proved.

From Lemmas 10 and 11 we obtain
Lemma 12. For any integer $n \geq 4, \mu_{2}\left(Q_{n}, n \cdot 2^{n-1}\right)=2^{n-1}$.
Lemma 13. For arbitrary integers $n$ and $t$, satisfying the conditions $n \geq 4, n \leq t \leq n \cdot 2^{n-1}$, the inequality $\mu_{2}\left(Q_{n}, t\right) \geq 2^{n-1}$ is true.

Proof. Choose an arbitrary integer $n_{0} \geq 4$. It follows from Corollary 6, that for any integer $t$, satisfying the inequality $n_{0} \leq t \leq n_{0} \cdot 2^{n_{0}-1}$, there exists $\varphi_{t} \in \alpha\left(Q_{n_{0}}, t\right)$ with $f_{Q_{n_{0}}}\left(\varphi_{t}\right) \geq 2^{n_{0}-1}$. It means that for any integer $t$, satisfying the inequality $n_{0} \leq t \leq n_{0} \cdot 2^{n_{0}-1}$, we also have $\mu_{2}\left(Q_{n_{0}}, t\right) \geq$ $2^{n_{0}-1}$.

## The Lemma is proved.

From Lemmas 12 and 13 we obtain
Proposition 6. For any integer $n \geq 4, \mu_{21}\left(Q_{n}\right)=2^{n-1}$.
From Lemma 9 we obtain
Lemma 14. $\mu_{2}\left(Q_{3}, 12\right) \geq 5$.
Lemma 15. $\mu_{2}\left(Q_{3}, 12\right) \leq 5$.

Proof. Assume the contrary: $\mu_{2}\left(Q_{3}, 12\right) \geq 6$. It means that there exists $\xi \in \alpha\left(Q_{3}, 12\right)$ with $f_{Q_{3}}(\xi) \geq 6$. By Lemma 3, $Q_{3}\left[V_{i n t}\left(Q_{3}, \xi\right)\right]$ is a forest each connected component of which is a simple path. But it is incompatible with Lemma 6 .
The Lemma is proved.
From Lemmas 14 and 15 we obtain
Lemma 16. $\mu_{2}\left(Q_{3}, 12\right)=5$.
Lemma 17. For any integer $t$, satisfying the condition $3 \leq t \leq 12$, the inequality $\mu_{2}\left(Q_{3}, t\right) \geq 5$ is true.

Proof. It is not difficult to check that the proper edge 12-coloring $\psi$ of the graph $Q_{3}$ constructed for the proof of Lemma 9 is a harmonic edge 12 -coloring of $Q_{3}$. From Remark 4 it follows that for any integer $t$ satisfying the inequality $3 \leq t \leq 11$, there exists $\psi_{t} \in \alpha\left(Q_{3}, t\right)$ with $V_{\text {int }}\left(Q_{3}, \psi\right) \subseteq V_{\text {int }}\left(Q_{3}, \psi_{t}\right)$. Hence, for the same values of $t$, the inequality $\mu_{2}\left(Q_{3}, t\right) \geq f_{Q_{3}}(\psi)=5$ is true.

## The Lemma is proved.

From Lemmas 16 and 17 we obtain
Proposition 7. $\mu_{21}\left(Q_{3}\right)=5$.
From Propositions 1, 6 and 7 we obtain
Proposition 8. For any positive integer $n$,

$$
\mu_{21}\left(Q_{n}\right)=2^{n-1}+\left\lceil 1-\frac{\min \{4, n\}}{4}\right\rceil .
$$

From Propositions 3 - 5 and 8 we obtain
Theorem 1. 14, 15, For any positive integer n, the following equalities hold:

$$
\begin{gathered}
\mu_{11}\left(Q_{n}\right)=3-\min \{3, n\}, \quad \mu_{12}\left(Q_{n}\right)=\mu_{22}\left(Q_{n}\right)=2^{n}, \\
\mu_{21}\left(Q_{n}\right)=2^{n-1}+\left\lceil 1-\frac{\min \{4, n\}}{4}\right\rceil .
\end{gathered}
$$
