# THE MAXIMAL ORDER OF STERN'S DIATOMIC SEQUENCE

#### Abstract

We answer a question of Calkin and Wilf concerning the maximal order of Stern's diatomic sequence. Specifically, we prove that $$
\limsup _{n \rightarrow \infty} \frac{a(n)}{\varphi^{\log _{2} n}}=\frac{\varphi^{\log _{2} 3}}{\sqrt{5}}
$$ where $\varphi=(\sqrt{5}+1) / 2$ is the golden ratio. This improves on previous results given by Berlekamp, Conway, and Guy, who showed that the limit value was bounded above by 1.25 , and by Calkin and Wilf, who showed that the exact value was in the interval $\left[(\varphi / \sqrt{5})(3 / 2)^{\log _{2} \varphi},(\varphi+1) / \sqrt{5}\right]$.


## 1. Introduction

Stern's Diatomic sequence (commonly called Stern's sequence), $\{a(n)\}_{n \geq 0}$, is given by $a(0)=0, a(1)=1$, and when $n \geq 1$, by

$$
a(2 n)=a(n) \quad \text { and } \quad a(2 n+1)=a(n)+a(n+1)
$$

In a recent survey article, Northshield [5] restated a question of Calkin and Wilf [2], which asks for the exact value of $\lim _{\sup _{n \rightarrow \infty}} a(n) / \varphi^{\log _{2} n}$, where $\varphi=(\sqrt{5}+1) / 2$ is the golden ratio and $\log _{2} n$ denotes the base- 2 logarithm of $n$; that is, they asked one to determine the exact maximal order of the Stern sequence. This question goes back at least to the 1982 book of Berlekamp, Conway, and Guy [1, page 115] who showed that $a(n-1)$ is the number of nim-sums corresponding to a given ordinary sum $n$, and gave an upper bound of 1.25 for the limit in question. Calkin and Wilf [2] improved on the bounds; they showed that

$$
0.958854 \cdots=\frac{\varphi}{\sqrt{5}}\left(\frac{3}{2}\right)^{\log _{2} \varphi} \leq \limsup _{n \rightarrow \infty} \frac{a(n)}{\varphi^{\log _{2} n}} \leq \frac{\varphi+1}{\sqrt{5}}=1.170820 \cdots
$$

We answer this question by proving the following theorem.
Theorem 1. Let $\{a(n)\}_{n \geq 0}$ denote the Stern sequence. Then

$$
\limsup _{n \rightarrow \infty} \frac{a(n)}{\varphi^{\log _{2} n}}=\frac{\varphi}{\sqrt{5}}\left(\frac{3}{2}\right)^{\log _{2} \varphi}=\frac{\varphi^{\log _{2} 3}}{\sqrt{5}}=0.9588541900 \cdots
$$

## 2. Preliminaries

It is well-known that the maximum value of $a(m)$ in the interval $2^{n-2} \leq m \leq$ $2^{n-1}$ is the $n$th Fibonacci number $F_{n}$ and that this maximum first occurs at

$$
m_{n}:=\frac{1}{3}\left(2^{n}-(-1)^{n}\right) ;
$$

see Lehmer [3] and Lind [4].

[^0]For our proof, we will use the points $\left(m_{n}, a\left(m_{n}\right)\right)$ to produce a continuous function $h(x)$ which is an upper bound for the Stern sequence, and which is asympotitically a lower bound for the function $\left(\varphi^{\log _{2} 3} / \sqrt{5}\right) \varphi^{\log _{2} x}$. We will then use these functions combined with some properties of limits to prove Theorem 1 ,

Before giving the proof of Theorem [1 we give a formal definition of $h(x)$ and provide some useful lemmas concerning $h(x)$ and its relationships to both $a(n)$ and $\varphi^{\log _{2} x}$.

Definition 2. Let $h: \mathbb{R}_{\geq 0} \rightarrow \mathbb{R}_{\geq 0}$ denote the piecewise linear function connecting the set of points $\{(0,0)\} \cup\left\{\left(m_{n}, a\left(m_{n}\right)\right): n \geq 2\right\}$.

By definition, $h(x)$ is continuous in $\mathbb{R}_{\geq 0}$ and differentiable in the intervals $\left(m_{n}, m_{n+1}\right)$. Using point-slope form, for $x \in\left[m_{n}, m_{n+1}\right]$, we have

$$
\begin{align*}
h(x) & =\frac{a\left(m_{n+1}\right)-a\left(m_{n}\right)}{m_{n+1}-m_{n}}\left(x-m_{n}\right)+a\left(m_{n}\right) \\
& =3 \cdot \frac{F_{n-1}}{2^{n}+2(-1)^{n}} x+F_{n}-F_{n-1} \cdot \frac{2^{n}-(-1)^{n}}{2^{n}+2(-1)^{n}}  \tag{1}\\
& =\frac{1}{\sqrt{5}}\left[\frac{3}{2}\left(\frac{\varphi}{2}\right)^{n-1} x+\varphi^{n}\left(1-\frac{(-1)^{n-1}}{\varphi^{2(n-1)}}-\frac{1}{\varphi}\right)\right] \cdot\left(1+O\left(2^{-n}\right)\right) . \tag{2}
\end{align*}
$$

Here we have used Binet's formula that $F_{n}=\frac{\varphi^{n}-(-\varphi)^{-n}}{\sqrt{5}}$, where $\varphi=\frac{1+\sqrt{5}}{2}$ is the golden ratio.

Lemma 3. We have

$$
\lim _{x \rightarrow \infty}\{h(4 x-3)-h(2 x-1)-h(x)\}=0
$$

Proof. Consider first the numbers $x, 2 x+2$, and $4 x+6$. Suppose that $x \in\left[m_{n}, m_{n+1}\right]$. Then since $m_{n+1}=2 m_{n}+(-1)^{n}$, we have $2 x+2 \in\left[m_{n+1}, m_{n+2}\right]$ and $4 x+6 \in$ [ $m_{n+2}, m_{n+3}$ ], so that $x, 2 x+2$ and $4 x+6$ are in distinct subintervals [ $m_{i}, m_{i+1}$ ].

For $x \in\left[m_{n}, m_{n+1}\right]$, using (11), we have that

$$
\begin{aligned}
& h(4 x+6)-h(2 x+2)-h(x) \\
&=\left\{12 \cdot \frac{F_{n+1}}{2^{n+2}+2(-1)^{n+2}}-6 \cdot \frac{F_{n}}{2^{n+1}+2(-1)^{n+1}}-3 \cdot \frac{F_{n-1}}{2^{n}+2(-1)^{n}}\right\} x \\
&+\left\{18 \cdot \frac{F_{n+1}}{2^{n+2}+2(-1)^{n+2}}-6 \cdot \frac{F_{n}}{2^{n+1}+2(-1)^{n+1}}-3 \cdot \frac{F_{n-1}}{2^{n}+2(-1)^{n}}\right\} \\
& \quad-F_{n+1} \cdot \frac{2^{n+2}-(-1)^{n+2}}{2^{n+2}+2(-1)^{n+2}}+F_{n} \cdot \frac{2^{n+1}-(-1)^{n+1}}{2^{n+1}+2(-1)^{n+1}}+F_{n-1} \cdot \frac{2^{n}-(-1)^{n}}{2^{n}+2(-1)^{n}} \\
&= \mathfrak{S}_{1} \cdot x+\mathfrak{S}_{2}+\mathfrak{S}_{3},
\end{aligned}
$$

where $\mathfrak{S}_{1}, \mathfrak{S}_{2}$ and $\mathfrak{S}_{3}$ represent the three-term sums from the three previous lines, respectively. We have

$$
\begin{aligned}
\left|\mathfrak{S}_{1} \cdot x\right| & =\left|12 \cdot \frac{F_{n+1}}{2^{n+2}+2(-1)^{n+2}}-6 \cdot \frac{F_{n}}{2^{n+1}+2(-1)^{n+1}}-3 \cdot \frac{F_{n-1}}{2^{n}+2(-1)^{n}}\right| \cdot m_{n+1} \\
& =\left|\frac{3 \cdot F_{n+1}}{2^{n}+\frac{(-1)^{n+2}}{2}}-\frac{3 \cdot F_{n}}{2^{n}+(-1)^{n+1}}-\frac{3 \cdot F_{n-1}}{2^{n}+2(-1)^{n}}\right| \cdot \frac{\left(2^{n}-(-1)^{n}\right)}{3} \\
& <\left|\frac{F_{n+1}}{1+\frac{(-1)^{n+2}}{2^{n+1}}}-\frac{F_{n}}{1+\frac{(-1)^{n+1}}{2^{n}}}-\frac{F_{n-1}}{1+\frac{(-1)^{n}}{2^{n-1}}}\right| \cdot 2 \\
& =\left|F_{n+1} \cdot\left(1+O\left(2^{-n}\right)\right)-F_{n} \cdot\left(1+O\left(2^{-n}\right)\right)-F_{n-1} \cdot\left(1+O\left(2^{-n}\right)\right)\right| \cdot 2 \\
& =O\left(\frac{\varphi^{n}}{2^{n}}\right)
\end{aligned}
$$

where for the last equality we have used both the Fibonacci recursion and the fact that $F_{n}=O\left(\varphi^{n}\right)$. Using $F_{n}=O\left(\varphi^{n}\right)$ again, we immediately gain

$$
\left|\mathfrak{S}_{2}\right|=O\left(\frac{\varphi^{n}}{2^{n}}\right)
$$

and similarly

$$
\left|\mathfrak{S}_{3}\right|=\left|F_{n+1}\left(1+O\left(2^{-n}\right)\right)-F_{n}\left(1+O\left(2^{-n}\right)\right)-F_{n-1}\left(1+O\left(2^{-n}\right)\right)\right|=O\left(\frac{\varphi^{n}}{2^{n}}\right)
$$

Thus

$$
|h(4 x+6)-h(2 x+2)-h(x)| \leq\left|\mathfrak{S}_{1} \cdot x\right|+\left|\mathfrak{S}_{2}\right|+\left|\mathfrak{S}_{3}\right|=O\left(\frac{\varphi^{n}}{2^{n}}\right)
$$

Noting that $2>\varphi$, gives then that

$$
\lim _{x \rightarrow \infty}\{h(4 x+6)-h(2 x+2)-h(x)\}=0
$$

By (2)

$$
\lim _{\substack{x \rightarrow \infty \\ x \neq m_{n}}} \frac{d}{d x} h(x)=\lim _{n \rightarrow \infty} \frac{3}{2 \sqrt{5}}\left(\frac{\varphi}{2}\right)^{n-1}\left(1+O\left(2^{-n}\right)\right)=0
$$

and since $h(x)$ is continuous for all $x \in \mathbb{R}_{\geq 0}$, we have that for any fixed number $y$,

$$
\lim _{x \rightarrow \infty}\{h(x+y)-h(x)\}=0
$$

Thus

$$
\lim _{x \rightarrow \infty}\{h(4 x+6)-h(2 x+2)-h(x)-[h(4 x-3)-h(2 x-1)-h(x)]\}=0
$$

and so

$$
\lim _{x \rightarrow \infty}\{h(4 x-3)-h(2 x-1)-h(x)\}=0
$$

Lemma 4. Let $\varepsilon>0$ be given, then there is an $M:=M(\varepsilon)>0$ such that for $m \geq M, a(m) \leq h(m)+\varepsilon$. In particular, we have that

$$
\limsup _{m \rightarrow \infty} \frac{a(m)}{h(m)}=1
$$

Proof. Note that by design, $a\left(m_{n}\right)=h\left(m_{n}\right)$ for all $n \geq 2$. So suppose that $m \neq m_{n}$ for any $n$. We will consider the three cases, of $m$ even or odd modulo 4 , separately.

If $m=2 k$ for some $k$, then

$$
a(m)=a(2 k)=a(k)<h(m)<h(2 m)
$$

where the last inequality is valid since $h(x)$ is a monotone increasing function.
For the odd cases, we suppose that $\varepsilon>0$ is given and that $m$ is large enough with respect to $\varepsilon$, so that using Lemma 3, for all $x \geq \frac{m}{5}$ we have

$$
\begin{equation*}
|h(4 x-3)-h(2 x-1)-h(x)|<\varepsilon \tag{3}
\end{equation*}
$$

If $m=4 k+1$, then $m=2(2 k)+1$, so that using the recursion of the Stern sequence combined with (3) with $x=k+1=\frac{m+3}{4}>\frac{m}{5}$, we have

$$
\begin{aligned}
a(m) & =a(2(2 k)+1)=a(2 k)+a(2 k+1)=a(k)+a(2 k+1) \\
& \leq h(k)+h(2 k+1)<h(k+1)+h(2 k+1)<h(4 k+1)+\varepsilon=h(m)+\varepsilon
\end{aligned}
$$

If $m=4 k+3$, then $m=2(2 k+1)+1$, so that using the same properties as the previous sentence combined with (3) with $x=k+1=\frac{m+1}{4}>\frac{m}{5}$, we have, we have

$$
\begin{aligned}
& a(m)=a(2(2 k+1)+1)=a(2 k+1)+a(2 k+2)=a(2 k+1)+a(k+1) \\
& \leq h(k+1)+h(2 k+1)<h(4 k+1)+\varepsilon<h(4 k+3)+\varepsilon=h(m)+\varepsilon .
\end{aligned}
$$

This proves that for all $m$ large enough $a(m) \leq h(m)+\varepsilon$.
For the limit result, note that

$$
1=\lim _{n \rightarrow \infty} \frac{a\left(m_{n}\right)}{h\left(m_{n}\right)} \leq \limsup _{m \rightarrow \infty} \frac{a(m)}{h(m)} \leq \limsup _{m \rightarrow \infty} \frac{h(m)+\varepsilon}{h(m)}=1
$$

Though we have not shown it here, as it was not needed for the results of this paper, it seems that actually $a(m)<h(m)$ for all $m \neq m_{n}$. That is, $h(x)$ is the upper boundary of the convex hull of the points $\{(0,0)\} \cup\left\{\left(m_{n}, a\left(m_{n}\right)\right): n \geq 2\right\}$. A proof of this should follow if one makes Lemma 3 effective, and applies the theory of continued fractions to the slope of $h(x)$.

Lemma 5. Let $\varepsilon>0$ be given. Then for large enough $x$, we have

$$
\sqrt{5} \cdot h(x) \leq \varphi^{\log _{2} 3} \varphi^{\log _{2} x}+\varepsilon
$$

Proof. Note that at the points $\left(m_{n}, a\left(m_{n}\right)\right)$, we have $h\left(m_{n}\right)=a\left(m_{n}\right)=F_{n}$ by construction. Thus, noting that

$$
\varphi^{\log _{2}\left(1-\frac{(-1)^{n}}{2^{n}}\right)}=1+O\left(2^{-n}\right)
$$

we have

$$
\begin{aligned}
\sqrt{5} \cdot h\left(m_{n}\right)-\varphi^{\log _{2} 3} \varphi^{\log _{2} m_{n}} & =\sqrt{5} \cdot F_{n}-\varphi^{\log _{2} 3} \varphi^{\log _{2} m_{n}} \\
& =\varphi^{n}-\frac{(-1)^{n}}{\varphi^{n}}-\varphi^{n} \varphi^{\log _{2}\left(1-\frac{(-1)^{n}}{2^{n}}\right)}=O\left(\left(\frac{\varphi}{2}\right)^{n}\right)
\end{aligned}
$$

This shows that the result holds for $x=m_{n}$ for large enough $n$.
Using this, let $\varepsilon>0$ be given and let $N$ be large enough so that we have

$$
\begin{equation*}
\sqrt{5} \cdot h\left(m_{n}\right)-\varphi^{\log _{2} 3} \varphi^{\log _{2} m_{n}}<\varepsilon \tag{4}
\end{equation*}
$$

for all $m_{n}>N$ and, towards a contradiction, suppose that there is an $x_{n} \in$ $\left(m_{n}, m_{n+1}\right)$ such that

$$
\begin{equation*}
\sqrt{5} \cdot h\left(x_{n}\right)-\varphi^{\log _{2} 3} \varphi^{\log _{2} x_{n}} \geq \varepsilon \tag{5}
\end{equation*}
$$

Then since $\sqrt{5} \cdot h(x)-\varphi^{\log _{2} 3} \varphi^{\log _{2} x}$ is differentiable for $x \in\left(m_{n}, m_{n+1}\right)$, by (44) and (5), the function attains a maximum value at some $x \in\left(m_{n}, m_{n+1}\right)$. Thus there is an $x \in\left(m_{n}, m_{n+1}\right)$ such that the second derivative of $\sqrt{5} \cdot h(x)-\varphi^{\log _{2} 3} \varphi^{\log _{2} x}$ is negative. But

$$
\begin{aligned}
\frac{d^{2}}{d x^{2}}\left\{\sqrt{5} \cdot h(x)-\varphi^{\log _{2} 3} \varphi^{\log _{2} x}\right\} & =\frac{d^{2}}{d x^{2}}\left\{-\varphi^{\log _{2} 3} x^{\log _{2} \varphi}\right\} \\
& =-\varphi^{\log _{2} 3} \log _{2} \varphi \cdot\left(\log _{2} \varphi-1\right) x^{\log _{2} \varphi-2}
\end{aligned}
$$

which is positive for all $x \in\left(m_{n}, m_{n+1}\right)$ as

$$
-\varphi^{\log _{2} 3} \log _{2} \varphi \cdot\left(\log _{2} \varphi-1\right)>0
$$

Thus we arrive at the contradiction, which proves the lemma.

## 3. The maximal growth of Stern's diatomic sequence

In order to remove the $\varepsilon$-values given in the previous lemmas, we will use the following result, which is a common exercise in introductory analysis texts, and so as not to ruin the reader's experience we will not prove it here.
Lemma 6. Suppose that $\{f(n)\}_{n \geq 0}$, and $\{g(n)\}_{n \geq 0}$ be sequences of real numbers such that $f(n)$ and $g(n)$ are eventually positive. Then

$$
\limsup _{n \rightarrow \infty} f(n) g(n) \leq \limsup _{n \rightarrow \infty} f(n) \cdot \limsup _{n \rightarrow \infty} g(n)
$$

Proof of Theorem 1. By Lemma [5 we have for large enough $x$ that

$$
h(x) \leq \frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} x}+\varepsilon
$$

and by Lemma 4 we have

$$
\limsup _{n \rightarrow \infty} \frac{a(n)}{h(n)}=1
$$

Thus we have for large enough $n$ that

$$
\frac{a(n)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}+\varepsilon} \leq \frac{a(n)}{h(n)}
$$

and so we have

$$
\begin{equation*}
\limsup _{n \rightarrow \infty} \frac{a(n)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}+\varepsilon} \leq \limsup _{n \rightarrow \infty} \frac{a(n)}{h(n)} \leq 1 \tag{6}
\end{equation*}
$$

Using Lemma 6 and (6), we have
(7) $\quad \limsup _{n \rightarrow \infty} \frac{a(n)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}}=\limsup _{n \rightarrow \infty} \frac{a(n)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}+\varepsilon} \cdot \frac{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}+\varepsilon}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}}$

$$
\leq \limsup _{n \rightarrow \infty} \frac{a(n)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}+\varepsilon} \leq \limsup _{n \rightarrow \infty} \frac{a(n)}{h(n)} \leq 1
$$

But we also have that

$$
\frac{a\left(m_{n}\right)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} m_{n}}}=\frac{F_{n}}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} m_{n}}}=\frac{\varphi^{n}-\frac{(-1)^{n}}{\varphi^{n}}}{\varphi^{n} \varphi^{\log _{2}\left(1-\frac{(-1)^{n}}{2^{n}}\right)}}=1+O\left(2^{-n}\right)
$$

Thus by (7) we have

$$
1=\lim _{n \rightarrow \infty} \frac{a\left(m_{n}\right)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} m_{n}}} \leq \limsup _{n \rightarrow \infty} \frac{a(n)}{\frac{\varphi^{\log _{2} 3}}{\sqrt{5}} \varphi^{\log _{2} n}} \leq 1
$$

which proves the theorem.
