# A NOTE ON THE NEW $q$-EXTENSION OF FROBENIUS-EULER NUMBERS AND POLYNOMIALS

#### Abstract

In this paper, we consider the new $q$-extension of FrobeniusEuler numbers and polynomials and we derive some interesting identities from the orthogonality type properties for the new q-extension of Frobenius-Euler polynomials. Finally we suggest one open question related to orthogonality of polynomials.


## 1. Introduction

For $q \in[0,1]$, we define the $q$-shifted factorials by $(a: q)_{0}=1,(a: q)_{n}=$ $\prod_{i=0}^{n-1}\left(1-a q^{i}\right),(a: q)_{\infty}=\prod_{i=0}^{\infty}\left(1-a q^{i}\right)$. If $x$ is classical object, such as a complex number, its $q$-version is defined by $[x]_{q}=\frac{1-q^{x}}{1-q}$. As is well known, the $q$-exponential function is given by

e_{q}(z)=\sum_{n=0}^{\infty} \frac{z^{n}}{[n]_{q}!}=\frac{1}{((1-q) z: q)_{\infty}}, \quad(\text { see }[5],[7]) \tag{1.1}
\end{equation*}
$$

where $z \in \mathbb{C}$ with $|z|<1$. The $q$-derivative is defined by

D_{q} f(x)=\frac{f(x)-f(q x)}{(1-q) x}, \quad(\text { see }[5],[8],[9],[10]) \tag{1.2}
\end{equation*}
$$

Note that $\lim _{q \rightarrow 1} D_{q} f(x)=\frac{d f(x)}{d x}$.
The definite $q$-integral is given by

\int_{0}^{x} f(t) d_{q} t=(1-q) \sum_{a=0}^{\infty} f\left(q^{a} x\right) x q^{a}, \quad(\text { see }[4],[7],[10]) \tag{1.3}
\end{equation*}
$$

From (1.2) to (1.3), we have

\int_{0}^{x} t^{n} d_{q} t=\frac{1}{[n+1]_{q}} x^{n+1}, \quad D_{q} x^{n}=[n]_{q} x^{n-1} \tag{1.4}
\end{equation*}
$$

\]

The $q$-Bernoulli polynomials of Hegazi and Mansour are defined by the generating function to be

\begin{equation*}
\sum_{n=0}^{\infty} B_{n, q}(x) \frac{t^{n}}{[n]_{q}!}=\frac{t}{e_{q}(t)-1} e_{q}(x t), \quad(\text { see }[4]) \tag{1.5}
\end{equation*}
$$

In the special case, $x=0, B_{n, q}(0)=B_{n, q}$ are called the $n$-th $q$-Bernoulli numbers.
$\mathrm{By}(1.5)$, we get

$$
\begin{align*}
\sum_{n=o}^{\infty} B_{n, q}(x) \frac{t^{n}}{[n]_{q}!} & =\left(\sum_{l=0}^{\infty} B_{l, q} \frac{t^{l}}{[l]_{q}!}\right)\left(\sum_{m=0}^{\infty} \frac{x^{m}}{[m]_{q}!} t^{m}\right) \\
& =\sum_{n=0}^{\infty}\left(\sum_{l=0}^{n}\binom{n}{l}_{q} B_{l, q} x^{n-l}\right) \frac{t^{n}}{[n]_{q}!} \tag{1.6}
\end{align*}
$$

where $\binom{n}{k}_{q}=\frac{[n]_{q}!}{[k]_{q}![n-k]_{q}!}, \quad[n]_{q}!=[n]_{q}[n-1]_{q} \cdots[2]_{q}[1]_{q}$.
Thus, from (1.6), we have

B_{n, q}(x)=\sum_{l=0}^{n}\binom{n}{l}_{q} B_{l, q} x^{n-l} \tag{1.7}
\end{equation*}
$$

In [1.6], the new $q$-extension of Euler polynomials are also defined by the generating function to be

\frac{2}{e_{q}(t)+1} e_{q}(x t)=\sum_{n=0}^{\infty} E_{n, q}(x) \frac{t^{n}}{[n]_{q}!} \tag{1.8}
\end{equation*}
$$

In the special case, $x=0, E_{n, q}(0)=E_{n, q}$ are called the $n$-th $q$-Euler numbers.
By (1.8), we easily get

$$
\begin{equation*}
E_{n, q}(x)=\sum_{k=0}^{n}\binom{n}{k}_{q} E_{k, q} x^{n-k}, \quad(\text { see }[7]) \tag{1.9}
\end{equation*}
$$

More than five decades age, Carlitz(see [8],[9]) defined a $q$-extension of Bernoulli and Euler polynomials. In a recent paper(see [10]), B.A. Kupershmidt constructed reflection symmetries of $q$-Bernoulli numbers and polynomials. From the methods of B.A. Kupershmidt, Hegazi and Mansour derived some interesting identities and properties related to $q$-Bernoulli and Euler polynomials. Recently, several authors have studied various $q$-extention of Bernoulli,

Euler and Genocchi polynomials(see [1],[2],[4]-[14]). Let $\mathcal{F}$ be the set of all formal power series in variable $t$ over $\mathbb{C}$ with

\mathcal{F}=\left\{\left.f(t)=\sum_{k=0}^{\infty} \frac{a_{k}}{[k]_{q}} t^{k} \right\rvert\, a_{k} \in \mathbb{C}\right\} \tag{1.10}
\end{equation*}
$$

Let $\mathbb{P}=\mathbb{C}[x]$ and let $\mathbb{P}^{*}$ be the vector space of all linear functionals on $\mathbb{P}$. $<L \mid p(x)>$ denotes the action of linear functional $L$ on the polynomials $p(x)$, and it is well know that the vector space operation on $\mathbb{P}^{*}$ defined by $<L+M \mid$ $p(x)>=<L|p(x)>+<M| p(x)>,<c L|p(x)>=c<L| p(x)>$, where $c$ is complex constant. For $f(t)=\sum_{k=0}^{\infty}=\frac{a_{k}}{[k]_{q}!} t^{k} \in \mathcal{F}$, Let us define the linear functional on $\mathbb{P}$ by setting

<f(t) \mid x^{n}>=a_{n} \quad(n \geq 0) \tag{1.11}
\end{equation*}
$$

By (1.11), we get

$$
\begin{equation*}
<t^{k} \mid x^{n}>=[n]_{q}!\delta_{n, k}, \quad(n, k \geq 0) \tag{1.12}
\end{equation*}
$$

where $\delta_{n, k}$ is Kronecker's symbol.
Let $f_{L}(t)=\sum_{k=0}^{\infty}<L \left\lvert\, x^{k}>\frac{t^{k}}{[k]_{q}!}\right.$. Then, by (1.12), we get

$$
\begin{equation*}
<f_{L}(t)\left|x^{n}>=<L\right| x^{n}> \tag{1.13}
\end{equation*}
$$

Additionally, the map $L \rightarrow f_{L}(t)$ is a vector space isomorphism from $\mathbb{P}^{*}$ onto $\mathbb{F}$. Henceforth, $\mathbb{F}$ denotes both the algebra of formal power series in $t$ and the vector space of all linear functionals on $\mathbb{P}$, and so an element $f(t)$ of $\mathbb{F}$ will be thought as a formal power series and a linear functional. We call $\mathbb{F}$ the $q$-umbral algebra. The $q$-umbral calculus is the study of $q$-umbral algebra. By (1.1) and (1.11), we easily see that $<e_{q}(y t) \mid x^{n}>=y^{n}$ and so $<e_{q}(y t) \mid p(x)>=p(y)$ for $p(x) \in \mathbb{P}$. The order $O(f(t))$ of the power series $f(t) \neq 0$ is the smallest positive integer for which $a_{k}$ does not vanish. If $O(f(t))=0$, then $f(t)$ is called an invertible series. If $O(f(t))=1$, then $f(t)$ is called a delta series(see[13], [14]).

For $f(t) \in \mathbb{F}(t), p(x) \in \mathbb{P}$, we have

f(t)=\sum_{k=0}^{\infty}<f(t)\left|t^{k}>\frac{t^{k}}{[k]_{q}!}, \quad p(x)=\sum_{k=0}^{\infty}<t^{k}\right| p(x)>\frac{x^{k}}{[k]_{q}!} \tag{1.14}
\end{equation*}
$$

Thus, by (1.14), we get

$$
\begin{equation*}
p^{(k)}(0)=<t^{k}|p(x)>, \quad<1| p^{(k)}(x)>=p^{(k)}(0) \tag{1.15}
\end{equation*}
$$

where $p^{(k)}(x)=D_{q}^{k} p(x)($ see [13], [14]).
From (1.15), we have

$$
\begin{equation*}
t^{k} p(x)=p^{(k)}(x)=D_{q}^{k} p(x) \tag{1.16}
\end{equation*}
$$

For $f(t), g(t) \in \mathbb{F}$ with $O(f(t))=1, O(g(t))=0$, there exists a unique sequence $S_{n}(x)\left(\operatorname{deg} S_{n}(x)=n\right)$ of polynomial such that $<g(t) f(t)^{k} \mid S_{n}(x)>=$ $[n]_{q}!\delta_{n, k},(n, k \geq 0)$. The sequence $S_{n}(x)$ is called the $q$-Sheffer sequence for $(g(t), f(t))$ which is denoted by $S_{n}(x) \sim(g(t), f(t))$.
For $S_{n}(x) \sim(g(t), f(t))$, we have

$$
\begin{equation*}
\frac{1}{g(\bar{f}(t))} e_{q}(y \bar{f}(t))=\sum_{k=0}^{\infty} \frac{S_{k}(y)}{[k]_{q}!} t^{k}, \text { for all } y \in \mathbb{C} \tag{1.17}
\end{equation*}
$$

where $\bar{f}(t)$ is the compositional inverse of $f(t)$ (see[13]).
Many researchers told that the properties of the $q$-extension of Frobenius-Euler polynomials are valuable and worthwhile in the areas of both number theory and mathematical physics (see[1],[2],[4]-[12]). In this paper, we consider new approach to $q$-extension of Frobenius-Euler numbers and polynomials which are derived from $q$-umbral Calculus and we give some interesting identities of our $q$-Frobenius-Euler numbers and polynomials. Finally, we suggest one open question related to orthogonality of Carlitz's $q$-Bernoulli polynomials.

## 2. $q$-extension of Frobenius-Euler polynomials

In this section, we assume that $\lambda \in \mathbb{C}$ with $\lambda \neq 1$. Now, we consider new $q$-extension of Frobenius-Euler polynomials which are derived form the generating function as follows:

$$
\begin{equation*}
\frac{1-\lambda}{e_{q}(t)-\lambda} e_{q}(x t)=\sum_{n=0}^{\infty} H_{n, q}(x \mid \lambda) \frac{t^{n}}{[n]_{q}!} \tag{2.1}
\end{equation*}
$$

In the special case, $x=0, H_{n, q}(0 \mid \lambda)=H_{n, q}(\lambda)$ are called the $n$-th $q$-Frobenius-Euler numbers. Note that $\lim _{q \rightarrow 1} H_{n, q}(x \mid \lambda)=H_{n}(x \mid \lambda)$, where $H_{n}(x \mid \lambda)$ are the $n$-th ordinary Frobenius-Euler polynomials.
By (2.1), we easily see that

$$
\begin{align*}
\sum_{n=0}^{\infty} H_{n, q}(x \mid \lambda) \frac{t^{n}}{[n]_{q}!} & =\left(\sum_{l=0}^{\infty} H_{l, q}(\lambda) \frac{t^{l}}{[l]_{q}!}\right)\left(\sum_{m=0}^{\infty} \frac{x^{m}}{[m]_{q}!} t^{m}\right) \\
& =\sum_{n=0}^{\infty}\left(\sum_{l=0}^{n}\binom{n}{l}_{q} H_{l, q}(\lambda) x^{n-l}\right) \frac{t^{n}}{[n]_{q}!} . \tag{2.2}
\end{align*}
$$

Thus, from (2.2), we have

$$
\begin{equation*}
H_{n . q}(x \mid \lambda)=\sum_{l=0}^{n}\binom{n}{l}_{q} H_{l, q}(\lambda) x^{n-l} \tag{2.3}
\end{equation*}
$$

By the definition of $q$-Frobenius-Euler numbers, we get

$$
\begin{align*}
1-\lambda & =\left(\sum_{l=0}^{\infty} H_{l, q}(\lambda) \frac{t^{l}}{[l]_{q}!}\right)\left(e_{q}(t)-\lambda\right) \\
& =\sum_{n=0}^{\infty}\left\{\sum_{m=o}^{n}\binom{n}{m}_{q} H_{n-m, q}(\lambda)\right\} \frac{t^{n}}{[n]_{q}!}-\lambda \sum_{n=0}^{\infty} H_{n, q}(\lambda) \frac{t^{n}}{[n]_{q}!}  \tag{2.4}\\
& =\sum_{n=0}^{\infty}\left\{H_{n, q}(1 \mid \lambda)-\lambda H_{n, q}(\lambda)\right\} \frac{t^{n}}{[n]_{q}!} .
\end{align*}
$$

By comparing the coefficients on the both sides, we get

$$
H_{0, q}(\lambda)=1, H_{n, q}(1 \mid \lambda)-\lambda H_{n, q}(\lambda)=\left\{\begin{array}{cl}
1-\lambda, & \text { if } n=0  \tag{2.5}\\
0, & \text { if } n>0 .
\end{array}\right.
$$

Therefore, by (2.3) and (2.5), we obtain the following theorem.
Theorem 2.1. For $n \geq 0$, we have

$$
H_{n, q}(x \mid \lambda)=\sum_{l=0}^{n}\binom{n}{l}_{q} H_{n-l, q}(\lambda) x^{l} .
$$

Moreover,

$$
H_{0, q}(\lambda)=1, H_{n, q}(1 \mid \lambda)-\lambda H_{n, q}(\lambda)=(1-\lambda) \delta_{0, n} .
$$

For examples, $H_{0, q}(\lambda)=1, H_{1, q}(\lambda)=\frac{-1}{1-\lambda}, H_{2, q}(\lambda)=\frac{\lambda+q}{(1-\lambda)^{2}}, \cdots$.
From (1.17) and (2.1), we have

$$
\begin{equation*}
H_{n, q}(x \mid \lambda) \sim\left(\frac{e_{q}(t)-\lambda}{1-\lambda}, t\right), \tag{2.6}
\end{equation*}
$$

and

$$
\begin{equation*}
\frac{1-\lambda}{e_{q}(t)-\lambda} e_{q}(x t)=\sum_{n=0}^{\infty} H_{n, q}(x \mid \lambda) \frac{t^{n}}{[n]_{q}!} . \tag{2.7}
\end{equation*}
$$

Thus, by (2.7), we get

$$
\begin{equation*}
\frac{1-\lambda}{e_{q}(t)-\lambda} x^{n}=H_{n, q}(x \mid \lambda),(n \geq 0) \tag{2.8}
\end{equation*}
$$

From (1.4), (1.16) and (2.8), we have

$$
\begin{align*}
t H_{n, q}(x \mid \lambda) & =\frac{1-\lambda}{e_{q}(t)-\lambda} t x^{n}=[n]_{q} \frac{1-\lambda}{e_{q}(t)-\lambda} x^{n-1}  \tag{2.9}\\
& =[n]_{q} H_{n-1, q}(x \mid \lambda) .
\end{align*}
$$

Therefore, by (2.8) and (2.9), we obtain the following lemma.

Lemma 2.2. For $n \geq 0$, we have

$$
H_{n, q}(x \mid \lambda)=\frac{1-\lambda}{e_{q}(t)-\lambda} x^{n}, t H_{n, q}(x \mid \lambda)=[n]_{q} H_{n-1, q}(x \mid \lambda)
$$

By (2.9), we get

$$
\begin{align*}
\left\langle\left.\frac{e_{q}(t)-\lambda}{1-\lambda} t^{k} \right\rvert\, H_{n, q}(x \mid \lambda)\right\rangle & =\frac{[k]_{q}!}{1-\lambda}\binom{n}{k}_{q}\left\langle e_{q}(t)-\lambda \mid H_{n-k, q}(x \mid \lambda)\right\rangle \\
& =\frac{[k]_{q}!}{1-\lambda}\binom{n}{k}_{q}\left\{H_{n-k, q}(1 \mid \lambda)-\lambda H_{n-k, q}(\lambda)\right\} \tag{2.10}
\end{align*}
$$

From (2.6), we have

$$
\begin{equation*}
\left\langle\left.\frac{e_{q}(t)-\lambda}{1-\lambda} t^{k} \right\rvert\, H_{n, q}(x \mid \lambda)\right\rangle=[n]_{q}!\delta_{n, k} \tag{2.11}
\end{equation*}
$$

By (2.10) and (2.11), we get

$$
\begin{align*}
0 & =\frac{1}{1-\lambda}\left(H_{n-k, q}(1 \mid \lambda)-\lambda H_{n-k, q}(\lambda)\right) \\
& =\sum_{l=0}^{n-k-l}\binom{n-k}{l}_{q} H_{l, q}(\lambda)+(1-\lambda) H_{n-k, q}(\lambda) \tag{2.12}
\end{align*}
$$

where $n, k \in \mathbb{Z}_{\geq 0}$ with $n>k$.
Thus, from (2.12), we have

$$
\begin{equation*}
H_{n-k, q}(\lambda)=\frac{1}{\lambda-1} \sum_{l=0}^{n-k-l}\binom{n-k}{l} H_{l, q}(\lambda) \tag{2.13}
\end{equation*}
$$

where $n, k \in \mathbb{Z}_{\geq 0}$ with $n>k$.
Therefore, by (2.13), we obtain the following theorem.
Theorem 2.3. For $n \geq 1$, we have

$$
H_{n, q}(\lambda)=\frac{1}{\lambda-1} \sum_{l=0}^{n-l}\binom{n}{l} H_{l, q}(\lambda)
$$

From (1.4) and (2.3), we have

$$
\begin{align*}
\int_{x}^{x+y} H_{n, q}(u \mid \lambda) d_{q} u & =\frac{1}{[n+1]_{q}} \sum_{l=0}^{n}\binom{n+1}{l+1}_{q} H_{n-l, q}(\lambda)\left\{(x+y)^{l+1}-x^{l+1}\right\} \\
& =\frac{1}{[n+1]_{q}} \sum_{l=0}^{n+1}\binom{n+1}{l}_{q} H_{n+1-l, q}(\lambda)\left\{(x+y)^{l}-x^{l}\right\} \\
& =\frac{1}{[n+1]_{q}}\left\{H_{n+1, q}(x+y \mid \lambda)-H_{n+1, q}(x \mid \lambda)\right\} \tag{2.14}
\end{align*}
$$

Thus, by (2.14), we get

$$
\begin{align*}
\left\langle\left.\frac{e_{q}(t)-1}{t} \right\rvert\, H_{n, q}(x \mid \lambda)\right\rangle & =\frac{1}{[n+1]_{q}}\left\langle\left.\frac{e_{q}(t)-1}{t} \right\rvert\, t H_{n+1, q}(x \mid \lambda)\right\rangle \\
& =\frac{1}{[n+1]_{q}}\left\langle e_{q}(t)-1 \mid H_{n+1, q}(x \mid \lambda)\right\rangle  \tag{2.15}\\
& =\frac{1}{[n+1]_{q}}\left\{H_{n+1, q}(1 \mid \lambda)-H_{n+1, q}(\lambda)\right\} \\
& =\int_{0}^{1} H_{n, q}(u \mid \lambda) d_{q} u
\end{align*}
$$

Therefore, by (2.15), we obtain the following theorem.
Theorem 2.4. For $n \geq 0$, we have

$$
\left\langle\left.\frac{e_{q}(t)-1}{t} \right\rvert\, H_{n, q}(x \mid \lambda)\right\rangle=\int_{0}^{1} H_{n, q}(u \mid \lambda) d_{q} u
$$

Let

$$
\begin{equation*}
\mathbb{P}_{n}=\{p(x) \in \mathbb{C}[x] \mid \operatorname{deg} p(x) \leq n\} \tag{2.16}
\end{equation*}
$$

be the $(n+1)$-dimensional vector space over $\mathbb{C}$. For $p(x) \in \mathbb{P}_{n}$, let us assume that

$$
\begin{equation*}
p(x)=\sum_{k=0}^{n} C_{k} H_{k, q}(x \mid \lambda), \quad(n \geq 0) \tag{2.17}
\end{equation*}
$$

Then, by (2.6), (2.11) and (2.17), we get

$$
\begin{align*}
\left\langle\left.\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right) t^{k} \right\rvert\, p(x)\right\rangle & =\sum_{l=0}^{n} C_{l}\left\langle\left.\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right) t^{k} \right\rvert\, H_{l, q}(x \mid \lambda)\right\rangle  \tag{2.18}\\
& =\sum_{l=0}^{n} C_{l}[l]_{q}!\delta_{l, k}=[k]_{q}!C_{k}
\end{align*}
$$

By (2.18), we get

$$
\begin{align*}
C_{k} & =\frac{1}{[k]_{q}!}\left\langle\left.\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right) t^{k} \right\rvert\, p(x)\right\rangle  \tag{2.19}\\
& =\frac{1}{(1-\lambda)[k]_{q}!}\left\{p^{(k)}(1)-\lambda p^{(k)}(0)\right\},
\end{align*}
$$

where $p^{(k)}(x)=D_{q}^{k} p(x)$. Therefore, by (2.17) and (2.19), we obtain the following theorem.
Theorem 2.5. For $p(x) \in \mathbb{P}_{n}$, let $p(x)=\sum_{k=0}^{n} C_{k} H_{k, q}(x \mid \lambda)$
Then we have

$$
C_{k}=\frac{1}{[k]_{q}!(1-\lambda)}\left\{p^{(k)}(1)-\lambda p^{(k)}(0)\right\},
$$

where $p^{(k)}(x)=D_{q}^{k} p(x)$.
Let us take $p(x)=B_{n, q}(x)$ with

$$
\begin{equation*}
B_{n, q}(x)=p(x)=\sum_{k=0}^{n} C_{k} H_{k, q}(x \mid \lambda) . \tag{2.20}
\end{equation*}
$$

Then, by Theorem 2.5, we get

$$
\begin{align*}
C_{k} & =\frac{1}{[k]_{q}!(1-\lambda)} \\
& \times\left\{[n]_{q}[n-1]_{q} \cdots[n-k+1]_{q} B_{n-k, q}(1)-\lambda[n]_{q} \cdots[n-k+1]_{q} B_{n-k, q}\right\} \\
& =\binom{n}{k}_{q} \frac{1}{1-\lambda}\left\{B_{n-k, q}(1)-\lambda B_{n-k, q}\right\} . \tag{2.21}
\end{align*}
$$

Therefore, by (2.21), we obtain the following theorem.
Theorem 2.6. For $n, k \geq 0$, with $n-k>0$, we have

$$
B_{n, q}(x)=\frac{1}{1-\lambda} \sum_{k=0}^{n}\binom{n}{k}_{q}\left\{B_{n-k, q}(1)-\lambda B_{n-k, q}\right\} H_{k, q}(x \mid \lambda)
$$

Let us take $p(x)=x^{n}$ with

$$
\begin{equation*}
x^{n}=p(x)=\sum_{k=0}^{n} C_{k} H_{k, q}(x \mid \lambda) \tag{2.22}
\end{equation*}
$$

From (1.5), we have

$$
\begin{equation*}
C_{k}=\frac{1}{1-\lambda}\binom{n}{k}_{q}-\frac{\lambda}{1-\lambda}\binom{n}{k}_{q} 0^{n-k} \tag{2.23}
\end{equation*}
$$

Thus, we have

$$
\begin{aligned}
x^{n} & =\frac{1}{1-\lambda} \sum_{k=0}^{n}\binom{n}{k}_{q} H_{k, q}(x \mid \lambda)-\frac{\lambda}{1-\lambda} H_{n, q}(x \mid \lambda) \\
& =\frac{1}{1-\lambda} \sum_{k=0}^{n-1}\binom{n}{k}_{q} H_{k, q}(x \mid \lambda)-H_{n, q}(x \mid \lambda) .
\end{aligned}
$$

By the same method, we easily see that

$$
E_{n, q}(x)=\frac{1}{1-\lambda} \sum_{k=0}^{n}\binom{n}{k}\left\{E_{n-k, q}(1)-\lambda E_{n-k, q}\right\} H_{k, q}(x \mid \lambda) .
$$

The $q$-extension of Frobenius-Euler polynomials of order $r(r \in \mathbb{N})$ are defined by the generating function to be

$$
\begin{equation*}
\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} e_{q}(x t)=\sum_{n=0}^{\infty} H_{n, q}^{(r)}(x \mid \lambda) \frac{t^{n}}{[n]_{q}!} \tag{2.24}
\end{equation*}
$$

In the special case, $x=0, H_{n, q}^{(r)}(0 \mid \lambda)=H_{n, q}^{(r)}(\lambda)$ are called the $n-$ th $q$-Frobenius-Euler numbers of order $r$.

From (2.24), we can derive the following equation (2.25):

$$
\begin{equation*}
H_{n, q}^{(r)}(x \mid \lambda)=\sum_{l=0}^{n}\binom{n}{l}_{q} H_{n-l, q}^{(r)}(\lambda) x^{l} \tag{2.25}
\end{equation*}
$$

by (1.17) and (2.24), we get

$$
\begin{equation*}
H_{n, q}^{(r)}(x \mid \lambda) \sim\left(\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right)^{r}, t\right) \tag{2.26}
\end{equation*}
$$

Thus, from (2.26), we have

$$
\begin{equation*}
\left\langle\left.\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right)^{r} t^{k} \right\rvert\, H_{n, q}^{(r)}(x \mid \lambda)\right\rangle=[n]_{q}!\delta_{n, k} \tag{2.27}
\end{equation*}
$$

For $p(x) \in \mathbb{P}_{n}$, let us assume that

$$
\begin{equation*}
p(x)=\sum_{k=0}^{n} C_{k}^{r} H_{k, q}^{(r)}(x \mid \lambda), \quad(n \geq 0) \tag{2.28}
\end{equation*}
$$

From (2.27) and (2.28), we can derive the following equation (2.29):

$$
\begin{align*}
\left\langle\left.\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right)^{r} t^{k} \right\rvert\, p(x)\right\rangle & =\sum_{l=0}^{n} C_{l}^{r}\left\langle\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right)^{r} t^{k}\right| H_{l, q}^{(r)}(x|\lambda\rangle \\
& =\sum_{l=0}^{n} C_{l}^{r}[l]_{q}!\delta_{l, k}=C_{k}^{r}[k]_{q}! \tag{2.29}
\end{align*}
$$

Thus, by (2.29), we get

$$
\begin{align*}
C_{k}^{r} & =\frac{1}{[k]_{q}!}\left\langle\left.\left(\frac{e_{q}(t)-\lambda}{1-\lambda}\right)^{r} t^{k} \right\rvert\, p(x)\right\rangle \\
& =\frac{1}{[k]_{q}!(1-\lambda)^{r}} \sum_{j=0}^{r}\binom{r}{j}(-\lambda)^{r-j}\left\langle\left(e_{q}(t)\right)^{j} \mid t^{k} p(x)\right\rangle \\
& =\frac{1}{[k]_{q}!(1-\lambda)^{r}} \sum_{j=0}^{r}\binom{r}{j}(-\lambda)^{r-j} \sum_{l=0}^{\infty} \sum_{l_{1}+\cdots+l_{j}=l} \frac{\left\langle 1 \mid p^{(k+l)}(x)\right\rangle}{\left[l_{1}\right]_{q}!\cdots\left[l_{j}\right]_{q}!}  \tag{2.30}\\
& =\frac{1}{[k]_{q}!(1-\lambda)^{r}} \sum_{l=0}^{\infty} \sum_{j=0}^{r} \sum_{l_{1}+\cdots+l_{j}=l} \frac{\binom{r}{j}(-\lambda)^{r-j}}{\left[l_{1}\right]_{q}!\cdots\left[l_{j}\right]_{q}!} p^{(k+l)}(0) .
\end{align*}
$$

Therefore, by (2.28) and (2.30), we obtain the following theorem.
Theorem 2.7. For $p(x) \in \mathbb{P}_{n}$, let $p(x)=\sum_{k=0}^{n} C_{k}^{r} H_{k, q}^{(r)}(x \mid \lambda)$.
Then we have

$$
C_{k}^{r}=\frac{1}{[k]_{q}!(1-\lambda)^{r}} \sum_{l=0}^{\infty} \sum_{j=0}^{r} \sum_{l_{1}+\cdots+l_{j}=l} \frac{\binom{r}{j}(-\lambda)^{r-j}}{\left[l_{1}\right]_{q}!\cdots\left[l_{j}\right]_{q}!} p^{(k+l)}(0),
$$

where $p^{(k+l)}(x)=D_{q}^{k+l} p(x)$.
From (1.17) and (2.30), we have

$$
\begin{equation*}
\sum_{n=0}^{\infty} H_{n, q}^{(r)}(x \mid \lambda) \frac{t^{n}}{[n]_{q}!}=\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} e_{q}(x t) \tag{2.31}
\end{equation*}
$$

Thus, from (2.31), we have.

$$
\begin{equation*}
H_{n, q}^{(r)}(x \mid \lambda)=\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} x^{n}, \quad(n \geq 0) \tag{2.32}
\end{equation*}
$$

and

$$
\begin{align*}
t H_{n, q}^{(r)}(x \mid \lambda) & =\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} t x^{n}=[n]_{q}\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} x^{n-1}  \tag{2.33}\\
& =[n]_{q} H_{n-1, q}^{(r)}(x \mid \lambda) .
\end{align*}
$$

Indeed,

$$
\begin{equation*}
\left\langle\left.\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} e_{q}(y t) \right\rvert\, x^{n}\right\rangle=H_{n, q}^{(r)}(y \mid \lambda)=\sum_{l=0}^{n}\binom{n}{l}_{q} H_{n-l, q}^{(r)}(\lambda) y^{l} \tag{2.34}
\end{equation*}
$$

and

$$
\begin{align*}
\left\langle\left.\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} \right\rvert\, x^{n}\right\rangle & =\sum_{m=0}^{\infty}\left(\sum_{i_{1}+\cdots+i_{r}=m} \frac{H_{i_{1}, q}(\lambda) \cdots H_{i_{r}, q}(\lambda)}{\left[i_{1}\right]_{q}!\cdots\left[i_{r}\right]_{q}!}\right)\left\langle t^{m} \mid x^{n}\right\rangle \\
& =\sum_{i_{1}+\cdots+i_{r}=n} \frac{[n]_{q}!}{\left[i_{1}\right]_{q}!\cdots\left[i_{r}\right]_{q}!} H_{i_{1}, q}(\lambda) \cdots H_{i_{r}, q}(\lambda) \\
& =\sum_{i_{1}+\cdots+i_{r}=n}\binom{n}{i_{1}, \cdots, i_{r}}_{q} H_{i_{1}, q}(\lambda) \cdots H_{i_{r}, q}(\lambda), \tag{2.35}
\end{align*}
$$

where $\binom{n}{i_{1}, \cdots, i_{r}}_{q}=\frac{[n]_{q}!}{\left[i_{1}\right]_{q}!\cdots\left[i_{r}\right]_{q}!}$.
From (2.34), we note that

$$
\begin{equation*}
\left\langle\left.\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r} \right\rvert\, x^{n}\right\rangle=H_{n, q}^{(r)}(\lambda),(n \geq 0) \tag{2.36}
\end{equation*}
$$

Therefore, by (2.35) and (2.36), we obtain the following theorem.
Theorem 2.8. For $n \geq 0$, we have

$$
H_{n, q}^{(r)}(\lambda)=\sum_{i_{1}+\cdots+i_{r}=n}\binom{n}{i_{1}, \cdots, i_{r}}_{q} H_{i_{1}, q}(\lambda) \cdots H_{i_{r}, q}(\lambda)
$$

Let us take $p(x)=H_{n, q}^{(r)}(x \mid \lambda) \in \mathbb{P}_{n}$ with

$$
H_{n, q}^{(r)}(x \mid \lambda)=p(x)=\sum_{k=0}^{n} C_{k} H_{k, q}(x \mid \lambda) .
$$

Then, by Theorem2.5, we get

$$
\begin{align*}
C_{k} & =\frac{1}{(1-\lambda)[k]_{q}!}\left\langle\left(e_{q}(t)-\lambda\right) t^{k} \mid p(x)\right\rangle \\
& =\frac{1}{1-\lambda}\binom{n}{k}_{q}\left\langle e_{q}(t)-\lambda \mid H_{n-k, q}^{(r)}(x \mid \lambda)\right\rangle  \tag{2.37}\\
& =\frac{\binom{n}{k}_{q}}{1-\lambda}\left\{H_{n-k, q}^{(r)}(1 \mid \lambda)-\lambda H_{n-k, q}^{(r)}(\lambda)\right\} .
\end{align*}
$$

From (2.24), we can readily derive the following equation (2.38):

$$
\begin{align*}
& \sum_{n=0}^{\infty}\left\{H_{n, q}^{(r)}(1 \mid \lambda)-\lambda H_{n, q}(\lambda)\right\} \frac{t^{n}}{[n]_{q}!} \\
& =\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r}\left(e_{q}(t)-\lambda\right)=(1-\lambda)\left(\frac{1-\lambda}{e_{q}(t)-\lambda}\right)^{r-1}  \tag{2.38}\\
& =(1-\lambda) \sum_{n=0}^{\infty} H_{n, q}^{(r-1)}(\lambda) \frac{t^{n}}{[n]_{q}!}
\end{align*}
$$

By comparing the coefficients on the both sides of (2.38), we get

$$
\begin{equation*}
H_{n, q}^{(r)}(1 \mid \lambda)-\lambda H_{n, q}^{(r)}(\lambda)=(1-\lambda) H_{n, q}^{(r-1)}(\lambda) \tag{2.39}
\end{equation*}
$$

Therefore, by (2.37) and (2.39), we obtain the following theorem.
Theorem 2.9. For $n \in \mathbb{Z}_{\geq 0}$ and $r \in \mathbb{N}$, we have

$$
H_{n, q}^{(r)}(x \mid \lambda)=\sum_{k=0}^{n}\binom{n}{k}_{q} H_{n-k, q}^{(r-1)}(\lambda) H_{k, q}(x \mid \lambda)
$$

Let us assume that $p(x)=H_{n, q}(x \mid \lambda) \in \mathbb{P}_{n}$ with

$$
\begin{equation*}
H_{n, q}(x \mid \lambda)=p(x)=\sum_{k=0}^{n} C_{k}^{r} H_{k, q}^{(r)}(x \mid \lambda) \tag{2.40}
\end{equation*}
$$

Then, by Theorem 2.7, we get

$$
\begin{align*}
C_{k}^{r}= & \frac{1}{(1-\lambda)^{r}[k]_{q}!} \sum_{m=0}^{n-k} \sum_{l=0}^{r}\binom{r}{l}(-\lambda)^{r-l} \\
& \times \sum_{i_{1}+\cdots+i_{l}=m}\binom{m}{i_{1}, \cdots, i_{l}}_{q} \frac{[n]_{q} \cdots[n-m-k+1]_{q}}{[m]_{q}!} H_{n-m-k, q}(\lambda) \\
= & \frac{1}{(1-\lambda)} \sum_{m=0}^{n-k} \sum_{l=0}^{r}\binom{r}{l}(-\lambda)^{r-l} \sum_{i_{1}+\cdots+i_{l}=m}\binom{m}{i_{1}, \cdots, i_{l}}_{q} \\
& \times \frac{[m+k]_{q}!}{\left.[m]_{q}[k]\right]_{q}!} \times \frac{[n]_{q} \cdots[n-m-k+1]_{q}}{[m+k]_{q}!} H_{n-m-k, q}(\lambda) \\
(1-\lambda)^{r} & \sum_{m=0}^{n-k} \sum_{l=0}^{r} \sum_{i_{1}+\cdots+i_{l}=m}\binom{r}{l} \\
& \times\binom{ m}{i_{1}, \cdots, i_{l}}_{q}\binom{m+k}{m}_{q}\binom{n}{m+k}_{q}(-\lambda)^{r-l} H_{n-m-k, q}(\lambda) . \tag{2.41}
\end{align*}
$$

Therefore, by (2.40) and (2.41), we obtain the following theorem.
Theorem 2.10. For $n, r \geq 0$, we have

$$
\begin{aligned}
& H_{n, q}(x \mid \lambda)=\frac{1}{(1-\lambda)^{r}} \sum_{k=0}^{n} \\
& \left\{\sum_{m=0}^{n-k} \sum_{l=0}^{r} \sum_{i_{1}+\cdots+i_{l}=m}\binom{r}{l}(-\lambda)^{r-l}\binom{m}{i_{1}, \cdots, i_{l}}_{q}\binom{m+k}{m}_{q}\binom{n}{m+k}_{q} H_{n-m-k, q}(\lambda)\right\} \\
& \times H_{k, q}^{(r)}(x \mid \lambda)
\end{aligned}
$$

Remark. By the same method, we can see that

$$
\begin{aligned}
& B_{n, q}^{(r)}(x) \\
& =\frac{1}{(1-\lambda)^{r}} \sum_{k=0}^{n}\left\{\sum_{m=0}^{n-k} \sum_{l=0}^{r} \sum_{i_{1}+\cdots+i_{l}=m}\binom{r}{l}(-\lambda)^{r-l}\binom{m}{i_{1}, \cdots, i_{l}}_{q}\binom{m+k}{m}_{q}\binom{n}{m+k}_{q} B_{n-m-k, q}^{(r)}\right\} \\
& \times H_{k, q}^{(r)}(x \mid \lambda) .
\end{aligned}
$$

As is well known, the Carltz's $q$-Bernoullli polynomials are defined by the generating function to be

$$
\begin{align*}
f(t, x) & =\sum_{n=0}^{\infty} \beta_{n, q} \frac{t^{n}}{n!} \\
& =-t \sum_{m=0}^{\infty} q^{2 m} e^{[m+x]_{q} t}+(1-q) \sum_{m=0}^{\infty} q^{m} e^{[m+x]_{q} t} \tag{2.42}
\end{align*}
$$

Thus, we note that $f(t, x)$ is an invertible series. From (2.42), we note that

$$
\begin{equation*}
\beta_{n, q}(x)=\frac{1}{(1-q)^{n}} \sum_{l=0}^{n}\binom{n}{l}(-1)^{l} q^{l x} \frac{l+1}{[l+1]_{q}},(\text { see }[3]) \tag{2.43}
\end{equation*}
$$

In the special case, $x=0, \beta_{n, q}=\beta_{n, q}(0)$ are called the $n$-th Carlitz's $q$-Bernoulli numbers.
By (2.42) and (2.43), we readily see that

$$
\beta_{n, q}(x)=\sum_{l=0}^{n}\binom{n}{l} q^{l x} \beta_{l, q}[x]_{q}^{n-l} \sim(f(t, x), t)
$$

Open Problem. Let

$$
\mathbb{P}_{n, q}=\left\{p\left([x]_{q}\right) \in \mathbb{C}\left[[x]_{q}\right] \mid \operatorname{deg} p\left([x]_{q}\right) \leq n\right\}
$$

For $p\left([x]_{q}\right) \in \mathbb{P}_{n, q}$, let us assume that $p\left([x]_{q}\right)=\sum_{k=0}^{n} C_{k, q} \beta_{k, q}(x)$.
Determine the coefficient $C_{k, q}$
